In no case is the author personally responsible for paying the page charge, nor is acceptance of the author's paper for publication dependent upon payment of the page charge.

INFORMATION FOR SUBSCRIBERS

Subscription prices per volume for Volume 82 (1976) and Volume 83 (1977) are list \$22.00, member \$11.00. The subscription price for members is included in the annual dues. Back number prices per volume for Volumes 1-55 (1894-1949) are list \$28.00, member \$21.00; Volumes 56-80 (1950-1974), list \$21.00, member \$15.75; Volume 81 (1975), list \$27.00, member \$20.25. Volume 82 (1976) when sold at back number prices will be list \$36.00, member \$27.00.

Back volumes of the BULLETIN are also available on 16 mm microfilm, either negative or positive, and may be mounted either on spools or in Eastman or 3M cartridges.
