# LIMIT THEOREMS FOR CERTAIN PARABOLIC EQUATION OF BOLTZMANN TYPE AND THEIR ASSOCIATED MARKOV PROCESSES*

## 1. Introduction

Consider the equation of Boltzmann type for a gas model with discrete velocity states:

\frac{\partial}{\partial t} u(t, i, x)=d_{i} \frac{\partial^{2}}{\partial x^{2}} u(t, i, x)+v_{i} \frac{\partial}{\partial x} u(t, i, x)  \tag{I}\\
\quad+\sum_{j, k=1}^{n} a_{j, k}^{i} u(t, j, x) u(t, k, x) \\
u(0, i, x)=u(i, x), \\
\quad i \in\langle 1, n\rangle, t \geqq 0, x \in R^{1},
\end{array}\right.
$$

where $\langle 1, n\rangle$ denotes the set $\{1,2, \cdots, n\}$,

$$
\left\{\begin{array}{l}
d_{1} \geqq 0, \cdots, d_{n} \geqq 0,  \tag{1.1}\\
v_{i} \text { and } a_{j, k}^{i} \text { are real numbers },
\end{array}\right.
$$

and $\left\{a_{j, k}{ }^{i}\right\}$ satisfies:

$$
\begin{cases}\sum_{i=1}^{n} a_{j, k}^{i}=0 & j, k \in\langle 1, n\rangle  \tag{1.2}\\ a_{j, k}^{i} \geqq 0 & \text { if } i \text { equals neither } j \text { nor } k\end{cases}
$$

This equation has been considered by Mimura [6], Yamaguchi [12], Conner [1] and Kolodner [4].

In this paper, we shall first discuss the asymptotic behavior of the solution $u(t, i, x)$ of equation (I) and, second, construct the temporally inhomogeneous Markov process $\left(X_{t}\right)$ associated with an appropriate solution $u(t, i, x)$ of equation (I) and, finally, investigate the limiting property of the process $\left(X_{t}\right)$.

[^0]When we consider a Markov process associated with equation (I), the second condition of (1.2) is strengthened as follows:

The following typical example of equation (I) is taken from Conner [1]. Let the velocity space be $\langle 1, n\rangle$, and assume that molecules travel $R^{1}$ with velocity $v_{i}$ if they are in the state $i$. Let $u(t, i, x) d x$ be the density of molecules at time $t$ with state $i$ whose positions belong to $d x$. Let $\nu_{j, k}=\nu_{k, j} \geqq 0$ be the collision rate between molecules of state $j$ and $k$ over the epoch $d t$, and $0 \leqq \Gamma_{j, k}^{i}$ $\leqq 1$ be the probability for a molecule of state $j$ to have its velocity state scattered from $j$ to $i$ through collision with a molecule of state $k$. Then we have,

= & \sum_{j, k=1}^{n}\left(\Gamma_{j, k}^{i} \nu_{j, k} u(t, j, x) u(t, k, x)-\Gamma_{i, k}^{j} \nu_{i, k} u(t, i, x) u(t, k, x)\right) .
\end{aligned}
$$

Conner defined

$$
B_{j, k}^{i}=\frac{1}{2} \nu_{j, k}\left(\Gamma_{j, k}^{i}+\Gamma_{k, j}^{i}-\left(\delta_{i, k}+\delta_{i, j}\right) \sum_{l=1}^{n} \Gamma_{j, k}^{l}\right)=\frac{1}{2} \nu_{j, k}\left(\Gamma_{j, k}^{i}+\Gamma_{k, j}^{i}-\delta_{i, j}-\delta_{i, k}\right)
$$

and represented the above equation in the form

$$
\frac{\partial}{\partial t} u(t, i, x)=-v_{i} \frac{\partial}{\partial x} u(t, i, x)+\sum_{j, k=1}^{n} B_{j, k}^{i} u(t, j, x) u(t, k, x) .
$$

This $B_{j, k}{ }^{i}$ is symmetric in $j$ and $k$ for each $i$ and satisfies condition (1.2) but does not satisfy condition (1.3). However if one defines

\end{aligned}

then the equation also is of the form

$$
\frac{\partial}{\partial t} u(t, i, x)=-v_{i} \frac{\partial}{\partial x} u(t, i, x)+\sum_{j, k=1}^{n} a_{j, k}^{i} u(t, j, x) u(t, k, x),
$$

with the $a_{j, k}{ }^{i}$ satisfying condition (1.2) and (1.3).
Throughout the paper, we shall discuss the case when the initial condition $u(0, i, x)$ is periodic with respect to $x$. Let $u(0, i, x)$ be a continuous, nonnegative periodic function on $R^{1}$ with period $\omega$. It then follows that the solution $u(t, i, x)$ of equation (I) is nonnegative, continuous and periodic with period $\omega$ on $R^{1}$ as well as $u(0, i, x)$, and the equation

\sum_{i=1}^{n} \int_{0}^{\omega} u(t, i, x) d x=\sum_{i=1}^{n} \int_{0}^{\omega} u(0, i, x) d x \quad t \geqq 0, \tag{1.4}
\end{equation*}
$$

is satisfied whenever the solution exists.
We shall also discuss separately the spatially homogeneous case, i.e.,

\frac{d}{d t} u(t, i)=\sum_{j, k=1}^{n} a_{j, k}^{i} u(t, j) u(t, k),  \tag{II}\\
u(0, i)=u(i)
\end{array}\right.
$$

Jenks [3] has studied the asymptotic behavior of the equation (II). Hence in this case, we confine ourselves to the problem on Markov processes.

## 2. Summary

We are concerned with spatially homogeneous cases in section 3 and section 4 , and spatially inhomogeneous cases from section 5 to 9.

In section 3, we construct a Markov process corresponding to the equation (II) when a nonnegative solution $u(t, i)$ is given. McKean [5] introduced a class of Markov processes associated with certain nonlinear parabolic equations, and Tanaka [9] and Ueno [11] continued its investigation in somewhat special cases. The process we consider here is the Markov process associated with (II) in the sense of McKean [5]. In section 4, we investigate the asymptotic behavior of the process.

In section 5, we study the equation (I) in a neighborhood of the fixed point $\left(u_{1}^{0}, \cdots, u_{n}^{0}\right)$, i.e., the solution of equation $\sum_{j, k=1}^{n} a_{j, k}{ }^{2} u_{j}^{0} u_{k}^{0}=0, i \in\langle 1, n\rangle$. We take ( $u_{1}^{0}, \cdots, u_{n}^{0}$ ) to be a probability vector. Suppose that the initial data $u(0, i, x)$ is continuous and periodic in $x$ with period $\omega$ and $\frac{1}{\omega} \sum_{i=1}^{n} \int_{0}^{\omega} u(0, i, x) d x=1$. Then if $\max _{i, x}\left|u(0, i, x)-u_{i}^{0}\right|$ is sufficiently small, equation (I) has a global solution $u(t, i, x)$ which converges to $u_{i}^{0}$ exponentially fast. In section 6 , under certain additional conditions, we shall show that the above result is valid for every positive initial data $u(0, i, x)$. In section 7, we construct a Markov process corresponding to the equation (I) with an appropriate solution $u(t, i, x)$ being fixed. This is also a Markov process of the type introduced by McKean [5]. Ogawa [7] [8] has proved a similar result. In section 8, we study the asymptotic behavior of the Markov process. In section 9, we treat the case $n=2$ in more details.

## 3. Markov processes corresponding to the equation (II)

Let $u(t, i)$ be a solution of equation (II):

$$

\frac{d}{d t} u(t, i)=\sum_{j, k=1}^{n} a_{j, k}^{i} u(t, j) u(t, k)  \tag{II}\\
u(0, i)=u(i)
\end{array}\right.
$$

where, $\left\{a_{j, k}{ }^{i}\right\}$ satisfies (1.2) and (1.3).
It is easy to see that if $u(0,1) \geqq 0, \cdots, u(0, n) \geqq 0$, then $u(t, 1) \geqq 0, \cdots, u(t, n)$ $\geqq 0$ for every $t \geqq 0$. (see. Yamaguchi [12]). The equation (II) implies that $\frac{d}{d t} \sum_{i=1}^{n} u(t, i)=0$, and $\sum_{i=1}^{n} u(t, i)=$ constant. Therefore the solution of (II) remains nonnegative and bounded.
In this paper, $\Omega$ denotes the set of probability $n$-vectors, i.e.,

Lemma 3.1. There exists $\left(u_{1}^{0}, \cdots, u_{n}^{0}\right)$ in $\Omega$ satisfying

\sum_{j, k=1}^{n} a_{j, k}^{i} u_{j}^{0} u_{k}^{0}=0 \quad i \in\langle 1, n\rangle \tag{3.1}
\end{equation*}
$$

Proof. Choose $L>0$ large enough to satisfy

u_{i}+\frac{1}{L} \sum_{j, k=1}^{n} a_{j, k}^{i} u_{j} u_{k} \geqq 0
$$

for any ( $u_{1}, \cdots, u_{n}$ ) in $\Omega$ and $i$ in $\langle 1, n\rangle$.
Then the mapping

$$
\Omega \ni\left(u_{i}\right) \rightarrow\left(u_{i}+\frac{1}{L} \sum_{j, k=1}^{n} a_{j, k}^{{ }^{i} u_{j}} u_{k}\right) \in R^{n}
$$

is continuous, and the range is contained in $\Omega$. Therefore, applying Brouwer's fixed point theorem, there exists $\left(u_{i}^{0}\right)$ in $\Omega$ such that

u_{i}^{0}+\frac{1}{L} \sum_{j, k=1}^{n} a_{j, k}^{i} u_{j}^{0} u_{k}^{0}=u_{i}^{0} & i \in\langle 1, n\rangle, \\
\text { i.e., } \sum_{j, k=1}^{n} a_{j, k}^{i} u_{j}^{0} u_{k}^{0}=0 & i \in\langle 1, n\rangle .
\end{array}
$$

Fix a nonnegative solution $u(t, i)$ of the equation (II), and put

$$
\left\{\begin{array}{l}
a_{i, j}(t)=\sum_{k=1}^{n} a_{i, k}^{j} u(t, k)  \tag{3.2}\\
A(t)=\left(a_{i, j}(t)\right)
\end{array}\right.
$$

Secondly, construct the fundamental solution $\left(U_{s, t}(i, j)\right)_{s \leq t}$ of the differential equation,

$$

\frac{d}{d t} \phi(t)=\phi(t) A(t)  \tag{3.3}\\
\phi(t)=(\phi(t, 1), \cdots, \phi(t, n))
\end{array}\right.
$$

That is $\left(U_{s, t}(i, j)\right)$ satisfies

$$
\left\{\begin{array}{l}
U_{s, s}=I=\left(\delta_{i, j}\right),  \tag{3.4}\\
\frac{d}{d t} U_{s, t}=U_{s, t} A(t), \\
U_{s, t} U_{t, u}=U_{s, u} \quad s \leqq t \leqq u
\end{array}\right.
$$

Since $u(t)$ is a solution of equation (II), and since $A(t)$ is defined by (3.2), it follows that $U_{s, t}$ depends only on $u(s)$ and $t-s$. Hence we may define

Theorem 3.1. $\quad\left(P_{i}^{u(s)}(i, j)\right)$ has the following properties:

& P_{t-s}^{u(s)}(i, j) \geqq 0 \quad s \leqq t, \tag{3.8}

\begin{equation*}
\sum_{j=1}^{n} P_{t-s}^{u(s)}(i, j)=1 \quad \text { for any } i \in\langle 1, n\rangle \tag{3.9}
\end{equation*}
$$

(3.10) If $\phi(t, i)$ is a solution of (3.3), then

$$
\phi(t, j)=\sum_{k=1}^{n} \phi(s, k) P_{t-s}^{u(s)}(k, j),
$$

especially, $u(t, j)=\sum_{k=1}^{n} u(s, k) P_{t-s}^{u(s)}(k, j)$.
Proof. (3.6), (3.7) and (3.10) are properties of $\left(U_{s, t}\right)$. Because $\{A(t)\}_{t \geq 0}$ are nonnegative offdiagonal matrices, (3.8) is obvious. (3.9) follows from $\frac{d}{d t} \sum_{i=1}^{n} \phi(t, i)=0$.

By this theorem, there exists a (in general) temporally inhomogeneous Markov process $\left(X_{t}\right)_{t \geq 0}$, whose transition probability is $U_{s, t}(i, j)=P_{t-s}^{u(s)}(i, j)$, and with state space $\langle 1, n\rangle$. Let $P_{s, i}(\cdot)$ denote the measure of the process starting at $i$ at time $s$.
4. Asymptotic behavior of the process $\left(X_{t}\right)$ associated with equation (II)

In this section, we consider the limit distribution of the process $\left(X_{t}\right)$. We
shall discuss the following three cases separately.
(A.1) There exists $u_{1}^{0}>0, \cdots, u_{n}^{0}>0$ and $m>0$ such that

\begin{aligned}
& \lim _{t \rightarrow \infty} u(t, i)=m u_{i}^{0} \quad i \in\langle 1, n\rangle \\
& \text { and } \sum_{i=1}^{n} u_{i}^{0}=1
\end{aligned}
$$

(A.2) There exists $\left(u_{1}^{0}, \cdots, u_{n}^{0}\right)$ in $\Omega$ and $m>0$ such that

\lim _{t \rightarrow \infty} u(t, i)=m u_{i}^{0} \quad \text { for any } i \in\langle 1, n\rangle \text { and } \int_{0}^{\infty}\left\|u(t)-m u^{0}\right\| d t<\infty
$$

For $x=\left(x_{1}, \cdots, x_{n}\right)$ in $R^{n},\|x\|$ means $\sum_{i=1}^{n}\left|x_{i}\right|$.
(A.3) There exists $T>0$ such that $u(t, k)=u(t+T, k)$ for any $k$ and $t \geqq 0$ and there exists $t_{0}$ in $[0, T]$ such that $u\left(t_{0}, k\right)>0$ for any $k$.

### 4.1. Case (A.1)

$$
\begin{equation*}
a_{i, j}=m \sum_{k=1}^{n} a_{i, k}{ }^{j} u_{k}^{0} \tag{4.1}
\end{equation*}
$$

satisfies

$$
\left\{\begin{array}{l}
\sum_{j=1}^{n} a_{i, j}=0  \tag{4.2}\\
\sum_{i=1}^{n} u_{i}^{0} a_{i, j}=0 \\
a_{i, j} \geqq 0 \quad \text { if } i \neq j
\end{array}\right.
$$

Therefore the matrix $A=\left(a_{i . j}\right)$ is a generator of a continuous time Markov chain having a positive invariant measure $\left(u_{1}^{0}, \cdots, u_{n}^{0}\right)$. Therefore, if necessary, changing the order of rows and columns, we may assume that $A$ has the form

\end{array}\right)
$$

where $A_{1}, \cdots, A_{l}$ are irreducible, and $A_{p}$ is $a k_{p} \times k_{p}$ square matrix $(1 \leqq p \leqq l)$ and $\sum_{p=1}^{1} k_{p}=n$.

In general, for a nonnegative offdiagonal matrix $A$, there exists $\lambda>0$ such that $A_{\lambda}=A+\lambda I$ is a nonnegative matrix. A nonnegative offdiagonal matrix $A$ is said to be irreducible if for any $i$ and $j$ in $\langle 1, n\rangle$, there exists $k(i, j)>0$ such that the ( $i, j$ ) component of $A_{\lambda}^{k(i, j)}$ is positive. Obviously, if $A$ is irreducible, then $e^{h A}(h>0)$ is a positive matrix, and the converse is also true.
$A(t)$ can be written in the form
(4.4) $\quad\left(\begin{array}{ccc}A_{1}(t) & & \\ & A_{2}(t) & 0 \\ 0 & \ddots & \\ & & \\ l & A_{l}(t)\end{array}\right)$
because $a_{i, j}=0$ implies $a_{i, j}(t)=0$. Therefore, we may consider each block separately. Hence we first assume that $A$ is irreducible.

Put

$$
\begin{equation*}
\mathscr{F}=\left\{\phi=\left(\phi_{1}, \cdots, \phi_{n}\right): \sum_{i=1}^{n} \phi_{i}=0\right\} \tag{4.5}
\end{equation*}
$$

Obviously, for $\phi$ in $R^{n}$, it holds that
(4.6) $\quad\left\|\phi e^{t A}\right\| \leqq\|\phi\| \quad t \geqq 0$.

For $h>0$, let $e^{h A}=\left(\alpha_{i, j}(h)\right), c(h)=\min _{1 \leqq i, j \leqq n} \alpha_{i, j}(h)>0$. If $\phi$ belongs to $\mathscr{F}$, then

\left\|\phi e^{h A}\right\| & =\sum_{j=1}^{n}\left|\sum_{i=1}^{n} \phi_{i} \alpha_{i, j}(h)\right|  \tag{4.7}\\
& =\sum_{j=1}^{n}\left|\sum_{i=1}^{n} \phi_{i}\left(\alpha_{i, j}(h)-c(h)\right)\right| \\
& \leqq \sum_{j=1}^{n} \sum_{i=1}^{n}\left|\phi_{i}\right|\left(\alpha_{i, j}(h)-c(h)\right) \\
& =(1-n c(h))\|\phi\|
\end{align*}
$$

These two results implies that there exists $K>0$ and $\rho>0$ satisfying
(4.8) $\quad\left\|\phi e^{t A}\right\| \leqq K e^{-\rho t}\|\phi\| \quad \phi \in \mathscr{F}$.

We can write equation (3.3) as

\frac{d}{d t} \phi(t)=\phi(t) A+\phi(t)(A(t)-A)
$$

or equivalently

\end{equation*}

Taking norms both sides of (4.9),

\left\|\phi(t)-\phi(0) e^{t A}\right\| \leqq \int_{0}^{t}\|\phi(s)(A(s)-A)\| K e^{-\rho(t-s)} d s \rightarrow 0
$$

This implies

\lim _{t \rightarrow \infty} \phi(t)=\lim _{t \rightarrow \infty} \phi(0) e^{t A}=\phi(0)\left(\begin{array}{l}
u_{1}^{0}, \cdots, u_{n}^{0}  \tag{4.10}\\
\cdots \cdots \cdots \cdots \\
u_{1}^{0}, \cdots, u_{n}^{0}
\end{array}\right) .
$$

In the general case, put $I_{p}$ be the set $\left\langle k_{1}+\cdots+k_{p-1}+1, k_{1}+\cdots+k_{p}\right\rangle$. Then

\lim _{t \rightarrow \infty} e^{t A_{p}}=\frac{1}{\sum_{j \in I_{p}} u_{j}^{0}}\left(\begin{array}{l}
u_{k_{1}+\cdots+k_{p-1}+1}^{0}, \cdots, u_{k_{1}+\cdots+k p}^{0} \\
\cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \\
u_{1_{1}+\cdots+k_{p-1}+1}^{0}, \cdots, u_{k_{1}+\cdots+k p}^{0}
\end{array}\right)
$$

Therefore, for $i$ in $I_{p}$ and $j$ in $I_{q}$, we get

\lim _{t \rightarrow \infty} P_{0, i}\left(X_{t}=j\right)= \begin{cases}0 & p \neq q,  \tag{4.11}\\ \frac{u_{j}^{0}}{\sum_{k \in I_{p}} u_{k}^{0}} & p=q\end{cases}
$$

### 4.2. Case (A.2)

Let $A=\left(a_{i, j}\right)$ be the matrix defined by (4.1). By the general theory of Markov chain, there always exists

Rewrite (4.9),

\phi(t)=\phi(0) e^{t A} & +\int_{0}^{t} \phi(s)(A(s)-A) \Pi d s  \tag{4.13}\\
& +\int_{0}^{t} \phi(s)(A(s)-A)\left(e^{(t-s) A}-\Pi\right) d s
\end{align*}
$$

Therefore, by the Assumption (A.2)

\| \phi(t)-\phi(0) e^{t A} & -\int_{0}^{t} \phi(s)(A(s)-A) \Pi d s \| \\
& \leqq \int_{0}^{t}\|\phi(s)(A(s)-A)\| \cdot\left\|e^{(t-s) A}-\Pi\right\| d s \rightarrow 0
\end{aligned}
$$

where, for $A=\left(a_{i, j}\right),\|A\|$ means $\max _{i \in\langle 1, n\rangle}\left(\sum_{j=1}^{n}\left|a_{i, j}\right|\right)$.
Since $\int_{0}^{\infty}\left\|u(t)-m u^{0}\right\| d t<\infty$, the integral $\int_{0}^{\infty} \phi(s)(A(s)-A) \Pi d s$ converges.
Therefore,

$$
\lim _{t \rightarrow \infty} \phi(t)=\phi(0) \Pi+\int_{0}^{\infty} \phi(s)(A(s)-A) \Pi d s
$$

Since we can write $\phi(t)=\phi(0) P_{t}^{u(0)}$, this means that

\lim _{t \rightarrow \infty} P_{t}^{u) 0}=\left(c^{u(0)}(i, j)\right)
$$

exists. Hence, we obtain
(4.14) $\quad \lim _{t \rightarrow \infty} P_{0, i}\left(X_{t}=j\right)=c^{u(0)}(i, j) \quad i, j \in\langle 1, n\rangle$.

### 4.3. Case (A.3)

\end{equation*}

Let

U_{t_{0}, t_{0}+T}=\left(c_{i, j}\right), \tag{4.16}
\end{equation*}
$$

then

\sum_{j=1}^{n} c_{i, j}=1  \tag{4.17}\\
\sum_{i=1}^{n} u\left(t_{0}, i\right) c_{i, j}=u\left(t_{0}, j\right) \quad j \in\langle 1, n\rangle \\
c_{i, j} \geqq 0
\end{array}\right.
$$

are satisfied. Changing, if necessary, the order of rows and columns of $A\left(t_{0}\right)$, we may write

Therefore, $U_{t_{0}, t_{0}+T}=\left(\begin{array}{cc}U_{1} & 0 \\ * & 0 \\ & \\ U_{l}\end{array}\right)$, where $U_{1}, \cdots, U_{l}$ are positive matrices. From this we shall show that $U_{t_{0}, t_{0}+T}$ must be of the form

We prove the case $l=2$, since the general case follows by induction. We write $U_{t_{0}, t_{0}+T}=\binom{U_{1}, 0}{U, U_{2}}$. If $U \neq 0$, the Perron-Frobenius root $\rho_{2}$ of $U_{2}$ is strictly smaller than 1 . This contradicts (4.17).

We first consider the case that $U_{t_{0}, t_{0}+T}$ is a single positive matrix. (4.15) and (4.17) implies

In general, let $U_{p}$ be $a k_{p} \times k_{p}$ square matrix for each $p \in\langle 1, l\rangle$ and $\sum_{p=1}^{i} k_{p}=n$ and $I_{p}$ be the set $\left\langle k_{1}+\cdots+k_{p-1}+1, k_{1}+\cdots+k_{p}\right\rangle$. Then

\cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots \cdots, \cdots \\
u\left(t_{0}, k_{1}+\cdots+k_{p-1}+1\right), \cdots, u\left(t_{0}, k_{1}+\cdots+k_{p}\right)
\end{array}\right) \frac{1}{\sum_{g \in I_{p}} u(0, g)}

and therefore for $i$ in $I_{p}$ and $j$ in $I_{q}$,

5. The basic theorem on the asymptotic behavior of the solution $\boldsymbol{u}(\boldsymbol{t}, \boldsymbol{i}, \boldsymbol{x})$ of equation (I)

Hereafter we shall be concerned with equation (I) under the condition (1.1) and (1.2) and always assume that either of the following condition is satisfied.
(I. a) $\quad d_{1}+\cdots+d_{n}>0$,
(I.b) $\quad d_{1}=\cdots=d_{n}=0$ and there exists $i$ and $j$ such that $v_{i} \neq v_{j}$.

If neither (I.a) nor (I.b) is satisfied, equation (I) is reduced to equation (II) by a simple change of variables.

Let $\omega>0$ be fixed, $S^{1}=R^{1} / \omega Z$, where $Z$ denotes the set of all integers, and $E=\langle 1, n\rangle \times S^{1}$.Let $\mu$ be the counting measure on $\langle 1, n\rangle$ :

\mu(d i)=\sum_{j=1}^{n} \delta_{j}(d i)

where $\delta_{j}(A)$ is the delta measure at $j$.
We use the notation $C(E)$ to denote the set of all bounded continuous functions on $E$ and the norm $\|\phi\|_{\infty}=\max _{(i, x) \in E}|\phi(i, x)|$, then $C(E)$ becomes a Banach space. As was pointed out in section 1 , if the initial condition $u(0, i, x)$ is a function of $C(E)$, then the solution $u(t, i, x)$ of equation (I) is in $C(E)$ for every $t \geqq 0$. Hence, we may consider equation (I) as an evolution equation in $C(E)$.

For each $i$ in $\langle 1, n\rangle$, let $\left\{T_{t}^{i}(x, d y)\right\}$ be the Markovian semigroup, whose
generator is given by the differential operator $d_{i} \frac{\partial^{2}}{\partial x^{2}}+v_{i} \frac{\partial}{\partial x}$.
Then we can transform equation (I) into the integral equation:

u(t, i, x)=T_{t}^{i} u(0, i, x)+\int_{0}^{t} T_{t-s}^{i}\left(\sum_{j, k=1}^{n} a_{j, k}^{i} u(s, j, \cdot) u(s, k, \cdot)\right)(x) d s \tag{I}

If $u(0, i, x)$ is twice continuously differentiable with respect to $x$, then the solution $u(t, i, x)$ of equation (I)' is also such a function (see Conner [1]), and therefore satisfies equation (I). For this reason, we say that $u(t, i, x)$ is the solution of equation (I) whenever $u(t, i, x)$ is the solution of the integral equation (I)'.

As we shall see below, we investigate a transformed function $v(t, i, x)$ rather than $u(t, i, x)$. The same situation for $u(t, i, x)$ is valid for the differential equation and the corresponding integral equation satisfied by $v(t, i, x)$.

If $\phi(x)$ is a periodic function on $R^{1}$ with period $\omega$, then

is satisfied. Therefore, we may consider that the semigroup acts on the function defined on $S^{1}$.

Assumption 5.1. There exists $u^{0}=\left(u_{1}^{0}, \cdots, u_{n}^{0}\right)$ in $\Omega$ such that $u_{1}^{0}>0, \cdots$, $u_{n}^{0}>0$ and $\sum_{j, k=1}^{n} a_{j, k}{ }^{i} u_{j}^{0} u_{k}^{0}=0$ are satisfied for $i$ in $\langle 1, n\rangle$. Let $b_{i, j}$ be $\sum_{k=1}^{n}\left(a_{j, k}^{i}+a_{k, j}^{i}\right) u_{k}^{0}$, and $B$ be the matrix $\left(b_{i, j}\right)$, then $B$ is a nonnegative offdiagonal irreducible matrix.

Remark. Assumption 5.1 (except the part of the irreducibility of $B$ ) was introduced by Jenks [3] to prove the asymptotic stability of the solution of equation (II).

Let $1=\frac{1}{\omega} \int_{E} u(0, i, x) \mu(d i) d x$ and $u(t, i, x)=u_{i}^{0}+v(t, i, x) u_{i}^{0}$, then equation (I) is transformed into the following equation:

We first consider the linearized equation for $v(t, i, x)$,

We choose $q\rangle 0$ large enough to satisfy $q+c_{i, i} \geqq 0$ for all $i$ in $\langle 1, n\rangle$. For this $q$, (5.3) is equivalent to

Let $\left\{T_{t}\right\}$ be the semigroup generated by equation (5.3)' i.e., $\left(T_{t} v\right)(i, x)=$ $\int_{E} T_{t}(i, x: d j, d y) v(j, y)$, where $T_{t}(i, x: d j, d y)$ is the solution of the equation

holds for some positive constant $K$.
(ii) Case (I.b).

Let $d_{i}=0$ for every $i$ and let $v_{i_{0}} \neq v_{j_{0}}$ for some $i_{0} \neq j_{0}$. Using (5.5), we shall prove for any $m \geqq 1$,

& \quad \cdots p_{k_{m-1}, k_{m}} \delta_{k_{m}}(d j) \delta\left(z+v_{k}\left(s-s_{1}\right)+v_{k_{1}}\left(s_{1}-s_{2}\right)+\cdots+v_{k_{m-1}}\left(s_{m-1}-s_{m}\right)\right. \\
& \left.\quad+v_{k_{m}-m} s_{m}, d y\right) \\
& \quad=\text { the right hand side of }(5.9) \text { for } m+1 .
\end{aligned}

Therefore, for a nonnegative function $\phi$ on $E$,

is satisfied. By Assumption 5.1, for any $i$ and $j$, we can find $m$ and $k_{1}, \cdots, k_{m-1}$ such that

& =\int_{0}^{\left(v_{j}-v_{k_{0}}\right) s_{r_{0}}} \frac{y^{m-1-r_{0}}}{\left(m-1-r_{0}\right)!} \phi(j, \theta+y) \frac{d y}{\left(v_{j}-v_{k r_{0}}\right)^{m-r_{0}}}
\end{align*}

If $s_{r_{0}}>\frac{\omega}{\left|v_{j}-v_{k r_{0}}\right|}$, there exists $K>0$ such that for every $\theta$,
(5.10) $\geqq K \int_{0}^{\omega} \phi(j, y) d y$.

From this, we can easily show that $T_{t}(i, x: j, d y) \geqq L d y$ for sufficiently large $t$ and every $i, j$ and $x$.

Next we set

Combining this and $\left\|T_{t} \phi\right\|_{\infty} \leqq\|\phi\|_{\infty}$ for any $\phi$ in $C(E)$, we obtain the result.

We now turn to the nonlinear equation (5.2). We define a mapping $B$ : $C(E) \rightarrow C(E)$ by

\|v(t)\|_{\infty} \leqq N e^{-\rho t}\|v(0)\|_{\infty}+\int_{0}^{t} d s N e^{-\rho_{s}} K\|v(t-s)\|_{\infty}^{2} \tag{5.17}
\end{equation*}
$$

If $\|v(0)\|_{\infty}<\frac{\rho}{N^{2} K}$ then (5.16) has a global solution and

\begin{equation*}
\|v(t)\|_{\infty} \leqq \frac{\rho}{N K+\frac{\rho-N^{2} K\|v(0)\|_{\infty}}{N\|v(0)\|_{\infty}} e^{\rho t}} \tag{5.18}
\end{equation*}

is satisfied. Summing up the above results, we obtain
Theorem 5.1. Under the Assumption 5.1, let $N>0, \rho>0$ and $K>0$ be the constants defined in Lemma 5.3 and (5.15) respectively. Suppose that $u(0, i, x) \in$ $C(E), \frac{1}{\omega} \int_{E} u(0, i, x) \mu(d i) d x=1$ and $\sup _{(i, x) \in E}\left(\frac{\left|u(0, i, x)-u_{i}^{0}\right|}{u_{i}^{0}}\right)<\frac{\rho}{N^{2} K}$. Then equation (I) has a global solution $u(t, i, x)$ in $C(E)$ tending to $u_{i}^{0}$ exponentially fast.

Remark. Let $m$ be a positive constant. If $m=\frac{1}{\omega} \int_{E} u(0, i, x) \mu(d i) d x$, then we transform $u(t, i, x)=m u_{i}^{0}+v(t, i, x) u_{i}^{0}$, and we get similar results as in Lemma 5.1~Lemma 5.3. Therefore, if $\left\|u(0, i, x)-m u_{i}^{0}\right\|_{\infty}$ is sufficiently small, then equation (I) has a global solution $u(t, i, x)$ and $u(t, i, x)$ converges to $m u_{i}^{0}$ exponentially fast.
6. Further results on the asymptotic behavior of the solution $u(t, i, x)$ of equation (I)

In this section, we assume the following condition as well as Assumption 5.1.
Assumption 6.1. There exists $c>0$ such that for every $\left(\eta_{1}, \cdots, \eta_{n}\right)$ in $[0,1]^{n}$,

Remark. Broadwell's model (see [6]) does not satisfy Assumption 5.1 and Assumption 6.1.

By the following remarks, it is seen that this condition assures the boundedness of solutions of equation (I).

If Assumption 6.1 is satisfied, then for any $M>0$ and $\left(\eta_{1}, \cdots, \eta_{n}\right)$ in $[0, M]^{n}$,

Assumption 6.1 is not easy to be verified. However one can show that Assumption 6.1 holds if

Since $\sum_{k=1}^{n} c_{j, k}^{i}=0$ and $c_{j, k}^{i} \geqq 0$ if $i \neq j$ and $i \neq k$, the first term on the right is majorized by $c\left(1-\eta_{i}\right)$, where $c \geqq-\sum_{j \neq i} c_{j, i}{ }^{i} \geqq 0$ for every $i$. By virtue of (6.2), it follows that second term on the right is also majorized by $c\left(1-\eta_{i}\right)$, where $c \geqq-\left(\sum_{k=1}^{n} b_{i, k}+b_{i, j}{ }^{i}-a_{i, i}\right) \geqq 0$ for every $i$.

Lemma 6.1. Suppose that Assumption 6.1 is satisfied, then the equation

is a confinement system for $[0, M]^{n}$ for every $M>0$. Conversely, if equation (6.3) is a confinement system for $[0, M]^{n}$ for some $M>0$, then Assumption 6.1 is satisfied.

Equation (6.3) is said to be a confinement system for $[0, M]^{n}$ if for any initial value $0 \leqq v(0, i, x) \leqq M(1 \leqq i \leqq n)$, we have $0 \leqq v(t, i, x) \leqq M(1 \leqq i \leqq n)$ for every $t \geqq 0$.

Proof. If Assumption 6.1 is satisfied, rewrite (6.3) as

If we solve (6.3)" in the iteration scheme, it follows that equation (6.3) is a confinement system for $[0, M]^{n}$ for every $M>0$.

Conversely, suppose that equation (6.3) is a confinement system for $[0, M]^{n}$ for some $M>0$. Let

then $w(t, i, x) \geqq e^{-c M t} z(t, i, x)$, especially $v(t, i, x) \geqq \delta$ and we can see that $m(t)$ is an increasing function in $t$. By Lemma 5.1, there exists $t_{0}>0$ and $k>0$ satisfying

By step (i), we may assume $v(t, i, x) \geqq \delta>0$ for any $t, i$ and $x$. By Lemma 6.1, $M(t)$ is a decreasing function. By Lemma 5.1, there exists $t_{1}>0$ and $c>0$ such that

Using Assumption 6.1 and $w(s, j, y)=v(s, j, y)-\delta \leqq M\left(n t_{1}\right)-\delta$ for $n t_{1} \leqq s$, we have

Following Jenks [3], the system $\left\{a_{j, k}{ }^{i}\right\}$ is said to be irreducible, if for any partition of $\langle 1, n\rangle$ into $I$ and $J$, there always exists some $i$ in $I$ and $(j, k)$ in $J \times J$ satisfying $a_{j, k}^{i}>0$.

Lemma 6.2. Suppose that either (a) or (b) is satisfied:
(a) Assumption 6.1 and the following condition are satisfied:

There exists $c>0$ and a nonnegative, irreducible matrix $\left(e_{i, j}\right)$ such that

Take a probability matrix $\left(\tilde{e}_{i, j}\right)$ i.e.., $\sum_{j=1}^{n} \tilde{e}_{i, j}=1$ such that $\tilde{e}_{i, j}=0$ iff $e_{i, j}=0$ and a small $k>0$ such that $e_{i, j} \geqq k \tilde{e}_{i, j}$ for all $(i, j)$ in $\langle 1, n\rangle \times\langle 1, n\rangle$. $n>0$, and $E^{0}$ is a single point $\{\partial\}$ ), and we write $P_{(i, x)}$ for its measure starting at $(i, x)$ in $E$, and $E_{(i, x)}$ for its expectation. Function $\phi$ on $E$ with $0 \leqq \phi(i, x) \leqq 1$ can be extended on $S$ by

It is known that

Since $v(t, i, x) \geqq w(t, i, x)$, it is sufficient to show $w\left(t_{1}, i, x\right)>0$ for some $t_{1}>0$. Let $\left\{T_{t}\left(i, x: d\left(j_{1}, y_{1}\right) \cdots d\left(j_{k}, y_{k}\right)\right)\right\}$ be the branching semigroup of $\left(X_{t}\right)$, then

We first consider the case (I.b) in the beginning of section 5 . In general for $m \geqq 1$, we have

& \prod_{k_{2}=0}^{1} \int_{0}^{s_{2}^{h_{3}}} e^{-c\left(s_{2}^{\left.h_{3}-s_{1}^{h_{2}}\right)} d s_{1}^{h_{2}} e^{-2 c s_{1}^{h_{2}}} k \tilde{e}_{k_{2}, k_{1}}\right.} \\
& \prod_{h_{1}=0}^{1} \delta\left(k_{1}, x+v_{i}(t-s)+v_{k_{m}}\left(s-s_{m-1}^{h_{m}}\right)+\cdots+v_{k_{2}}\left(s_{2}^{h_{3}}-s_{1}^{h_{2}}\right)+v_{k_{1}} s_{1}^{k_{2}}: d\left(j, y_{h_{m} \cdots h_{1}}\right)\right),
\end{aligned}

where each $k_{m}$ is an arbitrary integer in $\langle 1, n\rangle$ and $y_{h_{m} \cdots h_{1}}$ denotes $y_{h_{m^{2}}{ }^{m-1}+\cdots+h_{1}}$. In fact $T_{t}\left(i, x: d\left(j, y_{0}\right) \cdots d\left(j, y_{2}{ }^{m}{ }_{-1}\right)\right)$ equals the summation of the right side of (6.12) over all $k_{m}, \cdots, k_{1}$ in $\langle 1, n\rangle$.

Therefore, there exists $c_{m}(t)>0$ for each $t>0$ and $m>1$ such that

Fix a $j$ such that $v(0, j, x) \neq 0$ and suppose that $v_{i_{0}} \neq v_{j 0}$. For any $i$, we can choose $k_{2}, k_{3}, \cdots, k_{m-1}$ such that

This proves that $w\left(t_{1}, i, x\right)>0$ for some $t_{1}$ which does not depend on $i$ and $x$.

Next we consider the case (I.a) in the beginning of section 5. Suppose that $d_{i_{0}}>0$. As before, fix a $j$ such that $v(0, j, x) \equiv 0$. In general for $m \geqq 1$, it follows from the preceding property that

where $y_{h_{m} \cdots h_{1}}$ denotes $y_{h_{m^{2}}{ }^{m-1}+\cdots+h_{1}}$.
Therefore, there exists $c_{m}(t)>0$ for each $t>0$ and $m \geqq 1$, such that

We can choose $k_{2}, k_{3}, \cdots, k_{m-1}$ such that

We shall show that $T_{t_{0}} \hat{v}\left(0, i_{0}, x\right)>0$ for large enough $t_{0}$, by the induction on $m$. It is easy to see this in the case $m=1$. We assume that we have shown $1,2, \cdots$, $m-1$ and prove the case $m$. If some $d_{k_{l}}$ or $d_{j}$ is positive, then this is reduced to the case that we assumed to have shown. Therefore, we may assume $d_{k_{2}}=$ $\cdots=d_{k_{m}}=0$. Inequality (6.14) becomes

If $v_{k_{1}}=\cdots=v_{k_{m}}$, then $v\left(0, j, y+v_{k_{m}}\left(s-s_{m-1}^{h_{m}}\right)+\cdots+v_{j} s_{1}^{h}\right)^{2}=v\left(0, j, y+v_{j} s\right)^{2}$, so that

If $\left(v_{j}, v_{k_{1}}, \cdots, v_{k_{m}}\right)$ contains at least two different numbers, then this is reduced to the case (I.b) which we have proved previously.

Set $\left.J=\left\{j \in\langle 1, n\rangle: \inf _{x \in S^{1}} v\left(2 t_{0}, j, x\right)\right\rangle 0\right\}$. If $J$ is a proper subset of $\langle 1, n\rangle$, then let $I$ be the set $\langle 1, n\rangle-J$. Since ( $\tilde{e}_{i, j}$ ) is irreducible, there exists $i$ in $I$ and $J$ such that $\tilde{e}_{i, j}>0$. Then by equation (6.11)', we have

We next delete the restriction $0 \leqq v(0, i, x) \leqq 1$. If $0 \leqq v(0, i, x) \leqq M$, set $\tilde{v}(t, i, x)=\frac{v(t, i, x)}{M}$, then $\tilde{v}(t, i, x)$ satisfies the equation

It follows that $\tilde{b}_{j, k}{ }^{i}=M b_{j, k}{ }^{i}$ satisfies Assumption 6.2 with $c$ and $b_{i, j}$ replaced by $M c$ and $M b_{i, j}$. By the preceding result, it follows that $\inf _{(i, k) \in B} \bar{v}\left(t_{1}, i, x\right)>0$ for some $t_{1}$. Hence we have $\inf _{(i, k) \in B} v\left(t_{1}, i, x\right)>0$. Thus we have shown Lemma 6.2.

Summing up Theorem 6.1 and Lemma 6.2, we obtain
Theorem 6.2. Suppose that either (a) or (b) in Lemma 6.2 is satisfied, then for any nonnegative $u(0, i, x)$ in $C(E)$, the solution $u(t, i, x)$ of equation (I) converges to $m u_{i}^{0}$ exponentially fast, where $m=\frac{1}{\omega} \int_{E} u(0, i, x) \mu(d i) d x$.

## 7. Markov processes corresponding to equation (I)

In section 7 and section 8, condition (1.3) is always assumed. In this section, we also assume that equation (I) has a continuous nonnegative solution $u(t, i, x)$. Fix this $u(t, i, x)$ and consider the following equation for $s \leqq t$

Here the precise meaning of (7.1) shoud be understood as

for all $f \in C^{\infty}(E)$.
For each $T<\infty$, let $q_{T}=\max _{\substack{c i, x \in \in \in \\ 0 \leqq t \leqq T}}\left\{\sum_{k=1}^{n}\left|a_{i, k}^{i} u(t, k, x)\right|\right\}$. We denote $\left\{\tilde{T}_{t}^{i}(x, d y)\right\}$ to be the Markovian semigroup whose generator is the differential operator $d_{i} \frac{\partial^{2}}{\partial x^{2}}-v_{i} \frac{\partial}{\partial x}$. Then we can transform equation (7.1) into the integral equation

& \quad 0 \leqq s \leqq t \leqq T .
\end{align*}

Let $\phi(t)=\phi(t, E) . \quad$ Then from (7.2),

i.e., $\phi(t)=\phi(s)$, and therefore the solution preserves the total measure. If $\phi(s, d i, d x)$ is a nonnegative measure, then the solution $\phi(t, d i, d x)$ of (7.2) is also a nonnegative measure. If we solve (7.2) in the iteration scheme, then we get a minimal solution $\phi(t, d i, d x)$. Because of the preservation of total measure, (7.1) has a unique solution. Since (7.2) is a linear equation in $\phi$, (7.2) (i.e., (7.1)) always has a unique solution. We denote $\left\{P_{s, t}(i, x: d j, d y)\right\}_{s \leq t}$ the solution of (7.1) when $\phi(s, d j, d y)=\delta_{(i, x)}(d j, d y)$.

Theorem 7.1. $\left\{P_{s, t}(i, x: d j, d y)\right\}_{s \leq t}$ has the following properties:

and let $\phi(t, d i, d x)$ be the solution of (7.1) with $\phi(s, d i, d x)=\psi(i, x) \mu(d i) d x$, then it follows that

Proof. It is sufficient to show our theorem for each $T<\infty$ and $0 \leqq s \leqq t$ $\leqq u \leqq T$. (7.3) and (7.6) follow from the uniqueness of solution of equation (7.1). If we solve (7.2) in the iteration scheme, then (7.4) is clear. (7.5) follows from the preservation of total measure. Next we prove (7.8). Let $\phi(t, d i, d x)=$ $\psi(t, i, x) \mu(d i) d x$, then for any $v(i, x)$ in $C^{\infty}(E)$,

and $\phi(s, d i, d x)=\psi(i, x) \mu(d i) d x$. By the uniqueness of solution of (7.1), $\phi(t, d i, d x)$ $=\psi(t, i, x) \mu(d i) d x$.

By Theorem 7.1, we can construct a temporally inhomogeneous Markov process $\left(X_{t}\right)$ with transition probability $\left(P_{s, t}\right)$ and the state space $E$. Let $P_{s,(i, x)}(\cdot)$ denote the measure of the process starting at $(i, x)$ at time $s$.
8. Asymptotic behavior of the process $\left(X_{t}\right)$ associated with equation (I)

Let $u(i, x)$ be a twice continuously differentiable and strictly positive function, satisfying

Suppose that $u(t, i, x)$ is a nonnegative solution of equation (I) such that

Throughout in this section, we shall fix such $u(i, x)$ and $u(t, i, x)$ and assume the following condition:

Assumption 8.1. Each nonnegative offdiagonal matrix $\left(\sum_{k=1}^{n} a_{j, k}^{i} u(k, x)\right), x \in S^{1}$, is irreducible.

Under these hypothesis, we shall study the asymptotic behavior of the process $\left(X_{t}\right)$ defined in the preceding section.

Let $\left\{S_{t}\right\}$ be the semigroup generated by the following differential equation,

or, equivalently

Lemma 8.1. There exists $K>0$ and $\rho>0$ satisfying

& \leqq \sum_{i=1}^{n} \int_{S^{1}} d x \int_{E}\left(S_{t_{1}}(i, x: d j, d y)-c \mu(d j) d y\right)|\phi(0, j, y)| \\
& =(1-c n \omega) \sum_{j=1}^{n} \int_{S^{1}}|\phi(0, j, y)| d y
\end{aligned}
$$

i.e., $\left\|S_{t_{1}} \phi\right\|_{1} \leqq(1-c n \omega)\|\phi\|_{1}$. Combining this and $\left\|S_{t} \phi\right\|_{1} \leqq\|\phi\|_{1}$, we get the result.

Theorem 7.1 implies the $L^{1}$-boundedness of the solution $\psi(t, i, x)$ of equation (8.3). Therefore

& \left\|\psi(t)-S_{t} \psi(0)\right\|_{1}=\left\|\int_{0}^{t} S_{t-s}(A(s)-A) \psi(s) d s\right\|_{1} \\
& \leqq \int_{0}^{t} K e^{-\rho(t-s)}\|(A(s)-A) \psi(s)\|_{1} d s \rightarrow 0, \text { as } t \rightarrow \infty
\end{aligned}
$$

since $\|(A(s)-A) \psi(s)\|_{1} \leqq \max _{1 \leqq j \leqq n}\left(\sum_{i, k=1}^{n}\left|a_{j, k}{ }^{i}\right|\right)\|u(s)-u\|_{\infty}\|\psi(s)\|_{1}$.

Let $m=\frac{\int_{E} \psi(0, i, x) \mu(d i) d x}{\int_{E} u(i, x) \mu(d i) d x}$, then $\eta(0)=\psi(0)-m u$ belongs to $\mathscr{E}$, therefore,

\lim _{t \rightarrow \infty} \psi(t)=\lim _{t \rightarrow \infty} S_{t} \psi(0)=\lim _{t \rightarrow \infty}\left(S_{t} \eta(0)+m S_{t} u\right)=m u
$$

in the $L^{1}$ sense. This means that

\lim _{t \rightarrow \infty} \int_{E} \psi(t, i, x) f(i, x) \mu(d i) d x=m \int_{E} u(i, x) f(i, x) \mu(d i) d x \tag{8.4}
\end{equation*}
$$

holds for any bounded Borel measurable function $f(i, x)$.
Theorem 8.1. Under the Assumption 8.1, it holds that for any Borel set $A$ in $S^{1}$, and $(i, x)$ in $E$,

By (7.8) in Theorem 7.1, (8.5) is nothing but (8.4) when the initial measure has a density with respect to the Lebesgue measure. In the general case, we fix $i_{0}$ and $x_{0}$ arbitrarily and divide

Let $\phi(t)=\int_{E} p_{0, t}\left(i_{0}, x_{0}: j, y\right) \mu(d j) d y$.
Lemma 8.2. $\quad \phi(t)$ increases to 1 .
Proof. Since $\int_{E} p_{0, t}\left(i_{0}, x_{0}: k, z\right) \mu(d k) d z P_{t, t+s}(k, z: j, d y)$ is absolutely continuous for the Lebesgue measure it follows that $p_{0, t+s}\left(i_{0}, x_{0}: j, y\right) \mu(d j) d y \geqq \int_{E} p_{0, t}$ $\left(i_{0}, x_{0}: k, z\right) \mu(d k) d z P_{t, t+s}(k, z: d j, d y)$ and $\phi(t+s) \geqq \phi(t)$. This means that $\phi(t)$ is an increasing function. We show that there exists $s_{0}>0, s_{1}>0$ and $c>0$ such that

Since $u(i, x)$ is strictly positive, and by (8.1), there exists $s_{1}>0, m>0$ and $M<\infty$ such that

then for $t \geqq s_{1}$,

\left(\sum_{k=1}^{n} a_{j, k}^{i} u(t, k, x)\right) \geqq\left(a_{j, i}\right)
$$

It is easy to see that the matrix $\left(a_{j, i}\right)$ is irreducible. Let $q=\max _{1 \leq i \leq n}\left|a_{i, i}\right|$, and $p_{j, i}=a_{j, i}+q \delta_{j, i}$, then for $t \geqq s \geqq s_{1}$,

& \geqq \delta_{i, j} \widetilde{T}_{t-s}^{i}(x, d y) e^{-q(t-s)}+\int_{s}^{t} e^{-q(t-r)} d r \int_{E} P_{s, r}(i, x: d l, d z) p_{l, j} \widetilde{j}_{t-r}^{j}(z, d y) .
\end{aligned}
$$

This means that for all $i, x, j$ and $t \geqq r \geqq s_{1}$, it holds that

where $Q_{t-r}(\cdot: \cdot)$ is the solution of

Q_{t-s}(i, x: j, d y)= \\
\delta_{i, j} \widetilde{T}_{t-s}^{i}(x, d y) e^{-q(t-s)}
\end{array}\right. \\
\quad+\int_{s}^{t} e^{-q(t-r)} d r \int_{E} Q_{r-s}(i, x: d l, d z) p_{l, j} \widetilde{T}_{t-r}^{j}(z, d y)
\end{array}\right.
$$

The above equation is analogous to (5.5), as that the proof of Lemma 5.1 is applicable, therefore we can see that there exists $c>0$ and $s_{0}>0$ such that

Q_{s_{0}}(i, x: j, d y) \geqq c d y
$$

for all $(i, x)$ in $E$ and $j$ in $\langle 1, n\rangle$. This proves (8.7).
For $t \geqq s_{1}$, we have

& \quad+\int_{E} P_{0, t}^{(s)}\left(i_{0}, x_{0}: d k, d z\right) c \int_{E} \mu(d j) d y \\
& =\phi(t)+c n \omega(1-\phi(t))
\end{aligned}
$$

Let $\phi(\infty)=\lim _{t \rightarrow \infty} \phi(t)$, then it follows that

\phi(\infty) \geqq \phi(\infty)+c n \omega(1-\phi(\infty))
$$

This means $\phi(\infty)=1$, and we have proved Lemma 8.2.
We now turn to the proof of Theorem 8.1. Let $f$ be a measurable function such that $0 \leqq f(i, x) \leqq 1$.
$\int_{E} p_{0, s}\left(i_{0}, x_{0}: k, z\right) \mu(d k) d z P_{s, s+t}(k, z: d i, d x)=\Phi(t, d i, d x)$ is a solution of the equation (7.1) with the initial value $p_{0, s}\left(i_{0}, x_{0}: i, x\right) \mu(d i) d x$. Let $\Psi(t, i, x)$ be the solution of the equation (7.7) with the initial value $p_{0, s}\left(i_{0}, x_{0}: i, x\right)$. From (7.8) $\Phi(t, d i, d x)=\Psi(t, i, x) \mu(d i) d x$. Since $\int_{E} p_{0, s}\left(i_{0}, x_{0}: i, x\right) \mu(d i) d x=\phi(s),(8.4)$ implies

& =\frac{\phi(s)}{\int_{E} u(i, x) \mu(d i) d x} \int_{E} f(i, x) u(i, x) \mu(d i) d x
\end{align*}

From (8.6), it holds that

P_{0, t+s} f\left(i_{0}, x_{0}\right)= & \int_{E} p_{0, s}\left(i_{0}, x_{0}: i, x\right) P_{s, s+t} f(i, x) \mu(d i) d x \\
& +\int_{E} P_{0, s}^{(s)}\left(i_{0}, x_{0}: d i, d x\right) P_{s, s+t} f(i, x)
\end{aligned}
$$

Therefore, combining (8.8) with

& \leqq \int_{E} P_{0, s+t} f\left(i_{0}, x_{0}\right) \\
& \leqq \int_{E} p_{0, s}\left(i_{0}, x_{0}: i, x\right) P_{s, s+t} f(i, x) \mu(d i) d x+\int_{E} P_{0, s}^{(s)}\left(i_{0}, x_{0}: d i, d x\right) \\
& =\int_{E} p_{0, s}\left(i_{0}, x_{0}: i, x\right) P_{s, s+1} f(i, x) \mu(d i) d x+1-\phi(s)
\end{aligned}
$$

we obtain

$$
\begin{aligned}
& \phi(s) \frac{\int_{E} u(i, x) f(i, x) \mu(d i) d x}{\int_{E} u(i, x) \mu(d i) d x}+1-\phi(s) \\
& \geqq \varlimsup_{t \rightarrow \infty} P_{0, s+t} f\left(i_{0}, x_{0}\right) \geqq \lim _{t \rightarrow \infty} P_{0, s+t} f\left(i_{0}, x_{0}\right) \\
& \geqq \phi(s) \frac{\int_{E} u(i, x) f(i, x) \mu(d i) d x}{\int_{E} u(i, x) \mu(d i) d x} .
\end{aligned}
$$

From Lemma 8.2,

\lim _{t \rightarrow \infty} P_{0, t} f\left(i_{0}, x_{0}\right)=\frac{\int_{E} u(i, x) f(i, x) \mu(d i) d x}{\int_{E} u(i, x) \mu(d i) d x} .

Therefore we have proved Theorem 8.1.

## 9. The case $\boldsymbol{n}=2$. Examples and some degenerate cases

In this section, we always assume that $d_{1}=d_{2}=0$ and $v_{1} \neq v_{2}$. We do not assume (1.3) unless otherwise stated.

### 9.1. Classification of equation (I)

Noting that $a_{j, k}^{2}=-a_{j, k}^{1}$ by (1.2), equation (I) becomes

\frac{\partial}{\partial t} u(t, 1, x)= & v_{1} \frac{\partial}{\partial x} u(t, 1, x)+a_{1,1}^{1} u(t, 1, x)^{2} \\
& +\left(a_{1,2}^{1}+a_{2,1}^{1}\right) u(t, 1, x) u(t, 2, x)+a_{2,2}^{1} u(t, 2, x)^{2}, \\
\frac{\partial}{\partial t} u(t, 2, x)= & v_{2} \frac{\partial}{\partial x} u(t, 2, x)-a_{1,1}^{1} u(t, 1, x)^{2} \\
& -\left(a_{1,2}^{1}+a_{2,1}^{1}\right) u(t, 1, x) u(t, 2, x)-a_{2,2}^{1} u(t, 2, x)^{2} .
\end{aligned}\right.
$$

We first classify equation $(E)$ into three cases.
Case 1. $\quad a_{1,1}^{1} \neq 0$.
Let $a=-a_{1,1}{ }^{1}>0$, and we define $\alpha$ and $\beta$ as the solution of equation

$$
\left\{\begin{array}{l}
\alpha+\beta=-\frac{a_{1,2}^{1}+a_{2,1}^{1}}{a_{1,1}^{1}} \\
\alpha \beta=\frac{a_{2,2}^{1}}{a_{1,1}^{1}}
\end{array}\right.
$$

Baecause $a_{1,1}^{1} a_{2,2}{ }^{1} \leqq 0$, we may assume that $\alpha \leqq 0 \leqq \beta$.
Case 2. $a_{1,1}{ }^{1}=a_{2,2}{ }^{1}=0$.
Let $b=-\left(a_{1,2}^{1}+a_{2,1}{ }^{1}\right)$. If $b=0$, then equation $(E)$ becomes a linear differential equation, and therefore we omit this case. We may assume $b>0$, for the case when $b<0$ is reduced to this case by interchanging $u_{1}$ and $u_{2}$.

Case 3. $a_{1,1}^{1}=0, a_{2,2}^{1} \neq 0$.
This is reduced to case 1 again by interchanging $u_{1}$ and $u_{2}$. Therefore we may only consider equation $(E)$ in two cases.

$$
\begin{aligned}
& (E .1)\left\{\begin{aligned}
& \frac{\partial}{\partial t} u(t, 1, x)= v_{1} \frac{\partial}{\partial x} u(t, 1, x)-a(u(t, 1, x)-\alpha u(t, 2, x))(u(t, 1, x) \\
&-\beta u(t, 2, x)), \\
& \frac{\partial}{\partial t} u(t, 2, x)= v_{2} \frac{\partial}{\partial x} u(t, 2, x)+a(u(t, 1, x)-\alpha u(t, 2, x))(u(t, 1, x) \\
&-\beta u(t, 2, x)), \\
&(E .2)
\end{aligned} \begin{array}{rl}
\left\{\begin{aligned}
& \frac{\partial}{\partial t} u(t, 1, x)= v_{1} \frac{\partial}{\partial x} u(t, 1, x)-b u(t, 1, x) u(t, 2, x) \\
& \frac{\partial}{\partial t} u(t, 2, x)= v_{2} \frac{\partial}{\partial x} u(t, 2, x)+b u(t, 1, x) u(t, 2, x) \\
& b
\end{aligned}\right. \\
b>0 .
\end{array}\right.
\end{aligned}
$$

We discuss (E.1) in four cases separately:

\text { (E.1.a) } & \alpha<0<\beta, \\
\text { (E.1.b) } & \alpha=0<\beta, \\
\text { (E.1.c) } & \alpha<0=\beta, \\
\text { (E.1.d) } & \alpha=0=\beta .

### 9.2. Behaviors of solutions of equation $(E)$

Hereafter, we shall assume that the initial values are non trivial, i.e., $u(0, i, x)$ $\not \equiv 0$, and we denote $m=\frac{1}{\omega} \int_{s^{1}}(u(0,1, x)+u(0,2, x)) d x$. In cases (E.1.a) and (E.1.b), let $u_{1}^{0}=\frac{\beta}{\beta+1}$ and $u_{2}^{0}=\frac{1}{\beta+1}$. Then it follows that

\sum_{j, k=1}^{2} a_{j, k}^{i} u_{j}^{0} u_{k}^{0}=0 \quad i=1,2 .
$$

Let $b_{j, k}{ }^{i}=\left(u_{i}^{0}\right)^{-1} a_{j, k}{ }^{i} u_{j}^{0} u_{k}^{0}$ and $b_{i, j}=\sum_{k=1}^{2}\left(a_{j, k}{ }^{i}+a_{k, j}{ }^{i}\right) u_{k}^{0}$ as in the Assumption 5.1. Then

\left(b_{i, j}\right)=\frac{a(\beta-\alpha)}{1+\beta}\left(\begin{array}{rr}
-1, & \beta \\
1, & -\beta
\end{array}\right)
$$

is a nonnegative offdiagonal irreducible matrix. Therefore Assumption 5.1 is satisfied.
By (E.1),

& \sum_{j, k=1}^{2} a_{j, k}^{1} \eta_{j} \eta_{k}=-a\left(\eta_{1}-\alpha \eta_{2}\right)\left(\eta_{1}-\beta \eta_{2}\right), \\
& \sum_{j, k=1}^{2} a_{j, k}^{2} \eta_{j} \eta_{k}=a\left(\eta_{1}-\alpha \eta_{2}\right)\left(\eta_{1}-\beta \eta_{2}\right) .
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
\sum_{j, k=1}^{2} b_{j, k}^{1} \eta_{j} \eta_{k} & =-\frac{a}{1+\beta}\left(\eta_{1}-\eta_{2}\right)\left(\beta \eta_{1}-\alpha \eta_{2}\right), \\
\sum_{j, k=1}^{2} b_{j, k}^{2} \eta_{j} \eta_{k} & =\frac{a \beta}{1+\beta}\left(\eta_{1}-\eta_{2}\right)\left(\beta \eta_{1}-\alpha \eta_{2}\right) .
\end{aligned}
$$

This means for $c=\max \left(\frac{a(\beta-\alpha)}{1+\beta}, \frac{a \beta(\beta-\alpha)}{1+\beta}\right)$, and $0 \leqq \eta_{1}, \eta_{2} \leqq 1$,

& 0 \leqq \sum_{j, k=1}^{2} b_{j, k}^{1} \eta_{j} \eta_{k}+c \eta_{1} \leqq c, \\
& 0 \leqq \sum_{j, k=1}^{2} b_{j, k}^{2} \eta_{j} \eta_{k}+c \eta_{2} \leqq c .
\end{aligned}

Therefore Assumption 6.1 is also satisfied. By Lemma 6.1, equation ( $E .1$ ) always has a bounded global solution.

### 9.2.1. Case (E.1.a)

We verify condition $(a)$ in Lemma 6.2. Let $c \geqq \max \left(\frac{a \beta^{2}-2 a \alpha \beta}{1+\beta}, \frac{a(\beta-\alpha)}{1+\beta}\right)$, then for $0 \leqq \eta_{1}, \eta_{2} \leqq 1$,

& \geqq \frac{-a \alpha}{1+\beta} \eta_{2}^{2}+\left(c-\frac{a \beta}{1+\beta}+\frac{a \alpha}{1+\beta}\right) \eta_{1}^{2}, \\
\sum_{j, k=1}^{2} b_{j, k}^{2} \eta_{j} \eta_{k}+c \eta_{2} & =\left(\frac{a \alpha \beta}{1+\beta} \eta_{1}-\frac{a \beta^{2}}{1+\beta} \eta_{1}+\frac{a \alpha \beta}{1+\beta} \eta_{2}+c\right) \eta_{2}+\frac{a \beta^{2}}{1+\beta} \eta_{1}^{2} \\
& \geqq \frac{a \beta^{2}}{1+\beta} \eta_{1}^{2}+\left(c+\frac{2 a \alpha \beta}{1+\beta}-\frac{a \beta^{2}}{1+\beta}\right) \eta_{2}^{2} .
\end{aligned}
$$

Hence the irreducible matrix

$$
\left(\begin{array}{cc}
c-\frac{a \beta}{1+\beta}+\frac{a \alpha}{1+\beta}, & \frac{-a \alpha}{1+\beta} \\
\frac{a \beta^{2}}{1+\beta}, & c+\frac{2 a \alpha \beta}{1+\beta}-\frac{a \beta^{2}}{1+\beta}
\end{array}\right)
$$

satisfies condition (6.8). Therefore by Theorem 6.2 , the solution $(u(t, 1, x)$, $u(t ., 2, x))$ converges to $m\left(\frac{\beta}{1+\beta}, \frac{1}{1+\beta}\right)$ exponentially fast.

### 9.2.2. Case (E.1.b)

In this case, it is not difficult to see that condition (a) of Lemma 6.2 is not satisfied. However, condition (6.5) of Theorem 6.1 is replaced by

Proof. Let $u(t, x)=\frac{1}{\beta} u(t, 1, x)$ and $v(t, x)=u(t, 2, x)$, then equation ( $E .1$ ) becomes

We may assume that there exists $M>0$ such that

Transform equation (9.2) as
$(9.2)^{\prime} \quad\left\{\begin{array}{l}\frac{\partial}{\partial t} u(t, x)=v_{1} \frac{\partial}{\partial x} u(t, x)-2 \beta a M u(t, x)+\beta a(v(t, x)-u(t, x)+2 M) u(t, x), \\ \frac{\partial}{\partial t} v(t, x)=v_{2} \frac{\partial}{\partial x} v(t, x)-2 \beta^{2} a M v(t, x)+\beta^{2} a(u(t, x)-v(t, x)+2 M) u(t, x),\end{array}\right.$ or equivalently,

u(t, x)=e^{-2 \beta a M t} u\left(0, x+v_{1} t\right) \\
\quad+\int_{0}^{t} e^{-2 \beta a M(t-s)} \beta a\left(v\left(s, x+v_{1}(t-s)\right)-u\left(s, x+v_{1}(t-s)\right)+2 M\right) u\left(s, x+v_{1}(t-s)\right) d s \\
v(t, x)=e^{-2 \beta^{2} a M t} v\left(0, x+v_{2} t\right) \\
\quad+\int_{0}^{t} e^{-2 \beta^{2} a M(t-s)} \beta^{2} a\left(u\left(s, x+v_{2}(t-s)\right)-v\left(s, x+v_{2}(t-s)\right)+2 M\right) u\left(s, x+v_{2}(t-s)\right) d s
\end{array}\right.
$$

Therefore, $u(t, x) \geqq e^{-2 \beta a M t} u\left(0, x+v_{1} t\right) \geqq e^{-2 \beta a M t} \delta$, and therefore,

$$
\begin{aligned}
v(t, x) & \geqq \int_{0}^{t} e^{-2 \beta^{2} a M(t-s)} \beta^{2} a u\left(s, x+v_{2}(t-s)\right)^{2} d s \\
& \geqq \int_{0}^{t} e^{-2 \beta^{2} a M(t-s)-4 \beta a M s} \delta^{2} \beta^{2} a d s \\
& \geqq t e^{-2 \beta^{2} a M t-4 \beta a M t} \delta^{2} \beta^{2} a .
\end{aligned}
$$

By this proposition, if $u(0,1, x) \geqq \delta>0$, then $(u(t, 1, x), u(t, 2, x))$ converges
to $m\left(\frac{\beta}{1+\beta}, \frac{1}{1+\beta}\right)$ exponentially fast.
In the following three paragraphs, general theory in the preceding sections is not applicable, but we can show directly the asymptotic behavior of solutions.

### 9.2.3. Case (E.1.c)

Let $u(t, x)=-\frac{1}{\alpha} u(t, 1, x)$ and $v(t, x)=u(t, 2, x)$, then equation ( $E .1$ ) becomes

$$
\left\{\begin{array}{l}
\frac{\partial}{\partial t} u(t, x)=v_{1} \frac{\partial}{\partial x} u(t, x)+a \alpha u(t, x)(u(t, x)+v(t, x)),  \tag{9.3}\\
\frac{\partial}{\partial t} v(t, x)=v_{2} \frac{\partial}{\partial x} v(t, x)+a \alpha^{2} u(t, x)(u(t, x)+v(t, x)),
\end{array}\right.
$$

or equivalently,

$$
\left\{\begin{align*}
u(t, x)= & u\left(0, x+v_{1} t\right) \exp \left[a \alpha \int_{0}^{t}\left\{u\left(s, x+v_{1}(t-s)\right)+v\left(s, x+v_{1}(t-s)\right)\right\} d s\right]  \tag{9.3}\\
v(t, x)= & v\left(0, x+v_{2} t\right)+\int_{0}^{t} a \alpha^{2} u\left(s, x+v_{2}(t-s)\right)\left\{u\left(s, x+v_{2}(t-s)\right)\right. \\
& \left.+v\left(s, x+v_{2}(t-s)\right)\right\} d s
\end{align*}\right.
$$

Therefore, there exists $M>0$ such that

$$
u(t, x) \leqq M \quad \text { for any } t \geqq 0, x \in S^{1}
$$

and equation (9.3) has a global solution. If $u(0, x) \equiv 0$, then $u(t, x) \equiv 0, v(t, x)=v\left(0, x+v_{1} t\right)$.

Proposition 9.2. If $u(0, x) \neq 0$, then there exists $N>0$ and $c>0$ such that

$$
\begin{equation*}
u(t, x) \leqq N e^{-c t} \quad t \geqq 0, x \in S^{1} \tag{9.4}
\end{equation*}
$$

and therefore, $v(t, x)$ is bounded in $t$ and $x$.
Proof. By (9.3)', for any $T<\infty$, there exists $c(T)>0$ such that

$$
c(T) u\left(0, x+v_{1} t\right) \leqq u(t, x) \quad 0 \leqq t \leqq T, x \in S^{1}
$$

Therefore, for any $t \leqq T$,

$$
\begin{aligned}
v(t, x) & \geqq \int_{0}^{t} a \alpha^{2} u\left(s, x+v_{2}(t-s)\right)^{2} d s \\
& \geqq a \alpha^{2} c(T)^{2} \int_{0}^{t} u\left(0, x+v_{2} t+\left(v_{1}-v_{2}\right) s\right)^{2} d s
\end{aligned}
$$

and there exists $T_{1}>0$ and $d>0$ such that

$$
v\left(T_{1}, x\right) \geqq d \quad x \in S^{1}
$$

Consider (9.3), $\left(u\left(T_{1}, x\right), v(T, x)\right)$ as the initial value, we get

$$
v(t, x) \geqq d \quad t \geqq T_{1}, x \in S^{1}
$$

By (9.3)', for $t \geqq T_{1}$,

$$
\begin{aligned}
u(t, x) & \leqq u\left(0, x+v_{2} t\right) \exp \left[a \alpha \int_{0}^{t} v\left(s, x+v_{2}(t-s)\right) d s\right] \\
& \leqq u\left(0, x+v_{2} t\right) \exp \left[a \alpha\left(t-T_{1}\right) d\right]
\end{aligned}
$$

By (9.3) and (9.4), $v(t, x)$ remains bounded in $t$ and $x$.
If $v_{2}=0$, then

$$
\lim _{t \rightarrow \infty} v(t, x)=v(0, x)+\int_{0}^{\infty} a \alpha^{2} u(s, x)\{u(s, x)+v(s, x)\} d s
$$

If $v_{2} \neq 0$, then

$$
\begin{aligned}
& \lim _{n \rightarrow \infty} v\left(\frac{n \omega}{\left|v_{2}\right|}+t, x\right)=v\left(0, x+v_{2} t\right) \\
& \quad+\int_{0}^{\infty} a \alpha^{2} u\left(s, x+v_{2}(t-s)\right)\left\{u\left(s, x+v_{2}(t-s)\right)+v\left(s, x+v_{2}(t-s)\right)\right\} d s .
\end{aligned}
$$

### 9.2.4. Case (E.1.d)

Equation ( $E .1$ ) becomes

$$
\left\{\begin{array}{l}
\frac{\partial}{\partial t} u(t, 1, x)=v_{1} \frac{\partial}{\partial x} u(t, 1, x)-a u(t, 1, x)^{2}  \tag{9.5}\\
\frac{\partial}{\partial t} u(t, 2, x)=v_{2} \frac{\partial}{\partial x} u(t, 2, x)+a u(t, 1, x)^{2}
\end{array}\right.
$$

or, equivalently,

$$
\left\{\begin{aligned}
u(t, 1, x) & =\frac{u\left(0,1, x+v_{1} t\right)}{1+\operatorname{tau}\left(0,1, x+v_{1} t\right)}, \\
u(t, 2, x) & =u\left(0,2, x+v_{2} t\right)+\int_{0}^{t}\left(\frac{u\left(0,1, x+v_{1} s+v_{2}(t-s)\right)}{1+\operatorname{sau}\left(0,1, x+v_{1} s+v_{2}(t-s)\right)}\right)^{2} d s
\end{aligned}\right.
$$

By (9.5)', $u(t, 1, x)$ converges to 0 as $t \rightarrow \infty$. If $v_{2} \neq 0$, then

$$
\lim _{n \rightarrow \infty} u\left(\frac{n \omega}{\left|v_{2}\right|}+t, 2, x\right)=u\left(0,2, x+v_{2} t\right)+\int_{0}^{\infty}\left(\frac{u\left(0,1, x+v_{2} t+\left(v_{1}-v_{2}\right) s\right)}{1+\operatorname{sau}\left(0,1, x+v_{2} t+\left(v_{1}-v_{2}\right) s\right.}\right)^{2} d s
$$

If $v_{2}=0$, then

$$
\lim _{t \rightarrow \infty} u(t, 2, x)=u(0,2, x)+\int_{0}^{\infty}\left(\frac{u\left(0,1, x+v_{1} s\right)}{1+\operatorname{sau}\left(0,1, x+v_{1} s\right)}\right)^{2} d s
$$

### 9.2.5. Equation (E.2)

Equation (E.2) is equivalent to
$(E .2)^{\prime} \quad\left\{\begin{array}{l}u(t, 1, x)=u\left(0,1, x+v_{1} t\right) \exp \left\{-b \int_{0}^{t} u\left(s, 2, x+v_{1}(t-s)\right) d s\right\}, \\ u(t, 2, x)=u\left(0,2, x+v_{2} t\right) \exp \left\{b \int_{0}^{t} u\left(s, 1, x+v_{2}(t-s)\right) d s\right\} .\end{array}\right.$
By this expression,

$$
\left\{\begin{array}{l}
u(t, 1, x) \leqq u\left(0,1, x+v_{1} t\right)  \tag{9.6}\\
u(t, 2, x) \geqq u\left(0,2, x+v_{2} t\right)
\end{array}\right.
$$

It then follows that

$$
\left\{\begin{array}{l}
u(t, 1, x) \leqq u\left(0,1, x+v_{1} t\right) \exp \left\{-b \int_{0}^{t} u\left(0,2, x+v_{1} t+\left(v_{2}-v_{1}\right) s\right) d s\right\}  \tag{9.7}\\
u(t, 2, x) \leqq u\left(0,2, x+v_{2} t\right) \exp \left\{b \int_{0}^{t} u\left(0,1, x+v_{2} t+\left(v_{1}-v_{2}\right) s\right) d s\right\}
\end{array}\right.
$$

If $u(0,2, x) \equiv 0$, then $(E .2)^{\prime}$ implies that $u(t, 2, x) \equiv 0$ and therefore $u(t, 1, x)=$ $u\left(0,1, x+v_{1} t\right)$. Similarly if $u(0,1, x) \equiv 0$, then $u(t, 1, x) \equiv 0, u(t, 2, x)=u(0,2, x$ $\left.+v_{2} t\right)$.
In other case, since $u(0,2, x) \neq 0$ and $v_{1} \neq v_{2}$, we have

$$
\begin{aligned}
& \frac{1}{t} \int_{0}^{t} u\left(0,2, x+\left(v_{1}-v_{2}\right) s\right) d s=\frac{1}{t\left(v_{1}-v_{2}\right)} \int_{0}^{t\left(v_{1}-v_{2}\right)} u(0,2, x+s) d s \\
& \rightarrow \frac{1}{\omega} \int_{0}^{\omega} u(0,2, y) d y>0
\end{aligned}
$$

for any $x$ in $S^{1}$. Therefore by (9.7),

$$
u(t, 1, x) \leqq M e^{-c t}
$$

for some $c>0$ and $M>0$. By the second part of $(E .2)^{\prime}, u(t, 2, x)$ remains bounded.
If $v_{2}=0$, then by $(E .2)^{\prime}$

$$
\lim _{t \rightarrow \infty} u(t, 2, x)=u(0,2, x) \exp \left\{a \int_{0}^{\infty} u(s, 1, x) d s\right\}
$$

If $v_{2} \neq 0$, then

$$
\lim _{n \rightarrow \infty} u\left(\frac{n \omega}{\left|v_{2}\right|}+t, 2, x\right)=u\left(0,2, x+v_{2} t\right) \exp \left\{a \int_{0}^{\infty} u\left(s, 1, x+v_{2}(t-s)\right) d s\right\}
$$

Yoshikawa [13] has obtained more detailed results in this case.

### 9.3. Limit distributions of the associated Markov processes

We now assume (1.3). For a solution $(u(t, 1, x), u(t, 2, x))$ of $(E)$, let $\left(X_{t}\right)$
be its associated Markov process defined in section 7.

### 9.3.1. Cases (E.1.a) and (E.1.b)

In case (E.1.a), $(u(t, 1, x), u(t, 2, x))$ converges to $m\left(\frac{\beta}{1+\beta}, \frac{1}{1+\beta}\right)$. By Theorem 8.1,

$$
\lim _{t \rightarrow \infty} P_{0,(i, x)}\left(X_{t} \in(j, d y)\right)= \begin{cases}\frac{\beta}{1+\beta} \frac{d y}{\omega} & j=1, i=1,2, x \in S^{1} \\ \frac{1}{1+\beta} \frac{d y}{\omega} & j=2, i=1,2, x \in S^{1}\end{cases}
$$

In case (E.1.b), we assume that the additional hypothesis (9.1) on $u(0,1, x)$ is satisfied, then the same conclusion is valid.

### 9.3.2. Cases (E.1.c), (E.1.d) and equation (E.2)

We have seen in 9.2, that in general

$$
\lim _{t \rightarrow \infty} u(t, 1, x)=0,
$$

and there exists a bounded nonnegative function $v(x)$ on $S^{1}$ such that if $v_{2}=0$, then $\lim _{t \rightarrow \infty} u(t, 2, x)=v(x)$, and if $v_{2} \neq 0$, then

$$
\lim _{n \rightarrow \infty} u\left(\frac{n \omega}{\left|v_{2}\right|}+t, 2, x\right)=v\left(x+v_{2} t\right) .
$$

Therefore we can not apply Theorem 8.1 in these cases. However we can discuss on the limit distribution of $\left(X_{t}\right)$ under the following additional assumption:

Assumption. There exists a bounded nonnegative function $v(x)$ which is not identically 0 , such that if $v_{2}=0$, then

$$
\left\{\begin{array}{l}
u(t, 1, x)=0 \\
u(t, 2, x)=v(x)
\end{array}\right.
$$

is a solution of equation (I), and if $v_{2} \neq 0$, then

$$
\left\{\begin{array}{l}
u(t, 1, x)=0 \\
u(t, 2, x)=v\left(x+v_{2} t\right),
\end{array}\right.
$$

is a solution of equation $(E)$.
In the present cases, since $a_{2,2}{ }^{1}=a_{2,2}{ }^{2}=0, a_{1,2}{ }^{1}=-a_{1,2}{ }^{2}<0$, we may only consider the following equation:

$$
\left\{\begin{array}{l}
\frac{\partial}{\partial t} \phi(t, 1, d x)=\phi(t, 1, d x)\left(-v_{1} \frac{\partial}{\partial x}+a_{1,2}^{1} u(t, 2, x)\right),  \tag{9.8}\\
\frac{\partial}{\partial t} \phi(t, 2, d x)=\phi(t, 2, d x)\left(-v_{2} \frac{\partial}{\partial x}\right)+\phi(t, 1, d x)\left(a_{1,2}^{2} u(t, 2, x)\right),
\end{array}\right.
$$

or equivalently,

$$
\begin{align*}
& \left\{\begin{aligned}
& \phi(t, 1, d x)=\int_{S^{1}} \phi(0,1, d y) e^{a_{1}, 2} \int_{0}^{t} u\left(s, 2, y-v_{1} s\right) d s \\
& \delta_{y-v_{1} t}(d x) \\
&=\int_{S^{1}} \phi(0,1, d y) e^{a_{1} 1,2} \int_{0}^{t} \int_{0}^{t\left(y+\left(v_{2}-v_{1}\right) s\right) d s} \delta_{y-v_{1} t}(d x), \\
& \phi(t, 2, d x)
\end{aligned}\right.  \tag{9.8}\\
& =\int_{s^{1}} \phi(0,2, d y) \delta_{y-v_{2} t}(d x)+\int_{0}^{t} d a s_{1,2}^{2} \int_{s^{1}} \phi(s, 1, d y) u(s, 2, y) \delta_{y-v_{2}(t-s)}(d x) \\
& =\int_{S^{1}} \phi(0,2, d y) \delta_{y-v_{2} t}(d x) \\
& +\int_{0}^{t} d s a_{1,2}^{2} \int_{S^{1}} \phi(0,1, d y) e^{a_{1}, 2} \int_{0}^{s} v\left(y+\left(v_{1}-v_{2}\right) r\right) d r v\left(y+\left(v_{2}-v_{1}\right) s\right) \delta_{y-v_{2} t+\left(v_{2}-v_{1}\right) s}(d x) .
\end{align*}
$$

Since we have assumed that $v_{2} \neq v_{1}$ and $v(x) \neq 0$,

$$
\lim _{t \rightarrow \infty} \int_{0}^{t} v\left(y+\left(v_{2}-v_{1}\right) s\right) d s=\infty \quad \text { for any } y \text { in } S^{1}
$$

and therefore,

$$
\lim _{t \rightarrow \infty} \phi\left(t, 1, S^{1}\right)=0
$$

If $\phi(0, d i, d y)=\delta_{2}(d i) \delta_{x}(d y)$, then by $(9.8)^{\prime}$

$$
\left\{\begin{array}{l}
\phi(t, 2, d y)=\delta_{x-v_{2} t}(d y)  \tag{9.9}\\
\phi(t, 1, d y)=0
\end{array}\right.
$$

If $\phi(0, d i, d y)=\delta_{1}(d i) \delta_{x}(d y)$, then by $(9.8)^{\prime}$

$$
\phi(t, 2, d y)=\int_{0}^{t} d s a_{1,2}^{2} e^{a_{1,2}^{1} \int_{0}} \int^{s\left(x+\left(v_{2}-v_{1}\right) r\right) d r} v\left(x+\left(v_{2}-v_{1}\right) s\right) \delta_{x-v_{2} t+\left(v_{2}-v_{1}\right) s}(d y) .
$$

Therefore if $v_{2}=0$, then
(9.10) $\lim _{t \rightarrow \infty} \phi(t, 2, d y)=\int_{0}^{\infty} d s a_{1,2}^{2} e^{a_{1}{ }^{1}, 2} \int_{0}^{s} v\left(x-v_{1} r\right) d r v\left(x-v_{1} s\right) \delta_{x-v_{1} s}(d y)$,
and if $v_{2} \neq 0$, then

$$
\begin{align*}
& \lim _{n \rightarrow \infty} \phi\left(\frac{n \omega}{\left|v_{2}\right|}+t, 2, d y\right)  \tag{9.11}\\
& =\int_{0}^{\infty} d s a_{1,2}^{2} e^{a_{1,2}, \int_{0}^{s}} \int_{0}^{s}\left(x+\left(v_{2}-v_{1}\right) r\right) d r v\left(x+\left(v_{2}-v_{1}\right) s\right) \delta_{x-v_{2} t+\left(v_{2}-v_{1}\right) s}(d y)
\end{align*}
$$

Summing up (9.9), (9.10) and (9.11), we obtain:

$$
\lim _{t \rightarrow \infty} P_{0,(i, x)}\left(X_{t} \in\left(1, S^{1}\right)\right)=0 \quad i=1,2, x \in S^{1}
$$

If $v_{2}=0$, then

$$
\begin{aligned}
& \lim _{t \rightarrow \infty} P_{0,(2, x)}\left(X_{t} \in(2, d y)\right)=\delta_{x}(d y) \\
& \lim _{t \rightarrow \infty} P_{0,(1, x)}\left(X_{t} \in(2, d y)\right)=K(x, d y)
\end{aligned}
$$

where $K(x, d y)$ is the kernel defined by the right side of (9.10).
If $v_{2} \neq 0$, then

$$
\begin{array}{ll}
\lim _{n \rightarrow \infty} P_{0,(2, x)}\left(X_{n \omega / / v_{2} \mid+t} \in(2, d y)\right)=\delta_{x-v_{2} t}(d y) & 0 \leqq t \leqq \frac{\omega}{\left|v_{2}\right|}, \\
\lim _{n \rightarrow \infty} P_{0,(1, x)}\left(X_{n \omega / v_{2} \mid+t} \in(2, d y)\right)=K_{t}(x, d y) & 0 \leqq t \leqq \frac{\omega}{\left|v_{2}\right|},
\end{array}
$$

where $K_{t}(x, d y)$ is the kernel defined by the right side of (9.11).
