Generalized Contractions of Rational Type in Ordered Partial Metric Spaces

Without the continuity and nondecreasing property of the comparison function, we in this paper prove some fixed point theorems of generalized contractions of rational type in ordered partial metric spaces, which generalize and improve the corresponding results of Luong and Thuan. An example is given to support the usability of our results.

1. Introduction and Preliminaries

Throughout this paper, \mathbb{R}_+ and \mathbb{N} will denote the set of nonnegative real numbers and the set of all positive integer numbers.

It is well known that the Banach contraction principle is one of the pivotal results of analysis. Generalizations of this principle have been obtained in several directions. In [1], Jaggi introduced a contraction of rational type in a metric space and proved the unique existence of fixed point as the contraction is continuous and the metric space is complete, which was then extended to the case of ordered metric spaces by Harjani et al. [2]. In [3], Luong and Thuan considered weak contractions of rational type in ordered metric spaces and proved the following fixed point theorem.

Theorem 1 (see [3]). Let (X, d, \leq) be a complete ordered metric space and $T : X \to X$ a nondecreasing mapping such that there exists a function $\eta : \mathbb{R}_+ \to \mathbb{R}_+$ with $\eta^{-1}(\{0\}) = \{0\}$ such that

$$d(Tx, Ty) \le M_{d \cdot r}(x, y) - \eta(M_{d \cdot r}(x, y)), \qquad (1)$$

for all $x, y \in X$ with $x \leq y$ and $x \neq y$, where $M_{d,r}(x, y) = \max\{d(x, y), ((d(x, Tx) \cdot d(y, Ty))/d(x, y))\}$. Assume that η is lower semicontinuous, and X has the following property:

(A1) if $\{x_n\}$ is a nondecreasing sequence in X such that $x_n \xrightarrow{d} x$, then $x = \sup\{x_n\}$.

If there exists $x_0 \in X$ such that $x_0 \preceq Tx_0$, then T has a fixed point.

In [4], Matthews introduced the partial metric space and extended the Banach contraction principle to the case of partial metric spaces, which was then improved by Oltra and Valero [5]. In [6–8], the authors studied the unique existence of fixed point of generalized contractions in partial metric spaces. Recall that a mapping $T : X \to X$ is called a M_p^i -generalized contraction (M_p^i-GC) if there exists a comparison function $\varphi : \mathbb{R}_+ \to \mathbb{R}_+$ such that

$$p(Tx, Ty) \le \varphi\left(M_p^i(x, y)\right),\tag{2}$$

where (X, p) is a partial metric space, $M_p^1(x, y) = \max\{p(x, y), p(x, Tx), p(y, Ty), (p(x, Ty) + p(y, Tx))/2\}$, and $M_p^2(x, y) = \max\{p(x, y), p(x, Tx), p(y, Ty)\}$. Under several different assumptions made on φ , they obtained the following fixed point results.

Theorem 2 (see Theorem 1 of [6], Theorem 1 of [7], and Theorems 3 and 4 of [8]). Let (X, p) be a complete partial metric space. Assume the following.

(*i*) $T : X \rightarrow X$ is a M_p^1 -GC and one of the following conditions is satisfied:

(H1) φ is continuous and nondecreasing, and $\varphi(t) < t$ for all t > 0;

- (H2) φ is nondecreasing, and the series $\sum_{n=0}^{\infty} \varphi^n(t)$ is convergent for all t > 0 (φ^n denotes the nth iterate of φ);
- (H3) φ is upper semicontinuous from the right, and $\varphi(t) < t$ for all t > 0.

 $Or(ii)T: X \rightarrow X$ is a M_p^2 -GC and the following condition is satisfied:

(H4) φ is nondecreasing, and $\lim_{n\to\infty} \varphi^n(t) = 0$ for all t > 0. Then T has a unique fixed point.

For other references concerned with various fixed point results and common fixed point results for contractions in the setting of metric-like, partial metric, and ordered partial metric spaces, we refer the readers to [9–24].

In this paper, we establish some fixed point theorems for generalized contractions of rational type in ordered partial metric spaces, which generalize and improve Theorems 1 and 2. An example is given to support the usability of our results. Even in the setting of metric spaces, the results presented in this paper are still new since the comparison function φ is not necessarily assumed to be upper semicontinuous from the right or nondecreasing.

Following [4, 5], a partial metric on a set *X* is a function $p: X \times X \rightarrow \mathbb{R}_+$ such that, for each *x*, *y*, *z* \in *X*,

- (p1) p(x, y) = p(x, x) = p(y, y) if and only if x = y; (p2) p(x, y) = p(y, x); (p3) $p(x, x) \le p(x, y)$;
- (p4) $p(x, y) \le p(x, z) + p(z, y) p(z, z)$.

Observe that, if p(x, y) = 0, then x = y. A partial metric space is a pair (X, p) such that X is a set and p is a partial metric on X. Each partial metric p on X induces a T_0 topology τ_p on X which has as a base of the family of open balls $\{B_p(x, \varepsilon) : x \in X, \varepsilon > 0\}$, where $B_p(x, \varepsilon) = \{y \in X : p(x, y) < \varepsilon + p(x, x)\}$ for all $x \in X$ and $\varepsilon > 0$.

Let (X, p) be a partial metric space and $\{x_n\}$ a sequence of X. The sequence $\{x_n\}$ converges, with respect to τ_p , to a point $x \in X$ (denoted by $x_n \xrightarrow{p} x$) if $\lim_{n \to \infty} p(x_n, x) = p(x, x)$. Define a function $p^s : X \times X \to \mathbb{R}_+$ by $p^s(x, y) = 2p(x, y) - p(x, x) - p(y, y)$. Then p^s is a metric on X. The sequence $\{x_n\}$ converges, with respect to τ_{p^s} , to a point $x \in X$ (denoted by

$$x_n \xrightarrow{p} x$$
) if and only if
 $\lim_{n \to \infty} p(x_n, x) = \lim_{m,n \to \infty} p(x_m, x_n) = p(x, x).$ (3)

The sequence $\{x_n\}$ is called a Cauchy sequence if $\lim_{m,n\to\infty} p(x_m, x_n)$ exists and is finite; (X, p) is called complete if every Cauchy sequence $\{x_n\} \subset X$ converges, with respect to τ_p , to a point $x \in X$ such that $p(x, x) = \lim_{m,n\to\infty} p(x_m, x_n)$. In particular, $\{x_n\}$ is called a 0-Cauchy sequence if $\lim_{m,n\to\infty} p(x_m, x_n) = 0$; (X, p) is called 0-complete if every 0-Cauchy sequence $\{x_n\} \subset X$ converges, with respect to τ_p , to a point $x \in X$ such that p(x, x) = 0. Every complete partial metric space (X, p) is 0-complete, but the converse may not be true; see [17].

Remark 3 (see [4, 5]). A partial metric space (X, p) is complete if and only if (X, p^s) is complete.

2. Fixed Point Theorems

Let (X, p, \leq) be an ordered partial metric space and $T : X \rightarrow X$. For all $x, y \in X$ with p(x, y) > 0, set

$$M_{p,r}^{1}(x, y) = \max \left\{ p(x, y), p(x, Tx), p(y, Ty), \\ \frac{p(x, Tx) \cdot p(y, Ty)}{p(x, y)}, \frac{p(x, Ty) + p(y, Tx)}{2} \right\}, \\ M_{p,r}^{2}(x, y) = \max \left\{ p(x, y), p(x, Tx), p(y, Ty), \\ \frac{p(x, Tx) \cdot p(y, Ty)}{p(x, y)} \right\}.$$
(4)

A mapping $T : X \to X$ is said to be a $M_{p,r}^i$ -generalized contraction of rational type $(M_{p,r}^i$ -GCRT), if there exists a comparison function $\varphi : \mathbb{R}_+ \to \mathbb{R}_+$ such that

$$p(Tx,Ty) \le \varphi\left(M_{p,r}^{i}(x,y)\right),\tag{5}$$

for all $x, y \in X$ with $x \leq y$ and p(x, y) > 0.

Lemma 4. Let (X, p, \leq) be an ordered partial metric space and $T: X \rightarrow X$ a nondecreasing $M^{1}_{p,r}$ -GCRT. Assume that

(H5)
$$\varphi(s) < s$$
 and $\limsup_{t \to s^+} (\varphi(t)/t) < 1$ for all $s > 0$.

For each $x_0 \in X$ such that $x_0 \preceq Tx_0$, let $x_n = T^n x_0$ for all $n \in \mathbb{N}$. If $x_n \neq x_{n-1}$ for all $n \in \mathbb{N}$, then

$$\lim_{m,n\to\infty} p\left(x_m, x_n\right) = 0. \tag{6}$$

Proof. Note that *T* is nondecreasing and $x_0 \leq Tx_0$; then $\{x_n\}$ is nondecreasing. Since $x_n \neq x_{n-1}$ for all $n \in \mathbb{N}$, then

$$p\left(x_{n-1}, x_n\right) > 0,\tag{7}$$

for all $n \in \mathbb{N}$. By (4) and (p4), for all $n \in \mathbb{N}$, we have

$$\max \left\{ p(x_{n-1}, x_n), p(x_n, x_{n+1}) \right\}$$

$$\leq \max \left\{ p(x_{n-1}, x_n), p(x_n, x_{n+1}), \frac{p(x_{n-1}, x_{n+1}) + p(x_n, x_n)}{2} \right\}$$

$$= M_{p,r}^1(x_{n-1}, x_n)$$

$$\leq \max \left\{ p(x_{n-1}, x_n), p(x_n, x_{n+1}), \frac{p(x_{n-1}, x_n) + p(x_n, x_{n+1})}{2} \right\}$$

$$= \max \left\{ p(x_{n-1}, x_n), p(x_n, x_{n+1}) \right\}.$$
(8)

Thus by the nondecreasing property of $\{x_n\}$, (7), and (8),

$$p(x_{n}, x_{n+1}) \leq \varphi \left(M_{p \cdot r}^{1} (x_{n-1}, x_{n}) \right)$$

= $\varphi \left(\max \left\{ p(x_{n-1}, x_{n}), p(x_{n}, x_{n+1}) \right\} \right),$ (9)

for all $n \in \mathbb{N}$. Now, we claim that, for all $n \in \mathbb{N}$,

$$p(x_n, x_{n+1}) \le p(x_{n-1}, x_n).$$
 (10)

Suppose, on the contrary, that there exists some $n \in \mathbb{N}$ such that $p(x_n, x_{n+1}) > p(x_{n-1}, x_n)$. Then by (8), (9), and $\varphi(s) < s$ for all s > 0, we have

$$p(x_n, x_{n+1}) \le \varphi(p(x_n, x_{n+1})) < p(x_n, x_{n+1}).$$
 (11)

This is a contradiction and hence (10) is true. Consequently, $\{p(x_n, x_{n+1})\}$ is a decreasing sequence of positive real numbers. This yields that there exists $\alpha \ge 0$ such that

$$p(x_n, x_{n+1}) \longrightarrow \alpha^+.$$
(12)

In the following, we will show that $\alpha = 0$. Suppose, on the contrary, that $\alpha > 0$. It follows from (8), (9), and (10) that, for all $n \in \mathbb{N}$,

$$\frac{p(x_n, x_{n+1})}{p(x_{n-1}, x_n)} \le \frac{\varphi(p(x_{n-1}, x_n))}{p(x_{n-1}, x_n)}.$$
(13)

Letting $n \to \infty$ in (13), by (12), (H5), and $\alpha > 0$, we get a contradiction $1 \le \limsup_{t\to \alpha^+} (\varphi(t)/t) < 1$. Hence $\alpha = 0$, and consequently by (12)

$$\lim_{n \to \infty} p(x_n, x_{n+1}) = 0.$$
(14)

Now, we show that conclusion (6) is true. If otherwise, there exist some $\beta > 0$ and subsequences $\{m_k\}_{k \in \mathbb{N}}$ and $\{n_k\}_{k \in \mathbb{N}}$ in \mathbb{N} , with $m_k > n_k \ge k$, such that, for all $k \in \mathbb{N}$,

$$p\left(x_{n_k}, x_{m_k}\right) \ge \beta. \tag{15}$$

From (15) we may assume that, without loss of generality, for all $k \in \mathbb{N}$,

$$p\left(x_{n_k}, x_{m_k-1}\right) < \beta. \tag{16}$$

Then by (p4), for all $k \in \mathbb{N}$, we have

$$\beta \le p(x_{n_k}, x_{m_k}) \le p(x_{n_k}, x_{m_k-1}) + p(x_{m_k}, x_{m_k-1}) < \beta + p(x_{m_k}, x_{m_k-1}).$$
(17)

Letting $k \to \infty$ in the above inequality, by (14), we get

$$\lim_{k \to \infty} p\left(x_{n_k}, x_{m_k}\right) = \beta.$$
(18)

Also by (p4), for all $k \in \mathbb{N}$, we have

$$p(x_{n_{k}}, x_{m_{k}}) - p(x_{n_{k}}, x_{n_{k}+1}) - p(x_{m_{k}}, x_{m_{k}+1})$$

$$\leq p(x_{n_{k}+1}, x_{m_{k}+1})$$

$$\leq p(x_{n_{k}}, x_{n_{k}+1}) + p(x_{n_{k}}, x_{m_{k}}) + p(x_{m_{k}}, x_{m_{k}+1}).$$
(19)

Letting $k \to \infty$ in the above inequality, by (14) and (18), we get

$$\lim_{k \to \infty} p\left(x_{n_{k}+1}, x_{m_{k}+1}\right) = \beta.$$

Similarly, we can obtain

$$\lim_{k \to \infty} p\left(x_{n_k}, x_{m_k+1}\right) = \lim_{k \to \infty} p\left(x_{n_k+1}, x_{m_k}\right) = \beta.$$
(21)

By the nondecreasing property of $\{x_n\}$, (5), and (15), we get, for all $k \in \mathbb{N}$,

$$p(x_{n_{k}+1}, x_{m_{k}+1}) = p(Tx_{n_{k}}, Tx_{m_{k}}) \le \varphi(M_{p,r}^{1}(x_{n_{k}}, x_{m_{k}})),$$
(22)

where $M_{p,r}^1(x_{n_k}, x_{m_k}) = \max\{p(x_{n_k}, x_{m_k}), p(x_{n_k}, x_{n_{k+1}}), p(x_{m_k}, x_{m_{k+1}}), (p((x_{n_k}, x_{n_{k+1}}) \cdot p(x_{m_k}, x_{m_{k+1}}))/p(x_{n_k}, x_{m_k})), (p(x_{n_k}, x_{m_k+1}) + p(x_{n_{k+1}}, x_{m_k})/2)\}$. By (14) and (18), we have

$$\lim_{k \to \infty} \frac{p(x_{n_k}, x_{n_{k+1}}) \cdot p(x_{m_k}, x_{m_{k+1}})}{p(x_{n_k}, x_{m_k})} = 0, \qquad (23)$$

which together with (14), (18), and (21) implies that there exists $k_1 \in \mathbb{N}$ such that, for all $k \ge k_1$,

$$M_{p\cdot r}^{1}\left(x_{n_{k}}, x_{m_{k}}\right) = M_{1}\left(x_{n_{k}}, x_{m_{k}}\right), \qquad (24)$$

where $M_1(x_{n_k}, x_{m_k}) = \max\{p(x_{n_k}, x_{m_k}), (p(x_{n_k}, x_{m_k+1}) + p(x_{n_k+1}, x_{m_k}))/2\}$. It follows from (15), (18), and (21) that

$$M_1\left(x_{n_k}, x_{m_k}\right) \longrightarrow \beta^+, \tag{25}$$

By (15), (22), and (24), we have, for all $k \ge k_1$,

$$\frac{p\left(x_{n_{k}+1}, x_{m_{k}+1}\right)}{M_{1}\left(x_{n_{k}}, x_{m_{k}}\right)} \le \frac{\varphi\left(M_{1}\left(x_{n_{k}}, x_{m_{k}}\right)\right)}{M_{1}\left(x_{n_{k}}, x_{m_{k}}\right)}.$$
(26)

Letting $k \to \infty$ in (26), by (20), (25), (H5), and $\beta > 0$, we get a contradiction $1 \le \limsup_{t \to \beta^+} (\varphi(t)/t) < 1$. Hence conclusion (6) is true. The proof is complete.

Remark 5. It is easy to see that Lemma 4 is still valid for $M_{p,r}^2$ -GCRT and M_p^1 -GC.

Theorem 6. Let (X, p, \leq) be a 0-complete ordered partial metric space and $T : X \rightarrow X$ a nondecreasing M_{pr}^1 -GCRT. Assume that

- (H6) $\varphi(s) < s$ and $\limsup_{t \to s} (\varphi(t)/t) < 1$, for all s > 0, and X has the following property:
- (A2) if $\{x_n\}$ is a nondecreasing sequence in X such that $x_n \xrightarrow{p^s} x$, then $x = \sup\{x_n\}$.

If there exists $x_0 \in X$ such that $x_0 \preceq Tx_0$, then T has a fixed point.

Proof. Let $x_n = T^n x_0$ for all $n \in \mathbb{N}$. If there exists some $n \in \mathbb{N}$ such that $Tx_{n-1} = x_n = x_{n-1}$, then x_{n-1} is a fixed point and hence the proof is complete. Therefore, we may assume that $x_n \neq x_{n-1}$ for all $n \in \mathbb{N}$. By Lemma 4, $\{x_n\}$ is 0-Cauchy. So by the 0-completeness of X, there exists $x_* \in X$ such that $x_n \xrightarrow{p} x_*$, and consider

$$\lim_{n \to \infty} p(x_n, x_*) = p(x_*, x_*) = \lim_{m, n \to \infty} p(x_m, x_n) = 0.$$
(27)

That is, $x_n \xrightarrow{p^*} x_*$. By (A2), $\sup\{x_n\} = x^*$, and so, for all $n \in \mathbb{N}$,

$$x_n \le x_*. \tag{28}$$

Now, we claim that, for all $n \in \mathbb{N}$,

$$x_n \neq x_*. \tag{29}$$

If otherwise, there exists some n_* such that $x_{n_*} = x_*$; then $x_n = x_*$ for all $n \ge n_*$ since $\{x_n\}$ is nondecreasing. This contradicts with the assumption $x_n \ne x_{n-1}$ for all $n \in \mathbb{N}$, and hence (29) is true. Since *T* is nondecreasing, then $x_{n+1} = Tx_n \le Tx_*$, for all $n \in \mathbb{N}$, and hence by (A2)

$$x_* = \sup\left\{x_n\right\} \le Tx_*. \tag{30}$$

Let $y_n = T^n x_*$ for all $n \in \mathbb{N}$. Then $\{y_n\}$ is a nondecreasing sequence since *T* is nondecreasing. We may assume that, for all $n \in \mathbb{N}$,

$$y_n \neq y_{n-1}.\tag{31}$$

If otherwise, there exists some $n \in \mathbb{N}$ such that $Ty_{n-1} = y_n = y_{n-1}$; then y_{n-1} is a fixed point and hence the proof is complete. By Lemma 4 and the 0-completeness of *X*, there exists $y_* \in X$ such that $y_n \xrightarrow{p} y_*$, and consider

$$\lim_{n \to \infty} p(y_n, y_*) = p(y_*, y_*) = \lim_{m, n \to \infty} p(y_m, y_n) = 0.$$
(32)

That is, $y_n \xrightarrow{p^s} y_*$. By (A2), we have, for all $n \in \mathbb{N}$,

$$y_n \preceq y_*. \tag{33}$$

It follows from $x_n \xrightarrow{p^s} x_*, y_n \xrightarrow{p^s} y_*$, and the continuity of the metric p^s that

$$\lim_{n \to \infty} p^{s}(x_{n}, y_{n}) = p^{s}(x_{*}, y_{*}).$$
(34)

That is,

$$\lim_{n \to \infty} \left[2p(x_n, y_n) - p(x_n, x_n) - p(y_n, y_n) \right] = 2p(x_*, y_*),$$
(35)

which together with (27) and (32) implies that

$$\lim_{n \to \infty} p(x_n, y_n) = p(x_*, y_*).$$
(36)

By (p4), we have, $n \in \mathbb{N}$,

$$p(x_{n}, y_{n}) - p(x_{n}, x_{n+1})$$

$$\leq p(x_{n+1}, y_{n}) \leq p(x_{n}, y_{n}) + p(x_{n}, x_{n+1}),$$

$$p(x_{n}, y_{n}) - p(y_{n}, y_{n+1})$$

$$\leq p(x_{n}, y_{n+1}) \leq p(x_{n}, y_{n}) + p(y_{n}, y_{n+1}).$$
(37)

Letting $n \to \infty$ in the above two inequalities, by (27), (32), and (36), we get

$$\lim_{n \to \infty} p(x_{n+1}, y_n) = \lim_{n \to \infty} p(x_n, y_{n+1}) = p(x_*, y_*).$$
(38)

In what follows, we will show $x_* = y_*$. Suppose, on the contrary, that $x_* \neq y_*$; then $p(x_*, y_*) > 0$. Clearly, $x_n \leq y_n$ and $x_n \neq y_n$ for all $n \in \mathbb{N}$ by (29), (30), and (31). Consequently,

$$p\left(x_n, y_n\right) > 0,\tag{39}$$

for all $n \in \mathbb{N}$. Thus by (5), we have, for all $n \in \mathbb{N}$,

$$p(x_{n+1}, y_{n+1}) = p(Tx_n, Ty_n) \le \varphi\left(M_{p,r}^1(x_n, y_n)\right), \quad (40)$$

where $M_{p,r}^1(x_n, y_n) = \max\{p(x_n, y_n), p(x_n, x_{n+1}), p(y_n, y_{n+1}), (p(x_n, x_{n+1}) \cdot p(y_n, y_{n+1}))/p(x_n, y_n), (p(x_n, y_{n+1}) + p(y_n, x_{n+1}))/2\}$. By (27), (32), and (36), we have

$$\lim_{n \to \infty} \frac{p(x_n, x_{n+1}) \cdot p(y_n, y_{n+1})}{p(x_n, y_n)} = 0,$$
(41)

which together with (27), (32), (36), and (38) implies that there exists $n_1 \in \mathbb{N}$ such that, for all $n \ge n_1$,

$$M_{p,r}^{1}(x_{n}, y_{n}) = M_{2}(x_{n}, y_{n}), \qquad (42)$$

where $M_2(x_n, y_n) = \max\{p(x_n, y_n), (p(x_n, y_{n+1}) + p(y_n, x_{n+1}))/2\}$. It follows from (36) and (38) that

$$M_2(x_n, y_n) \longrightarrow p(x_*, y_*). \tag{43}$$

By (39), (40), and (42), we have, for all $n \ge n_1$,

$$\frac{p(x_{n+1}, y_{n+1})}{M_2(x_n, y_n)} \le \frac{\varphi(M_2(x_n, y_n))}{M_2(x_n, y_n)}.$$
(44)

Letting $n \to \infty$ in (44), by (36), (43), (H6), and $p(x_*, y_*) > 0$, we get a contradiction $1 \le \limsup_{t \to p(x_*, y_*)} (\varphi(t)/t) < 1$. Hence $p(x_*, y_*) = 0$, and consequently $x_* = y_*$. From (30) and (33), it follows that $x_* \le Tx_* = y_1 \le y_*$. This together with $x_* = y_*$ yields that $x_* = Tx_*$. The proof is complete. \Box

In particular when *T* is a $M_{p,r}^2$ -GCRT, condition (H6) could be weakened, and we have the following result.

Theorem 7. Let (X, p, \leq) be a 0-complete ordered partial metric space and $T : X \rightarrow X$ a nondecreasing M_{pr}^2 -GCRT. Assume that (H5) is satisfied and X has property (A2). If there exists $x_0 \in X$ such that $x_0 \leq Tx_0$, then T has a fixed point.

Proof. Following the proof of Theorem 6, we find that (27)–(36) and (39) still hold by Remark 5. Instead of (40), by (5), (6), (39), and $x_n \leq y_n$, we have, for all $n \in \mathbb{N}$,

$$p(x_{n+1}, y_{n+1}) = p(Tx_n, Ty_n) \leq \varphi(M_{p,r}^2(x_n, y_n)) < M_{p,r}^2(x_n, y_n),$$
(45)

where $M_{p,r}^2(x_n, y_n) = \max\{p(x_n, y_n), p(x_n, x_{n+1}), p(y_n, y_{n+1}), (p(x_n, x_{n+1}) \cdot p(y_n, y_{n+1}))/p(x_n, y_n)\}$. By (28), (32), (36), and $p(x_*, y_*) > 0$, there exists $n_2 \in \mathbb{N}$ such that, for all $n \ge n_2$,

$$M_{p,r}^{2}(x_{n}, y_{n}) = p(x_{n}, y_{n}), \qquad (46)$$

which together with (45) implies that, for all $n \ge n_2$,

$$p(x_{n+1}, y_{n+1}) < p(x_n, y_n).$$
 (47)

That is, $\{p(x_n, y_n)\}_{n=n_2}^{\infty}$ is decreasing. Moreover by (36), we have

$$p(x_n, y_n) \longrightarrow p(x_*, y_*)^+.$$
 (48)

Instead of (44), by (39), (45), and (46), for all $n \ge n_2$,

$$\frac{p(x_{n+1}, y_{n+1})}{p(x_n, y_n)} \le \frac{\varphi(p(x_n, y_n))}{p(x_n, y_n)}.$$
(49)

Letting $n \to \infty$ in (49), by (48), (H5), and $p(x_*, y_*) > 0$, we get a contradiction $1 \le \lim_{t \to p(x_*, y_*)^+} (\varphi(t)/t) < 1$. Hence $p(x_*, y_*) = 0$, and consequently $x_* = y_*$. From (30) and (33), it follows that $x_* \le Tx_* = y_1 \le y_*$. This together with $x_* = y_*$ yields that $x_* = Tx_*$. The proof is complete.

Corollary 8. Let (X, p, \leq) be a 0-complete ordered partial metric space and $T : X \to X$ a nondecreasing mapping such that there exists a function $\eta : \mathbb{R}_+ \to \mathbb{R}_+$ with $\eta^{-1}(\{0\}) = \{0\}$ such that

$$p(Tx,Ty) \le M_{p,r}^2(x,y) - \eta(M_{p,r}^2(x,y)),$$
 (50)

for all $x, y \in X$ with $x \leq y$ and p(x, y) > 0. Assume that, for all s > 0,

$$\liminf_{t \to s^+} \frac{\eta(t)}{t} > 0, \tag{51}$$

and X has property (A2). If there exists $x_0 \in X$ such that $x_0 \preceq Tx_0$, then T has a fixed point.

Proof. Let $\varphi(t) = t - \eta(t)$. Clearly, $\varphi(t) < t$ for all t > 0 by $\eta^{-1}(\{0\}) = \{0\}$. For all s > 0, it follows from (51) that

$$\limsup_{t \to s^+} \frac{\varphi(t)}{t} = \limsup_{t \to s^+} \frac{t - \eta(t)}{t} \le 1 - \liminf_{t \to s^+} \frac{\eta(t)}{t} < 1.$$
(52)

Then the conclusion follows immediately from Theorem 7. The proof is complete. $\hfill \Box$

Remark 9. If η is lower semicontinuous from the right and $\eta^{-1}(\{0\}) = \{0\}$, then, for all s > 0,

$$\liminf_{t \to s^+} \frac{\eta(t)}{t} \ge \frac{\eta(s)}{s} > 0.$$
(53)

Therefore Theorem 1 follows immediately from Corollary 8.

Now we illustrate Theorems 6 and 7 by the following example.

Example 10. Let $X = \mathbb{R}_+$ with the partial metric $p(x, y) = \max\{x, y\}$ for all $x, y \in X$. Clearly, $p^s(x, y) = 2p(x, y) - p(x, x) - p(y, y) = |x - y|$ and hence, by Remark 3, (X, p)

is a complete partial metric space since (X, p^s) is a complete metric space. Define a partial order \leq on X by

$$x \leq y \Longleftrightarrow \begin{cases} x = y, & x, y \in X \setminus (\{0\} \cup B), \\ x \leq y, & x, y \in \{0\} \cup B, \end{cases}$$
(54)

where $B = \{(1/n) : n = 2, 3, ...\}$ and \leq is the usual order of reals. Let

$$Tx = \begin{cases} 0, & x = X \setminus B, \\ \frac{x}{1+x}, & x = \frac{1}{n}, n = 2, 4, \dots, \end{cases}$$
(55)
$$\varphi(t) = \begin{cases} t - t^3, & t \in [0, 1) \setminus B, \\ \frac{t}{1+t}, & t = \frac{1}{n}, n = 2, 3, \dots, \\ t - \frac{1}{2}, & t \ge 1. \end{cases}$$
(56)

It is easy to see that *T* is nondecreasing, *X* has property (A2), and $\varphi(t) < t$ for all t > 0. Direct calculations give that

$$\limsup_{t \to s} \frac{\varphi(t)}{t} = \begin{cases} 1 - s^2 < 1, & s \in (0, 1), \\ 1 - \frac{1}{2s} < 1, & s \ge 1. \end{cases}$$
(57)

That is, (H6) is satisfied. In particular, (H5) is satisfied. For each $x, y \in X \setminus B$ with $x \leq y$ and p(x, y) > 0, we must have p(Tx, Ty) = 0 and hence $p(Tx, Ty) \leq \varphi(M_{p,r}^i(x, y)), i = 1, 2$. For each $x, y \in \{0\} \cup B$ with $x \leq y$ and p(x, y) > 0, we have two cases:

- (i) if x = 0 and y = (1/n), $n \ge 2$, then $p(Tx, Ty) = 1/(n+1) \le 1/n = p(x, y) = M_{p,r}^{i}(x, y)$, i = 1, 2;
- (ii) if y = 1/n and x = 1/m, $m \ge n \ge 3$, then $p(Tx, Ty) = 1/(n+1) \le 1/n = p(x, y) = M_{p,r}^{i}(x, y)$, i = 1, 2.

Thus by (56), $p(Tx, Ty) \leq M_{p,r}^{i}(x, y) = \varphi(M_{p,r}^{i}(x, y))$, i = 1, 2. This shows that T is a $M_{p,r}^{i}$ -GCRT(i = 1, 2), and consequently the existence of fixed point follows immediately from Theorem 6 or Theorem 7. In fact, 0 is a fixed point of T.

In what follows, we will extend Theorem 2 to the case of ordered partial metric space under weaker conditions.

Theorem 11. Let (X, p, \leq) be a 0-complete ordered partial metric space and $T : X \rightarrow X$ a nondecreasing mapping such that, for each $x, y \in X$ with $x \leq y$, (2) is satisfied for M_p^1 . Assume that either (H4) or (H5) is satisfied and X has the following property:

(A3) if $\{x_n\}$ is a nondecreasing sequence in X such that $x_n \xrightarrow{p^s} x$, then $x_n \preceq x$ for all $n \in \mathbb{N}$.

If there exists $x_0 \in X$ such that $x_0 \preceq Tx_0$, then T has a fixed point.

Proof.

Case 1 ((H5) is satisfied). Following the proof of Theorem 6, we get (27) and (28) by Remark 5 and (A3). By (p4), for all $n \in \mathbb{N}$,

$$p(x_{*}, Tx_{*}) - p(x_{n+1}, x_{*}) \le p(x_{n+1}, Tx_{*})$$

$$\le p(x_{*}, Tx_{*}) + p(x_{n+1}, x_{*}).$$
(58)

Letting $n \to \infty$ in (58), by (27), we get

$$\lim_{n \to \infty} p(x_{n+1}, Tx_*) = p(x_*, Tx_*).$$
(59)

Now, we show that x_* is a fixed point of *T*. If otherwise, then $p(x_*, Tx_*) > 0$. By (p4), (2), and (28), we have, for all $n \in \mathbb{N}$,

$$p(x_{*}, Tx_{*}) \leq p(x_{n+1}, x_{*}) + p(Tx_{n}, Tx_{*})$$

$$\leq p(x_{n+1}, x_{*}) + \varphi(M_{p}^{1}(x_{n}, x_{*})),$$
(60)

where $M_p^1(x_n, x_*) = \max\{p(x_n, x_*), p(x_n, x_{n+1}), p(x_*, Tx_*), (p(x_n, Tx_*) + p(x_*, x_{n+1}))/2\}$. It follows from (27) and (59) that

$$\lim_{n \to \infty} \frac{p(x_n, Tx_*) + p(x_*, x_{n+1})}{2} = \frac{p(x_*, Tx_*)}{2}, \quad (61)$$

which together with (27) implies that there exist $\delta_0 \in (0, p(x_*, Tx_*)/2]$ and $n_0 \in \mathbb{N}$ such that, for all $n \ge n_0$,

$$\frac{p(x_{n}, Tx_{*}) + p(x_{*}, x_{n+1})}{2} \leq \frac{p(x_{*}, Tx_{*})}{2} + \delta_{0} \leq p(x_{*}, Tx_{*}),$$

$$p(x_{n}, x_{*}) \leq \delta_{0}, \qquad p(x_{n}, x_{n+1}) \leq \delta_{0}.$$
(62)

Thus, for all $n \ge n_0$,

$$M_{p}^{1}(x_{n}, x_{*}) = p(x_{*}, Tx_{*}), \qquad (63)$$

and hence, by (60),

$$p(x_*, Tx_*) \le p(x_{n+1}, x_*) + \varphi(p(x_*, Tx_*)).$$
 (64)

Letting $n \to \infty$ in (64), by (27), we get a contradiction

$$p(x_*, Tx_*) \le \varphi(p(x_*, Tx_*)) < p(x_*, Tx_*), \qquad (65)$$

since $\varphi(s) < s$ for all s > 0. Hence x_* is a fixed point of *T*.

Case 2 ((H4) is satisfied). By the same method used in Lemma 4 and [8, Theorem 4], we can show that (27) and (59) still hold. Then by analogy to Case 1, x_* is a fixed point of *T*. The proof is complete.

Remark 12. If *T* is a generalized contraction of rational type, then the method used in Theorem 11 fails to work since there exists $n_0 \in \mathbb{N}$ such that $M_{p,r}^i(x_n, x_*) = p(x_*, Tx_*)$ for all $n \ge n_0$ unless $\lim_{n\to\infty} p(x_n, x_{n+1})/p(x_n, x_*) \le 1$, which could not be done. Therefore the existence of fixed point of generalized contractions of rational type could not be obtained under the weaker condition (A3).

By the methods used in Theorem 11 and [8, Theorem 4], we have the following fixed point result.

Theorem 13. Let (X, p) be a 0-complete partial metric space and $T : X \to X$ a M_p^1 -GC. If either (H4) or (H5) is satisfied, then T has a unique fixed point.

Remark 14. (i) In the case that (H5) is satisfied, the continuity and nondecreasing property of φ necessarily assumed in Theorem 2 is removed in Theorem 13. Note that (H3) implies (H5); then Theorem 13 improves Theorem 1 of [6], Theorem 3 of [8], and Theorem 2.3 of [23].

(ii) In the case that (H4) is satisfied, Theorem 13 is generalization of Theorem 4 of [8] to the case of M_p^1 -GC and hence improves Theorem 1 of [7] since (H2) implies (H4).

Example 15. Let $X = \{0\} \cup \{1/n : n = 2, 3, ...\}$ with the partial metric $p(x, y) = \max\{x, y\}$ for all $x, y \in X$. By analogy to Example 10, we find from Remark 3 that (X, p) is a complete partial metric space. Let

$$Tx = \begin{cases} 0, & x = 0, \\ \frac{x}{1+x}, & x = \frac{1}{n}, n = 2, 3, \dots, \end{cases}$$
(66)

and φ is given by (56). It is easy to check that *T* is a M_p^1 -GC and (H5) is satisfied. Therefore the unique existence of fixed point follows immediately from Theorem 13. In fact, 0 is the unique fixed point of *T*.

For each s = 1/n, $n \ge 2$, we have $\limsup_{t \to s^+} \varphi(t) = (n^2 - 1)/n^3 > 1/(n + 1) = \varphi(s)$. This implies that φ is not upper semicontinuous from the right at s = 1/n, $n \ge 2$. Meanwhile, it is clear that φ is decreasing on (1/3, 1). Therefore, we cannot invoke Theorem 2 to show the unique existence of fixed point.

Remark 16. It is worth mentioning that, even in the setting of metric spaces, the main results in this paper are still new since the continuity and nondecreasing property of the comparison function φ necessarily assumed in [24] and other relating references is removed.
