# Adaptive pointwise estimation of conditional density function

#### Abstract

In this paper we consider the problem of estimating $f$, the conditional density of $Y$ given $X$, by using an independent sample distributed as $(X, Y)$ in the multivariate setting. We consider the estimation of $f(x, \cdot)$ where $x$ is a fixed point. We define two different procedures of estimation, the first one using kernel rules, the second one inspired from projection methods. Both adaptive estimators are tuned by using the Goldenshluger and Lepski methodology. After deriving lower bounds, we show that these procedures satisfy oracle inequalities and are optimal from the minimax point of view on anisotropic Hölder balls. Furthermore, our results allow us to measure precisely the influence of $\mathrm{f}_{X}(x)$ on rates of convergence, where $\mathrm{f}_{X}$ is the density of $X$. Finally, some simulations illustrate the good behavior of our tuned estimates in practice.


Résumé. Dans cet article, nous considérons le problème de l'estimation de $f$, la densité conditionnelle de $Y$ sachant $X$, en utilisant un échantillon de même loi que ( $X, Y$ ), dans le cadre multivarié. On considère l'estimation de $f(x, \cdot)$ où $x$ est un point fixé. Nous définissons deux procédures d'estimation différentes, la première utilisant des estimateurs à noyau, alors que la seconde s'inspire des méthodes de projection. Les deux procédures adaptatives sont calibrées en utilisant la méthodologie proposée par Goldenshulger et Lepski. Une fois obtenu le calcul des bornes inférieures du risque, nous montrons que ces procédures satisfont des inégalités oracles et sont optimales du point de vue minimax sur les boules de Hölder anisotropes. De plus, nos résultats nous permettent de mesurer précisément l'influence de $\mathrm{f}_{X}(x)$ sur les vitesses convergence, où $\mathrm{f}_{X}$ est la densité de $X$. Finalement, des simulations numériques illustrent le bon comportement de nos procédures calibrées en pratique.

## 1. Introduction

### 1.1. Motivation

In this paper, we consider the problem of conditional density estimation. For this purpose, we assume we are given an i.i.d. sample ( $X_{i}, Y_{i}$ ) of couples of random vectors (for any $i, X_{i} \in \mathbb{R}^{d_{1}}$ and $Y_{i} \in \mathbb{R}^{d_{2}}$, with $d_{1} \geq 1$ and $d_{2} \geq 1$ ) with common probability density function $f_{X, Y}$ and marginal densities $f_{Y}$ and $\mathrm{f}_{X}$ : for any $y \in \mathbb{R}^{d_{2}}$ and any $x \in \mathbb{R}^{d_{1}}$,

f_{Y}(y)=\int_{\mathbb{R}^{d_{1}}} f_{X, Y}(u, y) \mathrm{d} u, \quad \mathrm{f}_{X}(x)=\int_{\mathbb{R}^{d_{2}}} f_{X, Y}(x, v) \mathrm{d} v
$$

The conditional density function of $Y_{i}$ given $X_{i}=x$ is defined by

$$
f(x, y)=\frac{f_{X, Y}(x, y)}{\mathrm{f}_{X}(x)}
$$

for all $y \in \mathbb{R}^{d_{2}}$ and $x \in \mathbb{R}^{d_{1}}$ such that $\mathrm{f}_{X}(x)>0$. Our goal is to estimate $f$ using the observations ( $X_{i}, Y_{i}$ ). The conditional density is much more informative than the simple regression function and then its estimation has many practical applications: in Actuaries (Efromovich [17]), Medicine (Takeuchi et al. [37]), Economy (Hall et al. [26]), Meteorology (Jeon and Taylor [29]) among others. In particular, due to recent advances in ABC methods, the problem of conditional density estimation in the multivariate setting is of main interest.

Indeed, the ABC methodology, where ABC stands for approximate Bayesian computation, offers a resolution of untractable-yet-simulable models, that is models for which it is impossible to calculate the likelihood. The standard ABC procedure is very intuitive and consists in

- simulating a lot of parameters values using the prior distribution and, for each parameter value, a corresponding dataset;
- comparing this simulated dataset to the observed one;
- finally, keeping the parameter values for which distance between the simulated dataset and the observed one is smaller than a tolerance level.

That is a crude nonparametric approximation of the target posterior distribution (the conditional distribution of the parameters given the observation). Even if some nonparametric perspectives have been considered (see Blum [8] or Biau et al. [6]), we easily imagine that, using the simulated couples (parameters and datasets), a good nonparametric estimation of the posterior distribution can be a credible alternative to the ABC method. Such a procedure has to consider that the conditional density has to be estimated only for the observed value in the conditioning.

All previous points clearly motivate our work and in the sequel, we aim at providing an estimate with the following 4 requirements:

1. The estimate has to be fully data-driven and implementable in a reasonable computational time.
2. The parameters of the method have to adapt to the function $f$ in the neighborhood of $x$. Tuning the hyperparameters of the estimate has to be an easy task.
3. The estimate should be optimal from the theoretical point of view in an asymptotic setting but also in a nonasymptotic one.
4. Estimating $f$ in neighborhoods of points $x$ where $\mathrm{f}_{X}(x)$ is equal or close to 0 is of course a difficult task and a loss is unavoidable. Studying this loss and providing estimates that are optimal with respect to this problem are the fourth motivation of this paper.
To address the problem of conditional density estimation, the first idea of statisticians was to estimate $f$ by the ratio of a kernel estimator of the joint density $f_{X, Y}$ and a kernel estimator of $f_{X}$ : see Rosenblatt [33], Chen et al. [12], or also Hyndman et al. [27], De Gooijer and Zerom [15] for refinements of this method. An important work in this line is the one of Fan et al. [18] who extend the Rosenblatt estimator by a local polynomial method (see also Hyndman and Yao [28]). The estimators introduced in the ABC literature are also of this kind: a linear (or quadratic) adjustment is realized on the data before applying the classic quotient estimator (Beaumont et al. [4], Blum [8]). Other directions are investigated by Bouaziz and Lopez [9] who use a single-index model, or Györfi and Kohler [25] who partition the space and obtain a piecewise constant estimate. All these papers have in common to involve a ratio between two density estimates, though we can mention Stone [36] for a spline tensor based maximum likelihood estimator. An original approach which rather involves a product is the copula one of Faugeras [20]. But his method depends on a bandwidth, that remains to select from the data. In particular, for all of these methods, the second requirement is not satisfied.

The practical choice of the bandwidth and cross-validation methods are studied in Bashtannyk and Hyndman [3] and [19]. However, no theoretical result is associated to this study. The first adaptive results can be found in Clémençon [13] for the estimation of the transition density of a Markov chain, which is a very similar problem to the one of conditional density estimation (set $Y_{i}=X_{i+1}$ ). He uses thresholding of wavelet estimator. Afterwards, using different methods, the works of Brunel et al. [10] or Efromovich [16] yield oracle inequalities and minimax rates of
convergence for anisotropic conditional densities. The case of inhomogeneous regularities is studied in Akakpo and Lacour [1] or Sart [34] in the case of Markov chains. Still for global adaptive approach, we can cite Chagny [11] who applies the Goldenshluger-Lepski methodology to warped bases and Cohen and Le Pennec [14] who use a model selection approach with Kullback risk. All the previous authors use a global risk and either consider integration with respect to $\mathrm{f}_{X}(x) \mathrm{d} x$ or assume that $\mathrm{f}_{X}$ is bounded from below by a constant (as it is done in regression estimation). We are interested in precisely studying this assumption to show that it is unavoidable in some sense.

### 1.2. Our strategy and our contributions

Our strategy to estimate $f$ is based on the Goldenshluger and Lepski methodology proposed in the seminal papers Goldenshluger and Lepski $[22,23]$ in the case of density estimation and extended to the white noise and regression models in Goldenshluger and Lepski [24]. This strategy detailed in Section 2 allows us to derive two procedures: kernel and projection rules. If they seem different, they are based on similar ideas and they lead to quite similar theoretical results. Our method automatically selects a regularization parameter, and in particular a bandwidth for kernel rules. Note that the tolerance level in ABC methods can be reinterpreted as a regularization parameter.

Unlike most of previous works of the literature, we shall not use a global risk and we will evaluate the quality of an estimator $\hat{f}$ at a fixed point $x \in \mathbb{R}$ and in the $\mathbb{L}_{2}$-norm with respect to the variable $y$. In other words, we will use the risk

R_{x}(\hat{f}, q)=\left(\mathbb{E}\left[\|\hat{f}-f\|_{x, 2}^{q}\right]\right)^{1 / q} \tag{1.1}
\end{equation*}

where for any function $g$,

$$
\begin{equation*}
\|g\|_{x, 2}=\left(\int_{\mathbb{R}^{d_{2}}} g^{2}(x, y) \mathrm{d} y\right)^{1 / 2} . \tag{1.2}
\end{equation*}

The previously mentioned motivating applications show that the tuning parameter has to depend on $x$, which is not the case of other cited-above adaptive methods. As shown later, combined with the Goldenshluger and Lepski methodology, considering this risk allows us to derive estimates satisfying this property. Furthermore, for a given $x$, $y \mapsto f(x, y)$ is a density, so it is natural for us to study the estimation pointwisely in $x$.

From the theoretical point of view, we establish nonasymptotic meaningful oracle inequalities and rates of convergence on anisotropic Hölder balls $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$. More precisely, in Proposition 1 and Theorem 4, we establish lower bounds in oracle and minimax settings. Then, upper bounds of the risk for our adaptive kernel procedure are established (see Theorems 1, 2 and 5). If the density $f_{X}$ is smooth enough, Corollary 1 shows that upper and lower bounds match up to constants in the asymptotic setting. Then, there is a natural question: is this assumption on the smoothness of $\mathrm{f}_{X}$ mandatory? We prove that the answer is no by establishing the upper bound of the risk for our adaptive projection estimate (see Theorems 3 and 6). In particular, the latter achieves a polynomial rate of convergence on anisotropic Hölder balls with rate exponent $\bar{\alpha} /(2 \bar{\alpha}+1)$, where $\bar{\alpha}$ is the classical anisotropic smoothness index. To our knowledge, this rate exponent is new in the conditional density estimation setting for the pointwise risk in $x$. Our result also explicits the dependence of the rate with respect to $\mathbf{L}$ on the one hand and to $\mathrm{f}_{X}(x)$ on the other hand, which is not classical. Indeed, as previously recalled, estimation is harder when $\mathrm{f}_{X}(x)$ is small and this is the reason why most of the papers assume that $\mathrm{f}_{X}$ is bounded from below by a constant. For kernel rules, our study is sharp enough to measure precisely the influence of $\mathrm{f}_{X}(x)$ on the performance of our procedure. Under some conditions and if the sample size is $n$, we show that the order of magnitude of minimax rates (that are achieved by our procedure), is $\left(n \mathrm{f}_{X}(x)\right)^{\bar{\alpha} /(2 \bar{\alpha}+1)}$. We conclude that our setting is equivalent to the setting where $\mathrm{f}_{X}$ is locally bounded from 0 by 1 but we observe $n \mathrm{f}_{X}(x)$ observations instead of $n$.

Finally, we study our procedures from a practical point of view. We aim at completing theoretical results by studying tuning issues. More precisely, our procedures are data driven and tuning parameters depend on $x$ and on an hyperparameter $\eta$, a constant that has to be tuned. We lead a precise study that shows how to choose $\eta$ in practice. We also show that reconstructions for various examples and various values of $n$ are satisfying. All these results show that our procedures fulfill requirements listed in Section 1.1.

### 1.3. Overview and notations

Our paper is organized as follows. In Section 2, we present the Goldenshluger and Lepski methodology in the setting of conditional density estimation. In Sections 4 and 5 respectively, kernel and projection rules are derived and studied in the oracle setting by using assumptions of Section 3. Rates of convergence on anisotropic Hölder balls are studied in Section 6. Then a simulation study is lead in Section 7, where we focus on tuning aspects of our procedures. Finally, in Section 8 and in the Appendix, we prove our results. To avoid too tedious technical aspects, most of proofs are only given for $d_{1}=d_{2}=1$ but can easily be extended to the general case. In the sequel, we assume that the sample size is $2 n$. The first $n$ observations $\left(X_{1}, Y_{1}\right), \ldots,\left(X_{n}, Y_{n}\right)$ are used to estimate $f$, whereas $X_{n+1}, \ldots, X_{2 n}$ are used to estimate $\mathrm{f}_{X}$ when necessary. We recall that for any $i, X_{i} \in \mathbb{R}^{d_{1}}$ and $Y_{i} \in \mathbb{R}^{d_{2}}$ and we set $d=d_{1}+d_{2}$.

In addition to notations $R_{x}(\cdot, \cdot)$ and $\|\cdot\|_{x, 2}$ introduced in (1.1) and (1.2), we use for any $1 \leq q<\infty\|\cdot\|_{q}$, the classical $\mathbb{L}_{q}$-norm of any function $g$ :

$$
\|g\|_{q}^{q}=\int|g(x)|^{q} \mathrm{~d} x .
$$

Some assumptions on functions $f$ and $\mathrm{f}_{X}$, specified in Section 3, will depend on the following neighborhood of $x$, denoted $V_{n}(x)$ : Given $A$ a positive real number and $\left(k_{n}\right)_{n}$ any positive sequence larger than 1 only depending on $n$ and such that $k_{n}$ goes to $+\infty$, we set:

V_{n}(x)=\prod_{i=1}^{d_{1}}\left[x_{i}-\frac{2 A}{k_{n}}, x_{i}+\frac{2 A}{k_{n}}\right] .
$$

Note that the size of $V_{n}(x)$ goes to 0 . Then, we set

$$
\|f\|_{\infty}=\sup _{t \in V_{n}(x)} \sup _{y \in \mathbb{R}^{d_{2}}} f(t, y) \in[0,+\infty], \quad\left\|\mathrm{f}_{X}\right\|_{\infty}=\sup _{t \in V_{n}(x)} \mathrm{f}_{X}(t) \in[0,+\infty]
$$

and

$$
\delta=\inf _{t \in V_{n}(x)} \mathrm{f}_{X}(t) \geq 0 .
$$

Our results will strongly depend on these quantities. Finally, for any $u \in \mathbb{R}$, we set $\{u\}_{+}=\max (u, 0)$.

## 2. Methodology

### 2.1. The Goldenshluger-Lepski methodology

This section is devoted to the description of the Goldenshluger-Lepski methodology (GLM for short) in the setting of conditional density estimation.

The GLM consists in selecting an estimate from a family of estimates, each of them depending on a parameter $m$. Most of the time, choosing this tuning parameter can be associated to a regularization scheme: if we take $m$ too small, then the estimate oversmooths; if we take $m$ too large, data are overfitted.

So, given a set of parameters $\mathcal{M}_{n}$, for any $m \in \mathcal{M}_{n}$, we assume we are given a smoothing linear operator denoted $\mathcal{K}_{m}$ and an estimate $\hat{f}_{m}$. For any $m \in \mathcal{M}_{n}, \hat{f}_{m}$ is related to $\mathcal{K}_{m}(f)$ via its expectation and we assume that $\mathbb{E}\left[\hat{f}_{m}\right]$ is close to (or equal to) $\mathcal{K}_{m}(f)$. The main assumptions needed for applying the GLM are

$$
\begin{equation*}
\mathcal{K}_{m} \circ \mathcal{K}_{m^{\prime}}=\mathcal{K}_{m^{\prime}} \circ \mathcal{K}_{m} \tag{2.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{K}_{m}\left(\hat{f}_{m^{\prime}}\right)=\mathcal{K}_{m^{\prime}}\left(\hat{f}_{m}\right) \tag{2.2}
\end{equation*}
$$

for any $m, m^{\prime} \in \mathcal{M}_{n}$. The GLM is a convenient way to select an estimate among $\left(\hat{f}_{m}\right)_{m \in \mathcal{M}_{n}}$ which amounts to selecting $m \in \mathcal{M}_{n}$ and can be described as follows: For $\|\cdot\|$ a given norm and $\sigma$ a function to be chosen later, we set for any $m$ in $\mathcal{M}_{n}$,

A(m):=\sup _{m^{\prime} \in \mathcal{M}_{n}}\left\{\left\|\hat{f}_{m^{\prime}}-\mathcal{K}_{m^{\prime}}\left(\hat{f_{m}}\right)\right\|-\sigma\left(m^{\prime}\right)\right\}_{+}
$$

Then we estimate $f$ by using $\hat{f}:=\hat{f}_{\hat{m}}$, where $\hat{m}$ is selected as follows:

$$
\hat{m}:=\underset{m \in \mathcal{M}_{n}}{\arg \min }\{A(m)+\sigma(m)\} .
$$

This choice can be seen as a bias-variance tradeoff, with $\sigma(m)$ an estimator of the standard deviation of $\hat{f}_{m}$ and $A(m)$ an estimator of the bias (see later). Let us now fix $m \in \mathcal{M}_{n}$. Using (2.2), we have:

& \leq\left\|\hat{f}_{\hat{m}}-\mathcal{K}_{\hat{m}}\left(\hat{f}_{m}\right)\right\|+\left\|\mathcal{K}_{m}\left(\hat{f}_{\hat{m}}\right)-\hat{f}_{m}\right\|+\left\|\hat{f}_{m}-f\right\| \\
& \leq A(m)+\sigma(\hat{m})+A(\hat{m})+\sigma(m)+\left\|\hat{f}_{m}-f\right\| \\
& \leq 2 A(m)+2 \sigma(m)+\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\|+\left\|\mathcal{K}_{m}(f)-f\right\| .
\end{aligned}
$$

But

$$
\begin{aligned}
A(m) & =\sup _{m^{\prime} \in \mathcal{M}_{n}}\left\{\left\|\hat{f}_{m^{\prime}}-\mathcal{K}_{m^{\prime}}\left(\hat{f}_{m}\right)\right\|-\sigma\left(m^{\prime}\right)\right\}_{+} \\
& \leq \xi(m)+B(m)
\end{aligned}
$$

with for any $m \in \mathcal{M}_{n}$,

$$
\xi(m):=\sup _{m^{\prime} \in \mathcal{M}_{n}}\left\{\left\|\left(\hat{f}_{m^{\prime}}-\mathcal{K}_{m^{\prime}}(f)\right)-\left(\mathcal{K}_{m^{\prime}}\left(\hat{f}_{m}\right)-\left(\mathcal{K}_{m^{\prime}} \circ \mathcal{K}_{m}\right)(f)\right)\right\|-\sigma\left(m^{\prime}\right)\right\}_{+}
$$

and

$$
B(m):=\sup _{m^{\prime} \in \mathcal{M}_{n}}\left\|\mathcal{K}_{m^{\prime}}(f)-\left(\mathcal{K}_{m^{\prime}} \circ \mathcal{K}_{m}\right)(f)\right\|
$$

We finally obtain:

\|\hat{f}-f\| \leq 2 B(m)+2 \sigma(m)+\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\|+\left\|f-\mathcal{K}_{m}(f)\right\|+2 \xi(m) \tag{2.3}
\end{equation*}

Now, let us assume that

$$
\begin{equation*}
\|\mathcal{K}\|:=\sup _{m \in \mathcal{M}_{n}}\left\|\mathcal{K}_{m}\right\|<\infty \tag{2.4}
\end{equation*}

where $\left\|\mathcal{K}_{m}\right\| \|$ is the operator norm of $\mathcal{K}_{m}$ associated with $\|\cdot\|$. In this case, $B(m)$ is upper bounded by $\left\|f-\mathcal{K}_{m}(f)\right\|$ up to the constant $\|\mathcal{K}\| \|$, which corresponds to the bias of $\hat{f}_{m}$ if

$$

\mathcal{K}_{m}(f)=\mathbb{E}\left[\hat{f}_{m}\right] \tag{2.5}
\end{equation*}

Furthermore, using (2.1) and (2.2), for any $m \in \mathcal{M}_{n}$,

$$
\xi(m) \leq \sup _{m^{\prime} \in \mathcal{M}_{n}}\left\{(1+\|\mathcal{K}\|)\left\|\hat{f}_{m^{\prime}}-\mathcal{K}_{m^{\prime}}(f)\right\|-\sigma\left(m^{\prime}\right)\right\}_{+}
$$

Then we choose $\sigma$ such that, with high probability, for any $m \in \mathcal{M}_{n}$,

$$
\begin{equation*}
\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\| \leq \sigma(m) /(\|\mathcal{K}\| \|+1) \tag{2.6}
\end{equation*}
$$

So, (2.3) gives that, with high probability,

$$
\begin{equation*}
\|\hat{f}-f\| \leq C \inf _{m \in \mathcal{M}_{n}}\left\{\left\|f-\mathcal{K}_{m}(f)\right\|+\sigma(m)\right\} \tag{2.7}
\end{equation*}
$$

where $C$ depends only on $\|\|\mathcal{K}\|\|$. Since under (2.5), $\sigma(m)$ controls the fluctuations of $\hat{f}_{m}$ around its expectation, $\sigma^{2}(m)$ can be viewed as a variance term and the oracle inequality (2.7) justifies our procedure. Previous computations combined with the upper bound of $A(m)$ also justify why $A(m)$ is viewed as an estimator of the bias.

Now, we illustrate this methodology with two natural smoothing linear operators: convolution and projection. The natural estimates associated with these operators are kernel rules and projection rules respectively. Next paragraphs describe the main aspects of both procedures and discuss assumptions (2.1), (2.2), (2.4) and (2.5) which are the key steps of the GLM.

### 2.2. Convolution and kernel rules

Kernel rules are the most classical procedures for conditional density estimation. To estimate $f$, the natural approach consists in considering the ratio of a kernel estimate of $f_{X, Y}$ with a kernel estimate of $\mathrm{f}_{X}$. Actually, we use an alternative approach and to present our main ideas, we assume for a while that $\mathrm{f}_{X}$ is known and positive.

We introduce a kernel $K$, namely a bounded integrable function $K$ such that $\iint K(u, v) \mathrm{d} u \mathrm{~d} v=1$ and $\|K\|_{2}<\infty$. Then, given a regularization parameter, namely a $d$-dimensional bandwidth $h$ belonging to a set $\mathcal{H}_{n}$ to be specified later, we set

$$
K_{h}(u, v)=\frac{1}{\prod_{i=1}^{d} h_{i}} K\left(\frac{u_{1}}{h_{1}}, \ldots, \frac{u_{d_{1}}}{h_{d_{1}}}, \frac{v_{1}}{h_{d_{1}+1}}, \ldots, \frac{v_{d_{2}}}{h_{d}}\right), \quad u \in \mathbb{R}^{d_{1}}, v \in \mathbb{R}^{d_{2}}
$$

Then, we use the setting of Section 2.1 except that regularization parameters are denoted $h$, instead of $m$ to match with usual notation of the literature. Similarly, the set of bandwidths is denoted by $\mathcal{H}_{n}$, instead of $\mathcal{M}_{n}$. For any $h \in \mathcal{H}_{n}$, we set:

\forall g \in \mathbb{L}_{2}, \quad \mathcal{K}_{h}(g)=K_{h} * g
$$

where $*$ denotes the standard convolution product and

$$

\hat{f}_{h}(x, y):=\frac{1}{n} \sum_{i=1}^{n} \frac{1}{\mathrm{f}_{X}\left(X_{i}\right)} K_{h}\left(x-X_{i}, y-Y_{i}\right) \tag{2.8}
\end{equation*}
$$

The regularization operator $\mathcal{K}_{h}$ corresponds to the convolution with $K_{h}$. Note that

$$
\mathbb{E}\left[\hat{f}_{h}(x, y)\right]=\left(K_{h} * f\right)(x, y)
$$

Therefore 3 of 4 assumptions of the GLM are satisfied, namely (2.1), (2.2) and (2.5). Unfortunately, (2.4) is satisfied with $\|\cdot\|$ the classic $\mathbb{L}_{2}$-norm but not with $\|\cdot\|_{x, 2}$, as adopted in this paper. We shall see how to overcome this problem later on.

Another drawback of this description is that $\hat{f}_{h}$ is based on the knowledge of $\mathrm{f}_{X}$. A kernel rule based on $\hat{\mathrm{f}}_{X}$, an estimate of $\mathrm{f}_{X}$, is proposed in Section 4.2 where we define $\sigma$ (see (2.6)) to apply the GLM methodology and then to obtain oracle inequalities similar to (2.7). Additional terms in oracle inequalities will be the price to pay for using $\hat{\mathrm{f}}_{X}$ instead of $f_{X}$.

### 2.3. Projection

We introduce a collection of models $\left(S_{m}\right)_{m \in \mathcal{M}_{n}}$ and for any $m$, we denote $\mathcal{K}_{m}$ the projection on $\left(S_{m},\langle\cdot, \cdot\rangle_{X}\right)$ where $\langle\cdot, \cdot\rangle_{X}$ is the scalar product defined by:

$$
\begin{equation*}
\forall g, g^{\prime}, \quad\left\langle g, g^{\prime}\right\rangle_{X}=\iint g(u, y) g^{\prime}(u, y) \mathrm{f}_{X}(u) \mathrm{d} u \mathrm{~d} y \tag{2.9}
\end{equation*}
$$

Of course, (2.1) is satisfied, but as for kernel rules, (2.4) is not valid with $\|\cdot\|=\|\cdot\|_{x, 2}$. Now, we introduce the following empirical contrast:

$$
\text { for all function } t, \quad \gamma_{n}(t)=\frac{1}{n} \sum_{i=1}^{n}\left[\int_{\mathbb{R}} t^{2}\left(X_{i}, y\right) \mathrm{d} y-2 t\left(X_{i}, Y_{i}\right)\right] \text {, }
$$

so that $\mathbb{E}\left(\gamma_{n}(t)\right)$ is minimum when $t=f$ (see Lemma 1 in Section 5.2). Given $m$ in $\mathcal{M}_{n}$, the conditional density can be estimated by:

$$
\begin{equation*}
\hat{f}_{m} \in \underset{t \in S_{m}}{\arg \min } \gamma_{n}(t) \tag{2.10}
\end{equation*}
$$

Unlike kernel rules, this estimate does not depend on $f_{X}$ but (2.2) and (2.5) are not satisfied even if for large values of $n, \mathcal{K}_{m}(f) \approx \mathbb{E}\left[\hat{f}_{m}\right]$. Therefore, we modify this approach to overcome this problem. The idea is the following. Let us denote $S_{m \wedge m^{\prime}}=S_{m} \cap S_{m^{\prime}}$. Taking inspiration from the fact that $\mathcal{K}_{m} \circ \mathcal{K}_{m^{\prime}}(f)=\mathcal{K}_{m \wedge m^{\prime}}(f)$, set for any $\left(m, m^{\prime}\right) \in \mathcal{M}_{n}^{2}$,

$$
\tilde{\mathcal{K}}_{m}\left(\hat{f}_{m^{\prime}}\right)=\hat{f}_{m \wedge m^{\prime}} .
$$

This operator is only defined on the set of the estimators $\hat{f}_{m}$ but verifies (2.2). Now the previous reasoning can be reproduced and the GLM described in Section 2.1 can be applied by replacing $\mathcal{K}_{m^{\prime}}$ by $\tilde{\mathcal{K}}_{m^{\prime}}$ in $A(m)$ and by setting

$$
\xi(m):=\sup _{m^{\prime} \in \mathcal{M}_{n}}\left\{\left\|\left(\hat{f}_{m^{\prime}}-\mathcal{K}_{m^{\prime}}(f)\right)-\left(\tilde{\mathcal{K}}_{m^{\prime}}\left(\hat{f}_{m}\right)-\left(\mathcal{K}_{m^{\prime}} \circ \mathcal{K}_{m}\right)(f)\right)\right\|-\sigma\left(m^{\prime}\right)\right\}_{+}
$$

In Section 5.2, we define $\sigma$ such that for all $m, m^{\prime} \in \mathcal{M}_{n}, \sigma\left(m \wedge m^{\prime}\right) \leq \sigma\left(m^{\prime}\right)$ and similarly to (2.6), with high probability, for any $m \in \mathcal{M}_{n}$,

$$
\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\| \leq \frac{\sigma(m)}{2}
$$

Then, for all $m, m^{\prime} \in \mathcal{M}_{n}$,

$$
\left\|\tilde{\mathcal{K}}_{m^{\prime}}\left(\hat{f}_{m}\right)-\left(\mathcal{K}_{m^{\prime}} \circ \mathcal{K}_{m}\right)(f)\right\|=\left\|\hat{f}_{m \wedge m^{\prime}}-\mathcal{K}_{m \wedge m^{\prime}}(f)\right\| \leq \frac{\sigma\left(m \wedge m^{\prime}\right)}{2} \leq \frac{\sigma\left(m^{\prime}\right)}{2}
$$

so that $\xi(m)$ vanishes with high probability. Thus, we shall be able to derive oracle inequalities in this case as well.

### 2.4. Discussion

We have described two estimation schemes for which the GLM is appropriate: kernel and projection rules. In these schemes, the main commutative properties of the GLM, namely (2.1) and (2.2), are satisfied. Due to the particular choice of the loss-function $\|\cdot\|_{x, 2}$, the property (2.4) is not satisfied. However in both schemes, we shall be able to prove that for any function $g$

$$
\begin{equation*}
\left\|\mathcal{K}_{m}(g)\right\|_{x, 2} \leq C \sup _{t \in V_{n}(x)}\|g\|_{t, 2} \tag{2.11}
\end{equation*}
$$

where $C$ is a constant, $V_{n}(x)$ is the neighborhood of $x$ introduced in Section 1.3, and this property will allow us to control the bias term $B(m)$, as well as the term $\xi(m)$. In the sequel, we shall cope with the following specific features of each scheme:

- For kernel rules, when $\mathrm{f}_{X}$ is known, (2.5) is satisfied and these estimates lead to straightforward application of the GLM. But, when $\mathrm{f}_{X}$ is unknown, serious difficulties will arise.
- For projection rules, the dependence on the knowledge of $f_{X}$ will be weaker but since (2.5) is not satisfied, the control of the bias term will not be straightforward.

Beyond these aspects, our main task in next sections will be to derive for each estimation scheme a function $\sigma$ that conveniently controls the fluctuations of preliminary estimates as explained in Section 2.1.

## 3. Assumptions

In this section, we state our assumptions on $f$ and $\mathrm{f}_{X}$.
$\left(\mathrm{H}_{1}\right)$ The conditional density $f$ is uniformly bounded on $V_{n}(x) \times \mathbb{R}^{d_{2}}:\|f\|_{\infty}<\infty$.
$\left(\mathrm{H}_{2}\right)$ The density $\mathrm{f}_{X}$ is uniformly bounded on $V_{n}(x):\left\|\mathrm{f}_{X}\right\|_{\infty}<\infty$.
$\left(\mathrm{H}_{3}\right)$ The density $\mathrm{f}_{X}$ is bounded away from 0 on $V_{n}(x): \delta>0$. In the sequel, without loss of generality, we assume that $\delta \leq 1$.

Assumptions $\left(\mathrm{H}_{1}\right)$ and $\left(\mathrm{H}_{2}\right)$ are very mild. Note that under $\left(\mathrm{H}_{1}\right)$, since $f$ is a conditional density, for any $t \in V_{n}(x)$, $\int f(t, v) \mathrm{d} v=1$ and

$$
\begin{equation*}
\sup _{t \in V_{n}(x)}\|f\|_{t, 2}^{2} \leq \sup _{t \in V_{n}(x), y \in \mathbb{R}^{d_{2}}} f(t, y) \int f(t, v) \mathrm{d} v=\|f\|_{\infty}<\infty . \tag{3.1}
\end{equation*}
$$

Assumption $\left(\mathrm{H}_{3}\right)$ is not mild but is in some sense unavoidable. As said in Introduction, one goal of this paper is to measure the influence of the parameter $\delta$ on the performance of the estimators of $f$.

For the procedures considered in this paper, if $\mathrm{f}_{X}$ is unknown, we need a preliminary estimator of $\mathrm{f}_{X}$ denoted $\hat{\mathrm{f}}_{X}$ that is constructed with observations $\left(X_{i}\right)_{i=n+1, \ldots, 2 n}$. Then, we first assume that $\hat{\mathrm{f}}_{X}$ satisfies the following condition:

$$
\begin{equation*}
\hat{\delta}:=\inf _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)\right|>0 . \tag{3.2}
\end{equation*}
$$

For estimating $\mathrm{f}_{X}, \hat{\mathrm{f}}_{X}$ has to be rather accurate:

$$
\begin{equation*}
\forall \lambda>0, \quad \mathbb{P}\left(\sup _{t \in V_{n}(x)}\left|\frac{\mathrm{f}_{X}(t)-\hat{\mathrm{f}}_{X}(t)}{\hat{\mathrm{f}}_{X}(t)}\right|>\lambda\right) \leq \kappa \exp \left\{-(\log n)^{3 / 2}\right\}, \tag{3.3}
\end{equation*}
$$

where $\kappa$ is a constant only depending on $\lambda$ and $\mathrm{f}_{X}$. Theorem 4 in Bertin et al. [5] proves the existence of an estimate $\hat{\mathrm{f}}_{X}$ satisfying these properties.

## 4. Kernel rules

In this section, we study the data-driven kernel rules we propose for estimating the conditional density $f$. They are precisely defined in Section 4.2 and their theoretical performances in the oracle setting are studied in Section 4.3. Before doing this, in Section 4.1, we establish a lower bound of the risk for any kernel estimate.

### 4.1. Lower bound for kernel rules

In this section, we consider the kernel estimate $\hat{f}_{h}$ defined in (2.8) for $h \in \mathcal{H}_{n}$. In particular, $\mathrm{f}_{X}$ is assumed to be known. For any fixed $h \in \mathcal{H}_{n}$, we provide a lower bound of the risk of $\hat{f}_{h}$ with $q=2$ by using the following bias-variance decomposition:

$$
R_{x}^{2}\left(\hat{f}_{h}, 2\right)=\mathbb{E}\left[\left\|\hat{f}_{h}-f\right\|_{x, 2}^{2}\right]=\left\|K_{h} * f-f\right\|_{x, 2}^{2}+\int \operatorname{var}\left(\hat{f}_{h}(x, y)\right) \mathrm{d} y .
$$

Proposition 1. Assume that $\left(\mathrm{H}_{1}\right)$ is satisfied. Then if $K(x, y)=K^{(1)}(x) K^{(2)}(y)$ with $K^{(1)}$ supported by $[-A, A]^{d_{1}}$, for any $h \in \mathcal{H}_{n}$, we have for any $n$,

$$
R_{x}^{2}\left(\hat{f_{h}}, 2\right) \geq\left\|K_{h} * f-f\right\|_{x, 2}^{2}+\frac{\left\|K^{(2)}\right\|_{2}^{2}}{n \prod_{i=1}^{d} h_{i}} \times \int \frac{\left[K^{(1)}(s)\right]^{2}}{\mathrm{f}_{X}\left(x-\left(s_{1} h_{1}, \ldots, s_{d_{1}} h_{d_{1}}\right)\right)} \mathrm{d} s+\frac{C_{1}}{n},
$$

where $C_{1}$ depends on $\|K\|_{1}$ and $\|f\|_{\infty}$. If we further assume that $\mathrm{f}_{X}$ is positive and continuous on a neighborhood of $x$, then if $\max \mathcal{H}_{n} \rightarrow 0$ when $n \rightarrow+\infty$,

$$
\begin{equation*}
R_{x}^{2}\left(\hat{f}_{h}, 2\right) \geq\left\|K_{h} * f-f\right\|_{x, 2}^{2}+\frac{\|K\|_{2}^{2}}{\mathrm{f}_{X}(x) n \prod_{i=1}^{d} h_{i}} \times(1+\mathrm{o}(1))+\mathrm{O}\left(\frac{1}{n}\right), \tag{4.1}
\end{equation*}
$$

when $n \rightarrow+\infty$.
The proof of Proposition 1 is given in Section 8. The lower bounds of Proposition 1 can be viewed as benchmarks for our procedures. In particular, our challenge is to build a data-driven kernel procedure whose risk achieves the lower bound given in (4.1). It is the goal of the next section where we modify $\hat{f}_{h}$ by estimating $\mathrm{f}_{X}$ when $\mathrm{f}_{X}$ is unknown.

### 4.2. Kernel estimator

Let us now define more precisely our kernel estimator. We consider the kernel $K$ defined in Section 2.2, but following assumptions of Proposition 1, we further assume until the end of the paper that following conditions are satisfied.

- The kernel $K$ is of the form $K(u, v)=K^{(1)}(u) K^{(2)}(v), u \in \mathbb{R}^{d_{1}}, v \in \mathbb{R}^{d_{2}}$.
- The function $K^{(1)}$ is supported by $[-A, A]^{d_{1}}$.

Our data-driven procedure is based on $\hat{\mathrm{f}}_{X}$ (see Section 3) and is defined in the following way. We naturally replace $\hat{f_{h}}$ defined in (2.8) with

$$
\begin{equation*}
\hat{f}_{h}(x, y)=\frac{1}{n} \sum_{i=1}^{n} \frac{1}{\hat{\mathrm{f}}_{X}\left(X_{i}\right)} K_{h}\left(x-X_{i}, y-Y_{i}\right) . \tag{4.2}
\end{equation*}
$$

Then, we set

$$
\begin{equation*}
\sigma(h)=\frac{\chi}{\sqrt{\hat{\delta} n \prod_{i=1}^{d} h_{i}}} \text { with } \chi=(1+\eta)\left(1+\|K\|_{1}\right)\|K\|_{2} \tag{4.3}
\end{equation*}
$$

where $\hat{\delta}$ is defined in (3.2) and $\eta>0$ is a tuning parameter. The choice of this parameter will be discussed in Section 7 but all theoretical results are true for any $\eta>0$. We also specify the set $\mathcal{H}_{n}$ :
(CK) For any $h=\left(h_{1}, \ldots, h_{d}\right) \in \mathcal{H}_{n}$, we have for any $i, h_{i}^{-1}$ is a positive integer and

$$
k_{n} \leq \frac{1}{h_{i}}, \quad \forall i \in\left\{1, \ldots, d_{1}\right\}, \quad \frac{1}{\prod_{i=1}^{d_{1}} h_{i}} \leq \frac{\hat{\delta} n}{(\log n)^{3}} \quad \text { and } \quad \log ^{2}(n) \leq \frac{1}{\prod_{i=d_{1}+1}^{d} h_{i}} \leq n .
$$

The GLM described in Section 2.2 can be applied and we estimate $f$ with $\hat{f}=\hat{f}_{\hat{h}}$ where

$$
\begin{aligned}
& \hat{h}=\hat{h}(x):=\underset{h \in \mathcal{H}_{n}}{\arg \min }\{A(h)+\sigma(h)\}, \\
& A(h):=\sup _{h^{\prime} \in \mathcal{H}_{n}}\left\{\left\|\hat{f}_{h^{\prime}}-\hat{f}_{h, h^{\prime}}\right\|_{x, 2}-\sigma\left(h^{\prime}\right)\right\}_{+},
\end{aligned}
$$

and

$$
\begin{equation*}
\hat{f}_{h, h^{\prime}}(x, y)=\frac{1}{n} \sum_{i=1}^{n}\left[\hat{\mathrm{f}}_{X}\left(X_{i}\right)\right]^{-1}\left(K_{h} * K_{h^{\prime}}\right)\left(x-X_{i}, y-Y_{i}\right)=\left(K_{h^{\prime}} * \hat{f}_{h}\right)(x, y) . \tag{4.4}
\end{equation*}
$$

In the case where $\mathrm{f}_{X}$ is known, $\hat{\mathrm{f}}_{X}$ is replaced by $\mathrm{f}_{X}$ and $\hat{\delta}$ by $\delta$. In particular, we obtain the expressions of Section 2.2 except that now $\sigma$ is specified.

### 4.3. Oracle inequalities for kernel rules

We establish in this section oracle inequalities for our estimator $\hat{f}$ with in mind the benchmarks given in (4.1). To shed lights on the performance of our procedure and on the role of $\delta$, we first deal with the case where $\mathrm{f}_{X}$ is known. We first state a trajectorial oracle inequality and then a control of the risk.

Theorem 1. Assume that the density $\mathrm{f}_{X}$ is known so that $\hat{\mathrm{f}}_{X}=\mathrm{f}_{X}$. We also assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{3}\right)$ and (CK) are satisfied. If $\delta n \geq 1$, we have with probability larger than $1-C \exp \left\{-(\log n)^{5 / 4}\right\}$,

$$
\begin{equation*}
\|\hat{f}-f\|_{x, 2} \leq \inf _{h \in \mathcal{H}_{n}}\left\{C_{1} \sup _{t \in V_{n}(x)}\left\|K_{h} * f-f\right\|_{t, 2}+\frac{C_{2}}{\sqrt{\delta n \prod_{i=1}^{d} h_{i}}}\right\}, \tag{4.5}
\end{equation*}
$$

where $C_{1}=1+2\|K\|_{1}, C_{2}=(1+\eta)\|K\|_{2}\left(3+2\|K\|_{1}\right)$ and $C$ depends on $K, \eta$ and $\|f\|_{\infty}$. Furthermore, for any $q \geq 1$,

$$
\begin{equation*}
R_{x}(\hat{f}, q) \leq \tilde{C}_{1} \inf _{h \in \mathcal{H}_{n}}\left\{\sup _{t \in V_{n}(x)}\left\|K_{h} * f-f\right\|_{t, 2}+\frac{1}{\sqrt{\delta n \prod_{i=1}^{d} h_{i}}}\right\}+\frac{\tilde{C}_{2}}{\sqrt{n}}, \tag{4.6}
\end{equation*}
$$

where $\tilde{C}_{1}$ depend on $K, \eta$ and $q$ and $\tilde{C}_{2}$ depends on $K, \eta,\|f\|_{\infty}$ and $q$.
Due to the assumptions on $\mathcal{H}_{n}$, the last term of the right hand side of (4.6), namely $\tilde{C}_{2} / \sqrt{n}$, is negligible with respect to the first one. Furthermore, since $\sigma^{2}(h)$ is proportional to $\left(\delta n \prod_{i=1}^{n} h_{i}\right)^{-1}$, the latter can be viewed as a variance term (see Section 2.1). Then right hand sides of (4.5) and (4.6) correspond to the best tradeoff between a bias term and a variance term, so (4.5) and (4.6) correspond indeed to oracle inequalities. Next, we can compare the (squared) upper bound of (4.6) and the lower bound of (4.1) when $q=2$ and $\mathrm{f}_{X}$ is continuous. We note that these bounds match up to leading constants, asymptotically negligible terms and up to the fact that terms of (4.6) are computed on $V_{n}(x)$ instead at $x$ (note that the size of $V_{n}(x)$ goes to 0 when $n \rightarrow+\infty$ and $\delta$ and $\mathrm{f}_{X}(x)$ are close). Actually, since (2.4) is not valid for $\|\cdot\|=\|\cdot\|_{x, 2}$, we use Inequality (2.11). This explains why we need to compute suprema of the bias term on $V_{n}(x)$. Theorem 1 shows the optimality of our kernel rule.

From these results, we can also draw interesting conclusions with respect to the term $\delta$ that appears in the variance term. From (4.1), we already know that the term $\delta$ is unavoidable. Of course, the lower $\delta$ the worse the performance of $\hat{f}$. Actually, in the oracle context, our setting is (roughly speaking) equivalent to the classical setting where $\mathrm{f}_{X}$ is lower bounded by an absolute constant (see Brunel et al. [10] for instance), but with $\delta n$ observations to estimate $f$ instead of $n$. A similar remark will hold in the minimax framework of Section 6 .

The following theorem deals with the general case where $\mathrm{f}_{X}$ is unknown and estimated by $\hat{\mathrm{f}}_{X}$.
Theorem 2. We assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right)$, (CK), (3.2) and (3.3) are satisfied. If $\delta n \geq 1$, we have with probability larger than $1-C \exp \left\{-(\log n)^{5 / 4}\right\}$,

$$
\begin{equation*}
\|\hat{f}-f\|_{x, 2} \leq \inf _{h \in \mathcal{H}_{n}}\left\{C_{1} \sup _{t \in V_{n}(x)}\left\|K_{h} * f-f\right\|_{t, 2}+\frac{C_{2}}{\sqrt{\hat{\delta} n \prod_{i=1}^{d} h_{i}}}\right\}+\frac{C_{3}}{\delta} \sup _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)-\mathrm{f}_{X}(t)\right|, \tag{4.7}
\end{equation*}
$$

where $C_{1}=1+2\|K\|_{1}, C_{2}=(1+\eta)\|K\|_{2}\left(3+2\|K\|_{1}\right), C_{3}$ depends on $K, \eta$ and $\|f\|_{\infty}$ and $C$ depends on $K, \eta, \mathrm{f}_{X}$ and $\|f\|_{\infty}$. Furthermore, for any $q \geq 1$,

$$
R_{x}(\hat{f}, q) \leq \tilde{C}_{1} \inf _{h \in \mathcal{H}_{n}}\left\{\sup _{t \in V_{n}(x)}\left\|K_{h} * f-f\right\|_{t, 2}+\frac{1}{\sqrt{\delta n \prod_{i=1}^{d} h_{i}}}\right\}+\frac{\tilde{C}_{2}}{\delta} \mathbb{E}^{1 / q}\left(\sup _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)-\mathrm{f}_{X}(t)\right|^{q}\right)+\frac{\tilde{C}_{3}}{\sqrt{n}},
$$

where $\tilde{C}_{1}$ depend on $K, \eta$ and $q, \tilde{C}_{2}$ depends on $K, \eta, q$ and $\|f\|_{\infty}$ and $\tilde{C}_{3}$ depends on $K, \eta, \mathrm{f}_{X},\|f\|_{\infty}$ and $q$.
The main difference between Theorems 2 and 1 lie in the terms involving $\sup _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)-\mathrm{f}_{X}(t)\right|$ in right hand sides. Of course, if $\mathrm{f}_{X}$ is regular enough, we can build $\hat{\mathrm{f}}_{X}$ so that this term is negligible. But in full generality, this unavoidable term due to the strong dependence of $\hat{f}_{h}$ on $\hat{\mathrm{f}}_{X}$, may be cumbersome. Therefore, even if Theorem 1 established the optimality of kernel rules in the case where $f_{X}$ is known, it seems reasonable to investigate other rules to overcome this problem.

## 5. Projection rules

Unlike previous kernel rules that strongly depend on the estimation of $\mathrm{f}_{X}$, this section presents estimates based on the least squares principle. The dependence on $\hat{\mathrm{f}}_{X}$ is only expressed via the use of $\hat{\delta}$ and $\left\|\hat{\mathrm{f}}_{X}\right\|_{\infty}:=\sup _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)\right|$. For ease of presentation, we assume that $d_{1}=d_{2}=1$ but following results can be easily extended to the general case (see Section 6.3).

### 5.1. Models

As previously, we are interested in the estimation of $f$ when the first variable is in the neighborhood of $x$, so we still use $V_{n}(x)$ defined in Section 1.3. We introduce a collection of models $\left(S_{m}\right)_{m \in \mathcal{M}_{n}}$.

Definition 1. Let $\mathcal{M}_{n}$ be a finite subset of $\{0,1,2, \ldots\}^{2}$. For each $m=\left(m_{1}, m_{2}\right) \in \mathcal{M}_{n}$ and given two $\mathbb{L}_{2}(\mathbb{R})$ orthonormal systems of bounded functions $\left(\varphi_{j}^{m}\right)_{j \in J_{m}}$ and $\left(\psi_{k}^{m}\right)_{k \in K_{m}}$, we set

$$
F_{m_{1}}=\operatorname{Span}\left(\varphi_{j}^{m}, j \in J_{m}\right), \quad H_{m_{2}}=\operatorname{Span}\left(\psi_{k}^{m}, k \in K_{m}\right)
$$

and the model $S_{m}$ is

$$
S_{m}=F_{m_{1}} \otimes H_{m_{2}}=\left\{t, t(x, y)=\sum_{j \in J_{m}} \sum_{k \in K_{m}} a_{j, k}^{m} \varphi_{j}^{m}(x) \psi_{k}^{m}(y), a_{j, k}^{m} \in \mathbb{R}\right\} .
$$

Finally, we denote

$$
D_{m_{1}}=\left|J_{m}\right| \quad \text { and } \quad D_{m_{2}}=\left|K_{m}\right|,
$$

respectively the dimension of $F_{m_{1}}$ and $H_{m_{2}}$.
In this paper, we only focus on systems $\left(\varphi_{j}^{m}\right)_{j \in J_{m}}$ based on Legendre polynomials. More precisely, the estimation interval $[x-2 A, x+2 A]$ is split into $2^{m_{1}}$ intervals of length $4 A 2^{-m_{1}}$ :

$$
I_{l}=I_{l}^{m}=\left[x-2 A+4 A(l-1) 2^{-m_{1}}, x-2 A+4 A l 2^{-m_{1}}\right), \quad l=1, \ldots, 2^{m_{1}} .
$$

Then $J_{m}=\left\{(l, d), l=1, \ldots, 2^{m_{1}}, d=0, \ldots, r\right\}, D_{m_{1}}=(r+1) 2^{m_{1}}$ and for any $u$,

$$
\varphi_{j}^{m}(u)=\varphi_{l, d}^{m}(u)=\sqrt{\frac{2^{m_{1}}}{2 A}} \sqrt{\frac{2 d+1}{2}} P_{d}\left(T_{l}(u)\right) \mathbb{1}_{I_{l}}(u),
$$

where $P_{d}$ is the Legendre polynomial with degree $d$ on $[-1,1]$, and $T_{l}$ is the affine map which transforms $I_{l}$ into $[-1,1]$.

In the $y$-direction, we shall also take piecewise polynomials. In the sequel, we only use the following two assumptions: for all $m, m^{\prime} \in \mathcal{M}_{n}, D_{m_{2}} \leq D_{m_{2}^{\prime}} \Rightarrow H_{m_{2}} \subset H_{m_{2}^{\prime}}$, and there exists a positive real number $\phi_{2}$ such that for all $m \in \mathcal{M}_{n}$ for all $u \in \mathbb{R}$,

$$
\sum_{k \in K_{m}}\left(\psi_{k}^{m}\right)^{2}(u) \leq \phi_{2} D_{m_{2}} .
$$

Note that this assumption is also true for $F_{m_{1}}$. Indeed the spaces spanned by the $\varphi_{j}^{m}$ 's are nested and, for all $u \in$ $[x-2 A, x+2 A]$,

$$
\sum_{l=1}^{2^{m_{1}}} \sum_{d=0}^{r} \varphi_{l, d}^{m}(u)^{2} \leq \frac{2^{m_{1}}}{2 A} \sum_{d=0}^{r} \frac{2 d+1}{2}=\frac{2^{m_{1}}}{4 A}(r+1)^{2}=\frac{r+1}{4 A} D_{m_{1}}
$$

using properties of the Legendre polynomials. Therefore, with $\phi_{1}=(r+1) /(4 A)$, for any $u \in[x-2 A, x+2 A]$,

$$
\sum_{j}\left(\varphi_{j}^{m}\right)^{2}(u) \leq \phi_{1} D_{m_{1}} .
$$

### 5.2. Projection estimator

As in Brunel et al. [10] and following Section 2.3, we introduce the following empirical contrast:

\gamma_{n}(t)=\frac{1}{n} \sum_{i=1}^{n}\left[\int_{\mathbb{R}} t^{2}\left(X_{i}, y\right) \mathrm{d} y-2 t\left(X_{i}, Y_{i}\right)\right] .
$$

We have the following lemma whose proof is easy by using straightforward computations. We use the norm $\|\cdot\|_{X}$ associated with the dot product $\langle\cdot, \cdot\rangle_{X}$ defined in (2.9), so we have for any $t$,

\|t\|_{X}^{2}=\iint t^{2}(u, y) \mathrm{f}_{X}(u) \mathrm{d} u \mathrm{~d} y .
$$

Lemma 1. Assume that the function $\sum_{j \in J_{m}} \sum_{k \in K_{m}} \hat{a}_{j, k}^{m} \varphi_{j}^{m} \psi_{k}^{m}$ minimizes the empirical contrast function $\gamma_{n}$ on $S_{m}$, then

\begin{equation*}
\hat{G}_{m} \hat{A}_{m}=\hat{Z}_{m}, \tag{5.1}
\end{equation*}
$$

where $\hat{A}_{m}$ denotes the matrix with coefficients $\left(\hat{a}_{j, k}^{m}\right)_{j \in J_{m}, k \in K_{m}}$,

$$
\hat{G}_{m}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{j_{1}}^{m}\left(X_{i}\right) \varphi_{j_{2}}^{m}\left(X_{i}\right)\right)_{j_{1}, j_{2} \in J_{m}} \quad \text { and } \quad \hat{Z}_{m}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right) \psi_{k}^{m}\left(Y_{i}\right)\right)_{j \in J_{m}, k \in K_{m}} .
$$

Similarly, if $\mathcal{K}_{m}(f)$ is the orthogonal projection of $f$ on $\left(S_{m},\langle\cdot, \cdot\rangle_{X}\right)$, it minimizes on $S_{m}$

$$
t \mapsto \gamma(t)=\|t-f\|_{X}^{2}-\|f\|_{X}^{2}=\mathbb{E}\left(\gamma_{n}(t)\right)
$$

and if $\mathcal{K}_{m}(f)=\sum_{j \in J_{m}} \sum_{k \in K_{m}} a_{j, k}^{m} \varphi_{j}^{m} \psi_{k}^{m}$ then,

$$
G_{m} A_{m}=Z_{m},
$$

where $A_{m}$ denotes the matrix with coefficients $\left(a_{j, k}^{m}\right)_{j \in J_{m}, k \in K_{m}}, G_{m}=\mathbb{E}\left(\hat{G}_{m}\right)=\left(\left\langle\varphi_{j_{1}}^{m}, \varphi_{j_{2}}^{m}\right\rangle_{X}\right)_{j_{1}, j_{2} \in J_{m}}$ and

$$
Z_{m}=\mathbb{E}\left(\hat{Z}_{m}\right)=\left(\iint \varphi_{j}^{m}(u) \psi_{k}^{m}(y) f(u, y) \mathrm{f}_{X}(u) \mathrm{d} u \mathrm{~d} y\right)_{j \in J_{m}, k \in K_{m}}
$$

From this lemma, we obtain that $\mathbb{E}\left(\gamma_{n}(t)\right)$ is minimum when $t=f$, which justifies the use of $\gamma_{n}$.
Then, to derive $\hat{f}_{m}$ an estimate of $f$, we use (5.1) as a natural consequence of the minimization problem (2.10). But if $\hat{G}_{m}$ is not invertible, $\hat{A}_{m}$ can be not uniquely defined.

Since $x$ is fixed, we can define, for each $m=\left(m_{1}, m_{2}\right)$, the index $l_{m_{1}}=l_{m_{1}}(x)$ such that $x$ belongs to $I_{l_{m_{1}}}$ (actually, since the estimation interval is centered in $x, l_{m_{1}}=2^{m_{1}-1}+1$ ). Furthermore, since we use a piecewise polynomial system, the Gram matrix $\hat{G}_{m}$ is a block diagonal matrix with blocks $\hat{G}_{m}^{(1)}, \ldots, \hat{G}_{m}^{\left(2^{m_{1}}\right)}$, where

$$
\hat{G}_{m}^{(l)}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{l, d_{1}}^{m}\left(X_{i}\right) \varphi_{l, d_{2}}^{m}\left(X_{i}\right)\right)_{0 \leq d_{1}, d_{2} \leq r}
$$

In the same way, we can define for $l=1, \ldots, 2^{m_{1}}$

$$
\hat{Z}_{m}^{(l)}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{l, d}^{m}\left(X_{i}\right) \psi_{k}^{m}\left(Y_{i}\right)\right)_{0 \leq d \leq r, k \in K_{m}}
$$

Now, and by naturally using the blockwise representation of $\hat{G}_{m}$, we define the collection of estimators $\left(\hat{f}_{m}\right)_{m \in \mathcal{M}_{n}}$ as:

$$
\hat{f}_{m}(x, y)=\sum_{d=0}^{r} \sum_{k \in K_{m}} \hat{a}_{\left(l_{m_{1}}, d\right), k}^{m} \varphi_{l_{m_{1}}, d}^{m}(x) \psi_{k}^{m}(y)
$$

and

$$
\left(\hat{a}_{\left(l_{m_{1}}, d\right), k}^{m}\right)_{0 \leq d \leq r, k \in K_{m}}:=\hat{A}_{m}^{\left(l_{m_{1}}\right)}:= \begin{cases}\left(\hat{G}_{m}^{\left(l_{m_{1}}\right)}\right)^{-1} \hat{Z}_{m}^{\left(l_{m_{1}}\right)} & \text { if } \min \left(\operatorname{Sp}\left(\hat{G}_{m}^{\left(l_{m_{1}}\right)}\right)\right)>(1+\eta)^{-2 / 5} \hat{\delta}, \\ 0 & \text { otherwise },\end{cases}
$$

where $\eta$ is a positive real number. Here, for a symmetric matrix $M, \operatorname{Sp}(M)$ denotes the spectrum of $M$, i.e. the set of its eigenvalues. This expression allows us to overcome problems if $\hat{G}_{m}$ is not invertible. Note that, when $r=0$, where $r$ is maximal degree of Legendre polynomials, this estimator can be written

$$
\hat{f}_{m}(x, y)=\sum_{j \in J_{m}} \sum_{k \in K_{m}} \frac{\sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right) \psi_{k}^{m}\left(Y_{i}\right)}{\sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right)^{2}} \varphi_{j}^{m}(x) \psi_{k}^{m}(y) .
$$

Now, to choose a final estimator among this collection, as explained in Section 2.3, we denote $m \wedge j=\left(m_{1} \wedge j_{1}\right.$, $\left.m_{2} \wedge j_{2}\right)=\left(\min \left(m_{1}, j_{1}\right), \min \left(m_{2}, j_{2}\right)\right)$ and by using $\hat{\mathrm{f}}_{X}$ introduced in Section 3, we set

$$
\begin{equation*}
\sigma(m)=\hat{\chi} \sqrt{\frac{D_{m_{1}} D_{m_{2}}}{\hat{\delta} n}} \quad \text { with } \hat{\chi}^{2}=(1+\eta)^{2}\left(4 \phi_{1} \phi_{2}(r+1)\right) \frac{\widehat{\left\|f_{X}\right\|_{\infty}}}{\hat{\delta}}, \tag{5.2}
\end{equation*}
$$

where $\left\|\widehat{f_{X} \|_{\infty}}=\right\| \hat{f}_{X} \|_{\infty}$ and $\hat{\delta}$ is defined in (3.2). We also specify the models we use: The following condition is the analog of (CK):
(CM) For any $m \in \mathcal{M}_{n}$,

$$
k_{n}(r+1) \leq D_{m_{1}} \leq \frac{\hat{\delta} n}{(\log n)^{3}} \quad \text { and } \quad \log ^{2}(n) \leq D_{m_{2}} \leq n
$$

The GLM described in Section 2.2 can be applied and we estimate $f$ with $\tilde{f}=\hat{f}_{\hat{m}}$ where

$$
\hat{m}=\hat{m}(x):=\underset{m \in \mathcal{M}_{n}}{\arg \min }\{A(m)+\sigma(m)\}
$$

and

$$
A(m):=\sup _{m^{\prime} \in \mathcal{M}_{n}}\left[\left\|\hat{f}_{m^{\prime}}-\hat{f}_{m^{\prime} \wedge m}\right\|_{x, 2}-\sigma\left(m^{\prime}\right)\right]_{+} .
$$

The next section studies the performance of the estimate $\tilde{f}$.

### 5.3. Oracle inequality for projection estimators

We establish in this section oracle inequalities for the projection estimate in the same spirit as for the kernel rule. We recall that $\mathcal{K}_{m}(f)$ is the orthogonal projection of $f$ on $\left(S_{m},\langle\cdot, \cdot\rangle_{X}\right)$ where $\langle\cdot, \cdot\rangle_{X}$ is the dot product defined in (2.9). The following result is the analog of Theorem 2.

Theorem 3. We assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right),(\mathrm{CM})$, (3.2) and (3.3) are satisfied. If $\delta n \geq 1$, we have with probability larger than $1-C \exp \left\{-(\log n)^{5 / 4}\right\}$,

$$
\|\tilde{f}-f\|_{x, 2} \leq \inf _{m \in \mathcal{M}_{n}}\left(C_{1} \sup _{t \in V_{n}(x)}\left\|\mathcal{K}_{m}(f)-f\right\|_{t, 2}+\frac{5}{2} \hat{\chi} \sqrt{\frac{D_{m_{1}} D_{m_{2}}}{\hat{\delta} n}}\right)
$$

with $\hat{\chi}$ defined in (5.2), $C_{1}=1+2(r+1) \delta^{-1}\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $C$ depends on $\phi_{1}, \phi_{2}, r, \eta,\|f\|_{\infty}$ and $\mathrm{f}_{X}$. Furthermore, for any $q \geq 1$

$$
R_{x}(\tilde{f}, q) \leq \tilde{C}_{1} \inf _{m \in \mathcal{M}_{n}}\left(\sup _{t \in V_{n}(x)}\left\|\mathcal{K}_{m}(f)-f\right\|_{t, 2}+\sqrt{\frac{D_{m_{1} D_{m_{2}}}}{\delta n}}\right)+\frac{\tilde{C}_{2}}{\sqrt{n}},
$$

where $\tilde{C}_{1}$ depends on $\phi_{1}, \phi_{2}, r, \eta,\left\|\mathrm{f}_{X}\right\|_{\infty}, \delta$ and $q$ and $\tilde{C}_{2}$ depends on $\phi_{1}, \phi_{2}, r, \eta,\|f\|_{\infty}, \mathrm{f}_{X}$ and $q$.
As for Theorem 2, using the definition of $\sigma$, the right hand sides correspond to the best tradeoff between a bias term and a variance term. Note that unlike kernel rules, the performances of $\tilde{f}$ do not depend on the rate of convergence of $\hat{\mathrm{f}}_{X}$ for estimating $\mathrm{f}_{X}$. But there is a price to pay: due to a rougher control of the bias term, $\hat{\chi}$ depends on $\hat{\delta}$ and the leading constants $C_{1}$ and $\tilde{C}_{1}$ depend on $\delta$. In particular, when $\mathrm{f}_{X}$ is known, conclusions drawn from Theorem 1 do not hold here. However, in the case where $r=0$ (the basis in the first coordinate is simply the histogram basis), we can use the simpler penalty term $\hat{\chi}=(1+\eta) \sqrt{4 \phi_{1} \phi_{2}}$ and the previous result still holds. To prove this, it is sufficient to use the basis $\left(\left\|\varphi_{j}\right\|_{X}^{-1} \varphi_{j} \otimes \psi_{k}\right)_{j, k}$ which is orthonormal for the scalar product $\langle\cdot, \cdot\rangle_{X}$.

## 6. Rates of convergence

In this section, minimax rates of convergence will be computed on Hölder balls $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$. We recall that for two $d$-tuples of positive reals $\boldsymbol{\alpha}=\left(\alpha_{1}, \ldots, \alpha_{d}\right)$ and $\mathbf{L}=\left(L_{1}, \ldots, L_{d}\right)$,

$$
\begin{aligned}
\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})= & \left\{f: \mathbb{R}^{d} \rightarrow \mathbb{R} \text { s.t. } \forall 1 \leq i \leq d\left\|\frac{\partial^{m} f}{\partial x_{i}^{m}}\right\|_{\infty} \leq L_{i}, m=0, \ldots,\left\lfloor\alpha_{i}\right\rfloor\right. \\
& \text { and for all } \left.t \in \mathbb{R}\left\|\frac{\partial^{\left\lfloor\alpha_{i}\right\rfloor} f}{\left.\partial x_{i}^{\left\lfloor\alpha_{i}\right\rfloor}\right\rfloor}\left(\cdot+t e_{i}\right)-\frac{\partial^{\left\lfloor\alpha_{i}\right\rfloor} f}{\partial x_{i}^{\left\lfloor\alpha_{i}\right\rfloor}}(\cdot)\right\|_{\infty} \leq L_{i}|t|^{\alpha_{i}-\left\lfloor\alpha_{i}\right\rfloor}\right\},
\end{aligned}
$$

where for any $i,\left\lfloor\alpha_{i}\right\rfloor=\max \left\{l \in \mathbb{N}: l<\alpha_{i}\right\}$ and $e_{i}$ is the vector where all coordinates are null except the $i$ th one which is equal to 1 . In the sequel, we use the classical anisotropic smoothness index defined by

$$
\bar{\alpha}=\left(\sum_{i=1}^{d} \frac{1}{\alpha_{i}}\right)^{-1}
$$

and introduced in the seminal paper Kerkyacharian et al. [30]. See also Goldenshluger and Lepski [21].

### 6.1. Lower bound

We have the following result that holds without making any assumption. It is proved in Section 8.3 of Bertin et al. [5].
Theorem 4. There exists a positive constant $C$ not depending on $\mathbf{L}$ nor $n$ such that, if $n$ is large enough,

$$
\inf _{T_{n}} \sup _{\left(f, \mathrm{f}_{X}\right) \in \tilde{\mathcal{H}}(\boldsymbol{\alpha}, \mathbf{L})}\left\{\left(\mathrm{f}_{X}(x)\right)^{(2 \bar{\alpha}) /(2 \bar{\alpha}+1)} \mathbb{E}\left\|f-T_{n}\right\|_{x, 2}^{2}\right\} \geq C\left(\prod_{i=1}^{d} L_{i}^{1 / \alpha_{i}}\right)^{(2 \bar{\alpha}) /(2 \bar{\alpha}+1)} n^{-(2 \bar{\alpha}) /(2 \bar{\alpha}+1)},
$$

where the infimum is taken over all estimators $T_{n}$ of $f$ based on the observations $\left(X_{i}, Y_{i}\right)_{i=1, \ldots, n}$ and $\tilde{\mathcal{H}}(\boldsymbol{\alpha}, \mathbf{L})$ is the set such that the conditional density $f$ belongs to $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$ and the marginal density $\mathrm{f}_{X}$ is continuous.

Note that we consider the ball $\tilde{\mathcal{H}}(\boldsymbol{\alpha}, \mathbf{L})$ which may be (slightly) smaller than the ball $\mathcal{H}(\boldsymbol{\alpha}, \mathbf{L})$. Actually, we wish to point out the dependence of the lower bound with respect to $n, \boldsymbol{\alpha}$ and $\mathbf{L}$ as usual but also to $\mathrm{f}_{X}(x)$, which is less classical. The goal in next sections is to show that our procedures achieve the lower bound of Theorem 4.

### 6.2. Upper bound for kernel rules

In this section, we need an additional assumption on $f$.
$\left(\mathrm{H}_{4}\right)$ There exists a compact set $B$, such that for all $t \in V_{n}(x)$, the function $y \mapsto f(t, y)$ has a support included into $B$. We denote by $|B|$ the length of the compact set $B$.

This assumption could be avoided at the price of studying the risk restricted on $B$. Moreover, to study the bias of the kernel estimator, we consider for any $\mathbf{M}=\left(M_{1}, \ldots, M_{d}\right)$ the following condition.
$\left(\mathrm{BK}_{\mathbf{M}}\right)$ For any $i \in\{1, \ldots, d\}$, for any $1 \leq j \leq M_{i}$, we have

$$
\int_{\mathbb{R}}\left|x_{i}\right|^{j}|K(x)| \mathrm{d} x_{i}<\infty \quad \text { and } \quad \int_{\mathbb{R}} x_{i}^{j} K(x) \mathrm{d} x_{i}=0
$$

We refer the reader to Kerkyacharian et al. [30] for the construction of a kernel $K$ satisfying ( $\mathrm{BK}_{\mathbf{M}}$ ) and previous required conditions. We obtain the following result showing the optimality of our first procedure from the minimax point of view, up to the rate for estimating $f_{X}$.

Theorem 5. We assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right),\left(\mathrm{H}_{4}\right),(\mathrm{CK})$, (3.2) and (3.3) are satisfied. Let $\mathbf{M}=\left(M_{1}, \ldots, M_{d}\right)$ such that $\left(\mathrm{BK}_{\mathbf{M}}\right)$ is satisfied. Then if $f$ belongs to $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$ such that $\left\lfloor\alpha_{i}\right\rfloor \leq M_{i}$ for all $i=1, \ldots, d$, the kernel rule $\hat{f}$ satisfies for any $q \geq 1$,

$$
R_{x}^{q}(\hat{f}, q) \leq \tilde{C}_{1}\left(\prod_{i=1}^{d} L_{i}^{1 / \alpha_{i}}\right)^{(q \bar{\alpha}) /(2 \bar{\alpha}+1)}(n \delta)^{-(q \bar{\alpha}) /(2 \bar{\alpha}+1)}+\frac{\tilde{C}_{2}}{\delta^{q}} \mathbb{E}\left(\sup _{t \in V_{n}(x)}\left|\hat{\mathrm{f}}_{X}(t)-\mathrm{f}_{X}(t)\right|^{q}\right)+\tilde{C}_{3} n^{-q / 2}
$$

where $\tilde{C}_{1}$ depend on $K, \eta$ and $q, \tilde{C}_{2}$ depends on $K, \eta, q$ and $\|f\|_{\infty}$ and $\tilde{C}_{3}$ depends on $K, \eta, \mathrm{f}_{X},\|f\|_{\infty}$ and $q$.
If the leading term in the last expression is the first one, then, up to some constants, the upper bound of Theorem 5 matches with the lower bound obtained in Theorem 4 (note that $\delta$ is close to $\mathrm{f}_{X}(x)$ ) when $q=2$. In this case, our estimate is adaptive minimax. To study the second term, we can use Theorem 4 of Bertin et al. [5] that proves that, in our setting, there exists an estimate $\hat{f}_{X}$ achieving the rate $(\log / n)^{\bar{\beta} /(2 \bar{\beta}+1)}$ if $\mathrm{f}_{X} \in \mathcal{H}_{d_{1}}(\boldsymbol{\beta}, \tilde{\mathbf{L}})$ and we obtain the following corollary.

Corollary 1. We assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right),\left(\mathrm{H}_{4}\right),(\mathrm{CK})$ and $\left(\mathrm{BK}_{\mathbf{M}}\right)$ are satisfied. We also assume that $\mathrm{f}_{X} \in$ $\mathcal{H}_{d_{1}}(\boldsymbol{\beta}, \tilde{\mathbf{L}})$ such that for any $i=1, \ldots, d_{1}, \tilde{L}_{i}>0$ and $0<\beta_{i} \leq \beta_{i}^{(m)}$ with some known $\beta_{i}^{(m)}>0$. Then if $f$ belongs to $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$ such that $\left\lfloor\alpha_{i}\right\rfloor \leq M_{i}$ for all $i=1, \ldots, d$, the kernel rule $\hat{f}$ satisfies for any $q \geq 1$,

R_{x}^{q}(\hat{f}, q) \leq C_{1}\left(\left(\prod_{i=1}^{d} L_{i}^{1 / \alpha_{i}}\right)^{(q \bar{\alpha}) /(2 \bar{\alpha}+1)}(n \delta)^{-(q \bar{\alpha}) /(2 \bar{\alpha}+1)}+\frac{1}{\delta^{q}}\left(\frac{\log n}{n}\right)^{(q \bar{\beta}) /(2 \bar{\beta}+1)}\right)+C_{2} n^{-q / 2}
$$

where $C_{1}$ is a constant not depending on $\mathbf{L}, n$ and $\delta$ and $C_{2}$ is a constant not depending on $\mathbf{L}$ and $n$.

From the corollary, we deduce that if $\bar{\beta}>\bar{\alpha}$ and if $\delta$ is viewed as a constant, then the leading term is first one. Furthermore, in this case, the rate is polynomial and the rate exponent is the classical ratio associated with anisotropic Hölder balls: $\bar{\alpha} /(2 \bar{\alpha}+1)$. Our result also explicits the dependence of the rate with respect to $\mathbf{L}$ and $\delta$.

### 6.3. Upper bound for projection estimates

In the same way, we can control the bias for our second procedure of estimation in order to study the rate of convergence. Let us briefly explain how the procedure defined in Section 5 can be extended to the estimation of conditional anisotropic densities $f: \mathbb{R}^{d_{1}} \times \mathbb{R}^{d_{2}} \rightarrow \mathbb{R}$ with $d_{1}, d_{2} \geq 2$. The contrast is still the same and the estimators $\hat{f}_{m}$ have to be defined for $m=\left(m_{1}, \ldots, m_{d}\right)$ with a polynomial basis on hyperrectangles: see Akakpo and Lacour [1] for a precise definition. The model dimension is now

D_{m_{1}}=\prod_{i=1}^{d_{1}} r_{i} 2^{m_{i}}
$$

where $r_{1}, \ldots, r_{d_{1}}$ are the maximum degrees. Then, the selection rule to define $\tilde{f}$ is unchanged, except that in (5.2)

\hat{\chi}^{2}=(1+\eta)^{2}\left(4 \phi_{1} \phi_{2} \prod_{i=1}^{d_{1}} r_{i}\right) \frac{\widehat{\left\|f_{X}\right\|_{\infty}}}{\hat{\delta}}

In order to control precisely the bias, we introduce the following condition.
$\left(\mathrm{BM}_{\mathbf{r}}\right) H_{m_{2}}$ is a space of piecewise polynomials with degrees bounded by $r_{d_{1}+1}, \ldots, r_{d}$, with $D_{m_{2}}=\prod_{i=d_{1}+1}^{d} r_{i} 2^{m_{i}}$. This allows us to state the following result.

Theorem 6. We assume that $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right),\left(\mathrm{H}_{4}\right),(\mathrm{CM}),(3.2)$ and (3.3) are satisfied. Let $\mathbf{r}=\left(r_{1}, \ldots, r_{d}\right)$ such that $\left(\mathrm{BM}_{\mathbf{r}}\right)$ is satisfied. Then if $f$ belongs to $\mathcal{H}_{d}(\boldsymbol{\alpha}, \mathbf{L})$ such that $\alpha_{i}<r_{i}$ for all $i=1, \ldots, d$, the projection rule $\tilde{f}$ satisfies for any $q \geq 1$,

R_{x}^{q}(\tilde{f}, q) \leq \tilde{C}\left(\prod_{i=1}^{d} L_{i}^{1 / \alpha_{i}}\right)^{(q \bar{\alpha}) /(2 \bar{\alpha}+1)} n^{-(q \bar{\alpha}) /(2 \bar{\alpha}+1)}
$$

where $\tilde{C}$ depend on $A,|B|, \mathbf{r}, \boldsymbol{\alpha}, \delta$ and $\left\|\mathrm{f}_{X}\right\|_{\infty}$.
Thus, even if the control of $\delta$ is less accurate, the projection estimator achieves the optimal rate of convergence whatever the regularity of $\mathrm{f}_{X}$.

## 7. Simulations

In this section we focus on the numerical performances of our estimators. We first describe the algorithms. Then, we introduce the studied examples and we illustrate the performances of our procedures with some figures and tables.

### 7.1. Estimation algorithms

For both methods (kernel or projection), we need a preliminary estimator of $\mathrm{f}_{X}$. In order to obtain an accurate estimator of $\mathrm{f}_{X}$, we use a pointwise Goldenshluger-Lepski procedure which consists in the following for estimating $\mathrm{f}_{X}$ at $x$. This preliminary estimator is constructed using the sample $\left(X_{i}\right)_{i=n+1, \ldots, 2 n}$. Let us define for $h>0$,

where $\tilde{\mathrm{f}}_{X}$ is a preliminary estimator of $\mathrm{f}_{X}$ obtained by the rule of thumb (see Silverman [35]), and $K$ is the classical Gaussian kernel. The value 2.2 is the adjusted tuning constant which was convenient on a set of preliminary simulations. Given $H$ a finite set of bandwidths (actually $H$ is a set of 10 bandwidths centered at the bandwidth obtained by the rule of thumb) and for $h, h^{\prime} \in H$, consider

We consider

\mathrm{A}(h, x):=\max _{h^{\prime} \in H}\left\{\left|\hat{\mathrm{f}}_{h, h^{\prime}}(x)-\hat{\mathrm{f}}_{h^{\prime}}(x)\right|-\operatorname{pen}\left(n, h^{\prime}\right)\right\}_{+}
$$

Finally we define $h_{0}$ by

$$
\begin{equation*}
h_{0}:=\underset{h \in H}{\arg \min }\{\mathrm{~A}(h, x)+\operatorname{pen}(n, h)\} \tag{7.2}
\end{equation*}
$$

and we consider the following procedure of estimation: $\hat{\mathrm{f}}_{X}(x)=\hat{\mathrm{f}}_{h_{0}}(x)$.
Now, the algorithm for the kernel estimation of $f$ is entirely described in Section 4.2 and we perform it with $K$ the Gaussian kernel and a set of 10 bandwidths in each direction, that means that the size of $\mathcal{H}_{n}$ is $10^{d_{1}+d_{2}}$. The quantity $\left\|\hat{f}_{h^{\prime}}-\hat{f}_{h, h^{\prime}}\right\|_{x, 2}$ is made easy to compute with some preliminary theoretical computations (in particular, note that for the Gaussian kernel $K_{h} * K_{h}^{\prime}=K_{h^{\prime \prime}}$ with $h^{\prime \prime 2}=h^{2}+h^{\prime 2}$ ). The only remaining parameter to tune is $\eta$ which appears in the penalty term $\sigma$ (see (4.3)).

In the same way, we follow Section 5.2 to implement the projection estimator. Matrix computations are easy to implement and make the implementation very fast. We only present the case of polynomials with degrees $r=s=0$, i.e. histograms, since the performance is already good in this case. Again, the only remaining parameter to tune is $\eta$ which appears in the penalty term $\sigma$ (see (5.2)). Note that in the programs, it is possible to use nonintegers $m_{i}$ and in fact this improves the performance of the estimation. However, to match with the theory we shall not tackle this issue.

### 7.2. Simulation study and analysis

We apply our procedures to different examples of conditional density functions with $d_{1}=d_{2}=1$. More precisely, we observe $\left(X_{i}, Y_{i}\right)_{i=1, \ldots, n}$ such that

Example 1. The $X_{i}$ 's are i.i.d. uniform variables on $[0,1]$ and

Y_{i}=2 X_{i}^{2}+5+\varepsilon_{i}\left(1.3-\left|X_{i}\right|\right)^{1 / 2}, \quad i=1, \ldots, n
$$

where the $\varepsilon_{i}$ 's are i.i.d. reduced and centered Gaussian variables, independent of the $X_{i}$ 's. Note that we also studied heavy-tailed noises in this example (i.e. the $\varepsilon_{i}$ 's are variables with a standard Cauchy distribution) and the results were almost identical.

Example 2. The $X_{i}$ 's are i.i.d. uniform variables on $[0,1]$ and the distribution of the $Y_{i}$ 's is a mixture of a normal distribution and an exponential distribution: $Y_{i} \sim 0.75 \varepsilon_{i}+0.25\left(2+E_{i}\right)$, where $\varepsilon_{i}$ is a zero-mean normal distribution with standard deviation $2+X_{i}$ and $E_{i}$ is exponential with parameter 2.


Fig. 1. Plots of true function $f(x, \cdot)$ (plain line) versus kernel estimator $\hat{f}(x, \cdot)$ (dashed line) and projection estimator $\tilde{f}(x, \cdot)$ (dot-dashed line) in $x=0(n=1000)$ for Example 3 (left) and Example 4 (right).

Example 3. The $X_{i}$ 's are i.i.d. and their common distribution is a mixture of two normal distributions, $0.5 \mathcal{N}(0,1 / 81)+0.5 \mathcal{N}(1,1 / 16)$ and

$$
Y_{i}=X_{i}^{2}+1+\varepsilon_{i}\left(1.3+\left|X_{i}\right|\right)^{1 / 2}, \quad i=1, \ldots, n
$$

where the $\varepsilon_{i}$ 's are i.i.d. reduced and centered Gaussian variables, independent of the $X_{i}$ 's.
Example 4. The $X_{i}$ 's are i.i.d. and their common distribution is a mixture of two normal distributions, $0.5 \mathcal{N}(0,1 / 81)+0.5 \mathcal{N}(1,1 / 16)$ and the distribution of the $Y_{i}$ 's is a mixture of a normal distribution and an exponential distribution: $Y_{i} \sim 0.75 \varepsilon_{i}+0.25\left(2+E_{i}\right)$, where $\varepsilon_{i}$ is a zero-mean normal distribution with standard deviation $2+X_{i}$ and $E_{i}$ is exponential with parameter 2 .

We simulate our observations for three sample sizes: $n=250, n=500$ and $n=1000$. In Figure 1, we illustrate the quality of reconstructions for both estimates when $\mathrm{f}_{X}$ is unknown. We use $\eta=-0.2$ for the projection estimator and $\eta=1$ for the kernel estimator (see the discussion below).

To go further, for each sample size, we evaluate the mean squared error of the estimators, in other words

$$
\operatorname{MSE}(\hat{f})=\int(\hat{f}(x, y)-f(x, y))^{2} \mathrm{~d} y,
$$

where $\hat{f}$ is either the kernel rule or the projection estimate. In Appendix B, we give approximations of the MSE based on $N=100$ samples for different values of $\eta$.

Now, let us comment our results from the point of view of tuning, namely we try to answer the question: how to choose the parameter $\eta$ ? We first focus on kernel rules. Tables of Appendix B show that, often, the optimal value is $\eta=1$. More precisely, it is always the case for Examples 1 and 2 . For Examples 3 and 4 , when $\eta=1$ is not the optimal value, taking $\eta=1$ does not deteriorate the risk too much. So, for kernel rules, the choice $\eta=1$ is recommended even if larger values can be convenient in some situations. To shed more lights on these numerical results, in Figure 2, we draw the MSE for the kernel rule in function of the parameter $\eta$. We observe that the shape of the curve is the same whatever the example. If $\eta$ is too small the risk blows up, which shows that the assumption $\eta>0$ in theoretical results is unavoidable at least asymptotically. Furthermore, we observe that if $\eta$ is too large, then the estimate oversmooths and the risk increases but without explosion for $\eta$ not too far from the minimizer. Similar phenomena have already been observed for wavelet thresholding rules for density estimation (see Section 2.2 of Reynaud-Bouret et al. [32]). Tuning kernel rules is then achieved.


Fig. 2. $\operatorname{MSE}(\hat{f})$ for $n=500$, Example $1(x=0.5)$, Example $2(x=0.5)$, Example $3(x=0)$, Example $4(x=0)$.

We now deal with projection rules. Unfortunately, the plateau phenomenon of Figure 2 does not happen for projection estimators. In this case, the optimal value for $\eta$ seems to change according to the example. Tuning this procedure is not so obvious. Note that performances of kernel and projections rules are hardly comparable since they are respectively based on a Gaussian kernel function and piecewise constant functions.

For kernel rules, we study the influence of the knowledge of $f_{X}$. Tables B. 1 and B. 3 show that when $\mathrm{f}_{X}$ is known results are a bit better as expected, but the difference is not very significant. Since projections rules are less sensitive to the estimate $\hat{\mathrm{f}}_{X}$, we only show results with $\mathrm{f}_{X}$ unknown. Finally, to study the dependence of estimation with respect to $x$, we focus on Tables B. 5 and B. 6 that show that in Example 3 estimation is better at $x=0$ and $x=1$ than at $x=0.36$. This was expected since the density design is smaller at $x=0.36$ and this confirms the role of $\delta$ in the rate of convergence of both estimators (see Theorems 2 and 3). Similar conclusions can be drawn for Example 4. Finally, we wish to mention that the ratio between the risk of our procedures and the oracle risk (the upper bounds of Theorems 1,2 and 3) remains bounded with respect to $n$, which corroborates our theoretical results.

## 8. Proofs

In this section, after giving intermediate technical results, we prove the results of our paper. Most of the time, as explained in Introduction, we only consider the case $d_{1}=d_{2}=1$. We use notations that we have previously defined. The classical Euclidean norm is denoted $\|\cdot\|$. Except if the context is ambiguous, from now on, the $\|\cdot\|_{\infty}$-norm shall denote the supremum either on $\mathbb{R}$, on $V_{n}(x)$ or on $V_{n}(x) \times \mathbb{R}$. We shall also use for any function $g$

$$
\|g\|_{\infty, 2}:=\sup _{t \in V_{n}(x)}\|g\|_{t, 2}
$$

This section is divided into two parts: Section 8.1 (respectively Section 8.2) is devoted to the proofs of the results for the kernel rules (respectively for the projection rules). We first prove in Section 8.1.1 the lower bound stated in Proposition 1. Main results for kernel rules, namely Theorems 1 and 2 are proved in Section 8.1.2. They depend on several intermediate results that are proved in Sections 8.1.3-8.1.6 (see the sketch of proofs in Section 8.1.2). Theorem 5 that derives rates for kernel rules is proved in Section 8.1.7. For projection rules, the main theorem, namely Theorem 3, is proved in Section 8.2.1. It is based on intermediate results shown in Sections 8.2.2-8.2.4. Finally, Theorem 6 that derives rates for projection rules is proved in Section 8.2.5. As usual in nonparametric statistics, our
results are based on sharp concentration inequalities that are stated in Lemmas 2, 3 and 4. These lemmas and other technical results stated in Lemmas 5 and 6 are proved in Appendix A.

Lemma 2 (Bernstein Inequality). Let $\left(U_{i}\right)$ be a sequence of i.i.d. variables uniformly bounded by a positive constant $c$ and such that $\mathbb{E} U_{1}^{2} \leq v$. Then

Note that Lemma 2 is a simple consequence of Birgé and Massart [7], p. 366.
Lemma 3 (Talagrand Inequality). Let $U_{1}, \ldots, U_{n}$ be i.i.d. random variables and $v_{n}(a)=\frac{1}{n} \sum_{i=1}^{n}\left[\tau_{a}\left(U_{i}\right)-\right.$ $\left.\mathbb{E}\left(\tau_{a}\left(U_{i}\right)\right)\right]$ for a belonging to $\mathcal{A}$ a countable subset of functions. For any $\zeta>0$,

Let $\rho>1$ and consider the event

\chi_{1}=(1+\eta)\|K\|_{1}\|K\|_{2}, \quad \chi_{2}=(1+\eta)\|K\|_{2} .
$$

We shall use following propositions that deal with the general case when $\mathrm{f}_{X}$ is estimated by $\hat{\mathrm{f}}_{X}$. When $\mathrm{f}_{X}$ is known, it can easily be checked that these propositions also hold with $g$ replaced by $f$ and $\hat{\delta}$ by $\delta$. We also use the set $\Lambda_{\rho}$ studied in Lemma 4 with $\rho=(1+\eta / 2)^{2}$.

Let us give a sketch of the proof. The main steps for proving Theorems 1 and 2 are the following. We first prove an oracle inequality for the function $g$ on the set $\Gamma$ (Proposition 2). Then, in Proposition 3, we prove that the event $\Gamma$ occurs with large probability by using Lemma 3. Finally, Proposition 4 studies the impact of replacing $g$ by $f$. Proposition 5 gives a polynomial control in $n$ of our estimate that is enough to control its risk on $\Gamma^{c}$ by using Proposition 3 and Lemma 4.

Proposition 2. On the set $\Gamma$, we have the following result.

Proposition 3. Under $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{3}\right)$ and $(\mathrm{CK})$, we have:

Proposition 5. Assume that (CK) is satisfied. For any $h \in \mathcal{H}_{n}$,

The first part of Theorem 1 can be deduced from Propositions 2 and 3. Note that in the case of Theorem 1, since $\mathrm{f}_{X}$ is known, $g=f$ and $\mathbb{P}\left(\Lambda_{\rho}\right)=1$. The second part of Theorem 1 is a consequence of Proposition 5, (3.1) and (4.5). Since

the first part of Theorem 2 is a consequence of Propositions 2, 3 and 4 combined with Lemma 4. The second part of Theorem 2 is a consequence of Proposition 5, (3.1) and (4.7).

We apply the GLM as explained in Section 2 with $\hat{f_{h}}$ given in (4.2) for estimating $g, \mathcal{M}_{n}=\mathcal{H}_{n},\|\cdot\|=\|\cdot\|_{x, 2}$, $\sigma(h)=\chi / \sqrt{\hat{\delta} n h_{1} h_{2}}$, and the operator $\mathcal{K}_{h}$ is the convolution product with $K_{h}$. Note that (2.1), (2.2) and (2.5) are satisfied but not (2.4). But we have:

But, on $\Gamma, \forall h, h^{\prime} \in \mathcal{H}_{n},\left\|\hat{h}_{h^{\prime}}-\mathcal{K}_{h^{\prime}}(g)\right\|_{x, 2} \leq \chi_{2} / \sqrt{\hat{\delta} n h_{1}^{\prime} h_{2}^{\prime}}$ and $\left\|\mathcal{K}_{h^{\prime}}\left(\hat{f_{h}}\right)-\left(\mathcal{K}_{h^{\prime}} \circ \mathcal{K}_{h}\right)(g)\right\|_{x, 2} \leq \chi_{1} / \sqrt{\hat{\delta} n h_{1}^{\prime} h_{2}^{\prime}}$, so that $\xi(h)=0$. \end{aligned}
$$

with $2 \chi+\chi_{2}=2 \chi_{1}+3 \chi_{2}=(1+\eta)\left(2\|K\|_{1}+3\right)\|K\|_{2}$.

For $\left(h_{1}^{\prime}, h_{2}^{\prime}\right) \in \mathcal{H}_{n}, \frac{(\log n)^{3}}{\rho n} \leq \frac{(\log n)^{3}}{\rho \delta n} \leq \frac{(\log n)^{3}}{\hat{\delta} n} \leq h_{1}^{\prime}<1$ and $\frac{1}{n} \leq h_{2}^{\prime}<\frac{1}{(\log n)^{2}-1}$. So, $-\sqrt{n h_{1}^{\prime} \hat{\delta}} \leq-(\log n)^{3 / 2}$ and $-\frac{1}{h_{2}^{\prime}}<-(\log n)^{2}+1$. Therefore, on $\Lambda_{\rho}$,

\sum_{h, h^{\prime} \in \mathcal{H}_{n}} \tilde{\mathbb{P}}\left(\left\|\hat{f}_{h, h^{\prime}}-\tilde{\mathbb{E}}\left[\hat{f}_{h, h^{\prime}}\right]\right\|_{x, 2} \geq(1+\eta) \frac{\|K\|_{1}\|K\|_{2}}{\sqrt{\hat{\delta} n h_{1}^{\prime} h_{2}^{\prime}}}\right) & \leq \rho^{2} n^{4} \mathrm{e}^{-C_{5}\left(K, \eta,\|f\|_{\infty}\right)(\log n)^{3 / 2}} \\
& \leq C_{6}\left(K, \eta,\|f\|_{\infty}\right) \mathrm{e}^{-(\log n)^{5 / 4}} \tag{8.4}
\end{align*}
$$

with $C_{5}\left(K, \eta,\|f\|_{\infty}\right)$ and $C_{6}\left(K, \eta,\|f\|_{\infty}\right)$ positive constants depending on $K, \eta$ and $\|f\|_{\infty}$. We have a similar result for $\sum_{h^{\prime} \in \mathcal{H}_{n}} \tilde{\mathbb{P}}\left(\left\|\hat{f}_{h^{\prime}}-\tilde{\mathbb{E}}\left[\hat{f}_{h^{\prime}}\right]\right\|_{x, 2} \geq(1+\eta) \frac{\|K\|_{2}}{\sqrt{\hat{\delta} n h_{1}^{\prime} h_{2}^{\prime}}}\right)$. & \leq n(\log n)^{-6}\left\|K^{(1)}\right\|_{\infty}^{2} \sum_{i=1}^{n} \int \frac{1}{h_{2}^{2}}\left|K^{(2)}\left(\frac{y-Y_{i}}{h_{2}}\right)\right|^{2} \mathrm{~d} y \\
& \leq n^{3}(\log n)^{-6}\left\|K^{(1)}\right\|_{\infty}^{2}\left\|K^{(2)}\right\|_{2}^{2},

& \quad+\iint K(u, v)\left[\frac{\left(-v h_{2}\right)^{\left\lfloor\alpha_{2}\right\rfloor}}{\left\lfloor\alpha_{2}\right\rfloor!}\left(\frac{\mathrm{d}^{\left\lfloor\alpha_{2}\right\rfloor}}{\mathrm{d} y^{\left\lfloor\alpha_{2}\right\rfloor}} f\left(x, y+\tilde{v} h_{2}\right)-\frac{\mathrm{d}^{\left\lfloor\alpha_{2}\right\rfloor}}{\mathrm{d} y^{\left\lfloor\alpha_{2}\right\rfloor}} f(x, y)\right)\right] \mathrm{d} u \mathrm{~d} v,

using $\left(\mathrm{H}_{4}\right)$ and where $C$ is a positive constant that does not depend on $\delta, n$ and $\mathbf{L}$. By using Theorem 2 , this concludes the proof of Theorem 5 .

### 8.2. Proofs for the projection estimator

The structure of the proof of the main theorem, namely Theorem 3, is similar to the structure of the proofs for kernel rules. It is detailed along Section 8.2.1.

As already explained in Section 2, we introduce $\tilde{\mathcal{K}}_{m}\left(\hat{f}_{m^{\prime}}\right)=\hat{f}_{m \wedge m^{\prime}}$ and

The heart of the proof of Theorem 3 is the following concentration result:
Proposition 6. Assume that assumptions $\left(\mathrm{H}_{1}\right),\left(\mathrm{H}_{2}\right),\left(\mathrm{H}_{3}\right)$ and $(\mathrm{CM})$ are satisfied. There exists $C>0$ only depending on $\eta, \phi_{1}, \phi_{2}, r,\|f\|_{\infty}$ and $\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $\delta$ such that

& \leq \tilde{C}_{4}\left(\sup _{t \in V_{n}(x)}\left\|f-\mathcal{K}_{m}(f)\right\|_{t, 2}+\sqrt{\frac{\left\|\mathbf{f}_{X}\right\|_{\infty}}{\delta}} \sqrt{\frac{D_{m_{1}} D_{m_{2}}}{\delta n}}\right)^{q}+\tilde{C}_{3}^{q} n^{2 q} \mathbb{P}\left(\left(\Gamma \cap \Lambda_{\rho} \cap \Omega_{\rho}\right)^{c}\right),
\end{aligned}
$$

where $\tilde{C}_{4}$ depends on $\eta, \phi_{1}, \phi_{2}, r,\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $\delta$. Using (8.8), this concludes the proof of Theorem 3.

Now, let us begin the proof of Proposition 6. Since

we deduce

\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\|_{x, 2}^{2} & =\sum_{k}\left(\sum_{d}\left(\hat{a}_{d, k}-a_{d, k}\right) \varphi_{d}(x)\right)^{2} \leq \sum_{d} \varphi_{d}^{2}(x) \sum_{k} \sum_{d}\left(\hat{a}_{d, k}-a_{d, k}\right)^{2} \\
& \leq \phi_{1} D_{m_{1}}\|\hat{A}-A\|_{F}^{2} .
\end{aligned}
$$

On $\Lambda_{\rho}, \delta \geq \rho^{-1} \hat{\delta}$. Then, using (8.10), on $\Omega_{\rho} \cap \Lambda_{\rho}, \min (\operatorname{Sp}(\hat{G})) \geq \rho^{-2} \hat{\delta}=(1+\eta)^{-2 / 5} \hat{\delta}$, so we are in the case where $\hat{A}=\hat{G}^{-1} \hat{Z}$. From now on, we always assume that we are on $\Omega_{\rho} \cap \Lambda_{\rho}$. We have:

Since $\hat{G}$ is symmetric, $\left\|\hat{G}^{-1}\right\|_{2}$ is equal to the spectral radius of $\hat{G}^{-1}$. And, using (8.10), its eigenvalues are positive, then

\left\|\hat{G}^{-1}-G^{-1}\right\|_{2}=\left\|\hat{G}^{-1}(G-\hat{G}) G^{-1}\right\|_{2} \leq \rho \delta^{-2}\|G-\hat{G}\|_{2} \leq \rho \delta^{-2}\|G-\hat{G}\|_{F} .
$$

Thus

\|\hat{A}-A\|_{F} \leq \rho \delta^{-2}\|G-\hat{G}\|_{F}\|Z\|_{F}+\rho \delta^{-1}\|\hat{Z}-Z\|_{F}
$$

Moreover, since for any function $s, \sum_{d}\left\langle s, \varphi_{d}\right\rangle^{2} \leq \int_{I_{l}} s^{2}(u) \mathrm{d} u$, where $\langle\cdot, \cdot\rangle$ denotes the standard $\mathbb{L}_{2}$ dot product,

\begin{aligned}
\|Z\|_{F}^{2} & =\sum_{d=0}^{r} \sum_{k \in K_{m}}\left\langle\int \varphi_{d}(u) f(u, \cdot) \mathrm{f}_{X}(u) \mathrm{d} u, \psi_{k}\right)^{2} \\
& \leq \sum_{d=0}^{r} \int\left(\int \varphi_{d}(u) f(u, y) \mathrm{f}_{X}(u) \mathrm{d} u\right)^{2} \mathrm{~d} y \\
& \leq \iint_{I_{l}} f^{2}(u, y) \mathrm{f}_{X}^{2}(u) \mathrm{d} u \mathrm{~d} y \leq\left\|\mathrm{f}_{X}\right\|_{\infty}^{2}\|f\|_{\infty}\left(4 A 2^{-m_{1}}\right) .
\end{aligned}
$$

Finally (still on $\Omega_{\rho} \cap \Lambda_{\rho}$ ),

$$
\left\|\hat{f}_{m}-\mathcal{K}_{m}(f)\right\|_{x, 2} \leq C_{3}\|\hat{G}-G\|_{F}+\rho \delta^{-1} \sqrt{\phi_{1} D_{m_{1}}}\|\hat{Z}-Z\|_{F} .
$$

Here $C_{3}=\left\|\mathrm{f}_{X}\right\|_{\infty} \rho \delta^{-2}(r+1) \sqrt{\|f\|_{\infty}}$. Thus, with $\mathbb{P}_{\rho}(\cdot)=\mathbb{P}\left(\cdot \cap \Lambda_{\rho} \cap \Omega_{\rho}\right)$, we can write:

P_{2, m}=\mathbb{P}_{\rho}\left(\|\hat{G}-G\|_{F} \geq \frac{\sigma(m)}{2 \rho C_{3}}(\rho-1)\right) .
\end{array}\right.
$$

[1] Study of $P_{1, m}$ : Let $v_{n}(t)=\frac{1}{n} \sum_{i=1}^{n} t\left(X_{i}, Y_{i}\right)-\mathbb{E}\left(t\left(X_{i}, Y_{i}\right)\right)$ and

$$
S_{m}^{(l)}=F_{m_{1}}^{(l)} \otimes H_{m_{2}}=\left\{t, t(x, y)=\sum_{d=0}^{r} \sum_{k \in K_{m}} b_{d, k} \varphi_{d}(x) \psi_{k}(y), b_{d, k} \in \mathbb{R}\right\} .
$$

Then,

$$
\sup _{t \in S_{m}^{(l)},\|t\|_{2} \leq 1}\left|v_{n}(t)\right|^{2}=\sum_{d, k}\left|v_{n}\left(\varphi_{d} \otimes \psi_{k}\right)\right|^{2}=\sum_{d, k}\left|\frac{1}{n} \sum_{i=1}^{n} \varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)-\mathbb{E}\left(\varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)\right)\right|^{2}=\|\hat{Z}-Z\|_{F}^{2} .
$$

We are reduced to bound:

$$
\mathbb{P}_{\rho}\left(\sup _{t \in S_{m}^{(l)},\|t\|_{2} \leq 1}\left|v_{n}(t)\right| \geq \frac{\sigma(m)}{2 \rho^{2} \delta^{-1} \sqrt{\phi_{1} D_{m_{1}}}}\right) .
$$

To deal with this term, we use Lemma 3. So, we consider $\mathcal{A}$ a dense subset of $\left\{t \in S_{m}^{(l)},\|t\|_{2} \leq 1\right\}$ and we compute $M, H$ and $v$.

- First, if $t=\sum_{d, k} b_{d k} \varphi_{d} \otimes \psi_{k}$ then

\operatorname{Var}\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)\right)=\frac{1}{n} \operatorname{Var}\left(\varphi_{d}\left(X_{1}\right) \psi_{k}\left(Y_{1}\right)\right) .
$$

We deduce:

\begin{aligned}
\sum_{k} \mathbb{E}\left|\frac{1}{n} \sum_{i=1}^{n} \varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)-\mathbb{E}\left(\varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)\right)\right|^{2} & \leq \frac{1}{n} \iint \varphi_{d}^{2}(u) \sum_{k} \psi_{k}^{2}(v) \mathrm{f}_{X}(u) f(u, v) \mathrm{d} u \mathrm{~d} v \\
& \leq \frac{\phi_{2} D_{m_{2}}}{n} \int \varphi_{d}^{2}(u) \mathrm{f}_{X}(u)\left(\int f(u, v) \mathrm{d} v\right) \mathrm{d} u \\
& \leq \frac{\phi_{2} D_{m_{2}}}{n}\left\|\mathrm{f}_{X}\right\|_{\infty} .
\end{aligned}
$$

Hence,

\mathbb{E} \sup _{t \in \mathcal{A}} v_{n}^{2}(t) \leq(r+1)\left\|\mathrm{f}_{X}\right\|_{\infty} \frac{\phi_{2} D_{m_{2}}}{n}

so that we can take $H^{2}=(r+1)\left\|\mathrm{f}_{X}\right\|_{\infty} \phi_{2} D_{m_{2}} / n$.

- Thirdly

\operatorname{Var}\left(t\left(X_{1}, Y_{1}\right)\right) & \leq \mathbb{E}\left|t\left(X_{1}, Y_{1}\right)\right|^{2} \\
& \leq \iint t^{2}(u, v) \mathrm{f}_{X}(u) f(u, v) \mathrm{d} u \mathrm{~d} v \\
& \leq\|t\|_{2}^{2}\|f\|_{\infty}\left\|\mathrm{f}_{X}\right\|_{\infty}
\end{aligned}
$$

and then we can take $v=\|f\|_{\infty}\left\|\mathrm{f}_{X}\right\|_{\infty}$.

Finally

$$
\begin{aligned}
& \frac{\zeta^{2} n H^{2}}{6 v}=\frac{\zeta^{2}(r+1) \phi_{2}}{6\|f\|_{\infty}} D_{m_{2}} \\
& \frac{\min (\zeta, 1) \zeta n H}{21 M}=\frac{\min (\zeta, 1) \zeta \sqrt{(r+1)\left\|f_{X}\right\|_{\infty}}}{21 \sqrt{\phi_{1}}} \sqrt{\frac{n}{D_{m_{1}}}}
\end{aligned}
$$

According to condition $(\mathrm{CM})$, on $\Lambda_{\rho}$, since $\delta \leq 1, D_{m_{1}} \leq \rho n /(\log n)^{3}$ and $D_{m_{2}} \geq(\log n)^{2}$. Thus Talagrand's Inequality gives

\mathbb{P}_{\rho}\left[\sup _{t \in \mathcal{A}}\left|v_{n}(t)\right| \geq(1+2 \zeta) H\right] \leq 2 \exp \left(-C \log ^{3 / 2}(n)\right)

with $C$ only depending on $\eta, \zeta, r, \phi_{1}, \phi_{2},\|f\|_{\infty},\left\|\mathrm{f}_{X}\right\|_{\infty}$. Moreover,

(1+2 \zeta) H=(1+2 \zeta) \sqrt{(r+1)\left\|\mathrm{f}_{X}\right\|_{\infty} \phi_{2}} \sqrt{\frac{D_{m_{2}}}{n}}
$$

and, since $\delta>\rho^{-1} \hat{\delta}$ and $\widehat{\left\|\mathrm{f}_{X}\right\|_{\infty}}>\rho^{-2}\left\|\mathrm{f}_{X}\right\|_{\infty}$ on $\Lambda_{\rho}$,

$$
\frac{\sigma(m)}{2 \rho^{2} \delta^{-1} \sqrt{\phi_{1} D_{m_{1}}}} \geq \rho^{-4}(1+\eta) \sqrt{(r+1)\left\|\mathrm{f}_{X}\right\|_{\infty} \phi_{2}} \sqrt{\frac{D_{m_{2}}}{n}}
$$

Then, since $\rho^{5}=1+\eta$, choosing $\zeta$ such that $1+2 \zeta=\rho$ gives

\frac{\sigma(m)}{2 \rho^{2} \delta^{-1} \sqrt{\phi_{1} D_{m_{1}}}} \geq(1+2 \zeta) H
$$

and then

P_{1, m} \leq 2 \exp \left(-C \log ^{3 / 2}(n)\right)

[2] Study of $P_{2, m}$ : We now have to bound (with large probability) the term

If we set $\varepsilon=C_{4} \sqrt{\frac{D_{m_{1}} D_{m_{2}}}{n}}$, with $C_{4}=(\rho-1)(1+\eta) \sqrt{\phi_{1} \phi_{2}\left\|\mathrm{f}_{X}\right\|_{\infty}} /\left(\rho^{3} C_{3} \delta \sqrt{r+1}\right)$ then, on $\Lambda_{\rho}$,

\varepsilon \leq \frac{(\rho-1) \sigma(m)}{2 \rho C_{3}(r+1)}
$$

Moreover on $\Lambda_{\rho}$, since $\delta \leq 1$,

\frac{n \varepsilon^{2}}{v} & =\frac{C_{4}^{2}}{\phi_{1}\left\|\mathrm{f}_{X}\right\|_{\infty}} D_{m_{2}} \geq \frac{C_{4}^{2}}{\phi_{1}\left\|\mathrm{f}_{X}\right\|_{\infty}}(\log n)^{2} \\
\frac{n \varepsilon}{c} & =\frac{C_{4}}{\phi_{1}} \sqrt{\frac{n D_{m_{2}}}{D_{m_{1}}}} \geq \frac{C_{4}}{\phi_{1} \sqrt{\rho \delta}}(\log n)^{5 / 2} \geq \frac{C_{4}}{\phi_{1 \sqrt{\rho}}}(\log n)^{5 / 2}
\end{aligned}
$$

Then, using Lemma 2,

\mathbb{P}_{\rho}\left[\|\hat{G}-G\|_{F} \geq(\rho-1) \frac{\sigma(m)}{2 C_{3} \rho}\right] & \leq \sum_{d, d^{\prime}} \mathbb{P}_{\rho}\left(\left|\frac{1}{n} \sum_{i=1}^{n} \varphi_{d} \varphi_{d^{\prime}}\left(X_{i}\right)-\mathbb{E}\left[\varphi_{d} \varphi_{d^{\prime}}\left(X_{i}\right)\right]\right| \geq \frac{(\rho-1) \sigma(m)}{2 \rho C_{3}(r+1)}\right) \\
& \leq 2(r+1)^{2} \exp \left(-C_{5} \log ^{2}(n)\right),
\end{aligned}
$$

with $C_{5}$ only depending on $\eta, r, \phi_{1}, \phi_{2},\|f\|_{\infty},\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $\delta$. Finally, we denote

$$
\overline{\mathcal{M}_{n}}=\left\{\left(m_{1}, m_{2}\right), 2^{m_{1}} \leq \rho \delta n, D_{m_{2}} \leq n\right\}
$$

which verifies $\mathcal{M}_{n} \subset \overline{\mathcal{M}_{n}}$ on $\Lambda_{\rho}$. Gathering all the terms together, we obtain

& \leq \sum_{m \in \overline{\mathcal{M}_{n}}} P_{1, m}+P_{2, m} \\
& \leq \sum_{m \in \overline{\mathcal{M}_{n}}} 4(r+1)^{2} \exp \left(-C_{6} \log ^{3 / 2}(n)\right) \\
& \leq 4(r+1)^{2} \rho \delta n^{2} \exp \left(-C_{6} \log ^{3 / 2}(n)\right),
\end{aligned}
$$

with $C_{6}$ depending on $\eta, r, \phi_{1}, \phi_{2},\|f\|_{\infty},\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $\delta$, which yields Proposition 6.

$$

Under (CM), we have: $k_{n}(r+1) \leq D_{m_{1}} \leq \hat{\delta} n /(\log n)^{3}$, and on $\Lambda_{\rho}$, we have: $2^{m_{1}} \leq \rho \delta n$. Let $\mu_{n}$ be the empirical process defined by

But, for all $t \in F_{m_{1}}^{\left(l_{m_{1}}\right)}$ such that $\|t\|_{X}=1$

\left|\mu_{n}\left(t^{2}\right)\right|^{2} \leq \delta^{-2} \sum_{d, d^{\prime}} \mu_{n}^{2}\left(\varphi_{l_{m_{1}}, d}^{m} \varphi_{l_{m_{1}}, d^{\prime}}^{m}\right) .

Using Lemma 2, we easily prove as in Section 8.2.2 that $\forall m \in \mathcal{M}_{n}$

\mathbb{P}\left(\Omega^{c} \cap \Lambda_{\rho}\right) & \leq \sum_{m_{1}, 2^{m_{1}} \leq \rho \delta n} \mathbb{P}\left(\sum_{d, d^{\prime}} \mu_{n}^{2}\left(\varphi_{l_{m_{1}}, d}^{m} \varphi_{l_{m_{1}}, d^{\prime}}^{m}\right)>\left(\delta\left(1-\rho^{-1}\right)\right)^{2}\right) \\
& \leq \sum_{m_{1}, 2^{m_{1}} \leq \rho \delta n} \sum_{d, d^{\prime}} \mathbb{P}\left(\left|\mu_{n}\left(\varphi_{l_{m_{1}}, d}^{m} \varphi_{l_{m_{1}}, d^{\prime}}^{m}\right)\right|>\delta\left(1-\rho^{-1}\right) /(r+1)\right) \\
& \leq 2(r+1)^{2} \sum_{m_{1}, 2^{m_{1}} \leq \rho \delta n} \exp \left(-K(\log n)^{3}\right) \leq 2(r+1)^{2} \rho \delta n \exp \left(-K \log ^{3}(n)\right),
\end{aligned}
$$

which yields the result.

The elements of $\hat{A}$ are denoted $\left(\hat{a}_{d, k}\right)_{d, k}$ instead of $\left(\hat{a}_{\left(l_{m_{1}}, d\right), k}^{m}\right)_{d, k}$.
If $\operatorname{Sp}(\hat{G}) \geq(1+\eta)^{-2 / 5} \hat{\delta}$ (otherwise $\hat{A}=0$ ),

\left\|\hat{G}^{-1}\right\|_{2}=\rho\left(\hat{G}^{-1}\right)=(\min (\operatorname{Sp}(\hat{G})))^{-1} \leq(1+\eta)^{2 / 5} \hat{\delta}^{-1}
$$

Therefore, we have:

$$
\begin{aligned}
\|\hat{A}\|_{F}^{2} & \leq\left\|\hat{G}^{-1}\right\|_{2}^{2}\|\hat{Z}\|_{F}^{2} \leq(1+\eta)^{4 / 5} \hat{\delta}^{-2} \sum_{d, k}\left|\frac{1}{n} \sum_{i=1}^{n} \varphi_{d}\left(X_{i}\right) \psi_{k}\left(Y_{i}\right)\right|^{2} \\
& \leq(1+\eta)^{4 / 5} \hat{\delta}^{-2} \sum_{d, k} \phi_{1} \phi_{2} D_{m_{1}} D_{m_{2}} \\
& \leq(1+\eta)^{4 / 5} \hat{\delta}^{-2}(r+1) \phi_{1} \phi_{2} D_{m_{1}} D_{m_{2}}^{2} .
\end{aligned}
$$

Finally

$$
\begin{aligned}
\left\|\hat{f}_{m}\right\|_{x, 2}^{2} & =\sum_{k \in K_{m}}\left(\sum_{d=0}^{r} \hat{a}_{d k} \varphi_{d}(x)\right)^{2} \leq\|\hat{A}\|_{F}^{2} \phi_{1} D_{m_{1}} \\
& \leq(1+\eta)^{4 / 5} \hat{\delta}^{-2}(r+1) \phi_{1}^{2} \phi_{2} D_{m_{1}}^{2} D_{m_{2}}^{2} .
\end{aligned}
$$

### 8.2.5. Proof of Theorem 6

We first assume that $d_{1}=d_{2}=1$. We denote $\mathcal{K}_{m}^{1}$ the projection on $F_{m_{1}}$ endowed with the scalar product $(g, h)_{X}=$ $\int g(z) h(z) \mathrm{f}_{X}(z) \mathrm{d} z$, and $\mathcal{K}_{m}^{2}$ the projection on $H_{m_{2}}$ endowed with the usual scalar product $(g, h)_{u s}=\int g(z) h(z) \mathrm{d} z$. The projection $\mathcal{K}_{m}(f)$ can be written for any $u$ and any $y$,

\mathcal{K}_{m}(f)(u, y)=\sum_{k \in K_{m}}\left(f^{1}(u, \cdot), \psi_{k}^{m}\right)_{u s} \psi_{k}^{m}(y)=\mathcal{K}_{m}^{2}\left(f^{1}(u, \cdot)\right)(y),
$$

where $f^{1}(\cdot, y)=\mathcal{K}_{m}^{1}(f(\cdot, y))$. Thus we have the factorization

$$
\left(\mathcal{K}_{m}(f)-f\right)(u, \cdot)=\mathcal{K}_{m}^{2}\left(f^{1}(u, \cdot)-f(u, \cdot)\right)+\mathcal{K}_{m}^{2}(f(u, \cdot))-f(u, \cdot)
$$

and applying Pythagora's theorem

$$
\begin{aligned}
\left\|\mathcal{K}_{m}(f)-f\right\|_{x, 2}^{2} & =\left\|\mathcal{K}_{m}^{2}\left(f^{1}(x, \cdot)-f(x, \cdot)\right)\right\|_{2}^{2}+\left\|\mathcal{K}_{m}^{2}(f(x, \cdot))-f(x, \cdot)\right\|_{2}^{2} \\
& \leq\left\|f^{1}(x, \cdot)-f(x, \cdot)\right\|_{2}^{2}+\left\|\mathcal{K}_{m}^{2}(f(x, \cdot))-f(x, \cdot)\right\|_{2}^{2} .
\end{aligned}
$$

Now, we shall use the following result. Let $\tau$ be a univariate function belonging to the Hölder space $\mathcal{H}_{1}(\alpha, L)$ on a interval with length $b$. If $S$ is the space of piecewise polynomials of degree bounded by $r>\alpha-1$ based on the regular partition with $2^{J}$ pieces, then there exists a constant $C(\alpha, b)$ only depending on $\alpha$ and $b$ such that

$$
d_{\infty}(\tau, S):=\inf _{t \in S}\|t-\tau\|_{\infty} \leq C(\alpha, b) L 2^{-J \alpha}
$$

(see for example Lemma 12 in Barron et al. [2]). Let $\mathcal{K}$ the orthogonal projection on $S$ endowed with some scalar product. We denote

\|\mathcal{K}\| \|=\sup _{t \in \mathbb{L}_{\infty} \backslash\{0\}} \frac{\|\mathcal{K}(t)\|_{\infty}}{\|t\|_{\infty}} .

Then, for all $t \in S$, since $\mathcal{K}(t)=t$,

\|\tau-\mathcal{K}(\tau)\|_{\infty}=\|\tau-t+\mathcal{K}(t-\tau)\|_{\infty} \leq(1+\|\mathcal{K}\|)\|t-\tau\|_{\infty} .
$$

We obtain:

\|\tau-\mathcal{K}(\tau)\|_{\infty} \leq(1+\|\mathcal{K}\| \|) \inf _{t \in S}\|t-\tau\|_{\infty} \leq(1+\|\mathcal{K}\| \|) C(\alpha, b) L 2^{-J \alpha} .
$$

It remains to bound $||\mathcal{K}| \|$ in the following cases.

- Case 1: $S$ is the space of piecewise polynomials of degree bounded by $r_{1}$, endowed with $(\cdot, \cdot)_{X}\left(S=F_{m_{1}}\right.$, $\left.\mathcal{K}=\mathcal{K}_{m}^{1}\right)$. It is sufficient to apply Lemma 6 to the function $\tau(u, y)=t(u) \psi_{k}^{m}(y)$ to obtain $\|\mathcal{K}\|\left\|\leq\left(r_{1}+1\right)\right\| \mathrm{f}_{X} \|_{\infty} \delta^{-1}$.
- Case 2: $S$ is the space of piecewise polynomials of degree bounded by $r_{2}$, endowed with the usual dot product ( $S=H_{m_{2}}, \mathcal{K}=\mathcal{K}_{m}^{2}$ ). Then it is sufficient to apply the previous case with $\mathrm{f}_{X}$ identically equal to 1 , to obtain $\|\mathcal{K}\| \leq$ $\left(r_{2}+1\right)$.

Finally, we have obtained the following result: if $\tau$ is a univariate function belonging to the Hölder space $\mathcal{H}_{1}(\alpha, L)$ then

$$
\begin{aligned}
\left\|\tau-\mathcal{K}_{m}^{1}(\tau)\right\|_{\infty} & \leq C\left(\alpha, A, r_{1},\left\|\mathrm{f}_{X}\right\|_{\infty} / \delta\right) L D_{m_{1}}^{-\alpha}, \\
\left\|\tau-\mathcal{K}_{m}^{2}(\tau)\right\|_{\infty} & \leq C\left(\alpha,|B|, r_{2}\right) L D_{m_{2}}^{-\alpha} .
\end{aligned}
$$

Now $f(x, \cdot)$ belongs to the Hölder space $\mathcal{H}_{1}\left(\alpha_{2}, L_{2}\right)$ then

$$
\left\|\mathcal{K}_{m}^{2}(f(x, \cdot))-f(x, \cdot)\right\|_{\infty} \leq C_{2} L_{2} D_{m_{2}}^{-\alpha_{2}}
$$

with $C_{2}$ depending on $\alpha_{2},|B|$ and $r_{2}$. Moreover, for all $y \in B, f(\cdot, y)$ belongs to the Hölder space $\mathcal{H}_{1}\left(\alpha_{1}, L_{1}\right)$ then

$$
\left|f^{1}(x, y)-f(x, y)\right| \leq\left\|\mathcal{K}_{m}^{1}(f(\cdot, y))-f(\cdot, y)\right\|_{\infty} \leq C_{1}\left(\alpha_{1}, A, r,\left\|\mathrm{f}_{X}\right\|_{\infty} / \delta\right) L_{1} D_{m_{1}}^{-\alpha_{1}}
$$

with $C_{1}$ not depending on $y$. Finally, since the support of $f(x, \cdot), f^{1}(x, \cdot), \mathcal{K}_{m}^{2}(f(x, \cdot))$ is compact, we obtain

$$
\left\|\mathcal{K}_{m}(f)-f\right\|_{x, 2} \leq C_{0}\left(L_{1} D_{m_{1}}^{-\alpha_{1}}+L_{2} D_{m_{2}}^{-\alpha_{2}}\right)
$$

with $C_{0}$ depending on $A,|B|, \mathbf{r}, \alpha_{1}, \alpha_{2}$ and $\left\|\mathrm{f}_{X}\right\|_{\infty}$ and $\delta$. We can easily generalize this result to the case $d_{1}, d_{2} \geq 2$ and we obtain:

$$
\left\|\mathcal{K}_{m}(f)-f\right\|_{x, 2} \leq C \sum_{i=1}^{d} L_{i} 2^{-\alpha_{i} m_{i}}
$$

for $C$ a constant. To conclude, by using Theorem 3, it remains to find ( $m_{1}, \ldots, m_{d}$ ) that minimizes

$$
\left(m_{1}, \ldots, m_{d}\right) \mapsto \sum_{i=1}^{d} L_{i} 2^{-\alpha_{i} m_{i}}+\sqrt{\frac{\prod_{i=1}^{d} 2^{m_{i}}}{\delta n}} .
$$

Solving this minimization problem shows that $2^{m_{i}}$ has to be equal to $L_{i}^{1 / \alpha_{i}} \Delta_{n}^{1 / \alpha_{i}}$ up to a constant and

$$
\Delta_{n}=\left(\prod_{i=1}^{d} L_{i}^{1 / \alpha_{i}}\right)^{-\bar{\alpha} /(2 \bar{\alpha}+1)}(\delta n)^{\bar{\alpha} /(2 \bar{\alpha}+1)}
$$

It gives the result.

## Appendix A: Proofs of technical results

## A.1. Proof of Lemma 3

We apply the Talagrand concentration inequality given in Klein and Rio [31] to the functions $s^{i}(x)=\tau_{a}(x)-$ $\mathbb{E}\left(\tau_{a}\left(U_{i}\right)\right)$ and we obtain

\mathbb{P}\left(\sup _{a \in A}\left|v_{n}(a)\right| \geq H+\lambda\right) \leq 2 \exp \left(-\frac{n \lambda^{2}}{2(v+4 H M)+6 M \lambda}\right) .
$$

Then we modify this inequality following Birgé and Massart [7], Corollary 2, p. 354. It gives

$$
\begin{equation*}
\mathbb{P}\left(\sup _{a \in \mathcal{A}}\left|v_{n}(a)\right| \geq(1+\zeta) H+\lambda\right) \leq 2 \exp \left(-\frac{n}{3} \min \left(\frac{\lambda^{2}}{2 v}, \frac{\min (\zeta, 1) \lambda}{7 M}\right)\right) . \tag{A.1}
\end{equation*}
$$

To conclude, we set $\lambda=\zeta H$.

## A.2. Proof of Lemma 4

The lemma is a consequence of (3.3) used with $\lambda=\rho-1, \lambda=1-\rho^{-1}, \lambda=\rho^{2}-1$ or $\lambda=1-\rho^{-2}$. Indeed, under (3.3), with probability $1-\kappa \exp \left(-(\log n)^{3 / 2}\right)$, for all $t \in V_{n}(x),\left|\mathrm{f}_{X}(t)-\hat{\mathrm{f}}_{X}(t)\right| \leq \lambda\left|\hat{\mathrm{f}}_{X}(t)\right|$, which implies

(1-\lambda)\left|\hat{\mathbf{f}}_{X}(t)\right| \leq\left|\mathrm{f}_{X}(t)\right| \leq(1+\lambda)\left|\hat{\mathrm{f}}_{X}(t)\right|

(1+\lambda)^{-1}\left|\mathrm{f}_{X}(t)\right| \leq\left|\hat{\mathbf{f}}_{X}(t)\right| \leq(1-\lambda)^{-1}\left|\mathrm{f}_{X}(t)\right| .

Thus, with probability $1-\kappa \exp \left(-(\log n)^{3 / 2}\right),(1+\lambda)^{-1} \delta \leq \hat{\delta} \leq(1-\lambda)^{-1} \delta$ and $(1+\lambda)^{-1}\left\|\mathrm{f}_{X}\right\|_{\infty} \leq\left\|\hat{\mathrm{f}}_{X}\right\|_{\infty} \leq$ $(1-\lambda)^{-1}\left\|f_{X}\right\|_{\infty}$.

& =\left\|f_{2}\right\|_{1} \iint\left\|f_{1}(x-u, \cdot)\right\|_{2}^{2}\left|f_{2}(u, v)\right| \mathrm{d} u \mathrm{~d} v \leq \sup _{t \in V_{n}(x)}\left\|f_{1}\right\|_{t, 2}^{2} \times\left\|f_{2}\right\|_{1}^{2} .
\end{aligned}
$$

## A.4. Proof of Lemma 6

Let $l$ the index such that $x$ belongs to the interval $I_{l}$. We denote

\varphi_{d}=\varphi_{l, d}^{m}, \quad \psi_{k}=\psi_{k}^{m}, \quad I(\tau)=\left(\iint \varphi_{d}(u) \psi_{k}(y) \tau(u, y) \mathrm{f}_{X}(u) \mathrm{d} u \mathrm{~d} y\right)_{0 \leq d \leq r, k \in K_{m}}

\mathcal{K}_{m}(\tau)(x, y)=\sum_{k} \sum_{d} b_{d, k} \varphi_{d}(x) \psi_{k}(y) .
$$

Lemma 1 shows that the matrix of coefficients $B=\left(b_{d, k}\right)_{0 \leq d \leq r, k \in K_{m}}$ verifies the equation $G B=I(\tau)$, with

G=\mathbb{E}(\hat{G})=\left(\left\langle\varphi_{d_{1}}, \varphi_{d_{2}}\right\rangle_{X}\right)_{0 \leq d_{1}, d_{2} \leq r} .

\left\|\mathcal{K}_{m}(\tau)\right\|_{x, 2}^{2} & =\sum_{k}\left(\sum_{d} b_{d, k} \varphi_{d}(x)\right)^{2} \leq \sum_{d} \varphi_{d}^{2}(x) \sum_{k} \sum_{d} b_{d, k}^{2} \\
& \leq \phi_{1} D_{m_{1}}\|B\|_{F}^{2} \leq \phi_{1} D_{m_{1}}\left\|G^{-1}\right\|_{2}^{2}\|I(\tau)\|_{F}^{2} \leq \phi_{1} D_{m_{1}} \delta^{-2}\|I(\tau)\|_{F}^{2}
\end{aligned}
$$

Now we denote $\operatorname{Proj}_{H_{m_{2}}}$ the usual $\mathbb{L}_{2}$ orthogonal projection on $H_{m_{2}}$ and $(\cdot, \cdot)_{u s}$ the standard $\mathbb{L}_{2}$ dot product. Notice that for any function $s \in \mathbb{L}_{2}(\mathbb{R}), \sum_{k \in K_{m}}\left(s, \psi_{k}\right)_{u s}^{2}=\int\left|\operatorname{Proj}_{H_{m_{2}}}(s)\right|^{2}(y) \mathrm{d} y \leq \int s^{2}(y) \mathrm{d} y$. Then

\begin{aligned}
\|I(\tau)\|_{F}^{2} & =\sum_{d=0}^{r} \sum_{k \in K_{m}}\left(\int \varphi_{d}(u) \tau(u, \cdot) \mathrm{f}_{X}(u) \mathrm{d} u, \psi_{k}\right)_{u s}^{2} \\
& \leq \sum_{d=0}^{r} \int\left(\int \varphi_{d}(u) \tau(u, y) \mathrm{f}_{X}(u) \mathrm{d} u\right)^{2} \mathrm{~d} y \leq \int\left(\int_{I_{l}} \tau^{2}(u, y) \mathrm{f}_{X}^{2}(u) \mathrm{d} u\right) \mathrm{d} y
\end{aligned}
$$

using that for any function $s, \sum_{d}\left(\int s \varphi_{d}\right)^{2} \leq \int_{I_{l}} s^{2}$. Next, using that $I_{l}$ is an interval with length $4 A(r+1) D_{m_{1}}^{-1}$,

$$
\|I(\tau)\|_{F}^{2} \leq \sup _{t \in I_{l}}\|\tau\|_{t, 2}^{2} \int_{I_{l}} \mathrm{f}_{X}^{2}(u) \mathrm{d} u \leq 4 A(r+1) D_{m_{1}}^{-1}\left\|\mathrm{f}_{X}\right\|_{\infty}^{2} \sup _{t \in I_{l}}\|\tau\|_{t, 2}^{2} .
$$

Finally

$$
\left\|\mathcal{K}_{m}(\tau)\right\|_{x, 2}^{2} \leq \phi_{1} D_{m_{1}} \delta^{-2} 4 A(r+1) D_{m_{1}}^{-1}\left\|\mathrm{f}_{X}\right\|_{\infty}^{2} \sup _{t \in I_{l}}\|\tau\|_{t, 2}^{2} \leq(r+1)^{2}\left\|\mathrm{f}_{X}\right\|_{\infty}^{2} \delta^{-2} \sup _{t \in V_{n}(x)}\|\tau\|_{t, 2}^{2}
$$

and the lemma is proved.
