INFORMATION FOR AUTHORS

Manuscripts

Manuscripts for publication should be sent to Ms. Linda Kitch, Department of Mathematics, Harvard University, Cambridge, Massachusetts, 02138, U.S.A.

Manuscripts should be written in English, French, German, or Italian, and should be typewritten, double spaced, with generous margins. Diagrams should be drawn with black India ink on glossy white paper.

To eliminate unnecessary delay or difficulties in printing, authors may be guided by the article Manual for authors of mathematical papers, Bull. Amer. Math. Soc. 68 (1962), 429-444.

Footnotes, except a possible acknowledgement of assistance or financial support on the first page, should be avoided by being incorporated into the text, perhaps parenthetically.

The list of references must be in alphabetical-chronological order; abbreviations of names of journals and references to books should follow the standard form established by Mathematical Reviews. The following references are two typical examples:

Proofs

Authors receive only one set of proofs for corrections and will be responsible for the expense of making excessive alterations of the original manuscripts during the proofreading.

Offprints

One hundred offprints with covers are supplied free for each article. In the case of multiple authors, the 100 free offprints will be divided equally among the authors. Additional offprints may be purchased at a reasonable cost.

Electronically Prepared Manuscripts

The Editors of the Journal of Differential Geometry encourage submission of electronically prepared manuscripts in AMS-TEX or AMS-LATEX because properly prepared electronic manuscripts save the author proofreading time and move more quickly through the production process. To this end, there have been prepared "preprint" style files, specifically the amsppt style of AMS-TEX and the amsart style of AMS-LATEX, which will simplify the work of authors and of the production staff. Those authors who make use of these style files from the beginning of the writing process will further reduce their own effort.

Guidelines for Preparing Electronic Manuscripts provides additional assistance and is available for use with either \mathcal{AMS} -TEX or \mathcal{AMS} -LATEX. Electronic manuscripts should be submitted only after the paper has been accepted for publication. Electronically prepared manuscripts (.T_EX files) should be sent via e-mail to pub-submit@math.ams.org (Internet) or on diskettes to the Publications Department address listed above. When submitting electronic manuscripts please include a message indicating the paper has been accepted for publication in the *Journal of Differential Geometry*.
