Jarmo PULKKINEN, *The Threat of Logical Mathematism: A Study on the Critique of Mathematical Logic in Germany at the Turn of the 20th Century* (Frankfurt am Main/Berlin/Bern/New York/Paris, Vienna, Peter Lang GmbH, 1994). After a survey of German contributions to logic from 1830 to 1920 against the background of German academic philosophy, the author examines the reception of mathematical logic in Germany from 1880 to 1920 and the interrelations between logic and psychology, logic and linguistics, and logic and mathematics as viewed in German philosophy in this period. Particular attention is focused on the critiques of mathematical logic by Fritz Mauthner, Heinrich Rickert, and Theodor Ziehen.
