## Information for Authors

Main languages of publication are English, French, German, and Russian. Contributions in Dutch, Italian, Polish, or Spanish are also accepted. In exceptional cases, contributions may also be accepted in Bulgarian, Hungarian, Portuguese or Serbo-Croatian. Please submit contributions to the most appropriate editorial board member (for areas of specialization and languages in which each board member will accept papers, refer to the Editorial Board Membership listing on the masthead).

All contributions will be refereed. Copies of the referees' comments will be forwarded to the author along with the Editor's decision. Our policy is to provide a source for the most expeditious publication possible at the lowest possible cost to subscribers of papers of high scholarly quality. This places the primary duty for the careful preparation of manuscripts upon the individual authors. We therefore request that authors submit camera-ready contributions in hard copy (paper, in triplicate) or in electronic form with a back-up hard copy. Authors are also responsible for the careful proofreading of their own work, as editorial board members and referees are neither required nor expected to act as proofreaders or typesetters, and editors may return to the author any paper requiring editorial corrections.

## Guidelines for Preparation of Manuscripts.

General formatting instructions. Reproduction of manuscripts by a photographic process using an optical scanner and a multilingual optical character recognition program makes it essential that all contributions, and especially those submitted in hard copy (paper), be prepared with a printed area not exceeding $15.25 \times 23 \mathrm{~cm}$. ( $6 \times 9$ inches), with left- and right-hand margins of 4 cm . ( $1^{1 / 2}$ inches) and top and bottom margins being at least 2.5 cm . ( 1 inch ). Text should be $1 \frac{1}{2}$ or doublespaced, using 14-point type if available; a serif typeface is preferable. Pages should not be permanently numbered by the authors, since pagination will be provided by the journal; instead, authors should write page numbers in pencil only on the blank verso of their manuscript. Manuscripts which do not meet these guidelines or are otherwise unsuitable for reproduction may in some cases require that manuscripts be returned to their authors for formatting.

For the transliteration of the Cyrillic alphabet, we have adopted the current system in use by Mathematical Reviews as the general rule. Exceptions are made only in the case of names which have already attained a common accepted transliteration (e.g. Lobachevsky rather than Lobachevskij, Lobatchewsky, etc.) or the person owning the name has selected a preferred transliteration (e.g. Khinchin or Khinchine, not Hinchin, for Хинчин, Zhegalkin or Gegalkine for Жегалкин, Mints rather than Minc for Murm). Use the author's own transliteration for works written in French English, German, etc., e.g. Alexandroff for Alexandroff \& Hopf's Topologie but Aleksandrov otherwise. Transliterations requiring use of diacritical marks should be avoided whenever possible.

Authors having access to any version of $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ are requested to submit the final versions of their paper typeset in $\mathrm{T}_{\mathrm{E}} \mathrm{X}$ and printed, where possible, on a laser printer.

Authors unable to prepare their own camera-ready copy may request Modern Logic Publishing to do so for them at a cost of US $\$ 10.00$ per page. In that case, Modern Logic Publishing can ordinarily undertake only necessary formatting changes and the correction of grammatical and spelling errors.

Cover page. The first page of articles must include the title of the paper, author's name, mailing address (and institutional affiliation), an abstract or descriptive summary (not longer than one page) written in one or more of the journal's primary languages, preferably English, French, German, or Russian, and the appropriate AMS (MOS) 1991 subject classifications.

Footnotes and references. Cited references at the end of the review should be listed alphabetically by author and year. Complete bibliographic information must also include place of publi-
