# ON THE STRUCTURE OF SOLUTIONS OF ERGODIC TYPE BELLMAN EQUATION RELATED TO RISK-SENSITIVE CONTROL

#### Abstract

Bellman equations of ergodic type related to risk-sensitive control are considered. We treat the case that the nonlinear term is positive quadratic form on first-order partial derivatives of solution, which includes linear exponential quadratic Gaussian control problem. In this paper we prove that the equation in general has multiple solutions. We shall specify the set of all the classical solutions and classify the solutions by a global behavior of the diffusion process associated with the given solution. The solution associated with ergodic diffusion process plays particular role. We shall also prove the uniqueness of such solution. Furthermore, the solution which gives us ergodicity is stable under perturbation of coefficients. Finally, we have a representation result for the solution corresponding to the ergodic diffusion.


1. Introduction. We consider the following nonlinear partial differential equation:

or equivalently

\frac{1}{2} a^{i j} D_{i j} W+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W+\tilde{b} \cdot \nabla W+V & =\Lambda,  \tag{1.2}\\
\tilde{b}^{i}(x) & \equiv b^{i}(x)+\frac{1}{2} D_{j} a^{i j}(x),
\end{align*}

where $a(x)=\left[a^{i j}(x)\right], \quad \hat{a}(x)=\left[\hat{a}^{i j}(x)\right]$ are symmetric matrices, $b(x)=\left(b^{1}(x), \ldots, b^{N}(x)\right)$ is a mapping of $\mathbb{R}^{N}$ into $\mathbb{R}^{N}$, and $V(x)$ is a function on $\mathbb{R}^{N}$. Here we utilize the notation $D_{i j}=\partial^{2} / \partial x_{i} \partial x_{j}, D_{i}=\partial / \partial x_{i}$ and the summation convention for multiple indexes. We think of a pair ( $W, \Lambda$ ) of function $W(x)$ and constant $\Lambda$ as a solution of (1.1). Equation (1.1) is called an ergodic type Bellman equation. Such equations have been treated in ergodic control problems (cf. [1]). In ergodic control problems, $\hat{a}$ is negative-definite and more general forms of (1.1) have been studied under rather general conditions (cf. [2]). On the other hand, (1.1) also appears in risk-sensitive problems in infinite time horizon

[^0]and has been studied under certain conditions (cf. [10, 13, 14, 20]). One of the main features of (1.1) in risk-sensitive control is that $\hat{a}$ might be indefinite. Indeed, the following equation is studied in a risk-sensitive control problem (see [10]):

where $f: \mathbb{R}^{N} \times Z \rightarrow \mathbb{R}^{N}, L: \mathbb{R}^{N} \times Z \rightarrow \mathbb{R}, Z$ is a Borel subset in $\mathbb{R}^{M}$ and $\theta$ is a constant in $\mathbb{R} \backslash\{0\}$ which is called a risk-sensitive parameter. Equation (1.3) is considered to characterize a logarithm-exponential type criterion per unit time on infinite time:

where $\left\{X_{t}\right\}$ is a controlled diffusion process satisfying

d X_{t}=f\left(X_{t}, z_{t}\right) d t+\sigma\left(X_{t}\right) d B_{t}, \quad X_{0}=x \in \mathbb{R}^{N}, \quad a^{i j}(x)=\left(\sigma \sigma^{T}\right)^{i j}(x)
$$

$\left\{B_{t}\right\}$ is standard Brownian motion and $\left\{z_{t}\right\}$ is a $Z$-valued process which is considered as a control. The infimum in (1.4) is taken over some class of $\left\{z_{t}\right\}$. In particular, if we take $f(x, z)=b(x)+C(x) z, L(x, z)=V(x)+(1 / 2) z^{T} S(x) z$, $Z=\mathbb{R}^{M}$, where $C(x), S(x)$ are matrices with suitable dimension and $S(x)$ is positive-definite, then (1.3) reads

\frac{1}{2} a^{i j} D_{i j} W+\frac{1}{2}\left(\theta a-C S^{-1} C^{T}\right)^{i j} D_{i} W D_{j} W+b \cdot \nabla W+V=\Lambda
$$

Note that the sign of nonlinear term $\hat{a}=\theta a-C S^{-1} C^{T}$ depends on $\theta$. We also remark that the infimum in (1.3) is attained at $z=-S(x)^{-1} C(x)^{T} \nabla W(x)$. We are concerned with the case that $\theta a-C S^{-1} C^{T}$ is positive-definite since in this paper we shall study the solutions of (1.1) in the case that $\hat{a}$ is positive-definite. Recently, it has also become known that this case happens in some investment problems in mathematical finance (cf. [3, 8, 11, 12, 21]). However, we remark that, unlike these papers, the verification theorem will not be considered in this paper. The verification theorem is to show $\Lambda$ in (1.4) is equal to $\Lambda^{*}$ in Theorem 2.6 and

is a feedback optimal control, $W^{*}$ is a solution corresponding to $\Lambda^{*}$ [ $W^{*}$ is usually unique if $W^{*}(0)=0$ ]. See also [15] for some examples from investment problems. The relation between the drift term $\hat{a} \nabla W^{*}$ in (1.8) for $W=W^{*}$ and $z_{t}^{*}$ as well as its role in the risk-sensitive control problem can be seen from the arguments in [11, 12]. The main merit of our study is to show that multiple solutions exist in general for such equations. We also provide particular solution(s) that is(are) responsible for the verification theorem. We observe that the case when $\theta a-C S^{-1} C^{T}$ is negative-definite can also be treated by considering the equation for $(-W)$. Therefore, according to Theorem 2.6, we have the following interesting observation. Assume $c_{1} \leq a(x) \leq c_{2}$ and $c_{1} \leq C(x) S(x)^{-1} C(x)^{T} \leq c_{2}$ for some
constants $c_{1}, c_{2}>0$. Then for small $\theta>0$, there is $\Lambda^{*}$ (depending on $\theta$ ) such that the above equation has solution if and only if $\Lambda \leq \Lambda^{*}$. For large $\theta>0$, there is $\Lambda^{*}$ (depending on $\theta$ ) such that the above equation has solution if and only if $\Lambda \geq \Lambda^{*}$. In a risk-sensitive control problem, it is more interesting to assume $V(x) \rightarrow \infty$ as $|x| \rightarrow \infty$. In this case, it may happen that $\Lambda^{*}=\infty$ for large $\theta$. See some discussion in [20].

As we mentioned in the above, the studies of solutions for Bellman equations from an analytical point of view are considered to be fundamental to determine an optimal control. Note that solutions of (1.1) have ambiguity of additive constant, that is, if $(W, \Lambda)$ is a solution of (1.1), $W(x)+c$ still satisfies (1.1) for each constant $c$. As some examples show, it is known that (1.1) has multiple solutions even if we identify the solutions up to additive constants. So, it is important to study how we pick up a particular solution of (1.1) which gives an optimal control for the problems at hand. A common way to obtain a particular solution for ergodic type Bellman equations is to study the discounted type equations. The discounted type Bellman equation corresponding to (1.1) is as follows:

\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{\alpha}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{\alpha} D_{j} W_{\alpha}+b \cdot \nabla W_{\alpha}+V=\alpha W_{\alpha}
$$

$\alpha>0$ is called a discount factor. Under certain conditions, it is shown that $W_{\alpha}(x)-W_{\alpha}\left(x_{0}\right)$ normalized at some point $x_{0} \in \mathbb{R}^{N}$ and $\alpha W_{\alpha}$ converge to some function $W(x)$ and some constant $\Lambda$, respectively. Furthermore $(W, \Lambda)$ satisfies (1.1) (cf. [10, 13, 14]). Under the conditions including the linear exponential quadratic Gaussian (LEQG) control problem, we need to consider the case that $b(x)$ [resp. $V(x)$ ] is at most linearly growing (resp. quadratically growing). Under such settings, $W$ is characterized to meet some growth condition and $(W, \Lambda)$ obtained by this procedure is considered to be the right solution (cf. [13, 14]).

In the present paper we directly tackle (1.1) without the procedure using the discounted type equation under the conditions including the LEQG case. We shall specify the set of $\Lambda$ for which (1.1) has a smooth solution. Furthermore we shall characterize the set of $\Lambda$ by noting the global behavior of diffusion process which is related to some control problem.

To explain how we relate (1.1) to a control problem, we shall give a control interpretation to (1.1). Let ( $\Omega, \mathcal{F}, P,\left\{\mathcal{F}_{t}\right\}$ ) be a probability space with filtration. Consider the following controlled stochastic differential equation (SDE):

d X_{t}=\left(\tilde{b}\left(X_{t}\right)+u_{t}\right) d t+\sigma\left(X_{t}\right) d B_{t}, \quad X_{0}=x \in \mathbb{R}^{N}, \sigma(x) \equiv a(x)^{1 / 2}
$$

where $\left\{B_{t}\right\}$ is $N$-dimensional $\left\{\mathcal{F}_{t}\right\}$-Brownian motion and $\left\{u_{t}\right\}$ is an $\left\{\mathcal{F}_{t}\right\}$-progressively measurable process taking its value in $\mathbb{R}^{N} .\left\{u_{t}\right\}$ is considered as control process. We define the value function as follows:

v(t, x)=\sup _{u .} E_{x}\left[\int_{0}^{T-t}\left(V\left(X_{s}\right)-\frac{1}{2} \hat{a}_{i j}^{-1}\left(X_{s}\right) u_{s}^{i} u_{s}^{j}\right) d s\right],

where $\hat{a}_{i j}^{-1}$ is the $(i, j)$-component in inverse of $\hat{a}$. By using the Bellman principle, we see that $v(t, x)$ satisfies the following equation formally:

\frac{\partial v}{\partial t}+\frac{1}{2} a^{i j} D_{i j} v+\sup _{u \in \mathbb{R}^{N}}\left\{(\tilde{b}(x)+u) \cdot \nabla_{x} v-\frac{1}{2} \hat{a}_{i j}^{-1} u^{i} u^{j}\right\}+V=0
$$

$$
\begin{equation*}
\text { in }(0, T) \times \mathbb{R}^{N}, \tag{1.5}
\end{equation*}
$$

$$
\begin{equation*}
v(T, x)=0, \quad x \in \mathbb{R}^{N} \tag{1.6}
\end{equation*}
$$

Since $\sup _{u \in \mathbb{R}^{N}}\left\{(\tilde{b}+u) \cdot \nabla_{x} v-(1 / 2) \hat{a}_{i j}^{-1} u^{i} u^{j}\right\}=(1 / 2) \hat{a}^{i j} D_{i} v D_{j} v+\tilde{b} \cdot \nabla_{x} v$, (1.5) reduces to the following:

\frac{\partial v}{\partial t}+\frac{1}{2} a^{i j} D_{i j} v+\frac{1}{2} \hat{a}^{i j} D_{i} v D_{j} v+\tilde{b} \cdot \nabla_{x} v+V=0 .
$$

Note that the supremum is attained at $\bar{u}(t, x)=\hat{a}(x) \nabla_{x} v(t, x)$. If $-(\partial v / \partial t)(0, x)$ converges to some constant $\Lambda$ and $v(0, x)-v\left(0, x_{0}\right)$ normalized at some point $x_{0} \in \mathbb{R}^{N}$ converges to some function $W(x)$ as $T \rightarrow \infty$, we have formally the following equation which we shall discuss in this paper:

\frac{1}{2} a^{i j} D_{i j} W+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W+\tilde{b} \cdot \nabla W+V=\Lambda
$$

This is considered to characterize the long-time average cost defined as following:

\Lambda=\sup _{u_{0}} \limsup _{T \rightarrow \infty} \frac{1}{T} E_{x}\left[\int_{0}^{T}\left(V\left(X_{s}\right)-\frac{1}{2} \hat{a}_{i j}^{-1}\left(X_{s}\right) u_{s}^{i} u_{s}^{j}\right) d s\right] . \tag{1.7}
\end{equation*}
$$

Following the Bellman principle, we can expect that $\bar{u}_{t}=\hat{a}\left(X_{t}\right) \nabla W\left(X_{t}\right)$ should be a candidate of optimal control for (1.7), where $\left\{X_{t}\right\}$ is defined by the controlled SDE with $u_{t}=\bar{u}_{t}=\hat{a}\left(X_{t}\right) \nabla W\left(X_{t}\right)$ :

d X_{t}=\left(\tilde{b}\left(X_{t}\right)+\hat{a} \nabla W\left(X_{t}\right)\right) d t+\sigma\left(X_{t}\right) d B_{t}, \quad X_{0}=x \tag{1.8}
\end{equation*}

We shall study the structure of solutions of (1.1) by relating to (1.8) under conditions which include the LEQG case, that is, $b(x)$ [resp. $V(x)$ ] has at most linear growth (resp. quadratic growth).

The paper is organized as follows.
In Section 2 we shall specify the set of $\Lambda$ for which (1.1) has a solution under rather general conditions on $b(x)$ and $V(x)$. Indeed, it is proved that the set of $\Lambda$ is equal to closed half-line $\left[\Lambda^{*}, \infty\right)$ for some $\Lambda^{*} \in(-\infty, \infty)$.

In Section 3 we shall classify $\Lambda$ according to the global property of the diffusion process defined by (1.8). We shall prove that for $\Lambda>\Lambda^{*}$, the diffusion process $\left\{X_{t}\right\}$ in (1.8) corresponding to solution $(W, \Lambda)$ is transient and for $\Lambda=\Lambda^{*},\left\{X_{t}\right\}$ is ergodic. Moreover, we shall show that solution $W(x)$ corresponding to $\Lambda^{*}$ is unique up to additive constant.

We show the structure of solutions in Sections 2 and 3. In Section 4 we shall consider the problem that the structures specified in Sections 2 and 3 are preserved
under the perturbation on coefficients in (1.1). More precisely, consider (1.1) with $a=a_{n}, \hat{a}=\hat{a}_{n}, b=b_{n}, V=V_{n}$ :

\frac{1}{2} D_{i}\left(a_{n}^{i j} D_{j} W_{n}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{n} D_{j} W_{n}+b \cdot \nabla W_{n}+V_{n}=\Lambda_{n} .
$$

In similar ways to Sections 2 and 3 we can find $\left[\Lambda_{n}^{*}, \infty\right.$ ) for (1.1) parameterized by $n$ and solution $W_{n}$ corresponding to $\Lambda_{n}^{*}$ is unique. In Section 4 we mainly study the case that $a_{n}=a, \hat{a}_{n}=\hat{a}, b_{n}=b$, independent of $n$, and shall show that if $V_{n}$ converges to $V, \Lambda_{n}^{*}$ converges to $\Lambda^{*}$ and unique solution $W_{n}$ corresponding to $\Lambda_{n}^{*}$ converges to unique solution corresponding to $\Lambda^{*}$.

In Section 5 we shall study the representation for $\Lambda^{*}$. To obtain the representation result, we consider perturbation on $V$ and notice the dependence on $V$ for $\Lambda^{*}$. By using the representation, we can prove the moment condition for invariant measure of the ergodic diffusion process in (1.8) corresponding to $\Lambda^{*}$.

Last, we mention the connection to positive solutions of linear equations. Suppose $a^{i j}(x)=\hat{a}^{i j}(x), i, j=1, \ldots, N$. If we take the transformation $\phi(x) \equiv e^{W(x)}$ in (1.1), we have

\frac{1}{2} a^{i j} D_{i j} \phi+\tilde{b} \cdot \nabla \phi+V \phi=\Lambda \phi \tag{1.9}
\end{equation*}
$$

Thus, in the case that $a^{i j}(x)=\hat{a}^{i j}(x)$, the study of solutions for (1.1) reduces to that of positive solutions for (1.9). We note that the structure of $\Lambda$ specified in this paper is considered to be a generalization in the theory of positive harmonic function for linear differential operators (cf. [22]). Some applications of our results to the evaluation of large time asymptotics of expectations of diffusion processes will be given in [17].
2. Set of $\boldsymbol{\Lambda}$ with solutions. In the present section we shall consider the set of $\Lambda$ for which (1.1) has a classical solution $W$ under rather general conditions. In the next section we shall classify $\Lambda$ by following the global behavior of the diffusion process related to the solution $W$ corresponding to $\Lambda$.

We define the following set:
(2.1) $\mathcal{A} \equiv\{\Lambda$ : there exists smooth function $W$ satisfying (1.1) for $\Lambda\}$.

Under the assumptions given below, we can prove that $\mathcal{A}$ has the following form for some $\Lambda^{*} \in(-\infty, \infty)$ :

$$
\mathcal{A}=\left[\Lambda^{*}, \infty\right) .
$$

For simplicity, we always assume $a^{i j}, \hat{a}^{i j}, b, V$ are sufficiently smooth. We shall give the following assumptions:
(A1) There exist $0<\nu_{1}<\nu_{2}$ such that

\nu_{1}|\xi|^{2} \leq a^{i j}(x) \xi_{i} \xi_{j} \leq \nu_{2}|\xi|^{2} \quad \forall x, \xi \in \mathbb{R}^{N}
$$

(A2) There exist $0<\mu_{1}<\mu_{2}$ such that

$$
\mu_{1}|\xi|^{2} \leq \hat{a}^{i j}(x) \xi_{i} \xi_{j} \leq \mu_{2}|\xi|^{2} \quad \forall x, \xi \in \mathbb{R}^{N}
$$

(A3) There exists a smooth function $W_{0}(x)$ such that

$$
\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{0}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{0} D_{j} W_{0}+b \cdot \nabla W_{0}+V \rightarrow-\infty \quad \text { as }|x| \rightarrow \infty
$$

REMARK 2.1. Note that it follows from (A1), (A2) that there exist $c, \bar{c}>0$ such that

$$
\begin{equation*}
c a(x) \leq \hat{a}(x) \leq \bar{c} a(x), \quad x \in \mathbb{R}^{N} . \tag{2.2}
\end{equation*}
$$

REMARK 2.2. In the following, we give some interesting examples for (A3).
(a) Assume $a_{i j}(x), \hat{a}_{i j}(x)$ are bounded together with their derivatives. Assume also that there are $c_{0}, r_{0}>0$ such that

b(x) \cdot x \leq-c_{0}|x|^{2}, \quad|x| \geq r_{0}
$$

(b) Assume $a_{i j}(x), \hat{a}_{i j}(x)$ are bounded together with their derivatives. Assume also that there are $c_{0}, r_{0}>0$ such that

$$
b(x) \cdot x \geq c_{0}|x|^{2}, \quad|x| \geq r_{0}
$$

(c) Assume $V(x) \rightarrow-\infty$ as $|x| \rightarrow \infty$.

For (a), we take $W_{0}(x)=c|x|^{2}$ for small $c>0$. For (b), we take $W_{0}(x)=-c|x|^{2}$ for small $c>0$. For (c), we take $W_{0}=0$.

REMARK 2.3. For the purpose of discussion in the present section, we can replace (A3) with the existence of a super solution of (1.1) for some $\Lambda$ to ensure that $\mathcal{A} \neq \varnothing$. We need (A3) to classify $\Lambda$ in the next section. In the following, we show for any $\Lambda$ and $\tilde{R}>0$, we can construct a subsolution of (1.2) in $B_{\tilde{R}}$ with boundary value $W_{0}$ on $\partial B_{\tilde{R}}$, where $B_{\tilde{R}}$ is open ball with radius $\tilde{R}$ centered at 0 . Indeed, we consider linear partial differential equation with Dirichlet boundary condition:

\frac{1}{2} D_{i}\left(a^{i j} D_{j} \tilde{W}_{0}\right)+b \cdot \nabla \tilde{W}_{0}+V & =\Lambda & & \text { in } B_{\tilde{R}} \\
\tilde{W}_{0}(x) & =W_{0}(x) & & \text { on } \partial B_{\tilde{R}}
\end{aligned}
$$

Under (A1) and smoothness of coefficients, we have unique solution $\tilde{W}_{0} \in C^{2, \alpha}\left(B_{\tilde{R}}\right) \cap C\left(\bar{B}_{\tilde{R}}\right)$. By (A2), we have

\frac{1}{2} D_{i}\left(a^{i j} D_{j} \tilde{W}_{0}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} \tilde{W}_{0} D_{j} \tilde{W}_{0}+b \cdot \nabla \tilde{W}_{0}+V \geq \Lambda \quad \text { in } B_{\tilde{R}}
$$

In order to see $\mathcal{A} \neq \varnothing$, consider the following Dirichlet problem:

\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{R}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{R} D_{j} W_{R}+b \cdot \nabla W_{R}+V & =\Lambda & & \text { in } B_{R}  \tag{2.3}\\
W_{R} & =W_{0} & & \text { on } \partial B_{R} \tag{2.4}
\end{align*}
$$

where $B_{R}$ is open ball with radius $R$ centered at 0 and $W_{0}$ is taken from (A3). Note that (2.3) is equivalent to

\frac{1}{2} a^{i j} D_{i j} W_{R}+\frac{1}{2} \hat{a}^{i j} D_{i} W_{R} D_{j} W_{R}+\tilde{b} \cdot \nabla W_{R}+V=\Lambda \quad \text { in } B_{R} \tag{2.5}
\end{equation*}
$$

By (A3), $W_{0}$ satisfies the following inequality for some $\Lambda$ :

\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{0}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{0} D_{j} W_{0}+b \cdot \nabla W_{0}+V \leq \Lambda \quad \text { in } \mathbb{R}^{N}
$$

Also, from Remark 2.3, we see that for $\tilde{R}>R$, there exists a smooth function $\tilde{W}_{0}(x)$ such that

\frac{1}{2} D_{i}\left(a^{i j} D_{j} \tilde{W}_{0}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} \tilde{W}_{0} D_{j} \tilde{W}_{0}+b \cdot \nabla \tilde{W}_{0}+V \geq \Lambda \quad \text { in } B_{\tilde{R}}
$$

Then, under (A1)-(A3), there exists $W_{R} \in C^{2, \alpha}\left(\bar{B}_{R}\right)$ satisfying (2.3) and (2.4) (cf. [18], Chapter 4, Theorem 8.4).

We need a uniform bound for $\nabla W_{R}$ on compact sets to obtain a solution $W$ of (1.1) by sending the radius $R$ to $\infty$. The following gradient estimate is also useful in the later discussions.

LEMMA 2.4. Let $W_{R}$ be a smooth function satisfying (2.3) in $B_{R}$. Under (A1) and (A2), we have for each $r>0$ and $R>2 r$

\sup _{B_{r}}\left|\nabla W_{R}\right|^{2} \leq C_{r}+C \Lambda \tag{2.6}
\end{equation*}
$$

where $C$ is a nonnegative constant independent of $r$ and $R$, and $C_{r}$ is a constant depending only on $r$.

Proof. Equation (1.1) has the nonlinear term similar to those treated in $[13,14]$ and we can follow the same arguments to obtain the gradient estimate. However, we shall give a proof to specify the dependence of $\Lambda$.

We set $W=W_{R}$ for simplicity. By differentiating each side of (2.5) on $x_{k}$, we have

& \quad+D_{k} \tilde{b}^{i} D_{i} W D_{k} W+D_{k} V D_{k} W-\frac{1}{2} a^{i j} D_{k i} W D_{k j} W .
\end{align*}

We note the second-order derivative terms. Then, we have

\leq & \frac{1}{4 \delta}\left(\sum_{i, j}\left|D a^{i j}\right|^{2}\right)|D W|^{2}+\frac{1}{2} D_{k} \hat{a}^{i j} D_{i} W D_{j} W D_{k} W \\
& +D_{k} \tilde{b}^{i} D_{i} W D_{k} W+D_{k} V D_{k} W-\frac{1}{4} a^{i j} D_{k i} W D_{k j} W
\end{aligned}

where $\delta>0$ is a small constant. Indeed, we can take $\delta$ satisfying $\delta<\nu_{1}$. From matrix inequality $(\operatorname{tr} A B)^{2} \leq N \nu_{2}\left(\operatorname{tr} A B^{2}\right)$ where $A, B$ are $N \times N$-symmetric matrices, $A$ is nonnegative-definite and $\nu_{2}$ is the maximum eigenvalue of $A$, we finally obtain the following inequality:

Here and in the proof below, we suppose that $C_{r}$ is constant depending only on $r$ and $C$ is nonnegative constant independent of $r$ and $R$.

Fix arbitrary $\xi \in B_{r}$ and take a cut-off function $\varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ satisfying the following:

where $B_{r}(\xi)$ is open ball with radius $r$ centered at $\xi$. Let $x_{0}$ be a maximum point
of $\varphi G$ in $\bar{B}_{r}(\xi)$. By the maximum principle, we can see

\leq & \varphi\left\{-\frac{1}{2} a^{i j} D_{i j} G-\hat{a}^{i j} D_{i} W D_{j} G-\tilde{b}^{i} D_{i} G\right\} \\
& +C_{r} G+C \varphi^{1 / 2} G^{3 / 2} \quad \text { at } x_{0},
\end{align*}

where we used $0=D(\varphi G)=G D \varphi+\varphi D G$ and (2.10). From (2.5) and (2.9), it is implied that

& \left.\quad-\frac{1}{N \nu_{2}}\left(-\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W-\tilde{b}^{i} D_{i} W-V+\Lambda\right)^{2}\right\} \\
& +C_{r} G+C \varphi^{1 / 2} G^{3 / 2} \quad \text { at } x_{0} .
\end{align*}

By (A2), the following inequalities hold for some positive constant $\kappa$ which depends on $\mu_{1}$,

In the case that $-\kappa|D W|^{2}+C_{r}-V+\Lambda \geq 0$ at $x_{0}$, we have

\leq & \varphi\left\{C_{r} G^{1 / 2}+C_{r} G+C_{r} G^{3 / 2}-\frac{4 \kappa^{2}}{N \nu_{2}} G^{2}+\frac{4 \kappa}{N \nu_{2}} G\left(C_{r}-V+\Lambda\right)\right\} \\
& +C_{r} G+C \varphi^{1 / 2} G^{3 / 2}
\end{align*}
$$

If $C_{r}-V+\Lambda \geq \kappa G\left(x_{0}\right) / 4$ or $C_{r} \geq G\left(x_{0}\right)$ we have the bound $|D W|^{2}(\xi) \leq$ $C_{r}+C \Lambda$ in the same way as the above case. We shall consider the case that $C_{r}-V+\Lambda \leq \kappa G\left(x_{0}\right) / 4$ and $C_{r} \leq G\left(x_{0}\right)$. Then, from (2.14), we have

\equiv & -C_{1} \varphi G^{2}+C_{2} \varphi^{1 / 2} G^{3 / 2}+\tilde{C}_{3} G \quad \text { at } x_{0}, \tilde{C}_{3} \equiv C_{3} C_{r}
\end{aligned}
$$

where $C_{1}, C_{2}, C_{3}$ are positive constants independent of $r, R$ and $\Lambda$. By setting $X \equiv \varphi^{1 / 2}\left(x_{0}\right) G^{1 / 2}\left(x_{0}\right)$, we have

Since $(1 / 2)|D W|^{2}(\xi)=(1 / 2)|D W|^{2}(\xi) \varphi^{2}(\xi) \leq G\left(x_{0}\right) \varphi\left(x_{0}\right)$, we obtain the bound for $|D W|(\xi)$.

REMARK 2.5. Under some growth conditions for coefficients of (1.2), we can obtain growth order for gradient of solutions. For instance, besides (A1), (A2), suppose the following growth conditions: $D a^{i j}(x), D \hat{a}^{i j}(x)$ are bounded and there exist $c_{1}, c_{2}>0$ and $m \geq 1$ such that

Then, in Lemma 2.4, we can take $C_{r}=C\left(1+r^{2 m}\right)$, that is,

We may normalize $W_{R}$ as $W_{R}(0)=0$ because (1.1) does not include a zeroth term on $W_{R}$. Then, from Lemma 2.4, there exists $W \in C\left(\mathbb{R}^{N}\right)$ such that $W_{R}$ converges to $W$ on each compact set as $R \rightarrow \infty$ by taking a subsequence if necessary. Also, since $\left\{W_{R}\right\}_{R>2 r}$ is bounded in $H^{1}\left(B_{r}\right)$ by Lemma 2.4, $W_{R}$ converges to $W L_{\text {loc }}^{2}$-strongly and $H_{\mathrm{loc}}^{1}$-weakly. Furthermore, we can see that $\nabla W_{R}$ converges $L_{\text {loc }}^{2}$-strongly in a similar way to Lemma 2.8 in [14] and Section 1.4 in [20].

We rewrite (2.3), (2.4) in integral form:

Fix $r>0$. Since $W_{R}$ converges to $W H_{\text {loc }}^{1}$-strongly, we obtain the following by sending $R$ to $\infty$ :

Owing to the regularity theorem of elliptic equations and the imbedding theorem, we have $W$ as a classical solution of (1.1). Therefore, we have proved that $\mathscr{A} \neq \varnothing$.

We shall state and prove the form of the set of $\Lambda$.

THEOREM 2.6. Under the assumptions (A1)-(A3), there exists $\Lambda^{*} \in$ $(-\infty, \infty)$ such that $\mathcal{A}=\left[\Lambda^{*}, \infty\right)$.

Proof. In order to show $\inf \mathscr{A}>-\infty$, we suppose $\inf \mathscr{A}=-\infty$, that is, there exists $\left\{\Lambda_{n}\right\} \subset \mathcal{A}$ such that $\Lambda_{n}$ tends to $-\infty$ as $n \rightarrow \infty$. Let $W_{n}$ be a solution of (1.1) corresponding to $\Lambda_{n}$. Then, by the integral form of (1.1), we have

& -\frac{1}{2} \int a^{i j} D_{i} W_{n} D_{j} \varphi d x+\frac{1}{2} \int \hat{a}^{i j} D_{i} W_{n} D_{j} W_{n} \varphi d x \\
& \quad+\int b \cdot \nabla W_{n} \varphi d x+\int V \varphi d x=\int \Lambda_{n} \varphi d x, \quad \varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right) \tag{2.15}
\end{align*}
$$

Take $\varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ such that $\int \varphi d x \neq 0$. Since $\left\{\Lambda_{n}\right\}$ is bounded from above, it is implied from Lemma 2.4 that

where $C_{r}$ is a constant independent of $n$ and $r$ is taken such that $\sup \varphi \subset B_{r}$. Therefore, the left-hand side of (2.15) is bounded on $n$. On the other hand, the
right-hand side of (2.15) is unbounded because of the assumption which we made above. This leads to a contradiction.

We shall next prove if $\tilde{\Lambda} \in \mathcal{A}$, then $[\tilde{\Lambda}, \infty) \subset \mathcal{A}$. Let $\tilde{W}$ be a solution corresponding to $\tilde{\Lambda}$. For arbitrary $\Lambda \geq \tilde{\Lambda}$, we have

By Remark 2.3, for $\tilde{R}>R$, there exists $\tilde{W}_{0}$ such that

\end{equation*}
$$

Consider the Dirichlet problem (2.3) with boundary condition $W_{R}=\tilde{W}_{0}$ on $\partial B_{R}$. From (2.17), (2.18), the existence of a classical solution for this Dirichlet problem is guaranteed by Theorem 8.4, Chapter 4 in [18]. In the same manner as that right after the proof of Lemma 2.4, we can see that there exists a smooth function $W$ satisfying (1.1) for $\Lambda$.

We shall prove that $\Lambda^{*} \equiv \inf \mathscr{A}$ actually belongs to $\mathcal{A}$. $\left\{\Lambda_{n}\right\}$ is a sequence in $\mathcal{A}$ such that $\Lambda_{n} \rightarrow \Lambda^{*}$ and $W_{n}$ is a solution of (1.1) corresponding to $\Lambda_{n}$ normalized as $W_{n}(0)=0$. Then, $W_{n}$ satisfies (2.15). Since $\left\{\Lambda_{n}\right\}$ is bounded, it follows from Lemma 2.4 that (2.16) holds for some constant $C_{r}$ independent of $n$. Following the same way as the discussion after Lemma 2.4, we can see that a sequence of $W_{n}$ converges to $W^{*} \in C\left(\mathbb{R}^{N}\right)$ uniformly on compact sets and $H_{\text {loc }}^{1}$-strongly. By taking a limit in (2.15) as $n \rightarrow \infty$, we have

& -\frac{1}{2} \int a^{i j} D_{i} W^{*} D_{j} \varphi d x+\frac{1}{2} \int \hat{a} D_{i} W^{*} D_{j} W^{*} \varphi d x \\
& \quad+\int b \cdot \nabla W^{*} \varphi d x+\int V \varphi d x=\int \Lambda^{*} \varphi d x \quad \forall \varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)
\end{aligned}
$$

Therefore, the existence of a classical solution $W^{*}$ of (1.1) for $\Lambda^{*}$ follows from the regularity theorem of elliptic equations (see Theorems 5.1, 6.3, Chapter 4 in [18]).

## 3. Classification of solutions.

3.1. Transience and ergodicity of diffusion processes. In the last section we proved that the set of $\Lambda$ for which (1.1) has a smooth solution is $\mathcal{A}=\left[\Lambda^{*}, \infty\right.$ ) for some $\Lambda^{*} \in(-\infty, \infty)$. In the present section we shall study the classification of $\Lambda$ by global behavior of $\left\{X_{t}\right\}$ defined by (1.8).

Let $\left(\Omega, \mathcal{F}, P,\left\{\mathcal{F}_{t}\right\}\right)$ be a filtered probability space on which $N$-dimensional Brownian motion $\left\{B_{t}\right\}$ is defined. For given $\Lambda \in\left[\Lambda^{*}, \infty\right)$, consider the SDE:

$$
\begin{equation*}
d X_{t}=\left(\tilde{b}\left(X_{t}\right)+\hat{a} \nabla W\left(X_{t}\right)\right) d t+\sigma\left(X_{t}\right) d B_{t}, \quad X_{0}=x \tag{3.1}
\end{equation*}
$$

where $W(x)$ is a solution of (1.1) corresponding to $\Lambda$. We shall classify $\Lambda$ according to the global properties of $\left\{X_{t}\right\}$. More precisely, we shall prove that for
$\Lambda>\Lambda^{*},\left\{X_{t}\right\}$ is transient and for $\Lambda=\Lambda^{*},\left\{X_{t}\right\}$ is ergodic. Note that solution of (3.1) might explode in finite time.

We shall next discuss transience of $\left\{X_{t}\right\}$ for $\Lambda \in\left(\Lambda^{*}, \infty\right)$. We introduce the operator associated to solution $(W, \Lambda)$ of (1.1):

$$
\begin{aligned}
T_{t}^{W, \Lambda} f(x) & \equiv E_{x}\left[f\left(X_{t}\right) ; t<\tau_{\infty}\right], & & f \in C_{0}\left(\mathbb{R}^{N}\right), \\
\tau_{n} & \equiv \inf \left\{t ; X_{t} \notin B_{n}(0)\right\}, & & \tau_{\infty} \equiv \lim _{n \rightarrow \infty} \tau_{n},
\end{aligned}
$$

where $\left\{X_{t}\right\}$ is a solution of (3.1) up to $t<\tau_{\infty}$ corresponding to ( $W, \Lambda$ ).
Lemma 3.1. Under (A1)-(A3), the following inequality holds for each solution $(W, \Lambda)$ of (1.1):

T_{t}^{W, \Lambda} f(x) \leq k(x) e^{-c\left(\Lambda-\Lambda^{*}\right) t}, \quad f \in C_{0}\left(\mathbb{R}^{N}\right), f \geq 0
$$

where $c$ is in Remark 2.1 and $k(x)$ is a constant depending only on $x$.
Proof. Let $W^{*}$ be a solution of (1.1) corresponding to $\Lambda^{*}$. We set $W_{c} \equiv c W$, $W_{c}^{*} \equiv c W^{*}$, where $c>0$ is taken from Remark 2.1. Then, we have from (1.2)

\frac{1}{2} a^{i j} D_{i j} W_{c}^{*}+\frac{1}{2 c} \hat{a}^{i j} D_{i} W_{c}^{*} D_{j} W_{c}^{*}+\tilde{b} \cdot \nabla W_{c}^{*}+c V & =c \Lambda^{*} . \tag{3.3}
\end{align*}
$$

Subtracting (3.3) from (3.2),

& \frac{1}{2} a^{i j} D_{i j}\left(W_{c}-W_{c}^{*}\right)+\left(\tilde{b}+\hat{a} \nabla W^{*}\right) \cdot \nabla\left(W_{c}-W_{c}^{*}\right) \\
& \quad+\frac{1}{2 c} \hat{a} \nabla\left(W_{c}-W_{c}^{*}\right) \cdot \nabla\left(W_{c}-W_{c}^{*}\right)=c\left(\Lambda-\Lambda^{*}\right)
\end{aligned}
$$

Setting $\bar{W} \equiv W_{c}-W_{c}^{*}$, we have

& +\left(\frac{1}{c} \hat{a} \nabla \bar{W} \cdot \nabla \bar{W}-a \nabla \bar{W} \cdot \nabla \bar{W}\right)\left(X_{t}\right) d t+\sigma \nabla \bar{W}\left(X_{t}\right) d \tilde{B}_{t} \\
= & \left(-\frac{1}{2 c} \hat{a} \nabla \bar{W} \cdot \nabla \bar{W}+c\left(\Lambda-\Lambda^{*}\right)\right)\left(X_{t}\right) d t \\

THEOREM 3.2. Let $(W, \Lambda)$ be a solution of (1.1) and $\left\{X_{t}\right\}$ be a solution of (3.1) corresponding to $(W, \Lambda)$. If (A1)-(A3) hold, then for $\Lambda>\Lambda^{*},\left\{X_{t}\right\}$ is transient.

Proof. Let $f \in C_{0}\left(\mathbb{R}^{N}\right)$ and $f \geq 0$. Since $\Lambda>\Lambda^{*}$, we can see that by Lemma 3.1,

We proved that for $\Lambda>\Lambda^{*},\left\{X_{t}\right\}$ defined by (3.1) is transient. We next show that if $\Lambda=\Lambda^{*}$, the corresponding diffusion process $\left\{X_{t}^{*}\right\}$ satisfying (3.1) is ergodic.

We have to show the following proposition.
Proposition 3.3. Let $(W, \Lambda)$ be a solution of $(1.1)$ and let $\left\{X_{t}\right\}$ be the corresponding diffusion process defined by (3.1). Assume (A1)-(A3). If $\left\{X_{t}\right\}$ is transient, then there exists $\alpha>0$ such that

Let $(W, \Lambda)$ be a solution of (1.1) and $\left\{X_{t}\right\}$ be a solution of (3.1). We define occupation measure for $\left\{X_{t}\right\}$ on $\left\{t<\tau_{\infty}\right\}$ as follows:

We think of $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ as the topological vector space with topology compatible to weak convergence. Note that $\mu_{t} \in \mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ on $\left\{t<\tau_{\infty}\right\}$.

The following lemma on large deviation type estimate is useful.

Lemma 3.4. Let $\left\{X_{t}\right\}$ be a solution of (3.1). Then, the following estimate holds:

Note that $I^{W}(\mu)$ takes values on $[0, \infty]$ and is convex, lower semi-continuous on $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$. This type of estimate is well known in large deviation theory. As noted in [5], even if the state space of $\left\{X_{t}\right\}$ is not compact, (3.8) holds for compact set $\mathcal{K}$ (cf. comments in Section 7, page 440 of [5] and see the proof in Section 2.2 of [4] for Brownian motion).

where $\left\{\delta_{l}\right\}$ is a sequence such that $\delta_{l} \rightarrow 0$ and determined later. Note that $\mathcal{C}_{m}$ is a relative compact set in $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ because $\mathcal{C}_{m}$ is tight. From the definition of $T_{t}^{W, \Lambda} f$,

& +E_{x}\left[f\left(X_{t}\right) ; \mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right] \\
\leq & \|f\|_{\infty} P_{x}\left[\mu_{t} \in \mathcal{C}_{m}, t<\tau_{\infty}\right] \\
& +E_{x}\left[f\left(X_{t}\right) ; \mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right],  \tag{3.16}\\
\leq & \|f\|_{\infty} P_{x}\left[\mu_{t} \in \mathcal{C}_{m}, t<\tau_{\infty}\right] \\
& +\left\|f \bar{\phi}^{-1}\right\|_{\infty} E_{x}\left[\bar{\phi}\left(X_{t}\right) ; \mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right], \\
& f \in C_{0}\left(\mathbb{R}^{N}\right), f \geq 0 .
\end{align*}
$$

We shall prove that $E_{x}\left[\bar{\phi}\left(X_{t}\right) ; \mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right]$ decays exponentially as $t \rightarrow \infty$. On the event $\left\{\mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right\}$, there exists $l \geq m$ such that

Then, we have on $\left\{\mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right\}$

\int_{0}^{t} c\left(U_{0}\left(X_{s}\right)+\Lambda\right) d s= & \int_{0}^{t} c\left(U_{0}\left(X_{s}\right)+\Lambda\right) \mathbb{1}_{B_{l}}\left(X_{s}\right) d s \\
& +\int_{0}^{t} c\left(U_{0}\left(X_{s}\right)+\Lambda\right) \mathbb{1}_{B_{l}^{c}}\left(X_{s}\right) d s \\
\geq & \inf _{x} c\left(U_{0}(x)+\Lambda\right) \int_{0}^{t} \mathbb{1}_{B_{l}}\left(X_{s}\right) d s  \tag{3.19}\\
& +\inf _{|x| \geq l} c\left(U_{0}(x)+\Lambda\right) \int_{0}^{t} \mathbb{1}_{B_{l}^{c}}\left(X_{s}\right) d s \\
= & \beta_{0} \mu_{t}\left(B_{l}\right) t+\beta_{l} \mu_{t}\left(B_{l}^{c}\right) t
\end{align*}
$$

where we set $\beta_{0}=\inf _{x} c\left(U_{0}(x)+\Lambda\right), \beta_{l}=\inf _{|x| \geq l} c\left(U_{0}(x)+\Lambda\right)$. By (A3), there exists $m \geq 1$ such that

Take a positive constant $M>0$. Then we choose $\delta_{l}$ such that $M=-\left|\beta_{0}\right|\left(1-\delta_{l}\right)+$ $\beta_{l} \delta_{l}$. Indeed, $\delta_{l}$ is defined by

& \geq e^{M t} E_{x}\left[\bar{\phi}\left(X_{t}\right) ; \mu_{t} \notin \mathcal{C}_{m}, t<\tau_{\infty}\right] .
\end{aligned}

Therefore we obtain

where $\overline{\mathcal{C}}_{m}$ is the closure of $\mathcal{C}_{m}$. Since $I^{W}(\mu)$ is lower semi-continuous and $\overline{\mathcal{C}}_{m}$ is compact in $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right), \inf _{\mu \in \overline{\mathcal{C}}_{m}} I^{W}(\mu)$ is attained at some $\mu^{*} \in \overline{\mathcal{C}}_{m}$. Since existence of invariant measure implies recurrence, it follows from Lemmas 3.5 and 3.6 and transience of $\left\{X_{t}\right\}$

\inf _{\mu \in \overline{\mathcal{C}}_{m}} I^{W}(\mu)>0
$$

Hence, we can find a positive constant $\alpha_{m}>0$ such that

We are ready to prove that for $\Lambda=\Lambda^{*}$, the corresponding diffusion process $\left\{X_{t}^{*}\right\}$ is ergodic.

THEOREM 3.7. Let $\left(W^{*}, \Lambda^{*}\right)$ be a solution of (1.1) corresponding to $\Lambda^{*}=\inf \mathcal{A}$ and let $\left\{X_{t}^{*}\right\}$ be a solution of (3.1) for ( $W^{*}, \Lambda^{*}$ ). Under (A1)-(A3), $\left\{X_{t}^{*}\right\}$ is ergodic.

Proof. Suppose that $\left\{X_{t}^{*}\right\}$ is transient. Then, by Proposition 3.3,

Then, there exists Green function $G(x, y)$ for $(1 / 2) a^{i j} D_{i j}+\left(\tilde{b}+\hat{a} \nabla W^{*}\right) \cdot \nabla+\varepsilon$ and $G(x, y)$ satisfies the following:

\frac{1}{2} a^{i j} D_{i j} G(\cdot, y)+\left(\tilde{b}+\hat{a} \nabla W^{*}\right) \cdot \nabla G(\cdot, y)+\varepsilon G(\cdot, y)=0 \quad \text { in } \mathbb{R} \backslash\{y\} \tag{3.24}
\end{equation*}

We take a sequence $\left\{y_{n}\right\}$ in $\mathbb{R}^{N}$ such that $y_{n} \in B_{n+1} \backslash \bar{B}_{n}$. Define $\bar{\phi}_{n}(x)$ as follows:

\bar{\phi}_{n}(x) \equiv \frac{G\left(x, y_{n}\right)}{G\left(0, y_{n}\right)}, \quad x \in \mathbb{R}^{N} \backslash\left\{y_{n}\right\}
$$

Then, we have from (3.24)

\frac{1}{2} a^{i j} D_{i j} \bar{\phi}_{n}+\left(\tilde{b}+\hat{a} \nabla W^{*}\right) \cdot \nabla \bar{\phi}_{n}+\varepsilon \bar{\phi}_{n}=0 \quad \text { in } \mathbb{R}^{N} \backslash\left\{y_{n}\right\} . \tag{3.25}
\end{equation*}
$$

We note that by setting $\bar{W}_{n} \equiv(1 / \bar{c}) \log \bar{\phi}_{n},(3.25)$ is equivalent to the following:

where $\bar{c}$ is taken from Remark 2.1. By Lemma 2.4, we have

Adding (3.26) to (3.27), it follows from Remark 2.1 that

& +\frac{1}{2} \hat{a} \nabla W^{*} \cdot \nabla W^{*}+\hat{a} \nabla W^{*} \cdot \nabla \bar{W}+\frac{\bar{c}}{2} a \nabla \bar{W} \cdot \nabla \bar{W}+V-\left(\Lambda^{*}-\frac{\varepsilon}{\bar{c}}\right) \\
\geq & \frac{1}{2} a^{i j} D_{i j}\left(W^{*}+\bar{W}\right)+\tilde{b} \cdot\left(\nabla W^{*}+\nabla \bar{W}\right) \\
& +\frac{1}{2} \hat{a} \nabla W^{*} \cdot \nabla W^{*}+\hat{a} \nabla W^{*} \cdot \nabla \bar{W}+\frac{1}{2} \hat{a} \nabla \bar{W} \cdot \nabla \bar{W}+V-\left(\Lambda^{*}-\frac{\varepsilon}{\bar{c}}\right) \\
= & \frac{1}{2} a^{i j} D_{i j}\left(W^{*}+\bar{W}\right)+\tilde{b} \cdot \nabla\left(W^{*}+\bar{W}\right) \\
& +\frac{1}{2} \hat{a} \nabla\left(W^{*}+\bar{W}\right) \cdot \nabla\left(W^{*}+\bar{W}\right)+V-\left(\Lambda^{*}-\frac{\varepsilon}{\bar{c}}\right) .
\end{aligned}
$$

Thus, $W^{*}+\bar{W}$ is a super solution of (1.1) for $\Lambda=\Lambda^{*}-\varepsilon / \bar{c}$. In the same way as the proof that $\mathcal{A} \neq \varnothing$ given in Section 2 we can see that there exists a smooth function $\tilde{W}$ such that

In order to see that $\left\{X_{t}^{*}\right\}$ is actually ergodic, we recall the proof of Proposition 3.3. If we suppose $\inf _{\mu \in \bar{ल}_{m}} I^{W^{*}}(\mu)>0$ where $m$ is chosen in (3.20), we can prove Proposition 3.3, which implies that $\left\{X_{t}^{*}\right\}$ is transient. Hence, we see that

3.2. Uniqueness of solutions corresponding to the bottom. We proved that solution $\left(W^{*}, \Lambda^{*}\right)$ of (1.1) for $\Lambda^{*}=\inf \mathscr{A}$ corresponds to ergodicity to $\left\{X_{t}^{*}\right\}$ of (3.1). Now we shall show that the solution corresponding to $\Lambda^{*}$ is unique up to an additive constant. Note that the solution of (1.1) has ambiguity on an additive constant.

THEOREM 3.8. Let $W_{i}^{*}, i=1,2$, be solutions of (1.1) corresponding to $\Lambda^{*}=\inf \mathcal{A}$. Under $(\mathrm{A} 1)-(\mathrm{A} 3)$, there exists constant $k$ such that $W_{2}^{*}(x)=$ $W_{1}^{*}(x)+k$.

Proof. Since $W_{i}^{*}, i=1,2$, are solutions of (1.2),

& \frac{1}{2} a^{i j} D_{i j} W_{1}^{*}+\frac{1}{2} \hat{a} \nabla W_{1}^{*} \cdot \nabla W_{1}^{*}+\tilde{b} \cdot \nabla W_{1}^{*}+V=\Lambda^{*}, \\
& \frac{1}{2} a^{i j} D_{i j} W_{2}^{*}+\frac{1}{2} \hat{a} \nabla W_{2}^{*} \cdot \nabla W_{2}^{*}+\tilde{b} \cdot \nabla W_{2}^{*}+V=\Lambda^{*} .
\end{aligned}
$$

Subtracting each side in the above equations, we have

\frac{1}{2} a^{i j} D_{i j}\left(W_{1}^{*}-W_{2}^{*}\right)+\left(\tilde{b}+\hat{a} \nabla W_{2}^{*}\right) \cdot\left(\nabla W_{1}^{*}-\nabla W_{2}^{*}\right)  \tag{3.29}\\
\quad+\frac{1}{2} \hat{a}\left(\nabla W_{1}^{*}-\nabla W_{2}^{*}\right) \cdot\left(\nabla W_{1}^{*}-W_{2}^{*}\right)=0
\end{gather*}
$$

Let us set $\phi(x) \equiv e^{c\left(W_{1}^{*}(x)-W_{2}^{*}(x)\right)}$, where $c$ is in Remark 2.1. Rewriting (3.29) in terms of $\phi$, we have

Hence it is implied from Remark 2.1 that

Let us take $x, y \in \mathbb{R}^{N}$ and consider the SDE of (3.1) for $W=W_{2}^{*}$ :

$$

Define $\tau_{B_{n}}=\inf \left\{t: X_{t}^{*} \notin B_{n}\right\}, \sigma_{B_{\varepsilon}(y)}=\inf \left\{t: X_{t}^{*} \in B_{\varepsilon}(y)\right\}$. Note that $\left\{X_{t}^{*}\right\}$ is ergodic from Theorem 3.7, especially recurrent. It follows from the Itô formula and
(3.30) that

\phi\left(X_{t \wedge \tau_{B_{n}} \wedge \sigma_{B_{\varepsilon}(y)}}^{*}\right)= & \phi(x)+\int_{0}^{t \wedge \tau_{B_{n}} \wedge \sigma_{B_{\varepsilon}(y)}} L \phi\left(X_{s}^{*}\right) d s \\
& +\int_{0}^{t \wedge \tau_{B_{n}} \wedge \sigma_{B_{\varepsilon}(y)}} \nabla \phi\left(X_{s}^{*}\right) \cdot \sigma\left(X_{s}^{*}\right) d B_{s} \\
\leq & \phi(x)+\int_{0}^{t \wedge \tau_{B_{n}} \wedge \sigma_{B_{\varepsilon}(y)}} \nabla \phi\left(X_{s}^{*}\right) \cdot \sigma\left(X_{s}^{*}\right) d B_{s} .
\end{aligned}
$$

Thus we have $E_{x}\left[\phi\left(X_{t \wedge \tau_{B_{n}} \wedge \sigma_{B_{\varepsilon}(y)}}^{*}\right)\right] \leq \phi(x)$. By taking the limit as $n \rightarrow \infty$, it follows by Fatou's lemma that $E\left[\phi\left(X_{t \wedge \sigma_{B_{\varepsilon}(y)}}^{*}\right)\right] \leq \phi(x)$. Noting that $P_{x}\left[\sigma_{B_{\varepsilon}(y)}<\infty\right]=1$, we have by sending $t \rightarrow \infty$,

$D, M, a, \hat{a}$ are matrices and $M$ is symmetric; $a, \hat{a}$ are positive-definite. We consider quadratic solution $W$,

\end{aligned}

If $M$ is negative-definite, then there is a unique solution $K$ such that $K$ is nonpositive-definite and $D+\hat{a} K$ is stable. See [15]. For such $K$, the equation for $e$ can be uniquely solved. The stability of $D+\hat{a} K$ implies that the diffusion

is ergodic, $\sigma$ is the square root of $a$. This implies $\Lambda$ defined above is equal to $\Lambda^{*}$ and $W$ obtained is the unique solution corresponding to $\Lambda^{*}$. We note there are also solutions that are not quadratic.

In particular, in the one-dimensioned case, the equation for $K$ becomes

\end{aligned}
$$

Then

D+\hat{a} K_{-}=-\sqrt{\left(\frac{D}{\hat{a}}\right)^{2}-M}<0
$$

and

$$
D+\hat{a} K_{+}=\sqrt{\left(\frac{D}{\hat{a}}\right)^{2}-M}>0
$$

Solution corresponding to $K_{-}$is $W^{*}$.
EXAMPLE 3.10. In [9, 10], the following conditions are considered:
(a) $a(x)=\hat{a}(x)=I$.
(b) $b(0)=0 ; b_{j}(x)$ has continuous first-order derivatives, $D_{i} b_{j}(x)$ is bounded for all $i, j$.
(c) There is $c_{0}>0$ such that for all $x, \eta \in \mathbb{R}^{d}, \eta \cdot D b(x) \eta \leq-c_{0}|\eta|^{2}$. Here $D b(x)=\left(D_{i} b_{j}(x)\right)_{i j}$.
(d) $V(x), D_{i} V(x), i=1, \ldots, d$, are bounded.

Under these conditions, Fleming and co-workers prove that there exists unique solution ( $W, \Lambda$ ) satisfying the condition

|\nabla W(x)| \leq \frac{1}{c_{0}}\|\nabla V\|_{\infty}
$$

$\|\nabla V\|_{\infty}=\sup _{x}|\nabla V(x)|$. Let $\left\{X_{t}\right\}$ be the diffusion,

d X_{t}=\left(b\left(X_{t}\right)+\nabla W\left(X_{t}\right)\right) d t+d B_{t} .
$$

Denote

c=\frac{1}{c_{0}}\|\nabla V\|_{\infty} .
$$

Then

d\left|X_{t}\right|^{2}=2\left(X_{t} \cdot b\left(X_{t}\right)+X_{t} \cdot \nabla W\left(X_{t}\right)+\frac{d}{2}\right) d t+2 X_{t} d B_{t}
$$

By (a), (c) and the mean value theorem,

x \cdot b(x) \leq-c_{0}|x|^{2}
$$

Property of $W$ implies

$$
x \cdot \nabla W(x) \leq c|x|
$$

By using a routine argument and considering $\left|X_{t}\right|^{2} \exp \left(c_{0} t\right)$, we can prove

E_{x}\left[\left|X_{t}\right|^{2}\right] \leq \exp \left(-c_{0} t\right)|x|^{2}+\frac{1}{c_{0}}\left(d+\frac{c^{2}}{c_{0}}\right)
$$

This implies $\left\{X_{t}\right\}$ is ergodic. Therefore, $\Lambda=\Lambda^{*}$ and $W=W^{*}$.
In [15], different conditions are considered that are given as follows:
(a) ${ }^{\prime}$ There are $c_{1}, c_{2}>0$ such that

c_{1} \leq a(x) \leq c_{2}, \quad c_{1} \leq \hat{a}(x) \leq c_{2} .
$$

(b) ${ }^{\prime}$ There are $c_{0}, r_{0}>0$ such that

x \cdot b(x) \leq-c_{0}|x|^{2}, \quad|x| \geq r_{0}
$$

(c) $a_{i j}(x), \hat{a}_{i j}(x)$ and $b_{i}(x)$ have bounded first-order derivatives.
(d)' $V(x), \nabla V(x)$ are bounded.

Then (1.1) with $\Lambda=\Lambda^{*}$ has unique solution $W^{*}$ with $W^{*}(0)=0$. Moreover, for any $\alpha, \beta>0$, there are $c_{\alpha, \beta}$ such that

4. Perturbation of coefficients. In the present section we shall consider the structures of solutions of (1.1) under perturbation of coefficients. This is to consider the following equation parameterized by $n \in \mathbb{N}$ :

\tilde{b}_{n}^{i}(x) & \equiv b_{n}^{i}(x)+\frac{1}{2} D_{j} \hat{a}_{n}^{i j}(x) \tag{4.2}
\end{align*}

In the same way as (2.1) we define $\mathcal{A}_{n}$ as follows:

Under certain assumptions, we can show that $\mathscr{A}_{n}=\left[\Lambda_{n}^{*}, \infty\right)$ for some finite $\Lambda_{n}^{*}$. Furthermore, we can classify the set $\mathcal{A}_{n}$ of $\Lambda_{n}$ according to the global behavior of diffusion process defined by the SDE:

d X_{t}=\left(\tilde{b}_{n}\left(X_{t}\right)+\hat{a}_{n} \nabla W_{n}\left(X_{t}\right)\right) d t+\sigma_{n}\left(X_{t}\right) d B_{t}, \quad \sigma_{n}(x) \equiv a_{n}(x)^{1 / 2} \tag{4.4}
\end{equation*}
$$

where $W_{n}$ is a solution of (4.1) corresponding to $\Lambda_{n}$ and $\left\{B_{t}\right\}$ is $\mathcal{F}_{t}$-standard Brownian motion on a filtered probability space $\left(\Omega, \mathcal{F}, P,\left\{\mathcal{F}_{t}\right\}\right)$. Indeed, we can prove that $\Lambda_{n}=\Lambda_{n}^{*}\left(\right.$ resp. $\left.\Lambda_{n}>\Lambda_{n}^{*}\right)$ corresponds to ergodicity (resp. transience) of $\left\{X_{t}\right\}$ defined by (4.4) and $W_{n}^{*}$ corresponding to $\Lambda_{n}^{*}$ is unique up to additive constants.

It is interesting to study stability of solution $\left(W_{n}^{*}, \Lambda_{n}^{*}\right)$ corresponding to the bottom of $\mathscr{A}_{n}$ under perturbation of coefficients. Suppose that all coefficients converge to corresponding ones, respectively, in some sense:

a_{n}^{i j} \rightarrow a^{i j}, \quad \hat{a}_{n}^{i j} \rightarrow \hat{a}^{i j}, \quad b_{n} \rightarrow b, \quad V_{n} \rightarrow V \quad \text { as } n \rightarrow \infty

We hope to prove that $W_{n}^{*}$ and $\Lambda_{n}^{*}$ converge to $W^{*}$ and $\Lambda^{*}=\inf \mathcal{A}$, respectively, where $\mathcal{A}$ is defined by (2.1) and $W^{*}$ is a unique solution of (1.1) corresponding to $\Lambda^{*}$. This means that the solutions corresponding to $\Lambda_{n}^{*}=\inf \mathscr{A}_{n}$ are stable under the perturbation.

It turns out this is a delicate problem. For the illustration of the idea, we shall be content with the following special example. The result obtained will be used in Section 5. We refer to [16] for more general discussion and a counterexample.

We now consider the following special example; we consider the following equation:

We assume the following conditions. We suppose implicitly that all the coefficients are smooth.
(B1) There exists smooth function $W_{0}$ such that

(B2) $\bar{V}_{n}, D \bar{V}_{n}$ are bounded in $\mathbb{R}^{N}$ uniformly on $n$.
(B3) $\bar{V}_{n}$ converges to $\bar{V}$ uniformly on each compact set as $n \rightarrow \infty$.

Let $W_{n}^{*}$ (resp. $W^{*}$ ) be solution of (4.5) [resp. (4.6)] corresponding to $\Lambda_{n}^{*}$ $\left(\operatorname{resp} . \Lambda^{*}\right)$.

Proposition 4.1. Under (A1), (A2), (B1)-(B3), $\Lambda_{n}^{*}$ converges to $\Lambda^{*}$.
Proof. It is easy to prove that $\liminf _{n \rightarrow \infty} \Lambda_{n}^{*} \geq \Lambda^{*}$. We shall prove $\lim \sup _{n \rightarrow \infty} \Lambda_{n}^{*} \leq \Lambda^{*}$. Since $W_{n}^{*}\left(\right.$ resp. $W^{*}$ ) is solution of (4.5) for $\Lambda_{n}^{*}$ [resp. (4.6) for $\left.\Lambda^{*}\right]$,

\end{aligned}

By subtracting both of sides, we have

& \quad+\frac{1}{2} \hat{a} \nabla\left(W^{*}-W_{n}^{*}\right) \cdot \nabla\left(W^{*}-W_{n}^{*}\right)=\Lambda^{*}-\Lambda_{n}^{*}+\bar{V}_{n}-\bar{V}
\end{aligned}
$$

Then, we can see that for $c>0$,

& \frac{1}{2} a^{i j} D_{i j}\left(c\left(W^{*}-W_{n}^{*}\right)\right)+\left(\tilde{b}+\hat{a} \nabla W_{n}^{*}\right) \cdot \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \\
& \quad+\frac{1}{2} a \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \cdot \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \\
& \quad=c\left(\Lambda^{*}-\Lambda_{n}^{*}+\bar{V}_{n}-\bar{V}\right)+\frac{1}{2 c}(c a-\hat{a}) \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \cdot \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right)
\end{aligned}
$$

If we take $c>0$ from Remark 2.1, then

& \quad+\frac{1}{2} a \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \cdot \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \leq c\left(\Lambda^{*}-\Lambda_{n}^{*}+\bar{V}_{n}-\bar{V}\right)
\end{align*}
$$

Let $\mu_{n}^{*}$ be invariant measure of diffusion process $X_{t}^{*, n}$ defined by the following SDE:

I_{n}^{W_{n}^{*}}(\mu) & =-\inf _{u \in \mathcal{U}_{n}} \int \frac{L_{n} u}{u} d \mu, \quad \mu \in \mathcal{M}_{1} \\
L_{n} & =\frac{1}{2} a^{i j} D_{i j}+\left(b+\hat{a} \nabla W_{n}^{*}\right) \cdot \nabla, \\
U_{n} & =\left\{u \in C^{2}\left(\mathbb{R}^{N}\right) ; u(x)>0, L_{n} u / u \text { is bounded above }\right\} .
\end{aligned}
$$

Set $u=\exp \left(c\left(W^{*}-W_{n}^{*}\right)\right)$. Then, from (4.7), we have

& +\frac{1}{2} a \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right) \cdot \nabla\left(c\left(W^{*}-W_{n}^{*}\right)\right)  \tag{4.9}\\
\leq & c\left(\Lambda^{*}-\Lambda_{n}^{*}+\bar{V}_{n}-\bar{V}\right) .
\end{align*}

Since $\bar{V}, \bar{V}_{n}$ are bounded, $u \in \mathcal{U}_{n}$. Hence, by (4.8),

U_{0}(x) & \equiv-\sup _{n}\left(\frac{1}{2} a^{i j} D_{i j} W_{0}+\frac{1}{2} \hat{a} \nabla W_{0} \cdot \nabla W_{0}+\tilde{b} \cdot \nabla W_{0}+V_{n}\right), \\
\alpha & =\inf _{n} \Lambda_{n}^{*} .
\end{aligned}

$W_{0}$ is from ( B 1$)$ and $m$ is taken so that

Since $\bar{V}_{n}$ are uniformly bounded and $\bar{V}_{n}$ converges to $\bar{V}$ uniformly on compact sets, we can see that

THEOREM 4.2. Let $W_{n}^{*}$ (resp. $W^{*}$ ) be solution of (4.5) for $\Lambda_{n}^{*}$ [resp. (4.6) for $\left.\Lambda^{*}\right]$. Under (A1), (A2), (B1)-(B3), $W_{n}^{*}\left(r e s p . ~ \Lambda_{n}^{*}\right)$ converges to $W^{*}\left(r e s p . \Lambda^{*}\right)$ uniformly on compact sets, $H_{\mathrm{loc}}^{1}$-strongly as $n \rightarrow \infty$.

Proof. By using the estimate of $\nabla W_{n}$ as in Lemma 2.4 and the argument in the proof of Theorem 2.6, we can show $W_{n}^{*}\left(\right.$ resp. $\left.\Lambda_{n}^{*}\right)$ converges to $\tilde{W}^{*}\left(\right.$ resp. $\left.\tilde{\Lambda}^{*}\right)$ uniformly on compact sets, $H_{\text {loc }}^{1}$-strongly by taking a subsequence if necessary. Furthermore $\left(\tilde{W}^{*}, \tilde{\Lambda}^{*}\right)$ is a solution of (4.6). Indeed, we see that $\Lambda^{*}=\tilde{\Lambda}^{*}$ by Proposition 4.1. By uniqueness of solution corresponding to $\Lambda^{*}$ in Proposition 4.1, we have $W^{*}(x)=\tilde{W}^{*}(x)$.
5. Representation of $\Lambda^{*}$. For (1.1) with the coefficients satisfying the conditions (A1)-(A3), we have proved that there is a unique solution ( $W^{*}, \Lambda^{*}$ ) with $W^{*}(0)=0$ and $\Lambda=\Lambda^{*}$ is the smallest such that (1.1) has solution $W$. In this section we will give a representation of $\Lambda^{*}$. From the representation, we will get some moment condition for $\mu^{*}$, the invariant measure for the diffusion in (3.1) constructed from $W=W^{*}$. Before we state our main results, we give some notation.

We shall consider a family of $V$. That is, we consider a particular $V_{0}$ and the bounded perturbation of $V_{0}$, say $V_{0}+\bar{V}$ for bounded $\bar{V}$. Therefore, in this section we consider the equation

\begin{equation*}
\frac{1}{2} D_{i}\left(a^{i j} D_{j} W\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W+b \cdot \nabla W+V_{0}+V=\Lambda \quad \text { in } \mathbb{R}^{N} \tag{5.1}
\end{equation*}
$$

The smallest $\Lambda$ such that this has solution $W$ is denoted $\Lambda^{*}(V)$. We still use $W^{*}$ for the solution corresponding to $\Lambda^{*}(V)$. We shall mention if we want to emphasize the dependence of $W^{*}$ on $V$.

In this section we assume the following condition:
(A3) $)^{\prime} V_{0}$ is smooth and there exists a smooth function $W_{0}$ such that

U_{0}(x)=-\left(\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{0}\right)+b \cdot \nabla W_{0}+\frac{1}{2} \hat{a}^{i j} D_{i} W_{0} D_{j} W_{0}+V_{0}\right) \rightarrow \infty \\
\text { as }|x| \rightarrow \infty .
\end{array}
$$

We consider $V$ satisfying the condition:

\end{equation*}
$$

where $c$ is a constant that may depend on $V$.
Let $W$ be a smooth function. We denote

For each probability measure $\mu$ on $\mathbb{R}^{N}$, we define

J(\mu)=\sup \{-\langle G(W), \mu\rangle ; W \text { is smooth and } G(W) \text { is bounded above }\} .
$$

Here for a function $f$

\langle f, \mu\rangle=\int f(x) d \mu(x)
$$

Now we can state our main results.

THEOREM 5.1. Assume (A1), (A2), (A3)' and (5.2). Let ( $\left.W^{*}, \Lambda^{*}(V)\right)$ be the solution defined above. Then $\Lambda^{*}(V)$ has the representation

$$
\Lambda^{*}(V)=\sup _{\mu \in \mathcal{M}_{1}\left(\mathbb{R}^{N}\right)}\{\langle V, \mu\rangle-J(\mu)\}
$$

Here $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ denotes the set of all probability measures on $\mathbb{R}^{N}$. The supremum attains at $\mu=\mu^{*}, \mu^{*}$ is the invariant measure of the diffusion in (3.1) for $W=W^{*}$.

From this theorem, we have

\Lambda^{*}(V) & =\left\langle V, \mu^{*}\right\rangle-J\left(\mu^{*}\right) \\
& \leq\left\langle V, \mu^{*}\right\rangle+\left\langle G\left(W_{0}\right), \mu^{*}\right\rangle \\
& =\left\langle V, \mu^{*}\right\rangle+\left\langle-U_{0}, \mu^{*}\right\rangle
\end{aligned}
$$

Therefore, we have the following corollary.
COROLLARY 5.2. We assume the condition as in the above theorem. Then

\int U_{0}(x) d \mu^{*}(x) \leq-\Lambda^{*}(V)+\|V\|_{\infty}
$$

In particular,

\int U_{0}(x) d \mu^{*}(x)<\infty
$$

Here $\|V\|$ is the supnorm of $V$.
Before we prove Theorem 5.1, we mention some elementary properties of $\Lambda^{*}(V)$.

Lemma 5.3. (i) $\Lambda^{*}(V)$ is Lipschitz with constant 1. That is,

\left|\Lambda^{*}\left(V_{1}\right)-\Lambda^{*}\left(V_{2}\right)\right| \leq\left\|V_{1}-V_{2}\right\|_{\infty}
$$

for $V_{1}, V_{2}$ satisfying (5.2). From this, $\Lambda^{*}(V)$ can be defined for all bounded continuous functions $V$ by extension.
(ii) $\Lambda^{*}(V)$ is convex in $V$.

Proof. Let $W_{1}^{*}$ be the solution of (5.1) for $V=V_{1}, \Lambda=\Lambda^{*}\left(V_{1}\right)$. Then

& \frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{1}^{*}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{1}^{*} D_{j} W_{1}^{*}+b \cdot \nabla W_{1}^{*}+V_{0}+V_{2} \\
& \quad=\Lambda^{*}\left(V_{1}\right)+V_{2}-V_{1} \\
& \quad \leq \Lambda^{*}\left(V_{1}\right)+\left\|V_{2}-V_{1}\right\|_{\infty}
\end{aligned}
$$

This implies

$$
\Lambda^{*}\left(V_{2}\right) \leq \Lambda^{*}\left(V_{1}\right)+\left\|V_{2}-V_{1}\right\|_{\infty}
$$

See the argument in the proof of Theorem 2.6. Similarly,

$$
\Lambda^{*}\left(V_{1}\right) \leq \Lambda^{*}\left(V_{2}\right)+\left\|V_{2}-V_{1}\right\| .
$$

Therefore,

$$
\left|\Lambda^{*}\left(V_{1}\right)-\Lambda^{*}\left(V_{2}\right)\right| \leq\left\|V_{1}-V_{2}\right\|_{\infty}
$$

We now show that $\Lambda^{*}(V)$ is convex. Let $V_{1}, V_{2}$ satisfy (5.2) and $W_{k}^{*}, k=1,2$, satisfy
$\frac{1}{2} D_{i}\left(a^{i j} D_{j} W_{k}^{*}\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W_{k}^{*} D_{j} W_{k}^{*}+b \cdot \nabla W_{k}^{*}+V_{0}+V_{k}=\Lambda^{*}\left(V_{k}\right), \quad k=1,2$.
Let $0<\lambda<1$ and denote $W=\lambda W_{1}^{*}+(1-\lambda) W_{2}^{*}, V=\lambda V_{1}+(1-\lambda) V_{2}$ and $\Lambda=\lambda \Lambda^{*}\left(V_{1}\right)+(1-\lambda) \Lambda^{*}\left(V_{2}\right)$. Then by a simple calculation, we have

$$
\frac{1}{2} D_{i}\left(a^{i j} D_{j} W\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W+b \cdot \nabla W+V_{0}+V \leq \Lambda, \quad k=1,2 .
$$

This implies

$$
\Lambda^{*}(V) \leq \Lambda
$$

See the proof of Theorem 2.6. That is, we have

$$
\Lambda^{*}\left(\lambda V_{1}+(1-\lambda) V_{2}\right) \leq \lambda \Lambda^{*}\left(V_{1}\right)+(1-\lambda) \Lambda^{*}\left(V_{2}\right)
$$

Denote by $C_{b}\left(\mathbb{R}^{N}\right)$ the collection of all bounded continuous functions defined on $\mathbb{R}^{N} . C_{b}\left(\mathbb{R}^{N}\right)$ is a Banach space with supnorm. The dual space $C_{b}\left(\mathbb{R}^{N}\right)^{*}$ can be identified with the set of all regular bounded finitely additive set functions defined on the field generated by closed sets of $\mathbb{R}^{N}$. That is, for an element $T \in C_{b}\left(\mathbb{R}^{N}\right)^{*}$, there is regular bounded finitely additive set function $\mu$ such that

$$
T(V)=\int V(x) d \mu(x), \quad V \in C_{b}\left(\mathbb{R}^{n}\right)
$$

See [6], Theorem IV.6.2. For regular additive function see [6], Theorem III.5.11. We note that $\mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ is a subset of $C_{b}\left(\mathbb{R}^{N}\right)^{*}$.

For $\mu \in C_{b}\left(\mathbb{R}^{N}\right)^{*}$, we define

$$
I(\mu)=\sup _{V \in C_{b}\left(\mathbb{R}^{N}\right)}\left\{\langle V, \mu\rangle-\Lambda^{*}(V)\right\}
$$

Proposition 5.4. Let $V$ be bounded continuous. Then

$$
\Lambda^{*}(V)=\sup _{\mu \in C_{b}\left(\mathbb{R}^{N}\right)^{*}}\{\langle V, \mu\rangle-I(\mu)\}
$$

See [7], Proposition 4.1, Chapter 1 or [23], Theorem 7.15.
We shall prove that $I(\mu)=J(\mu)$ if $\mu$ is a probability measure. For $V$ satisfying (5.2), the supremum is attained at $\mu=\mu^{*}$, where $\mu^{*}$ is the invariant measure of the diffusion in (3.1) for $W=W^{*}$. Our main theorem is a consequence of this. We begin with some elementary observations. We follow essentially the argument in [23].

LEMMA 5.5. If $I(\mu)<\infty$, then $\mu$ is nonnegative and $\mu\left(\mathbb{R}^{N}\right)=1$.
Proof. We first prove $I(\mu)=\infty$ if $\mu$ is not nonnegative. For such $\mu$, we take $V \geq 0$ such that $\mu(V)<0$. For any $\alpha>0$,

$$
I(\mu) \geq\langle-\alpha V, \mu\rangle-\Lambda^{*}(-\alpha V)
$$

Now $\Lambda^{*}(-\alpha V) \leq \Lambda^{*}(0)$, since $-\alpha V \leq 0$. Therefore,

$$
I(\mu) \geq-\alpha\langle V, \mu\rangle-\Lambda^{*}(0) \rightarrow \infty
$$

as $\alpha$ tends to infinity. Hence $I(\mu)=\infty$.
We now prove $I(\mu)=\infty$ if $\mu\left(\mathbb{R}^{N}\right) \neq 1$. For such $\mu$,

$$
I(\mu) \geq\langle\alpha, \mu\rangle-\Lambda^{*}(\alpha)=\alpha \mu\left(\mathbb{R}^{N}\right)-\alpha-\Lambda^{*}(0)=\alpha\left(\mu\left(\mathbb{R}^{N}\right)-1\right)-\Lambda^{*}(0)
$$

Here $\alpha$ is any real number. From this, it is easy to see that $I(\mu)=\infty$.

LEMMA 5.6. Let $\mu$ be a probability measure. Then $I(\mu) \geq J(\mu)$.
Proof. Let $W$ be a smooth function such that $G(W)$ is bounded above. Take

$$
V_{n}=\min \{-G(W), n\} .
$$

Then $V_{n}$ is a bounded continuous function.
It is easy to see that

$$
\frac{1}{2} D_{i}\left(a^{i j} D_{j} W\right)+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W+b \cdot \nabla W+V_{0}+V_{n} \leq 0 .
$$

Therefore, $\Lambda^{*}\left(V_{n}\right) \leq 0$. From the relation

$$
I(\mu) \geq\left\langle V_{n}, \mu\right\rangle-\Lambda^{*}\left(V_{n}\right) \geq\left\langle V_{n}, \mu\right\rangle
$$

and $V_{n} \rightarrow-G(W), V_{n} \leq V_{n+1}$ such that $V_{n}$ are bounded below, we can apply the monotone convergence theorem to get

$$
I(\mu) \geq-\langle G(W), \mu\rangle
$$

Then
$I(\mu) \geq \sup \{-\langle G(W), \mu\rangle ; W$ is smooth, $G(W)$ is bounded above $\}=J(\mu)$.
Lemma 5.7. Let $V \in C_{b}\left(\mathbb{R}^{N}\right)$. Define

$$
J^{*}(V)=\sup _{\mu \in \mathcal{M}_{1}\left(\mathbb{R}^{N}\right)}\{\langle V, \mu\rangle-J(\mu)\} .
$$

Then $J^{*}(V) \leq \Lambda^{*}(V)$.

Proof. It is enough to prove this for $V$ satisfying (5.2) which we assume now. We first observe the relation

$$
\begin{aligned}
J^{*}(V) & =\sup _{\mu}\left\{\langle V, \mu\rangle+\inf _{W}\{\langle G(W), \mu\rangle\}\right\} \\
& =\sup _{\mu} \inf _{W}\{\langle G(W)+V, \mu\rangle\} \\
& \leq \inf _{W} \sup _{\mu}\{\langle G(W)+V, \mu\rangle\} \\
& =\inf _{W} \sup _{x \in \mathbb{R}^{N}}\{G(W)(x)+V(x)\} .
\end{aligned}
$$

Here the $\mu, W$ are taken over all those satisfying $\mu \in \mathcal{M}_{1}\left(\mathbb{R}^{N}\right)$ and $W$ smooth with $G(W)$ bounded above. Let $W^{*}$ be the solution of (5.1) for $\Lambda=\Lambda^{*}(V)$. Take $W=W^{*}$ in the above relation; we have $J^{*}(V) \leq \Lambda^{*}(V)$.

Lemma 5.8. Let $V$ satisfy (5.2) and let $\mu^{*}$ be the invariant measure of the diffusion in (3.1) for $\Lambda=\Lambda^{*}(V)$ and $W^{*}$ the solution of (5.1). Then

$$
\Lambda^{*}(V)=\left\langle V, \mu^{*}\right\rangle-I\left(\mu^{*}\right)
$$

Proof. We need to prove that

$$
\left\langle V^{\prime}, \mu^{*}\right\rangle-\Lambda^{*}\left(V^{\prime}\right) \leq\left\langle V, \mu^{*}\right\rangle-\Lambda^{*}(V)
$$

for all $V^{\prime} \in C_{b}\left(\mathbb{R}^{N}\right)$. This is equivalent to

$$
\Lambda^{*}\left(V^{\prime}\right)-\Lambda^{*}(V) \geq\left\langle V^{\prime}-V, \mu^{*}\right\rangle, \quad V^{\prime} \in C_{b}\left(\mathbb{R}^{N}\right)
$$

Since $\Lambda^{*}(\cdot)$ is a convex function on $C_{b}\left(\mathbb{R}^{N}\right)$, there is a subgradient $\bar{\mu} \in C_{b}\left(\mathbb{R}^{N}\right)^{*}$ of this function at $V$ such that

$$
\Lambda^{*}\left(V^{\prime}\right)-\Lambda^{*}(V) \geq\left\langle V^{\prime}-V, \bar{\mu}\right\rangle, \quad V^{\prime} \in C_{b}\left(\mathbb{R}^{N}\right)
$$

See [7], Proposition 5.2, Chapter 1 . We only need to prove $\bar{\mu}=\mu^{*}$, since this implies the claim.

First, the nondecreasing of $\Lambda^{*}(\cdot)$ implies $\bar{\mu}$ is nonnegative.
Applying the above relation to $V^{\prime}=V+\alpha, \alpha$ is constant, and using $\Lambda^{*}(V+\alpha)=\Lambda^{*}(V)+\alpha$, we can easily deduce $\bar{\mu}\left(\mathbb{R}^{N}\right)=1$.

Now take $\phi_{n}$ smooth functions on $\mathbb{R}^{N}$ satisfying the following properties: $0 \leq$ $\phi_{n} \leq \phi_{n+1} \leq 1, \phi_{n}$ has compact support, $\nabla \phi_{n}$ are bounded uniformly in $n, \phi_{n} \rightarrow 1$ uniformly on compact sets. Then Proposition 4.1 implies $\Lambda^{*}\left(V+\alpha \phi_{n}\right) \rightarrow \Lambda^{*}(V+$ $\alpha)=\Lambda^{*}(V)+\alpha$ as $n \rightarrow \infty$. Then

$$
\limsup _{n \rightarrow \infty} \alpha\left\langle\phi_{n}, \bar{\mu}\right\rangle \leq \alpha
$$

for all $\alpha$. From this, we have

$$
\lim _{n \rightarrow \infty}\left\langle 1-\phi_{n}, \bar{\mu}\right\rangle=0
$$

Then $\bar{\mu}$ must be a probability measure. This is a consequence of [6], Theorem III.5.13.

We now prove

$$
\int\left(\frac{1}{2} a^{i j}(x) D_{i j} W(x)+\left(b(x)+\hat{a} \nabla W^{*}(x)\right) \cdot \nabla W(x)\right) d \bar{\mu}(x)=0
$$

for $W$ smooth function on $\mathbb{R}^{n}$ with compact support. This implies $\bar{\mu}$ is an invariant measure of the diffusion in (3.1). Hence $\bar{\mu}=\mu^{*}$ by the uniqueness of the invariance measure. To prove this last statement, we take such $W$ and consider

$$
V^{\prime}=V-\left(\frac{1}{2} a^{i j} D_{i j} W+\left(b+\hat{a} \nabla W^{*}\right) \cdot \nabla W+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W\right)
$$

Then by a simple calculation, we see

$$
\begin{aligned}
& \frac{1}{2} a^{i j} D_{i j}\left(W+W^{*}\right)+b \cdot \nabla\left(W+W^{*}\right) \\
& \quad+\frac{1}{2} \hat{a}^{i j} D_{i}\left(W+W^{*}\right) D_{j}\left(W+W^{*}\right)+V_{0}+V^{\prime}=\Lambda^{*}(V) .
\end{aligned}
$$

Therefore, $\Lambda^{*}\left(V^{\prime}\right)=\Lambda^{*}(V)$. Then,

$$
0 \geq\left\langle V^{\prime}-V, \bar{\mu}\right\rangle=-\left\langle\frac{1}{2} a^{i j} D_{i j} W+\left(b+\hat{a} \nabla W^{*}\right) \cdot \nabla W+\frac{1}{2} \hat{a}^{i j} D_{i} W D_{j} W, \bar{\mu}\right\rangle
$$

We replace $W$ by $\alpha W, \alpha>0$, divide the relation by $\alpha$ and let $\alpha$ tend to 0 . We get

$$
-\left\langle\frac{1}{2} a^{i j} D_{i j} W+\left(b+\hat{a} \nabla W^{*}\right) \cdot \nabla W, \bar{\mu}\right\rangle \leq 0 .
$$

We replace $W$ by $-W$. Then we find

$$
\left\langle\frac{1}{2} a^{i j} D_{i j} W+\left(b+\hat{a} \nabla W^{*}\right) \nabla W, \bar{\mu}\right\rangle=0 .
$$

This is what we want to prove.
Corollary 5.9. Let $V \in C_{b}\left(\mathbb{R}^{N}\right)$. Then $J^{*}(V)=\Lambda^{*}(V)$. Let $\mu$ be a probability measure. Then $I(\mu)=J(\mu)$.

Proof. We assume $V \in C_{b}\left(\mathbb{R}^{N}\right)$ satisfying (5.2). Let $\mu^{*}$ be the invariant measure for the diffusion in (3.1) with $W=W^{*}$. Then

$$
J^{*}(V) \geq\left\langle V, \mu^{*}\right\rangle-J\left(\mu^{*}\right) \geq\left\langle V, \mu^{*}\right\rangle-I\left(\mu^{*}\right)=\Lambda^{*}(V)
$$

But we have already proved $J^{*}(V) \leq \Lambda^{*}(V)$. Therefore, they are equal.
We now prove $I(\mu)=J(\mu)$. We use the relation

$$
J(\mu)=\sup _{V \in C_{b}\left(\mathbb{R}^{N}\right)}\left\{\langle V, \mu\rangle-J^{*}(V)\right\} .
$$

See [23], Theorem 7.18. By definition,

$$
I(\mu)=\sup _{V \in C_{b}\left(\mathbb{R}^{N}\right)}\left\{\langle V, \mu\rangle-\Lambda^{*}(V)\right\} .
$$

Since $J^{*}(V)=\Lambda^{*}(V)$ for all $V$, we have $I(\mu)=J(\mu)$.
