

REDUCED-FORM FRAMEWORK UNDER MODEL UNCERTAINTY

In this paper, we introduce a sublinear conditional expectation with respect to a family of possibly nondominated probability measures on a *progressively enlarged* filtration. In this way, we extend the classic reduced-form setting for credit and insurance markets to the case under model uncertainty, when we consider a family of priors possibly mutually singular to each other. Furthermore, we study the superhedging approach in continuous time for payment streams under model uncertainty, and establish several equivalent versions of dynamic robust superhedging duality. These results close the gap between robust framework for financial market, which is recently studied in an intensive way, and the one for credit and insurance markets, which is limited in the present literature only to some very specific cases.

1. Introduction. In this paper, we study the problem of defining a sublinear conditional operator with respect to a progressively enlarged filtration and a family of probability measures possibly mutually singular to each other. In this way, we are able to derive a consistent reduced-form framework for credit and insurance markets under model uncertainty. It is well known that the reduced-form framework can be used for credit risk modeling, for life insurance modeling and for any context where the intensity of occurrence related to a random event of particular interest is deducible from the reference information, but the occurrence itself is not. While robust framework for financial markets has been intensively studied, a corresponding analysis for credit and insurance markets is still missing. The contribution of the paper is hence manifold. As the main result, we extend the classic reduced-form or intensity-based framework in [10] to the case under model uncertainty and introduce a sublinear conditional expectation on a filtration enlarged progressively by a random event, in a way consistent with the construction in [34] on the canonical space endowed with the natural filtration. Second, we note that credit and insurance contracts are typically payment streams, hence we study here for the first time the problem of superhedging for payment streams in continuous time under model uncertainty. Several equivalent dynamic robust superhedging dualities for payment streams are provided. In view of these superhedging results,

the constructed sublinear conditional expectation can be considered as a pricing operator.

In the existing literature for credit risk and insurance modeling, there are several papers which deal with model uncertainty, but only with dominated probability family, for example, [12, 24] and [25]. When a generic family of possibly mutually singular probability measures is taken into account, the main problem of the underlying stochastic analysis is the aggregation of stochastic notions defined traditionally only under one prior (e.g., conditional expectation, stochastic integral, semimartingale decomposition) into one independent of the underlying measure; see, for example, the discussion in [44]. There are many independent results using different approaches, such as capacity theory, stochastic control technique etc., which have been applied to financial market modeling; see, for example, [1, 9, 15–17, 20, 23, 26, 30, 36, 38, 45] and [49]. A pathwise solution is provided in, for example, [29, 31] and [34]. However, the above results hold only on the canonical space endowed with the natural filtration \mathbb{F} and do not allow filtrations with dependency structure. This problem is mentioned in [2] and solved for initial enlargement of filtration. However, the case of enlargement of filtration by introducing a totally inaccessible jump with \mathbb{F} -adapted intensity remains an open problem. This case is particularly relevant to describe an event which occurs as a surprise but admits observable occurrence intensity under the reference filtration \mathbb{F} , as in the case of the default of a financial institute or the decease of a person. The existing construction of sublinear conditional expectation on \mathbb{F} relies on the properties of the natural filtration of the canonical space and cannot be directly extended to a filtration \mathbb{G} progressively enlarged by a random jump. In order to solve this problem, we construct the filtration \mathbb{G} according to the canonical way in Section 6.5 of [10]. Properties of this canonical construction allow the construction of a \mathbb{G} -sublinear conditional expectation, which is consistent with the one in [34] if restricted to \mathbb{F} . However, there are several additional technical difficulties in comparison to the construction on the canonical space. In particular, in order to be well defined, the \mathbb{G} -sublinear conditional expectation requires integrability conditions, which are not necessary for the pathwise construction in [34]. This also implies that this extended sublinear operator only satisfies a weak version of dynamic programming principle or tower property in the general case, as in [35], as well as that it does not preserve integrability. However, the classic tower property and integrability invariance are shown to be satisfied in all cases of most common credit and insurance contracts. In Appendix B, we discuss further sufficient conditions, which guarantee the classic tower property. We refer to Section 2.3, Appendices A and B for a thorough discussion on these issues.

Furthermore, we analyze for the first time the superhedging problem for a generic payment stream under model uncertainty and in continuous time. Superhedging dualities within the context of nondominated probability family have been intensively studied in recent years, for example, [4, 18, 21, 22, 27, 32, 33] and [41]. However, duality results achieved in these papers are mostly limited to the initial

time and can be applied only to contingent claims. The superhedging problem for a generic payment stream, which is typically the case of credit or insurance cash flows, is studied only without model uncertainty and mostly in discrete time, for example, [19, 39] and [40]. Here we investigate dynamic robust superhedging duality for a generic payment stream in continuous time with respect to a nondominated probability family. Still in a dynamic way, we define separately global and local superhedging strategies and prices, which we are able to determine as a consequence of our duality results. These results are first shown in standard setting and then extended to the robust reduced-form framework. In view of the superhedging results, the constructed \mathbb{G} -sublinear conditional expectation can be considered as a pricing operator for insurance and credit risk products. We would like to emphasize that our definitions and results hold without changes also in the case without model uncertainty, that is, when a specific prior is considered.

The paper is organized as follows. In Section 2, we construct a consistent robust reduced-form framework based on the canonical construction in [10]. As the main result, we define explicitly sublinear conditional expectation on the progressively enlarged filtration and analyze its properties. The constructed operator is then applied to the valuation of credit and insurance contracts. In Section 3, we formulate the robust superhedging problem for payment streams in continuous time. We determine the robust superhedging price and prove the existence of optimal robust superhedging strategies first in the standard setting on the canonical space with the natural filtration and then in the reduced-form framework. In Appendix A, we provide a counterexample showing that the classic tower property does not hold in full generality, while in Appendix B, we state sufficient conditions beside the ones in Section 2, which guarantee the validity of the tower property.

2. Reduced-form framework under model uncertainty. In this section, we introduce the reduced-form setting under model uncertainty. We note that, the standard framework under model uncertainty considers only the canonical space endowed with the natural filtration, and do not allow to treat more general filtrations; see [2] for a discussion on this point. In [2], the case of initial enlargement is solved while the case of progressive enlargement of filtration remains open. This issue arises in credit and insurance market modeling, when we want to model an event which occurs as a surprise and is itself not observable under the reference information flow, represented by a filtration \mathbb{F} , but has an \mathbb{F} -adapted intensity process. Here we propose a solution for this problem by using the canonical construction in Section 6.5 of [10] to introduce a random time $\tilde{\tau}$, which is not an \mathbb{F} -stopping time but admits an \mathbb{F} -adapted intensity, and extend the concept of sublinear conditional expectation on the filtration progressively enlarged by this random time. We first recall the setting in [34].

2.1. *(P, F)-conditional expectation.* Let $\Omega = D_0(\mathbb{R}_+, \mathbb{R}^d)$ be the space of càdlàg functions $\omega = (\omega_t)_{t \geq 0}$ in \mathbb{R}^d which start from zero. Equipped with a metric induced by the Skorokhod topology, Ω is a Polish space, that is, a complete separable metrizable space. We denote by $\mathcal{F} := \mathcal{B}(\Omega)$ the Borel σ -algebra and by $\mathcal{P}(\Omega)$ the set of all probability measures on (Ω, \mathcal{F}) . On $\mathcal{P}(\Omega)$, we consider the topology of weak convergence. According to Prokhorov’s theorem (see, e.g., [11, 14] and [42]), $\mathcal{P}(\Omega)$ inherits from Ω the property of being a Polish space with the Lévy–Prokhorov metric.

We consider the canonical process $B := (B_t)_{t \geq 0}$, where $B_t(\omega) := \omega_t, t \geq 0$, and denote its raw filtration by $\mathbb{F} = (\mathcal{F}_t)_{t \geq 0}$. It is easy to see that $\mathcal{F}_0 = \{\emptyset, \Omega\}$ and $\mathcal{F}_\infty := \bigvee_{t \geq 0} \mathcal{F}_t = \mathcal{F}$. For every $P \in \mathcal{P}(\Omega)$ and $t \in \overline{\mathbb{R}}_+$, we denote by \mathcal{N}_t^P the collection of sets which are (P, \mathcal{F}_t) -null and define

$$\mathcal{F}_t^* := \mathcal{F}_t \vee \mathcal{N}_t^*, \quad \mathcal{N}_t^* := \bigcap_{P \in \mathcal{P}(\Omega)} \mathcal{N}_t^P.$$

The corresponding universally completed filtration is denoted by $\mathbb{F}^* := (\mathcal{F}_t^*)_{t \geq 0}$. Furthermore, for every $P \in \mathcal{P}(\Omega)$ the usual P -augmentation is denoted by \mathbb{F}_+^P , that is, \mathbb{F}_+^P is the right continuous version of $\mathbb{F}^P := (\mathcal{F}_t^P)_{t \geq 0}$, with

$$\mathcal{F}_t^P := \mathcal{F}_t \vee \mathcal{N}_\infty^P, \quad t \geq 0.$$

Trivially, the above enlargements of the raw filtration are ordered in the following way:

$$(2.1) \quad \mathcal{F}_t \subseteq \mathcal{F}_t^* \subseteq \mathcal{F}_t^P \subseteq \mathcal{F}_{t+}^P, \quad t \geq 0, P \in \mathcal{P}.$$

Let $\mathcal{P} \subseteq \mathcal{P}(\Omega)$ be a generic nonempty set, we define the following σ -algebra:

$$\mathcal{F}^{\mathcal{P}} := \mathcal{F} \vee \mathcal{N}_\infty^{\mathcal{P}}, \quad \mathcal{N}_\infty^{\mathcal{P}} := \bigcap_{P \in \mathcal{P}} \mathcal{N}_\infty^P.$$

We denote by $L^0(\Omega)$ the space of all real-valued $\mathcal{F}^{\mathcal{P}}$ -measurable functions and define the upper expectation $\mathcal{E} : L^0(\Omega) \rightarrow \overline{\mathbb{R}}$ associated to \mathcal{P} by

$$(2.2) \quad \mathcal{E}(X) := \sup_{P \in \mathcal{P}} E^P[X], \quad X \in L^0(\Omega),$$

where for every $P \in \mathcal{P}$, we set $E^P[X] := E^P[X^+] - E^P[X^-]$ if $E^P[X^+]$ or $E^P[X^-]$ is finite, and we use the convention $E^P[X] := -\infty$ if $E^P[X^+] = E^P[X^-] = +\infty$, as in [44].

REMARK 2.1. Throughout the paper, all results also hold if the space $D_0(\mathbb{R}_+, \mathbb{R}^d)$ is replaced by $C_0(\mathbb{R}_+, \mathbb{R}^d)$, that is, the space of continuous functions $\omega = (\omega_t)_{t \geq 0}$ in \mathbb{R}^d which start from zero, equipped with the topology of locally uniform convergence. Since there is no ambiguity, we keep the notations B and \mathbb{F} for the canonical process on $C_0(\mathbb{R}_+, \mathbb{R}^d)$ and its natural filtration, respectively.

We now recall the pathwise construction in [34] of conditional expectation on Ω with respect to the filtration \mathbb{F} and a family $\mathcal{P} \subseteq \mathcal{P}(\Omega)$ of probability measures. For notational simplicity, we consider only the case when the parametrized families in Assumption 2.1 of [34] have no dependence on the parameters. As noted in, for example, [9, 29] and [32], the results in [34] hold both on the space $D_0(\mathbb{R}_+, \mathbb{R}^d)$ and on the space $C_0(\mathbb{R}_+, \mathbb{R}^d)$.

We introduce the following notation according to [34]. Let τ be a finite-valued \mathbb{F} -stopping time and $\omega \in \Omega$. For every $\omega' \in \Omega$, the concatenation $\omega \otimes_\tau \omega' := ((\omega \otimes_\tau \omega')_t)_{t \geq 0}$ of (ω, ω') at τ is given by

$$(2.3) \quad (\omega \otimes_\tau \omega')_t := \omega_t \mathbf{1}_{[0, \tau(\omega))}(t) + (\omega_{\tau(\omega)} + \omega'_{t-\tau(\omega)}) \mathbf{1}_{[\tau(\omega), +\infty)}(t), \quad t \geq 0.$$

For every function X on Ω , we define the following function:

$$(2.4) \quad X^{\tau, \omega}(\omega') := X(\omega \otimes_\tau \omega'), \quad \omega' \in \Omega.$$

Similarly, for every probability measure P we set

$$P^{\tau, \omega}(A) := P_\tau^\omega(\omega \otimes_\tau A), \quad A \in \mathcal{B}(\Omega),$$

which is still a probability measure, where $\omega \otimes_\tau A := \{\omega \otimes_\tau \omega' : \omega' \in A\}$ and P_τ^ω is the \mathcal{F}_τ -conditional probability measure chosen to be

$$P_\tau^\omega(\omega' \in \Omega : \omega' = \omega \text{ on } [0, \tau(\omega)]) = 1.$$

Furthermore, we recall that a set of a Polish space is called analytic if it is the image of a Borel set of an other Polish space under a Borel-measurable mapping. A \mathbb{R} -valued function f on a Polish space is called upper semianalytic if $\{f > c\}$ is analytic for every $c \in \mathbb{R}$. In particular, we note that all Borel sets are analytic and all Borel-measurable functions are upper semianalytic.

ASSUMPTION 2.2. For every finite-valued \mathbb{F} -stopping time τ , the family \mathcal{P} satisfies the following conditions:

1. measurability: the set $\mathcal{P} \in \mathcal{P}(\Omega)$ is analytic;
2. invariance: $P^{\tau, \omega} \in \mathcal{P}$ for P -a.e. $\omega \in \Omega$;
3. stability under pasting: for every \mathcal{F}_τ -measurable kernel $\kappa : \Omega \rightarrow \mathcal{P}(\Omega)$ such that $\kappa(\omega) \in \mathcal{P}$ for P -a.e. $\omega \in \Omega$, the following measure

$$\bar{P}(A) := \iint (\mathbf{1}_A)^{\tau, \omega}(\omega') \kappa(d\omega'; \omega) P(d\omega), \quad A \in \mathcal{B}(\Omega),$$

still belongs to \mathcal{P} .

REMARK 2.3. As shown in [29], Assumption 2.2 is satisfied when the family \mathcal{P} is generated by all semimartingale laws with differential characteristics taking values in a Borel-measurable set $\theta \subseteq \mathbb{R}^d \times \mathbb{S}_+^d \times \mathcal{L}$, where \mathbb{S}_+^d is the set of symmetric nonnegative definite $(d \times d)$ -matrices and \mathcal{L} is the set of all Lévy measures. In particular, this case includes the G -expectations introduced in [36].

The following proposition is a special case of Theorem 2.3 of [34], when we restrict our attention to one family \mathcal{P} satisfying Assumption 2.2.

PROPOSITION 2.4. *Under Assumption 2.2, for all finite-valued \mathbb{F} -stopping times σ, τ such that $\sigma \leq \tau$ and for every upper semianalytic function X on Ω , the function $\mathcal{E}_\tau(X)$ defined by*

$$(2.5) \quad \mathcal{E}_\tau(X)(\omega) := \mathcal{E}(X^{\tau, \omega}) = \sup_{P \in \mathcal{P}} E^P[X^{\tau, \omega}], \quad \omega \in \Omega$$

is \mathcal{F}_τ^* -measurable, upper semianalytic and satisfies the following consistency condition:

$$(2.6) \quad \mathcal{E}_\tau(X) = \text{ess sup}_{P' \in \mathcal{P}(\tau; P)}^P E^{P'}[X|\mathcal{F}_\tau] \quad P\text{-a.s. for all } P \in \mathcal{P},$$

where $\mathcal{P}(\tau; P) := \{P' \in \mathcal{P} : P' = P \text{ on } \mathcal{F}_\tau\}$. Furthermore, the tower property holds, that is,

$$(2.7) \quad \mathcal{E}_\sigma(X)(\omega) = \mathcal{E}_\sigma(\mathcal{E}_\tau(X))(\omega) \quad \text{for all } \omega \in \Omega.$$

DEFINITION 2.5. We call the family of sublinear conditional expectations $(\mathcal{E}_t)_{t \geq 0}$ $(\mathcal{P}, \mathbb{F})$ -conditional expectation.

In the special case of G -setting introduced in [36], G -martingales are càdlàg; see, for example, [48]. However, under generic assumptions, the process $(\mathcal{E}_t(X))_{t \geq 0}$ with X upper semianalytic is not always càdlàg. In the following proposition, we show an independent result which gives sufficient conditions for having $(\mathcal{E}_t(X))_{t \geq 0}$ càdlàg. We recall that by Prokhorov’s theorem, a family of probability measures is tight if and only if its weak closure is compact. In particular, the probability measure family which generates the G -expectation is tight; see, for example, Proposition 49 in [15].

PROPOSITION 2.6. *If \mathcal{P} is a tight family satisfying Assumption 2.2 and X is an upper semianalytic function on Ω which is bounded and continuous P -a.s. for all $P \in \mathcal{P}$, then the process $(\mathcal{E}_t(X))_{t \geq 0}$ is càdlàg.*

PROOF. Let $A \in \mathcal{B}(\Omega)$ be a set such that X is bounded and continuous on A and $P(A^c) = 0$ for every $P \in \mathcal{P}$. We start with the right continuity. Let $t \geq 0$ and $(t_n)_{n \in \mathbb{N}}$ be a sequence in \mathbb{R} such that $t_n \downarrow t$. We want to show that for all $\omega \in \Omega$,

$$\mathcal{E}_t(X)(\omega) = \lim_{n \rightarrow \infty} \mathcal{E}_{t_n}(X)(\omega).$$

Consider $\omega \in \Omega$. By definitions (2.5) and (2.4), we have

$$\mathcal{E}_t(X)(\omega) = \mathcal{E}(X^{t, \omega}) = \sup_{P \in \mathcal{P}} E^P[X^{t, \omega}] = \sup_{P \in \mathcal{P}} \int X(\omega \otimes_t \omega') P(d\omega').$$

For fixed t and ω , we define the concatenation function $c^{t,\omega} : \Omega \rightarrow \Omega$ by $c^{t,\omega}(\omega') := \omega \otimes_t \omega'$, $\omega' \in \Omega$. This function is uniformly continuous in ω' with respect to Skorokhod topology on $\Omega = D_0(\mathbb{R}_+, R^d)$.² Namely, if we denote by d the distance induced by Skorokhod topology on Ω , we have that for every $\varepsilon > 0$, there is a $\delta > 0$ such that for all $\omega', \omega'' \in \Omega$ with $d(\omega', \omega'') < \delta$, it holds

$$d(\omega \otimes_t \omega', \omega \otimes_t \omega'') < \varepsilon.$$

Indeed, it is sufficient to take $\delta = \varepsilon$. We note that $\delta = \varepsilon$ does not depend on the choice of t , hence in particular the sequence of functions $(c^{t_n,\omega})_{n \in \mathbb{N}}$ is equicontinuous. Furthermore, the sequence $(c^{t_n,\omega})_{n \in \mathbb{N}}$ converges to $c^{t,\omega}$ pointwisely,

$$d(\omega \otimes_{t_n} \omega', \omega \otimes_t \omega') \xrightarrow{n \rightarrow \infty} 0 \quad \text{for all } \omega' \in \Omega,$$

since $D_0(\mathbb{R}_+, R^d)$ is the space of càdlàg paths. Hence, by the Ascoli–Arzelà theorem, the sequence $(c^{t_n,\omega})_{n \in \mathbb{N}}$ converges to $c^{t,\omega}$ uniformly on every compact set $K \subseteq \Omega$, that is, we have

$$\sup_{\omega' \in K} d(c^{t_n,\omega}(\omega'), c^{t,\omega}(\omega')) = \sup_{\omega' \in K} d(\omega \otimes_{t_n} \omega', \omega \otimes_t \omega') \xrightarrow{n \rightarrow \infty} 0.$$

In particular, given a compact set $K \in \mathcal{B}(\Omega)$, the composition $X^{t,\omega} = X \circ c^{t,\omega}$ is bounded and continuous on $A \cap K$, and $X^{t,\omega}$ is the uniform limit of $(X^{t_n,\omega})_{n \in \mathbb{N}}$, that is, for every $\varepsilon > 0$, there is $N \in \mathbb{N}$ such that for all $n \geq N$,

$$|X(\omega \otimes_{t_n} \omega') - X(\omega \otimes_t \omega')| < \varepsilon \quad \text{for every } \omega' \in A \cap K.$$

As a consequence, on one hand, for every $n \in \mathbb{N}$, the function f^n defined by $f^n(P) := E^P[X^{t_n,\omega}]$, $P \in \mathcal{P}(\Omega)$, is continuous in P with respect to Lévy–Prokhorov metric on $\mathcal{P}(\Omega)$, since it coincides with the metric induced by weak convergence of measures. Hence the restriction $f^n|_{\mathcal{P}}$ is still continuous. On the other hand, the tightness of \mathcal{P} yields that there is a compact set $K \in \mathcal{B}(\Omega)$ such that $P(K^c) < \frac{\varepsilon}{4C}$ for all $P \in \mathcal{P}$, where C is such that $|X(\omega)| \leq C$ for every $\omega \in A$. For n big enough, since $X^{t,\omega}$ is the P -a.s. uniform limit of $(X^{t_n,\omega})_{n \in \mathbb{N}}$ on $A \cap K$, we have

$$\begin{aligned} & |E^P[X^{t_n,\omega}] - E^P[X^{t,\omega}]| \\ & \leq E^P[|X^{t_n,\omega} - X^{t,\omega}|] \\ & = E^P[\mathbf{1}_{A \cap K} |X^{t_n,\omega} - X^{t,\omega}|] + E^P[\mathbf{1}_{A \setminus K} |X^{t_n,\omega} - X^{t,\omega}|] \\ & < \frac{\varepsilon}{2} + \frac{\varepsilon}{4C} \cdot 2C = \varepsilon \quad \text{for all } P \in \mathcal{P}. \end{aligned}$$

²Or locally uniform convergence on $\Omega = C_0(\mathbb{R}_+, R^d)$.

Hence for all $\omega \in \Omega$,

$$\begin{aligned} \mathcal{E}(X^{t,\omega}) &= \sup_{P \in \mathcal{P}} E^P \left[\lim_{n \rightarrow \infty} X^{t_n,\omega} \right] \\ &= \sup_{P \in \mathcal{P}} \lim_{n \rightarrow \infty} E^P [X^{t_n,\omega}] \\ &= \lim_{n \rightarrow \infty} \sup_{P \in \mathcal{P}} E^P [X^{t_n,\omega}] = \lim_{n \rightarrow \infty} \mathcal{E}(X^{t_n,\omega}). \end{aligned}$$

A similar argument also shows the existence and finiteness of the left limit, which concludes the proof. \square

REMARK 2.7. Proposition 4.5 of [33] introduces a family of sublinear operators depending on a filtration different from \mathbb{F}^* , that is,

$$(\mathbb{F}_{t+} \cup \mathcal{N}_T^{\mathcal{P}})_{t \in [0, T]},$$

where $\mathcal{N}_T^{\mathcal{P}}$ is the collection of sets which are (P, \mathcal{F}_T) -null for all $P \in \mathcal{P}$. In this way, the resulting sublinear operator is càdlàg in t . However, for the applications which we consider in this paper, it is fundamental to work with the filtration \mathbb{F}^* , since it represents the information available to the agents.

2.2. *Space construction.* We keep the same notation in Section 2.1. In this section, we follow the canonical space construction in Section 6.5 of [10] to introduce a random time $\tilde{\tau}$, which is not an \mathbb{F} -stopping time but has an \mathbb{F} -progressively measurable intensity process μ , to represent a totally unexpected default or decrease time under model uncertainty. Let $\hat{\Omega}$ be an additional Polish space equipped with its Borel σ -algebra $\mathcal{B}(\hat{\Omega})$. We now consider the product measurable space $(\tilde{\Omega}, \mathcal{G}) := (\Omega \times \hat{\Omega}, \mathcal{B}(\Omega) \otimes \mathcal{B}(\hat{\Omega}))$, and use the notation $\tilde{\omega} = (\omega, \hat{\omega})$ for $\omega \in \Omega$ and $\hat{\omega} \in \hat{\Omega}$. The following standard conventions are made on the product space $(\tilde{\Omega}, \mathcal{G})$. For every function or process X on $(\Omega, \mathcal{B}(\Omega))$, we consider its natural immersion into the product space, that is, $X(\tilde{\omega}) := X(\omega)$ for all $\omega \in \Omega$, similarly for $(\hat{\Omega}, \mathcal{B}(\hat{\Omega}))$. For every sub- σ -algebra \mathcal{A} of $\mathcal{B}(\Omega)$, we consider its natural extension $\mathcal{A} \otimes \{\emptyset, \hat{\Omega}\}$ as a sub- σ -algebra of \mathcal{G} on the product space, similarly for sub- σ -algebras of $\mathcal{B}(\hat{\Omega})$. To avoid cumbersome notation, when there is no ambiguity, $\mathcal{A} \otimes \{\emptyset, \hat{\Omega}\}$ is still denoted by \mathcal{A} .

On $(\hat{\Omega}, \mathcal{B}(\hat{\Omega}))$, we fix a probability measure \hat{P} such that $(\hat{\Omega}, \mathcal{B}(\hat{\Omega}), \hat{P})$ is an atomless probability space, that is, there exists a random variable with an absolutely continuous distribution, and let ξ be a Borel-measurable surjective random variable

$$\xi : (\hat{\Omega}, \mathcal{B}(\hat{\Omega}), \hat{P}) \rightarrow ([0, 1], \mathcal{B}([0, 1])),$$

with uniform distribution, that is,

$$\xi \sim U([0, 1]).$$

Without loss of generality, we assume $\mathcal{B}(\hat{\Omega}) = \sigma(\xi)$.

REMARK 2.8. We note that the space $(\hat{\Omega}, \mathcal{B}(\hat{\Omega}), \hat{P})$ can be set canonically as

$$([0, 1], \mathcal{B}([0, 1]), U([0, 1])),$$

with ξ the identity function on $[0, 1]$.

We denote by $\mathcal{P}(\tilde{\Omega})$ the set of all probability measures on $(\tilde{\Omega}, \mathcal{G})$ and consider the following family of probability measures

$$(2.8) \quad \tilde{\mathcal{P}} := \{ \tilde{P} \in \mathcal{P}(\tilde{\Omega}) : \tilde{P} = P \otimes \hat{P}, P \in \mathcal{P} \}.$$

On $(\Omega, \mathcal{B}(\Omega))$, let $\Gamma := (\Gamma_t)_{t \geq 0}$ be a real-valued, \mathbb{F} -adapted, continuous and increasing process such that $\Gamma_0 = 0$ and $\Gamma_\infty = +\infty$. In particular, Γ can be represented by

$$\Gamma_t := \int_0^t \mu_s \, ds, \quad t \geq 0,$$

where $\mu := (\mu_t)_{t \geq 0}$ is a nonnegative \mathbb{F} -progressively measurable process such that for all $t \geq 0$ and for all $\omega \in \Omega$,

$$\int_0^t \mu_s(\omega) \, ds < \infty.$$

We define

$$\tilde{\tau} := \inf\{t \geq 0 : e^{-\Gamma_t} \leq \xi\} = \inf\{t \geq 0 : \Gamma_t \leq -\ln \xi\}$$

on $\tilde{\Omega} = \Omega \times \hat{\Omega}$, with the convention $\inf \emptyset = \infty$.

REMARK 2.9. An immediate consequence of the above assumptions is that $\tilde{\tau}(\omega, \cdot)$ is a surjective function on \mathbb{R}_+ for every fixed $\omega \in \Omega$.

LEMMA 2.10. For every $t \geq 0$, we have $\{\tilde{\tau} \leq t\} = \{e^{-\Gamma_t} \leq \xi\}$.

PROOF. We note that $\{e^{-\Gamma_t} \leq \xi\} \subseteq \{\tilde{\tau} \leq t\}$ always holds. The other inclusion follows from

$$\tilde{\tau} = \min\{s \geq 0 : e^{-\Gamma_s} \leq \xi\},$$

since Γ is continuous and nondecreasing. \square

Under every $\tilde{P} \in \tilde{\mathcal{P}}$, we define the \tilde{P} -hazard process $\Gamma^{\tilde{P}} := (\Gamma_t^{\tilde{P}})_{t \geq 0}$ by

$$\Gamma_t^{\tilde{P}} := -\ln \tilde{P}(\tilde{\tau} > t | \mathcal{F}_t), \quad t \geq 0.$$

The following proposition is a natural but important consequence of the above construction.

PROPOSITION 2.11. *The process Γ is a \tilde{P} -a.s. version of \tilde{P} -hazard process $\Gamma^{\tilde{P}}$ for every $\tilde{P} \in \tilde{\mathcal{P}}$.*

PROOF. By Lemma 2.10,

$$\{\tilde{\tau} > t\} = \{e^{-\Gamma_t} > \xi\} \quad \text{for all } t \geq 0.$$

Hence for every $t \geq 0$ and for every $\tilde{P} \in \tilde{\mathcal{P}}$ with $\tilde{P} = P \otimes \hat{P}$, it holds

$$\begin{aligned} e^{-\Gamma_t^{\tilde{P}}(\omega)} &= \tilde{P}(\tilde{\tau} > t | \mathcal{F}_t)(\omega) = \tilde{P}(e^{-\Gamma_t} > \xi | \mathcal{F}_t)(\omega) \\ &\stackrel{(i)}{=} \tilde{P}(e^{-x} > \xi) |_{x=\Gamma_t(\omega)} = \hat{P}(e^{-x} > \xi) |_{x=\Gamma_t(\omega)} \\ &\stackrel{(ii)}{=} e^{-x} |_{x=\Gamma_t(\omega)} \\ &= e^{-\Gamma_t(\omega)} \quad \text{for } \tilde{P}\text{-a.e. } \omega, \end{aligned}$$

where equality (i) follows from the independence between ξ and \mathcal{F}_t under each $\tilde{P} \in \tilde{\mathcal{P}}$, and equality (ii) follows from the fact that ξ has uniform distribution on $(\hat{\Omega}, \hat{\mathcal{F}}, \hat{P})$. The continuity of Γ yields

$$\Gamma^{\tilde{P}} = \Gamma \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

which concludes the proof. \square

On the product space $\tilde{\Omega}$, we consider the filtration $\mathbb{H} := (\mathcal{H}_t)_{t \geq 0}$ generated by the process $H := (H_t)_{t \geq 0}$ defined by

$$H_t := \mathbf{1}_{\{\tilde{\tau} \leq t\}}, \quad t \geq 0,$$

and the enlarged filtration $\mathbb{G} := (\mathcal{G}_t)_{t \geq 0}$ defined by $\mathcal{G}_t := \mathcal{F}_t \vee \mathcal{H}_t, t \geq 0$. In particular, we have $\mathcal{G} = \mathcal{F}_\infty \otimes \sigma(\xi) = \mathcal{H}_\infty \vee \mathcal{F}_\infty = \sigma(\tilde{\tau}) \vee \mathcal{F}_\infty$. By construction, $\tilde{\tau}$ is an \mathbb{H} -stopping time as well as a \mathbb{G} -stopping time, but not an \mathbb{F} -stopping time. The filtration \mathbb{F} can be interpreted as the reference information flow, while the filtration \mathbb{G} represents the minimal information flow of the extended market including default information. As in Section 2.1, for every $\tilde{P} \in P(\tilde{\Omega})$ we denote by $\mathbb{G}^*, \mathbb{G}^{\tilde{P}}$ and $\mathbb{G}_+^{\tilde{P}}$ the corresponding enlargements of the raw filtration \mathbb{G} . Similar to (2.1), we have

$$\mathcal{G}_t \subseteq \mathcal{G}_t^* \subseteq \mathcal{G}_t^{\tilde{P}} \subseteq \mathcal{G}_{t+}^{\tilde{P}}, \quad t \geq 0, \tilde{P} \in \tilde{\mathcal{P}}.$$

2.3. $(\tilde{\mathcal{P}}, \mathbb{G})$ -conditional expectation. In this section, we give a construction of sublinear conditional expectations with respect to the filtration \mathbb{G} and the family of probability $\tilde{\mathcal{P}}$ introduced in (2.8). These will be denoted by $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ and called $(\tilde{\mathcal{P}}, \mathbb{G})$ -conditional expectation. Such construction is motivated by the results in Section 2.1 and should reflect the underlying structure of the space construction in

Section 2.2. According to, for example, [13, 34, 44, 46] and [47], the family $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ should satisfy the following necessary consistency condition: for every $t \geq 0$ and \mathcal{G} -measurable function \tilde{X} on $\tilde{\Omega}$,

$$(2.9) \quad \tilde{\mathcal{E}}_t(\tilde{X}) = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})} E^{\tilde{P}'}[\tilde{X} | \mathcal{G}_t] \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

where $\tilde{\mathcal{P}}(t; \tilde{P}) := \{\tilde{P}' \in \tilde{\mathcal{P}} : \tilde{P}' = \tilde{P} \text{ on } \mathcal{G}_t\}$. We emphasize that this cannot be done by using exactly the same method proposed in [34] and summarized in Section 2.1, even if we choose $\hat{\Omega} = D_0(\mathbb{R}^+, \mathbb{R}^d)$ or $\hat{\Omega} = C_0(\mathbb{R}^+, \mathbb{R}^d)$. Indeed, the approach in [34] is based on some special properties of the natural filtration generated by the canonical process, for example, Galmarino’s test, which the filtration \mathbb{G} does not have. Nevertheless, we are able to extend the results of [34] to the setting of Section 2.2, and construct a consistent $(\tilde{\mathcal{P}}, \mathbb{G})$ -conditional expectation. As in [35], we show that the family $(\tilde{\mathcal{E}}_t(\tilde{X}))_{t \geq 0}$ satisfies a weak form of time-consistency, called also dynamic programming principle or tower property, that is,

$$(2.10) \quad \tilde{\mathcal{E}}_s(\tilde{\mathcal{E}}_t(\tilde{X})) \geq \tilde{\mathcal{E}}_s(\tilde{X}) \quad \text{for all } 0 \leq s \leq t \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}.$$

From an economical point of view, by using $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ as pricing functional, the weak tower property (2.10) can be interpreted as: making valuation of an evaluated future price is more conservative than making direct valuation of the price. We provide some sufficient conditions such that the classic tower property holds. These include all cases of often used credit and insurance contracts, as explained in Section 2.4.

As in Section 2.1, we use the corresponding notation and denote the upper expectation associated to $\tilde{\mathcal{P}}$ by $\tilde{\mathcal{E}}$, that is,

$$(2.11) \quad \tilde{\mathcal{E}}(\tilde{X}) := \sup_{\tilde{P} \in \tilde{\mathcal{P}}} E^{\tilde{P}}[\tilde{X}], \quad \tilde{X} \in L^0(\tilde{\Omega}).$$

Let $\mathcal{G}^P := \mathcal{G} \vee \mathcal{N}_{\infty}^P$, $P \in \mathcal{P}$, and $\mathcal{G}^{\tilde{P}} := \mathcal{G} \vee \mathcal{N}_{\infty}^{\tilde{P}}$. We introduce the following sets:

$$L^1_{\tilde{P}}(\tilde{\Omega}) := \{ \tilde{X} | \tilde{X} : (\tilde{\Omega}, \mathcal{G}^{\tilde{P}}) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})) \text{ measurable function such that } E^{\tilde{P}}[|\tilde{X}|] < \infty \},$$

for every $\tilde{P} \in \tilde{\mathcal{P}}$, and

$$L^1(\tilde{\Omega}) := \{ \tilde{X} | \tilde{X} : (\tilde{\Omega}, \mathcal{G}^{\tilde{P}}) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})) \text{ measurable function such that } \tilde{\mathcal{E}}(|\tilde{X}|) < \infty \}.$$

We emphasize that in the above definitions we only consider (Ω, \mathcal{G}^P) -measurable (or $(\Omega, \mathcal{G}^{\tilde{P}})$ -measurable, resp.) functions, and not $(\Omega, \mathcal{G}^{\tilde{P}})$ -measurable (or $(\Omega, \mathcal{G}^{\tilde{P}})$ -measurable, resp.) functions; see also Remark 2.14.

Given $t \geq 0$, every real-valued function \tilde{X} on $\tilde{\Omega}$ can be decomposed in

$$\tilde{X} = \mathbf{1}_{\{\tilde{\tau} \leq t\}} \tilde{X} + \mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}.$$

Corollary 5.1.2 of [10], which holds without the usual conditions on the filtrations, together with Proposition 2.11 shows that if $\tilde{X} \in L^1(\tilde{\Omega})$, then for every $\tilde{P} \in \tilde{\mathcal{P}}$,

$$\begin{aligned} E^{\tilde{P}}[\tilde{X}|\mathcal{G}_t] &= \mathbf{1}_{\{\tilde{\tau} \leq t\}} E^{\tilde{P}}[\tilde{X}|\sigma(\tilde{\tau}) \vee \mathcal{F}_t] \\ (2.12) \quad &+ \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\Gamma_t} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}|\mathcal{F}_t] \quad \tilde{P}\text{-a.s.} \end{aligned}$$

Our goal is to find a representation of (2.12) with the right-hand side reduced to conditional expectations restricted to Ω . This will play a fundamental role in the definition of conditional expectation on $\tilde{\Omega}$. The following lemma solves the problem for the second term on the right-hand side of (2.12). For the sake of simplicity, we use a slight abuse of notation and denote

$$(2.13) \quad E^{\hat{P}}[\tilde{X}](\omega) := \int_{\hat{\Omega}} \tilde{X}(\omega, \hat{\omega}) \hat{P}(d\hat{\omega}), \quad \omega \in \Omega.$$

LEMMA 2.12. *Let $t \geq 0$ and $\tilde{P} = P \otimes \hat{P}$. If $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$, then*

$$E^{\tilde{P}}[\tilde{X}|\mathcal{F}_t] = E^P[E^{\hat{P}}[\tilde{X}]|\mathcal{F}_t] \quad \tilde{P}\text{-a.s.}$$

PROOF. It is sufficient to see that for any $A \in \mathcal{F}_t$, by the Fubini–Tonelli theorem we have

$$\begin{aligned} \int_{A \times \hat{\Omega}} \tilde{X}(\omega, \hat{\omega}) \tilde{P}(d(\omega, \hat{\omega})) &= \int_A \int_{\hat{\Omega}} \tilde{X}(\omega, \hat{\omega}) \hat{P}(d\hat{\omega}) P(d\omega) \\ &= \int_A E^{\hat{P}}[\tilde{X}](\omega) P(d\omega) \\ &= \int_{A \times \hat{\Omega}} E^P[E^{\hat{P}}[\tilde{X}]|\mathcal{F}_t](\omega) \tilde{P}(d(\omega, \hat{\omega})), \end{aligned}$$

where we use the notation introduced in (2.13). \square

Now we focus on the first term on the right-hand side of (2.12).

LEMMA 2.13. *Let $t \in \overline{\mathbb{R}}_+$. If \tilde{X} is a real-valued $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable function on $\tilde{\Omega}$, then there exists a unique measurable function*

$$\varphi : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_t) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})),$$

such that

$$(2.14) \quad \tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}.$$

PROOF. The uniqueness of φ which satisfies (2.14) follows directly from the surjectivity of $\tilde{\tau}$ for every fixed $\omega \in \Omega$, see Remark 2.9. Indeed, if φ and ψ are two functions such that

$$\varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega) = \psi(\tilde{\tau}(\omega, \hat{\omega}), \omega) \quad \text{for all } (\omega, \hat{\omega}) \in \tilde{\Omega},$$

then for every $(x, \omega) \in \mathbb{R}_+ \times \Omega$, the surjectivity of $\tilde{\tau}$ for every fixed $\omega \in \Omega$ yields that there is an $\hat{\omega} \in \tilde{\Omega}$ such that $\tau(\omega, \hat{\omega}) = x$. Consequently,

$$\varphi(x, \omega) = \psi(x, \omega) \quad \text{for all } (x, \omega) \in \mathbb{R}_+ \times \Omega.$$

Now we consider the following set:

$$E = \{ \tilde{X} | (\tilde{\Omega}, \sigma(\tilde{\tau}) \vee \mathcal{F}_t) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})), \tilde{X} \text{ of the form (2.14)} \},$$

and show that it contains a monotone class. The set E clearly contains all constants and is closed under linear operations. Furthermore, all indicator functions of a π -system which generates $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ belong to E . Now let $(\tilde{X}_n)_{n \in \mathbb{N}}$ be a sequence in E such that $\tilde{X}_n(\tilde{\omega}) \uparrow \tilde{X}(\tilde{\omega})$ for all $\tilde{\omega} \in \tilde{\Omega}$, where \tilde{X} is a bounded function. For every $n \in \mathbb{N}$, we have $\tilde{X}_n(\omega, \hat{\omega}) = \varphi_n(\tilde{\tau}(\omega, \hat{\omega}), \omega)$ for all $(\omega, \hat{\omega}) \in \tilde{\Omega}$, where φ_n is a measurable function

$$\varphi_n : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_t) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})).$$

By Remark 2.9 and the boundedness of \tilde{X} , we note that the function

$$(2.15) \quad \varphi(z, \omega) := \lim_{n \rightarrow \infty} \varphi_n(z, \omega), \quad z \in \mathbb{R}_+, \omega \in \Omega,$$

is well defined and finite. In particular, φ is also $(\mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_t)$ -measurable. By applying again Remark 2.9, \tilde{X} can be represented by

$$\tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}.$$

Hence X belongs to E as well. By the monotone class theorem (see, e.g., Theorem 8 in Chapter I of [43]), the set E contains all bounded $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable functions.

Furthermore, every nonnegative $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable function \tilde{X} is the pointwise limit of a nondecreasing sequence of simple functions, that is, there exists a sequence of simple functions $(\tilde{X}_n)_{n \in \mathbb{N}}$ such that $\tilde{X}_n(\tilde{\omega}) \uparrow \tilde{X}(\tilde{\omega})$ for all $\tilde{\omega} \in \tilde{\Omega}$. In particular, by the argument above, if $\tilde{X}_n(\omega, \hat{\omega}) = \varphi_n(\tilde{\tau}(\omega, \hat{\omega}), \omega)$ for all $(\omega, \hat{\omega}) \in \tilde{\Omega}$, by defining φ as the pointwise limit of $(\varphi_n)_{n \in \mathbb{N}}$ as in (2.15), we conclude that all nonnegative $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable functions have representation (2.14). The results can be extended to all $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable functions since $\tilde{X} = \tilde{X}^+ + \tilde{X}^-$. \square

REMARK 2.14. Lemma 2.13 can be carried out without changes if \tilde{X} is \mathcal{G}^P -measurable or \mathcal{G}^P -measurable. In such case, φ is $(\mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_\infty^P)$ -measurable or

$(\mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_\infty^P)$ -measurable, respectively. However, it does not hold if \tilde{X} is $\mathcal{G}^{\tilde{P}}$ -measurable with $\mathcal{G}^{\tilde{P}} := \mathcal{G} \vee \mathcal{N}_\infty^{\tilde{P}}$ or $\mathcal{G}^{\tilde{P}}$ -measurable with $\mathcal{G}^{\tilde{P}} = \mathcal{G} \vee \mathcal{N}_\infty^{\tilde{P}}$, respectively. The reason is analogue to the case of the classic Doob–Dynkin lemma, which states that if X, Y are two real-valued measurable functions and Y is $\sigma(X)$ -measurable, then there is a Borel-measurable function f such that $Y = f(X)$. This representation does not hold pathwisely if $\sigma(X)$ is completed with null sets of some measure Q , that is, if $\sigma(X)$ is replaced by $\sigma(X) \vee \mathcal{N}^Q$. Indeed, it is sufficient to take $Y = \mathbf{1}_A$ with $A \in \mathcal{N}^Q$ as a counterexample.

LEMMA 2.15. *Let $t \geq 0$ and $\tilde{P} = P \otimes \hat{P}$. If $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$, then*

$$(2.16) \quad \mathbf{1}_{\{\tilde{\tau} \leq t\}} E^{\tilde{P}}[\tilde{X} | \sigma(\tilde{\tau}) \vee \mathcal{F}_t] = \mathbf{1}_{\{\tilde{\tau} \leq t\}} E^P[\varphi(x, \cdot) | \mathcal{F}_t] |_{x=\tilde{\tau}} \quad \tilde{P}\text{-a.s.},$$

where φ is the measurable function

$$\varphi : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_\infty^P) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})),$$

such that

$$(2.17) \quad \tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}.$$

PROOF. By Lemma 2.13 and Remark 2.14, a unique representation (2.17) exists and the right-hand side of (2.16) is $\sigma(\tilde{\tau}) \vee \mathcal{F}_t$ -measurable. We first show that relation (2.16) holds for indicator functions of a π -system which generates $\mathcal{G} = \sigma(\tilde{\tau}) \vee \mathcal{F}_\infty$. Given $s \geq 0$ and $A \in \mathcal{F}_\infty$, we show

$$\mathbf{1}_{\{\tilde{\tau} \leq t\}} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} \leq s\} \cap \{A \times \hat{\Omega}\}} | \sigma(\tilde{\tau}) \vee \mathcal{F}_t] = \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathbf{1}_{\{\tilde{\tau} \leq s\}} E^P[\mathbf{1}_A | \mathcal{F}_t] \quad \tilde{P}\text{-a.s.}$$

Indeed, let $u \geq 0$ and $B \in \mathcal{F}_t$,

$$\begin{aligned} & \int_{\{\tilde{\tau} \leq u\} \cap \{B \times \hat{\Omega}\}} \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathbf{1}_{A \times \hat{\Omega}} d\tilde{P} \\ &= \int_{B \times \hat{\Omega}} \mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} \mathbf{1}_{A \times \hat{\Omega}} d\tilde{P} \\ (2.18) \quad &= \int_{B \times \hat{\Omega}} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} \mathbf{1}_{A \times \hat{\Omega}} | \mathcal{F}_t] d\tilde{P} \\ &= \int_{B \times \hat{\Omega}} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} | \mathcal{F}_t] E^{\tilde{P}}[\mathbf{1}_{A \times \hat{\Omega}} | \mathcal{F}_t] d\tilde{P} \\ &= \int_{B \times \hat{\Omega}} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} | \mathcal{F}_t] E^P[\mathbf{1}_A | \mathcal{F}_t] d\tilde{P} \\ &= \int_{B \times \hat{\Omega}} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} E^P[\mathbf{1}_A | \mathcal{F}_t] | \mathcal{F}_t] d\tilde{P} \\ (2.19) \quad &= \int_{B \times \hat{\Omega}} \mathbf{1}_{\{\tilde{\tau} \leq t \wedge s \wedge u\}} E^P[\mathbf{1}_A | \mathcal{F}_t] d\tilde{P} \\ &= \int_{\{\tilde{\tau} \leq u\} \cap \{B \times \hat{\Omega}\}} \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathbf{1}_{\{\tilde{\tau} \leq s\}} E^P[\mathbf{1}_A | \mathcal{F}_t] d\tilde{P}, \end{aligned}$$

where equalities (2.18) and (2.19) follow from the definition of conditional expectation,³ while in the third equality we use the \mathcal{F}_t -conditional independence between \mathcal{H}_t and \mathcal{F}_∞ ; see page 166 of [10]. Lemma 2.13 together with the conditional monotone convergence yields that the set of bounded measurable functions $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$, which satisfy relation (2.16), contains a monotone class. Hence by monotone class theorem, relation (2.16) holds for all bounded measurable functions $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$. The result can be extended to every $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$ by conditional monotone convergence theorem applied to \tilde{X}^+ and \tilde{X}^- , respectively, since every nonnegative measurable function is the pointwise limit of a sequence of nonnegative and nondecreasing simple functions. \square

We note that the above results hold clearly also for \tilde{X} which is \mathcal{G}^P -measurable and nonnegative. A summary is given in the following proposition.

PROPOSITION 2.16. *Let $t \geq 0$ and $\tilde{P} = P \otimes \hat{P}$. If $\tilde{X} \in L^1_{\tilde{P}}(\tilde{\Omega})$ or \tilde{X} is \mathcal{G}^P -measurable and nonnegative, then*

$$E^{\tilde{P}}[\tilde{X}|\mathcal{G}_t] = \mathbf{1}_{\{\tilde{\tau} \leq t\}} E^P[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\Gamma_t} E^P[E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}}\tilde{X}|\mathcal{F}_t]] \quad \tilde{P}\text{-a.s.},$$

where φ is the measurable function

$$\varphi : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_\infty^P) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})),$$

such that

$$(2.20) \quad \tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}.$$

PROOF. It is sufficient to apply Lemma 2.12 and Lemma 2.15 to decomposition (2.12). \square

Before we state the main results, we list some properties of upper semianalytic functions which we will use later.

LEMMA 2.17. *Let X, Y be two Polish spaces:*

1. *If $f : X \rightarrow Y$ is a Borel-measurable function and a set $A \subseteq X$ is analytic, then $f(A)$ is analytic. If a set $B \subseteq Y$ is analytic, then $f^{-1}(B)$ is analytic.*
2. *If $f_n : X \rightarrow \mathbb{R}$, $n \in \mathbb{N}$, is a sequence of upper semianalytic functions and $f_n \rightarrow f$, then f is upper semianalytic.*

³Note that, as specified at the beginning of Section 2.2, we identify \mathcal{F}_t with $\mathcal{F}_t \otimes \{\emptyset, \hat{\Omega}\}$.

3. If $f : X \rightarrow Y$ is a Borel-measurable function and $g : Y \rightarrow \bar{\mathbb{R}}$ is upper semianalytic, then the composition $g \circ f$ is also upper semianalytic. If $f : X \rightarrow Y$ is a surjective Borel-measurable function and there is a function $g : Y \rightarrow \mathbb{R}$ such that $g \circ f$ is upper semianalytic, then g is upper semianalytic.

4. If $f, g : X \rightarrow \bar{\mathbb{R}}$ are two upper semianalytic functions, then $f + g$ is upper semianalytic.

5. If $f : X \rightarrow \bar{\mathbb{R}}$ is an upper semianalytic function, $g : X \rightarrow \bar{\mathbb{R}}$ is a Borel-measurable function and $g \geq 0$, then the product $f \cdot g$ is upper semianalytic.

6. If $f : X \times Y \rightarrow \bar{\mathbb{R}}$ is upper semianalytic and $\kappa(dy; x)$ is a Borel-measurable stochastic kernel on Y given X , then the function $g : X \rightarrow \bar{\mathbb{R}}$ defined by

$$g(x) = \int f(x, y)\kappa(dy; x), \quad x \in X,$$

is upper semianalytic.

PROOF. See Proposition 7.40, Lemma 7.30 and Proposition 7.48 of [5]⁴ for points 1, 2, 4, 5 and 6. For the third point, the fact that g upper semianalytic implies $g \circ f$ upper semianalytic is proved in Lemma 7.30 (3) of [5]. For the inverse implication, we note that if $g \circ f$ is upper semianalytic, then for every $c \in \mathbb{R}$, the set

$$A := \{x \in X : g \circ f(x) > c\}$$

is analytic. Moreover, if we define

$$B := \{y \in Y : g(y) > c\},$$

we have $f(A) \subseteq B$. Since f is surjective, it also holds that for all $y \in B$, there exists $x \in X$ such that $y = f(x)$ and $g(f(x)) > c$. Hence $f(A) \supseteq B$. It follows from the first point that the set B is analytic. This implies that g is upper semianalytic. \square

THEOREM 2.18. *Let Assumption 2.2 hold for \mathcal{P} and consider an upper semianalytic function \tilde{X} on $\tilde{\Omega}$ such that $\tilde{X} \in L^1(\tilde{\Omega})$ or \tilde{X} is $\mathcal{G}^{\mathcal{P}}$ -measurable and non-negative. If $t \geq 0$, then the following function*

$$(2.21) \quad \tilde{\mathcal{E}}_t(\tilde{X}) := \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])$$

is well defined, where φ is the measurable function

$$\varphi : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_{\infty}^{\mathcal{P}}) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})),$$

⁴In [5], only lower semianalytic functions are considered. However, the results hold also for upper semianalytic functions without changes.

such that

$$\tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}.$$

Furthermore, $\tilde{\mathcal{E}}_t(\tilde{X})$ satisfies the consistency condition (2.9).

PROOF. By points 5 and 6 of Lemma 2.17, $e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau}>t\}} \tilde{X}]$ is an upper semianalytic function on Ω . Hence the second component on the right-hand side of (2.21) is well defined. For the first component, it is sufficient to prove that for every fixed $x \in \mathbb{R}_+$, the function $\varphi_x(\omega) := \varphi(x, \omega)$, $\omega \in \Omega$, is upper semianalytic. First, φ as function of $(x, \omega) \in \mathbb{R}_+ \times \Omega$ is upper semianalytic by Remark 2.9 and the second implication of point 3 of Lemma 2.17, since $\tilde{X}(\omega, \hat{\omega}) = \varphi \circ (\tau, id|_{\Omega})(\omega, \hat{\omega})$, $(\omega, \hat{\omega}) \in \Omega \times \hat{\Omega}$ is upper semianalytic. Second, for every fixed $x \in \mathbb{R}_+$, by the first implication of point 3 of Lemma 2.17 we have that φ_x as function of $\omega \in \Omega$ is also upper semianalytic, since $\varphi_x = \varphi \circ \psi_x$ where $\psi_x(\omega) := (x, \omega)$, $\omega \in \Omega$, and the function ψ_x is Borel-measurable.

Now we show that consistency condition (2.9) holds. By Proposition 2.4, under every $\tilde{P} \in \tilde{\mathcal{P}}$ we have

$$\mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))|_{x=\tilde{\tau}} = \mathbf{1}_{\{\tilde{\tau} \leq t\}} \operatorname{ess\,sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}} \quad \tilde{P}\text{-a.s.},$$

$$\mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) = \mathbf{1}_{\{\tilde{\tau} > t\}} \operatorname{ess\,sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]|\mathcal{F}_t] \quad \tilde{P}\text{-a.s.}$$

Moreover, for every $\tilde{P} = P \otimes \hat{P}$,

$$\tilde{\mathcal{P}}(t; \tilde{P}) = \{\tilde{P}' \in \tilde{\mathcal{P}} : P' \otimes \hat{P} = P \otimes \hat{P} \text{ on } \mathcal{G}_t\} = \{\tilde{P}' \in \tilde{\mathcal{P}} : P' = P \text{ on } \mathcal{F}_t\}.$$

Hence, \tilde{P} -a.s. we have that

$$\operatorname{ess\,sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}} = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{P'}[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}},$$

$$\operatorname{ess\,sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]|\mathcal{F}_t] = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{P'}[e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]|\mathcal{F}_t].$$

We note that $\{\tilde{\tau} \leq t\}$ and $\{\tilde{\tau} > t\}$ are disjoint events, hence \tilde{P} -a.s.

$$\begin{aligned} & \mathbf{1}_{\{\tilde{\tau} \leq t\}} \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{P'}[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}} \\ & + \mathbf{1}_{\{\tilde{\tau} > t\}} \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{P'}[e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]|\mathcal{F}_t] \\ & = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} (\mathbf{1}_{\{\tilde{\tau} \leq t\}} E^{P'}[\varphi(x, \cdot)|\mathcal{F}_t]|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} E^{P'}[e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]|\mathcal{F}_t]). \end{aligned}$$

Finally, since the integrability conditions on \tilde{X} guarantee that we can apply the Fubini–Tonelli theorem, then Proposition 2.16 yields

$$\tilde{\mathcal{E}}_t(\tilde{X}) = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{\tilde{P}'}[\tilde{X} | \mathcal{G}_t] \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}. \quad \square$$

REMARK 2.19. Set $t \geq 0$ and let \tilde{X} satisfy the conditions in Theorem 2.18. The following holds:

1. If $\tilde{X}(\omega, \hat{\omega}) = X(\omega)$ for all $\hat{\omega} \in \hat{\Omega}$, then $\tilde{\mathcal{E}}_t(X)$ defined in (2.21) coincides with $\mathcal{E}_t(X)$ defined in (2.5).
2. The function $\tilde{\mathcal{E}}_t(\tilde{X})$ defined in (2.21) is sublinear in \tilde{X} .
3. If \tilde{Y} is an upper semianalytic function on $\tilde{\Omega}$, such that $\tilde{Y} \in L^1(\tilde{\Omega})$ and

$$\operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{\tilde{P}'}[\tilde{X} | \mathcal{G}_t] = \operatorname{ess\,sup}_{\tilde{P}' \in \tilde{\mathcal{P}}(t; \tilde{P})}^{\tilde{P}} E^{\tilde{P}'}[\tilde{Y} | \mathcal{G}_t] \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

then $\tilde{\mathcal{E}}_t(\tilde{X}) = \tilde{\mathcal{E}}_t(\tilde{Y})$ \tilde{P} -a.s. for all $\tilde{P} \in \tilde{\mathcal{P}}$.

4. If $A \in \mathcal{G}_t$, then $\tilde{\mathcal{E}}_t(\mathbf{1}_A \tilde{X}) = \mathbf{1}_A \tilde{\mathcal{E}}_t(\tilde{X})$. This follows from Lemma 5.1.1 of [10] and the above point.

5. The following pathwise equalities hold:

$$\begin{aligned} \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} \leq t\}} \tilde{X}) &= \mathbf{1}_{\{\tilde{\tau} \leq t\}} \tilde{\mathcal{E}}_t(\tilde{X}), \\ \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}) &= \mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{\mathcal{E}}_t(\tilde{X}), \\ \tilde{\mathcal{E}}_t(\tilde{X}) &= \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} \leq t\}} \tilde{X}) + \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}). \end{aligned}$$

REMARK 2.20. We note that in Theorem 2.18, integrability conditions are required on the upper semianalytic function \tilde{X} in order to define the sublinear operator $\tilde{\mathcal{E}}_t$. These are necessary for applying Fubini–Tonelli theorem in the proof. This creates a fundamental difference with respect to the construction in [34], where measurability conditions alone are sufficient for defining the sublinear operator in (2.5).

For the sake of simplicity, we use the following notation:

$$(2.22) \quad E^P[\tilde{X} | \mathcal{F}_t](\omega, \hat{\omega}) := E^P[\tilde{X}(\cdot, \hat{\omega}) | \mathcal{F}_t](\omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}, t \geq 0,$$

$$(2.23) \quad \mathcal{E}_t(\tilde{X})(\omega, \hat{\omega}) := \mathcal{E}_t(\tilde{X}(\cdot, \hat{\omega}))(\omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega}, t \geq 0.$$

We note that since the concatenation function is Borel-measurable, the right-hand side of (2.23) is well defined by (2.5) and points 3 and 6 of Lemma 2.17.

PROPOSITION 2.21. *Let Assumption 2.2 hold for \mathcal{P} and let \tilde{X} be an upper semianalytic function on $\tilde{\Omega}$ such that $\tilde{X} \in L^1(\tilde{\Omega})$ or \tilde{X} is $\mathcal{G}^{\mathcal{P}}$ -measurable and non-negative. For every $t \geq 0$, the function $\tilde{\mathcal{E}}_t(\tilde{X})$ defined in (2.21) is upper semianalytic and measurable with respect to \mathcal{G}_t^* and $\mathcal{G}^{\mathcal{P}}$.*

PROOF. Let $t \geq 0$. By definition (2.21) and Proposition 2.4, we have that $\tilde{\mathcal{E}}_t(\tilde{X})$ is $(\mathcal{F}_t^* \vee \sigma(\tau))$ -measurable, hence also \mathcal{G}_t^* - and \mathcal{G}^P -measurable. It is upper semianalytic by points 3, 4, 5 of Lemma 2.17 and Proposition 2.4. \square

Remark 2.19 and Proposition 2.21 show that $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ is a family of sublinear conditional expectations which extends $(\mathcal{E}_t)_{t \geq 0}$ defined for functions on Ω . We now prove that the family $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ satisfies a weak form of dynamic programming principle or tower property, similar to the one of [35].

THEOREM 2.22. *Let Assumption 2.2 hold and \tilde{X} be an upper semianalytic function on $\tilde{\Omega}$ such that \tilde{X} is \mathcal{G}^P -measurable and nonnegative. If $0 \leq s \leq t$, then*

$$(2.24) \quad \tilde{\mathcal{E}}_s(\tilde{\mathcal{E}}_t(\tilde{X})) \geq \tilde{\mathcal{E}}_s(\tilde{X}) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}.$$

PROOF. We recall that we use notation (2.13), (2.22) and (2.23). Since \tilde{X} is assumed to be \mathcal{G}^P -measurable and nonnegative, by Proposition 2.21 and the sublinearity of the operator $\tilde{\mathcal{E}}_t$, the left-hand side of (2.24) is well defined. By definition (2.21), relation (2.24) equals the following:

$$(2.25) \quad \begin{aligned} & \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\bar{\varphi}(x, \cdot))|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s(e^{\Gamma_s} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{\mathcal{E}}_t(\tilde{X})]) \\ & \geq \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\varphi(x, \cdot))|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s(e^{\Gamma_s} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}]), \end{aligned}$$

where φ is the measurable function

$$\varphi : (\mathbb{R}_+ \times \Omega, \mathcal{B}(\mathbb{R}_+) \otimes \mathcal{F}_\infty^P) \rightarrow (\mathbb{R}, \mathcal{B}(\mathbb{R})),$$

such that

$$\tilde{X}(\omega, \hat{\omega}) = \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega), \quad (\omega, \hat{\omega}) \in \tilde{\Omega},$$

and

$$\bar{\varphi}(x, \omega) = \mathbf{1}_{\{x \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))(\omega) + \mathbf{1}_{\{x > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])(\omega),$$

for all $(x, \omega) \in \mathbb{R}_+ \times \Omega$. We show first the equality between the first terms on both hand sides of (2.25) by using (2.21) and the tower property (2.7) of $(\mathcal{P}, \mathbb{F})$ -conditional expectation:

$$\begin{aligned} & \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\bar{\varphi}(x, \cdot))|_{x=\tilde{\tau}} \\ & = \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\mathbf{1}_{\{x \leq t\}} \mathcal{E}_t(\varphi(x, \cdot)) + \mathbf{1}_{\{x > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]))|_{x=\tilde{\tau}} \\ & = \mathbf{1}_{\{\tilde{\tau} \leq s\}} (\mathbf{1}_{\{x \leq t\}} \mathcal{E}_s(\mathcal{E}_t(\varphi(x, \cdot))) + \mathbf{1}_{\{x > t\}} \mathcal{E}_s(\mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])))|_{x=\tilde{\tau}} \\ & = \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\mathcal{E}_t(\varphi(x, \cdot)))|_{x=\tilde{\tau}} \\ & = \mathbf{1}_{\{\tilde{\tau} \leq s\}} \mathcal{E}_s(\varphi(x, \cdot))|_{x=\tilde{\tau}}. \end{aligned}$$

For the second terms, we note first that for every fixed $\hat{\omega} \in \hat{\Omega}$, $\tilde{\tau}(\cdot, \hat{\omega})$ is an \mathbb{F} -stopping time. Hence by Galmarino’s test, on the event $\{\tilde{\tau} \leq t\}$ we have

$$\tilde{\tau}(\omega \otimes_t \omega', \hat{\omega}) = \tilde{\tau}(\omega, \hat{\omega}) \quad \text{for all } \omega' \in \Omega.$$

Hence on the event $\{\tilde{\tau} \leq t\}$, for every fixed $\hat{\omega} \in \hat{\Omega}$, by using definitions (2.4), (2.5) and representation (2.14), we have

$$\begin{aligned} \mathcal{E}_t(\tilde{X})(\omega, \hat{\omega}) &= \sup_{P \in \mathcal{P}} \int_{\Omega} \tilde{X}(\omega \otimes_t \omega', \hat{\omega}) P(d\omega') \\ &= \sup_{P \in \mathcal{P}} \int_{\Omega} \varphi(\tilde{\tau}(\omega \otimes_t \omega', \hat{\omega}), \omega \otimes_t \omega') P(d\omega') \\ &= \sup_{P \in \mathcal{P}} \int_{\Omega} \varphi(\tilde{\tau}(\omega, \hat{\omega}), \omega \otimes_t \omega') P(d\omega') \\ &= \sup_{P \in \mathcal{P}} \int_{\Omega} \varphi(x, \omega \otimes_t \omega') P(d\omega')|_{x=\tilde{\tau}(\omega, \hat{\omega})} \\ &= \mathcal{E}_t(\varphi(x, \cdot))(\omega)|_{x=\tilde{\tau}(\omega, \hat{\omega})} \quad \text{for all } \omega \in \Omega, \end{aligned}$$

that is,

$$(2.26) \quad \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))|_{x=\tilde{\tau}} = \mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X}) \quad \text{for every fixed } \hat{\omega} \in \hat{\Omega}.$$

Furthermore, we note that by (2.6), for every $P \in \mathcal{P}$

$$(2.27) \quad \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) = e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) \quad P\text{-a.s.}$$

Now by (2.21), (2.26), (2.27) and Remark 2.4(iii) of [34], we have

$$\begin{aligned} &\mathcal{E}_s(e^{\Gamma_s} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{\mathcal{E}}_t(\tilde{X})]) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} (\mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))|_{x=\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]))]) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X}) + \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])]) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X}) \\ &\quad + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])]) \quad P\text{-a.s. for all } P \in \mathcal{P}. \end{aligned}$$

Since $e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])$ depends only on the first component ω , using the definition of Γ and (2.13), it follows from Lemma 2.10 that

$$\begin{aligned} (2.28) \quad E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])] &= E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}}] e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) \\ &= e^{-\Gamma_t} e^{\Gamma_t} \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) \\ &= \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]). \end{aligned}$$

It follows

$$\begin{aligned}
 \mathcal{E}_s(e^{\Gamma_s} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{\mathcal{E}}_t(\tilde{X})]) &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])) \\
 &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])) \\
 (2.29) \qquad &\geq e^{\Gamma_s} \mathcal{E}_s(\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X}]) + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]))
 \end{aligned}$$

$$\begin{aligned}
 (2.30) \qquad &\geq e^{\Gamma_s} \mathcal{E}_s(\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X}] + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])) \\
 &= e^{\Gamma_s} \mathcal{E}_s(\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}])) \\
 &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}]) \\
 &= \mathcal{E}_s(e^{\Gamma_s} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}]) \qquad P\text{-a.s. for all } P \in \mathcal{P}.
 \end{aligned}$$

In the second equality, we use the properties that for every fixed $\hat{\omega} \in \hat{\Omega}$, $\{s < \tilde{\tau}(\cdot, \hat{\omega}) \leq t\} \in \mathcal{F}_t$ and $\mathcal{E}_t(\mathbf{1}_A X) = \mathbf{1}_A \mathcal{E}_t(X)$, if $A \in \mathcal{F}_t$ and X is upper semianalytic; see Remark 2.4(iv) of [34]. Inequality (2.29) follows from (2.6) and the conditional Fubini–Tonelli theorem. Indeed, with the notation (2.13) we have

$$\begin{aligned}
 E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] &= E^{\hat{P}}[\text{ess sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X} | \mathcal{F}_t]] \\
 &\geq E^{\hat{P}}[E^P[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X} | \mathcal{F}_t]] \\
 &= E^P[E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X} | \mathcal{F}_t]] \qquad P\text{-a.s. for all } P \in \mathcal{P}.
 \end{aligned}$$

Hence,

$$\begin{aligned}
 E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] &\geq \text{ess sup}_{P' \in \mathcal{P}(t; P)}^P E^{P'}[E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X} | \mathcal{F}_t]] \\
 &= \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X}]) \qquad P\text{-a.s. for all } P \in \mathcal{P}.
 \end{aligned}$$

Inequality (2.30) follows from the sublinearity of $(\mathcal{P}, \mathbb{F})$ -conditional expectation. In the second last equality, we use the tower property (2.7). This concludes the proof. \square

COROLLARY 2.23. *Let Assumption 2.2 hold and \tilde{X} be an upper semianalytic function on $\tilde{\Omega}$ such that $\tilde{X} \in L^1(\tilde{\Omega})$. If for $t \geq 0$, $\tilde{\mathcal{E}}_t(\tilde{X}) \in L^1(\tilde{\Omega})$, then*

$$\tilde{\mathcal{E}}_s(\tilde{\mathcal{E}}_t(\tilde{X})) \geq \tilde{\mathcal{E}}_s(\tilde{X}) \qquad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

for $0 \leq s \leq t$.

In Appendix A, an explicit counterexample shows that the above weak tower property of the family $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ cannot be improved in full generality. However, in

Section 2.4 we show that the classic tower property holds in all cases of practical interest for credit or insurance products. In Appendix B, further sufficient conditions for the tower property are provided.

REMARK 2.24. The classic dynamic programming property fails in the reduced-form setting due to the nature of the progressively enlarged filtration \mathbb{G} . Indeed, while the canonical filtration \mathbb{F} is consistent with the “path-pasting” construction shown in [34], from which the dynamic programming property follows as a natural consequence; this is not the case for the enlarged filtration \mathbb{G} . Furthermore, we note that $\tilde{\mathcal{E}}_t$ does not always map $L^1(\tilde{\Omega})$ into $L^1(\tilde{\Omega})$, the reason is the same that causes the dynamic programming property to fail. For a detailed discussion on these technical difficulties, we refer to [51].

In view of the above results, we give the following definition which extends the one in Proposition 2.4 to the reduced-form setting under model uncertainty.

DEFINITION 2.25. We call the family of sublinear conditional expectations $(\tilde{\mathcal{E}}_t)_{t \geq 0}$ $(\tilde{\mathcal{P}}, \mathbb{G})$ -conditional expectation.

2.4. Valuation of credit and insurance products under model uncertainty. We now consider the valuation of credit and insurance products under model uncertainty. We show in Proposition 2.31 that in these cases, the classic tower property holds and the sublinear operator $\tilde{\mathcal{E}}_t$ maps $L^1(\tilde{\Omega})$ into $L^1(\tilde{\Omega})$. As we will see in Section 3.4, the following valuation formulas can be hence interpreted as superhedging prices for the given cash flows.

Let $T < \infty$ be the maturity time. We define the filtration $\mathbb{F}^{\mathcal{P}} := (\mathcal{F}_t^{\mathcal{P}})_{t \in [0, T]}$ by

$$\mathcal{F}_t^{\mathcal{P}} := \mathcal{F}_t^* \vee \mathcal{N}_T^{\mathcal{P}}, \quad t \in [0, T],$$

where $\mathcal{N}_T^{\mathcal{P}}$ is the collection of sets which are (P, \mathcal{F}_T) -null for all $P \in \mathcal{P}$. For both credit and insurance markets, the main products associated to a particular default event represented by $\tilde{\tau}$ can be modeled by three kinds of contracts with the following payoff:⁵

1. $\mathbf{1}_{\{\tilde{\tau} > T\}} Y$, where Y is an $\mathcal{F}_T^{\mathcal{P}}$ -measurable nonnegative upper semianalytic function on Ω such that $\mathcal{E}(Y) < \infty$; that is, the payment is made at the maturity of the contract only if the default event does not occur before the maturity date;
2. $\mathbf{1}_{\{0 < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}}$, where $Z := (Z_t)_{t \in [0, T]}$ is an $\mathbb{F}^{\mathcal{P}}$ -predictable nonnegative process on Ω , such that the function $Z(t, \omega) := Z_t(\omega)$, $(t, \omega) \in [0, T] \times \Omega$, is upper semianalytic and $\sup_{t \in [0, T]} Z_t < M$ P -a.s. for all $P \in \mathcal{P}$, where $M \in \mathbb{R}_+$; that is, the payment is made at $\tilde{\tau}$ only if the default event occurs before or at the maturity of the contract;

⁵Note that here we extend the standard assumptions of the classical setting of [10] to the case under model uncertainty.

3. $\int_0^T (1 - H_u) dC_u$ ⁶ = $\mathbf{1}_{\{\tilde{\tau} > T\}} C_T + \mathbf{1}_{\{0 < \tilde{\tau} \leq T\}} C_{\tilde{\tau}-}$, where $C := (C_t)_{t \in [0, T]}$ is a nonnegative $\mathbb{F}^{\mathcal{P}}$ -adapted nondecreasing process on Ω , with $C(t, \omega) := C_t(\omega)$, $(t, \omega) \in [0, T] \times \Omega$, upper semianalytic with $\sup_{t \in [0, T]} C_t < M$ P -a.s. for all $P \in \mathcal{P}$ and for $M \in \mathbb{R}_+$, which represents the cumulative payment; that is, a payment flow is made as long as the default event does not occur or the contract is valid.

We give first valuation formulas for these three kinds of contracts under model uncertainty.

LEMMA 2.26. *Let $Y = Y(\omega)$, $\omega \in \Omega$, be an $\mathcal{F}_T^{\mathcal{P}}$ -measurable upper semianalytic function such that $\mathcal{E}(|Y|) < \infty$. Then for every $t \in [0, T]$,*

$$\mathbf{1}_{\{\tilde{\tau} > T\}} Y \quad \text{and} \quad Y e^{-\int_t^T \mu_u du}$$

are upper semianalytic and belong to $L^1(\tilde{\Omega})$. Furthermore, if \mathcal{P} satisfies Assumption 2.2, the following holds pathwisely for every $t \in [0, T]$:

$$(2.31) \quad \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > T\}} Y) = \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(Y e^{-\int_t^T \mu_u du}).$$

PROOF. We note that $\mathbf{1}_{\{\tilde{\tau} > T\}}$ and $e^{-\int_t^T \mu_u du}$ are nonnegative Borel-measurable functions. By point 5 of Lemma 2.17, we have that

$$\mathbf{1}_{\{\tilde{\tau} > T\}} Y \quad \text{and} \quad Y e^{-\int_t^T \mu_u du}$$

are upper semianalytic and clearly belong to $L^1(\tilde{\Omega})$. Equality (2.31) follows from (2.21) and the fact that Y does not depend on $\hat{\omega} \in \hat{\Omega}$,

$$\begin{aligned} \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > T\}} Y) &= \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\tilde{P}}[\mathbf{1}_{\{\tilde{\tau} > T\}} Y]) \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(Y e^{\Gamma_t - \Gamma_T}) \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(Y e^{-\int_t^T \mu_u du}). \end{aligned} \quad \square$$

LEMMA 2.27. *Let $Z := (Z_t)_{t \in [0, T]}$ be an $\mathbb{F}^{\mathcal{P}}$ -predictable process on Ω . Then under every $\tilde{P} \in \tilde{\mathcal{P}}$ with $\tilde{P} = P \otimes \hat{P}$, we have*

$$(2.32) \quad E^{\tilde{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} | \mathcal{G}_s] = \mathbf{1}_{\{\tilde{\tau} > s\}} E^P \left[\int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du | \mathcal{F}_s \right] \quad \tilde{P}\text{-a.s.},$$

for $s, t \in [0, T]$ with $s \leq t$.

⁶This integral is a pathwisely defined Lebesgue–Stieltjes integral.

PROOF. Let $\tilde{P} \in \tilde{\mathcal{P}}$ and $0 \leq s \leq t \leq T$. By Proposition 2.11, Proposition 5.1.1 and Corollary 5.1.3 of [10], which hold without the usual conditions on the filtrations, we have

$$E^{\tilde{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} | \mathcal{G}_s] = \mathbf{1}_{\{\tilde{\tau} > s\}} E^{\tilde{P}} \left[\int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du \mid \mathcal{F}_s \right] \quad \tilde{P}\text{-a.s.}$$

Then \tilde{P} -a.s. equality (2.32) follows from $P \otimes \hat{P}|_{(\Omega, \mathcal{F})} = P$. \square

COROLLARY 2.28. Let $Z := (Z_t)_{t \in [0, T]}$ be an $\mathbb{F}^{\mathcal{P}}$ -predictable process on Ω such that the function $Z(t, \omega) := Z_t(\omega)$, $(t, \omega) \in [0, T] \times \Omega$, is upper semianalytic and there exists $M \in \mathbb{R}_+$ such that $\sup_{t \in [0, T]} |Z_t| < M$ P -a.s. for all $P \in \mathcal{P}$. Then

$$\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} \quad \text{and} \quad \int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du$$

are upper semianalytic and belong to $L^1(\tilde{\Omega})$, for all $s, t \in [0, T]$ with $s \leq t$. Furthermore, if Assumption 2.2 holds for \mathcal{P} , we have

$$(2.33) \quad \tilde{\mathcal{E}}_s(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}) = \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(\int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du \right) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

for all $s, t \in [0, T]$ with $s \leq t$.

If in addition Z is a stepwise \mathbb{F} -predictable process, that is,

$$Z_t = \sum_{i=0}^n Z_{t_i} \mathbf{1}_{\{t_i < t \leq t_{i+1}\}}, \quad t \in [0, T],$$

where $t_0 = s < \dots < t_{n+1} = t$, Z_{t_i} is \mathcal{F}_{t_i} -measurable for all $i = 0, \dots, n$, then equality (2.33) holds pathwisely, that is,

$$(2.34) \quad \tilde{\mathcal{E}}_s(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}) = \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(\int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du \right).$$

PROOF. We note that point 6 of Lemma 2.17 holds also for $Y = [0, T]$, $\kappa(dy; x) \equiv dy$. This together with points 3 and 5 of Lemma 2.17 shows that

$$\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} \quad \text{and} \quad \int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du$$

are upper semianalytic and belong to $L^1(\tilde{\Omega})$. Equality (2.33) follows from Lemma 2.27 and point 3 of Remark 2.19.

If Z is a stepwise \mathbb{F} -predictable process, by (2.21) we have

$$\begin{aligned} \tilde{\mathcal{E}}_s(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}) &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(e^{\Gamma_s} E^{\hat{P}} \left[\sum_{i=0}^n Z_{t_i} \mathbf{1}_{\{t_i < \tilde{\tau} \leq t_{i+1}\}} \right] \right) \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(e^{\Gamma_s} \sum_{i=0}^n Z_{t_i} E^{\hat{P}} [\mathbf{1}_{\{t_i < \tilde{\tau} \leq t_{i+1}\}}] \right) \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(e^{\Gamma_s} \sum_{i=0}^n Z_{t_i} (e^{-\Gamma_{t_i}} - e^{-\Gamma_{t_{i+1}}}) \right) \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(\int_s^t Z_u e^{\Gamma_s - \Gamma_u} d\Gamma_u \right) \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(\int_s^t Z_u e^{-\int_s^u \mu_v dv} \mu_u du \right), \end{aligned}$$

where the integrals above are pathwise Lebesgue–Stieltjes integrals. \square

LEMMA 2.29. *Let $C := (C_t)_{t \in [0, T]}$ be a nonnegative \mathbb{F}^P -adapted nondecreasing and continuous process on Ω . Then under every $\tilde{P} \in \tilde{\mathcal{P}}$ with $\tilde{P} = P \otimes \hat{P}$, we have*

$$\begin{aligned} &E^{\tilde{P}} \left[\int_s^t (1 - H_u) dC_u | \mathcal{G}_s \right] \\ (2.35) \quad &= \mathbf{1}_{\{\tilde{\tau} > s\}} E^P \left[\int_s^t C_u e^{-\int_s^u \mu_v dv} \mu_u du + C_t e^{-\int_s^t \mu_u du} | \mathcal{F}_s \right] \quad \tilde{P}\text{-a.s.}, \end{aligned}$$

for all $s, t \in [0, T]$ with $s \leq t$.

PROOF. Let $\tilde{P} \in \tilde{\mathcal{P}}$ and $0 \leq s \leq t \leq T$. We use the same proof of the first part of Proposition 5.1.2 of [10], which hold without the usual conditions on the filtrations, together with Proposition 2.11 and get

$$\begin{aligned} &E^{\tilde{P}} \left[\int_s^t (1 - H_u) dC_u | \mathcal{G}_s \right] \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} E^{\tilde{P}} \left[\int_s^t C_u e^{-\int_s^u \mu_v dv} \mu_u du + C_t e^{-\int_s^t \mu_u du} | \mathcal{F}_s \right] \quad \tilde{P}\text{-a.s.} \end{aligned}$$

Then \tilde{P} -a.s. equality (2.35) follows from $P \otimes \hat{P}|_{(\Omega, \mathcal{F})} = P$. \square

COROLLARY 2.30. *Let $C := (C_t)_{t \in [0, T]}$ be a nonnegative \mathbb{F}^P -adapted nondecreasing process on Ω , with $C(t, \omega) := C_t(\omega)$, $(t, \omega) \in [0, T] \times \Omega$, upper semi-analytic and such that $\sup_{t \in [0, T]} C_t < M$ P -a.s. for all $P \in \mathcal{P}$, where $M \in \mathbb{R}_+$. Then*

$$\int_s^t (1 - H_u) dC_u \quad \text{and} \quad \int_s^t C_u e^{-\int_s^u \mu_v dv} \mu_u du + C_t e^{-\int_s^t \mu_u du}$$

are upper semianalytic and belong to $L^1(\tilde{\Omega})$ for all $s, t \in [0, T]$ with $s \leq t$. Furthermore, if Assumption 2.2 holds for \mathcal{P} , we have

$$\begin{aligned} & \tilde{\mathcal{E}}_s \left(\int_s^t (1 - H_u) dC_u \right) \\ &= \mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_s \left(\int_s^t C_u e^{-\int_s^u \mu_v dv} \mu_u du + C_t e^{-\int_s^t \mu_u du} \right) \end{aligned} \tag{2.36}$$

\tilde{P} -a.s. for all $\tilde{P} \in \tilde{\mathcal{P}}$,

for all $s, t \in [0, T]$ with $s \leq t$.

PROOF. Since

$$\int_s^t (1 - H_u) dC_u = \mathbf{1}_{\{s < \tilde{\tau} \leq t\}} C_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} C_t,$$

points 2, 4, 5 and 6 of Lemma 2.17 show that

$$\int_s^t (1 - H_u) dC_u \quad \text{and} \quad \int_s^t C_u e^{-\int_s^u \mu_v dv} \mu_u du + C_t e^{-\int_s^t \mu_u du}$$

are upper semianalytic and belong to $L^1(\tilde{\Omega})$. Equality (2.36) follows from Lemma 2.29 and point 3 of Remark 2.19. \square

Now we show that in all these cases of practical interest, the classic tower property holds and the sublinear operator $\tilde{\mathcal{E}}_t$ maps $L^1(\tilde{\Omega})$ into $L^1(\tilde{\Omega})$. The following proposition is slightly more general.

PROPOSITION 2.31. *Let $Z := (Z_t)_{t \in [0, T]}$ be an $\mathbb{F}^{\mathcal{P}}$ -predictable process on Ω such that $\sup_{t \in [0, T]} |Z_t| < M$ P -a.s. for all $P \in \mathcal{P}$, where $M \in \mathbb{R}_+$, and the function $Z(t, \omega) := Z_t(\omega)$, $(t, \omega) \in [0, T] \times \Omega$, is upper semianalytic, and Y an $\mathcal{F}_T^{\mathcal{P}}$ -measurable upper semianalytic function on Ω such that $\mathcal{E}(|Y|) < \infty$. Let Assumption 2.2 hold for \mathcal{P} . If*

$$\tilde{X} = \mathbf{1}_{\{0 < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y,$$

then we have

$$\tilde{\mathcal{E}}_t(\tilde{X}) \in L^1(\tilde{\Omega}),$$

for all $t \in [0, T]$ and the tower property holds, that is,

$$\tilde{\mathcal{E}}_s(\tilde{\mathcal{E}}_t(\tilde{X})) = \tilde{\mathcal{E}}_s(\tilde{X}) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

for all $s, t \in [0, T]$ with $s \leq t$.

PROOF. Let $t \in [0, T]$. Arguments similar to Lemma 2.26 and Corollary 2.28 show that $\tilde{\mathcal{E}}_t(\tilde{X})$ is well defined and $\tilde{\mathcal{E}}(|\tilde{X}|) < \infty$. We prove first that

$$\tilde{\mathcal{E}}(|\tilde{\mathcal{E}}_t(\tilde{X})|) < \infty.$$

By calculations, similar to the ones in Theorem 2.22 and Corollary 2.28, we have

$$\begin{aligned} & \sup_{\tilde{P} \in \tilde{\mathcal{P}}} E^{\tilde{P}}[|\tilde{\mathcal{E}}_t(\tilde{X})|] \\ (2.37) \quad & \leq \sup_{\tilde{P} \in \tilde{\mathcal{P}}} E^{\tilde{P}}[|\mathbf{1}_{\{\tilde{\tau} \leq t\}} \mathcal{E}_t(\varphi(x, \cdot))|_{x=\tilde{\tau}} + |\mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])|] \\ & = \sup_{P \in \mathcal{P}} E^P[E^{\hat{P}}[|\mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}|] + E^{\hat{P}}[|\mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(e^{\Gamma_t} E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])|]] \\ (2.38) \quad & = \sup_{P \in \mathcal{P}} E^P[E^{\hat{P}}[|\mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}|] + |\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])|] \\ & = \sup_{P \in \mathcal{P}} E^P[E^{\hat{P}}[|\mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}|] + |\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y])|] \\ & \leq \sup_{P \in \mathcal{P}} E^P \left[\int_0^t |Z_u| e^{-\Gamma_u} d\Gamma_u \right. \\ & \quad \left. + \left| \mathcal{E}_t \left(\int_t^T Z_u e^{-\Gamma_u} d\Gamma_u + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > T\}} Y] \right) \right| \right] \\ & \leq \sup_{P \in \mathcal{P}} E^P \left[\int_0^t |Z_u| e^{-\Gamma_u} d\Gamma_u \right] \\ & \quad + \sup_{P \in \mathcal{P}} E^P \left[\left| \mathcal{E}_t \left(\int_t^T Z_u e^{-\Gamma_u} d\Gamma_u + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > T\}} Y] \right) \right| \right] \\ & \leq \sup_{P \in \mathcal{P}} E^P \left[\int_0^t |Z_u| e^{-\Gamma_u} d\Gamma_u \right] \\ (2.39) \quad & \quad + \sup_{P \in \mathcal{P}} E^P \left[\left| \int_t^T Z_u e^{-\Gamma_u} d\Gamma_u + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > T\}} Y] \right| \right] \\ & \leq \sup_{P \in \mathcal{P}} E^P \left[\int_0^t |Z_u| e^{-\Gamma_u} d\Gamma_u \right] \\ & \quad + \sup_{P \in \mathcal{P}} E^P \left[\int_t^T |Z_u| e^{-\Gamma_u} d\Gamma_u + |Y| \right] \\ & \leq \sup_{P \in \mathcal{P}} E^P \left[\int_0^t M e^{-\Gamma_u} d\Gamma_u \right] + \sup_{P \in \mathcal{P}} E^P \left[\int_t^T M e^{-\Gamma_u} d\Gamma_u \right] \\ & \quad + \sup_{P \in \mathcal{P}} E^P[|Y|] \end{aligned}$$

$$\begin{aligned} &\leq M \sup_{P \in \mathcal{P}} P(0 < \tau \leq t) + M \sup_{P \in \mathcal{P}} P(t < \tau \leq T) + \sup_{P \in \mathcal{P}} E^P[|Y|] \\ &< \infty, \end{aligned}$$

where (2.37) is a consequence of the definition (2.21), equality (2.38) is derived with the same computations as in (2.28) and inequality (2.39) follows from Step 1 of the proof of Theorem 2.3 in [27]. This shows that for every $t > 0$, $\tilde{\mathcal{E}}_t(\tilde{X})$ still belongs to $L^1(\tilde{\Omega})$. We now prove the tower property. Let $\tilde{P} \in \tilde{\mathcal{P}}$, by the proof of Theorem 2.22, the classic tower property holds if and only if (2.29) and (2.30) are equalities. That is,

$$\begin{aligned} &e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])) \\ &= e^{\Gamma_s} \mathcal{E}_s(\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}])) \quad \tilde{P}\text{-a.s.} \end{aligned}$$

We have indeed

$$\begin{aligned} &E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}]) \\ &= E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y]) \\ &= E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y]) \\ &= \int_s^t Z_u e^{-\Gamma_u} d\Gamma_u + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y]) \\ &= \mathcal{E}_t\left(\int_s^t Z_u e^{-\Gamma_u} d\Gamma_u + E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y]\right) \\ &= \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}] + E^{\hat{P}}[\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > T\}} Y]) \\ &= \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}]) \quad \tilde{P}\text{-a.s.,} \end{aligned}$$

where we stress that for fixed $\hat{\omega}$, $\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}$ is $\mathcal{F}_t^{\mathcal{P}}$ -measurable, and $\int_s^t Z_u e^{-\Gamma_u} d\Gamma_u$ is $\mathcal{F}_t^{\mathcal{P}}$ -measurable as well. \square

3. Superhedging for payment streams. We now study the problem of superhedging payment streams under model uncertainty. We stress that the dynamic superhedging problem in continuous time for payment streams has been not yet defined in the literature. Even in the case with a single prior, the problem is addressed only in discrete time; see, for example, [19, 39] and [40]. Here we aim to fill this gap, by formulating rigorously the meaning of dynamic superhedging payment streams in continuous time and by analysing in detail its consequence. A finite time horizon $[0, T]$ with $T > 0$ is fixed through out this section.

3.1. *Optional decomposition.* We recall first some preliminary results of Section 2 in [32], which are useful for further discussion. Definitions and theorems

in this section are all independent of the choice of the measurable space Ω , the filtration \mathbb{F} and the probability family \mathcal{P} . In the sequel, “sigma martingale” can be replaced by “local martingale”.

Let $S := (S_t)_{t \in [0, T]}$ be an m -dimensional \mathbb{F} -adapted process with càdlàg paths, where m is a positive integer. If under a probability P the process S is a (P, \mathbb{F}) -semimartingale, we denote its characteristics by (B^P, C^P, ν^P) . By Proposition 2.2 of [28], the process S is also a (P, \mathbb{F}_+^P) -semimartingale with the same characteristics. Moreover, if S is a (P, \mathbb{F}) -semimartingale for all $P \in \mathcal{P}$, we denote by $L(S, \mathcal{P})$ the set of all m -dimensional \mathbb{F} -predictable processes which are S -integrable for all $P \in \mathcal{P}$, and by ${}^{(P)}\int \delta \, dS := ({}^{(P)}\int_0^t \delta \, dS)_{t \in [0, T]}$ the usual Itô integral under P for all $\delta \in L(S, \mathcal{P})$.

ASSUMPTION 3.1. The following conditions hold:

1. \mathcal{P} is a set of sigma martingale measures for S : the process S is a (P, \mathbb{F}_+^P) -sigma martingale for all $P \in \mathcal{P}$;
2. \mathcal{P} is saturated: all equivalent sigma martingale measures of its element still belong to \mathcal{P} ;
3. S has dominating diffusion under every $P \in \mathcal{P}$: we have $\nu^P \ll (C^P)^{ii}$ P -a.s. for all $i = 1, \dots, m$ and for all $P \in \mathcal{P}$.

REMARK 3.2. If S has continuous paths, then it always has dominating diffusion under a sigma martingale measure P , since its characteristics are reduced to $(0, C^P, 0)$; in particular, it is a continuous local martingale under P .

REMARK 3.3. Under the choice of $m = d$ and $S = B$, Lemma 4.2 and Proposition 4.3 of [32] give a sufficient condition such that Assumption 2.2 and Assumption 3.1 are both satisfied.

We recall Theorem 2.4 of [32].

THEOREM 3.4. Under Assumption 3.1, let $Y := (Y_t)_{t \in [0, T]}$ be a real-valued, \mathbb{F} -adapted process with càdlàg paths, which is a (P, \mathbb{F}_+^P) -local supermartingale for all $P \in \mathcal{P}$. Then there exists an \mathbb{F} -predictable process $\delta := (\delta_t)_{t \in [0, T]}$ in $L(S, \mathcal{P})$ such that

$$Y - Y_0 - \int_0^{\cdot} \delta \, dS \quad \text{is nonincreasing } P\text{-a.s. for all } P \in \mathcal{P}.$$

3.2. *Problem formulation.* We give now the formulation of the superhedging problem. Definitions in this section are independent of the choice of the measurable space Ω , the filtration \mathbb{F} and the probability family \mathcal{P} as well.

We define the filtration $\mathbb{F}^{\mathcal{P}} := (\mathcal{F}_t^{\mathcal{P}})_{t \in [0, T]}$ by

$$\mathcal{F}_t^{\mathcal{P}} := \mathcal{F}_t^* \vee \mathcal{N}_T^{\mathcal{P}}, \quad t \in [0, T],$$

where $\mathcal{N}_T^{\mathcal{P}}$ is the collection of sets which are (P, \mathcal{F}_T) -null for all $P \in \mathcal{P}$. Let $R := (R_t)_{t \in [0, T]}$ be a nonnegative $\mathbb{F}^{\mathcal{P}}$ -adapted process with nondecreasing paths such that $R_t(\omega)$, $\omega \in \Omega$, is upper semianalytic for all $t \geq 0$. Without loss of generality, we assume $R_0 = 0$. Let $S := (S_t)_{t \in [0, T]}$ be a m -dimensional $\mathbb{F}^{\mathcal{P}}$ -adapted process with càdlàg paths, which is a $(P, \mathbb{F}^{\mathcal{P}})$ -semimartingale for all $P \in \mathcal{P}$. The processes R and S represent respectively an (eventually discounted) *cumulative payment stream* and (eventually discounted) tradable assets on the market.

We denote by $L(S, \mathcal{P})$ the set of all m -dimensional $\mathbb{F}^{\mathcal{P}}$ -predictable processes which are S -integrable for all $P \in \mathcal{P}$ and define the following set of *admissible strategies*:

$$\Delta := \left\{ \delta \in L(S, \mathcal{P}) : \int_0^\tau \delta \, dS \text{ is a } (P, \mathbb{F}_+^{\mathcal{P}})\text{-supermartingale for all } P \in \mathcal{P} \right\}.$$

DEFINITION 3.5. A process $\delta \in \Delta$ is called *robust global superhedging strategy for a cumulative payment stream R* if there exists $v \in \mathbb{R}$ such that

$$v + \int_0^\tau \delta_u \, dS_u \geq R_\tau \quad P\text{-a.s. for all } P \in \mathcal{P},$$

for all $[0, T]$ -valued \mathbb{F} -stopping time τ .

DEFINITION 3.6. Let σ, τ be two $[0, T]$ -valued \mathbb{F} -stopping times such that $\sigma \leq \tau$. A process $\delta \in \Delta$ is called *robust local superhedging strategy for a cumulative payment stream R on the random interval $[\sigma, \tau]$* if there exists a real-valued $\mathcal{F}_\sigma^{\mathcal{P}}$ -measurable function v such that

$$v + \int_\sigma^{\sigma'} \delta_u \, dS_u \geq R_{\sigma'} - R_\sigma \quad P\text{-a.s. for all } P \in \mathcal{P},$$

for all $[0, T]$ -valued \mathbb{F} -stopping time σ' with $\sigma \leq \sigma' \leq \tau$.

We note that Definition 3.6 agrees with the definition of superhedging strategies given in, for example, [19, 39] and [40] in discrete time and without model uncertainty. Furthermore, clearly an admissible strategy δ is a robust global superhedging strategy if and only if it is a robust local superhedging strategy on all random intervals in $[0, T]$. Similarly, we define global and local superhedging prices as follows.

DEFINITION 3.7. We call *robust global superhedging price for R* the value $\pi_0^T \in \mathbb{R}$ such that

$$\pi_0^T = \inf \left\{ v \in \mathbb{R} : \exists \delta \in \Delta \text{ such that for every } [0, T]\text{-valued } \mathbb{F}\text{-stopping time } \tau, \right. \\ (3.1) \quad \left. v + \int_0^\tau \delta_u \, dS_u \geq R_\tau \text{ } P\text{-a.s. for all } P \in \mathcal{P} \right\}.$$

DEFINITION 3.8. Let σ, τ be two $[0, T]$ -valued \mathbb{F} -stopping times such that $\sigma \leq \tau$. We call *robust local superhedging price for R over the random interval $[\sigma, \tau]$* a real-valued $\mathcal{F}_\sigma^{\mathcal{P}}$ -measurable function π_σ^τ such that

$$\begin{aligned} \pi_\sigma^\tau &= \text{ess inf}^P \left\{ v \text{ is } \mathcal{F}_\sigma^{\mathcal{P}}\text{-measurable} : \right. \\ &\quad \exists \delta \in \Delta \text{ such that for every } \mathbb{F}\text{-stopping time } \sigma' \\ &\quad \left. \text{with } \sigma \leq \sigma' \leq \tau, v + \int_\sigma^{\sigma'} \delta_u \, dS_u \stackrel{(P)}{\geq} R_{\sigma'} - R_\sigma \text{ } P\text{-a.s. for all } P \in \mathcal{P} \right\} \\ (3.2) \quad &P\text{-a.s. for all } P \in \mathcal{P}. \end{aligned}$$

Definition 3.8 agrees with the definition of superhedging price (or superhedging premium) given in, for example, [19, 39] and [40] in discrete time and without model uncertainty. We emphasize that the robust local superhedging price is unique only up to a set $N \in \mathcal{N}^{\mathcal{P}}$.

We are mainly interested in the following two problems:

1. Show the existence of robust global and local superhedging prices as defined in Definition 3.7 and Definition 3.8 and determine their value.
2. Show the existence of global and local superhedging strategies for a payment stream associated to robust global and local superhedging prices. In particular, we call *optimal superhedging strategies for R* a robust global superhedging strategy δ for R such that, for all $[0, T]$ -valued \mathbb{F} -stopping times σ, σ', τ with $\sigma \leq \sigma' \leq \tau$, we have

$$\pi_\sigma^\tau + \int_\sigma^{\sigma'} \delta_u \, dS_u \stackrel{(P)}{\geq} R_{\sigma'} - R_\sigma \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

The first issue is a *pricing problem*. The robust global (or resp., local) superhedging price of R can be indifferently interpreted as the minimal amount of money the company should keep in order to be able to pay out in the future, or as the minimal price the product should be sold. The second problem is a *hedging problem*. We emphasize the importance of distinguishing robust global and local superhedging problems. Clearly, for products with single payoff such as European contingent claims, only the global problem is relevant. However, in the case of a generic payment stream, investors may be interested in the superhedging problem over a particular time interval.

3.3. *Robust superhedging for payment streams.* We now study the dynamic superhedging for payment streams in the standard setting, where we use notation of Section 2.2.

The following theorem is an intermediate step.

THEOREM 3.9. *Let Assumptions 2.2 and 3.1 hold. Let σ, τ be two $[0, T]$ -valued \mathbb{F} -stopping times such that $\sigma \leq \tau$, and $R := (R_t)_{t \in [0, T]}$ be a cumulative payment stream with $\mathcal{E}(R_T) < \infty$. If there exists an \mathbb{F}^P -adapted process $Y = (Y_t)_{t \in [0, T]}$ with càdlàg path, such that for all $t \in [0, T]$*

$$Y_t = \mathcal{E}_t(R_\tau) \quad P\text{-a.s. for all } P \in \mathcal{P},$$

then we have the following equivalent dualities for every $P \in \mathcal{P}$:

$$\begin{aligned} & \mathcal{E}_\sigma(R_\tau) \\ &= \text{ess inf}^P \left\{ v \text{ is } \mathcal{F}_\sigma^P\text{-measurable} : \exists \delta \in \Delta \text{ such that } v + \int_\sigma^\tau \delta_u dS_u \geq R_\tau \right. \\ (3.3) \quad & \left. P'\text{-a.s. for all } P' \in \mathcal{P} \right\} \quad P\text{-a.s.} \end{aligned}$$

$$\begin{aligned} &= \text{ess inf}^P \left\{ v \text{ is } \mathcal{F}_\sigma^P\text{-measurable} : \exists \delta \in \Delta \text{ such that } v + \int_\sigma^\tau \delta_u dS_u \geq R_\tau \right. \\ (3.4) \quad & \left. P'\text{-a.s. for all } P' \in \mathcal{P}(\sigma; P) \right\} \quad P\text{-a.s.,} \end{aligned}$$

and

$$\begin{aligned} & \mathcal{E}_\sigma(R_\tau - R_\sigma) \\ &= \text{ess inf}^P \left\{ v \text{ is } \mathcal{F}_\sigma^P\text{-measurable} : \exists \delta \in \Delta \text{ such that } v \right. \\ & \quad \left. + \int_\sigma^\tau \delta_u dS_u \geq R_\tau - R_\sigma \right. \\ (3.5) \quad & \left. P'\text{-a.s. for all } P' \in \mathcal{P} \right\} \quad P\text{-a.s.} \end{aligned}$$

$$\begin{aligned} &= \text{ess inf}^P \left\{ v \text{ is } \mathcal{F}_\sigma^P\text{-measurable} : \exists \delta \in \Delta \text{ such that } v \right. \\ & \quad \left. + \int_\sigma^\tau \delta_u dS_u \geq R_\tau - R_\sigma \right. \\ (3.6) \quad & \left. P'\text{-a.s. for all } P \in \mathcal{P}(\sigma; P) \right\} \quad P\text{-a.s.} \end{aligned}$$

PROOF. The proof is based on Theorem 3.4 and is similar to Theorem 3.2 of [32] and Theorem 3.4 of [6] with minor changes. We refer to [51] for further details. \square

Theorem 3.9 extends Theorem 3.4 of [6] to the case of payment streams and can be considered as a dynamic version of Theorem 3.2 of [32]. It includes also

the static robust superhedging dualities in, for example, [4, 18] and [41]. We note that a priori the robust global superhedging price of R as defined in Definition 3.7 is higher than $\mathcal{E}(R_T)$ and the robust local superhedging price of R on the interval $[\sigma, \tau]$ as defined in Definition 3.8 is higher than $\mathcal{E}_\sigma(R_\tau - R_\sigma)$. However, in the following we will see that equality holds.

For all $[0, T]$ -valued \mathbb{F} -stopping times σ, τ such that $\sigma \leq \tau$, we define the following set:

$$C_\sigma^\tau := \left\{ \delta \in \Delta : \mathcal{E}_{\sigma_1}(R_\tau) + \int_{\sigma_1}^{\sigma_2} \delta_u dS_u \geq R_{\sigma_2} P\text{-a.s. for all } [0, T]\text{-valued } \mathbb{F}\text{-stopping times } \sigma_1, \sigma_2 \text{ such that } \sigma \leq \sigma_1 \leq \sigma_2 \leq \tau, \text{ for all } P \in \mathcal{P} \right\}.$$

If $\sigma, \sigma', \tau, \tau'$ are $[0, T]$ -valued \mathbb{F} -stopping times such that $\sigma \leq \sigma' \leq \tau \leq \tau'$, then it clearly holds by definition

$$(3.7) \quad C_0^T \subseteq C_{\sigma'}^{\tau'} \subseteq C_\sigma^\tau \subseteq C_{\sigma'}^{\tau'}.$$

The following theorem solves both the pricing and hedging problem for a payment stream.

THEOREM 3.10. *Under the same assumptions as in Theorem 3.9, we have:*

1. *the set C_0^T is not empty;*
2. *the robust global superhedging price of R is given by $\mathcal{E}(R_T)$ and the robust local superhedging price of R on the interval $[\sigma, \tau]$ is given by $\mathcal{E}_\sigma(R_\tau - R_\sigma)$;*
3. *the infimum value in (3.1) and (3.2) is attained, that is, optimal superhedging strategies exist.*

PROOF. Since it holds that

$$(3.8) \quad \begin{aligned} \mathcal{E}_\sigma(R_\tau) - R_\sigma &:= \operatorname{ess\,sup}_{P' \in \mathcal{P}(\sigma; P)}^P E^{P'}[R_\tau | \mathcal{F}_\sigma] - R_\sigma \\ &= \operatorname{ess\,sup}_{P' \in \mathcal{P}(\sigma; P)}^P E^{P'}[R_\tau - R_\sigma | \mathcal{F}_\sigma] \\ &= \mathcal{E}_\sigma(R_\tau - R_\sigma) \quad P\text{-a.s. for all } P \in \mathcal{P}, \end{aligned}$$

every set C_σ^τ can be equivalently represented as

$$C_\sigma^\tau = \left\{ \delta \in \Delta : \mathcal{E}_{\sigma_1}(R_\tau - R_{\sigma_1}) + \int_{\sigma_1}^{\sigma_2} \delta_u dS_u \geq R_{\sigma_2} - R_{\sigma_1} P\text{-a.s. for all } [0, T]\text{-valued } \mathbb{F}\text{-stopping times } \sigma_1, \sigma_2 \text{ such that } \sigma \leq \sigma_1 \leq \sigma_2 \leq \tau, \text{ for all } P \in \mathcal{P} \right\}.$$

Hence, point 2 and point 3 follow from point 1 together with dualities (3.3), (3.5) and inclusion (3.7).

Now we show the first point. Similar to the proof of Theorem 3.9 and Theorem 2.3 of [33], by applying Theorem 3.4 it is possible to find a $\mathbb{F}^{\mathcal{P}}$ -predictable process $\delta \in L(S, \mathcal{P})$ such that for every $[0, T]$ -valued \mathbb{F} -stopping time σ we have

$$\mathcal{E}_\sigma(R_T) + \int_\sigma^{(P)} \delta_u dS_u \geq R_T \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

In particular, if σ' is another $[0, T]$ -valued \mathbb{F} -stopping time such that $\sigma \leq \sigma'$, then

$$\mathcal{E}_\sigma(R_T) + \int_\sigma^{(P)} \delta_u dS_u + \int_{\sigma'}^{(P)} \delta_u dS_u \geq R_T \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

Since $\int \delta dS$ is a (P, \mathbb{F}_+^P) -supermartingale, by applying conditional expectation on both hand sides we get

$$\mathcal{E}_\sigma(R_T) + \int_\sigma^{(P)} \delta_u dS_u \geq E^P[R_T | \mathcal{F}_{\sigma'+}^P] \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

We note that since R is nondecreasing, we have

$$E^P[R_T | \mathcal{F}_{\sigma'+}^P] - R_{\sigma'} = E^P[R_T - R_{\sigma'} | \mathcal{F}_{\sigma'+}^P] \geq 0 \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

Hence

$$\mathcal{E}_\sigma(R_T) + \int_\sigma^{(P)} \delta_u dS_u \geq R_{\sigma'} \quad P\text{-a.s. for all } P \in \mathcal{P}.$$

This shows that the set \mathcal{C}_0^T is not empty. \square

We stress that Theorem 3.9 and Theorem 3.10 can be carried out without changes also in the situation without model uncertainty, that is, when we have a single prior P which is a sigma (or local) martingale measure for S .

3.4. *Robust superhedging in the reduced-form framework.* In view of the construction in Section 2.2 and Section 2.3, we can now extend the superhedging results to the reduced-form setting.

Similar to Section 3.3, we define the filtration $\mathbb{G}^{\tilde{\mathcal{P}}} := (\mathcal{G}_t^{\tilde{\mathcal{P}}})_{t \in [0, T]}$ by

$$\mathcal{G}_t^{\tilde{\mathcal{P}}} := \mathcal{G}_t^* \vee \mathcal{N}_T^{\tilde{\mathcal{P}}}, \quad t \in [0, T],$$

where $\mathcal{N}_T^{\tilde{\mathcal{P}}}$ is the collection of sets which are $(\tilde{P}, \mathcal{G}_T)$ -null for all $\tilde{P} \in \tilde{\mathcal{P}}$. Let $\tilde{R} := (\tilde{R}_t)_{t \in [0, T]}$ be a nonnegative $\mathbb{G}^{\tilde{\mathcal{P}}}$ -adapted process with nondecreasing paths, such that \tilde{R}_t is upper semianalytic for all $t \in [0, T]$ and $\tilde{R}_0 = 0$. The process \tilde{R} represents an (eventually discounted) cumulative payment stream on the extended

market. We set S to be an m -dimensional $\mathbb{G}^{\tilde{\mathcal{P}}}$ -adapted process with càdlàg paths, which is a $(\tilde{\mathcal{P}}, \mathbb{G}^{\tilde{\mathcal{P}}})$ -semimartingale for all $\tilde{P} \in \tilde{\mathcal{P}}$ and represents (eventually discounted) tradable assets on the enlarged market. Let $\tilde{L}(S, \tilde{\mathcal{P}})$ be the set of all m -dimensional $\mathbb{G}^{\tilde{\mathcal{P}}}$ -predictable processes which are S -integrable for all $\tilde{P} \in \tilde{\mathcal{P}}$. We define the following set of admissible strategies on the extended market:

$$\tilde{\Delta} := \left\{ \tilde{\delta} \in \tilde{L}(S, \tilde{\mathcal{P}}) : \int^{(\tilde{P})} \tilde{\delta} dS \text{ is a } (\tilde{P}, \mathbb{G}_+^{\tilde{\mathcal{P}}})\text{-supermartingale for all } \tilde{P} \in \tilde{\mathcal{P}} \right\},$$

where $\int^{(\tilde{P})} \tilde{\delta} dS := (\int_0^t \tilde{\delta} dS)_{t \in [0, T]}$ is the usual Itô integral under \tilde{P} . Robust global and local superhedging strategies, robust global and local superhedging prices and the sets \tilde{C}_s^t with $0 \leq s \leq t \leq T$ are defined correspondingly as in Section 3.3.

Theorem 3.11 and Theorem 3.12 are analogue to Theorem 3.9 and Theorem 3.10 for the \mathbb{F} -filtration.

THEOREM 3.11. *Let Assumption 2.2 hold for the probability family \mathcal{P} , Assumption 3.1 hold for $\tilde{\mathcal{P}}$, and $\tilde{R} := (\tilde{R}_t)_{t \in [0, T]}$ be a cumulative payment stream with $\tilde{\mathcal{E}}_t(\tilde{R}_T) \in L^1(\tilde{\Omega})$ for all $t \in [0, T]$. If $t \in [0, T]$ and there exists a $\mathbb{G}^{\tilde{\mathcal{P}}}$ -adapted process $\tilde{Y} = (\tilde{Y}_s)_{s \in [0, T]}$ with càdlàg paths, such that for $s \in [0, t]$,*

$$\tilde{Y}_s = \tilde{\mathcal{E}}_s(\tilde{R}_t) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

and if the tower property holds for \tilde{R}_t , that is, for all $r, s \in [0, t]$ with $r \leq s$,

$$\tilde{\mathcal{E}}_r(\tilde{R}_t) = \tilde{\mathcal{E}}_r(\tilde{\mathcal{E}}_s(\tilde{R}_t)) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

then we have the following equivalent dualities for all $\tilde{P} \in \tilde{\mathcal{P}}$ and $0 \leq s \leq t \leq T$:

$$\begin{aligned} & \tilde{\mathcal{E}}_s(\tilde{R}_t) \\ &= \text{ess inf}^{\tilde{\mathcal{P}}} \left\{ \tilde{v} \text{ is } \mathcal{G}_s^{\tilde{\mathcal{P}}}\text{-measurable} : \exists \tilde{\delta} \in \tilde{\Delta} \text{ such that } \tilde{v} \right. \\ & \quad \left. + \int_s^{(\tilde{P}')} \tilde{\delta}_u dS_u \geq \tilde{R}_t \text{ } \tilde{P}'\text{-a.s. for all } \tilde{P}' \in \tilde{\mathcal{P}} \right\} \quad \tilde{P}\text{-a.s.} \\ &= \text{ess inf}^{\tilde{\mathcal{P}}} \left\{ \tilde{v} \text{ is } \mathcal{G}_s^{\tilde{\mathcal{P}}}\text{-measurable} : \exists \tilde{\delta} \in \tilde{\Delta} \text{ such that } \tilde{v} \right. \\ & \quad \left. + \int_s^{(\tilde{P}')} \tilde{\delta}_u dS_u \geq \tilde{R}_t \text{ } \tilde{P}'\text{-a.s. for all } \tilde{P}' \in \tilde{\mathcal{P}}(s; \tilde{P}) \right\} \quad \tilde{P}\text{-a.s.} \end{aligned}$$

and

$$\begin{aligned} & \tilde{\mathcal{E}}_s(\tilde{R}_t - \tilde{R}_s) \\ &= \text{ess inf}^{\tilde{\mathcal{P}}} \left\{ \tilde{v} \text{ is } \mathcal{G}_s^{\tilde{\mathcal{P}}}\text{-measurable} : \exists \tilde{\delta} \in \tilde{\Delta} \text{ such that } \tilde{v} \right. \end{aligned}$$

$$\begin{aligned}
 & + \left. \int_s^{(\tilde{P}')} \tilde{\delta}_u \, dS_u \geq \tilde{R}_t - \tilde{R}_s \text{ } \tilde{P}'\text{-a.s. for all } \tilde{P}' \in \tilde{\mathcal{P}} \right\} \quad \tilde{P}\text{-a.s.} \\
 & = \text{ess inf}^{\tilde{P}} \left\{ \tilde{v} \text{ is } \mathcal{G}_s^{\tilde{P}}\text{-measurable} : \exists \tilde{\delta} \in \tilde{\Delta} \text{ such that } \tilde{v} \right. \\
 & \left. + \int_s^{(\tilde{P}')} \tilde{\delta}_u \, dS_u \geq \tilde{R}_t - \tilde{R}_s \text{ } \tilde{P}'\text{-a.s. for all } \tilde{P}' \in \tilde{\mathcal{P}}(s; \tilde{P}) \right\} \quad \tilde{P}\text{-a.s.}
 \end{aligned}$$

PROOF. The proof of the theorem is the same as in Theorem 3.9. Indeed, we can apply Theorem 3.4 to the measurable space $\tilde{\Omega}$ with filtration $\mathbb{G}^{\tilde{P}}$ and to the process \tilde{Y} . \square

THEOREM 3.12. *Under the same assumptions in Theorem 3.11, for $0 \leq s \leq t \leq T$, we have the following statements:*

1. *The set \tilde{C}_0^T is not empty.*
2. *The robust global superhedging price of \tilde{R} is given by $\tilde{\mathcal{E}}(\tilde{R}_T)$ and the robust local superhedging price of \tilde{R} on the interval $[s, t]$ is given by $\tilde{\mathcal{E}}_s(\tilde{R}_t - \tilde{R}_s)$.*
3. *Optimal superhedging strategies exist.*

PROOF. The theorem can be proved in the same way as in Theorem 3.10. \square

By using the results in Section 2.4, we show that the superhedging problem can be solved for all main credit and insurance cash flows. As already noticed in, for example, [3, 7] and [8], we recall that the three kinds of main products are special cases of payment streams by setting

$$(3.9) \quad \tilde{R}_t = \mathbf{1}_{\{\tilde{\tau} > T\}} Y \mathbf{1}_{\{t=T\}}, \quad t \in [0, T],$$

$$(3.10) \quad \tilde{R}_0 = 0, \quad \tilde{R}_t = \mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}}, \quad t \in [0, T],$$

or

$$(3.11) \quad \tilde{R}_0 = 0, \quad \tilde{R}_t = \mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} C_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} C_t, \quad t \in [0, T],$$

respectively.

PROPOSITION 3.13. *Under the same assumptions of Lemma 2.26, Corollary 2.28 and Corollary 2.30, if in addition the family \mathcal{P} is tight and μ, Y, Z and C are bounded and continuous in ω P -a.e. for all $P \in \mathcal{P}$, then the processes*

$$\left(\tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > T\}} Y) \right)_{t \in [0, T]}, \quad \left(\tilde{\mathcal{E}}_t(\mathbf{1}_{\{0 < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}}) \right)_{t \in [0, T]},$$

and

$$\left(\tilde{\mathcal{E}}_t \left(\int_0^T (1 - H_u) \, dC_u \right) \right)_{t \in [0, T]}$$

are \mathbb{G}^* -adapted and respectively equal to a càdlàg process $Y := (Y_t)_{t \in [0, T]}$ \tilde{P} -a.s. for all $\tilde{P} \in \tilde{\mathcal{P}}$.

PROOF. The three processes are clearly \mathbb{G}^* -adapted by definition. For every $t \in [0, T]$, by Lemma 2.26, Corollary 2.28 and Corollary 2.30, we have

$$\begin{aligned} \tilde{\mathcal{E}}_t(\mathbf{1}_{\{\tilde{\tau} > T\}} Y) &= \mathbf{1}_{\{\tilde{\tau} > T\}} \mathcal{E}_t(Y e^{-\int_t^T \mu_u \, du}) \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\int_0^t \mu_u \, du} \mathcal{E}_t(Y e^{-\int_0^T \mu_u \, du}) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}, \\ \tilde{\mathcal{E}}_t(\mathbf{1}_{\{0 < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}}) &= \tilde{\mathcal{E}}_t(\mathbf{1}_{\{t < \tilde{\tau} \leq T\}} Z_{\tilde{\tau}}) + \mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t\left(\int_t^T Z_u e^{-\int_t^u \mu_v \, dv} \mu_u \, du\right) + \mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\int_0^t \mu_v \, dv} \left[\mathcal{E}_t\left(\int_0^T Z_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du\right) \right. \\ &\quad \left. - \int_0^t Z_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du \right] \\ &\quad + \mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} Z_{\tilde{\tau}} \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}, \end{aligned}$$

and

$$\begin{aligned} &\tilde{\mathcal{E}}_t\left(\int_0^T (1 - H_u) \, dC_u\right) \\ &= \tilde{\mathcal{E}}_t\left(\int_t^T (1 - H_u) \, dC_u\right) - \int_0^t (1 - H_u) \, dC_u \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t\left(\int_t^T C_u e^{-\int_t^u \mu_v \, dv} \mu_u \, du + C_T e^{-\int_t^T \mu_u \, du}\right) \\ &\quad - (\mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} C_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} C_t) \\ &= \mathbf{1}_{\{\tilde{\tau} > t\}} e^{\int_0^t \mu_v \, dv} \left[\mathcal{E}_t\left(\int_0^T C_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du + C_T e^{-\int_0^T \mu_u \, du}\right) \right. \\ &\quad \left. - \int_0^t C_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du \right] \\ &\quad - (\mathbf{1}_{\{0 < \tilde{\tau} \leq t\}} C_{\tilde{\tau}} + \mathbf{1}_{\{\tilde{\tau} > t\}} C_t) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}}. \end{aligned}$$

Under our assumptions, Proposition 2.6 shows that

$$\left(\mathcal{E}_t(Y e^{-\int_0^T \mu_u \, du})\right)_{t \in [0, T]}, \quad \left(\mathcal{E}_t\left(\int_0^T Z_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du\right)\right)_{t \in [0, T]}$$

and

$$\left(\mathcal{E}_t\left(\int_0^T C_u e^{-\int_0^u \mu_v \, dv} \mu_u \, du + C_T e^{-\int_0^T \mu_u \, du}\right)\right)_{t \in [0, T]}$$

are càdlàg, hence the thesis follows. \square

As a consequence, we now show that the superhedging price and strategy can be determined for the credit or insurance products of the form (3.9), (3.10) and (3.11).

COROLLARY 3.14. *Under the same assumptions of Proposition 3.13 and Proposition 2.31, if in addition \mathcal{P} satisfies Assumption 3.1, then Theorem 3.11 and Theorem 3.12 apply to credit or insurance products of the form (3.9), (3.10) and (3.11).*

PROOF. It follows directly from Proposition 2.31, Proposition 3.13, Theorem 3.11 and Theorem 3.12. \square

APPENDIX A: COUNTEREXAMPLE FOR THE TOWER PROPERTY

In this section we provide a counterexample to show that the classic tower property does not hold in general for the $(\tilde{\mathcal{P}}, \mathbb{G})$ -conditional expectation constructed in Section 2.3.

Let $\Omega = C_0(\mathbb{R}_+, \mathbb{R}^d)$ and consider the G -conditional defined in, for example, [37] as $(\mathcal{P}, \mathbb{F})$ -conditional expectation. Since the G -conditional expectation is only sublinear, there exist $t \geq 0$ and sufficiently regular functions X, Y on Ω such that on a measurable set A with $P(A) > 0$ for all $P \in \mathcal{P}$, the following strict inequality holds:

$$(A.1) \quad \mathcal{E}_t(X)(\omega) + \mathcal{E}_t(Y)(\omega) > \mathcal{E}_t(X + Y)(\omega) \quad \text{for all } \omega \in A.$$

Then there exists s with $s < t$ such that

$$(A.2) \quad \mathcal{E}_s(\mathcal{E}_t(X) + \mathcal{E}_t(Y)) > \mathcal{E}_s(\mathcal{E}_t(X + Y)) \quad P\text{-a.s. for all } P \in \mathcal{P} \text{ on } A.$$

Indeed, if there exists a measurable subset $B \subseteq A$ with $P(B) > 0$ for all $P \in \mathcal{P}$, such that for all $s < t$ we have

$$\mathcal{E}_s(\mathcal{E}_t(X) + \mathcal{E}_t(Y)) = \mathcal{E}_s(\mathcal{E}_t(X + Y)) \quad P\text{-a.s. for all } P \in \mathcal{P} \text{ on } B,$$

then by taking the limit for $s \uparrow t$, we get

$$\mathcal{E}_t(\mathcal{E}_t(X) + \mathcal{E}_t(Y)) = \mathcal{E}_t(\mathcal{E}_t(X + Y)) \quad P\text{-a.s. for all } P \in \mathcal{P} \text{ on } B,$$

since the operator \mathcal{E}_t is continuous in t in the case of the G -conditional expectation; see, for example, [45] and [48]. By (2.6), the above equality is equivalent to

$$\mathcal{E}_t(X) + \mathcal{E}_t(Y) = \mathcal{E}_t(X + Y) \quad P\text{-a.s. for all } P \in \mathcal{P} \text{ on } B,$$

which contradicts (A.1).

Now we take r, l with $s < r \leq t \leq l$ and define

$$\bar{X} := \frac{X}{e^{-\Gamma_s} - e^{-\Gamma_r}}, \quad \bar{Y} := \frac{Y}{e^{-\Gamma_l}}.$$

Inequality (A.2) thus equals the following:

$$(A.3) \quad \begin{aligned} & \mathcal{E}_s((e^{-\Gamma_s} - e^{-\Gamma_r})\mathcal{E}_t(\bar{X}) + \mathcal{E}_t(e^{-\Gamma_l}\bar{Y})) \\ & > \mathcal{E}_s(\mathcal{E}_t((e^{-\Gamma_s} - e^{-\Gamma_r})\bar{X} + e^{-\Gamma_l}\bar{Y})) \end{aligned} \quad P\text{-a.s. for all } P \in \mathcal{P} \text{ on } A.$$

If we set

$$\tilde{X} := \mathbf{1}_{\{\tilde{\tau} \leq r\}}\bar{X} + \mathbf{1}_{\{\tilde{\tau} > l\}}\bar{Y},$$

then the classic tower property does not hold for \tilde{X} , since (2.30) in Theorem 2.22 becomes a strict inequality on A .

APPENDIX B: SUFFICIENT CONDITIONS FOR THE TOWER PROPERTY

In this section, we state some other sufficient conditions which guarantees the tower property for $(\tilde{\mathcal{P}}, \tilde{\mathbb{G}})$ -conditional expectation. We note that these conditions do not include the case in Proposition 2.31.

The following useful theory, called Yan’s commutability theorem, can be found in [50] and in Theorem a3 of [35].

THEOREM B.1. *Let (Ω, \mathcal{F}, P) be an arbitrary probability space and H be a subset of $L^1(\Omega, \mathcal{F}, P)$ such that $\sup_{\xi \in H} E^P[\xi] < +\infty$. The following statements are equivalent:*

1. For all $\varepsilon > 0$ and $\xi_1, \xi_2 \in H$, there exists a $\xi_3 \in H$ such that

$$E^P[(\xi_1 \vee \xi_2 - \xi_3)^+] \leq \varepsilon.$$

2. $E^P[\text{ess sup}_{\xi \in H}^P \xi] = \sup_{\xi \in H} E^P[\xi]$.
3. For any sub- σ -algebra \mathcal{J} of \mathcal{F} , we have

$$E^P[\text{ess sup}_{\xi \in H}^P \xi | \mathcal{J}] = \text{ess sup}_{\xi \in H}^P E^P[\xi | \mathcal{J}].$$

PROPOSITION B.2. *Under the same assumptions of Theorem 2.22 or Corollary 2.23, the tower property holds for $(\tilde{\mathcal{P}}, \tilde{\mathbb{G}})$ -conditional expectation, that is,*

$$(B.1) \quad \tilde{\mathcal{E}}_s(\tilde{\mathcal{E}}_t(\tilde{X})) = \tilde{\mathcal{E}}_s(\tilde{X}) \quad \tilde{P}\text{-a.s. for all } \tilde{P} \in \tilde{\mathcal{P}},$$

with $0 \leq s \leq t$, if one of the following conditions is satisfied:

1. \tilde{X} does not depend on $\hat{\omega} \in \hat{\Omega}$;
2. $\mathcal{E}_t(\mathbf{1}_{\{\tilde{\tau} > s\}}\tilde{X})$ is $\mathcal{B}(\hat{\Omega})$ -measurable and $\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}}\tilde{X}]) = E^{\hat{P}}[\mathcal{E}_t \times (\mathbf{1}_{\{\tilde{\tau} > s\}}\tilde{X})]$ P -a.s. for all $P \in \mathcal{P}$ and for all $0 \leq s \leq t$;
3. for all $P \in \mathcal{P}$, P -a.e. ω , $0 \leq s \leq t$, $\varepsilon > 0$ and $P_1, P_2 \in \mathcal{P}$, there is a $P_3 \in \mathcal{P}$ such that if $\tilde{Y} := \mathbf{1}_{\{\tilde{\tau} > s\}}\tilde{X}$, the functions

$$\xi_i(\hat{\omega}) = \int_{\Omega} \tilde{Y}(\omega \otimes_t \omega', \hat{\omega}) dP_i(\omega'), \quad i = 1, 2, 3,$$

with $\omega \otimes_t \omega'$ defined in (2.3) are $\mathcal{B}(\hat{\Omega})$ -measurable and

$$E^{\hat{P}}[(\xi_1 \vee \xi_2 - \xi_3)^+] \leq \varepsilon \quad P\text{-a.s.}$$

PROOF. Condition 1 is trivial. Indeed, by point 1 of Remark 2.19, in such case the $(\tilde{\mathcal{P}}, \tilde{\mathcal{G}})$ -conditional expectation is reduced to the $(\mathcal{P}, \tilde{\mathcal{F}})$ -conditional expectation which satisfies the tower property.

If condition 2 is satisfied, according to the proof of Theorem 2.22, it is sufficient to check that (2.29) and (2.30) are equalities. We have indeed

$$\begin{aligned} & e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathcal{E}_t(\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \tilde{X})] + \mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \tilde{X}])) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X})] + E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(\tilde{X})]) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{s < \tilde{\tau} \leq t\}} \mathcal{E}_t(\tilde{X}) + \mathbf{1}_{\{\tilde{\tau} > t\}} \mathcal{E}_t(\tilde{X})]) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \mathcal{E}_t(\tilde{X})]) \\ &= e^{\Gamma_s} \mathcal{E}_s(\mathcal{E}_t(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}])) \\ &= e^{\Gamma_s} \mathcal{E}_s(E^{\hat{P}}[\mathbf{1}_{\{\tilde{\tau} > s\}} \tilde{X}]) \quad P\text{-a.s. for all } P \in \mathcal{P}. \end{aligned}$$

Condition 3 is equivalent to condition 2 by using the equivalence between statements 1 and 2 in Yan's commutability theorem B.1. \square
