# Some remarks on inertial manifolds

## 1. Introduction

A recently developed theory of inertial manifolds reveals that the asymptotic behavior of solutions to some classes of semilinear evolution equations is controlled by a finite-dimensional system. More precisely such equations admit a finite-dimensional invariant manifold which attracts every solution exponentially (we call it inertial manifold) and the ordinary differential equation reduced on the manifold determines the asymptotic behavior of the original equation. For example it is known that there exists an inertial manifold for a reaction-diffusion equation and Kuramoto-Sivashinsky equation under some condition (see C. Foias, B. Nicolaenko, G. R. Sell and R. Temam [7], C. Foias, G. R. Sell and R. Temam [8], J. Mallet-Paret and G. R. Sell [12] and R. Temam [15]).

Although there are many works for the existence of the inertial manifold, it seems that three basic techniques work in them: Hadamard method (or the graph transformation method, see [12] and P. Constantin, C. Foias, B. Nicolaenko and R. Temam [3]), Lyapunov-Perron method (based on the variation of constants formula, see S.N. Chow and K. Lu [1] and [7], [8], [15]) and the elliptic regularization method (see A. Debussche [4] and so on). Our aim of this paper is to charactrize Lyapunov-Perron method from the point of dynamics of the semiflow (generated by solutions). Usually the technique to find a fixed point of some operator (which comes from the variation of constants formula) is called Lyapunov-Perron method; this fixed point in a suitable function space whose graph gives the inertial manifold. However in the classical adaptation of the Lyapunov-Perron method, it seems to be difficult to relate it to some property of the semiflow explicitly. C. Foias, G. R. Sell and R. Temam used in [8] some property of the flow namely squeezing property (or cone property) for the proof of the existence of the manifold. Through their researches we will use the squeezing property more effectively for the above purpose than in the related works including [8]. Since the squeezing property is charactrized in terms of differential inequalities, we hardly use the variation of constants formula in the proof. Furthermore we can also make clear a geometrical meaning of the exponential tracking in the squeezing property and prove it shortly.

We will also prove the regularity of the inertial manifold ( $C^{1}$-manifold). Here we will show that the inertial manifold is a limit of a family of approximate inertial manifolds of Galerkin approximate equations in $C^{1}$-topology. This will be discussed
in §4. In §5 we investigate how the inertial manifold varies when the nonlinear term is perturbed. Roughly speaking the difference of inertial manifolds is estimated by size of the perturbed term.

## 2. Main Results

Let $H$ be a separable Hilbert space and denote its inner product and its norm by $(\cdot, \cdot)$ and $|\cdot|$ respectively. We consider the equation in $H$

We assume the following:
A1: $A$ is a positive selfajoint operator and $A^{-1}$ is compact.
It has eigenvalues $\lambda_{j}$ and eigenfunctions $w_{j}$ satisfying

A2: There is a $\gamma(0 \leqq \gamma \leqq 1 / 2)$ such that there are constants $K_{0}, K_{1}$ and $K_{2}$ such that for every $t, h$ in $\mathbf{R}$ and $u, v$ in $D\left(A^{r}\right)$,

where $A^{r}$ and $D\left(A^{r}\right)$ denote the fractional power of $A$ and its domain respectively.
A3: There exists an integer $N>0$ satisfying

Remark 2.1. The equation (2.1) has a unique solution $u(t)$ in $C\left(\left[t_{0}, \infty\right) ; D\left(A^{\gamma}\right)\right) \cap$ $L_{i o c}^{2}\left(\left[t_{0}, \infty\right) ; D(A)\right)$ for every $t_{0} \in \mathbf{R}$ and $u_{0} \in D\left(A^{r}\right)$ under A1 and A2. Then we can define a semiflow

S\left(t, t_{0}\right): u\left(t_{0}\right) \in D\left(A^{r}\right) \longrightarrow u(t) \in D\left(A^{r}\right) \quad \text { for } t \geqq t_{0} .
$$

Under the above assumptions, we can obtain three theorems below.
Theorem 2.2. Under A1, A2 and A3, there exists an manifold $M_{\iota}$ for each $t \in \mathbf{R}$ which satisfies the following:
(1) Lipschitz property:

There exists a Lipschitz function $\Phi(\cdot, \cdot)$ from $\mathbf{R} \times P_{N} D\left(A^{r}\right)$ into ( $\left.I-P_{N}\right) D\left(A^{r}\right)$ such that for each $t$ in $\mathbf{R}$,

$$

where $P_{N}$ is a projection operator onto the space spanned by $w_{1}, w_{2}, w_{3}, \cdots, w_{N}$.
(ii) Invariant property:

M_{t}=S\left(t, t_{0}\right) M_{t_{0}} \quad \text { for } t, t_{0} \text { in } \mathbf{R}
$$

(iii) Exponential tracking:

For any solution $u(t)=S\left(t, t_{0}\right) u_{0}$, there exists a $v_{0} \in M_{t_{0}}$ such that

\left|A^{r}\left(S\left(t+t_{0}, t_{0}\right) u_{0}-S\left(t+t_{0}, t_{0}\right) v_{0}\right)\right|<c_{1} e^{-2 t} \quad(t \geqq 0)
$$

where $c_{1}$ and $\nu$ are positive constants independent of $t$ and $t_{0}$.

Remark 2.3. We call the manifold $\mathcal{M}=\left\{M_{t}\right\}_{-\infty<t<\infty}$ inertial manifold for (2.1). If the nonlinear term $R$ is periodic with respect to $t$, then $\Phi$ is also periodic. For an autonomous equation (2.1), $\Phi$ is independent of time $t$. Then $\mathscr{M}=M_{t}$ for any $t$.

The constant $\nu$ is any number between $\nu_{1}$ and $\nu_{2}$ which are defined in (3.2) and $c_{1}$ is given by (3.23) in $\S 3$.

Theorem 2.4. In addition to A 2 and A 3 , assume that $R(t, u)$ has a Fréchet derivative $D_{u} R$ which belongs to $C^{0}\left(\mathbf{R} \times D\left(A^{r}\right) ; \mathcal{L}\left(D\left(A^{r}\right) ; H\right)\right)$. Then $M_{t}$ is a $C^{\prime}$-manifold.

Next we will consider the perturbed equation of (2.1)

\end{array}\right.
$$

where we assume that $\hat{R}(t, u)$ satisfies A1, A2 and A3 as $R(t, u)$ does. Under A1, A2 and A3, we have Lipschitz functions $\Phi, \tilde{\Phi}$ whose graphs represent inertial manifolds for (2.1) and (2.6) respectively. Let us consider the equation on the manifold,

We denote a solution of (2.7) (resp. (2.8)) by $p_{1}\left(t, t_{0}, p_{01}\right)$ (resp. $p_{2}\left(t, t_{0}, p_{02}\right)$ ). Let us introduce the next equation.

It is easily checked that (2.9) has two solutions, say $l_{1}, l_{2}\left(l_{1}>l_{2}>0\right)$. We assume
A4: There exists a constant $K_{3}$ satisfying

where $\eta$ is some number satisfying

Theorem 2.5. Let the equations (2.1) and (2.6) satisfy A1-A4. Let $\Phi, \tilde{\Phi}$ be the mapping representing the inertial manifolds for (2.1) and (2.6) respectively. Then for any $t \in \boldsymbol{R}, p \in P D\left(A^{r}\right)$,

\left|A^{r}(\Phi(t, p)-\tilde{\Phi}(t, p))\right| \leqq c_{2} K_{\mathrm{s}} e^{-\eta \iota},
$$

where $c_{2}$ is a positive constant independent of $t, p$. Moreover, if

then for every solution of (2.6) there exists a solution of (2.1) which approaches it exponentially. That is the following sense: For $t_{0} \in \mathbf{R}, p_{02} \in P D\left(A^{r}\right)$, there exists $p_{01} \in$ $P_{N} D\left(A^{r}\right)$ such that for all $t$ in $\mathbf{R}$,

where $c_{3}$ is a positive constant independent of $t, t_{0}$ and $p_{02}$.
Remark 2.6. In particular, when $\eta=0$, we have the estimate:

$$
\left|A^{\gamma}(\Phi(t, p)-\tilde{\Phi}(t, p))\right| \leqq c_{2} \sup _{t \in \mathbf{R}, u \in D\left(A^{r}\right)}|R(t, u)-\tilde{R}(t, u)| .
$$

The above Theorem 2.5 will be proved in $\S 5$ where the constants $c_{2}$ and $c_{3}$ are given by (5.3) and (5.7).

Remark 2.7. The squeezing property is first introduced by C. Foias, G. R. Sell and R. Temam [8]. In this paper, this property is modified and the condition for the existence of the manifold is improved by its modification. In addition this modification makes us to treat the regularity and the perturbation of the manifold easily. S.N. Chow and $\mathrm{K} . \mathrm{Lu}$ proved the existence of $C^{1}$-manifold and the exponential attractivity by estimating an integral equation. Their gap condition is rather restrictive. On the other hand, P. Constantin, C. Foias, B. Nicolaenko and R. Temam [3] and M. Miklavčič [13] proved the existence of the manifold with the better gap condition than that of this paper. But they did not make mention of the regularity and the perturbation.

## 3. Proof of the existence of an inertial manifold

We simply write $P=P_{N}, Q=I-P_{N}$, Preparatory to a proof of Theorem 2.2, we will prove an elementary lemma below.

Lemma 3.1. If A 3 in $\S 2$ is satisfied, then there exist positive constants $l$ and $\theta$ such that

Proof. We can see from the inequality of A3 that there exists a positive constant $l$ satisfying

\lambda_{N+1}-\lambda_{N}-K_{1}\left(1+l^{-1}\right) \lambda_{N+1}^{\gamma}-K_{1}(1+l) \lambda_{N}^{\gamma}>0 .
$$

It is clear that we can take $0<\theta<1$ satisfying

\lambda_{N+1}-\lambda_{N}-K_{1}\left(\theta^{-1}+l^{-1}\right) \lambda_{N+1}^{\gamma}-K_{1}\left(1+\theta^{-1} l\right) \lambda_{N}^{\gamma}>0 .
$$

Set

\nu_{1}=\lambda_{N}+K_{1}\left(1+\theta^{-1} l\right) \lambda_{N}^{\gamma},  \tag{3.2}\\
\nu_{2}=\lambda_{N+1}-K_{1}\left(\theta^{-1}+l^{-1}\right) \lambda_{N+1}^{\gamma} .
\end{array}\right.
$$

We introduce a complete metric space:

& \left|A^{\gamma} q(t)\right| \leqq \frac{e^{-\gamma} K_{0}}{1-\gamma} \lambda_{N+1}^{r-1} e^{\nu\left(t_{0}-t\right)},  \tag{3.3}\\
& \left.\left|A^{\gamma}(q(t+h)-q(t))\right| \leqq B_{1}|h| e^{\nu\left(t_{0}-t\right)} \quad \text { for all } t \leqq t+h \leqq t_{0}\right\}
\end{align*}
$$

with the metric:

d_{\nu}\left(q_{1}, q_{2}\right)=\sup _{t \leq i_{0}}\left|A^{r}\left(q_{1}(t)-q_{2}(t)\right)\right| e^{\nu\left(t-t_{0}\right)},
$$

where $\nu$ is any number such that $\nu_{1}<\nu<\nu_{2}$. The positive constant $B_{1}$ will be determined later. Fix any $t_{0}$ in $\mathbf{R}, p_{0} \in P D\left(A^{r}\right)$. We define a map $T_{t_{0}, p_{0}}$ on $\mathscr{F}$ in the following way. For $q(t) \in \mathcal{F}$, consider the equation

This finite-dimensional equation has a unique solution $p(t)=p\left(t, t_{0}, p_{0}, q\right)$ for all $t \leqq t_{0}$. Using the solution $p(t)$, we define the following mapping:

T_{t_{0}, p_{0}}(q)(t)=-\int_{-\infty}^{t} e^{-\Lambda(t-s)} Q R(s, p(s)+q(s)) d s \tag{3.5}
\end{equation*}

Hereafter we often write $T(q)(t)$ without its subscripts $t_{0}$ and $p_{0}$. Since the function $R(t, p(t)+q(t))$ is Lipschitz, (3.5) is equivalent to

(see D. Henry [10]).
Proposition 3.2. For all $t_{0} \in \mathbf{R}$ and $p_{0} \in P D\left(A^{r}\right), T_{t_{0}, p_{0}}$ is a contraction mapping from $\mathscr{F}$ into $\mathcal{F}$.

Before the proof of Proposition 3.2, we give definitions of several sets and three key lemmas. Define $\Pi, C_{l}, \Omega(B)$ and $\Omega^{\prime}(B)$ as follows:

\Omega^{\prime}(B) & =\left\{(w, z) \in \mathbf{R}^{2} ; z \geqq l w \geqq 0, z \geqq \theta B\right\}(\subset \Pi) .
\end{align*}\right.

In the next three lemmas, it is assumed that the functions $w(t), z(t)$ are non negative and belong to $C^{0}\left(\left(-\infty, t_{0}\right], \mathbf{R}\right) \cap C^{1}\left(\left(-\infty, t_{0}\right), \mathbf{R}\right)$.

Lemma 3.3. Assume that two functions $w(t), z(t)$ satisfy the following differential inequalities:

\frac{1}{2} \frac{d}{d t} z^{2} \leqq-\left(\lambda_{N+1}-K_{1} \lambda_{N+1}\right) z^{2}+K_{1} \lambda_{N+1} w z \quad \text { in } C_{l} .
\end{array}\right.
$$

If $\left(w\left(t_{1}\right), z\left(t_{1}\right)\right) \in C_{\iota}$ for some $t_{1}\left(\leqq t_{0}\right)$, then $(w(t), z(t)) \in C_{l}$ for any $t \leqq t_{1}$ and the following estimate holds:

Moreover if $z(t)$ is bounded in $\left(-\infty, t_{0}\right]$, then

Lemma 3.4. Assume that two functions $w(t), z(t)$ satisfy the following differential inequalities:

\frac{1}{2} \frac{d}{d t} w^{2} \geqq-\left(\lambda_{N}+K_{1} \lambda_{N}^{\gamma}-\nu\right) w^{2}-K_{1} \lambda_{N}^{\gamma} w z-K_{1} \lambda_{N}^{\gamma} B w \quad \text { in } \Pi,  \tag{3.11}\\
\frac{1}{2} \frac{d}{d t} z^{2} \leqq-\left(\lambda_{N+1}-K_{1} \lambda_{N+1}^{\gamma}-\nu\right) z^{2}+K_{1} \lambda_{N+1}^{\gamma} w z+K_{1} \lambda_{N+1}^{\gamma} B z \quad \text { in } \Omega(B),
\end{array}\right.
$$

where $B$ is a positive constant. If there exists $t_{1}\left(\leqq t_{0}\right)$ such that

\left(w\left(t_{1}\right), z\left(t_{1}\right)\right) \in \Omega(B),
$$

then $(w(t), z(t)) \in \Omega(B)$ for any $t \leqq t_{1}$ and

0 \leqq z(t) \leqq z\left(t_{2}\right) e^{-\left(\tau_{2}-2\right)\left(t-t_{2}\right)} \quad \text { for } t_{2} \leqq t \leqq t_{1} \tag{3.12}

where $\nu_{2}$ is as in (3.2). Furthermore if $z(t)$ is bounded in $\left(-\infty, t_{0}\right]$ and $w\left(t_{0}\right) \leqq$ $\theta B /(1-\theta) l$, then

0 \leqq w(t) \leqq \frac{\theta}{(1-\theta) l} B, \quad 0 \leqq z(t) \leqq \frac{\theta}{(1-\theta)} B \quad \text { for all } t \leqq t_{0} . \tag{3.13}

Lemma 3.5. Assume that two functions $w(t), z(t)$ satisfy

\frac{1}{2} \frac{d}{d t} w^{2} \geqq-\left(\lambda_{N}+K_{1} \lambda_{N}^{\gamma}-\nu\right) w^{2}-K_{1} \lambda_{N}^{\gamma} B w \quad \text { in } \Pi,  \tag{3.14}\\
\frac{1}{2} \frac{d}{d t} z^{2} \leqq-\left(\lambda_{N+1}-\nu\right) z^{2}+K_{1} \lambda_{N+1}^{\gamma} w z+K_{1} \lambda_{N+1}^{\gamma} B z \quad \text { in } \Omega^{\prime}(B),
\end{array}\right.
$$

and that $z(t)$ is bounded in $\left(-\infty, t_{0}\right]$ and $w\left(t_{0}\right) \leqq \theta l^{-1} B$. Then $z(t) \leqq \theta$ for all $t \leqq t_{0}$.
Remark 3.6. These lemmas will be applied to the difference of solutions $u(t), v(t)$ to the equation (2.1) or equations specified later. For example,

w(t)=\left|A^{r} P(u(t)-v(t))\right|, \quad z(t)=\left|A^{r} Q(u(t)-v(t))\right|
$$

or

w(t)=e^{\iota\left(t-t_{0}\right)}\left|A^{\gamma} P(u(t)-v(t))\right|, \quad z(t)=e^{冫\left(t-t_{0}\right)}\left|A^{\gamma} Q(u(t)-v(t))\right| .

If the flow for those equations satisfies the condition of Lemmas 3.3, we call the flow has squeezing property (or cone property). We also call the flow has modified squeezing property if the flow satisfies that of Lemma 3.4 or Lemma 3.5.

Proof of Lemma 3.3. If $(w, z) \in C_{l}$, then (3.8) yields

\frac{1}{2} \frac{d}{d t}\left(z^{2}-l^{2} w^{2}\right) \leqq-\left(\lambda_{N+1}-\lambda_{N}-K_{1}\left(1+l^{-1}\right) \lambda_{N+1}^{\lambda_{N}}-K_{\mathbf{1}}(1+l) \lambda_{N}^{\gamma}\right) z^{2}
$$

This inequality implies the invariance of the cone $\left\{(w, z) \in \mathbf{R}^{2} ; 0 \leqq z \leqq l w\right\}$ (see Fig. 1). Therefore it is seen as above that if $\left(w\left(t_{1}\right), z\left(t_{1}\right)\right) \in C_{l}$, then $(w(t), z(t)) \in C_{l}$ for any $t \leqq t_{1}$. In this region, the following inequality holds:

\frac{1}{2} \frac{d}{d t} z^{2} \leqq-\left(\lambda_{N+1}-K_{1}\left(1+l^{-1}\right) \lambda_{N+1}^{\gamma}\right) z^{2}
$$

Thus we get a desired inequality (3.9).
We will next prove the latter part of this lemma. If there exists $t_{1}\left(\leqq t_{0}\right)$ such that $\left(w\left(t_{1}\right), z\left(t_{1}\right)\right)$ in $C_{l}$, then by letting $t_{2} \rightarrow-\infty$ in (3.9) we get $z(t)=0$ and $w(t)=0$ for any $t \leqq t_{1}$. In such a case, the inequality $z(t) \leqq l w(t)$ also holds for all $t \leqq t_{1}$. Consequently $z(t) \leqq l w(t)$ for any $t \leqq t_{0}$. Then the first inequality of (3.8) yields

& +K_{1} \lambda_{N+1}^{\gamma-1 / 2}\left(\left|A^{\gamma} \Delta_{t} p\right|+\left(B_{1} e^{\iota\left(t_{0}-t\right)}+\frac{K_{2}}{K_{1}}\right)|h|\right)\left|A^{\gamma+1 / 2} \Delta_{t} q\right| .

Put $\Delta_{q} p=p\left(t, t_{0}, p_{0}, q_{1}\right)-p\left(t, t_{0}, p_{0}, q_{2}\right), \Delta_{q} q=T_{t_{0}, p_{0}}\left(q_{1}\right)(t)-T_{t_{0}, p_{0}}\left(q_{2}\right)(t)$ which satisfy the following inequalities:

\end{aligned}

Set $w_{q}(t)=e^{\nu\left(t-t_{0}\right)}\left|A^{r} \Delta_{q} p\right|, z_{q}(t)=e^{\nu\left(t-t_{0}\right)}\left|A^{r} \Delta_{q} q\right|$ and

\end{aligned}

It follows from the boundedness of $z_{\xi}(t)$ and the squeezing property that $z_{\xi}(t) \leqq l w_{\xi}(t)$ $\leqq l\left|A^{\gamma} \xi\right|$ for all $t \leqq t_{0}$, which proves Lipschitz continuity with respect to $p_{0}$. As for Lipschitz continuity with respect to $t_{0}$, we can prove the following similarly:

We will show that this fixed point $q\left(t, t_{0}, p_{0}\right)$ is represented by a graph from $P D\left(A^{r}\right)$ into $Q D\left(A^{r}\right)$.

Proof. Put $\Delta p=p\left(t, t_{0}, p_{0}\right)-p\left(t, t_{1}, p_{1}\right), \Delta q=q\left(t, t_{0}, p_{0}\right)-q\left(t, t_{1}, p_{1}\right)$. The squeezing property shows that $\left|A^{r} \Delta q\right| \leqq l\left|A^{\gamma} \Delta p\right|$. This lemma follows from substituting $t=t_{1}$ into $\Delta p, \Delta q$ i.e.,

This set is not empty because $P u(t)+\Phi(t, P u(t)) \in D_{t, u_{0}}$. On the other hand, the semiflow is invertible on the inertial manifold. Setting $\tilde{S}\left(t_{1}, t_{2}\right)=\left.S\left(t_{1}, t_{2}\right)\right|_{\boldsymbol{M}_{t_{2}}}$, we have

We set $K_{t, u_{0}}=P \tilde{S}\left(t_{0}, t\right) D_{\iota, u_{0}}$ for $t \geqq t_{0}$. By applying the squeezing property in Lemma 3.3 to the difference of two solutions, we get

Thus $K_{t_{2}, u_{0}} \subset K_{t_{1}, u_{0}} \subset K_{t_{0}, u_{0}}$ for $t_{0} \leqq t_{1} \leqq t_{2}$ (see Fig. 3). It is obvious that $K_{t, u_{0}}$ is a closed bounded set with finite dimension. Set $K_{u_{0}}=\cap_{t i 0} K_{t, u_{0}}$ which is a nonempty compact
set. We can choose an element $p_{0}$ in $K_{0}$. Take the solution $v(t)$ on the manifold as

Because of the definition of $K_{t, u_{0}}$,

& \leqq\left(\left|A^{r} Q u_{0}\right|+K_{0} \frac{e^{-r}}{1-\gamma} \lambda_{N+1}^{r-1}\right) e^{-\nu\left(t-t_{0}\right)} .
\end{aligned}

Thus we can conclude

## 4. Regularity of an inertial manifold

Consider the Galerkin approximate equation

\left|A^{r}\left(p\left(t, t_{0}, p_{0}+s \xi\right)-p\left(t, t_{0}, p_{0}\right)-\rho\left(t, t_{0}, p_{0}\right) s \xi\right)\right| \\
\quad \leqq \int_{0}^{1}\left|A^{r}\left(\rho\left(t, t_{0}, p_{0}+s \zeta \xi\right)-\rho\left(t, t_{0}, p_{0}\right)\right) s \xi\right| d \zeta \\
\quad \leqq o(|s|) \\
\left|A^{r}\left(q\left(t, t_{0}, p_{0}+s \xi\right)-q\left(t, t_{0}, p_{0}\right)-\sigma\left(t, t_{0}, p_{0}\right) s \xi\right)\right| \\
\quad \leqq o(|s|)
\end{array}\right.
$$

Thus we have proved that $p\left(t, t_{0}, p_{0}\right)$ and $q\left(t, t_{0}, p_{0}\right)$ have Fréchlet derivatives.

## 5. Proof of Theorem 2.5

First, we note that we can choose $l, \theta$ and $\nu$ satisfying

$$
\left\{\begin{aligned}
& \lambda_{N}+K_{1}\left(1+\theta^{-1} l\right) \lambda_{N}^{\gamma} \leqq \nu \leqq \lambda_{N+1}-K_{1}\left(\theta^{-1}+l^{-1}\right), \\
& 0<\theta<1, \\
& \eta \leqq \nu .
\end{aligned}\right.
$$

Recall that $p_{1}\left(t, t_{0}, p_{0}\right), p_{2}\left(t, t_{0}, p_{0}\right)$ are the solutions to (2.7) and (2.8) respectively. For simplicity of our notations, we set

$$
\begin{cases}p_{1}(t)=p_{1}\left(t, t_{0}, p_{0}\right), & p_{2}(t)=p_{2}\left(t, t_{0}, p_{0}\right),  \tag{5.1}\\ q_{1}(t)=\Phi\left(t, p_{1}(t)\right), & q_{2}(t)=\tilde{\Phi}\left(t, p_{2}(t)\right), \\ p(t)=p_{1}(t)-p_{2}(t), & q(t)=q_{1}(t)-q_{2}(t) .\end{cases}
$$

Then we get the following equations by (2.7) and (2.8) :

$$
\begin{aligned}
& \frac{d p}{d t}+A p+P R\left(t, p_{1}+\Phi\left(t, p_{1}\right)\right)-P \tilde{R}\left(t, p_{2}+\tilde{\Phi}\left(t, p_{2}\right)\right)=0 \\
& \frac{d q}{d t}+A q+Q R\left(t, p_{1}+\Phi\left(t, p_{1}\right)\right)-Q \tilde{R}\left(t, p_{2}+\tilde{\Phi}\left(t, p_{2}\right)\right)=0 .
\end{aligned}
$$

Therefore putting

$$
\begin{equation*}
w(t)=e^{\left\ulcorner\left(t-t_{0}\right)\right.}\left|A^{\gamma} p(t)\right|, \quad z(t)=e^{\nu\left(t-t_{0}\right)}\left|A^{r} q(t)\right| \quad \text { for any } t \leqq t_{0} \tag{5.2}
\end{equation*}
$$

and using the same arguement in §3, we have

$$
\frac{d}{d t} w^{2} \geqq-\lambda_{N} w^{2}-K_{1} \lambda_{N}^{\gamma}(w+z) w-K_{1} \lambda_{N}^{\gamma} B_{6} w \quad \text { in } I I,
$$

$$
\frac{d}{d t} z^{2} \leqq-\lambda_{N+1} z^{2}+K_{1} \lambda_{N+1}^{\gamma}(w+z) z+K_{1} \lambda_{N+1} B_{5} z \quad \text { in } \Omega\left(B_{5}\right),
$$

where $B_{5}=\left(K_{3} / K_{1}\right) e^{-\eta t_{0}}$. Using Lemma 3.5 yields

$$
z(t) \leqq \frac{\theta K_{3}}{(1-\theta) K_{1}} e^{-\eta t_{0}} \quad \text { for any } t \leqq t_{0}
$$

Particularly when we put $t=t_{0}$, we get

$$
\left|A^{r}\left(\Phi\left(t_{0}, p_{0}\right)-\tilde{\Phi}\left(t_{0}, p_{0}\right)\right)\right| \leqq c_{2} K_{s} e^{-\eta t_{0}}
$$

where

$$
\begin{equation*}
c_{2}=\frac{\theta}{(1-\theta) K_{1}} \tag{5.3}
\end{equation*}
$$

(see (5.1) and (5.2)). Let us prove the last part of Theorem 2.5. The condition (2.12) assure that we can find $l, \theta$ satisfying $\nu_{1}<\eta<\nu_{2}$ where $\nu_{1}, \nu_{2}$ are as in (3.2). We put

$$
p_{1}\left(t ; t_{i}\right)=p_{1}\left(t, t_{i}, p_{2}\left(t_{i}\right)\right) \quad(i=1,2) .
$$

Then we can easily check that

$$
\left\{\begin{array}{l}
\frac{1}{2} \frac{d}{d t}\left|A^{\gamma} \bar{p}\right|^{2} \geqq-\left(\lambda_{N}+K_{1}(1+l) \lambda_{N}^{\lambda}\right)\left|A^{r} \bar{p}\right|^{2} \geqq-\nu_{1}\left|A^{\gamma} \bar{p}\right|^{2} \\
\bar{p}(t)=p_{1}\left(t ; t_{1}\right)-p_{1}\left(t ; t_{2}\right) .
\end{array}\right.
$$

Thus for $t \leqq t_{1} \leqq t_{2}$,

$$
\begin{equation*}
\left|A^{\gamma}\left(p_{1}\left(t ; t_{1}\right)-p_{1}\left(t ; t_{2}\right)\right)\right| \leqq\left|A^{r}\left(p_{2}\left(t_{1}\right)-p_{1}\left(t_{1} ; t_{2}\right)\right)\right| e^{\nu_{1}\left(t_{1}-t\right)} . \tag{5.4}
\end{equation*}
$$

On the other hand we estimate the difference of the solutions of (2.7) and (2.8). Considering A4, we see that $\tilde{p}(t)=p_{2}(t)-p_{1}\left(t ; t_{2}\right)$ satisfies

$$
\frac{1}{2} \frac{d}{d t}\left|A^{\gamma} \tilde{p}\right|^{2}+\left(\lambda_{N}+K_{1}(1+l) \lambda_{N}^{\gamma}\right)\left|A^{\gamma} \tilde{p}\right|^{2} \geqq-K_{3} e^{-\eta t} \lambda_{N}^{\gamma}\left|A^{\gamma} \tilde{p}\right| .
$$

Through the observation of the flow of

$$
\tilde{w}(t)=e^{\eta t}\left|A^{\gamma} \tilde{p}(t)\right|
$$

and the fact $\tilde{w}\left(t_{2}\right)=0$, we have

$$
\tilde{w}(t) \leqq \frac{\theta}{(1-\theta) l} \frac{K_{3}}{K_{1}} \quad \text { for any } t \leqq t_{2} .
$$

Hence

$$
\begin{equation*}
\left|A^{\gamma} \tilde{p}\left(t_{1}\right)\right| \leqq \frac{\theta K_{3}}{(1-\theta) l K_{1}} e^{-\eta t_{1}} \quad \text { for any } t_{1} \leqq t_{2} \tag{5.5}
\end{equation*}
$$

Substituting (5.5) to (5.4) yields

$$
\begin{equation*}
\left|A^{\gamma}\left(p_{1}\left(t ; t_{1}\right)-p_{1}\left(t ; t_{2}\right)\right)\right| \leqq \frac{\theta K_{3}}{(1-\theta) l K_{1}} e^{-\left(\eta-\nu_{1}\right) t_{1}-\nu_{1} t} \quad \text { for } t \leqq t_{1} \leqq t_{2} . \tag{5.6}
\end{equation*}
$$

It is shown that $p_{1}\left(t ; t_{2}\right)$ converges compact uniformly when $t_{2}$ tends to infinity. The limit function $\hat{p}_{1}(t)=\lim _{t_{2} \rightarrow \infty} p_{1}\left(t ; t_{2}\right)$ is also the solution of (2.7). By letting $t_{1}=t$ and
$t_{2} \rightarrow \infty$ in (5.6), we obtain

$$
\left|A^{r}\left(p_{2}(t)-\hat{p}_{1}(t)\right)\right| \leqq c_{3} K_{3} e^{-\eta t}
$$

where

$$
\begin{equation*}
c_{3}=\frac{\theta}{(1-\theta) l K_{1}}\left(=\frac{c_{2}}{l}\right) \tag{5.7}
\end{equation*}
$$

## 6. Example

Consider the next example, Kuramoto-Sivashinsky equation,

$$
\begin{cases}\frac{\partial u}{\partial t}+\frac{\partial^{4} u}{\partial x^{4}}+\frac{\partial^{2} u}{\partial x^{2}}+u \frac{\partial u}{\partial x}=0 & \text { in }-\infty<x<\infty, t>0  \tag{6.1}\\ u(0, x)=u_{0}(x) & \text { in }-\infty<x<\infty \\ u(t, x+L)=u(t, x) & \text { in }-\infty<x<\infty, t>0 \\ u(t,-x)=u(t, x) & \text { in }-\infty<x<\infty, t>0\end{cases}
$$

Let $H$ be

$$
\left\{u \in L^{2}\left(-\frac{L}{2}, \frac{L}{2}\right) ; u(x)=-u(-x)\right\}
$$

This equation has an absorbing set $\mathscr{B}$, that is, a compabt set which attracts solutions in a finite time. Especially,

$$
\mathscr{G} \subset\left\{u \in H ; u \in H^{2}\left(-\frac{L}{2}, \frac{L}{2}\right),|u| \leqq \rho_{0},\left|u_{x}\right| \leqq \rho_{1}\right\}
$$

where constants $\rho_{0}, \rho_{1}$ depend only on $L$ (see B. Nicolaenko, B. Scheuer and R. Temam [14] and its refeIences)

$$
\begin{aligned}
& \rho_{0}=O\left(L^{5 / 2}\right) \\
& \rho_{1}=O\left(L^{7 / 2}\right)
\end{aligned}
$$

We define

$$
\begin{aligned}
A_{0} u & =\left(P_{N_{0}} u\right)_{x x} \\
A u & =u_{x x x x}+u_{x x}-A_{0} u \\
R(u) & =\varphi\left(\frac{|u|}{2 \rho_{0}}\right) \varphi\left(\frac{\left|u_{x}\right|}{2 \rho_{1}}\right)\left(u u_{x}-A_{0} u\right),
\end{aligned}
$$

where $N_{0}=[L / 2 \pi]$ ( $[\cdot]$ is denoted by Gauss' symbol) and $\varphi$ is a smooth function satisfying $\left|\varphi^{\prime}\right| \leqq 3$ and

$$
\varphi(x)= \begin{cases}1 & \text { if } x \leqq 1 \\ 0 & \text { if } x \geqq \frac{3}{2}\end{cases}
$$

Then we can easily check that

$$
|R(u)-R(v)| \leqq c_{4} L^{4}|u-v|+c_{5} L^{3}\left|A^{1 / 4}(u-v)\right|
$$

(see P. Constantin, C. Foias, B. Nicolaenko and R. Temam [3] and [7]). It is easily shown that the condition A1 and A2 are satisfied. We can find some number $N$ satisfying

$$
\lambda_{N+1}-\lambda_{N}-4 c_{4} L^{4}-2 c_{5} L^{3}\left(\lambda_{N+1}^{1 / 4}+\lambda_{N}^{1 / 4}\right)>0 .
$$

because $\lambda_{N}=O\left(N^{4}\right), \lambda_{N+1}-\lambda_{N}=O\left(N^{3}\right)$. Since $R(\cdot)$ is $C^{1}$, we can construct the $C^{1}$ inertial manifold.
