# Multilinear Fourier multipliers with minimal Sobolev regularity, II

#### Abstract

We provide characterizations for boundedness of multilinear Fourier multiplier operators on Hardy or Lebesgue spaces with symbols locally in Sobolev spaces. Let $H^{q}\left(\mathbb{R}^{n}\right)$ denote the Hardy space when $0<q \leq 1$ and the Lebesgue space $L^{q}\left(\mathbb{R}^{n}\right)$ when $1<q \leq \infty$. We find optimal conditions on $m$-linear Fourier multiplier operators to be bounded from $H^{p_{1}} \times \cdots \times H^{p_{m}}$ to $L^{p}$ when $1 / p=1 / p_{1}+\cdots+1 / p_{m}$ in terms of local $L^{2}$-Sobolev space estimates for the symbol of the operator. Our conditions provide multilinear analogues of the linear results of Calderón and Torchinsky [1] and of the bilinear results of Miyachi and Tomita [17]. The extension to general $m$ is significantly more complicated both technically and combinatorially; the optimal Sobolev space smoothness required of the symbol depends on the Hardy-Lebesgue exponents and is constant on various convex simplices formed by configurations of $m 2^{m-1}+1$ points in $[0, \infty)^{m}$.


## 1. Introduction.

We denote by $T_{\sigma}$ the linear Fourier multiplier operator, acting on Schwartz functions $f$, defined by

\begin{equation*}
T_{\sigma}(f)(x)=\int_{\mathbb{R}^{n}} \sigma(\xi) \widehat{f}(\xi) e^{2 \pi i x \cdot \xi} d \xi \tag{1.1}
\end{equation*}
$$

where $\sigma$ is a bounded function on $\mathbb{R}^{n}$ and $\widehat{f}(\xi)=\int_{\mathbb{R}^{n}} f(x) e^{-2 \pi i x \cdot \xi} d x$ denotes the Fourier transform of $f$. Hörmander [15] proved that $T_{\sigma}$ is bounded from $L^{p}\left(\mathbb{R}^{n}\right)$ to itself for $1<p<\infty$ if

\sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{s}}<\infty \tag{1.2}
\end{equation*}
$$

for some $s>n / 2$, where $\widehat{\psi}$ is a smooth function supported in $1 / 2 \leq|\xi| \leq 2$ that satisfies

$$
\sum_{j \in \mathbb{Z}} \widehat{\psi}\left(2^{-j} \xi\right)=1
$$

for all $\xi \neq 0$. In this paper, $W^{s}$ denotes the Sobolev space with norm

\|g\|_{W^{s}}=\left\|(I-\Delta)^{s / 2} g\right\|_{L^{2}}
$$
where $I$ is the identity operator and $\Delta=\sum_{j=1}^{n} \partial_{j}^{2}$ is the Laplacian on $\mathbb{R}^{n}$. Hörmander's result strengthens an earlier result of Mikhlin [19].

Throughout this work, $H^{p}\left(\mathbb{R}^{n}\right)$ denotes the real-variable Hardy space of Fefferman and Stein [4], for $0<p \leq \infty$. This space coincides with the Lebesgue space $L^{p}\left(\mathbb{R}^{n}\right)$ when $1<p \leq \infty$. Calderón and Torchinsky [1] provided an extension of Hörmander's result to $H^{p}\left(\mathbb{R}^{n}\right)$ for $p \leq 1$. They showed that the Fourier multiplier operator in (1.1) admits a bounded extension from the Hardy space $H^{p}\left(\mathbb{R}^{n}\right)$ to $H^{p}\left(\mathbb{R}^{n}\right)$ with $0<p \leq 1$ if

$$
\sup _{t>0}\|\sigma(t \cdot) \hat{\psi}\|_{W^{s}}<\infty
$$

and $s>(n / p)-(n / 2)$. Moreover, the boundedness of $T_{\sigma}$ on $H^{p}$ may not hold if $s<$ $(n / p)-(n / 2)$; in other words, the Calderón and Torchinsky condition $s>(n / p)-(n / 2)$ is sharp (for this, see for instance [17, Remark 1.3]).

In this work we study analogues of these results for multilinear multipliers defined on products of Hardy or Lebesgue spaces on the entire range of indices $0<p \leq \infty$. Multilinear multiplier operators were studied by Coifman and Meyer [2], [3], [16] and more recently by Grafakos and Torres [14]. Multilinear Fourier multiplier is a bounded function $\sigma$ on $\mathbb{R}^{m n}=\mathbb{R}^{n} \times \cdots \times \mathbb{R}^{n}$ associated with the $m$-linear Fourier multiplier operator

$$
\begin{equation*}
T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x)=\int_{\mathbb{R}^{m n}} e^{2 \pi i x \cdot\left(\xi_{1}+\cdots+\xi_{m}\right)} \sigma\left(\xi_{1}, \ldots, \xi_{m}\right) \widehat{f_{1}}\left(\xi_{1}\right) \cdots \widehat{f_{m}}\left(\xi_{m}\right) d \vec{\xi} \tag{1.3}
\end{equation*}
$$

where $f_{j}$ are in the Schwartz space of $\mathbb{R}^{n}$ and $d \vec{\xi}=d \xi_{1} \cdots d \xi_{m}$.
A short history of the known results concerning multilinear multipliers with minimal smoothness is as follows: Tomita [22] obtained $L^{p_{1}} \times \cdots \times L^{p_{m}} \rightarrow L^{p}$ boundedness $(1<$ $\left.p_{1}, \ldots, p_{m}, p<\infty\right)$ for multilinear multiplier operators under condition (1.2). Grafakos and $\mathrm{Si}[\mathbf{1 2}]$ extended Tomita's result to the case $p \leq 1$ using $L^{r}$-based Sobolev spaces with $1<r \leq 2$. Fujita and Tomita [6] provided weighted extensions of these results and also noticed that the Sobolev space $W^{s}$ in (1.2) can be replaced by a product-type Sobolev space $W^{\left(s_{1}, \ldots, s_{m}\right)}$ when $p>2$. Grafakos, Miyachi, and Tomita [10] extended the range of $p$ in $[\mathbf{6}]$ to $p>0$ and obtained the boundedness even in the endpoint case where all but one indices $p_{j}$ are equal to infinity. Miyachi and Tomita [17] provided sharp conditions on the entire range of indices $\left(0<p_{j} \leq \infty\right)$, extending the Calderón and Torchinsky [1] result to the case $m=2$.

In this work we provide extensions of the result of Calderón and Torchinsky [1] $(m=1)$ and of Miyachi and Tomita $[\mathbf{1 7}](m=2)$ to the cases $m \geq 3$. We point out that the complexity of the problem increases significantly as $m$ increases. In fact, the main difficulty concerns the case where $1<p_{j}<2$, in which the boundedness holds exactly in the interior of a convex simplex in $\mathbb{R}^{m}$. This simplex has $m 2^{m-1}+1$ vertices but it is not enough to obtain the corresponding estimates for the vertices of the simplex, since interpolation between the vertices does not yield minimal smoothness in the interior. We overcome this difficulty by establishing estimates for all the points inside the simplex
being arbitrarily close to those $m 2^{m-1}+1$ points without losing smoothness.
Before stating our main result we introduce some notation. First, for $x \in \mathbb{R}^{n}$ we set $\langle x\rangle=\sqrt{1+|x|^{2}}$. For $s_{1}, \ldots, s_{m}>0$, we denote by $W^{\left(s_{1}, \ldots, s_{m}\right)}$ the product-type-Sobolev space consisting of all functions $f$ on $\mathbb{R}^{m n}$ such that

\|f\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}:=\left(\int_{\mathbb{R}^{m n}}\left|\widehat{f}\left(y_{1}, \ldots, y_{m}\right)\left\langle y_{1}\right\rangle^{s_{1}} \cdots\left\langle y_{m}\right\rangle^{s_{m}}\right|^{2} d y_{1} \cdots d y_{m}\right)^{1 / 2}<\infty
$$

Notice that $W^{\left(s_{1}, \ldots, s_{m}\right)}$ is a subspace of $L^{2}$.
We also denote by $\psi$ a smooth function on $\mathbb{R}^{m n}$ whose Fourier transform $\widehat{\psi}$ is supported in $1 / 2 \leq|\xi| \leq 2$ and satisfies

$$
\sum_{j \in \mathbb{Z}} \widehat{\psi}\left(2^{-j} \xi\right)=1, \quad \xi \neq 0
$$

The following is the main result of this paper. It concerns boundedness of operators of the form (1.3) on products of Hardy spaces in the full range of indices.

Theorem 1.1. Let $0<p_{1}, \ldots, p_{m} \leq \infty, 0<p<\infty, 1 / p_{1}+\cdots+1 / p_{m}=1 / p$, $s_{1}, \ldots, s_{m}>n / 2$, and suppose

$$
\begin{equation*}
\sum_{k \in J}\left(\frac{s_{k}}{n}-\frac{1}{p_{k}}\right)>-\frac{1}{2} \tag{1.4}
\end{equation*}
$$

for every nonempty subset $J \subset\{1,2, \ldots, m\}$. If $\sigma$ satisfies

$$
\begin{equation*}
A:=\sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}<\infty \tag{1.5}
\end{equation*}
$$

then we have

$$
\begin{equation*}
\left\|T_{\sigma}\right\|_{H^{p_{1} \times \cdots \times H^{p_{m}}} \longrightarrow L^{p}} \lesssim A . \tag{1.6}
\end{equation*}
$$

Moreover, this result is optimal in the sense that if (1.5) and (1.6) are valid then we must necessarily have $s_{1}, \ldots, s_{m} \geq n / 2$ and

$$
\begin{equation*}
\sum_{k \in J}\left(\frac{s_{k}}{n}-\frac{1}{p_{k}}\right) \geq-\frac{1}{2} \tag{1.7}
\end{equation*}
$$

for every nonempty subset $J$ of $\{1,2, \ldots, m\}$.
Remark 1.2. This paper is a sequel of $[\mathbf{1 3}]$ for the following reasons:
(1) The case $p_{i} \leq 1$ for all $1 \leq i \leq m$ is contained in [13].
(2) The endpoint case of Theorem 1.1 in the case where $p_{i}=p=\infty$ for all $i \in$ $\{1, \ldots, m\}$ is proved in [13]:

\left\|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)\right\|_{B M O} \lesssim \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} \prod_{i=1}^{m}\left\|f_{i}\right\|_{L^{\infty}}
$$

for $s_{1}, \ldots, s_{m}>n / 2$.
(3) The necessity of the conditions $s_{i} \geq n / 2$ and (1.7) was shown in [13, Theorem 5.1] for the entire range of indices $0<p_{j} \leq \infty, 0<p<\infty$.

We will consistently use the notation $A \lesssim B$ to indicate that $A \leq C B$ for some constant $C>0$, and $A \approx B$ if $A \lesssim B$ and $B \lesssim A$ simultaneously.

The paper is structured as follows. Section 2 contains preliminaries and known results. In Section 3, we give the proof of the main result by considering four cases. In Section 4, we present detailed proofs of the lemmas used in Section 3. In the last section, Section 5, we give a result concerning the space $L^{1}$ and weak type estimate.

## 2. Preliminaries and known results.

Now fix $0<p \leq \infty$ and a Schwartz function $\Phi$ with $\widehat{\Phi}(0) \neq 0$. Then the Hardy space $H^{p}$ contains all tempered distributions $f$ on $\mathbb{R}^{n}$ such that

$$
\|f\|_{H^{p}}:=\left\|\sup _{0<t<\infty}\left|\Phi_{t} * f\right|\right\|_{L^{p}}<\infty
$$

It is well known that the definition of the Hardy space does not depend on the choice of the function $\Phi$. Note that $H^{p}=L^{p}$ for all $p>1$. When $0<p \leq 1$, one of nice features of Hardy spaces is their atomic decomposition. More precisely, any distribution $f \in H^{p}(0<p \leq 1)$ can be decomposed as $f=\sum_{k} \lambda_{k} a_{k}$, where $a_{k}$ 's are $L^{\infty}$-atoms for $H^{p}$ supported in cubes $Q_{k}$ such that $\left\|a_{k}\right\|_{L^{\infty}} \leq\left|Q_{k}\right|^{-1 / p}$ and $\int x^{\gamma} a_{k}(x) d x=0$ for all $|\gamma|<N$, and the coefficients $\lambda_{k}$ satisfy $\sum_{k}\left|\lambda_{k}\right|^{p} \leq 2^{p}\|f\|_{H^{p}}^{p}$. The order $N$ of the moment condition can be taken arbitrarily large.

A fundamental $L^{2}$ estimate for $T_{\sigma}$ is given in the following theorem.
Theorem 2.1 ([10]). If $s_{1}, \ldots, s_{m}>n / 2$, then

$$
\left\|T_{\sigma}\right\|_{L^{2} \times L^{\infty} \times \cdots \times L^{\infty} \longrightarrow L^{2}} \leq C \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j}\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}
$$

The following two lemmas are essentially contained in [17], modulo a few minor modifications.

Lemma $2.2([\mathbf{1 7}])$. Let $m$ be a positive integer, $\sigma$ be a function defined on $\mathbb{R}^{m n}$, and $K=\sigma^{\vee}$, the inverse Fourier transform of $\sigma$. Suppose that $\sigma$ is supported in the ball $\left\{y \in \mathbb{R}^{m n}:|y| \leq 2\right\}$ and suppose, $s_{i} \geq 0$ for $1 \leq i \leq m$ and $1 \leq p \leq q \leq \infty$. Then for each multi-index $\alpha$ there exists a constant $C_{\alpha}$ such that

$$
\left\|\left\langle y_{1}\right\rangle^{s_{1}} \cdots\left\langle y_{m}\right\rangle^{s_{m}} \partial_{y}^{\alpha} K(y)\right\|_{L^{q}\left(\mathbb{R}^{m n}, d y_{1} \cdots d y_{m}\right)} \leq C_{\alpha}\left\|\left\langle y_{1}\right\rangle^{s_{1}} \cdots\left\langle y_{m}\right\rangle^{s_{m}} K(y)\right\|_{L^{p}\left(\mathbb{R}^{m n}, d y_{1} \cdots d y_{m}\right)},
$$

where $y=\left(y_{1}, \ldots, y_{m}\right)$ with $y_{j} \in \mathbb{R}^{n}$.

Lemma 2.3 ([17]). Let $s_{i}>n / 2$ for $1 \leq i \leq m$, and let $\widehat{\zeta}$ be a smooth function which is supported in an annulus centered at zero. Suppose that $\Phi$ is a smooth function away from zero that satisfies the estimates

$$
\left|\partial_{\xi}^{\alpha} \Phi(\xi)\right| \leq C_{\alpha}|\xi|^{-|\alpha|}
$$

for all $\xi \in \mathbb{R}^{m n}, \xi \neq 0$, and for all multi-indices $\alpha$. Then there exists a constant $C$ such that

$$
\sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j}\right) \Phi\left(2^{j}\right) \widehat{\zeta}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} \leq C \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}
$$

Adapting the Calderón and Torchinsky interpolation techniques in the multilinear setting (for details on this we refer to [10, p. 318]) allows us to interpolate between two estimates for multilinear multiplier operators from a product of some Hardy spaces or Lebesgue spaces to Lebesgue spaces.

Theorem 2.4 ([10]). Let $0<p_{i}, p_{i, k} \leq \infty$ and $s_{i, k}>0$ for $i=1,2$ and $1 \leq$ $k \leq m$. For $0<\theta<1$, set $1 / p=(1-\theta) / p_{1}+\theta / p_{2}, 1 / p_{k}=(1-\theta) / p_{1, k}+\theta / p_{2, k}$, and $s_{k}=(1-\theta) s_{1, k}+\theta s_{2, k}$. Assume that the multilinear operator $T_{\sigma}$ defined in (1.3) satisfies the estimates

$$
\left\|T_{\sigma}\right\|_{H^{p_{i, 1}} \times \cdots \times H^{p_{i, m}} \longrightarrow L^{p_{i}}} \leq C_{i} \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{i, 1}, \ldots, s_{i, m}\right)}}, \quad i=1,2
$$

where $L^{p_{i}}$ should be replaced by $B M O$ if $p_{i}=\infty$. Then

$$
\left\|T_{\sigma}\right\|_{H^{p_{1} \times \cdots \times H^{p_{m}}} \longrightarrow L^{p}} \leq C \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}},
$$

where $L^{p}$ should be replaced by $B M O$ if $p=\infty$.
Fix a Schwartz function $K$. We denote the multilinear operator of convolution type associated with the kernel $K$ by

$$
T^{K}\left(f_{1}, \ldots, f_{m}\right)(x)=\int_{\mathbb{R}^{m n}} K\left(x-y_{1}, \ldots, x-y_{m}\right) f_{1}\left(y_{1}\right) \cdots f_{m}\left(y_{m}\right) d y_{1} \cdots d y_{m}
$$

The following result can be verified with a very similar argument to that in [13, Proposition 3.4].

Proposition 2.5. Let $0<p_{1}, \ldots, p_{l} \leq 1$ and $1<p_{l+1}, \ldots, p_{m} \leq \infty$. Let $K$ be a smooth function with compact support. Suppose $f_{i} \in H^{p_{i}}, 1 \leq i \leq l$, has atomic representation $f_{i}=\sum_{k_{i}} \lambda_{i, k_{i}} a_{i, k_{i}}$, where $a_{i, k_{i}}$ are $L^{\infty}$-atoms for $H^{p_{i}}$ and $\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|^{p_{i}} \leq$ $2^{p_{i}}\left\|f_{i}\right\|_{H^{p_{i}}}^{p_{i}}$. Suppose $f_{i} \in L^{p_{i}}$ for $l+1 \leq i \leq m$. Then

$$
T^{K}\left(f_{1}, \ldots, f_{m}\right)(x)=\sum_{k_{1}} \cdots \sum_{k_{l}} \lambda_{1, k_{1}} \cdots \lambda_{l, k_{l}} T^{K}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)
$$

for almost all $x \in \mathbb{R}^{n}$.

We also use the following lemmas.
Lemma 2.6 ([9, Lemma 2.1]). Let $0<p \leq 1$ and let $\left(f_{Q}\right)_{Q \in \mathcal{J}}$ be a family of nonnegative integrable functions with $\operatorname{supp}\left(f_{Q}\right) \subset Q$ for all $Q \in \mathcal{J}$, where $\mathcal{J}$ is a family of finite or countable cubes in $\mathbb{R}^{n}$. Then we have

$$
\left\|\sum_{Q \in \mathcal{J}} f_{Q}\right\|_{L^{p}} \lesssim\left\|\sum_{Q \in \mathcal{J}}\left(\frac{1}{|Q|} \int_{Q} f_{Q}(x) d x\right) \chi_{Q}\right\|_{L^{p}}
$$

where the implicit constant of the inequality depends only on $p$.
Lemma 2.7 ([10, Lemma 3.3]). Let $s>n / 2, \max \{1, n / s\}<q<2$, and

$$
\zeta_{j}(x)=2^{j n}\left(1+\left|2^{j} x\right|\right)^{-s q}, \quad j \in \mathbb{Z}, \quad x \in \mathbb{R}^{n} .
$$

Suppose $\sigma \in W^{(s, \ldots, s)}\left(\mathbb{R}^{m n}\right)$ and $\operatorname{supp} \sigma \subset\left\{|\xi| \leq 2^{j+1}\right\}$ for some $j \in \mathbb{Z}$. Then there exists a constant $C>0$ depending only on $m, n$, s, and $q$ such that

$$
\left|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x)\right| \leq C\left\|\sigma\left(2^{j} \cdot\right)\right\|_{W^{(s, \ldots, s)}}\left(\zeta_{j} *\left|f_{1}\right|^{q}\right)(x)^{1 / q} \cdots\left(\zeta_{j} *\left|f_{m}\right|^{q}\right)(x)^{1 / q}
$$

for all $x \in \mathbb{R}^{n}$.
Lemma $2.8\left(\left[\mathbf{1 0}\right.\right.$, Lemma 3.2]). Let $\varphi \in \mathcal{S}\left(\mathbb{R}^{n}\right)$ be such that $\varphi(0)=0$, and set

$$
\begin{equation*}
\Delta_{j} f(x)=\int_{\mathbb{R}^{n}} e^{2 \pi i x \cdot \xi} \varphi\left(2^{-j} \xi\right) \widehat{f}(\xi) d \xi, \quad j \in \mathbb{Z} \tag{2.1}
\end{equation*}
$$

Let $\epsilon>0$ and $\zeta_{j}(x)=2^{j n}\left(1+\left|2^{j} x\right|\right)^{-n-\epsilon}, j \in \mathbb{Z}, x \in \mathbb{R}^{n}$. Then the following inequalities hold for each $0<q<2$ :

$$
\begin{align*}
& \sum_{j \in \mathbb{Z}} \int_{\mathbb{R}^{n}}\left|\Delta_{j} f(x)\right|^{2} d x \leq C\|f\|_{L^{2}}^{2},  \tag{2.2}\\
& \sum_{j \in \mathbb{Z}} \int_{\mathbb{R}^{n}}\left(\zeta_{j} *|f|^{q}\right)(x)^{2 / q}\left(\zeta_{j} *\left|\Delta_{j} g\right|^{q}\right)(x)^{2 / q} d x \leq C_{q}\|f\|_{L^{2}}^{2}\|g\|_{B M O}^{2} \tag{2.3}
\end{align*}
$$

Lemma 2.9. Suppose $\left\{F_{j}\right\} \subset \mathcal{S}^{\prime}\left(\mathbb{R}^{n}\right)$ and suppose there exists a constant $B>1$ such that $\operatorname{supp} \widehat{F_{j}} \subset\left\{\zeta \in \mathbb{R}^{n}\left|B^{-1} 2^{j} \leq|\zeta| \leq B 2^{j}\right\}\right.$ for all $j \in \mathbb{Z}$. Then, for each $0<p<\infty$,

$$
\left\|\sum_{j} F_{j}\right\|_{H^{p}} \lesssim\left\|\left(\sum_{j}\left|F_{j}\right|^{2}\right)^{1 / 2}\right\|_{L^{p}}
$$

The preceding lemma is well known in the Littlewood-Paley theory, see for example [23, 5.2.4] and [8, Lemma 7.5.2].

## 3. The proof of the main result.

In this section, we prove the main theorem by considering four cases.

### 3.1. The first case: $0<p_{i} \leq 1,1 \leq i \leq m$.

This case is a consequence of the following result established in [13]:
Theorem 3.1 ([13]). Let $n / 2<s_{1}, \ldots, s_{m}<\infty, 0<p_{1}, \ldots, p_{m} \leq 1$, and $1 / p_{1}+$ $\cdots+1 / p_{m}=1 / p$. Suppose (1.4) holds for every nonempty subset $J$ of $\{1,2, \ldots, m\}$. Then (1.6) holds.

### 3.2. The second case: $0<p_{i} \leq 1$ or $p_{i}=\infty$.

Theorem 3.2. Let $n / 2<s_{1}, \ldots, s_{m}<\infty, 0<p_{1}, \ldots, p_{l} \leq 1,1 \leq l<m$, and $1 / p_{1}+\cdots+1 / p_{l}=1 / p$. Suppose (1.4) holds for every nonempty subset $J$ of $\{1,2, \ldots, l\}$. Then

$$
\begin{equation*}
\left\|T_{\sigma}\right\|_{H^{p_{1} \times \cdots \times H^{p_{l}} \times L^{\infty} \times \cdots \times L^{\infty} \longrightarrow L^{p}}} \lesssim \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} \tag{3.1}
\end{equation*}
$$

Proof. The proof of this theorem is similar to the proof of Theorem 3.1 given in [13].

By regularization (see [13, Section 3]), we can always assume that the inverse Fourier transform of $\sigma$ is smooth and compactly supported. The aim is to show that

\left\|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)\right\|_{L^{p}} \lesssim A\left\|f_{1}\right\|_{H^{p_{1}}} \cdots\left\|f_{l}\right\|_{H^{p_{l}}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \tag{3.2}
\end{equation*}
$$

Fix functions $f_{i} \in H^{p_{i}}$. Using atomic representations for $H^{p_{i}}$-functions, write

$$
f_{i}=\sum_{k_{i} \in \mathbb{Z}} \lambda_{i, k_{i}} a_{i, k_{i}}, \quad 1 \leq i \leq l,
$$

where $a_{i, k_{i}}$ are $L^{\infty}$-atoms for $H^{p_{i}}$ satisfying

$$
\operatorname{supp}\left(a_{i, k_{i}}\right) \subset Q_{i, k_{i}}, \quad\left\|a_{i, k_{i}}\right\|_{L^{\infty}} \leq\left|Q_{i, k_{i}}\right|^{-1 / p_{i}}, \quad \int_{Q_{i, k_{i}}} x^{\alpha} a_{i, k_{i}}(x) d x=0
$$

for $|\alpha|<N_{i}$ with $N_{i}$ large enough, and $\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|^{p_{i}} \leq 2^{p_{i}}\left\|f_{i}\right\|_{H^{p_{i}}}^{p_{i}}$.
For a cube $Q$ we denote by $Q^{*}$ its dilation by the factor $2 \sqrt{n}$. Since $K=\sigma^{\vee}$ is smooth and compactly supported, Proposition 2.5 yields that

T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x)=\sum_{k_{1}} \cdots \sum_{k_{l}} \lambda_{1, k_{1}} \cdots \lambda_{l, k_{l}} T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)
$$

for a.e. $x \in \mathbb{R}^{n}$. Now we can split $T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)$ into two parts and estimate

$$
\left|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x)\right| \leq G_{1}(x)+G_{2}(x)
$$

where

$$
G_{1}=\sum_{k_{1}} \cdots \sum_{k_{l}}\left|\lambda_{1, k_{1}}\right| \cdots\left|\lambda_{l, k_{l}}\right|\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)\right| \chi_{Q_{1, k_{1}}^{*} \cap \cdots \cap Q_{t, k_{l}}^{*}}
$$

and

$$
G_{2}=\sum_{k_{1}} \cdots \sum_{k_{l}}\left|\lambda_{1, k_{1}}\right| \cdots\left|\lambda_{l, k_{l}}\right|\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)\right| \chi_{\left(Q_{1, k_{1}}^{*} \cap \cdots \cap Q_{l, k_{l}}^{*}\right)^{c \cdot}} .
$$

The first part $G_{1}(x)$ can be dealt via the argument in [9] (reprised more clearly in [13]). Suppose the cubes $Q_{1, k_{1}}^{*}, \ldots, Q_{l, k_{l}}^{*}$ satisfy $Q_{1, k_{1}}^{*} \cap \cdots \cap Q_{l, k_{l}}^{*} \neq \emptyset$. From these cubes, choose a cube that has the minimum sidelength, and denote it by $R_{k_{1}, \ldots, k_{l}}$. Then

$$
Q_{1, k_{1}}^{*} \cap \cdots \cap Q_{l, k_{l}}^{*} \subset R_{k_{1}, \ldots, k_{l}} \subset Q_{1, k_{1}}^{* *} \cap \cdots \cap Q_{l, k_{l}}^{* *},
$$

where $Q_{i, k_{i}}^{* *}$ denotes a suitable dilation of $Q_{i, k_{i}}^{*}$. We shall prove

$$
\begin{align*}
& \frac{1}{\left|R_{k_{1}, \ldots, k_{l}}\right|} \int_{R_{k_{1}, \ldots, k_{l}}}\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)\right| d x \\
& \lesssim A \prod_{i=1}^{l}\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} . \tag{3.3}
\end{align*}
$$

To show this, assume without loss of generality $R_{k_{1}, \ldots, k_{l}}=Q_{1, k_{1}}^{*}$. Theorem 2.1 gives us

& \int_{R_{k_{1}, \ldots, k_{l}}}\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)\right| d x \\
& \quad \leq\left\|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)\right\|_{L^{2}}\left|R_{k_{1}, \ldots, k_{l}}\right|^{1 / 2} \\
& \quad \lesssim A\left|R_{k_{1}, \ldots, k_{l}}\right|^{1 / 2}\left\|a_{1, k_{1}}\right\|_{L^{2}} \prod_{i=2}^{l}\left\|a_{i, k_{i}}\right\|_{L^{\infty}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \\
& \leq A\left|R_{k_{1}, \ldots, k_{l}}\right|^{1 / 2}\left|Q_{1, k_{1}}\right|^{1 / 2} \prod_{i=1}^{l}\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \\
& \quad \leq A\left|R_{k_{1}, \ldots, k_{l}}\right| \prod_{i=1}^{l}\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}},
\end{aligned}
$$

which implies (3.3). Now using Lemma 2.6, the estimate (3.3), and Hölder's inequality, we obtain

& \times \int_{R_{k_{1}, \ldots, k_{l}}}\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)\right| d x \|_{L^{p}} \\
\lesssim A & \left\|\sum_{k_{1}} \cdots \sum_{k_{m}}\left(\prod_{i=1}^{l}\left|\lambda_{i, k_{i}}\right|\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \chi_{Q_{i, k_{i}}^{* *}}\right) \prod_{i=l+1}^{m}\right\| f_{i}\left\|_{L^{\infty}}\right\|_{L^{p}}
\end{aligned}
$$

$$
\begin{aligned}
& =A\left\|\prod_{i=1}^{l}\left(\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \chi_{Q_{i, k_{i}}^{* *}}\right)\right\|_{L^{p}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \\
& \leq A \prod_{i=1}^{l}\left\|\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|\left|Q_{i, k_{i}}\right|^{-1 / p_{i}} \chi_{Q_{i, k_{i}}^{* *}}\right\|_{L^{p_{i}}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \\
& \lesssim A \prod_{i=1}^{l}\left\|f_{i}\right\|_{H^{p_{i}}} \prod_{i=l+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} .
\end{aligned}
$$

Thus we have

$$
\begin{equation*}
\left\|G_{1}\right\|_{L^{p}} \lesssim A\left\|f_{1}\right\|_{H^{p_{1}}} \cdots\left\|f_{m}\right\|_{H^{p_{m}}} \tag{3.4}
\end{equation*}
$$

Now for the more difficult part, $G_{2}(x)$, we first restrict $x \in\left(\bigcap_{i \notin J} Q_{i, k_{i}}^{*}\right) \backslash\left(\bigcup_{i \in J} Q_{i, k_{i}}^{*}\right)$ for some nonempty subset $J$ of $\{1,2, \ldots, l\}$. To continue, we need the following lemma whose proof is given in Section 4.

Lemma 3.3. Let $n / 2<s_{1}, \ldots, s_{m}<\infty, 0<p_{1}, \ldots, p_{l} \leq 1,1 \leq l<m$, and suppose (1.4) holds for all $J \subset\{1, \ldots, l\}$. Let $\sigma$ be a function satisfying (1.5). Suppose $a_{i}, 1 \leq i \leq l$, are $H^{p_{i}}$ atoms supported in the cube $Q_{i}$ such that

$$
\left\|a_{i}\right\|_{L^{\infty}} \leq\left|Q_{i}\right|^{-1 / p_{i}}, \quad \int_{Q_{i}} x^{\alpha} a_{i}(x) d x=0
$$

for all $|\alpha|<N_{i}$ with $N_{i}$ sufficiently large. Fix a non-empty subset $J_{0}$ of $\{1, \ldots, l\}$. Then there exist positive functions $b_{1}, \ldots, b_{l}$ such that $b_{i}$ depends only on $m, n,\left(s_{i}\right)_{i=1, \ldots, m}$, $\left(p_{i}\right)_{i=1, \ldots, m}, \sigma, J_{0}, N_{i}$, and $Q_{i}$, and

$$
\left|T_{\sigma}\left(a_{1}, \ldots, a_{l}, f_{l+1}, \ldots, f_{m}\right)(x)\right| \lesssim A b_{1}(x) \cdots b_{l}(x)\left\|f_{l+1}\right\|_{L^{\infty}} \cdots\left\|f_{m}\right\|_{L^{\infty}}
$$

for all $x \in\left(\bigcap_{i \notin J_{0}} Q_{i}^{*}\right) \backslash\left(\bigcup_{i \in J_{0}} Q_{i}^{*}\right)$, and $\left\|b_{i}\right\|_{L^{p_{i}}} \lesssim 1,1 \leq i \leq l$.
For each nonempty subset $J$ of $\{1,2, \ldots, l\}$, Lemma 3.3 guarantees the existence of positive functions $b_{1, k_{1}}^{J}, \ldots, b_{l, k_{l}}^{J}$ depending on $Q_{1, k_{1}}, \ldots, Q_{l, k_{l}}$ respectively, such that

$$
\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)\right| \lesssim A b_{1, k_{1}}^{J} \cdots b_{l, k_{l}}^{J} \prod_{i=l+1}^{\infty}\left\|f_{i}\right\|_{L^{\infty}}
$$

for all $x \in\left(\bigcap_{i \notin J} Q_{i, k_{i}}^{*}\right) \backslash\left(\bigcup_{i \in J} Q_{i, k_{i}}^{*}\right)$ and $\left\|b_{i, k_{i}}^{J}\right\|_{L^{p_{i}}} \lesssim 1$. Now set

$$
b_{i, k_{i}}=\sum_{\emptyset \neq J \subset\{1,2, \ldots, l\}} b_{i, k_{i}}^{J} .
$$

Then

$$
\begin{equation*}
\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)\right| \chi_{\left(Q_{1, k_{1}}^{*} \cap \cdots \cap Q_{l, k_{l}}^{*}\right)^{c}} \lesssim A b_{1, k_{1}} \cdots b_{l, k_{l}} \prod_{i=l+1}^{\infty}\left\|f_{i}\right\|_{L^{\infty}} \tag{3.5}
\end{equation*}
$$

and $\left\|b_{i, k_{i}}\right\|_{L^{p_{i}}} \lesssim 1$. Estimate (3.5) yields

$$
G_{2}(x) \lesssim A \prod_{i=1}^{l}\left(\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right| b_{i, k_{i}}(x)\right) \prod_{i=l+1}^{\infty}\left\|f_{i}\right\|_{L^{\infty}}
$$

Then apply Hölder's inequality to deduce that

\left\|G_{2}\right\|_{L^{p}} \lesssim A\left\|f_{1}\right\|_{H^{p_{1}}} \cdots\left\|f_{l}\right\|_{H^{p_{l}}} \prod_{i=l+1}^{\infty}\left\|f_{i}\right\|_{L^{\infty}} \tag{3.6}
\end{equation*}
$$

Combining (3.4) and (3.6), we obtain (3.2) as needed. This completes the proof.

### 3.3. The third case: $0<\boldsymbol{p}_{\boldsymbol{i}} \leq \mathbf{1}$ or $\mathbf{2} \leq \boldsymbol{p}_{\boldsymbol{i}} \leq \infty$.

Theorem 3.4. Let $n / 2<s_{1}, \ldots, s_{m}<\infty, p_{1}, \ldots, p_{m} \in(0,1] \cup[2, \infty], 0<p<\infty$, and $1 / p_{1}+\cdots+1 / p_{m}=1 / p$. Assume there exists at least one index $i$ such that $p_{i} \in(0,1]$ and also assume the condition (1.4) holds for every nonempty subset $J$ of $\{1,2, \ldots, m\}$. Then (1.6) holds.

Proof. In addition to the assumptions of the theorem, we also assume there exists at least one $i$ such that $p_{i} \in[2, \infty)$, since otherwise the claim is already covered by Theorem 3.1 or Theorem 3.2. Thus without loss of generality, we may assume that $0<p_{1}, \ldots, p_{l} \leq 1,2 \leq p_{l+1}, \ldots, p_{\rho}<\infty, p_{\rho+1}=\cdots=p_{m}=\infty, 1 \leq l<\rho \leq m$, and $1 / p_{1}+\cdots+1 / p_{\rho}=1 / p$. Our goal is to establish the estimate

Assume momentarily the validity of the following estimate

Then using Theorem 2.4 to interpolate between (3.8) and (3.1), we obtain the estimate (3.7) as required. (In fact, since the condition (1.4) with $\left(p_{i}\right)_{i=1, \ldots, m}$ in the estimates of (3.1), (3.7), and (3.8) gives the same restriction on $\left(s_{i}\right)_{i=1, \ldots, m}$, in order to deduce (3.7) from (3.8) and (3.1), we may fix $\left(s_{i}\right)_{i=1, \ldots, m}$ and could use the usual real or complex interpolation for linear operators.) Thus it suffices to prove (3.8). In the rest of the proof, we assume $p_{l+1}=\cdots=p_{\rho}=2$.

Before we proceed to the proof of (3.8), we shall see that it is sufficient to consider $\sigma$ that has support in some cone. To see this, for $\eta=\left(\eta_{1}, \ldots, \eta_{m}\right) \in \mathbb{R}^{m n}$, consider the $m+1$ vectors $\eta_{1}, \ldots, \eta_{m}, \eta_{m+1}=\sum_{i=1}^{m} \eta_{i} \in \mathbb{R}^{n}$. If $\eta$ belongs to the unit sphere $\Sigma=\left\{\eta \in \mathbb{R}^{m n}:|\eta|=1\right\}$, then at least two of these $m+1$ vectors are not zero. Hence, by the compactness of $\Sigma$, there exists a constant $a>0$ such that $\Sigma$ is covered by the $\binom{m+1}{2}$ open sets

$$
V\left(k_{1}, k_{2}\right)=\left\{\eta \in \Sigma:\left|\eta_{k_{1}}\right|>a,\left|\eta_{k_{2}}\right|>a\right\}, \quad 1 \leq k_{1}<k_{2} \leq m+1 .
$$

We take a smooth partition of unity $\left\{\varphi_{k_{1}, k_{2}}\right\}$ on $\Sigma \operatorname{such}$ that $\operatorname{supp} \varphi_{k_{1}, k_{2}} \subset V\left(k_{1}, k_{2}\right)$ and decompose the multiplier $\sigma$ as

$$
\sigma(\xi)=\sum_{1 \leq k_{1}<k_{2} \leq m+1} \sigma(\xi) \varphi_{k_{1}, k_{2}}(\xi /|\xi|)=\sum_{1 \leq k_{1}<k_{2} \leq m+1} \sigma_{k_{1}, k_{2}}(\xi) .
$$

Then

$$
\operatorname{supp} \sigma_{k_{1}, k_{2}} \subset \Gamma\left(V\left(k_{1}, k_{2}\right)\right)=\left\{\xi \in \mathbb{R}^{m n} \backslash\{0\}: \xi /|\xi| \in V\left(k_{1}, k_{2}\right)\right\}
$$

and Lemma 2.3 gives

$$
\sup _{j \in \mathbb{Z}}\left\|\sigma_{k_{1}, k_{2}}\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} \lesssim \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j}\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} .
$$

The estimate (1.6) follows if we prove it with $\sigma_{k_{1}, k_{2}}$ in place of $\sigma$. This means that it is sufficient to prove (1.6) under the additional assumption that

$$
\begin{equation*}
\operatorname{supp} \sigma \subset \Gamma\left(V\left(k_{1}, k_{2}\right)\right) \tag{3.9}
\end{equation*}
$$

for some $1 \leq k_{1}<k_{2} \leq m+1$.
To simplify notation, we also assume

$$
\begin{equation*}
\sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}=1 \tag{3.10}
\end{equation*}
$$

and write

$$
\begin{equation*}
\sigma=\sum_{j \in \mathbb{Z}} \sigma_{j}, \quad \sigma_{j}(\xi)=\sigma(\xi) \widehat{\psi}\left(2^{-j} \xi\right) \tag{3.11}
\end{equation*}
$$

We shall divide the proof into two cases. First case: $\sigma$ satisfies (3.9) with $1 \leq k_{1}<$ $k_{2} \leq m$. Second case: $\sigma$ satisfies (3.9) with $1 \leq k_{1} \leq m$ and $k_{2}=m+1$. In the first case, we shall directly prove the estimate

$$
\begin{equation*}
\left\|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)\right\|_{L^{p}} \lesssim \prod_{i=1}^{m}\left\|f_{i}\right\|_{H^{p_{i}}} \tag{3.12}
\end{equation*}
$$

In the second case, we shall use a Littlewood-Paley function. Notice that, in the second case, the support of the Fourier transform of $T_{\sigma_{j}}\left(f_{1}, \ldots, f_{m}\right)$ is included in the annulus $\left\{\xi \in \mathbb{R}^{n}: B^{-1} 2^{j} \leq|\xi| \leq B 2^{j}\right\}$ with some constant $B>1$. Hence, by Lemma 2.9, we have

\left\|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)\right\|_{H^{p}} \lesssim\left\|\left(\sum_{j \in \mathbb{Z}}\left|T_{\sigma_{j}}\left(f_{1}, \ldots, f_{m}\right)\right|^{2}\right)^{1 / 2}\right\|_{L^{p}} \tag{3.13}
\end{equation*}
$$

Thus, in the second case, we shall consider the function

$$
G T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)=\left(\sum_{j \in \mathbb{Z}}\left|T_{\sigma_{j}}\left(f_{1}, \ldots, f_{m}\right)\right|^{2}\right)^{1 / 2}
$$

and prove the estimate

$$
\begin{equation*}
\left\|G T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)\right\|_{L^{p}} \lesssim \prod_{i=1}^{m}\left\|f_{i}\right\|_{H^{p_{i}}} \tag{3.14}
\end{equation*}
$$

which combined with (3.13) implies (3.12).
The essential part of the proofs of (3.12) and (3.14) are given in the following two lemmas.

LEMMA 3.5. Let $n / 2<s_{1}, \ldots, s_{m}<\infty, 0<p_{1}, \ldots, p_{l} \leq 1, p_{l+1}=\cdots=p_{\rho}=2$, $p_{\rho+1}=\cdots=p_{m}=\infty, 1 \leq l<\rho \leq m$, and suppose (1.4) holds for every nonempty subset $J$ of $\{1, \ldots, l\}$. Let $a_{i}, 1 \leq i \leq l$, be $H^{p_{i}}$ atoms such that

$$
\operatorname{supp} a_{i} \subset Q_{i}, \quad\left\|a_{i}\right\|_{L^{\infty}} \leq\left|Q_{i}\right|^{-1 / p_{i}}, \quad \int a_{i}(x) x^{\alpha} d x=0
$$

for $|\alpha|<N_{i}$, where $N_{i}$ is a sufficiently large positive integer and $Q_{i}$ is a cube. Let $f_{l+1}, \ldots, f_{\rho} \in L^{2}$ and $f_{\rho+1}, \ldots, f_{m} \in L^{\infty}$. Finally suppose $\sigma$ satisfies (3.10) and (3.9) with some $1 \leq k_{1}<k_{2} \leq m$. Then there exist functions $b_{1}, \ldots, b_{l}$ and $\widetilde{f}_{l+1}, \ldots, \widetilde{f}_{\rho}$ such that

$$
\begin{equation*}
\left|T_{\sigma}\left(a_{1}, \ldots, a_{l}, f_{l+1}, \ldots, f_{m}\right)(x)\right| \lesssim \prod_{i=1}^{l} b_{i}(x) \cdot \prod_{i=l+1}^{\rho} \widetilde{f}_{i}(x) \cdot \prod_{i=\rho+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \tag{3.15}
\end{equation*}
$$

the function $b_{i}$ depends only on $m, n,\left(s_{i}\right)_{i=1, \ldots, m},\left(p_{i}\right)_{i=1, \ldots, m}, \sigma, i, a_{i}$, and $\left(f_{i}\right)_{i=\rho+1, \ldots, m}$; the function $\tilde{f}_{i}$ depends only on $m, n,\left(s_{i}\right)_{i=1, \ldots, m}, i, f_{i}$, and $\left(f_{i}\right)_{i=\rho+1, \ldots, m} ;$ and they satisfy the estimates $\left\|b_{i}\right\|_{L^{p_{i}}} \lesssim 1$ and $\left\|\widetilde{f}_{i}\right\|_{L^{2}} \lesssim\left\|f_{i}\right\|_{L^{2}}$.

LEMMA 3.6. Let $s_{i}, p_{i}, a_{i}$, and $f_{i}$ be the same as in Lemma 3.5. Suppose $\sigma$ satisfies (3.10) and (3.9) with some $1 \leq k_{1} \leq m$ and $k_{2}=m+1$. Then there exist functions $b_{1}, \ldots, b_{l}$ and $\widetilde{f}_{l+1}, \ldots, \widetilde{f}_{\rho}$ that satisfy

$$
G T_{\sigma}\left(a_{1}, \ldots, a_{l}, f_{l+1}, \ldots, f_{m}\right)(x) \lesssim \prod_{i=1}^{l} b_{i}(x) \cdot \prod_{i=l+1}^{\rho} \widetilde{f}_{i}(x) \cdot \prod_{i=\rho+1}^{m}\left\|f_{i}\right\|_{L^{\infty}}
$$

and have the same properties as in Lemma 3.5.
The proofs of these lemmas will be given in Section 4 . We shall continue the proof of Theorem 3.4. To utilize the above lemmas, we decompose $f_{i} \in H^{p_{i}}, 1 \leq i \leq l$, into atoms as $f_{i}=\sum_{k_{i} \in \mathbb{Z}} \lambda_{i, k_{i}} a_{i, k_{i}}$ with $\lambda_{i, k_{i}}, a_{i, k_{i}}$, and the cubes $Q_{i, k_{i}}$ being the same as in the proof of Theorem 3.2.

Consider the first case where $\sigma$ satisfies (3.9) with $1 \leq k_{1}<k_{2} \leq m$. In this case, Lemma 3.5 yields functions $b_{i, k_{i}}\left(1 \leq i \leq l, k_{i} \in \mathbb{Z}\right)$ and $\widetilde{f}_{i}(l+1 \leq i \leq \rho)$ such that

$$
\left|T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x)\right| \lesssim \prod_{i=1}^{l} b_{i, k_{i}}(x) \cdot \prod_{i=l+1}^{\rho} \widetilde{f}_{i}(x) \cdot \prod_{i=\rho+1}^{m}\left\|f_{i}\right\|_{L^{\infty}}
$$

and $\left\|b_{i, k_{i}}\right\|_{L^{p_{i}}} \lesssim 1$ and $\left\|\widetilde{f}_{i}\right\|_{L^{2}} \lesssim\left\|f_{i}\right\|_{L^{2}}$. Notice that $b_{i, k_{i}}$ do not depend on $k_{j}$ with $j \neq i$ and $\widetilde{f}_{i}$ do not depend on $k_{1}, \ldots, k_{l}$. Hence, by the multilinear property of the operator $T_{\sigma}$, we have

$$
\begin{aligned}
\left|T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x)\right| & \lesssim \sum_{k_{1}} \cdots \sum_{k_{l}}\left|\lambda_{1, k_{1}} \cdots \lambda_{l, k_{l}}\right| \prod_{i=1}^{l} b_{i, k_{i}}(x) \cdot \prod_{i=l+1}^{\rho} \widetilde{f}_{i}(x) \cdot \prod_{i=\rho+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} \\
& =\prod_{i=1}^{l}\left(\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right| b_{i, k_{i}}(x)\right) \cdot \prod_{i=l+1}^{\rho} \widetilde{f}_{i}(x) \cdot \prod_{i=\rho+1}^{m}\left\|f_{i}\right\|_{L^{\infty}} .
\end{aligned}
$$

(We omit a necessary limiting argument to treat the infinite sum, which could be achieved with the aid of Proposition 2.5.) For $1 \leq i \leq l$, we have

$$
\left\|\sum_{k_{i}}\left|\lambda_{i, k_{i}}\right| b_{i, k_{i}}\right\|_{L^{p_{i}}}^{p_{i}} \leq \sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|^{p_{i}}\left\|b_{i, k_{i}}\right\|_{L^{p_{i}}}^{p_{p_{i}}} \lesssim \sum_{k_{i}}\left|\lambda_{i, k_{i}}\right|^{p_{i}} \lesssim\left\|f_{i}\right\|_{H^{p_{i}}}^{p_{i}}
$$

The above pointwise inequality and Hölder's inequality now give (3.12).
Next consider the second case where $\sigma$ satisfies (3.9) with $1 \leq k_{1} \leq m$ and $k_{2}=m+1$. By the sublinear property of square function, we have

$$
G T_{\sigma}\left(f_{1}, \ldots, f_{m}\right)(x) \leq \sum_{k_{1}} \cdots \sum_{k_{l}}\left|\lambda_{1, k_{1}} \cdots \lambda_{l, k_{l}}\right| G T_{\sigma}\left(a_{1, k_{1}}, \ldots, a_{l, k_{l}}, f_{l+1}, \ldots, f_{m}\right)(x) .
$$

(Again we omit the necessary limiting argument.) Hence, using Lemma 3.6 and arguing in the same way as in the first case, we obtain (3.14). Thus the proof of Theorem 3.4 is reduced to Lemmas 3.5 and 3.6.

### 3.4. The last case: $0<p_{i} \leq \infty$.

In this subsection, we shall prove the estimate (1.6) for the entire range $0<p_{i} \leq \infty$. Since the necessity of the conditions $s_{i} \geq n / 2$ and (1.7) has already been shown in [13, Theorem 5.1], this will complete the proof of Theorem 1.1. To simplify notation, we use the letters $\boldsymbol{s}$ and $\boldsymbol{p}$ to denote $\left(s_{1}, \ldots, s_{m}\right)$ and $\left(p_{1}, \ldots, p_{m}\right)$, respectively.

We shall slightly change the formulation of the claim of Theorem 1.1. We assume $0<p_{1}, \ldots, p_{m} \leq \infty$,

$$
\begin{equation*}
\infty>s_{1}, \ldots, s_{m} \geq n / 2 \tag{3.16}
\end{equation*}
$$

and assume they satisfy (1.7) for every nonempty subset $J$ of $\{1, \ldots, m\}$. We shall prove the estimate

$$
\begin{equation*}
\left\|T_{\sigma}\right\|_{H^{p_{1}} \times \cdots \times H^{p_{m}} \rightarrow L^{p}} \lesssim \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}+\epsilon, \ldots, s_{m}+\epsilon\right)}} \tag{3.17}
\end{equation*}
$$

holds for every $\epsilon>0$, where $1 / p=1 / p_{1}+\cdots+1 / p_{m}$ and the space $L^{p}$ should be replaced
by $B M O$ if $p_{1}=\cdots=p_{m}=p=\infty$. This is equivalent to the estimate given in Theorem 1.1. The proof will be given in two steps.

In the first step, we fix $s$ satisfying (3.16) and consider the set $\Delta(s)$ that consists of all $\left(1 / p_{1}, \ldots, 1 / p_{m}\right) \in[0, \infty)^{m}$ such that the condition (1.7) holds for every nonempty subset $J$ of $\{1, \ldots, m\}$. We prove the following lemma.

Lemma 3.7. If $\boldsymbol{s}$ satisfies $(3.16)$, then $\Delta(s)$ is the convex hull of the point $(0, \ldots, 0)$ and the points $\left(1 / p_{1}, \ldots, 1 / p_{m}\right)$ that satisfy

$$
\begin{equation*}
1 / p_{i}=0 \text { or } 1 / p_{i}=s_{i} / n \text { or } 1 / p_{i}=s_{i} / n+1 / 2 \text { for all } i, \tag{3.18}
\end{equation*}
$$

and

$$
\begin{equation*}
1 / p_{i}=s_{i} / n+1 / 2 \text { for exactly one } i . \tag{3.19}
\end{equation*}
$$

Proof. Fix $s=\left(s_{1}, \ldots, s_{m}\right)$ such that $s_{i} \geq n / 2$ for all $1 \leq i \leq m$. Condition (1.7) gives a clearer presentation of the set $\Delta(s)$ as

$$
\Delta(m, s)=\left\{\left(\frac{1}{p_{1}}, \ldots, \frac{1}{p_{m}}\right) \in \mathbb{R}^{m}: 0 \leq \frac{1}{p_{i}} \leq \frac{s_{i}}{n}+\frac{1}{2}, \quad \sum_{i \in J} \frac{1}{p_{i}} \leq \sum_{i \in J} \frac{s_{i}}{n}+\frac{1}{2}\right\}
$$

where $J$ runs over all non-empty subsets of $\{1, \ldots, m\}$. We let $H$ denote the convex hull of $(0, \ldots, 0)$ and of all the points $\left(1 / p_{1}, \ldots, 1 / p_{m}\right)$ that satisfy (3.18) and (3.19). We will show that $\Delta(m, s)=H$ by induction in $m$.

The case when $m=2$ is trivial because $\Delta(2, s)$ is the convex hull of the following points $(0,0),\left(s_{1} / n+1 / 2,0\right),\left(s_{1} / n+1 / 2, s_{2} / n\right),\left(0, s_{2} / n+1 / 2\right)$ and $\left(s_{1} / n, s_{2} / n+1 / 2\right)$; hence, the statement of Lemma 3.7 holds obviously in this case.

Now fix an $m>2$ and suppose that the statement of the lemma is true for $m-1$. For $1 \leq k \leq m$, denote

$$
\begin{aligned}
& \Delta^{k}(m, s)=\left\{\left(\frac{1}{p_{1}}, \ldots, \frac{1}{p_{m}}\right) \in \Delta(m, s): 0 \leq \frac{1}{p_{k}} \leq \frac{s_{k}}{n}\right\}, \\
& F_{0}^{k}(m, s)=\left\{\left(\frac{1}{p_{1}}, \ldots, \frac{1}{p_{m}}\right) \in \Delta(m, s): \frac{1}{p_{k}}=0\right\} \\
& F_{1}^{k}(m, s)=\left\{\left(\frac{1}{p_{1}}, \ldots, \frac{1}{p_{m}}\right) \in \Delta(m, s): \frac{1}{p_{k}}=\frac{s_{k}}{n}\right\},
\end{aligned}
$$

and

$$
\Delta^{0}(m, s)=\left\{\left(\frac{1}{p_{1}}, \ldots, \frac{1}{p_{m}}\right) \in \Delta(m, \boldsymbol{s}): \frac{s_{i}}{n} \leq \frac{1}{p_{i}} \leq \frac{s_{i}}{n}+\frac{1}{2}, \forall 1 \leq i \leq m\right\}
$$

It is easy to see that $\Delta(m, s)=\bigcup_{k=0}^{m} \Delta^{k}(m, s)$. We observe that $H$ is a subset of $\Delta(m, s)$, since each vertex of $H$ obviously sits inside the convex set $\Delta(m, s)$. Thus, it suffices to prove that $\Delta^{k}(m, s)$ is a subset of $H$ for every $0 \leq k \leq m$.

We first consider $\Delta^{k}(m, s)$ for $1 \leq k \leq m$. By induction, the face $F_{0}^{k}(m, s)$ is the convex hull of the following points $(0, \ldots, 0)$ and $\left(1 / p_{1}, \ldots, 1 / p_{m}\right)$, where $1 / p_{k}=0$,
$1 / p_{i} \in\left\{0, s_{i} / n, s_{i} / n+1 / 2\right\}$ for $i \neq k$, and there exists exactly one $i \neq k$ such that $1 / p_{i}=s_{i} / n+1 / 2$. Similarly, the face $F_{1}^{k}(m, s)$ is determined by the same constraints for all variables $1 / p_{i}, i \neq k$ as those for $F_{0}^{k}(m, s)$. Therefore, by induction, we have that $F_{1}^{k}(m, s)$ is the convex hull of the points $\left(0, \ldots, 0, s_{k} / n, 0, \ldots, 0\right)$ and $\left(1 / p_{1}, \ldots, 1 / p_{m}\right)$, where $1 / p_{k}=s_{k} / n, 1 / p_{i} \in\left\{0, s_{i} / n, s_{i} / n+1 / 2\right\}$ for $i \neq k$, and there exists exactly one $i \neq k$ such that $1 / p_{i}=s_{i} / n+1 / 2$. Note that the point $\left(0, \ldots, 0, s_{k} / n, 0, \ldots, 0\right)$ belongs to the line segment that joins the origin $(0, \ldots, 0)$ with $\left(0, \ldots, 0, s_{k} / n+1 / 2,0, \ldots, 0\right)$. Thus $F_{0}^{k}(m, s)$ and $F_{1}^{k}(m, s)$ are contained in $H$, and hence, $\Delta^{k}(m, s)$ is a subset of $H$ since $\Delta^{k}(m, s)$ is a convex hull of two faces $F_{0}^{k}(m, s)$ and $F_{1}^{k}(m, s)$.

It remains to check that $\Delta^{0}(m, s) \subset H$. In this case, we note that the constraints $0 \leq 1 / p_{i}-s_{i} / n \leq 1 / 2, \forall 1 \leq i \leq m$ and

$$
\sum_{i=1}^{m}\left(\frac{1}{p_{i}}-\frac{s_{i}}{n}\right) \leq \frac{1}{2}
$$

imply that $\Delta^{0}(m, s)$ is a standard $m$-simplex with vertices $\left(s_{1} / n, \ldots, s_{m} / n\right)$ and $\left(1 / p_{1}, \ldots, 1 / p_{m}\right)$, where $1 / p_{i} \in\left\{s_{i} / n, s_{i} / n+1 / 2\right\}$ for $1 \leq i \leq m$, and there exists exactly one $i$ such that $1 / p_{i}=s_{i} / n+1 / 2$, which implies $\Delta^{0}(m, s) \subset H$ with noting that the point $\left(s_{1} / n, \ldots, s_{m} / n\right) \in F_{1}^{k}(m, s) \subset H$.

By virtue of Lemma 3.7 and Theorem 2.4, to prove the estimate (3.17) under the assumptions (3.16) and (1.7), it is sufficient to show it for $\boldsymbol{p}=(\infty, \ldots, \infty)$ and for $\boldsymbol{p}$ satisfying (3.18) and (3.19). For $\boldsymbol{p}=(\infty, \ldots, \infty)$, the estimate (3.17) with $B M O$ in place of $L^{p}$ is established in [13, Corollary 6.3]. Thus it is sufficient to consider the latter points.

In the second step, we shall prove the following lemma, which will complete the proof of Theorem 1.1.

Lemma 3.8. Estimate (3.17) holds if $\boldsymbol{s}$ and $\boldsymbol{p}$ satisfy (3.16), (3.18), and (3.19).
Proof. For $\boldsymbol{p} \in(0, \infty]^{m}$, we define $\ell(\boldsymbol{p})$ to be the number of the indices $i \in$ $\{1, \ldots, m\}$ such that $1<p_{i}<2$. We shall prove the claim by induction on $\ell(\boldsymbol{p})$.

The conditions (3.16) and (3.19) imply in particular that there exists at least one $i$ such that $p_{i} \leq 1$. Hence if $\ell(\boldsymbol{p})=0$ then the claim directly follows from Theorem 3.4.

Assume $\ell_{0} \geq 1$ and assume the claim holds if $\ell(\boldsymbol{p})<\ell_{0}$. Let

$$
\left(\boldsymbol{p}^{0}, s^{0}\right)=\left(p_{1}^{0}, \ldots, p_{m}^{0}, s_{1}^{0}, \ldots, s_{m}^{0}\right)
$$

be a point that satisfies the conditions (3.16), (3.18), and (3.19), and satisfies $\ell\left(\boldsymbol{p}^{0}\right)=\ell_{0}$. There exists an index $i$ such that $1<p_{i}^{0}<2$. Notice that $1 / p_{i}^{0}=s_{i}^{0} / n$ for this index $i$. Without loss of generality, we assume $1>1 / p_{1}^{0}=s_{1}^{0} / n>1 / 2$. Then the condition (3.19) implies that there exists exactly one $i$ such that $2 \leq i \leq m$ and $1 / p_{i}^{0}=s_{i}^{0} / n+1 / 2$. Consider the following two points:

$$
\begin{aligned}
\left(\boldsymbol{p}^{\prime}, \boldsymbol{s}^{\prime}\right) & =\left(1, p_{2}^{0}, \ldots, p_{m}^{0}, n, s_{2}^{0}, \ldots, s_{m}^{0}\right), \\
\left(\boldsymbol{p}^{\prime \prime}, s^{\prime \prime}\right) & =\left(2, p_{2}^{0}, \ldots, p_{m}^{0}, n / 2, s_{2}^{0}, \ldots, s_{m}^{0}\right) .
\end{aligned}
$$

Both $\left(\boldsymbol{p}^{\prime}, \boldsymbol{s}^{\prime}\right)$ and $\left(\boldsymbol{p}^{\prime \prime}, \boldsymbol{s}^{\prime \prime}\right)$ satisfy the conditions (3.16), (3.18), and (3.19), and $\ell\left(\boldsymbol{p}^{\prime}\right)=$ $\ell\left(\boldsymbol{p}^{\prime \prime}\right)=\ell_{0}-1$. Hence by the induction hypothesis the estimate (3.17) holds for ( $\boldsymbol{p}^{\prime}, \boldsymbol{s}^{\prime}$ ) and $\left(\boldsymbol{p}^{\prime \prime}, \boldsymbol{s}^{\prime \prime}\right)$. Then, by Theorem 2.4, it follows that the estimate (3.17) also holds for $\left(\boldsymbol{p}^{0}, \boldsymbol{s}^{0}\right)$. This completes the proof of Lemma 3.8.

## 4. Proofs of the key lemmas.

Proof of Lemma 3.3. Without loss of generality, we assume that $J_{0}=\{1, \ldots, r\}$ for some $1 \leq r \leq l$, and $\left\|f_{i}\right\|_{L^{\infty}}=1$ for all $l+1 \leq i \leq m$. Fix

x \in\left(\bigcap_{i=r+1}^{l} Q_{i}^{*}\right) \backslash \bigcup_{i=1}^{r} Q_{i}^{*}
$$

(when $r=l$, just fix $x \in \mathbb{R}^{n} \backslash \bigcup_{i=1}^{l} Q_{i}^{*}$ ). Now we can write

T_{\sigma}\left(a_{1}, \ldots, a_{l}, f_{l+1}, \ldots, f_{m}\right)(x)=\sum_{j \in \mathbb{Z}} g_{j}(x)
$$

where $g_{j}(x)$ is the function

$$
\int_{\mathbb{R}^{m n}} 2^{j m n} K_{j}\left(2^{j}\left(x-y_{1}\right), \ldots, 2^{j}\left(x-y_{m}\right)\right) a_{1}\left(y_{1}\right) \cdots a_{l}\left(y_{l}\right) f_{l+1}\left(y_{l+1}\right) \cdots f_{m}\left(y_{m}\right) d \vec{y}
$$

with $K_{j}=\left(\sigma\left(2^{j} .\right) \widehat{\psi}\right)^{\vee}$. Let $c_{i}$ be the center of the cube $Q_{i}(1 \leq i \leq l)$. For $1 \leq i \leq r$, since $x \notin Q_{i}^{*}$, we have $\left|x-c_{i}\right| \approx\left|x-y_{i}\right|$ for all $y_{i} \in Q_{i}$. Fix $1 \leq k \leq r$. Using Lemma 2.2 and applying the Cauchy-Schwarz inequality we obtain

& \prod_{i=1}^{r}\left\langle 2^{j}\left(x-c_{i}\right)\right\rangle^{s_{i}}\left|g_{j}(x)\right| \\
& \vdots 2^{j m n} \int_{Q_{1} \times \cdots \times Q_{l} \times \mathbb{R}^{(m-l) n}} \prod_{i=1}^{r}\left\langle 2^{j}\left(x-y_{i}\right)\right\rangle^{s_{i}}\left|K_{j}\left(2^{j}\left(x-y_{1}\right), \ldots, 2^{j}\left(x-y_{m}\right)\right)\right| \prod_{i=1}^{l}\left\|a_{i}\right\|_{L^{\infty}} d \vec{y} \\
& \leq 2^{j m n} \prod_{i=1}^{l}\left|Q_{i}\right|^{-1 / p_{i}} \int_{Q_{1} \times \cdots \times Q_{r} \times \mathbb{R}^{(m-r) n}} \prod_{i=1}^{r}\left\langle 2^{j}\left(x-y_{i}\right)\right\rangle^{s_{i}}\left|K_{j}\left(2^{j}\left(x-y_{1}\right), \ldots, 2^{j}\left(x-y_{m}\right)\right)\right| d \vec{y} \\
& =2^{j r n} \prod_{i=1}^{l}\left|Q_{i}\right|^{-1 / p_{i}} \int_{Q_{1} \times \cdots \times Q_{r} \times \mathbb{R}^{(m-r) n}} \prod_{i=1}^{r}\left\langle 2^{j}\left(x-y_{i}\right)\right\rangle^{s_{i}} \\
& \quad \times\left|K_{j}\left(2^{j}\left(x-y_{1}\right), \ldots, 2^{j}\left(x-y_{r}\right), y_{r+1}, \ldots, y_{m}\right)\right| d y_{1} \cdots d y_{r} d y_{r+1} \cdots d y_{m} \\
& \leq 2^{j r n} \prod_{i=1}^{r}\left|Q_{i}\right|^{1-1 / p_{i}} \prod_{i=r+1}^{l}\left|Q_{i}\right|^{-1 / p_{i}} \int_{\mathbb{R}^{(m-r) n}} \int_{Q_{k}}\left|Q_{k}\right|^{-1}\left\langle 2^{j}\left(x-y_{k}\right)\right\rangle^{s_{k}}
\end{aligned}
$$

$$
\begin{align*}
& \times\left\|\prod_{i=1}^{r}\left\langle y_{i}\right\rangle^{s_{i}} K_{j}\left(y_{1}, \ldots, y_{k-1}, 2^{j}\left(x-y_{k}\right), y_{k+1}, \ldots, y_{m}\right)\right\|_{L^{\infty}\left(d y_{1} \cdots \widehat{d y_{k}} \cdots d y_{r}\right)} d y_{k} d y_{r+1} \cdots d y_{m} \\
\lesssim & 2^{j r n} \prod_{i=1}^{r}\left|Q_{i}\right|^{1-1 / p_{i}} \prod_{i=r+1}^{l}\left|Q_{i}\right|^{-1 / p_{i}} \int_{\mathbb{R}^{(m-r) n}} \int_{Q_{k}}\left|Q_{k}\right|^{-1}\left\langle 2^{j}\left(x-y_{k}\right)\right\rangle^{s_{k}} \\
& \times\left\|\prod_{i=1}^{r}\left\langle y_{i}\right\rangle^{s_{i}} K_{j}\left(y_{1}, \ldots, y_{k-1}, 2^{j}\left(x-y_{k}\right), y_{k+1}, \ldots, y_{m}\right)\right\|_{L^{2}\left(d y_{1} \cdots \widehat{d y_{k}} \cdots d y_{r}\right)} d y_{k} d y_{r+1} \cdots d y_{m} \\

Thus it is sufficient to construct the functions $u_{k, j}^{J}$.

Thus, by the assumption (3.10),

for all $x \in E_{J}$ and for each $k \in J$. We take positive numbers $\left(\beta_{k}\right)_{k \in J}$ satisfying $\sum_{k \in J} \beta_{k}=1$ and take a geometric mean of the above estimates to obtain

We have $\gamma_{k}>0$ since $N_{k}$ is sufficiently large and $\delta_{k}>0$ since $\delta_{k}=n \beta_{k} / 2-n+s_{k} \geq$ $n \beta_{k} / 2-n / p_{k}+s_{k}>0$ by our choice of $\beta_{k}$. This completes the proof of Lemma 3.5.

Proof of Lemma 3.6. Since the proof is similar to that of Lemma 3.5, we shall briefly indicate only the key points. We use the same notation as in the proof of Lemma 3.5. We also write

Observe that the estimate of $g_{j}(x)$ on $E_{J}, J \neq \emptyset$, given in the latter half of the proof of Lemma 3.5 holds in the present case as well, since we did not use the assumption (3.9) in that argument. Also observe that there we have actually proved the estimate

## 5. The space $L^{1}$ and weak type estimates.

In this section, we prove that if we replace $H^{1}$ by $L^{1}$, then we obtain the weak type estimate for $T_{\sigma}$ under the same regularity assumption on the multipliers. Precisely, we prove the following theorem.

Theorem 5.1. Let $s_{1}, \ldots, s_{m}, p_{1}, \ldots, p_{m}$, and $p$ satisfy the same assumptions as in Theorem 1.1. Define $X_{i}, i=1, \ldots, m$, by $X_{i}=H^{p_{i}}$ if $p_{i} \neq 1$ and $X_{i}=L^{1}$ if $p_{i}=1$. Then

$$
\begin{equation*}
\left\|T_{\sigma}\right\|_{X_{1} \times \cdots \times X_{m} \longrightarrow L^{(p, \infty)}} \lesssim \sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} \cdot\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}} \tag{5.1}
\end{equation*}
$$

The conditions given above are optimal in the sense that if (5.1) holds then we must have $s_{1}, \ldots, s_{m} \geq n / 2$ and (1.7) for every nonempty subset $J$ of $\{1,2, \ldots, m\}$.

The proof depends on the following lemma, which is a slight generalization of the remark given in Stein [21, 5.24].

Lemma 5.2. Let $p_{0}, p_{1}, q_{0}, q_{1}$, r satisfy $n /(n+1)<p_{0}<1<p_{1}<\infty, 0<q_{0}<$ $r<q_{1}<\infty$, and $1 / p_{0}-1 / q_{0}=1 / p_{1}-1 / q_{1}=1-1 / r$. Let $T$ be a linear operators that maps $L^{1}\left(\mathbb{R}^{n}\right)$ to $\mathcal{M}(\mathbb{R})^{n}$, the space of all measurable functions on $\mathbb{R}^{n}$. Assume that there are $M_{0}$ and $M_{1}$ positive constants such that for all $f \in L^{1}\left(\mathbb{R}^{n}\right)$ we have

\|T(f)\|_{L^{\left(q_{0}, \infty\right)}} & \leq M_{0}\|f\|_{H^{p_{0}}}  \tag{5.2}\\
\|T(f)\|_{L^{\left(q_{1}, \infty\right)}} & \leq M_{1}\|f\|_{L^{p_{1}}} \tag{5.3}
\end{align*}
$$

whenever the right hand sides are finite. Then

for all $f \in L^{1}\left(\mathbb{R}^{n}\right)$, where $C$ is a constant depending only on $p_{0}, p_{1}, q_{0}, q_{1}, r$, and $n$, and $\theta$ is given by $1=(1-\theta) / p_{0}+\theta / p_{1}$.

Proof. Let $f \in L^{1}\left(\mathbb{R}^{n}\right)$ and we assume $\|f\|_{L^{1}}=1$. Let $0<\lambda<\infty$ be given. We apply the Calderón-Zygmund decomposition to $f$ at height $\delta \lambda^{r}$, where $\delta$ is a positive constant to be determined later. Thus we obtain a family of disjoint cubes $\left\{Q_{j}\right\}$ such that

& \sum_{j}\left|Q_{j}\right| \leq\left(\delta \lambda^{r}\right)^{-1}
\end{aligned}

and we write $f=g+b, b=\sum_{j} b_{j}$ with

\lesssim\left(M_{1}\left(\delta \lambda^{r}\right)^{1-1 / p_{1}} \lambda^{-1}\right)^{q_{1}}=\left(M_{1} \delta^{1-1 / p_{1}}\right)^{q_{1}} \lambda^{-r} .
$$

Each $b_{j}$ satisfies

\operatorname{supp} b_{j} \subset Q_{j}, \quad \int b_{j}(x) d x=0, \quad \frac{1}{\left|Q_{j}\right|} \int_{Q_{j}}\left|b_{j}(x)\right| d x \lesssim \delta \lambda^{r},
$$

and thus $\left|Q_{j}\right|^{-1 / p_{0}}\left(\delta \lambda^{r}\right)^{-1} b_{j}$ is a constant multiple of an $L^{1}$-atom for $H^{p_{0}}$ since $n /(n+$ $1)<p_{0}<1$. Hence we have

Combining the above estimates with the fact that $T(f)=T(g)+T(b)$, we obtain

Proof of Theorem 5.1. Suppose $s_{1}, \ldots, s_{m}$ and $p_{1}, \ldots, p_{m}$ satisfy the assumptions of the theorem and suppose for example $p_{1}=1$. If we take $\epsilon>0$ sufficiently small, then $s_{1}, \ldots, s_{m}$ also satisfy the assumptions of the theorem with $p_{1}=1$ replaced by $1 \pm \epsilon$. Thus Theorem 1.1 yields two estimates

$$
\begin{aligned}
& \left\|T_{\sigma}\left(f_{1}, f_{2}, \ldots, f_{m}\right)\right\|_{L^{\left(p_{-}, \infty\right)}} \lesssim A\left\|f_{1}\right\|_{H^{1-\epsilon}}\left\|f_{2}\right\|_{H^{p_{2}}} \cdots\left\|f_{m}\right\|_{H^{p_{m}}} \\
& \left\|T_{\sigma}\left(f_{1}, f_{2}, \ldots, f_{m}\right)\right\|_{L^{\left(p_{+}, \infty\right)}} \lesssim A\left\|f_{1}\right\|_{L^{1+\epsilon}}\left\|f_{2}\right\|_{H^{p_{2}}} \cdots\left\|f_{m}\right\|_{H^{p_{m}}}
\end{aligned}
$$

where $A=\sup _{j \in \mathbb{Z}}\left\|\sigma\left(2^{j} .\right) \widehat{\psi}\right\|_{W^{\left(s_{1}, \ldots, s_{m}\right)}}$ and $p_{ \pm}$is given by $1 /(1 \pm \epsilon)+1 / p_{2}+\cdots+1 / p_{m}=$ $1 / p_{ \pm}$. We freeze the functions $f_{2}, \ldots, f_{m}$ and apply Lemma 5.2 to the linear operator $f_{1} \mapsto T_{\sigma}\left(f_{1}, f_{2}, \ldots, f_{m}\right)$ to obtain

$$
\left\|T_{\sigma}\left(f_{1}, f_{2}, \ldots, f_{m}\right)\right\|_{L^{(p, \infty)}} \lesssim A\left\|f_{1}\right\|_{L^{1}}\left\|f_{2}\right\|_{H^{p_{2}}} \cdots\left\|f_{m}\right\|_{H^{p_{m}}}
$$

Repeated application of the same argument gives the desired weak type estimate.
The necessity of the conditions $s_{i} \geq n / 2$ and (1.7) can be shown by the same method as in [13, Theorem 5.1]. This completes the proof of Theorem 5.1.
