# Restricted likelihood representation and decision-theoretic aspects of meta-analysis

In the random-effects model of meta-analysis a canonical representation of the restricted likelihood function is obtained. This representation relates the mean effect and the heterogeneity variance estimation problems. An explicit form of the variance of weighted means statistics determined by means of a quadratic form is found. The behavior of the mean squared error for large heterogeneity variance is elucidated. It is noted that the sample mean is not admissible nor minimax under a natural risk function for the number of studies exceeding three.

Keywords: DerSimonian-Laird estimator; Hedges estimator; Mandel-Paule procedure; minimaxity; quadratic forms; random-effects model; Stein phenomenon

## 1. Parameter estimation in meta-analysis: Random-effects model

In the simplest random-effects model of meta-analysis involving, say, $n$ studies the data is supposed to consist of treatment effect estimators $x_{i}, i=1, \ldots, n$, which have the form

$$
x_{i}=\mu+b_{i}+\varepsilon_{i} .
$$

Here $\mu$ is an unknown common mean, $b_{i}$ is zero mean between-study effect with variance $\tau^{2}$, $\tau^{2} \geq 0$, and $\varepsilon_{i}$ represents the measurement error of the $i$ th study, with variance $\sigma_{i}^{2}, \sigma_{i}^{2}>0$. Then the variance of $x_{i}$ is $\tau^{2}+\sigma_{i}^{2}$. In practice $\sigma_{i}$ is often treated as a given constant, $s_{i}$, which is the reported standard error or uncertainty of the $i$ th study.

The considered here problem is that of estimation of the common mean $\mu$ and of the heterogeneity variance $\tau^{2}$ from the statistical decision theory point of view under normality assumption. If $\tau^{2}$ is known, then the best unbiased estimator of $\mu$ is the weighted means statistic, $\hat{\mu}_{\text {opt }}=\sum \omega_{i}^{0} x_{i}$, with the normalized weights,

$$
\begin{equation*}
\omega_{i}^{0}=\frac{1}{\tau^{2}+s_{i}^{2}}\left(\sum_{k} \frac{1}{\tau^{2}+s_{k}^{2}}\right)^{-1} \tag{1.1}
\end{equation*}
$$

$\sum \omega_{i}^{0}=1$. Its variance has the form

$$
\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)=\left[\sum_{i} \frac{1}{\tau^{2}+s_{i}^{2}}\right]^{-1}
$$

When $\tau^{2}$ is unknown, to estimate $\mu$ the common practice uses a plug-in version of $\hat{\mu}_{\mathrm{opt}}$,

$$
\begin{equation*}
\hat{\mu}_{\mathrm{plug}}=\sum_{i} \frac{x_{i}}{\hat{\tau}^{2}+s_{i}^{2}}\left(\sum_{i} \frac{1}{\hat{\tau}^{2}+s_{i}^{2}}\right)^{-1} \tag{1.2}
\end{equation*}
$$

so that an estimator $\hat{\tau}^{2}$ of $\tau^{2}$ is required in the first place.
Usually such an estimator is obtained from a moment-type equation [15]. For example, the DerSimonian-Laird [3] estimator of $\tau^{2}$ is

$$
\hat{\tau}_{\mathrm{DL}}^{2}=\frac{\sum_{i}\left(x_{i}-\delta_{\mathrm{GD}}\right)^{2} s_{i}^{-2}-n+1}{\sum_{i} s_{i}^{-2}-\sum_{i} s_{i}^{-4} /\left(\sum_{i} s_{i}^{-2}\right)}
$$

with $\delta_{\mathrm{GD}}=\sum_{i} s_{i}^{-2} x_{i} / \sum_{i} s_{i}^{-2}$ denoting the Graybill-Deal estimator of $\mu$. The popular DerSimonian-Laird $\mu$-estimator is obtained from (1.2) by using the positive part of $\hat{\tau}_{\mathrm{DL}}^{2}$.

Similarly the estimator of $\tau^{2}$,

$$
\hat{\tau}_{\mathrm{H}}^{2}=\frac{\sum_{i}\left(x_{i}-\bar{x}\right)^{2}-(n-1) \sum_{i} s_{i}^{2} / n}{n-1}
$$

leads to the Hedges estimator of $\mu$.
The paper questions the wisdom of using under all circumstances the tradition of plugging in $\tau^{2}$ estimators to get $\mu$ estimators. Indeed the routine of plug-in estimators may lead to poor procedures. For example, by replacing the unknown $\tau^{2}$ by $\hat{\tau}^{2}$ in the above formula for $\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)$, one can get a flagrantly biased estimator which leads to inadequate confidence intervals for $\mu$.

A large class of weighted means statistics is motivated by the form of Bayes procedures derived in Section 2.2. These statistics which typically do not admit the representation (1.2) induce estimators of the weights (1.1) which shows the primary role of $\mu$-estimation.

The main results of this work are based on a canonical representation of the restricted likelihood function in terms of independent normal random variables and possibly of some $\chi^{2}$-random variables. An important relationship between the weighted means statistics with weights of the form (1.1) and linear combinations of $x$ 's, which are shift invariant and independent, follows from this fact. Our representation transforms the original problem to that of estimating curveconfined expected values of independent heterogeneous $\chi^{2}$-random variables. This reduction makes it possible to describe the risk behavior of the weighted means statistics whose weights are determined by a quadratic form.

We make use of the concept of permissible estimators which cannot be uniformly improved in terms of the differential inequality in Section 2.3. This inequality shows that the sample mean exhibits the Stein-type phenomenon being an inadmissible estimator of $\mu$ under the quadratic loss when $n>3$. A risk function for the weights in a weighted means statistic whose main purpose is $\mu$-estimation is suggested in Section 2.4. It is shown there that under this risk the sample mean is not even minimax. Section 2.5 discusses the case of approximately equal uncertainties, and Section 3 gives an example. The derivation of the canonical representation of the likelihood function is given in the Appendix; the proof of Theorem 2.1 is delegated to the Electronic Supplement [16].

## 2. Estimating the common mean

### 2.1. Restricted likelihood, heterogeneity variance estimation and quadratic forms

The setting with the common mean $\mu$ and the heterogeneity variance $\tau^{2}$ described in Section 1 is a special case of a mixed linear model where statistical inference is commonly based on the restricted (residual) likelihood function.

The (negative) restricted log-likelihood function ([17], Section 6.6) has the form

$$
\mathcal{L}=\frac{1}{2}\left[\sum_{i} \frac{\left(x_{i}-\hat{\mu}_{\mathrm{opt}}\right)^{2}}{\tau^{2}+s_{i}^{2}}+\sum_{i} \log \left(\tau^{2}+s_{i}^{2}\right)+\log \left(\sum_{i} \frac{1}{\tau^{2}+s_{i}^{2}}\right)\right] .
$$

It is possible that some of $s_{i}^{2}$ are equal; let $s_{i}^{2}$ have the multiplicity $\nu_{i}, v_{i} \geq 1$, so that $\sum \nu_{i}=n$. Then with the index $i$ now taking values from 1 to $p$,

$$
\mathcal{L}=\frac{1}{2}\left[\sum_{i} \frac{\nu_{i}\left(\bar{x}_{i}-\hat{\mu}_{\mathrm{opt}}\right)^{2}}{\tau^{2}+s_{i}^{2}}+\sum_{i} \nu_{i} \log \left(\tau^{2}+s_{i}^{2}\right)+\log \left(\sum_{i} \frac{\nu_{i}}{\tau^{2}+s_{i}^{2}}\right)+\sum_{i} \frac{\left(v_{i}-1\right) u_{i}^{2}}{\tau^{2}+s_{i}^{2}}\right]
$$

Here, $p$ denotes the number of pairwise different $s_{i}^{2}, \bar{x}_{i}=\sum_{k: s_{k}=s_{i}} x_{k} / v_{i}$ represents the average of $v_{i} x$ 's corresponding to the particular $s_{i}^{2}, i=1, \ldots, p$, and $u_{i}^{2}$ is their sample variance when $v_{i} \geq 2$. To simplify the notation, we write $x_{i}$ for $\bar{x}_{i}$, so that $\hat{\mu}_{\text {opt }}=\sum_{i} v_{i}\left(\tau^{2}+\right.$ $\left.s_{i}^{2}\right)^{-1} x_{i} / \sum_{i} \nu_{i}\left(\tau^{2}+s_{i}^{2}\right)^{-1}$. In our problem $x=\left(x_{1}, \ldots, x_{p}\right)$ and $u_{i}^{2}=\sum_{k: s_{k}=s_{i}}\left(x_{k}-\bar{x}_{i}\right)^{2} /\left(v_{i}-\right.$ 1), $\nu_{i}>1$, form a sufficient statistic for $\mu$ and $\tau^{2}$.

Throughout this paper, we assume that $p \geq 2$. Otherwise all $\mu$-estimators reduce to the sample mean (but see Section 2.5 where $\tau^{2}$-estimation for equal uncertainties is considered). The results in the Appendix relate the likelihood function $\mathcal{L}$ to the joint density of $p-1$ independent normal, zero mean random variables $y_{1}, \ldots, y_{p-1}$. The ( $p-1$ )-dimensional normal random vector $y=$ $\left(y_{1}, \ldots, y_{p-1}\right)^{\mathrm{T}}$ which is a linear transform of $x$ has zero mean (no matter what $\mu$ is) and the covariance matrix, $\operatorname{diag}\left(\tau^{2}+t_{1}^{2}, \ldots, \tau^{2}+t_{p-1}^{2}\right)$, with $t_{1}^{2}, \ldots, t_{p-1}^{2}$ larger than $\min s_{i}^{2}$.

To find these numbers, we introduce the polynomial $P(v)=\prod_{i}\left(v+s_{i}^{2}\right)^{v_{i}}$ of degree $n$, and its minimal annihilating polynomial $M(v)=\prod_{i}\left(v+s_{i}^{2}\right)$ which has degree $p$. Define

$$
\begin{equation*}
Q(v)=M(v) \frac{P^{\prime}(v)}{P(v)}=\sum_{i} v_{i} \prod_{k: k \neq i}\left(v+s_{k}^{2}\right) \tag{2.1}
\end{equation*}
$$

Thus $Q$ is a polynomial of degree $p-1$ which has only real (negative) roots, denoted by $-t_{1}^{2}, \ldots,-t_{p-1}^{2}$ (coinciding with the roots of $P^{\prime}$ different from $-s_{1}^{2}, \ldots,-s_{p}^{2}$ ). Thus $Q(v)=$ $n \prod_{j}\left(v+t_{j}^{2}\right)$. Note that $M\left(-t_{j}^{2}\right) \neq 0$. When $v_{i} \equiv 1, M(v)=P(v)$, and $Q(v)=P^{\prime}(v)$.

According to (2.1),

$$
\sum_{i} \log \left(\tau^{2}+s_{i}^{2}\right)+\log \left(\sum_{i} \frac{v_{i}}{\tau^{2}+s_{i}^{2}}\right)=\sum_{j} \log \left(\tau^{2}+t_{j}^{2}\right)+\log n
$$

so that by using (A.8) one gets

$$
\begin{align*}
\mathcal{L}=\frac{1}{2} & {\left[\sum_{j} \frac{y_{j}^{2}}{\tau^{2}+t_{j}^{2}}+\sum_{j} \log \left(\tau^{2}+t_{j}^{2}\right)\right.} \\
& \left.+\sum_{i} \frac{\left(v_{i}-1\right) u_{i}^{2}}{\tau^{2}+s_{i}^{2}}+\sum_{i}\left(v_{i}-1\right) \log \left(\tau^{2}+s_{i}^{2}\right)+\log n\right] . \tag{2.2}
\end{align*}
$$

The representation (2.2) of the restricted likelihood function very explicitly takes into account one degree of freedom used for estimating $\mu$, as it corresponds to $p-1$ independent zero mean, normal random variables $y_{j}$ with variances $\tau^{2}+t_{j}^{2}, j=1, \ldots, p-1$. In addition, this likelihood includes independent $u_{i}^{2}$, each being a multiple of a $\chi^{2}$-random variable with $\nu_{i}-1$ degrees of freedom. When $\nu_{i}>1, u_{i}^{2}$ is an unbiased estimator of $\tau^{2}+s_{i}^{2}, u_{i}^{2} \sim\left(\tau^{2}+s_{i}^{2}\right) \chi_{\nu_{i}-1}^{2} /\left(v_{i}-1\right)$. For $\nu_{i}=1, u_{i}^{2}=0$ with probability one. According to the sufficiency principle, all statistical inference about $\tau^{2}$ involving the restricted likelihood can be based exclusively on $y_{1}^{2}, \ldots, y_{p-1}^{2}$ and $u_{1}^{2}, \ldots, u_{p}^{2}$. Their joint distribution forms a curved exponential family whose natural parameter is formed by $\left(\tau^{2}+t_{j}^{2}\right)^{-1}$ (and perhaps by some $\left(\tau^{2}+s_{i}^{2}\right)^{-1}$ ).

Evaluation of the restricted maximum likelihood estimator (REML) $\hat{\tau}^{2}$ is considerably facilitated by employing $y_{1}^{2}, \ldots, y_{p-1}^{2}$ and $u_{1}^{2}, \ldots, u_{p}^{2}$. Indeed (2.2) shows that this estimator can be determined by simple iterations as

$$
\hat{\tau}^{2}=\left(\sum_{j} \frac{y_{j}^{2}-t_{j}^{2}}{\left(\hat{\tau}^{2}+t_{j}^{2}\right)^{2}}+\sum_{i} \frac{\left(v_{i}-1\right)\left(u_{i}^{2}-s_{i}^{2}\right)}{\left(\hat{\tau}^{2}+s_{i}^{2}\right)^{2}}\right) /\left(\sum_{j} \frac{1}{\left(\hat{\tau}^{2}+t_{j}^{2}\right)^{2}}+\sum_{i} \frac{v_{i}-1}{\left(\hat{\tau}^{2}+s_{i}^{2}\right)^{2}}\right)
$$

with $\hat{\tau}_{\mathrm{DL}}^{2}$ as a good starting point, and truncation at zero if the iteration process converges to a negative number. Thus, $\hat{\tau}^{2}$ is related to a quadratic form whose coefficients are inversely proportional to the estimated variances of $y_{j}^{2}-t_{j}^{2}$ and of $u_{i}^{2}-s_{i}^{2}$ (cf. [4], Section 8).

The form of the likelihood function $\mathcal{L}$ also motivates the moment-type equations based on general quadratic forms, $\sum_{j} q_{j} y_{j}^{2}+\sum_{i}\left(v_{i}-1\right) r_{i} u_{i}^{2}$ with positive constants $q_{j}, r_{i}$. The momenttype equation written in terms of random variables $y_{1}^{2}, \ldots, y_{p-1}^{2}$ and $u_{1}^{2}, \ldots, u_{p}^{2}$ is

$$
E\left[\sum_{j} q_{j} y_{j}^{2}+\sum_{i}\left(v_{i}-1\right) r_{i} u_{i}^{2}\right]=\left[\sum_{j} q_{j}+\sum_{i}\left(v_{i}-1\right) r_{i}\right] \tau^{2}+\sum_{j} q_{j} t_{j}^{2}+\sum_{i}\left(v_{i}-1\right) r_{i} s_{i}^{2} .
$$

Then the estimator of $\tau^{2}$ by the method of moments is

$$
\hat{\tau}^{2}=\frac{\sum_{j} q_{j}\left(y_{j}^{2}-t_{j}^{2}\right)+\sum_{i}\left(v_{i}-1\right) r_{i}\left(u_{i}^{2}-s_{i}^{2}\right)}{\sum_{j} q_{j}+\sum_{i}\left(v_{i}-1\right) r_{i}} .
$$

Unless $\tau^{2}$ is large, the probability that $\hat{\tau}^{2}$ takes negative values is non-negligible. Non-negative statistics $\hat{\tau}_{+}^{2}=\max \left(\hat{\tau}^{2}, 0\right)$ are used to get $\mu$-estimators of the form (1.2).

The representations of two traditional statistics in Section 1 easily follow,

$$
\hat{\tau}_{\mathrm{DL}}^{2}=\frac{\sum_{j} t_{j}^{-2} y_{j}^{2}+\sum_{i}\left(v_{i}-1\right) s_{i}^{-2} u_{i}^{2}-n+1}{\sum_{j} t_{j}^{-2}+\sum_{i}\left(v_{i}-1\right) s_{i}^{-2}}
$$

and

$$
\hat{\tau}_{\mathrm{H}}^{2}=\frac{\sum_{j}\left(y_{j}^{2}-t_{j}^{2}\right)+\sum_{i}\left(\nu_{i}-1\right)\left(u_{i}^{2}-s_{i}^{2}\right)}{n-1} .
$$

A different method-of-moments procedure suggested by Paule and Mandel [12] is based on solving the equation,

$$
\sum_{i} \frac{v_{i}\left(x_{i}-\hat{\mu}\right)^{2}}{\tau^{2}+s_{i}^{2}}+\sum_{i} \frac{\left(v_{i}-1\right) u_{i}^{2}}{\tau^{2}+s_{i}^{2}}=n-1
$$

which has a unique positive solution, $\tau^{2}=\hat{\tau}_{\mathrm{MP}}^{2}$, provided that $\sum_{i} v_{i}\left(x_{i}-\hat{x}_{\mathrm{GD}}\right)^{2} s_{i}^{-2}+\sum_{i}\left(v_{i}-\right.$ 1) $u_{i}^{2} s_{i}^{-2}>n-1$. If this inequality does not hold, $\hat{\tau}_{\mathrm{MP}}^{2}=0$. Because of (A.8), the equation can be rewritten in terms of $y$ 's and $t$ 's as

$$
\sum_{j} \frac{y_{j}^{2}}{\tau^{2}+t_{j}^{2}}+\sum_{i} \frac{\left(v_{i}-1\right) u_{i}^{2}}{\tau^{2}+s_{i}^{2}}=n-1
$$

This representation allows for an explicit form of $\hat{\tau}_{\text {MP }}^{2}$ in some cases.
Indeed, when $n=p=2, \hat{\tau}_{\mathrm{MP}}^{2}=\hat{\tau}_{\mathrm{DL}}^{2}=\hat{\tau}_{\mathrm{H}}^{2}=\max \left[0, y_{1}^{2}-t_{1}^{2}\right]$, which is also the REML. When $n=p=3, y_{1}^{2} / t_{1}^{2}+y_{2}^{2} / t_{2}^{2} \geq 2$,

$$
\hat{\tau}_{\mathrm{MP}}^{2}=\frac{y_{1}^{2}+y_{2}^{2}}{4}-\frac{t_{1}^{2}+t_{2}^{2}}{2}+\sqrt{\left(\frac{y_{1}^{2}+y_{2}^{2}}{4}\right)^{2}+\left(\frac{t_{1}^{2}-t_{2}^{2}}{2}\right)^{2}-\frac{\left(t_{1}^{2}-t_{2}^{2}\right)\left(y_{1}^{2}-y_{2}^{2}\right)}{4}} .
$$

We conclude this section by noticing that the widely used heterogeneity index $I^{2}$ ([1], page 117) in terms of $y$ 's and $u$ 's takes the from

$$
I^{2}=\frac{\sum_{j} t_{j}^{-2} y_{j}^{2}+\sum_{i}\left(\nu_{i}-1\right) s_{i}^{-2} u_{i}^{2}-n+1}{\sum_{j} t_{j}^{-2} y_{j}^{2}+\sum_{i}\left(\nu_{i}-1\right) s_{i}^{-2} u_{i}^{2}}, \quad 0 \leq I^{2}<1
$$

### 2.2. Weighted means statistics and suggested estimators

Let us look now at the generalized Bayes estimator of $\mu$ when $\Lambda$ is a prior distribution for $\tau^{2}$ while $\mu$ has the uniform (non-informative) prior. Under the quadratic loss this estimator has the form with $\mathcal{L}$ given in (2.2)

$$
\begin{equation*}
\delta=\frac{\int_{0}^{\infty} \hat{\mu}_{\mathrm{opt}} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right)}{\int_{0}^{\infty} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right)}=\sum_{i} \omega_{i} x_{i} \tag{2.3}
\end{equation*}
$$

Thus $\delta$ is a weighted means statistic with normalized weights, $\omega_{i} \propto \nu_{i} \int_{0}^{\infty}\left(\tau^{2}+s_{i}^{2}\right)^{-1}\left[\sum \nu_{k}\left(\tau^{2}+\right.\right.$ $\left.\left.s_{k}^{2}\right)^{-1}\right]^{-1} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right), \sum_{i} \omega_{i}=1$, which are shift invariant, $\omega_{i}\left(x_{1}+c, \ldots, x_{p}+c\right)=$ $\omega_{i}\left(x_{1}, \ldots, x_{p}\right)$ for any real $c$. (Any function of $y_{1}, \ldots, y_{p-1}$ is shift invariant.) Indeed the use of restricted likelihood is tantamount to the practice of weighted means statistics with invariant weights as $\mu$ estimators. (cf. [17], Section 9.2).

Formula (A.10) in the Appendix gives

$$
\delta=\bar{x}-\sum_{j} \frac{\int_{0}^{\infty}\left(\tau^{2}+t_{j}^{2}\right)^{-1} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right)}{\int_{0}^{\infty} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right)} \sqrt{b_{j}} y_{j}=\bar{x}-\sum_{j} w_{j} \sqrt{b_{j}} y_{j}
$$

with $y_{j}$ discussed in Section 2.1. Positive coefficients $b_{j}$ (the diagonal elements of the diagonal matrix $A^{\mathrm{T}} J^{-1} A$ defined in Lemma A.1) can be found from (A.3) or rather from (A.11); $w_{j}$ is the posterior mean of $\left(\tau^{2}+t_{j}^{2}\right)^{-1}$,

$$
w_{j}=-2 \frac{\partial}{\partial y_{j}^{2}} \log \lambda\left(y_{1}^{2}, \ldots, y_{p-1}^{2}, u_{1}^{2}, \ldots, u_{p}^{2}\right)
$$

with $\lambda=\int_{0}^{\infty} \exp \{-\mathcal{L}\} \mathrm{d} \Lambda\left(\tau^{2}\right)$. Thus positive $w_{j}$ is designed to estimate $\left(\tau^{2}+t_{j}^{2}\right)^{-1}, w_{j} \leq t_{j}^{-2}$, and as a function of $y_{\ell}^{2}, w_{j}$ decreases. The inequalities, $t_{j}^{2}<t_{\ell}^{2}$, and $w_{j}>w_{\ell}$, are equivalent.

If $p>2$ and the support of $\Lambda$ has at least two points, $\delta$ does not admit representation (1.2) which suggests a more general class of $\mu$-estimators. Namely, we propose to use weighted means statistics $\delta=\sum_{i} \omega_{i} x_{i}$ with weights $\omega_{i}=1 / p-\sum_{j} w_{j} A_{i j}$. The Bayes weights belong to a smaller part of this polyhedron, namely to the convex hull of the vectors with coordinates $\left(\tau^{2}+t_{1}^{2}\right)^{-1}, \ldots,\left(\tau^{2}+t_{p-1}^{2}\right)^{-1}$ for $\tau^{2} \geq 0$. If $\hat{\tau}^{2}$ is an estimate of $\tau^{2}$, the weights corresponding to (1.2),

$$
\begin{equation*}
w_{j}=\frac{1}{\hat{\tau}^{2}+t_{j}^{2}} \tag{2.4}
\end{equation*}
$$

lie on the boundary of this convex hull. A corner point, $\left(t_{1}^{-2}, \ldots, t_{p-1}^{-2}\right)$, of the convex hull always is an inner point of the polyhedron.

Thus the focus in this paper is on estimators $\delta$ of $\mu$, which admit the representation,

$$
\begin{equation*}
\delta=\sum_{i} \omega_{i} x_{i}=\bar{x}-\sum_{j} \sqrt{b_{j}} w_{j} y_{j} \tag{2.5}
\end{equation*}
$$

with $w_{j}, 0 \leq w_{j} \leq t_{j}^{-2}, y_{j}$ and $b_{j}$ as defined above. The last term in the right-hand side of (2.5) can be viewed as an arguably necessary heterogeneity correction to $\bar{x}$.

Notice that (2.5) does not need an estimate of $\tau^{2}$ as a prerequisite. Since $w_{j}$ is an approximation to $\left(\tau^{2}+t_{j}^{2}\right)^{-1}$, when $n=p$, the form of the REML $\hat{\tau}^{2}$ in Section 2.1 suggests such an estimator: $\left[\sum w_{j}^{2}\left(y_{j}-t_{j}^{2}\right)\right]_{+} / \sum w_{j}^{2}$. If some of the multiplicities exceed one, an estimator of $\left(\tau^{2}+s_{i}^{2}\right)^{-1}$ can be derived from $w_{j}$ by replacing $t_{j}^{2}$ by $s_{i}^{2}$. According to (A.10), $\hat{\mu}_{\mathrm{opt}}$ as well as $\bar{x}$, has the form (2.5). In fact, all traditional statistics (1.2) admit this representation.

### 2.3. Estimation of multivariate normal mean and permissible procedures

We look now at the quadratic risk behavior of $\mu$-estimators of the form (2.5). If $\delta=\sum_{i} \omega_{i} x_{i}$ is such an estimator with positive normalized weights $\omega_{i}$ which are shift invariant functions of $x_{1}, \ldots, x_{p}$, then it is unbiased. Its variance does not depend on $\mu$ and can be written as

$$
\begin{equation*}
\operatorname{Var}(\delta)=\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)+E\left(\delta-\hat{\mu}_{\mathrm{opt}}\right)^{2}=\left[\sum_{i} \frac{v_{i}}{\tau^{2}+s_{i}^{2}}\right]^{-1}+E\left(\delta-\hat{\mu}_{\mathrm{opt}}\right)^{2} \tag{2.6}
\end{equation*}
$$

by independence of $\hat{\mu}_{\text {opt }}$ and $\delta-\hat{\mu}_{\text {opt }}$. This and more general decompositions of the mean squared error are discussed by Harville [5]. The second term in the right-hand side of this identity is an important variance component which shows how well $\delta$ approximates the optimal but unavailable $\hat{\mu}_{\mathrm{opt}}$, and which relates our setting to the classical estimation problem of the multivariate $(p-1)$ dimensional normal mean.

Proposition 2.1. If the coefficients $w_{j}=w_{j}\left(y_{1}^{2}, \ldots, y_{p-1}^{2}, u_{1}^{2}, \ldots, u_{p}^{2}\right)$ defining the estimator (2.5) are piecewise differentiable in $y$ 's, then

$$
\begin{aligned}
\operatorname{Var}(\delta) & =\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)+\sum_{j} b_{j} E y_{j}^{2}\left(w_{j}-\frac{1}{\tau^{2}+t_{j}^{2}}\right)^{2} \\
& =\operatorname{Var}(\bar{x})+E \sum_{j} b_{j}\left(f_{j}^{2}-2 \frac{\partial}{\partial y_{j}} f_{j}\right)
\end{aligned}
$$

where $f_{j}=y_{j} w_{j}$. When $p>3, \bar{x}$ is an inadmissible estimator of $\mu$ under the quadratic loss.
The omitted proof of Proposition 2.1 is based on (A.10), (A.11), and on familiar integration by parts technique. It demonstrates linkage of our situation to the differential inequality of a statistical estimation problem [2]. Namely, if for some vector $\theta, Y \sim N_{p-1}(\theta, I)$, then $\sum_{j} b_{j}\left(f_{j}^{2}-2 \partial f_{j} / \partial y_{j}\right)$ is an unbiased estimate of $\sum_{j} b_{j} E\left(Y_{j}+f_{j}(Y)-\theta_{j}\right)^{2}-\sum_{j} b_{j} \theta_{j}^{2}$. Therefore $Y+g(Y), g=\left(g_{1}, \ldots, g_{p-1}\right)^{\mathrm{T}}$, improves on $Y+f(Y), f=\left(f_{1}, \ldots, f_{p-1}\right)^{\mathrm{T}}$, as a $\theta$-estimator provided that for all values $Y_{1}, \ldots, Y_{p-1}$,

$$
\begin{equation*}
\sum_{j} b_{j}\left(f_{j}^{2}-2 \frac{\partial}{\partial Y_{j}} f_{j}\right) \geq \sum_{j} b_{j}\left(g_{j}^{2}-2 \frac{\partial}{\partial Y_{j}} g_{j}\right) \tag{2.7}
\end{equation*}
$$

Following [13], let us call a (piecewise differentiable) vector function $f$ permissible if (2.7) does not have any solutions $g$ providing a strict inequality at some point. Thus, $Y+f$ is a permissible estimator of the vector normal mean $\theta$ if and only if the corresponding scalar $\mu$-estimator, $\bar{x}-$ $\sum_{j} \sqrt{b}_{j} f_{j}$, cannot be improved upon in the sense of differential inequality (2.7). Since for $p>3$, $f \equiv 0$ is not a permissible function, the sample mean $\bar{x}$ is inadmissible in the original setting. Indeed the left-hand side of (2.7) is negative for $f_{j}^{S}=y_{j} w_{j}^{S}, w_{j}^{S}=(p-3) /\left(b_{j} \sum y_{\ell}^{2} / b_{\ell}\right)$ proving this statement.

The differential operator in (2.7) does not involve $t$ 's or $s$ 's, but in our problem only functions $f_{j}$ such that $\left|f_{j}\right| \leq\left|y_{j}\right| t_{j}^{-2}$ and $f_{j} / y_{j} \geq 0$ are of interest. Since $\left(\tau^{2}+t_{j}^{2}\right)^{-1}$ is positive and cannot exceed $t_{j}^{-2}$, according to the first equality in Proposition 2.1, $w_{j}$ can be improved by $\max \left[0, \min \left(w_{j}, t_{j}^{-2}\right)\right]$.

The proof of Theorem 1 in [2] shows that any permissible $w_{j}$ in our situation is of the form

$$
w_{j}=\max \left[0, \min \left(-\frac{\partial}{\partial y_{j}^{2}} \log \lambda, \frac{1}{t_{j}^{2}}\right)\right]
$$

with some piecewise differentiable positive function $\lambda=\lambda\left(y_{1}^{2}, \ldots, y_{p-1}^{2}, u_{1}^{2}, \ldots, u_{p}^{2}\right)$. When $n=p$ and $\lambda=\lambda(q)$ for a positive quadratic form $q=\sum_{j} q_{j} y_{j}^{2}, q_{j}>0$, one gets $w_{j}=$ $\min \left[-q_{j}(\log \lambda)^{\prime}(q), t_{j}^{-2}\right]$. If there are multiplicities exceeding one, the quadratic form $q$ is to be replaced by $q=\sum_{j} q_{j} y_{j}^{2}+\sum_{i}\left(\nu_{i}-1\right) r_{i} u_{i}^{2}$. For example, the function, $\lambda(q)=q^{-\alpha}, \alpha>0$, leads to the estimator (2.5) with

$$
\begin{equation*}
w_{j}=\min \left[\frac{\alpha q_{j}}{\sum_{\ell} q_{\ell} y_{\ell}^{2}+\sum_{i}\left(v_{i}-1\right) r_{i} u_{i}^{2}}, \frac{1}{t_{j}^{2}}\right] \tag{2.8}
\end{equation*}
$$

The statistic $w_{j}^{J S}=\min \left(w_{j}^{S}, t_{j}^{-2}\right)$, corresponding to $q_{j}=b_{j}^{-1}, \alpha=p-3$, when $n=p$ is similar to the positive part of the Stein estimator of the vector normal mean which improves over $Y$. However, in the meta-analysis context it is desirable having the coefficients $q_{j}$ of the same ordering as $t_{j}^{-2}$, and this condition may not hold for $q_{j} \propto b_{j}^{-1}$. As a matter of fact, despite doing better than $w_{j} \equiv 0$ or $w_{j}^{S}$, the weights $w_{j}^{J S}$ do not produce a good estimator of $\mu$. The same is true for many other procedures (2.8) satisfying condition (2.10) of Theorem 2.1 in the next section. This theorem shows that if $p \leq 3<n, \bar{x}$ is an inadmissible estimator of $\mu$ although the function $f \equiv 0$ is permissible then.

## 2.4. $R$-risk and asymptotic optimality

According to (2.6) the variance of estimator (2.5) is completely determined by the term, $E(\delta-$ $\left.\hat{\mu}_{\text {opt }}\right)^{2}$, which can be interpreted as a cost of not knowing $\tau^{2}$ when estimating $\mu$, or as a new risk of $\delta$ viewed as a procedure providing approximations to $\left(\tau^{2}+t_{j}^{2}\right)^{-1}, j=1, \ldots, p-1$. More conveniently, with $s^{2}=\sum_{i} v_{i} s_{i}^{2} / n$, define

$$
R\left(\delta, \tau^{2}\right)=\frac{E\left(\delta-\hat{\mu}_{\mathrm{opt}}\right)^{2}}{\operatorname{Var}(\bar{x})-\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)}=\frac{E\left[\sum_{i}\left(\omega_{i}-\omega_{i}^{0}\right) x_{i}\right]^{2}}{\left(\tau^{2}+s^{2}\right) / n-\left[\sum_{i} \nu_{i} /\left(\tau^{2}+s_{i}^{2}\right)\right]^{-1}}
$$

to be the $R$-risk of $\delta$. Because of (A.10) and (2.5), the ensuing random loss function has the form,

$$
L\left(\delta, \tau^{2}\right)=\frac{\left(\delta-\hat{\mu}_{\mathrm{opt}}\right)^{2}}{\left(\tau^{2}+s^{2}\right) / n-\left[\sum_{i} \nu_{i} /\left(\tau^{2}+s_{i}^{2}\right)\right]^{-1}}=\frac{\sum_{j}\left(w_{j}-1 /\left(\tau^{2}+t_{j}^{2}\right)\right)^{2} b_{j} y_{j}^{2}}{\sum_{j} b_{j} /\left(\tau^{2}+t_{j}^{2}\right)} .
$$

This loss is invariant under a scale change of $y_{j}, \tau, t_{j}\left(\right.$ or of $\left.x_{i}, \tau, s_{i}\right)$. For $\tau^{2} \rightarrow \infty$,

$$
\frac{\tau^{2}+s^{2}}{n}-\left[\sum_{i} \frac{v_{i}}{\tau^{2}+s_{i}^{2}}\right]^{-1} \sim \frac{\sum_{i} v_{i}\left(s_{i}^{2}-s^{2}\right)^{2}}{n^{2} \tau^{2}}
$$

so that the normalizing factor in the definition of $L$ amplifies the error in approximating $\hat{\mu}_{\text {opt }}$ when $\tau^{2}$ is large. The results of this section show that for estimators $\delta$ satisfying conditions of the following Theorem 2.1,

$$
\operatorname{Var}(\delta)=\operatorname{Var}(\bar{x})+\left[\operatorname{Var}(\bar{x})-\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)\right]\left[R\left(\delta, \tau^{2}\right)-1\right]=\frac{\tau^{2}+s^{2}}{n}+\mathrm{O}\left(\frac{1}{\tau^{2}}\right)
$$

when $\tau^{2} \rightarrow \infty$. Thus, $\operatorname{Var}(\bar{x})=\left(\tau^{2}+s^{2}\right) / n$ is the dominating contribution to the variance of $\delta$ when $\tau^{2}$ is large. The $R$-risk is a useful tool for the comparison of estimators (2.5), as unlike the normalized quadratic risk, $E(\delta-\mu)^{2} / \operatorname{Var}(\bar{x})$, it removes this linear in $\tau^{2}$ term.

If $\delta=\hat{\mu}_{\text {plug }}$ with an invariant $\hat{\tau}^{2}$, then $R\left(\hat{\mu}_{\text {plug }}, \tau^{2}\right)$ can be interpreted as a conventional risk of the estimator $\hat{\tau}^{2}$. However under this risk large values of $\hat{\tau}^{2}$ are not penalized very much no matter what $\tau^{2}$ is. Indeed $\hat{\tau}^{2}$ is not designed to estimate $\tau^{2}$ itself, but rather $\left(\hat{\tau}^{2}+t_{j}^{2}\right)^{-1}$ estimates $\left(\tau^{2}+t_{j}^{2}\right)^{-1}$ (cf. [11], page 329). When $n=p=2$, the estimator $\bar{x}$, which corresponds to $\hat{\tau}^{2}=$ $\infty$, is even admissible which of course cannot happen for any unbounded loss function. This circumstance explains why an estimator $\hat{\tau}^{2}$ may have a large quadratic risk, while the associated estimator $\hat{\mu}_{\text {plug }}$ in (1.2) has a small variance. That phenomenon is known to happen in the case of the DerSimonian-Laird procedure [6].

The estimator $\bar{x}$ has a constant risk, $R\left(\bar{x}, \tau^{2}\right) \equiv 1$, which raises the question of its $R$ minimaxity, i.e., if $\inf _{\delta} \sup _{\tau^{2}} R\left(\delta, \tau^{2}\right)=1$. In contrast, for the Graybill-Deal estimator, $R\left(\delta_{\mathrm{GD}}\right.$, $\left.\tau^{2}\right)=\tau^{4}\left[\sum b_{j}\left(\tau^{2}+t_{j}^{2}\right)^{-1} t_{j}^{-4}\right] /\left[\sum b_{j}\left(\tau^{2}+t_{j}^{2}\right)^{-1}\right]$, so that its $R$-risk, which vanishes when $\tau^{2}=0$, grows quadratically in $\tau^{2}$. The next result gives a large class of estimators with bounded $R$-risk improving on $\bar{x}$ when $n>3$.

Theorem 2.1. Under notation of Section 2.1, let for $n>3, q=\sum_{j} q_{j} y_{j}^{2}+\sum_{i}\left(\nu_{i}-1\right) r_{i} u_{i}^{2}$ be a quadratic form with positive coefficients $q_{j}, r_{i}$. If $\delta$ has the form (2.5) such that for $q \rightarrow \infty, w_{j} \sim$ $\alpha_{j} / q, 0<\alpha_{j}<\infty$, then

$$
\begin{align*}
\lim _{\tau^{2} \rightarrow \infty} R\left(\delta, \tau^{2}\right)=1 & -\frac{1}{\sum_{j} b_{j}} \sum_{j} b_{j} \\
& \times\left[2 \alpha_{j} E \frac{z_{j}^{2}}{\sum_{\ell} q_{\ell} z_{\ell}^{2}+\sum_{i} r_{i} \chi_{\nu_{i}-1}^{2}}-\alpha_{j}^{2} E \frac{z_{j}^{2}}{\left(\sum_{\ell} q_{\ell} z_{\ell}^{2}+\sum_{i} r_{i} \chi_{v_{i}-1}^{2}\right)^{2}}\right]  \tag{2.9}\\
\geq & \frac{2}{n-1}
\end{align*}
$$

where independent standard normal $z_{1}, \ldots, z_{p-1}$ are independent of $\chi_{v_{1}-1}^{2}, \ldots, \chi_{v_{p}-1}^{2}$. Equal coefficients $q_{j}=r_{i}$ (and only they) provide the asymptotically optimal quadratic form. If $q_{j}=$
$r_{i}=1$, the optimal choice is $\alpha_{j} \equiv n-3$. The sample mean $\bar{x}$ is not $R$-minimax, any estimator (2.5) with weights (2.8) improves on it if

$$
\begin{equation*}
0<\alpha \leq 2(n-3) \frac{\min \left[\min _{j} q_{j}^{2} t_{j}^{4}, \min _{i: v_{i} \geq 2} r_{i}^{2} s_{i}^{4}\right] \sum_{j} b_{j} q_{j}}{\max \left[\max _{j} q_{j}^{2} t_{j}^{4}, \max _{i: v_{i} \geq 2} r_{i}^{2} s_{i}^{4}\right] \sum_{j} b_{j} q_{j}^{2}} \tag{2.10}
\end{equation*}
$$

Theorem 2.1 shows that the traditional weights (2.4) with $\hat{\tau}^{2}=q / \alpha$ are not asymptotically optimal unless the quadratic form $q$ coincides (up to a positive factor) with $q^{\infty}=$ $\sum_{j} y_{j}^{2}+\sum_{i}\left(v_{i}-1\right) u_{i}^{2}=\sum_{i} v_{i}\left(x_{i}-\bar{x}\right)^{2}+\sum_{i}\left(v_{i}-1\right) u_{i}^{2}$, and $\alpha=n-3$. Only then (2.9) is an equality. Thus, the Hedges estimator for which $\alpha=n-1$ and $R\left(\delta_{\mathrm{H}}, \tau^{2}\right) \sim 2(n-3)^{-1}$, is not asymptotically optimal albeit its performance is the best when $\tau^{2}$ is large. For the MandelPaule estimator from Section 2.1, as well as for the REML, (2.9) also holds with the same quadratic form and the same $\alpha$. The DerSimonian-Laird estimator is defined by the quadratic form $q^{0}=\sum_{j} y_{j}^{2} / t_{j}^{2}+\sum_{i}\left(\nu_{i}-1\right) u_{i}^{2} / s_{i}^{2}$ with $\alpha=\sum_{j} t_{j}^{-2}+\sum_{i}\left(v_{i}-1\right) s_{i}^{-2}$. Therefore, these three statistics are not optimal for large $\tau^{2}$ either.

The case when $n=p=2$ was studied in [14]. Then $\bar{x}$ is admissible (so that it is automatically minimax under $R$ ). Any estimator (2.5) has the form (1.2) with some $\hat{\tau}^{2}=\hat{\tau}^{2}\left(y_{1}^{2}\right)$, and its $R$-risk grows linearly in $\tau$,

$$
R\left(\delta, \tau^{2}\right) \sim \frac{\sqrt{2}}{\sqrt{\pi}} \int_{0}^{\infty} \frac{y^{2} \mathrm{~d} y}{\left(\hat{\tau}^{2}+s^{2}\right)^{2}} \tau
$$

For $n=p=3$, as $\tau^{2} \rightarrow \infty, R\left(\delta, \tau^{2}\right) \sim C \log \tau^{2}$ (see Electronic Supplement). By analogy with the Stein phenomenon, admissibility of the sample mean when $n=3$ is expected.

### 2.5. Equal uncertainties and minimax value

When $n>3$, the minimax value, $\inf _{\delta} \sup _{\tau^{2}} R\left(\delta, \tau^{2}\right.$ ), (which does not exceed one since $R\left(\bar{x}, \tau^{2}\right) \equiv 1$ ) cannot be smaller than $2(n-1)^{-1}$. Indeed for any estimator $\delta$,

$$
\sup _{\tau^{2}} R\left(\delta, \tau^{2}\right) \geq \limsup _{\tau^{2} \rightarrow \infty} R\left(\delta, \tau^{2}\right) \geq \frac{2}{n-1}
$$

This fact can be proven by constructing a sequence of proper prior densities for $\tau^{2}$ such that the corresponding sequence of the Bayes $R$-risks converges to $2(n-1)^{-1}$.

Thus for large $\tau^{2}$, the estimators (2.5) with $q^{\infty}, \alpha=n-3$, cannot be improved upon. The most natural of these statistics, say, $\delta_{1}$ has the form (2.5) with

$$
\begin{equation*}
w_{j}^{1}=\min \left(\frac{n-3}{q^{\infty}}, \frac{1}{t_{j}^{2}}\right) \tag{2.11}
\end{equation*}
$$

Another modified Hedges estimator, $\delta_{\mathrm{mH}}$, has the form (1.2) with $\hat{\tau}^{2}=(n-3)^{-1}\left[q^{\infty}-\sum_{j} t_{j}^{2}-\right.$ $\left.\sum_{i}\left(v_{i}-1\right) s_{i}^{2}\right]_{+}$and also is asymptotically optimal although in general its performance is worse than that of (2.11).

If $\sum_{i} v_{i}\left(s_{i}^{2}-s^{2}\right)^{2} \rightarrow 0$, so that all $t_{j}^{2}$ and $s_{i}^{2}$ tend to $s^{2}=\sum_{i} v_{i} s_{i}^{2} / n, w_{j}(v) \rightarrow w(v)$,

$$
R\left(\delta, \tau^{2}\right) \rightarrow\left(\tau^{2}+s^{2}\right)^{2} \int_{0}^{\infty}\left[w(v)-\frac{1}{\tau^{2}+s^{2}}\right]^{2} \mathrm{~d} G_{n+1}\left(\frac{v}{\tau^{2}+s^{2}}\right)
$$

Here and further $G_{k}$ is the distribution function of $\chi^{2}$-law with $k$ degrees of freedom. Thus if $s_{i}^{2} \approx s^{2}$, our problem is that of estimation of the reciprocal of the scale parameter $\sigma=\tau^{2}+s^{2}$ under the restriction, $\sigma \geq s^{2}$. The "data" $v$ in this problem is $\chi^{2}$-distributed, $v \sim \sigma \chi_{n+1}^{2}$, and the invariant loss function, $\sigma^{2}\left(w-\sigma^{-1}\right)^{2}$, corresponds to the $R$-risk. Then the minimax value, $2(n-1)^{-1}$, is the same as in the non-restricted $(s=0)$ parameter case [8]. As in unrestricted scale parameter estimation, the generalized prior, $\mathrm{d} \sigma / \sigma, \sigma \geq s^{2}$, or $\mathrm{d} \tau^{2} /\left(\tau^{2}+s^{2}\right)$, provides a least favorable distribution. See also [9] for more general results.

Thus in meta-analysis problems with $s_{i}^{2}$ exhibiting little variation, the minimax value is expected to stay close to $2(n-1)^{-1}$. Indeed when $w(v)=\min \left(\alpha v^{-1}, s^{-2}\right), \xi=\alpha s^{2} /\left(\tau^{2}+s^{2}\right)$,

$$
\begin{equation*}
R\left(\delta, \tau^{2}\right) \rightarrow 1-\left(1-\frac{\tau^{4}}{s^{4}}\right) G_{n+1}(\xi)-\frac{2 \alpha\left(1-G_{n-1}(\xi)\right)}{n-1}+\frac{\alpha^{2}\left(1-G_{n-3}(\xi)\right)}{(n-1)(n-3)} \tag{2.12}
\end{equation*}
$$

The formula (2.12) shows that the estimator (2.11) is minimax unlike $\delta_{\mathrm{mH}}$ for which $w(v)=$ $\left\{\left[v-(n-1) s^{2}\right]_{+} /(n-3)+s^{2}\right\}^{-1}$.

The DerSimonian-Laird rule, $w_{\mathrm{DL}}(v)=\left\{\left[v-(n-1) s^{2}\right]_{+} /(n-1)+s^{2}\right\}^{-1}, \alpha=n-1$, coincides in this situation with the REML and the Hedges estimator. For the proper maximum likelihood estimator of $\left(\tau^{2}+s^{2}\right)^{-1}, \alpha=n+1$. None of these procedures is minimax which indicates that their good properties in meta-analysis may be attributable to a large number of individual studies (large $n$ ) or to lack of interest in high heterogeneity (small $\tau^{2}$ ).

Figure 1 shows the graphs of the $R$-risk in (2.12) when $s^{2}=1$. It suggests that the estimator $\delta_{1}$ performs quite well for small/medium $n$ 's. Indeed this estimator is better than other procedures except for small $\tau^{2}$ in which case $\delta_{\mathrm{DL}}$ dominates $\delta_{\mathrm{mH}}$ (at the price of higher risk for larger values of $\tau^{2}$ ).

## 3. Example: $p=2$

When there are only two different values $s_{1}^{2}$ and $s_{2}^{2}$ with multiplicities $\nu_{1}$ and $\nu_{2}, n=v_{1}+\nu_{2}>3$,

\begin{aligned}
& t_{1}^{2}=t^{2}=\frac{\nu_{2} s_{1}^{2}+v_{1} s_{2}^{2}}{n}, \\
& A_{11}=-A_{21}=\frac{\nu_{1} \nu_{2}\left(s_{1}^{2}-s_{2}^{2}\right)}{n^{2}}, \\
& b_{1}=b=\frac{\nu_{1} \nu_{2}\left(s_{1}^{2}-s_{2}^{2}\right)^{2}}{n^{3}},
\end{aligned}
$$



Figure 1. The modified Hedges estimator $\delta_{\mathrm{mH}}$ with $\hat{\tau}^{2}=(n-3)^{-1}\left[q^{\infty}-t^{2}-\left(\nu_{1}-1\right) s_{1}^{2}-\left(\nu_{2}-1\right) s_{2}^{2}\right]_{+}$typically has its $R$-risk at $\tau^{2}=0$ larger than that of $\delta_{1}$. (The exact condition for $\delta_{\mathrm{mH}}$ to have a smaller $R$-risk at $\tau^{2}=0$ than $\delta_{1}$ is: $n \geq 5$, and if $\nu_{1} \leq \nu_{2}$, then $\nu_{1} \leq n(n-4) /(2 n-5),\left[n(n-1)-\nu_{1}(2 n-5)\right] s_{2}^{2} \geq$ $\left[n(n-4)-v_{1}(2 n-5)\right] s_{1}^{2}$.)

The $R$-risk of $\delta_{1}$ at $\tau^{2}=0$ can be larger than $2 /(n-1)$. Indeed

With $a=t^{2} /\left[t^{6} s_{1}^{2\left(\nu_{1}-1\right)} \times\right.$ $\left.s_{2}^{2\left(v_{2}-1\right)}\right]^{1 /(n+1)}$, according to the Okamoto inequality [10], $F\left(t^{2} v\right) \leq G_{n+1}(a v)$. Thus, since $\left[(n-3) v^{-1}-1\right]^{2}$ is an increasing function of $v, v \geq n-3$,

This inequality shows that $R\left(\delta_{1}, 0\right) \geq 2(n-1)^{-1}$, if $a<a_{0}<1$, where $a_{0}=a_{0}(n)$ is monotonically increasing to 1 in $n, a_{0}(4)=0.637 \ldots, a_{0}(10)=0.798 \ldots$ For small $a, \delta_{1}$ cannot have its risk at the origin smaller than $2(n-1)^{-1}$. For example, when $n=4, v_{1}=1, v_{2}=3$, $R\left(\delta_{1}, 0\right) \leq 2(n-1)^{-1}$ if and only if $s_{1}^{2} / s_{2}^{2} \geq 0.173 \ldots$, i.e., iff $a \geq 0.679 \ldots$

The DerSimonian-Laird estimator $\delta_{\mathrm{DL}}$ with $\hat{\tau}_{\mathrm{DL}}^{2}=\left(q^{0}-n+1\right)_{+} /\left(1 / t^{2}+\left(v_{1}-1\right) / s_{1}^{2}+\left(v_{2}-\right.\right.$ 1) $\left./ s_{2}^{2}\right), q^{0}=y^{2} / t^{2}+\left(\nu_{1}-1\right) u_{1}^{2} / s_{1}^{2}+\left(\nu_{2}-1\right) u_{2}^{2} / s_{2}^{2}$, has its $R$-risk at $\tau^{2}=0$ of the form

But $\delta_{0}$ is also competitive against $\delta_{\mathrm{DL}}$. Indeed $R\left(\delta_{0}, 0\right)<R\left(\delta_{\mathrm{DL}}, 0\right)$ if and only if $\kappa<n-1$, that is, iff

Thus provided that $\nu_{1}, \nu_{2}>1, s_{1}^{2} / s_{2}^{2} \approx \sqrt{\left(\nu_{1}-1\right) \nu_{1} /\left[\left(\nu_{2}-1\right) \nu_{2}\right]}, \delta_{0}$ improves upon $\delta_{\mathrm{DL}}$ for small $\tau^{2}$. If, say, $\nu_{1}=1$, this domination means that $s_{1}^{2}<s_{2}^{2}$. Thus, when one study reports a smaller uncertainty than all other studies whose standard errors are approximately equal, $\delta_{0}$ improves upon the DerSimonian-Laird estimator for small $\tau^{2}$.

However, there is no uniform domination as the condition, $\kappa<n-1$, means that for large $\tau^{2}, R\left(\delta_{0}, \tau^{2}\right)>R\left(\delta_{\mathrm{DL}}, \tau^{2}\right)$.

## 4. Conclusions

Author's attempt was to give a perspective of a meta-analysis setting from the point of view of the statistical decision theory. Although concepts like admissibility or minimaxity have not so
far generated much interest among meta-analysts, there is a realization that different desirable qualities of the employed procedures call for different loss functions. The quadratic loss for the mean effect estimators from a wide class leads in a natural way to the $R$-risk suggested and studied in this paper. This risk strongly recommends against the use of the sample mean as a consensus estimate which still happens in some collaborative studies.

Moreover, the $R$-risk questions well recognized excellent properties of the DerSimonian-Laird estimator $\delta_{\mathrm{DL}}$ in the situation when $s_{i}$ are almost equal, or when one study claims a high precision while all other studies report larger uncertainties which are about the same. The unsatisfactory performance of the Graybill-Deal estimator $\delta_{\mathrm{GD}}$ is well known in the latter case. It is of interest that $\delta_{0}$ improves on the DerSimonian-Laird estimator for moderate/small $\tau^{2}$. Inference on the overall effect can be obtained before the heterogeneity variance is estimated, but even in the simplest cases considered here there is no unique rule dominating all others.
This paper is dedicated to the memory of George Casella who was always interested in implications of the statistical decision theory results to practical estimation problems [7].

b_{j}\left(\sum_{i} \frac{v_{i}}{\tau^{2}+s_{i}^{2}}\right)\left[\frac{1}{n}-\sum_{\ell \neq j} \frac{b_{\ell}}{\left(t_{j}^{2}-t_{\ell}^{2}\right)\left(\tau^{2}+t_{\ell}^{2}\right)}+\frac{b_{j} Q^{\prime \prime}\left(-t_{j}^{2}\right)+2 M^{\prime}\left(-t_{j}^{2}\right)}{2 Q^{\prime}\left(-t_{j}^{2}\right)\left(\tau^{2}+t_{j}^{2}\right)}\right]
$$

Define the polynomial $Q_{j}$ by the formula,

$$
\frac{Q_{j}\left(\tau^{2}\right)}{Q\left(\tau^{2}\right)}=\sum_{\ell \neq j} \frac{b_{\ell}}{\left(t_{\ell}^{2}-t_{j}^{2}\right)\left(\tau^{2}+t_{\ell}^{2}\right)}+\frac{b_{j} Q^{\prime \prime}\left(-t_{j}^{2}\right)+2 M^{\prime}\left(-t_{j}^{2}\right)}{2 Q^{\prime}\left(-t_{j}^{2}\right)\left(\tau^{2}+t_{j}^{2}\right)}
$$

Then the degree of $Q_{j}$ is $p-2$, and this polynomial is determined by its values at $-t_{\ell}^{2}, \ell=$ $1, \ldots, p-1: Q_{j}\left(-t_{\ell}^{2}\right)=b_{\ell} Q^{\prime}\left(-t_{\ell}^{2}\right) /\left(t_{\ell}^{2}-t_{j}^{2}\right)=-M\left(-t_{\ell}^{2}\right) /\left(t_{\ell}^{2}-t_{j}^{2}\right), \ell \neq j$, and $Q_{j}\left(-t_{j}^{2}\right)=$ $b_{j} Q^{\prime \prime}\left(-t_{j}^{2}\right) / 2+M^{\prime}\left(-t_{j}^{2}\right)$. It follows that

$$
Q_{j}\left(\tau^{2}\right)=\frac{M\left(\tau^{2}\right)}{\tau^{2}+t_{j}^{2}}+\frac{b_{j} Q\left(\tau^{2}\right)}{\left(\tau^{2}+t_{j}^{2}\right)^{2}}-\frac{Q\left(\tau^{2}\right)}{n}
$$

Indeed, the polynomial in the right-hand side has degree $p-2$. Since

$$
\lim _{\tau^{2} \rightarrow-t_{j}^{2}} \frac{M\left(\tau^{2}\right)\left(\tau^{2}+t_{j}^{2}\right)+b_{j} Q\left(\tau^{2}\right)}{\left(\tau^{2}+t_{j}^{2}\right)^{2}}=M^{\prime}\left(-t_{j}^{2}\right)+\frac{b_{j} Q^{\prime \prime}\left(-t_{j}^{2}\right)}{2}
$$

it assumes the same values as $Q_{j}$ at $-t_{\ell}^{2}, \ell=1, \ldots, p-1$, which establishes (A.7).
Because of (A.6) and (A.2), $x-\hat{\mu}_{\mathrm{opt}} e=x-\bar{x} e+\left(\bar{x}-\hat{\mu}_{\mathrm{opt}}\right) e=\left[I-e e^{\mathrm{T}} J /\left(e^{\mathrm{T}} J e\right)\right] x+$ $\left(\rho^{\mathrm{T}} A^{\mathrm{T}} x\right) e$. Thus the quadratic form in the left-hand side of (A.8) can be written as

$$
\begin{aligned}
{[ } & \left.J^{-1} A\left(A^{\mathrm{T}} J^{-1} A\right)^{-1} A^{\mathrm{T}} x+e \rho^{\mathrm{T}} A^{\mathrm{T}} x\right]^{\mathrm{T}} C^{-1}\left[J^{-1} A\left(A^{\mathrm{T}} J^{-1} A\right)^{-1} A^{\mathrm{T}} x+e \rho^{\mathrm{T}} A^{\mathrm{T}} x\right] \\
= & y^{\mathrm{T}}\left[\left(A^{\mathrm{T}} J^{-1} A\right)^{-1 / 2} A^{\mathrm{T}} J^{-1}+\left(A^{\mathrm{T}} J^{-1} A\right)^{1 / 2} \rho e e^{\mathrm{T}}\right] \\
& \times C^{-1}\left[J^{-1} A\left(A^{\mathrm{T}} J^{-1} A\right)^{-1 / 2}+e \rho^{\mathrm{T}}\left(A^{\mathrm{T}} J^{-1} A\right)^{1 / 2}\right] y \\
= & y^{\mathrm{T}} \operatorname{diag}(\rho) y,
\end{aligned}
$$

where the second equality follows from (A.7) and (A.9).

The following important representation for $\hat{\mu}_{\text {opt }}$

$$
\begin{equation*}
\hat{\mu}_{\mathrm{opt}}=\bar{x}-\sum_{i, j} \frac{A_{i j} x_{i}}{\tau^{2}+t_{j}^{2}}=\bar{x}-\sum_{j} \frac{\sqrt{b_{j}} y_{j}}{\tau^{2}+t_{j}^{2}} \tag{A.10}
\end{equation*}
$$

is a consequence of Lemma A.1. Here $y_{j}=\sum_{i} A_{i j} x_{i} / \sqrt{b_{j}}$ are independent normal, zero mean random variables with the variances $\tau^{2}+t_{j}^{2}$. Indeed the normal random vector $y=$ $\left(A^{\mathrm{T}} J^{-1} A\right)^{-1 / 2} A^{\mathrm{T}} x$ has the covariance matrix $\left(A^{\mathrm{T}} J^{-1} A\right)^{-1 / 2} A^{\mathrm{T}} C A\left(A^{\mathrm{T}} J^{-1} A\right)^{-1 / 2}=\operatorname{diag}\left(\tau^{2}+\right.$ $\left.t_{1}^{2}, \ldots, \tau^{2}+t_{p-1}^{2}\right)$. Since $E y_{j}\left(\hat{\mu}_{\text {opt }}-\mu\right)=0, \hat{\mu}_{\text {opt }}$ and $y_{j}$ are independent implying independence of $\hat{\mu}_{\text {opt }}$ and $\delta-\hat{\mu}_{\text {opt }}$ in Section 2.3.

The coefficients $A_{i j}$ provide a simple expression for $\operatorname{Var}(\bar{x})-\operatorname{Var}\left(\hat{\mu}_{\text {opt }}\right)$. Indeed, by dividing (A.1) by $\nu_{i}$ and multiplying it by $A_{i \ell}$, one gets after summing up over all $i$ and $\ell$ and using (A.4), (A.5),

$$
\begin{aligned}
\frac{P\left(\tau^{2}\right)}{P^{\prime}\left(\tau^{2}\right)} \sum_{i, \ell} \frac{A_{i \ell}}{\tau^{2}+s_{i}^{2}} & =\frac{M\left(\tau^{2}\right)}{n Q\left(\tau^{2}\right)} \sum_{i} \frac{v_{i}\left(s_{i}^{2}-s^{2}\right)}{\tau^{2}+s_{i}^{2}} \\
& =\left[\sum_{i} \frac{v_{i}}{\tau^{2}+s_{i}^{2}}\right]^{-1}-\frac{\tau^{2}+s^{2}}{n}=-\sum_{i, j} \frac{A_{i j}^{2}}{v_{i}\left(\tau^{2}+t_{j}^{2}\right)}
\end{aligned}
$$

This formula can be written in the form,

$$
\begin{equation*}
\sum_{j} \frac{b_{j}}{\tau^{2}+t_{j}^{2}}=\operatorname{Var}(\bar{x})-\operatorname{Var}\left(\hat{\mu}_{\mathrm{opt}}\right)=\frac{\sum_{i} \nu_{i}\left(s^{2}-s_{i}^{2}\right) \prod_{k \neq i}\left(\tau^{2}+s_{k}^{2}\right)}{n Q\left(\tau^{2}\right)} \tag{A.11}
\end{equation*}
$$

which provides the representation of the left-hand side of (A.11) as a ratio of two polynomials of degree $p-2$ and $p-1$, respectively and which allows numerical evaluation of $b$ 's without calculating $A_{i j}$.
