GUIDE TO AUTHORS

ARTICLES in all areas of philosophical and mathematical logic, as well as historical and expository works in these fields are invited. Works accessible and of interest to both philosophers and mathematicians are especially welcome.

MANUSCRIPTS must be double spaced (including quotations, footnotes, and references) with wide margins, and all pages should be numbered. For refereeing purposes two copies should be submitted, each with concise abstract and complete mailing address. Authors should exercise extreme care in preparing manuscripts; improperly prepared manuscripts will be returned for retyping. Manuscripts should be submitted to only one journal at a time, and authors should retain a copy of everything submitted. We regret that manuscripts cannot be returned unless postage is included.

FOOTNOTES should be indicated by consecutive superscript numerals and listed on a separate page at the end of the article. A footnote acknowledging a foundation or individuals should be indicated by an asterisk attached to the first sentence of the text.

REFERENCES should be listed in alphabetical order by author, numbered consecutively in square brackets, on a separate page after the footnotes. Citations should be made by using the numbers in the text rather than by footnotes.

PAGE PROOFS are sent to authors for correction of errors that occur in composition. However, any special composition costs arising out of an author's revision of the text of an article in proof will be charged to the author.

FIFTY REPRINTS, without covers, of each article will be supplied free of charge. Additional offprints or covers for offprints may be purchased.
