MEROMORPHIC OR HOLOMORPHIC COMPLETION OF A REINHARDT DOMAIN

Introduction

In the theory of functions of several complex variables, the problem about the continuation of meromorphic functions has not been much in vestigated for a long time in spite of its importance except the deeper result of the continuity theorem due to E. E. Levi [4] and H. Kneser [3]. The difficulty of its investigation is based on the following reasons: we can not use the tools of not only Cauchy's integral formula but also the power series and there are indetermination points for the meromorphic function of many variables different from one variable. Therefore we shall also follow the Levi and Kneser's method and seek for the aspect of meromorphic completion of a Reinhardt domain in *Cⁿ .*

The main purpose of the present note is to prove that any meromor phic function in a Reinhardt domain *D* in *Cⁿ* is meromorphically continued to the envelope of holomorphy of *D.*

Kajiwara and the author [2] have proved this result for any domain over a Stein manifold. Therefore the above result is established naturally as the special case of [2]. However, for the elementary domain like the Reinhardt domain, it is desirable to give the direct and simple proof. For the case of $n = 2$, Thullen [8] has discussed in detail such a completion. In the case of $n \geq 2$ complex variables, we shall give a new proof about theorems on meromorphic completion by the only use of Continuity Theo rem of Levi-Kneser (Kneser [3]).

If throughout this paper we replace the term "meromorphic (or mero morphy)" by "holomorphic (or holomorphy)", then the given theorems are

all reduced to the well-known theorems on holomorphic completion obtained by Fabry, Faber, Hartogs and H. Cartan. So the new proof of their theo rems is obtained by the only use of the continuity theorem of Hartogs.

§1. **Notations and definitions**

Let C^n ($n \geq 2$) denote the *n*-dimensional complex number space which is the direct product of *n* complex planes, each letter of *a*, *b*, *c*, \cdots , *w*, *z* etc. denote a point of C^n , (z_1, \cdots, z_n) denote coordinates of a point z , and $\{|z_j - a_j| < r_j\}_{j=1}^n$ denote a *polydisc* which is the direct product of *n* discs $\{|z_i - a_j| < r_j\}, j = 1, \dots, n.$

A domain¹) *D* of *Cⁿ* is called a *Reinhardt domain* with center at the point *c* with coordinates c_1 , \cdots , c_n if it is invariant under the *n*-parameter transformation group $\{T(\theta_1, \dots, \theta_n)\},$ each element of which is a biholo morphic mapping:

$$
T(\theta_1, \cdots, \theta_n): z'_j = e^{i\theta_j}(z_j - c_j) + c_j, \quad j = 1, \cdots, n,
$$

where $0 \le \theta_j \le 2\pi$, $j = 1, \dots, n$.

The Reinhardt domain *D* is called *proper* if the center *c* is an interior point of *D*. If along with each point $z^{(0)} \in D$ there belong to the domain *D* all the points *z* for which

$$
|z_j-c_j|\leq |z_j^{(0)}-c_j|, \qquad j=1, \cdots, n,
$$

then the domain Z) is called a *complete* Reinhardt domain. Of course, a complete Reinhardt domain is proper. If *D* is a Reinhardt domain with center at the point *c*, then by means of a domain²⁾ *Δ* in first closed quad rant $\{x_j \ge 0\}_{j=1}^n$ of the *n*-dimensional real Euclid space $\mathbb{R}^n \langle x_1, \dots, x_n \rangle$, *D* is expressed by the form

$$
D = \{z \in \mathbb{C}^n; (|z_1 - c_1|, \cdots, |z_n - c_n|) \in \Delta\}.
$$

We shall call such a domain Δ a *domain of real expression* of D . Let D be a Reinhardt domain with center at the point c. If the domain *Δ* of real expression of *D* is mapped onto the (geometrically) convex domain Δ^* of the Euclid space $\mathbb{R}^n(\xi_1, \dots, \xi_n)$ by the transformation $\xi_j = \log|z_j - c_j|$,

 $j = 1, \dots, n$, then *D* is said to have the *logarithmically convex* domain of real expression.

Finally, we shall show that the envelope of meromorphy of a proper Reinhardt domain *D* is the least complete Reinhardt domain containing *D* which has the logarithmically convex domain of real expression.

§2. Lemmas

First of all we shall introduce the continuity theorem obtained by Kneser [3] and Okuda-Sakai [5].

Continuity Theorem of Levi-Kneser. If *f(z)* is meromorphic in a neighbourhood of the union of the sets $\{z_1 = a_1, \dots, z_{n-1} = a_{n-1}, |z_n| = r\}^{3}$ and $\{z_1 = a_1^{(p)}, \dots, z_{n-1} = a_{n-1}^{(p)}, |z_n| \leq r\}, p = 1, 2, \dots, \text{ then } f(z) \text{ can be}$ meromorphically continued also to a neighbourhood of the set $\{z_1 = a_1, \dots, z_n\}$ $z_{n-1} = a_{n-1}, \, |z_n| \leq r \},$ where $\lim_{n \to \infty} a_j^{(p)} = a_j, \, j = 1, \, \cdots, \, n-1.$

By a remark of Okuda-Sakai [5], this theorem is equivalent to the following

CONTINUATION THEOREM. If $f(z)$ is meromorphic in a neighbourhood of the union of the sets $\{|z_1 - a_1| \leq \rho, z_2 = a_2, \cdots, z_{n-1} = a_{n-1}, |z_n| = r\}$ and $\{z_1 = a_1, z_2 = a_2, \cdots, z_{n-1} = a_{n-1}, |z_n| = r\}$ $z_2 = a_2, \dots, z_{n-1} = a_{n-1}, \quad |z_n| \leq r$, then $f(z)$ can be meromorphically continued *also to a neighbourhood of the set* $\{|z_1 - a_1| \leq \rho, z_2 = a_2, \cdots, z_{n-1} = a_{n-1}, |z| \leq \rho$

Proof of equivalence. From the assumption there exists $\delta > 0$ such that f is meromorphic in a neighbourhood of $C_{\delta} = \{|z_1 - a_1| \leq \delta, z_2 = a_2, \cdots, z_n = a_n|\}$ $z_{n-1} = a_{n-1}$, $|z_n| \leq r$. Let δ_0 denote the supremum of the set of positive numbers δ such that f is meromorphic in a neighbourhood of C_{δ} . Assume that $\delta_0 \leq \rho$. Let b_1 be an arbitrary point on the circle $\{|z_1 - a_1| = \delta_0\}$ and $b_1^{(p)} \in \{ |z_1 - a_1| < \delta_0 \}$ $(p = 1, 2, \cdots)$ be a sequence convergent to b_1 from the interior of the circle. Then f is meromorphic in a neighbourhood of the union of the sets $\{z_1 = b_1, z_2 = a_2, \dots, z_{n-1} = a_{n-1}, |z_n| = r\}$ and $\{z_1 = b_1^{(p)}\}$ $z_2 = a_2, \dots, z_{n-1} = a_{n-1}, \ |z_n| \leq r$. Hence f can be meromorphically con $x_1 = a_1, \quad x_2 = a_2, \quad \cdots, \quad z_{n-1} = a_{n-1}, \quad |z_n| \leq r$ from Continuity Theorem of Levi-Kneser. By the arbitrariness of b_i , f can be meromorphically continued to a neighbourhood of *Cδ^o* This contradicts the definition of δ_0 . Thus it must hold $\delta_0 > \rho$ and the proof is completed.

Conversely, .we shall show that Continuation Theorem implies Con tinuity Theorem of Levi-Kneser. From the assumption of Continuity Theo rem there exists $\delta > 0$ such that f is meromorphic in a neighbourhood of the set $\{|z_1 - a_1| < 2\delta, \cdots, |z_{n-1} - a_{n-1}| < 2\delta, |z_n| = r\}.$ Let p be a sufficiently large integer such that $a_j^{(p)} \in \{ \vert z_j - a_j \vert < \delta \}, \ j = 1, \cdots, n-1$. Then f is meromorphic in a neighbourhood of the union of the sets $\{|z_1 - a_i^{(p)}| \leq \delta$, $z_2 = a_2^2$, \cdots , $z_{n-1} = a_{n-1}$, $|z_n| = r$ and $|z_1 = a_1^2$, $z_2 = a_2^2$, \cdots , $z_{n-1} = a_{n-1}^2$ $\left| z_{n}\right| =r$. Consequently, from Continuation Theorem f can be meromor phically continued to a neighbourhood of $\{|z_1 - a_1^{(p)}| \leq \delta, z_2 = a_2^{(p)}, \cdots,$ $z_{n-1} = a_{n-1}^{(p)}, \ |z_n| \leq r \}$ and hence of $\{z_1 = a_1, \ z_2 = a_2^{(p)}, \cdots, z_{n-1} = a_{n-1}^{(p)}, \ |z_n| \leq r \}.$ By the mathematical induction, we come to the conclusion.

We have given the proof of Continuation Theorem equivalent to Con tinuity Theorem of Levi-Kneser ([5]). Here we do not touch this proof.

Using Continuation Theorem, we obtain the following two lemmas.

LEMMA 1. If $f(z)$ is meromorphic in the union⁴ of the domains $\{a_1 < |z_1| < b_1$, $|z_2| < b_2, \ \cdots, \ |z_n| < b_n$ and $\{ |z_j| < b_j' \}_{j=1}^n$, then $f(z)$ can be meromorphically *continued to the polydisc* $\{|z_j| < b_j\}_{j=1}^n$, where a_i , b_j and b'_j $(j = 1, \ldots, n)$ are *real numbers satisfying the condition* $0 < a_1 < b'_1 \leq b_1$ and $0 < b'_j \leq b_j$ ($j = 2, \cdots, n$).

Proof. Take any point $z^0 = (z_1^0, \dots, z_n^0)$ in the polydisc $\{|z_j| < b'_j\}_{j=1}^n$. Let ε be any positive number satisfying the inequalities $a_{1} < b'_{1} - \varepsilon$ and $b'_n < b_n - \varepsilon$. From the assumption f is meromorphic in a neighbourhood of union of the sets $\{|z_1| = b'_1 - \varepsilon, z_2 = z_2^0, \dots, z_{n-1} = z_{n-1}^0, |z_n| \leq b_n - \varepsilon\}$ and $\{ |z_1| \leq b'_1 - \varepsilon, z_2 = z_2^0, \cdots, z_{n-1} = z_{n-1}^0, z_n = 0 \}.$ Then f can be mero morphically continued to the set $\{|z_1| \leq b'_1 - \varepsilon, z_2 = z_2^0, \cdots, z_{n-1} = z_{n-1}^0,$ $\vert z_n \vert \leq b_n - \varepsilon$ from Continuation Theorem. Since z_j^0 $(j = 2, \dots, n-1)$ and ε are chosen arbitrarily, f can be also meromorphically continued to the polydisc $\{ |z_1| < b'_1, \ldots, |z_{n-1}| < b'_{n-1}, |z_n| < b_n \}.$ By the use of mathe matical induction, f can be meromorphically continued to the polydisc $\{|z_1| < b'_1, |z_2| < b_2, \cdots, |z_n| < b_n\}$ at last. Observing that the union of $\alpha_1 \leq a_1 \leq a_2 \leq a_2 \leq a_3 \leq a_1 \leq a_2 \leq a_2 \cdots$, $|z_n| < b_n$ and $\{|z_1| < b_1', \ |z_2| < b_2,$ \cdots , $|z_n| < b_n$ is the polydisc $\{|z_j| < b_j\}_{j=1}^n$, we complete the proof of our Lemma.

LEMMA 2. If $f(z)$ is meromorphic in the union⁵⁾ of the domains $\{ |z_1| < b_1,$ $a_2 < |z_2| < b_2, \ \cdots, \ a_n < |z_n| < b_n$ and $\{|z_j| < b'_j\}_{j=1}^n$, then $f(z)$ can be mero*morphically continued to the polydisc* $\{|z_j| < b_j\}_{j=1}^n$, where $0 < b'_1 \leq b_1$ and $0 < a_j < b_j$ $b'_j \leq b_j$ $(j = 2, \dots, n)$.

Proof. For the simplicity we shall prove this lemma in the case of $n = 3$. Let f be meromorphic in the union of domains $B = \{ |z_1| < b_1, a_2 \}$ $\langle z_1 | z_2 | \langle z_2 | x_3 | \langle z_3 | z_4 | \rangle \rangle$ and $C = {\{ |z_j| \langle b'_j \}_{j=1}^3}.$ If we take any point z_2^0 $\lambda(a_2 < |z_2^o| < b_2')$ and any positive number ε so that it holds $b_1' < b_1 - \varepsilon$ and $a_3 < b'_3 - \varepsilon$, f is meromorphic in a neighbourhood of the union of the sets ${|z_1| \leq b_1 - \varepsilon, z_2 = z_2^0, |z_3| = b'_3 - \varepsilon}$ and ${|z_1 = 0, z_2 = z_2^0, |z_3| \leq b'_3 - \varepsilon}.$ Then considering the arbitrariness of *z%* and ε, we can find by Continuation Theorem that f can be meromorphically continued to the domain $B_1 =$ $\{ |z_1| < b_1, a_2 < |z_2| < b'_2, |z_3| < b'_3 \}.$ Hence *f* is meromorphic in $B \cup B_1 \supset \tilde{B}_1 =$ ${\{|z_1| < b_1, \ z_2| < b_2', \ |z_3| < b_3\}}$. Further we can find by Lemma 1 that *f* can be meromorphically continued to the polydisc $C_2 = {\vert z_1 \vert < b_1, \vert z_2 \vert < b'_2, \atop z_2 \to z_1}$ $|z_3| < b_3$ from the meromorphy of f in $\tilde{B}_1 \cup C$. If the index 2 is replaced with the index 3, f can be also meromorphically continued to the polydisc $C_3 = \{ |z_1| < b_1, |z_2| < b_2, |z_3| < b'_3 \}.$ Since $B \cup C_2 \cup C_3 = \{ |z_1| < b_j \}_{j=1}^3$, we conclude that f is meromorphic in the polydisc $\{ |z_j| < b_j \}_{j=1}^3$.

EXAMPLE 1. Consider the domain $D_0 = {\{|z_j| < 1\}}_{j=1}^n - {\{|z_j| - 1\}}^2 +$ *n* $\sum_{j=2}^{\infty}$ $\binom{|k_j| - 1}{2} \geq 1$ of such domain D_0 is a well-known example (Behnke Stein's example) of the domain in which the first Cousin problem is always solvable, but the second is not necessarily solvable. If f is meromorphic
in D_0 , f can be meromorphically continued to the unit polydisc $\{|z_i| < 1\}_{i=1}^n$ $\sum_{j=1}^{n}$ $\sum_{j=1}^{n}$ can be incremely continued to the unit polydisc $\binom{|\mathcal{X}|}{|\mathcal{X}|}$ from Lemma 2. Because / is meromorphic in the union of the domains $\frac{1}{4}$, $\frac{1}{4}$, $\frac{1}{821}$, $\frac{1}{4}$, $\frac{1}{4}$, $\frac{1}{8}$, $\frac{1}{4}$ and $\frac{1}{811}$, $\frac{1}{4}$, $\frac{1}{4}$, $\frac{1}{821}$, $\frac{1}{4}$, $\frac{1}{4}$ $|z_n| < 1$.

EXAMPLE 2. Consider the domain $D = \{|z_n| < |z_{n-1}| < \cdots < |z_1| < 1\}.$ This is a domain of holomorphy. But if f is meromorphic in a neighbourhood of the closure \overline{D} of D , there exists some δ (>0) so that f can be meromorphically continued to the polydisc $\{|z_j| < 1 + \delta\}_{j=1}^n$.

Now let us prove this in the case of $n = 3$ for simplicity. If f is meromorphic in the closure of $D = \{ |z_3| < |z_2| < |z_1| < 1 \}$, there exists some $\delta > 0$ so that f is meromorphic in the union of the domains $B_1 = \{|z_1| < 1 + \delta$, $|z_2| < \delta$, $|z_3| < \delta$, $B_2 = \{1 - \delta < |z_1| < 1 + \delta$, $|z_2| < 1 + \delta$, $|z_3| < \delta\}$ and $B_3 =$ $\{1 - \delta < |z_1| < 1 + \delta, \ 1 - \delta < |z_2| < 1 + \delta, \ |z_3| < 1 + \delta\}.$ Hence it is found by Lemma 1 that f can be meromorphically continued to $\tilde{B}_1 = \{|z_1| <$ $1 + \delta$, $|z_2| < 1 + \delta$, $|z_3| < \delta$ from the meromorphy of f in $B_1 \cup B_2$ and then it is also found by Lemma 2 that f can be meromorphically continued to $\{|z_j| < 1 + \delta\}_{j=1}^3$ from the meromorphy of f in $\tilde{B}_1 \cup B_3$.

§3. **Removable singularities**

We note that the second theorem on removable singularities holds for meromorphic functions ([6]).

PROPOSITION⁶). *Let V be an analytic set of complex dimension n* — 2, *which is defined by the common zeros of two functions g{z) and h{z) holomorphic and locally* $\mathit{coprime}^{\gamma}$ in a domain D of \mathbf{C}^n . If $f(z)$ is meromorphic in $D-V$, then V is a *set of removable singularities of f(z).*

This is an immediate result of Weierstrass preparation theorem and the following lemma obtained easily from Lemma 1.

LEMMA 3. Let F_j $(j = 1, 2)$ denote a closed set on the z_j -plane, where F_i lies *entirely in* $\{|z_1| < r_1\}$ and $\{|z_2| < r_2\} - F_2$ is not empty. If $f(z)$ is meromorphic *in the set of all those points in a polydisc* $\{|z_j| < r_j\}_{j=1}^n$, for which $z_1 \notin F_1$ or $z_{\scriptscriptstyle 2} \in F_{\scriptscriptstyle 2}, \;$ then $f(z)$ can be meromorphically continued to the complete polydisc $\{|z_j| < r_j\}_{j=1}^n$.

Proof. Denote by D_j the disc $\{|z_j| < r_j\}$ on the z_j -plane, $(j = 1, \dots, n)$. From the assumption f is meromorphic in $[(D_1 - F_1) \times D_2 \times \cdots \times D_n]$ $[D_1 \times (D_2 - F_2) \times D_3 \times \cdots \times D_n]$. Since the meromorphy is invariant under the biholomorphic mapping, it may be assumed that $D_2 - F_2$ contains the origin in the z_2 -plane. Then there exist some positive numbers $\rho \, \langle \langle r_1 \rangle$ and $(*r*₂)$ so that *f* is meromorphic in the domain ${\rho < |z_1| < r_1, |z_2| < r_2}$, $\cdot \cdot \cdot$, $|z_n| < r_n$, \cup $\{|z_1| < r_1$, $|z_2| < \delta$, $|z_3| < r_3$, $\cdot \cdot \cdot$, $|z_n| <$ *}.* Therefore

it is concluded from Lemma 1 that f can be meromorphically continued to the polydisc $\{|z_j| < r_j\}_{j=1}^n$.

§4.* **Radius of Meromorphy**

In [5] we proved the equivalence of Continuation Theorem and the fact that the logarithm of the radius of meromorphy is superharmonic⁸). If we could obtain another proof of the latter fact, then the above equiva lence would give a new proof of Continuity Theorem of Levi-Kneser.

Let $f(w_1, \dots, w_n, z)$ be meromorphic in a neighbourhood of the set ${w = (w_1, \dots, w_n) \in D, z = c}, \text{ where } D \text{ is a domain in the space } C^n(w).$ For each point $w^{\mathfrak{g}}$ in *D*, let $R(w^{\mathfrak{g}})$ denote the supremum of the set of radii *r* such that f is meromorphic in (w, z) in a neighbourhood of the set ${w = w^0, |z - c| < r}.$ Then $R(w^0)$ is called the radius of meromorphy of f at a point w^0 with center at the point c .

THEOREM 1. If $R(w_1, \dots, w_n)$ is the radius of meromorphy of a meromorphic *function* $f(w_1, \ldots, w_n, z)$ at a point w, then for a fixed point (w_2^0, \ldots, w_n^0) $\log R(w_1, w_2^0, \cdots, w_n^0)$ is superharmonic in w_1 . Further $\log R(w_1, \cdots, w_n)$ is *plurisuperharmonic in* (w_1, \cdots, w_n) .

A proof of the first statement of this theorem was given in [5]. To prove the second statement, it is enough to show that if the definition domain *D* of *R{w)* is cut by any analytic plane *E:*

 $w_j = a_j t + b_j$ (a_j , b_j constant, *t* complex parameter), $j = 1, \dots, n$, then $\log R(a_1 t + b_1, \dots, a_n t + b_n)$ is always superharmonic in t on each con nected component of *DΠE.* We can reduce easily to the first half by a unitary transformation of w_1 -axis onto E , considering that the meromorphy is invariant under a biholomorphic mapping.

 $\text{In fact, let a unitary transformation of } w_1\text{-axis onto } E \text{ be }$

$$
(1) \t\t w = \zeta U + b,
$$

where $w = (w_1, \dots, w_n)$, $\zeta = (\zeta_1, \dots, \zeta_n)$ and $b = (b_1, \dots, b_n)$ are the $1 \times n$ matrices, and *U* is an $n \times n$ unitary matrix. Let D^* be the image of *D* by the transformation (1). Let $f^*(\zeta, z)$ and $R^*(\zeta)$ denote the transformed function of $f(w, z)$ by (1) and the radius of meromorphy of f^* at each point

 $\zeta \in D^*$ with center at the point *c*, respectively. Then it holds $R(\zeta U + b) =$ $R^*(\zeta)$ in D^* . Now, from the first statement of Theorem 1 $\log R^*(\zeta_1, 0, \dots, 0)$ is superharmonic in ζ_1 . Therefore $\log R(a_1t + b_1, \cdots, a_nt + b_n)$ is superhar monic in *t*, when log $R^*(\zeta_1, 0, \cdots, 0)$ is returned to w-space by the trans formation (1).

§5. **Reinhardt domains**

In what follows, we shall treat proper Reinhardt domains with center at the origin.

First of all we shall discuss the meromorphic continuation concerning meromorphic functions in such a domain of $Cⁿ$. In the case of $n = 2$, Thullen [8] has investigated in detail such a continuation. In the general case of *n* complex variables, we shall give another proof about theorems on meromorphic completion by the only use of Continuation Theorem.

By the use of Lemma 2, we obtain easily the following theorem which corresponds to the expansion theorem of H. Cartan in the case of holo morphic functions.

THEOREM 2. *If f(z) is meromorphic in a proper Reinhardt domain D, then f(z) can be meromorphically continued to the least complete Reinhardt domain containing D.*

Proof. Now let *z°* be any point of *D.* Without loss of generality we may assume that each coordinate of $z^{\mathfrak{g}}$ is nonzero. Since D contains the origin and is connected, we can join a neighbourhood $\{ \{z_j | < b_j^0 \}_{j=1}^n \,\, (\subset\!D)$ of the origin with z^0 by a finite number of ring polydomains $Q_k = \{a_j^{(k)} \leq$ $|z_j| < b_j^{(k)}\}_{j=1}^n \subset D$, $(k = 1, 2, \cdots, m)$, where $\{|z_j| < b_j^{0}\}_{j=1}^n \cap Q_1 \neq \phi$, $Q_k \cap Q_{k+1} \neq \phi$ $(k = 1, 2, \cdots, m-1)$ and $z^0 \in Q_m$.

We must show that f can be meromorphically continued to a neighbourhood of $\{|z_j| \leq |z_j^0|\}_{j=1}^n$. For this purpose it is enough to prove that *f* can be meromorphically continued to the polydisc $\{ |z_j| < b_j \}_{j=1}^n$, provided that f is meromorphic in $\{|z_j| < b_j\}_{j=1}^n \cup \{a_j < |z_j| < b_j\}_{j=1}^n$, $(a_j < b_j \leq b_j, j =$ $1, 2, \cdots, n$).

For the simplicity, we shall show this in the case of $n = 3$. At first it is easily seen that the union of domains $\{|z_j| < b_j^0\}_{j=1}^3$ and $B = \{a_j < j\}$ $|z_1| < b_j$, $\sum_{j=1}^3$ contains the domain $\{|z_1| < b_1, a_2 < |z_2| < b_2^0, a_3 < |z_3| < b_3^0$ Hence from Lemma 2, f can be meromorphically continued to the polydisc $\{|z_1| < b_1, |z_2| < b_2^0, |z_3| < b_3^0\}.$ Further since the union of this polydisc

and *B* contains the domain $\{a_1 < |z_1| < b_1, |z_2| < b_2, a_3 < |z_3| < b_3^0\}$, *f* can be meromorphically continued to the polydisc $C_3 = {\vert z_1 \vert < b_1, \ \vert z_2 \vert < b_2,}$ $|z_3| < b_3$ by the use of Lemma 2 again. In the similar manner, f can be meromorphically continued to the polydisc $C_2 = {\{|z_1| < b_1, |z_2| < b_2^0, |z_3| < b_3\}}$ $\text{and} \ \ C_1 = {\{|z_1| < b_1^0, \ |z_2| < b_2, \ |z_3| < b_3\}}. \ \ \ \text{Since} \ \ B \cup C_1 \cup C_2 \cup C_3 = {\{|z_j| < b_j\}_{j=1}^3, \ |z_j| < b_j\}}.$ we complete the proof of this theorem.

THEOREM 3. If $f(z)$ is meromorphic in a proper Reinhardt domain D , then *f{z) can be meromorphically continued to the least complete Reinhardt domain containing D which has the logarithmically convex domain of real expression.*

Proof. By Theorem 2, it may be assumed that *D* is a complete Reinhardt domain. Let *Δ* and J* denote the domain of real expression of *D* and the image of *Δ* contained in *Rⁿ {ξ)* by the transformation

$$
\xi_j = \log |z_j|, \qquad j = 1, 2, \cdots, n,
$$

respectively. Take any two points $\alpha = (\alpha_1, \dots, \alpha_n)$, $\beta = (\beta_1, \dots, \beta_n)$ in Δ^* . If $\xi = (\xi_1, \dots, \xi_n)$ is any point on the line segment, which joins α and β , it is represented by the form

(3)
$$
\xi = \theta \alpha + (1 - \theta)\beta, \qquad (0 \le \theta \le 1),
$$

where $\theta \alpha$ denotes the scalar multiplication $(\theta \alpha_1, \cdots, \theta \alpha_n)$. *).* Eliminating *θ* in (3), we have the following representation by the components of *ξ:*

(3')
$$
\frac{\xi_1 - \beta_1}{\alpha_1 - \beta_1} = \cdots = \frac{\xi_{n-1} - \beta_{n-1}}{\alpha_{n-1} - \beta_{n-1}} = \frac{\xi_n - \beta_n}{\alpha_n - \beta_n}.
$$

Here we note that $\xi_k = \beta_k$ if $\alpha_k = \beta_k$ for some $k \ (1 \leq k \leq n)$.

Let $z = (z_1, \cdots, z_n)$, $a = (a_1, \cdots, a_n)$ and $b = (b_1, \cdots, b_n)$ denote one of the inverse images of ξ , α and β by the transformation (2), respectively. Then it is sufficient to prove that any meromorphic function *f in D* can be meromorphically continued to a domain which contains a point *z* cor responding to *ξ* in (3). Since *D* is a complete Reinhardt domain, this is clear in the case $\alpha_j \leq \beta_j$ ($j = 1, \dots, n$) or $\alpha_j \geq \beta_j$ ($j = 1, \dots, n$) and hence it will be sufficient to prove this in the case where there exist two integers *j*, *k* (1 \leq *j*, *k* \leq *n*, *j* \div *k*) with α _{*i*} \lt *β_{<i>i*}</sub> and α _{*k*} \gt *β*_{*k*}. Then without loss of generality we may assume

$$
\alpha_1 < \beta_1 \quad \text{and} \quad \alpha_n > \beta_n.
$$

Denote by $(\xi_1, \dots, \xi_{n-1}, \beta_n)$ any point on the line segment

(5)
$$
\frac{\xi_1 - \beta_1}{\alpha_1 - \beta_1} = \cdots = \frac{\xi_{n-1} - \beta_{n-1}}{\alpha_{n-1} - \beta_{n-1}}, \ \xi_n = \beta_n,
$$

which joins two points $(\alpha_1, \dots, \alpha_{n-1}, \beta_n)$ and $(\beta_1, \dots, \beta_{n-1}, \beta_n)$, and further denote by $R(z_1, \dots, z_{n-1})$ the radius of meromorphy of f at a point (z_1, \dots, z_{n-1}) with center at the origin $z_n = 0$, where f is a meromorphic function in *D* and (z_1, \ldots, z_{n-1}) is a point corresponding to the point $(\xi_1, \dots, \xi_{n-1})$. Then it will be sufficient to prove the inequality

(6)
$$
R(z_1, \cdots, z_{n-1}) > |z_n|
$$

for a point $z = (z_1, \dots, z_{n-1}, z_n)$ corresponding to any point ξ on the line segment (3').

Since *D* is a complete Reinhardt domain, it holds for any real θ_j (0 \le $\theta_j \leq 2\pi$, $j = 1, \cdots, n - 1$)

$$
R(z_1, \cdots, z_{n-1}) = R(z_1 e^{i\theta_1}, \cdots, z_{n-1} e^{i\theta_{n-1}}),
$$

and the following inequalities are obtained:

(7) $R(a_1, \cdots, a_{n-1}) > |a_n|$ and $R(b_1, \cdots, b_{n-1}) > |b_n|$.

We divide the proof of (6) into two cases $n = 2$ and $n > 2$.

(a) Case of $n = 2$. Since $\log R(z_1)$ is superharmonic in $\{|z_1| \leq |b_1|\}$ from Theorem 1 and $\xi_1 = \log |z_1|$ is harmonic in $\{|a_1| \leq |z_1| \leq |b_1|\}$, then the function

$$
u(z_1) = \log R(z_1) - \beta_2 - \frac{\alpha_2 - \beta_2}{\alpha_1 - \beta_1} (\xi_1 - \beta_1)
$$

is superharmonic in $\{|a_1| \leq |z_1| \leq |b_1|\}$, where $\alpha_j = \log |a_j|$, $\beta_j = \log |b_j|$ $(j = 1, 2)$ and $\xi_1 = \log |z_1|$. By the inequalities (7), $u(z_1)$ takes the positive value on $\{|z_1| = |a_1|\}$ and $\{|z_1| = |b_1|\}$. Therefore by the minimum principle i t holds $u(z_1) > 0$ in $\{|a_1| < |z_1| < |b_1|\}$ and it implies

$$
\log R(z_1) > \beta_2 + \frac{\alpha_2 - \beta_2}{\alpha_1 - \beta_1} (\xi_1 - \beta_1).
$$

Since the right hand side of the above inequality is equal to *ξ²* and hence to $\log|z_2|$ by (3'), the inequality (6) establishes.

(b) Case of $n > 2$. For the simplicity we assume that $\alpha_j \leq \beta_j$ ($j = 2$, \cdots , $n-1$) with (4). From Theorem 1 log $R(z_1, \ldots, z_{n-1})$ is plurisuper harmonic in $\{|z_j| \leq |b_j|\}_{j=1}^{n-1}$. A mapping φ :

(8)
$$
\begin{cases} z_1 = t \\ z_j = \exp \left\{ \beta_j + \frac{\alpha_j - \beta_j}{\alpha_1 - \beta_1} (\log t - \beta_1) \right\}, \quad j = 2, \dots, n-1, \end{cases}
$$

give the holomorphic mapping from $\{|a_1| \leq |t| \leq |b_1|\}$ onto $\{|a_j| \leq |z_j| \leq$ $|b_i| \}_{i=1}^{n-1}$. If the radius $R(z_1, \dots, z_{n-1})$ of meromorphy is transformed by then $f(t) = \log R(z_1, \cdots, z_{n-1})$ is a superharmonic function of t in $\{|a_i| \leq |t| \leq |b_1|\}.$

Let us consider the behavior of the function

(9)
$$
\log R(z_1, \cdots, z_{n-1}) - \beta_n - \frac{\alpha_n - \beta_n}{\alpha_1 - \beta_1} (\log |z_1| - \beta_1)
$$

on the line segment (5). Denoting by $u(t)$ the transformed function of (9) by (8) for the purpose, we may consider it in $\{|a_1| \leq |t| \leq |b_1|$ *\}*. Then it can be seen easily that $u(t)$ is superharmonic in $\{|a_1| \leq |t| \leq |b_1|\}$. Since $u(a_1) = \log R(a_1, \cdots, a_{n-1}) - \beta_n - \frac{a_n - \beta_n}{\alpha - \beta_n} (\alpha_1 - \beta_1) = \log R(a_1, \cdots, a_{n-1}) - \alpha_n > 0$ \mathfrak{m}_1 \mathfrak{m}_1 and $u(v_1)$ – $log n(v_1, \cdots, v_{n-1})$ $p_n > 0$ from (*i*), it holds by the minimum principle $u(t) > 0$ in $\left(\frac{|u_1|}{2} \right) \times \left| v_1 \right| \times \left| v_1 \right|$, and this implies

$$
f(t)=\log R(z_1,\ \cdots,\ z_{n-1})>\beta_n+\frac{\alpha_n-\beta_n}{\alpha_1-\beta_1}(\xi_1-\beta_1).
$$

From (3') the right hand side of the above inequality is equal to *ξⁿ* and hence to $log|z_n|$. Thus the inequality (6) is proved.

Now, a complete Reinhardt domain *D* which has the logarithmically convex domain of real expression, is a domain of holomorphy. For we can construct easily a power series $f(z)$ absolutely convergent in \tilde{D} , so that \tilde{D} is the domain of existence of $f(z)$. Consequently, it is concluded that the envelope of meromorphy of a proper Reinhardt domain *D* coincides with the envelope of holomorphy of *D.*
