# ON THE PLANCHEREL FORMULAS FOR SOME TYPES OF SIMPLE LIE GROUPS

The problem of finding the explicit Plancherel formulas for semisimple Lie groups has been solved completely in the case of complex semisimple Lie groups (see [3(b)]). Moreover Harish-Chandra showed [3(f)] that the problem is solved also for a real semisimple Lie group having only one conjugate class of Cartan subgroups. In the case of real semisimple Lie groups with several conjugate classes of Cartan subgroups, the problem is very difficult to attack. As far as the auther knows, the problem was taken up and solved for $\boldsymbol{S L}(2, \boldsymbol{R})$ by V. Bargman, [1], Harish-Chandra [3(a)], R. Takahashi [9 (a)] and L. Pukánszky [7]; also for the universal covering group of $\boldsymbol{S L}(2, \boldsymbol{R})$ by L. Pukánszky. In the previous note [6], we gave a method of finding the Plancherel formula for the universal covering group of De Sitter group. The purpose of this paper is to generalize this method and to obtain the explicit Plancherel formulas for simple Lie groups $G$ which satisfy the following conditions (A.1)~(A.5).
(A.1) There exists a simply connected complex simple analytic group $G^{c}$ containing $G$ as a real analytic subgroup corresponding to a real form of the Lie algebra of $G^{c}$.
(A.2) $G$ has a compact Cartan subgroup.
(A. 3) $G$ has two conjugate classes of Cartan subgroups.
(A.4) Every Cartan subgroup of $G$ is connected (c.f. Proposition 7).
(A.5) Let $T_{\Lambda}$ be the invariant distribution defined by the formula (3.8) in $\S 3$. Then there exists a finite number of irreducible unitary representations $\omega_{\Lambda}^{(1)}, \cdots, \omega_{\Lambda}^{(s)}$ of $G$ such that the character of the representation $\omega_{\Lambda}^{(1)} \oplus \cdots \oplus \omega_{\Lambda}^{(s)}$ coincides with the distribution $T_{\Lambda}$ (c.f. Remark 1).

The Plancherel formula for such a group $G$, which is our main result, will be given in Theorem 2 in $\S 4$ and Theorem $2^{\prime}$ in $\S 5$.

We shall see that the assumptions (A.1)~(A.5) are satisfied by the universal covering group of De Sitter group. We shall thus obtain the
explicit Plancherel formula for this group in Theorem 3 in $\S 6$. This formula was conjectured by R. Takahashi in [9 (b)].

## 1. Preliminaries

Let $G$ be a simple Lie group which satisfies the conditions (A.1), (A.2) and (A.3). We denote by $\mathfrak{g}, \mathfrak{g}^{c}$ the Lie algebras of $G, G^{c}$ respectively. Let $K$ be a connected maximal compact subgroup of $G$ and $\mathfrak{f}$ its Lie algebra. We put

\mathfrak{p}=\{X \in \mathfrak{g}: B(X, Y)=0 \quad \text { for all } \quad Y \in \mathfrak{f}\},
$$

where $B$ denotes the Killing form of the Lie algebra $g^{c}$. We have then

$$
\mathfrak{g}=\mathfrak{f}+\mathfrak{p}, \quad \mathfrak{f} \cap \mathfrak{p}=(0), \quad[\mathfrak{p}, \mathfrak{p}] \subset \mathfrak{f}, \quad[\mathfrak{f}, \mathfrak{p}] \subset \mathfrak{p} .
$$

We take a maximal connected abelian subgroup $A_{1}$ of $K$ and fix it once for all and let $\mathfrak{h}_{1}$ denote its Lie algebra. Then from (A.1) and (A.2) $A_{1}$ is a Cartan subgroup of $G$ corresponding to $\mathfrak{h}_{1}$; i.e.

A_{1}=\left\{g \in G: \operatorname{Ad}(g) H=H \quad \text { for all } H \in \mathfrak{h}_{1}\right\},
$$

where Ad denotes the adjoint representation of $G$. For any subspace $\mathfrak{l}$ of $\mathfrak{g}$, we denote its complexification by $\mathfrak{r c}$. Let $\Sigma_{1}$ denote the set of all non zero roots of $\mathfrak{g}^{c}$ with respect to $\mathfrak{G}$. Let $\sigma$ be the conjugation of $\mathrm{g}^{c}$ with respect to g and let $t^{t}$ be the linear transformation on the dual space $\hat{\mathfrak{h}}_{1}^{C}$ of $\mathfrak{h}_{1}^{c}$ defined by

\left({ }^{t} \sigma \Lambda\right)(H)=\overline{\Lambda(\sigma H)} \quad\left(H \in \mathfrak{h}_{1}^{C}\right)

for any $\Lambda \in \hat{h}_{1}^{c}$.
Since ${ }^{t_{\sigma}}$ induces a substitution of roots, there exists a complex number $\kappa_{\alpha}$ for each $\alpha \in \Sigma_{1}$ such that

\sigma E_{\alpha}=\kappa_{\alpha} E_{t_{\sigma \alpha}}
$$

It is well known that we can find a basis $\left\{E_{a} ; \alpha \in \Sigma_{1}\right\}$ of $\mathfrak{p}^{C} \bmod \mathfrak{h}_{1}^{C}$ satisfying the following conditions;

\left|\kappa_{\alpha}\right|=1 . \tag{1.4}

Since $\left[\mathfrak{h}_{1}^{C}, \mathfrak{f}^{c}\right] \subset \mathfrak{f}^{c}$ and $\left[\mathfrak{h}_{1}^{C}, \mathfrak{p}^{c}\right] \subset \mathfrak{p}^{C}$, it is clear that either $E_{\infty} \in \mathfrak{f}^{C}$ or $E_{\alpha} \in \mathfrak{p}^{c}$. A root $\alpha \in \Sigma_{1}$ is called compact or non compact according to $E_{\infty} \in \mathfrak{f}^{c}$ or $E_{\infty} \in \mathfrak{p}^{C}$.

For any $\alpha \in \Sigma_{1}$, let $H_{a}$ denote the unique element in $\mathfrak{h}_{1}^{C}$ such that

Put

V_{a} & =\sqrt{-1} \sqrt{2}\left(E_{a}-E_{-a}\right) /\left(\alpha\left(H_{\alpha}\right)\right)^{1 / 2} \tag{1.6}
\end{align*}

Fix a non compact root $\alpha_{0}$ in $\Sigma_{1}$ once for all. Then from (A.2) and (A.3), $\mathfrak{a}=\sqrt{-1} \boldsymbol{R} U_{a_{0}}$ is a maximal abelian subalgebra in $\mathfrak{p}$ (see [8]).

We consider the automorphism $\nu=\exp \left\{(\pi / 4)\right.$ ad $\left.V_{a_{0}}\right\}$ of $g^{c}$ where ad denotes the adjoint representation of $\mathrm{g}^{c}$. Then we have

where $H_{0}=\frac{2}{\alpha_{0}\left(H_{a_{0}}\right)} H_{a_{0}}$.
Put $\mathfrak{h}^{-}=\left\{H \in \mathfrak{h}_{1}:[H, X]=0\right.$ for all $\left.X \in \mathfrak{a}\right\}$. Then $\mathfrak{h}_{2}=\mathfrak{a}+\mathfrak{h}^{-}$is a Cartan subalgebra of $\mathfrak{g}$ which is not conjugate to $\mathfrak{h}_{1}$ (see [8]). From the above assumption (A.3), every Cartan subalgebra of $g$ is conjugate to either $\mathfrak{h}_{1}$ or $\mathfrak{h}_{2}$. It is easy to see that

\nu\left(\mathfrak{h}_{2}^{C}\right)=\mathfrak{h}_{1}^{C} \quad \text { and } \quad \nu(H)=H \quad \text { for all } \quad H \in \mathfrak{h}^{-} . \tag{1.8}

For any $\Lambda \in \hat{\mathfrak{h}}_{1}^{c}$, let $\tilde{\Lambda}$ denote the linear form on $\mathfrak{h}_{2}^{C}$ defined by

\tilde{\Lambda}(H)=\Lambda(\nu H) \quad\left(H \in \mathfrak{h}_{2}^{C}\right) . \tag{1.9}

Put $\Sigma_{2}=\left\{\tilde{\alpha}: \alpha \in \Sigma_{1}\right\}$. Since $\nu$ is an automorphism of $g^{C}$ it follows that $\Sigma_{2}$ is exactly the set of all non zero roots of $\mathrm{g}^{C}$ with respect to $\mathfrak{h}_{2}^{C}$. Select compatible orderings in the dual spaces of $\mathfrak{a}$ and $\mathfrak{a}+\sqrt{-1} \mathfrak{h}$ and let $\widetilde{\alpha}_{1}, \check{\alpha}_{2}, \cdots, \widetilde{\alpha}_{l}$ be all the simple roots in $\Sigma_{2}$ under this order. Since $\left\{\tilde{\alpha}_{1}, \tilde{\alpha}_{2}, \cdots, \tilde{\alpha}_{l}\right\}$ is a fundamental root system of $\Sigma_{2},\left\{\alpha_{1}, \alpha_{2}, \cdots, \alpha_{l}\right\}$ is a fundamental root system of $\Sigma_{1}$. Hence we can define an order in $\Sigma_{1}$ such that $\left\{\alpha_{1}, \alpha_{2}, \cdots, \alpha_{l}\right\}$ is exactly the set of all simple roots in this order. Moreover we may assume $\alpha_{0}>0$. We put $H_{i}=\frac{2}{\alpha_{i}\left(H_{\alpha_{i}}\right)} H_{\alpha_{i}}(i=1, \cdots, l)$. Let $P_{1}$ (resp. $P_{2}$ ) be the set of all positive roots of $\Sigma_{1}$ (resp. $\Sigma_{2}$ ). We put

\begin{aligned}
& P_{2}^{+}=\left\{\tilde{\alpha} \in P_{2}: \check{\alpha}(\mathfrak{a}) \neq(0)\right\}, \\
& P_{2}^{-}=P_{2}-P_{2}^{+} .
\end{aligned}
$$

Then $P_{2}^{-}$is the set of all compact positive roots in $\Sigma_{2}$. Let $\mathfrak{F}$ (resp. $\mathfrak{F}_{0}$ ) be the set of all integral (resp. dominant integral) forms on $\mathfrak{h}_{1}^{C}$. Then we have

& \mathfrak{F}=\left\{\Lambda=\sum_{i=1}^{l} m_{i} \Lambda_{i}: m_{i} \in \boldsymbol{Z}(i=1, \cdots, l)\right\} \\
& \mathfrak{F}_{0}=\left\{\Lambda=\sum_{i=1}^{l} m_{i} \Lambda_{i}: m_{i} \geqslant 0, m_{i} \in \boldsymbol{Z}(i=1, \cdots, l)\right\}
\end{aligned}
$$

where $\left\{\Lambda_{1}, \Lambda_{2}, \cdots, \Lambda_{l}\right\}$ is the dual basis of $\left\{H_{1}, H_{2}, \cdots, H_{l}\right\}$.
Since $A_{1}$ is a connected abelian Lie group, the mapping $H \rightarrow$ $\exp H\left(H \in \mathfrak{h}_{1}\right)$ is a homomorphism of $\mathfrak{h}_{1}$ onto $A_{1}$. Let $\Lambda$ be a linear form on $\mathfrak{h}_{1}$ such that $e^{\Lambda(H)}=1$ for all $H \in \Gamma\left(\mathfrak{h}_{1}\right)$, where

\Gamma\left(\mathfrak{h}_{1}\right)=\left\{H \in \mathfrak{h}_{1}: \exp H=e\right\}
$$

Then we can define a function $\xi_{\Lambda}$ on $A_{1}$ by

\xi_{\Lambda}(\exp H)=e^{\Lambda(H)} \quad\left(H \in \mathfrak{h}_{1}\right) \tag{1.10}
\end{equation*}
$$

Moreover $\xi_{\Lambda}$ is uniquely extended to a holomorphic function on $A_{1}^{C}=\exp \mathfrak{G}_{1}^{C}$.
Although the following proposition is well known, it is fundamental in the present paper so that we shall give a proof of it.

Proposition 1. Let $\hat{A}_{1}$ be the character group of $A_{1}$. Then $\hat{A}_{1}=\left\{\xi_{\Lambda}: \Lambda \in \mathfrak{F}\right\}$.

Proof. Put

$$
\Gamma=\left\{2 \pi \sqrt{-1} \sum_{i=1}^{l} m_{i} H_{i}: m_{i} \in \boldsymbol{Z}(i=1,2, \cdots, l)\right\}
$$

Then, since $\mathfrak{h}_{1} / \Gamma\left(\mathfrak{h}_{1}\right) \cong A_{1}$, the proposition follows immediately if we prove $\Gamma=\Gamma\left(\mathfrak{h}_{1}\right)$.

Let $H \in \Gamma\left(\mathfrak{h}_{1}\right)$. Then $\exp H=e$, where $e$ is the identity of $G$. Since $\Lambda_{i}(i=1, \cdots, l)$ is a dominant integral form, there exists an irreducible finite dimentional representation $\tau_{i}$ of $\mathrm{g}^{c}$ with the highest weight $\Lambda_{i}$. Since $G^{c}$ is simply connected, there exists a representation $\tilde{\tau}_{i}$ of $G^{c}$ such that $d \widetilde{\tau}_{i}=\tau_{i}$. Let $u_{i}$ be a weight vector corresponding to $\Lambda_{i}$. Then we get

e^{\Lambda_{i}(H)} u_{i}=\exp \left(\tau_{i} H\right) u_{i}=\widetilde{\tau}_{i}(\exp H) u_{i}=u_{i} \neq 0
$$

Hence $\Lambda_{i}(H) \in 2 \pi \sqrt{-1} Z(i=1,2, \cdots, l)$. This means $H \in \Gamma$.
Conversely let $H \in \Gamma$. Then $H=2 \pi \sqrt{-1} \sum_{i=1}^{i} m_{i} H_{i}$ for some $m_{i} \in \boldsymbol{Z}$ $(i=1,2, \cdots, l)$. Let $\tau$ be a faithful representation of $G^{c}$ on a finite di-
mensional vector space $V$. It is known that every weight $\Lambda$ of $\tau$ is an integral form on $\mathfrak{h}_{1}^{c}$ and that $V$ is the direct sum of eigenspaces $V_{\Lambda}, \Lambda$ being a weight of $\tau$. For any $u \in V_{\Lambda}$, we have

& \tau(\exp H) u=\exp \left(2 \pi \sqrt{-1} \sum_{i=1}^{l} m_{i} d \tau\left(H_{i}\right)\right) u \\
&=e^{2 \pi \sqrt{-1}} \sum_{i=1}^{l} m_{i} \Lambda\left(H_{i}\right) \\
&
\end{aligned}

This is equal to $u$, since $\Lambda$ is an integral form. Hence $\tau(\exp H)$ is an identity transformation. Since $\tau$ is a faithful representation, it follows that $\exp H=e$. This implies $H \in \Gamma\left(\mathfrak{h}_{1}\right)$. Thus the proposition is proved.

## 2. Some results of Harish-Chandra

In this section we gather some results of Harish-Chandra which will be used in this paper.

In this section we assume that $G$ satisfies the conditions (A.1)~(A.4).
For any submanifold $U$ of $G$, let $C_{c}^{\infty}(U)$ denote the set of all complex valued $C^{\infty}$-functions on $U$ with the compact supports. Then for any $f \in C_{c}^{\infty}(G)$ and a fixed $g \in G$, the function $f^{g}: x \rightarrow f\left(g x g^{-1}\right)(x \in G)$ is again in $C_{c}^{\infty}(G)$, and if $T$ is a distribution on $G$, the mapping $T^{g}: f \rightarrow T\left(f^{g-1}\right)$ ( $f \in C_{c}^{\infty}(G)$ ) is also a distribution. We say $T$ is invariant if $T^{g}=T$ for all $g \in G$. Let 3 be the algebra of all differential operators on $G$ which are invariant under both left and right translations. We denote by $D(x)$ the coefficitent of $t^{l}$ in $\operatorname{det}(t+1-\operatorname{Ad}(x))(x \in G)$. Then $D$ is an analytic function on $G$ and an element $x \in G$ is called regular if $D(x) \neq 0$. Let $G^{\prime}$ be the set of all regular elements in $G$. Then $G^{\prime}$ is an open and dense subset of $G$ whose complement is of measure zero with respect to the Haar measure of $G$. For any subset $B$ of $G$, we define $B^{\prime}=B \cap G^{\prime}$. A distribution $T$ on an open submanifold $U$ of $G$ is called an eigendistribution of $\mathcal{Z}$ on $U$ if it satisfies the equation $\Delta T=\chi(\Delta) T$ for any $\Delta \in \mathcal{B}$, where $\chi$ denotes a homomorphism of $\mathcal{Z}$ into $\boldsymbol{C}$.

Lemma 1. Let $T$ be an invariant eigendistribution of 3 on $G$. Then $T$ is a locally summable function (as distribution) which is analytic on $G^{\prime}$. (see $[3(\mathrm{~g})]$ ).

Since $A_{k}$ is connected by virtue of (A.4), we can define a continous function $\Delta_{k}$ on $A_{k}$ by

\Delta_{k}(h)=\left|\prod_{\alpha \in P_{k}^{+}}\left(e^{\alpha(H) / 2}-e^{-\alpha(H) / 2}\right)\right| \prod_{\alpha \in P_{k}^{0} \cup P_{k}^{-}}\left(e^{\alpha(H) / 2}-e^{-\alpha(H) / 2}\right), \tag{2.1}
\end{equation*}
$$

for all $h=\exp H \in A_{k}$.
Where $P_{1}^{0}$ (resp. $P_{1}^{-}$) is the set of all non compact (resp. compact) roots in $\Sigma_{2}$ and $P_{1}^{+}=P_{2}^{0}=\phi$ (empty set). Let $x \rightarrow x^{(k)}(x \in G)$ be the canonical
projection of $G$ onto $G / A_{k}(k=1,2)$. For any $f \in C_{c}^{\infty}(G)$, we put

\begin{equation*}
F_{f}^{(k)}(h)=\overline{\Delta_{k}(h)} \int_{G / A_{k}} f\left(h^{x(k)}\right) d x^{(k)} \quad\left(h \in A_{k}^{\prime}\right), \tag{2.2}
\end{equation*}
$$

where $d x^{(k)}$ is the invariant measure on $G / A_{k}$ and $h^{x(k)}=x h x^{-1}\left(h \in A_{k}\right)$.
Let $S\left(\mathfrak{h}_{k}^{C}\right)$ be the universal enveloping algebra of $\mathfrak{h}_{k}^{C}$. Let $B$ be an open subset of $A_{k}$. We regard it as an open submanifold of $A_{k}$ and consider the space $\mathfrak{D}(B)$ of all complex valued functions $F$ on $B$ of class $C^{\infty}$ satisfying the following two conditions.
(1) The closure in $A_{k}$ of the support of $F$ is compact.
(2) For every $u \in S\left(\mathfrak{h}_{k}^{C}\right)$,

\tau_{u}(F)=\sup _{h \in B}|F(h ; u)|<\infty \quad \text { where } \quad F(h ; u)=(u F)(h)
$$

Define a topology in $\mathfrak{D}(B)$ by means of the collection of seminorms $\tau_{u}\left(u \in S\left(\mathfrak{h}_{k}^{C}\right)\right)$. Then $\mathfrak{D}(B)$ is a locally convex space and the same holds for $C_{c}^{\infty}(G)$ under its usual topology (introduced by Schwartz).

Lemma 2. The mapping $f \rightarrow F_{f}^{(k)}$ is a continuous mapping of $C_{c}^{\infty}(G)$ into $\mathfrak{D}\left(A_{k}^{\prime}\right)$. Moreover, for any relatively compact open subset $U$ of $G$, there exists an open subset $B$ of $A_{k}^{\prime}$ such that $\bar{B}$ is compact and that $F_{f}^{(k)}$ is zero outside $B$ for every $f \in C_{c}^{\infty}(U)$.

For the proof, see [3(f)].
Let $A_{1}^{\prime \prime}$ be the set of all points $h=\exp H \in A_{1}$ such that

\prod_{\alpha \in P_{1}^{0}}\left(e^{\alpha<H) / 2}-e^{-\alpha(H) / 2}\right) \neq 0
$$

Lemma 3. (1) Let $B$ be any connected component of $A_{1}^{\prime}$. Then $u F_{f}^{(1)}\left(u \in S\left(\mathfrak{h}_{1}^{C}\right)\right)$ can be extended to a continuous function on the closure of $B$ in $A_{1}$ with the compact support which is of class $C^{\infty}$ on $A_{1}^{\prime \prime}$.
(2) $F_{f}^{(2)}$ can be extended to a function of class $C^{\infty}$ on $A_{2}$ with the compact support.

For the proof, see [3(f)].
Let $\mathfrak{U}$ be the universal enveloping algebra of $\mathfrak{g}^{c}$. Let $W_{k}$ be the Weyl group of $\mathrm{g}^{c}$ with respect to $\mathfrak{G}_{k}^{C}(k=1,2)$. For any $s \in W_{k}$, let $u \rightarrow s u$ ( $u \in S\left(\mathfrak{h}_{k}^{C}\right)$ ) denote the automorphism of $S\left(\mathfrak{h}_{k}^{C}\right)$ which coincides with $s$ on $\mathfrak{h}_{k}^{C}(k=1,2)$. Let $\Im_{k}$ be the subalgebra of all elements $u \in S\left(\mathfrak{h}_{k}^{C}\right)$ such that $s u=u$ for all $s \in W_{k}$.

Lemma 4. There exists an algebraic isomorphism $\gamma_{k}: \Delta \rightarrow \gamma_{k}(\Delta)(\Delta \in \mathbb{R})$ of 3 onto $\Im_{k}$ which satisfies the following conditions $(k=1,2)$;
(1) Let $u \rightarrow u^{*}(u \in \mathfrak{U})$ denote the anti-automorphism of $\mathfrak{U}$ which maps $X$ on $-X\left(X \in \mathrm{~g}^{c}\right)$. Then

& \gamma_{k}\left(\Delta^{*}\right)=\left(\gamma_{k}(\Delta)\right)^{*} \quad(\Delta \in \mathcal{Z}) . \\
& F_{\Delta J}^{(k)}=\gamma_{k}(\Delta) F_{f}^{(k)} \quad \text { for all } \quad f \in C_{c}^{\infty}(G) \quad \text { and } \quad \Delta \in \mathcal{Z} . \tag{2}
\end{align*}

For the proof of this lemma, see [3(d), (f)]. One should notice that our definition of $F_{f}^{(k)}$ is a little different from the one given in [3(f)] and consequetly (2) in Lemma 4 is a slight modification of [3(f)].

Lemma 5. For arbitrarily normalized Haar measures $d g$ and dh, the invariant measures $d x^{(k)}$ can be normalized so that we have

\int_{G} f(g) d g=\sum_{k=1}^{2} \int_{A_{k}} \Delta_{k}(h) F_{f}^{(k)}(h) d h \quad \text { for all } \quad f \in C_{c}^{\infty}(G) .
$$

This lemma is proved in the same way as [3(b)].
Now we fix the normalizations of the Haar measures of $G$ and $A_{2}$ arbitrarily. As for the Haar measure of $A_{1}$, we normalize the measure $d h$ such that

\end{equation*}

After this, we normalize the invariant measure $d x^{(k)}$ so that the equality in Lemma 5 holds.

Now let $S\left(\hat{\mathfrak{h}}_{k}^{c}\right)$ be the symmetric algebra over $\hat{\mathfrak{G}}_{k}^{c}$, where $\hat{\mathfrak{h}}_{k}^{c}$ is the vector space of all linear forms on $\mathfrak{h}_{k}^{C}(k=1,2)$. For any $\lambda \in \hat{h}_{k}^{c}$, we denote by $H_{\lambda}$ the unique element of $\mathfrak{h}_{k}^{C}$ such that $B\left(H_{\lambda}, H\right)=\lambda(H)$ for all $H \in \mathfrak{h}_{k}^{c}$. Then the mapping $\lambda \rightarrow H_{\lambda}\left(\lambda \in \hat{h}_{k}^{C}\right)$ can be uniquely extended to an isomorphism of $S\left(\hat{\mathfrak{h}}_{k}^{C}\right)$ onto $S\left(\mathfrak{h}_{k}^{C}\right)$ which we denote by $\partial$. Put $\pi_{k}=\prod_{\alpha \in P_{k}} \alpha$ and $\rho_{k}=\frac{1}{2} \sum_{\alpha \in P_{k}} \alpha$. We also put $\pi=\pi_{1}$ and $\rho=\rho_{1}$. Then $\partial(\pi) \in S\left(\mathfrak{h}_{1}^{C}\right)$.

Lemma 6. For any $f \in C_{c}^{\infty}(G), \partial(\pi) F_{f}^{(1)}$ can be extended to a continuous function on $A_{1}$. Moreover, there exists a positive number $c$ independent of $f$ such that

\lim _{h \rightarrow e} F_{f}^{(1)}(h ; \partial(\pi))=c(-1)^{n_{+} q} f(e) \quad\left(h \in A_{1}^{\prime}\right),
$$

for all $f \in C_{c}^{\infty}(G)$, where $n\left(\right.$ resp. $q$ ) is the number of the elements of $\mathrm{P}_{1}$ (resp. $\mathrm{P}_{1}^{0}$ ).

For the proof, see $[3(\mathrm{f}),(\mathrm{h})]$, and notice that $\overline{\Delta_{1}(h)}=(-1)^{n} \Delta_{1}(h)$.

## 3. Definition and Properties of $\boldsymbol{T}_{\Lambda}$

In this section we shall define a distribution $T_{\Lambda}$ for $\Lambda \in \mathfrak{F}$ and get some formulas on $T_{\wedge}$ under the additional assumption (A.5). Let $G$
be a simple Lie group which satisfies the conditions (A.1)~(A.4).
$S\left(\hat{h}_{k}^{C}\right)$ can be regarded as the algebra of all polynomial functions on $\mathfrak{h}_{k}^{c}$. For any $\lambda \in \hat{\mathfrak{h}}_{k}^{C}$ and $p \in S\left(\hat{\mathfrak{h}}_{k}^{C}\right)$, let $\langle\lambda, p\rangle=\langle\lambda, \partial(p)\rangle$ denote the value of $p$ at $H_{\lambda}$. Let $\mathfrak{F}^{\prime}$ be the set of all elements $\Lambda \in \mathfrak{F}$ such that $\langle\Lambda+\rho, \pi\rangle \neq 0$. We put $W=W_{1}$ and for any $s \in W$ define $\tilde{s}$ by

\tilde{s} H=s(\nu H) \text { for all } H \in \mathfrak{h}_{2}^{C} . \tag{3.1}
\end{equation*}
$$

For any $\Lambda \in \mathfrak{F}^{\prime}$ we put

& { }_{+} A_{\Lambda}=\left\{h=\exp H \in A_{2}:\left|e^{(\tilde{\Lambda}+\tilde{\mathcal{Y}})(H)}\right| \leqslant 1\right\},  \tag{3.2}\\
& { }_{-} A_{\Lambda}=\left\{h=\exp H \in A_{2}:\left|e^{(\tilde{\Lambda}+\tilde{\mathcal{P}})(H)}\right|>1\right\} . \tag{3.3}
\end{align*}
$$

Now we define a bounded continuous function $\tilde{\xi}_{\Lambda}^{(2)}$ on $A_{2}$ as follows;

\tilde{\xi}_{\Lambda}^{(2)}(h)=\left\{\begin{array}{lll}
e^{(\tilde{\Lambda}+\tilde{\rho})(H)} & \text { if } & h=\exp H \in{ }_{+} A_{\Lambda},  \tag{3.4}\\
e^{s_{0}(\tilde{\Lambda}+\tilde{\rho})(H)} & \text { if } & h=\exp H \in A_{\Lambda}
\end{array}\right.
$$

where $s_{0}$ denotes the Weyl reflexion $H \rightarrow H-2\left(\alpha_{0}(H) / \alpha_{0}\left(H_{\alpha_{0}}\right)\right) H_{\alpha_{0}}$ on $\mathfrak{h}_{1}^{C}$. We put

$$
\begin{equation*}
\tilde{\xi}_{\Lambda}^{(1)}=\xi_{\Lambda+\rho} . \tag{3.5}
\end{equation*}
$$

For any $s \in W$, we put

$$
\begin{align*}
& \varepsilon_{1}(s)=\varepsilon(s), \\
& \varepsilon_{2}(s)=\left\{\begin{array}{rlll}
-\varepsilon(s) & \text { if } & \left\langle s \rho, \alpha_{0}\right\rangle>0, \\
\varepsilon(s) & \text { if } & \left\langle s \rho, \alpha_{0}\right\rangle<0,
\end{array}\right. \tag{3.6}
\end{align*}
$$

where $\varepsilon(s)$ denotes the constant which is uniquely determined by

\Delta_{1}(\exp s H)=\varepsilon(s) \Delta_{1}(\exp H) \quad \text { for all } \quad H \in \mathfrak{h}_{1}
$$

For any $\Lambda \in \mathfrak{F}_{0}$ we define

\begin{equation*}
\eta_{\Lambda}^{(k)}(h)=\sum_{s \in W} \varepsilon_{k}(s) \tilde{\xi}_{\left.\Lambda^{( }\right)}^{(k)}(h) \quad \text { for } \quad h \in A_{k} \quad(k=1,2), \tag{3.7}
\end{equation*}
$$

where $\Lambda^{s}=s(\Lambda+\rho)-\rho$.
Proposition 2. Let

$$
\begin{equation*}
T_{\Lambda}(f)=(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}(h) F_{f}^{(k)}(h) d h \quad\left(f \in C_{c}^{\infty}(G)\right) \tag{3.8}
\end{equation*}
$$

Then $T_{\Lambda}$ is an invariant distribution on $G$. Moreover $T_{\wedge}$ is an eigendistribution of 3 on $G^{\prime}$.

Proof. Since $\eta_{\Lambda}^{(k)}$ is continuous on $A_{k}$, making use of Lemma 2, we can easily show that $T_{\Lambda}$ is a distribution. Moreover, from the definition of $F_{f}^{(k)}$, we have

F_{f g}^{(k)}=F_{f}^{(k)} \quad(g \in G),
$$

for all $f \in C_{c}^{\infty}(G)$.
Therefore from (3.8) we have

T_{\Lambda}\left(f^{g}\right)=T_{\Lambda}(f) \quad(g \in G)
$$

for all $f \in C_{c}^{\infty}(G)$. Hence $T_{\Lambda}$ is an invariant distribution. For any $\Delta \in 3$ and $f \in C_{c}^{\infty}\left(G^{\prime}\right)$, we have

\left(\Delta T_{\Lambda}\right)(f) & =T_{\Lambda}\left(\Delta^{*} f\right)  \tag{3.9}\\
& =(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}(h) F_{\Delta * f}^{(k)}(h) d h \\
& =(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}(h) F_{f}^{(k)}\left(h ; \gamma_{k}\left(\Delta^{*}\right)\right) d h \\
& =(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}(h) F_{f}^{(k)}\left(h ; \gamma_{k}(\Delta)^{*}\right) d h \\
& =(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}\left(h ; \gamma_{k}(\Delta)\right) F_{f}^{(k)}(h) d h
\end{align*}
$$

In the above deduction, we made use of Lemma 3 and 4. From Lemma 4 , we can easily deduce that

\gamma_{k}(\Delta) \tilde{\xi}_{\Lambda^{s}}^{(k)}=\left\langle\Lambda+\rho, \gamma_{1}(\Delta)\right\rangle \tilde{\xi}_{\Lambda^{s}}^{(k)} \text { for all } s \in W \tag{3.10}
\end{equation*}
$$

Since $\left\langle\tilde{\Lambda}+\tilde{\rho}, \gamma_{2}(\Delta)\right\rangle=\left\langle\Lambda+\rho, \gamma_{1}(\Delta)\right\rangle$ and $s \gamma_{1}(\Delta)=\gamma_{1}(\Delta)(s \in W)$. It follows from (3.7), (3.9) and (3.10) that

This completes the proof of the proposition.
Now we assume that $G$ satisfies the additional condition (A.5) (see Introduction).

converges absolutely.
Proof. By the assumption (A.5), there exists for any $\Lambda \in \mathfrak{F}_{0}$ a finite number of irreducible unitary representations $\omega_{\AA}^{(1)}, \cdots, \omega_{\AA}^{(s)}$ of $G$ such
that

\end{equation*}

where $T_{\Lambda}^{(k)}$ denotes the character of $\omega_{\Lambda}^{(k)}(k=1, \cdots, s)$. We may assume that $\omega_{\Lambda}^{(1)}, \cdots, \omega_{\Lambda}^{(s)}$ are not mutually equivalent.

Take any $f \in C_{c}^{\infty}\left(G^{\prime}\right)$. Then from Proposition 2, there exists a homomorphism $\chi_{\Lambda}$ of 3 in $C$ such that

T_{\Lambda}\left(\Delta^{*} f\right)=\chi_{\Lambda}(\Delta) T_{\Lambda}(f) \quad(\Delta \in \mathbb{Z}) \tag{3.13}
\end{equation*}

On the other hand, we have

T_{\Lambda}^{(k)}\left(\Delta^{*} f\right)=\chi_{\Lambda}^{(k)}(\Delta) T_{\Lambda}^{(k)}(f) \quad(\Delta \in \mathbb{Z}), \tag{3.14}

where $\chi_{\Lambda}^{(k)}$ is the infinitesimal character of $\omega_{\Lambda}^{(k)}$.
From (3.12), (2.13) and (3.14) we get

\sum_{k=1}^{s}\left(\chi_{\Lambda}^{(k)}(\Delta)-\chi_{\Lambda}(\Delta)\right) T_{\Lambda}^{(k)}(f)=0 \quad(\Delta \in \mathfrak{Z})
$$

Therefore from Lemma 1, we can show (see [3 (c)]) that

\chi_{\Lambda}^{(k)}(\Delta)=\chi_{\Lambda}(\Delta) \quad(\Delta \in \mathcal{B}) \quad(k=1, \cdots, s)
$$

Now let $f$ be an element of $C_{c}^{\infty}(G)$. Then we have

\Delta T_{\Lambda}(f)=T_{\Lambda}\left(\Delta^{*} f\right) & =\sum_{k=1}^{s} T_{\Lambda}^{(k)}\left(\Delta^{*} f\right)=\sum_{k=1}^{s} \chi_{\Lambda}^{(k)}(\Delta) T_{\Lambda}^{(k)}(f)  \tag{3.15}\\
& =\sum_{k=1}^{s} \chi_{\Lambda}(\Delta) T_{\Lambda}^{(k)}(f)=\chi_{\Lambda}(\Delta) T_{\Lambda}(f)
\end{align*}
$$

Hence $T_{\Lambda}$ is an eigendistribution of 3 on $G$.
Let $C$ be the Casimir operator on $G$. Then from (3.11) and (3.15) we have

\chi_{\Lambda}(C)=\left\langle\Lambda+\rho, \gamma_{1}(C)\right\rangle . \tag{3.16}
\end{equation*}
$$

On the other hand from (3.8) we have

\left|T_{\Lambda}(f)\right| & \leqslant \sum_{k=1}^{2} \int_{A_{k}}\left|\eta_{\Lambda}^{(k)}(h)\right| \cdot\left|F_{f}^{(k)}(h)\right| d h \\
& \leqslant w \sum_{k=1}^{2} \int_{A_{k}}\left|F_{f}^{(k)}(h)\right| d h<\infty
\end{aligned}
$$

where $w$ is the order of the Weyl group $W$.
The convergence of the integral follows from (1) in Lemma 3. Put

M_{f}=w \sum_{k=1}^{2} \int_{A_{k}}\left|F_{f}^{(k)}(h)\right| d h
$$

Then $M_{f}$ is independent of $\Lambda$ and

\left|T_{\Lambda}(f)\right| \leqslant M_{f} \tag{3.17}
\end{equation*}
$$

Since $\gamma_{1}(C)$ is a differential operator of elliptic type, we can find integers $l, m$ such that

& |\langle\Lambda+\rho, \pi\rangle| \leqslant \mid\left\langle\Lambda+\rho,\left.\gamma_{1}(C)\right|^{l}\right. \text { and }  \tag{3.18}\\
& \sum_{\Lambda \in \tilde{F}} \frac{1}{\left.\left\langle\Lambda+\rho, \gamma_{1}(C)\right\rangle\right|^{m}}<\infty  \tag{3.19}\\
& \tilde{F}=\left\{\Lambda \in \mathfrak{F}_{0}:\left\langle\Lambda+\rho, \gamma_{1}(C)\right\rangle \neq 0\right\} \text {. }
\end{align*}
$$

where
Therefore, from (3.15) (3.18) we have

\begin{align*}
|\langle\Lambda+\rho, \pi\rangle| \cdot\left|T_{\Lambda}(f)\right|= & |\langle\Lambda+\rho, \pi\rangle| \cdot\left|\frac{T_{\Lambda}\left(C^{l+m} f\right)}{\chi_{\Lambda}\left(C^{l+m}\right)}\right|  \tag{3.20}\\
& \leqslant \frac{|\langle\Lambda+\rho, \pi\rangle|}{\left|\left\langle\Lambda+\rho, \gamma_{1}(C)\right\rangle\right|^{l}} \cdot \frac{\left|T_{\Lambda}\left(C^{l+m} f\right)\right|}{\left|\left\langle\Lambda+\rho, \gamma_{1}(C)\right\rangle\right|^{m}} \\
& \leqslant \frac{M_{C^{l+m_{f}}}}{\left.\left\langle\Lambda \Lambda+\rho, \gamma_{1}(C)\right\rangle\right|^{m}} .
\end{align*}
$$

It is easy to see that $\mathfrak{F}_{0}-\widetilde{\mathfrak{F}}$ is a finite set. It follows from (3.19) and (3.20) that

First we define $\xi_{\Lambda}^{(1)}$, $\eta_{\Lambda}^{(1)}$ also by (3.5), (3.7) respectively.
Then we have

& { }_{-} A_{2}=\left\{h=\exp H \in A_{2}:\left|e^{\alpha_{0}(H)}\right|<1\right\} .
\end{aligned}
$$

For any $\Lambda \in \mathfrak{F}$ such that $\left\langle\Lambda+\rho, \alpha_{0}\right\rangle=0$, we define

{ }_{+} A_{\Lambda}={ }_{+} A_{2} \quad \text { and } \quad{ }_{-} A_{\Lambda}={ }_{-} A_{2}
$$

On the other hand, for any $\Lambda \in \mathfrak{F}$ such that $\left\langle\Lambda+\rho, \alpha_{0}\right\rangle \neq 0$, we define ${ }_{+} A_{\Lambda},{ }_{-} A_{\Lambda}$ again by (3.2), (3.3) respectively. We define $\tilde{\xi}_{\Lambda}^{(2)}$ also by (3.4). For any $\Lambda \in \mathfrak{F}$ such that $\Lambda+\rho \in \mathfrak{F}_{0}$ we define $\eta_{\Lambda}^{(2)}$ and $T_{\Lambda}$ again by (3.7), (3.8) respectively. Finally for any $\Lambda \in \mathfrak{F}$ we define

T_{\Lambda}=T_{\Lambda_{1}}
$$

where $\Lambda_{1}$ is a unique element of $\mathfrak{F}$ such that

\Lambda_{1}+\rho \in \mathfrak{F}_{0} \quad \text { and } \quad \Lambda^{s}=\Lambda_{1} \quad \text { for some } \quad s \in W
$$

It is easy to see that

T_{\Lambda} s=T_{\Lambda} \text { for all } s \in W \text { and } \quad \Lambda \in \mathfrak{F}
$$

The following proposition is a direct consequence of Proposition 3.
Proposition 3'. The series

\sum_{\Lambda \in \mathfrak{F}}|\langle\Lambda+\rho, \pi\rangle| T_{\Lambda}(f) \quad\left(f \in C_{c}^{\infty}(G)\right)
$$

converges absolutely.
For the proof, we have only to notice that $\mathfrak{F}^{\prime}=\left\{\Lambda^{s}: \Lambda \in \mathfrak{F}_{0}, s \in W\right\}$ and that $\langle\Lambda+\rho, \pi\rangle=0$ for all $\Lambda \in \mathfrak{F}-\mathfrak{F}^{\prime}$.

Now for any $\Lambda \in \mathfrak{F}$, we define

\xi_{\Lambda}^{(2)}(h)=\left\{\begin{array}{rll}
\tilde{\xi}_{\Lambda}^{(2)}(h) & \text { if } & h \in_{+} A_{2},  \tag{3.21}\\
-\tilde{\xi}_{\Lambda}^{(2)}(h) & \text { if } & h \in{ }_{-} A_{2},
\end{array}\right.
$$

and

\begin{equation*}
\widetilde{\boldsymbol{\eta}}_{\Lambda}^{(k)}(h)=\sum_{s \in W} \xi_{\Lambda}^{(k)}(h) \quad \text { for } \quad h \in A_{k} \quad(k=1,2), \tag{3.22}
\end{equation*}
$$

where

\xi_{\Lambda}^{(1)}=\xi_{\Lambda+\rho} .
$$

Theorem 1. For any $\Lambda \in \mathfrak{F}$,

|\langle\Lambda+\rho, \pi\rangle| T_{\Lambda}(f)=(-1)^{n_{+q}} \sum_{k=1}^{2} \int_{A_{k}} \tilde{\eta}_{\Lambda}^{(k)}(h) F_{f}^{(k)}\left(h ; \partial\left(\pi_{k}\right)\right) d h . \tag{3.23}
\end{equation*}
$$

A proof of this theorem will be given in $\S 7$.
We shall now prove some formulas which will be needed in the next section.

Proposition 4. The notation being as in Lemma 6, we have

\sum_{\Lambda \in \mathfrak{F}} \int_{A_{1}} \widetilde{\dddot{\eta}}_{\Lambda}^{(1)}(h) F_{f}^{(1)}(h ; \partial(\pi)) d h=w c(-1)^{n_{+}+q} f(e) \\
\text { for all } f \in C_{c}^{\infty}(G),
\end{array}
$$

where $w$ is the order of the group $W$.
Proof. In the proof of Proposition 1, we have shown that $\mathfrak{h}_{1} / \Gamma \cong A_{1}$, the isomorphism being induced by the exponential mapping. Hence if we put

F\left(\theta_{1}, \theta_{2}, \cdots, \theta_{l}\right)=F_{f}^{(1)}\left(\exp \left(\sum_{i=1}^{l} \sqrt{-1} \theta_{i} H_{i}\right) ; \partial(\pi)\right),
$$

then $F$ is periodic in each of the variables with period $2 \pi$. Therefore if we put $\Lambda=\sum_{i=0}^{l} m_{i} \Lambda_{i}$, then we have

& \int_{A_{1}} \xi_{\Lambda}(h) F_{f}^{(1)}(h ; \partial(\pi)) d h \\
& \quad=\frac{1}{(2 \pi)^{i}} \int_{0}^{2 \pi} \cdots \int_{0}^{2 \pi} F\left(\theta_{1}, \theta_{2}, \cdots, \theta_{l}\right) e^{\sum_{i=1}^{l} \sqrt{-1} m_{i} \theta_{i}} d \theta_{1} d \theta_{2} \cdots d \theta_{l}
\end{aligned}
$$

From (1) in Lemma 3, we easily see that $F$ is piecewise smooth in each of the variables $\theta_{i}(i=1,2, \cdots, l)$. It follows from the theory of Fourier series and Lemma 6 that the series

& \sum_{\Lambda \in \mathscr{F}} \int_{A_{1}} \xi_{\Lambda}(h) F_{f}^{(1)}(h: \partial(\pi)) d h \\
& =\sum_{m_{1}, \cdots, m_{l}} \frac{1}{(2 \pi)^{l}} \int_{0}^{2 \pi} \cdots \int_{0}^{2 \pi} F\left(\theta_{1}, \cdots, \theta_{l}\right) e^{\sum_{i=1}^{1} \sqrt{1-m_{i}} \theta_{i}} d \theta_{1} \cdots d \theta_{l} \tag{3.24}
\end{align*}
$$

converges absolutely to

$$
\begin{aligned}
\lim _{\left(\theta_{1}, \ldots \theta_{l}\right) \rightarrow(0, \ldots, 0)} F\left(\theta_{1}, \cdots, \theta_{l}\right) & =\lim _{h \rightarrow e} F_{f}^{(1)}(h ; \partial(\pi)) \\
& =c(-1)^{n_{+} q} f(e) .
\end{aligned}
$$

Therefore from the absolute convergence of (3.24) we have

& =\sum_{\Lambda \in \mathfrak{F}} \sum_{s \in W} \int_{A_{1}} \xi_{\Lambda^{s}}^{(1)}(h) F_{f}^{(1)}(h ; \partial(\pi)) d h \\
& =\sum_{s \in W}\left\{\sum_{\Lambda \in \mathfrak{F}} \int_{A_{1}} \xi_{s(\Lambda+\rho)}(h) F_{f}^{(1)}(h ; \partial(\pi)) d h\right\} \\
& =\sum_{s \in W}\left\{\sum_{\Lambda \in \mathfrak{F}} \int_{A_{1}} \xi_{\Lambda}(h) F_{f}^{(1)}(h ; \partial(\pi)) d h\right\} \\
& =w c(-1)^{n^{+q}} f(e) .
\end{aligned}

In the above deduction, we made use of the fact that $\rho$ is a integral form and that for any $s \in W$ the mapping $\Lambda \rightarrow s \Lambda(\Delta \in \mathfrak{F})$ is a bijection from $\mathfrak{F}$ onto itself. Thus Proposition 4 is proved.

Now we consider the series

Then any $h \in A_{2}$ is written uniquely in the form $h=a_{t} h^{-}\left(t \in R, h^{-} \in A^{-}\right)$. Put $\mathfrak{h}^{+}=\nu \mathfrak{a}$. Then we have $\mathfrak{h}_{1}=\mathfrak{h}^{+}+\mathfrak{h}^{-}$(direct) (see §1).

Let $\hat{\mathfrak{h}}^{+}, \hat{\mathfrak{h}}^{-}, \hat{\mathfrak{h}}_{1}$ denote the vector spaces of all pure imaginary valued linear forms on $\mathfrak{h}^{+}, \mathfrak{G}^{-}, \mathfrak{h}_{1}$ respectively. Since $\mathfrak{h}_{1}=\mathfrak{h}^{+}+\mathfrak{h}^{-}$(direct), we can consider $\hat{\mathfrak{h}}^{+}$and $\hat{\mathfrak{h}}^{-}$as subspaces of $\hat{\mathfrak{h}}_{1}$ so that $\hat{\mathfrak{h}}_{1}=\hat{\mathfrak{h}}^{+}+\hat{\mathfrak{h}}^{-}$(direct). For any $\Lambda \in \hat{\mathfrak{h}}_{1}$ we denote by $\Lambda^{+}, \Lambda^{-}$the $\hat{\mathfrak{h}}^{+}, \hat{\mathfrak{h}}^{-}$-component of $\Lambda$ respectively. We put $A^{+}=\exp \mathfrak{G}^{+}$. Then it is clear that $A_{1}=A^{+} A^{-}$and that $D=A^{+} \cap A^{-}$ is a finite group. Let $A_{0}$ be a closed subgroup of $A_{1}$. Then it is well known that the character group $\hat{A}_{0}$ of $A_{0}$ is given by

Select $\Gamma^{+} \in \mathfrak{h}^{+}$and $\Gamma^{-} \in \mathfrak{h}^{-}$ such that $\gamma=\exp \Gamma^{+}=\exp \Gamma^{-}$. For any integer $k(0 \leqslant k<m)$, we put

For any $\Lambda \in \mathfrak{F}$, there exists: an integer $r$ such that $\Lambda^{+}+\rho^{+}=r \Lambda_{0}^{+}$, where $\Lambda_{0}=\frac{1}{2} \alpha_{0}$. It is clear that

This lemma is an immediate consequence of (2) in Lemma 3 and Lemma 7.

From the absolute convergence of the series (3.25), using (3.22) and (3.29), we have

& =w \sum_{k=0}^{m-1} \sum_{\Lambda-\in \mathcal{F}_{k}}\left\{\sum_{\Lambda^{+} \in \mathcal{F}_{k}^{t}} \int_{A_{2}} \xi_{\Lambda}^{(2)}(h) F_{f}^{(2)}\left(h ; \partial\left(\pi_{2}\right)\right) d h\right\} \\
& \left.=2 w \sum_{k=0}^{m-1} \sum_{-\in \mathcal{F}_{k}^{-}} \int_{0}^{\infty} \int_{A^{-}} \frac{\operatorname{ch}((m-2 k) t / 2)}{\operatorname{sh}(m t / 2)} e^{\left(\boldsymbol{\Lambda}^{-}+\rho^{-}\right)\left(H^{-}\right)} F_{f^{(2)}\left(a_{t} h^{-}\right.} ; \partial\left(\pi_{2}\right)\right) d t d h^{-} \\

Remark 1. It is plausible that a simple Lie group $G$ satisfies always the condition (A.5) whenever it satisfies the conditions (A.1)~(A.4).

Remark 2. We shall prove in $\S 5$ that the order $m$ of the cyclic group $D=A^{+} \cap A^{-}$is equal to 2 .

## 4. Main theorem

Let $\mathfrak{m}$ be the centralizer of $\mathfrak{a}$ in $\mathfrak{t}$ and let $M$ be the corresponding analytic subgroup of $G$. Then it is easy to see that $\mathfrak{h}^{-}$is a Cartan subalgebra of m and that $A^{-}$is a Cartan subgroup of $M . \quad P_{2}^{-}$is naturally identified with the set of all positive roots of $\mathfrak{m}^{c}$ with respect to $\left(\mathfrak{h}^{-}\right)^{C}$ under some linear order.

For any $\Lambda^{-} \in \mathfrak{F}^{-}$we put

Take a $\Lambda^{-} \in \mathfrak{F}^{-}$such that $\left\langle\Lambda^{-}+\rho^{-}, \pi^{-}\right\rangle$ $\neq 0$. Then it is known that there exists an irreducible unitary representation $\delta_{\Lambda^{-}}$of $M$ whose character $\zeta_{\Lambda^{-}}$is given by the following formula;

For each $\alpha \in P_{2}$ let $X_{\infty}$ be an element of $\mathrm{g}^{c}$ such that $X_{\alpha} \neq 0$ and $\left[H, X_{\alpha}\right]=\alpha(H) X_{\alpha}$ for all $H \in \mathfrak{b}_{2}^{C}$. Then from the assumption for the
order intronduced in $\Sigma_{2}$, we can show that

For a non zero real number $\lambda$ and $\Lambda^{-} \in \mathfrak{F}^{-}$such that $\left\langle\Lambda^{-}+\rho^{-}, \pi^{-}\right\rangle \neq 0$, we define the irreducible unitary representation $L_{\lambda, \Lambda^{-}}$of the group $M A N$ by

Let $\omega_{\lambda, \Lambda^{-}}$denote the unitary representation of $G$ induced by the representation $L_{\lambda, \Lambda^{-}}$of MAN (see [2]). The following formula for the character $T_{\lambda, \Lambda^{-}}$of the representation $\omega_{\lambda, \Lambda^{-}}$is due to Harish-Chandra (see [3(b)]).

To prove this lemma, we have only to notice that $\zeta_{\left(\Lambda^{-}\right)_{0} s_{0}} \zeta_{\Lambda^{-}}$and $c=1$ in Theorem 2 of [3(b)].

Moreover this series converges absolutely and uniformly with respect to $\lambda$.

By a complex root $\alpha$, we mean a root $\alpha$ in $\Sigma_{2}$ such that $\alpha(\mathfrak{a}) \neq(0)$ and $\alpha\left(\mathfrak{h}^{-}\right) \neq(0)$. It is easy to see that for any $\alpha \in P_{2}^{+},{ }^{t} \sigma \alpha=\alpha$ if and only if $\alpha=\tilde{\alpha}_{0}$. Since ${ }^{t} \sigma P_{2}^{+}=P_{2}^{+}$, it follows that the number $r$ of all complex roots in $P_{2}$ is even. Moreover there exists a subset $P_{2}^{\prime}$ of $P_{2}^{+}-\left\{\tilde{\alpha}_{0}\right\}$ such that ${ }^{t} \sigma P_{2}^{\prime} \cap P_{2}^{\prime}=\phi$ and $P_{2}^{+}-\left\{\widetilde{\alpha}_{0}\right\}={ }^{t} \sigma P_{2}^{\prime} \cap P_{2}^{\prime}$.

Now we shall prove that

This formula is valid for a real number $a$ such that $0<a<m$, in particular for $a=k(0<k<m)$. Since $T_{\lambda, \Lambda^{-}}(f)$ is a Fourier transform of a function of class $C^{\infty}$ with the compact support, it follows that the integral on the right hand side in (4.11) is convergent uniformly for sufficiently small $a$. In view of Lemma 8 similar statements hold for the left hand side in (4.11). Tending $a$ to zero, we conclude that the equality (4.11) is valid also for $a=0$. Hence the equality (4.11) is valid for all integers $a=k$ such that $0 \leqslant k<m$. Therefore from Proposition 5 we have

Now let $\Omega$ denote the set of all equivalence classes of irreducible unitary representations of $M$. Then it is well known that the correspondence $\Lambda^{-} \rightarrow \delta_{\Lambda^{-}}\left(\Lambda^{-} \in \mathfrak{F}_{0}^{-}\right)$is a bijection of $\mathfrak{F}_{0}^{-}$onto $\Omega$.

Remark 3. With a slight modification, our method can be applied also to $\boldsymbol{S L}(2, \boldsymbol{R})$ which does not satisfy the condition (A.4) (see §5).

Remark 4. It is instructive to compare (4.14), (4.15) with the formula for the formal degree given by Harish-Chandra (see [3(e)] p. 612).
5. Some consequences of (A.1), (A.2) and (A.3)

In this section we shall make use of the notation of $\S 1$ and [4] without further comment.

Let $G$ be a simple Lie group which satisfies the conditions (A.1), (A.2) and (A.3). It is known that the Lie algebra $g$ of such a group is one of the types $\mathfrak{H u t}(l, 1)(l \geqslant 1), \mathfrak{s o}(2 l, 1)(l \geqslant 2), \mathfrak{g}(l-1,1)(l \geqslant 2)$ and FII (see [8]). The diagrams of the complexifications $\mathrm{g}^{c}$ of these Lie algebras are as follows;
( I ) $\mathfrak{s u}(l, 1)$

(II) $\operatorname{son}_{0}(2 l, 1)$

(III) $\mathfrak{~} \mathfrak{p}(l-1,1)$

(IV) FII


In these diagrams the white vertex $\bigcirc$ denotes the unique non compact simple root of $\mathfrak{g}^{c}$ with respect to $\mathfrak{h}_{1}^{c}$ under a certain linear order. From these diagrams we see easily that

Therefore the value of $\alpha_{1}$ at $H=2 \pi \sqrt{-1} \sum_{i=1}^{i} a_{i} H_{i}$ in $\mathfrak{h}_{1}$ is equal to $\alpha_{1}(H)=2 \pi \sqrt{-1}\left(2 a_{1}-a_{2}\right)$. It follows that in the case of rank $G \geqslant 2$,

Put $\tilde{\mathfrak{h}}_{2}=\sqrt{-1} \boldsymbol{R} U_{\omega_{1}}+\tilde{\mathfrak{h}}^{-}$. Then $\tilde{\mathfrak{h}}_{2}$ is a Cartan subalgebra of g which is not conjugate to $\mathfrak{h}_{1}$ (c.f. §1). Let $\widehat{A}_{2}$ be the Cartan subgroup corresponding to $\tilde{\mathfrak{h}}_{2}$. Then from (A.3) $A_{2}$ is connected if and only if $\widehat{A}_{2}$ is connected.

Proposition 7. Let g be one of the above types (I), (II) and (III).

Then every Cartan subgroup of $G$ is connected if and only if rank $G \geqslant 2$.
Proof. In view of (A.1), in the cases (I), (III) we have $G=\boldsymbol{S} \boldsymbol{U}(l, 1)$ or $\boldsymbol{S}_{\boldsymbol{p}}(l-1,1)$. The proposition is verified immediately in these cases. In the case (II), $G$ is a proper covering group of the identity component $\boldsymbol{S \boldsymbol { O } _ { 0 }}(2 l, 1)$ of $\boldsymbol{S O}(2 l, 1)$ and

where $Z$ is the center of $G$.
We remark that every Cartan subgroup of $\mathbf{S O}_{0}(2 l, 1)(l \geqslant 2)$ is connected. On the other hand it is clear that $\widehat{A}^{-}=\exp \widetilde{\mathfrak{G}}^{-} \subset\left(\widetilde{A}_{2}\right)_{0}$, where $\left(\widetilde{A}_{2}\right)_{0}$ is the connected component of $\widehat{A}_{2}$. Therefore, if we show

it follows from (5.3) that $\widehat{A}_{2}=\left(\widehat{A}_{2}\right)_{0} Z=\left(\widehat{A}_{2}\right)_{0}$, which proves that $\widehat{A}_{2}$ is connected. Since compact Cartan subgroups are connected (see $\S 1$ ), this will prove Proposition 7.

Now we come to the proof of (5.4). Let $z \in Z$. Then from the definition of $A_{1}$ we have $z \in A_{1}$. Suppose $H=2 \pi \sqrt{-1} \sum_{i=1}^{i} c_{i} H_{i} \in \mathfrak{h}_{1}$ be such that $z=\exp H$. Then $\alpha_{1}(H)$ is an integral multiple of $2 \pi \sqrt{-1}$, that is, there exists an integer $l$ such that $2 c_{1}-c_{2}=l$ (see (5.1)). Since $\exp \left(2 \pi \sqrt{-1} H_{2}\right)$ is the identity element of $G$ (see $\S 1$ ), it follows that $\exp H=\exp \left(2 \pi \sqrt{-1}\left(c_{1} H_{1}+2 c_{1} H_{2}+\sum_{i=3}^{i} c_{i} H_{i}\right)\right)$. In view of (5.2), the right hand side belongs to $\widehat{A}^{-}=\exp \tilde{\mathfrak{h}}^{-}$. This proves (5.4) and so Proposition 7.

Proposition 8. Under the assumptions (A.1), (A.2) and (A.3) put $\mathfrak{h}^{+}=\sqrt{-1} \boldsymbol{R} H_{1}$, and $A^{+}=\exp \mathfrak{h}^{+}$. Then the order $m$ of the cyclic group $D=A^{+} \cap A^{-}$is equal to 2 if and only if rank $G \geqslant 2$. Moreover, $D$ consists of the elements $\exp \left(k \pi \sqrt{-1} H_{1}\right)(k=0,1)$.

Proof. Since $\alpha_{0}$ was arbitrary fixed non compact root in $\Sigma_{1}$, we may assume $\alpha_{0}=\alpha_{1}$ by changing the order introduced $\Sigma_{1}$ if necessary. "Only if" part of the proposition is trivial. So we assume that rank $G \geqslant 2$. Suppose that $\exp H^{+}=\exp H^{-}\left(H^{+} \in \mathfrak{h}^{+}, H^{-} \in \mathfrak{h}^{-}\right)$. Then $H^{+}-H^{-} \in \Gamma$ (see §1). On the other hand it follows from (5.2) that

H^{+}=2 \pi \sqrt{-1} a H_{1}, \quad H^{-}=2 \pi \sqrt{-1}\left(a_{1} H_{1}+2 a_{1} H_{2}+\sum_{i=3}^{l} a_{i} H_{i}\right),

where $a, a_{1}, a_{3}, \cdots, a_{l}$ are real numbers (see $\S 3$ ). Therefore, in order that $H^{+}-H^{-} \in \Gamma$, it is necessary and sufficient that $a-a_{1}, 2 a_{1}, a_{3}, \cdots, a_{\ell}$ are
integers. From this, it follows that $D$ consists of the elements

Thus Proposition 8 is proved.
Making use of Proposition 8, we obtain the following improved version of Theorem 2.

Theorem 2'. Let $G$ be a simple Lie group which satisfies the conditions (A. 1)~(A.5).

Then the Haar measure of $G$ can be so normalized that

## 6. Universal covering group of De Sitter group

In this section we shall prove that the formula of Theorem 2 actually gives the explicit Plancherel formula for the universal covering group $G$ of De Sitter group. Let $\boldsymbol{Q}$ be the usual quaternion field. For any $q \in \boldsymbol{Q}$ let $\bar{q}$ denote the conjugate quaternion of $q$. The field of complex numbers $\boldsymbol{C}$ can be canonically identified with a subfield of $\boldsymbol{Q}$. Let $G$ be the group of all matrices $g$ of degree 2 with coefficients in the quaternion field, satisfying the condition;

where $\sigma=\left(\begin{array}{rr}1 & 0 \\ 0 & -1\end{array}\right)$ and $g^{*}=\left(\begin{array}{ll}\bar{a} & \bar{c} \\ \bar{b} & \bar{d}\end{array}\right)$ if $g=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right)$. Then $G$ is isomorphic to the universal covering group of De Sitter group (see [9 (b)]). It follows that $G$ satisfies the conditions (A.1) $\sim(A .4)$ (see $\S 5$ ). We put

Then $A_{1}$ and $A_{2}$ are the non conjugate Cartan subgroups of $G$. Every Cartan subgroup of $G$ is conjugate with either $A_{1}$ or $A_{2}$ (see [8]). The Lie algebra of $A_{1}$ is

Then if $l$ and $m$ are both non negative integers, $n$ and $p$ are half integers such that $n \geqslant p \geqslant 1$ and $n-p \in \boldsymbol{Z}$. Moreover we have

For any $\Lambda=l \Lambda_{1}+m \Lambda_{2} \in \mathfrak{F}_{0}$, we define

representations $T^{n, 0, p}, T^{0, n, p}$ and $U^{n, 3 / 2+i v}$ respectively. Then

under the normalization of the Haar mearure of $G$ that is introduced in [9 (b)].

This formula was conjectured by R. Takahashi in [9(b)] (p.432).
Remark 5. As far as the author knows, the explicit character formulas of the representations $T^{n, 0, p}$ and $T^{0, n, p}$ are not known although the character of the representation $T^{n, 0, p} \oplus T^{0, n, p}$ is known (see (6.1), (6.2)). As we saw above, in order to obtain the explicit Plancherel formula, it is sufficient for us only to know the character of the representation $T^{n, 0, p} \oplus T^{0, n, p}$. These facts suggest that it is natural to consider the character $T_{\Delta}$ which is the sum of the characters of irreducible unitary representations having the same infinitesimal and central character (see the proof of Proposition 3).

Remark 6. There are some misprints in the character formulas given in [6]. The correct formulas should be (6.1) and (6.2). Other misprints in [6] are as follows; p. 24, line 12, read " $+\frac{1}{4} \ldots$ " instead of " $-\frac{1}{4} \ldots$ "; p. 26, line 16, read "Lemma 2" instead of "Theorem 1", line 19 , read " $-H_{0} H_{2}\left(H_{0}^{2}-H_{2}^{2}\right)$ " instead of " $H_{0} H_{2}\left(H_{0}^{2}-H_{2}^{2}\right)$ ".

## 7. Proof of Theorem 1

In this section we shall give a proof of Theorem 1. In view of the definition of $T_{\Lambda}$, it is sufficient to prove the theorem when $\Lambda+\rho \in \mathfrak{F}_{0}$. Let $\alpha_{1}, \alpha_{2}, \cdots, \alpha_{n}$ be all the distinct roots in $P_{1}$. Then $P_{2}=\left\{\tilde{\alpha}_{1}, \tilde{\alpha}_{2}, \cdots, \widetilde{\alpha}_{n}\right\}$. Put

&\left.\left.+\int_{+A_{2}} \tilde{\xi}_{\Lambda^{s}}^{(2)}(h) F_{f}^{(2)}\left(h ; \partial\left(\pi_{2}\right)\right) d h-\int_{-A_{2}} \tilde{\xi}_{\Lambda^{(2)}(h)}^{(2)} F_{f}^{(2)}\left(h ; \partial \pi_{2}\right)\right) d h\right\}
\end{aligned}
$$

(see (§3)). From the definition of $\widetilde{\eta}_{A}^{(k)}(k=1,2)$, Theorem 1 is now obvious.

Now we come to the proof of $\left(P_{r}\right)(0 \leqslant r \leqslant n)$. Again making use of Lemma 11, we can show that ( $P_{0}$ ) is equivalent to

$$
T_{\Lambda}(f)=(-1)^{q} \sum_{k=1}^{2} \int_{A_{k}} \eta_{\Lambda}^{(k)}(h) F_{f}^{(k)}(h) d h .
$$

Since this is valid from the definition of $T_{\Lambda}$, our assertion follows immediately for $r=0$. Assume now that $\left(P_{r}\right)$ is valid for some $r(0 \leqslant r<n)$. It is easy to see that $\left\langle\Lambda+\rho, \alpha_{r+1}\right\rangle e^{s(\Lambda+\rho)(H)}=\left\langle s(\Lambda+\rho), s \alpha_{r+1}\right\rangle e^{s(\Lambda+\rho)(H)}$ $=\partial\left(s \alpha_{r+1}\right) e^{s(\Lambda+\rho)(H)},\left\langle\Lambda+\rho, \alpha_{r+1}\right\rangle e^{\tilde{s}(\tilde{\Lambda}+\tilde{\beta})(H)}=\left\langle\tilde{s}(\tilde{\Lambda}+\tilde{\rho}), \tilde{s} \tilde{\alpha}_{r+1}\right\rangle e^{\tilde{s}(\tilde{\Lambda}+\tilde{\rho})(H)}=\partial\left(\tilde{s} \tilde{\alpha}_{r+1}\right)$ $e^{\xi_{( }(\bar{\Lambda}+\tilde{\rho})(H)}$. Hence multiplying the both sides of $\left(P_{r}\right)$ by $\left\langle\Lambda+\rho, \alpha_{r+1}\right\rangle$, we get

$$
\begin{align*}
\langle\Lambda & \left.+\rho, p_{r+1}\right\rangle T_{\Lambda}\left(f^{\prime}\right)  \tag{7.1}\\
& =(-1)^{r+q} \sum_{s \in W}\left\{\varepsilon(s) \int_{A_{1}}\left[\partial\left(s \alpha_{r+1}\right) e^{s(\Lambda+\rho)(H)}\right] F_{f}^{(1)}\left(h ; \partial\left(s p_{r}\right)\right) d h\right. \\
& \left.+2 \varepsilon_{2}(s) \int_{+} A_{\Lambda^{s}}\left[\partial\left(\tilde{s} \tilde{\alpha}_{r+1}\right) e^{\tilde{s}(\tilde{\Lambda}+\tilde{\beta})(H)}\right] F_{f}^{(2)}\left(h ; \partial\left(\tilde{s} \tilde{p}_{r}\right)\right) d h\right\} \\
& =(-1)^{r+1+q} \sum_{s \in W}\left\{\varepsilon(s) \int_{A_{1}} e^{s(\Lambda+\rho)(H)} F_{f}^{(1)}\left(h ; \partial\left(s p_{r+1}\right)\right) d h\right. \\
& \left.+2 \varepsilon_{2}(s) \int_{+A_{\Lambda^{s}}} e^{\tilde{s}(\tilde{\Lambda}+\tilde{\beta})(H)} F_{f}^{(2)}\left(h ; \partial\left(\tilde{s} \tilde{p}_{r+1}\right)\right) d h\right\} \\
& +(-1)^{r+q} \sum_{s \in W}\left\{\varepsilon(s) \int_{A_{1}} \partial\left(s \alpha_{r+1}\right)\left[e^{s(\Lambda+\rho)(H)} F_{f}^{(1)}\left(h ; \partial\left(s p_{r}\right)\right)\right] d h\right. \\
& \left.\left.+2 \varepsilon_{2}(s) \int_{+A_{\Lambda^{s}}} \partial\left(\tilde{s} \tilde{\alpha}_{r++1}\right)\left[e^{\tilde{s}(\tilde{\Lambda}+\tilde{\rho})(H)} F_{f}^{(2)}\left(h ; \partial \tilde{s} \tilde{p}_{r}\right)\right)\right] d h\right\} .
\end{align*}
$$

Put

$$
\begin{aligned}
& J_{\Lambda}^{(1)}=\sum_{s \in W} \varepsilon(s) \int_{A_{1}} \partial\left(s \alpha_{r+1}\right)\left[e^{s(\Lambda+\rho)(H)} F_{f}^{(1)}\left(h ; \partial\left(s p_{r}\right)\right)\right] d h, \\
& J_{\Lambda}^{(2)}=\sum_{s \in W} 2 \varepsilon_{2}(s) \int_{+A_{\Lambda^{s}}} \partial\left(\tilde{s}^{\tilde{\alpha}_{r+1}}\right)\left[e^{z_{(\tilde{\Lambda}+\tilde{\beta}}(\boldsymbol{H})} F_{f}^{(2)}\left(h ; \partial\left(\tilde{s} \tilde{p}_{r}\right)\right)\right] d h .
\end{aligned}
$$

Then the validity of $\left(P_{r+1}\right)$ is equivalent to $J_{\Lambda}^{(1)}+J_{\Lambda}^{(2)}=0$. In order to prove that $J_{\Lambda}^{(1)}+J_{\Lambda}^{(2)}=0$, we need more precise informations about $J_{\Lambda}^{(1)}$ and $J_{\Lambda}^{(2)}$.

First we consider $J_{\Lambda}^{(1)}$. For any $\alpha \in P_{1}^{0}$, put $\sigma_{\alpha}=\left\{h=\exp H \in A_{1}\right.$ : $\alpha(H) \in 2 \pi \sqrt{-1} \boldsymbol{Z}\}$. It is easy to see that $P_{1}^{0}$ is exactly the set of all positive singular roots in $\Sigma_{1}$ (see [3(h)] for the definition of a singular root).

Put $F^{(1)}(h: s)=F_{f}^{(1)}\left(h ; \partial\left(s p_{r}\right)\right)$. Then by making use of (1) in Lemma 3 we have the following (c.f. [3(h)]).

$$
\begin{equation*}
J_{\Lambda}^{(1)}=\sqrt{-1} \sum_{s \in W} \sum_{\alpha \in P_{1}^{0}} \frac{\varepsilon(s)\left\langle\alpha, s \alpha_{r+1}\right\rangle}{\sqrt{\alpha\left(H_{a}\right)}} \int_{\sigma_{a}} e^{s(\Lambda+\rho)(H)} F_{\alpha}^{(1)}(h: s) d \sigma_{a} \tag{7.2}
\end{equation*}
$$

where
$F_{\alpha}^{(1)}(h: s)=\lim _{\varepsilon \rightarrow+0}\left\{F^{(1)}\left(\exp \left(H+\varepsilon \sqrt{-1} H_{a}\right): s\right)-F^{(1)}\left(\exp \left(H-\varepsilon \sqrt{-1} H_{a}\right): s\right)\right\}$, (this limit always exists from (1) in Lemma 3). In this formula $d \sigma_{\infty}$ denotes the canonical Lebesgue measure induced by $d h$ on $\sigma_{a}$. Let $W_{K}$ denote the set of all elements $t \in W$ such that $\operatorname{Ad}(k) \mid \mathfrak{h}_{1}=t$ for some $k \in K$. Then for any $\alpha \in P_{1}^{0}$, there exists an element $t \in W_{K}$ such that $t \alpha_{0}=\alpha$. For each $\alpha \in P_{1}^{0}$, we fix such an element $t$ and denote it by $t_{c c}$. Then by definition, there exists an element $k \in K$ such that $\operatorname{Ad}(k) \mid \mathfrak{h}_{1}=t_{\infty}$. We also fix such an element $k$ and denote it by $k_{a}$. Then we have

$$
\begin{aligned}
& F_{f}^{(1)}\left(\exp \left(t_{\infty} H_{t} \pm \varepsilon \sqrt{-1} H_{\alpha}\right) ; \partial\left(s p_{r}\right)\right) \\
&=F_{f}^{(1)}\left(k_{\alpha} \exp \left(H \pm \varepsilon \sqrt{-1} t_{\alpha}^{-1} H_{\alpha}\right) k_{\alpha}^{-1} ; \partial\left(s p_{r}\right)\right) \\
&=\left(F_{f}^{(1)}\right)^{k_{\alpha}-1}\left(\exp \left(\left(H \pm \varepsilon \sqrt{-1} H_{t_{\alpha}{ }^{-1}}\right) ; \partial\left(t_{\alpha}^{-1} s p_{r}\right)\right)\right. \\
& \quad=\varepsilon\left(t_{\alpha}\right) F_{f}^{(1)}\left(\exp \left(H \pm \varepsilon \sqrt{-1} H_{a_{0}}\right) ; \partial\left(t_{\alpha}^{-1} s p_{r}\right)\right) .
\end{aligned}
$$

## Hence

$$
\begin{equation*}
F_{\alpha}^{(1)}\left(k_{\alpha} h k_{\alpha}^{-1}: s\right)=F_{\alpha}^{(1)}\left(\exp t_{\infty} H: s\right)=\varepsilon\left(t_{\alpha}\right) F_{\alpha_{0}}^{(1)}\left(h: t_{\alpha}^{-1} s\right) . \tag{7.3}
\end{equation*}
$$

Moreover it is easy to see that

$$
\begin{equation*}
\alpha\left(H_{a}\right)=\alpha_{0}\left(H_{\alpha_{0}}\right), \quad\left\langle\alpha, s \alpha_{r+1}\right\rangle=\left\langle\alpha_{0}, t_{\alpha}^{-1} s \alpha_{r+1}\right\rangle \tag{7.4}
\end{equation*}
$$

On the other hand, $d \sigma_{a_{0}}$ goes to $d \sigma_{a}$ under the mapping $h \rightarrow k_{a} h k_{\alpha}^{-1}$ which maps $\sigma_{\alpha_{0}}$ onto $\sigma_{\alpha}$.

Therefore it follows from (7.2), (7.3) and (7.4) that

$$
\begin{aligned}
J_{\Lambda}^{(1)} & =\sqrt{-1} \sum_{s \in W} \sum_{\alpha \in P_{1}^{0}} \frac{\varepsilon(s)\left\langle\alpha_{0}, t_{\alpha}^{-1} s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(H_{\alpha_{0}}\right)}} \int_{\sigma_{\alpha_{0}}} e^{s(\Lambda+\rho)\left(t_{\alpha} H\right)} \varepsilon\left(t_{\alpha)}\right) F_{\alpha_{0}}^{(1)}\left(h: t_{\alpha}^{-1} s\right) d \sigma_{\alpha_{0}} \\
& =\sqrt{-1} \sum_{\alpha \in P_{1}^{0}}\left\{\sum_{s \in W} \frac{\varepsilon\left(t_{\alpha}^{-1} s\right)\left\langle\alpha_{0}, t_{\alpha}^{-1} s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(H_{\alpha_{0}}\right)}} \int_{\sigma_{\alpha_{0}}} e^{t \alpha_{\alpha}^{1} s(\Lambda+\rho)(H)} F_{\alpha_{0}}^{(1)}\left(h: t_{\alpha}^{-1} s\right) d \sigma_{\alpha_{0}}\right. \\
& =\sqrt{-1} q \sum_{s \in W} \frac{\varepsilon(s)\left\langle\alpha_{0}, s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(H_{\alpha_{0}}\right)}} \int_{\sigma_{\alpha_{0}}} e^{s(\Lambda+\rho)(H)} F_{\alpha_{0}}^{(1)}(h: s) d \sigma_{\alpha_{0}} .
\end{aligned}
$$

Put

$$
\begin{equation*}
K_{s}^{(1)}(\Lambda)=\frac{\sqrt{-1} q \varepsilon(s)\left\langle\alpha_{0}, s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(H_{a_{0}}\right)}} \int_{\sigma_{\alpha_{0}}} e^{s(\Lambda+\rho)(H)} F_{\alpha_{0}}^{(1)}(h: s) d \sigma_{\alpha_{0}} \tag{7.5}
\end{equation*}
$$

Then

$$
\begin{equation*}
J_{\Lambda}^{(1)}=\sum_{s \in W} K_{s}^{(1)}(\Lambda) \tag{7.6}
\end{equation*}
$$

Now we come to $J_{\Lambda}^{(2)}$. Notice that $\widetilde{\alpha}_{0}$ is the only one positive singular root in $\Sigma_{2}$. Then we get similarly as above

$$
\begin{equation*}
J_{\Lambda}^{(2)}=\sum_{s \in W} \frac{2 \varepsilon_{2}(s)\left\langle\alpha_{0}, s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(H_{\alpha_{0}}\right)}} \int_{A^{-}} e^{s(\Lambda+\rho)\left(H^{-}\right)} F^{(2)}\left(h^{-}: s\right) d h^{-}, \tag{7.7}
\end{equation*}
$$

where $F_{\Lambda}^{(2)}\left(h^{-}: s\right)=\lim _{\varepsilon \rightarrow 0} F_{f}^{(2)}\left(a_{\varepsilon} h^{-} ; \partial\left(\tilde{s} \tilde{\rho}_{r}\right)\right)$. It is easily seen from (2) in Lemma 3 that $F^{(2)}\left(h^{-}: s\right)$ is a function of class $C^{\infty}$. We put

$$
\begin{equation*}
K_{s}^{(2)}(\Lambda)=\frac{2 \varepsilon_{2}(s)\left\langle\alpha_{0}, s \alpha_{r+1}\right\rangle}{\sqrt{\alpha_{0}\left(\overline{H_{\alpha_{0}}}\right)}} \int_{A^{-}} e^{s(\Lambda+\rho)\left(H^{-}\right)} F^{(2)}\left(h^{-}: s\right) d h^{-} . \tag{7.8}
\end{equation*}
$$

Then

$$
\begin{equation*}
J_{\Lambda}^{(2)}=\sum_{s \in W} K_{s}^{(2)}(\Lambda) . \tag{7.9}
\end{equation*}
$$

Put $W_{0}=\left\{s \in W: s \alpha_{0}= \pm \alpha_{0}\right\}$.
Then from (7.6) and (7.9) we have

$$
\begin{align*}
J_{\Lambda}^{(1)}+J_{\Lambda}^{(2)} & =\sum_{s \in W}\left\{K_{s}^{(1)}(\Lambda)+K_{s}^{(2)}(\Lambda)\right\}  \tag{7.10}\\
& =\sum_{s^{*} \in W_{0} \backslash W} \sum_{t \in W_{0}}\left\{K_{t s}^{(1)}(\Lambda)+K_{t s}^{(2)}(\Lambda)\right\}
\end{align*}
$$

where $s^{*}$ denotes the coset in $W_{0} \backslash W$ which contains $s$. Hence in order to prove $J_{\Lambda}^{(1)}+J_{\Lambda}^{(2)}=0$, it is sufficient to prove that $\sum_{t \in W_{0}}\left\{K_{t s}^{(1)}(\Lambda)+K_{t s}^{(2)}(\Lambda)\right\}$ $=0$ for all $s \in W$. For this purpose we need some additional lemmas.

Now fix a coset $s_{1}^{*} \in W_{0} \backslash W$ arbitrarily.
Put $\Lambda(l)=\Lambda+l s_{1}^{-1} \alpha_{0}$.
Lemma 12.

$$
\lim _{l \rightarrow \infty}\left\langle\Lambda(l)+\rho, p_{r}\right\rangle T_{\Lambda(l)}(f)=0 \quad(l \in \boldsymbol{Z}) .
$$

Proof. Since $\Lambda$ is an integral form, $\Lambda(l)=\Lambda+l s_{1}^{-1} \alpha^{0}(l \in \boldsymbol{Z})$ is again an integral form. Moreover if $l \neq l^{\prime}\left(l, l^{\prime} \in \boldsymbol{Z}\right)$ then $\Lambda(l) \neq \Lambda\left(l^{\prime}\right)$. Therefore since

$$
\left|\left\langle\Lambda(l)+\rho, p_{r}\right\rangle\right| \leqslant|\langle\Lambda(l)+\rho, \pi\rangle|
$$

for sufficiently large $l$, the lemma follows immediately from Proposition 3.

Lemma 13. Let $s$ be any element of $W$. Then we have
(2).

$$
\begin{align*}
& \lim _{l \rightarrow \infty} \int_{A_{1}} e^{s(\Lambda(l)+\rho)(H)} F_{f}^{(1)}\left(h ; \partial\left(s p_{r+1}\right)\right) d h=0  \tag{1}\\
& \lim _{l \rightarrow \infty} \int_{+A_{\Lambda(l)^{s}}} e^{\tilde{s}(\tilde{\Lambda}(l)+\tilde{\beta})(H)} F_{f}^{(2)}\left(h ; \partial\left(\tilde{s} \tilde{p}_{r+1}\right)\right) d h=0
\end{align*}
$$

Proof. In view of (1) in Lemma 3, (1) follows immediately from Riemann-Lebesgue theorem. When $s^{*} \neq s_{1}^{*}$ it is obvious that

$$
\left\{H \in \mathfrak{h}^{-}: B\left(H, \mathfrak{h}_{s}\right)=(0)\right\} \neq(0)
$$

where

$$
\mathfrak{h}_{s}=\left\{H \in \mathfrak{h}^{-}: s s_{1}^{-1} \alpha_{0}(H)=0\right\}
$$

Therefore in case $s^{*} \neq s_{1}^{*}$, (2) follows also from Riemann-Lebesgue theorem. Now we assume that $s^{*}=s_{1}^{*}$ in (2). When $l$ is sufficiently large $\left|e^{\tilde{s}_{1}\left(\tilde{X}(l)+\tilde{\beta}_{( }(H)\right.}\right|<1$ if and only if $\left|e^{\tilde{\omega}_{0}(H)}\right|<1$. Hence

$$
\begin{aligned}
& \int_{+} A_{\Lambda(l) s} e^{\tilde{s}_{1}\left(\tilde{\mathrm{~N}}(l)+\tilde{p}_{(H)}(H)\right.} F_{f}^{(2)}\left(h ; \partial\left(\tilde{s} \tilde{p}_{r+1}\right)\right) d h \\
& \quad=\int_{0}^{\infty} e^{-2 l t}\left\{\int_{A^{-}} e^{s_{1}(\Lambda+\rho)\left(t H_{0}+H^{-}\right)} F_{f}^{(2)}\left(a_{t} h^{-} ; \partial\left(\tilde{s} \tilde{p}_{r+1}\right)\right) d h^{-}\right\} d t
\end{aligned}
$$

for sufficiently large $l$. Obviously the right hand side of the last equality tends to zero when $l \rightarrow \infty$. This proves the lemma.

## Lemma 14.

$$
\begin{equation*}
\lim _{l \rightarrow \infty}\left\{J_{\Lambda(l)}^{(1)}+J_{\Lambda(l)}^{(2)}\right\}=0 . \tag{7.11}
\end{equation*}
$$

This lemma is a direct consequence of Lemma 12, Lemma 13 and (7. 1).

Lemma 15. Let $s$ be any element of $W$ such that $s^{*} \neq s_{1}^{*}$. Then we have

$$
\begin{equation*}
\lim _{l \rightarrow \infty} K_{t s}^{(k)}(\Lambda(l))=0 \quad(k=1,2) \tag{7.12}
\end{equation*}
$$

for all $t \in W_{0}$.
This lemma is proved in the same way as Lemma 13.

## Lemma 16.

$$
\begin{equation*}
K_{t s_{1}}^{(k)}(\Lambda(l))=K_{t s_{1}}^{(k)}(\Lambda) \quad(k=1,2) \tag{7.13}
\end{equation*}
$$

for all $l \in \boldsymbol{Z}$.
Proof. For $t \in W_{0}$ and $\exp H \in \sigma_{x_{0}}$ we have

$$
\begin{aligned}
& t \alpha_{0}(H)= \pm \alpha_{0}(H) \in 2 \pi \sqrt{-1} \boldsymbol{Z} \\
& e^{t s_{1}\left(\Lambda+l s_{1}^{-1} \omega_{0}+\boldsymbol{\rho}\right)(\boldsymbol{H})}=e^{t s_{1}(\Lambda+\rho)(\boldsymbol{H})}
\end{aligned}
$$

Hence
for all $l \in \boldsymbol{Z}$.
It follows from (7.5) that

$$
K_{t s_{1}}^{(1)}(\Lambda(l))=K_{t s_{1}}^{(1)}(\Lambda) .
$$

Similarly from (7.8) we get

$$
K_{t s_{1}}^{(2)}(\Lambda(l))=K_{t s_{1}}^{(2)}(\Lambda)
$$

for all $t \in W_{0}$ and $l \in \boldsymbol{Z}(l \geqslant 0)$.
This proves the lemma.
When $l$ tends to infinity in (7.10), we have from (7.11), (7.12) and (7.13)

$$
\begin{aligned}
\sum_{t \in W_{0}} & \left\{K_{t s_{1}}^{(1)}(\Lambda)+K_{t s_{1}}^{(2)}(\Lambda)\right\} \\
& =\lim _{l \rightarrow \infty} \sum_{t \in W_{0}}\left\{K_{t s_{1}}^{(1)}(\Lambda(l))+K_{t s_{1}}^{(2)}(\Lambda(l))\right\} \\
& =\lim _{l \rightarrow \infty}\left\{J_{\Lambda(l)}^{(1)}+J_{\Lambda(l)}^{(2)}-\sum_{\substack{s^{*} \in W_{0} \backslash W \\
s^{*} \neq s_{1}^{*}}} \sum_{t \in W}\left\{K_{t s}^{(1)}(\Lambda(l))+K_{t s}^{(2)}(\Lambda(l))\right\}\right\} \\
& =0 .
\end{aligned}
$$

Since $s_{1}^{*}$ was arbitrarily chosen, we have

$$
\sum_{t \in W_{0}}\left\{K_{t s}^{(1)}(\Lambda)+K_{t s}^{(2)}(\Lambda)\right\}=0
$$

for all $s \in W$. Thus Theorem 1 is proved.
