# REPRESENTATION OF THE SCATTERING KERNEL FOR THE ELASTIC WAVE EQUATION AND SINGULARITIES OF THE BACK-SCATTERING

## 1. Introduction and main results

By Yamamoto [15], Shibata and Soga [7], etc., we know that we can construct the scattering theory for the elastic wave equation corresponding to the theory for the scalar-valued wave equation formulated by Lax and Phillips [3, 4]. Employing Lax and Phillips' theory, Majda [5] obtained a representation of the scattering kernel (operator), which was very useful for investigation on the inverse scattering problems (cf. Majda [5], Soga [8, 10], etc.). In the present paper we shall give the similar representation of the scattering kernel for the elastic wave equation considered in Shibata and Soga [7], and examine the singular support of that kernel.

Let $\Omega$ be an exterior domain in $\boldsymbol{R}_{x}^{n}\left(x=\left(x_{1}, \cdots, x_{n}\right)\right)$ whose boundary $\partial \Omega$ is a compact $C^{\infty}$ hypersurface, and consider the elastic wave equation

Here, $u={ }^{t}\left(u_{1}, \cdots, u_{n}\right)$ is the displacement vector, $a_{i j}$ are constant $n \times n$ matrices whose ( $p, q$ )-components $a_{i p j q}$ satisfy

and the boundary operator $B$ is of the form

where $\nu=\left(\nu_{1}, \cdots, \nu_{n}\right)$ is the unit outer vector normal to $\partial \Omega$. We denote by $U(t)$ the mapping: $f=\left(f_{1}, f_{2}\right) \rightarrow\left(u(t, \cdot), \partial_{t} u(t, \cdot)\right)$ associated with (1.1), and by $U_{0}(t)$
the one associated with the equation in the free space ( $\Omega=\boldsymbol{R}^{n}$ ).
Shibata and Soga [7] show that under the assumptions (A.1) and (A.2) $U(t)$ (resp. $\left.U_{0}(t)\right)$ becomes a group of unitary operators on the Hilbert space $H$ (resp. $H_{0}$ ) equipped with the energy norm

(resp. $\|f\|_{E, R^{n}}$ ) (cf. $\S 1$ of [7]). Furthermore, adding the assumption

they show that the wave operators $W_{ \pm}=\lim _{t \rightarrow \pm \infty} U(-t) U_{0}(t)$ are well defined and complete (cf. §3 of [7]).

As is shown in $\S 2$ of Shibata and Soga [7], if (A.1) $\sim(A .3)$ are satisfied, we can construct concretely the translation representations corresponding to Lax and Phillips' [3, 4] by means of the Radon transformation: $g(x) \rightarrow \tilde{g}(s, \omega)=$ $\int_{x \cdot \omega=s} g(x) d S_{x}\left((s, \omega) \in \boldsymbol{R} \times S^{n-1}\right)$. Let $\left\{\lambda_{j}(\xi)\right\}_{j=1, \cdots, d}\left(\lambda_{1}<\cdots<\lambda_{d}\right)$ be the distinct positive eigenvalues of $\sum_{i, j=1}^{n} a_{i j} \xi_{i} \xi_{j}$, and let $P_{j}(\xi)$ be the projection into the eigenspace of $\lambda_{j}(\xi)$. Then the translation representations of the data $f=\left(f_{1}, f_{2}\right)$ $(\in \mathcal{S})$ in the free space are defined by

where $J_{ \pm}=\left(-\partial_{s}\right)^{(n-1) / 2}$ for odd $n$ and $J_{ \pm}$for even $n$ mean the operators $F^{-1}\left[(-i \sigma)_{ \pm}^{(n-1) / 2} F \cdot\right](F$ being the Fourier transformation in $s)$ whose symbols $(-i \sigma)_{+}^{(n-1) / 2}$ and $(-i \sigma)^{(n-1) / 2}$ denote the branches of $(-i \sigma)^{(n-1) / 2}$ continued analytically into the upper and lower half complex plane respectively (cf. §2 in Shibata and Soga [7]).

We define the scattering operator $S$ by $S=T_{0}^{+}\left(W_{+}\right)^{-1} W_{-}\left(T_{0}^{-}\right)^{-1}$, as Lax and Phillips [3, 4] did. $S$ is a unitary operator from $L^{2}\left(\boldsymbol{R} \times S^{n-1}\right)\left(=\left\{L^{2}\left(\boldsymbol{R} \times S^{n-1}\right)\right\}^{n}\right)$ to itself, and is expressed with the distribution kernel $S(s, \theta, \omega)$ (called the scattering kernel):

Let $v_{l}(t, x ; \omega)$ be the solution of the equation

$v_{l}(t, x ; \omega)$ is an $n \times n$ matrix of $C^{\infty}$ functions of $x$ and $\omega$ with the value of the distribution in $t$.

Theorem 1. We assume (A.1)~(A.3) and the following
every slowness hypersurface $\Sigma_{i}=\left\{\xi: \lambda_{i}(\xi)=1\right\}(i=1, \cdots, d)$ is strictly convex (i.e. the Gaussian curvature does not vanish anywhere).

Then the scattering kernel is represented in the following way:

where $N=\sum_{i, j=1}^{n} \nu_{i}(x) a_{i j} \partial_{x_{j}}$.
It has been announced in Soga [12] that we can obtain this representation in the space of the odd dimension $n$. Improving the methods in [12], we shall prove it in $\S 3$ inclusive of the even dimension. We need much more precise analysis when $n$ is even than when $n$ is odd.

In the proof of Theorem 1 there are two difficulties which we did not encounter in the scalar-valued wave equation treated in Majda [5], Soga [8, 9], etc., although the idea of the procedures is similar. The first difficulty is to verify the following theorem. This is one of the bases for the proof of Theorem 1.

Theorem 2. For $\theta \in S^{n-1}$ and $j=1, \cdots, d$ set

where $K_{j}(\theta)$ denotes the Gaussian curvature of $\Sigma_{j}$ at $\lambda_{j}(\theta)^{-1 / 2} \theta\left(\in \Sigma_{j}\right)$. Then, for any $f$ with $T_{0}^{+} f \in \mathcal{S}\left(\boldsymbol{R} \times S^{n-1}\right)$ we have

In the scalar-valued wave equation Lax and Phillips [3] obtained similar formula (see Theorem 2.4 in Ch. IV of [3]), but their methods do not work well in our case.

In the proof of Theorem 1 we use the fundamental solution of the wave equation (1.1) as Majda [5] and Soga [8, 9] did. The fundamental solution of the d'Alembert equation can be expressed concretely, e.g., $4 \pi t^{-1} \delta(|x|-t)(n=3)$, etc. They in $[5,8,9]$ utilized this concrete expression skilfully. In the present case, however, we cannot expect that the fundamental solution is written in such a concrete form. This is the second difficulty. We can obtain the representation of the scattering kernel without the concrete expression of the fundamental solution, by examining the integrals $\int\left(J_{ \pm} k\right)(t \varphi(\omega), \omega) d \omega$ as $|t| \rightarrow \infty(\varphi(\omega)$ being some real-valued function on $S^{n-1}$ ). The proof of Theorem 2 is also reduced to examination of the same integrals. In Appendix (§5) we show some properties of those integrals needed in the proofs, which are similar to the well-known results for the method of stationary phases; however, our results can not obviously be derived by this method. Especially, this derivation for even $n$ is much more difficult than for odd $n$. This is because $J_{ \pm}$are not differential operators when $n$ is even.

Using the representation in Theorem 1, we obtain the following theorem about the (singular) support of the back-scattering $S(s,-\omega, \omega)$ corresponding to the one in Majda [5] and Soga [10]:

Theorem 3. For any fixed $\omega \in S^{n-1}$ we have

where $r(\omega)=\min _{x \in \partial \Omega} x \cdot \omega$.
The above results are reasonable since $P_{i}(-\omega) S\left(\lambda_{i}(\omega)^{-1 / 2} \omega \cdot x-t,-\omega, \omega\right)$ $P_{j}(\omega)$ means the $\lambda_{i}(\omega)$-mode wave scattered in the direction $-\omega$ for the incident $\lambda_{j}(\omega)$-mode wave in the direction $\omega$. Theorem 3 was announced in Soga [12] under some more restricted assumptions. When (1.1) is the isotropic equation (i.e. $a_{i p j q}=\mu\left(\delta_{p q} \delta_{i j}+\delta_{i q} \delta_{j p}\right)+\lambda \delta_{i p} \delta_{j q}, \mu>0, \mu+2 \lambda / 3>0$ ) with the Dirichlet boundary condition in the case of $n=3$, Yamamoto [16] has also obtained the same results as in Theorem 3. But it seems difficult to apply his methods to our case.

We can obtain Theorem 3 by the same procedures as in Majda [5], Soga [10], etc.: Employing the asymptotic solutions of (1.1) (constructed in Soga [13]), we expand asymptotically the Fourier transform of $\alpha(s) P_{i}(-\omega) S(s,-\omega, \omega)$ $P_{j}(\omega)$ in the form $\sum_{k=0}^{\infty} \int_{R^{n-1}} e^{-i \sigma \varphi(y)} \beta_{k}(y)(i \sigma)^{-k} d y$ (as $\left.|\sigma| \rightarrow \infty\right)$, and apply Theorem 2 in Soga [10] to this form (which deals with those oscillatory integals).

It is an interesting problem whether or not $P_{i}(-\omega) S(s,-\omega, \omega) P_{j}(\omega)$ with
$i \neq j$ is singular at $s=-\left(\lambda_{i}(\omega)^{-1 / 2}+\lambda_{j}(\omega)^{-1 / 2}\right) r(\omega)$. To solve this problem, however, we need more precise analysis than for Theorem 3. It is examined in the paper Kawashita and Soga [1].

## 2. Properties of the translation representations

In this section we assume (A.1) $\sim(A .4)$ in Introduction, and show some properties of the translation representations $T_{0}^{ \pm}$in the free space and the ones $T^{ \pm}\left(=T_{0}^{ \pm}\left(W^{ \pm}\right)^{-1}\right)$ for the mixed problem (1.1). Theorem 2 in $\S 1$ follows immediately from Theorem 2.1 below. The notations in $\S 1$ are used also in this section.

We set $L=\sum_{i, j=1}^{n} a_{i j} \partial_{x_{i}} \partial_{x_{j}}$. Let $A_{0}$ be the operator on $H_{0}$ defined by $A_{0}=$ $\left[\begin{array}{cc}I & 0 \\ 0 & L\end{array}\right]$, and denote the domain of $A_{0}^{m}$ by $D\left(A_{0}^{m}\right) . \quad A_{0}$ is the generator of $U_{0}(t)$.
In the same way we denote by $A$ the generator of $U(t)$. The properties of these operators are described precisely in Shibata and Soga [7]. We denote by $C_{0}^{m}(M)$ the space of $C^{m}$ functions on $M$ with compact support, and by $\mathscr{B}^{\circ}(M)$ the space of $C^{m}$ functions $v(x)$ on $M$ satisfying $\sum_{|\alpha| \leq m} \sup _{x \in \mathbb{K}}\left|\partial_{x}^{\infty} v(x)\right|<\infty\left(\mathscr{B}^{\infty}=\bigcap_{m \geq 0} \mathscr{B}^{m}\right)$. $\mathcal{S}$ means the set of the Schwartz rapidly decreasing functions. We abbreviate the product $E \times \cdots \times E$ of a functional space $E$ by $E$.

Theorem 2.1. Let $\kappa_{j}(\theta), \eta_{j}(\theta)$ and $\zeta_{j}(\theta)$ be the functions defined in Theorem 2.
(i) Let $f$ be any data satisfying $f \in D\left(A_{0}^{n+3}\right)$. Then, for any $h(s, \theta) \in$ $C_{0}^{\infty}\left(\boldsymbol{R} \times S^{n-1}\right)$ there exists a constant $C$ independent of $f$ and $t \in \boldsymbol{R}$ such that

(ii) If $f \in H_{0}$ satisfies $T_{0}^{+} f \in \mathcal{S}\left(\boldsymbol{R} \times S^{n-1}\right)$, then for any $(s, \theta)$ we have

If $f \in D\left(A_{0}^{n+3}\right)$, then the above equality is valid in the sense of the distributions on $\boldsymbol{R}_{s} \times S_{\theta}^{n-1}$.

From the above theorem we obtain the following theorem concerning $T^{+}=$ $T_{0}^{+}\left(W_{+}\right)^{-1}$, which is one of the bases for the proof of Theorem 1 in $\S 1$.

Theorem 2.2. Let $\kappa_{j}(\theta), \eta_{j}(\theta)$ and $\zeta_{j}(\theta)$ be the functions defined in Theo-
rem 2. If $f \in D\left(A^{n+3}\right)$, then $t^{(n-1) / 2} \sum_{j=1}^{d} \kappa_{j}(\theta) P_{j}(\theta)(U(t) f)_{2}\left(t_{\eta_{j}}(\theta)+s \zeta_{j}(\theta)\right)$ converges to $T^{+} f(s, \theta)$ in the sense of the distributions as $t \rightarrow \infty$; i.e., for any $h(s, \theta) \in C_{0}^{\infty}(\boldsymbol{R} \times$ $S^{n-1}$ ) we have

The above theorems are the main results in this section and will be proved later.

The slowness surfaces $\Sigma_{i}$ are $(n-1)$ dimensional $C^{\infty}$ hypersurfaces expressed by $\left\{\lambda_{i}(\omega)^{-1 / 2} \omega\right\}_{\omega \in S^{n-1}}$. Each mapping: $\omega \rightarrow \lambda_{i}(\omega)^{-1 / 2} \omega$ is a diffeomorphism from $S^{n-1}$ to $\Sigma_{i}$. It is easy to see

Lemma 2.3. Fix $\eta \in \boldsymbol{R}^{n}(\neq 0)$ arbitrarily, and set $\varphi_{i}(\omega)=\lambda_{i}(\omega)^{-1 / 2} \omega \cdot \eta$ $\left(\omega \in S^{n-1}\right)$.
(i) $\boldsymbol{\varphi}_{i}(\omega)$ is maximum at only one point $\omega_{i}^{+}$and minimum at only one point $\omega_{\bar{i}}^{-} ;$furthermore, $\omega_{i}^{+}=-\omega_{\bar{i}}^{-}$.
(ii) The gradient of $\varphi_{i}(\omega)$ does not vanish at any $\omega$ which is not equal to $\omega_{i}^{+}$ or $\omega_{i}^{\bar{i}}$.
(iii) $\varphi_{i}\left(\omega_{\overline{1}}^{-}\right)<\cdots<\varphi_{i}\left(\omega_{\bar{d}}^{-}\right)<0<\varphi_{i}\left(\omega_{d}^{+}\right)<\cdots<\varphi_{i}\left(\omega_{1}^{+}\right)$.

The following lemmas are key lemmas for the proof of Theorem 2.1.
Lemma 2.4. Let $\eta \in \boldsymbol{R}^{n}(\neq 0)$ and $s_{0} \in \boldsymbol{R}$, and set $\varphi_{l}(\omega)=\lambda_{l}(\omega)^{-1 / 2} \omega \cdot \eta$ $+s_{0}\left(\omega \in S^{n-1}\right)$. Then, for any $k(s, \omega) \in \mathcal{S}\left(\boldsymbol{R} \times S^{n-1}\right)$ we have

where $\omega_{l}^{ \pm}$are the points in Lemma 2.3 and $\tilde{\kappa}_{l}(\omega)=2(2 \pi)^{(n-1) / 2}|\eta|^{(1-n) / 2} \lambda_{l}(\omega)^{(n+1) / 2}$ $K_{l}(\omega)^{-1 / 2}\left|\partial_{\xi} \lambda_{l}(\omega)\right|^{-1}$.

Lemma 2.5. Let $\mu$ be any vector in $\left\{\mu \in \boldsymbol{R}^{n} ; \mu_{0}^{-1} \leqq|\mu| \leqq \mu_{0}\right\}\left(\mu_{0}>1\right)$, and let $s_{0} \in \boldsymbol{R}$. Set $\psi_{i}(\theta)=\mu \cdot\left(\partial_{\xi} \lambda_{i}\right)\left(\lambda_{i}(\theta)^{-1 / 2} \theta\right)+s_{0}\left(\theta \in S^{n-1}\right)$. Then, for any $k(s, \theta) \in$ $\mathcal{S}\left(\boldsymbol{R} \times S^{n-1}\right)$ we have

where $\|\cdot\|_{m, \boldsymbol{R} \times S^{n-1}}$ denotes the Sobolev norm on $\boldsymbol{R} \times S^{n-1}$ of order $m$ and $C$ is a constant independent of $\mu, k$ and $t(\in \boldsymbol{R})$.

Proof of Lemma 2.4. Take a prtition $\left\{\chi_{j}\right\}_{j \geq 0}$ of unity on $S^{n-1}$ such that $\operatorname{supp}\left[\chi_{0}\right] \ni \omega_{l}^{+} \notin \operatorname{supp}\left[\chi_{j}\right](j \geqq 1)$ and $\operatorname{supp}\left[\chi_{1}\right] \ni \omega_{l} \notin \operatorname{supp}\left[\chi_{j}\right](j \geqq 2$ and $=0)$. It is seen that $\psi_{i}(\theta)$ is maximum at $\theta_{+}=|\mu|^{-1} \mu$ and minimum at $\theta_{-}=-|\mu|^{-1} \mu$, and that the gradient of $\psi_{i}(\theta)$ does not vanish when $\theta \neq \theta_{ \pm}$; furthermore the Hessian of $\psi_{i}(\theta)$ does not vanish near $\theta=\theta_{ \pm}$. In the same way as in the proof of Lemma 2.4, taking the partition of unity, we can derive Lemma 2.5 from Theorem 5.2 and (i) of Theorem 5.6 in $\S 5$. The proof is complete.

## 3. The representation of the scattering kernel

At first, we state a theorem (Theorem 3.1) basic for proof of the representation of the scattering kernel. And next we prove this representation, that is, Theorem 1 in $\S 1$ and more precise results (Theorem 3.3). We use the notations in the previous sections also in this section.

The first step is to prove that $\lim _{\tilde{t} \rightarrow \infty} \Phi_{1}(\tilde{t})=0$. The function $\left\{1-\lambda_{l}(\omega)^{-1 / 2}\right.$ $\left.\omega \cdot \eta_{j}(\theta)\right\}$ (on $S_{\omega}^{u-1}$ ) is maximum at only one point $\omega_{+}$and minimum at only another point $\omega_{-}$; furthermore there are no stationary points in $S_{\omega}^{n-1}$ except $\omega_{ \pm}$(cf. Lemma 2.3). The second step is to examine the behavior of $\Phi_{0}(\tilde{t})$ as $\tilde{t} \rightarrow \infty$. We employ the same reduction with the partition $\left\{\alpha_{i}(\omega)\right\}_{i=0,1, \ldots .}$ as in the first step. Then there are no stationary points of $1-\lambda_{l}(\omega)^{-1 / 2} \omega \cdot \eta_{j}$ in $\operatorname{supp}\left[\alpha_{i}(\omega)\right]$ if $i \geqq 2$. And therefore, in the same way as in the first step we see from Theorem 5.2 in $\S 5$ that the absolute values of the terms with $\alpha_{i}(i \geqq 2)$ are of the order less than $\tilde{t}^{2-n}$ (as $\tilde{t} \rightarrow \infty$ ) and tend to 0 as $\tilde{t} \rightarrow \infty$. Consequently it suffices to examine only the terms containing $\alpha_{0}$ or $\alpha_{1}$.

We take local coordinates $\omega=\omega(y)\left(y \in \boldsymbol{R}^{n-1}\right)$ available in a neighborhood

In view of the equalities that $J_{+}^{*} \Lambda_{n-2}=i J_{+} \partial_{t}^{n-2}$ and $i J_{+}^{*} \Lambda_{n-1}=i J_{+} \partial_{t}^{n-1}$, we see that the term (with $\alpha_{1}$ ) to be examined is sum of the forms $\tilde{t}^{(n-1) / 2} \iint$ $J_{+} k(\tilde{t} \varphi(y), y ; x) d y d S_{x} . \quad$ Noting that $\varphi(0) \neq 0$ if $l \neq j$ and $\varphi(0)=0$ if $l=j$, we apply Theorem 5.4 or Theorem 5.6 to the integral $\int J_{+} k(\tilde{t} \varphi(y), y ; x) d y$ (see (ii) of Remark below Theorem 5.4 also). Thus it is proved that as $\tilde{t} \rightarrow \infty \Phi_{1}(\tilde{t})$ converges to the limit of the term containing $\alpha_{1}$ and satisfying $l=j$. The proof is complete.

Regard the Dirac function $\delta\left(t-\lambda_{j}(\omega)^{-1 / 2} \omega \cdot x\right)$ as a distribution-valued $C^{\infty}$ funation on $\boldsymbol{R}_{x}^{n} \times S_{\omega}^{n-1}$, and consider the equation

In the above theorem, the integral means the Riemann sum with the value of the distributions on $\boldsymbol{R}$. Theorem 2 in $\S 1$ follows from the above theorem since the kernel of $K$ is equal to 0 when $\theta \neq \omega$. This theorem will be derived later from Theorem 2.2, Theorem 3.1 and the following lemma.

Furthermore, $\sum_{i=1}^{d} \iint_{R \times s^{n-1}} v_{l}(t+s, x ; \omega) J^{*} k(s, \omega) d s d \omega=0$ if $t$ is small enough, because $J^{*} k(s, \omega)=$ 0 for $s>s_{0}$ (cf. Thus, from the uniqueness of the solutions, it follows that $u_{t}(t, x)=\tilde{u}_{t}(t, x)$ on $\boldsymbol{R} \times \Omega$. The proof is complete.

Proof of Theorem 3.3. Let $k(s, \omega) \in C_{0}^{\infty}\left(\boldsymbol{R} \times S^{n-1}\right)$, and set $f=W_{-}\left(T_{0}^{-}\right)^{-1} k$. Then $f \in D\left(A^{\infty}\right)$ and $U(t) f(x) \in C^{\infty}$. Theorem 2.2 means that

## 4. Singularities of the scattering kernel

In this section, using Theorem 1 in $\S 1$, we examine the support and the singular support of the back-scattering $S(s,-\omega, \omega)$, and prove Theorem 3 in §1. The notations in the previous sections are used also in this section. We denote by $H^{-\infty}(M)$ the dual space of the Sobolev space of order $\infty$ on $M$.

At first we solve (3.6) approximately by means of the asymptotic solutions obtained in Soga [13]. Namely we construct the Poisson operator for the nonglancing boundary data:

Theorem 4.1. We have an operator $P: H^{-\infty}(\boldsymbol{R} \times \partial \Omega) \rightarrow H^{-\infty}(\boldsymbol{R} \times \Omega)$ with the following properties: There exist a neighborhood $U$ of $\partial \Omega\left(\right.$ in $\left.\boldsymbol{R}^{n}\right)$ and an open conic set $\Gamma$ in $T^{*}(\boldsymbol{R} \times \partial \Omega)=\boldsymbol{R}_{t} \times \boldsymbol{R}_{\sigma} \times T^{*}(\partial \Omega)$ containing $\boldsymbol{R}_{t} \times\left(\boldsymbol{R}_{\sigma}-\{0\}\right) \times \partial \Omega \times\{0\}$ such that
(i) $\quad\left(\partial_{t}^{2}-L\right) P h \in C^{\infty}(\boldsymbol{R} \times(\bar{\Omega} \cap U)), h\left(t, x^{\prime}\right) \in H^{-\infty}(\boldsymbol{R} \times \partial \Omega)$;
(ii) $\operatorname{Ph}(t, x) \in C^{\infty}\left(\left(-\infty, r_{0}\right) \times \bar{\Omega}\right)$ if $h\left(t, x^{\prime}\right)$ is $C^{\infty}$ smooth when $t<r_{0}$;
(iii) $\operatorname{BPh}\left(t, x^{\prime}\right)$ is well defined for any $h\left(t, x^{\prime}\right) \in H^{-\infty}(\boldsymbol{R} \times \partial \Omega)$, and furthermore

(iv) the mapping $T:\left.h \rightarrow N P h\right|_{R \times \partial \Omega}\left(\right.$ resp. $\left.\left.h \rightarrow P h\right|_{R \times \partial \Omega}\right)$ is a pseudo-differential operator of order 1 (resp. -1) on $\boldsymbol{R} \times \partial \Omega$ independent of $t$ in the case of $B u=\left.u\right|_{\boldsymbol{R} \times \partial \Omega}\left(\right.$ resp. $\left.B u=\left.N u\right|_{R \times \partial \Omega}\right)$; furthermore, each local symbol $T(y ; \sigma, \eta)((y, \eta)$ being local coordinates of $T^{*}(\partial \Omega)$ ) has homogeneous asymptotic expansion $\sum_{j=0}^{\infty}$ $T_{j}(y ; \sigma, \eta)$ such that every $i^{j+1} T_{j}(y ; \sigma, \eta)$ is real-valued and homogeneous of order $1-j(r e s p .-1-j)$ in $(\sigma, \eta)$ and that

Proof. We take a fine partition $\left\{\chi_{k}\right\}_{k=1,2, \ldots}$ of unity on $\partial \Omega$, and carry out the following analysis in each neighborhood $W_{k}\left(\subset \boldsymbol{R}^{n}\right)$ of $\operatorname{supp}\left[\chi_{k}\right]$. We introduce local coordinates $x^{\prime}=x^{\prime}(y)$ on $\partial \Omega \cap W_{k}\left(y \in \boldsymbol{R}^{n-1}\right)$.

If $|\eta|\left(\eta \in \boldsymbol{R}^{n-1}\right)$ is small enough, we have the solution $\varphi^{l}(x ; \eta)(l=1, \cdots, d)$ of the equation

by the Hamilton-Jacobi method. Here, we choose $W_{k}$ so that $\varphi^{l}(x ; \eta)$ is defined on the whole $\Omega \cap W_{k}$. Using the asymptotic solutions in Soga [13] (cf. Theorem 1.1 of [13]), in $\Omega \cap W_{k}$ and for $\sigma \in \boldsymbol{R}$ and small $|\eta|$ we can construct $C^{\infty}$ functions $p^{l}(x ; \sigma, \eta)(l=1, \cdots, d)$ with asymptotic expansions $\sum_{j=0}^{\infty} p_{j}^{l}(x ; \eta)(i \sigma)^{-j+z}$ (as $|\sigma| \rightarrow \infty)$ such that $i^{j+1} p_{j}^{l}(x ; \eta)$ are real-valued and that

where $\varepsilon=0$ (resp. -1) when $B u=\left.u\right|_{R \times \partial \Omega}\left(\right.$ resp. $\left.B u=\left.N u\right|_{R \times \partial \Omega}\right)$ and $I$ is the $n \times n$ identity matrix.

Let $\mathcal{X}_{k}^{0}(x ; \eta)$ be a $C^{\infty}$ function such that $\mathcal{X}_{k}^{0}(x ; \eta)=1$ in a neighborhood of $\operatorname{supp}\left[\chi_{k}\right] \times\{\eta=0\}$ and $\operatorname{supp}\left[\chi_{k}^{0}\right]$ is in a place where $\varphi^{l}$ and $p^{l}$ are defined. We set

where $\mathscr{F}\left[\chi_{k} h\right](\sigma, \eta)=\iint e^{-i \sigma t-i \eta y} \chi_{k}\left(x^{\prime}(y)\right) h\left(t, x^{\prime}(y)\right) d t d y$. Then it is seen that the operator $P=\sum_{k} P_{k}$ has the all properties stated in Theorem 4.1. Hnece the theorem is obtained.

Proof of Theorem 3. (i) Let $v_{j}(t, x ; \omega)(j=1, \cdots, d)$ be the solutions of (3.6) in §3. Then $u=v_{j} P_{l}(\omega)$ satisfies the equations ( $\left.\partial_{t}^{2}-L\right) u=0$ in $\boldsymbol{R} \times \Omega$ and $B u=\delta_{j l} B v_{j}$ on $\boldsymbol{R} \times \partial \Omega$, which implies that $v_{j}(t, x ; \omega)=\delta_{j l} v_{j}(t, x ; \omega) P_{l}(\omega)$ in $\boldsymbol{R} \times \Omega$ (from the uniqueness of the solutions). Combining these equalities with Theorem 1, we have

Since $v_{j}(t, x ; \omega)=0$ if $t<\lambda_{j}(\omega)^{-1 / 2} r(\omega)$, it follows that $v_{j}\left(-\lambda_{i}(\omega)^{-1 / 2} \omega \cdot x-s, x ; \omega\right)$ $=0$ if $s>-\left(\lambda_{i}(\omega)^{-1 / 2}+\lambda_{j}(\omega)^{-1 / 2}\right) r(\omega)$. Therefore the right side of (4.1) is equal to 0 if $s>-\left(\lambda_{i}(\omega)^{-1 / 2}+\lambda_{j}(\omega)^{-1 / 2}\right) r(\omega)$. which proves (i) of Theorem 3.
(ii) Choose $\psi(t) \in C_{0}^{\infty}(\boldsymbol{R})$ satisfying $\psi(t)=1$ in a neighborhood of $t=\lambda_{j}(\omega)^{-1 / 2} r(\omega)$, and multiply the boundary data in (3.6) (with $l=j$ ) by $\psi(t)$.

Let $h\left(t, x^{\prime}\right)$ be this multiplied data. Then the wave front set (cf. $\S 3$ in Ch. 10 of Kumano-go [2], etc.) of $h$ is contained in the set $\Gamma$ stated in Theorem 4.1 if $\operatorname{supp}[\psi]$ is small enough. From Theorem 4.1 it follows that $B(P h(t, x)$ $v_{j}(t, x ; \omega)$ ) are $C^{\infty}$ smooth when $t<\lambda_{j}(\omega)^{-1 / 2} r(\omega)+\delta(\delta$ is some positive constant) and that $\left(\partial_{t}^{2}-L\right)\left(P h(t, x)-v_{j}(t, x ; \omega)\right) \in C^{\infty}(\boldsymbol{R} \times(\bar{\Omega} \cap U))$. This implies that $v_{j}(t, x ; \omega)$ can be approximated by $P h(t, x) \bmod C^{\infty}$ in $\left(-\infty, \lambda_{j}(\omega)^{-1 / 2} r(\omega)+\delta\right) \times$ ( $\bar{\Omega} \cap U$ ), since the mixed problem (1.1) is $C^{\infty}$ solvable and has a finite propagation speed (cf. Shibata and Soga [7]). Therefore, when $s<2 \lambda_{j}(\omega)^{-1 / 2} r(\omega)+2 \delta$, we can change $N v_{j}\left(-\lambda_{j}(\omega)^{-1 / 2} \omega \cdot x^{\prime}-s, x^{\prime} ; \omega\right)\left(\right.$ resp. $\left.v_{j}\left(-\lambda_{j}(\omega)^{-1 / 2} \omega \cdot x^{\prime}-s, x^{\prime} ; \omega\right)\right)$ for $T h\left(-\lambda_{j}(\omega)^{-1 / 2} \omega \cdot x^{\prime}-s, x^{\prime}\right) \bmod C^{\infty}$ in the case of $B u=\left.u\right|_{\partial \Omega}$ (resp. $\left.B u=\left.N u\right|_{\partial \Omega}\right)$. Combining this with (4.1) yields that

Here, $\alpha(s)$ is an arbitrary cutoff $C^{\infty}$ function with sufficently small support such that $\alpha\left(-2 \lambda_{j}(\omega)^{-1 / 2} r(\omega)\right) \neq 0$, and $\chi\left(x^{\prime}\right)$ is a $C^{\infty}$ function on $\partial \Omega$ such that $\chi\left(x^{\prime}\right)=1$ on the set $W=\left\{x^{\prime} \in \partial \Omega ;\left(s, x^{\prime}\right) \in\right.$ $\operatorname{supp}\left[\alpha(s) h\left(-\lambda_{j}(\omega)^{-1 / 2} \omega \cdot x^{\prime}-s, x^{\prime}\right)\right]$ for some $\left.s\right\}$ and that supp $[\chi]$ is sufficiently small.

Let $(y, z)\left(\in \boldsymbol{R}^{n-1} \times \boldsymbol{R}\right)$ be an orthonormal system of coordinates such that the plane $\{x: \omega \cdot x=s\}$ is expressed by $z=s$. Since $\partial \Omega \cap \operatorname{supp}[\chi]$ is close to the plane $\{x: \omega \cdot x=r(\omega)\}, \partial \Omega$ is represented near supp $[\chi]$ by $z=2^{-1} \lambda_{j}(\omega)^{1 / 2} \varphi(y)$ for some $C^{\infty}$ function $\varphi(y)$. Introducing the local coordinates $(z, y)$ and combining (4.2) with (iv) of Theorem 4.1, we see in the same way as in §4 of Soga [8] that there exists a matrix $\beta_{k}(y)$ of real-valued $C^{\infty}$ functions $(k=0,1, \cdots)$ with $\operatorname{supp}\left[\beta_{k}(y)\right] \subset \operatorname{supp}\left[\chi\left(x^{\prime}(y)\right)\right]$ such that for any positive integer $m$

when $B u=\left.u\right|_{\partial \Omega}$ (resp. when $B u=\left.N u\right|_{\partial \Omega}$ ). The function $\varphi(y)$ is minimum when $\omega \cdot x^{\prime}(y)=r(\omega)$, and then, by (iv) of Theorem 4.1, we have $\beta_{0}(y)=\varepsilon 2 \alpha(-2$ $\left.\lambda_{j}(\omega)^{-1 / 2} r(\omega)\right) \lambda_{j}(\omega)^{1 / 2} P_{j}(\omega) \neq 0\left(\varepsilon=+\left(\right.\right.$ resp. 一) when $B u=\left.u\right|_{\partial \Omega}$ (resp. $B u=$ $\left.\left.N u\right|_{\partial \Omega}\right)$ ). Therefore we can apply Theorem 2 in Soga [10] to the oscillatory integral in (4.3). Hence it follows that $\left(1+|\sigma|^{\kappa}\right) F\left[P_{j}(-\omega) \alpha(s) S(s,-\omega, \omega)\right.$ $\left.P_{j}(\omega)\right](\sigma) \notin L^{2}(\boldsymbol{R})$ for some $\kappa \in \boldsymbol{R}$, which proves (ii) of Theorem 3.

Remark. The above methods (for the proof of (ii) of Theorem 3) do not work well when examining the singularities of $P_{i}(-\omega) S(s,-\omega, \omega) P_{j}(\omega)$ in the case of $i \neq i$. For in this case the $\beta_{0}(y)$ is of the form $\varepsilon 2 \alpha\left(-2 \lambda_{j}(\omega)^{-1 / 2} r(\omega)\right)$ $\lambda_{j}(\omega)^{1 / 2} P_{i}(\omega) P_{j}(\omega)$ for $y$ with $\omega \cdot x^{\prime}(y)=r(\omega)$, and so $\beta_{0}(y)=0$ for these $y$. Therefore, in order to examine these singularities, we need a new analysis. Kawashita and Soga [1] deal with the case of $i \neq j$ under some assumptions.

## 5. Appendix

For a function $p(\sigma)$ on $\boldsymbol{R}$ we denote by $p\left(D_{s}\right)$ (or $p$ ) the pseudo-differential operator: $h(s) \rightarrow F^{-1}[p(\sigma) F[h](\sigma)](s)$. It is known that $p\left(D_{s}\right)$ becomes a continuous operator from $\mathscr{B}^{\infty}(\boldsymbol{R})$ to itself if $p(\sigma)$ is a $C^{\infty}$ function satisfying $\sup _{\sigma \in \boldsymbol{R}}$ $(1+|\sigma|)^{-\kappa+1}\left|\partial_{\sigma}^{i} p(\sigma)\right|<\infty$ for all non-negative integers $i$ (cf. $\S 1$ in Ch. 2 of Kumano-go [2]). We denote by $|\cdot|_{m}$ or $|\cdot|_{m, M}$ the norm of $\mathscr{B}^{m}(M)$, and by $\|\cdot\|_{m}$ or $\|\cdot\|_{m, M}$ the norm of the Sobolev space on $M$ of order $m$.

Lemma 5.1. Let $p(\sigma)$ be a function on $\boldsymbol{R}$ homogeneous of order $\kappa>0$. Then $p\left(D_{s}\right)$ becomes a bounded operator from $\mathscr{B}^{m}(\boldsymbol{R})$ to $\mathscr{B}^{m}(\boldsymbol{R})(m$ and $\tilde{m}$ being any integers with $0 \leqq \tilde{m} \leqq m-\kappa-2$ ). Furthermore, for any $\delta$ with $0 \leqq \delta<\kappa$ we have the estimate

where $\left(1+s^{2}\right)^{8 / 2} h(s) \in \mathscr{B}^{\infty}$ and $C$ is a constant independent of $h$.
Let us note that Lemma 5.1 implies that if $p(\sigma)$ is homogeneous of order $\kappa>0, p\left(D_{s}\right)$ becomes a continuous operator from $\mathscr{B}^{\infty}(\boldsymbol{R})$ to itself.

Let $U$ be an open ball $\{y:|y|<\varepsilon\}$ in $\boldsymbol{R}^{l}(l \geqq 2)$. Assume that $\varphi(y)$ is a real-valued function $\in \mathscr{B}^{\infty}(U)$, and denote by $H_{\varphi}(y)$ the Hesse matrix $\left\{\partial_{y_{i}} \partial_{y_{j}} \varphi(y)\right\}_{i, j=1, \cdots, l}$. From now on, we examine the behavior of the integral
$\int_{U} p\left(D_{s}\right) k(t \varphi(y), y) d y\left(k(s, y) \in \mathscr{D}^{\infty}(\boldsymbol{R} \times U)\right)$ as the parameter $t$ tends to $\infty$ or $-\infty$.

Theorem 5.2. Let $p(\sigma)$ be homogeneous of order $\kappa>1$. Assume that $\partial_{y} \varphi(y) \neq 0$ on $\bar{U}$, and that $k(s, y)$ is any function $\in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$ with supp $[k] \subset$ $\boldsymbol{R} \times U$. Then there is a constant $C$ independent of $k$ and $t \in \boldsymbol{R}$ such that

Introducing a partition of unity on $U$, we can assume that the support of $k(s, y)$ in $y$ is contained in a small open ball $\tilde{U}$ and that $\partial_{y_{i}} \varphi(y) \neq 0$ on the closure of $\tilde{U}$ for some $i$. Let $i=1$ and $y=\left(y_{1}, y^{\prime}\right)$. Transforming the variable $y_{1}$ into $s=\boldsymbol{\varphi}(y)$, we have

It is seen that $\left(p\left(D_{s}\right) h\right)(t s)=t^{-\kappa}\left[p\left(D_{r}\right)(h(t r))\right](s)$. Therefore, by Lemma 5.3 we obtain

where $\tilde{k}\left(s, \tilde{s}, y^{\prime}\right)=k\left(s, y_{1}\left(\tilde{s}, y^{\prime}\right), y^{\prime}\right)\left|\frac{\partial y_{1}}{\partial s}\left(\tilde{s}, y^{\prime}\right)\right|$. Lemma 5.1 yields that $\left|\left(p\left(-D_{\tilde{s}}\right) \tilde{k}\right)\left(t s^{\prime}, s^{\prime}, y^{\prime}\right)\right| \leqq C_{1}\left(1+\left|s^{\prime}\right|\right)^{-1-\delta} \sup _{\substack{0 \leq i<k+3 \\ s, \tilde{s} \in \boldsymbol{R}}}(1+|\tilde{s}|)^{-1-\delta}\left|\partial_{\tilde{s}}^{i} \tilde{k}\left(s, \tilde{s}, y^{\prime}\right)\right| \leqq C_{2}$ $\left(1+\left|s^{\prime}\right|\right)^{-1-\delta} \sup _{\substack{|\alpha|<\kappa+3 \\(s, y) \in R \times \sigma}}\left|\partial_{y}^{\alpha} k(s, y)\right|(0<\delta<\kappa-1)$. Hence Theorem 5.2 is obtained.

Hereafter we consider the case

Theorem 5.4. Let (5.1) be satisfied, and assume that $p(\sigma)$ is homogeneous of order $\kappa$ with $[\kappa]>l / 2([\kappa]=$ the maximum integer $<\kappa)$. Then we have the following properties (i) and (ii) for any function $k(s, y) \in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$ with supp $[k] \subset$ $\boldsymbol{R} \times \boldsymbol{U}$.
(i) There is a constant $C$ independent of $k$ and $t \in \boldsymbol{R}$ such that

If $p\left(D_{s}\right)$ is a differential operator, the above statements (i) and (ii) are valid also when $\kappa>l / 2$.

Remark. (i) In Theorem 5.2, let $h(s, y)=\int_{0}^{s} k(r, y) d r \in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$, which is satisfied if, e.g., $\left(1+s^{2}\right) k(s, y) \in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$ or $k(s, y)=\partial_{s} \tilde{k}(s, y)$ for some $\tilde{k}(s, y) \in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$. Then, noting that $p\left(D_{s}\right) k=p\left(D_{s}\right) \partial_{s} h$ for such functions $k$, we obtain the estimate $\left|t^{\kappa+1} \int_{U} p k(t \varphi(y), y) d y\right| \leqq C_{1}$ (for a constant $C_{1}$ independent of $t$ ).
(ii) The same assertion is correct also in Theorem 5.4: For any $k(s, y)$ with $\int_{0}^{s} k(r, y) d r \in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$, we have the estimate $\left|t^{l / 2} \int_{U} p k(t \varphi(y), y) d y\right| \leqq C_{2}$ (for a constant $C_{2}$ independent of $t$ ) and the property (ii) in Theorem 5.4 so long as $[\kappa]>2^{-1} l-1$; furthermore, if $p\left(D_{s}\right)$ is a differential operator, they are valid when $\kappa>2^{-1} l-1$.

Theorem 5.4 is reduced to
Lemma 5.5. Let $\chi(s) \in C_{0}^{\infty}(\boldsymbol{R})$, and let $r_{0}$ be any real constant. Assume that $p(\sigma)$ is homogeneous of order $\kappa>1$ and that $h(s, r)$ is any $C^{\infty}$ function on $\boldsymbol{R} \times \boldsymbol{R}_{+}$ $\left(\boldsymbol{R}_{+}=(0, \infty)\right)$ satisfying $\sup _{(s, r) \in \boldsymbol{R} \times \boldsymbol{R}_{+}}\left|r^{i} \partial_{r}^{i} \partial_{s}^{j} h(s, r)\right|<\infty$ fo revery $i, j=0,1, \cdots$. Then for any constant $m$ with $0<m<[\kappa]([\kappa]=$ the maximum integer $<\kappa)$ we have the following properties (i) and (ii):
(i) There is a constant $C$ independent of $h$ and $t \in \boldsymbol{R}$ such that

(ii) If $r_{0} \neq 0$ and $\lim _{|s| \rightarrow \infty} \sum_{i=0}^{[r]+3} \sup _{r \in I_{+}}\left|r^{i} \partial_{r}^{i} h(s, r)\right|=0\left(I_{+}=\operatorname{supp}[\chi] \cap \boldsymbol{R}_{+}\right)$, then

If $p\left(D_{s}\right)$ is a differential operator, the above statements (i) and (ii) are valid when $1 \leqq \kappa$ and $0<m<\kappa$.

Proof. Let $\tilde{\chi}(r)$ be a $C^{\infty}$ function on $\boldsymbol{R}$ such that $\tilde{\chi}(r)=1$ when $r \leqq 1$ and $\tilde{\chi}(r)=0$ when $r \geqq 2$, and set $\chi_{\varepsilon}^{0}(r)=\tilde{\chi}(r / \varepsilon), \chi_{\varepsilon}^{1}(r)=\tilde{\chi}(\varepsilon r)-\tilde{\chi}(r / \varepsilon)$ and $\chi_{\varepsilon}^{2}(r)=1-$ $\tilde{\chi}(\varepsilon r)$, where $\varepsilon$ is a positive constant determined later. Then we have

By Lemma 5.1 we get

for a constant $C_{1}$ independent of $t, \varepsilon$ and $h$. By integration by parts, we have

\end{array}
$$

for some constants $c_{i_{1} i_{2}}$ depending only on [ $\kappa$ ]. There are constants $C_{2}$ and $C_{2}$ independent of $\varepsilon, t$ and $h$ such that

Here, Lemma 5.1 is used in the above second inequality. Therefore we have

Combining (5.4) with (5.2) yields (i) of the lemma. (5.2) (with $i=0$ ) and (5.4) imply that for any $\delta>0$ we can choose $\varepsilon$ so that $\left|I_{\varepsilon}^{i}(t)\right|<\delta$ for $i=0$ and 2 (uniformly in $t$ ). After fixing $\varepsilon$ in this way, we let $|t|$ tend to $\infty$. Then we get $\left|I_{\mathrm{e}}^{1}(t)\right|<\delta($ as $|t| \rightarrow \infty)$ also. In fact, it follows from Lemma 5.3 that

By Lemma 5.1 we see (in the above integral) that $\left|p\left(-D_{r}\right)\{\cdots\}\right| \leqq C_{1}\left(1+r^{2}\right)^{-(1+\gamma) / 2}$ $\sum_{i=0}^{[k]+3} \sup _{\rho \in \boldsymbol{R}}\left|\partial_{\rho}^{i}\left\{\left(1+\rho^{2}\right)^{(1+\gamma) / 2} h(s, \rho / t)|\rho|^{m-1} \chi(\rho / t) \chi_{\mathrm{e}}^{1}((\operatorname{sgn} t) \rho)\right\}\right| \leqq C_{2}(\varepsilon)\left(1+r^{2}\right)^{-(1+\gamma) / 2}$ $\sum_{i=0}^{[\kappa]+3} \sup _{\rho \in I_{+}}\left|\rho^{i} \partial_{\rho}^{i} h(s, \rho)\right|(0<\gamma<\kappa-1)$, where the constants $C_{1}$ and $C_{2}(\varepsilon)$ do not depend on $t$. Therefore, by the Lebesgue convergence theorem, we get $\lim _{|t| \rightarrow \infty} I_{\mathrm{z}}^{1}(t)$ $=0$. Hence (ii) of the lemma is also obtained.

Since $\partial_{s}^{-\kappa} p\left(D_{s}\right)$ is a constant if $p\left(D_{s}\right)$ is a differential operator, we can change [ $\kappa$ ] in (5.3) for $\kappa$ and carry out the above arguments with $m<\kappa$ and $\kappa \geqq 1$. Hence, in this case, (i) and (ii) in the lemma are valid also when $m<\kappa$ and $\kappa \geqq 1$. Thus Lemma 5.5 is proved.

Proof of Theorem 5.4. Since $\varphi(y)$ is minimum at $y=0$, the eigenvalues $\mu_{i}$ of $H_{\varphi}(0)$ are all positive. By means of Morse's lemma (e.g., cf. the proof of Theorem 4.1 in Mastumura [6]), we see that there exist local coordinates $y(\tilde{y})$ available in a neighborhood $U_{0}$ of the origin $y=0$ such that $\varphi(y(\tilde{y}))=\varphi(0)+2^{-1}$ $\sum_{i=1}^{l} \mu_{i} \tilde{y}_{i}^{2}\left(\tilde{y}=\left(\tilde{y}_{1}, \cdots, \tilde{y}_{l}\right)\right)$ and that $\frac{\partial y}{\partial \tilde{y}}(0)$ is an orthogonal matrix. Therefore, introducing the variables $z={ }^{t}\left(\mu_{1}^{1 / 2} \mathfrak{y}_{1}, \cdots, \mu_{l}^{1 / 2} \mathfrak{y}_{t}\right)$, we have

Assume that the support of $k(s, y)$ is contained in $\boldsymbol{R} \times U_{0}$. Then, using the variables $r=2^{-1}|z|^{2}$ and $\zeta=|z|^{-1} z$ yields that

The function $\tilde{k}(s, r, \zeta)=k(s, y(\sqrt{2 r} \zeta))\left|\operatorname{det} \frac{\partial y}{\partial z}(\sqrt{2 r} \zeta)\right|$ is a $C^{\infty}$ function on $\boldsymbol{R} \times \boldsymbol{R}_{+} \times S^{l-1}$ satisfying $\sup _{(s, r, \zeta) \in \boldsymbol{R} \times \boldsymbol{R}_{+} \times s^{l-1}}\left|r^{i} \partial_{r}^{i} \partial_{s}^{j} \tilde{k}(s, r, \zeta)\right|<\infty$ for every $i, j=$ $0,1, \cdots$ and $\tilde{k}(s, r, \zeta)=0$ when $r>r_{1}$ (for some constrnt $r_{1}$ ). Therefore we can apply Lemma 5.5 to integral $t^{l / 2} \int p\left(D_{s}\right) k r^{(l-2) / 2}\left|\operatorname{det} \frac{\partial y}{\partial z}\right| d r$, and from (i) of Lemma 5.5 derive

This yields (i) of Theorem 5.4. $\lim _{|s| \rightarrow \infty}$ $\sum_{i=0}^{\left[{ }^{[r]+3}\right.} \sup _{\substack{(r, \zeta) \in \boldsymbol{R}_{+} \times s^{l-1}}}\left|r^{i} \partial_{r}^{i} \tilde{k}(s, r, \zeta)\right|=0$ follows from $\lim _{\substack{|s| \rightarrow \infty \\|\alpha| \alpha \mid<+3 \\ y \in J}} \sup _{y}^{\infty}\left|\partial_{y}^{\infty} k(s, y)\right|=0$. Hence, if $\varphi(0) \neq 0$ and $\lim _{|\alpha| \rightarrow \infty} \sup _{\substack{|\alpha|<\alpha+3 \\ y \in J}}\left|\partial_{y}^{\alpha} k(s, y)\right|=0$, by (ii) of Lemma 5.5 and the Lebesgue convergence theorem we get $\lim _{\lim _{t \rightarrow \infty}} t^{t / 2} \int\left(p\left(D_{s}\right) k\right)(t \boldsymbol{\varphi}(y), y) d y=0$. Thus the requirements are obtained if $\operatorname{supp}[k] \subset \boldsymbol{R} \times U_{0}$.

If $\operatorname{supp}[k]$ is not contained in $\boldsymbol{R} \times U_{0}$, we take a function $\chi(y) \in C_{0}^{\infty}\left(U_{0}\right)$ with supp $[1-\chi] \nRightarrow 0$, and apply the above methods to $\int_{U}\left(P\left(D_{s}\right) k\right)(t \varphi(y), y)$ $\chi(y) d y$. For the other term $\int_{U}\left(p\left(D_{s}\right) k\right)\left(t_{\varphi}(y), y\right)(1-\chi(y)) d y$, we can use Theorem 5.2 since $\partial_{\varphi} \varphi(y) \neq 0$ on $\operatorname{supp}[1-\chi]$. Hence it follows that $\left|t^{l / 2} \int_{U}\left(p\left(D_{s}\right) k\right)(t \varphi(y), y)(1-\chi(y)) d y\right| \leqq C_{2}|t|^{2^{-1} l-\kappa} \rightarrow 0$ (as $\left.|t| \rightarrow \infty\right)$, which yields the required properties. Thus (i) and (ii) of Theorem 5.4 in the general case are proved. It is easy to verify the note in the case where $p(D)$ is a differential operator (by Lemma 5.5). The proof is complete.

Theorem 5.4 is not valid if $p\left(D_{s}\right)=J_{ \pm}\left(=\left(-\partial_{s}\right)_{ \pm}^{l / 2}\right.$ defined in §1), but we obtain similar results:

Theorem 5.6. Let (5.1) be satisfied, and assume that $k(s, y)$ is any function $\in \mathscr{B}^{\infty}(\boldsymbol{R} \times U)$ such that supp $[k] \subset \boldsymbol{R} \times U$. Then we have the following properties (i) and (ii):
(i) There is a constant $C$ independent of $k$ and $t \in \boldsymbol{R}$ such that

Proof. We give the proof only when $l$ is odd since we can get the theorem by much easier methods when $l$ is even.
(i) We can obtain (i) of Theorem 5.6 in the same way as (i) of Theorem 5.4 if we have the following estimate similar to the one in (i) of Lemma 5.5:

where $h$ and $\chi$ are the functions of the same types as in (i) of Lemma 5.5 and $m$ is the integer with $(l+6) / 2 \leqq m \leqq(l+7) / 2$. Define $I_{8}^{i}(t)(i=0,1,2)$ in the same way as in the proof of Lemma 5.5. Then it is easy to see that $\left|I_{\mathrm{e}}^{i}(t)\right| \leqq C_{2} \sum_{j=0}^{[1 / 2]+4}$ $\left\|\sup _{r \in R_{+}}\left|\partial_{s}^{j} h(s, r)\right|\right\|_{L_{s}^{2}}$ for $i=0$ and 1 .

When $l$ is odd, $\partial_{s}^{-(l+1) / 2} J_{ \pm}$is written in the form $\partial_{s}^{-(l+1) / 2} J_{ \pm} h(s)=\int_{-\infty}^{\infty} \chi_{ \pm}(\tau)$ $h(s-\tau) d \tau$ for some functions $\chi_{ \pm}(\tau)$ homogeneous of order $-1 / 2$ (cf. the proof of Theorem 1.2 in Soga [8]). We take $\psi_{1}(s) \in C^{\infty}(\boldsymbol{R})$ such that $\left|\psi_{1}\right| \leqq 1, \psi_{1}(s)$ $=1$ for $|s|<1$ and $=0$ for $|s|>2$, and set $\psi_{2}(s)=1-\psi_{1}(s)$. By the same calculation as in (5.3) (with $p=J_{ \pm}$and $m=l / 2$ ), we have

I^{2}(t)= & \sum_{i_{1}+i_{2}=\kappa} c_{i_{1} i_{2}}\left[\int_{1 / \varepsilon}^{\infty}\left\{\int_{|\tau| \leq 1 / \varepsilon} \chi_{ \pm}(\tau) h_{i_{1}}((\operatorname{sgn} t) r-\tau, r) d \tau\right\} \alpha_{i_{1} i_{2}}(r) d r\right. \\
& \left.+\sum_{j=1,2} \int_{1 / \varepsilon}^{\infty}\left\{\int_{|\tau|>1 / z} \chi_{ \pm}(r) \psi_{j}(\tau / r) h_{i_{1}}((\operatorname{sgn} t) r-\tau, r) d \tau\right\} \alpha_{i_{1} i_{2}}(r) d r\right] \\
\equiv & \left.\sum_{i_{1}+i_{2}=\kappa} c_{i_{1} i_{2}}\left[\Phi_{i_{1} i_{2}}^{0}(t)+\sum_{j=1,2} \Phi_{i_{1} i_{2}}^{j}(t)\right] \quad(\kappa=(l+1) / 2)\right)
\end{aligned}
$$

where $h_{i_{1}}(s, r)=\partial_{r_{1}^{1}}^{i_{1}} h\left(s+t r_{0}, r \| t \mid\right) r^{i_{1}}|t|^{-i_{1}}$ and $\alpha_{i_{1} i_{2}}(r)=r^{-i_{1}} \partial_{r_{2}}^{i_{2}}\left\{r^{(l-2) / 2} \chi(r| | t \mid)\right.$ $\left.\chi_{\mathrm{e}}^{2}(r)\right\}$. Since $\left|\alpha_{i_{1} i_{2}}(r)\right| \leqq C_{3}(1+|r|)^{-3 / 2}$ (for a constant $C_{3}$ independent of $t$ and $r)$, it follows that

\left|\Phi_{i_{1} i_{2}}^{0}(t)\right| \leqq C_{3}| |(1+|r|)^{-3 / 2}\left|\left\|_{L^{2}} \int_{|\tau| \leq 1 / \mathrm{e}}\left|\chi_{ \pm}(\tau)\right| d \tau\right\|_{r \in R_{+}}\right| h_{i_{1}}(s, r) \mid \|_{L_{s}^{2}}, \\
\left|\Phi_{i_{1} i_{2}}^{1}(t)\right| \leqq C_{3} \int_{1 / \mathrm{e}}^{\infty} d r \int_{1 / \varepsilon \ll \tau \mid<2 r} d \tau\left|\chi_{ \pm}(\tau) \tau^{-\delta} h_{i_{1}}((\operatorname{sgn} t) r-\tau, r)\right|(1+|r|)^{-3 / 2}(2 r)^{\delta} \\
\leqq C_{4}\left\|\sup _{r \in R_{+}}\left|h_{i_{1}}(s, r)\right|\right\|_{L_{s}^{2}}(0<\delta<1 / 2) .
\end{gathered}
$$

The function $\tilde{h}_{i_{1 i 2}}(s, r) \equiv \int_{\infty}^{r} h_{i_{1}}(s, \rho) \alpha_{i_{1} i_{2}}(\rho) d \rho$ satisfies $\left|\tilde{h}_{i_{1} i_{2}}(s, r)\right| \leqq C_{5} \sup _{\rho \in R_{+}} \mid h_{i_{1}}(s$, $\rho) \mid(1+|r|)^{-1 / 2}$. On the hand, by integration by parts we have

\Phi_{i_{1} i_{2}}^{2}(t)=\int_{1 / \mathrm{e}}^{\infty} d r \int_{r<\mid \tau 1} d \tau\left\{-(\operatorname{sgn} t) \chi_{ \pm}^{\prime}(\tau) \psi_{2}(\tau / r)-(\operatorname{sgn} t) \chi_{ \pm}(\tau) \frac{1}{r} \psi_{2}^{\prime}(\tau / r)\right. \\
\left.+\chi_{ \pm}(\tau) \frac{\tau}{r^{2}} \psi_{2}^{\prime}(\tau / r)\right\} \tilde{h}_{i_{1} i_{2}}((\operatorname{sgn} t) r-\tau, r)
\end{gathered}
$$

Therefore it follows that

$$
\begin{array}{r}
\left|\Phi_{i_{1} i_{2}}^{2}(t)\right| \leqq C_{6} \int_{1 / \mathrm{s}}^{\infty} r^{-1-\delta} d r\left\|(1+|\tau|)^{-1+\delta}\right\|_{L^{2}}\left\|\sup _{\rho \in R_{+}}\left|h_{i_{1}}(\tau, \rho)\right|\right\|_{L_{\tau}^{2}} \\
(0<\delta<1 / 2)
\end{array}
$$

Thus (5.6) is obtained.
(ii) Next let us prove (ii) of Theorem 5.6, In veiw of (5.5) we have

\begin{aligned}
& t^{l / 2} \int_{U}\left(J_{ \pm} k\right)( \pm t \varphi(y), y) d y \\
& =2^{(l-2) / 2} \int_{S^{t-1}} d \zeta t^{l / 2} \int_{0}^{\infty}\left(J_{ \pm} k\right)( \pm t r, 0)\left|\operatorname{det} \frac{\partial y}{\partial z}(0)\right| \chi(r) r^{(l-2) / 2} d r \\
& \quad+t^{-1 / 4} \int_{S^{t-1}}\left\{t^{(2 l+1) / 4} \int_{0}^{\infty}\left(J_{ \pm} \tilde{k}\right)( \pm t r, r, \zeta) r^{(2 l+1) / 4-1} d r\right\} d \zeta \\
& \quad \equiv I_{1}(t)+I_{2}(t)
\end{aligned}
$$

where $\chi(r)$ is a $C^{\infty}$ function satisfying $\chi(r)=1$ for $r \leqq 1$ and $\chi(r)=0$ for $r \geqq 2$, and $\tilde{k}(s, r, \zeta)$ is of the form

$$
\begin{aligned}
\tilde{k}(s, r, \zeta)=2^{(l-2) / 2} & \left\{k(s, y(\sqrt{2 r} \zeta))\left|\operatorname{det} \frac{\partial y}{\partial z}(\sqrt{2 r} \zeta)\right|\right. \\
& \left.-k(s, 0)\left|\operatorname{det} \frac{\partial y}{\partial z}(0)\right| \chi(r)\right\} r^{-1 / 4}
\end{aligned}
$$

It is seen that $h(s, r, \zeta)=\int_{0}^{s} \tilde{k}(\tau, r, \zeta) d \tau$ satisfies $\sup _{(s, r, \zeta) \in \boldsymbol{R} \times \boldsymbol{R}_{+} \times s^{l-1}}\left|r^{i} \partial_{r}^{i} \partial_{s}^{j} h(s, r, \zeta)\right|$ $<\infty$ for every $i, j=1,2, \cdots$, and that $J_{ \pm} \tilde{k}=J_{ \pm} \partial_{s} h$. Applying Lemma 5.5 with $p\left(D_{s}\right)=J_{ \pm} \partial_{s}$ and $m=(2 l+1) / 4$, we get $\sup _{\substack{t \geq 1 \\ \zeta \in s^{l-1}}} \mid t^{(2 l+1) / 4} \int_{0}^{\infty}\left(J_{ \pm} \tilde{k}\right)( \pm t r, r, \zeta) r^{((2 l+1) / 4)-1}$ $d r \mid<\infty$, which yields that $\lim _{t \rightarrow \infty} I_{2}(t)=0$.

When $l$ is odd, $J_{ \pm}$are of the form $\left(-\partial_{s}\right)^{(l-1) / 2} \lambda_{ \pm}\left(D_{s}\right)$, where $\lambda_{ \pm}(\sigma)$ are defined by $\lambda_{ \pm}(\sigma)=2^{-1 / 2}(1-i) \sigma^{1 / 2}$ for $\sigma \geqq 0$ and $= \pm 2^{-1 / 2}(1+i)|\sigma|^{1 / 2}$ for $\sigma<0$. By integration by parts, we have

$$
\begin{aligned}
I_{1}(t)= & ( \pm 1)^{(l-1) / 2} 2^{(l-2) / 2}\left(\frac{l-2}{2} \frac{l-4}{2} \cdots \frac{1}{2}\right)\left|\operatorname{det} \frac{\partial y}{\partial z}(0)\right| \\
& \int_{S^{l-1}} d \zeta t^{1 / 2} \int_{0}^{\infty}\left(\lambda_{ \pm} k\right)( \pm t r, 0) r^{-1 / 2} \chi(r) d r \\
+ & ( \pm 1)^{(l+1) / 2} 2^{(l-2) / 2}\left|\operatorname{det} \frac{\partial y}{\partial z}(0)\right| \int_{S^{l-1}} d \zeta t^{-1 / 2} \int_{0}^{\infty}\left(\lambda_{ \pm} h\right)( \pm t r, 0) \\
& \partial_{r}\left\{\partial_{r}^{(l-1) / 2}\left(r^{(l-2) / 2} \chi(r)\right)-\left(\partial_{r}^{(l-1) / 2} r^{(l-2) / 2}\right) \chi(r)\right\} d r
\end{aligned}
$$

where $h(s)=\int_{0}^{s} k(\tau, 0) d \tau$. Since $\lambda_{ \pm} h(s) \in \mathscr{B}^{0}(\boldsymbol{R})$, the second term of the right side in the above equality converges to 0 as $|t| \rightarrow \infty$. Therefore, by means of Lemma 5.7 below, we obtain $\lim _{t \rightarrow \infty} I_{1}(t)=c_{ \pm}^{l}(2 \pi)^{l / 2}\left(\operatorname{det} H_{\varphi}(0)\right)^{-1 / 2} K(0,0)$. Thus (ii) of Theorem 5.6 is also proved.

Lemma 5.7. Let $\chi(r)$ be a $C^{\infty}$ function on $\boldsymbol{R}$ such that $\chi(r)=1$ for $r \leqq 1$
and $\chi(r)=0$ for $r \geqq 2$. Then, for any $C^{\infty}$ function $h(r)$ with $\int_{0}^{r} h(s) d s \in \mathscr{B}^{0}(\boldsymbol{R})$, we obtain

$$
\begin{aligned}
& \left|t^{1 / 2} \int_{0}^{\infty}\left(\lambda_{ \pm} h\right)( \pm t r)^{-1 / 2} \chi(r) d r-c_{ \pm} \sqrt{\pi} h(0)\right| \\
& \quad \leqq C t^{-1 / 2}\left|\int_{0}^{r} h(s) d s\right|_{3}, \quad t \geqq 1
\end{aligned}
$$

where $c_{+}=1, c_{-}=-i$ and the constant $C$ does not depend on $h$ or $t$.
We can derive the above lemma from the equalities that $\int_{-\infty}^{0}\left(\lambda_{+} k\right)(s-r)$ $(-r)^{-1 / 2} d r=\sqrt{\pi} k(s)$ and $\int_{0}^{\infty}\left(\lambda_{-} k\right)(s-r) r^{-1 / 2} d r=-i \sqrt{\pi} k(s)$ for $k(s) \in C_{0}^{\infty}(\boldsymbol{R})$ (cf. 1.13) of Soga [8]).
