

On the number of ovals of a symmetry of a compact Riemann surface

Abstract

Let X be a symmetric compact Riemann surface whose full group of conformal automorphisms is cyclic. We derive a formula for counting the number of ovals of the symmetries of X in terms of few data of the monodromy of the covering $X \rightarrow X/G$, where $G = \text{Aut}^\pm X$ is the full group of conformal and anticonformal automorphisms of X .

Introduction

A *symmetry* on a compact Riemann surface X is an anticonformal involution $\tau : X \rightarrow X$, and surfaces admitting some symmetry are called *symmetric*. Under the well known equivalence between compact Riemann surfaces and (smooth, projective) complex algebraic curves, the symmetries correspond to *real algebraic curves*, that is, curves which may be defined over the field of real numbers. The fixed point set of a symmetry is either empty or consists of a disjoint union of simple closed curves, called *ovals* in Hilbert's terminology. These correspond to the connected components of the set of \mathbb{R} -rational points of the associated real algebraic curve.

The study of ovals on surfaces is a classical problem started at the end of the XIX century by Harnack [6], Klein [7] and Weichold [15], among others. Concerning the computation of the number of ovals, the seminal result is Harnack's bound, which states that the maximum number of ovals of a symmetry on a genus g compact Riemann surface is $g + 1$. More recently, efforts have been directed to obtain bounds for the sum of the number of ovals of all symmetries of a surface of genus g . Natanzon [12] showed, among other things, that this sum does not exceed $42(g - 1)$, and in [4] this bound

was improved to $12(g - 1)$ (for $g \neq 2, 3, 5, 7, 9$) and proved to be sharp for infinitely many values of g . Other bounds for the sum of the number of ovals of k non-conjugate symmetries are due to Singerman [14] and the fourth author [5]. Related results on ovals of symmetries appear in [9, 11].

On the other hand, there are few results concerning the difficult task of computing the precise value of the number of ovals of symmetries. This paper deals with this problem in the case of Riemann surfaces X whose full group Aut^+X of conformal automorphisms is cyclic (although our results are valid in a more general context, see Remark 2.6). Let $\text{Aut}^\pm X$ be the full group of conformal and anticonformal automorphisms of X . We derive a formula in terms of surprisingly few data of the monodromy of the covering $X \rightarrow X/\text{Aut}^\pm X$ (see Theorem 2.1) which provides the precise value of the sum of the number of ovals of the conjugacy classes of symmetries of X . The main result in [2] can be seen as a particular case of this formula, see also [8]. In Section 3 we obtain sharp bounds for this sum in terms of the genus g and of the nature of the 2-extension $\text{Aut}^\pm X$ of the cyclic group Aut^+X . Some applications to compute the number of ovals of a single symmetry are given in Section 2. In the proofs we use the combinatorial theory of Riemann surfaces and non-euclidean crystallographic groups.

1. Preliminaries

A non-Euclidean crystallographic (NEC) group is a discrete group of (orientation preserving or reversing) isometries of the hyperbolic plane U with compact quotient space. The *signature* $\sigma(\Lambda)$ of an NEC group Λ is a collection of non-negative integers and symbols of the form

$$(1.1) \quad \sigma(\Lambda) = (h; \pm; [m_1, \dots, m_r]; \{(n_{11}, \dots, n_{1s_1}), \dots, (n_{k1}, \dots, n_{ks_k})\}),$$

which determines the algebraic structure of Λ and the geometric structure of its quotient orbifold U/Λ . This has genus h , $k \geq 0$ boundary components, and it is orientable if the sign “+” occurs, and non-orientable otherwise. The integers m_1, \dots, m_r are the *proper periods* of Λ , and represent the branching over interior points of U/Λ in the natural projection $U \rightarrow U/\Lambda$. The k brackets $(n_{i1}, \dots, n_{is_i})$ are the *period cycles* and represent the branching over the i -th boundary component. The integers n_{ij} are the *link periods*. An *empty period cycle* corresponds to a boundary component with no ramification over it, *i.e.*, it has no link periods, and it will be represented by $(-)$. For short, we say that a period cycle of Λ is *odd* if it is non-empty and all its link periods are odd. The signature also determines the algebraic structure of Λ . It has generators

- x_1, \dots, x_r (elliptic isometries)
- $c_{10}, \dots, c_{1s_1}, \dots, c_{k0}, \dots, c_{ks_k}$ (reflections)
- e_1, \dots, e_k (orientation preserving isometries, which will be called *connecting generators*)
- $a_1, b_1, \dots, a_h, b_h$ (hyperbolic isometries) if the sign of $\sigma(\Lambda)$ is “+” or d_1, \dots, d_h (glide reflections) otherwise.

and relations

- $x_i^{m_i} = 1$ for $i = 1, \dots, r$;
- $c_{i,j-1}^2 = c_{ij}^2 = (c_{i,j-1}c_{ij})^{n_{ij}} = 1$, for $i = 1, \dots, k$, and $j = 1, \dots, s_i$;
- $e_i c_{i0} e_i^{-1} c_{is_i} = 1$
- $x_1 \cdots x_r e_1 \cdots e_k [a_1, b_1] \cdots [a_h, b_h] = 1$ if the sign “+” occurs, and $x_1 \cdots x_r e_1 \cdots e_k d_1^2 \cdots d_h^2$ otherwise.

A set of generators as the above is called a *set of canonical generators*. Any reflection in Λ is conjugate within Λ to a canonical one. Moreover, it follows from the presentation that all the canonical reflections of an odd period cycle are mutually conjugate, and that the number of conjugacy classes of reflections of a period cycle with $v > 0$ even link periods is v .

The area of a fundamental domain for an NEC group Λ with signature (1.1) is

$$(1.2) \quad \mu(\Lambda) = 2\pi \left(\eta h + k - 2 + \sum_{i=1}^r \left(1 - \frac{1}{m_i} \right) + \frac{1}{2} \sum_{i=1}^k \sum_{j=1}^{s_i} \left(1 - \frac{1}{n_{ij}} \right) \right),$$

where $\eta = 1$ if the sign “-” occurs and $\eta = 2$ otherwise. If Δ is a subgroup of Λ of finite index then the *Riemann-Hurwitz formula* reads

$$(1.3) \quad \mu(\Delta) = [\Lambda : \Delta] \mu(\Lambda).$$

For each compact Riemann surface X of genus $g \geq 2$ there exists a *surface Fuchsian group* Γ *i.e.*, a torsion free NEC group with sign “+”, such that X is isomorphic to the quotient surface U/Γ . Each subgroup G of the full group $\text{Aut}^\pm X$ of conformal and anticonformal automorphisms of X is isomorphic to a quotient Λ/Γ for some NEC group Λ containing Γ as a normal subgroup. Hence, there exists an epimorphism $\theta : \Lambda \rightarrow G$ with $\ker \theta = \Gamma$. Epimorphisms as the above whose kernel is a surface Fuchsian group will be called *smooth*. The subgroup of $\text{Aut}^\pm X$ consisting of conformal automorphisms will be denoted by $\text{Aut}^+ X$.

Let τ be a symmetry on a compact Riemann surface X of genus $g \geq 2$, and let u be a conformal automorphism of X of order n such that τ normalizes $\langle u \rangle$, that is, $\tau u \tau \in \langle u \rangle$. Then the group $\langle u, \tau \rangle$ has a presentation of the form

$$(1.4) \quad G_n^\alpha := \langle u, \tau \mid u^n = \tau^2 = 1, \tau u \tau = u^\alpha \rangle,$$

where $\alpha^2 \equiv 1 \pmod{n}$. For example, G_n^α is abelian if and only if $\alpha = 1$, and dihedral if and only if $\alpha = n - 1$.

Notice that if $\text{Aut}^+ X = \langle u \rangle$ is cyclic then τ normalizes $\langle u \rangle$, and so $\text{Aut}^\pm X = G_n^\alpha$ for some α .

Viewing G_n^α as a group of automorphisms of X , those involutions in G_n^α which can be written with an odd number of occurrences of the letter τ are symmetries of X , and so we call them the *symmetries* of G_n^α . We will represent by $\|s\|$ the number of ovals of a symmetry s .

We fix the following notations. The cyclic group of order n will be denoted by C_n . We set

$$d = \text{gcd}(n, \alpha + 1) \quad \text{and} \quad f = \text{gcd}(n, \alpha - 1),$$

where gcd stands for the greatest common divisor. Note that $\text{gcd}(d, f) = 1$ if n is odd and $\text{gcd}(d, f) = 2$ otherwise.

Let us state first a purely group theoretic lemma concerning the conjugacy classes of symmetries in G_n^α .

Lemma 1.1 *A set of representatives of all the conjugacy classes of symmetries in G_n^α is the following:*

- $\{\tau\}$ if n is odd or $\alpha^2 \not\equiv 1 \pmod{2n}$;
- $\{\tau, u^{n/d}\tau\}$ if n is even and $\alpha^2 \equiv 1 \pmod{2n}$.

Proof. It is easy to check that the symmetries in G_n^α are of the form $u^{jn/d}\tau$ for $j = 1, \dots, d$. Conjugation by u gives $u^{jn/d}\tau \sim u^{(\alpha-1)+jn/d}\tau$; hence, conjugation by u groups the d symmetries into sets of $h := \text{ord}(u^{\alpha-1}) = n/f$ elements. We claim that $h = d$ or $d/2$. First, $h|d$ because $h|n$ and also $h|(\alpha+1)$ since $(u^{\alpha-1})^{\alpha+1} = u^{\alpha^2-1} = 1$. Now, d/h divides $\alpha + 1$, and d/h also divides $n/h = f$ which in turn divides $\alpha - 1$; hence d/h divides $\text{gcd}(\alpha + 1, \alpha - 1) = 1$ or 2 , proving our claim. If $h = d$ then the d symmetries $u^{jn/d}\tau$ are all conjugate (via powers of u) to τ , for instance. If, on the contrary, $d = 2h$ then all the symmetries $u^{jn/d}\tau$ are conjugate via powers of u to either τ or $u^{n/d}\tau$. Since the other generator τ of G_n^α does not conjugate these two symmetries, they are representatives of the two conjugacy classes of symmetries in G_n^α . Finally, observe that $d = 2h$ if and only if $\text{gcd}(n, \alpha + 1) \text{gcd}(n, \alpha - 1) = 2n$ and this happens if and only if n is even and $2n$ divides $(\alpha + 1)(\alpha - 1)$. ■

Remark 1.2 We have just shown that $n/f = d$ or $n/f = d/2$. In fact,

- i) If n is odd or $\alpha^2 \not\equiv 1 \pmod{2n}$ then $n = df$ and all of the d symmetries in G_n^α are conjugate to τ .
- ii) If n is even and $\alpha^2 \equiv 1 \pmod{2n}$ then $2n = df$ and $d/2$ symmetries in G_n^α are conjugate to τ and the other $d/2$ to $u^{n/d}\tau$.

In order to compute the number of ovals of a symmetry we need a description of the centralizer of a reflection c in an NEC group. Singerman [13] proved that this centralizer is $C_2 \oplus C_\infty$, if c corresponds to an empty or an odd period cycle, and to $C_2 \oplus (C_2 * C_2)$ otherwise, where C_∞ is the cyclic group of infinite order, and $*$ stands for the free product. Going a bit more into the details of Singerman’s proof, one can find explicitly the generators of this group.

Lemma 1.3 *Let e, c_0, \dots, c_s be a set of canonical generators associated to a period cycle (n_1, \dots, n_s) of an NEC group Λ and let $C(\Lambda, c_i)$ be the centralizer in Λ of c_i .*

(i) *If $s = 0$ then $C(\Lambda, c_0) = \langle c_0 \rangle \oplus \langle e \rangle$.*

(ii) *If $s \neq 0$ and all n_i are odd then $C(\Lambda, c_0) = \langle c_0 \rangle \oplus \langle \prod_{i=0}^{s-1} (c_{i+1}c_i)^{(n_{i+1}-1)/2} e \rangle$.*

(iii) *If n_i, n_j are even and n_{i+1}, \dots, n_{j-1} are odd ($i < j \leq s$) then*

$$C(\Lambda, c_i) = \langle c_i \rangle \oplus \left(\langle (c_{i-1}c_i)^{n_i/2} \rangle * \langle x^{-1}(c_{j-1}c_j)^{n_j/2} x \rangle \right),$$

where $x = (c_{j-2}c_{j-1})^{(n_{j-1}-1)/2} \dots (c_i c_{i+1})^{(n_{i+1}-1)/2}$.

(iv) *If n_i is even, $n_{i+1}, \dots, n_s, n_1, \dots, n_{j-1}$ are odd and n_j is even with $1 \leq j \leq i$ then*

$$C(\Lambda, c_i) = \langle c_i \rangle \oplus \left(\langle (c_{i-1}c_i)^{n_i/2} \rangle * \langle x^{-1}(c_{j-1}c_j)^{n_j/2} x \rangle \right),$$

$$\text{where } x = \prod_{t=1}^{j-1} (c_{j-1-t}c_{j-t})^{(n_{j-t}-1)/2} e^{-1} \prod_{t=0}^{s-i-1} (c_{s-1-t}c_{s-t})^{(n_{s-t}-1)/2}.$$

Proof. Claim (i) is actually proved by Singerman in [13]. For (ii), observe that $\beta = e^{-1}(c_{s-1}c_s)^{(n_s-1)/2} \dots (c_1c_2)^{(n_2-1)/2}(c_0c_1)^{(n_1-1)/2}$ belongs to $C(\Lambda, c_0)$, which gives one of the inclusions. For the converse, let F be a fundamental region for Λ , and let $\gamma_0, \gamma_1, \dots, \gamma_s$ be the part of the surface symbol for F corresponding to the period cycle (n_1, \dots, n_s) . The axis ℓ of c_0 splits into intervals being edges of the images of F abutting ℓ , each segment having

a label from the surface symbol to which it belongs. Now for $\lambda \in \Lambda$, the element $\lambda c_0 \lambda^{-1}$ is a reflection with axis $\lambda(\ell)$. So λ centralizes c_0 if and only if $\lambda(\ell) = \ell$ while the last is true if and only if $\lambda(F)$ abuts ℓ at an edge labelled by γ_0 . Thus there is a bijective correspondence between segments of ℓ labelled by γ_0 and elements of $C(\Lambda, c_0)$. Finally

$$(c_i c_{i+1})^{(n_{i+1}-1)/2} c_i (c_i c_{i+1})^{-(n_{i+1}-1)/2} = c_{i+1} \quad \text{and} \quad e^{-1} c_s e = c_0.$$

So the segment labelled by γ_i is followed by γ_{i+1} for $i = 0, \dots, s - 1$ while γ_s by γ_0 . Therefore $\gamma_0, \gamma_1, \dots, \gamma_s, \gamma_0$ are the labels of consecutive segments on ℓ and this labelling repeats on ℓ periodically. Hence c_0 and β generate $C(\Lambda, c_0)$ indeed.

Proofs of claims (iii) and (iv) are similar and we omit them. ■

2. Main result

Let $X = U/\Gamma$ be a symmetric Riemann surface whose full group of conformal automorphisms $\text{Aut}^+ X$ is cyclic of order n , say $\text{Aut}^+ X = \langle u \rangle$. Then $\text{Aut}^\pm X = G_n^\alpha$ for some α , where G_n^α has presentation (1.4). Let $\theta : \Lambda \rightarrow G_n^\alpha = \langle u, \tau \rangle$ be the associated smooth epimorphism with $\ker \theta = \Gamma$. Let us write $\theta(e_i) = u^{\varepsilon_i}$ where e_1, \dots, e_k is a set of connecting generators associated to the k period cycles of Λ . Recall that a non-empty period cycle is said to be *odd* if all its link periods are odd. The next theorem shows the close relation between the integers ε_i and the number of ovals of the symmetries of X . We stress that this result is stated for surfaces with $\text{Aut}^+ X$ cyclic, but it can be applied to a wider variety of Riemann surfaces, see Remark 2.6.

Theorem 2.1 *With the above notations, let us consider the following subsets of $\{1, \dots, k\}$:*

- $T = \{i \mid \text{the } i^{\text{th}} \text{ period cycle of } \Lambda \text{ is empty}\};$
- $S_1 = \{i \mid \text{the } i^{\text{th}} \text{ period cycle of } \Lambda \text{ is odd and } \frac{\varepsilon_i(\alpha+1)}{\gcd(\varepsilon_i(\alpha+1), n)} \text{ is odd}\};$
- $S_2 = \{i \mid \text{the } i^{\text{th}} \text{ period cycle of } \Lambda \text{ is odd and } \frac{\varepsilon_i(\alpha+1)}{\gcd(\varepsilon_i(\alpha+1), n)} \text{ is even}\}.$

Let v be the total number of even link periods in the signature of Λ . Then

$$(2.1) \quad \|\tau\| + \|u^{n/d}\tau\| = \sum_{i \in T} \frac{2 \gcd(\varepsilon_i, n)}{d} + \sum_{i \in S_1} \gcd\left(\frac{n}{d}, \varepsilon_i\right) + 2 \sum_{i \in S_2} \gcd\left(\frac{n}{d}, \varepsilon_i\right) + v \frac{n}{d}.$$

If Λ has no period cycle then $\|\tau\| = 0$ for each symmetry τ in X .

Proof. Observe first that each $\theta(e_i)$ is indeed of the form u^{ε_i} since $\theta(e_i)$ belongs to $\langle u \rangle$, the orientation preserving subgroup of G_n^α . If Λ has no period cycle then Λ contains no reflection and each symmetry τ in G_n^α is the image of a glide reflection. It follows that the fixed point set of τ is empty. If Λ has some period cycle then the image $\theta(c)$ of each canonical reflection c is a symmetry s whose fixed point set is non-empty. In this case, Theorem 3.1 in [4] shows that $\|s\| = \sum_i [C(G_n^\alpha, \theta(c_i)) : \theta(C(\Lambda, c_i))]$ where $C(G, g)$ denotes the centralizer in the group G of the element $g \in G$ and the sum is taken over a set of representatives of conjugacy classes of canonical reflections in Λ whose images under θ are conjugate within G_n^α to s .

Assume first that n is even and $\alpha^2 \equiv 1 \pmod{2n}$. Then each $\theta(c_i)$ is conjugate to either τ or $u^{n/d}\tau$, and so

$$(2.2) \quad \|\tau\| + \|u^{n/d}\tau\| = \sum_i [C(G_n^\alpha, \theta(c_i)) : \theta(C(\Lambda, c_i))]$$

where now the sum is taken over all representatives of conjugacy classes of canonical reflections in Λ . There are $t + s + v$ of such classes, where t is the number of empty period cycles, s is the number of odd period cycles, and v is the total number of even link periods in the signature of Λ . So the sum in (2.2) has terms of three types.

For those terms corresponding to reflections c_i associated to empty period cycles, part (i) in Lemma 1.3 yields $|\theta(C(\Lambda, c_i))| = 2 \operatorname{ord}(u^{\varepsilon_i}) = 2n / \gcd(\varepsilon_i, n)$.

Let c_i be a reflection such that the corresponding link period n_i is even. Parts (iii) and (iv) in Lemma 1.3 show that $|\theta(C(\Lambda, c_i))| = 2|H|$ where H is the image of the group $\langle (c_{i-1}c_i)^{n_i/2} \rangle * \langle x^{-1}(c_{j-1}c_j)^{n_j/2}x \rangle$ for a certain $x \in \Lambda$. In fact, x is an orientation preserving element and so the image of H lies in the cyclic group $\langle u \rangle$; in addition, $\theta(c_{i-1}c_i)^{n_i/2} = \theta(c_{j-1}c_j)^{n_j/2} = u^{n/2}$. It follows that $|\theta(C(\Lambda, c_i))| = 4$.

Let us consider now an odd period cycle (n_1, \dots, n_s) of Λ . Let c_0, \dots, c_s be a set of canonical reflections associated to it, and e be its connecting generator, with image $\theta(e) = u^\varepsilon$. The image $\theta(c_i)$ of each reflection c_i is a symmetry in $G_n^\alpha = \langle u, \tau \rangle$ and so it is of the form $\theta(c_i) = u^{h_i n/d} \tau$ for some $h_i \in \{1, \dots, d\}$. In particular,

$$\theta(c_{i+1}c_i) = u^{(h_{i+1} + \alpha h_i)n/d} = u^{(h_{i+1} - h_i)n/d},$$

and from the relation $ec_0 = c_s e$ we get $\varepsilon(\alpha - 1) \equiv (h_0 - h_s)n/d \pmod{n}$. Part (ii) in Lemma 1.3 shows that the order of $\theta(C(\Lambda, c_0))$ is twice the order of $\prod_{i=0}^{s-1} \theta(c_{i+1}c_i)^{(n_{i+1}-1)/2} \theta(e)$, which is an element of the form u^h . It is easier to compute the order of its square u^{2h} . Indeed, $\theta(c_{i+1}c_i)^{n_{i+1}-1} = \theta(c_{i+1}c_i)^{-1} = u^{(h_i - h_{i+1})n/d}$ and so

$$2h \equiv \sum_{i=0}^{s-1} (h_i - h_{i+1})n/d + 2\varepsilon \equiv (h_0 - h_s)n/d + 2\varepsilon \equiv \varepsilon(\alpha + 1) \pmod{n}.$$

Comparing $\gcd(n, 2h)$ with $\gcd(n, h)$ yields that

$$\text{ord}(u^h) = \begin{cases} \frac{n}{\gcd(\varepsilon(\alpha+1), n)} & \text{if } \frac{\varepsilon(\alpha+1)}{\gcd(\varepsilon(\alpha+1), n)} \text{ is even,} \\ \frac{2n}{\gcd(\varepsilon(\alpha+1), n)} & \text{otherwise.} \end{cases}$$

Since $(\alpha + 1)/d$ and n/d are coprime, we may replace $\gcd(\varepsilon(\alpha + 1), n)$ by $\gcd(\varepsilon d, n)$. Therefore

$$|\theta(C(\Lambda, c_0))| = \begin{cases} \frac{2n}{\gcd(\varepsilon d, n)} & \text{if } \frac{\varepsilon(\alpha+1)}{\gcd(\varepsilon(\alpha+1), n)} \text{ is even,} \\ \frac{4n}{\gcd(\varepsilon d, n)} & \text{otherwise.} \end{cases}$$

Finally, since $d/2$ of the d symmetries of G_n^α are conjugate to $\theta(c_0)$ we get $|C(G_n^\alpha, \theta(c_0))| = |G_n^\alpha|/(d/2) = 4n/d$. Formula (2.1) follows easily.

In case n is odd or $\alpha^2 \not\equiv 1 \pmod{2n}$, all the images of the canonical reflections in Λ are conjugate to τ . So the sum in the right hand side in (2.2) gives just $\|\tau\|$; but in this case $|C(G_n^\alpha, \theta(c_i))| = |G_n^\alpha|/d = 2n/d$, which is half of the value obtained above. On the other hand, the value of $|\theta(C(\Lambda, c_i))|$ is the same as in the preceding case, and so

$$(2.3) \quad \|\tau\| = \sum_{i \in T} \frac{\gcd(\varepsilon_i, n)}{d} + \sum_{i \in S_1} \frac{1}{2} \gcd\left(\frac{n}{d}, \varepsilon_i\right) + \sum_{i \in S_2} \gcd\left(\frac{n}{d}, \varepsilon_i\right) + v \frac{n}{2d}.$$

Therefore $\|\tau\| + \|u^{n/d}\tau\| = 2\|\tau\|$ coincides with the right hand side in (2.1). ■

Remark 2.2 Note that in order to count the number of ovals of symmetries of X we do not require the complete knowledge of the monodromy of the covering $X \rightarrow X/G_n^\alpha$. In fact, Formula (2.1) just involves the number of odd and empty period cycles, the number of even link periods and the images under θ of the connecting generators of Λ .

Formula (2.1) can be written in a much simpler way in case n is odd.

Corollary 2.3 *With the above notations, if n is odd then*

$$(2.4) \quad \|\tau\| = \sum_{i=1}^k \gcd(\varepsilon_i, f).$$

Proof. If n is odd then $n/d = f$ and $v = 0$. So, the k period cycles of Λ are either empty or odd. Moreover, S_1 is empty since $\varepsilon_i(\alpha + 1) = 2h$ is even for each ε_i (see the proof of Theorem 2.1) and $\gcd(\varepsilon_i(\alpha + 1), n)$ is odd. Now, for each $i \in T$, we have $\gcd(\varepsilon_i, n)/d = \gcd(\varepsilon_i/d, f) = \gcd(\varepsilon_i, f)$, where in the last equality we have used that d and f are coprime. ■

Remarks 2.4 (1) As particular cases of Corollary 2.3, if $\alpha = n - 1$ (G_n^α dihedral) then $f = 1$ and so $\|\tau\| = k$, which coincides with [2, Theorem 2(ii)]; if $\alpha = 1$ (G_n^α cyclic) then $f = n$ and so $\|\tau\| = \sum_{i=1}^k \gcd(\varepsilon_i, n) = \sum_{i=1}^k n/\text{ord}(\theta(e_i))$, which coincides with [10, Theorem 1(e)].

(2) If n is even and $\alpha^2 \equiv 1 \pmod{2n}$ then τ and $u^{n/d}\tau$ are not conjugate. Formula (2.1) provides the sum of the number of ovals of both symmetries, but in this case, it does not give us the precise value of each summand. In fact, the values of $\|\tau\|$ and $\|u^{n/d}\tau\|$ depend not only on the images $\theta(e_i)$ but also on the images of each canonical reflection. Indeed, it follows from the proof of Theorem 2.1 that

$$(2.5) \quad \|\tau\| = \sum_i \frac{2 \gcd(\varepsilon_i, n)}{d} + \sum_i \gcd\left(\frac{n}{d}, \varepsilon_i\right) + 2 \sum_i \gcd\left(\frac{n}{d}, \varepsilon_i\right) + v_\tau \frac{n}{d}$$

where the sums restrict to those period cycles (empty or odd) for which the images of the associated canonical reflections are conjugate to τ , and v_τ is the number of even link periods n_{ij} in $\sigma(\Lambda)$ such that the image $\theta(c_{ij})$ of the corresponding canonical reflection is conjugate to τ . An analogous formula holds for $\|u^{n/d}\tau\|$.

(3) If n is even and G_n^α is dihedral (that is, $d = n$) then

$$\|\tau\| + \|u\tau\| = \sum 2 \gcd(\varepsilon_i, n)/d + \text{card}(S_1) + 2 \text{card}(S_2) + v.$$

This is the value which should be given in Theorem 2(i) in [2] to make it correct. This mistake was pointed out in [8], where upper and lower bounds for $\|\tau\| + \|u\tau\|$ are given.

Example 2.5 Let us consider compact symmetric Riemann surfaces of genus $g = 5$ on which the cyclic group C_8 acts as a group of conformal automorphisms. Let τ be a symmetry on such a surface X . We claim that:

1. If $C_8 = \text{Aut}^+ X$ then $\|\tau\| \leq 3$. Conversely, for each $k \leq 3$ there exist a surface X_k of genus 5 such that $C_8 = \text{Aut}^+ X_k$, and a symmetry τ_k on X_k with $\|\tau_k\| = k$.
2. If $C_8 \subset \text{Aut}^+ X$ and τ normalizes C_8 , then $\|\tau\| \leq 5$. Conversely, for each $k \leq 5$ there exist a surface X_k of genus 5 such that $C_8 \subset \text{Aut}^+ X_k$, and a symmetry τ_k on X_k with $\|\tau_k\| = k$.

In fact, if C_8 acts on a genus 5 surface $X = U/\Gamma$ then $C_8 = \Delta/\Gamma$ for some Fuchsian group Δ whose signature (by Riemann-Hurwitz formula) is either $\sigma_1 = (0; +; [2, 4, 8, 8]; \{-\})$ or $\sigma_2 = (1; +; [2, 2]; \{-\})$. Theorem 4.1 in [1] on the extendability of cyclic group actions yields that if $\sigma(\Delta) = \sigma_2$

then Aut^+X is strictly larger than C_8 . Let τ be a symmetry on X which normalizes $C_8 = \langle u \rangle$. Then $\text{Aut}^\pm X$ contains $\langle u, \tau \rangle = G_8^\alpha$ for some α and so there exist an NEC group Λ and a smooth epimorphism $\theta : \Lambda \rightarrow G_8^\alpha$ with $\ker \theta = \Gamma$. Observe that the canonical Fuchsian subgroup Λ^+ of Λ equals Δ . Using Corollary 2.2.5 in [3] we get that there exist two possible signatures for Λ if $\sigma(\Delta) = \sigma_1$ and six if $\sigma(\Delta) = \sigma_2$. The “if” parts of statements 1 and 2 follow easily from formula (2.5) and a detailed analysis of the possible epimorphisms $\theta : \Lambda \rightarrow G_8^\alpha$. For the converse parts, we also have to take into account that σ_1 is a maximal Fuchsian signature (see [3, Section 5.1] for the definition of maximal signature). So if $\sigma(\Delta) = \sigma_1$ then X can be chosen such that $\text{Aut}^+X = C_8$.

The largest values (4 and 5) for the number of ovals of a symmetry, can be attained by two symmetries of the same surface. Indeed, let us consider an NEC group Λ with signature $(0; +; [-]; \{(2, 2), (-)\})$ and the smooth epimorphism $\theta : \Lambda \rightarrow G_8^1 = \langle u \rangle \times \langle \tau \rangle$ given by

$$c_{10} \mapsto u^4\tau, \quad c_{11} \mapsto \tau, \quad c_{12} \mapsto u^4\tau, \quad e_1 \mapsto u, \quad c_{20} \mapsto \tau, \quad e_2 \mapsto u^{-1}.$$

Then $X = U/\ker \theta$ is a genus 5 Riemann surface which admits two symmetries τ and $u^4\tau$ such that $\|\tau\| = 5$ and $\|u^4\tau\| = 4$, as formula (2.5) easily shows.

Remark 2.6 Theorem 2.1 may be seen as an approach to the solution of the problem of counting the number of ovals of a symmetry τ on a compact Riemann surface X . Although the theorem is stated for surfaces with cyclic full conformal automorphism group, it can also be applied to a wider variety of Riemann surfaces. Let τ be a symmetry of an arbitrary Riemann surface X which admits a non-trivial conformal automorphism u such that τ normalizes $\langle u \rangle$. Then $\langle u, \tau \rangle$ is of the form G_n^α . In this situation, Theorem 2.1 and its proof as mentioned in Remark 2.4 (2) can be applied to obtain both $\|\tau\|$ and $\|u^{n/d}\tau\|$, provided the geometric action of $\langle u, \tau \rangle$ on X , that is, the corresponding smooth epimorphism $\theta : \Lambda \rightarrow \langle u, \tau \rangle$, is known. Indeed, in the proof of Theorem 2.1, we make no use of the fact that G_n^α is the *full* automorphism group of X (but just a group acting on it), except when applying Theorem 3.1 in [4]. This theorem is proved there for the full group $\text{Aut}^\pm X$, but the proof actually works for any group containing τ .

It is worth mentioning that the existence of a non-trivial conformal automorphism u such that τ normalizes $\langle u \rangle$ is guaranteed, for example, if the group Aut^+X contains a characteristic abelian subgroup (*e.g.*, if Aut^+X itself is abelian), or if Aut^+X contains an abelian normal Sylow p -subgroup (*e.g.*, if $|\text{Aut}^+X|$ is the product of two primes).

3. Bounds

Let τ be a symmetry on a compact Riemann surface X which admits a non-trivial conformal automorphism u of order n such that τ normalizes $\langle u \rangle$. In this section we apply Theorem 2.1 to derive upper bounds for the sum of the number of ovals of the conjugacy classes of symmetries of $\langle u, \tau \rangle = G_n^\alpha$. We also show that the bounds are attained constructing, for infinitely many values of g, n and α , a compact Riemann surface of genus g on which G_n^α acts as a group of automorphisms, and a symmetry τ in X whose number of ovals reaches the proposed bound. Recall that $d = \gcd(\alpha + 1, n)$ and $f = \gcd(\alpha - 1, n)$.

We begin with the case n odd.

Proposition 3.1 *If $\langle u, \tau \rangle = G_n^\alpha$ with n odd then*

$$\|\tau\| \leq \frac{g-1}{d} + 2,$$

and the bound is attained for every odd n and every g such that $n|(g-1)$.

Proof. We first show that the bound is attained provided that $n|(g-1)$. In this case, let us consider an NEC group Λ with signature $(0; +; [-]; \{(-)^k\})$ where $k = (g-1)/n + 2$. Let $\theta : \Lambda \rightarrow G_n^\alpha$ be the homomorphism given by $\theta(e_1) = u^d, \theta(e_2) = u^{-d}, \theta(e_i) = 1$ for all $i \geq 3, \theta(c_1) = \tau, \theta(c_2) = u^f \tau, \theta(c_i) = \tau$ for all $i \geq 3$. It is easy to see that it is a well defined smooth epimorphism and so $X = U/\Gamma$, for $\Gamma = \ker \theta$, is a symmetric Riemann surface of genus g on which G_n^α acts. Corollary 2.3 gives

$$\|\tau\| = 2 \gcd(d, f) + f(k-2) = 2 + f \left(\frac{g-1}{n} \right) = \frac{g-1}{d} + 2.$$

To show that this value is an upper bound for $\|\tau\|$, observe that τ and $u^{n/d} \tau$ generate a dihedral group of order $2d$ which acts on X . Then, Theorem 3(ii) in [2] yields $\|\tau\| + \|u^{n/d} \tau\| \leq (2g-2)/d + 4$. Since d is odd, both symmetries are conjugate and so $\|\tau\| = \|u^{n/d} \tau\| \leq (g-1)/d + 2$. ■

Remark 3.2 In the conditions of the above proposition, a genus g Riemann surface X admitting a symmetry with the maximal number $(g-1)/d$ of ovals, can be chosen to have G_n^α as its full group $\text{Aut}^\pm X$ if and only if n is a *proper* divisor of $g-1$. Indeed, if this is so, then the signature $\sigma = (0; +; [-]; \{(-)^k\})$ with $k = (g-1)/n + 2 \geq 4$ used in the proof is maximal, and so we may choose a maximal NEC group Λ with this signature. With this choice, the surface U/Γ constructed there has G_n^α as its full automorphism group $\text{Aut}^\pm X$. However, if $n = g-1$ then σ is not maximal, and

indeed, an NEC group Λ such that $\text{Aut}^\pm X = \Lambda/\Gamma$ cannot have signature σ ; otherwise $\text{Aut}^+ X$ would act with Fuchsian signature $(2; -)$, and it is shown in [1] that in this case $\text{Aut}^+ X$ would contain a dihedral group. But it is not difficult to see that σ is the unique signature providing $(g - 1)/d + 2 = f + 2$ ovals. So the number of period cycles of Λ is $k \leq 2$ and it can be shown that in this case $\|\tau\| \leq (g - 1)/d = f$.

Let us deal now with n even. An upper bound for $\|\tau\| + \|u^{n/d}\tau\|$ in case G_n^α is dihedral (*i.e.*, $\alpha = n - 1$) was given in Lemma 3.3 in [11] and also in Theorems 3(i) and 4(i) in [2]. Namely, $\|\tau\| + \|u\tau\| \leq 4g/n + 2$, and the bound is attained for every n and every g such that $n|4g$. We now deal with the remainder values of α .

Proposition 3.3 *Assume that $\langle u, \tau \rangle = G_n^\alpha$ is not dihedral and n is even.*

- (1) *If n/f is even then $\|\tau\| + \|u^{n/d}\tau\| \leq (4g + 2f - n)/d$.*
 - (1.1) *If $n/(2f)$ is even then the bound is attained for every g , n and α such that n is a proper divisor of $4g + 2f$.*
 - (1.2) *If $n/(2f)$ is odd then the bound is attained for every g , n and α such that $n|(2g + f)$.*
- (2) *Assume n/f is odd.*
 - (2.1) *If $n/2$ is even then $\|\tau\| + \|u^{n/d}\tau\| \leq (4g + f - n)/d$, and the bound is attained for every g , n and α such that $(4g + f)/n$ is an odd integer ≥ 3 .*
 - (2.2) *If $n/2$ is odd then $\|\tau\| + \|u^{n/d}\tau\| \leq (4g + 4 + f - n)/d$, and the bound is attained for every g , n and α such that n is a proper divisor of $4g + 4 + f$.*

Proof. If Λ has signature (1.1) then the Riemann-Hurwitz formula yields $k + \eta h + \sum(1 - 1/m_i) + \sum(1 - 1/n_{ij})/2 = (g - 1)/n + 2$ where $\eta = 1$ or 2 according to the sign of Λ . In order to maximize the right hand side of formula (2.1) in Theorem 2.1 (keeping constant the area of Λ), it is clear that we first have to deal with NEC groups with $k = 1$, $h = 0$ and the maximum number of (even) link periods equal to 2 . Observe that there must exist an elliptic canonical generator x_1 in Λ since the images of the canonical reflections generate a subgroup of $\langle u^{n/d}, \tau \rangle$, and we are not considering the case $d = n$. So we first have to consider NEC groups Λ whose signature has the form

$$\sigma = (0; +; [m]; \{(2, .v', 2, d')\})$$

with $d' \geq 2$ (even) and m as small as possible but such that $\text{lcm}(m, d') = n$ (to assure the surjectivity of $\theta : \Lambda \rightarrow G_n^\alpha$). Here lcm stands for the least common multiple. Observe that, up to an automorphism in G_n^α , the images of the canonical reflections are of the form $\theta(c_{2i}) = \tau$, $\theta(c_{2i+1}) = u^{n/2}\tau$ for $2i + 1 \leq v'$, while $\theta(x_1) = u^{n/m}$. Since $\theta(c_{v'}c_{v'+1})$ has order d' , we get $\theta(c_{v'+1}) = u^{hn/d'}\tau$ where h is prime with d' or $d'/2$ according to the parity of v' . But also $\theta(c_{v'+1}) = \theta(e_1c_0e_1^{-1}) = u^{(\alpha-1)n/m}\tau$ and so

$$\gcd(hn/d', n) = \gcd((\alpha - 1)n/m, n).$$

This yields $d' = m/\gcd(\alpha - 1, m)$ or $d' = 2m/\gcd(\alpha - 1, m)$. In the first case, $d'|m$ and so $n = \text{lcm}(m, d') = m$ and $d' = n/f$. In the second, $m = n$ and $d' = 2n/f$ if m is even, while $m = n/2$ and $d' = 2n/f$ if m is odd. This leads us to consider the following three signatures:

- $\sigma_1 = (0; +; [n]; \{(2, \dots, 2, n/f)\})$ with $v' = (4g + 2f)/n - 2$;
- $\sigma_2 = (0; +; [n]; \{(2, \dots, 2, 2n/f)\})$ with $v' = (4g + f)/n - 2$;
- $\sigma_3 = (0; +; [n/2]; \{(2, \dots, 2, 2n/f)\})$ with $v' = (4g + f + 4)/n - 2$ and $n/2$ odd.

If n/f is even then the largest number of ovals is given by σ_1 , namely $(v' + 1)n/d = (4g + 2f - n)/d$. Let us study whether this bound is attained. Observe that $\theta(c_{v'+1}) = u^{\alpha-1}\tau$ and $\theta(x_1) = u$. If v' is even then $\theta(c_{v'}) = \tau$ and it is easy to see that θ is a well defined smooth epimorphism. However, if v' is odd, then $\theta(c_{v'}) = u^{n/2}\tau$, and for $\theta(c_{v'}c_{v'+1})$ to have order n/f , it has to be $\gcd(\alpha - 1 + n/2, n) = f$; this happens if and only if $n/(2f)$ is even. Therefore, if $n/(2f)$ is even then the bound is attained independently of the parity of v' , while if $n/(2f)$ is odd, then v' is required to be even. This proves part (1) of the proposition.

If n/f is odd and $n/2$ is even then the largest number of ovals is given by σ_2 , namely $(4g + f - n)/d$. If v' is even then $\theta(c_{v'}c_{v'+1}) = u^{1-\alpha}$, whose order is not $2n/f$. Hence there is no smooth epimorphism in this case. However, if v' is odd then $\theta(c_{v'}c_{v'+1}) = u^{n/2+1-\alpha}$, which has order $2n/f$ as is easy to see. So the bound is attained only if v' is odd. This proves (2.1).

If n/f and $n/2$ are odd then the largest number of ovals is given by σ_3 , namely $(4g + 4 + f - n)/d$. Observe that v' is odd. So $\theta(c_{v'}) = u^{n/2}\tau$ and it is easy to see that $\theta(c_{v'}c_{v'+1})$ has order $2n/f$. Therefore, θ is a well defined epimorphism and the bound is attained provided that v' is a non-negative integer. This proves (2.2). ■

Remark 3.4 The symmetries τ and $u^{n/d}\tau$ generate a dihedral group of order $2d$, so Theorem 3(i) in [2] yields $\|\tau\| + \|u^{n/d}\tau\| \leq 4g/d + 2$. This bound is less precise than ours.
