This fundamental exposition, by two leading researchers in the field, answers the need for a mathematically sound reference work on the subject and will quickly be the standard reference. It contains an introduction to general probabilistic methods applicable to queueing systems with ergodic inputs. The main aspects treated are stability, time and customer averages, comparison of service disciplines, and priority rules. The originality of the presentation lies in the systematic use of recurrence equations to describe the dynamics of the systems, and of the Palm probability framework to describe the stationary behavior of such systems.

ASPECTS OF RISK THEORY



The text is divided into sixteen lectures, each covering a major topic. The introductory notions and classical results are included. Besides statistical mechanics, other interesting, less common topics found in the book are: percolation, the concept of stability in the central limit theorem and the study of probability of large deviations.

MEASURE THEORY

This book is different from other books on measure theory in that it accepts probability theory as an essential part of measure theory. This means that many examples are taken from probability; that probabilistic concepts such as independence, Markov processes, and conditional expectations are integrated into the text rather than being relegated to an appendix; that more attention is paid to the role of algebras than is customary; and that the metric defining the distance between sets as the measure of their symmetric difference is exploited more than is customary.
