# Relation between Small Functions with Differential Polynomials Generated by Solutions of Linear Differential Equations

This paper is devoted to studying the growth of solutions of second-order nonhomogeneous linear differential equation with meromorphic coefficients. We also discuss the relationship between small functions and differential polynomials  $L(f) = d_2 f'' + d_1 f' + d_0 f$  generated by solutions of the above equation, where  $d_0(z)$ ,  $d_1(z)$ , and  $d_2(z)$  are entire functions that are not all equal to zero.

## 1. Introduction and Main Results

A function  $f(z)$  is called meromorphic if it is nonconstant and analytic in the complex plane  $\mathbb{C}$  except at possible isolated poles. If no poles occur, then  $f(z)$  reduces to an entire function. Throughout this paper, we assume that the reader is familiar with the fundamental results and the standard notations of the Nevanlinna's value distribution theory of meromorphic functions, for reference see [1]. In addition, we use notations  $\sigma(f)$  and  $\lambda(f)$  to denote the order and the exponent of convergence of zero sequence and  $\bar{\lambda}(f)$  to denote the sequence of distinct zeros of  $f(z)$ , respectively. A meromorphic function  $\psi(z)$  is called a small function with respect to  $f(z)$  if  $T(r, \psi) = o(T(r, f))$  as  $r \rightarrow \infty$ , possibly outside of a set of  $r$  with finite measure, where  $T(r, f)$  is the Nevanlinna characteristic function of  $f(z)$ .

For the second-order linear differential equation

$$f'' + e^{-z} f' + B(z) f = 0, \quad (1.1)$$

where  $B(z)$  is an entire function of finite order, it is well known that each solution  $f$  of (1.1) is an entire function, and that if  $f_1$  and  $f_2$  are any two linearly independent solutions of (1.1), then at least one of  $f_1, f_2$  must have infinite order, see [2, pages 167-168].

Thus, a natural question is the following: what condition on  $B(z)$  will guarantee that every solution  $f \neq 0$  of (1.1) has infinite order? Many researchers have studied the question, for the details see [3, page 291]. For the case that  $B(z)$  is a transcendental entire function, Gundersen [4] proved that if  $\sigma(B) \neq 1$ , then every solution  $f \neq 0$  of (1.1) has infinite order. In 2002, Chen considered the problem and proved the following result which is an improvement of Gundersen's result.

**Theorem A** (see [3]). *Let  $a, b$  be nonzero complex numbers satisfying  $ab \neq 0$  and  $\arg a \neq \arg b$  or  $a = cb$  ( $0 < c < 1$ ), and let  $A_j(z) \neq 0$  ( $j = 1, 2$ ) be entire functions with  $\sigma(A_j) < 1$ , then every solution  $f (\neq 0)$  of the equation*

$$f'' + A_1(z)e^{az}f' + A_0(z)e^{bz}f = 0 \quad (1.2)$$

*has infinite order.*

*Some further results on (1.2) were obtained for several cases. Chen [3] got the same conclusion when  $a = cb$  ( $c > 1$ ), and Chen and Shon [5] investigated the more general equations with meromorphic coefficients. Under the same assumption of Theorem A, if  $A_1(z)$  and  $A_0(z)$  are meromorphic functions with  $\sigma(A_j) < 1$  ( $j = 0, 1$ ), then there is the same conclusion with Theorem A. In 2008, Wang and Laine [6] extended Theorem A to nonhomogeneous second-order linear differential equations.*

**Theorem B** (see [6]). *Let  $A_j(z) \neq 0$  ( $j = 0, 1$ ) and  $F \neq 0$  be entire functions with  $\max\{\sigma(A_j), (j = 0, 1), \sigma(F)\} < 1$ , and let  $a, b$  be complex constants that satisfy  $ab \neq 0$  and  $a \neq b$ , then every solution  $f$  of differential equation*

$$f'' + A_1(z)e^{az}f' + A_0(z)e^{bz}f = F \quad (1.3)$$

*is of infinite order.*

*Remark 1.1.* Belaïdi and El Farissi [7] also proved Theorem B and got  $\bar{\lambda}(f) = \lambda(f) = \sigma(f) = \infty$ . We note that (2.21) in [7] cannot be deduced by following their proof. Indeed, as  $r \rightarrow \infty$ ,  $|f(z)| > 1$  holds just for the points  $z$  satisfying  $|f(z)| = M(r, f)$ , not for all  $z$ . However, the difficulty can be got over by using Lemmas 2.5 and 2.6 in [8], and the method can be used in our proof of the following Theorem 1.2.

Since the beginning of the last four decades, a substantial number of research papers have been written to describe the fixed points of general transcendental functions. However, there are few studies on the fixed points of solutions of the general differential equations. In 2000, Chen [9] first studied the problems on the fixed points of solutions of second-order linear differential equations with entire coefficients. Since then, many results on fixed points of solutions of differential equations with entire coefficients were obtained, see [10–12]. In 2006, Chen and Shon [13] further studied the relation between small functions and solutions or differential polynomials of solutions of differential equations and obtained the following.

**Theorem C.** Let  $A_j(z) \neq 0$  ( $j = 0, 1$ ) be entire functions with  $\sigma(A_j) < 1$ , and let  $a, b$  be complex constants such that  $ab \neq 0$  and  $\arg a \neq \arg b$  or  $a = cb$  ( $0 < c < 1$ ). If  $\psi(z) \neq 0$  is an entire function with finite order, then every solution  $f \neq 0$  of (1.2) satisfies  $\bar{\lambda}(f - \psi) = \bar{\lambda}(f' - \psi) = \bar{\lambda}(f'' - \psi) = \infty$ . Furthermore, let  $d_0(z), d_1(z),$  and  $d_2(z)$  be polynomials that are not all equal to zero, and let  $L(f) = d_2f'' + d_1f' + d_0f$ . If the order of  $\psi$  is less than 1, then  $\bar{\lambda}(L(f) - \psi) = \infty$ .

Belaïdi and El Farissi [7] also studied the relation between small functions and some differential polynomials generated by solutions of the second-order nonhomogeneous linear differential equation (1.3). They obtained the following.

**Theorem D.** Let  $A_j(z) \neq 0$  ( $j = 0, 1$ ) and  $F \neq 0$  be entire functions with  $\max\{\sigma(A_j) (j = 0, 1), \sigma(F)\} < 1$ , and let  $a, b$  be complex constants that satisfy  $ab \neq 0$  and  $\arg a \neq \arg b$  or  $a = cb$  ( $0 < c < 1$ ). Let  $d_0(z), d_1(z), d_2(z)$  be entire functions that are not all equal to zero with  $\sigma(d_j) < 1$  ( $j = 0, 1, 2$ ), and let  $\psi(z)$  be an entire function with finite order. If  $f$  is a solution of (1.3), then the differential polynomial  $L(f) = d_2f'' + d_1f' + d_0f$  satisfies  $\bar{\lambda}(L(f) - \psi) = \infty$ .

The main purpose of this paper is to study the growth and the oscillation of solutions of second-order linear differential equation with meromorphic coefficients. Also, we will investigate the relation between small functions and differential polynomials generated by solutions of the above equation. Our results can be stated as follows.

**Theorem 1.2.** Let  $A_j(z) \neq 0$  ( $j = 0, 1$ ) and  $F(z)$  be meromorphic functions with  $\max\{\sigma(F), \sigma(A_j)\} < n$ , and let  $P(z) = a_nz^n + \dots + a_0$ ,  $Q(z) = b_nz^n + \dots + b_0$  be polynomials with degree  $n$  ( $n \geq 1$ ), where  $a_i, b_i$  ( $i = 0, 1, \dots, n$ ),  $a_nb_n \neq 0$  are complex constants such that  $\arg a_n \neq \arg b_n$  or  $a_n = cb_n$  ( $0 < c < 1$ ), then every meromorphic solution  $f \neq 0$  of the equation

$$f'' + A_1e^{P(z)}f' + A_0e^{Q(z)}f = F \tag{1.4}$$

has infinite order and satisfies

$$\bar{\lambda}(f) = \lambda(f) = \sigma(f) = \infty. \tag{1.5}$$

**Theorem 1.3.** Under the assumption of Theorem 1.2, and let  $d_0(z), d_1(z), d_2(z)$  be meromorphic functions that are not all equal to zero with  $\sigma(d_j) < 1$  ( $j = 0, 1, 2$ ), and let  $\psi(z)$  be a meromorphic function with finite order, if  $f \neq 0$  is a meromorphic solution of (1.4), then the differential polynomial  $L(f) = d_2f'' + d_1f' + d_0f$  satisfies  $\bar{\lambda}(L(f) - \psi) = \infty$ .

*Remark 1.4.* Clearly, the method used in linear differential equations with entire coefficients cannot deal with the case of meromorphic coefficients. In addition, the proof of the results in [7, 13] relies heavily on the idea of Lemma 5 in [13] or Lemma 2.5 in [7]. However, it seems too complicated to deal with our cases. We will use an important result in uniqueness theory of meromorphic functions, that is Lemma 2.5, to prove our theorems.

## 2. Preliminary Lemmas

In order to prove our theorems, we need the following lemmas.

**Lemma 2.1** (see [14]). Let  $\omega(z)$  be a transcendental meromorphic function with  $\sigma(f) = \sigma < \infty$ . Let  $\Gamma = \{(k_1, j_1), \dots, (k_m, j_m)\}$  be a finite set of distinct pairs of integers satisfying  $k_i > j_i \geq 0$  for  $i = 1, 2, \dots, m$ . Also let  $\epsilon > 0$  be a given constant, then there exists a set  $E_1 \subset (1, \infty)$  that has finite logarithmic measure, such that for all  $z$  satisfying  $z \notin E \cup [0, 1]$  and for all  $(k, j) \in \Gamma$ , one has

$$\frac{|\omega^{(k)}(z)|}{|\omega^{(j)}(z)|} \leq |z|^{(k-j)(\sigma-1+\epsilon)}. \quad (2.1)$$

Now we introduced a notation, see [15] and [8, Lemma 2.3]. Let  $P(z) = (\alpha + \beta i)z^n + \dots$  is a nonconstant polynomial, and  $\alpha, \beta$  is real constants. For  $\theta \in [0, 2\pi)$ , set  $\delta(P(z), \theta) = \alpha \cos n\theta - \beta \sin n\theta$ .

**Lemma 2.2** (see [15]). Let  $P(z)$  be a nonconstant polynomial of degree  $n$ . Let  $\omega(z)$  be a meromorphic function, not identically zero, of order less than  $n$ , and set  $g(z) = \omega(z)e^{P(z)}$ . Then for any given  $\epsilon > 0$  there exists a zero measure set  $H_1 \subset [0, 2\pi)$  such that if  $\theta \in \theta \in [0, 2\pi) \setminus (H_1 \cup H_2)$ , then for  $|z| > r(\theta)$ ,

- (1) if  $\delta(P, \theta) < 0$ , then  $\exp((1 + \epsilon)\delta(P, \theta)r^n) \leq |g(re^{i\theta})| \leq \exp((1 - \epsilon)\delta(P, \theta)r^n)$ ,
- (2) if  $\delta(P, \theta) > 0$ , then  $\exp((1 - \epsilon)\delta(P, \theta)r^n) \leq |g(re^{i\theta})| \leq \exp((1 + \epsilon)\delta(P, \theta)r^n)$ , where  $H_2 = \{\theta : \delta(P, \theta) = 0, 0 \leq \theta < 2\pi\}$  is a finite set.

**Lemma 2.3** (see [8, Lemma 2.5]). Let  $f(z)$  be an entire function, and suppose that

$$G(z) := \frac{\log^+ |f^{(k)}|}{|z|^\rho} \quad (2.2)$$

is unbounded on some ray  $\arg z = \theta$  with constant  $\rho > 0$ , then there exists an infinite sequence of points  $z_n = r_n e^{i\theta}$  ( $n = 1, 2, \dots$ ), where  $r_n \rightarrow \infty$ , such that  $G(z_n) \rightarrow \infty$  and

$$\frac{|f^{(j)}(z_n)|}{|f^{(k)}(z_n)|} \leq \frac{1}{(k-j)!} (1 + o(1)) r_n^{k-j}, \quad j = 0, \dots, k-1, \quad (2.3)$$

as  $n \rightarrow \infty$ .

**Lemma 2.4** (see [16]). Let  $A_0, \dots, A_{k-1}, F \neq 0$  be finite-order meromorphic functions. If  $f$  is an infinite-order meromorphic solution of the equation

$$f^{(k)} + A_{k-1}f^{(k-1)} + \dots + A_0f = F, \quad (2.4)$$

then  $f$  satisfies  $\lambda(f) = \bar{\lambda}(f) = \sigma(f) = \infty$ .

**Lemma 2.5** (see [17, page 79]). Suppose that  $f_1(z), f_2(z), \dots, f_n(z)$  ( $n \geq 2$ ) are meromorphic functions and  $g_1(z), g_2(z), \dots, g_n(z)$  are entire functions satisfying the following conditions:

- (1)  $\sum_{j=1}^n f_j(z)e^{g_j(z)} \equiv 0$ ,
- (2)  $g_j(z) - g_k(z)$  are not constants for  $1 \leq j < k \leq n$ ,

(3) for  $1 \leq j \leq n, 1 \leq h < k \leq n, T(r, f_j) = o\{T(r, e^{g^h - g^k})\} (r \rightarrow \infty, r \notin E)$ , where  $E$  has a finite measure.

then  $f_j(z) \equiv 0 (j = 1, 2, \dots, n)$ .

**Lemma 2.6** (see [8, Lemma 2.6]). *Let  $f(z)$  be an entire function of order  $\sigma(f) = \sigma < \infty$ . Suppose that there exists a set  $E \subset [0, 2\pi)$  which has linear measure zero, such that  $\log^+ |f(re^{i\theta})| \leq Mr^\rho$  for any ray  $\arg z = \theta \in [0, 2\pi) \setminus E$ , where  $M$  is a positive constant depending on  $\theta$ , while  $\rho$  is a positive constant independent of  $\theta$ . Then  $\sigma(f) \leq \rho$ .*

**Lemma 2.7.** *Under the assumption of Theorem 1.2, and let  $f$  be a meromorphic solution of (1.4). Set  $w = f'' + A_1 e^{P(z)} f' + A_0 e^{Q(z)} f$ . If  $f \not\equiv 0$  is of finite order, then  $\sigma(w) \geq n$ .*

*Proof.* Suppose the contrary that  $\sigma(w) < n$ , we will deduce a contradiction.

First, if  $f(z) \equiv C \neq 0$ , then  $w = CA_0 e^{Q(z)}$ . Clearly,  $\sigma(w) = n$ , this is a contradiction.

Now suppose that  $f \not\equiv C$ . If  $\sigma(f) < n$ , then

$$f'' + A_1 e^{P(z)} f' + A_0 e^{Q(z)} f - w = 0. \tag{2.5}$$

By Lemma 2.5, we have  $A_0 \equiv 0$ , and this is a contradiction. Hence,  $\sigma(f) \geq n$ .

Since  $f$  is a meromorphic solution of (1.4), we know that the poles of  $f$  can occur only at the poles of  $A_j (j = 0, 1)$  and  $F$ . Let  $f = g(z)/d(z)$ , where  $d(z)$  is the canonical product formed with the nonzero poles of  $f(z)$ , with  $\sigma(d) \leq \max\{\sigma(F), \sigma(A_j), j = 0, 1\} < n$ , and  $g$  is an entire function with  $n \leq \sigma(g) = \sigma(f) = \sigma \leq \infty$ . Substituting  $f = g/d$  into (2.5), by some calculation we can get

$$d\tau w = g'' + g' \left[ A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right] + g \left[ A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right]. \tag{2.6}$$

Now, we rewrite (2.6) into

$$\frac{d\tau w}{g} - \frac{g''}{g} - \left[ A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right] \frac{g'}{g} = \left[ A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right]. \tag{2.7}$$

Set  $\max\{\sigma(w), \sigma(A_j), j = 0, 1\} = \beta < n$ . By Lemma 2.1, for any given  $\varepsilon (0 < \varepsilon < 1 - \beta)$ , there exists a set  $E_2 \in [0, 2\pi)$  which has linear measure zero, such that if  $\theta \in [0, 2\pi) \setminus E_2$ , then there is a constant  $R_1 = r_1(\theta) > 1$  such that for all  $z$  satisfying  $\arg z = \theta$  and  $|z| \geq R_1$ , we have

$$\frac{|g^{(i)}(z)|}{|g(z)|} \leq |z|^{2(\sigma-1+\varepsilon)}, \quad \frac{|d^{(i)}(z)|}{|d(z)|} \leq |z|^{2(\beta-1+\varepsilon)}, \quad i = 1, 2. \tag{2.8}$$

□

Case 1. Suppose that  $a_n = cb_n$  ( $0 < c < 1$ ), then by Lemmas 2.1 and 2.2, there exists a ray  $\arg z = \theta \in [0, 2\pi) \setminus E_2 \cup H_1 \cup H_2$ ,  $H_1$  and  $H_2$  being defined in Lemma 2.2, such that  $\delta(P, \theta) = c\delta(Q, \theta) > 0$ , and for the above  $\varepsilon$  and sufficiently  $r$ ,

$$\begin{aligned} \left| A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| &\geq \left| A_0 e^{Q(z)} \right| - \left| A_1 e^{P(z)} \right| \left| \frac{d'}{d} \right| - \left| 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| \\ &\geq \frac{1}{2} \exp\{(1 - \varepsilon)\delta(Q, \theta)r^n\}. \end{aligned} \quad (2.9)$$

Also, by Lemmas 2.1 and 2.2, we have

$$\left| A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right| \leq \left| A_1 e^{P(z)} \right| + \left| \frac{2d'}{d} \right| \leq M \exp\{(1 + \varepsilon)c\delta(Q, \theta)r^n\}, \quad (2.10)$$

where  $M$  is a constant.

Now we claim that

$$\frac{\log^+ |g(z)|}{|z|^{\beta+\varepsilon}} \quad (2.11)$$

is bounded on the ray  $\arg z = \theta$ . Otherwise, by Lemma 2.3, there exists a sequence of points  $z_m = r_m e^{i\theta}$ , such that  $r_m \rightarrow \infty$

$$\frac{\log^+ |g(z_m)|}{r_m^{\beta+\varepsilon}} \rightarrow \infty. \quad (2.12)$$

From (2.12) and the definition of order, we see that

$$\left| \frac{d(z_m)w(z_m)}{g(z_m)} \right| \rightarrow 0, \quad (2.13)$$

for  $m$  is large enough. By (2.7), (2.8), (2.9), (2.10), and (2.13), we get

$$\begin{aligned} \frac{1}{2} \exp\{(1 - \varepsilon)\delta(Q, \theta)r_m^n\} &\leq \left| A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| \\ &\leq \left| \frac{d\tau w}{g} \right| + \left| \left( A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right) \frac{g'}{g} \right| + \left| \frac{g''}{g} \right| \\ &\leq M_1 \exp\{(1 + \varepsilon)c\delta(Q, \theta)r_m^n\}, \end{aligned} \quad (2.14)$$

where  $M_1$  is a constant. Clearly, we can choose  $\varepsilon$  such that  $0 < \varepsilon < (1 - c)/(1 + c)$ . Then by (2.14), we can obtain a contradiction. Therefore,

$$\frac{\log^+ |g(z)|}{|z|^{\beta+\varepsilon}} \tag{2.15}$$

is bounded, and we have  $|g(z)| \leq M \exp\{r^{\beta+\varepsilon}\}$  on the ray  $\arg z = \theta$ .

*Case 2.* Suppose that  $\arg a_n \neq \arg b_n$ . By Lemma 2.2, there exists a ray  $\arg z = \theta \in [0, 2\pi) \setminus E_2 \cup H_1 \cup H_2$ , where  $E_2, H_1$ , and  $H_2$  are defined, respectively, as in Case 1, such that

$$\delta(Q, \theta) > 0, \quad \delta(P, \theta) < 0. \tag{2.16}$$

Then, for any given  $\varepsilon$  ( $0 < \varepsilon < n - \beta$ ), by Lemma 2.2 and (2.7), we have, for sufficiently large  $|z| = r$ ,

$$\begin{aligned} \left| A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| &\geq \left| A_0 e^{Q(z)} \right| - \left| A_1 e^{P(z)} \right| \left| \frac{d'}{d} \right| - \left| 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| \\ &\geq \frac{1}{2} \exp\{(1 - \varepsilon)\delta(Q, \theta)r^n\}, \end{aligned} \tag{2.17}$$

$$\begin{aligned} \left| A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right| &\leq \left| A_1 e^{P(z)} \right| + 2 \left| \left( \frac{d'}{d} \right) \right| \\ &\leq \exp\{\beta + \varepsilon\} \exp\{(1 - \varepsilon)\delta(P, \theta)r^n\} + r^{2(\beta-1+\varepsilon)}. \end{aligned} \tag{2.18}$$

As in Case 1, we prove that

$$\frac{\log^+ |g(z)|}{|z|^{\beta+\varepsilon}} \tag{2.19}$$

is bounded on the ray  $\arg z = \theta$ . Otherwise, similarly as in Case 1, there exists a sequence of points  $z_m = r_m e^{i\theta}$ , such that  $r_m \rightarrow \infty$ ,

$$\frac{\log^+ |g(z_m)|}{r_m^{\beta+\varepsilon}} \rightarrow \infty. \tag{2.20}$$

Further, we have

$$\left| \frac{d(z_m)w(z_m)}{g(z_m)} \right| \rightarrow 0, \tag{2.21}$$

for  $m$  is large enough.

By (2.7), (2.8), (2.17), (2.18), and (2.21), we get

$$\begin{aligned} \frac{1}{2} \exp\{(1-\varepsilon)\delta(Q, \theta)r_m^n\} &\leq \left| A_0 e^{Q(z)} - A_1 e^{P(z)} \frac{d'}{d} + 2 \left( \frac{d'}{d} \right)^2 - \frac{d''}{d} \right| \\ &\leq \left| \frac{dw}{g} \right| + \left| \left( A_1 e^{P(z)} - 2 \left( \frac{d'}{d} \right) \right) \frac{g'}{g} \right| + \left| \frac{g''}{g} \right| \\ &\leq \exp\{(1-\varepsilon)\delta(P, \theta)r_m^n\} + r_m^{2(\beta-1+\varepsilon)}. \end{aligned} \quad (2.22)$$

Since  $\delta(Q, \theta) > 0$  and  $\delta(P, \theta) < 0$ , we obtain a contradiction. So

$$\frac{\log^+ |g(z)|}{|z|^{\beta+\varepsilon}} \quad (2.23)$$

is bounded, and we have

$$|g(z)| \leq M \exp\{r^{\beta+\varepsilon}\} \quad (2.24)$$

on the ray  $\arg z = \theta$ .

Combining Cases 1 and 2, for any given ray  $\arg z = \theta \in [0, 2\pi) \setminus E$ ,  $E$  of linear measure zero, we have (2.24) on the ray  $\arg z = \theta$ , provided that  $r$  is sufficiently large. Thus by Lemma 2.6, we get  $\sigma(g) \leq \beta + \varepsilon < n$ , which is a contradiction. Then  $\sigma(w) \geq n$ .

**Lemma 2.8.** *Under the assumption of Theorem 1.3, let  $f(z)$  be an infinite-order meromorphic solution of (1.4), then  $\sigma(L(f)) = \infty$ .*

*Proof.* Suppose that  $f(z)$  is a meromorphic solution of (1.4), then by Theorem 1.2, we have  $\sigma(f) = \infty$ .

Now suppose that  $d_2 \neq 0$ . Substituting  $f'' = F - A_1 e^{P(z)} f' - A_0 e^{Q(z)}$  into  $L(f)$ , we have

$$L(f) - d_2 F = (d_1 - d_2 A_1 e^{P(z)}) f' + (d_0 - d_2 A_0 e^{Q(z)}) f. \quad (2.25)$$

Differentiating both sides of (2.25), and replacing  $f''$  with  $f'' = F - A_1 e^P f' - A_0 e^Q f$ , we obtain

$$\begin{aligned} &L(f)' - (d_2 F)' - (d_1 - d_2 A_1 e^P) F \\ &= \left[ d_2 A_1^2 e^{2P} - ((d_2 A_1)' + P' d_2 A_1 + d_1 A_1) e^P - d_2 A_0 e^Q + d_0 + d_1' \right] f' \\ &\quad + \left[ d_2 A_0 A_1 e^{P+Q} - ((d_2 A_0)' + Q' d_2 A_0 + d_1 A_0) e^Q + d_0' \right] f. \end{aligned} \quad (2.26)$$



Set

$$\begin{aligned} \alpha_1 &= d_1 - d_2 A_1 e^P, & \alpha_0 &= d_0 - d_2 A_0 e^Q, \\ \beta_1 &= d_2 A_1^2 e^{2P} - ((d_2 A_1)' + P' d_2 A_1 + d_1 A_1) e^P - d_2 A_0 e^Q + d_0 + d_1', \\ \beta_0 &= d_2 A_0 A_1 e^{P+Q} - ((d_2 A_0)' + Q' d_2 A_0 + d_1 A_0) e^Q + d_0'. \end{aligned} \tag{2.27}$$

Then we rewrite (2.25) and (2.26) into

$$\begin{aligned} \alpha_1 f' + \alpha_0 f &= L(f) - d_2 F, \\ \beta_1 f' + \beta_0 f &= L(f)' - (d_2 F)' - (d_1 - d_2 A_1 e^P) F. \end{aligned} \tag{2.28}$$

Set

$$\begin{aligned} h &= \alpha_1 \beta_0 - \alpha_0 \beta_1 \\ &= [d_1 - d_2 A_1 e^P] [d_2 A_0 A_1 e^{P+Q} - ((d_2 A_0)' + Q' d_2 A_0 + d_1 A_0) e^Q + d_0'] \\ &\quad - [d_0 - d_2 A_0 e^Q] [d_2 A_1^2 e^{2P} - ((d_2 A_1)' + P' d_2 A_1 + d_1 A_1) e^P \\ &\quad - d_2 A_0 e^Q + d_0 + d_1'] \\ &= h_0 + h_P(z) e^P + h_{P+Q} e^{P+Q} + h_Q e^Q + h_{2P} e^{2P} - d_2^2 A_0^2 e^{2Q}, \end{aligned} \tag{2.29}$$

where  $h_i(z)$  ( $i \in \Lambda = \{0, P, Q, P + Q, 2P\}$ ) are meromorphic functions formed by  $A_0, A_1, d_0,$  and  $d_1$  and their derivatives, with order less than  $n$ , and  $\Lambda$  is a index set. Since any one of  $\{P, Q, P + Q, 2P\}$  is not equal to  $2Q$ , then by Lemma 2.5, we have  $d_2^2 A_0^2 \equiv 0$ . This is a contradiction. Thus,  $h \neq 0$ .

By (2.28), we get

$$f = \frac{1}{h} (\alpha_1 (L(f)' - (d_2 F)' - \alpha_1 F) - \beta_1 (L(f) - d_2 F)). \tag{2.30}$$

If  $\sigma(L(f)) < \infty$ , then by (2.30) we have  $\sigma(f) < \infty$ . Clearly, it is a contradiction. Hence,  $\sigma(L(f)) = \infty$ .

Suppose that  $d_2 \equiv 0, d_1 \neq 0$  or  $d_2 = d_1 \equiv 0$ , and  $d_0 \neq 0$ , then by similar discussion as above, we can get the same conclusion.  $\square$

### 3. Proof of Theorem 1.2

Let  $f \neq 0$  be a meromorphic solution of (1.4). Conversely, suppose that  $\sigma(f) < \infty$ . By Lemma 2.7, we have  $n \leq \sigma(w) = \sigma(F) < n$ . This is a contradiction. By Lemma 2.4,  $f$  satisfies  $\bar{\lambda}(f) = \lambda(f) = \sigma(f) = \infty$ .

#### 4. Proof of Theorem 1.3

Suppose that  $\arg a_n \neq \arg b_n$  or  $a_n = cb_n (0 < c < 1)$  and that  $f$  is a meromorphic solution of (1.4). Set  $k(z) = L(f) - \psi$ . By  $\sigma(\psi) < \infty$  and Lemma 2.8, we have  $\sigma(k) = \infty$ . Without loss of generality, we assume that  $d_2 \neq 0$ . Indeed, the remaining cases can be obtained by similar discussion. Substituting  $L(f) = k(z) + \psi$  into (2.30), we have

$$f = \frac{1}{h}(\alpha_1(k' + \psi' - (d_2F)' - \alpha_1F) - \beta_1(k + \psi - d_2F)) = \frac{1}{h}(\alpha_1k' - \beta_1k) + \phi, \quad (4.1)$$

where

$$\phi(z) = \frac{\alpha_1}{h}(\psi' - (d_2F)' - \alpha_1F) - \frac{\beta_1}{h}(\psi - d_2F) \quad (4.2)$$

is a meromorphic function of finite order. Then substituting (4.1) into (1.4), we have

$$\frac{\alpha_1}{h}k''' + \phi_2k'' + \phi_1k' + \phi_0k = F - (\psi'' + A_1e^P\psi' + A_0e^Q\psi), \quad (4.3)$$

where  $\phi_j (j = 0, 1, 2)$  are meromorphic functions formed by  $\alpha_1/h, \beta_1/h, \phi$ , and their derivatives. If  $F - (\psi'' + A_1e^P\psi' + A_0e^Q\psi) \equiv 0$ , then by Theorem 1.2, we have  $\sigma(\psi) = \infty$ . This is impossible, and hence  $F - (\psi'' + A_1e^P\psi' + A_0e^Q\psi) \neq 0$ . Thus, by  $h \neq 0, \alpha_1 \neq 0$ , (4.3), and Lemma 2.4, we get  $\lambda(k) = \bar{\lambda}(k) = \sigma(k) = \infty$ .
