Abstracts should be submitted in duplicate to the Managing Editor, K. J. C. Smith, Department of Statistics, University of North Carolina, Chapel Hill, North Carolina 27514, on abstract blanks which may be obtained from him or from any Secretary or Associate Secretary. Abstracts must be received at least 50 days before the first day of the meeting at which they are to be presented, indicating whether presented by title or in person. (Only one contributed paper may be given in person at any one meeting.) They may be printed prior to the publication of the report of the meeting. Ordinarily, each issue will contain those abstracts received at least 75 days before it appears. Abstracts should be limited to 200 words or the equivalent and should avoid displayed expressions and complicated formulae. They can be accepted from non-members of the IMS only if introduced by members. Abstracts must follow the stylistic requests on the abstract blank, or they may be returned.
