The likelihood principle is one of the simplest ideas in all of statistics, and yet has astonishing consequences. The monograph begins with an elementary review of conditioning concepts in statistics, leading up to development of the likelihood principle and its generalizations. Also included are careful discussions of existing criticisms of the likelihood principle, and introductions to its startling implications for frequentist theory, sequential analysis, censoring, significance testing, and randomization analysis. A final section includes discussions by Bruce Hill, David Lane, and Lucien LeCam and a reply by the authors. Except for a few theoretical sections (which may be omitted without loss of continuity), this book should be easily readable by statisticians at almost any level.
