The Council announces that a reciprocity agreement has been consummated with the London Mathematical Society. Members of the American Mathematical Society not residing in Great Britain are now to be admitted to full membership in the London Mathematical Society on payment of the initiation fee (forty-two shillings) and one-half the annual dues (one-half of forty-two shillings). Members of the London Mathematical Society not residing in the United States or in Canada are now to be admitted to full membership in the American Mathematical Society on payment of the initiation fee (\$5.00) and one-half the annual dues (one-half of \$6.00); and they may substitute the *TRANSACTIONS* for the *BULLETIN* on payment of two dollars (\$2.00) extra annually.
