

On a Quadratic First Integral for the Charged Particle Orbits in the Charged Kerr Solution*

Abstract. Associated with the charged Kerr solution of the Einstein gravitational field equation there is a Killing tensor of valence two. The Killing tensor, which is related to the angular momentum of the field source, is shown to yield a quadratic first integral of the equation of the motion for charged test particles.

The Hamilton-Jacobi equation for charged particle orbits in the Kerr spacetime¹ has been found by Carter [1] to be solvable by separation of variables. The separation constant, an expression which is quadratic in the orbital tangent vector, provides in turn a fourth first integral of the equation of motion for charged particles, the other three having been obtained by reason of the two symmetries of the field, and the conservation of the particle rest mass. Walker and Penrose [2] have demonstrated

in an earlier communication how the fourth first integral of the geodesic equation arises from the existence of a tensor K_{ab} which satisfies² $\nabla_{(a}K_{bc)}=0$. In the present communication we show that the quadratic Killing tensor may be used to obtain also Carter's fourth first integral of the equation of motion for *charged test particles*.

To expedite the discussion, we begin with a simplified proof of the existence of a quadratic Killing tensor for the Kerr spacetime. The proof is based on the following remark: let o^A and l^A be a normalized spinor dyad whose corresponding null vectors $l^a := o^A \bar{o}^{A'}$ and $n^a := l^A \bar{l}^{A'}$ are tangent to congruences of nonshearing null geodesic curves³, and let ϕ be a complex scalar such that $\phi_{AB} = \phi o_{(A}l_{B)}$ satisfies the vacuum Maxwell equation

$$\nabla^{AA'} \phi_{AB} = 0. \tag{1}$$

Then the quantity $X_{AB} := \phi^{-3/2} \phi_{AB}$ satisfies the twistor equation⁴

$$\nabla_{(A}{}^{A'} X_{BC)} = 0. \tag{2}$$

To see this, we observe that the dyad component

$$6\phi^{3/2} o^A o^B l^C \nabla_{(A}{}^{A'} [\phi^{-1/2} o_B l_{C)}] = o^A \nabla_A{}^{A'} \phi - 2\phi o^B l^A \nabla_A{}^{A'} o_B$$

of $\nabla_{(A}{}^{A'} X_{BC)}$ is simply one of the dyad components of $\nabla^{AA'} [\phi o_{(A}l_{B)}]$, which vanishes by virtue of the Maxwell equation. The component with o^A and l^A interchanged vanishes for the same reason, and the remaining two components vanish by virtue of the *GSF* conditions on o^A and l^A .

The converse of the remark above is also true: If $\nabla_{(A}{}^{A'} X_{BC)} = 0$, then the principal spinors of X_{AB} are *GSF*, and $(X_{CD} X^{CD})^{-3/2} X_{AB}$ satisfies the Maxwell equation. More generally, the principal spinors of a Killing

Finally, to be consistent with the *Battelle conventions* for Latin and Gothic indices, the indices in the first line following Eq. (16) should be Latin. The first unnumbered equation after Eq. (17) and the remark following it should read

$${}^{**} \delta_a^c \delta_b^d \delta_c^e \nabla^a Q^{bc} = g^{e(a} \nabla_c Q^{bc)} - Q^{e(a} \nabla_c g^{bc)}$$

in any coordinate system x^a , with $\delta_a^a := \nabla_a x^a$, so that $\nabla_a = \partial/\partial x^a$.

³ Such spinors will be said to be *GSF*. We notice that the *GSF* condition $o^A o^B \nabla_{AA'} o_B = 0$ is preserved under the rescaling $o^A \rightarrow \lambda o^A$ for an arbitrary complex scalar λ .

spinor of arbitrary valence are *GSF*⁵. In the case of a non-flat vacuum spacetime, this fact would allow us to conclude from the Goldberg-Sachs theorem [5] that at most two of the principal spinors of a Killing spinor of arbitrary valence are not proportional.

Upon examining the Bianchi identities it may be seen readily that in any vacuum spacetime of type {22} with a Weyl spinor $\psi o_{(A} o_B l_C l_{D)}$ we can construct an electromagnetic test field of the kind we have been considering above: $\phi_{AB} = \psi^{2/3} o_{(A} l_{B)}$. Moreover, it is well known that in correspondence with each vacuum spacetime of type {22} there exists a parametrized family of type {22} solutions of the Einstein-Maxwell equations for which the principal null directions of the electromagnetic field coincide with those of the gravitational field⁶. Here the test electromagnetic fields of interest are already at our disposal. Associated, then, with each of these spacetimes is a Killing spinor of valence two⁷.

Given the Killing spinor X_{AB} we define the tracefree symmetric tensor

$$P_{ab} := X_{AB} \bar{X}_{A'B'}$$

As a consequence of Eq. (2), P_{ab} is found to satisfy, as it is shown in paper [2], the conformal Killing equation,

$$\nabla_{(a} P_{bc)} = P_{(a} g_{bc)}$$

where g_{ab} is the spacetime metric and where the vector P^a is defined by $P^a := \frac{1}{3} \nabla_b P^{ab}$. If P_a is the gradient of a scalar P , then it may easily be verified that the tensor

$$K_{ab} := P_{ab} - P g_{ab}$$

satisfies the Killing equation:

$$\nabla_{(a} K_{bc)} = 0. \tag{3}$$

⁵ Let us consider, for example, an algebraically general Killing spinor $X_{A_1 \dots A_n}$ of valence n :

$$\begin{aligned} \nabla_{A'(A} X_{A_1 \dots A_n)} &= 0, \\ X_{A_1 \dots A_n} &= \sigma_{(A_1} \dots \sigma_{A_n)}. \end{aligned}$$

Upon transvection n times with σ_A the twistor equation becomes

$$\begin{aligned} &\sigma^A \sigma^{A_1} \dots \sigma^{A_n} \nabla_{A'(A} X_{A_1 \dots A_n)} \\ &\left(\sigma^{A_1} \sigma_{A_1} \right) \dots \left(\sigma^{A_{n-1}} \sigma_{A_{n-1}} \right) \left[\sigma^A \sigma^{A_n} \nabla_{A'A} \sigma_{A_n} \right] = 0 \end{aligned}$$

which is seen to be the *GSF* condition on the congruence defined by σ_A .

⁶ Kinnersley [6] has provided an explicit algorithm for generating the electrification of any type {22} vacuum spacetime.

⁷ The argument given in paper [2] for the existence of a Killing spinor of valence 2 is not quite complete as it stands for the *charged* Kerr solution, since the proof given would seem to rely on the vacuum Bianchi identities. Our procedure here should clarify that derivation.

Let us examine the condition that P_a be a gradient. This condition may be expressed in a particularly convenient form if we first observe that the stress-energy tensor

$$\tau_{ab} := \phi_{AB} \bar{\phi}_{A'B'} = \phi \bar{\phi} [l_{(a} n_{b)} - \frac{1}{4} g_{ab}]$$

of the test electromagnetic field ϕ_{AB} is proportional to the conformal Killing tensor P_{ab} , and satisfies

$$\nabla^a \tau_{ab} = 0$$

as a consequence of the vacuum Maxwell equation. From these facts it follows that

$$P_a = \frac{1}{3} \nabla^b P_{ab} = f^2 \tau_{ab} \nabla^b f = l_{(a} n_{b)} \nabla^b f - \frac{1}{4} \nabla_a f$$

where $f := (\phi \bar{\phi})^{-1/2}$. Therefore, the requirement that P_a be a gradient is equivalent to the existence of a scalar h such that

$$l_{(a} n_{b)} \nabla^b f = \nabla_a h.$$

We shall now consider explicitly the case of the Kerr spacetime. In the coordinate system of paper [2], the scalar ϕ is given by

$$\phi = (r - ia \cos \theta)^{-2}$$

so that $f = r^2 + a^2 \cos^2 \theta$. A simple computation shows that

$$l_{(a} n_{b)} \nabla^b f = \nabla_a (\frac{1}{2} r^2).$$

Thus we establish that *the Kerr spacetime admits a Killing tensor of valence two*⁸.

The equation of motion of a test particle with charge ε , moving under the influence of an electromagnetic field F_{ab} , may be written

$$t^c \nabla_c t^a = \varepsilon t^c F^a_c, \tag{4}$$

where t^a is tangent to the orbit of the particle. As in the case of an affinely parametrized geodesic orbit, as would be given by $\varepsilon = 0$, the equation of motion admits $g^{ab} t_a t_b$ as a first integral since

$$t^c \nabla_c (g^{ab} t_a t_b) = 2 t^b t^c \nabla_c t_b = 2 \varepsilon t^b t^c F_{bc} = 0.$$

Suppose that g_{ab} admits a one parameter group of isometries generated by a Killing vector ξ^a , so that $\mathcal{L}_\xi g_{ab} = 0$. A first integral may be constructed from ξ^a provided that the electromagnetic field is also invariant under the action of the group. In fact, we may demonstrate that $\mathcal{L}_\xi F_{ab} = 0$ is the necessary and sufficient condition that there exist a

⁸ We comment, incidentally, that our analysis is more generally valid for the charged *Kerr-NUT* spacetimes [1, 7] wherein the Killing tensor assumes the form

$$K_{ab} = (l - a \cos \theta)^2 l_{(a} n_{b)} + r^2 m_{(a} \bar{m}_{b)}$$

where l is the *NUT* parameter.

scalar α such that

$$t^c \nabla_c (\xi^a t_a + \varepsilon \alpha) = 0. \tag{5}$$

Using the equation of motion (4) we find Eq. (5) to be satisfied if and only if

$$\nabla_a \alpha + F_a{}^c \xi_c = 0$$

for which we have the integrability condition

$$\nabla_{[a} (F_{b]c} \xi^c) = 0.$$

Then, using Maxwell's equations in the form

$$2\nabla_{[a} F_{b]c} + \nabla_c F_{ab} = 0$$

we arrive at the desired relation:

$$\xi^c \nabla_c F_{ab} + F_{ac} \nabla_b \xi^c + F_{cb} \nabla_a \xi^c := \mathcal{L}_\xi F_{ab} = 0.$$

If a local vector potential A_a for F_{ab} be chosen with the gauge condition $\mathcal{L}_\xi A_a = 0$, then $\alpha = \xi^a A_a$, and the conserved quantity is given by

$$\xi^a (t_a + \varepsilon A_a).$$

Thus far our discussion of first integrals has been valid in general. We restrict our attention now to those spacetimes which admit a Killing spinor \mathbf{X}_{AB} , and ask under what conditions we can construct from \mathbf{X}_{AB} a quadratic first integral for the orbits defined by Eq. (4). First we consider the case in which the orbit is *null*⁸. If the tangent to the orbit is written $t^a := \lambda^A \bar{\lambda}^{A'}$, then the equation of motion (4) assumes the form

$$\begin{aligned} \bar{\lambda}_{A'} (t_c \nabla^c \lambda_A + \varepsilon \phi_{AB} \lambda^B) + \lambda_A (t_c \nabla^c \bar{\lambda}_{A'} + \varepsilon \bar{\phi}_{A'B'} \bar{\lambda}^{B'}) = 0 \\ F_{ab} := \phi_{AB} \varepsilon_{A'B'} + \bar{\phi}_{A'B'} \varepsilon_{AB} \end{aligned} \tag{6}$$

from which we deduce that

$$t^c \nabla_c \lambda_A + \varepsilon \phi_{AB} \lambda^B = i\omega \lambda_A$$

for some real scalar ω . A suitable new choice for the phase of λ_A serves to eliminate ω . Then the equation of motion becomes

$$t^c \nabla_c \lambda_A + \varepsilon \phi_{AB} \lambda^B = 0.$$

It is easy to see that the complex scalar $\mathbf{X} := \mathbf{X}_{AB} \lambda^A \lambda^B$ formed from the Killing spinor \mathbf{X}_{AB} is constant along the orbits, $t^a \nabla_a \mathbf{X} = 0$, provided that

$$\mathbf{X}_{B(A} \phi_{C)}{}^B = 0,$$

which is precisely the condition that \mathbf{X}_{AB} and ϕ_{AB} be proportional. Therefore, *for those spacetimes in which the principal null directions of the electromagnetic field are aligned with those of the Killing spinor*

⁹ The null charged particle orbits are, due to their conformal invariance, of some interest in connection with the theory of *twistor quantization* [8].

we obtain a first integral for the charged null orbits. This condition is fulfilled, of course, for the charged Kerr spacetime.

We now demonstrate the construction of a first integral from the Killing tensor

$$K_{ab} := X_{AB} \bar{X}_{A'B'} - P g_{ab}$$

for the non-null charged particle orbits in the Kerr case. Applying Eqs. (3), (4), and (6) we find that

$$t^c \nabla_c (K^{ab} t_a t_b) = 2\epsilon t^a t^c K_{b(a} F_{c)}{}^b = -2\epsilon t^a t^c [X_{AC} \bar{X}_{B'(A} \bar{\phi}^{B'}{}_{C')} + \bar{X}_{A'C'} X_{B(A} \phi^B{}_{C)}],$$

which vanishes identically due to the proportionality $X_{AB} = \phi^{-3/2} \phi_{AB}$. Thus we obtain the first integral

$$K^{ab} t_a t_b.$$

We remark, finally, on the *physical* meaning of the Killing spinor in Kerr's spacetime. Suppose that from the Killing spinor X_{AB} we construct the bivector

$$M_{ab} := X_{AB} \varepsilon_{A'B'} + \bar{X}_{A'B'} \varepsilon_{AB}.$$

Then in the linear approximation to Einstein's theory, this bivector can be shown to be related to the expression for the total angular momentum of the source of the gravitational field¹⁰.
