tance or rejection of papers in their field which are sub-  
mitted to the Communications in Mathematical Physics. The  
authors should address their paper either directly to the  
appropriate editors or to the chief editor who will then  
either send the manuscript to one of the editors or, in  
cases beyond any doubt, accept or reject it. The editors  
can consult referees, and they can suggest alterations be-  
fore an article is finally accepted. The chief editor will  
keep track of all the articles which are received, accepted,  
and rejected by the journal, and transfer all manuscripts  
which are ready for printing to Springer-Verlag. With the  
help of the advisory board the editors and the chief editor  
together will establish the publication policy of the jour-  
nal which will follow essentially the present successful  
line. Due to lack of space we have to be strongly biased  
against overlong papers, against purely mathematical arti-  
cles with no direct relevance to physics, and against phe-  
nomenological papers.*
