

ON A FORMULA CONCERNING STOCHASTIC DIFFERENTIALS

KIYOSI ITÔ

In his previous paper [1]¹⁾ the author has stated a formula²⁾ concerning stochastic differentials with the outline of the proof. The aim of this paper is to show this formula in details in a little more general form (Theorem 6).

1. Definitions. Throughout this paper we assume that all stochastic processes³⁾ $\xi(t, \omega)$, $\eta(t, \omega)$, $a(t, \omega)$, $b(t, \omega)$, etc. are measurable in variables t and ω . A system of r one-dimensional Brownian motions independent of each other is called an r -dimensional Brownian motion.

Given two system of stochastic processes :

$$(1.1) \quad \xi = \{\xi_\lambda(t, \omega), \lambda \in A\}, \quad \eta = \{\eta_\mu(t, \omega), \mu \in M\}.$$

We say that ξ has the property α with regard to η in $u \leq t \leq v$, if, for any t , the following two systems of random variables are independent of one another :

$$(1.2) \quad \begin{cases} \varphi_t = \{\xi_\lambda(\tau, \omega), \lambda \in A, \eta_\mu(\tau, \omega), \mu \in M, u \leq \tau \leq t\} \\ \psi_t = \{\eta_\mu(\sigma, \omega) - \eta_\mu(t, \omega), \mu \in M, t \leq \sigma \leq v\}. \end{cases}$$

Now we shall state an outline⁴⁾ of a stochastic integral of the form :

$$(1.3) \quad \int_s^t \xi(\tau, \omega) d\beta(\tau, \omega), \quad u \leq s \leq t \leq v, \quad \omega \in \Omega_1,$$

where $\beta(t, \omega)$ is a one-dimensional Brownian motion and Ω_1 is a measurable subset of Ω . We shall set the two conditions on ξ ;

$$(C.1) \quad \xi(t, \omega) \text{ has the property } \alpha \text{ concerning } \beta(t, \omega) \text{ in } u \leq t \leq v,$$

$$(C.2) \quad \int_u^v \xi(\tau, \omega)^2 d\tau \text{ for almost all } \omega \in \Omega_1.$$

Case 1. When ξ is uniformly stepwise, that is when there exists a system of time-points:

$$(1.4) \quad u = s_0 < s_1 < \dots < s_n = v$$

such that

$$\xi(\tau, \omega) = \xi(s_{i-1}, \omega), \quad s_{i-1} \leq \tau < s_i, \quad i=1, 2, \dots, n,$$

we define

$$(1.5) \quad \int_s^t \xi(\tau, \omega) d\beta(\tau, \omega) = \sum_{i=k+1}^{l-1} \xi(s_{i-1}, \omega) (\beta(s_i, \omega) - \beta(s_{i-1}, \omega)) \\ + \xi(s_{k-1}, \omega) (\beta(s_k, \omega) - \beta(s, \omega)) + \xi(s_{l-1}, \omega) (\beta(t, \omega) - \beta(s_{l-1}, \omega)) \\ (s_{k-1} \leq s < s_k, \quad s_{l-1} \leq t < s_l).$$

Case 2. When

$$(1.6) \quad \int_{\Omega} \int_u^v \xi(t, \omega)^2 dt P(d\omega) < \infty,$$

there exists a sequence of uniformly stepwise processes $\xi_n(t, \omega)$, $n=1, 2, \dots$ whose value at any time-point t is a B -measurable function of $\xi(\tau, \omega)$, $u \leq \tau \leq t$, such that

$$(1.7) \quad \int_{\Omega} \int_u^v (\xi_n(t, \omega) - \xi(t, \omega))^2 dt P(dw) < 8^{-n}.$$

We define

$$(1.8) \quad \int_s^t \hat{\xi}_n(\tau, \omega) d\beta(\tau, \omega) = \lim_n \int_s^t \xi_n(\tau, \omega) d\beta(\tau, \omega).$$

As was proved in our previous paper [2], the sequence:

$$\int_s^t \xi_n(\tau, \omega) d\beta(\tau, \omega), \quad n=1, 2, \dots,$$

is uniformly convergent in $u \leq s \leq t \leq v$ for almost all ω , and the definition is independent of the special choice of the sequence $\{\xi_n(t, \omega)\}$.

Case 3. Now we shall consider the general case. Put

$$(1.9) \quad \phi_n(\lambda) = \begin{cases} 1 & (|\lambda| \leq n) \\ 0 & (|\lambda| > n) \end{cases}$$

and

$$\hat{\xi}_n(t, \omega) = \phi_n \left(\int_u^t \xi(\tau, \omega)^2 dt \right) \xi(t, \omega), \quad n=1, 2, \dots$$

Then $\hat{\xi}_n(t, \omega)$ satisfies the conditions (1.6) and (C.1), and so their stochastic integrals are well defined. Since $\hat{\xi}_n(t, \omega) = \hat{\xi}(t, \omega)$, $u \leq t \leq v$, for a sufficiently large n for almost all $\omega \in \Omega$, by (C.2), we define naturally

$$\int_s^t \xi(\tau, \omega) d\beta(\tau, \omega) = \lim_n \int_s^t \xi_n(\tau, \omega) d\beta(\tau, \omega).$$

2. Preliminary properties of stochastic integrals. In the following Theorems 1, 3, and 4 we shall assume that $\xi(t, \omega)$ satisfies the conditions (C.1) and (C.2).

THEOREM 1. *The stochastic integral (1.3) is continuous in s, t for almost all $\omega \in \Omega_1$.*

THEOREM 2. *If each of $\xi(t, \omega)$ and $\eta(t, \omega)$ satisfies (C.1) and (C.2), and if the system $\{\xi(t, \omega), \eta(t, \omega)\}$ has the property α with regard to the Brownian motion β , then $\zeta(t, \omega) \equiv a\xi(t, \omega) + b\eta(t, \omega)$ (a, b being constants) satisfies (C.1) and (C.2) and we obtain*

$$(2.1) \quad \int_s^t (a\xi(\tau, \omega) + b\eta(\tau, \omega)) d\beta(\tau, \omega) = a \int_s^t \xi(\tau, \omega) d\beta(\tau, \omega) + b \int_s^t \eta(\tau, \omega) d\beta(\tau, \omega)$$

for $u \leq t \leq s \leq v$ for almost all $\omega \in \Omega_1$.

THEOREM 3. *We have*

$$(2.2) \quad \int_{s_1}^{s_2} \xi(\tau, \omega) d\beta(\tau, \omega) + \int_{s_2}^{s_3} \xi(\tau, \omega) d\beta(\tau, \omega) = \int_{s_1}^{s_3} \xi(\tau, \omega) d\beta(\tau, \omega)$$

for $u \leq s_1 \leq s_2 \leq s_3 \leq v$ for almost all $\omega \in \Omega_1$.

THEOREM 4. *If (1.6) is satisfied, then we have*

$$(2.4) \quad \begin{aligned} & \frac{c^2}{2} \Pr \left\{ \sup_{u \leq s \leq t \leq v} \left| \int_s^t \xi(\tau, \omega) d\beta(\tau, \omega) \right| \geq 2c \right\} \\ & \leq c^2 \Pr \left\{ \sup_{u \leq t \leq v} \left| \int_u^t \xi(\tau, \omega) d\beta(\tau, \omega) \right| \geq c \right\} \\ & \leq \int_{\Omega} \left(\int_u^v \xi(t, \omega) d\beta(t, \omega) \right)^2 P(d\omega) = \int_{\Omega} \int_u^v \xi(t, \omega)^2 dt P(d\omega). \end{aligned}$$

THEOREM 5. *If each of $\xi_n(t, \omega)$, $n=1, 2, \dots$, satisfies (C.1) and (C.2) and if the system $\{\xi_n(t, \omega), n=1, 2, \dots, \infty\}$ has the property α with regard to β in $u \leq t \leq v$, and further if*

$$(2.5) \quad \int_u^v (\xi_n(t, \omega) - \xi_\infty(t, \omega))^2 dt \rightarrow 0$$

for almost all $\omega \in \Omega_1$, then

$$(2.6) \quad \sup_{u \leq s < t \leq v} \left| \int_s^t \xi_n(\tau, \omega) d\beta(\tau, \omega) - \int_s^t \xi_\infty(\tau, \omega) d\beta(\tau, \omega) \right|$$

tends to 0 in probability over Ω_1 .

Since Theorems 1, 2, 3 and 4 follow at once from the properties of the stochastic integral established in [2], we shall here prove Theorem 5 only.

Since we have

$$\int_u^v \xi_n(t, \omega)^2 dt \rightarrow \int_u^v \xi_\infty(t, \omega)^2 dt$$

for almost all $\omega \in \Omega_1$, by the assumption (2.5) and since there exists $M = M(\varepsilon)$ for any $\varepsilon > 0$ such that

$$Pr\left\{\omega \in \Omega_1, \int_u^v \xi_\infty(t, \omega)^2 dt < M\right\} > P(\Omega_1) - \varepsilon$$

by the assumption that $\xi_\infty(t, \omega)$ satisfies (C.2), there exists $N_1 = N_1(\varepsilon)$ for any $\varepsilon > 0$

$$(2.7) \quad Pr\left\{\omega \in \Omega_1, \int_u^v \xi_n(t, \omega)^2 dt < M, N_1 < n \leq \infty\right\} > P(\Omega_1) - 2\varepsilon.$$

Put

$$\xi_n^M(t, \omega) = \phi_M\left(\sup_{n \leq k \leq \infty} \int_u^t \xi_k(\tau, \omega)^2 d\tau\right) \xi_n(t, \omega), \quad n = 1, 2, \dots, \infty,$$

where ϕ_M is defined by (1.9). Then it follows from (2.7) that

$$(2.8) \quad Pr\left\{\omega \in \Omega_1, \xi_n^M(t, \omega) = \xi_n(t, \omega), u \leq t \leq v, N_1 < n \leq \infty\right\} > P(\Omega_1) - 2\varepsilon.$$

Since we have

$$\begin{aligned} \int_u^v (\xi_n^M(t, \omega) - \xi_\infty^M(t, \omega))^2 dt &\leq \int_u^v \xi_n(t, \omega) - \xi_\infty(t, \omega))^2 dt \rightarrow 0, \\ \int_u^v (\xi_n^M(t, \omega) - \xi_\infty^M(t, \omega))^2 dt &\leq 2 \int_u^v \xi_n^M(t, \omega)^2 dt + 2 \int_u^v \xi_\infty^M(t, \omega)^2 dt < 4M, \end{aligned}$$

we obtain

$$\int_\Omega \int_u^v (\xi_n^M(t, \omega) - \xi_\infty^M(t, \omega))^2 dt P(d\omega) \rightarrow 0.$$

By Theorem 4 there exists $N_2 = N_2(\varepsilon)$ for any $\varepsilon > 0$ such that

$$(2.9) \quad Pr\left\{\sup_{u \leq s \leq t \leq v} \left| \int_s^t \xi_n^M(\tau, \omega) d\beta(\tau, \omega) - \int_s^t \xi_\infty^M(\tau, \omega) d\beta(\tau, \omega) \right| < \varepsilon\right\} > P(\Omega_1) - 3\varepsilon,$$

which, combined with (2.8), proves our theorem.

3. A formula concerning stochastic differentials. Let $\beta \equiv (\beta^i(t, \omega), i = 1, 2, \dots, r)$ be an r -dimensional Brownian motion, and let the system:

$$(3.1) \quad \{\xi^i(t, \omega), a^i(t, \omega), b_j^i(t, \omega), i = 1, 2, \dots, n, j = 1, 2, \dots, r\}$$

have the property α with regard to β in $u \leq t \leq v$. When we have

$$(3.2) \quad \xi^i(s, \omega) - \xi^i(t, \omega) = \int_t^s a^i(\tau, \omega) d\tau + \int_t^s b_j^i(\tau, \omega) d\beta^j(\tau, \omega),^{5)} \quad u \leq t \leq s \leq v, 1 \leq i \leq n,$$

for almost all $\omega \in \Omega_1$, we write this relation in the differential form as follows:

$$(3.3) \quad d\xi^i(t, \omega) = a^i(t, \omega)dt + b_j^i(t, \omega)d\beta^j(t, \omega), \quad u \leq t \leq v, \quad \omega \in \Omega_1, \quad 1 \leq i \leq n.$$

THEOREM 6. Let $\xi^i(t, \omega)$, $i=1, 2, \dots, n$, satisfy

$$(3.4) \quad d\xi^i(t, \omega) = a^i(t, \omega)dt + b_j^i(t, \omega)d\beta^j(t, \omega), \quad i=1, 2, \dots, n,$$

and G be an open subset of the n -space R^n which contains all the points $(\xi^i(t, \omega))$, $i=1, 2, \dots, n$ for $u \leq t \leq v$, $\omega \in \Omega_1$.

Let $f(t, x^1, x^2, \dots, x^n)$ be a continuous function defined in $u \leq t \leq v$, $(x^1, x^2, \dots, x^n) \in G$, such that

$$(3.5) \quad \begin{cases} f_0(t, x^1, \dots, x^n) = \frac{\partial f}{\partial t}(t, x^1, \dots, x^n) \\ f_i(t, x^1, \dots, x^n) = \frac{\partial f}{\partial x_i}(t, x^1, \dots, x^n), \quad i=1, 2, \dots, n, \\ f_{ij}(t, x^1, \dots, x^n) = \frac{\partial^2 f}{\partial x^i \partial x^j}(t, x^1, \dots, x^n), \quad i, j=1, 2, \dots, n. \end{cases}$$

are all continuous.

Then $\eta(t, \omega) \equiv f(t, \xi^1(t, \omega), \dots, \xi^n(t, \omega))$ satisfies

$$(3.6) \quad d\eta(t, \omega) = (f_0(t, \xi) + f_i(t, \xi)a^i(t, \omega) + \frac{1}{2}f_{ij}(t, \xi)b_k^i(t, \omega)b_k^j(t, \omega))dt + f_i(t, \xi)b_j^i(t, \omega)d\beta^j(t, \omega),$$

where $\xi \equiv (\xi^1(t, \omega), \xi^2(t, \omega), \dots, \xi^n(t, \omega))$.

LEMMA 1. For any stochastic process $\xi(t, \omega)$ satisfying

$$(3.7) \quad \int_u^v \xi(t, \omega)^2 dt < \infty, \quad \omega \in \Omega_1,$$

there exists a sequence of uniformly stepwise stochastic processes $\xi_n(t, \omega)$, $n=1, 2, \dots$ whose value at any time-point t is a B -measurable function of $\xi(\tau, \omega)$, $\tau \leq t$, and such that

$$\int_u^v |\xi_n(t, \omega) - \xi(t, \omega)|^2 dt \rightarrow 0$$

for almost all $\omega \in \Omega_1$.

This Lemma follows immediately from Lemma 7.1 in [2].

LEMMA 2. Let $\xi(t, \omega)$, $\eta(t, \omega)$ be stochastic processes such that the system $\{\xi(t, \omega), \eta(t, \omega)\}$ has the property α with regard to a one-dimensional Brownian motion $\beta(t, \omega)$ in $u \leq t \leq v$ and that

$$\int_u^v \xi(t, \omega)^2 dt < \infty, \quad \int_u^v \eta(t, \omega)^2 dt < \infty$$

for almost all $\omega \in \Omega_1$. Then we have

$$\begin{aligned}
(3.8) \quad & \int_u^v \xi(t, \omega) d\beta(t, \omega) \int_u^v \eta(s, \omega) d\beta(s, \omega) \\
&= \int_u^v \xi(t, \omega) \int_u^t \eta(s, \omega) d\beta(s, \omega) d\beta(t, \omega) \\
&+ \int_u^v \eta(s, \omega) \int_u^s \xi(t, \omega) d\beta(t, \omega) d\beta(s, \omega) + \int_u^v \xi(t, \omega) \eta(t, \omega) dt
\end{aligned}$$

for almost all.

Proof. Firstly we shall prove (3.8) in the case that both $\xi(t, \omega)$ and $\eta(t, \omega)$ are uniformly stepwise. Then we may assume that

$$(3.9) \quad \xi(t, \omega) = \xi(u_{i-1}, \omega), \quad \eta(t, \omega) = \eta(u_{i-1}, \omega), \quad u_{i-1} \leq t \leq u_i, \quad i=1, 2, \dots, n,$$

where

$$(3.10) \quad u = u_0 < u_1 < \dots < u_n = v.$$

The left side of (3.8) equals the following: $(u_{ij} = u_i + \frac{j}{N}(u_{i+1} - u_i))$

$$\begin{aligned}
& \sum_{ijpq} \int_{u_{i,j-1}}^{u_{ij}} \xi(t, \omega) d\beta(t, \omega) \int_{u_{p,q-1}}^{u_{pq}} \eta(s, \omega) d\beta(s, \omega) \\
&= \sum_{u_{ij} > u_{pq}} + \sum_{u_{pq} > u_{ij}} + \sum_{p=i, q=j} = \int_u^v \xi(t, \omega) \int_u^{\lambda_n(t)} \eta(s, \omega) d\beta(s, \omega) d\beta(t, \omega) \\
&+ \int_u^v \eta(s, \omega) \int_u^{\lambda_n(s)} \xi(t, \omega) d\beta(t, \omega) d\beta(s, \omega) \\
&+ \sum_i \xi(u_{i-1}, \omega) \eta(u_{i-1}, \omega) \sum_{j=1}^N (\beta(u_{ij}, \omega) - \beta(u_{i, j-1}, \omega))^2 = I_1 + I_2 + I_3,
\end{aligned}$$

where $\lambda_n(t)$ is the maximum u_{ij} which does not exceed t .

As $N \rightarrow \infty$, I_1 tends to the first term of the right side of (3.8) in probability by virtue of Theorem 5, since we have

$$\begin{aligned}
& \int_u^v \left| \xi(t, \omega) \int_u^{\lambda_n(t)} \eta(s, \omega) d\beta(s, \omega) - \xi(t, \omega) \int_u^t \eta(s, \omega) d\beta(s, \omega) \right|^2 dt \\
&= \int_u^v \left| \xi(t, \omega) \int_{\lambda_n(t)}^t \eta(s, \omega) d\beta(s, \omega) \right|^2 dt \\
&= \int_u^v \left| \xi(t, \omega) \eta(\lambda_n(t), \omega) (\beta(t, \omega) - \beta(\lambda_n(t), \omega)) \right|^2 dt \rightarrow 0
\end{aligned}$$

for almost all ω . By the same reason we see that I_2 tends to the second term of the right side of (3.8) in probability.

Since $\sum_{j=1}^N (\beta(u_{ij}, \omega) - \beta(u_{i, j-1}, \omega))^2 \rightarrow u_i - u_{i-1}$ (in probability), I_3 tends to the third term of the right side of (3.8).

Next we shall consider the general case. By Lemma 1 we shall construct $\xi_n(t, \omega)$, $n=1, 2, \dots$, and $\eta_n(t, \omega)$, $n=1, 2, \dots$ for $\xi(t, \omega)$ and $\eta(t, \omega)$ respec-

tively. Since our Lemma 2 holds for uniformly stepwise processes as is proved above, we have

$$\begin{aligned}
 (3.11) \quad & \int_u^v \xi_n(t, \omega) d\beta(t, \omega) \int_u^v \eta_n(t, \omega) d\beta(s, \omega) \\
 & = \int_u^v \xi_n(t, \omega) \int_u^t \eta_n(s, \omega) d\beta(s, \omega) d\beta(t, \omega) \\
 & \quad + \int_u^v \eta_n(s, \omega) \int_u^s \xi_n(t, \omega) d\beta(t, \omega) d\beta(s, \omega) + \int_u^v \xi_n(t, \omega) \eta_n(t, \omega) dt.
 \end{aligned}$$

Put

$$\begin{aligned}
 \zeta_n(t, \omega) &= \int_u^t \eta_n(s, \omega) d\beta(s, \omega), & \zeta(t, \omega) &= \int_u^t \eta(s, \omega) d\beta(s, \omega), \\
 \rho_n(t, \omega) &= \int_u^t \xi_n(s, \omega) d\beta(s, \omega), & \rho(t, \omega) &= \int_u^t \xi(s, \omega) d\beta(s, \omega).
 \end{aligned}$$

By taking adequate subsequences we see, by Theorem 5, that $\zeta_n(t, \omega)$ and $\rho_n(t, \omega)$ converge uniformly in t to $\zeta(t, \omega)$ and $\rho(t, \omega)$ respectively for almost all $\omega \in \Omega_1$. Therefore we have

$$\begin{aligned}
 & \int_u^v |\xi_n(t, \omega) \zeta_n(t, \omega) - \xi(t, \omega) \zeta(t, \omega)|^2 dt \\
 & \leq 2 \int_u^v |\xi_n(t, \omega) - \xi(t, \omega)|^2 |\zeta_n(t, \omega)|^2 dt \\
 & \quad + 2 \int_u^v |\xi(t, \omega)|^2 |\zeta_n(t, \omega) - \zeta(t, \omega)|^2 dt \rightarrow 0
 \end{aligned}$$

for almost all $\omega \in \Omega_1$, from which follows by Theorem 5

$$\int_u^v \xi_n(t, \omega) \zeta_n(t, \omega) d\beta(t, \omega) \rightarrow \int_u^v \xi(t, \omega) \zeta(t, \omega) d\beta(t, \omega) \quad (\text{in probability}).$$

Similaly we have

$$\int_u^v \eta_n(s, \omega) \rho_n(s, \omega) d\beta(s, \omega) \rightarrow \int_u^v \eta(s, \omega) \rho(s, \omega) d\beta(s, \omega) \quad (\text{in probability}).$$

Further we have

$$\begin{aligned}
 & \left| \int_u^v \xi_n(t, \omega) \eta_n(t, \omega) dt - \int_u^v \xi(t, \omega) \eta(t, \omega) dt \right| \\
 & \leq \sqrt{\int_u^v \eta_n(t, \omega)^2 dt \int_u^v (\xi_n(t, \omega) - \xi(t, \omega))^2 dt} \\
 & \quad + \sqrt{\int_u^v \xi(t, \omega)^2 dt \int_u^v (\eta_n(t, \omega) - \eta(t, \omega))^2 dt} \rightarrow 0.
 \end{aligned}$$

Thus our Lemma 2 is completely proved.

By the same way as above, we obtain the following Lemmas 3 and 4.

LEMMA 3. *Let $\xi(t, \omega)$ and $\eta(t, \omega)$ be stochastic processes such that the system $\{\xi(t, \omega), \eta(t, \omega)\}$ has the property α with regard to the two-dimensional Brownian motion $(\beta(t, \omega), \gamma(t, \omega))$ and that*

$$\int_u^v \xi(t, \omega)^2 dt < \infty, \quad \int_u^v \eta(t, \omega)^2 dt < \infty$$

for almost all $\omega \in \Omega_1$.

Then we have

$$\begin{aligned} (3.12) \quad & \int_u^v \xi(t, \omega) d\beta(t, \omega) \int_u^t \eta(s, \omega) d\gamma(s, \omega) \\ &= \int_u^v \xi(t, \omega) \int_u^t \eta(s, \omega) d\gamma(s, \omega) d\beta(t, \omega) \\ &+ \int_u^v \eta(s, \omega) \int_u^s \xi(t, \omega) d\beta(t, \omega) d\gamma(s, \omega) \end{aligned}$$

for almost all $\omega \in \Omega_1$.

LEMMA 4. *Let $a(t, \omega)$ and $b(t, \omega)$ be stochastic processes such that the system $a(t, \omega), b(t, \omega)$ has the property α with regard to a one-dimensional Brownian motion $\beta(t, \omega)$ and that*

$$\int_u^v |a(t, \omega)| dt < \infty, \quad \int_u^v |b(t, \omega)|^2 dt < \infty$$

for almost all $\omega \in \Omega_1$. Then we have

$$\begin{aligned} (3.13) \quad & \int_u^v a(t, \omega) dt \int_u^v b(s, \omega) d\beta(s, \omega) \\ &= \int_u^v a(t, \omega) \int_u^t b(s, \omega) d\beta(s, \omega) dt + \int_u^v b(s, \omega) \int_u^s a(t, \omega) dt d\beta(s, \omega). \end{aligned}$$

LEMMA 5. *Let $\xi^i(t, \omega)$, $i=1, 2, \dots, n$, be determined as in Theorem 6. Then we have*

$$\begin{aligned} (3.14) \quad & (\xi^i(s, \omega) - \xi^i(t, \omega))(\xi^j(s, \omega) - \xi^j(t, \omega)) \\ &= \int_t^s \{(\xi^i(\tau, \omega) - \xi^i(t, \omega))a^j(\tau, \omega) + (\xi^j(\tau, \omega) - \xi^j(t, \omega))a^i(\tau, \omega) + b_k^i(\tau, \omega)b_k^j(\tau, \omega)\} d\tau \\ &+ \int_t^s \{(\xi^i(\tau, \omega) - \xi^i(t, \omega))b_k^j(\tau, \omega) + (\xi^j(\tau, \omega) - \xi^j(t, \omega))b_k^i(\tau, \omega)\} d\beta^k(\tau, \omega) \end{aligned}$$

for almost all $\omega \in \Omega_1$ and for $u \leq t \leq s \leq v$.

Proof. By the assumption we have

$$\begin{aligned} & (\xi^i(s, \omega) - \xi^i(t, \omega)) (\xi^i(s, \omega) - \xi^j(t, \omega)) \\ &= \int_t^s a^i(\tau, \omega) d\tau \int_t^s a^j(\sigma, \omega) d\sigma + \int_t^s b_k^i(\tau, \omega) d\beta^k(\tau, \omega) \int_t^s a^j(\sigma, \omega) d\sigma \\ &+ \int_t^s a^i(\tau, \omega) d\tau \int_t^s b_l^j(\sigma, \omega) d\beta^l(\sigma, \omega) \\ &+ \int_t^s b_k^i(\tau, \omega) d\beta(\tau, \omega) \int_t^s b_l^j(\sigma, \omega) d\beta^l(\sigma, \omega), \end{aligned}$$

from which follows (3.14) at once by virtue of Lemmas 2, 3 and 4.

LEMMA 6. Let $\xi^i(t, \omega)$, $i=1, 2, \dots, n$, be determined as in Theorem 6. For the point-system:

$$\Delta: t=t_0 < t_1 < \dots < t_m = s$$

we put

$$S(\Delta, \omega) = \sum_{\mu=1}^m | \xi^i(t_\mu, \omega) - \xi^i(t_{\mu-1}, \omega) | | \xi^j(t_\mu, \omega) - \xi^j(t_{\mu-1}, \omega) |.$$

Then there exists $M=M(\varepsilon)$ independent of Δ for any $\varepsilon > 0$ such that

$$(3.15) \quad Pr\{\omega \in \Omega_1, S(\Delta, \omega) > M\} < \varepsilon.$$

Proof. We may consider the case that

$$\int_{\Omega} \int_t^s b_k^p(\tau, \omega) dt P(d\omega) < \infty, \quad p=i, j, \quad k=1, 2, \dots, n.$$

since, if our Lemma is established in this case, we can easily deduce our Lemma in the general case by the definition of stochastic integral. When there is no confusion, we omit the time parameter and the probability parameter ω in the following.

$$\begin{aligned} & (\xi^i(t_\mu) - \xi^i(t_{\mu-1})) (\xi^j(t_\mu) - \xi^j(t_{\mu-1})) \\ &= \int_{t_{\mu-1}}^{t_\mu} a^i d\tau \int_{t_{\mu-1}}^{t_\mu} a^j d\sigma + \int_{t_{\mu-1}}^{t_\mu} b_k^i d\beta^k \int_{t_{\mu-1}}^{t_\mu} a^j d\sigma \\ &+ \int_{t_{\mu-1}}^{t_\mu} a^i d\tau \int_{t_{\mu-1}}^{t_\mu} b_k^j d\beta^k + \int_{t_{\mu-1}}^{t_\mu} b_k^i d\beta^k \int_{t_{\mu-1}}^{t_\mu} b_l^j d\beta^l. \end{aligned}$$

Since

$$S_1(\Delta, \omega) \equiv \sum_{\mu} \left| \int_{t_{\mu-1}}^{t_\mu} a^i d\tau \right| \left| \int_{t_{\mu-1}}^{t_\mu} a^j d\sigma \right| \leq \max_{t \leq t' \leq s' \leq s} \left| \int_{t'}^{s'} a^i d\tau \right| \left| \int_t^s a^j d\sigma \right|$$

for almost all $\omega \in \Omega_1$ we may find $M_1(\varepsilon)$ independent of Δ for any $\varepsilon > 0$ such that $M > M_1(\varepsilon)$ implies

$$(3.16) \quad Pr\{\omega \in \Omega_1, S_1(\Delta, \omega) > M\} < \varepsilon/4.$$

By the same way we may find $M_{2k}(\varepsilon)$ and $M_{3k}(\varepsilon)$ independent of Δ for any

$\varepsilon < 0$ such that $M > M_{2k}(\varepsilon)$ or $M > M_{3k}(\varepsilon)$ implies

$$(3.17) \quad Pr\{\omega \in \Omega_1, S_{2k}(A, \omega) > M\} < \varepsilon/4r \quad \text{or} \quad Pr\{\omega \in \Omega_2, S_{3k}(A, \omega) > M\} < \varepsilon/4r$$

respectively, where

$$S_{2k}(A, \omega) = \sum_{\mu} \left| \int_{t_{\mu-1}}^{t_{\mu}} b_k^i d\beta^k \right| \left| \int_{t_{\mu-1}}^{t_{\mu}} a^i d\sigma \right|,$$

$$S_{3k}(A, \omega) = \sum_{\mu} \left| \int_{t_{\mu-1}}^{t_{\mu}} a^i d\tau \right| \left| \int_{t_{\mu-1}}^{t_{\mu}} b_k^j d\beta^k \right|.$$

Put

$$S_{3kl}(A, \omega) \equiv \sum_{\mu} \left| \int_{t_{\mu-1}}^{t_{\mu}} b_k^i d\beta^k \right| \left| \int_{t_{\mu-1}}^{t_{\mu}} b_l^j d\beta^l \right| = \sum_{\mu} A_{\mu} B_{\mu}.$$

$$\int S_{4kl}(A, \omega) P(d\omega) = \sum_{\mu} \int_{\Omega} |A_{\mu}|^2 P(d\omega) + \sum_{\mu} \int_{\Omega} |B_{\mu}|^2 P(d\omega)$$

$$\leq \sum_{\mu} \int_{\Omega} \int_{t_{\mu-1}}^{t_{\mu}} (b_k^i)^2 d\tau P(d\omega) + \sum_{\mu} \int_{\Omega} \int_{t_{\mu-1}}^{t_{\mu}} (b_l^j)^2 d\tau P(d\omega)$$

$$\leq \int_{\Omega} \int_t^s (b_k^i)^2 d\tau P(d\omega) + \int_{\Omega} \int_t^s (b_l^j)^2 d\sigma P(d\omega).$$

Thus we may find $M_{4kl}(\varepsilon)$ independent of A for any $\varepsilon > 0$ such that $M > M_{4kl}(\varepsilon)$ implies

$$Pr\{\omega \in \Omega_1, S_{4kl}(A, \omega) > M\} < \varepsilon/4r^2.$$

Since

$$S(A, \omega) \leq S_1(A, \omega) + \sum_k S_{2k}(A, \omega) + \sum_k S_{3k}(A, \omega) + \sum_{k,l} S_{4kl}(A, \omega),$$

we have (3.15) by putting

$$M = M(\varepsilon) = M_1(\varepsilon) + \sum_k M_{2k}(\varepsilon) + \sum_k M_{3k}(\varepsilon) + \sum_{k,l} M_{4kl}(\varepsilon).$$

Proof of THEOREM 6. By Taylor expansion of $f(t, x^1, \dots, x^n)$ we have (the probability parameter ω being omitted)

$$\begin{aligned} \eta(s, \omega) - \eta(t, \omega) &= \sum_{k=1}^m (\eta(t_k^m, \omega) - \eta(t_{k-1}^m, \omega)) \quad (t_k^m = t + \frac{k}{m}(s-t)) \\ &= \sum_{k=1}^m [f(*k)(t_k^m - t_{k-1}^m) + \sum_{i=1}^n f_i(*k)(\xi^i(t_k^m) - \xi^i(t_{k-1}^m))] \\ &\quad + \frac{1}{2} \sum_{ij} f_{ij}(*k)(\xi^i(t_k^m) - \xi^i(t_{k-1}^m))(\xi^j(t_k^m) - \xi^j(t_{k-1}^m)) \\ &\quad + \sum_{ij} \theta_{ij}^m(\xi^i(t_k^m) - \xi^i(t_{k-1}^m))(\xi^j(t_k^m) - \xi^j(t_{k-1}^m)), \end{aligned}$$

where

$$*k = (t_{k-1}^m, \xi^1(t_{k-1}^m), \dots, \xi^n(t_{k-1}^m)).$$

Since $f_{ij}(t, x^1, \dots, x^n)$ are continuous and $\xi^i(t, \omega)$, $i=1, 2, \dots, n$ are all continuous in t for almost all $\omega \in \Omega_1$, $\theta_{i,j,k}^m$ tends to 0 uniformly in m and k as $n \rightarrow \infty$ for almost all $\omega \in \Omega_1$. Therefore we have

$$\sum_{kij} \theta_{ijk}^m \text{ ("") } \rightarrow 0 \text{ (in probability on } \Omega_1)$$

by virtue of Lemma 6.

By Lemma 5 the remainder equals the following expression :

$$\begin{aligned} (3.18) \quad & \int_t^s (f_0(*) + f_i(*)a^i(\tau) + \frac{1}{2}f_{ij}(*)b_k^i(\tau)b_k^j(\tau))d\tau + \int_t^s f_i(*)b_j^i(\tau)d\beta^j(\tau) \\ & + \frac{1}{2} \int_t^s f_{ij}(*)[(\xi^i(\tau) - \xi^i(\lambda_m(\tau)))a^j(\tau) + (\xi^j(\tau) - \xi^j(\lambda_m(\tau)))a^i(\tau)]d\tau \\ & + \frac{1}{2} \int_t^s f_{ij}(*)[(\xi^i(\tau) - \xi^i(\lambda_m(\tau)))b_k^j(\tau) + (\xi^j(\tau) - \xi^j(\lambda_m(\tau)))b_k^i(\tau)]d\beta^k(\tau), \end{aligned}$$

where $\lambda_m(\tau)$ denotes the maximum t_k^m which dose not exceed τ and $*$ denotes $(\lambda_m(\tau), \xi^1(\lambda_m(\tau)), \dots, \xi^n(\lambda_m(\tau)))$.

But $\xi^i(\lambda_n(\tau), \omega) \rightarrow \xi^i(\tau, \omega)$ uniformly in τ for almost all $\omega \in \Omega_1$ as $n \rightarrow \infty$. Therefore, by letting $n \rightarrow \infty$ in (3.18) we obtain

$$\begin{aligned} \eta(s) - \eta(t) = & \int_t^s (f_0(\tau, \xi) + f_i(\tau, \xi)a^i(\tau) + \frac{1}{2}f_{ij}(\tau, \xi)b_k^i(\tau)b_k^j(\tau))d\tau \\ & + \int_t^s f_i(\tau, \xi)b_j^i(\tau)d\beta^j(\tau), \end{aligned}$$

which proves our Theorem 5.
