# WIENER FUNCTIONALS AND PROBABILITY LIMIT THEOREMS I: THE CENTRAL LIMIT THEOREMS

## 1. Introduction

Our object is to study limit theorems in relation to functionals built on a dynamical system generated by the flow of Gaussian white noise or equivalently functionals subordinate to a real Gaussian stationary process

with $E \xi(t)=0$, complex spectral measure $d \beta$, and spectral measure $d \sigma(\lambda)=$ $E|d \beta(\lambda)|^{2}$, which is absolutely continuous with respect to Lebesgue measure, $d \sigma(\lambda)=f(\lambda) d \lambda$.

Define $\mathcal{L}_{k, p}(1 \leq k<\infty, 0<p \leq \infty)$ to be the set of complex symmetric Borel functions $h$ on $\boldsymbol{R}^{k}$ satisfying (i) $\overline{h(\lambda)}=h(-\lambda) \quad$ (ii) $h \in L^{p}\left(d^{k} \sigma\right), d^{k} \sigma=d \sigma\left(\lambda_{1}\right) d \sigma\left(\lambda_{2}\right)$ $\cdots d \sigma\left(\lambda_{k}\right), \lambda=\left(\lambda_{1}, \cdots, \lambda_{k}\right) \in R^{k}$. A real-valued second order strictly stationary process $X(t)$, subordinate to $\xi$, with zero mean is represented by the Ito-Wiener expansion

\end{equation*}

where $c_{k} \in \mathcal{L}_{k, 2}, e_{k}(\lambda, t)=\exp i \lambda t, \bar{\lambda}=\lambda_{1}+\cdots+\lambda_{k}, d^{k} \beta=d \beta\left(\lambda_{1}\right) \cdots d \beta\left(\lambda_{k}\right)$; the $k$-fold multiple Ito Integral ([2], [3]) in (1.2) is understood in the usual way ([6], [7], [8]). Throughout the paper the whole space as an integration domain is suppressed in an integral sign. $\boldsymbol{R}^{k}$ is such an example for the integral in (1.2).

Summarizing notational conventions: Constants will be denoted by $c, c_{1}, c_{2}$, ... which are not always the same for each appearance. Given non-negative $f(x), g(x)$, we use $f(x) \asymp g(x)$ to indicate that there exist constants $c_{1}, c_{2}>0$ such that $c_{1} f(x) \leq g(x) \leq c_{2} f(x)$ on a specified region.

To formulate the main theorem introduce an integral transform which maps $u \in L^{1}\left(d^{k} \sigma\right)(k \geq 1)$ to $\varphi(u ; \lambda) \in L^{1}(\boldsymbol{R})$, the space of Lebesgue integrable functions on $\boldsymbol{R}$ :

\bar{\lambda}^{\prime}=\lambda_{1}+\cdots+\lambda_{k-1} \quad(k \geq 2), \quad \lambda^{\prime}=\left(\lambda_{1}, \cdots, \lambda_{k-1}\right) \\
\varphi(u ; \lambda)=u(\lambda) f(\lambda) \quad(k=1) .

Our main theorem is
Theorem 1. Suppose that the following conditions (i)-(iv) are satisfied.
(i) $f(\lambda)$ is bounded.
(ii) $V(T)=V\left(\int_{0}^{T} X(t) d t\right) \asymp T$, as $T \rightarrow \infty$,
where $V$ denotes variance.
(iii) $\lim _{n \rightarrow \infty} \varlimsup_{T \rightarrow \infty} \frac{1}{T} \Delta V_{n}(T)=0$
where

(iv) For every $\varepsilon>0, k \geq 1$

and $\Phi\left(\left|c_{k}\right|^{2} ; h\right)$ is the functional of $\left|c_{k}\right|^{2}$ defined by

Then

with

where dist denotes probability distribution, and $N(0,1)$ the normal law with zero mean and variance 1.

This theorem anounced in [8], [9] refines the central limit theorem in [6].
It will be easy to see that the conditions of Theorem 1 ensure the convergence of finite-dimensional distributions of the process $X_{T}(t), 0 \leq t<\infty$, to the corresponding ones of standard Brownian motion, as $T \rightarrow \infty$, where

The functional central limit theorem, which will be studied in a forthcoming paper, would require further regularity conditions imposed on $c_{k}, f(\lambda)$.

## 2. Preliminaries

Given real random variables $\xi_{i}(1 \leq i \leq m)$, each with the $m$ th moment, the cumulant $S\left(\xi_{1}, \cdots, \xi_{m}\right)$ as a multi-linear symmetric functional of them is defined by

S\left(\xi_{1}, \cdots, \xi_{m}\right)=\left.i^{-m}\left(\frac{\partial^{m}}{\partial \alpha_{1} \cdots \partial \alpha_{m}}\right) \log E\left\{\exp i\left[\alpha_{1} \xi_{1}+\cdots+\alpha_{m} \xi_{m}\right]\right\}\right|_{\alpha_{1}=\cdots=\alpha_{m}=0}
$$

When $\xi_{1}, \cdots, \xi_{m}$ consist of $m(1) \eta_{1} ' s, \cdots, m(k) \eta_{k}$ 's, with $m(1)+\cdots+m(k)=m$, we use $S_{m(1) \cdots m(k)}\left(\eta_{1}, \cdots, \eta_{k}\right)$ instead of $S\left(\xi_{1}, \cdots, \xi_{m}\right)$.

Consider a family of functions $\mathscr{F}=\left\{f_{i}, 1 \leq i \leq p\right\}, f_{i} \in L^{2}\left(d^{l(i)} \sigma\right)$, with $\sum_{i=1}^{p} l(i)=2 m(m=1,2, \cdots)$, and corresponding integrals with kernels $f_{i}$

I_{i}=I\left(f_{i}\right)=\int f_{i} d^{l(i)} \beta, \quad 1 \leq i \leq p
$$

The arguments involved in $f_{i}, 1 \leq i \leq p$, together form a set of $2 m$ letters. Make couples $\left(a_{1}, b_{1}\right),\left(a_{2}, b_{2}\right), \cdots$ of letters taken at once from the $2 m$ letters, demanding that the letters in each couple are from different kernels e.g. $a_{1}$ is from $f_{k}$ but $b_{1}$ from $f_{l}, 1 \leq k \neq l \leq p$, we want to make as many couples as possible. When we could get just $m$ couples, $\Gamma=\left\{\left(a_{1}, b_{1}\right),\left(a_{2}, b_{2}\right), \cdots,\left(a_{m}, b_{m}\right)\right\}$ (a complete set of couples) the coupling is complete. Whether there exists a complete coupling depends on the composition of the numbers $l(1), \cdots, l(p)$. For example, if $l(1)$ is too large compared with the others, a complete coupling does not exist. If $l(1), \cdots, l(p)$ are well balanced, there may be several complete couplings which yield different complete sets of couples.

Given a complete set of couples $\Gamma$, make substitutions $a_{1} \rightarrow \lambda_{1}, b_{1} \rightarrow-\lambda_{1}$, $a_{m} \rightarrow \lambda_{m}, b_{m} \rightarrow-\lambda_{m}$ in the arguments of the product $f_{1} f_{2} \cdots f_{p}$, to obtain a function of $\lambda_{1}, \cdots, \lambda_{m}, \mathscr{F}\left(\Gamma ; \lambda_{1}, \cdots, \lambda_{m}\right)$. $\mathscr{F}\left(\Gamma ; \lambda_{1}, \cdots, \lambda_{m}\right)$ is called a $p$-fold kernel composed of $f_{1}, \cdots, f_{p}$ and will also be denoted by $\mathcal{K}\left(\Gamma ; f_{1}, \cdots, f_{p}\right) ; f_{i}(1 \leq i \leq p)$ is said to be concerned with $\mathcal{K}\left(\Gamma ; f_{1}, \cdots, f_{p}\right), f_{k}, f_{l}(k \neq l)$ are said to be connected by $\Gamma$ if there exists a couple $\left(a_{i}, b_{i}\right)$ with letters $a_{i}, b_{i}$ from either $f_{k}$ or $f_{l}$.

To proceed further, represent $f_{j}, 1 \leq j \leq p$, by distinct $p$ points on the plane, again denoted by $f_{j}$. They are called vertices. If $f_{k}, f_{l}(k \neq l)$ are connected, draw a segment connecting them, which will be called an edge. To avoid configurational complexity, the points representing vertices are so chosen that on an edge there are no other vertices than its end vertices.

The figure composed of all the edges and vertices is called the graph corresponding to a complete coupling $\Gamma$, and is again denoted by $\Gamma$. A subset of the edges and vertices form a subgraph of $\Gamma$. A figure composed of successively connected vertices and edges connecting them is called a polygonal line.

In general, $f_{k}, f_{l}(k \neq l)$ are said to be connected if there is a polygonal line starting at $f_{k}$ and ending in $f_{l}$. If vertices in $\Gamma$ are connected each other, $\Gamma$ is called a connected graph, and $\mathscr{F}\left(\Gamma ; \lambda_{1}, \cdots, \lambda_{m}\right)$ a connected kernel. In general, a disconnected graph $\Gamma$ is a disjoint union of connected subgraphs $\Gamma_{0}, \cdots, \Gamma_{s}$, and the corresponding kernel $\mathcal{K}\left(\Gamma_{1} ; f_{1}, \cdots, f_{p}\right)$ is a product of connected kernels corresponding to $\Gamma_{0}, \cdots, \Gamma_{s}$. If $f_{k}, f_{l}(k \neq l)$ are connected, the total number of couples $\left(a_{j}, b_{j}\right)$ connecting $f_{k}, f_{l}$ is called the multiplicity of the edge connec$\operatorname{ting} f_{k}, f_{l}$.

Let us denote by $\mathbb{E}(\mathscr{F})$ and $\mathbb{C}(\mathscr{F})$ respectively the set of graphs and connected ones based on $\mathscr{F}=\left\{f_{i}: 1 \leq i \leq p\right\}$. Obviously $\mathbb{C}(\mathscr{F}) \subset \mathbb{F}(\mathscr{F})$. When $l(1)+\cdots+l(p)$ is odd, $\mathscr{( H}(\mathscr{F}), \mathfrak{G}(\mathscr{F})$ are empty. We have the following formulas ([4], [8])

& E\left(I\left(f_{1}\right) \cdots I\left(f_{p}\right)\right)=\sum_{\Gamma \in \mathscr{G}(\mathscr{I})} \int \mathscr{F}(\Gamma ; \lambda) d^{m} \sigma,  \tag{2.1}\\
& S\left(I\left(f_{1}\right) \cdots I\left(f_{p}\right)\right)=\sum_{\Gamma \in \mathbb{E}(\mathscr{F})} \int \mathscr{F}(\Gamma ; \lambda) d^{m} \sigma, \tag{2.2}
\end{align*}
$$

where $m=(l(1)+\cdots+l(p)) / 2$ if $l(1)+\cdots+l(p)$ is even, and $\mathscr{F}(\Gamma ; \lambda)$ are abbreviations of $\mathcal{K}\left(\Gamma ; f_{1}, \cdots, f_{l}\right)$, while if it is odd the right-hand members stand for zero.

Proof. The product $I\left(f_{1}\right) \cdots I\left(f_{p}\right)$ can be represented as a sum of homegeneous polynomials (p. 388, [9]). $E\left(I\left(f_{1}\right) \cdots I\left(f_{p}\right)\right)$ is then given by the nonrandom term of the sum. This proves (2.1).

The formula (2.2) follows in turn from (2.1). We will prove it by induction. When $p=1$, the right-hand side of (2.2) is equal to zero since $\mathbb{C}(\mathscr{F})$ is empty, whereas by the equality $S\left(I\left(f_{1}\right)\right)=E\left(I\left(f_{1}\right)\right)$, the left-hand side is also equal to zero.

Let $p \geq 2$, assume (2.2) up to the ( $p-1$ )th step, and notice that there hold the relations between moments and cumlants ([5]):

& +S\left(I\left(f_{1}\right), I\left(f_{2}\right)\right) S\left(I\left(f_{3}\right), \cdots, I\left(f_{p}\right)\right)+\cdots
\end{align*}
$$

Suppose that $l(1)+\cdots+l(p)$ is odd, then on the right-hand side of this equality every term vanishes by the induction hypothesis, while on the lefthand side the first term vanishes, so does the second one. This means that (2.2) is true.

Suppose next that $l(1)+\cdots+l(p)$ is even, and using the induction hypothesis rewrite every term on the right-hand member of $(2,3)$ in terms of integrals with connected kernels; then they give rise to the sum

where $\mathfrak{D}$ is a set of disconnected graphs $\Gamma$. Here in view of the composition of terms on the right-hand side of (2.3), one recognizes that $\mathfrak{D}$ must be the totality of disconnected graphs formed by $\mathscr{F}$. Therefore by (2.1), (2.3) we have

& =\sum_{\Gamma \in \mathbb{C}(\mathscr{F})} \int \mathscr{F}(\Gamma ; \lambda) d^{m} \sigma,
\end{aligned}
$$

which proves (2.2).
Taking into account of (1.2)

& =\int_{-\infty}^{\infty} e^{i \lambda \tau} f_{2 k}(\lambda) d \lambda, \quad f_{2 k}(\lambda)=\varphi\left(\left|c_{k}\right|^{2} ; \lambda\right)
\end{aligned}

So that the spectral densities of $X(t)$ and $R_{n}(t)$ are respectively

Define

Obviously $\theta_{k}(\lambda) \in \mathcal{L}_{k, \infty}$.
For later use we set up several fundamental propositions (I-V) mostly pertaining to the expression (1.2).

## I. Suppose that

Proof. Suppose

whence by (2.5)

$$

Suppose

\Phi\left(\delta\left[\left|c_{k}\right|^{2}\right] ; h\right)=o(h)
$$

Since by (2.6)

\left|\Delta c_{k}\right|^{2} \leq\left(\left|c_{k}\right|-\left|c_{k}\right| \wedge \eta\right)\left(\left|c_{k}\right|+\left|c_{k}\right| \wedge \eta\right)=\delta\left[\left|c_{k}\right|^{2}\right]
$$

one obtains

II. Let $X(t)$ be a real second order stationary process, with zero mean and spectral density $\varphi(\lambda)$. Put

v(T)=V\left(\int_{0}^{T} X(t) d t\right), \quad \Phi(h)=\int_{0}^{h} \varphi(\lambda) d \lambda
$$

Then

\varlimsup_{T \rightarrow \infty} v(T) / T \leq 18 \varlimsup_{h \downarrow 0} \Phi(h) / h \leq 3 \pi^{2} \overline{\lim }_{T \rightarrow \infty} v(T) / T . \tag{2.8}
\end{gather*}

Proof. Write

K(\lambda)=\left(\frac{\sin \lambda T / 2}{\lambda / 2}\right)^{2} \frac{\varphi(\lambda)}{T}

Then obviously

On making $T \rightarrow \infty$, and then $\delta \downarrow 0$

(2.11) implies (2.7) and the second inequality of (2.8), while (2.9), (2.11), (2.13) do the first one of (2.8).

## III. Write

Then under the assumptions of the theorem

In relation to the method of moments we mention without proof an elememtary proposition.

By the formula (2.2), the right-hand member of the last equation is represented as a sum of integrals involving connected kernels corresponding to connected graphs. Those connected kernels are given birth through couplings among the components of $\boldsymbol{x}, \boldsymbol{y}, \boldsymbol{z}$. To be precise, write $k=b+c, l=c+a, m=a+b$ and suppose that $a$ components of $\boldsymbol{y}$ are connected with $a$ ones of $\boldsymbol{z}, b$ components of $\boldsymbol{z}$ with $b$ ones of $\boldsymbol{x}$ and similarly for $c$. Next make the substitutions denoted by $Q=Q\left(\lambda^{(a)}, \mu^{(b)}, \nu^{(c)}\right)$, with $\lambda^{(a)}=\left(\lambda_{1}, \cdots, \lambda_{a}\right) \in R^{a}$ etc.: substitute $\mu_{1}, \cdots, \mu_{b}, \nu_{1}, \cdots, \nu_{c}$ into the components of $\boldsymbol{x},-\nu_{1} \cdots,-\nu_{c}, \lambda_{1}, \cdots, \lambda_{a}$ into those
of $\boldsymbol{y}$, and $-\lambda_{1}, \cdots,-\lambda_{a},-\mu_{1}, \cdots,-\mu_{b}$ into those of $\boldsymbol{z}$. $Q$ are restricted to the set $\mathbb{C}$ of those substitutions which give rise to connected kernels. Let $N=N(Q)$ be the number of edges of the connected graph corresponding to $Q$. Then $N$ is equal to the number of positive $a, b, c$. The right-hand side of (3.7) is rewritten as

Depending on the composition of $d(\boldsymbol{e}), \cdots, d(\boldsymbol{j})$, there arise several cases. However, there is no essential change of technicality for different cases. So that we will restrict ourselves to the case that $d(\boldsymbol{e}), \cdots, d(\boldsymbol{j})>0 . \quad l_{p}(1 \leq p \leq 4)$ are linearly dependent functions of 6 variables $e, f, \cdots, j$, actually

The left-hand side of (3.24) is the discrepancy between the characteristic function of $L$ and $\exp \left(-z^{2} / 2\right)$, while on making $n \rightarrow \infty$, the right-hand side tends to zero. So that $L=N(0,1)$, or $\boldsymbol{M}$ consists of a single element $N(0,1)$. Since $\{\operatorname{dist} \bar{X}(T), T \geq 1\}$ is compact, this means that the conclusion (1.3) is true. This completes the proof of Theorem 1.

## 4. Random fields

We consider a direct extension of Theorem 1 to random fields. Let $X(x)$, $x \in \boldsymbol{R}^{d}$ be a strictly stationary random field subordinate to a strictly stationary real Gaussian random field

Then similarly to (1.2), $X(x)$ is represented by the Ito-Wiener expansion

where $\lambda=\left(\lambda^{1}, \cdots, \lambda^{k}\right), \quad d^{k} \beta=d \beta\left(\lambda^{1}\right) \cdots d \beta\left(\lambda^{k}\right), \quad \lambda^{j} \in R^{d}(1 \leq j \leq k), \quad e_{k}(\lambda, x)=$ $\exp i \bar{\lambda} \cdot x, \bar{\lambda} \cdot x$ is the inner product of $\bar{\lambda}=\lambda^{1}+\cdots+\lambda^{k}$ with $x$, and each $c_{k}(\lambda)$ $(1 \leq k<\infty)$ is symmetric in $\lambda^{1}, \cdots, \lambda^{k}$, subject to the conditions that $\overline{c_{k}(\boldsymbol{\lambda})}=c_{k}(-\boldsymbol{\lambda})$,

Write $a \leq b, a \rightarrow \infty$, $a \rightarrow 0(+0)$ respectively to abbreviate the relations, $a_{i} \leq b_{i}, a_{i} \rightarrow \infty, a_{i} \rightarrow 0(+0)$ $(1 \leq i \leq d)$. For $\delta>0, a \in \boldsymbol{R}^{d}$ we use the abbreviation $|a| \leq \delta(|a| \geq \delta)$ if $\left|a_{i}\right| \leq \delta\left(\left|a_{i}\right| \geq \delta\right)(1 \leq i \leq d)$. For example $0 \leq|h| \leq \delta\left(h=\left(h_{1}, h_{2}\right)\right)$ means $0 \leq\left|h_{1}\right|,\left|h_{2}\right| \leq \delta$.

As in Section 1 define

where $T \in \boldsymbol{R}^{d}, T>0$, and $|Q(T)|$ is the volume of $Q(T)=\left\{x \in R^{d}: 0 \leq x \leq T\right\}$.
(iii) $\lim _{n \rightarrow \infty} \varlimsup_{|Q(T)| \rightarrow \infty} \frac{1}{|Q(T)|} \Delta V_{n}(T)=0$,
where

In the same spirit as in Section 3 we clarify first relations (propositions VI-VIII) between the growth of $V(T)$ and behavior of spectral density of $X(x)$. The proof of Theorem 2 is essentially similar to that of Theorem 1. Stress is made on the features specific to the dimensionality $d>1$, but to avoid notational complexity, we restrict ourselves to the case $d=2$, and put $\boldsymbol{E}=\boldsymbol{R}^{2}$. So we are dealing with a random field $X(x)$ defined by (4.2) with $x \in E, \boldsymbol{\lambda}$ an $\boldsymbol{E}^{k}$-vector, i.e. a vector with $k$ components from $\boldsymbol{E}$.
VI. Let $\{X(x), x \in \boldsymbol{E}\}$ be a square-integrable strictly stationary real random field with mean zero and spectral density $\varphi(\lambda)=\varphi\left(\lambda_{1}, \lambda_{2}\right), \lambda=\left(\lambda_{1}, \lambda_{2}\right) \in \boldsymbol{E}$. Then

Similarly as in (3.14) we have thus 6 base $\boldsymbol{E}$-vectors $e, \cdots, j, \boldsymbol{E}$-vectors $l_{1}, \cdots, l_{4}$ as their linear combinations which satisfy $l_{1}+\cdots+l_{4}=0$, and bounded $L^{1}$-functions on $\boldsymbol{E}, g_{p}(1 \leq p \leq 6)$. There are several varieties of permissible compositions for $d(\boldsymbol{e}), \cdots, d(\boldsymbol{j})$. However, by the same reason as in (3.13) we confine ourselves to the case $d(\boldsymbol{e}), \cdots, d(\boldsymbol{j})>0$ and proceed along the same line as before. Choose linear transformations $\tilde{l}_{4}$, $\tilde{l}_{5}, \tilde{l}_{6}$ of the base $\boldsymbol{E}$-vectors, in order that these together with $l_{1}, l_{2}, l_{3}$ form a linearly independent set. By means of these 6 linear functions, make a linear transformation from $\boldsymbol{E}^{6}$ onto itself, and consider its inverse, with the same representation as in (3.15), (3.16). Obviously this transformation resolves into a linear transformation $\tilde{D}$ from $\boldsymbol{R}^{12}$ onto itself. With no loss of generality we assume that $e_{1}, \cdots, j_{1}$ satisfy the same relation as (3.17) with non-singular $A$, which determines a linear map from $\boldsymbol{E}^{3}$ onto itself, or equivalently a linear map $A$ from $R^{6}$ onto itself. Then, corresponding to (3.18), this time we have

## 5. Asymptotic independence and supplementary remarks

In relation to the limit theorems in Section 3, 4 we draw our attention to a structural interrelation between $X_{k}(t), 1 \leq k<\infty$, of (1.2) and (4.2). For this purpose we make

Definition 5.1. Let $X(t)=\left\{x_{1}(t), \cdots, x_{k}(t)\right\}, t \in[0, \infty)$, be an $R^{k}$-valued stochastic process such that dist $X(t), 0 \leq t<\infty$ form a relatively compact set under the weak topology.

The components of $X(t)$ are asymptotically independent as $t \rightarrow \infty$ if and only if

Notice that the relative compactness of dist. $X(t), 0 \leq t<\infty$, implies that (5.1) is true if only it is so for an arbitrary choice of $f_{j} \in \mathcal{S}(\boldsymbol{R})$, the Schwartz space of all real-valued rapidly decreasing infinitely differentiable functions on $\boldsymbol{R}$.
IX. Let $X(t)=\left(x_{1}(t), \cdots, x_{k}(t)\right), 0 \leq t<\infty$, be an $\boldsymbol{R}^{k}$-valued stochastic process, and suppose that each $X(t)$ has the moment of an arbitrary order and satisfies the conditions that there exists a non-negative sequence $\lambda_{2 n}, 1 \leq n<\infty$, such that

Then the components of $X(t)$ are asymptotically independent, as $t \rightarrow \infty$.
Sketch of the proof. For notational simplicity we deal with the case $k=3$. First notice that by (i), we can find a $t_{0} \geq 0$ such that dist $X(t), t_{0} \leq t<\infty$, is relatively compact.

For this purpose, to obtain an expansion of $\left\{\bar{X}_{q}{ }^{2}(T)\right\}^{m}, 1 \leq q \leq k$, into Ito's multiple integrals, introduce $P=\left\|p_{i j}\right\|$, an $m \times m$ symmetric matrix with integer entries $p_{i j} \geq 0$ such that $p_{i i}=0, o \leq p_{i} \leq q(1 \leq i \leq m)$, where $p_{i}=\sum_{j=1}^{m} p_{i j} \leq q$, and take $m(m-1) / 2$ independent variables $x_{i j} \in \boldsymbol{R}^{p_{i j}}, 1 \leq i<j \leq m, p_{i j}=d\left(x_{i j}\right)$.

Choose $p_{1}$ arguments of $a_{1}$ and replace them by $\boldsymbol{x}_{1}=\left(x_{12}, x_{13}, \cdots, x_{1 m}\right) \in \boldsymbol{R}^{p_{1}}$, choose $p_{2}$ ones of $a_{2}$ and replace them by $\boldsymbol{x}_{2}=$ $\left(x_{21}, x_{23}, \cdots, x_{2 m}\right) \in \boldsymbol{R}^{p_{2}}$, and so on, where $x_{j i}$ is defined to be $-x_{i j}$ if $i<j$, to get successively $\gamma_{q}\left(\boldsymbol{x}_{1}, \lambda_{1}\right), \cdots, \gamma_{q}\left(\boldsymbol{x}_{m}, \lambda_{m}\right), \lambda_{1} \in \boldsymbol{R}^{u}, \cdots, \lambda_{m} \in \boldsymbol{R}^{u_{m}}$, with $u_{i}=q-p_{i}$ $(1 \leq i \leq m)$. By the multiplication rule for Ito's multiple integrals (p. 53, [8], p. 388 [9])

where $\kappa_{0}$ is non-random and the summation in (5.7.1) is taken over all the matrices $P$ satisfying $s=u_{1}+\cdots+u_{m} \geq 1$ in addition to the above-mentioned restrictions, while the integration in (5.7.2) is over $\boldsymbol{R}^{r}$ with respect to $d^{\boldsymbol{\gamma}} \sigma=$ $\Pi_{1 \leq i<j \leq m} d^{p_{i j \sigma}}\left(x_{i j}\right)$. Those $x_{i j}$ for which $p_{i j}=0$ are to be dropped out of the above descriptions. Similarly only those $\lambda_{i}(1 \leq i \leq m)$ for which $u_{i}>0$ actually appear on the right-hand sides of (5.7.1), (5.7.2), the others being fictitious. The concrete expression of $\kappa(P)$, which is immaterial for the present use, can be shown to be given by (p. 53, [8])

& \widetilde{c}_{1}(\lambda)=\int \gamma_{j 1}\left(\boldsymbol{x}_{1}, \lambda_{1}\right) \cdots \gamma_{j 1}\left(\boldsymbol{x}_{m},\right.  \tag{5.9}\\
&\left.\lambda_{m}\right) d^{r_{1}} \sigma, \lambda=\left(\lambda_{1}, \cdots, \lambda_{m}\right), \\
& \widetilde{c}_{2}(\lambda)=\int \gamma_{j 2}\left(\boldsymbol{y}_{1}, \mu_{1}\right) \cdots \gamma_{j 2}\left(\boldsymbol{y}_{m},\right. \\
&\left.\mu_{m}\right) d^{r_{2}} \sigma, \mu=\left(\mu_{1}, \cdots, \mu_{m}\right), \\
& \cdots \cdots,
\end{align*}
$$

$K_{1}\left(\gamma_{j 1}\right)$ a product of integrals with connected kernels composed of $\gamma_{j 1}$, and similarly for the other $K$ 's. Then $\int F d^{s} \sigma$ in (5.8) results in an integral with a kernel $G$ composed of $\gamma_{j 1}, \cdots, \gamma_{j l}$, through a complete coupling of arguments involved in $\gamma$ 's. Resolve $G$ into a product of connected kernels $G_{1}, \cdots, G_{g}$ composed of $\gamma_{j 1}, \cdots, \gamma_{j l}$ :

G=G_{1} \cdots G_{g} . \tag{5.10}
\end{equation*}
$$

Let $d\left(G_{p}\right), 1 \leq p \leq g$, be the degree of $G_{p}$, i.e. the number of $\gamma$ 's concerned with $G_{p}$ (c.f. 2). On the right-hand sides of (5.9) one can find a $\gamma_{j k}(1 \leq k \leq l)$ which is concerned with $G_{p}$ and in its arguments contains a non-fictitious component of some of $\lambda, \mu, \cdots$, otherwise $G_{p}$ would be absorbed in the kernel of $K_{1}\left(\gamma_{j 1}\right) \cdots K_{l}\left(\gamma_{j l}\right)$. With no loss of generality, assume that $\lambda_{1}$ is such a nonfictitious component; $\gamma_{j 1}\left(\boldsymbol{x}, \lambda_{1}\right)$ is concerned with $G_{p}$. Think of a coupling procedure making a connected kernel $G_{p}$, then one knows that there is a $\gamma_{j t}$, $1 \leq t \leq l$, such that $t \neq 1$ and $\gamma_{j t}$ is concerned with $G_{p}$. Then, in order that $G_{p}$ be connected, $G_{p}$ must be concerned with the other $\gamma$. This means that $d\left(G_{p}\right) \geq 3$.

By (5.8), (5.9), the cumulant in (5.6) is expanded into a sum of constant multiples of expressions of the form

$$
\begin{equation*}
K_{1}\left(\gamma_{j 1}\right) \cdots K_{l}\left(\gamma_{j l}\right)\left(\int G_{1} d^{s_{1}} \sigma\right) \cdots\left(\int G_{g} d^{s_{g}}\right) \tag{5.11}
\end{equation*}
$$

$K_{1}\left(\gamma_{j 1}\right) \cdots K\left(\gamma_{j l}\right)$ is represented as a product of integrals $\int G^{\prime} d^{u} \sigma$ with connected kernels $G^{\prime}$ each of which is composed of a single one of $\gamma_{j 1}, \cdots, \gamma_{j l}$. It may happen that $d\left(G^{\prime}\right)=2$, and $G^{\prime}$ is concerned with $\gamma_{j k}$. Then

$$
\int G^{\prime} d^{u} \sigma=E\left(\bar{X}_{j k}^{\mathrm{e}}(T)\right)^{2} \leq 1
$$

If $d_{0} \equiv d\left(G_{p}\right)(1 \leq p \leq g)$, then since $d_{0} \geq 3, \int G_{p} d^{s} p \sigma$ is of the same type as a connected-kernel summand of $S_{k(1) \cdots k(n)}\left(\eta_{1}^{\mathrm{z}}(T), \cdots, \eta_{n}^{2}(T)\right)$, with $k(1)+\cdots+k(n)=$ $d_{0}$, in Lemma 1. So that by Lemma 1 one obtains

$$
L=\varlimsup_{T \rightarrow \infty}\left|S\left(\left\{\bar{X}_{j 1}^{\mathrm{e}}(T)\right\}^{m_{1}}, \cdots,\left\{\bar{X}_{j l}^{\mathrm{e}}(T)\right\}^{m_{l}}\right)\right| \leq c \varepsilon,
$$

where $c>0$ is a constant independent of $\varepsilon$. The same is true with $\int G^{\prime} d^{u} \sigma$ if $d\left(G^{\prime}\right) \geq 3$. By the relative compactness of $\{$ dist $X(T), T \geq 1\}$, equi-convergence of $\bar{X}$ and $\bar{X}^{\boldsymbol{q}}(T)$, (5.5), and IV, one can find a sequence $\left\{T_{n}\right\} \in \mathscr{D}_{0}$, such that there exist

$$
\begin{aligned}
& F=\lim _{n \rightarrow \infty} \operatorname{dist} \bar{X}\left(T_{n}\right)=\lim _{n \rightarrow \infty} \bar{X}^{\mathrm{q}}\left(T_{n}\right), \\
& L=\lim _{n \rightarrow \infty}\left|S\left(\left\{\bar{X}_{j 1}^{\mathrm{z}}\left(T_{n}\right)\right\}^{m_{1}}, \cdots,\left\{\bar{X}_{j l}^{\mathrm{z}}\left(T_{n}\right)\right\}^{m_{\imath}}\right)\right|,
\end{aligned}
$$

and

$$
\lim _{n \rightarrow \infty} S\left(\left\{\bar{X}_{j 1}^{\mathrm{j}_{1}}\left(T_{n}\right)\right\}^{m_{1}}, \cdots,\left\{\bar{X}_{j l}^{\mathrm{e}}\left(T_{n}\right)\right\}^{m_{l}}\right)=S\left(\xi_{j 1}^{m_{1}}, \cdots, \xi_{j l}^{m_{l}}\right),
$$

where $\left(\xi_{1}, \cdots, \xi_{l}\right)$ is distributed according to $F$. Therefore $L$ is independent of $\varepsilon$. Since $\varepsilon, 0 \leq \varepsilon \leq 1$, is arbitrary, this implies that $L=0$. This completes
the proof of (5.6).
By the known functional relations between cumulants and moments (c.f. [5]) (5.6) implies that

$$
\begin{equation*}
\lim _{T \rightarrow \infty}\left\{E\left(\left\{\bar{X}_{1}^{\mathrm{e}}(T)\right\}^{m_{1} \ldots\left\{\bar{X}_{k}^{\mathrm{e}}\right.}(T)\right\}^{m_{k}}\right)-E\left\{\bar{X}_{1}^{\mathrm{e}}(T)\right\}^{\left.m_{1} \ldots E\left\{\bar{X}_{k}^{\mathrm{e}}(T)\right\}^{m_{k}}\right\}=0 .} \tag{5.12}
\end{equation*}
$$

As we have seen in the proof of Theorem 1

$$
\lim _{r \rightarrow \infty} S_{m}\left(\bar{X}_{j}^{\mathrm{e}}(T)\right)=0, \quad \text { for } \quad m \geq 3,1 \leq j \leq k
$$

Then again by the relations between cumulants and moments

$$
\varlimsup_{r \rightarrow \infty}\left\{\bar{X}_{j}^{\mathrm{q}}(T)\right\}^{2 n} \leq \frac{(2 n)!}{2^{n} n!} \varlimsup_{r \rightarrow \infty}\left\{\bar{X}_{j}^{\mathrm{q}}(T)\right\}^{2} \leq \frac{(2 n)!}{2^{n} n!} .
$$

Appealing to IX, the components of $\bar{X}^{\mathrm{e}}(T)$ are asymptotically independent, so are those of $\bar{X}(T)$, as $T \rightarrow \infty$. This completes the proof of Theorem 3.

At the final stage of this section, we will describe sufficient conditions of practical use which guarantee the realization of some of assumptions in Theorem 1, Theorem 2. Although those conditions are confined to the frame work of Theorem 1, it is an easy task to modify them to be adapted to Theorem 2.

In the notations of 1 define

$$
\begin{aligned}
\Psi_{k}(h)= & k!\int f\left(\lambda_{1}\right) \cdots f\left(\lambda_{k-1}\right) d \lambda_{1} \cdots d \lambda_{k-1} \\
& \times \sup _{x} \int_{x}^{x+h}\left|c_{k}\left(\lambda, \lambda_{1}, \cdots, \lambda_{k-1}\right)\right|^{2} f(\lambda) d \lambda, \quad h>0, \quad k \geq 2
\end{aligned}
$$

Then obviously

$$
\Phi\left(\left|c_{k}\right|^{2} ; h\right) \leq \Psi_{k}(h)
$$

Applying the first inequality in (2.8) with $X(t)$ replaced by $R_{n}(t)$ one obtains:
In order that the assumption (iii), Theorem 1 be true it is sufficient that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \varlimsup_{h \ngtr 0} \frac{1}{h} \sum_{k \geq n} \Phi\left(\left|c_{k}\right|^{2} ; h\right)=0 \tag{A}
\end{equation*}
$$

or more strongly

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \varlimsup_{h \downarrow 0} \frac{1}{h} \sum_{k \geq n} \Psi_{k}(h)=0 . \tag{B}
\end{equation*}
$$

Let $a, b>0$, and suppose $x$ satisfies $-(a+b)<x<a+b$. Then one can find a $y$ such that $-b<y<b,-a<x-y<a$.

Define $\mathcal{C}_{e b}(\boldsymbol{R})$ to be the set of real even bounded continuous functions on $\boldsymbol{R}$, and for non-negative $g \in \mathcal{C}_{e b}(\boldsymbol{R})$ define $z(g)=\inf (x: x \geq 0, g(x)=0)$. If
$g, h \in \mathcal{C}_{e b}(\boldsymbol{R}) \cap L^{1}(\boldsymbol{R})$, are non-negative, $z(g * h) \geq z(g)+z(h)$. This is a consequence of addition of independent random variables with constant multiples of $g, h$ as their density functions, or the above algebraic fact combined with the convolution $g * h$.

Put

$$
l_{k}(a)=k!\underset{\left|\lambda_{1}+\cdots+\lambda_{k}\right| \leq^{a}}{\operatorname{ess} \inf _{k}}\left|c_{k}(\lambda)\right|^{2}, \quad a>0, \quad k \geq 1
$$

Then

$$
\begin{equation*}
\varphi\left(\left|c_{k}\right|^{2} ; \lambda\right) \geq l_{k}(a) f_{k}(\lambda), \quad|\lambda| \leq a, \quad f_{k}=f^{k *} \tag{5.13}
\end{equation*}
$$

$c_{k}(k \geq 1)$ is said to satisfy $(L)$ if there exists $a_{h}>0$ such that $l_{k}\left(a_{k}\right)>0$. Since $f_{k} \in \mathcal{C}_{e b}(R)$ for $k \geq 2$, and $f_{2}(0)=\|f\|_{2}^{2}>0, \delta_{1}=z\left(f_{2}\right)>0, \delta_{k}=z\left(f_{2 k}\right) \geq k \delta_{1}$. Suppose that $c_{2 k} \equiv \equiv_{0}$ and it satisfies $(L)$, then by (5.13)

$$
\varphi\left(\left|c_{2 k}\right|^{2} ; \lambda\right) \geq \alpha \quad \text { for } \quad|\lambda| \leq \beta
$$

where

$$
\alpha=\inf _{|\lambda| \leq \delta_{k} / 2} f_{2 k}(\lambda) l_{2 k}\left(a_{2 k}\right)>0, \quad \beta=a_{2 k} \wedge \delta_{k} / 2 .
$$

Then, since

$$
\lim _{h \downarrow 0} \Phi\left(\left|c_{k}^{2}\right| ; h\right) / h \geq \alpha
$$

by (2.7)

$$
\varliminf_{T \rightarrow \infty} v_{k}(T) / T>0
$$

whence

$$
\lim _{T \rightarrow \infty} V(T) / T>0
$$

There exists a $\lambda_{0}>0$ such that $f_{3}\left(\lambda_{0}\right)>0$. Suppose that $c_{2 k+3} \neq 0(k \geq 1)$, $(L)$ is satisfied for $c_{2 k+3}$ and $k$ is so large that $k \delta_{1}-\lambda_{0}>0$. Then arguing as above $f_{2 k+3}(x)$ is positive on $I=\left(-k \delta_{1}-\lambda_{0}, k \delta_{1}-\lambda_{0}\right)$ and, since one can find out $\varepsilon>0$ such that $I \supset[-\varepsilon, \varepsilon]$,

$$
\alpha=\inf _{|\lambda| \leq 巳^{2}} f_{2 k+3}(\lambda) l_{2 k+3}\left(a_{2 k+3}\right)>0
$$

Therefore having

$$
\varphi\left(\left|c_{2 k+3}\right|^{2} ; \lambda\right) \geq \alpha \quad \text { for } \quad|\lambda| \leq a_{2 k+3} \wedge \varepsilon
$$

one obtains as above

$$
\varliminf_{T \rightarrow \infty} V_{2 k+3}(T) / T>0
$$

whence also

$$
\lim _{T \rightarrow \infty} V(T) / T>0 .
$$

$c_{k}(k \geq 1)$ is said to satisfy $(U)$ if there exists a $b_{k}>0$ such that

$$
u_{k}=k!\operatorname{cess}_{\left|\lambda_{1}+\cdots+\lambda_{k}\right| \leq b_{k}}\left|c_{k}(\lambda)\right|^{2}<\infty
$$

If this is the case

$$
\begin{aligned}
& \varphi\left(\left|c_{k}\right|^{2} ; \lambda\right) \leq u_{k}\left\|f_{k}\right\|_{\infty}, \quad|\lambda| \leq b_{k}, \\
& \lim _{h \neq 0} \Phi\left(\left|c_{k}\right|^{2} ; h\right) / h<\infty,
\end{aligned}
$$

whence by (2.8)

$$
\varlimsup_{T \rightarrow \infty} v_{k}(T) / T<\infty,
$$

and moreover $\Phi\left(\delta\left[\left|c_{k}\right|^{2}\right] ; h\right)=0$ for all sufficiently small $h$, because $\delta\left[\left|c_{k}\right|^{2}\right](\lambda)=0$ for $\left|\lambda_{j}+\cdots+\lambda_{k}\right| \leq b$ and sufficiently small $h=1 / T$. If all $c_{k}, 1 \leq k<\infty$, satisfy $(U)$ in such a way that there exists a $b_{0}>0$ such that $b_{k}>b_{0}$ for all $k \geq 1$, then

$$
\frac{1}{h} \sum_{k=n}^{\infty} \Phi\left(\left|c_{k}\right|^{2} ; h\right) \leq \sum_{k=n}^{\infty} u_{k}\left\|f_{k}\right\|_{\infty} .
$$

Summarizing these we are led to the conclusions:
(C) If the expansion of $X(t)$ contains a summand of even degree whose kernel satisfies $(L)$, or it does infinitely many summands of odd degrees whose kernels satisfy $(L)$, then

$$
\lim _{T \rightarrow \infty} V(T) / T>0
$$

(D) If every $c_{k}, 1 \leq k \leq n$, satisfies ( $U$ )

$$
\varlimsup_{T \rightarrow \infty} V_{n}(T) / T<\infty
$$

(E) If all $c_{k}, 1 \leq k<\infty$, satisfy $(U)$ in such a way that there exists a $b_{0}>0$ such that $b_{k}>b_{0}$ for $k \geq 1$ and moreover

$$
\sum_{n=1}^{\infty} u_{k}\left\|f_{k}\right\|_{\infty}<\infty,
$$

then the both conditions

$$
\text { (A) and } \varlimsup_{T \rightarrow \infty} V(T) / T<\infty
$$

are satisfied.
(F) If (C), (E) in the above are satisfied, the conditions (ii), (iii), and (iv) of Theorem 1 are satisfied.
