# On the Spectral Problem for Anyons

#### Abstract

We consider the spectral problem resulting from the Schrödinger equation for a quantum system of $n \geqq 2$ indistinguishable, spinless, hard-core particles on a domain in two dimensional Euclidian space. For particles obeying fractional statistics, and interacting via a repulsive hard core potential, we provide a rigorous framework for analysing the spectral problem with its multi-valued wave functions.


## 1. Introduction

Let $\mathscr{M}$ be a bounded domain in $\mathbb{R}^{2}$, with boundary $\partial \mathscr{M}$ which we assume to be smooth. The standard choice for the configuration space for a system of $n$ indistinguishable particles constrained to the surface $\mathscr{M}$, and satisfying fractional statistics is the manifold

Here $\mathscr{M}^{n}$ denotes the $n$-fold cartesian product of $\mathscr{M}$ with itself, $\delta_{n}$ denotes the subset of points where two or more particle coordinates coincide (the diagonal) and $S_{n}$ denotes the group of permutations on $n$ symbols. The fundamental group of $Q_{n}$, $\pi_{1}\left(Q_{n}\right)$ is the $n$-braid group $B_{n}(\mathscr{M})$ of $\mathscr{M}$.

Now let $\chi: \pi_{1}\left(Q_{n}\right) \rightarrow U(1)$ be a finite, one dimensional, irreducible representation; clearly such a representation is a homomorphism onto the cyclic group of the roots of unity, $U_{m}=\{\exp (2 \pi i k / m), k=0,1, \ldots(m-1)\}$, for some $m \geqq 1$. Let $\widetilde{Q}_{n}^{[m]}$ be the $m$-fold covering space of $Q_{n}$ associated with the representation $\tilde{U}_{m}$, with $B_{n}(\mathscr{M})$ acting as deck transformations, and let $\pi: \tilde{Q}_{n}^{[m]} \rightarrow Q_{n}$, be the natural projection. It has been proposed, [10], that the space of admissible wave functions be a complex Hilbert space obtained from the class of smooth equivariant functions

[^0]Here we let $z=\left(z_{1}, \ldots, z_{n}\right)$ denote a generic point of $\mathbb{C}^{n}$, with $z^{*}=\left(\bar{z}_{1}, \ldots, \bar{z}_{n}\right)$ denoting its conjugate. A map in $C_{[m]}^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right)$ is obviously multivalued on $Q_{n}$ but single valued on $\widetilde{Q}_{n}^{[m]}$. This setting is an example of what has been dubbed "quantization on multiply connected spaces," a general exposition of which is given by Dowker [4]. The "statistics" of the system is embodied in the choice of a representation, wherein the phenomenon of phase changes of the wave function on interchanging particle positions is the $\chi$-equivariance (1.2). $m=1$ corresponds to bosons, particles obeying Bose-Einstein statistics, $m=2$ to fermions, particles obeying Fermi-Dirac statistics and $m \geqq 3$ corresponds to fractional statistics.

The phenomenon of fractional statistics has been explicitly demonstrated for the quasi-particles associated with the Fractional Quantum Hall Effect, [13, 21], and such systems are also conjectured to explain high temperature superconductivity, [2, 21].

A theory of particles obeying fractional statistics in two dimensions was first proposed by Leinaas and Myrheim [14]. The essence of the quantization procedure they adopt rests on the fact that the configuration space (1.1) has nontrivial topology due to the exclusion of the diagonal.

Prior to this, Laidlaw and DeWitt [12], following ideas of Schulman [17] had developed a conceptually similar quantization procedure, however applied to three dimensional space. In this case, the topology of the configuration space leads to the possibility of only two types of statistics, bosons or fermions. They did not consider however the two-dimensional case, which is the only case where fractional statistics is possible, as seen now via standard arguments, [10, 21, 22]. Fractional statistics was also discovered independently by Glodin, Menikoff and Sharp [6, 7], and by Wilczek, who actually coined the term "anyons" [19, 20]. In all the above fundamental works, obtaining fractional statistics rests on the $a$-priori exclusion of $\delta_{n}$ from the configuration space, (1.1). Although initially the exclusion of $\delta_{n}$ by Leinass and Myrheim seemed somewhat arbitrary, Goldin, Menikoff and Sharp in their framework, [6,7], put forward a theoretical justification. In [8, 9], they also introduced the use of the braid group in the theory, a device also extensively analysed by Wu [22].

We are interested in analysing the spectral problem resulting from the Schrödinger theory for these particle systems. We assume that $\mathscr{M}$ is equipped with, for simplicity, the Euclidian metric. The Laplacian, $\Delta$, acting on $C^{\infty}\left(\mathbb{C}^{n}\right)$ is given by

where $\partial_{k} f=\frac{\partial f}{\partial z_{k}}$, and $\bar{\partial}_{k} f=\frac{\partial f}{\partial \bar{z}_{k}}$. $\Delta$ lifts naturally to give a Laplacian $\tilde{\Delta}: C^{\infty}\left(\widetilde{Q_{n}^{[m]}}\right) \rightarrow$ $C^{\infty}\left(\tilde{Q}_{n}^{[m]}\right)$. Also let $V \in C^{\infty}\left(Q_{n}\right)$ be a given real valued function, which will play the role of an invariant potential. $V$ also lifts to give $\tilde{V}: \widetilde{Q}_{n}^{[m]} \rightarrow \mathbb{R}$. The Schrödinger theory for the quantization procedure, with the classical Hamiltonian leads to procuring wave functions $\widetilde{\psi}: \widetilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}$, and eigenvalues $\lambda \in \mathbb{C}$ which satisfy

where $\tilde{\Gamma}_{n}$ is the lift of the boundary $\Gamma_{n}=\partial \mathscr{M}^{n}$, and the fractional statistics,

$$
\begin{equation*}
\tilde{\psi}\left(\gamma z, \gamma z^{*}\right)=\chi(\gamma) \tilde{\psi}\left(z, z^{*}\right), \quad \text { for all } \gamma \in B_{n}(\mathscr{M}) . \tag{1.6}

As emphasized above, the non-trivial topology of $Q_{n}$ allows for fractional statistics. However, excluding $\delta_{n}$ also makes $Q_{n}$ noncompact and non-complete, a fact which obviously renders the spectral problem for the twisted Laplacian on $Q_{n}(1.4)-(1.6)$, quite intricate. The problem is further complicated by the fact that the action of the braid group has fixed points on $\tilde{\delta}_{n}$. We approach these problems by analysing an equivalent spectral problem on $Q_{n}$ itself. To this end let $\mathscr{D}_{n}=\mathscr{M}^{n}-\delta_{n}$. Let $\varphi: \mathscr{D}_{n} \rightarrow \mathbb{C}$, be the function, given by $\varphi(z)=\Pi_{i<j}\left(z_{i}-z_{j}\right)$, and let $\varphi_{m}: \widetilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}$ denote any one of the $m$ roots of the discriminant according to $\varphi_{m}(z)=[\varphi(z)]^{2 / m}$.

Since $\varphi^{2}$ never vanishes on $\widetilde{Q}_{n}^{[m]}$, given any $\tilde{\psi} \in C_{[m]}^{\infty}\left(\widetilde{Q_{n}^{[m]}}\right)$ we may consider the $\operatorname{map} \tilde{f}: \widetilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}$ given by $\tilde{f}\left(z, z^{*}\right)=\tilde{\psi}\left(z, z^{*}\right) / \varphi_{m}(z)$. Clearly $\tilde{f}$ is an invariant function, $\tilde{f}\left(\sigma z, \sigma z^{*}\right)=\tilde{f}\left(z, z^{*}\right)$ for all $\sigma \in B_{n}(\mathscr{M})$, for $z \in \tilde{Q}_{n}^{[m]}$, and thus corresponds to an invariant function $F: Q_{n} \rightarrow \mathbb{C}, \tilde{f}\left(z, z^{*}\right)=(F \circ \pi)\left(z, z^{*}\right)$. Thus we see that (1.2) may be written

C_{[m]}^{\infty}\left(\tilde{Q}_{n}^{[m]}\right)=\left\{\tilde{\psi}: \tilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}: \tilde{\psi}=\left(\varphi_{m}\right)(F \circ \pi), \text { for some } F \in C^{\infty}\left(Q_{n}\right)\right\} \tag{1.7}
\end{equation*}

Now setting $\alpha=2 / m$, a simple computation using (1.3) shows that $\tilde{\psi}=\left(\varphi_{m}\right)(F \circ \pi): \widetilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}$ is an eigenfunction with eigenvalue $\lambda \in \mathbb{C}$, satisfying (1.4)-(1.6), if and only if $F: \mathscr{D}_{n} \rightarrow \mathbb{C}$ satisfies the eigen problem:

F\left(\sigma z, \sigma z^{*}\right)=F\left(z, z^{*}\right), \quad \text { for all } \sigma \in S_{n} . \tag{1.10}

We are able to provide a set of sufficient conditions on the potential $V$ which guarantee that (1.4)-(1.6) possesses a pure point spectrum of real positive eigenvalues, and a corresponding set of eigenfunctions contained in the space (1.2), and which form an orthonormal and complete set in an appropriate Hilbert space; Theorem 3.11.

Our strategy is to first establish that the equivalent problem (1.8)-(1.10) has a pure point spectrum of complex eigenvalues; Theorem 2.46. We obtain this result by working on weighted Sobolev spaces on $\mathscr{D}_{n}$, to handle simultaneously the fact that $\mathscr{D}_{n}$ is noncompact and non-complete, and the fact that coefficients of the elliptic operator occurring in (1.8) have singularities on $\delta_{n}$, becoming unbounded on neighborhoods of $\tilde{\delta}_{n}$. This latter fact is a consequence, in analytical terms, of $B_{n}(\mathscr{M})$ having fixed points on $\widetilde{\delta}_{n}$. In Sect. 3 we then proceed to lift the results of Theorem 2.46 to the cover $\widetilde{Q}_{n}^{[m]}$, to obtain Theorem 3.11, the main result of the paper.

Indeed, what Theorem 3.11 demonstrates is that the lift of the Laplacian from the configuration space to the $m$-fold covering space $\widetilde{Q}_{n}^{[m]}$ is a self-adjoint operator acting on an appropriate Hilbert space of functions, equivariant with respect to the action of the braid group, and which decay sufficiently rapidly to zero or neighborhoods of the lift of the diagonal. Our program obtains the results indirectly by
carrying out the analysis on $\mathscr{D}_{n}$, and then lifting results to the cover. An explicit estimate for the rate of decay of the eigenfunctions is given in (3.18).

We also derive a lower bound, (3.22), for the first eigenvalue, the energy of the ground state for the system of anyons in terms of four basic parameters: $\alpha, n$, the diameter of the surface, and the strength of the virtual force derived from the exclusion principle of the hard core potential.

One could naturally propose analysing the spectral problem for systems of anyons on more general surfaces and with more sophisticated statistics, i.e. higher dimensional and non-abelian representations of the braid group. It is known [10] that if the surface is compact with genus $g \geqq 1$, the particles must be either bosons or fermions; thus on compact surfaces, anyons can only occur if the surface is simply connected. We are thus led to considering simply connected compact surfaces, or non-compact surfaces. Our work considers the simplest case in the latter category, as a point of departure.

We note that it has been claimed by Loss and Fu [15], that without employing a repulsive hard core potential, inconsistencies arise in the theory of anyons, concerning virial coefficients. We obtain here sufficient conditions on such a potential to obtain a pure point spectrum for the classical Hamiltonian.

## 2. A-Priori Estimates on Weighted Sobolev Spaces

In this section we establish certain a-priori inequalities on weighted Sobolev spaces which allow us to establish the existence of a Green's operator for the elliptic operator occurring in (1.8),

We show that the Green's operator on certain spaces is compact, which yields the result that $\mathscr{L}$ has a pure point spectrum, Theorem 2.46.

In general, for a subdomain $N \subset \mathscr{M}^{n}$ we shall let $C^{\infty}(N)$ denote the complex linear space of complex valued functions on $N$, which together with their partial derivatives of all orders, are continuous on $N . C_{0}^{\infty}(N)$ will denote the subspace of $C^{\infty}(N)$ whose members have compact support in $N$.

We define the functions, $\zeta_{k}: \mathscr{D}_{n} \rightarrow \mathbb{R}$,

where $p$ satisfies $2 p \geqq 1$, and is to be chosen specifically below. Let $\zeta: \mathscr{D}_{n} \rightarrow \mathbb{R}$, be

We set for any real $\beta$,

It is obvious that

We also define $q: \mathscr{D}_{n} \rightarrow \mathbb{R}$, by

Obviously $\left|z_{k}-z_{j}\right| \leqq l$, where $l$ is the diameter of $\mathscr{M}$, from which it follows that

and via Schwarz's inequality,

for all $\left(\xi_{1}, \ldots, \xi_{n}\right) \in \mathbb{C}^{n}$, and all $z \in \mathscr{D}_{n}$.
We make a further assumption on the potential $V \in \mathbb{C}^{\infty}\left(\mathscr{D}_{n}\right)$, in addition to its invariance with respect to the action of $S_{n}$ on $\mathscr{D}_{n}$. For constants $\tau>0$ and $\hat{\tau}<\infty$,

It will also be required that in relation to the other constants $\alpha, p$ and $l, \tau$ is such that

The assumption (2.9) may be viewed as requiring the particles to exist under the influence of a hard-core potential, which dictates a type of exclusion principle with the parameter $\tau$ prescribing the strength of the virtual force resulting from the exclusion principle.

On $C_{0}^{\infty}\left(\mathscr{D}_{n}\right)$ we may define for each $\beta>0$, the norm

where $d v_{n}$ denotes the volume element on $\mathscr{D}_{n} . H_{\beta}\left(\mathscr{D}_{n}\right)$ is defined to be the completion of $C_{0}^{\infty}\left(\mathscr{D}_{n}\right)$ with respect to the norm $\|\cdot\|_{H_{\beta}} . H_{\beta}\left(\mathscr{D}_{n}\right)$ is a Hilbert space with respect to the obvious inner product yielding (2.11).

Similarly on $C^{\infty}\left(\mathscr{D}_{n}\right)$ we may define, for $\beta>0$ the norm

$K_{\beta}\left(\mathscr{D}_{n}\right)$ is defined to be the completion of $C^{\infty}\left(\mathscr{D}_{n}\right)$ with respect to the norm $\|\cdot\|_{K_{\beta}}$. Also $K_{\beta}\left(\mathscr{D}_{n}\right)$ is a Hilbert space with the obvious inner product giving (2.12).

We write (2.1) more explicitly as

and define the sesquilinear form $B: C_{0}^{\infty}\left(\mathscr{D}_{n}\right) \times C^{\infty}\left(\mathscr{D}_{n}\right) \rightarrow \mathbb{C}$, given by

j \neq k}}^{n}\left(z_{k}-z_{j}\right)^{-1} \bar{\partial}_{k} f\right] \bar{g}\right. \\
& +V f \bar{g}\} d v_{n} \quad \text { for } f \in C_{0}^{\infty}\left(\mathscr{D}_{n}\right) \text { and } g \in C^{\infty}\left(\mathscr{D}_{n}\right) \tag{2.14}
\end{align*}

Simply integrating by parts gives from (2.13) and (2.14),

Henceforth we shall for brevity write $H_{\beta}\left(\mathscr{D}_{n}\right)$ simply as $H_{\beta}$, and $K_{\beta}\left(\mathscr{D}_{n}\right)$ as $K_{\beta}$. We now focus on some basic a-priori inequalities on the form $B(\cdot, \cdot)$; namely that it is continuous on $H_{\beta} \times K_{\beta}$ for all $\beta$, and coercive for the parameter $\beta$ sufficiently small, but positive.

Proposition 2.16. Let $\beta^{*}$ be the constant given by

(i) Under the conditions (2.9), there exists a constant $C_{1}$, depending only on $\alpha, \hat{\tau}$, and $l$, such that for all $\beta>0$,

(ii) Under conditions (2.9) and (2.10), there exists a constant $C^{*}>\frac{1}{3}$ depending only on $\alpha, \tau$ and $l$, such that for all $0<\beta \leqq \beta^{*}$, and for all $f \in H_{\beta}$,

(iii) Under conditions (2.9) and (2.10), there exists a constant $C^{* *}>\frac{2}{9}$, depending only on $\alpha, l$ and $\tau$, such that for all $0<\beta \leqq \beta^{*}$, and for all $g \in K_{\beta}$,

Proofs of the inequalities (2.18)-(2.20) are given in Appendix $A$ and $B$.
To define the Green's operator for $\mathscr{L}$, we make use of a theorem of Necas [16] which is a generalization of the Lax-Milgram lemma, [5].
Lemma 2.21. ([16], p. 318) Let $H$ and $K$ be complex Hilbert spaces with norms $\|\cdot\|_{H}$ and $\|\cdot\|_{K}$ respectively, and let $B: H \times K \rightarrow \mathbb{C}$ be a sesquilinear form which satisfies, for constants $C_{1}<\infty, C_{2}>0$ and $C_{3}>0$,

Then for each linear functional $U \in(K)^{*}$, where $(K)^{*}$ is the dual of $K$, there exists a unique $f_{U} \in H$ such that

Let $0<\beta \leqq \beta^{*}$ be fixed. We define $L_{\beta}$ to be the completion of $C_{0}^{\infty}\left(\mathscr{D}_{n}\right)$ with respect to the norm

$L_{\beta}$ is a Hilbert space with respect to the obvious inner product yielding (2.23), and because of (2.11) we have $H_{\beta} \subset L_{\beta}$.

For $u \in L_{\beta}$, we define the linear functional $U: K_{\beta} \rightarrow \mathbb{C}$ by $U(g)=\int_{\mathscr{D}_{n}} g \bar{u} d v_{n}$. From (2.7) and (2.12),

& \leqq\left[n(n-1)^{2}\right]^{-\frac{1}{2}} l^{2 p+1}\|g\|_{K_{\beta}}\|u\|_{L_{\beta}} . \tag{2.24}

Hence with $\left(K_{\beta}\right)^{*}$ denoting the dual of $K_{\beta}$, from (2.24),

$G_{\beta}: L_{\beta} \rightarrow H_{\beta}$ obtained above is our Green's operator for (2.1). We now establish some regularity results concerning the elliptic equation formulated weakly by (2.27).

Let $W^{k, 2}\left(\mathscr{M}^{n}\right)$ denote the Sobolev space, [1], of complex valued functions on $\mathscr{M}^{n}$. For $1 \leqq k<\infty, W^{k, 2}\left(\mathscr{M}^{n}\right)$ is the closure of $C^{\infty}\left(\mathscr{M}^{n}\right)$ with respect to the norm

$\partial^{v, \mu} f=\partial_{1}^{\nu_{1}} \bar{\partial}_{1}^{\mu_{1}} \ldots \partial_{n}^{v_{n}} \bar{\partial}_{n}^{\mu_{n}} f$, and $v=\left(v_{1}, \ldots, v_{n}\right), \mu=\left(\mu_{1}, \ldots, \mu_{n}\right)$ are multi-indices, with $|\nu|_{0}=v_{1}+\cdots+v_{n},|\mu|=\mu_{1}+\cdots+\mu_{n}$. Clearly $W^{0,2}\left(\mathscr{M}^{n}\right)=L^{2}\left(\mathscr{M}^{n}\right)$.

We let $W^{1,2}\left(\mathscr{M}^{n}\right)$ denote the closure of $C_{0}^{\infty}\left(\mathscr{M}^{n}\right)$ with respect to the norm, $\|\cdot\|_{W^{1,2}\left(\mathscr{M}^{n}\right)}$; it is a standard fact [1], that if $f \in \stackrel{\circ}{W}^{1,2}\left(\mathscr{M}^{n}\right)$, then $f=0$ a.e. on $\partial \mathscr{M}^{n}$.

Since the subset $\delta_{n}$ of $\mathscr{M}^{n}$ is of real codimension 2, it follows that

We define for $\beta>0, W_{\beta}^{k, 2}\left(\mathscr{M}^{n}\right)$ to be the proper linear subspace of $L_{\beta}$,

Now let $u \in L_{\beta}$ and set $h=G_{\beta} u$. Since obviously $C^{\infty}\left(\mathscr{M}^{n}\right) \subset K_{\beta}$, by (2.27), using (2.18) and (2.29) it follows that $h \in H_{\beta} \subset \dot{W}^{1,2}\left(\mathscr{M}^{n}\right)$ satisfies the weak elliptic equation:

for all $g \in C^{\infty}\left(\mathscr{M}^{n}\right)$. Integration by parts in (2.31) shows that $h \in \mathscr{W}^{1,2}\left(\mathscr{M}^{n}\right)$ satisfies in a distributional sense

Proposition 2.36. Let $0<\theta<1$ be any real number. Suppose that for some $r \geqq 0$ and $\beta>0, h \in W_{\beta}^{r+1,2}\left(\mathscr{M}^{n}\right) \cap \dot{W}^{1,2}\left(\mathscr{M}^{n}\right)$ satisfies (2.32), (2.33), with $u \in W_{\beta}^{r, 2}\left(\mathscr{M}^{n}\right)$. Then

Furthermore, there exists a constant $C_{\beta, n, r}$ such that

A proof of Proposition 2.36 is given in Appendix D. We also have:
Lemma 2.40. The embedding $H_{\beta} \subseteq L_{\beta}$ is compact, for each $\beta>0$.

## A proof of Lemma 2.40 is given in Appendix $C$.

From Proposition 2.36, and Lemma 2.40, it follows that the operator $G_{\beta}: L_{\beta} \rightarrow L_{\beta}$ defined by (2.27) is compact. It follows from standard spectral theory for compact non-selfadjoint operators, [11], that $G_{\beta}$ has a pure point spectrum consisting of complex eigenvalues. We list the nonzero eigenvalues of $G_{\beta}$ assumed ordered by decreasing magnitude, taking account of algebraic multiplicities: $\left\{\mu_{1}, \mu_{2}, \ldots\right\} \subset \mathbb{C}$; i.e., $\left|\mu_{1}\right| \geqq\left|\mu_{2}\right| \geqq \cdots \rightarrow 0$ and

Using (2.41) in (2.31), setting $\lambda_{j}=\mu_{j}^{-1}$, we obtain via (2.32), (2.33) for the system of eigenfunctions $\left\{u_{j}: j=1,2, \ldots\right\} \subset H_{\beta}$,

Iterating the regularity results of Proposition 2.36 in (2.42) shows that the eigenfunctions $u_{j}$ are smooth; one obtains easily from (2.39), $u_{j} \in C^{\infty}\left(\mathscr{M}^{n}\right) \cap H_{\beta^{*}}$.

For clarity we write the operator $\mathscr{L}$ of (2.1) as $\mathscr{L}=\mathscr{L}\left(z, z^{*}, \frac{\partial}{\partial z}, \frac{\partial}{\partial z^{*}}\right)$. It is clear from (2.1) that $\mathscr{L}$ is invariant under the action of $S_{n}$, i.e.,

Thus, via (2.44), if we define the symmetrized eigenfunctions

Theorem 2.46. The operator $\mathscr{L}: W^{2,2}\left(\mathscr{M}^{n}\right) \cap H_{\beta^{*}} \rightarrow L_{\beta^{*}},(2.1)$, possesses a pure point spectrum of (possibly complex) eigenvalues $\lambda_{1}, \lambda_{2}, \ldots$, listed in increasing order of magnitude $\left|\lambda_{1}\right| \leqq\left|\lambda_{2}\right| \leqq \cdots \rightarrow \infty$, according to algebraic multiplicities, and a set of corresponding eigenfunctions $\left\{F_{j}: j=1,2, \ldots\right\}$ defined by (2.45), (2.42) which satisfy:

\end{gather*}

We note that (2.47)-(2.49) correspond to (1.8)-(1.10) respectively. We now proceed to lift the result of Theorem 2.46 to the covering space $\widetilde{Q}_{n}^{[m]}$, to resolve the spectral problem (1.4)-(1.6).

## 3. Analysis on the Covering Space

Via (1.7) $\lambda \in \mathbb{C}$ is an eigenvalue of $\mathscr{L}$ with corresponding eigenfunction $F \in C^{\infty}\left(Q_{n}\right)$ satisfying (1.8)-(1.10), if and only if $\lambda$ is an eigenvalue of the Schrödinger operator $-\tilde{\Delta}+\tilde{V}$ on $\tilde{Q}_{n}^{[m]}$, with corresponding eigenfunction $\tilde{\psi}=\left(\varphi^{\alpha}\right)(F \circ \pi)$, satisfying (1.4)-(1.6).

Thus if we define the functions $\tilde{\psi}_{j}: \tilde{Q}_{n}^{[m]} \rightarrow \mathbb{C}$ by

where $F_{j}$ satisfies (2.47)-(2.49) it follows that $\tilde{\psi}_{j}$ is an eigenfunction of the Schrödinger operator on the cover $\widetilde{Q}_{n}^{[m]}$, satisfying (1.4)-(1.6) with $\lambda=\lambda_{j}$.

Now let $\stackrel{\circ}{C}_{[m]}^{\infty}\left(\tilde{Q}_{n}^{[m]}\right)$ be the subspace of $C_{[m]}^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right)$ (defined by (1.2) and (1.7)) consisting of functions compactly supported in $\widetilde{Q}_{n}^{[m]}$. On $\dot{C}_{[m]}^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right)$ we may define the inner product:

\end{equation*}

where $g^{*}$ denotes the complex conjugate of $g$, and $d \tilde{v}_{n}$ is the volume element on $\widetilde{Q}_{n}^{[m]}$.

We let $\stackrel{\circ}{W}_{V}^{1,2}\left(\tilde{Q}_{n}^{[m]}\right)$ be the completion of $\stackrel{\circ}{C}_{[m]}^{\infty}\left(\tilde{Q}_{n}^{[m]}\right)$ with respect to the norm resulting from (3.2); $W_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right)$ is thus a Hilbert space with inner product (3.2).

Let $\mathscr{F}\left(\lambda_{j}\right)$ denote the eigenspace of $\mathscr{L}$ corresponding to $\lambda_{j}$ in (2.47)-(2.49). Clearly for the Schrödinger operator the eigenspace of $\lambda_{j}, E\left(\lambda_{j}\right)$, is given by $E\left(\lambda_{j}\right)=\left\{\left(\varphi^{\alpha}\right)(F \circ \pi): F \in \mathscr{F}\left(\lambda_{j}\right)\right\}$. Since $\mathscr{F}\left(\lambda_{j}\right) \subset H_{\beta^{*}}$ it follows that $E\left(\lambda_{j}\right)$ $\subset \dot{W}_{V}^{1,2}\left(\tilde{Q}_{n}^{[m]}\right), j=1,2, \ldots$. Now using Stokes' theorem, taking into account the orientation of each sheet of the cover $\widetilde{Q}_{n}^{[m]}$, we obtain for $\tilde{g} \in \dot{C}_{[m]}^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right)$,

\end{equation*}

where $\tilde{g}^{*}$ is the conjugate of $\tilde{g}$.
Thus from (3.3), (1.4) and (1.5), we obtain

\end{equation*}

Now let $\left\{\tilde{g}_{s, r}: r=1,2, \ldots\right\} \subset \dot{C}_{[m]}^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right)$ be such that $\lim _{r \rightarrow \infty}\left\|\tilde{g}_{s, r}-\tilde{\psi}_{s}\right\|_{\dot{W}_{V}^{1,2}}^{\infty}\left(\tilde{Q}_{n}^{[m]}\right)$ $=0$. If we replace $\tilde{g}$ by $\tilde{g}_{s, r}$ in (3.4), then by completion by continuity we obtain

Hence from (3.5) and (3.6),

Choosing $j=s$ in (3.7) and (3.5) yields the fact that $\lambda_{j}$ is real and positive for all $j \geqq 1$ : (3.7) in turn yields that the eigenspaces corresponding to distinct eigenvalues are mutually orthogonal in $L^{2}\left(\tilde{Q}_{n}^{[m]}\right)$ and by (3.6) hence mutually orthogonal in $\stackrel{W}{V}_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right)$.

We now assume that the eigenfunctions have been normalized, so that

Now a standard argument shows that the system of eigenspaces $\left\{E\left(\lambda_{j}\right)\right.$ : $j=1,2, \ldots\}$ is complete in $\stackrel{\circ}{W}_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right)$ : i.e.,

Indeed if $\stackrel{\circ}{V}_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right) \neq \overline{\bigoplus_{j \geq 1} E\left(\lambda_{j}\right)}$, then there exists a $u \in \stackrel{\circ}{W}_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right), u \neq 0$, such that $u$ is orthogonal to $E\left(\lambda_{j}\right)$ for all $j$ with respect to the inner product on $\mathscr{W}_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right)$, (3.2). Without loss of generality we may choose $((u, u))_{V}=1$. Using (3.2), standard variational arguments give the characterization:

We summarize the above results in the following.

There exists a sequence of real positive eigenvalues $0<\lambda_{1} \leqq \lambda_{2} \leqq \ldots \rightarrow \infty$, with no finite accumulation point, listed according to multiplicities, and corresponding eigenfunctions $\quad\left\{\tilde{\psi}_{j}: \quad j=1,2, \ldots\right\}$ $\subset C^{\infty}\left(\widetilde{Q}_{n}^{[m]}\right) \cap \stackrel{ஸ}{V}_{V}^{1,2}\left(\tilde{Q}_{n}^{[m]}\right)$ satisfying the Schrödinger equation.

\begin{gather*}
-\tilde{\Delta} \tilde{\psi}_{j}+\tilde{V} \tilde{\psi}_{j}=\lambda_{j} \tilde{\psi}_{j} \text { on } \tilde{Q}_{n}^{[m]},  \tag{3.12}\\
\tilde{\psi}_{j}=0 \quad \text { on } \tilde{\Gamma}_{n}  \tag{3.13}\\
\tilde{\psi}_{j}\left(\gamma z, \gamma z^{*}\right)=\chi(\gamma) \tilde{\psi}_{j}\left(z, z^{*}\right), \quad \text { for all } \gamma \in B_{n}(\mathscr{M}), z \in \tilde{Q}_{n}^{[m]} . \tag{3.14}
\end{gather*}

Furthermore the system of eigenfunctions forms a complete orthonormal set in $W_{V}^{1,2}\left(\widetilde{Q}_{n}^{[m]}\right)$. The eigenfunctions decay exponentially to zero on neighborhoods of the lift of the diagonal, $\tilde{\delta}_{n}$, on which set the eigenfunctions vanish.

Proof. Existence of the system of eigenfunctions with the stated properties follows from the arguments above. We now simply make explicit the rate of decay of the eigenfunctions to zero on $\tilde{\delta}_{n}$. Equation (3.12) gives (2.47) via (3.1). Applying the
estimate (2.39) to (2.47) with $u=\lambda_{j} F_{j}$ and $h=F_{j}$ we obtain for any $0<\beta<\gamma \leqq \beta^{*}$, and $k \geqq 0$,

where we have used (2.11), (2.30) and (2.9).
Now for $\varepsilon>0$, let $\mathscr{N}_{\varepsilon}$ be the neighborhood of the diagonal $\delta_{n}$ in $\mathscr{M}^{n}$ given by $\mathscr{N}_{\varepsilon}=\left\{z \in \mathscr{M}^{n}:\left|z_{i}-z_{j}\right|<\varepsilon, 1 \leqq i, j \leqq n\right\}$. From (2.2)-(2.4) it follows that

Now let $0<\beta<\beta^{*}$, and set $\bar{\beta}=\frac{1}{2}\left(\beta+\beta^{*}\right)$. Using the Sobolev embedding theorem [1], it follows from (3.16), with $r=n+1$, that

Combining (3.17) with this last inequality gives, for $0<\beta<\beta^{*}$,

Finally, we give a rough lower bound for the energy of the ground state, as measured by the first eigenvalue $\lambda_{1}$.

Now $\lambda_{1}$ satisfies (3.12)-(3.14), and hence equivalently (2.47)-(2.49). Using (2.17), (2.7), (2.11) and (2.15), we obtain for any $\beta>0$, and $g \in C^{\infty}\left(\mathscr{D}_{n}\right)$,

& \leqq \lambda_{1}\left[n(n-1)^{2}\right]^{-1} l^{2(2 p+1)}\left\|F_{1}\right\|_{H_{\beta}}\|g\|_{K_{\beta}} \tag{3.19}
\end{align*}
$$

Thus from (2.17) and (2.19) in (3.19), for all $\beta \leqq \frac{1}{4 p}$,

Now from (B.14), (B.13) and (B.12), we have $C^{*}=\frac{4}{9} \min \left\{1, \frac{3}{4}+\alpha^{2} l^{4 p}\right\}$. Hence

Introducing the parameter $d=n l^{-2}$ which measures the density of the particles on the surface $\mathscr{M}$, we may write (3.21) in the form

Choosing $p=1$, (3.22) implies that if the density is kept constant, then the ground state energy never falls below the constant $\frac{1}{12} d^{3}$. Inequality (3.22) is not necessarily the best lower bound.

\leqq l^{2 p}\left(\int_{\mathscr{\mathscr { D }}_{n}} w^{\beta} \sum_{k=1}^{n}\left|\bar{\partial}_{k} f\right|^{2}\right)^{\frac{1}{2}}\left(\int_{\mathscr{D}_{n}} w^{-\beta} q|g|^{2} d v_{n}\right)^{\frac{1}{2}} \leqq l^{2 p}\|f\|_{H_{\beta}}\|g\|_{K_{\beta}} .

From (C.1), (C.2), (2.7) and (2.11), and (B.5)

$$
\begin{align*}
\left\|u_{j}\right\|_{W^{1,2}\left(\mathscr{D}_{n}\right)}^{2}= & \int_{\mathscr{O}_{n}}\left\{w ^ { \beta } \sum _ { k = 1 } ^ { n } \left[\left|\partial_{k} f_{j}+\frac{\beta}{2} f_{j} \partial_{k} \zeta\right|^{2}+\right.\right. \\
& \left.\left.+\left|\bar{\partial}_{k} f_{j}+\frac{\beta}{2} f_{j} \bar{\partial}_{k} \zeta\right|^{2}\right]+w^{\beta}\left|f_{j}\right|^{2}\right\} d v_{n} \\
\leqq & \int_{\mathscr{D}_{n}}\left\{2 w^{\beta} \sum_{k=1}^{n}\left[\left|\partial_{k} f_{j}\right|^{2}+\left|\bar{\partial}_{k} f_{j}\right|^{2}\right]\right. \\
& \left.+2 w^{\beta}\left[\sum_{k=1}^{n}\left|\partial_{k} \zeta\right|^{2}+\left|\bar{\partial}_{k} \zeta\right|^{2}+\frac{1}{2}\right]\left|f_{j}\right|^{2}\right\} d v_{n} \\
\leqq & 2\left(1+2 p^{2}+C_{n, l, p}\right)\left\|f_{j}\right\|_{H_{\beta}}^{2}, \text { where } C_{n, l, p}=\left[2 n(n-1)^{2}\right]^{-1} l^{2(2 p+1)} . \tag{C.3}
\end{align*}
$$

Thus $\left\{u_{j}: j=1,2, \ldots\right\}$ is a bounded sequence in $W^{1,2}\left(\mathscr{D}_{n}\right)$. By the Rellich lemma, [1], this sequence possesses a subsequence converging in $L^{2}\left(\mathscr{D}_{n}\right)$. Hence there exists a $u \in L^{2}\left(\mathscr{D}_{n}\right)$ such that $\lim _{k \rightarrow \infty}\left\|u_{j_{k}}-u\right\|_{L_{\left(\mathscr{O}_{n}\right)}^{2}}=0$, where $\left\{u_{j_{k}}: k=1,2 \ldots\right\}$ denotes the subsequence. Define $f=w^{-\frac{\beta}{2}} u$ and $f_{j_{k}}=w^{-\frac{\beta}{2}} u_{j_{k}}$. Then by (2.23)

$$
\begin{align*}
&\left\|f_{j_{k}}-f\right\|_{L_{\beta}}= \int_{\mathscr{D}_{n}} w^{\beta}\left|f_{j_{k}}-f\right|^{2} d v_{n} \\
&=\int_{\mathscr{D}_{n}}\left|u_{j_{k}}-u\right|^{2} d v_{n}=\left\|u_{j_{k}}-u\right\|_{L^{2}\left(\mathscr{D}_{n}\right)}, \text { and similarly, }  \tag{C.4}\\
&\|f\|_{L_{\beta}}=\|u\|_{L^{2}\left(\mathscr{O}_{n}\right)} \tag{C.5}
\end{align*}
$$

The result of the lemma now follows from (C.4) and (C.5), since $\lim _{k \rightarrow \infty}\left\|f_{j_{k}}-f\right\|_{L_{\beta}}=0$.

## Appendix D. Proof of Proposition 2.36

The result will be established by induction using the well known results on elliptic regularity as found in [5] for example. First we assume that

$$
\begin{equation*}
h \in W_{\beta}^{r+1,2}\left(\mathscr{M}^{n}\right) \cap \stackrel{\circ}{W}^{1,2}\left(\mathscr{M}^{n}\right) \tag{D.1}
\end{equation*}
$$

for some $r \geqq 0$ and some $\beta>0$. We set $\varepsilon=\theta \beta$, and let $2 \gamma+\varepsilon=\beta$, i.e.,

$$
\begin{equation*}
\gamma=\frac{\beta}{2}(1-\theta) . \tag{D.2}
\end{equation*}
$$

Our aim is thus to show that $h \in W_{2 \gamma}^{r+2,2}\left(\mathscr{M}^{n}\right)$. We accomplish this by first establishing the intermediate result that $w^{\nu} h \in W^{r+2,2}\left(\mathscr{M}^{n}\right)$.

To this end, we observe that from (1.3),

$$
\begin{equation*}
\Delta\left(w^{\nu} h\right)=w^{\nu} \Delta h+h \Delta\left(w^{\nu}\right)+4 \sum_{k=1}^{n}\left\{\bar{\partial}_{k}\left(w^{\nu}\right) \partial_{k} h+\bar{\partial}_{k} h \partial_{k}\left(w^{\nu}\right)\right\} . \tag{D.3}
\end{equation*}
$$

In a straightforward way we estimate the right-hand side of (D.3). Now from (2.3), (2.4), (B.3) and (B.4) of Appendix B,

$$
\begin{gather*}
\partial_{k} w^{\gamma}=-\gamma p w^{\gamma} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left(z_{k}-z_{j}\right)^{-(p+1)}\left(\bar{z}_{k}-\bar{z}_{j}\right)^{-p},  \tag{D.4}\\
\bar{\partial}_{k} w^{\nu}=-\gamma p w^{\gamma} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left(\bar{z}_{k}-\bar{z}_{j}\right)^{-(p+1)}\left(z_{k}-z_{j}\right)^{-p}, \text { and }  \tag{D.5}\\
\Delta\left(w^{\gamma}\right)=\gamma^{2} p^{2} w^{\gamma} \sum_{k=1}^{n}\left|\sum_{\substack{j=1 \\
j \neq k}}^{n}\left(z_{k}-z_{j}\right)^{-(p+1)}\left(\bar{z}_{k}-\bar{z}_{j}\right)^{-p}\right|^{2}-\gamma p w^{\gamma} \sum_{k=1}^{n} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-2(p+1)} . \tag{D.6}
\end{gather*}
$$

From (D.4), (D.5), (2.3), (2.4) and (2.5) it follows that for $2 p \geqq 1$ and any $\varepsilon>0$,

$$
\begin{align*}
& \sum_{k=1}^{n}\left[\left|\partial_{k} w^{\nu}\right|^{2}+\left|\bar{\partial}_{k} w^{\gamma}\right|^{2}\right] \leqq 2\left(\gamma p w^{\gamma}\right)^{2} \sum_{k=1}^{n}\left\{\sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-(2 p+1)}\right\}^{2} \\
& \quad \leqq 2\left(\gamma p w^{\nu}\right)^{2} \sum_{k=1}^{n}\left\{l^{2 p-1} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-4 p}\right\}^{2} \leqq 2\left(\gamma p w^{\nu} l^{2 p-1}\right)^{2} \sum_{k=1}^{n} \zeta_{k}^{2} \\
& \quad \leqq 8\left(\gamma p w^{\gamma} l^{2 p-1}\right)^{2} \zeta^{2} \leqq\left(4 \gamma p w^{\nu} l^{2 p-1}\right)^{2} \varepsilon^{-2} w^{\varepsilon}=\left(4 \gamma p l^{2 p-1} \varepsilon^{-1}\right)^{2} w^{2 \gamma+\varepsilon} \tag{D.7}
\end{align*}
$$

Similarly from (D.6) we have

$$
\begin{align*}
\left|\Delta w^{\nu}\right| & \leqq 2\left(4 \gamma p l^{2 p-1} \varepsilon^{-1}\right)^{2} w^{\gamma+\varepsilon / 2}+8 \gamma p l^{2(2 p-1)} w^{\nu \zeta \zeta^{3}} \\
& \leqq 32\left[\left(\gamma p l^{2 p-1} \varepsilon^{-1}\right)^{2}+12 \gamma p l^{2(2 p-1)} \varepsilon^{-3}\right] w^{\gamma+\varepsilon / 2} . \tag{D.8}
\end{align*}
$$

From (2.34), (D.3), (D.7) and (D.8), for any $\varepsilon>0$, and constants $C_{1}(\varepsilon), C_{2}(\varepsilon)$,
$\left|\Delta\left(w^{\nu} h\right)\right|^{2} \leqq 3 w^{2 \gamma}|\rho|^{2}+C_{1}(\varepsilon) w^{2 \gamma+\varepsilon}|h|^{2}+C_{2}(\varepsilon) w^{2 \gamma+\varepsilon}\left(\sum_{k=1}^{n}\left|\partial_{k} h\right|^{2}+\left|\bar{\partial}_{k} h\right|^{2}\right)$.

Also from (2.35), (2.2), (2.3) and (2.5),

$$
\begin{aligned}
|\rho|^{2} \leqq & 48 \alpha^{2}\left(\sum_{k=1}^{n}\left|\bar{\partial}_{k} h\right|^{2}\right)\left(\sum_{k=1}^{n}\left[\sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-1}\right]^{2}\right) \\
& +3 \hat{\tau}^{2}\left\{\sum_{\substack{k=1}}^{n} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-(2 p-1)}\right\}^{2}|h|^{2}+3|u|^{2}
\end{aligned}
$$

$$
\begin{align*}
& \leqq 96 \alpha^{2} l^{2 p-1} \zeta\left(\sum_{k=1}^{n}\left|\bar{\partial}_{k} h\right|^{2}\right)+3 \hat{\tau}^{2}\left(l^{2 p-1}\right)^{2}(2 \zeta)^{2}|h|^{2}+3|u|^{2} \\
& \leqq 192 \alpha^{2} l^{2 p-1} \varepsilon^{-1} w^{\varepsilon}\left(\sum_{k=1}^{n}\left|\bar{\partial}_{k} h\right|^{2}\right)+48 \hat{\tau}^{2} l^{2(2 p-1)} \varepsilon^{-2} w^{\varepsilon}|h|^{2}+3|u|^{2} \tag{D.10}
\end{align*}
$$

From (D.10), (D.9) together with the analagous estimates to (D.9), (D.10) for derivatives of $\Delta\left(w^{\nu} h\right)$, it follows that if $u \in W_{\beta}^{r, 2}$, then for $\varepsilon=\theta \beta$, and $\gamma$ such that $2 \gamma+\varepsilon=\beta$,

$$
\begin{gather*}
\Delta\left(w^{\nu} h\right) \in W^{r, 2}\left(\mathscr{M}^{n}\right), \quad \text { and }  \tag{D.11}\\
w^{\nu} h \in W^{1,2}\left(\mathscr{M}^{n}\right) . \tag{D.12}
\end{gather*}
$$

It follows from the standard theory of elliptic regularity, [5], from (D.11) and (D.12), that $w^{\nu} h \in W^{r+2,2}\left(\mathscr{M}^{n}\right) \cap \stackrel{\circ}{W}^{1,2}\left(\mathscr{M}^{n}\right)$, and

$$
\begin{equation*}
\left\|w^{\nu} h\right\|_{W^{r+2}\left(\mathcal{M}^{n}\right)} \leqq C_{\beta, l, n, r}\left\{\|h\|_{W_{\beta}^{r+1,2}\left(\mathcal{M}^{n}\right)}+\|u\|_{W^{r, 2}\left(\mathcal{M}^{n}\right)}\right\} \tag{D.13}
\end{equation*}
$$

for a constant $C_{\beta, l, n, r}$.
Now it is easily established by induction that from (2.2)-(2.5),

$$
\begin{equation*}
\left|\partial^{v} \bar{\partial}^{\mu} \zeta\left(z, z^{*}\right)\right| \leqq C_{\mu, v} \sum_{k=1}^{n} \sum_{\substack{j=1 \\ j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-(2 p+|v|+|\mu|)} \tag{D.14}
\end{equation*}
$$

for constants $C_{\mu \nu}$, and hence that

$$
\begin{align*}
\left|\partial^{v} \bar{\partial}^{\mu} w^{\gamma}\left(z, z^{*}\right)\right| & \leqq C_{\mu \nu}^{\prime} w^{\nu} \sum_{k=1}^{n} \sum_{\substack{j=1 \\
j \neq k}}^{n}\left|z_{k}-z_{j}\right|^{-(2 p+|v|+|\mu|)} \\
& \leqq C_{\mu, v, n} w^{\gamma+\frac{\varepsilon}{2}} \tag{D.15}
\end{align*}
$$

for constants $C_{\mu, v, n}$.
Now with the use of Leibnitz's rule together with (D.15), the assumptions (D.1), and (D.2) in (D.13), we obtain the bound (2.39) and hence the result (2.37), (2.38).
