## ON LEFT DEMOCRACY FUNCTION

#### Abstract

We continue the study undertaken in [1] of left democracy function


$$
h_{l}(N)=\inf _{\# \Lambda=N}\left\|\sum_{n \in \Lambda_{N}} x_{n}\right\|
$$

of an unconditional basis in a Banach space $X$. We provide an example of a basis with $h_{l}$ non-doubling. Then we show that for bases with non-doubling $h_{l}$ the greedy projection is not optimal. Together with results from [1] improved by C. Cabrelli, G. Garrigós, E. Hernandez and U. Molter we get that the basis is greedy if and only if the greedy projection is optimal.

Keywords: non-linear approximation, greedy algorithm, democratic basis.

## 1. Introduction

The aim of this note is to settle some problems left open in [1]. Suppose we have a Banach space $X$ with a normalised basis $\left(x_{n}\right)_{n=1}^{\infty}$. For $x=\sum_{n=1}^{\infty} a_{n} x_{n} \in X$ and $N=1,2, \ldots$ we define a non-linear operator

$$
\begin{equation*}
\mathcal{G}_{N}(x)=\sum_{n \in \Lambda_{N}} a_{n} x_{n} \tag{1}
\end{equation*}
$$

where $\Lambda_{N}$ is any $N$-element subset of indices such that $\min _{n \in \Lambda_{N}}\left|a_{n}\right| \geqslant$ $\max _{n \notin \Lambda_{N}}\left|a_{n}\right|$. Note that the set $\Lambda_{N}$ may not be uniquely defined; in such a case we are allowed to take arbitrary choice. This is a theoretical model of many practically important tresholding operators. Systematic study of such operators was undertaken in the last years of the XX century (see e.g. $[4,3,5]$ ) and is an active area of research. It became apparent already in [5] that quantities like $\left\|\sum_{n \in A} x_{n}\right\|$

are important for the properties of this operator. The basis is called democratic [3] if those quantities depend essentially only on the number of elements of $A$, more precisely if there exists a constant $C$ such that for all sets $A, B$ with $\# A=\# B$ we have

$$
\begin{equation*}
\left\|\sum_{n \in A} x_{n}\right\| \leqslant C\left\|\sum_{n \in B} x_{n}\right\| \tag{2}
\end{equation*}
$$

The main result of [3] asserts that a basis is unconditional and democratic if and only if it is greedy what means that $\mathcal{G}_{N}(x)$ is (up to a constant) a best $N$-term approximation of $x$ by elements $\left\{x_{n}\right\}_{n=1}^{\infty}$; more precisely there exists a constant $C$ such that for all $x \in X$ and $N=1,2, \ldots$ we have $\left\|x-\mathcal{G}_{N}(x)\right\|<C \sigma_{N}(x),\left(\sigma_{N}\right.$ is defined in (11)).

A more detailed study resulted in the definition [2] of the left democracy function

$$
\begin{equation*}
h_{l}(N)=\inf _{\# \Lambda=N}\left\|\sum_{n \in \Lambda} x_{n}\right\| \tag{3}
\end{equation*}
$$

and right democracy function

$$
\begin{equation*}
h_{r}(N)=\sup _{\# \Lambda=N}\left\|\sum_{n \in \Lambda} x_{n}\right\| . \tag{4}
\end{equation*}
$$

The detailed study of the role of those functions in approximation properties of the basis $\left(x_{n}\right)_{n=1}^{\infty}$ was recently undertaken in [1].

In the rest of this note we will always assume that $\left(x_{n}\right)_{n=1}^{\infty}$ is a lattice unconditional basis i.e.

$$
\begin{equation*}
\left\|\sum_{n=1}^{\infty} \lambda_{n} a_{n} x_{n}\right\| \leqslant\left\|\sum_{n=1}^{\infty} a_{n} x_{n}\right\| \tag{5}
\end{equation*}
$$

whenever $\left|\lambda_{n}\right| \leqslant 1$. Since every space with an unconditional basis can be renormed so that the basis will satisfy (5) we really consider unconditional bases here. We will use standard Banach space conventions and results, c.f. [6].

## 2. Space with nondoubling left democracy function

A positive function $\phi(n)$ defined for $n=1,2, \ldots$ is doubling if there exists a $C$ such that $\phi(2 n) \leqslant C \phi(n)$ for all $n$. Such functions appear in many places in analysis. It was observed in [1, Prop. 2.4] that $h_{r}(N)$ is doubling and that both $h_{l}$ and $h_{r}$ are increasing. The question if $h_{l}$ is always doubling was left open [1, Remark 2.5] and in some results an assumption that $h_{l}$ is doubling appears.

Now we are ready to state one of the main results of this note
Theorem 2.1. There exists a Banach space $X$ with the basis $\left(e_{j}\right)_{j=1}^{\infty}$ (satisfying (5)) such that the left democracy function $h_{l}$ of this basis is not doubling.

We will say that the basis $\left(x_{n}\right)_{n=1}$ is 1 -symmetric if for every permutation of indices $\pi$ and all sequences $\left(\epsilon_{n}\right)_{n=1}$ of numbers with absolute value one and all sequences $\left(a_{n}\right)_{n=1}$ of coefficients we have

$$
\begin{equation*}
\left\|\sum_{n=1} a_{n} x_{n}\right\|=\left\|\sum_{n=1} \epsilon_{n} a_{n} x_{\pi(n)}\right\| \tag{6}
\end{equation*}
$$

For natural numbers $n \leqslant N$ let $\mathcal{X}(n, N, 2)$ be a Banach space with 1 -symmetric basis $\left(e_{\mu}\right)_{\mu=1}^{N}$ such that

$$
\left\|\sum_{j \in \Gamma} e_{j}\right\|= \begin{cases}\sqrt{\# \Gamma} & \text { when } \# \Gamma \leqslant n \\ \sqrt{n} & \text { when } \# \Gamma>n\end{cases}
$$

One example of such a space can be defined as

$$
\left\|\sum_{j=1}^{N} x_{j} e_{j}\right\|:=\sup \left\{\sum_{j \in \Gamma} x_{j} v_{j}\right\}
$$

where the supremum is taken over all subsets $\Gamma \subset\{1, \ldots, N\}$ of cardinality $\leqslant n$ and all sequences $\left(v_{j}\right)_{j \in \Gamma}$ with $\sum_{j \in \Gamma}\left|v_{j}\right|^{2} \leqslant 1$. It is easy to see that it is a norm and the norm of a vector is the $\ell_{2}$ norm of its $n$ biggest (up to absolute value) coefficients. It also immediately follows from the definition that it is 1 -symmetric.

Given an increasing sequence of natural numbers $a_{j}$ for $j=1,2, \ldots$ with $a_{1} \geqslant 4$ and $\lim _{j \rightarrow \infty} a_{j}=\infty$ we define $n_{k}=\prod_{j=1}^{k} a_{j}$. This implies $n_{k+1} / n_{k} \geqslant 4$.

Now let us define the space

$$
\mathcal{X}=:\left(\sum_{k=1}^{\infty} \mathcal{X}\left(n_{k}, n_{k+1}, 2\right)\right)_{2}
$$

This space has a natural basis $\left(e_{\mu}\right)_{\mu \in Y}$ where $Y=\bigcup_{k=1}^{\infty} Y_{k}$ where $\# Y_{k}=n_{k+1}$ and $\operatorname{span}\left(e_{\mu}\right)_{\mu \in Y_{k}}=\mathcal{X}\left(n_{k}, n_{k+1}, 2\right)$.
Lemma 2.2. For the space $\mathcal{X}$ defined above the function $h_{l}(n)$ is not doubling.
Proof. We will show that $\sup _{n} \frac{h_{l}(2 n)}{h_{l}(n)}=\infty$. Let us take $\Gamma$ with $\# \Gamma=n_{k+1}$. If $\Gamma=Y_{k}$ we get $\left\|\sum_{j \in \Gamma} e_{j}\right\|=\sqrt{n_{k}}$ so $h_{l}\left(n_{k+1}\right) \leqslant \sqrt{n_{k}}$.

Now let us take $\Gamma$ with $\# \Gamma=2 n_{k+1}$. We have

$$
\begin{align*}
\# \bigcup_{j=1}^{k} Y_{j} & =n_{2}+n_{3}+\cdots+n_{k}+n_{k+1}  \tag{7}\\
& \leqslant n_{k+1}\left(1+\frac{1}{4}+\frac{1}{4^{2}}+\frac{1}{4^{k-1}}\right) \leqslant \frac{4}{3} n_{k+1} \tag{8}
\end{align*}
$$

This means that at least $\frac{2}{3} n_{k+1}$ elements from $\Gamma$ are in $\bigcup_{j=k+1}^{\infty} Y_{j}$. Let $\Gamma^{1}$ be a fixed set of such elements with $\frac{2}{3} n_{k+1} \leqslant \# \Gamma^{1} \leqslant n_{k+1}$ and let us write $\Gamma^{1}=\bigcup_{s=k+1}^{\infty} A_{s}$ where $A_{s}=\Gamma^{1} \cap Y_{s}$. Since each of $A_{s}$ 's has at most $n_{k+1}$ elements we get

$$
\begin{align*}
\left\|\sum_{j \in \Gamma} e_{j}\right\| & \geqslant\left\|\sum_{j \in \Gamma^{1}} e_{j}\right\|=\sqrt{\sum_{s=k+1}^{\infty}\left\|\sum_{j \in A_{s}} e_{j}\right\|^{2}}  \tag{9}\\
& =\sqrt{\sum_{s=k+1}^{\infty} \# A_{s}}=\sqrt{\# \Gamma^{1}} \geqslant \sqrt{\frac{2}{3} n_{k+1}} \tag{10}
\end{align*}
$$

So $h_{l}\left(2 n_{k+1}\right) \geqslant \sqrt{\frac{2}{3} n_{k+1}}$ and we get

$$
\frac{h_{l}\left(2 n_{k+1}\right)}{h_{l}\left(n_{k+1}\right)} \geqslant \frac{\sqrt{\frac{2}{3} n_{k+1}}}{\sqrt{n_{k}}}=\sqrt{\frac{2}{3}} \sqrt{a_{k+1}} .
$$

Since $a_{k}$ tends to infinity we get the claim.
Remark 2.1. A more careful analysis should show that $h_{l}(n)$ is exactly equal to the norm of the sum of the first $n$ unit vectors.

Remark 2.2. Clearly we can use other values of $p$ in place of 2 .

## 3. Approximation spaces

It is standard in approximation theory to define spaces of elements which admit some rate of approximation. In our context two spaces are esential. We define them for a fixed Banach space with the basis $\left(x_{n}\right)_{n=1}^{\infty}$.

1. Non-linear approximation space $\mathcal{A}_{q}^{\alpha}$ with $\alpha>0$ and $0<q<\infty$ defined as

$$
\mathcal{A}_{q}^{\alpha}=\left\{x \in X:\|x\|_{\mathcal{A}_{q}^{\alpha}}=\|x\|+\left[\sum_{N=1}^{\infty}\left(N^{\alpha} \sigma_{N}(x)\right)^{q} \frac{1}{N}\right]^{1 / q}<\infty\right\}
$$

and for $q=\infty$ we define

$$
\mathcal{A}_{\infty}^{\alpha}=\left\{x \in X:\|x\|_{\mathcal{A}_{q}^{\alpha}}=\|x\|+\sup _{N \geqslant 1} N^{\alpha} \sigma_{N}(x)<\infty\right\}
$$

where $\sigma_{N}(x)$ is the error of the best $N$-term approximation i.e.

$$
\begin{equation*}
\sigma_{N}(x)=\inf \left\{\left\|x-\sum_{n \in \Lambda} b_{n} x_{n}\right\|: \# \Lambda=N \text { and } b_{n} \text { 's are arbitrary }\right\} . \tag{11}
\end{equation*}
$$

2. Greedy classes $\mathcal{G}_{q}^{\alpha}$ are defined in the same way but we replace $\sigma_{N}(x)$ by error of a greedy approximation which is defined as $\gamma_{N}(x)=\max \left\|x-\mathcal{G}_{N}(x)\right\|$. The maximum is taken over all $\mathcal{G}_{N}(x)$ 's in case it is not uniquely defined.
It is well known that $\mathcal{A}_{q}^{\alpha}$ are quasi-Banach spaces with the quasi-norm $\|\cdot\|_{\mathcal{A}_{q}^{\alpha}}$. For the spaces $\mathcal{G}_{q}^{\alpha}$ the situation is not so clear-we do not know if it is a linear space. Clearly if the basis is greedy then $\sigma_{N} \sim \gamma_{N}$ and the spaces are equal. Also, since always $\sigma_{N}(x) \leqslant \gamma_{N}(x)$, we have $\mathcal{G}_{q}^{\alpha} \subset \mathcal{A}_{q}^{\alpha}$. The problem whether the equality $\mathcal{G}_{q}^{\alpha}=\mathcal{A}_{q}^{\alpha}$ characterise greedy bases was considered in [1]. Actually it turned out to be quite difficult so the authors considered the problem of equivalence of quantities $\|x\|_{\mathcal{A}_{q}^{\alpha}}$ and $\|x\|_{\mathcal{G}_{q}^{\alpha}}$. Let us say that greedy approximation is optimal ${ }^{1}$ for $\alpha$ and $q$ if there exists a constant $C$ such that for every $x \in \mathcal{A}_{q}^{\alpha}$ we have

$$
\|x\|_{\mathcal{G}_{q}^{\alpha}} \leqslant C\|x\|_{\mathcal{A}_{q}^{\alpha}} .
$$

The main result of this section is the following
Theorem 3.1. If $\left(x_{n}\right)$ in unconditional, the following are equivalent

1. $\left(x_{n}\right)$ is democratic
2. $\left\|x-\mathcal{G}_{N}(x)\right\| \leqslant C \sigma_{N}(x)$ for all $x$
3. $\|x\|_{\mathcal{G}_{q}^{\alpha}} \leqslant C\|x\|_{\mathcal{A}_{q}^{\alpha}}$ for all (some) $\alpha, q>0$.

Remark 3.3. This Theorem for bases with doubling $h_{l}$ was proved by C. Cabrelli, G. Garrigós, E. Hernández and U. Molter and stated without proof in a note Added in proof in [1]. Below I present their proof with their kind permission.

Proof. That for unconditional bases 1. is equivalent to 2 . was proved by Konyagin-Temlyakov [3]. 2. $\Rightarrow 3$. is clear and was already mentioned above. We will prove that for a non-greedy unconditional basis 3. fails. We will distinguish two cases: when $h_{l}$ is doubling and when $h_{l}$ is not doubling. To prove the first case we need to recall Proposition 7.1 from [1]

Proposition 3.2. Suppose that there exist integers $n_{\mu} \geqslant k_{\mu} \geqslant 1$ for $\mu=1,2, \ldots$ such that

$$
\begin{equation*}
\lim _{\mu \rightarrow \infty} \frac{n_{\mu}}{k_{\mu}}=\infty \quad \text { and } \quad \frac{h_{r}\left(k_{\mu}\right)}{h_{l}\left(n_{\mu}\right)} \geqslant C\left(\frac{n_{\mu}}{k_{\mu}}\right)^{\alpha} \tag{12}
\end{equation*}
$$

for some $C>0$ and $\alpha>0$. Then greedy approximation is not optimal for $\alpha$ and any $q \in(0, \infty]$.

Lemma 3.3 (C. Cabrelli, G. Garrigós, E. Hernández, U. Molter). Let $\alpha>0$ and $h_{r}, h_{l}: \mathbb{N} \rightarrow(0, \infty)$ be any two increasing functions such that $h_{l}$ is doubling and $\lim \sup _{\mu \rightarrow \infty} \frac{h_{r}(\mu)}{h_{l}(\mu)}=\infty$. Then there exists integers $n_{\mu} \geqslant k_{\mu} \geqslant 1$ for $\mu=1,2, \ldots$ such that (12) holds.

[^1]Proof. We easily see that there exists an increasing sequence of integers $\left\{w_{\mu}\right\}_{\mu=1}^{\infty}$ such that

$$
\begin{equation*}
\lim _{\mu \rightarrow \infty} h_{r}\left(w_{\mu}\right) / h_{l}\left(w_{\mu}\right)=\infty \tag{13}
\end{equation*}
$$

Given $w_{\mu}$ we fix an integer $r(\mu)$ such that $2^{r(\mu)-1} \leqslant w_{\mu}<2^{r(\mu)}$. Since $h_{l}$ is doubling, for any $M, \mu \in \mathbb{N}$ we have

$$
\begin{equation*}
h_{l}\left(w_{\mu} M\right) \leqslant h_{l}\left(2^{r(\mu)} M\right) \leqslant C^{r(\mu)} h_{l}(M) . \tag{14}
\end{equation*}
$$

Using (13) we fix an increasing sequence $\left(k_{\mu}\right)_{\mu=1}^{\infty}$ such that each $k_{\mu}$ is some $w_{\mu^{\prime}}$ such that

$$
\begin{equation*}
\frac{h_{r}\left(k_{\mu}\right)}{h_{l}\left(k_{\mu}\right)} \geqslant C^{r(\mu)} w_{\mu}^{\alpha} \tag{15}
\end{equation*}
$$

and we define $n_{\mu}=w_{\mu} k_{\mu}$, so the first part of (12) holds . Using (14) and (15), we obtain

$$
\frac{h_{r}\left(k_{\mu}\right)}{h_{l}\left(n_{\mu}\right)}=\frac{h_{r}\left(k_{\mu}\right)}{h_{l}\left(w_{\mu} k_{\mu}\right)} \geqslant \frac{h_{r}\left(k_{\mu}\right)}{C^{r(\mu)} h_{l}\left(k_{\mu}\right)} \geqslant w_{\mu}^{\alpha}=\left(\frac{n_{\mu}}{k_{\mu}}\right)^{\alpha}
$$

To settle the first case we note that a non-greedy basis with doubling $h_{l}$ satisfies the assumptions of Lemma 3.3 so using Proposition 3.2 we get the claim.

Now let us assume that we have a normalised, 1-unconditional basis $\left(e_{j}\right)_{j=1}^{\infty}$ with the function $h_{l}(n)$ not doubling. For each $s$ there exists $n_{s}$ such that $h_{l}\left(2 n_{s}\right) \geqslant$ $(s+1) h_{l}\left(n_{s}\right)$. For simplicity in what follows we will write $\|S\|=\left\|\sum_{j \in S} e_{j}\right\|$. Let us fix a set $M_{s}$ such that $\# M_{s}=n_{s}$ and $\left\|M_{s}\right\| \geqslant h_{l}\left(n_{s}\right) \geqslant\left\|M_{s}\right\|-\frac{1}{s+1}$. Then for any set $D$ disjoint from $M_{s}$ with $\# D=n_{s}$ we have

$$
\|D\|+\left\|M_{s}\right\| \geqslant\left\|M_{s} \cup D\right\| \geqslant h_{l}\left(2 n_{s}\right) \geqslant(s+1) h_{l}\left(n_{s}\right) \geqslant(s+1)\left(\left\|M_{s}\right\|-\frac{1}{s+1}\right)
$$

so for every such $D$ we have $\|D\| \geqslant s\left\|M_{s}\right\|-1 \geqslant s h_{l}\left(n_{s}\right)-1$.
Note that $h_{l}$ is unbounded (because bounded is doubling).
Given $M_{s}$ let us take $r=:\lfloor\sqrt{s}\rfloor$ disjoint sets $V_{j}$ also disjoint with $M_{s}$, such that $\# \bigcup_{j=1}^{r} V_{j}=n_{s}$ each of cardinality $\left\lfloor n_{s} / r\right\rfloor$ or $\left\lceil n_{s} / r\right\rceil$. Denote the set $V_{j}$ with the biggest $\left\|V_{j}\right\|$ as $V^{s}$. Since $r \max \left\|V_{j}\right\| \geqslant\left\|\bigcup_{j=1}^{r} V_{j}\right\| \geqslant s\left\|M_{s}\right\|-1$ we see that

$$
\begin{equation*}
\left\|V^{s}\right\| \geqslant \frac{s}{r}\left\|M_{s}\right\|-\frac{1}{r} \tag{16}
\end{equation*}
$$

Put $x_{s}=\sum_{V^{s}} e_{j}+2 \sum_{M_{s}} e_{j}$. We have $\left\|x_{s}\right\| \leqslant\left\|V^{s}\right\|+2\left\|M_{s}\right\| \leqslant 3\left\|V^{s}\right\|$. The number of non-zero coefficients of $x_{s}$ equals $\# V_{s}+\# M_{s} \leqslant 2 \# M_{s}$. In what follows we are only interested in $k \leqslant 2 \# M_{s}$ because for $k>2 \# M_{s}$ we have $\mathcal{G}_{k}\left(x_{s}\right)=x_{s}$ and $\sigma_{k}\left(x_{s}\right)=0$.

For $k \leqslant \# M_{s}$ we have

$$
\left\|x_{s}-\mathcal{G}_{k}\left(x_{s}\right)\right\| \geqslant\left\|V^{s}\right\|
$$

so for $0<q<\infty$ we have

$$
\begin{equation*}
\left\|x_{s}\right\|_{\mathcal{G}_{q}^{\alpha}} \geqslant\left[\sum_{k=1}^{\# M_{s}}\left(k^{\alpha}\left\|x_{s}-\mathcal{G}_{k}\left(x_{s}\right)\right\|\right)^{q} \frac{1}{k}\right]^{1 / q} \geqslant C\left\|V^{s}\right\|\left(\# M_{s}\right)^{\alpha} . \tag{17}
\end{equation*}
$$

and for $q=\infty$ we have

$$
\begin{equation*}
\left\|x_{s}\right\|_{\mathcal{G}_{\infty}^{\alpha}} \geqslant \max _{k \leqslant \# M_{s}} k^{\alpha}\left\|x-\mathcal{G}_{k}(x)\right\| \geqslant\left(\# M_{s}\right)^{\alpha}\left\|V_{s}\right\| . \tag{18}
\end{equation*}
$$

On the other hand for $k \geqslant \# V^{s}$ using (16) we have

$$
\begin{equation*}
\sigma_{k}\left(x_{s}\right) \leqslant 2\left\|M_{s}\right\| \leqslant 2 \frac{r\left\|V^{s}\right\|+1}{s} \leqslant 3 \frac{r\left\|V^{s}\right\|}{s} \tag{19}
\end{equation*}
$$

and for $k<\# V^{s}$

$$
\begin{equation*}
\sigma_{k}\left(x_{s}\right) \leqslant\left\|x_{s}\right\| \leqslant 3\left\|V^{s}\right\| \tag{20}
\end{equation*}
$$

Therefore using (20) and (19), for $q<\infty$ we have

$$
\begin{align*}
\left\|x_{s}\right\|_{\mathcal{A}_{q}^{\alpha}} & =\left\|x_{s}\right\|+\left[\sum_{k=1}^{2 \# M_{s}}\left(k^{\alpha} \sigma_{k}\left(x_{s}\right)\right)^{q} \frac{1}{k}\right]^{1 / q} \\
& \leqslant 3\left\|V^{s}\right\|+\left[\left(3\left\|V^{s}\right\|\right)^{q} \sum_{k=1}^{\# V^{s}-1} k^{q \alpha-1}+\left(3 \frac{r\left\|V^{s}\right\|}{s}\right)^{q} \sum_{k=\# V^{s}}^{2 \# M_{s}} k^{q \alpha-1}\right]^{1 / q} \\
& \leqslant 3\left\|V^{s}\right\|+\left[C\left\|V^{s}\right\|^{q}\left(\# V^{s}\right)^{q \alpha}+C(r / s)^{q}\left\|V^{s}\right\|^{q}\left(\# M_{s}\right)^{q \alpha}\right]^{1 / q} \\
& \leqslant C\left(\# M_{s}\right)^{\alpha}\left\|V^{s}\right\|\left(r^{-q \alpha}+(r / s)^{q}\right)^{1 / q} \\
& \leqslant C\left\|x_{s}\right\|_{\mathcal{G}_{q}^{\alpha}}\left(r^{-q \alpha}+(r / s)^{q}\right)^{1 / q} \\
& \leqslant C\left\|x_{s}\right\|_{\mathcal{G}_{q}^{\alpha}}\left(s^{-q \alpha / 2}+s^{-q / 2}\right)^{1 / q} \tag{21}
\end{align*}
$$

Analogously for $q=\infty$ we have

$$
\begin{align*}
\left\|x_{s}\right\|_{\mathcal{A}_{\infty}^{\alpha}} & =\left\|x_{s}\right\|+\sup _{k \geqslant 1} k^{\alpha} \sigma_{k}\left(x_{s}\right) \\
& \leqslant 3\left\|V^{s}\right\|+\max _{k<\# V^{s}} 3 k^{\alpha}\left\|V^{s}\right\|+\max _{\# V_{s} \leqslant k \leqslant 2 \# M_{s}} 3 k^{\alpha} \frac{r\left\|V^{s}\right\|}{s} \\
& \leqslant\left\|V^{s}\right\|\left(3+3\left(\# V^{s}\right)^{\alpha}+3\left(2 \# M_{s}\right)^{\alpha} r / s\right) \\
& \leqslant C\left\|x_{s}\right\|_{\mathcal{G}_{\infty}^{\alpha}}\left(\left(\# M_{s}\right)^{-\alpha}+s^{-\alpha / 2}+s^{-1 / 2}\right) . \tag{22}
\end{align*}
$$

Since $s$ is arbitrary, from (21) and (22) we infer that the greedy approximation is not optimal for any $\alpha$ and $q$ also in the nondoubling case.
