# Cohomology of classifying spaces of central quotients of rank two Kac-Moody groups

The goal of this paper is to compute the mod $p$ cohomology algebra -including the action of the Steenrod algebra and the Bockstein spectral sequence - of the classifying spaces of the quotients of (non-afine) Kac-Moody groups of rank two by finite central $p$-groups. These classifying spaces may be realized as a homotopy pushout of the classifying spaces of two compact Lie groups, intersecting along the classifying space of their common maximal torus. Such decompositions have recently been observed by S. Anjos and G. Granja [5] in their study of the symplectomorphism groups of $S^{2} \times S^{2}$. In particular, Anjos and Granja show that the classifying space of the symplectomorphism group of $S^{2} \times S^{2}$ with a suitable symplectic form may be written as the homotopy pushout of the classying spaces of two compact Lie groups, intersecting along the classifying space of their common sub-torus. We therefore believe that the results of this paper are useful in the study of such pushouts.

Kac-Moody groups are simply connected topological groups, generally infinite dimensional, associated to Kac-Moody Lie algebras. The study of their topological properties was first considered by V. Kac and D. Peterson [14] and further developed by N. Kitchloo [16]. It turned out that in many respects they closely resemble compact (simply connected) Lie groups. For example they admit (finite dimensional) maximal tori and a Weyl group. These Weyl groups are crystallographic groups, but not necessarily finite. The present paper is part of a more general project which, roughly speaking, aims to investigate the homotopy theory of the Kac-Moody groups with the tools that have led to the development of the homotopy theory of compact Lie groups (see, for instance, the surveys [11] and [18]). We would like to point out the papers [7] and [1] as further examples of how some of the homotopy theoretical results and techniques of compact Lie groups can be extended, with some appropriate reformulation, to Kac-Moody groups.

One of the most important invariants of compact Lie groups is the cohomology ring of the classifying space. This has played a central role in the development of the homotopy theory of compact Lie groups, including the

[^0]central results about homotopy uniqueness of Dwyer-Miller-Wilkerson [9], or Notbohm [17], among others. Although, comparable results are expected in the case of infinite dimensional Kac-Moody groups, the theory will be more involved due to the existence of exterior generators in the cohomology rings, linked to polynomial generators by higher Bockstein operations. Cohomology rings with comparable structure have been considered in [2], where a deep understanding of the cohomology rings of the spaces involved and their homotopy central quotients was required.

The investigation of Kac-Moody groups demands similar arguments and therefore the understanding of the cohomology rings of their classifying spaces and of the classifying spaces of their central quotients. However, the wise have taught us (cf. Ithaca in [8]) that in the trips which are really worth doing what we see and learn along the trip always turns out to become more important than the final destination. We think that the present work might be an example of this. The rank two Kac-Moody groups have a large family of central subgroups which yield a rather complex series of interesting unstable algebras over the Steenrod algebra, and when we started computing these cohomology algebras we learned that in order to study them in a systematic way we needed to relate them to representation theory and to invariant theory. In this context, we believe that the relationship between rank two Kac-Moody groups, representations of the infinite dihedral group, invariant theory of pseudoreflection groups and cohomology algebras that we display here is more interesting than the particular values of each cohomology algebra.

As it has been the case in different situations in homotopy theory it turns out that a better description of the mod $p$ cohomology rings and a deeper understanding of its structure is obtained by merging the classifying spaces of Kac-Moody groups and of their central quotients in a larger class of spaces sharing similar homotopy theoretic properties with them [7]. For the case of rank two Kac-Moody groups $K$ and their quotients $K / F$, by central subgroups $F$ of $K$, it is convenient to restrict to a family of spaces - the family which we call $S^{*}$ - which can be viewed as a homotopy theoretic generalization (and also a $p$-adic completion) of the spaces $B(K / F)$. The spaces in the set $\mathrm{S}^{*}$ can be parametrized by matrices in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ plus some extra data. A better parametrization of $S^{*}$ is given by a set called $R^{*}$ whose elements are faithful representations of the infinite dihedral group $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ plus some obstruction classes, modulo the action of the outer automorphisms of $D_{\infty}$. Hence, our results depend on the integral $p$-adic representation theory of the infinite dihedral group. This theory has been developed in [3] and we would like to point out that the work in [3] was motivated by the present paper and, moreover, the cohomological results in the present paper helped us in shaping the results in [3].

The present paper is organized as follows. In section 1 we recollect the notation on Kac-Moody groups and their central quotients that we use later. In section 2 we introduce the colimit decomposition of $B(K / F)$ that we will use to compute the cohomology and we define the family of spaces $S^{*}$ which contains all spaces $B(K / F)$. In section 3 we relate the spaces in $\mathrm{S}^{*}$ to representations of
$D_{\infty}$ and we introduce a set R* of representation data with obstruction classes which parametrizes $S^{*}$. Moreover, we review the results on representations of $D_{\infty}$ which we proved in [3], in a form which is more appropriate to our needs. Then, in the next three sections, we compute, for each data element of $\mathrm{R}^{*}$, the $\bmod p$ cohomology of the space in $\mathrm{S}^{*}$ corresponding to this data. The first of these three sections gives some generic information and the two other sections consider the case of the prime two and the case of the odd primes, respectively. We use the invariant theory of finite reflection groups as developed in [19]. In the final section, we return to Kac-Moody groups and we compute, for each quotient $K / F$, the representation data in $\mathrm{R}^{*}$ which gives $B(K / F)$ and we have in this way enough information to compute the mod $p$ cohomology algebras, the Steenrod algebra actions and the Bockstein spectral sequences of all spaces, of the form $B(K / F)$, but a few cases.

## 1. Rank two Kac-Moody groups and central quotients

We choose positive integers $a, b$ such that $a b>4$. Throughout this paper $K$ will always denote the unitary form of the Kac-Moody group associated to the generalized Cartan matrix

Sometimes we write $K(a, b)$ instead of $K$ when we want to make explicit the values of $a$ and $b$ used to construct $K$. The integers $a$ and $b$ can be interchanged, since the group associated to $(a, b)$ is isomorphic to the group associated to $(b, a)$. The case $a b<4$ gives rise to compact Lie groups while the case $a b=$ 4 is called the affine case and will be left aside. These infinite dimensional topological groups and their classifying spaces $B K$ have been studied from a homotopical point of view in several works, like [13], [12], [15], [16], [7], [1]. We recall here some properties of $K$ and $B K$ which we will use throughout this work and which can be found in the references that we have just mentioned.

By construction, $K$ comes with a standard maximal torus of rank two $T_{K}$ which is a maximal connected abelian subgroup of $K$. Any two such subgroups are conjugate. The Weyl group $W$ of $K$ is an infinite dihedral group acting on the Lie algebra of $T_{K}$ through reflections $\omega_{1}$ and $\omega_{2}$ given, in the standard basis, by the integral matrices:

-1 & b \\
0 & 1
\end{array}\right), \quad w_{2}=\left(\begin{array}{cc}
1 & 0 \\
a & -1
\end{array}\right) .
$$

The matrices of determinant +1 in $W$ form a subgroup $W^{+}$of index two which is infinite cyclic generated by $\omega_{1} \omega_{2}$.

The cohomology of $K$ and $B K$ was computed by Kitchloo ([16]) using, among other tools, the existence of a Schubert calculus for the homogeneous space $K / T_{K}$.

The center of $K$ is also well understood ([13]):

$$
Z K= \begin{cases}2 \mathbb{Z} /(a b-4) \times \mathbb{Z} / 2, & a \equiv b \equiv 0 \quad(\bmod 2) \\ \mathbb{Z} /(a b-4), & \text { otherwise }\end{cases}
$$

Hence, we have a family of central $p$-subgroups $F$ of $K$ and the purpose of this paper is to study the spaces $B(K / F)$.

Let us fix now the notation that we will use in this paper to refer to the various quotients of $K$ by central subgroups. We denote by $\nu_{p}$ the $p$-adic valuation.

- If $p$ is an odd prime or $p=2$ and $a$ or $b$ is odd then there is a unique central subgroup $F$ of $K$ of order $p^{m}$ for any $0 \leq m \leq \nu_{p}(a b-4)$. We denote $K / F$ by $P_{p^{m}} K$.
- If $p=2$ and $a$ and $b$ are both even then the 2-primary part of the center of $K$ is non-cyclic of the form $\mathbb{Z} / 2^{t} \times \mathbb{Z} / 2, t=\nu_{2}((a b-4) / 2)$. There are several quotient groups. We denote by $P_{2}^{R} K$ the quotient of $K$ by the right subgroup of the center of order two. We denote by $P_{2^{m}}^{L} K, 0 \leq m \leq t$ the quotient of $K$ by the left subgroup of the center of order $2^{m}$. We denote by $P_{2^{m}}^{D} K, 0<m \leq t$ the quotient of $K$ by the diagonal subgroup of the center of order $2^{m}$. Finally, we denote by $P_{2^{m+1}}^{N} K, 0<m \leq t$ the quotient of $K$ by the non-cyclic subgroup of the center of order $2^{m+1}$.


## 2. Colimit decompositions of $B K$ and $B(K / F)$ and the spaces in $S^{*}$

A fundamental result in the homotopy theory of the classifying spaces of Kac-Moody groups is the following (cf. [16]). If $L$ is any Kac-Moody group with infinite Weyl group and $\left\{P_{I}\right\}$ are the parabolic subgroups of $L$ indexed by proper subsets $I$ of $\{1, \ldots, \operatorname{rank}(L)\}$ then there is a homotopy equivalence

$$
B L \simeq \underset{I}{\operatorname{hocolim}} B P_{I} .
$$

Let us give a more precise description of this homotopy colimit in the case of the rank two group $K=K(a, b)$.

There are group homomorphisms $\varphi_{i}: S U(2) \rightarrow K, i=1,2$, such that the images of $\varphi_{1}$ and $\varphi_{2}$ generate $K$. If $D$ is the unit disc in $\mathbb{C}$ and we write

z_{i}(u)=\varphi_{i}\left(\begin{array}{cc}
u & \left(1-\|u\|^{2}\right)^{1 / 2} \\
-\left(1-\|u\|^{2}\right)^{1 / 2} & \bar{u}
\end{array}\right)
$$

then $K$ has a presentation with generators $\left\{z_{i}(u) \mid u \in D, i=1,2\right\}$ and relations
(i) $z_{i}(u) z_{i}(v)=z_{i}(u v)$ if $u, v \in S^{1}$.
(ii) $z_{i}(u) z_{i}(-\bar{u})=z_{i}(-1)$ if $u \in D \backslash S^{1}$.
(iii) $z_{i}(u) z_{i}(v)=z_{i}\left(u^{\prime}\right) z_{i}\left(v^{\prime}\right)$ if $u, v \in D \backslash S^{1}, u \neq v$, for some unique $u^{\prime} \in$ $D \backslash S^{1}$ and $v^{\prime} \in S^{1}$.
(iv) $z_{i}(u) z_{j}(v) z_{i}(u)^{-1}=z_{j}\left(u^{a_{i j}} v\right) z_{j}\left(u^{-a_{i j}}\right)$ if $u \in S^{1}, v \in D$ and $\left(a_{i j}\right)$ is the Cartan matrix of $K$.

Then $B K$ is a homotopy push out

where $H_{1}$ and $H_{2}$ are rank two compact Lie groups which contain the maximal torus $T_{K}$ and can be described from the generators $z_{i}(u)$ in the following way: $H_{i}$ is generated by $z_{i}(u)$ for $u \in D$ and $z_{j}(\lambda)$ for $j \neq i$ and $\lambda \in S^{1}$. Hence, these groups are split extensions

$$
H_{i}=S U(2) \rtimes S^{1}
$$

and the action of $S^{1}$ on $S U(2)$ can be read from relation (iv) above and it turns out to be

$$
\lambda \cdot\left(\begin{array}{ll}
x & y  \tag{2.1}\\
z & t
\end{array}\right)=\left(\begin{array}{cc}
x & \lambda^{-c} y \\
\lambda^{c} z & t
\end{array}\right)
$$

where $c=b$ for $H_{1}$ and $c=a$ for $H_{2}$. The Weyl group of both $H_{1}$ and $H_{2}$ is of order two. Depending on the parity of the integer $c$, this group is isomorphic to either $S U(2) \times S^{1}$ or $U(2)$ :

Proposition 2.1. Let $H$ be the split extension of $S^{1}$ by $S U(2)$ with action given by (2.1). Then

H \cong\left\{\begin{array}{l}
S^{1} \times S U(2), \quad c \text { even } \\
U(2), \quad c \text { odd }
\end{array}\right.
$$

Proof. If $c=2 c^{\prime}$ then consider the isomorphism

H=S U(2) \rtimes S^{1} & \xrightarrow{\psi} S^{1} \times S U(2) \\
(A, \tau) & \longmapsto\left(\tau, A\left(\begin{array}{cc}
\tau^{-c^{\prime}} & 0 \\

\end{array}\right)\right)
\end{aligned}
$$

If $c=2 c^{\prime}+1$ then consider the isomorphism

$$
\begin{aligned}
H=S U(2) \rtimes S^{1} & \xrightarrow{\psi} U(2) \\
(A, \tau) & \longmapsto A\left(\begin{array}{cc}
\tau^{-c^{\prime}} & 0 \\
0 & \tau^{c^{\prime}+1}
\end{array}\right) .
\end{aligned}
$$

This proposition gives concrete descriptions of the push out diagrams for $B K$ for any value of $a$ and $b$. We have:

- $a \equiv b \equiv 0(\bmod 2)$. Then
$B K \simeq \operatorname{hocolim}\left\{B S^{1} \times B S U(2) \stackrel{\left(\begin{array}{cc}1 & 0 \\ -\frac{a}{2} & 1\end{array}\right)}{ } B T_{K} \xrightarrow{\left(\begin{array}{cc}0 & 1 \\ 1 & -\frac{b}{2}\end{array}\right)} B S^{1} \times B S U(2)\right\}$.
- $a \equiv b \equiv 1(\bmod 2)$. Then
$B K \simeq \operatorname{hocolim}\left\{B U(2) \stackrel{\left(\begin{array}{cc}\frac{1-a}{2} & 1 \\ \frac{1+a}{2} & -1\end{array}\right)}{ } B T_{K} \xrightarrow{\left(\begin{array}{cc}1 & \frac{1-b}{2} \\ -1 & \frac{1+b}{2}\end{array}\right)} B U(2)\right\}$.
- $a \equiv 0, b \equiv 1(\bmod 2)$. Then

$$
B K \simeq \operatorname{hocolim}\left\{B S^{1} \times B S U(2) \stackrel{\left(\begin{array}{cc}
1 & 0 \\
-\frac{a}{2} & 1
\end{array}\right)}{\rightleftarrows} B T_{K} \xrightarrow{\left(\begin{array}{cc}
1 & \frac{1-b}{2} \\
-1 & \frac{1+b}{2}
\end{array}\right)} B U(2)\right\}
$$

Here each matrix $M$ written above an arrow means a map $B(i \circ \rho)$ where $i: T_{K} \hookrightarrow K$ is the inclusion and $\rho: T_{K} \rightarrow T_{K}$ is the homomorphism inducing $M$ on the Lie algebra level.

If we want to work one prime at a time (and we will want to do so) then we can complete the above push out diagrams and obtain $B K_{p}^{\wedge}$ as the $p$-completion of a push out of the form $(B H)_{p}^{\wedge} \leftarrow B T_{p}^{\wedge} \rightarrow\left(B H^{\prime}\right)_{p}^{\wedge}$.

Notice that the distinction between the three different types of diagrams above is only important at the prime two, since $B U(2)$ and $B S^{1} \times B S U(2)$ are homotopy equivalent at any odd prime. Moveover, If $N$ denotes the normalizer of $T_{K}$ in $K$ then the natural map $B N \rightarrow B K$ is a $\bmod p$ homotopy equivalence for any odd prime $p$ (see [16]).

Notice also that the classifying spaces of the central quotients of $K$ have also a colimit decomposition of this same form:

$$
B(K / F) \simeq \operatorname{hocolim}\left\{B(H / F) \leftarrow B\left(T_{K} / F\right) \rightarrow B\left(H^{\prime} / F\right)\right\} .
$$

The above considerations suggest considering the family $S$ of all spaces $X$ which can be constructed out of two rank two compact Lie groups $H, H^{\prime}$ with Weyl group of order two, as a push out $B H \leftarrow B T \rightarrow B H^{\prime}$. We introduce the following definition:

Definition 2.1. Choose a prime $p$ (which will be omitted from the notation) and choose a matrix $M \in G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. Let $T$ be a torus of rank two. Then:

1. If $p$ is odd, define $X(M)$ as the $p$-completion of the push out

$$
\left(B S^{1} \times B S U(2)\right)_{p}^{\wedge} \stackrel{M}{\longleftrightarrow}(B T)_{p}^{\wedge} \xrightarrow{\mathrm{id}}\left(B S^{1} \times B S U(2)\right)_{p}^{\wedge} .
$$

2. If $p=2$, define $X^{k, l}(M), k, l \in\{0,1,2\}$ as the 2 -completion of the push out

$$
\left(B H_{k}\right)_{2}^{\wedge} \stackrel{M}{\longleftrightarrow}(B T)_{2}^{\wedge} \xrightarrow{\mathrm{id}}\left(B H_{l}\right)_{2}^{\wedge},
$$

where $H_{0}=S^{1} \times S U(2), H_{1}=S^{1} \times S O(3)$ and $H_{2}=U(2)$.

The map called id is induced by the inclusion of the standard maximal torus and the map called $M$ is induced by the self equivalence of $B T_{p}^{\wedge}$ given by $M$ (in the standard basis) followed by the inclusion of the standard maximal torus.

Notice that a space obtained from a push out of the form

$$
(B H)_{p}^{\wedge} \stackrel{M}{\longleftarrow}\left(B T_{K}\right)_{p}^{\wedge} \xrightarrow{N}\left(B H^{\prime}\right)_{p}^{\wedge}
$$

fits also in the above definition as $X^{k, l}\left(M N^{-1}\right)$ for some $k, l$. Hence, the set S of all (homotopy types of) spaces of the form $X^{k, l}(M)$ contains all spaces that we want to study in this paper. Notice also that if we turn around the diagram used to define $X^{k, l}(M)$ we get the diagram for $X^{l, k}\left(M^{-1}\right)$ and so both spaces are homotopy equivalent. Hence, we can assume $k \leq l$ without loss of generality.

Hence, we have enlarged the set of spaces that we are going to consider in this paper in a way that we obtain a more general framework which will allow us a more systematic study of the classifying spaces of the central quotients of the rank two Kac-Moody groups. This larger family of spaces $S$ is parametrized by a set $M$ of diagrams $\{M ;\{k, l\}\}$, in the following way. We define $M$ as the set of diagrams

$$
\left(B H_{k}\right)_{p}^{\wedge} \stackrel{M}{\longleftarrow}(B T)_{p}^{\wedge} \xrightarrow{\mathrm{id}}\left(B H_{l}\right)_{p}^{\wedge}
$$

with $M \in G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ and $k \leq l$ in $I$, where $I=\{0\}$ for $p>2$ and $I=\{0,1,2\}$ for $p=2$. The assignment $\{M ;\{k, l\}\} \mapsto X^{k, l}(M)$ gives a surjection $M \rightarrow S$.

We can associate to each element $\{M ;\{k, l\}\} \in M$ a subgroup $W<$ $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ in the following way. $W$ is the subgroup generated by the matrices $A_{l}$ and $M^{-1} A_{k} M$ with

$$
A_{0}=A_{1}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right), \quad A_{2}=\left(\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right) .
$$

This group $W$ is a quotient of the infinite dihedral group and so it is either finite or infinite dihedral. We denote by $M^{*}$ the set of elements in $M$ whose corresponding group is infinite dihedral, and we denote by $S^{*}$ the image of $M^{*}$ in $S$. Notice that the spaces $(B K / F)_{p}^{\wedge}$ that we want to investigate in this paper are in $S^{*}$. The surjection

$$
\Phi: M^{*} \longrightarrow S^{*}
$$

gives a parametrization of the set $S^{*}$ in terms of $p$-adic matrices (with some indices, if the prime is 2 ). In the next section we present another parametrization of $S^{*}$ which will be more appropriate for our research of the cohomology of the spaces in $S^{*}$.

## 3. Spaces in $S^{*}$ and representations of $D_{\infty}$

In this section we give another parametrization of the set $S^{*}$ which is related to the integral $p$-adic representation theory of the infinite dihedral group
and which will allow us to give a more intrinsic view of the spaces $X^{k, l}(M)$ and will be useful to organize the cohomological computations of the following sections of this paper.

We denote by $\mathbf{R}^{*}$ the set of equivalence classes of pairs $(\rho, c)$ where $\rho$ is a faithful representation of the infinite dihedral group $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ and $c$ is an obstruction class in $H^{3}\left(D_{\infty} ; L\right)$, for $L$ a 2-dimensional $\widehat{\mathbb{Z}}_{p}$-lattice with the action of $D_{\infty}$ induced by $\rho$. The equivalence classes are taken with respect to the natural action of $\operatorname{Out}\left(D_{\infty}\right)$ on the set of representations and on $H^{*}\left(D_{\infty} ; L\right)$.

Remark 1. From a different point of view, we could denote by $\mathrm{R}=$ $\operatorname{Ext}\left(D_{\infty},\left(T^{2}\right)_{p}^{\wedge}\right)$ the set of equivalence classes of fibrations

$$
\left(B T^{2}\right)_{p}^{\wedge} \longrightarrow B N \longrightarrow B D_{\infty}
$$

where two fibrations are equivalent if there are homotopy equivalences $f^{\prime}, f$, and $f^{\prime \prime}$ such that the diagram

is homotopy commutative. Such a fibration is known to be determined by a homomorphism $\rho: D_{\infty} \longrightarrow G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$, and an extension class $c \in H^{3}\left(D_{\infty} ; L\right)$, for $L$ the 2-dimensional $\widehat{\mathbb{Z}}_{p}$-lattice with the given action of $D_{\infty}$. Moreover, two fibrations determined by $\left(\rho_{1}, c_{1}\right)$ and $\left(\rho_{2}, c_{2}\right)$ respectively are equivalent if and only if $\rho_{1}$ and $\rho_{2}$ are conjugate and $c_{1}=c_{2}$, up to the induced action of $\operatorname{Out}\left(D_{\infty}\right)$.

In case of Kac-Moody groups, $B N$ would be a fibrewise $p$-completion of the maximal torus normalizer. In the general case it might be understood as a homotopy theoretic maximal torus normalizer. However, we do not plan here to go deeper into these considerations.

We are interested in the case where the representation $\rho$ is faithful. Consistently with our notation in the previous section for $S^{*}$ and $M^{*}$, we have thus chosen to denote by $\mathrm{R}^{*}$ the subset of equivalence classes of R determined by pairs $(\rho, c)$ where $\rho$ is a faithful representation of $D_{\infty}$.

Recall that $D_{\infty}$ is generated by two involutions and the only non trivial outer automorphism of $D_{\infty}$ permutes these two involutions. A representation $\rho$ of $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ is given by two matrices of order two, $R_{1}, R_{2}$ and, according to [3], for $p>2$ these matrices are conjugate to $A_{1}=\left(\begin{array}{cc}1 & 0 \\ 0 & -1\end{array}\right)$, while for $p=2$ they are conjugate to either $A_{1}$ or $A_{2}=\left(\begin{array}{cc}0 & 1 \\ 1 & 1\end{array}\right)$. We write $\rho \in \operatorname{Rep}_{i, j}, i \leq$ $j$, to indicate that $\rho$ is defined by two involutions conjugate to $A_{i}$ and $A_{j}$, respectively. Notice that $\operatorname{Out}\left(D_{\infty}\right)$ identifies $\operatorname{Rep}_{i, j}$ and $\operatorname{Rep}_{j, i}$. Since $D_{\infty} \cong$ $\mathbb{Z} / 2 * \mathbb{Z} / 2$, we see that $H^{3}(W ; L) \cong H^{3}(\mathbb{Z} / 2 ; L) \oplus H^{3}(\mathbb{Z} / 2 ; L)$ and this vanishes if $p>2$. Hence, the obstruction class $c$ is irrelevant in the odd prime case
and $\mathrm{R}^{*}$ is just the set $\operatorname{fRep}\left(D_{\infty}\right)$ of faithful representations of $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$, modulo the action of the outer automorphisms of $D_{\infty}$. This set is equivalent to the set of all conjugacy classes of infinite dihedral subgroups of $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$.

For $p=2$, an elementary computation shows that

$$
H^{3}\left(D_{\infty} ; L\right) \cong \begin{cases}0, & \rho \in \operatorname{Rep}_{2,2} \\ \mathbb{Z} / 2, & \rho \in \operatorname{Rep}_{1,2} \\ \mathbb{Z} / 2 \oplus \mathbb{Z} / 2, & \rho \in \operatorname{Rep}_{1,1}\end{cases}
$$

$\operatorname{Out}\left(D_{\infty}\right)$ acts as the identity if $\rho \in \operatorname{Rep}_{2,2} \amalg \operatorname{Rep}_{1,2}$ and permutes the two summands if $\rho \in \operatorname{Rep}_{1,1}$. We can summarize the structure of $R^{*}$ in this way:

- If $p$ is odd then the elements of $\mathrm{R}^{*}$ are the conjugacy classes of infinite dihedral subgroups $W<G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$, i.e., $\mathrm{R}^{*}=\operatorname{fRep}\left(D_{\infty}\right) / \operatorname{Out}\left(D_{\infty}\right)$.
- If $p$ is even then $\mathrm{R}^{*}$ splits as a disjoint union of four sets:
- The set of all $(\rho, c)$ with $\rho \in \operatorname{fRep}_{2,2} / \operatorname{Out}\left(D_{\infty}\right)$ and $c=0$.
- The set of all $(\rho, c)$ with $\rho \in \operatorname{fRep}_{1,2}$ and $c=0$ or $c=1$.
- The set of all $(\rho, c)$ with $\rho \in \operatorname{fRep}_{1,1} / \operatorname{Out}\left(D_{\infty}\right)$ and $c=0$ or $c=$ $(1,1)$.
- The set of all $(\rho, c)$ with $\rho \in \operatorname{fRep}_{1,1}$ and $c=(0,1)$.

There is a surjection $\Psi: \mathrm{M}^{*} \longrightarrow \mathrm{R}^{*}$ which assigns to $\{M ;\{k, l\}\}$ the representation $\rho: D_{\infty} \rightarrow G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ given by the matrices $R_{1}=A_{l}, R_{2}=M^{-1} A_{k} M$ and the obstruction class given by

Remark 2. This assignment of an obstruction class is done in a way which reflects the non-splitting of the maximal torus normalizer of $S U(2)$ in contrast to the splitting of the maximal torus normalizer of $S O(3)$.

Then, we have a diagram

and we claim now that $\Phi$ factors through $R^{*}$, up to homotopy. This is an easy consequence of the following result.

Proposition 3.1. Let $\mathcal{D}$ be the subgroup of diagonal matrices in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ and let $\mathcal{Y}$ be the subgroup of matrices $\left(\begin{array}{c}x \\ y \\ y\end{array}\right) \in G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. Then:
(1) $\mathcal{D}$ is the centralizer of $A_{0}=A_{1}$ and $\mathcal{Y}$ is the centralizer of $A_{2}$.
(2) $X^{k, l}(M) \simeq X^{l, k}\left(M^{-1}\right)$.
(3) $X^{k, l}(M) \simeq X^{k, l}(A M B)$ for any $A$ in the centralizer of $A_{k}$ and $B$ in the centralizer of $A_{l}$.

Proof. The proof of part 1 is straightforward and part 2 has already been discussed in the preceding section. To prove part 3 , notice that the corollary 3.5 in [10] shows that any diagonal matrix lifts to self equivalences of $\left(B S^{1} \times\right.$ $B S U(2))_{p}^{\wedge}$ and $\left(B S^{1} \times B S O(3)\right)_{p}$ while any matrix in $\mathcal{Y}$ lifts to a self equivalence of $B U(2)_{p}^{\wedge}$. Using this, it is not difficult to construct an equivalence between the diagram for $X^{k, l}(M)$ and the diagram for $X^{k, l}(A M B)$.

We have thus obtained a surjection (up to homotopy)

$$
\bar{\Phi}: R^{*} \longrightarrow S^{*}
$$

which allows us to parametrize the homotopy types of spaces in $S^{*}$ by (faithful integral $p$-adic) representations of $D_{\infty}$, plus (for $p=2$ ) some obstruction classes.

Remark 3. An interesting question which arises naturally in this context is whether the map $\bar{\Phi}$ is injective. The injectivity of $\bar{\Phi}$ could be interpreted as saying that the spaces in $S^{*}$ and, in particular, the completions of the classifying spaces of central quotients of rank two Kac-Moody groups, are determined by the normalizer of a maximal torus. We are not going to consider these type of problems here.

Hence, the study of the homotopy type of the classifying spaces of the central quotients of rank two Kac-Moody groups has led us, in a natural way, to the representation theory of $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. This theory is developed in [3] in a purely algebraic way and thus a complete description of these representations is available. We reproduce here the results of [3] with a slightly different notation which is more convenient for the applications in the next sections of this paper.

First of all, the set $\operatorname{Rep}\left(D_{\infty}\right)$ of representations of $D_{\infty}$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ splits as a disjoint union

$$
\operatorname{Rep}\left(D_{\infty}\right)=\coprod_{i, j \in \mathcal{I}} \operatorname{Rep}_{i, j}
$$

where the index set $\mathcal{I}$ is $\{0,1,2,3\}$ for $p=2$ and $\{0,1,3\}$ for $p>2$. $\operatorname{Rep}_{i, j}$ contains all representations such that the two generating involutions $r_{1}, r_{2}$ of $D_{\infty}$ are conjugate to $A_{i}$ and $A_{j}$, respectively, where

$$
A_{0}=I, \quad A_{1}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right), \quad A_{2}=\left(\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right), \quad A_{3}=-I .
$$

Given a matrix $M \in G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ and given representations $\sigma_{i}, \sigma_{j}$ of $\mathbb{Z} / 2$ given by matrices $A_{i}, A_{j}$, we can consider the representation $\rho \in \operatorname{Rep}_{i, j}$ given by $\rho\left(r_{1}\right)=A_{i}$ and $\rho\left(r_{2}\right)=M^{-1} A_{j} M$. This assignment yields a bijection

$$
C\left(A_{j}\right) \backslash G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right) / C\left(A_{i}\right) \cong \operatorname{Rep}_{i, j}
$$

where $C(A)$ denotes the centralizer of $A$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. After this identification, the non trivial outer automorphism of $D_{\infty}$ interchanges $\operatorname{Rep}_{i, j}$ and $\operatorname{Rep}_{j, i}$ and acts on $\operatorname{Rep}_{i, i}$ by $M \mapsto M^{-1}$. To avoid trivial cases, we only need to consider $\operatorname{Rep}_{1,1}$ for $p>2$ and $\operatorname{Rep}_{1,1}, \operatorname{Rep}_{1,2}$ and $\operatorname{Rep}_{2,2}$ for $p=2$. Each of these sets has a description by double cosets:

$$
\begin{aligned}
& \operatorname{Rep}_{1,1} \cong \mathcal{D} \backslash G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right) / \mathcal{D} \\
& \operatorname{Rep}_{1,2} \cong \mathcal{Y} \backslash G L_{2}\left(\widehat{\mathbb{Z}}_{2}\right) / \mathcal{D} \\
& \operatorname{Rep}_{2,2} \cong \mathcal{Y} \backslash G L_{2}\left(\widehat{\mathbb{Z}}_{2}\right) / \mathcal{Y}
\end{aligned}
$$

where the subgroups $\mathcal{D}$ and $\mathcal{Y}$ are as defined in 3.1. We use the notation $\overline{\operatorname{Rep}}_{i, j}$ to denote the $\bmod p$ reductions of the representations in $\operatorname{Rep}_{i, j} .{ }^{*}$

Proposition 3.2 ([3]). The functions $\Gamma_{1,1}, \delta_{1}$ and $\delta_{2}$ defined on $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ by

$$
\begin{aligned}
\delta_{1}\left(\begin{array}{ll}
x & y \\
z & t
\end{array}\right) & =\nu_{p}(x z), \\
\delta_{2}\left(\begin{array}{ll}
x & y \\
z & t
\end{array}\right) & =\nu_{p}(y t), \\
\Gamma_{1,1}\left(\begin{array}{ll}
x & y \\
z & t
\end{array}\right) & =\frac{x t}{x t-y z} \in \widehat{\mathbb{Z}}_{p},
\end{aligned}
$$

are well defined in $\mathrm{Rep}_{1,1}$ and are a complete system of invariants. Using these invariants, $\operatorname{Rep}_{1,1}$ is tabulated in table 1.

Here and below, when we say that some functions form a complete system of invariants we mean that two matrices $M$ and $N$ are in the same double coset if and only if these functions take the same value in $M$ and $N$. One can check easily that the table 1 gives a complete set of representatives for Rep ${ }_{1,1}$ without repetition. One sees also that the range of the invariants $\Gamma_{1,1}, \delta_{1}, \delta_{2}$ is $\widehat{\mathbb{Z}}_{p} \times\{0, \ldots, \infty\}^{2}$, subject only to the restriction:

$$
\delta_{1}+\delta_{2}=\nu_{p}\left(\Gamma_{1,1}\right)+\nu_{p}\left(\Gamma_{1,1}-1\right)
$$

The non-trivial outer automorphism of $D_{\infty}$ leaves $\Gamma_{1,1}$ invariant. It also leaves $\delta_{1}$ and $\delta_{2}$ invariant in the types III to VI in the table and permutes $\delta_{1}$ and $\delta_{2}$ in the other types.

For $p=2$ it remains to describe $\operatorname{Rep}_{1,2}$ and $\operatorname{Rep}_{2,2}$.

[^1]Proposition 3.3 ([3]). The functions $\Gamma_{1,2}$ and $\delta_{3}$ defined on $G L_{2}\left(\widehat{\mathbb{Z}}_{2}\right)$ by

are well defined on $\operatorname{Rep}_{1,2}$ and are a complete system of invariants.

Proposition 3.4 ([3]). The functions $\Gamma_{2,2}, \varepsilon_{1}, \bar{\varepsilon}_{1}$ and $\varepsilon_{2}$ defined by

\end{array}\right)=\frac{x^{2}+t^{2}-y^{2}-z^{2}}{x t-y z} \in \widehat{\mathbb{Z}}_{2} \\

& \bar{\varepsilon}_{1}=\nu_{2}(x+z+y+t) \\
& \varepsilon_{2}=\min \left(\nu_{2}\left(x^{2}+z^{2}-y^{2}-t^{2}\right), \nu_{2}(x z-y t)\right)
\end{aligned}

form a complete system of invariants for $\operatorname{Rep}_{2,2}$.
Remark 4. Any coset $\left[\left(\begin{array}{c}x \\ z \\ z\end{array}\right)\right]$ of $\operatorname{Rep}_{2,2}$ has a representative of the form $\left(\begin{array}{ll}1 \\ 0 \\ 0 & v\end{array}\right)$ (cf. [3, Proposition 5]), but $u$ and $v$ are not uniquely determined.

## 4. Cohomology computations. I: General

Now, for any representation data $(\rho, c) \in \mathrm{R}^{*}$, we want to compute the mod $p$ cohomology of the associated space $X=\bar{\Phi}(\rho, c) \in \mathrm{S}^{*}$, including the action of the Steenrod algebra and the Bockstein spectral sequence. Since $X$ is defined as (the $\bmod p$ completion of) a push out

the obvious tool to compute the cohomology of $X$ is the Mayer-Vietoris long exact sequence associated to this push out diagram.

The first observation that we want to point out is that a knowledge of the matrix $M$ modulo some $p$-th power $p^{n}$ is enough to determine the structure of $H^{*}(X)$ up to level $n$, in the following sense.

Theorem 4.1. Assume that $p>2, n \geq 1$ or $p=2, n>1$. Let $M$ and $N$ be matrices such that $M=N \bmod p^{n}$. Then $H^{*}\left(X^{k, l}(M)\right)$ and $H^{*}\left(X^{k, l}(N)\right)$ are isomorphic as algebras. Moreover, this isomorphism respects the action of the Steenrod operations $\mathcal{P}^{i}\left(S q^{2 i}\right.$ if $\left.p=2\right)$ and the higher Bockstein homomorphisms $\beta_{(r)}$ of height $r<n$.

Proof. Let $A$ be the mod $p^{n}$ reduction of the matrices $M$ and $N$. Let $T(n)$ denote the abelian subgroup of the torus $T^{2}$ of elements of order smaller than or equal to $p^{n}$. Define the space $X(A)$ as the push out


It is easy to verify using the Mayer-Vietoris sequence that the natural map $X(A) \rightarrow X^{k, l}(M)$ induces a monomorphism in cohomology. We may investigate this map further as follows.

Let $I \subset H^{*}(B T(n))$ be the ideal consisting of nilpotent elements. It is clear from the definition that $I$ is a $H^{*}(X(A))$-submodule of $H^{*}(B T(n))$, where the $H^{*}(X(A))$-module structure on $H^{*}(B T(n))$ is given by restriction. Notice that $I$ is invariant under the Steenrod operations $\mathcal{P}^{i}\left(S q^{2 i}\right.$ if $\left.\mathrm{p}=2\right)$ and the higher Bockstein homomorphisms $\beta_{(r)}$ of height $r<n$. Let $J=\delta(I)$ be the image of $I$ under the boundary homomorphism $\delta: H^{*}(B T(n)) \rightarrow H^{*+1}(X(A))$ in the Mayer-Vietoris sequence. It follows from standard facts that $\delta$ is a map of $H^{*}(X(A))$-modules. Hence $J$ is an ideal in $H^{*}(X(A))$ invariant under the above operations.

Using the Mayer-Vietoris sequence, we see that the natural map $H^{*}\left(X^{k, l}(M)\right) \rightarrow H^{*}(X(A)) / J$ is an isomorphism of algebras which commutes with the action of the cohomology operations mentioned earlier. The same holds for the matrix $N$ and thus the proof is complete.

The computation of the cohomology of the spaces in $\mathrm{S}^{*}$ is done in the following two sections of this paper: the first deals with the prime 2 and the next deals with the odd primes.

## 5. Cohomology computations. II: The even prime case

Throughout this section we work at the prime $2,(\rho, c)$ will be an element in $\mathrm{R}^{*}$ and $X$ will denote the space $\bar{\Phi}(\rho, c) \in \mathrm{S}^{*}$. We choose a matrix $M=$ $\binom{\alpha \beta}{\lambda \mu} \in G L_{2}\left(\widehat{\mathbb{Z}}_{2}\right)$ and indices $k, l$ such that $X=X^{k, l}(M)$. We consider separately the cases of $\operatorname{Rep}_{1,1}, \operatorname{Rep}_{1,2}$ and $\operatorname{Rep}_{2,2}$ and we denote by $\Gamma_{1,1}, \Gamma_{1,2}$, $\Gamma_{2,2}, \delta_{1}, \delta_{2}, \delta_{3}, \epsilon_{1}, \bar{\epsilon}_{1}$ and $\epsilon_{2}$ the invariants defined in section 3.

### 5.1. Representations of type $\operatorname{Rep}_{1,1}$

According to table 1, these representations fall into five classes $\mathbf{I}$ to $\mathbf{V}$. (Notice that $\operatorname{Out}\left(D_{\infty}\right)$ identifies the classes II and II', and the class VI is void for $p=2$.) The obstruction class may take three different values: $c=(1,1)$, $c=(0,1)$ or $c=0$.

Theorem 5.1. If $W$ is of type $\operatorname{Rep}_{1,1}$ and $c=(1,1)$ then the cohomology algebra of $X$ and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 4.

Proof. The Mayer-Vietoris long exact sequence associated to the push out which defines $X$ has the form

$$
\begin{align*}
\cdots \longrightarrow H^{i}(X) \longrightarrow H^{i}\left(B S^{1} \times B S U(2)\right) \oplus H^{i}\left(B S^{1} \times B S U(2)\right) \xrightarrow{\bar{M}^{t}+j}  \tag{5.1}\\
\longrightarrow H^{i}\left(B T^{2}\right) \longrightarrow H^{i+1}(X) \longrightarrow \cdots
\end{align*}
$$

and it is a sequence of $H^{*}(X)$-modules. The map labelled $\bar{M}^{t}$ is induced by the transpose of the $\bmod 2$ reduction of the matrix $M$ and $j$ indicates the map induced by the inclusion of the standard maximal torus of $S^{1} \times S U(2)$.

For simplicity, we write $P_{0}=H^{*}\left(B T^{2}\right)=\mathbb{F}_{2}[u, v]$ and we identify $H^{*}\left(B S^{1}\right.$ $\times B S U(2))$, with its canonical image $\mathbb{F}_{2}\left[u, v^{2}\right]$ in $H^{*}\left(B T^{2}\right)$. In order to distinguish between the two components in the Mayer-Vietoris sequence (5.1), we will write $P_{1}=\mathbb{F}_{2}\left[\bar{u}, \bar{v}^{2}\right]$ for the first component and $P_{2}=\mathbb{F}_{2}\left[u, v^{2}\right]$ for the second one. Using this notation, and by degree reasons the sequence (5.1) becomes

$$
\begin{equation*}
0 \longrightarrow H^{\text {even }}(X) \longrightarrow P_{1} \oplus P_{2} \xrightarrow{\varphi} P_{0} \longrightarrow \Sigma^{-1} H^{\text {odd }}(X) \longrightarrow 0 \tag{5.2}
\end{equation*}
$$

with $\varphi=\bar{M}^{t}+j$. In particular, $H^{\text {even }}(X) \cong \operatorname{Ker} \varphi$ and $H^{\text {odd }}(X) \cong \Sigma \operatorname{Coker} \varphi$. We distinguish between two cases.

- Type I, II, or IV; that is $\beta \equiv 1 \bmod 2$ In this case $\varphi(\bar{u})=\alpha u+v$ and $\varphi\left(\bar{v}^{2}\right)=\lambda u^{2}+\mu v^{2}$, while $\varphi(u)=u$ and $\varphi\left(v^{2}\right)=v^{2}$, hence, the sequence (5.2) gives $H^{2}(X)=0$ and in degree 4 we get that $\mathbb{F}_{2}\left[\bar{u}^{2}+\alpha u^{2}+v^{2}, \bar{v}^{2}+\lambda u^{2}+\mu v^{2}\right] \subset$ $\operatorname{Ker} \varphi$. In particular, there are elements $x_{4}, y_{4} \in H^{*}\left(X ; \mathbb{F}_{2}\right)$ that project to $\bar{u}^{2}+\alpha u^{2}+v^{2}$ and $\bar{v}^{2}+\lambda u^{2}+\mu v^{2}$ respectively, thus $P\left[x_{4}, y_{4}\right]$ is a subalgebra of $H^{*}(X)$ and (5.2) might be seen as an exact sequence of $P\left[x_{4}, y_{4}\right]$-modules.

After dividing out by $P_{2}$ in $P_{1} \oplus P_{2}$ and in $P_{0}$, (5.2) is simplified to

$$
\begin{align*}
0 \longrightarrow \operatorname{Ker} \varphi \longrightarrow P\left[\bar{u}, \bar{v}^{2}\right] \xrightarrow{[\varphi]}[v] \mathbb{F}_{2}\left[u^{2}, v^{2}\right] \oplus[u v] \mathbb{F}_{2}\left[u^{2}, v^{2}\right] &  \tag{5.3}\\
& \longrightarrow \operatorname{Coker} \varphi \longrightarrow 0
\end{align*}
$$

where $[\varphi](\bar{u})=[\alpha u+v]=[v]$. It follows that $\operatorname{Ker} \varphi \cong P\left[x_{4}, y_{4}\right]$ and $\operatorname{Coker} \varphi \cong$ $[u v] P\left[u^{2}, v^{2}\right] \cong[u v] P\left[x_{4}, y_{4}\right]$.

Therefore, we have a splitting exact sequence of $P\left[x_{4}, y_{4}\right]$-modules

$$
\begin{equation*}
0 \longrightarrow \Sigma[u v] P\left[x_{4}, y_{4}\right] \longrightarrow H^{*}(X) \longrightarrow P\left[x_{4}, y_{4}\right] \longrightarrow 0 \tag{5.4}
\end{equation*}
$$

The action of the Steenrod squares on $u v$ is easily computed in $P_{0}=P[u, v]$ and it follows that the action on its class $[u v]$ in $[u v] P\left[u^{2}, v^{2}\right]$ is trivial. Now, if we call $z_{5}$ the image in $H^{*}(X)$ of the suspension of [uv], we have that the

Steenrod squares act trivially on $z_{5}$ and in particular that $z_{5}^{2}=S q^{5} z_{5}=0$, hence

$$
H^{*}(X) \cong \mathbb{F}_{2}\left[x_{4}, y_{4}\right] \otimes E\left(z_{5}\right)
$$

- Type III, or V; that is $\beta \equiv 0 \bmod 2$ In this case $\varphi(\bar{u})=\alpha u$ and we obtain a generator of $\operatorname{Ker} \varphi, \bar{u}+\alpha u$, in degree two. Also, as in the previous case $\bar{v}^{2}+\mu u^{2}+\lambda v^{2}$ is a generator in degree four of $\operatorname{Ker} \varphi$, and $\mathbb{F}_{2}\left[\bar{u}+\alpha u, \bar{v}^{2}+\mu u^{2}+\right.$ $\left.\lambda v^{2}\right] \subset \operatorname{Ker} \varphi$. Thus, we obtain now a subalgebra $P\left[x_{2}, y_{4}\right]$ of $H^{*}(X)$ and then (5.2) is an exact sequence of $P\left[x_{2}, y_{4}\right]$-modules. Now, the quotient by $P_{2}$ in (5.2) gives a new exact sequence

$$
\begin{equation*}
0 \longrightarrow \operatorname{Ker} \varphi \longrightarrow P\left[\bar{u}, \bar{v}^{2}\right] \xrightarrow{[\varphi]}[v] \mathbb{F}_{2}\left[u, v^{2}\right] \longrightarrow \operatorname{Coker} \varphi \longrightarrow 0 \tag{5.5}
\end{equation*}
$$

with $[\varphi]=0$, so that $\operatorname{Ker} \varphi \cong P\left[x_{2}, y_{4}\right]$ and $\operatorname{Coker} \varphi \cong[v] P\left[u, v^{2}\right] \cong$ $[v] P\left[x_{2}, y_{4}\right]$, as $P\left[x_{2}, y_{4}\right]$-modules. Again the Steenrod squares act trivially on the class $[v]$, so therefore if $z_{3}$ is the image in $H^{*}(X)$ of the suspension of [ $v$ ], we have

$$
H^{*}(X) \cong P\left[x_{2}, y_{4}\right] \otimes E\left(z_{3}\right)
$$

Finally, notice that $S q^{2}\left(y_{4}\right)=0$ in the quotient $P\left[x_{2}, y_{4}\right]$, and then, by degree reasons it is also trivial in $H^{*}(X)$. The action of all other Steenrod operations, besides $S q^{1}$, follows from the properties of the Steenrod squares, in a straightforward way.

Finally, it remains to compute, for all cases, the action of the higher Bockstein operations, including the primary Bockstein $\beta=S q^{1}$.

The argument uses the Mayer-Vietoris long exact sequence with coefficients in $\widehat{\mathbb{Z}}_{2}$

$$
\begin{align*}
& 0 \longrightarrow H^{\text {even }}\left(X ; \widehat{\mathbb{Z}}_{2}\right) \longrightarrow \widehat{\mathbb{Z}}_{2}\left[\bar{u}, \bar{v}^{2}\right] \oplus \widehat{\mathbb{Z}}_{2}\left[u, v^{2}\right] \xrightarrow{\varphi} \widehat{\mathbb{Z}}_{2}[u, v] \longrightarrow  \tag{5.6}\\
& \Sigma^{-1} H^{\text {odd }}\left(X ; \widehat{\mathbb{Z}}_{2}\right) \longrightarrow 0
\end{align*}
$$

in low dimensions. A first observation is that $\operatorname{Ker} \varphi$ is torsion free. Coker $\varphi$ is, in each degree, a finitely generated $\widehat{\mathbb{Z}}_{2}$-module that can be easily classified in terms of the homomorphism $\varphi$; that is, in terms of the matrix $M^{t}$. We obtain in degree $2 \operatorname{Coker} \varphi^{(2)} \cong \widehat{\mathbb{Z}}_{2} / \beta \widehat{\mathbb{Z}}_{2}$. Hence in case $\beta \equiv 0 \bmod 2$; that is, for types III, or IV, we have $H^{3}\left(X ; \widehat{\mathbb{Z}}_{2}\right) \cong \widehat{\mathbb{Z}}_{2} / \beta \widehat{\mathbb{Z}}_{2} \cong \widehat{\mathbb{Z}}_{2} / 2^{\nu_{2}(\beta)} \widehat{\mathbb{Z}}_{2}$. Notice that $\nu_{2}(\beta)$ coincides with the invariant $\delta_{1}$ in these cases (see Proposition 3.2), hence the result $\beta_{\left(\delta_{1}\right)}\left(x_{2}\right)=z_{3}$.

Finally, we compute the cokernel of $\varphi$ in degree four and we get

$$
\operatorname{Coker} \varphi^{(4)} \cong \widehat{\mathbb{Z}}_{2} / 2 \operatorname{gcd}(\alpha \beta, \lambda \mu) \cdot \widehat{\mathbb{Z}}_{2}
$$

Again, $\nu_{2}(\alpha \beta)=\delta_{1}$ and $\nu_{2}(\lambda \mu)=\delta_{2}$ (see Proposition 3.2), so, if we write $s=1+\min \left\{\delta_{1}, \delta_{2}\right\}$, then $H^{5}\left(X ; \widehat{\mathbb{Z}}_{2}\right) \cong \widehat{\mathbb{Z}}_{2} / 2^{s} \widehat{\mathbb{Z}}_{2}$.

We can choose generators such that $S q^{1} y_{4}=z_{5}$ in cases II and IV, and $\beta_{(s)} y_{4}=z_{5}, s \geq 2$, in case $\mathbf{I}$. In cases of type III, or $\mathbf{V}$ we already have
$\beta_{\left(\delta_{1}\right)} x_{2}=z_{3}$, hence $\beta_{(r)}\left(x_{2}^{2}\right)=0$ for $r \leq \delta_{1}$, and $\beta_{\left(\delta_{1}+1\right)}\left(x_{2}^{2}\right)=x_{2} z_{3}$, if these classes survive to the $\delta_{1}+1$ page of the Bockstein spectral sequence. We have then that $S q^{1} y_{4}=x_{2} z_{3}$ in case $\mathbf{V}$, and for case III, $s \geq 2$ and then $\beta_{(s)} x_{2}^{2}=x_{2} z_{3}$ if $\delta_{1}=\min \left\{\delta_{1}, \delta_{2}\right\}$ but $\beta_{(s)} y_{4}=x_{2} z_{3}$, otherwise.

All other calculations in this section use the same kind of arguments and we will omit the proofs. The interested reader will have no difficulty in completing the missing details.

Theorem 5.2. If $W$ is of type $\operatorname{Rep}_{1,1}$ and $c=(0,1)$ then the cohomology algebra of $X$ is

$$
H^{*}(X) \cong \mathbf{J}=\frac{P\left[z_{2}, z_{3}, z_{4}, z_{5}\right]}{\left(z_{5}^{2}+z_{3}^{2} z_{4}\right)}
$$

and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 5.

Notice that here we are using subscripts as in $\mathbf{J}_{i}$ to denote different Steenrod algebra actions on the same algebra $\mathbf{J}$.

Theorem 5.3. If $W$ is of type $\operatorname{Rep}_{1,1}$ and $c=0$ then the cohomology algebra of $X$ is

$$
H^{*}(X) \cong \mathbf{K}=P\left[w_{2}, w_{3}, \bar{w}_{2}, \bar{w}_{3}\right] /\left(w_{3} \bar{w}_{3}\right)
$$

and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 6 .

### 5.2. Representations of type $\operatorname{Rep}_{1,2}$

According to table 2, these representations fall into three classes I, II and III. The obstruction class $c$ may take two different values: $c=0$ or $c=1$.

Theorem 5.4. If $W$ is of type $\operatorname{Rep}_{1,2}$ and $c=1$ then the cohomology algebra of $X$ and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 7.

Theorem 5.5. If $W$ is of type $\operatorname{Rep}_{1,2}$ and $c=0$ then the cohomology algebra of $X$ is

$$
H^{*}(X) \cong \mathbf{L}=\frac{P\left[z_{2}, z_{3}, z_{4}, z_{5}\right]}{\left(z_{5}^{2}+z_{5} z_{3} z_{2}+z_{4} z_{3}^{2}\right)}
$$

and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 8.

### 5.3. Representations of type $\operatorname{Rep}_{2,2}$

Here we use the classification in types I and II of table 3. We obtain the following result.

Theorem 5.6. If $W$ is of type $\operatorname{Rep}_{2,2}$ then the cohomology algebra of $X$ and the action of the Steenrod algebra and the higher Bockstein operations are as described in table 9 .

## 6. Cohomology computations. III: The odd prime case

Throughout this section we work at a fixed odd prime $p$. We choose an element in $\mathrm{R}^{*}$ and we want to compute the $\bmod p$ cohomology of the space $X$ in $\mathrm{S}^{*}$ associated to that element in $\mathrm{R}^{*}$. As we saw in section 3, for an odd prime $p$, the elements in $\mathrm{R}^{*}$ are just conjugacy classes of infinite dihedral subgroups in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. Hence, we have such a subgroup which we denote by $W$ and which can be given either by a two by two matrix $M \in G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ or by three invariants $\Gamma=\Gamma_{1,1}, \delta_{1}, \delta_{2}$. The classification of these groups is summarized in table 1. We organize the statements in this section according to the six types of representations of the group $W$, labelled I to VI in table 1. Notice that we do not need to consider type II'. We denote by $X_{W}$ the space in $S^{*}$ which corresponds to the group $W$.

Let us point out that the invariants $\Gamma, \delta_{1}, \delta_{2}$ classify all representations of $D_{\infty}$, including those which are not faithful, while we are only interested in the spaces $X_{W}$ for $W$ of infinite order. The following result provides a partial answer to the question of which values of $\Gamma, \delta_{1}$ and $\delta_{2}$ yield Weyl groups of infinite order.

Proposition 6.1 ([3]). Let $\rho: D_{\infty} \rightarrow G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ (p odd) be a representation with invariants $\Gamma, \delta_{1}$ and $\delta_{2}$. Assume $\Gamma \equiv 0,1(p)$. Then $\rho\left(D_{\infty}\right)$ has finite order if and only if $\delta_{1}=\delta_{2}=\infty$ or $p=3$ and $\Gamma=3 / 4,1 / 4$.

This proposition implies that in the case in which $\delta_{1}+\delta_{2}>0$ (i.e. all types except type VI) we only have to eliminate the representations given by the matrices

$$

Let $L$ be the $p$-adic lattice of rank two with a $W$-action given by the inclusion of $W$ in $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$ and let us denote by $P$ the symmetric algebra on the $\mathbb{F}_{p}$-vector space $\operatorname{Hom}\left(L, \mathbb{F}_{p}\right) . P$ is thus a polynomial algebra on two generators $P=\mathbb{F}_{p}[u, v]$ which we grade by assigning degree two to the variables $u$ and $v . P$ inherits an action of the group $W$ and we are interested now in the subalgebra of invariant elements $P^{W}$. Notice that the action of $W$ on $P$ is dual to the representation of $W$ on $L$. Moreover, if we denote by $W_{p}$ the $\bmod p$ reduction of $W$ then the action of $W$ on $P$ factors through $W_{p}$. The group $W_{p}$ is finite dihedral and throughout this section we denote by $k$ the integer defined as

$$
k=\frac{\left|W_{p}\right|}{2} .
$$

Let us call $W$ exceptional if it belongs to types III or IV and let us call it ordinary otherwise.

We will use tools from the invariant theory of reflection groups. A very useful reference is the beautiful book [19].

Proposition 6.2. The ring of invariants of $W$ is a polynomial algebra on two generators, $P^{W} \cong \mathbb{F}_{p}[x, y]$, with $\operatorname{deg}(x) \operatorname{deg}(y)=8 k$. If $W$ is exceptional then $x$ has degree 2 and if $W$ is ordinary then $x$ has degree 4 .

Proof. Obviously, $P^{W}$ depends only on the group $W_{p}$ and we only need to study the $\bmod p$ reductions of the matrices in table 1, which are displayed in the column labelled $\overline{\operatorname{Rep}}_{1,1}$.

In the exceptional case we have the identity matrix and the matrices $A_{\lambda}=$ $\left(\begin{array}{ll}1 & 0 \\ \lambda & 1\end{array}\right)$. In the case of the identity matrix (i.e. type III), we have that $W_{p}$ has order two and is generated by the linear map which fixes $u$ and sends $v$ to $-v$. The invariants are $\mathbb{F}_{p}\left[u, v^{2}\right]$.

The representations corresponding to $A_{\lambda}$ are those of type IV. One sees easily that $W_{p}$ is conjugate to

$$
W_{p}=\left\langle\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right),\left(\begin{array}{cc}
1 & 0 \\
-1 & -1
\end{array}\right)\right\rangle .
$$

This dihedral group has order $2 p$ and its invariant theory is discussed in pages 128-129 of [19]. The invariants are polynomial in degrees 2 and $4 p$ namely $P^{W}=\mathbb{F}_{p}\left[t_{1},\left(t_{2} t_{1}^{p-1}-t_{2}^{p}\right)^{2}\right]$, if we denote by $t_{1}, t_{2}$ the new basis elements.

Let us discuss now the case in which $W$ is ordinary. Table 1 provides the matrices

$$
B=\left(\begin{array}{cc}
0 & 1 \\
1 & 0
\end{array}\right) ; \quad C_{\lambda}=\left(\begin{array}{ll}
1 & 1 \\
\lambda & 1
\end{array}\right), \lambda \neq 1 ; \quad D=\left(\begin{array}{ll}
1 & 1 \\
1 & 0
\end{array}\right) .
$$

The matrix $B$ produces type $\mathbf{I} . W_{p}$ is the representation of the elementary abelian 2 -group of order 4 by $t_{1} \mapsto \pm t_{1}, t_{2} \mapsto \pm t_{2}$. Then $P^{W}=\mathbb{F}_{p}\left[t_{1}^{2}, t_{2}^{2}\right]$.

The matrix $C_{0}$ gives the representation

$$
W_{p}=\left\langle\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right),\left(\begin{array}{cc}
1 & 2 \\
0 & -1
\end{array}\right)\right\rangle .
$$

This is again a dihedral group of order $2 p$ and this representation is also studied in pages 128-129 of [19]. The invariants are polynomial in degrees 4 and $2 p$, namely $P^{W}=\mathbb{F}_{p}\left[t_{2}^{2}, t_{1}\left(t_{1}^{p-1}-t_{2}^{p-1}\right)\right]$. This is type $\mathbf{V}$.

The matrix $D$ gives a group conjugate to

$$
W_{p}=\left\langle\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right),\left(\begin{array}{cc}
-1 & -2 \\
0 & 1
\end{array}\right)\right\rangle .
$$

It is a dihedral group of order $4 p$ and has a subgroup $H$ of index two which is of the type $C_{0}$ that we have just studied. Then $P^{H}=\mathbb{F}_{p}\left[x_{4}, y_{2 p}\right]$ and one sees that $W / H$ fixes $x$ and sends $y$ to $-y$. Then $P^{W}=\mathbb{F}_{p}\left[t_{2}^{2}, t_{1}^{2}\left(t_{1}^{p-1}-t_{2}^{p-1}\right)^{2}\right]$. This is type II.

Let us consider finally the case of the matrices $C_{\lambda}$ for $\lambda \neq 0,1$. This is type VI. $k$ is then the order of the matrix obtained multiplying the two generating reflections of $W_{p}$. This matrix is

$$
\tau=\frac{1}{1-\lambda}\left(\begin{array}{cc}
1+\lambda & 2 \\
2 \lambda & 1+\lambda
\end{array}\right) .
$$

The discriminant of the characteristic polynomial of this matrix does not vanish. Hence, $\tau$ diagonalizes over $\mathbb{F}_{p^{2}}$ and so the order of $\tau$ is a divisor of $p^{2}-1$. This implies that the order of $W_{p}$ is coprime to $p$ and, since $W_{p}$ is generated by reflections, the classical Shephard-Todd theorem ([19, 7.4.1]) implies that $P^{W}$ is a polynomial algebra. $\lambda t_{1}^{2}-t_{2}^{2}$ is an invariant of degree 4 and there are no invariants of degree 2 . Hence, $P^{W}=\mathbb{F}_{p}\left[x_{4}, y_{2 k}\right]$.

Along the proof of the previous proposition we have obtained a computation of the value of $k=\left|W_{p}\right| / 2$ :

Proposition 6.3. The value of $k$ is given by

- Type $\mathbf{I}: k=2$.
- Type II: $k=2 p$.
- Type III: $k=1$.
- Types IV and V: $k=p$.
- Type VI: $k$ is equal to the multiplicative order in $\mathbb{F}_{p^{2}}$ of the roots of the polynomial $X^{2}-2(2 \Gamma-1) X+1$.

We determine now the mod $p$ cohomology of the spaces $X_{W}$. As usual, we use subscripts to denote the degrees of the generators of an algebra and we denote by $E(x, y, \ldots)$ the exterior $\mathbb{F}_{p}$-algebra with generators $x, y, \ldots$

Theorem 6.1. Let $p$ be an odd prime and let $W$ be an infinite dihedral subgroup of $G L_{2}\left(\widehat{\mathbb{Z}}_{p}\right)$. Put $k=\left|W_{p}\right| / 2$. Then:
(1) $H^{\text {even }}\left(X_{W}\right)=H^{*}(B T)^{W}$.
(2) If $W$ is ordinary then $H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{4}, y_{2 k}\right] \otimes E\left(z_{2 k+1}\right)$.
(3) If $W$ is of type III then $H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{2}, y_{4}\right] \otimes E\left(z_{3}\right)$.
(4) If $W$ is of type $\boldsymbol{I} \boldsymbol{V}$ then $H^{\text {even }}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{2}, y_{4 p}\right]$ and we have

$$
H^{*}\left(X_{W}\right) \cong H^{\text {even }} \cdot 1 \oplus\left(\underset{i=0}{p-2} \frac{H^{\text {even }}}{x_{2} H^{\text {even }}} \cdot z_{4 i+3}\right) \oplus H^{\text {even }} \cdot z_{4 p-1}
$$

as an $H^{\text {even }}\left(X_{W}\right)$-module.
Proof. The proof uses the Mayer-Vietoris sequence of the push out dia$\operatorname{gram}\left(B H_{2}\right)_{p}^{\wedge} \leftarrow B T_{p}^{\wedge} \rightarrow\left(B H_{1}\right)_{p}^{\wedge}$ with $B H_{1}=B H_{2}=B S^{1} \times B S U(2)$. Notice that, since $p$ is odd, $H^{*}\left(B H_{i}\right) \cong H^{*}(B T)^{\left\langle\omega_{i}\right\rangle}$ for $i=1,2$, where $\omega_{1}, \omega_{2}$ are the generating reflections of $W$. For simplicity, let us write $P=H^{*}(B T)$, $H=H^{\text {odd }}\left(X_{W}\right)$. Then the even cohomology of $X_{W}$ coincides with the invariants of $P$ under the action of the Weyl group, while the odd cohomology is given by the exact sequence

$$
0 \rightarrow P^{W} \rightarrow P^{\omega_{1}} \oplus P^{\omega_{2}} \rightarrow P \rightarrow \Sigma^{-1} H \rightarrow 0
$$

Notice that this is an exact sequence of $P^{W}$-modules. The Poincaré series of $P^{W}$ can be deduced from the information provided by 6.2. Then, the above exact sequence gives the Poincaré series of $H^{\text {odd }}\left(X_{W}\right)$.

Assume first that $W$ is ordinary. Then one sees easily that the Poincaré series of $H$ is the same as the Poincaré series of the free $P^{W}$-module $z_{2 k+1} P^{W}$.

Let us prove that $H$ is indeed a free $P^{W}$-module. By [19, 6.1.1], it is enough to prove that $\operatorname{Tor}_{1}^{P^{W}}\left(\mathbb{F}_{p}, H\right)=0$. By [19, 6.7.11], the above exact sequence is a free resolution of $H$ as a $P^{W}$-module, hence

$$
\operatorname{Tor}_{1}^{P^{W}}\left(\mathbb{F}_{p}, H\right)=\frac{\operatorname{Ker}\left(\mathbb{F}_{p} \otimes_{P^{W}}\left(P^{\omega_{1}} \oplus P^{\omega_{2}}\right) \rightarrow \mathbb{F}_{p} \otimes_{P^{W}} P\right)}{\operatorname{Im}\left(\mathbb{F}_{p} \otimes_{P^{W}} P^{W} \rightarrow \mathbb{F}_{p} \otimes_{P^{W}}\left(P^{\omega_{1}} \oplus P^{\omega_{2}}\right)\right.}
$$

Now, since $p$ is odd, we can use the averaging map $x \mapsto\left(x+\omega_{i} \cdot x\right) / 2$ and we see that $\mathbb{F}_{p} \otimes_{P W} P^{\omega_{i}}=\left(\mathbb{F}_{p} \otimes_{P W} P\right)^{\omega_{i}}$ and the diagonal inclusion $P^{W} \rightarrow P^{\omega_{1}} \oplus P^{\omega_{2}}$ has a section. Hence, $\mathbb{F}_{p} \otimes_{P^{W}} P^{W} \rightarrow \mathbb{F}_{p} \otimes_{P^{W}}\left(P^{\omega_{1}} \oplus P^{\omega_{2}}\right)$ is a monomorphism and

$$
\operatorname{Ker}\left(\mathbb{F}_{p} \otimes_{P^{W}}\left(P^{\omega_{1}} \oplus P^{\omega_{2}}\right) \rightarrow \mathbb{F}_{p} \otimes_{P^{W}} P\right)=\left(\mathbb{F}_{p} \otimes_{P^{W}} P\right)^{W}
$$

If the order of $W_{p}$ is prime to $p$ then it is well known ([19, 7.5.2],) that $\mathbb{F}_{p} \otimes_{P W} P$ is the regular representation of $W_{p}$. Hence $\left(\mathbb{F}_{p} \otimes_{P^{W}} P\right)^{W}=\mathbb{F}_{p}$ and $\operatorname{Tor}_{1}^{P^{W}}\left(\mathbb{F}_{p}, H\right)$ $=0$.

If the order of $W_{p}$ is not prime to $p$ then $\mathbb{F}_{p} \otimes_{P W} P$ is not the regular representation ([19, p. 221]). When this happens, we have seen in the proof of 6.2 concrete descriptions of the invariants $P^{W}$. From these descriptions, it is not difficult to write down explicitly the coinvariants $\mathbb{F}_{p} \otimes_{P^{W}} P$ and see that there are no invariants of positive degree.

We have to consider now the case in which there is an invariant in degree 2, i.e. the case in which $W$ is exceptional. In this case, we have also seen in the proof of 6.2 concrete descriptions of the ring of invariants $P^{W}$. If $\delta_{1} \neq 0$ then it is very easy to compute the cokernel directly. If $\delta_{1}=0$ then the above proof breaks down because $H$ is not a free $P^{W}$-module anymore. However, one can also compute directly $H$ as a cokernel, at least as a $P^{W}$-module. We have $P^{W}=\mathbb{F}_{p}\left[u,\left(v u^{p-1}-v^{p}\right)^{2}\right]$ and we want to compute the cokernel $H$ of

$$
\varphi: \mathbb{F}_{p}\left[u, v^{2}\right] \oplus \mathbb{F}_{p}\left[u,(u+v)^{2}\right] \rightarrow \mathbb{F}_{p}[u, v]
$$

as a $P^{W}$-module. $\varphi$ is a linear map between free $P^{W}$-modules. We can take basis in the following way: $1, v^{2}, \ldots, v^{2 p-2}$ is a basis of $\mathbb{F}_{p}\left[u, v^{2}\right] ; 1,(u+$ $v)^{2}, \ldots,(u+v)^{2 p-2}$ is a basis of $\mathbb{F}_{p}\left[u,(u+v)^{2}\right]$ and $1, v, \ldots v^{2 p-1}$ is a basis of $\mathbb{F}_{p}[u, v]$. Then, if we study the matrix of $\varphi$ in these basis, we see easily that $z_{4 i+3}=\delta\left(v^{2 i+1}\right)$ for $i=0, \ldots, p-1$ generate $H$ as a $P^{W}$-module ( $\delta$ denotes the connecting homomorphism of the Mayer-Vietoris exact sequence). Also, we see that $u v^{2 i+1} \in \operatorname{Im} \varphi$ for $i=0, \ldots, p-2$. This gives an epimorphism

$$
\left({ }_{i=0}^{p-2} \frac{H^{\text {even }}}{x_{2} H^{\text {even }}} \cdot z_{4 i+3}\right) \oplus H^{\text {even }} \cdot z_{4 p-1} \rightarrow H
$$

Then, a computation of the Poincaré series which is left to the reader proves that this is an isomorphism.

The results of these last two propositions are displayed in the column "cohomology rings" of table 10 .

We want to compute now the action of the $\bmod p$ Steenrod powers on $H^{*}\left(X_{W}\right)$ and the differentials in the mod $p$ Bockstein spectral sequence. Since the even dimensional part of $H^{*}\left(X_{W}\right)$ coincides with the invariants of the mod $p$ Weyl group $W_{p}$, we only need to describe the values of the Steenrod powers on the odd dimensional generators. If $x$ and $y$ are in $H^{*}\left(X_{W}\right)$ the notation $\beta_{(r)}(x)=y$ means that $\beta_{(i)}(x)=0$ for $i<r$ (i.e. $x$ survives to the $E_{r}$-page of the Bockstein spectral sequence) while $\beta_{(r)}(x)=y+\operatorname{Im} \beta_{(r-1)}$. We consider each type I to VI separately.

- Type I. In this case

$$
H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{4}, y_{4}\right] \otimes E\left(z_{5}\right)
$$

The integral representation is given by a matrix $\left(\begin{array}{cc}p^{\delta_{1}} & 1 \\ 1 & \lambda\end{array}\right)$ with $\nu_{p}(\lambda)=\delta_{2}$ (cf. table 1). The integral cohomology of $B H_{1}$ and $B H_{2}$ is given by $\widehat{\mathbb{Z}}_{p}\left[p^{\delta_{1}} u+\right.$ $\left.v,(u+\lambda v)^{2}\right]$ and $\widehat{\mathbb{Z}}_{p}\left[u, v^{2}\right]$ respectively. As an integral lift of the class $z_{5}$ we can take the element $\delta(u v)$. Then, in a similar way as we did above, one sees that there are Bockstein relations $\beta_{\left(\delta_{1}\right)}\left(y_{4}\right)=z_{5}$ and $\beta_{\left(\delta_{2}\right)}\left(x_{4}\right)=z_{5}$. The action of the Steenrod powers on $z_{5}$ is given by the relation $\mathcal{P}^{1}\left(z_{5}\right)=\left(x_{4}^{\frac{p-1}{2}}+y_{4}^{\frac{p-1}{2}}\right) z_{5}$.

- Type II. We have

$$
H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{4}, y_{4 p}\right] \otimes E\left(z_{4 p+1}\right)
$$

The integral representation is given by a matrix $\left(\begin{array}{ll}1 & 1 \\ 1 & \lambda\end{array}\right)$ with $\lambda=\frac{\Gamma_{1,1}}{\Gamma_{1,1}-1}$ and $\nu_{p}(\lambda)=\delta_{2}($ cf. table 1$)$. The integral cohomology of $B H_{1}$ and $B H_{2}$ is given by $\left.\widehat{\mathbb{Z}}_{p}\left[u+v,(u+\lambda v)^{2}\right)\right]$ and $\widehat{\mathbb{Z}}_{p}\left[u, v^{2}\right]$ respectively. Then,
(a) Analyzing the map

$$
\varphi_{p}: \mathbb{F}_{p}\left[u, v^{2}\right] \oplus \mathbb{F}_{p}\left[u+v, u^{2}\right] \rightarrow \mathbb{F}_{p}[u, v]
$$

we observe that $P^{W}=\operatorname{Ker} \varphi_{p}=\mathbb{F}_{p}\left[u^{2}, v^{2}\left(u^{p-1}-v^{p-1}\right)^{2}\right]$, furthermore, in degrees $4 p$ and $2(3 p-1)$ we see that $u v^{2 p-1} \notin \operatorname{Im} \varphi_{p}$ while $2 u^{p} v^{2 p-1}-u v^{3 p-2} \in$ $\operatorname{Im} \varphi_{p}$.
(b) Analyzing the map

$$
\varphi_{p^{2}}: \mathbb{Z} / p^{2}\left[u, v^{2}\right] \oplus \mathbb{Z} / p^{2}\left[u+v, u^{2}\right] \rightarrow \mathbb{Z} / p^{2}[u, v]
$$

in degree $4 p$ (notice that $\lambda^{2} \equiv 0\left(p^{2}\right)$ ) we see that $p u v^{2 p-1} \in \operatorname{Im} \varphi_{p^{2}}$, except for the case in which $p=3$ and $\lambda \equiv 3(9)$.

From these facts, we can conclude that we can take as generator $z_{4 p+1}$ any non trivial multiple of $\delta\left(u v^{2 p-1}\right)$. Also, $z_{4 p+1}$ has to be in the image of a primary Bockstein (except for $p=3$ and $\lambda \equiv 3(9)$ ) and we can define $z_{4 p+1}=\beta\left(y_{4 p}\right)$. The identity $\mathcal{P}^{1}\left(u v^{2 p-1}\right)=u^{p} v^{2 p-1}-u v^{3 p-2}$ shows that $\mathcal{P}^{1}\left(z_{4 p+1}\right)=-x^{(p-1) / 2} z$ and the Adem relation $\mathcal{P}^{1} \beta \mathcal{P}^{p-1}=-\beta \mathcal{P}^{p}+\mathcal{P}^{p} \beta$ determines the value of $\mathcal{P}^{p}\left(z_{4 p+1}\right)$. The exceptional case in which $p=3$ and
$\lambda \equiv 3(9)$ can be investigated directly. We obtain that there is a Bockstein of order two joining $y_{12}$ and $z_{13}$ and also $\mathcal{P}^{3}\left(z_{13}\right)=\left(y_{12}+x_{4}^{3}\right) z_{13}$. The description of $H^{*}\left(X_{W}\right)$ is then complete.

- Type III. In this case

$$
H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{2}, y_{4}\right] \otimes E\left(z_{3}\right)
$$

The integral representation is given by a matrix $\left(\begin{array}{cc}1 & p^{\delta_{2}} \\ \lambda & 1\end{array}\right)$ with $\nu_{p}(\lambda)=\delta_{1}$ (cf. table 1). The integral cohomology of $B H_{1}$ and $B H_{2}$ is given by $\widehat{\mathbb{Z}}_{p}[u+$ $\left.p^{\delta_{2}} v,(\lambda u+v)^{2}\right]$ and $\widehat{\mathbb{Z}}_{p}\left[u, v^{2}\right]$ respectively. As an integral lift of the class $z_{3}$ we can take the element $\delta(v)$. Then, notice that $p^{\delta_{2}} v \in \operatorname{Im}\left\{P^{\omega_{1}} \oplus P^{\omega_{2}} \rightarrow P\right\}$. This produces a relation $\beta_{\left(\delta_{2}\right)}\left(x_{2}\right)=z_{3}$. On the other side, one sees that $p^{\delta_{1}} u v \in \operatorname{Im}\left\{P^{\omega_{1}} \oplus P^{\omega_{2}} \rightarrow P\right\}$ and so there is a relation $\beta_{\left(\delta_{1}\right)}\left(y_{4}\right)=x_{2} z_{3}$.

The action of the Steenrod powers on $z_{3}$ is given by the relation $\mathcal{P}^{1}\left(z_{3}\right)=$ $y_{4}^{\frac{p-1}{2}} z_{3}$. This follows from $z_{3}=\delta(v)$ and the fact that the Steenrod powers commute with the connecting homomorphism.

- Type IV. We will not compute the action of the Steenrod algebra nor the Bockstein spectral sequence for the spaces of this (quite weird) type.
- Type V. This case is quite similar to the case in type II. We have

$$
H^{*}\left(X_{W}\right) \cong \mathbb{F}_{p}\left[x_{4}, y_{2 p}\right] \otimes E\left(z_{2 p+1}\right)
$$

The integral representation is given by a matrix $\left(\begin{array}{ll}1 & 1 \\ \lambda & 1\end{array}\right)$ with $\lambda=\frac{\Gamma_{1,1}-1}{\Gamma_{1,1}}$ and $\nu_{p}(\lambda)=\delta_{1}($ cf. table 1$)$. The integral cohomology of $B H_{1}$ and $B H_{2}$ is given by $\left.\widehat{\mathbb{Z}}_{p}\left[u+v,(\lambda u+v)^{2}\right)\right]$ and $\widehat{\mathbb{Z}}_{p}\left[u, v^{2}\right]$ respectively. We leave as an exercise to the reader to check that the following holds:
(a) Analyzing the map

$$
\varphi_{p}: \mathbb{F}_{p}\left[u, v^{2}\right] \oplus \mathbb{F}_{p}\left[u+v, v^{2}\right] \rightarrow \mathbb{F}_{p}[u, v]
$$

in degrees $2 p$ and $2(2 p-1)$ we see that $u^{p-1} v \notin \operatorname{Im} \varphi_{p}$ while $u^{p-1} v^{p}-u^{2 p-2} v \in$ $\operatorname{Im} \varphi_{p}$.
(b) Analyzing the map

$$
\varphi_{p^{2}}: \mathbb{Z} / p^{2}\left[u, v^{2}\right] \oplus \mathbb{Z} / p^{2}\left[u+v, v^{2}\right] \rightarrow \mathbb{Z} / p^{2}[u, v]
$$

in degree $2 p$ (notice that $\lambda^{2} \equiv 0\left(p^{2}\right)$ ) we see that $p u^{p-1} v \in \operatorname{Im} \varphi_{p^{2}}$, except for the case in which $p=3$ and $\lambda \equiv 6(9)$.

From these facts, we can conclude that we can take as generator $z_{2 p+1}$ any non trivial multiple of $\delta\left(u^{p-1} v\right)$. Also, $z_{2 p+1}$ has to be in the image of a primary Bockstein (except for $p=3$ and $\lambda \equiv 6(9))$ and we can define $z_{2 p+1}=\beta\left(y_{2 p}\right)$. The identity $\mathcal{P}^{1}\left(u^{p-1} v\right)=u^{p-1} v^{p}-u^{2 p-2} v$ shows that $\mathcal{P}^{1}\left(z_{2 p+1}\right)=0$ and the Adem relation $\mathcal{P}^{1} \beta \mathcal{P}^{p-1}=-\beta \mathcal{P}^{p}+\mathcal{P}^{p} \beta$ yields $\mathcal{P}^{p}\left(z_{2 p+1}\right)=x_{4}^{p(p-1) / 2} z_{2 p+1}$.

The exceptional case in which $p=3$ and $\lambda \equiv 6(9)$ can be investigated directly. We obtain that there is a Bockstein of order two joining $y_{6}$ and $z_{7}$ and also $\mathcal{P}^{3}\left(z_{7}\right)=x_{4}^{3} z_{7}$.

In this way we have a complete description of the algebra $H^{*}\left(X_{W}\right)$, including the Steenrod operations and the Bockstein spectral sequence.

- Type VI. First of all, there is a Bockstein of height $r$ which connects $y_{2 k}$ and $z_{2 k+1}$ where the integer $r$ is given by the following lemma:

Lemma 6.1. The integer $r$ such that $\beta_{(r)}\left(y_{2 k}\right)=z_{2 k+1}$ is given by

- $r$ is such that $\left|W_{p}\right|=\left|W_{p^{2}}\right|=\cdots=\left|W_{p^{r}}\right|<\left|W_{p^{r+1}}\right|$.
- Let $\left(\lambda_{n}\right)$ be the sequence defined recursively by $\lambda_{0}=0, \lambda_{1}=1$,

$$
\begin{aligned}
\lambda_{2 n} & =\lambda_{2 n-1}-\lambda_{2 n-2} \\
\lambda_{2 n+1} & =4 \Gamma \lambda_{2 n}-\lambda_{2 n-1}
\end{aligned}
$$

Then $r$ is the $p$-adic valuation of $\lambda_{k}$ and $\lambda_{i}$ is prime to $p$ for $i<k$.
Proof. To prove the second part of the lemma, notice that the order of the finite dihedral group $W_{p^{r}}$ is equal to twice the order in $G L_{2}\left(\mathbb{Z} / p^{r} \mathbb{Z}\right)$ of the matrix

$$
\tau=\left(\begin{array}{cc}
2 \Gamma-1 & 2 \Gamma \\
2 \Gamma-2 & 2 \Gamma-1
\end{array}\right)
$$

which is the product of the two generating reflections of $W$. In particular, $k$ is the smallest integer such that $\tau^{k} \equiv I(p)$ and $r$ is the largest integer such that $\tau^{k} \equiv I\left(p^{r}\right)$. The linear transformation

$$
\left(\begin{array}{cc}
0 & 1 \\
1 / 2 \Gamma & -1
\end{array}\right)
$$

transforms $\tau$ into the matrix $A$ associated to the iterative system which produces the sequence $\left\{\lambda_{i}\right\}$ defined above. Then, an easy induction proof shows that

$$
A^{j}=\left(\begin{array}{cc}
\lambda_{2 j+1} & -4 \Gamma \lambda_{2 j} \\
\lambda_{2 j} & -\lambda_{2 j-1}
\end{array}\right)
$$

If $A^{j} \equiv I\left(p^{n}\right)$, then $\lambda_{2 j} \equiv 0\left(p^{n}\right)$ and $\lambda_{2 j-1} \equiv-1\left(p^{n}\right)$. Consider the sequence $\lambda_{0}, \lambda_{1}, \ldots, \lambda_{2 j-1}, \lambda_{2 j}$. If we compute the value of the central term $\lambda_{j}$ starting from both extremes of the sequence, we obtain $\lambda_{j} \equiv-\lambda_{j}\left(p^{n}\right)$ and so $\lambda_{j} \equiv 0\left(p^{n}\right)$.

Conversely, if $\lambda_{i} \equiv 0\left(p^{n}\right)$ and $i$ is odd, $i=2 j+1$, then

$$
A^{j} \equiv\left(\begin{array}{cc}
0 & -4 \Gamma \lambda_{2 j} \\
\lambda_{2 j} & -4 \Gamma \lambda_{2 j}
\end{array}\right)
$$

Since $A$ has determinant equal to one, we obtain $4 \Gamma \lambda_{2 j}^{2} \equiv 1\left(p^{n}\right)$. Then, a computation shows that $A^{i} \equiv I\left(p^{n}\right)$. If $i$ is even, $i=2 j$, then we have

$$
A^{j} \equiv\left(\begin{array}{cc}
\lambda_{2 j+1} & 0 \\
0 & \lambda_{2 j+1}
\end{array}\right)
$$

with $\lambda_{2 j+1} \equiv \pm 1\left(p^{n}\right)$, so $A^{2 j} \equiv I\left(p^{n}\right)$.
From this relationship between the order of the matrix $A$ and the $p$-adic valuation of the elements in the sequence $\left\{\lambda_{i}\right\}$ the second part of the proposition follows easily.

While we have been obtaining all the results in this paper in a pure algebraic and homotopy theoretic way, the proof of the first part of the proposition will be done using the geometric structure of the Kac-Moody groups. Let $M$ be a matrix which yields the space $X_{W}$. According to proposition 4.1, the cohomology algebra of $X_{W}$ and the Bockstein spectral sequence will not change if we choose any other matrix $M^{\prime} \equiv M\left(p^{N}\right)$, for some large $N$. The matrix $M$ is characterized by its invariant $\Gamma_{1,1}$ which is any $p$-adic integer $\not \equiv 0,1(p)$. On the other side, if we start with a Kac-Moody group $K(a, b)$, we obtain a space of the form $X\left(M^{\prime}\right)$ where $M^{\prime}$ has invariant $\Gamma_{1,1}=a b / 4$ (see proposition 7.1). This shows that it is possible to find values of $a$ and $b$ such that the Kac-Moody group $K=K(a, b)$ has the property that $B K_{p}^{\wedge} \simeq X\left(M^{\prime}\right)$ with $M^{\prime} \equiv M\left(p^{N}\right)$ for some large $N$. Hence, the action of the higher Bockstein operations on $X_{W}$ should be the same as the action on $B K$. This action was computed by Kitchloo ([16]), using the geometric structure of the homogeneous space $K / T_{K}$ (i.e. the Schubert calculus) and it agrees with the values given in this proposition.

Using what we have seen in the proof of the above proposition, we can produce now concrete descriptions of the generators $x_{4}, y_{2 k} \in H^{*}\left(X_{W}\right)$ in terms of the generators $u, v \in H^{2}(B T)$. Let $\left\{\lambda_{i}\right\}$ denote the sequence defined recursively in the previous proposition. Then we can choose

$$
\begin{aligned}
x_{4} & =u^{2}-4 \Gamma u v+4 \Gamma v^{2} \\
y_{2 k} & =\prod_{j=1}^{k}\left(\lambda_{2 j} u-\lambda_{2 j-1} v\right)
\end{aligned}
$$

and this allows us, in principle, to compute the action of the Steenrod algebra on the even dimensional part of $H^{*}\left(X_{W}\right)$.

Let us see now how we can compute the action of the Steenrod powers on the odd dimensional generator $z_{2 k+1}$. If we write $H=H^{\text {odd }}\left(X_{W}\right)$, then $H=z_{2 k+1} P^{W}$ and the Steenrod algebra action can be described by means of the Mayer-Vietoris exact sequence (see Theorem 6.1)

$$
0 \rightarrow P^{W} \rightarrow P^{\omega_{1}} \oplus P^{\omega_{2}} \rightarrow P \rightarrow \Sigma^{-1} H \rightarrow 0
$$

thus, the action of the Steenrod algebra on the class $z_{2 k+1}$ is determined if we are able to obtain a representative $J \in P$ for this class. We will show that the jacobian

$$
J=\operatorname{det}\left(\begin{array}{cc}
\frac{\partial x_{4}}{\partial u} & \frac{\partial x_{4}}{\partial v} \\
\frac{\partial y_{2 k}}{\partial u} & \frac{\partial y_{2 k}}{\partial v}
\end{array}\right)
$$

is a representative for $z_{2 k+1}$. This is a non trivial element of $P$, relative invariant to the determinant; that is, for any $g \in W_{p}, g(J)=\operatorname{det}(g) \cdot J$. This implies that
$J$, does not belong to the image of $P^{\omega_{1}} \oplus P^{\omega_{2}} \rightarrow P$. Assume otherwise that $J$ can be written as $J=p_{1}+p_{2}$, with $p_{1}$ invariant by $w_{1}$ and $p_{2}$ invariant by $w_{2}$. Apply $w_{1}$ to the equality $J=p_{1}+p_{2}$ and combine to get $2 J=p_{2}-w_{1} p_{2}$. Now apply $w_{2}:-2 J=p_{2}-\left(w_{2} w_{1}\right) p_{2}$. Observe that $J$ is invariant by $w_{2} w_{1}$, and therefore we can obtain, inductively $-2 n J=p_{2}-\left(w_{2} w_{1}\right)^{n} p_{2}$. Hence $-2 k J=0$, and since $k$ is coprime to $p$, this contradicts the fact that $J \neq 0$.

We have shown that $J$ represents a non trivial element in $H$. It has to be $z_{2 k+1}$, up to a unit of $\mathbb{F}_{p}$, by degree reasons.

Remark 5. Notice that $z_{2 k+1} P^{W} \cong H$ is a Thom module in the sense of [6]. For any linear character $\chi: W \rightarrow \mathbb{F}_{p}^{*}$, the relative invariants

$$
P_{\chi}^{W}=\{x \in P \mid w(x)=\chi(w) x\}
$$

form a Thom module over $P^{W}$; that is, a $P^{W}-\mathcal{U}$-module which is free of rank one as $P^{W}$-module [6]. The relative invariants of any non modular pseudoreflection group with respect to the determinant are computed in [19, p. 227] (notice that in our case we have det $\left.=\operatorname{det}^{-1}\right): P_{\operatorname{det}^{-1}}^{W}=J \cdot P^{W}$, where $J=\operatorname{det} \frac{\partial f_{i}}{\partial t_{j}}$, if we have $P^{W}=\mathbb{F}_{p}\left[f_{1}, \ldots, f_{d}\right]$. With this notation, the above argument shows that the composition $P_{\text {det }}^{W} \subset P \rightarrow \Sigma^{-1} H$ is an isomorphism of Thom modules.

## 7. Back to Kac-Moody groups

In section 2 we have included the family of the $p$-completions of the classifying spaces of the central quotients of the rank two Kac-Moody groups in a larger family which we called $S^{*}$. In section 3, we have seen how the spaces in $S^{*}$ are parametrized by a set $R^{*}$ which is closely related to the representations of the infinite dihedral group. Then, in the next sections, we have computed the cohomology of all spaces in $S^{*}$, as a function of the corresponding representations. In this final section we go back to Kac-Moody groups and we will describe, for each space of the form $B(K / F)$, its parameters as an element of $S^{*}$ or $R^{*}$ and so we will obtain in this way a complete description of the cohomology of the classifying spaces of the central quotients of the rank two Kac-Moody groups.

We start with a lemma which identifies some central quotients of compact Lie groups of rank two.

Lemma 7.1. We have the following Lie group isomorphisms:
(1) $\left(\begin{array}{cc}p^{m} & 0 \\ 0 & p^{n}\end{array}\right): \frac{T}{\left\langle\left(e^{2 \pi i / p^{m}}, 1\right),\left(1, e^{2 \pi i / p^{n}}\right)\right\rangle} \xlongequal{\cong} T$.
(2) $\left(\begin{array}{cc}p^{m} & -1 \\ 0 & 1\end{array}\right): \frac{T}{\left\langle\left(e^{2 \pi i / p^{m}}, e^{2 \pi i / p^{m}}\right)\right\rangle} \cong$.
(3) $\left(\begin{array}{cc}2^{m-1} & 1 \\ 2^{m-1} & -1\end{array}\right): \frac{S^{1} \times S U(2)}{\left\langle\left(e^{2 \pi i / 2^{m}},-I\right)\right\rangle} \cong U(2)$.
(4) $\left(\begin{array}{cc}2^{m-1} & 2^{m-1} \\ 1 & -1\end{array}\right): \frac{U(2)}{\left\langle e^{2 \pi i / 2^{m}} I\right\rangle} \stackrel{ }{\leftrightharpoons} S^{1} \times S O(3)$.

(5) $\left(\begin{array}{cc}2^{m} & 0 \\ 0 & 2\end{array}\right): \frac{S^{1} \times S U(2)}{\left\langle\left(e^{2 \pi i / 2^{m}}, 1\right),(1,-I)\right\rangle} \stackrel{ }{\leftrightharpoons} S^{1} \times S O(3)$.

Proof. Of course, the matrices that appear in the lemma represent the linear maps induced by each isomorphism on the Lie algebra of the maximal torus. The isomorphisms in (1), (2) and (5) are obvious and we only need to discuss (3) and (4).

Notice that if $A$ is a matrix in $U(2)$ then $A / \sqrt{\operatorname{det} A}$ has an indeterminacy in $S U(2)$ but it is well defined in $S O(3)=S U(2) / \pm I$. This fact allows us to define an epimorphism $\varphi: U(2) \rightarrow S^{1} \times S O(3)$ by $A \mapsto\left(\operatorname{det} A^{2^{m-1}}, A / \sqrt{\operatorname{det} A}\right)$. The kernel of $\varphi$ is a central subgroup in $U(2)$ generated by $e^{2 \pi i / 2^{m}} I$ and one can easily check that $\varphi$ is given, on the maximal torus level, by the matrix $\left(\begin{array}{cc}2^{m-1} & 2^{m-1} \\ 1 & -1\end{array}\right)$. This proves claim (4) in the lemma.

We also have an epimorphism $\psi: S^{1} \times S U(2) \rightarrow U(2)$ given by $(\lambda, A) \mapsto$ $\lambda^{2^{m-1}} A$, which describes $U(2)$ as a quotient of $S^{1} \times S U(2)$ by the central subgroup of $S^{1} \times S U(2)$ generated by $\left(e^{2 \pi i / 2^{m}},-I\right)$. Again, on the maximal torus level, one sees easily that $\psi$ is given by $\left(\begin{array}{cc}2^{m-1} & 1 \\ 2^{m-1} & -1\end{array}\right)$ and we have proven claim (3) in the lemma.

We can now represent the classifying spaces of the central quotients of $K$ as spaces of the form $X^{k, l}(M)$. We do first the case of an odd prime.

Proposition 7.1. Let p be an odd prime and $0 \leq m \leq \nu_{p}(a b-4)$. Write $P_{p^{0}} K=K$. We have

$$
B P_{p^{m}} K_{p}^{\wedge} \simeq X\left(\begin{array}{cc}
b / 2 & p^{m} \\
(4-a b) / 4 p^{m} & -a / 2
\end{array}\right) .
$$

Proof. The case $m=0$ is trivial. For $m>0$ we have

$$
B\left(\left(S^{1} \times S U(2)\right) / M F\right)_{p}^{\wedge} \stackrel{M}{\longleftarrow}(B T / F)_{p}^{\wedge} \xrightarrow{\mathrm{id}} B\left(\left(S^{1} \times S U(2)\right) / F\right)_{p}^{\wedge}
$$

where $M=\left(\begin{array}{cc}b / 2 & 1 \\ (4-a b) / 4 & -a / 2\end{array}\right)$ and $F$ is the cyclic subgroup of $T$ generated by $\left(e^{2 \pi i / p^{m}}, 1\right)$. Since $p^{m}$ divides $4-a b$, we see that $M F$ is the cyclic subgroup of $T$ generated by $\left(e^{2 \pi i / p^{m}}, 1\right)$. Now the diagram above is equivalent to the diagram for $X(N)$ for

$$
N=\left(\begin{array}{cc}
p^{m} & 0 \\
0 & 1
\end{array}\right) M\left(\begin{array}{cc}
1 / p^{m} & 0 \\
0 & 1
\end{array}\right)=\left(\begin{array}{cc}
b / 2 & p^{m} \\
(4-a b) / 4 p^{m} & -a / 2
\end{array}\right) .
$$

From the above description we can immediately recover the representation associated to the space $B P_{p^{m}} K(a, b)_{p}^{\wedge}$ as the one given by the invariants

$$
\Gamma_{1,1}=\frac{a b}{4}, \quad \delta_{1}=\nu_{p}(4-a b)+\nu_{p}(b)-m, \quad \delta_{2}=\nu_{p}(a)+m .
$$

In particular, this shows that, for $p$ odd, any representation of $D_{\infty}$ whose invariants are such that $4<4 \Gamma_{1,1} \in \mathbb{Z}$ and $\delta_{1}+\delta_{2}<\infty$ appears as a space of the form $B P_{p^{m}} K(a, b)_{p}^{\wedge}$ for some $a, b, m$.

Let us consider now the case of the even prime. This case is more involved since we have to take into account the parities of $a$ and $b$. Moreover, in some cases there are central 2-subgroups which are not cyclic. Let us distinguish three cases.

- $a \equiv b \equiv 1(\bmod 2)$. In this case, there are no central 2-subgroups and we only need to consider the case of the simply connected group $K$. We have

$$
B K_{2}^{\wedge} \simeq X^{2,2}\left(\begin{array}{ll}
\frac{(1-a)(1+b)}{4}+1 & \frac{(1-a)(b-1)}{4}+1 \\
\frac{(1+a)(1+b)}{4}-1 & \frac{(1+a)(b-1)}{4}-1
\end{array}\right) .
$$

- $a \equiv 0 b \equiv 1(\bmod 2)$. In this case, for each $m$ such that $2^{m}$ divides $a b-4$ there is only one central subgroup of $K$ of order $2^{m}$ and it is cyclic. To simplify the notation, let us write $a=2 a^{\prime}, b=2 b^{\prime}+1$. Then we have

$$
B K_{2}^{\wedge} \simeq X^{0,2}\left(\begin{array}{cc}
1+b^{\prime} & b^{\prime} \\
1-a^{\prime}-a^{\prime} b^{\prime} & 1-a^{\prime} b^{\prime}
\end{array}\right)
$$

The matrices corresponding to the groups $P_{2^{m}} K$ are given by:
Proposition 7.2. Let $a=2 a^{\prime}, b=2 b^{\prime}+1$. Then

$$
B P_{2^{m}} K_{2}^{\wedge} \simeq\left\{\begin{array}{l}
X^{0,1}\left(\begin{array}{cc}
b & 2^{m-1} \\
\frac{4-a b}{2^{m+1}} & -\frac{a^{\prime}}{2}
\end{array}\right) \quad 0<m<\nu_{2}(a b-4) \\
X^{1,2}\left(\begin{array}{cc}
\frac{a^{\prime}}{2}+2^{m-2} & \frac{a^{\prime}}{2}-2^{m-2} \\
\frac{4-a b}{2^{m+1}}-\frac{b}{2} & \frac{4-a b}{2^{m+1}}+\frac{b}{2}
\end{array}\right) \quad m=\nu_{2}(a b-4) .
\end{array}\right.
$$

Proof. Notice that the matrices above are in $G L_{2}\left(\widehat{\mathbb{Z}}_{2}\right)$ because $\nu_{2}(a b-4)=$ 1 when $a^{\prime}$ is odd. Let us recall that $B K$ is a push out

$$
B\left(S^{1} \times S U(2)\right) \stackrel{M}{\longleftrightarrow} B T \xrightarrow{\mathrm{id}} B U(2)
$$

with $M=\left(\begin{array}{cc}1+b^{\prime} & b^{\prime} \\ 1-a^{\prime}-a^{\prime} b^{\prime} & 1-a^{\prime} b^{\prime}\end{array}\right)$ and we have to divide out by a central cyclic subgroup $F$ of order $2^{m}$. This subgroup will be generated by the element $\left(e^{2 \pi i / 2^{m}}, e^{2 \pi i / 2^{m}}\right)$ in $T$ and $U(2)$. To compute the image of this element in $S^{1} \times S U(2)$ we need to apply the matrix $M$ to the vector $\left(1 / 2^{m}, 1 / 2^{m}\right)$. We get $\left(b / 2^{m},(4-a b) / 2^{m+1}\right)$ and two possibilities arise. If $m<\nu_{2}(a b-4)$ then $(4-a b) / 2^{m+1}$ is an integer and the image of $F$ by $M$ is the subgroup generated by $\left(e^{2 \pi i / 2^{m}}, 1\right)$ in $S^{1} \times S U(2)$. If $m=\nu_{2}(a b-4)$ then $(4-a b) / 2^{m+1}$ is half an integer and so the image of $F$ by $M$ is generated by $\left(e^{2 \pi i / 2^{m}},-I\right)$ in $S^{1} \times S U(2)$. In either case, we have to transform a diagram
in a diagram like the one used to define the spaces $X^{k, l}(N)$ for some $k, l$ and $N$. Apply the isomorphisms of lemma 7.1. We see that the right hand side of the diagram (*) is equivalent to $A: T \rightarrow S^{1} \times S O(3)$ with

$$
A=\left(\begin{array}{cc}
2^{m-1} & 2^{m-1} \\
1 & -1
\end{array}\right)\left(\begin{array}{cc}
1 / 2^{m} & 1 / 2^{m} \\
0 & 1
\end{array}\right)
$$

If $m<\nu_{2}(a b-4)$ then the left hand side of $(*)$ is equivalent to $B: T \rightarrow$ $S^{1} \times S U(2)$ with

$$
B=\left(\begin{array}{cc}
2^{m} & 0 \\
0 & 1
\end{array}\right)\left(\begin{array}{cc}
1+b^{\prime} & b^{\prime} \\
1-a^{\prime}-a^{\prime} b^{\prime} & 1-a^{\prime} b^{\prime}
\end{array}\right)\left(\begin{array}{cc}
1 / 2^{m} & 1 / 2^{m} \\
0 & 1
\end{array}\right)
$$

If $m=\nu_{2}(a b-4)$ then the left hand side of $(*)$ is isomorphic to $U(2)$. In either case, we can easily check the matrices in the proposition.

- $a \equiv b \equiv 0(\bmod 2)$. In this case we need to take into account the various groups $P_{2^{m}}^{L} K, P_{2}^{R} K, P_{2^{m}}^{D} K$ and $P_{2^{m+1}}^{N} K$ for $0<m \leq \nu_{2}((a b-4) / 2)$. Put $a=2 a^{\prime}, b=2 b^{\prime}$. One checks immediately that

$$
B K_{2}^{\wedge} \simeq X^{0,0}\left(\begin{array}{cc}
b^{\prime} & 1 \\
1-a^{\prime} b^{\prime} & -a^{\prime}
\end{array}\right)
$$

Proposition 7.3. Let $a=2 a^{\prime}, b=2 b^{\prime}$ and let $0<m \leq \nu_{2}((a b-4) / 2)$. Then

1. If $b^{\prime}$ is even then $m=1$ and

$$
B P_{2}^{L} K \simeq X^{0,1}\left(\begin{array}{cc}
2 a^{\prime} & 1 \\
1-a^{\prime} b^{\prime} & -b^{\prime} / 2
\end{array}\right) .
$$

2. If $b^{\prime}$ is odd then

$$
B P_{2^{m}}^{L} K_{2}^{\wedge} \simeq\left\{\begin{array}{cc}
X^{0,0}\left(\begin{array}{cc}
b^{\prime} & 2^{m} \\
\left(1-a^{\prime} b^{\prime}\right) / 2^{m} & -a^{\prime}
\end{array}\right) & 0<m<\nu_{2}((a b-4) / 2) \\
X^{0,2}\left(\begin{array}{cc}
a^{\prime}+2^{m-1} & a^{\prime}-2^{m-1} \\
\frac{1-a^{\prime} b^{\prime}}{2^{m}}-\frac{b^{\prime}}{2} & \frac{1-a^{\prime} b^{\prime}}{2^{m}}+\frac{b^{\prime}}{2}
\end{array}\right) & m=\nu_{2}((a b-4) / 2) .
\end{array}\right.
$$

Proof. The proof of this is similar to the proofs of 7.1 and $7.2 . B P_{2^{m}}^{L}$ is given by a diagram which is obtained from the diagram of Lie groups

$$
\frac{S^{1} \times S U(2)}{\left\langle M\left(e^{2 \pi i / 2^{m}}, 1\right)\right\rangle} \stackrel{M}{\leftarrow} \frac{T}{\left\langle\left(e^{2 \pi i / 2^{m}}, 1\right)\right\rangle} \stackrel{\mathrm{id}}{\rightarrow} \frac{S^{1} \times S U(2)}{\left\langle\left(e^{2 \pi i / 2^{m}}, 1\right)\right\rangle}
$$

with $M=\left(\begin{array}{cc}b^{\prime} & 1 \\ 1-a^{\prime} b^{\prime} & -a^{\prime}\end{array}\right)$. When we apply the matrix $M$ to the vector $\left(1 / 2^{m}, 0\right)$ we obtain $\left(b^{\prime} / 2^{m},\left(1-a^{\prime} b^{\prime}\right) / 2^{m}\right)$ and we have to distinguish the cases of
$b^{\prime}$ even and $b^{\prime}$ odd and also the cases when $m<\nu_{2}\left(2-a^{\prime} b\right)$ and $m=\nu_{2}\left(2-a^{\prime} b\right)$. Finally, we need to use the identifications given by Lemma 7.1. We leave the details to the reader.

The computations for the other central quotients $P_{2}^{R} K, P_{2^{m}}^{D} K$ and $P_{2^{m+1}}^{N} K$ can be done using the same ideas and we will omit the proofs.

Proposition 7.4. Let $a=2 a^{\prime}, b=2 b^{\prime}$. Then

1. If $a^{\prime}$ is even then

$$
B P_{2}^{R} K_{2}^{\wedge} \simeq X^{0,1}\left(\begin{array}{cc}
2 b^{\prime} & 1 \\
1-a^{\prime} b^{\prime} & -a^{\prime} / 2
\end{array}\right)
$$

2. If $a^{\prime}$ is odd then

$$
B P_{2}^{R} K_{2}^{\wedge} \simeq X^{1,2}\left(\begin{array}{cc}
\left(a^{\prime}+1\right) / 2 & \left(a^{\prime}-1\right) / 2 \\
1-b^{\prime}-a^{\prime} b^{\prime} & 1+b^{\prime}-a^{\prime} b^{\prime}
\end{array}\right)
$$

Proposition 7.5. Let $a=2 a^{\prime}, b=2 b^{\prime}$ and $1 \leq m \leq \nu_{2}\left(2-a^{\prime} b\right)$. Then 1. If $a^{\prime} b^{\prime}$ is odd, then

- $B P_{2}^{D} K_{2}^{\wedge} \simeq X^{1,2}\left(\begin{array}{cc}\left(b^{\prime}+1\right) / 2 & \left(b^{\prime}-1\right) / 2 \\ 1-a^{\prime} b^{\prime}-a^{\prime} & 1-a^{\prime} b^{\prime}+a^{\prime}\end{array}\right)$.
- $B P_{2^{m}}^{D} K_{2}^{\wedge} \simeq X^{2,2}\left(\begin{array}{ll}\frac{1-a^{\prime} b^{\prime}}{2^{\prime}}+\frac{b^{\prime}-a^{\prime}}{2}+2^{m-2} & \frac{1-a^{\prime} b^{\prime}}{2^{\prime}}+\frac{b^{\prime}+a^{\prime}}{2^{\prime}-1} \\ \frac{2^{m}}{2 m} & \frac{b^{\prime}+a^{\prime}}{2}+2^{m-2} \\ \frac{a^{\prime} b^{\prime}-1}{2^{m}}+\frac{b^{\prime}-a^{\prime}}{2}-2^{m-2}\end{array}\right)$, if $1<m<\nu_{2}\left(2-a^{\prime} b\right)$.
- $B P_{2^{m}}^{D} K_{2}^{\wedge} \simeq X^{0,2}\left(\begin{array}{cc}b^{\prime}+2^{m-1} & b^{\prime}-2^{m-1} \\ \frac{1-a^{\prime} b^{\prime}}{2^{m}}-\frac{a^{\prime}}{2} & \frac{1-a^{\prime} b^{\prime}}{2^{m}}+\frac{a^{\prime}}{2}\end{array}\right)$, if $m=\nu_{2}\left(2-a^{\prime} b\right)$.

2. If $a^{\prime}$ and $b^{\prime}$ are both even, then $m=1$ and

$$
B P_{2}^{D} K_{2}^{\wedge} \simeq X^{2,2}\left(\begin{array}{cc}
\frac{b^{\prime}-a^{\prime} b^{\prime}-a^{\prime}}{2}+1 & \frac{b^{\prime}-a^{\prime} b^{\prime}+a^{\prime}}{b^{\prime}} \\
\frac{b^{\prime}+a^{\prime} b^{\prime}+a^{\prime}}{2} & \frac{b^{\prime}+a^{\prime} b^{\prime}-a^{\prime}}{2}-1
\end{array}\right) .
$$

3. If $a^{\prime}$ is even and $b^{\prime}$ is odd, then $m=1$ and

$$
B P_{2}^{D} K_{2}^{\wedge} \simeq X^{1,2}\left(\begin{array}{cc}
\left(b^{\prime}+1\right) / 2 & \left(b^{\prime}-1\right) / 2 \\
1-a^{\prime} b^{\prime}-a^{\prime} & 1-a^{\prime} b^{\prime}+a^{\prime}
\end{array}\right)
$$

4. If $a^{\prime}$ is odd and $b^{\prime}$ is even, then $m=1$ and

$$
B P_{2^{m}}^{D} K_{2}^{\wedge} \simeq X^{0,2}\left(\begin{array}{cc}
b^{\prime}+1 & b^{\prime}-1 \\
\left(1-a^{\prime} b^{\prime}-a^{\prime}\right) / 2 & \left(1-a^{\prime} b^{\prime}+a^{\prime}\right) / 2
\end{array}\right)
$$

Proposition 7.6. Let $a=2 a^{\prime}, b=2 b^{\prime}$ and $1 \leq m \leq \nu_{2}\left(2-a^{\prime} b\right)$. Then

$$
B P_{2^{m+1}}^{N} K \simeq X^{1,1}\left(\begin{array}{cc}
b^{\prime} & 2^{m-1} \\
\left(1-a^{\prime} b^{\prime}\right) / 2^{m-1} & -a^{\prime}
\end{array}\right)
$$

This completes the description of the spaces $B(K / F)_{p}^{\wedge}$ as spaces in $\mathrm{S}^{*}$. From the above computations it is straightforward to determine, for each central quotient of each rank two Kac-Moody group, the values of their parameters in $R^{*}$ and then to use the computations in the preceding sections to determine the cohomology of its classifying space. In the case of the prime 2, the description of the invariants associated to each space has not the simple form that it has for the odd primes, except for the case in which the representation turns out to be in $\operatorname{Rep}_{1,1}$, when we always have $\Gamma_{1,1}=a b / 4$. The table 11 displays a part of the information which we have obtained in the above propositions in a more user-friendly way.
