Manuscripts should be sent in triplicate to Editors, P.O. Box 5, Notre Dame, Indiana 46556, U.S.A. Manuscripts are accepted for review with the understanding that the same work has not been and will not be published elsewhere, nor is presently submitted elsewhere, and that all persons listed as authors have given their approval for the submission of the paper; further that any person cited as a source of personal communications has approved such citation. Authors will be requested to sign a transfer of copyright to the Notre Dame Journal of Formal Logic so that the authors and publishers may be protected from misuse of copyrighted material even during the review process.

Form of Manuscript. All manuscripts must be typewritten in English, double-spaced (including notes and references) on one side of $8\frac{1}{2} \times 11$ inch or A4 white paper with 1 inch margins on all sides. To facilitate blind review by one or more readers, all indications of authorship should appear on a detachable cover page only. Handwritten symbols, non-Roman characters, and ambiguous symbols (1 vs. l, o vs. O and 0) should be identified in the margin.
