ON AN APPLICATION OF INTERMEDIATE LOGICS

TOSHIO UMEZAWA

In [1] I investigated some logics intermediate between intuitionistic and classical predicate logics. The purpose of this paper is to show the possibility of applying some intermediate logics to mathematics namely, to show that some mathematical theorems which are provable in the classical logic but not provable in the intuitionistic logic are provable in some intermediate logics. Let LZ be the logical system obtained from LJ', a variant of Gentzen's LJ [2], by adding as axioms all those sequents which can be obtained from a sequent scheme Z by substitution for propositional, predicate, or individual variables. Among many intermediate logics, LM, LK° , LMK° , LE, LD, and LD^{*} are used in this paper where M stands for $\rightarrow ZA$, ZZA, K° for $\rightarrow ZZVX(A(x) \lor ZA(x))$, MK° for $\rightarrow ZZVXA(x)$, ZZXZX(x), ZZXZX(x), ZZXZX(x), ZZXZXX(x), ZZXXX(x), ZZXX(x), ZZXXX(x), ZZXXX(x), ZZXX(x), ZZXX(x),

An interpretation of classical arithmetic is given in §1. Let us denote by $\mathbb{Z}\Gamma$ the result of applying $\mathbb{Z}\Gamma$ to each formulas of Γ . Then it is proved that if $\Gamma \to \Delta$ is provable in LK, then $\mathbb{Z}\Gamma \to \mathbb{Z}\Gamma \to \mathbb{Z}\Lambda$ is provable in LK°.

In § 2 we investigate an arithmetic of real number-generators. As for the intuitionistic terminologies not mentioned explicitly, we refer to Heyting [3]. Let us suppose that the intuitionistic theory of rational numbers has been developed. A sequence $\{a_n\}$ of rational numbers is called a J- or K° - or E-(real) numbergenerator, if it satisfies $\forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$, $\forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$, or $\forall k \forall k \forall n \forall p | a_{n+p} - a_n| < 2^{-k}$ where the ranges of variables are the set of all natural numbers. Any J-number-generator is $a \in K^{\circ}$ -number-generator but not vice versa and any K° -number-generator is E-number-generator but not vice versa. It is proved in Theorem 2 that in E as well as in E there is only one form of number-generator if we consider weakening in terms of double negation. Let α and β be arbitrary number-generators. We say that α and β

J-coincide, if $\forall k \exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-k}$; that α is *J*-inequal to β , if $\exists k \forall n \exists p \mid a_{n+p} - b_{n+p} \mid \ge 2^{-k}$; and that α lies *J*-apart from β , if $\exists k \exists n \forall p \mid a_{n+p} - b_{n+p} \mid \ge 2^{-k}$. The other weakened forms of these notions in terms of double negation are given. In LE as well as in LD there is only one form of definition for coincidence, inequality, and apartness respectively and moreover inequality is an equivalent notion to apartness and negation of coincidence to apartness.

In § 3 a definition of real numbers is given. Let X, Y, and Z stand for one of J, K° , and E. The species of X-real number-generators which Y-coincide with a given Z-real number-generator is called a (X, Y, Z)-real number. It is shown that there are nine forms of real numbers which are not known intuitionistically to be equivalent and relations of these forms of real numbers are given in a diagram. In LE as well as in LD there is only one form of real number.

In § 4 irrational numbers are treated. A *J*-real number-generator $\{a_n\}$ is defined to be rational or irrational if $\exists r \forall k \exists n \forall p | a_{n+p} - r| < 2^{-k}$ or $\forall r \exists k \forall n \exists p | a_{n+p} - r| \geq 2^{-k}$ where r ranges over the set of rational numbers. It is proved in Theorem 6 that in LD any real number is a *J*-rational number or a *J*-irrational number.

In §5 order relations are investigated. $\alpha < \beta$ means that $\exists k \exists n \forall p (a_{n+p} + 2^{-k} < b_{n+p})$ where a_{n+p} and b_{n+p} are the n+p-th components of α and β respectively. There are three weakened forms in terms of double negation which are not known intuitionistically to be equivalent and are equivalent in LD as well as in LE. We obtain $\rightarrow \alpha > \beta \lor \alpha = \beta \lor \alpha < \beta$ in LE as well as in LD. Let $\alpha \stackrel{*}{=} \beta$ be E-coincidence between α and β . In LM as well as in $LD^* \rightarrow a \stackrel{*}{=} \beta \lor > (\alpha \stackrel{*}{=} \beta)$ is provable. Also it is proved that in LM a virtual order relation is equivalent to an actual order relation.

Finally in § 6 we investigate many forms of convergences of rational numbers and of real number-generators. Let $\langle \alpha_n \rangle$ be a sequence of number-generators. $\langle \alpha_n \rangle$ is called a J- or K° - or E-fundamental sequence of the number-generators, if $\nabla k \exists n \nabla p | \alpha_{n+p} - \alpha_n| < 2^{-k}$, $\forall \forall k \exists n \nabla p | \alpha_{n+p} - \alpha_n| < 2^{-k}$, or $\nabla k \forall k \exists n \nabla p | \alpha_{n+p} - \alpha_n| < 2^{-k}$. The convergence of fundamental sequences of J-number-generators is treated. For any fundamental sequence $\{\alpha_n\}$ of any number-generators, it holds in LE as well as in LD that $\exists \alpha \forall k \exists n \forall p | \alpha - \alpha_{n+p}| < 2^{-k}$ where α ranges over J-number-generators.

§ 1. An interpretation of natural number theory

Since the most part of classical elementary arithmetic is provable in the intuitionistic mathematics except some assertions like the principle of the least number, we here prove a theorem concerning an interpretation of classical arithmetic.

The system of intuitionistic elementary arithmetic is given by adding the following mathematical axiom sequents and the complete induction to LJ'. Terms and formulas are introduced as usual (cf. Kleene [4] Chap. IV).

$$a = b \rightarrow a' = b'. \quad a' = b' \rightarrow a = b. \quad a' = 0 \rightarrow . \quad a = b, \ a = c \rightarrow b = c.$$

$$\rightarrow a + 0 = a. \quad \rightarrow a + b' = (a + b)'. \quad \rightarrow a \cdot 0 = 0. \quad \rightarrow a \cdot b' = a \cdot b + a.$$
Induction
$$\frac{\Gamma \rightarrow A(0) \quad A(a), \ \Gamma \rightarrow A(a')}{\Gamma \rightarrow \forall x A(x)}$$

where a shall not occur in the lower sequent.

Let us denote the result of applying \mathbb{Z} to each formulas of Γ by \mathbb{Z} ?

Theorem 1. For the elementary arithmetic, if $\Gamma \to \Delta$ holds classically, then $77\Gamma \to 77\Delta$ holds in LMK°.

Proof. We use the induction on the length of a given classical proof. As for the sequent $A \to A$ it is obvious. It is also true as for the mathematical axiom sequents, because for natural numbers a, $b \nearrow \nearrow (a = b) \to a = b$ is true. We treat only \forall -in-succedent and Induction.

V-in-succedent. We omit evident inferences, inserting a double line to show a finite number of occurrences of inference.

As for induction, we use the fact that K° is provable in LMK° .

Thus, the theorem has been proved.

§ 2. Arithmetic of real number-generators

The intuitionistic theory of rational numbers, including their order relation, is supposed to have been developed. In the following a mathematical sequent, which is intuitionistically provable, is admitted as an initial sequent.

Def. 1. A sequence $\{a_n\}$ of rational numbers is called a *J-real number-generator*, or shortly a *J-number-generator*, if for every natural number k we can find effectively a natural number n, such that $|a_{n+p}-a_n| < 2^{-k}$ for every natural number p: written symbolically,

$$(2.1) \qquad \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}.$$

Unless mentioned otherwise, quantifiers range over the natural numbers.

We consider the forms of number-generators in which double negations stand before quantifiers. They are called weakened forms.

Def. 2. A sequence $\{a_n\}$ of rational numbers is called a K° -(real) number-generator or E-(real) number-generator if it satisfies (2.2) or (2.3) respectively:

$$(2.3) \qquad \forall k \nearrow \nearrow \exists n \forall p | a_{n+p} - a_n | < 2^{-k},$$

Any other weakened form is equivalent to one of these three. Obviously a J-number-generator is a K° -number-generator, which is also a E-number-generator. We prove that (2.1) is a stronger condition than (2.2).

Let M be a finitary spread consisting of all infinitely proceeding sequences in which only 0 and 1 can be members, while 1 can only be followed by 1. By the definition of M we can show that $\exists x(a_x=1) \rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$ and $\forall \exists x(a_x=1) \rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$, hence $\exists x(a_x=1) \vee \forall \exists x(a_x=1)$ is provable intuitionistically, we obtain $\Rightarrow \forall \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$. Hence, every element of M is a K° -number-generator. Assume that (2.2) entails (2.1). By the definition of M (2.1) is equivalent to $\Rightarrow \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$. If we take the least value of such n, then for any element α of M a number is determined. We write the number as $f(\alpha)$. In virtue of the fan-theorem (cf. [3] p. 42), $f(\alpha)$ must be known after a finite number of components are given. However, it is impossible, q.e.d.

An example which satisfies (2.3) but does not seem to satisfy (2.2) was given in [5].

Since $\nearrow \nearrow \forall x A(x)$ is equivalent to $\forall x \nearrow \nearrow A(x)$ in LK° , a E-number-generator is a K° -number-generator. Therefore K° -number-generator and E-number-generator are the same conception in LK° . Kuroda [6] has developed a theory of real numbers on the assumption that K° is intuitionistically true if x or every variable, which may eventually occur in the inner construction of A(x), range over a denumerable infinite species, hence the real number theory in LK° (cf. [6], [7] and [8]).

Theorem 2. In LE as well as in LD there is only one form of numbergenerator for weakening in terms of double negations.

Proof. If suffices to prove the sequent $\forall k \nearrow \nearrow \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$ $\rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$ in LE and in LD. Let us abbreviate $|a_{n+p} - a_n| < 2^{-k}$ by $\mathfrak{A}(k, n, p)$.

- i) Since $\mathbb{ZZ} \forall x A(x) \rightarrow \forall x \mathbb{ZZ} A(x)$ and $\mathbb{ZZ} \mathfrak{U}(k, n, p) \rightarrow \mathfrak{U}(k, n, p)$ hold intuitionistically, we can obtain the desired result by applying E.
 - ii) The proof in LD is as follows.

where $\rightarrow \mathfrak{N}(k, n, p)$, $\nearrow \mathfrak{N}(k, n, p)$ and other sequents are provable intuitionistically, q.e.d.

If in the following, a number-generator is denoted by a small Greek letter, then the number-generator shall be understood that it denotes any one of the above three forms. Let number-generators $\{a_n\}$ and $\{b_n\}$ be denoted by α and β respectively.

Def. 3.
$$\alpha$$
 and β J-coincide, $\alpha = \beta$, if
$$(2.4) \qquad \forall k \exists n \forall p | a_{i+p} - b_{n+p}| < 2^{-k}.$$

Def. 4. α and β K° - or E-coincide in case of (2.5) or (2.6) respectively.

$$(2.6) \qquad \forall k \nearrow \exists n \forall p | a_{n+b} - b_{n+b}| < 2^{-k}.$$

We can prove in the same way as in Theorem 2 that in LK° K° -coincidence is equivalent to E-coincidence, and in LE as well as in LD, J- and K° - and E-coincidence are equivalent to each other.

Def. 5. α is *J-inequal* to β , if

(2.7)
$$\exists k \, \forall n \, \exists p \, |a_{n+p} - b_{n+p}| \geq 2^{-k}.$$

There are other weakenings which are not known intuitionistically to be equivalent:

$$(2.8) \exists k \mathbb{Z} \forall n \exists p | a_{n+p} - b_{n+p}| \ge 2^{-k}.$$

$$(2.10) \exists k \forall n \forall n \exists p | a_{n+p} - b_{n+p}| \ge 2^{-k}.$$

In LK° there are three forms which are not known to be equivalent, i.e. (2.7), (2.8) and (2.9). In LE as well as in LD these five forms are equivalent to each other.

As for the relations among the different forms of coincidence, inequality and their negations in LJ' or in LK° , we refer to [5] or [6] respectively.

Def. 6. α lies J-apart from β , $\alpha \# \beta$, if

(2.12)
$$\exists k \, \exists n \, \forall p \, | \, a_{n+p} - b_{n+p} \, | \geq 2^{-k}.$$

The other weakenings which are not known intuitionistically to be equivalent are as follows.

$$(2.14) \exists n \, 77 \, \exists k \, \forall p \, |a_{n+p} - b_{n+p}| \ge 2^{-k}.$$

(2.14) is a weakening of an equivalent form $\exists n \exists k \forall p | a_{n+p} - b_{n+p} \rceil \ge 2^{-k}$ of (2.12).

We prove that for J-number-generators (2.12) is equivalent to (2.7) and for any number-generator (2.13) to (2.8) and (2.15) to (2.9).

For any $\{a_n\}$ and $\{b_n\}$ $\exists k \exists n \forall p | a_{n+p} - b_{n+p}| \geq 2^{-k} \rightarrow \exists k \forall n \exists p | a_{n+p} - b_{n+p}| \geq 2^{-k}$ can be proved easily. The converse is proved for J-number-generators as follows. From the sequent $|a_{n+m+p} - a_n| < 2^{-u-3}$, $|a_{n+m+l} - a_n| < 2^{-u-3}$, $|a_{n+m+l} - a_n| < 2^{-u-3}$, $|a_{n+m+l} - a_n| < 2^{-u-3}$, $|a_{n+m+p} - a_n| < 2^{-u-3}$, $|a_{n+m+p} - a_n| < 2^{-u-2} \rightarrow |a_{n+m+p} - b_{n+m+p}| < 2^{-u}$ we obtain $\forall p | a_{n+p} - a_n| < 2^{-u-3}$, $\forall p | b_{m+p} - b_m| < 2^{-u-2}$, $|a_{n+m+p} - b_{n+m+p}| \geq 2^{-u} \rightarrow |a_{n+m+l} - b_{n+m+l}| \geq 2^{-u-2}$ and further $\forall p | a_{n+p} - a_n| < 2^{-u-3}$, $\forall p | b_{m+p} - b_m| < 2^{-u-2}$, $\forall n \exists p | a_{n+p} - b_{n+p}| \geq 2^{-u} \rightarrow \forall p | a_{n+m+p} - b_{n+m+p}| \geq 2^{-u-2}$. Then (ε) : $\exists n \forall p | a_{n+p} - a_n| < 2^{-u-3}$, $\exists n \forall p | b_{n+p} - b_n| < 2^{-u-2}$, $\forall n \exists p | a_{n+p} - b_{n+p}| \geq 2^{-u} \rightarrow |a_{n+p} - a_n| < 2^{-u-2}$ is obtained. Hence, using $\Rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$ and $\Rightarrow \forall k \exists n \forall p | b_{n+p} - b_n| < 2^{-k}$, we can obtain $\exists k \forall n \exists p | a_{n+p} - b_{n+p}| \geq 2^{-k} \rightarrow |a_{n+p} - a_{n+p}| > 2^{-k}$. Therefore for J-number-generators (2.12) is equivalent to (2.7).

THEOREM 3. In LE as well as in LD there is only one form of definition for coincidence and inequality and apartness respectively. Inequality and apartness are equivalent notions and negation of coincidence is apartness.

§ 3. Real numbers

Let X, Y and Z stand for any one of I, K° and E.

Def. 7. The species of X-real number-generators which Y-coincide with a given Z-real number-generator is called a (X, Y, Z)-real number.

Lemma 1. Let X stand for any one of J, K° , and E. Any number-generator which X-coincide with a X-number-generator is a X-number-generator.

Proof. The sequent $|a_{m+n+l} - b_{m+n+l}| < 2^{-u-2}$, $|a_{n+m+l} - a_n| < 2^{-u-2}$, $|a_{n+m} - a_n| < 2^{-u-2}$, $|a_{m+n} - b_{m+n}| < 2^{-u-2} \rightarrow |b_{n+m+l} - b_{n+m}| < 2^{-u}$ is intuitionistically

provable. From this we obtain (δ) : $\exists n \forall p \mid a_{n+p} - a_n \mid < 2^{-u-2}$, $\exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-u-2} \rightarrow \exists n \forall p \mid b_{n+p} - b_n \mid < 2^{-u}$. Further by \forall -in-succedent and \forall -in-antecedent, we obtain (ε) : $\forall k \exists n \forall p \mid a_{n+p} - a_n \mid < 2^{-k}$, $\forall k \exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-k} \rightarrow \forall k \exists n \forall p \mid b_{n+p} - b_n \mid < 2^{-k}$. Therefore if $\{a_n\}$ is a J-number-generator and $\{a_n\}$, $\{b_n\}$ J-coincide, then $\{b_n\}$ is a J-number-generator. From (ε) we can obtain $\forall \forall k \exists n \forall p \mid a_{n+p} - a_n \mid < 2^{-k}$, $\forall \forall k \exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-k} \rightarrow \forall \forall k \exists n \forall p \mid b_{n+p} - b_n \mid < 2^{-k}$. Hence if $\{a_n\}$ is a K°-number-generator and $\{a_n\}$, $\{b_n\}$ K°-coincide, then $\{b_n\}$ is a K°-number-generator. Using (δ) , we can prove that if $\{a_n\}$ is a E-number-generator and $\{a_n\}$, $\{b_n\}$ E-coincide, then $\{b_n\}$ is a E-number-generator, q.e.d.

THEOREM 4. (K°, J, J) - and (E, J, J)-real numbers and every (J, X, Y)-real number, in which X and Y stand for each of J, K° and E, are equal.

Proof. In virtue of Lemma 1, all members of (K°, J, J) - and (E, J, J)-real number are J-number-generators, hence (K°, J, J) - and (E, J, J)-real numbers are equal to (J, J, J)-real numbers. Similarly (J, J, K°) - and (J, J, E)-real numbers are (J, J, J)-real numbers.

Since for *J*-number-generators *J*-, K° - and *E*-coincidence are equivalent by [5] 2.51, (J, K°, J) - and (J, E, J)-real numbers are equal to (J, J, J)-real numbers. $(J, K^{\circ}, K^{\circ})$ -, (J, K°, E) - and (J, E, K°) -real numbers are (J, E, E)-real numbers. Let $\beta \equiv \{b_n\}$ and $\gamma \equiv \{c_n\}$ are arbitrary members of a (J, E, E)-real number. By definition, β and γ *E*-coincide with a *E*-number-generator, say $\alpha \equiv \{a_n\}$. Def. 8. Real numbers in Theorem 4 are called J-real numbers.

Lemma 2. For K° -number-generators K° - and E-coincidence are equivalent.

Proof. Let $\{a_n\}$ and $\{b_n\}$ be K° -number-generators which E-coincide. From an intuitionistically provable sequent $|a_{n+m}-a_n| < 2^{-u-4}$, $|a_{n+m+l}-a_n| < 2^{-u-4}$, $|a_{n+m+l}-a_n| < 2^{-u-4}$, $|a_{n+m+l}-a_n| < 2^{-u-4}$, $|a_{n+m}-a_n| < 2^{-u-4}$, $|a_{n+p}-a_n| < 2^{-u-4}$, $|a_{n+p}-a_n| < 2^{-u-4}$, $|a_{n+p}-a_n| \ge 2^{-u-4}$. By the assumption,

⇒ $\forall k \nearrow \nearrow \exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-k}$ is true. Using intuitionistically provable sequents ⇒ $|a_{n+m} - b_{n+m}| < 2^{-u-1}$, $|a_{n+m} - b_{n+m}| \ge 2^{-u-1}$ and $|a_{n+m+l} - a_n| < 2^{-u-4}$, $|a_{n+m} - a_n| < 2^{-u-4}$, $|a_{n+m} - b_{n+m}| < 2^{-u-1}$, $|b_{m+n} - b_m| < 2^{-u-4}$, $|b_{m+n+l} - b_m| < 2^{-u-4}$, $|a_{n+m+l} - b_{n+m+l}| < 2^{-u}$, we obtain $\forall p \mid a_{n+p} - a_n \mid < 2^{-u-4}$, $\forall p \mid b_{m+p} - b_m \mid < 2^{-u-4}$ ⇒ $|a_{n+m+l} - b_{n+m+l}| < 2^{-u}$. From this, the sequent $\nearrow \nearrow \forall k \exists n \forall p \mid a_{n+p} - a_n \mid < 2^{-u-4}$, $\forall p \mid b_{m+p} - b_n \mid < 2^{-u-4}$ ⇒ $|a_{n+m+l} - b_{n+m+l}| < 2^{-u}$. From this, the sequent $\nearrow \nearrow \forall k \exists n \forall p \mid a_{n+p} - b_{n+p} \mid < 2^{-k}$ can be obtained. THEOREM 5. (I) $(K^{\circ}, J, K^{\circ})$ -, (E, J, K°) -, and (K°, J, E) -real numbers are equal. (II) $(K^{\circ}, K^{\circ}, J)$ -, (K°, E, J) -, and (E, K°, J) -real numbers are equal. (III) $(K^{\circ}, K^{\circ}, K^{\circ})$ -, $(K^{\circ}, E, K^{\circ})$ -, $(E, K^{\circ}, K^{\circ})$ -, (K°, E, E) -, and $(K^{\circ}, K^{\circ}, E)$ -real numbers are equal.

Proof. $(K^{\circ}, J, K^{\circ})$ -real numbers are both (E, J, K°) - and (K°, J, E) -real numbers. Since J-coincidence entails K° -coincidence, (E, J, K°) - and (K°, J, E) -real numbers are, in virtue of Lemma 1, $(K^{\circ}, J, K^{\circ})$ -real numbers, hence (I) has been proved. It can be proved similarly, that $(K^{\circ}, K^{\circ}, J)$ - and (E, K°, J) -real numbers are equal. By Lemma 2, E-coincidence in (K°, E, J) -real numbers is equivalent to K° -coincidence, therefore (II) has been proved. In the same way (III) can be proved except for (K°, E, E) -real numbers. The equivalence of (K°, E, E) -real numbers to $(K^{\circ}, K^{\circ}, K^{\circ})$ -real numbers can be shown analogously as in (J, E, E)-real numbers, q.e.d.

Let us denote by $X \Rightarrow Y$ that X-real numbers entail Y-real numbers. Then relations among real numbers of various forms are shown in the following diagram;

$$J \longrightarrow (K^{\circ}, K^{\circ}, J) \rightarrow (E, E, J)$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$(K^{\circ}, J, K^{\circ}) \rightarrow (K^{\circ}, K^{\circ}, K^{\circ}) \rightarrow (E, E, K^{\circ})$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$(E, J, E) \rightarrow (E, K^{\circ}, E) \rightarrow (E, E, E).$$

A (E, E, E)-real number was called a weak real number in [3] p. 111.

It can be proved that in LE as well as in LD there is only one definition of real number.

§ 4. J-irrational number

Def. 9. Let $\langle a_n \rangle$ be a *J*-real number-generator. $\langle a_n \rangle$ is called a *J*-rational number-generator, if

$$\exists r \, \forall k \, \exists n \, \forall p \, |a_{n+p} - r| < 2^{-k},$$

in which r is supposed to range over the rational numbers.

The species of *J*-number-generators which *J*-coincide with a *J*-rational number-generator is called a *J*-rational number.

Def. 10. Let $\{a_n\}$ be a *J*-real number-generator. $\{a_n\}$ is called a *J*-irrational number-generator, if

$$\forall r \exists k \forall n \exists p | a_{n+p} - r| \geq 2^{-k}$$

where r is supposed to range over the rational numbers.

The species of *J*-number-generators which *J*-coincide with a given *J*-irrational number-generator is called a *J*-irrational number.

Any sequence of rational numbers which J-coincides with a J-rational or J-irrational number generator is a J-rational or J-irrational number-generator respectively.

THEOREM 6. In LD any real number is a J-rational number or a J-irrational number.

Proof. Let α be an arbitrary member of a given real number. In virtue of Theorem 2, we may assume that α is a J-number-generator. In the same way as the foregoings, we can prove that in LD α is a J-rational number-generator or a J-irrational number-generator. If α is a J-rational number-generator, then the given real number is a J-rational number and its members are all J-rational number-generators. If α is a J-irrational number-generator, then the given real number is a J-irrational number.

§ 5. Order relations

Def. 11. For real number-generators α and β , $\alpha < \beta$, if

(5.1)
$$\exists k \, \exists n \, \forall \, p (a_{n+p} + 2^{-k} < b_{n+p})$$

where a_{n+p} and b_{n+p} are the n+p-th components of α and β respectively. $\alpha > \beta$ means the same as $\beta < \alpha$.

There are three weakenings which are not known intuitionistically to be equivalent, where (5.3) is a weakening of an equivalent form of (5.1).

(5.2)
$$\exists k \, 77 \, \exists n \, \forall p (a_{n+p} + 2^{-k} < b_{n+p}).$$

(5.3)
$$\exists n \, \mathbb{Z} \, \exists k \, \forall p (a_{n+p} + 2^{-k} < b_{n+p}).$$

$$(5.4) 77 \exists k \exists n \forall p (a_{n+p} + 2^{-k} < b_{n+p}).$$

Equivalences are also not known in LK° . As in Theorem 2, we can prove that these four are equivalent to each other in LE as well as in LD.

Theorem 7. In LE as well as in LD there holds $\rightarrow \alpha = \beta \lor \angle(\alpha = \beta)$, hence by Theorem 3 $\rightarrow \alpha = \beta \lor \alpha \neq \beta$.

The proof is similar to Theorem 2. Since $\alpha \neq \beta \rightarrow \alpha > \beta \vee \alpha < \beta$ is provable intuitionistically (cf. [3] p. 25), we obtain by Theorem 7

Corollary 7.1. In LE as well as in $LD \rightarrow \alpha = \beta \lor \alpha > \beta \lor \alpha < \beta$. From this, we obtain further.

Corollary 7.2. In *LE* as well as in *LD* $\mathbb{Z}(\alpha > \beta) \to \alpha = \beta \lor \alpha < \beta$ and $\alpha \neq \beta \to \mathbb{Z}(\alpha > \beta) \lor \mathbb{Z}(\alpha < \beta)$ hold.

Proof. As to $\mathbb{Z}(\alpha > \beta) \to \alpha = \beta \vee \alpha < \beta$, it is obvious. From Corollary 7.1 $\alpha \neq \beta \to \alpha > \beta \vee \alpha < \beta$ follows. Since $\alpha > \beta \to \mathbb{Z}(\alpha < \beta)$ and $\alpha < \beta \to \mathbb{Z}(\alpha > \beta)$ are provable intuitionistically, the assertion can be obtained by cuts.

Def. 12. $\alpha \stackrel{\circ}{=} \beta$ denotes K° -coincidence of α and β and $\alpha \stackrel{*}{=} \beta$ E-coincidence.

Theorem 8. In $LM \rightarrow \alpha \stackrel{\circ}{=} \beta \vee \angle (\alpha \stackrel{\circ}{=} \beta)$ holds.

Proof. Obvious.

Theorem 9. Im LM as well as in $LD^* \to \alpha \stackrel{*}{=} \beta \lor \angle(\alpha \stackrel{*}{=} \beta)$ holds.

Proof. Since $\mathbb{Z}(\alpha \stackrel{*}{=} \beta)$ is equivalent to $\alpha \stackrel{*}{=} \beta$ intuitionistically, we obtain $\rightarrow \alpha \stackrel{*}{=} \beta \vee \mathbb{Z}(\alpha \stackrel{*}{=} \beta)$ from $\rightarrow \mathbb{Z}(\alpha \stackrel{*}{=} \beta) \vee \mathbb{Z}(\alpha \stackrel{*}{=} \beta)$ in LM.

Def. 13. Let S be a mathematical species. If < is a predicate which satisfies the following rules, then < is called a *virtual order relation* in S.

$$(V1) a < b \rightarrow \mathcal{Z}(a > b) \land \mathcal{Z}(a = b).$$

$$(V2) a = b \land b < c \rightarrow a < c.$$

$$(V3) a < b \land b = c \rightarrow a < c.$$

$$(V4) a < b \land b < c \rightarrow a < c.$$

a > b means the same as b < a.

Def. 14. If < satisfies the following rule instead of V5 and V6, then < is called an actual order relation in S.

$$(A) a = b \lor a > b \lor a < b.$$

Theorem 10. In LM a virtual order relation is the equivalent notion to an actual order relation.

Proof. An actual order relation is a virtual order relation. Conversely let us consider a virtual order relation. From V1 and V6 we see that a > b is equivalent to $\mathbb{Z}(a < b) \land \mathbb{Z}(a = b)$, therefore to $\mathbb{Z}(a < b \lor a = b)$. Hence $\mathbb{Z}(a > b)$ is equivalent to $\mathbb{Z}(a < b \lor a = b)$, consequently to $\mathbb{Z}(a < b \lor a = b)$. Therefore a > b is equivalent to $\mathbb{Z}(a > b)$. From $\rightarrow \mathbb{Z}(a > b)$, $\mathbb{Z}(a > b)$ we can obtain $\rightarrow a > b$, $\mathbb{Z}(a > b)$ by a cut. Then by cuts of V5 with $\rightarrow a < b$, $\mathbb{Z}(a < b)$ and $\rightarrow a > b$, $\mathbb{Z}(a > b)$, we can obtain A.

§ 6. Convergence

Def. 15. Let $\alpha \equiv \{a_n\}$ and $\beta \equiv \{b_n\}$ be number-generators and let c be a number. $\alpha - c$, $\alpha - \beta$ and $|\alpha|$ means $\{a_n - c\}$, $\{a_n - b_n\}$ and $\{|a_n|\}$ respectively. $\alpha < c$ means $\alpha < \{a_n\}$ where $a_n = c$.

Def. 16. A sequence $\{a_n\}$ of rational numbers is called X1-, X2-, X3-, X4-, or X5-convergent, if $\{a_n\}$ satisfies the following condition respectively:

$$(6.1) \exists \alpha \forall k \exists n \forall p | \alpha - a_{n+p} | < 2^{-k},$$

$$(6.2) \exists \alpha \, \overline{Z} \, \forall k \, \exists n \, \forall p \, | \, \alpha - a_{n+p} | < 2^{-k},$$

(6.3)
$$\exists \alpha \, \forall k \, \forall \beta \, | \, \alpha - a_{n+p} | < 2^{-k},$$

$$(6.4) 77\exists \alpha \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k},$$

where α is supposed to range over the X-number-generators.

If $\{a_n\}$ is X1-convergent, then it is X2-convergent. If $\{a_n\}$ is X2-convergent, then it is both X3- and X4-convergent. If $\{a_n\}$ is either X3- or X4-convergent, then it is X5-convergent.

THEOREM 11. If $\{a_n\}$ is a J-, K° -, or E-number-generator, then $\{a_n\}$ is J1-, $K^{\circ}2$ -, or E3-convergent respectively and vice versa.

Proof. From the sequent $|a_{n+q}-a_n| < 2^{-u-2}$, $|a_{n+p}-a_n| < 2^{-u-2} \rightarrow |a_{n+q}-a_n| < 2^{-u-2} \rightarrow |a_{n+q}-a_n| < 2^{-u-2} \rightarrow |a_{n+q}-a_n| < 2^{-u-2} \rightarrow |a_{n+q}-a_n| < 2^{-u-2} \rightarrow |a_{n+p}-a_n| < 2^{-u-2} \rightarrow |a_{n+p}-a_n| < 2^{-u-2} \rightarrow |a_{n+p}-a_n| < 2^{-u-2} \rightarrow |a_n-a_n| < 2^{-u}$, in which α^* is the sequence $\{a_n\}$. And further we obtain (δ) : $\forall k \exists n \forall p | a_{n+p}-a_n| < 2^{-k} \rightarrow \forall k \exists n \forall p | \alpha^*-a_{n+p}| < 2^{-k}$. Hence, if $\alpha^* \equiv \{a_n\}$ is a J-numbergenerator, then $\rightarrow \forall k \exists n \forall p | \alpha^*-a_{n+p}| < 2^{-k}$, consequently $\rightarrow \exists \alpha \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k}$. Namely, $\{a_n\}$ is J1-convergent. From (δ) we can obtain $\forall \forall k \exists n \forall p | a_{n+p}-a_n| < 2^{-k} \rightarrow \exists \alpha \forall \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k}$. Hence, if $\alpha^* \equiv \{a_n\}$ is a K°-number-generator, then α^* is K°2-convergent. It can be proved in a similar way, that if $\alpha^* \equiv \{a_n\}$ is a E-number-generator, then α^* is E3-convergent.

Conversely, from the sequent $|b_{t+s} - a_{n+m+l}| < 2^{-u-1} - 2^{-r}$, $|b_{s+t} - a_{n+m}| < 2^{-u-1} - 2^{-v} \rightarrow |a_{n+m+l} - a_{n+m}| < 2^{-u}$, we can obtain $\exists t \exists r \forall q (|b_{t+q} - a_{n+m+l}| + 2^{-r} < 2^{-u-1})$, $\exists t \exists r \forall q (|b_{t+q} - a_{n+m}| + 2^{-r} < 2^{-u-1}) \rightarrow |a_{n+m+l} - a_{n+m}| < 2^{-u}$. It may be written as $|\beta - a_{n+m+l}| < 2^{-u-1}$, $|\beta - a_{n+m}| < 2^{-u-1} \rightarrow |a_{n+m+l} - a_{n+m}| < 2^{-u}$. From this we can obtain (ε) : $\forall k \exists n \forall p | \beta - a_{n+p}| < 2^{-k} \rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$. Since β occurs free, the sequent $\exists \alpha \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k} \rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$ follows. Hence, if $\{a_n\}$ satisfies (6.1), then $\{a_n\}$ is a J-numbergenerator. From (ε) , we can obtain $\exists \alpha \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k} \rightarrow \forall k \exists n \forall p | \alpha - a_{n+p}| < 2^{-k} \rightarrow \forall k \exists n \forall p | a_{n+p} - a_n| < 2^{-k}$. Hence if $\{a_n\}$ satisfies (6.2), then $\{a_n\}$ is K° -number-generator. It can be proved in a similar way, that if $\{a_n\}$ satisfies (6.3), then $\{a_n\}$ is a E-number-generator, q.e.d.

Remark. The statement of Theorem 11 still holds, if < in the definitions (6.1)–(6.5) is replaced by any one of the order relations defined by (5.2)–(5.4).

Def. 17. A sequence $\{\alpha_n\}$ of number-generators is called a J-, K° -, or E-

fundamental sequence, if $\langle \alpha_n \rangle$ satisfies (6.6), (6.7), or (6.8) respectively:

$$(6.6) \qquad \forall k \exists n \forall p \mid \alpha_{n+p} - \alpha_n \mid < 2^{-k},$$

$$(6.8) \qquad \forall k \, \mathbb{Z} \, \exists n \, \forall p \, |\alpha_{n+p} - \alpha_n| < 2^{-k}.$$

Def. 18. A sequence $\{\alpha_n\}$ of *J*-number-generators is called X1-, X2-, X3-, X4-, or X5-convergent, if $\{\alpha_n\}$ satisfies (6.9)-(6.13) respectively:

$$(6.9) \exists \alpha \forall k \exists n \forall p | \alpha - \alpha_{n+p} | < 2^{-k},$$

$$(6.10) \qquad \exists \alpha \, \forall k \, \exists n \, \forall p \, | \, \alpha - \alpha_{n+p} \, | \, < 2^{-k},$$

$$(6.11) \exists \alpha \forall k \nearrow \nearrow \exists n \forall p | \alpha - \alpha_{n+p} | < 2^{-k},$$

where α is supposed to range over the X-number-generators.

Theorem 12. A J-, K° -, and E-fundamental sequence of number-generators are J1-, K° 2- and E3-convergent respectively.

Proof. Let $a_n^{(x)}$ be the *n*-th component of α_x in $\{\alpha_n\}$. We define $a^{(x)}$ to be $a_{n+1}^{(x)}$ where *n* is the least number such that $\forall p \mid \alpha_x - a_{n+1}^{(x)} \mid < 2^{-x}$. Then $|\alpha_x - a^{(x)}| < 2^{-x}$.

Let $d = \operatorname{Max}(m+1, u+2)$. The sequent $\exists n \forall p \mid \alpha_{d+l} - a_{n+p}^{(d+l)} \mid < 2^{-(d+l)}$, $\exists n \forall p \mid \alpha_d - a_{n+p}^{(d)} < 2^{-d}$, $\forall p \mid \alpha_{m+p} - \alpha_m \mid < 2^{-u-2} \rightarrow \mid a^{(d+l)} - a^{(d)} \mid < 2^{-u}$ is provable. Since $\forall r \mid a^{(d+l)} - a^{(d)} \mid < 2^{-u} \rightarrow \mid a^{(d+l)} - a^{(d)} \mid < 2^{-u}$ holds intuitionistically, we can obtain $\forall k \forall r \exists n \forall p \mid \alpha_k - a_{n+p}^{(k)} \mid < 2^{-k}$, $\forall p \mid \alpha_{m+p} - \alpha_m \mid < 2^{-u-2} \rightarrow \mid a^{(d+l)} - a^{(d)} \mid < 2^{-u}$. Since $\alpha_k \equiv \langle a_n^{(k)} \rangle$ is a number-generator, $\rightarrow \forall k \forall r \exists n \forall p \mid \alpha_k - a_{n+p}^{(k)} \mid < 2^{-k}$ is provable, as is seen from the proof of Theorem 11. Therefore we have $\forall p \mid \alpha_{m+p} - \alpha_m \mid < 2^{-u-2} \rightarrow \mid a^{(d+l)} - a^{(d)} \mid < 2^{-u}$, hence $\exists n \forall p \mid \alpha_{n+p} - \alpha_n \mid < 2^{-u-2} \rightarrow \exists n \forall p \mid a^{(n+p)} - a^{(n)} \mid < 2^{-u}$. From this, we can prove that (A): if $\langle \alpha_n \rangle$ is a X-fundamental sequence, then $\langle a^{(n)} \rangle$ is a X-number-generator where X stands for each of J, K° , and E.

Let $g = \operatorname{Max}(n, u)$. The sequent $\exists n \forall p \mid \alpha_{g+l} - a_{n+p}^{(g+l)} \mid 2^{-(g+l)}, \mid \alpha - a^{(g+l)} \mid 2^{-u-1}, \mid \alpha - a^{(g+l)} \mid 2^{-u-1}, \mid \alpha - a^{(g+l)} \mid 2^{-u-1}, \mid \alpha - \alpha_{g+l} \mid 2^{-u}$ is provable. As before we can obtain $\forall k \nearrow \exists n \forall p \mid \alpha_k - a_{n+p}^{(k)} \mid 2^{-k}, \mid \alpha - a^{(g+l)} \mid 2^{-u-1} \rightarrow \mid \alpha - \alpha_{g+l} \mid 2^{-u}$. Since $\rightarrow \forall k \nearrow \exists n \forall p \mid \alpha_k - a_{p+n}^{(k)} \mid 2^{-k}$ holds, we obtain $|\alpha - a^{(g+l)}| < 2^{-u-1} \rightarrow |\alpha - \alpha_{g+l}| < 2^{-u}$. Using $g \ge n$, we can obtain $\exists n \forall p \mid \alpha - a^{(n+p)} \mid 2^{-u-1} \rightarrow \exists n \forall p \mid \alpha - \alpha_{n+p} \mid 2^{-u}$. From

this, it can be proved that if $\{a^{(n)}\}$ is J1-, $K^{\circ}2$ -, or E3-convergent, then $\{\alpha_n\}$ is J1-, $K^{\circ}2$ -, or E3-convergent. In virtue of Theorem 11 and (A), the theorem follows, q.e.d.

Since $\mathbb{Z}[\alpha-a]<2^{-k}\to |\alpha-a|<2^{-k}$ and $\mathbb{Z}[\alpha-\beta]<2^{-k}\to |\alpha-\beta|<2^{-k}$ are provable in LE as well as in LD, it can be proved that (6.1)-(6.5), that (6.6)-(6.8), and that (0.9)-(6.13), are equivalent to each other.

Theorem 13. In LE as well as in LD any fundamental sequence of numbergenerators is J1-convergent.
