# ON THE LIMIT DISTRIBUTIONS OF DECOMPOSABLE GALTON-WATSON PROCESSES WITH THE PERRON-FROBENIUS ROOT I

## 1. Introduction

We consider a decomposable Galton-Watson process (GW process, for short) which contains no supercritical class and at least one critical or final class, that is, such a process for which the mean matrix has the Perron-Frobenius root $\rho=1$. The principal object of the present paper is to prove several limit theorems for the most general decomposable GW processes with $\rho=1$, and among others, give a new characterization of the limit distributions. Some of the main results were announced in [9].

Let us begin with the classification of multitype GW processes. Let $\boldsymbol{Z}(\boldsymbol{n})=$ $\left(Z_{i}(n)\right)_{1 \leq i \leq d}$ be a $d$-type GW process and $M=\left(m_{j}^{i}\right)_{1 \leq i, j \leq d}$ its mean matrix. Type $j$ is said to be accessible from type $i$ if $m_{j}^{i,(n)}$, the ( $i, j$ ) component of $M^{n}$, is positive for some $n \geqq 0$. This relation is written as $i \rightarrow j$. If $i \rightarrow j$ and $j \rightarrow i$, then $i$ and $j$ are said to communicate with each other. This relation is written as $i \leftrightarrow$ $j$. Since $\leftrightarrow$ is an equivalence relation, we can decompose the set of types $\{1,2$, $\cdots, d\}$ into the equivalence classes $C_{1}, C_{2}, \cdots, C_{N}$. Accessibility is a class property, i.e., if $i \rightarrow j$ for some $i \in C_{a}$ and $j \in C_{\beta}$, then $i^{\prime} \rightarrow j^{\prime}$ for all $i^{\prime} \in C_{a}$ and $j^{\prime} \in$ $C_{\beta}$. The relation $C_{\infty} \rightarrow C_{\beta}$ is simply written as $\beta \leqq \alpha(\beta<\alpha$ if $\beta \neq \alpha)$ and accessibility thus induces a partial order on the classes $C_{1}, C_{2}, \cdots, C_{N}$. The process $\boldsymbol{Z}(n)$ is said to be indecomposable (resp. decomposable) if $N=1$ (resp. $N \geqq 2$ ).

Set $M_{\beta}^{\alpha}=\left(m_{j}^{i}\right)_{i \in C_{a, j} \in C_{\beta}}$. Then, by definition, each $M_{\alpha}^{\alpha}$ is irreducible. As in most of the references we assume that each $M_{a}^{\alpha}$ is positively regular, i.e., irreducible and aperiodic. We denote, by $\rho_{a}$, the maximal eigenvalue of $M_{\alpha}^{\alpha}$. The class $C_{a}$ is said to be supercritical if $\rho_{a}>1$ and subcritical if $\rho_{\infty}<1$. When $\rho_{\infty}=$ $1, C_{a}$ is said to be final (resp. critical) if the generating function $F^{i}(s), i \in C_{a}$, are linear with respect to $s^{i}, i \in C_{\infty}$ (resp. otherwise).

The limit theorems for decomposable GW processes with $\rho=\max \left\{\rho_{1}, \rho_{2}, \cdots\right.$, $\left.\rho_{N}\right\}=1$ have been studied by several authors. The central problems for such processes are concerned with the limit distributions of random vectors of the form

where $\boldsymbol{Z}_{\beta}(n)=\left(Z_{i}(n)\right)_{i \in C_{\beta}}, 1 \leqq \beta \leqq N$, are the subvectors of $\boldsymbol{Z}(n)$ on $C_{\beta}, E_{n}$ is a conditioning on $\boldsymbol{Z}(n)$ and $a_{\beta}(n), 1 \leqq \beta \leqq N$, are certain normalizing sequences. Let $\boldsymbol{e}^{i}=(0, \cdots, 0,1,0, \cdots, 0)$, where the $i^{\prime}$ th component is 1 and the others are 0 , and let $P_{e^{i}}$ be the measure of the process such that $P_{e^{i}}\left[\boldsymbol{Z}(0)=e^{i}\right]=1$. Consider the process starting at $\boldsymbol{Z}(0)=\boldsymbol{e}^{\boldsymbol{i}}, i \in C_{\alpha}$. Unless $\beta \leqq \alpha, \boldsymbol{Z}_{\beta}(n)=\mathbf{0}$ for every $n \geqq 0$. Therefore, without loss of generality, we may assume that

We now list some of those results obtained in the references. Provisionally, $\lim _{n \rightarrow \infty} \boldsymbol{X}(n)$ means the limit of random vectors $\boldsymbol{X}(n)$ in distribution. First we state two unconditioned limit theorems.
[A] (Polin [6]). $\quad N=2$ and $1<2$ with $C_{1}$ a critical class and $C_{2}$ a final class. In this case $\lim _{n \rightarrow \infty}\left(n^{-1} \boldsymbol{Z}_{1}(n), \boldsymbol{Z}_{2}(n)\right)$ exists and its components are independent. The limit distribution is given explicitly.
[B] (Foster and Ney [2]). $\left\{C_{1}, \cdots, C_{N}\right\}$ is linearly ordered; $1<2<\cdots<N$. (Note that the order is converse with that of [2].) $C_{\alpha}$ is critical for $\alpha \neq N$ and $C_{N}$ is a one-type final class. Under these assumptions, $\lim _{n \rightarrow \infty}\left\{n^{-N+1} \boldsymbol{Z}_{1}(n), \cdots, n^{-1} \boldsymbol{Z}_{N-1}\right.$ $\left.(n), \boldsymbol{Z}_{N}(n)\right\}$ exists and is non-degenerate. The Laplace transform of the limit distributions is characterized by means of some semi-linear partial differential equation.

Next we state two conditioned limit theorems.
[C] (Foster and Ney [2]). As before, $1<2<\cdots<N$. Every $C_{\infty}$ is critical. In this case, the non-degenerate limit of $\left\{n^{-N} \boldsymbol{Z}_{1}(n), \cdots, n^{-1} \boldsymbol{Z}_{N}(n) \mid \boldsymbol{Z}_{N}(n) \neq 0\right\}$ exists and the limit distributions are characterized in a way similar to that in [B].
[D] (Ogura [5]). $\left\{C_{1}, \cdots, C_{N}\right\}$ contains no final class but may not be linearly ordered. Under this assumption, $\lim _{n \rightarrow \infty}\left\{n^{-1} \boldsymbol{Z}_{1}(n), \cdots, n^{-1} \boldsymbol{Z}_{N}(n) \mid \boldsymbol{Z}(n) \neq 0\right\}$ exists and the limit distribution is determined by some recurrence formula with respect to the partial order $<$. In this case, however, the support of the limit distributions are relatively small.

We extend all the above results to the most general GW processes with $\rho=1$. Theorem 2.3 contains [A] and [B]. Theorem 2.4 contains [C] and, together with Theorem 2.5, solves the conjecture in [2]. Theorem 10.1 generalizes [C] and [D] (and bridges them). The characterization of the limit distributions in Theorem 2.3 to Theorem 2.5 seems to be new (see [E] below) and the recurrence formula in Theorem 10.1 is simpler than that in [5].

All the main results of this paper heavily depend on Theorem 2.1 which
we shall call the fundamental limit theorem. Unlike the limit theorems mentioned above, this theorem and Theorem 2.2 are concerned with the limit of random vectors of the form

where $\boldsymbol{Y}(n)$ is the sum of $n$-independent copies of $\boldsymbol{Z}(n), \boldsymbol{Y}_{\beta}(n)$ is the subvectors of $\boldsymbol{Y}(n)$ on $C_{\beta}$ and $E_{n}$ is a conditioning on $\boldsymbol{Y}(n)$. In the simplest case, Theorem 2.1 and 2.2 are specialized as follows;
[E] As in [B], $1<2<\cdots<N$. Every $C_{a}$ is critical or final, i.e., $\rho_{a}=1$ for $\alpha=1,2, \cdots, N$. Then, for every $t>0$, the limit of

is non-degenerate. The logarithmic Laplace transform $\psi(t, \boldsymbol{\lambda})$ of the limit distribution of (1.4) is the solution of a first order ordinary differential equation in $t$ having $\boldsymbol{\lambda}$ as a parameter. Moreover if $C_{N}$ is critical, a similar result is valid for the limit of conditioned random vectors $\left\{n^{-N} \boldsymbol{Y}_{1}([n t]), \cdots, n^{-1} \boldsymbol{Y}_{N}([n t]) \mid \boldsymbol{Y}_{N}([n t])=\right.$ $0\}$.

The main results are summarized in section 2. Their proofs are given in sections 6 to 9 . The basic tools in the proof of Theorem 2.1 and 2.3 are the expansion formulas on generating function and an exponential formula on infinite products of matrices which are close to the mean matrix. This exponential formula will be proved in section 4. Standard expansion formulas are given in section 5 and a special expansion formula at a final class in section 8. The normalized limit $M^{*}$ of products of the mean matrix which is introduced in section 3 is useful for the characterization of limit distributions. Some part in the original proof of the limit theorems was much simplified by making use of general results on logarithmic Laplace transform. This was suggested by T. Watanabe. Above all, Lemma 7.2 and its application to conditioned limit theorems are due to him. In section 10 we shall extend Theorem 2.4 and 2.5 by the method of Ogura [5]. Finally a few examples will be given in section 11.

Acknowledgements. I would like to express my sincere thanks to Professor T. Watanabe for his valuable advices in the course of completing this work. Some of his contributions have been mentioned previously. Most of the results were improved by his advices. Especially he pointed out the fundamental role of Theorem 2.1 whose original version was Lemma 8.1 (i) and which I had taken as an auxiliary result for the proof of Theorem 2.3, and suggested the author to reduce all the other limit theorems to Theorem 2.1. The probabilistic interpretation of Theorem 2.1. is also due to him.

## 2. The main results

The process we consider in this paper is the following;
(A.1) For each $\alpha, M_{\alpha}^{\alpha}$ is positively regular,
(A.2) $\rho=\max \left\{\rho_{1}, \cdots, \rho_{N}\right\}=1$, that is, there is at least one critical or final class,
(A.3) For each critical class $C_{a}, \sum_{i, j, k \in C_{a}} E_{e}\left[Z_{j}(1) Z_{k}(1)\right]<\infty$,
(A.4) $\alpha<N$ for every $\alpha \neq N$.

Assumption (A.4) is no essential restriction for our purpose as was mentioned previously. We do not impose any further assumption besides Theorem 2.5 and 10.1.

We define the degree of relationship $\nu(\beta, \alpha)$ between classes $C_{\alpha}$ and $C_{\beta}$;

Since each $M_{a}^{\alpha}$ is positively regular, there exist uniquely a positive row vector $\boldsymbol{v}_{\boldsymbol{\alpha}}=\left(v_{i}\right)_{i \in C_{a}}$ and a positive column vector $\boldsymbol{u}^{\alpha}=\left(u^{i}\right)_{i \in C_{a}}$ such that

If $\rho_{\infty}=1$, we define

In section 3, we shall show the following fact (see Theorem 3.1); for each $i \in C_{a}$ and $j \in C_{\beta}$ there exists

Let $\boldsymbol{\lambda}=\left(\lambda^{i}\right)_{1 \leq i \leq d}$ denote a vector in $\boldsymbol{R}_{+}^{d}$.
Theorem 2.1 (Fundamental limit theorem).
Let $C_{a}$ be a critical or final class and $i \in C_{a}$. Then we have

$\exp \left(-\psi_{\infty}(t, \lambda)\right)$ is the Laplace transform of an infinitely divisible distribution.
Theorem 2.2. Let $C_{a}$ be a critical class and $i \in C_{\alpha}$. Then we have

$\exp \left(-\eta_{\boldsymbol{w}}(t, \lambda)\right)$ is the Laplace transform of an infinitely divisible distribution.
With the help of the above theorems we can obtain the limit theorems for the process $\boldsymbol{Z}(n)$ with $\boldsymbol{Z}(0)=\boldsymbol{e}^{i}, i \in C_{N}$, under certain normalization which depends on the degree of relationship $\nu(\beta)$ for each class $C_{\boldsymbol{\beta}}$. We first give an uncon-
ditioned limit theorem when $C_{N}$ is a final class.
Theorem 2.3. Let $C_{N}$ be a final class. Set $D(1)=\left\{i \in C_{a} ; \nu(\alpha) \geqq 2\right\}, D(2)$ $=\left\{i \in C_{a} ; \nu(\alpha)=1\right\}$ and $d_{i}=\# D(i), i=1,2$. Then, for each $i \in C_{N}$, there exists

the limit is independent of $i . \quad G(\lambda)$ can be decomposed as follows;

We next give two conditioned limit theorems according as $C_{N}$ is critical or subcritical.

Theorem 2.4. Let $C_{N}$ be a critical class and $i \in C_{N}$. Then we have

the limit is independent of $i . H(\boldsymbol{\lambda})$ is the Laplace transform of an infinitely divisible distribution on $\boldsymbol{R}_{+}^{d}$ and can be represented as follows;

H_{i}(\boldsymbol{\lambda})=\left(\sum_{\substack{\nu(\alpha)=1 \\ \rho_{\alpha}=1}} c_{\alpha}^{i}\left(B_{\alpha}\right)^{-1}\right)^{-1} \sum_{\substack{\nu(\alpha)=1 \\ \rho_{\alpha}=1}} c_{a}^{i}\left(\bar{\psi}_{\infty}^{\infty}(1, \lambda)-\bar{\psi}_{\alpha}(1, \lambda)\right), \tag{2.29}
\end{equation*}
$$

where $\bar{\Psi}_{a}(t, \lambda)$ is the solution of (2.24) and

$$
\begin{equation*}
\bar{\psi}_{\infty}^{\infty}(t, \lambda)=\lim _{\substack{\lambda_{j} \rightarrow \infty \\ j \in C_{\alpha}}} \bar{\Psi}_{\alpha}(t, \lambda) \tag{2.30}
\end{equation*}
$$

$\bar{\psi}_{a}^{\infty}(t, \lambda)$ is represented as follows;

where $\bar{\eta}_{a}(t, \lambda)$ is the solution of

& +\sum_{\nu(\beta, \alpha) \geqq 2} \sum_{j \in C_{\beta}} a_{\alpha, j} \lambda^{j} t^{\nu(\beta, \alpha)-2}, \\
& \nu(\beta, \alpha)+\nu(\alpha)=\nu(\beta)+1
\end{align*}\right.

## 3. The normalized limit $M^{*}$ of products of the mean matrix

Let $M=\left(m_{j}^{i}\right)_{1 \leqq i, j \leqq d}$ be the mean matrix. Let $M^{n}=\left(m_{j}^{i,(n)}\right)$ and $\left(M^{n}\right)_{\beta}^{\alpha}=$ $\left(m_{j}^{i,(n)}\right)_{i \in C_{a}, j \in C_{\beta}}$. Then $\left(M^{n}\right)_{\alpha}^{\alpha}=\left(M_{\alpha}^{\alpha}\right)^{n}$. In this section we study the asymptotic behavior of $M^{n}$.

The following lemma is well known (see [7]).
Lemma 3.1. Let $M_{a}^{a}$ be a positively regular matrix. Then there exists uniquely a positive row vector $\boldsymbol{v}_{\infty}=\left(v_{i}\right)_{i \in C_{a}}$ and a positive column vector $\boldsymbol{u}^{\infty}=\left(u^{i}\right)_{i \in C_{a}}$ such that

\boldsymbol{v}_{a} M_{\alpha}^{\alpha}=\rho_{\alpha} \boldsymbol{v}_{a}, M_{a}^{\alpha} \boldsymbol{u}^{\alpha}=\rho_{a} \boldsymbol{u}^{\alpha} \text { and } \sum_{i \in C_{a}} u^{i} v_{i}=\sum_{\imath \in C_{a}} v_{i}=1 \tag{3.1}
\end{equation*}
$$

Set

$$
\begin{equation*}
P_{a}^{\alpha}=\boldsymbol{u}^{\omega} \otimes \boldsymbol{v}_{a}=\left(u^{i} v_{j}\right)_{i, j \in C_{a}} \tag{3.2}
\end{equation*}
$$

Then we have

$$
\begin{equation*}
\left(M_{\alpha}^{\alpha}\right)^{n}=\rho_{\alpha}^{n} P_{\alpha}^{\alpha}+O\left(\rho^{n}\right) \text { for some } 0<\rho<\rho_{a} . \tag{3.3}
\end{equation*}
$$

The mean matrix $M=\left(M_{\beta}^{\alpha}\right)_{1 \leqq \alpha, \beta \leqq N}$ satisfies the condition that $M_{\beta}^{\alpha}=O$ unless $\beta \leqq \alpha$. If $L=\left(L_{\beta}^{\alpha}\right)$ also satisfies the same condition, then

\left(M^{n}\right)_{\beta}^{\alpha}=\sum_{\beta \leqq \gamma \leqq \alpha}\left(M^{n-1}\right)_{\gamma}^{\alpha} M_{\beta}^{\gamma}=\sum_{\beta \leqq \gamma \leqq \alpha} M_{\gamma}^{\alpha}\left(M^{n-1}\right)_{\beta}^{\gamma} \text { for } \beta \leqq \alpha . \tag{3.6}
\end{gather*}

A more useful form is

& =\sum_{k=0}^{n-1} \sum_{\beta \leqq \gamma<\alpha}\left(M_{\alpha}^{\alpha}\right)^{n-k-1} M_{\gamma}^{\alpha}\left(M^{k}\right)_{\beta}^{\gamma} \\
& \quad \text { if } \beta<\alpha \text { and } n \geqq 1 .
\end{align*}

Theorem 3.1. Let $\beta \leqq \alpha$. Then the following statements are valid;
(i) If $\nu(\beta, \alpha)=0$, then there exists $0<\rho<1$ such that

(ii) If $\nu(\beta, \alpha) \geqq 1$, then there exists a finite $M_{\beta}^{* \alpha}>O$ such that

and if $\nu(\beta, \alpha) \geqq 2$,

M_{\beta}^{* \alpha}=(\nu(\beta, \alpha)-1)^{-1} \sum_{\substack{\beta \leqq \gamma<\alpha \\ \nu(\beta, r)=\nu(\beta, \alpha)-1}} P_{\alpha}^{\alpha} M_{\gamma}^{\eta} M_{\beta}^{* \gamma} . \tag{3.12}

(iv) If $\rho_{\alpha}<1$ and $\nu(\beta, \alpha) \geqq 1$.

Remark. $\quad M_{a}^{* a}=P_{a}^{\alpha}$ if $\rho_{a}=1$.
Proof. We shall prove this theorem by induction with respect to the partial order $<$. First we shall show (i). If $\alpha$ is a minimal element, then $\rho<1$ and $\alpha=\beta$. In this case, (3.8) is clear by Lemma 3.1. We have to show (3.8) assuming $\left(M^{n}\right)_{\beta}^{\gamma}=O\left(\rho^{n}\right)$ for any $\beta \leqq \gamma<\alpha$ with $\nu(\beta, \gamma)=0$. But by (3.7) we have

\left(M^{n}\right)_{\beta}^{\alpha}=O\left(\sum_{k=0}^{n-1} \rho_{\alpha}^{k} \rho^{n-k-1}\right)=O\left(\bar{\rho}^{n}\right)

where $\max \left(\rho_{a}, \rho\right)<\bar{\rho}<1$. Positivity of (3.9) follows from the definition of the partial order $<$.

Next we shall show (ii), (iii) and (iv) simultaneously. If $\alpha$ is a minimal element, then $\rho_{a}=1$ and $\beta=\alpha$. (3.10) is clear by Lemma 3.1. For general $\alpha$, we have to show (3.10) assuming that $\lim _{n \rightarrow \infty} n^{-\nu(\beta, \gamma)+1}\left(M^{n}\right)_{\beta}^{\gamma}=M_{\beta}^{* \gamma}>O$ for any $\beta \leqq$ $\gamma<\alpha$ with $\nu(\beta, \gamma) \geqq 1$. If $\rho_{\infty}=1$ and $\nu(\beta, \alpha)=1$, then $\nu(\beta, \gamma)=0$ for any $\beta \leqq \gamma<$ $\alpha$. By (3.7), (3.8) and Lemma 3.1, we have

\lim _{n \rightarrow \infty}\left(M^{n}\right)_{\beta}^{\alpha}=\sum_{k=0}^{\infty} \sum_{\beta \leqq r<\alpha} P_{\alpha}^{\alpha} M_{\gamma}^{\alpha}\left(M^{k}\right)_{\beta}^{\gamma}
$$

This proves (3.11). Positivity follows from (3.9), $P_{\alpha}^{\alpha}>O$ and $M_{\gamma}^{\alpha} \neq O$ for some $\beta \leqq \gamma<\alpha$. If $\rho_{\omega}=1$ and $\nu(\beta, \alpha) \geqq 2$, then $\nu(\beta, \alpha)=\max _{\beta \leqq \gamma<\alpha} \nu(\beta, \gamma)+1$. Then by (3.7) we have

& \lim _{n \rightarrow \infty} n^{-\nu(\beta, \alpha)+1}\left(M^{n}\right)_{\beta}^{\alpha} \\
= & \lim _{n \rightarrow \infty} \sum_{k=0}^{n-1} \sum_{\beta \leqq r<\alpha} n^{-\nu(\beta, \alpha)+1}\left(M_{\alpha}^{\alpha}\right)^{k} M_{\gamma}^{\alpha}\left(M^{n-k-1}\right)_{\beta}^{\gamma} \\
= & \lim _{n \rightarrow \infty} \sum_{k=0}^{n-1} \frac{1}{n}\left(\frac{n-k-1}{n}\right)^{\nu(\beta, \alpha)-2} \sum_{\substack{\beta \leqq \gamma<\alpha \\
\nu(\beta, r)=\gamma<\beta, \alpha)-1}} P_{\alpha}^{\alpha} M_{\gamma}^{\alpha} M_{\beta}^{* \gamma} \\
= & (\nu(\beta, \alpha)-1)^{-1} \sum_{\substack{\beta \leq r<\alpha \\
\nu(\beta, r)=\nu(\beta, \alpha)-1}} P_{\alpha}^{\alpha} M_{\gamma}^{\alpha} M_{\beta}^{* \gamma},
\end{aligned}

which proves (3.12). Positivity follows from $P_{\alpha}^{\alpha}>O, M_{\beta}^{* \gamma}>O$ and $M_{\gamma}^{\alpha} \neq O$ for some $\beta \leqq \gamma<\alpha$ with $\nu(\beta, \gamma)=\nu(\beta, \alpha)-1$. If $\rho_{\alpha}<1$ and $\nu(\beta, \alpha) \geqq 1$, then $\nu(\beta, \alpha)$ $=\max _{\beta \leqq \gamma<\alpha} \nu(\beta, \gamma) . \quad$ By (3.7) we have

\begin{aligned}
& \lim _{n \rightarrow \infty} n^{-\nu(\beta, \alpha)+1}\left(M^{n}\right)_{\beta}^{\alpha} \\
= & \lim _{n \rightarrow \infty} \sum_{k=0}^{n-1} \sum_{\beta \leqq r<\alpha}\left(M_{\alpha}^{\alpha}\right)^{k} M_{\gamma}^{\alpha} n^{-\nu(\beta, \alpha)+1}\left(M^{n-k-1}\right)_{\beta}^{\gamma}
\end{aligned}
$$

$$
\begin{aligned}
& =\lim _{n \rightarrow \infty} \sum_{k=0}^{n-1} \sum_{\substack{\beta \leq \gamma<\alpha \\
\nu(\beta, r)=\nu(\beta, \alpha)}}\left(M_{a)^{\alpha}}^{\alpha} M_{\gamma}^{\alpha}\left(\frac{n-k-1}{n}\right)^{\nu(\beta, \alpha)-1} M_{\beta}^{* \gamma}\right. \\
& =\sum_{\substack{\beta \leq \gamma<\alpha \\
\nu(\beta, \gamma)=\nu(\beta, \alpha)}}\left(I-M_{a}^{\alpha}\right)^{-1} M_{\gamma}^{\alpha} M_{\beta}^{* \gamma} .
\end{aligned}
$$

This proves (3.13). Positivity follows from $\left(I-M_{\alpha}^{\alpha}\right)^{-1}>O, M_{\beta}^{* \gamma}>O$ and $M_{\gamma}^{\alpha} \neq O$ for some $\beta \leqq \gamma<\alpha$ with $\nu(\beta, \gamma)=\nu(\beta, \alpha)$.

## 4. Infinite products of matrices close to the mean matrix

In this section we shall establish some general results on infinite products of matrices close to the mean matrix. The exponential formula (4.12) or, more generally, (4.26) is a basic tool for the proof of Theorem 2.3 and has its own interest. For any sequence $\{M(n)\}_{n \geqq 0}$ of matrices and $n \geqq m$, we make the following convention;

\begin{equation*}
\prod_{k=m}^{n} M(k)=\prod_{k=0}^{n-m} M(n-k)=M(n) M(n-1) \cdots M(m) \tag{4.1}
\end{equation*}
$$

We shall also define $\prod_{k=m}^{m-1} M(k)=I$ (the identity matrix).
Lemma 4.1. Let $M_{a}^{\alpha}$ be a positively regular matrix with $\rho_{a}=1$ and $\{a(n)\}_{n \geqq 1}$ a sequence of positive integers going to infinity. Assume that the matrices $\left\{M_{\alpha}^{\alpha}(k\right.$, $n)\}_{0 \leq k \leq a(n), n \geq 1}$ and $\left\{M_{\alpha}^{\alpha}(k)\right\}_{k \geq 0}$ satisfy the following conditions;

\begin{gather*}
O \leqq M_{\alpha}^{\alpha}(k, n) \leqq M_{\alpha}^{\alpha}(k), \quad 0 \leqq k \leqq a(n), n \geqq 1,  \tag{4.2}\\
\lim _{n \rightarrow \infty} M_{\alpha}^{\alpha}(k, n)=M_{\alpha}^{\alpha}(k) \leqq M_{\alpha}^{\alpha}, k \geqq 0  \tag{4.3}\\
\sum_{k=0}^{\infty} M_{\alpha}^{\alpha}(k)<\infty \tag{4.4}
\end{gather*}
$$

Then there exists a row vector $\boldsymbol{w}_{\alpha}$ such that

$$
\begin{align*}
\lim _{n \rightarrow \infty} \prod_{k=0}^{a(n)}\left(M_{\alpha}^{\alpha}-M_{\alpha}^{\alpha}(k, n)\right) & =\lim _{n \rightarrow \infty} \prod_{k=0}^{a(n)}\left(M_{\alpha}^{\alpha}-M_{\alpha(k)}^{\alpha}(k)\right.  \tag{4.5}\\
& =\lim _{n \rightarrow \infty} \prod_{k=0}^{n}\left(M_{\alpha}^{\alpha}-M_{\alpha}^{\alpha}(k)\right)=\boldsymbol{u}^{\alpha} \otimes \boldsymbol{w}_{\alpha} .
\end{align*}
$$

Proof. To be short we omit the suffix $\alpha$. First we shall show the last equality of (4.5). Set $L_{n}=\prod_{k=0}^{n-1}(M-M(k))$ and $c(k)=\max \left\{m_{j}^{i}(k)\left(m_{j}^{i}\right)^{-1} ; i, j \in C_{a}, m_{j}^{i}\right.$ $>0\}$. Then by (4.4) we get

Since $(1-c(k)) M \leqq M-M(k) \leqq M$, we have $\left(\prod_{k=n}^{n+m-1}(1-c(k))\right) M^{m} L_{n} \leqq L_{m+n} \leqq M^{m} L_{n}$. Therefore by Lemma 3.1,

\end{equation*}
$$

Since $\lim _{n \rightarrow \infty} \prod_{k=n}^{\infty}(1-c(k))=1$ by (4.6), there exists $Q=\lim _{n \rightarrow \infty} L_{n}$. By (4.7) we get $Q=P Q=(\boldsymbol{u} \otimes \boldsymbol{v}) Q=\boldsymbol{u} \otimes \boldsymbol{v} Q . \quad$ Setting $\boldsymbol{w}=\boldsymbol{v} Q$, we have the last equality of (4.5).

The second equality in (4.5) is obvious.
The first equality of (4.5) follows from the following inequality;

& =\sum_{k=0}^{a(n)}\left(\prod_{l=k+1}^{a(n)}(M-M(l))\right)(M(k)-M(k, n))\left(\prod_{l=0}^{k-1}(M-M(l, n))\right) \\
& \leqq \sum_{k=0}^{a(n)} M^{a(n)-k}(M(k)-M(k, n)) M^{k}
\end{align*}
$$

because the last display goes to zero with $n$ by assumption (4.3) and (4.4).
Lemma 4.2. Let $M_{\alpha}^{\alpha}$ be a positively regular matrix with $\rho_{a}=1$ and $\{a(n)\}_{n \geq 1}$ a sequence of positive integers going to infinity. Assume that the matrices $\left\{M_{a}^{a}(k\right.$, $n)\}_{0 \leq k \leq a(n), n \geq 1}$ satisfy the following conditions;

$$
\begin{gather*}
O \leqq M_{\alpha}^{\alpha}(k, n) \leqq M_{\alpha}^{\alpha}  \tag{4.9}\\
\lim _{n \rightarrow \infty} \max _{0 \leqq k \leqq a(n)} \boldsymbol{v}_{\alpha} M_{\alpha}^{\alpha}(k, n) \boldsymbol{u}^{\infty}=0 \tag{4.10}
\end{gather*}
$$

and there exists a finite limit

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \sum_{k=0}^{a(n)} v_{\alpha} M_{a}^{\alpha}(k, n) u^{a}=c(\alpha) \tag{4.11}
\end{equation*}
$$

Then we have

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \prod_{k=0}^{a(n)}\left(M_{a}^{a}-M_{a}^{\alpha}(k, n)\right)=e^{-c(a)} P_{a}^{\alpha} \tag{4.12}
\end{equation*}
$$

Proof. As before we omit the suffix $\alpha$. Set

Q(m, n)=\prod_{k=m}^{a(n)}(M-M(k, n)), \quad q(m, n)=v Q(m, n) \boldsymbol{u} \tag{4.13}
\end{equation*}

To show (4.12), it suffices to prove the following two relations;

\end{equation*}

Set $\delta_{n}=\max _{0 \leqq k \leqq a(n)} \max _{i, j \in C_{\infty}}\left\{m_{j}^{i}(k, n)\left(m_{j}^{i}\right)^{-1} ; m_{j}^{i}>0\right\}$. Then we have

\left(1-\delta_{n}\right) M \leqq M-M(k, n) \leqq M, 0 \leqq k \leqq a(n), n \geqq 1, \tag{4.17}
\end{equation*}
$$

and by (4.10),

\lim _{n \rightarrow \infty} \delta_{n}=0 \tag{4.18}
\end{equation*}
$$

First we shall prove (4.14). Let $m$ be fixed arbitrarily and set $R(m, n)=$ $\prod_{k=m}^{a(n)-m}(M-M(k, n)) . \quad$ By (4.16) and (4.17) we have

& \quad \leqq Q(0, n) \leqq\left(\left(1+\boldsymbol{r}_{m}\right) \boldsymbol{u} \otimes \boldsymbol{v}\right) R(m, n)\left(\left(1+r_{m}\right) \boldsymbol{u} \otimes \boldsymbol{v}\right) .
\end{aligned}
$$

It then follows that

\left(1-\delta_{n}\right)^{2 m}\left(1-r_{m}\right)^{2}(\boldsymbol{v} R(m, n) \boldsymbol{u}) \boldsymbol{u} \otimes \boldsymbol{v}  \tag{4.19}\\
\leqq Q(0, n) \leqq\left(1+\boldsymbol{r}_{m}\right)^{2}(\boldsymbol{v} R(m, n) \boldsymbol{u}) \boldsymbol{u} \otimes \boldsymbol{v} \\
\left(1-\delta_{n}\right)^{2 m}\left(1-r_{m}\right)^{2} \boldsymbol{v} R(m, n) \boldsymbol{u} \leqq q(0, n) \leqq\left(1+\boldsymbol{r}_{m}\right)^{2} \boldsymbol{v} R(m, n) \boldsymbol{u} . \tag{4.20}
\end{gather*}
$$

Hence we get

\frac{\left(1-\delta_{n}\right)^{2 m}\left(1-r_{m}\right)^{2}}{\left(1+r_{m}\right)^{2}} \boldsymbol{u} \otimes \boldsymbol{v} \leqq \frac{Q(0, n)}{q(0, n)} \leqq \frac{\left(1+r_{m}\right)^{2}}{\left(1-\delta_{n}\right)^{2 m}\left(1-r_{m}\right)^{2}} \boldsymbol{u} \otimes \boldsymbol{v}
$$

Then letting $n \rightarrow \infty$ and $m \rightarrow \infty$, we obtain (4.14).
Next we shall prove (4.15). Set

$$
\begin{equation*}
\boldsymbol{u}(k, n)=\frac{Q(k, n) \boldsymbol{u}}{q(k, n)}-\boldsymbol{u} \tag{4.21}
\end{equation*}
$$

If we can show that

\begin{equation*}
\lim _{n \rightarrow \infty} \max _{0 \leqq k \leqq a(n)} \max _{i \in C_{\infty}}\left|u^{i}(k, n)\right|=0 \tag{4.22}
\end{equation*}
$$

then (4.15) is proved as follows. By (4.13) we have

q(0, n) & =q(1, n)-\boldsymbol{v} M(0, n) Q(1, n) \boldsymbol{u} \\
& =q(1, n)\left(1-\frac{\boldsymbol{v} M(0, n) Q(1, n) \boldsymbol{u}}{q(1, n)}\right)
\end{aligned}
$$

$$
\begin{aligned}
& =q(a(n), n) \prod_{k=0}^{a(n)-1}\left(1-\frac{\boldsymbol{v} M(k, n) Q(k+1, n) \boldsymbol{u}}{q(k+1, n)}\right) \\
& =(1-\boldsymbol{v} M(a(n), n) \boldsymbol{u}) \prod_{k=0}^{a(n)-1}(1-\boldsymbol{v} M(k, n)(\boldsymbol{u}+\boldsymbol{u}(k+1, n))) .
\end{aligned}
$$

Then by (4.22), $\log (1-r)=-r+O\left(r^{2}\right)$ and the assumptions of this lemma we obtain (4.15);

\begin{aligned}
& \lim _{n \rightarrow \infty} \log q(0, n) \\
= & \lim _{n \rightarrow \infty}\left\{\log (1-\boldsymbol{v} M(a(n), n) \boldsymbol{u})+\sum_{k=0}^{a(n)-1} \log (1-\boldsymbol{v} M(k, n)(\boldsymbol{u}+\boldsymbol{u}(k+1, n)))\right\} \\
= & -\lim _{n \rightarrow \infty}\left\{\boldsymbol{v} M(a(n), n) \boldsymbol{u}+\sum_{k=0}^{a(n)-1} \boldsymbol{v} M(k, n) \boldsymbol{u}\right\} \\
= & -c(\alpha) .
\end{aligned}
$$

It remains to prove (4.22). Let $m$ be fixed and consider two cases; $k \leqq a(n)$ $-m$ or $k>a(n)-m$. If $k \leqq a(n)-m$, then by (4.16) and (4.17),

\left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right)(\boldsymbol{u} \otimes \boldsymbol{v}) Q(k+m, n) \boldsymbol{u} \leqq Q(k, n) \boldsymbol{u} \leqq\left(1+r_{m}\right)(\boldsymbol{u} \otimes \boldsymbol{v}) Q(k+m, n) \boldsymbol{u} .
$$

Hence

\begin{aligned}
& \left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right) q(k+m, n) \boldsymbol{u} \leqq Q(k, n) \boldsymbol{u} \leqq\left(1+r_{m}\right) q(k+m, n) \boldsymbol{u}, \\
& \left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right) q(k+m, n) \leqq q(k, n) \leqq\left(1+r_{m}\right) q(k+m, n) .
\end{aligned}
$$

Then

$$
\frac{\left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right)}{1+r_{m}} \boldsymbol{u} \leqq \frac{Q(k, n) \boldsymbol{u}}{q(k, n)} \leqq \frac{1+\boldsymbol{r}_{m}}{\left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right)} \boldsymbol{u}
$$

and therefore

$$
\begin{equation*}
\left|u^{i}(k, n)\right| \leqq\left(\frac{1+r_{m}}{\left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right)}-\frac{\left(1-\delta_{n}\right)^{m}\left(1-r_{m}\right)}{1+r_{m}}\right) u^{i}, k \leqq a(n)-m, i \in C_{a} . \tag{4.23}
\end{equation*}
$$

If $k>a(n)-m$, then by (4.17) we get

$$
\begin{aligned}
\left(1-\delta_{n}\right)^{m} \boldsymbol{u} & \leqq\left(1-\delta_{n}\right)^{a(n)-k+1} M^{a(n)-k+1} \boldsymbol{u} \\
& \leqq Q(k, n) \boldsymbol{u} \leqq M^{a(n)-k+1} \boldsymbol{u}=\boldsymbol{u} \\
\left(1-\delta_{n}\right)^{m} & \leqq q(k, n) \leqq 1
\end{aligned}
$$

Then

$$
\left(1-\delta_{n}\right)^{m} \boldsymbol{u} \leqq \frac{Q(k, n) \boldsymbol{u}}{q(k, n)} \leqq \frac{1}{\left(1-\delta_{n}\right)^{m}} \boldsymbol{u}
$$

and therefore

$$
\begin{equation*}
\left|u^{i}(k, n)\right| \leqq\left(\frac{1}{\left(1-\delta_{n}\right)^{m}}-\left(1-\delta_{n}\right)^{m}\right) u^{i}, k>a(n)-m, i \in C_{a} \tag{4.24}
\end{equation*}
$$

By (4.23) and (4.24) we get

$$
\varlimsup_{n \rightarrow \infty} \max _{0 \leqq k \leqq a(n)} \max _{i \in C_{\infty}}\left|u^{i}(k, n)\right| \leqq\left(\frac{1+r_{m}}{1-r_{m}}-\frac{1-r_{m}}{1+r_{m}}\right) \max _{i \in C_{a}} u^{i} .
$$

Letting $m \rightarrow \infty$ we obtain (4.22).
Combining the above two lemmas, we have
Lemma 4.3. Let $M_{\infty}^{\alpha}$ be a positively regular matrix with $\rho_{\infty}=1$ and $\{a(n)\}$ a sequence of positive integers going to infinity. Let $\left\{M_{a}^{\alpha,(i)}(k, n)\right\}_{0 \leq k \leq a(n), n \geq 1}$, $i=1,2$, and $\left\{M_{a}^{a,(2)}(k)\right\}_{k \geq 0}$ be those matrices satisfying the following conditions;
$\left\{M_{a}^{\alpha,(1)}(k, n)\right\}$ satisfy the conditions in Lemma $4.2,\left\{M_{a}^{\alpha,(2)}(k, n)\right\}$ and $\left\{M_{a}^{a,(2)}(k)\right\}$ satisfy the conditions in Lemma 4.1 and

$$
\begin{equation*}
O \leqq M_{a}^{\alpha,(1)}(k, n)+M_{a}^{\alpha,(2)}(k, n) \leqq M_{\alpha}^{a}, 0 \leqq k \leqq a(n), n \leqq 1 . \tag{4.25}
\end{equation*}
$$

Then we have

\begin{equation*}
\lim _{n \rightarrow \infty} \prod_{k=0}^{a(n)}\left(M_{\alpha}^{\alpha}-M_{a}^{\alpha,(1)}(k, n)-M_{\alpha}^{\alpha,(2)}(k, n)\right)=e^{-c(\alpha)} \boldsymbol{u}^{\infty} \otimes \boldsymbol{w}_{\alpha} \tag{4.26}
\end{equation*}
$$

where

$$
\begin{align*}
& c(\alpha)=\lim _{n \rightarrow \infty} \sum_{k=0}^{a(n)} v_{\alpha} M_{a}^{\alpha,(1)}(k, n) \boldsymbol{u}^{\infty},  \tag{4.27}\\
& \boldsymbol{w}_{a}=\boldsymbol{v}_{a} \cdot \lim _{n \rightarrow \infty} \prod_{k=0}^{n}\left(M_{a}^{\alpha}-M_{a}^{\alpha,(2)}(k)\right) \tag{4.28}
\end{align*}
$$

Proof. As before we omit the suffix $\alpha$. Fix $m$ arbitrarily and set

$$
\left\{\begin{array}{l}
M(k, n)=M^{(1)}(k, n)+M^{(2)}(k, n), L(m, n)=\prod_{k=0}^{m-1}(M-M(k, n))  \tag{4.29}\\
Q(m, n)=\prod_{k=m}^{a(n)}(M-M(k, n)), Q^{(1)}(m, n)=\prod_{k=m}^{a(n)}\left(M-M^{(1)}(k, n)\right)
\end{array}\right.
$$

Then we have

$$
\begin{align*}
& \prod_{k=0}^{a(n)}(M--M(k, n))=Q(m, n) L(m, n)  \tag{4.30}\\
& \lim _{n \rightarrow \infty} L(m, n)=\prod_{k=0}^{m-1}\left(M-M^{(2)}(k)\right) \tag{4.31}
\end{align*}
$$

By Lemma 4.2,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} Q^{(1)}(m, n)=e^{-c(\alpha)} P \tag{4.32}
\end{equation*}
$$

and by a calculation similar to (4.8),

$$
\begin{align*}
O & \leqq Q^{(1)}(m, n)-Q(m, n)  \tag{4.33}\\
& =\sum_{k=m}^{a(n)}\left(\prod_{l=k+1}^{a(n)}(M-M(l, n))\right) M^{(2)}(k, n)\left(\prod_{l=m}^{k-1}\left(M-M^{(1)}(l, n)\right)\right) \\
& \leqq \sum_{k=m}^{a(n)} M^{a(n)-k} M^{(2)}(k, n) M^{k-m} .
\end{align*}
$$

Hence

\begin{align*}
e^{-c(a)} P_{j}^{i} & \geqq \varlimsup_{n \rightarrow \infty} Q_{j}^{i}(m, n) \geqq \varliminf_{n \rightarrow \infty} Q_{j}^{i}(m, n)  \tag{4.34}\\
& \geqq e^{-c(a)} P_{j}^{i}-\sum_{k=m}^{\infty}\left(P M^{(2)}(k) M^{k-m}\right)_{j}^{j}
\end{align*}
$$

Since $\lim _{m \rightarrow \infty} \sum_{k=m}^{\infty} M^{(2)}(k)=O$, it follows from (4.31) and (4.34) that

$$
\begin{aligned}
& \lim _{n \rightarrow \infty} \prod_{k=0}^{a(n)}(M-M(k, n))=\lim _{m \rightarrow \infty} \lim _{n \rightarrow \infty} Q(m, n) L(m, n) \\
= & e^{-c(\alpha)} P \cdot \lim _{m \rightarrow \infty} \prod_{k=0}^{m-1}\left(M-M^{(2)}(k)\right)=e^{-c(\alpha)} \boldsymbol{u} \otimes \boldsymbol{w} .
\end{aligned}
$$

Finally we shall generalize Theorem 3.1. This lemma will be often used in later sections.

Lemma 4.4. Let $\alpha$ be fixed and $\{a(n)\}$ a sequence of positive integers going to infinity. Assume that $\{M(k, n)\}_{0 \leqq k \leq a(n), n \geq 1}$ satisfy

O \leqq M_{\gamma}^{\beta}(k, n) \leqq M_{\gamma}^{\beta} \text { for any } \beta, \gamma \leqq \alpha \text { and } 0 \leqq k \leqq a(n), n \geqq 1, \tag{4.35}
\end{equation*}
$$

$$
\begin{align*}
& \lim _{n \rightarrow \infty} \max _{0 \leqq k \leqq a(n)} m_{j}^{i}(k, n)=0 \quad \text { for any } i, j \in \bigcup_{\gamma \leqq \alpha} C_{\gamma},  \tag{4.36}\\
& \lim _{n \rightarrow \infty} \sum_{k=0}^{a(n)} M_{\gamma}^{\gamma}(k, n)=O \quad \text { for any } \gamma \leqq \alpha \text { with } \rho_{\gamma}=1 .
\end{align*}
$$

Then, for any $\gamma \leqq \beta \leqq \alpha$, the following statements are valid.
(i) If $\nu(\gamma, \beta)=0$, then

$$
\begin{align*}
& \lim _{n \rightarrow \infty}\left(\prod_{k=0}^{m}(M-M(k, n))\right)_{\gamma}^{\beta}=\left(M^{m+1}\right)_{\gamma}^{\beta}, m \geqq 0,  \tag{4.38}\\
& \lim _{n \rightarrow \infty} \sum_{k=0}^{a(n)}\left(\prod_{l=0}^{k-1}(M-M(l, n))\right)_{\gamma}^{\beta}=\sum_{k=0}^{\infty}\left(M^{k}\right)_{\gamma}^{\beta} . \tag{4.39}
\end{align*}
$$

(ii) If $\nu(\gamma, \beta) \geqq 1$, then

$$
\begin{equation*}
\lim _{n \rightarrow \infty} a(n)^{-v(\gamma, \beta)+1}\left(\prod_{k=0}^{a(n)}(M-M(k, n))\right)_{\gamma}^{\beta}=M_{\gamma}^{* \beta} \tag{4.40}
\end{equation*}
$$

Proof. (4.38) is obvious and (4.39) follows from (3.8), (4.38) and the
dominated convergence theorem. We next prove (4.40). In fact we shall show the following relation by induction; if $\nu(\gamma, \beta) \geqq 1$, then for any $b(n) \leqq a(n)$ such that $\lim _{n \rightarrow \infty} b(n)=\infty$,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} b(n)^{-v(\gamma, \beta)+1}\left(\prod_{k=0}^{b(n)}(M-M(k, n))\right)_{\gamma}^{\beta}=M_{\gamma}^{* \beta} . \tag{4.41}
\end{equation*}
$$

If $\beta$ is a minimal element, then $\rho_{\beta}=1$ and $\beta=\gamma$. In this case, (4.41) is nothing but (4.12) in Lemma $4.2(c(\beta)=0)$. For general $\beta(\leqq \alpha)$, we have to show (4.41), assuming that $\lim _{n \rightarrow \infty} c(n)^{-\nu(\gamma, \delta)+1}\left(\prod_{k=0}^{c(n)}(M-M(k, n))\right)_{\gamma}^{\delta}=M_{\gamma}^{*_{\gamma}^{\delta}}$ for any $\gamma \leqq \delta<\beta$ with $\nu(\gamma, \delta) \geqq 1$ and any $c(n) \leqq a(n)$ with $\lim _{n \rightarrow \infty} c(n)=\infty$. This is proved in a way similar to the proof of Theorem 3.1 by using, instead of (3.7), the following formula;

$$
\begin{align*}
& \left(\prod_{k=0}^{m}(M-M(k, n))\right)_{\gamma}^{\beta}  \tag{4.42}\\
= & \sum_{k=0}^{m} \sum_{r \leqq \delta<\beta}\left(\prod_{l=m-k+1}^{m}\left(M_{\beta}^{\beta}-M_{\beta}^{\beta}(l, n)\right)\right)\left(M_{\delta}^{\beta}-M_{\delta}^{\beta}(m-k, n)\right) \\
& \left(\prod_{l=0}^{m-k-1}(M-M(l, n))\right)_{\gamma}^{\delta}, \gamma<\beta .
\end{align*}
$$

For example, if $\rho_{\beta}<1$ and $\nu(\gamma, \beta) \geqq 1$, then we have

\begin{aligned}
\lim _{n \rightarrow \infty} b(n)^{-\nu(\gamma, \beta)+1}\left(\prod_{k=0}^{b(n)}(M-M(k, n))\right)_{\gamma}^{\beta} & =\sum_{\substack{r \leq \delta<\beta \\
\nu(r, \delta)=\nu(r, \beta)}}\left(I-M_{\beta}^{\beta}\right)^{-1} M_{\delta}^{\beta} M_{\gamma}^{* \delta} \\
& =M_{\gamma}^{* \beta},
\end{aligned}
$$

where the last equality is due to (3.13) in Theorem 3.1. The cases when $\rho_{\beta}=1, \nu(\gamma, \beta)=1$ and $\rho_{\beta}=1, \nu(\gamma, \beta) \geqq 2$ are proved similarly.

## 5. An auxiliary limit theorem

Let $\nu$ be a nonnegative integer and $i \in C_{\beta}, \beta \leqq \alpha$. An important step for the fundamental limit theorem is to estimate

1-E_{e^{i}}\left[\exp \left(-\sum_{\gamma \leqq \beta} \sum_{j \in C_{\gamma}} n^{-\nu(\gamma, \alpha)-\nu+1} \lambda^{j} Z_{j}(k)\right)\right] . \tag{5.1}
\end{equation*}
$$

Let $\boldsymbol{X}$ be a random vector taking values in $\boldsymbol{R}_{+}^{d}$. The Laplace transform and the logarithmic Laplace transform of $\boldsymbol{X}$ (or the distribution of $\boldsymbol{X}$ ) are defined by

$$
\begin{aligned}
& f(\boldsymbol{\lambda})=E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}\right)\right] \\
& \psi(\boldsymbol{\lambda})=-\log E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}\right)\right]
\end{aligned} \text { for } \boldsymbol{\lambda} \in \boldsymbol{R}_{+}^{d} .
$$

We need the following facts from the general theory of Laplace transform.
Lemma 5.1. Let $\{\boldsymbol{X}(n)\}$ be a sequence of random vectors taking values in $\boldsymbol{R}_{+}^{d}$ and $\{a(n)\}$ a sequence of positive numbers increasing to infinity.
(i) If $\left\{a(n) \sum_{i=1}^{d} E\left[X_{i}(n)\right]\right\}$ is bounded, then

$$
\begin{equation*}
\psi_{n}(\lambda)=a(n)\left(1-E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}(n)\right)\right]\right) \tag{5.2}
\end{equation*}
$$

is uniformly bounded and equicontinuous in $\boldsymbol{\lambda}$ on compact subsets of $\boldsymbol{R}_{+}^{d}$.
(ii) The sequence (5.2) is convergent if and only if $E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}(n)\right)\right]^{a(n)}$ is convergent. In this case, the limit

$$
\begin{align*}
\psi(\lambda) & =\lim _{n \rightarrow \infty} a(n)\left(1-E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}(n)\right)\right]\right)  \tag{5.3}\\
& =-\lim _{n \rightarrow \infty} a(n) \log E\left[\exp \left(-\sum_{i=1}^{d} \lambda^{i} X_{i}(n)\right)\right]
\end{align*}
$$

is the logarithmic Laplace transform of an infinitely divisible distribution on $\boldsymbol{R}_{+}^{d}$, if $\psi(\boldsymbol{\lambda})$ is continuous. Then the convergence of (5.3) is uniform on compact sets of $\boldsymbol{R}_{+}^{d}$, so that for $\boldsymbol{\lambda}_{\boldsymbol{n}} \rightarrow \boldsymbol{\lambda}$ we have

$$
\begin{equation*}
\psi(\lambda)=\lim _{n \rightarrow \infty} a(n)\left(1-E\left[\exp \left(-\sum_{i=1}^{d} \lambda_{n}^{i} X_{i}(n)\right)\right]\right) \tag{5.4}
\end{equation*}
$$

(iii) Given a continuous function $\psi(\boldsymbol{\lambda})$ on $\boldsymbol{R}_{+}^{d}$ with $\psi(\mathbf{0})=0$, suppose that (5.3) holds for $\boldsymbol{\lambda}$ such that $\lambda^{i}>0$ for all $i$. Then, (5.3) holds for any $\boldsymbol{\lambda} \in \boldsymbol{R}_{+}^{d}$ and hence the conclusions of (ii) are valid.

We shall give several estimates of (5.1).
Lemma 5.2. Let $i \in C_{a}, \nu \geqq 0$ and $t>0$. Then there exists $c>0$ and $0<\rho<1$ such that

$$
\begin{align*}
& 1-E_{e^{i}}\left[\exp \left(-\sum_{r \leqq \alpha} \sum_{j \in C_{\gamma}} n^{-\nu(\gamma, \alpha)-\nu+1} \lambda^{j} Z_{j}(k)\right)\right]  \tag{5.5}\\
& \leqq c n^{-\nu} \sum_{\nu(\gamma, \alpha) \geqq} \sum_{j \in C_{\gamma}} \lambda^{j}+c n^{-\nu+1} \rho^{k} \sum_{\nu(r, \alpha)=0} \sum_{j \in C_{\gamma}} \lambda^{j}, \\
& 0 \leqq k \leqq[n t] .
\end{align*}
$$

Proof. Since 1-exp $(-r) \leqq r$ on $\boldsymbol{R}_{+}$, we have

$$
\begin{align*}
1- & E_{e^{i}}\left[\exp \left(-\sum_{r \leqq \alpha} \sum_{j \in C_{\gamma}} n^{-v(\gamma, \alpha)-\nu+1} \lambda^{j} Z_{j}(k)\right)\right]  \tag{5.6}\\
& \leqq \sum_{\gamma \leqq \alpha} \sum_{j \in C_{\gamma}} n^{-v(\gamma, \alpha)-\nu+1} \lambda^{j} E_{e^{i}}\left[Z_{j}(k)\right] \\
& =\sum_{\gamma \leqq \alpha} \sum_{j \in C_{\gamma}} n^{-\nu(\gamma, \alpha)-\nu+1} \lambda^{j} m_{j}^{i,(k)}
\end{align*}
$$

By Theorem 3.1, there exists $c>0$ and $0<\rho<1$ such that for any $k \geqq 0$ and $j \in C_{\gamma}$,

$$
\begin{cases}m_{j}^{i,(k)} \leqq c \rho^{k} & \text { if } \nu(\gamma, \alpha)=0  \tag{5.7}\\ m_{j}^{i,(k)} \leqq c(k+1)^{v(\gamma, \alpha)-1} & \text { if } \nu(\gamma, \alpha) \geqq 1 .\end{cases}
$$

(5.5) is an easy consequence of (5.6) and (5.7).

Lemma 5.3. Let $\beta \leqq \alpha, i \in C_{\beta}, \nu \geqq 0$ and $t>0$.
(i) If $\rho_{\beta}=1$, then there exists $c>0$ such that

\begin{align*}
& 1-E_{e^{i}}\left[\exp \left(-\sum_{\gamma \leqq \beta} \sum_{j \in C_{\gamma}} n^{-v(\gamma, \alpha)-\nu+1} \lambda^{j} Z_{j}(k)\right)\right]  \tag{5.8}\\
& \quad \leqq c n^{-v(\beta, \alpha)-\nu+1} \sum_{\gamma \leqq \beta} \sum_{j \in C_{\gamma}} \lambda^{j}, 0 \leqq k \leqq[n t]
\end{align*}
$$

(ii) If $\rho_{\beta}<1$, then there exists $c>0$ and $0<\rho<1$ such that

$$
\begin{array}{ll}
1-E_{e^{i}}\left[\operatorname { e x p } \left(-\sum_{\gamma \leqq \beta}\right.\right. & \left.\left.\sum_{j \in C_{\gamma}} n^{-\nu(\gamma, \alpha)-\nu+1} \lambda^{j} Z_{j}(k)\right)\right]  \tag{5.9}\\
\leqq c n^{-\nu(\beta, \alpha)-\nu} \sum_{\nu(\gamma, \beta)} \sum_{j \in C_{\gamma}} \lambda^{j}+c n^{-\nu(\beta, \alpha)-\nu+1} \rho^{k} \sum_{\nu(\gamma, \beta)=0} \sum_{j \in C_{\gamma}} \lambda^{j}, \\
0 \leqq k \leqq[n t]
\end{array}
$$

Proof. For any $\gamma \leqq \beta \leqq \alpha$, we have

$$
\begin{array}{ll}
\nu(\gamma, \beta)+\nu(\beta, \alpha) \leqq \nu(\gamma, \alpha)+1 & \text { if } \rho_{\beta}=1 \\
\nu(\gamma, \beta)+\nu(\beta, \alpha) \leqq \nu(\gamma, \alpha) & \text { if } \rho_{\beta}<1 \tag{5.11}
\end{array}
$$

Therefore

-\nu(\gamma, \alpha)-\nu+1 \leqq-\nu(\gamma, \beta)-(\nu(\beta, \alpha)+\nu-1)+1 & \text { if } \rho_{\beta}=1 \\
-\nu(\gamma, \alpha)-\nu+1 \leqq-\nu(\gamma, \beta)-(\nu(\beta, \alpha)+\nu)+1 & \text { if } \rho_{\beta}<1

Hence we obtain (5.8) (resp. (5.9)) by taking $\nu(\beta, \alpha)+\nu-1$ (resp. $\nu(\beta, \alpha)+\nu)$ for $\nu$ in (5.5).

If $\rho_{\beta}=1$ and $\beta \in A_{1}$, there is no $\delta$ such that $\delta<\beta, \delta \in A_{1}$. Hence the first case on the right hand side of (9.8) is valid by Lemma 7.1. The second equality is (9.7) itself. The third case is also obvious, since there is no $\delta \leqq \beta, \delta \in A_{1}$ if $\beta \notin$ $A_{1}$. Let $\boldsymbol{e}(\boldsymbol{\lambda})=\left(\exp \left(-\lambda^{i}\right)\right)_{1 \leqq i \leq d}$ and define $\boldsymbol{\lambda}_{0}$ by

## 10. More on conditioning

In this section we shall extend Theorem 2.4 and 2.5 in the present paper and Theorem 5.1 in [5] by the method of Ogura [5].

For each $k \geqq 1$, let

(i) Let $C_{N}$ be a critical class. Then for each $i \in C_{N}$ there exists

$I_{i}(\boldsymbol{\lambda})$ is the Laplace transform of a probability measure on $\boldsymbol{R}_{+}^{d}$ and is represented as follows;

Note that $I(\boldsymbol{\lambda})$ and $I_{i}(\boldsymbol{\lambda})$ depend only on ( $\left.\lambda^{i} ; i \in C_{a}, \nu(\alpha) \geqq k\right)$. The case of $k=1$ is nothing but Theorem 2.4 and 2.5. The case of $k=\max _{1 \leqq \alpha \leqq N} \nu(\alpha)$ was shown in Theorem 5.1 of [5], although Ogura [5] uses more complicated recurrence formulas than ours. The simplification of recurrence formulas is due to the recurrence formula (3.13) for $m^{* t}$ (see the proof of Lemma 10.1).

Actually we can prove a little more than Theorem 10.1. Let $\alpha \in A_{k}$ and $i \in C_{a}$. As in section 9 we have

The following three lemmas enable us to find the limit of (10.10). Taking $\alpha=$ $N$ we obtain (10.3) and (10.8). The first two lemmas are esesntially due to Ogura [5]. Set

Lemma 10.3 is a consequence of Lemma 10.1 and 10.2 , if Lemma 7.2 is applicable to this case. Since $\psi_{\alpha}^{k}(\boldsymbol{\lambda})$ depends only on $\left(\lambda^{\beta}\right)_{\nu(\beta) \geq k}$, write $\psi_{\alpha}^{k}(\lambda)=$ $\psi_{a}^{k}\left(\lambda^{\gamma}\right.$ for $\nu(\gamma)>k, \lambda^{\beta}$ for $\left.\nu(\beta)=k\right)$. It is enough to show that

Although our substantial task is to prove (10.19) and our recurrence formula (10.6), we will outline the whole proof.

Proof of Lemma 10.1. By Lemma 5.1 (iii) we have only to consider the case when $\lambda^{j}>0,1 \leqq j \leqq d$. The relation (10.12) for $\nu(\alpha)=k$ and (10.13) for $\nu(\alpha)$ $=k-1$ have been already shown in Lemma 8.1. For general $\alpha \in A_{k}$, we use induction with respect to the partial order $<$.

First we shall show (10.13). Let $\alpha$ with $\rho_{\infty}<1$ and $\nu(\alpha)=l(\leqq k-2)$ be fixed. Assume that (10.12) is valid for any $\alpha^{\prime}<\alpha$ such that $\rho_{\alpha^{\prime}}=1, \alpha^{\prime} \in A_{k}$, and (10.13) is valid for any $\alpha^{\prime}<\alpha$ such that $\rho_{\alpha^{\prime}}<1, \alpha^{\prime} \in A_{k}$. \lim _{n \rightarrow \infty} n^{\mu} c_{n}=B_{x} \psi_{a}^{k}(\boldsymbol{\lambda})^{2}>0,  \tag{10.28}\\
\lim _{n \rightarrow \infty} b_{n}=B_{\alpha}>0,  \tag{10.29}\\
\lim _{n \rightarrow \infty}\left(a_{n}\right)^{-1}\left(\mathbf{1}^{\infty}-\boldsymbol{F}^{\alpha}\left(n: \boldsymbol{e}_{n}(\boldsymbol{\lambda})\right)\right)=\boldsymbol{u}^{\infty} . \tag{10.30}
\end{gather*}
$$

By (10.27), (10.28) and (10.29) we can apply Lemma 4.6 of [5] to obtain

\lim _{n \rightarrow \infty} n^{\mu / 2} a_{n}=\left\{B_{a}^{-1} \cdot B_{a} \psi_{a}^{k}(\lambda)^{2}\right\}^{1 / 2}=\psi_{a}^{k}(\lambda) \tag{10.31}
\end{equation*}
$$

This, combined with (10.30), proves (10.12).
It remains to prove relations (10.27) to (10.30). First of all, by (5.31) of [5], there exists some $c>0$ such that
(10.32) $\quad F^{i}\left(n+1: \boldsymbol{e}_{n+1}(\lambda)\right)-F^{i}\left(n+1: \boldsymbol{e}_{n}(\lambda)\right) \leqq c n^{-1}\left(1-F^{i}\left(n+1: \boldsymbol{e}_{n+1}(\lambda)\right), i \in C_{\infty}\right.$.

We shall prove (10.27) (which is equivalent to (10.19)). Set $a=\varlimsup_{n \rightarrow \infty} a_{n}$. Then we can choose a subsequence $\left\{n_{j}\right\}$ so that

\end{equation*}

and there exists

\boldsymbol{\xi}_{(k)}^{\alpha}=\lim _{j \rightarrow \infty}\left(\mathbf{1}^{\alpha}-\boldsymbol{F}^{\alpha}\left(n_{j}-k: \boldsymbol{e}_{n_{j}-k}(\boldsymbol{\lambda})\right)\right), \tag{10.34}
\end{equation*}
$$

for every $k \geqq 0$. Substituting $\boldsymbol{s}=\boldsymbol{F}\left(n_{j}-1: \boldsymbol{e}_{n_{j-1}}(\lambda)\right)$ in (5.17), we have

\begin{align*}
& \mathbf{1}^{\infty}-\boldsymbol{F}^{\alpha}\left(n_{j}: \boldsymbol{e}_{n_{j}-1}(\boldsymbol{\lambda})\right)  \tag{10.35}\\
= & \left(M_{\alpha}^{\alpha}-M_{\alpha}^{\alpha}\left(\boldsymbol{F}\left(n_{j}-1: \boldsymbol{e}_{n_{j-1}}(\boldsymbol{\lambda})\right)\right)\right)\left(\mathbf{1}^{\infty}-\boldsymbol{F}^{\alpha}\left(n_{j}-1: \boldsymbol{e}_{n_{j}-1}(\boldsymbol{\lambda})\right)\right) \\
& +\sum_{\beta<\alpha}\left(M_{\beta}^{\alpha}-M_{\beta}^{\alpha}\left(\boldsymbol{F}\left(n_{j}-1: \boldsymbol{e}_{n_{j-1}}(\boldsymbol{\lambda})\right)\right)\right)\left(\mathbf{1}^{\beta}-\boldsymbol{F}^{\beta}\left(n_{j}-1: \boldsymbol{e}_{n_{j-1}}(\boldsymbol{\lambda})\right)\right) .
\end{align*}
$$

By (10.23) and (10.33) we get

\boldsymbol{\xi}_{(0)}^{\alpha}=\left(M_{\alpha}^{\alpha}-M_{\alpha}^{\alpha}\left(\mathbf{1}^{\alpha}-\boldsymbol{\xi}_{(1)}^{\alpha}\right)\right) \boldsymbol{\xi}_{(1)}^{\alpha},  \tag{10.36}\\
a=\boldsymbol{v}_{a} \boldsymbol{\xi}_{(0)}^{\alpha}=\boldsymbol{v}_{a} \boldsymbol{\xi}_{(1)}^{\alpha}-\boldsymbol{v}_{\alpha} M_{\alpha}^{\alpha}\left(\mathbf{1}^{\alpha}-\boldsymbol{\xi}_{(1)}^{\alpha}\right) \boldsymbol{\xi}_{(1)}^{\alpha}  \tag{10.37}\\
\leqq a-\boldsymbol{v}_{\alpha} M_{a}^{\alpha}\left(\mathbf{1}^{\alpha}-\boldsymbol{\xi}_{(\mathrm{I})}^{\alpha}\right) \boldsymbol{\xi}_{(1)}^{\alpha} .
\end{gather*}
$$

Therefore $\boldsymbol{v}_{a} M_{a}^{\alpha}\left(\mathbf{1}^{\alpha}-\boldsymbol{\xi}_{(1)}^{\alpha}\right) \boldsymbol{\xi}_{(1)}^{\alpha}=0$ and hence

Similarly we have

\end{equation*}

Repeating this argument we obtain

\boldsymbol{\xi}_{(1)}^{\alpha}=\left(M_{a}^{\alpha}\right)^{k} \boldsymbol{\xi}_{(k+1)}^{\alpha}, a=\boldsymbol{v}_{a} \boldsymbol{\xi}_{(k+1)}^{\alpha}, k \geqq 0 . \tag{10.41}
\end{equation*}
$$

Then, by (3.3), is follows that

\end{equation*}

If $a>0$, then $\mathbf{1} \geqq \boldsymbol{\xi}_{(1)}^{a}>\mathbf{0}$. But since $C_{a}$ is a critical class we have $\boldsymbol{m}_{j}^{i}\left(\mathbf{1}^{\infty}-\boldsymbol{\xi}_{(1)}^{a}\right)>0$ for some $i, j \in C_{a}$. This contradicts to (10.38).

Next we shall show (10.28). By (10.27) and (10.32), $\lim _{n \rightarrow \infty} \boldsymbol{v}_{\alpha}\left(\boldsymbol{F}^{\alpha}\left(n+1: \boldsymbol{e}_{n}(\boldsymbol{\lambda})\right)\right.$ $-\boldsymbol{F}^{a}\left(n+1: \boldsymbol{e}_{n+1}(\boldsymbol{\lambda})\right)=0$. Therefore by (10.23),
(10.43) $\lim _{n \rightarrow \infty} n^{\mu} c_{n}$

$$
\begin{aligned}
& =\sum_{\substack{\beta<\alpha \\
\nu(\beta)=\nu(\alpha)}} \boldsymbol{v}_{\alpha} M_{\beta}^{\alpha} \sum_{\substack{\nu(\gamma)=\nu(\beta)+1 \\
\rho_{\gamma}=1}} \psi_{\gamma}^{k}(\lambda) M^{*}{ }_{\gamma}^{\gamma} \boldsymbol{u}^{\gamma} \\
& +\sum_{\substack{\nu(\beta)=\nu(\alpha)+1 \\
\rho_{\beta}=1}} \psi_{\beta}^{k}(\lambda) \boldsymbol{v}_{\alpha} M_{\beta}^{\alpha} u^{\beta} \\
& =\sum_{\substack{\nu(\beta)=\nu(\alpha)+1 \\
\rho_{\beta}=1}} \psi_{\beta}^{k}(\lambda) \boldsymbol{v}_{a}\left(\sum_{\substack{\beta<\gamma<\alpha \\
\nu(\beta, r)=\nu(\beta, \alpha)=1}} P_{\alpha}^{\alpha} M_{\gamma}^{\alpha} M_{\beta}^{* \gamma}+P_{\alpha}^{\alpha} M_{\beta}^{\alpha} P_{\beta}^{\beta}\right) u^{\beta} \\
& =\sum_{\substack{\nu(\beta)=\nu(\alpha)+1 \\
\rho_{\beta}=1}} \psi_{\beta}^{k}(\lambda) v_{a} M_{\beta}^{* \alpha} u^{\beta}=B_{a} \psi_{\alpha}^{k}(\lambda)^{2},
\end{aligned}
$$

where the third equality follows from (3.12) and the last equality is due to the definition (10.6) and (10.7) for $\psi_{\alpha}^{k}(\boldsymbol{\lambda})$. Hence we have proved (10.28).

By (10.26), (10.27), (10.28) and the boundedness of $\left\{b_{n}\right\}$ we have $\lim _{n \rightarrow \infty} n^{\mu} a_{n}=$ $\varliminf_{n \rightarrow \infty} n^{\mu} a_{n+1}=\varliminf_{n \rightarrow \infty}\left\{n^{\mu} a_{n}\left(1-a_{n} b_{n}\right)+n^{\mu} c_{n}\right\}=\varliminf_{n \rightarrow \infty} n^{\mu} a_{n}+B_{\infty} \psi_{\alpha}^{k}(\lambda)^{2}$. This means that $\lim _{n \rightarrow \infty} n^{\mu} a_{n}=\infty$. Therefore by (10.23) we see that $\lim _{n \rightarrow \infty} \frac{\mathbf{1}^{\beta}-\boldsymbol{F}^{\beta}\left(n: \boldsymbol{e}_{n}(\boldsymbol{\lambda})\right)}{\boldsymbol{v}_{a}\left(\mathbf{1}^{\infty}-\boldsymbol{F}^{\omega}\left(n: \boldsymbol{e}_{n}(\boldsymbol{\lambda})\right)\right)}=\mathbf{0}$ for any $\beta<\alpha$. Then, as in the latter half of the proof of Lemma 6.1, we obtain (10.30). Therefore $\lim _{n \rightarrow \infty} b_{n}=B_{a}>0$ by definition of $b_{n}$.

For the proof of Lemma 10.2 we remark that as in Lemma 9.1, for any $\beta \leqq$ $\alpha$,

where $\boldsymbol{e}(\boldsymbol{\lambda})=\left(\exp \left(-\lambda^{i}\right)\right)_{1 \leq i \leq d}$ and $\boldsymbol{\lambda}_{0}$ is defined by

Then the proof of Lemma 10.2 is the same as that of Lemma 10.1.

## 11. Examples

In the first three examples, the mean matrix is assumed to have the form

& & \ddots & \ddots & \\
& 0 & 1 & 1 & 0 \\

Then it is easy to see that

C_{i}=\{i\}, \rho_{i}=1  \tag{11.2}\\
1<2<\cdots<d  \tag{11.3}\\
\nu(j, i)= \begin{cases}i-j+1 & \text { if } i \geqq j \\
-1 & \text { if } i<j\end{cases} \tag{11.4}
\end{gather*}
$$

and

$$
m_{j}^{* i}=\lim _{n \rightarrow \infty} n^{-\nu(j, i)+1} m_{j}^{i,(n)}= \begin{cases}\frac{1}{(i-j)!} & \text { if } i \geqq j  \tag{11.5}\\ 0 & \text { if } i<j\end{cases}
$$

Let $f(s)$ be a one-dimensional generating function such that

f^{\prime}(1)=1, f^{\prime \prime}(1)=2 B>0 \tag{11.6}
\end{equation*}
$$

Recall that $s, \boldsymbol{\lambda}$ denotes the $d$-dimensional vectors; $s=\left(s^{i}\right)_{1 \leqq i \leqq d}, 0 \leqq s^{i} \leqq 1$ and $\boldsymbol{\lambda}=$ $\left(\lambda^{i}\right)_{1 \leqq i}{ }^{3}, \lambda^{i} \geqq 0$.

Example 1. Let $F^{1}(s)=f\left(s^{1}\right), F^{i}(s)=s^{i-1} f\left(s^{i}\right), 2 \leqq i \leqq d-1$ and $F^{d}(s)=s^{d-1} s^{d}$. Then $C_{i}(i \leqq d-1)$ is a critical class and $C_{d}$ is a final class. We have $a_{i, j}=$ $\frac{1}{(i-j-1)!}, b_{i, j}=\frac{1}{(i-j)!} . \quad$ By Theorem 2.1, we get

\begin{equation*}
\psi_{i}(t, \lambda)=\lim _{n \rightarrow \infty} n\left(1-E_{e^{i}}\left[\exp \left(-\sum_{j=1}^{i} n^{-i+j-1} \lambda^{j} Z_{j}([n t])\right)\right]\right), \tag{11.7}
\end{equation*}
$$

and $\psi_{i}(t, \boldsymbol{\lambda})$ is the solution of

$$
\left\{\begin{array}{l}
\frac{d}{d t} \psi_{i}(t, \lambda)=-B \psi_{i}(t, \lambda)^{2}+\sum_{j=1}^{i-1} \frac{\lambda^{j}}{(i-j-1)!} t^{i-j-1}  \tag{11.8}\\
\psi_{i}(0, \lambda)=\lambda^{i}
\end{array}\right.
$$

for $i \leqq d-1$.
It is easy to see that $\bar{\psi}_{i}=\psi_{i}$. Then by Theorem 2.3 we obtain

$$
\begin{equation*}
\lim _{n \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\sum_{j=1}^{d} n^{j-d} \lambda^{j} Z_{j}(n)\right)\right]=\exp \left(-\int_{0}^{1} \psi_{d-1}(t, \lambda) d t\right) e^{-\lambda^{d}} \tag{11.9}
\end{equation*}
$$

This is already given in [2] by a different formulation.
In case it is necessary to distıngursh $\psi_{i}$ for varıous $d^{\prime} s$, we shall write $\psi_{d, i}$, $i=1,2, \cdots$.

If $d=2$ or 3 , we can solve (11.8) explicitly for $i=d-1$; if $d=2$,

\end{equation*}
$$

$$
\begin{equation*}
\lim _{n \rightarrow \infty} E_{e^{2}}\left[\exp \left(-n^{-1} \lambda^{1} Z_{1}(n)-\lambda^{2} Z_{2}(n)\right)\right]=\left(1+B \lambda^{1}\right)^{-1 / B} e^{-\lambda^{2}}, \tag{11.11}
\end{equation*}
$$ and if $d=3$,

$$
\begin{gather*}
\psi_{3,2}(t, \lambda)=\sqrt{\frac{\lambda^{1}}{B}} \frac{\sqrt{B} \lambda^{2} \cosh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \sinh \left(\sqrt{B \lambda^{1}} t\right)}{\sqrt{B} \lambda^{2} \sinh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \cosh \left(\sqrt{B \lambda^{1} t} t\right)},  \tag{11.12}\\
\lim _{n \rightarrow \infty} E_{e^{3}}\left[\exp \left(-\sum_{j=1}^{3} n^{j-3} \lambda^{j} Z_{j}(n)\right)\right]  \tag{11.13}\\
=\left(\cosh \left(\sqrt{B \lambda^{1}}\right)+\lambda^{2} \sqrt{\frac{B}{\lambda^{1}}} \sinh \left(\sqrt{B \lambda^{1}}\right)\right)^{-1 / B} e^{-\lambda^{3}} .
\end{gather*}
$$

Let $a_{i} \geqq 0,1 \leqq i \leqq d-1$ and $\lambda \geqq 0$. By substituting $\lambda^{j}=(d-j-2)!a_{j} \lambda,(j \leqq d-2)$, $\lambda^{d-1}=a_{d-1} \lambda, \lambda^{d}=0$ in (11.8) for $i=d-1$ and (11.9), we have

\begin{align*}
& \lim _{n \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\lambda \sum_{j=1}^{d-2} n^{j-d}(d-j-2)!a_{j} Z_{j}(n)-\lambda n^{-1} a_{d-1} Z_{d-1}(n)\right)\right]  \tag{11.14}\\
= & \exp \left(-\int_{0}^{1} \tilde{\Psi}_{d-1}(t, \lambda) d t\right),
\end{align*}
$$

where $\tilde{\psi}_{d-1}(t, \lambda)$ is the solution of

$$
\left\{\begin{array}{l}
\frac{d}{d t} \tilde{\psi}_{d-1}(t, \lambda)=-B \tilde{\psi}_{d-1}(t, \lambda)^{2}+\sum_{j=1}^{d-2} a_{j} t^{d-j-2} \lambda  \tag{11.15}\\
\widetilde{\psi}_{d-1}(0, \lambda)=a_{d-1} \lambda
\end{array}\right.
$$

If $a_{i}=0,1 \leqq i \leqq d-2$, then (11.14) is the Laplace transform of a gamma distribution. If $d \geqq 3$ and $a_{i}>0$ for some $1 \leqq i \leqq d-2$, then (11.14) is the Laplace transform of an infinitely divisible distribution with a smooth density (see [10]). A class of ordinary differential equations closely related to the infinitely divisible distributions is given in [11].

Example 2. Let $F^{1}(s)=f\left(s^{1}\right), F^{i}(s)=s^{i-1} f\left(s^{i}\right), 2 \leqq i \leqq d-2$, and $F^{i}(s)=s^{i-1} s^{i}$, $i=d-1, d$. In this case, $C_{i}(i \leqq d-2)$ is critical and $C_{i}(i=d-1, d)$ is final. By Theorem 2.1 we have

\begin{equation*}
\psi_{d-1}(t, \lambda)=\lim _{n \rightarrow \infty} n\left(1-E_{e^{d-1}}\left[\exp \left(-\sum_{j=1}^{d-1} n^{j-d} \lambda^{j} Z_{j}([n t])\right)\right]\right) \tag{11.16}
\end{equation*}
$$

where $\psi_{d-1}$ is the solution of

$$
\frac{d}{d t} \psi_{d-1}(t, \lambda)=\sum_{j=1}^{d-2} \frac{\lambda^{j}}{(d-j-2)!} t^{d-j-2}, \psi_{d-1}(0, \lambda)=\lambda^{d-1}
$$

i.e.,

$$
\psi_{d-1}(t, \lambda)=\sum_{j=1}^{d-1} \frac{\lambda^{j}}{(d-j-1)!} t^{d-j-1}
$$

Hence by Theorem 2.3,

\begin{equation*}
\lim _{n \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\sum_{j=1}^{d} n^{j-d} \lambda^{j} Z_{j}(n)\right)\right]=\exp \left(-\sum_{j=1}^{d} \frac{\lambda^{j}}{(d-j)!}\right) \tag{11.17}
\end{equation*}
$$

This is the Laplace transform of a delta measure.
Example 3. Let $F^{1}(s)=f\left(s^{1}\right), F^{i}(s)=s^{i-1} f\left(s^{i}\right), 2 \leqq i \leqq d$. Then all the classes are critical. By Theorem 2.4 we have

& \lim _{n \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\sum_{j=1}^{d} n^{-d+j-1} \lambda^{j} Z_{j}(n)\right) \mid Z_{d}(n) \neq 0\right]  \tag{11.18}\\
= & B\left(\psi_{d}^{\infty}(1, \lambda)-\psi_{d}(1, \lambda)\right)
\end{align*}
$$

where $\psi_{d}$ is the solution of

$$
\left\{\begin{array}{l}
\frac{d}{d t} \psi_{d}(t, \lambda)=-B \psi_{d}(t, \lambda)^{2}+\sum_{j=1}^{d-1} \frac{\lambda^{j}}{(d-j-1)!} t^{d-j-1}  \tag{11.19}\\
\psi_{d}(0, \lambda)=\lambda^{d}
\end{array}\right.
$$

and

$$
\begin{equation*}
\psi_{d}^{\infty}(t, \lambda)=\lim _{\lambda^{d} \rightarrow \infty} \psi_{d}(t, \lambda) \tag{11.20}
\end{equation*}
$$

This is already shown in [2] by a different formulation. If $d=1$ or 2 , then we can solve (11.19) explicitly; if $d=1$,

$$
\begin{gather*}
\psi_{1,1}(t, \lambda)=\frac{\lambda^{1}}{1+t B \lambda^{1}}, \psi_{1,1}^{\infty}(t, \lambda)=\frac{1}{t B}  \tag{11.21}\\
\lim _{n \rightarrow \infty} E_{e^{1}}\left[\exp \left(-n^{-1} \lambda^{1} Z_{1}(n)\right) \mid Z_{1}(n) \neq 0\right]=\left(1+B \lambda^{1}\right)^{-1} \tag{11.22}
\end{gather*}
$$

and if $d=2$,

$$
\left\{\begin{array}{l}
\psi_{2,2}(t, \lambda)=\sqrt{\frac{\lambda^{1}}{B}} \frac{\sqrt{B} \lambda^{2} \cosh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\bar{\lambda}^{1}} \sinh \left(\sqrt{\bar{B} \lambda^{2} \sinh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \cosh \left(\sqrt{B \lambda^{1} t} t\right)}\right.}{\psi_{2,2}^{\infty}(t, \lambda)=\sqrt{\frac{\lambda^{1}}{B}} \frac{\cosh \left(\sqrt{B \lambda^{1}} t\right)}{\sinh \left(\sqrt{B \lambda^{1}} t\right)}}, \tag{11.23}
\end{array}\right.
$$

$$
\begin{align*}
& \lim _{n \rightarrow \infty} E_{e^{2}}\left[\exp \left(-n^{-2} \lambda^{1} Z_{1}(n)-n^{-1} \lambda^{2} Z_{2}(n)\right) \mid Z_{2}(n) \neq 0\right]  \tag{11.24}\\
= & \sqrt{ } \overline{B \lambda^{1}}\left(\frac{\cosh \left(\sqrt{B \lambda^{1}}\right)}{\sinh \left(\sqrt{B \lambda^{1}}\right)}-\frac{\sqrt{B} \lambda^{2} \cosh \left(\sqrt{B \lambda^{1}}\right)+\sqrt{\lambda^{1}} \sinh \left(\sqrt{B \lambda^{1}}\right)}{\sqrt{B} \lambda^{2} \sinh \left(\sqrt{B \lambda^{1}}\right)+\sqrt{\lambda^{1}} \cosh \left(\sqrt{B \lambda^{1}}\right)}\right) .
\end{align*}
$$

Letting $k \geqq 2$, we apply Theorem 10.1. In this case, $\nu(\alpha)=k$ is valid only for $\alpha=d-k+1$. Hence

$$
\left\{\begin{array}{l}
b_{d-k+1}^{k}=B^{-1}  \tag{11.25}\\
\psi_{d-k+1}^{k}(\boldsymbol{\lambda})=\psi_{d-k+1}(1, \lambda)=\psi_{d-k+1}(1, \lambda), \\
\psi_{d-k+1}^{k, \infty}(\boldsymbol{\lambda})=\bar{\psi}_{d-k+1}^{\infty}(1, \boldsymbol{\lambda})=\psi_{d-k+1}^{\infty}(1, \boldsymbol{\lambda}),
\end{array}\right.
$$

where $\psi_{d-k+1}(t, \lambda)$ and $\psi_{d-k+1}^{\infty}(t, \lambda)$ are given by

$$
\left\{\begin{array}{l}
\frac{d}{d t} \psi_{d-k+1}(t, \lambda)=-B \psi_{d-k+1}(t, \lambda)^{2}+\sum_{j=1}^{d-k} \frac{\lambda^{j}}{(d-k-j)!} t^{d-k-j}  \tag{11.26}\\
\psi_{d-k+1}(0, \lambda)=\lambda^{d-k+1} \\
\psi_{d-k+1}^{\infty}(t, \lambda)=\lim _{\lambda^{d-k+1 \rightarrow \infty}} \psi_{d-k+1}(t, \lambda)
\end{array}\right.
$$

Recurrence formula (10.7) is given by

$$
\begin{equation*}
R_{i}\left(x_{j} ; j<i\right)=\left(B^{-1} x_{i-1}\right)^{1 / 2} \tag{11.27}
\end{equation*}
$$

It then follows that

$$
\begin{align*}
& \lim _{n \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\sum_{j=1}^{d-k+1} n^{-d+k+j-2} \lambda^{j} Z_{j}(n)-\sum_{j=d-k}^{d} n^{-1} \lambda^{j} Z_{j}(n)\right) \mid\right.  \tag{11.28}\\
= & \left(B \psi_{d-k+1}^{\infty}(1, \lambda)\right)^{2^{-k+1}}-\left(B \psi_{d-k+1}(1, \lambda)\right)^{2-k+1} .
\end{align*}
$$

If $k=d$, then $\psi_{1}(t, \lambda)=\frac{\lambda^{1}}{1+t B \lambda^{1}}$ and $\psi_{1}^{\infty}(t, \lambda)=\frac{1}{t B}$.
Therefore we have

$$
\begin{aligned}
& \lim _{u \rightarrow \infty} E_{e^{d}}\left[\exp \left(-\sum_{j=1}^{d} n^{-1} \lambda^{j} Z_{j}(n)\right) \mid\left(Z_{j}(n)\right)_{1 \leqq j \leqq d} \neq 0\right] \\
= & 1-\left(1-\frac{1}{1+B \lambda^{1}}\right)^{2^{1-d}} .
\end{aligned}
$$

The case of $d=2$ is already given in [5].
We shall give an example such that $C_{N}$ is a final class with $\# C_{N}>1$.
Example 4. Let $F^{1}(s)=f\left(s^{1}\right), F^{2}(s)=s^{1} f\left(s^{2}\right), F^{3}(s)=\frac{1}{2} f\left(s^{2}\right) s^{3}+\frac{1}{2} f\left(s^{1}\right) s^{4}$ and $F^{4}(s)=\frac{1}{4} f\left(s^{1}\right) s^{3}+\frac{3}{4} f\left(s^{2}\right) s^{4}$. Then the mean matrix is

$$
M=\left(\begin{array}{cccc}
1 & 0 & 0 & 0  \tag{11.29}\\
1 & 1 & 0 & 0 \\
\frac{1}{2} & \frac{1}{2} & \frac{1}{2} & \frac{1}{2} \\
\frac{1}{4} & \frac{3}{4} & \frac{1}{4} & \frac{3}{4}
\end{array}\right)
$$

It is easy to see that

$$
\begin{equation*}
C_{1}=\{1\}, C_{2}=\{2\}, C_{3}=\{3,4\}, \rho_{1}=\rho_{2}=\rho_{3}=1 \tag{11.30}
\end{equation*}
$$

$$
\begin{gather*}
1<2<3  \tag{11.31}\\
\nu(\beta, \alpha)= \begin{cases}\alpha-\beta+1 & \text { if } \alpha \geqq \beta \\
-1 & \text { if } \alpha<\beta,\end{cases} \tag{11.32}
\end{gather*}
$$

and by Theorem 3.1,

$$
M^{*}=\left(\begin{array}{cccc}
1 & 0 & 0 & 0  \tag{11.33}\\
1 & 1 & 0 & 0 \\
\frac{1}{3} & \frac{2}{3} & \frac{1}{3} & \frac{2}{3} \\
\frac{1}{3} & \frac{2}{3} & \frac{1}{3} & \frac{2}{3}
\end{array}\right)
$$

Obviously, $C_{1}, C_{2}$ are critical and $C_{3}$ is final. It follows from (11.33) that $a_{2,1}=$ $b_{2,1}=1$ and $c_{2}=\frac{2}{3}$. By Theorem 2.1 we get

$$
\begin{equation*}
\psi_{2}(t, \lambda)=\lim _{n \rightarrow \infty} n\left(1-E_{e^{2}}\left[\exp \left(-\sum_{j=1}^{2} n^{j-3} \lambda^{j} Z_{j}([n t])\right)\right]\right) \tag{11.34}
\end{equation*}
$$

and $\psi_{2}$ is the solution of

$$
\frac{d}{d t} \psi_{2}(t, \lambda)=-B \psi_{2}(t, \lambda)^{2}+\lambda^{1}, \psi_{2}(0, \lambda)=\lambda^{2}
$$

i.e.,

$$
\begin{equation*}
\psi_{2}(t, \lambda)=\sqrt{\frac{\lambda^{1}}{B}} \frac{\sqrt{B} \lambda^{2} \cosh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\bar{\lambda}^{1}} \sinh \left(\sqrt{B \lambda^{1} t}\right)}{\sqrt{B} \lambda^{2} \sinh \left(\sqrt{\left.\overline{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \cosh \left(\sqrt{B \lambda^{1} t}\right)}\right.} . \tag{11.35}
\end{equation*}
$$

Therefore, by Theorem 2.3, we have

$$
\begin{align*}
& \lim _{n \rightarrow \infty} E_{e^{i}}\left[\exp \left(-n^{-2} \lambda^{1} Z_{1}(n)-n^{-1} \lambda^{2} Z_{2}(n)-\lambda^{3} Z_{3}(n)-\lambda^{4} Z_{4}(n)\right)\right]  \tag{11.36}\\
&= \exp \left(-\frac{2}{3} \int_{0}^{1} \psi_{2}(t, \lambda) d t\right)\left(\frac{1}{3} e^{-\lambda^{3}}+\frac{2}{3} e^{-\lambda^{4}}\right) \\
&= \frac{1}{3}\left(\cosh \left(\sqrt{B \lambda^{1}}\right)+\lambda^{2} \sqrt{\frac{B}{\lambda^{1}}} \sinh \left(\sqrt{B \lambda^{1}}\right)\right)^{-2 / 3 B}\left(e^{-\lambda^{3}}+2 e^{-\lambda^{4}}\right), \\
& \quad \text { for } \quad i=3,4 .
\end{align*}
$$

Finally we shall give an example such that $\left\{C_{1}, \cdots, C_{N}\right\}$ is not linearly ordered.
Example 5. Let $F^{1}(s)=f\left(s^{1}\right), F^{2}(s)=s^{1} s^{2}, F^{3}(s)=s^{1} f\left(s^{3}\right)$ and $F^{4}(s)=s^{2} s^{3} s^{4}$. Then

$$
\begin{equation*}
C_{i}=\{i\}, \rho_{i}=1 \tag{11.37}
\end{equation*}
$$

$$
\begin{gather*}
1<2<4, \quad 1<3<4 \text { and neither } 2<3 \text { nor } 3<2,  \tag{11.38}\\
\nu(4)=1, \nu(3)=\nu(2)=2, \nu(1)=3 .
\end{gather*}
$$

In this case, $C_{1}$ and $C_{3}$ are critical and $C_{2}$ and $C_{4}$ are final. By Theorem 2.1 we have

$$
\begin{align*}
& \lim _{n \rightarrow \infty} n\left(1-E_{e^{i}}\left[\exp \left(-n^{-2} \lambda^{1} Z_{1}([n t])-n^{-1} \lambda^{i} Z_{i}([n t])\right)\right]\right)  \tag{11.40}\\
= & \psi_{i}(t, \lambda), i=2,3,
\end{align*}
$$

where $\psi_{2}$ and $\psi_{3}$ are the solutions of

$$
\begin{gather*}
\frac{d}{d t} \psi_{2}(t, \lambda)=\lambda^{1}, \psi_{2}(0, \lambda)=\lambda^{2}  \tag{11.41}\\
\frac{d}{d t} \psi_{3}(t, \lambda)=-B \psi_{3}(t, \lambda)^{2}+\lambda^{1}, \psi_{3}(0, \lambda)=\lambda^{3} \tag{11.42}
\end{gather*}
$$

i.e.,

$$
\begin{aligned}
& \psi_{2}(t, \lambda)=t \lambda^{1}+\lambda^{2}, \\
& \psi_{3}(t, \lambda)=\sqrt{\frac{\lambda^{1}}{B}} \frac{\sqrt{B} \lambda^{3} \cosh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \sinh \left(\sqrt{B \lambda^{1}} t\right)}{\sqrt{B} \lambda^{3} \sinh \left(\sqrt{B \lambda^{1}} t\right)+\sqrt{\lambda^{1}} \cosh \left(\sqrt{B \lambda^{1} t} t\right)} .
\end{aligned}
$$

Therefore, by Theorem 2.3, we obtain

$$
\begin{aligned}
& \lim _{n \rightarrow \infty} E_{e^{5}}\left[\exp \left(-n^{-2} \lambda^{1} Z_{1}(n)-n^{-1} \lambda^{2} Z_{2}(n)-n^{-1} \lambda^{3} Z_{3}(n)-\lambda^{4} Z_{4}(n)\right)\right] \\
= & \exp \left(-\int_{0}^{1} \psi_{2}(t, \lambda) d t\right) \exp \left(-\int_{0}^{1} \psi_{3}(t, \lambda) d t\right) \exp \left(-\lambda^{4}\right) \\
= & \exp \left(-\frac{1}{2} \lambda^{1}-\lambda^{2}-\lambda^{4}\right)\left(\cosh \left(\sqrt{B \lambda^{1}}\right)+\lambda^{3} \sqrt{\frac{B}{\lambda^{1}}} \sinh \left(\sqrt{B \lambda^{1}}\right)\right)^{-1 / B} .
\end{aligned}
$$
