# UNIFORM ASYMPTOTICS FOR REAL REDUCTIVE LIE GROUPS

Let $G$ be a real reductive Lie group, $\theta$ a Cartan involution of $G$, and $B=N_{0} A_{0} M_{0}^{1}$ a fixed minimal parabolic subgroup of $G$. Fix $H$ a $\theta$-stable Cartan subgroup of $G$, and assume that if $H=$ $H_{+} H_{-}$is the decomposition of $H$ relative to $\theta$, then $H_{-} \subset A_{0}$. Let $\chi \in \widehat{H_{+}}$, then following Harish-Chandra, we introduce the functions of type $\mathrm{II}(\chi)$. It is known that the positive chamber $A_{0}(B)$ can be covered by sectors $A_{0}(B \mid Q)$, where $Q$ varies over the maximal parabolic subgroups of $G$ which are standard with respect to $B$. Let $Q=N M$ be such a maximal parabolic for which the split component of $M$ can be conjugated by an element of $G$ into $H_{-}$. We show that given a function $\varphi(x, \lambda)$ of type $\mathbf{I I}(\chi)$ there exists an asymptotic expansion (along $Q$ ) for this function with the following properties: first the partial sums uniformly approximate the function as $\lambda$ varies over $\widehat{H_{-}}$, and $x$ varies over $A_{0}(B \mid Q)$, and second, the terms in this sum are essentially functions of type $I I(\chi)$ on an approximate Levi subgroup of $M$.

Introduction. For this introduction we shall let $G$ be a real reductive Lie group satisfying some restrictive conditions which are explained in the next section; this class of groups contains all connected semisimple groups with finite center. Fix a maximal compact subgroup $K$ of $G$, a Cartan involution $\theta$ fixing $K$ pointwise, and a finite dimensional double unitary $K$-module ( $V, \tau$ ). One of the central problems in the harmonic analysis of reductive groups has been the characterization of the Fourier transforms of the Schwartz spaces of $\tau$-spherical functions which are contained in $L^{p}(G)$, for $p \geq 1$. The inverse transform in these characterizations is defined by integrating a function on the Fourier transform side against the matrix elements of a parametrized family of representations, and showing that these so called "wavepackets" are rapidly decreasing on $G$. This analysis is therefore governed by the asymptotic behavior of the matrix elements. The estimates that one needs for these functions have to be uniform in the parameter so that one can transfer the asymptotic behavior of the matrix elements to their wavepackets.

For $p=2$, the characterization goes back to Harish-Chandra [1], [2], [5], [6], [7]. One of the fundamental techniques he used was
that of approximating the matrix elements by their so called constant term; specifically one considers series of unitary representations parametrized by the duals of certain abelian subgroups embedded in $G$. The $\tau$-spherical matrix elements of these representations are functions on $G$ which depend on a parameter in the dual group. The constant term roughly speaking is a function of the same type as the matrix element but defined on a reductive subgroup $M$ of $G$ having dimension strictly smaller than that of $G$, but of the same class as $G$; it represents the leading term describing the oscillations of the matrix elements at infinity on $G$, and the approximation is uniform in the parameter. If one wants to extend the Harish-Chandra theory and obtain the characterization of the Schwartz spaces corresponding to $L^{p}(G), p \geq 1$, the technique of the constant term is no longer adequate; it becomes necessary to construct a full asymptotic expansion at infinity. One wants a uniform asymptotic expansion for the matrix elements, which is an exponential sum with the following properties; (i) they have partial sums approximating the matrix elements very closely (in a sense we describe more fully below) uniformly as the parameter varies over the dual group, and (ii) the coefficients of the series are functions of the same type as those being approximated, but defined on the subgroup $M$ mentioned above. In Trombi and Varadarajan [1] such an expansion was obtained for the spherical principal series, thus extending the Harish-Chandra constant term (Harish-Chandra [1], [2]) for the case when $V=\mathbf{C}$, and $\tau$ is the trivial double representation. In Trombi [1] such an expansion was obtained for general ( $V, \tau$ ), but for $G$ of real rank one. This paper is the higher-rank-extension of this last paper. We shall explain the exact nature of our results presently; first we shall make some conventions and introduce some concepts and notations which we hope will facilitate the exposition.

Let $B=N_{0} M_{0}$ be a fixed minimal parabolic subgroup of $G$ such that $G=B K ; A_{0}$ will denote the split component of $M_{0}$. We adopt the convention used throughout the paper that subgroups of $G$ will have Lie algebras denoted by the corresponding lower case German letter; subspaces $\mathfrak{u}$ of $\mathfrak{g}$ will have duals denoted by $\mathfrak{u}^{*}$, and complexifications denoted by $\mathfrak{u}_{\mathbf{C}}$. If $\mathfrak{u}$ is $\theta$-invariant, then we shall write $\mathfrak{u}_{ \pm}$for the $\pm 1-\theta$-eigen subspaces of $\mathfrak{u}$. With these conventions, let $\mathfrak{h}_{0}$ be a $\theta$-stable Cartan subalgebra such that $\mathfrak{h}_{0,-}=\mathfrak{a}_{0}$. Further, we shall denote the universal enveloping algebra of $\mathfrak{g}_{\mathbf{C}}$ by $U\left(\mathfrak{g}_{\mathbf{C}}\right)$, and more generally for $\mathfrak{u}$ a subalgebra of $\mathfrak{g}$, we shall let $U\left(\mathfrak{u}_{\mathbf{C}}\right)$ denote the subalgebra of $U\left(\mathfrak{g}_{\mathbf{C}}\right)$ generated by $\mathfrak{u}_{\mathbf{C}}$ and 1 . In this case we let $\mathfrak{z}(\mathfrak{u})$ denote the center of $U\left(\mathfrak{u}_{\mathbf{C}}\right)$.

Now let us describe the unitary representations of concern to us. Fix $P$ a cuspidal parabolic subgroup of $G$ such that

P=N_{P} M_{P} \subset B, \quad \text { and } \quad G=P K .
$$

Denote the split component of $M_{P}$ by $A_{P}$ so that $\mathfrak{a}_{P} \subset \mathfrak{a}_{0}$, and $A_{P}=\exp \mathfrak{a}_{P}$ is abelian. Suppose that $\sigma$ is a discrete series representation of $M_{P}$, and $\lambda \in(-1)^{1 / 2} \mathfrak{a}_{P}^{*} \simeq \widehat{A_{P}}$. Then one can induce the representation $\sigma \otimes e^{\lambda}$ from $P$ to $G$, the tensor product being trivially extended from $M_{P}$ to $P$. The resulting unitary representation of $G$ will be referred to as a cuspidal principal series representation.

Let $\mathscr{A}_{\sigma}\left(M_{P}, \tau_{P}\right)$ denote the finite dimensional Hilbert space of $\tau_{P}$ spherical ( $\tau_{P}=\left.\tau\right|_{K \cap M_{P}}$ ) matrix elements of $\sigma$. For $\varphi \in \mathscr{A}_{\sigma}\left(M_{P}, \tau_{P}\right)$ we put

E_{P}(x, \varphi, \lambda)=\int_{K \cap M_{P} \backslash K} \tau\left(k^{-1}\right) \varphi_{P}(k x) e^{\left(\lambda+\rho_{P}\right) H_{P}(k x)} d k
$$

where $\varphi_{P}$ denotes the extension of $\varphi$ to a right $\tau$-spherical and left $N_{P}$-trivial function on $G$; recall the above equalities $G=P K=$ $N_{P} M_{P} K$. These functions will be referred to as Eisenstein integrals. From their definition it is easy to see that they are $\tau$-spherical and infinitely differentiable functions on $G$; they are the $\tau$-spherical matrix elements of the cuspidal principal series of $G$ induced from $\sigma \otimes e^{\lambda}$. These are the parametrized functions described above whose uniform approximation is the main concern of this paper.

Our expansions for an Eisenstein integral will be obtained on certain "sectors" of $G$ which we now want to describe. Let $A_{0}(B)$ denote the positive chamber in $A_{0}$ corresponding to $B$. Then we have

G=K \operatorname{cl} A_{0}(B) K .
$$

It follows that growth behaviour of $\tau$-spherical functions on $G$ is completely determined by their restrictions to the subset $\mathrm{cl} A_{0}(B)$ of the vector group $A_{0}, A_{0}(B)$ being the exponential of the positive cone $\mathfrak{a}_{0}(B)$ in $\mathfrak{a}_{0}$. Directions to infinity in $\mathfrak{a}_{0}(B)$ are parametrized by subsets of the simple roots, $\Sigma\left(B, A_{0}\right)$, of the pair $\left(B, A_{0}\right)$. A subset $F \subset \Sigma\left(B, A_{0}\right)$ determines a subcone of $\mathfrak{a}_{0}(B)$ which can be described as follows; $F$ defines a standard (with respect to $B$ ) parabolic subgroup, $P_{F}=N_{F} M_{F}$ of $G$. Let $\rho_{P_{F}}$ denote half the sum of the roots of ( $B, A_{0}$ ) which do not vanish on $\mathfrak{a}_{F}$, the split component of $\mathfrak{m}_{F}$;
where

\mathfrak{a}_{F}=\bigcap_{\alpha \in F} \operatorname{ker}(\alpha) .
$$

The subcone determined by $F$ is defined by

$$
\begin{aligned}
& \mathfrak{a}_{0}\left(B \mid P_{F}\right) \\
& \quad=\left\{H \in \mathfrak{a}_{0} \mid \alpha(H) \geq \mu \rho_{F}(H), \forall \alpha \text { a root of }\left.\left(B, A_{0}\right) \ni \alpha\right|_{\mathfrak{a}_{F}} \not \equiv 0\right\}
\end{aligned}

$\mu$ is some sufficiently small positive real number. $A_{0}\left(B \mid P_{F}\right)=$ $\exp \mathfrak{a}_{0}\left(B \mid P_{F}\right)$ is what we shall refer to as a sector of $G$. If $\beta \in$ $\Sigma\left(B, A_{0}\right)$, and $F=\Sigma\left(B, A_{0}\right) \backslash\{\beta\}$ is a maximal proper subset of $\Sigma\left(B, A_{0}\right)$, then $P_{F}$ is a maximal parabolic subgroup, and $a_{0}\left(B \mid P_{F}\right)$ is essentially (modulo the split component $\mathfrak{a}_{G}$ of $\mathfrak{g}$ ) a compact set crossed with a half line $\{t H: t>0\}$ where

H \in \mathfrak{a}_{F}, \quad \text { and } \quad \beta(H)=1
$$

We can choose a fixed $\mu$ above so that

$$
A_{0}(B)=\bigcup_{Q \supset B} A_{0}(B \mid Q)
$$

the union taken over all maximal standard parabolic subgroups $Q$.
Fix such a maximal parabolic $Q$; let $Q=N M$, with $A$ denoting the split component of $M$, and $H$ and $\beta$ defined as above for $Q=P_{F}$. We are interested in producing a "uniform asymptotic expansion" for an Eisenstein integral $E_{P}(x, \varphi, \lambda)$ along the parabolic $Q$ as described above. We can now be more specific; this means that we want an infinite exponential sum, with coefficients defined on the sector $A_{0}(B \mid Q)$, whose partial sums approximate the Eisenstein integral uniformly as the group variable ranges over $A_{0}(B \mid Q)$, and the parameter $\lambda$ varies over $(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$. Further we require that the coefficients of our expansion are given by Eisenstein integrals on the Levi factor $M$ of $Q$.

Although our analysis shows that it is possible to determine an asymptotic expansion for every maximal parabolic subgroup $Q$, we can determine the leading exponents of this expansion, and make the identification of its coefficients, only in the case that the split component of $Q$ is conjugate to a subgroup of the split component of $P$; otherwise, (5.2) is our best result. We should point out that in the exceptional case when $Q$ fails the conjugacy condition with respect to $P$, we have been able to obtain uniform estimates for the decay of the Eisenstein integrals $E_{P}(x, \varphi, \lambda)$ along the sector $A_{0}(B \mid Q)$ in
terms of the leading exponents of $\varphi$ along $B \cap M$; this result will appear elsewhere.

Let us now formulate the principal results in this paper more precisely. We assume for all that is to follow that $P$ and $Q$ satisfy the conjugacy condition on their split components. In this case we prove the existence of an asymptotic expansion ("along $Q$ ") for the functions $E_{P}(x, \varphi, \lambda)$ which uniformly approximates on $A_{0}(B \mid Q) \times(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$. If $\lambda$ is restricted to an open dense subset $\mathscr{F}^{\prime \prime}(\chi) \subset(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$, and $x=m \exp t H \in A_{0}(B \mid Q)$, then this expansion has the following form

\sum_{s} \sum_{n \geq 0} \Gamma_{s, n}(m, \lambda) e^{t\left(s \lambda-n \beta-\rho_{Q}\right)(H)}, \quad m \in M
$$

where the first sum is over those elements of the little Weyl group which have the property that $s^{-1} \mathfrak{a} \subset \mathfrak{a}_{P}$. We also show that given any $n \in \mathbf{Z}_{+}$, there exists a partial sum of this expansion

$$
\sum_{s} \sum_{n=0}^{p_{s}} \Gamma_{s, n}(m, \lambda) e^{t\left(s \lambda-n \beta-\rho_{Q}\right)(H)}, \quad m \in M
$$

which uniformly approximates $\varphi(m \exp t H, \lambda)$ as $\lambda$ varies over $\mathscr{F}^{\prime \prime}(\chi)$ and $m \exp t H$ varies over (essentially) $A_{0}(B \mid Q)$. The error estimate for the approximation is bounded by a constant times

$$
|(m, \lambda)|^{r} d_{Q}(m)^{-1} \Xi_{M}(m) e^{-n t}
$$

where the first term of the estimate is a polynomial factor in $m$ and $\lambda$, and other unexplained notation is as in $\S 3$. These results are stated in a more precise form in Theorems 5.1 and 5.9. Theorem 5.9 is a refinement of Theorem 5.1 which identifies the leading exponents of our expansion along $Q$. This shows in particular that our expansion has as its leading terms just the Harish-Chandra constant term along $Q$ (Harish-Chandra [3]) and hence, that our expansion is an extension of Harish-Chandra's constant term to a full asymptotic expansion.

The second principal result of the paper, Theorem 7.10, shows that the coefficients of our expansion along $Q$ are given by linear combinations of derivatives of Eisenstein integrals on the reductive group $M$, the Levi factor of $Q$. Assuming that $Q \supset P, \Lambda \in \mathfrak{a}_{P}^{*}, \Lambda$ perpendicular to $\mathfrak{a}^{*}$, and $\lambda \in \mathfrak{a}^{*}$, then we have by the principle of induction in stages that

E_{Q}\left(x, E_{P \cap M}(\Phi, \Lambda), \lambda\right)=E_{P}(x, \Phi, \Lambda+\lambda),
$$

the equality holding for all $\tau$-spherical matrix elements of $\sigma$. Applying Theorem 7.10 to this last equation can then be viewed as a generalization of Harish-Chandra's formula for the limit of an Eisenstein
integral along an associated parabolic direction (cf. Harish-Chandra [4], Theorem 18.1).

As we pointed out above, the results of this paper generalize results of Trombi [1], which were obtained for groups of real rank one. They are also a generalization of the first part of Trombi and Varadarajan [1] which considered the case where ( $V, \tau$ ) is the trivial bi- $K$ module. These earlier results were used in the investigation of the harmonic analysis of the $L^{p}$-Schwartz spaces $\mathscr{C}^{p}(G, \tau)$ (cf. Trombi and Varadarajan [2]) and we envision our results playing essentially the same role.

We shall now explain the mechanics for generating our uniform asymptotic expansion. The techniques used in Trombi and Varadarajan [1] and Trombi [1] are different from those used in this paper. In the general case treated here the iterative technique of those two papers will not work. We follow instead a method due to Wallach [1] but adapted to the task of getting uniform estimates.

Fix a maximal parabolic subgroup $Q=N M \supset B$; let the notations $A, \beta, H$, and $\rho_{Q}$ be given the same meaning as above. We begin by observing that the Eisenstein integrals are eigenfunctions for $\mathfrak{z}(\mathfrak{g})$. The first step in the analysis is to show how to construct from an Eisenstein integral, a vector function whose derivatives by elements of $\mathfrak{z}(\mathfrak{m})$ are perturbations of eigen-equations. The definition of this vector function is best understood by first making some general observations which we can then apply to the derivatives of the Eisenstein integrals.

Let $W$ be a Harish-Chandra module, and let $\bar{Q}=\bar{N} M$ be the parabolic opposite to $Q$. It is known that for any $k \in \mathbf{Z}_{+}$the quotient

W / \overline{\mathfrak{n}}^{k} W
$$

is locally $\mathfrak{a}$-finite. In the case $k=1$, Harish-Chandra determined a basis for this $\mathfrak{a}$-action when the module $W$ has infinitesimal character with Harish-Chandra parameter $\Lambda \in \mathfrak{h}_{0, \mathrm{C}}^{*}$. To describe this basis, observe that $\mathfrak{m}$ is a reductive subalgebra of $\mathfrak{g}$ which contains $\mathfrak{h}_{0}$. Let $\mathfrak{u}$ be a reductive subalgebra which contains $\mathfrak{h}_{0}$, and assume that $\mathfrak{a}_{\mathfrak{u}}$, the split component of $\mathfrak{u}$, is contained in $\mathfrak{h}_{0,-}$. We shall let

\mu_{\mathfrak{u} / \mathfrak{h}_{0}}: \mathfrak{z}(\mathfrak{u}) \mapsto S\left(\mathfrak{h}_{0}, \mathbf{c}\right)^{W_{0}^{u}}
$$

denote the Harish-Chandra isomorphism of the center of the enveloping algebra over $\mathfrak{u}_{\mathbf{C}}$ with the $W_{0}^{u}$-invariants in the symmetric algebra over $\mathfrak{h}_{0, \mathbf{c}} ; W_{0}$ denoting the Weyl group of the pair $\left(\mathfrak{g}, \mathfrak{h}_{0}\right)$, and $W_{0}^{u}$
denoting the subgroup which fixes $\mathfrak{a}_{\mathfrak{u}}$ pointwise; this subgroup can be identified with the Weyl group of the pair $\left(\mathfrak{u}, \mathfrak{h}_{0}\right)$. With this notation, we see that there exists an algebra injection

\mu: \mathfrak{z}(\mathfrak{g}) \mapsto \mathfrak{z}(\mathfrak{m})
$$

which is essentially defined by the following equation (recall that $\mu_{\mathfrak{g} / h_{0}}$ and $\mu_{\mathrm{m} / \mathfrak{h}_{0}}$ are isomorphisms, and clearly $\left.S\left(\mathfrak{h}_{0}\right)^{W_{0}} \subset S\left(\mathfrak{h}_{0}\right)^{W_{0}^{\mathrm{m}}}\right)$,

\mu_{\mathfrak{g} / \mathfrak{h}_{0}}(z)=\mu_{\mathrm{m} / \mathfrak{h}_{0}}(\mu(z)), \quad z \in \mathfrak{z}(\mathfrak{g}) .
$$

Harish-Chandra showed that $\mathfrak{z}(\mathfrak{m})$ is a finite free-module over $\mu(\mathfrak{z}(\mathfrak{g})$ ) of dimension $r=W_{0} / W_{0}^{\mathrm{m}}$. Let $v_{1}=1, \ldots, v_{r}$ be a basis for this module, and recall that $\mathfrak{a} \subset \mathfrak{z}(\mathfrak{m})$. Let $1 \leq i \leq r$, and $H$ be as above. Then there exists unique $z_{H: i j} \in \mathfrak{z}(\mathfrak{g})$ such that

Moreover, if we twist elements in $U\left(\mathfrak{m}_{\mathbf{C}}\right)$ by the quasicharacter $d_{Q}$ : $M \mapsto \mathbf{R}$ which appears in the estimates above, say

then the above action can be written as

and the twist is such that

In particular if $w \in W / \overline{\mathrm{n}} W$, then

where $\mu_{\mathfrak{g} / \mathfrak{h}_{0}}\left(z_{H: i j}\right)$ is considered as a polynomial on $\mathfrak{h}_{0, \mathrm{C}}^{*}$ and the notation

$$
\mu_{\mathfrak{g} / \mathfrak{h}_{0}}\left(z_{H: i j}: \Lambda\right)
$$

denotes the evaluation at $\Lambda$. Clearly,

is a basis for the local $\mathfrak{a}$-action. If $\Lambda$ is a regular element then the matrix operator

B(\Lambda)=\left(\mu_{\mathfrak{g} / \mathfrak{h}_{0}}\left(z_{H: i j}: \Lambda\right)-\rho(H) \delta_{i j}\right)
$$

has eigenvalues $s_{i} \Lambda(H)-\rho(H)$ where $\left\{s_{i} \mid 1 \leq i \leq r\right\}$ is a complete set of representatives for $W_{0} / W_{0}^{\mathrm{m}}$.

Now suppose that $\varphi(x, \lambda)=E_{P}(x, \varphi, \lambda)$ so that for all $z \in \mathfrak{z}(\mathfrak{g})$ we have

\varphi(x ; z, \lambda)=\mu_{\mathfrak{g} / \mathfrak{h}_{0}}\left(z: X_{\lambda}\right) \varphi(x, \lambda), \quad \lambda \in \mathfrak{a}_{P, \mathbf{C}}^{*},

where the notation " $; z$ " denotes that $z$ is differentiating the $x$ variable, and $X_{\lambda}$ denotes the Harish-Chandra parameter in $\mathfrak{h}_{0, \mathrm{c}}^{*}$ for the homomorphism of $\mathfrak{z}(\mathfrak{g})$ determined by $\varphi$. We can then reduce this system of equations satisfied by the function $\varphi$ to a first order vector equation as follows; let $e_{1}, \ldots, e_{r}$ denote the standard basis for $\mathbf{C}^{r}$ and put

\Phi(x, \lambda)=\sum_{i=1}^{r} \varphi\left(x ;^{\prime} v_{i}\right) \otimes e_{i} .

Now observe that for $1 \leq i \leq r$ we can write

& \left.\quad-\varphi\left(m \exp t H ; \xi_{H: i j^{\prime}} v_{j}\right)\right\} .

It is a simple matter now to show that $\Phi$ satisfies an equation of the following type:

Here

\Gamma\left(X_{\lambda}\right)=1 \otimes B\left(X_{\lambda}\right)
$$

and the function $\Psi$, which will be referred to below as the perturbation term, is formed from the terms

\phi\left(m \exp t H ; \xi_{H: i j}, \lambda\right) \otimes e_{i} .
$$

The next step is to obtain estimates for the function $\Psi$.

The $\xi_{H: i j}$ belong to the ideal $\overline{\mathfrak{n}} U\left(\mathfrak{g}_{\mathbf{C}}\right)$. If $Y \in \overline{\mathfrak{n}}$, and $\eta \in U\left(\mathfrak{g}_{\mathbf{C}}\right)$, then

\varphi(x ; Y \eta, \lambda)=\varphi\left(Y^{x} ; x ; \eta, \lambda\right),
$$

where $Y^{x}$ denotes the adjoint action of $x$ on $Y$, and the notation " $Y^{x}$ :" denotes the right $G$-invariant derivative determined by $Y^{x}$. If $x=m \exp t H \in A_{0}(B \mid Q)$, then it can be shown that

Y^{x} \mapsto 0, \quad \text { as } t \mapsto \infty,
$$

the decay being of the order of $e^{-t}$. Combining this result with the a priori estimates for the functions $\varphi=E_{P}$, we easily show that $\|\Psi(m \exp t H, \lambda)\|$ is bounded by a constant times

|(m, \lambda, t)|^{r} e^{-(1+\rho(H)) t} d_{Q}(m)^{-1} \Xi_{M}(m)

the estimate holding for $m \exp t H$ essentially varying in $A_{0}(B \mid Q)$, and $\lambda \in(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$. We have a similar estimate for $\|\Phi(m \exp t H, \lambda)\|$ with exponential term

e^{-\rho(H) t}
$$

so we pick up extra exponential decay for $\|\Psi(m \exp t H, \lambda)\|$ thanks to the right derivatives from the ideal $\bar{n} U\left(\mathfrak{g}_{\mathrm{C}}\right)$.

The above differential equation is equivalent to the integral equation

Let $E_{0}(\lambda)$ (resp. $\left.E_{ \pm}(\lambda)\right)$ denote the projection which maps $V \otimes \mathbf{C}^{r}$ onto the eigen-subspaces of $\Gamma\left(X_{\lambda}\right)$ which have zero (resp. positive or negative) real part. Let $\Phi_{0}(m, \lambda)$ equal

\end{aligned}

The integral in this expression converges thanks to the estimate of $\|\Psi(m \exp u H, \lambda)\| . \quad \Phi_{0}(m, \lambda)$ is essentially Harish-Chandra's constant term; more precisely if we write

\Phi_{0}(m, \lambda)=\sum_{i=1}^{r} \Phi_{0, i}(m, \lambda) \otimes e_{i}

then the constant term of $\varphi(m, \lambda)$ along $Q$ is the function $\varphi_{0}(m, \lambda)$ $=\Phi_{0,1}(m, \lambda)$.

The error estimate $\left\|\varphi(m \exp t H, \lambda)-\varphi_{0}(m \exp t H, \lambda)\right\|$ is no worse than

which in turn is bounded by,

Multiplying the above integral expression for $\Phi(m \exp t H, \lambda)$ by $E_{0}(\lambda)$ one can easily estimate the first term in this last expression and bound it by an error estimate of the type described above with $n=0$. The remaining two terms also satisfy similar estimates but they require more work. What is important to point out about the estimates of these terms is that the exponential factor in their estimates is determined by two things: first the rate of decay of $\|\Psi(m \exp t H, \lambda)\|$ and second, the eigenvalues of $\Gamma\left(X_{\lambda}\right)$ whose real parts are negative; the positive eigenvalues cannot contribute to the limit because of a priori estimates satisfied by the functions $\varphi=E_{P}$.

As already mentioned above, $\varphi_{0}$ gives the leading terms of our expansion, that is, the terms corresponding to $n=0$. The estimates we have described above lead to the desired "uniform estimates" for the partial sum

\sum_{s} \Gamma_{s, 0}(m, \lambda) e^{t\left(s \lambda-\rho_{Q}\right)(H)}

To this point we have taken $k=1$ in $\overline{\mathfrak{n}}^{k}$. We now wish to obtain the coefficients $\Gamma_{s, n}$ for $n>0$. To do this we must first obtain a basis for the local a-action on $W / \overline{\mathfrak{n}}^{k} W$ for any Harish-Chandra module $W$. We do this by extending the set of elements

defined above. The elements we add are obtained as follows. First note that from the above we have

Also recall that $\xi_{H: i j} \in \overline{\mathfrak{n}} U\left(\mathfrak{g}_{\mathbf{C}}\right)$. Let $Y \in \overline{\mathfrak{n}}$ and $\eta \in U\left(\mathfrak{g}_{\mathbf{C}}\right)$. Observe that we can compute the $\mathfrak{a}$-action on expressions of the form $Y^{\prime} v_{i} \eta$
as follows:

& +\sum_{j}\left(z_{H: i j}-\rho(H) \delta_{i j}\right) Y^{\prime} v_{j} \eta \quad\left(\bmod \bar{n}^{2} U(\mathfrak{g})\right),
\end{aligned}
$$

where $Y_{\alpha} \in \mathfrak{g}_{\alpha}=\left\{X \in \mathfrak{g} \mid[L, X]=\alpha(L) X, \forall L \in \mathfrak{a}_{0}\right\}$.
Fix a basis for $\bar{n}$, say

$$
\left\{Y_{1}, \cdots, Y_{n}\right\}
$$

with $Y_{i}$ belonging to some $\mathfrak{g}_{\gamma}, \gamma \in \Delta\left(B, A_{0}\right)$. We can then write

Note that

It should be clear from the above calculation and the last equality that if $w \in W / \overline{\mathfrak{n}}^{2} W$ then the $\mathfrak{a}$-action on $w$ is contained (assuming that $W$ has infinitesimal character) in the subspace spanned by the vectors

Hence we can continue to expand the set $\left\{{ }^{\prime} v_{1}, \ldots,{ }^{\prime} v_{r}\right\}$ for any $k$. In Lemma 2.1 we obtain these elements which we denote $u_{i j: M}$ with $1 \leq i \leq r, 1 \leq j \leq d_{M}$, and $M \in \mathbf{Z}_{+}^{n}$. Following the above, we form the vector functions $\Phi(x, \lambda)$ and $\Psi(x, \lambda)$ using the derivatives $u_{i j: M}$ and their "error terms" $\xi_{i j: M} \in \overline{\mathfrak{n}}_{\mathbf{C}}^{k} U\left(\mathfrak{g}_{\mathbf{C}}\right)$. These functions satisfy the same type of first order differential equation as before. Suppose then we fix $k$ sufficiently large. The eigenvalues of $\Gamma\left(X_{\lambda}\right)$ can be linearly ordered by their real parts independent of $\lambda \in(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$ (cf. $\S 5$ ). They are all of the form

where undefined notation is as in $\S 2$. Choose $z_{0}(\lambda)$, one of these eigenvalues such that

Let $E_{0}(\lambda)$ now denote the projection onto the eigenvalues of $\Gamma\left(X_{\lambda}\right)$ whose real part is greater than or equal to the real part of $z_{0}(\lambda)$, and
$E_{1}(\lambda)$ denote the projection onto the remaining eigenvalues of $\Gamma\left(X_{\lambda}\right)$; $E_{1}(\lambda)$ takes the place of $E_{ \pm}(\lambda)$ above. Note that if $Y=Y_{i_{1}} \cdots Y_{i_{k}} \in$ $\overline{\mathfrak{n}}^{k}, \eta \in U\left(\mathfrak{g}_{\mathbf{C}}\right)$, and $x=m \exp t H \in A_{0}(B \mid Q)$, then

Consequently we can estimate $\|\Psi(x, \lambda)\|$ as above with the exponential term now given by

Define $\Phi_{0}(x, \lambda)$ as above; the above estimate of $\|\Psi(x, \lambda)\|$ and the fact that the eigenvalues in the image of $E_{0}(\lambda)$ have real part greater than or equal to that of $\mathfrak{R} z_{0}(\lambda)$ where $\mathfrak{R} z_{0}(\lambda)>-\rho(H)-k$ allows us to easily show that the integral defining $\Phi_{0}$ exists. These same estimates and bounds on eigenvalues also gives us "uniform estimates" for (Lemma 5.3)

$$
\left\|E_{0}(\lambda) \Phi(m \exp t H, \lambda)-\Phi_{0}(m \exp t H, \lambda)\right\|
$$

and (Lemma 5.2)

of the type stated in the description of our principal results. Write the function $\Phi_{0}$ as

is the sum of the terms of our asymptotic expansion up to the exponent $z_{0}(\lambda)$. These results are developed in $\S \S 2$ through 5.

Section 6 contains some facts concerning Eisenstein integrals. The material for this section is a slight regurgitation of several sections of Arthur [1].

The material in $\S 7$ was directed by the analogous results in my joint paper with V. S. Varadarajan [1]. One final remark; asymptotic expansions "along the walls of $A_{0}(B)$ " for the matrix coefficients of a single representation have existed for some time; they were developed by Harish-Chandra around 1960, becoming available recently in his collected works (also see Casselman and Milicićc [1] and Wallach [1]). The expansion (5.2) already appears in Wallach [1]; our contribution is to observe that using the techniques of Wallach [1], we are able to carry the dependence of the Eisenstein integrals on the $\lambda$-parameter along. In this way we are able to give the precise dependence of the
coefficients and exponents of the asymptotic series on $\lambda$ and make our error estimates uniform in both variables. For technical reasons and with a view to possible future applications, we have carried out our uniform asymptotic analysis not only for the Eisenstein integrals, but more generally for any family of eigenfunctions satisfying the same weak estimates as the Eisenstein integrals. These are the functions of type $\mathrm{II}(\chi)$ and in doing this we have followed Harish-Chandra [6].

1. Notation and assumptions. Let $G$ be a reductive Lie group, and $K$ a fixed maximal compact subgroup. Lie subgroups of $G$ will be designated by upper case Roman letters, while their Lie algebras will be denoted by the corresponding lower case German letter. If $\mathfrak{m} \subset \mathfrak{g}$, then $U\left(g_{\mathbf{C}}\right)$ will denote the universal enveloping over $\mathfrak{g}_{\mathbf{C}}=\mathfrak{g} \otimes_{\mathbf{R}} \mathbf{C}$, and $U\left(\mathrm{~m}_{\mathrm{C}}\right)$ will denote the subalgebra of $U\left(\mathrm{gc}_{\mathrm{C}}\right)$ generated by 1 and $\mathfrak{m}_{\mathrm{C}}$. We assume that $G$ and $K$ satisfy the following general axioms: (1) $\operatorname{Ad}(G) \subset G_{\mathbf{C}}, G_{\mathbf{C}}$ the complex adjoint group of $\mathfrak{g}_{\mathbf{C}}$; (2) if $G_{1}$ is the analytic subgroup of $G$ corresponding to $\mathfrak{g}_{1}=[\mathfrak{g}, \mathfrak{g}]$, then the center of $G_{1}$ is finite; (3) if $G^{0}$ denotes the connected component of $G$, then $\left[G: G^{0}\right]<\infty$. In this case, $G$ and $\mathfrak{g}$ are equipped with a Cartan involution which fixes the elements of $K$ and $\mathfrak{t}$; we shall not distinguish between the two and simply designate it by $\theta$. The corresponding decomposition of $\mathfrak{g}$ into +1 and -1 eigenspaces of $\theta$ will be written as

If $P$ is a parabolic subgroup of $G$, then it has a decomposition $P=N_{P} M_{P}$, and $P=N_{P} A_{P} M_{P}^{1}$, where $N_{P}$ is the unipotent radical of $P$ and $M_{P}$ is a reductive subgroup of $G$ which is $\theta$ stable, and $A_{P}$ is the split component of $M_{P}$. We shall call $M_{P}$ the Levi component of $P$ and say that a subgroup $M$ of $G$ is a Levi subgroup if $M=$ $M_{P}$ for some parabolic $P$. Further we shall say a Levi subgroup is minimal (resp. maximal) if the corresponding parabolic is minimal (resp. maximal).

Suppose that $M_{1} \subset M$ are two Levi subgroups of $G$. We shall denote the set of Levi subgroups of $M$ which contain $M_{1}$ by $\mathscr{L}^{M}\left(M_{1}\right)$. Let us also write $\mathscr{F}^{M}\left(M_{1}\right)$ for the set of parabolic subgroups of $M$
which contain $M_{1}$, and $\mathscr{P}^{M}\left(M_{1}\right)$ for the set of groups in $\mathscr{F}^{M}\left(M_{1}\right)$ for which $M_{1}$ is the Levi component. Each of these sets is finite. If $M=G$ we shall usually drop the superscript $G$ in the above notations. If $R \in \mathscr{P}^{M}\left(M_{1}\right)$ and $Q \in \mathscr{P}(M)$, then we shall denote by $Q(R)$ the unique subgroup in $\mathscr{P}\left(M_{1}\right)$ which is contained in $Q$.

We choose and fix a minimal Levi subgroup $M_{0}$. If $M \in \mathscr{L}\left(M_{0}\right)$, let $K_{M}=K \cap M$. For induction we note that the properties of the triple $\left(G, K, M_{0}\right)$ are inherited by the triple $\left(M, K_{M}, M_{0}\right)$.

If $P \in \mathscr{F}\left(M_{0}\right)$, then it is known that

If $x \in G$, then let $n_{P}(x), m_{P}(x), \kappa_{P}(x), \mu_{P}(x)$, and $a_{P}(x)$ denote elements of $N_{P}, M_{P} \cap \operatorname{exps}, K, M_{P}^{1} \cap \operatorname{exps}$, and $A_{P}$ respectively such that

Suppose that $P \in \mathscr{P}(M)$. We shall sometimes write $A_{P}=A_{M}$ and $\mathfrak{a}_{P}=\mathfrak{a}_{M}$. Associated to $P$ are various real quasicharacters on these two groups. One arises from the modular function $\delta_{P}$ of $P$. Its restriction to $A_{P}$ equals

for a unique vector $\rho_{P}$ in $\mathfrak{a}_{M}^{*}$. We shall also put

Let $\Delta_{P}=\Delta\left(P, A_{P}\right)$ denote the roots of the pair $\left(P, A_{P}\right)$, and $\Sigma_{P}=$ $\Sigma\left(P, A_{P}\right)$ denote the set of simple roots contained in $\Delta_{P}$. If $F \subset \Delta_{P}$ then we shall write $\mathbf{Z}(F)$ for the abelian subgroup of $\mathfrak{a}_{P}^{*}$ generated by $F$, and $\mathbf{Z}_{+}(F)$ for the subset consisting of nonnegative integral combinations of elements in $F$.

We fix a $G$-invariant, symmetric bilinear form (, ) on $\mathfrak{g}$ such that the quadratic form

is positive definite. Let (for any vector space $V$ over $\mathbf{R}$ let us write $V_{\mathbf{C}}$ for $V \otimes_{\mathbf{R}} \mathbf{C}$ )

here we subscript objects associated to $M_{0}$ by 0 rather than by $M_{0}$. Then $\mathfrak{h}_{0, \mathfrak{c}} \cap \mathfrak{g}$ is a $\theta$ stable Cartan subalgebra of $\mathfrak{g}$, and (, ) is nondegenerate on $\mathfrak{h}_{0, \mathrm{c}}$ and

H \mapsto-(H, \theta(H)), \quad H \in \mathfrak{h}_{0, \mathbf{c}} \cap \mathfrak{g},
$$

extends to a Hermitian norm on $\mathfrak{h}_{0, \mathrm{c}}$. Then by restriction we obtain a bilinear form (, ) and a Hermitian norm $\|\cdot\|$ on both $\mathfrak{a}_{0, c}$ and $\mathfrak{a}_{0, \mathrm{c}}^{*}$. If $M \in \mathscr{L}\left(M_{0}\right)$, then there are imbeddings $\mathfrak{a}_{M, \mathrm{c}} \subset \mathfrak{a}_{0, \mathrm{c}}$ and $\mathfrak{a}_{M, \mathbf{C}}^{*} \subset \mathfrak{a}_{0, \mathbf{C}}^{*} ;$ hence we can apply (,) and $\|\cdot\|$ to these subspaces.

By a singular hyperplane in $\mathfrak{a}_{M}^{*}$, for $M \in \mathscr{L}\left(M_{0}\right)$, we mean a subspace of the form

Let $M \in \mathscr{L}\left(M_{0}\right)$ and let $W\left(A_{M}\right)$ denote the Weyl group of the pair $\left(G, A_{M}\right)$. If $P_{1}, P_{2} \in \mathscr{F}\left(M_{0}\right)$, then we shall denote by $W\left(\mathfrak{a}_{P_{1}}, \mathfrak{a}_{P_{2}}\right)$ the set of all distinct maps from $\mathfrak{a}_{P_{1}}$ into $\mathfrak{a}_{P_{2}}$ that are induced by elements of $W\left(A_{0}\right)$.

We shall call a subspace $\mathfrak{b}$ of $\mathfrak{a}_{0}^{*}$ a root subspace if it is of the form $\mathfrak{a}_{M}^{*}$ for some $M \in \mathscr{L}\left(M_{0}\right)$. If $\mathfrak{b}$ is such a space and $B \in \mathscr{P}\left(M_{0}\right)$, then put

It is known that the elements of $\operatorname{Chamb}(\mathfrak{b})$ are in one to one correspondence with the parabolic subgroups in $\mathscr{F}\left(M_{0}\right)$ whose split component is $\mathfrak{b}$.

Let $B \in \mathscr{P}\left(M_{0}\right), F \subset \Sigma_{B}$. Then we shall use the notation $B_{F}$ for the unique parabolic subgroup containing $B$ whose Levi component is the centraliser in $G$ of $\mathfrak{a}_{0, F}$ where

If $L \subset \mathbf{R}$, then we use the notation $L_{+}$for the nonnegative elements of $L$. If $L$ is a finite set, we shall write $|L|$ for the number of elements of $L$.

Unless specified otherwise, the integrals over the unimodular subgroups of $G$ will always be with respect to a fixed, but unnormalized, Haar measure. There will be two exceptions. On the compact group $K_{M}, M \in \mathscr{L}\left(M_{0}\right)$, we will always take the Haar measure for which the total volume is one. The second exception concerns the groups connected with the spaces $\mathfrak{a}_{M}$. On $\mathfrak{a}_{M}$ we will take the Euclidean measure with respect to the fixed norm $\|\cdot\|$. The exponential map will transform this measure to a fixed Haar measure which is dual to the measure we fixed on $\mathfrak{a}_{M}$.
2. Differential equations for eigenfunctions with regular infinitesimal character. In this section we shall determine elements $u_{i j: M}, \xi_{i j: M} \in$ $U(\mathfrak{g})$ which will allow us to write a first order vector equation (Lemma 2.2) for a function $\Phi(x)$ constructed from a $\mathfrak{z}(\mathfrak{g})$-eigenfunction $\varphi(x)$. As the definitions of $u_{i j: M}$ and $\xi_{i j: M}$ are inductively given, we must first establish some notation and make some choices of basis.

Let $B \in \mathscr{P}\left(M_{0}\right), B=N_{0} M_{0}=N_{0} A_{0} M_{0}^{1}$, be a fixed minimal parabolic subgroup; henceforth all objects associated with $B$ will be subscripted by 0 . We also fix $Q \in \mathscr{F}\left(M_{0}\right), Q \supset B, Q$ maximal, $Q=N M=N A M^{1}$. For ease of notation, we shall denote objects associated to $Q$ with no subscript; for example we shall write $\rho_{0}$ for one half the sum of the positive roots (with multiplicities) for $\mathfrak{a}_{0}$ in $\mathfrak{b}$, and the similarly defined function for $Q$ will be denoted by $\rho$. We shall fix $\alpha \in \Sigma(\mathfrak{q}, \mathfrak{a})$, and $H \in \mathfrak{a}$ such that

Let $\mu_{0}$ denote the Harish-Chandra homomorphism of $\mathfrak{z}(\mathfrak{g})$ onto $U\left(\mathfrak{h}_{0 \mathrm{C}}\right)^{W_{0}}$, where $W_{0}=W\left(\mathfrak{g}_{\mathrm{C}}, \mathfrak{h}_{\mathrm{Oc}}\right)$, and the superscript
$W_{0}$ denotes the set of invariants. As $\mathfrak{a} \subset \mathfrak{a}_{0}=\mathfrak{h}_{0 \mathbf{R}}$ then $\mathfrak{m} \supset \mathfrak{h}_{0}$. Denote the Harish-Chandra homomorphism of $\mathfrak{m}$ (relative to $\mathfrak{h}_{0, c}$ ) by $\mu_{1}$ and let $\mu_{10}$ be the canonical injection of $\mathfrak{z}(\mathfrak{g})$ into $\mathfrak{z}(\mathfrak{m})$ such that $\mu_{0}(z)=\mu_{1}\left(\mu_{10}(z)\right)$ for all $z \in \mathfrak{z}(\mathfrak{g})$. $\mu_{1}$ maps $\mathfrak{z}(\mathfrak{m})$ into $U\left(\mathfrak{h}_{0, \mathbf{C}}\right)^{W_{1}}$ where $W_{1}=W\left(\mathfrak{m}, \mathfrak{h}_{0, \mathrm{c}}\right)$. $W_{1}$ can be identified with the subgroup of $W_{0}$ generated by the reflections $s_{\beta}$ such that $\beta(H)=0, H$ as above. Let $r=\operatorname{dim}_{\mu_{1}(\mathfrak{z}(\mathfrak{g}))} \mathfrak{z}(\mathfrak{m})=\left|W_{0} / W_{1}\right|$, and $v_{1}=1, v_{2}, \ldots, v_{r}$ be a module basis for $\mathfrak{z}(\mathfrak{m})$ over $\mu_{10}(\mathfrak{z}(\mathfrak{g}))$. Define elements $z_{i j} \in \mathfrak{z}(\mathfrak{g})$ $(1 \leq i, j \leq r)$ by the equation

In particular, $B_{k}(\Lambda)$ is semisimple and has eigenvalues $X_{M}\left(s_{j} \Lambda\right)$ with $1 \leq j \leq r, M \in \mathbf{Z}_{+}^{n}$, and $o(M) \leq k$.

Proof. We proceed by induction on $k$. For $k=0, B_{0}=S_{O}(\Lambda)$ and the result is trivial (the semisimplicity follows from (2.16) and (2.18)). Assume the result for $k \geq 0$. Let $P_{k+1}$ denote the minimal polynomial of $S_{k+1}$; we wish to show that $P_{k+1}$ is also the minimal
polynomial of $B_{k+1}$. Observe that we can identify $T_{k}$ with a subspace of $T_{k+1}$ (which we again denote by $T_{k}$ ) defined by taking the span of the vectors $\left\{e_{i j: M} \mid o(M) \leq k, 1 \leq j \leq d_{M}, 1 \leq i \leq r\right\}$; and that $T_{k+1}=T_{k} \oplus T_{k k+1}$ (orthogonal direct sum) where $T_{k k+1}$ is the span of the remaining vectors $e_{i j: M}$ not in $T_{k}$. Further we have

3. Uniform estimates for functions of type $\mathrm{II}(\chi)$. We begin this section by introducing a class of functions which we are able to approximate by an asymptotic expansion. This class contains the matrix elements of cuspidal principal series representations, the so-called Eisenstein integrals. The introduction of this class follows HarishChandra [6]; it also is done for notational convenience; it's definition is a characterisation of those properties of Eisenstein integrals which we will need for later work.

We now fix a cuspidal parabolic subgroup $P=N_{P} M_{P}, P$ standard with respect to $B$ and we assume that $W\left(\mathfrak{a}, \mathfrak{a}_{P}\right) \neq \varnothing$. Let $\mathfrak{h} \subset \mathfrak{m}_{P}$ be a $\theta$-stable Cartan subalgebra such that $\mathfrak{h}_{\mathbf{R}}=\mathfrak{a}_{P} \quad\left(\mathfrak{h}_{\mathbf{R}}=\mathfrak{h} \cap \mathfrak{s}\right)$. An element $\chi \in\left(\mathfrak{h}_{\mathfrak{I}}\right)_{\mathbf{C}}^{*} \quad\left(\mathfrak{h}_{\mathfrak{I}}=\mathfrak{h} \cap \mathfrak{t}\right)$ is called singular if $\chi\left(H_{\beta}\right)=0$ for some imaginary root $\beta \in \Delta\left(\mathfrak{g}_{\mathbf{C}}, \mathfrak{h}_{\mathbf{C}}\right)$ and regular otherwise. Put $\mathscr{F}=(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$, and $\bar{\omega}=\bar{\omega}_{\mathfrak{g} / \mathfrak{h}}=\prod_{\beta>0} H_{\beta}$ where $\beta>0$ means that the product is taken over some system of positive roots of $\Delta\left(\mathfrak{g}_{\mathrm{C}}, \mathfrak{h}_{\mathrm{C}}\right)$. Fix a regular $\chi \in(-1)^{1 / 2} \mathfrak{h}_{1}^{*}$ and extend it trivially to $\mathfrak{h}$; similarly, extend any element of $\mathscr{F}_{\mathrm{C}}=\mathfrak{a}_{P \mathrm{C}}^{*}$ trivially to $\mathfrak{h}$ (note that our notation is nonstandard and nontypical for this paper as $\mathscr{F}_{\mathrm{C}}$ is not the complexification of $\mathscr{F}$; however, it avoids a lot of subscripting and will
be mostly used in this section). Let $\mathscr{F}_{\mathbf{C}}^{\prime}(\chi)$ denote the subset of $\mathscr{F}_{\mathrm{C}}$ of those elements such that $\bar{\omega}(\chi+\lambda) \neq 0$ and set $\mathscr{F}^{\prime}(\chi)=\mathscr{F} \cap \mathscr{F}_{\mathbf{C}}^{\prime}(\chi)$. Then $\mathscr{F}^{\prime}(\chi)$ is an open dense subset of $\mathscr{F}$.

As we have assumed that $P$ is standard with respect to $B$, then $\mathfrak{m}_{P}$ contains both $\mathfrak{h}$ and $\mathfrak{h}_{0}$. It follows that there exists $y \in G_{\mathbf{C}}$, the complex adjoint group of $\mathfrak{g}_{\mathrm{C}}$, such that $y$ centralizes $\mathfrak{h}_{\mathbf{R}}=\mathfrak{a}$ and $\mathfrak{h}_{\mathbf{C}}^{y}=\mathfrak{h}_{0, \mathbf{C}}$. Put $X_{\lambda}=(\chi+\lambda)^{y}$ for $\lambda \in \mathscr{F}_{\mathbf{C}}$. Then if $\lambda \in \mathscr{F}_{\mathbf{C}}^{\prime}(\chi)$ it is clear that $\bar{\omega}_{0}\left(X_{\lambda}\right) \neq 0$.

Let $\mathscr{D}=\mathscr{S}\left(\mathfrak{a}_{P \mathrm{C}}\right) \otimes \mathscr{S}(\mathscr{F})$ (if $W$ is a vector space we shall denote the symmetric algebra over $W$ by $\mathscr{S}(W)$; we also consider elements of $\mathscr{S}\left(\mathfrak{a}_{P \mathrm{C}}\right)$ as polynomial functions on $\mathfrak{a}_{P \mathrm{C}}^{*}$, and $\mathscr{S}(\mathscr{F})$ as derivatives of functions defined on the Euclidean space $\mathscr{\mathscr { C }}), g_{1} \otimes g_{2} \in$ $U\left(\mathfrak{g}_{\mathbf{C}}\right)^{(2)}=U\left(\mathfrak{g}_{\mathbf{C}}\right) \otimes U\left(\mathfrak{g}_{\mathbf{C}}\right)$, and let $\varphi \in C^{\infty}(G \times \mathscr{F}: V)$. (4) For any $D \in \widetilde{U}\left(\mathfrak{g}_{\mathbf{C}}\right)$, we can choose a number $r \geq 0$ such that $S_{D, r}(\varphi)<\infty$.

Assume now that $V$ is a double unitary $K$-module, $\tau=\left(\tau_{l}, \tau_{r}\right)$, $\tau(k) v=\tau_{l}(k) v, v \tau(k)=v \tau_{r}(k)$. If $x \in G$, we can write $x=$ $n_{P}(x) a_{P}(x) \mu_{P}(x) \kappa_{P}(x)$ where $\kappa_{P}(x) \in K, \mu_{P}(x) \in M_{P}^{1} \cap \operatorname{exps}$, $a_{P}(x) \in A_{P}, n_{P}(x) \in N_{P}$, and we put $H_{P}(x)=\log a_{P}(x)$. Then if $\psi \in C^{\infty}\left(M_{P}: V: \tau\right)$, where we use the obvious notation for the infinitely differentiable, $V$-valued functions on $G$ which are $\tau$-spherical, we define the Eisenstein integral $E_{P}(x, \psi, \lambda)$ by the equation,

We shall devote the next section to a more thorough investigation of the properties of these important functions. For the present however, we content ourselves with the following observation, indicative of the importance of functions of type $\mathrm{II}(\chi)$. If $\psi \in \mathscr{A}_{\text {cusp }}\left(M_{P}, \tau\right)$ (the space of $\tau$-spherical cusp forms on $M_{P}$ (cf. §3)) and $\zeta \psi=$ $\mu_{\mathrm{m}_{p} / \mathfrak{h}}(\zeta: \chi) \psi\left(\mu_{\mathrm{m}_{\rho} / \mathfrak{h}}\right.$ denoting the Harish-Chandra homomorphism for the pair $\left(\mathfrak{m}_{P}, \mathfrak{h}\right)$ ) then $E_{P}(x, \psi, \lambda)$ is a function of type $\mathrm{II}(\chi)$. In fact we have the following lemma. Note that $\lambda \in \mathscr{F}_{\mathrm{C}}$ can be written as $\lambda=\lambda_{\mathbf{R}}+(-1)^{1 / 2} \lambda_{\mathbf{I}}$ with $\lambda_{\mathbf{R}}, \lambda_{\mathbf{I}} \in \mathfrak{a}_{P}^{*}$.

where $c_{N M} \in C(M)$, and $\left|c_{N M}(m)\right| \leq \gamma(m)$ and therefore $c_{N M}$ remains bounded on $M^{+}$. As $\left(Y^{M}\right)^{a_{t}}=e^{-t\langle\beta, M\rangle(H)} Y^{M}$ and as $m \in$ $M^{+}$, then we see that there exists a constant $D_{k}$ depending only on $k$ such that

From this one can deduce the first inequality of the lemma for $\eta_{2}=1$. If $\eta_{2} \neq 1$ one must observe that $\mathfrak{m}$ leaves $\overline{\mathfrak{n}}$ stable. Hence $\eta_{2} Y^{M} \delta$ can be written as a sum of terms of the type $Y^{N} \delta^{\prime}$ with $o(N)=k+1$, and $\delta^{\prime} \in U\left(\mathfrak{g}_{\mathrm{C}}\right)$, from which one can deduce the inequality from the above calculation.
4. Spectral Analysis of $\Gamma_{k}\left(X_{\lambda}\right)$. Before applying our uniform estimates, we shall need some further refinements concerning the dependence of $\Gamma_{k}\left(X_{\lambda}\right)$ on $\lambda \in \mathscr{F}$. First we note that if

Identify $\mathfrak{h}_{0, \mathrm{C}}^{*}$ with $\mathbf{C}$ via the map $\Lambda \mapsto \Lambda(H)$. Observe that if $\mathfrak{h}_{\mathrm{C}}^{y}=$ $\mathfrak{h}_{0, \mathbf{c}}$ then using the notation $\left(\mathfrak{b}_{\mathbf{C}}\right)^{\mathbf{R}}=\sum_{\alpha>0} \mathbf{R} H_{\alpha}$ where $\mathfrak{b}$ is a Cartan subalgebra of $\mathfrak{g}, \sum_{\alpha>0}$ denotes the sum over any system of positive roots for $\Delta\left(\mathfrak{g}_{\mathbf{C}}, \mathfrak{b}_{\mathbf{C}}\right)$, we have $\left[\left(\mathfrak{h}_{\mathbf{C}}\right)^{\mathbf{R}}\right]^{y}=\left(\mathfrak{h}_{0, \mathrm{C}}\right)^{\mathbf{R}}$. It is known that if $s \in W_{0}$ then $s$ leaves $\left(\mathfrak{h}_{0, \mathbf{c}}\right)^{\mathbf{R}}$ invariant. Hence as $H \in \mathfrak{a} \subset \mathfrak{a}_{0} \subset$ $\left(\mathfrak{h}_{0, \mathbf{C}}\right)^{\mathbf{R}}$ then there exists $H_{1 j} \in(-1)^{1 / 2} \mathfrak{h}_{\mathfrak{I}}, H_{2 j} \in \mathfrak{h}_{\mathbf{R}}=\mathfrak{a}_{P}$ such that

Note that if $\mathscr{E}_{k}(\lambda)=\left\{\zeta_{1}(\lambda), \ldots, \zeta_{p}(\lambda)\right\}, \mathscr{E}_{k+1}(\lambda)=\left\{\mu_{1}(\lambda), \ldots\right.$, $\left.\mu_{q}(\lambda)\right\}$ then although $\mathscr{E}_{k}(\lambda) \subset \mathscr{E}_{k+1}(\lambda)$ it may happen that for some
$1 \leq j \leq q$ and some $i \leq p, i<j, \mathfrak{R} \mu_{j}(\lambda) \leq \Re \zeta_{i}(\lambda)$. However, if we fix $l<p$ and let $k$ increase, then we can guarantee that $\zeta_{i}(\lambda)=$ $\mu_{i}(\lambda)=z_{i}(\lambda)$ if $1 \leq i \leq l$.

We can in fact say more about the numbers $z_{i}(\lambda)$. Let $H^{\chi}$ be any element of $(-1)^{1 / 2} \mathfrak{h}_{\mathbf{I}}$ such that

Let ${ }^{o} Q \subset\{1, \ldots, r\}$ denote the maximal elements relative to this partial order; we also denote by $Q^{o}$ a subset of one through $r$ such that if $i, j \in Q^{o}, i \neq j$, then $H_{2 i} \neq H_{2 j}$, and $Q^{o}$ is maximal with respect to this property. Then if $j \in\{1, \ldots, r\}$ we must have $j \preceq \alpha$ for some $\alpha \in{ }^{o} Q$. It follows that

By the equality of the imaginary parts we must have as $i_{1}, i_{2} \in Q_{\alpha}^{o}$, with $\alpha=\alpha_{j}, j=1,2$, that $i_{1}=i_{2}$. It follows then that $n_{1}=n_{2}$. Now let

From the analyticity of the map $\lambda \mapsto \operatorname{Exp}\left\{t \Gamma\left(X_{\lambda}\right)\right\}$ we have for $\lambda$ denoting a generic point in $\mathscr{F}^{\prime \prime}(\chi)$

where for each $\alpha \in{ }^{o} Q$ there exists $q_{\alpha}<\operatorname{deg}(f)$ and for each $j, l$ with $0 \leq l \leq q_{\alpha}, j \in Q_{\alpha}^{o}$ there exists $\Lambda_{j l}^{\alpha} \in \mathscr{S}\left(\mathfrak{a}_{P \mathbf{C}}^{*}\right)$ with $\Lambda_{j 0}^{\alpha}=1$, and $\widetilde{E}_{j, l}(\alpha, n) \in \operatorname{End}\left(V \otimes T_{k}\right)$ such that

5. Uniform asymptotics of functions of type $\mathrm{II}(\chi)$. We can now state an initial form of the first principal result of this paper. Let us recall the notation of $\S 4$; the eigenvalues of $\Gamma_{k}\left(X_{\lambda}\right)$ were denoted by $\zeta_{1}(\lambda), \ldots, \zeta_{p}(\lambda)$. We denoted the elements of $\mathscr{E}(\lambda)$ as $z_{i}(\lambda)$, and ordered the real parts of this sequence;

Next we chose $m_{0}=m_{j_{0}}$ so that $z_{0}(\lambda)=z_{m_{0}}(\lambda)$, had real part smaller than all the prospective leading terms of our expansion. Finally we chose $k$ so large that the first $m_{0}$ eigenvalues of $\Gamma_{k}\left(X_{\lambda}\right)$ had stabilized; that is so that

From Harish-Chandra [3], §6 all leading exponents satisfy the requisite property. As all other exponents are integrally equivalent to a leading one, then all exponents (i.e. those exponential terms in (5.2) which appear with a nonzero coefficient) satisfy the required property. Hence Theorem 5.1 is completely proved.

where $p_{s} \in \mathbf{Z}_{+}$is chosen so that $-\left(p_{s} \alpha+\rho\right)(H) \geq \mathfrak{R} z_{0}(\lambda)$, and $-\left(\left(p_{s}+1\right) \alpha+\rho\right)(H)<\mathfrak{R} z_{0}(\lambda)$ for all $\lambda \in \mathscr{F}$.

Proof. The existence of the series follows easily from Theorem 5.1. The estimate (5.23) follows from Theorem 5.1 on noting that the function $\varphi_{0}$ equals the sum on $\mathscr{F}^{\prime \prime}(\chi)$.
6. Eisenstein integrals. In this section we shall recall some standard facts concerning Eisenstein integrals. Most of the section is taken from Arthur [1]. We shall therefore only state the results which we find necessary, and refer the reader to Arthur for their proofs.

As before $V$ will denote a fixed finite dimensional double unitary $K$-module. Fix a Levi subgroup $M$ in $\mathscr{L}\left(M_{0}\right)$. Let $\mathscr{A}_{\text {cusp }}(M, \tau)$ be the space of $\tau$-spherical functions on $M / A_{M}$ which are square integrable, and $\mathfrak{z}(\mathfrak{m})$-finite. Equivalently, we may consider elements of $\mathscr{A}_{\text {cusp }}(M, \tau)$ as functions defined on $M$ which are right invariant under $A_{M}$, i.e. $\varphi(m a)=\varphi(m), m \in M$, and $a \in A_{M}$, and which are $\mathfrak{z}(\mathfrak{m})$-finite and square integrable on $M / A_{M}$. The space $\mathscr{A}_{\text {cusp }}(M, \tau)$ is finite dimensional, and equals $\{0\}$ unless $M / A_{M}$ has discrete series. If $\omega$ is an equivalence class of square integrable representations of $M / A_{M}$, let $\mathscr{A}_{\omega}(M, \tau)$ be the space of functions $\varphi \in \mathscr{A}_{\text {cusp }}(M, \tau)$ such that for any $\xi^{*} \in V^{*}$, the function

m \mapsto \xi^{*}(\varphi(m)), \quad m \in M / A_{M},
$$

is a sum of matrix coefficients of $\omega$. Then

\mathscr{A}_{\text {cusp }}(M, \tau)=\bigoplus_{\omega} \mathscr{A}_{\omega}(M, \tau) .
$$

Let $\varphi \in \mathscr{A}_{\text {cusp }}(M, \tau), P \in \mathscr{P}(M), x \in G$, and $\lambda \in \mathfrak{a}_{M, \mathrm{C}}$. As in $\S 3$ we define the Eisenstein integral by the formula

where the function $\varphi_{P}$ is the function on $G$ such that

Then the function

depends analytically on $\lambda$, and is a $\mathfrak{z}(\mathfrak{g})$-finite, $\tau$-spherical function on $G$.

Let $W\left(A_{0}\right)$ be the Weyl group of $\left(G, A_{0}\right)$. It is a finite group which acts on the vector spaces $\mathfrak{a}_{0}$ and $\mathfrak{a}_{0}^{*}$. Suppose that $M_{1}$ is another Levi subgroup in $\mathscr{L}\left(M_{0}\right)$. As is customary, we will write $W\left(\mathfrak{a}_{M}, \mathfrak{a}_{M_{1}}\right)$ for the set of distinct isomorphisms from $\mathfrak{a}_{M}$ into $\mathfrak{a}_{M_{1}}$, which are induced by $W\left(A_{0}\right)$. Recall that any two groups $P \in \mathscr{P}(M)$ and $P_{1} \in \mathscr{P}\left(M_{1}\right)$ are said to be associated if $\operatorname{dim} \mathfrak{a}_{M}=\operatorname{dim} \mathfrak{a}_{M_{1}}$ and this set is not empty. If $t \in W\left(\mathfrak{a}_{M}, \mathfrak{a}_{M_{1}}\right)$ we shall denote by $w_{t}$ some representative of $t$ in $K$. Now, suppose that $\Sigma$ is any subset of $M$ such that $K_{M} \Sigma K_{M}=\Sigma$, and that $\varphi$ is a $\tau$-spherical function from $\Sigma$ to $V$. If $t \in W\left(\mathfrak{a}_{M}, \mathfrak{a}_{M_{1}}\right)$, define a $\tau$-spherical function on $\Sigma_{1}=w_{t} \Sigma w_{t}^{-1}$ by

If $P \in \mathscr{P}(M)$ let $t P$ be the group $w_{t} P w_{t}^{-1}$ in $\mathscr{P}\left(M_{1}\right)$. Then if $\varphi \in \mathscr{A}_{\text {cusp }}(M, \tau)$, it is easily shown that

More generally, if $L$ is any Levi subgroup which contains both $M$ and $M_{1}$, and $R \in \mathscr{P}^{L}(M)$, there is an identity

Suppose that $P \in \mathscr{P}(M)$. If $T$ is a Cartan subgroup of $M$, let $\Delta_{P}(G, T)$ be the set of roots of $(G, T)$ whose restriction to $A_{P}$ belongs to $\Delta\left(P, A_{P}\right)$. Suppose that $P^{\prime}$ also belongs to $\mathscr{P}(M)$. Then the number

\beta_{P^{\prime} \mid P}=\prod\left(\frac{(\alpha, \alpha)}{2}\right)^{1 / 2} \quad\left(\text { product over } \alpha \in \Delta_{\bar{P}}(G, T) \cap \Delta_{P^{\prime}}(G, T)\right)

is independent of $T$. (As usual, $\bar{P}$ stands for the group in $\mathscr{P}(M)$ opposite to $P$.) Let $d X$ be the Euclidean measure on $\mathfrak{n}_{P^{\prime}}$ associated to the norm

We can normalize a Haar measure $d n^{\prime}$ on $N_{P^{\prime}}$ by

The same prescription gives a Haar measure on the subgroup $N_{P^{\prime}} \cap$ $N_{P}$. From these two measures we then obtain an invariant quotient measure on the coset space $N_{P^{\prime}} \cap N_{P} \backslash N_{P^{\prime}}$. Now if $\varphi \in \mathscr{A}_{\text {cusp }}(M, \tau)$, $\lambda \in \mathfrak{a}_{M, \mathbf{C}}^{*}$ and $m \in M$, define

& \quad=\beta_{P^{\prime} \mid P} \int_{N_{P^{\prime}} \cap N_{P} \backslash N_{P^{\prime}}} \varphi\left(m M_{P}(n)\right) \tau\left(K_{P}(n)\right) e^{\left(\lambda+\rho_{P}\right)\left(H_{P}(n)\right)} d n .
\end{aligned}

The integrals converge if

for each root $\alpha \in \Delta_{P} \cap \Delta_{\bar{P}^{\prime}}$. Because of the factor $\beta_{P^{\prime} \mid P}$, the integrals are independent of the measure on $N_{P^{\prime}}$ and of the form $($,$) .$

Both $J_{P^{\prime} \mid P}^{l}(\lambda)$ and $J_{P^{\prime} \mid P}^{r}(\lambda)$ can be continued as meromorphic functions from $\mathfrak{a}_{M, \mathbf{C}}$ to the finite dimensional space of endomorphisms of $\mathscr{A}_{\text {cusp }}(M, \tau)$. They satisfy all the usual properties of intertwining operators. In particular, let $d\left(P^{\prime}, P\right)$ be the number of singular hyperplanes which lie between the chambers $\mathfrak{a}_{M}(P)$ and $\mathfrak{a}_{M}\left(P^{\prime}\right)$. If $P^{\prime \prime}$ is a third group in $\mathscr{P}(M)$ such that

If $\lambda \in \mathfrak{a}_{M, \mathrm{C}}$ and $P_{1}, P_{1}^{\prime} \in \mathscr{P}(M)$, the operators $J_{P_{1}^{\prime} \mid P_{1}}^{\prime}(\lambda)$ and $J_{P^{\prime} \mid P}^{r}(\lambda)$ commute. They also both commute with $\mathfrak{z}(\mathfrak{m})$.

Suppose that $s \in W\left(\mathfrak{a}_{M}, \mathfrak{a}_{M_{1}}\right)$. Let $P \in \mathscr{P}(M)$ and $P_{1} \in \mathscr{P}\left(M_{1}\right)$. The groups $s^{-1} P_{1}$ and $s^{-1} \bar{P}_{1}$ both belong to $\mathscr{P}(M)$. Define

These are all meromorphic functions on $\mathfrak{a}_{M, \mathrm{C}}$ with values in the space of linear maps from $\mathscr{A}_{\text {cusp }}(M, \tau)$ to $\mathscr{A}_{\text {cusp }}\left(M_{1}, \tau\right)$. We have the following functional equations:

the equalities holding for $s_{1} \in W\left(\mathfrak{a}_{M_{1}}, \mathfrak{a}_{M_{2}}\right)$ and $P_{2} \in \mathscr{P}\left(M_{2}\right)$. Suppose that $t \in W\left(A_{0}\right)$. If $M^{\prime} \in \mathscr{L}\left(M_{0}\right)$,

is another Levi subgroup; if $P \in \mathscr{P}(M)$, then $t P \in \mathscr{P}\left(t M^{\prime}\right)$. The restriction of $t$ to $\mathfrak{a}_{M^{\prime}}$ defines an element in $W\left(\mathfrak{a}_{M^{\prime}}, \mathfrak{a}_{M^{\prime}}\right)$, which we will also denote by $t$. We then have the following identities:

We shall now quickly review the relation between Eisenstein integrals and induced representations. Fix $M \in \mathscr{L}\left(M_{0}\right)$. Let $\omega$ be an equivalence class of irreducible square integrable representations of
$M / A_{M}$, and let $\left(\sigma, U_{\sigma}\right)$ be a representation in the class of $\omega$ ( $U_{\sigma}$ is the Hilbert space on which $\sigma$ acts). Let $P \in \mathscr{P}(M)$ and define $\mathscr{H}(\sigma)$ to be the Hilbert space of measurable functions

(i) $\psi(m k)=\sigma(m) \psi(k), m \in K_{M}, k \in K$,

If $\lambda \in \mathfrak{a}_{M, \mathbf{C}}$, there is the usual induced representation

$\psi \in \mathscr{H}(\sigma), x \in G$, which acts on $\mathscr{H}(\sigma)$.
Let now ( $V, \tau$ ) be an irreducible representation of $K$, instead of a double representation. Let $\mathscr{H}(\sigma)_{\tau}$ be the finite dimensional subspace of vectors in $\mathscr{H}(\sigma)$ under which the restriction of $I_{P}(\sigma, \lambda)$ to $K$ is equivalent to a multiple of $\tau$. Suppose that $S \in \operatorname{Hom}_{K_{M}}\left(V, U_{\sigma}\right)$; that is, $S$ is a map from $V$ to $U_{\sigma}$ such that

\end{aligned}

defined a priori only for those $\lambda \in \mathfrak{a}_{M, \mathbf{c}}^{*}$ for which the integral converges, $J_{P^{\prime} \mid P}(\sigma, \lambda)$ can be continued as a meromorphic function from $\mathfrak{a}_{M, \mathrm{C}}^{*}$ to the space of endomorphisms of $\operatorname{Hom}_{K_{M}}\left(V, U_{\sigma}\right)$. The map

\Psi_{S}(\xi) \mapsto \Psi_{J_{\rho^{\prime} \mid P}(\sigma, \lambda) S}(\xi), \quad S \in \operatorname{Hom}_{K_{M}}\left(V, U_{\sigma}\right), \xi \in V

which we can also denote by $J_{P^{\prime} \mid P}(\sigma, \lambda)$, is just the restriction to $\mathscr{H}(\sigma)_{\tau}$ of the usual intertwining operator from $I_{P}(\sigma, \lambda)$ to $I_{P^{\prime}}(\sigma, \tau)$.

There is a canonical isomorphism

If $S_{1} \in$ $\operatorname{Hom}_{K_{M}}\left(V_{1}, U_{\sigma}\right)$, and $S_{2}^{*} \in \operatorname{Hom}_{K_{M}}\left(U_{\sigma}, V_{2}\right)$, then

is a function in $\mathscr{A}_{\text {cusp }}(M, \tau)$. The $J$ functions defined above are related to those defined previously by the formulas

We now will recall some facts concerning the Harish-Chandra asymptotic expansion of the Eisenstein integrals. Let $B, B^{\prime} \in$ $\mathscr{P}\left(M_{0}\right)$ and consider the expansions of the functions

If $\varepsilon$ is a small positive number and $a \in A_{0}^{\varepsilon}\left(B^{\prime}\right)$, (cf. (6.27) below) then $E_{B}(a, \Phi, \Lambda)$ can be written

where $c_{B^{\prime} \mid B, \zeta}(s, \Lambda)$ is a meromorphic function of $\Lambda$ with values in $\operatorname{End}\left(\mathscr{N}_{0}\right)$, the space of endomorphisms of $\mathscr{\varkappa}_{0}$. The functional equations for the Eisenstein integral give rise to the formulae

for elements $t, s_{1} \in W\left(A_{0}\right)$ and $B_{1} \in \mathscr{P}\left(M_{0}\right)$. Suppose that $x$ is an element of

Then $E_{B^{\prime} \mid B, s}(\Phi, \Lambda)$ is a $\tau$-spherical function on $G_{\varepsilon}$. It is meromorphic in $\Lambda$, and

These functions are all $\mathfrak{z}(\mathfrak{g})$-finite. Indeed, if $z \in \mathfrak{z}(\mathfrak{g})$ let $\mu_{10}(z: \Lambda)$ be the differential operator on $M_{0}^{1}$ obtained by evaluating $\mu_{10}(z)$ at $\Lambda$. Then the equation

Let $M \in \mathscr{L}\left(M_{0}\right), r \in W\left(A_{0}\right)^{M}, R, R^{\prime} \in \mathscr{P}^{M}\left(M_{0}\right)$, where $W\left(A_{0}\right)^{M}$ denotes the subgroup of elements of $W\left(A_{0}\right)$ which leave $\mathfrak{a}_{M}^{*}$ pointwise fixed; it can be identified with the Weyl group of the pair ( $M, A_{0}$ ). Then we can define the functions

on a neighborhood of infinity in $M$. Let $P, L \in \mathscr{P}(M)$. Let $B=$ $P(R)$. There is a unique coset $s$ in $W\left(A_{0}\right) / W\left(A_{0}\right)^{M}$ such that the group $P_{1}=s L$ contains $B$. If $M_{1}=w_{s} M w_{s}^{-1}$ then $P_{1}$ belongs to $\mathscr{P}\left(M_{1}\right)$. Let $s_{B}$ be the unique representative of $s$ in $W\left(A_{0}\right)$ such that $s_{B}(\alpha) \in \Delta\left(B, A_{0}\right)$ for every $\alpha \in \Delta\left(R, A_{0}\right)$.

Lemma 6.2 [Arthur [1], Lemma I.4.2]. If $\Lambda$ is in general positive in $\mathfrak{a}_{0}^{*}$, then

& =\sum_{\zeta \in \mathbf{Z}_{+}\left(\Sigma_{R}\right)}\left(c_{B \mid B, \zeta}\left(s_{B}, \Lambda\right) \Phi\right)(1) a^{\left(s_{B}\left(\Lambda-\rho_{R}\right)-\zeta\right)},
\end{aligned}

here we consider $\Sigma_{R}$ as a subset of $\Sigma_{B}$, and the equality holds on $M_{\varepsilon}$.
We shall also need two results of Harish-Chandra's. Fix $M \in$ $\mathscr{P}\left(M_{0}\right), M$ cuspidal, $T$ a Cartan subgroup contained in $M$, and $P \in \mathscr{P}(M)$. Let notation be as in $\S 2$; in particular $\mathscr{F}=(-1)^{-1 / 2} \mathfrak{a}_{M, \mathbf{C}}^{*}$. Further let $\mathscr{F}^{\prime}$ denote the set of $\lambda \in \mathscr{F}$ such that $\pi(\lambda) \neq 0$, where

Moreover, we can choose $\delta>0$ such that for every $s \in W(A)$, $\pi(\lambda) c_{P_{2} \mid P_{1}}(s, \lambda)$ extends to a holomorphic function of $\lambda$ on $\mathscr{F}_{\mathbf{C}}, \delta$.

Lemma 6.4 [Harish-Chandra [5], Lemma 17.3, Lemma 19.2]. (1) Let $s \in W(A), P_{1}, P_{2} \in \mathscr{P}(M)$, then ${ }^{0} c_{P_{1} \mid P_{2}}(s, \lambda)$ maps $\mathscr{A}_{\omega}(M, \tau)$ into $\mathscr{A}_{s \omega}(M, \tau), \omega$, an equivalence class of square integrable representations on $M$. Moreover, if $\lambda \in \mathscr{F}^{\prime}$, then ${ }^{0} \mathcal{C}_{P_{1} \mid P_{2}}(s, \lambda)$ is unitary.
(2) Fix $P, Q \in \mathscr{P}(A)$ and $s \in W(A)$. Then

defines a rational map of $\mathfrak{a}_{\mathbf{C}}^{*}$ into End $L$.
7. Continuation of the asymptotic expansion. Suppose that $\varphi(x, \lambda)$ equals $E_{P}(x, \Phi, \lambda)$, where $P$ is some cuspidal parabolic subgroup, $\Phi \in \mathscr{A}_{\text {cusp }}\left(M_{P}, \tau\right)$. We will now show that the coefficients of the asymptotic expansion (5.22) of $\varphi$ along $Q$, where $W\left(\mathfrak{a}_{Q}, \mathfrak{a}_{P}\right) \neq \varnothing$, can be expressed in terms of Eisenstein integrals defined on $M$. This shows that the asymptotic expansion has coefficients which have meromorphic extensions to $\mathfrak{a}_{P, \mathbf{C}}$.

Let $B \subset P, B \subset Q$, with $B$ minimal, $Q$ maximal, and $P$ cuspidal. We shall continue to use the notational conventions of $\S 2$. Namely, we shall not subscript objects associated with $Q$ (so we shall write $\mathfrak{a}$ for $\mathfrak{a}_{Q}=\mathfrak{a}_{M}$ where $\left.Q=N M\right)$, and subscript objects associated to $B$ with 0 (e.g. $A_{0}=A_{B}$ ). Further, we let $\mathscr{F}=(-1)^{1 / 2} \mathfrak{a}_{P}^{*}$, and we recall the nonstandard notation, $\mathscr{F}_{\mathbf{C}}=\mathfrak{a}_{P, \mathbf{c}}$. Let $L \in \mathscr{F}\left(M_{0}\right)$ and put,

Let $\Sigma\left(B, A_{0}\right)=\left\{\alpha_{1}, \ldots, \alpha_{q}\right\}$. Denote by $\beta_{i}, 1 \leq i \leq q$, the fundamental dominant weights dual to $\check{\alpha}_{i}$ where $\check{\alpha}_{i}=2 /\left(\alpha_{i}, \alpha_{i}\right) \cdot \alpha_{i}$. As $Q$
is a maximal parabolic, standard with respect to $B$, then there exists $k, 1 \leq k \leq q$, such that $\alpha_{i}(H)=0$ for all $i \neq k$. Define $\lambda_{H} \in \mathfrak{a}_{0, \mathbf{C}}^{*}$ by the equation

This last equality since $\lambda_{H}$ is a positive multiple of a dominant weight. Hence

This shows that $\Lambda\left(s^{-1} H-H\right) \leq 0$ as $\left(\Lambda, \check{\alpha}_{i}\right)>0$ by definition of $\mathfrak{a}_{0}^{*}(B)$. Further, we see that $\Lambda\left(s^{-1} H-H\right)=0$ if and only if $m_{i}=0$ for all $i$, which is equivalent to $s H-H=0$ which would imply that $s \in W\left(A_{0}\right)^{M}$.

For any $b \in U\left(\mathfrak{g}_{\mathbf{C}}\right)$ let $\nu_{Q}(b)$ be that unique element of $\lambda(\mathscr{S}(\mathfrak{m} \cap \mathfrak{s})) U(\mathfrak{t})$ such that $b-\nu_{Q}(b) \in \theta\left(\mathfrak{n}_{Q}\right) U\left(\mathfrak{g}_{\mathrm{C}}\right)$. Then by Lemma 4.3 of Trombi and Varadarajan [2] we have

where $\xi_{i}, \zeta_{i} \in U\left(\mathrm{t}_{\mathbf{C}}\right), \eta_{i} \in U\left(\mathfrak{m}_{\mathbf{C}}\right)$ and $g_{i}(m \exp t H) \mapsto 0$ as $t \mapsto \infty$, $H$ as in (2.1).

Let $R=B \cap M$. Note that $R$ is a minimal parabolic subgroup of $M$. Put

Cohn [1], Theorems 4 and 5) that for a parabolic subgroup $P$, the singularities of $c_{P \mid P}(1, \lambda)$ and $c_{P \mid P}(1, \lambda)^{-1}$ are all of the form $\mathscr{U}_{\alpha, r}=\left\{\lambda \in \mathfrak{a}_{0, \mathbf{c}} \mid(\lambda, \alpha)=r\right\}$, where $r \in \mathbf{C}, \alpha \in \mathbf{Z}_{+}\left(\Delta\left(P, A_{P}\right)\right)$. We shall say that $\lambda \in \mathfrak{a}_{P, \mathbf{C}}^{*}$ is in general position if $\lambda$ does not lie on any of the singular hyperplanes $\mathscr{U}_{\alpha, r}$.

Lemma 7.2. If $\lambda \in \mathfrak{a}_{0, \mathrm{C}}^{*}(B), \lambda$ in general position $a_{t}=\exp t H$, with $H$ as in (2.1), then

Here, the first sum is over a complete set of representatives of the cosets of $W\left(A_{0}\right)^{M}$ in $W\left(A_{0}\right)$, where we choose the element 1 to represent the identity coset. As $\lambda$ is assumed to be in general position we have by (6.32) that the above equals
