DEFORMATION OF SUBMANIFOLDS OF REAL PROJECTIVE SPACE

We prove that two surfaces in \mathbb{RP}^3 are projective deformations of each other (in the sense of E. Cartan) if and only if their induced projective structures are equivalent with respect to the Frenet framing. This result gives a projective generalization of molding surfaces.

0. Introduction. Equivalence problems of induced structures on submanifolds of homogeneous spaces are closely related to so called G-deformation problems. In the case of surfaces in $\mathbb{RP}^3 \cong \mathrm{PGL}(4; \mathbb{R})/G_0$ the projective deformation (PGL(4; $\mathbb{R})$ -deformation) problem has been investigated by E. Cartan (cf. [2]). In this paper we establish a relationship between the notion of projective deformation of surfaces and the notion of equivalence of induced projective structures on surfaces. Our main result is that two surfaces in \mathbb{RP}^3 are projective deformations of each other (in the sense of E. Cartan) if and only if their induced projective structures are equivalent with respect to the Frenet framing. (Theorem 5.3)

To better understand the geometric content of our result consider the analogous situation from classical surface theory. Take two surfaces in $\mathbf{R}^3 \cong \mathbf{E}(3)/O(3)$. Then the $\mathbf{E}(3)$ -deformation problem is just the equivalence problem of induced Riemannian structures (i.e., the problem of local isometry). However, $\mathbf{E}(3)$ -deformations in general do not preserve the Frenet frames (of Euclidean geometry) whereas, as we shall show, PGL(4; **R**)-deformations do preserve the Frenet frames (of projective geometry). Requiring that an $\mathbf{E}(3)$ -deformation should preserve the Frenet frames is equivalent to requiring that the corresponding local isometry preserves the lines of curvature, and the solutions to this latter problem are given by molding surfaces. (See [1], §5.) Our result may be thought of as a projective analog of molding surfaces.

Several features distinguish the projective differential geometry from the Euclidean differential geometry:

(i) A projective structure is a G-structure of degree two, i.e., it is a subbundle of the bundle of quadratic frames, and

(ii) an induced projective structure on a submanifold is not uniquely determined. In fact, it depends upon a choice of normal frame field.

The first order deformation problem becomes trivial (Theorem 4.4) reflecting the fact that a projective structure is a G-structure of degree two.

We now explain the organization of our paper.

The principal tools to be used are the notions of Pfaffian systems and their prolongations. In §1 the notion of prolongation is defined and applying the technique inductively an upper bound for the number of successive prolongations required to obtain singular integrals of the system is computed. This section constitutes a general method for attacking over-determined Pfaffian systems in two independent variables.

In §2 we discuss moving frames on submanifolds of \mathbb{RP}^n . In particular, the construction of Frenet frames on surfaces in \mathbb{RP}^3 are given.

In §3 we give a brief exposition on the general theory of induced projective structures and their equivalences.

In §4 we derive exterior systems describing projective deformations of submanifolds in \mathbb{RP}^n . The system describing first order deformations is seen to be involutive and the system describing second order deformations is seen to be over-determined in general.

In §5 we consider surfaces in \mathbb{RP}^3 . We show that for generic surfaces the exterior system describing second order deformations is over-determined. Applying the technique of prolongation it is shown that second order deformations take the Frenet frames to the Frenet frames: This gives the theorem that the second order deformation implies the equivalence of induced projective structures with respect to the Frenet frames. The converse implication is also proven. We complete the process of successive prolongations arriving at the integrability condition of E. Cartan (see [2], p. 288). This solves the problem of determining when non-trivial second order deformations exist: It also gives an upper bound on the dimension of the parameter space of the surface that are second order deformations of a given surface.

We shall work within the category of smooth maps and objects, except where we apply the Cartan-Kähler theorem and draw positive conclusions in which case we must assume real analyticity. Such assumptions will be explicitly made.

Finally, we acknowledge a great debt to E. Cartan's work. In particular, this paper grew out of an attempt to understand his paper [2]. The author is also grateful to Gary Jensen for several helpful discussions on E. Cartan's work and G-deformation problems in general. 1. Prolongations of Pfaffian systems. A Pfaffian system on a manifold M of dimension m can be thought of as a subbundle of the linear frame bundle L(M) defined by the equations

(1.1)
$$\Sigma: \{ \theta^{\alpha} = 0 \colon \theta^{\alpha} \in T^*M, i = 1, 2, \dots, s \},$$

where we assume that 1-forms (θ^{α}) are linearly independent.

Fix a *p*-dimensional submanifold $S_0 \xrightarrow{i_0} M$. We introduce the following index convention which will be used in this section:

$$1 \le i, j, k, \dots \le p,
1 \le \alpha, \beta, \gamma, \dots \le s,
1 \le a, b, c, \dots \le m - (p + s).$$

Let $(\omega^i, \omega^a, \omega^\alpha)$ be a coframe field on M so that $i_0^*(\omega^1 \wedge \omega^2 \wedge \cdots \wedge \omega^p) \neq 0$. We will be interested in finding *p*-dimensional integral submanifolds $S \xrightarrow{i} M$ so that i_*TS projects onto $i_{0*}TS_0$. That being so, we may as well assume that $\omega^1 \wedge \omega^2 \wedge \cdots \wedge \omega^p \wedge \theta^1 \wedge \cdots \wedge \theta^s \neq 0$, since otherwise such integral submanifolds clearly do not exist. Possibly rechoosing $(\omega^a, \omega^\alpha)$ we assume that $(\omega^i, \omega^a, \theta^\alpha)$ form a coframe field on M.

We differentiate (θ^{α}) and, suppressing the terms containing (θ^{α}) , obtain the following.

(1.2) $d\theta^{\alpha} \equiv A^{\alpha}_{ai}\omega^{a} \wedge \omega^{i} + \frac{1}{2}B^{\alpha}_{ij}\omega^{i} \wedge \omega^{j} + \frac{1}{2}C^{\alpha}_{ab}\omega^{a} \wedge \omega^{b}$ (modulo Σ), where A^{α}_{ai} , $B^{\alpha}_{ij} = -B^{\alpha}_{ji}$, $C^{\alpha}_{ab} = -C^{\alpha}_{ba}$ are functions on M.

DEFINITION 1.1. We say that the system is in normal form if $(C_{ab}^{\alpha}) \equiv 0$.

The significance of the system in normal form is that in such a case Cartan's involutivity criterion reduces the existence question of generic integral submanifolds to linear algebra.

Let (e_i, e_a, e_α) be the frame field on M dual to $(\omega', \omega^a, \theta^\alpha)$. We will choose a local coordinate system on the Grassman bundle of p-planes $G_p(M) \to M$, about the p-dimensional plane field defined by $e_1 \land e_2 \land$ $\dots \land e_p$, arising from the choice $(\omega', \omega^a, \theta^\alpha)$. A p-plane $E \in G_p(M)$ in the neighborhood defined by $\omega^1 \land \omega^2 \land \dots \land \omega^p \neq 0$ is represented by an $n \times p$ matrix,

$$\begin{bmatrix} \left(\boldsymbol{\delta}_{j}^{i}\right) \\ \left(l_{j}^{a}\right) \\ \left(l_{j}^{\alpha}\right) \end{bmatrix}.$$

That is to say, *E* is given by a decomposable *p*-vector $v_1 \wedge v_2 \wedge \cdots \wedge v_p$, where $v_j = e_j + l_j^a e_a + l_j^\alpha e_\alpha$. We take (l_j^a, l_j^α) as the standard fibre coordinates on $G_p(M)$.

We now express the condition that (θ^{θ}) and $(d\theta^{\alpha})$ vanish on $E \in G_p(M)$ in terms of the standard coordinates on $G_p(M)$. (Such elements $E \in G_p(M)$ are called integral elements; observe that they are possible tangent spaces of *p*-dimensional integral submanifolds.) On such an $E \in G_p(M)$, we have $\theta^{\alpha} = l_j^{\alpha} \omega^j = 0$, $\omega^a = l_j^a \omega^j$, $d\theta^{\theta} = 0$. Using (1.2) and substituting, we obtain,

$$(1.3) F_i^{\alpha}: l_i^{\alpha} = 0,$$

(1.4)
$$F_{ij}^{\alpha}: A_{aj}^{\alpha} l_i^{a} - A_{ai}^{\alpha} l_j^{a} + B_{ij}^{\alpha} + C_{ab}^{\alpha} \left(l_i^{a} l_j^{b} - l_i^{b} l_j^{a} \right) = 0.$$

Observe that the variety in $G_p(M)$ defined by $(F_i^{\alpha}) \equiv (F_{ij}^{\alpha}) \equiv 0$ may be empty. We then say that the system Σ is incompatible. We also note that if Σ is in normal form then equations (1.3) and (1.4) define a system of inhomogeneous linear equations, and hence the variety in question is irreducible.

We now define the prolongation of Σ .

DEFINITION 1.2. The prolongation of Σ , denoted by Σ' is the exterior differential system on $G_p(M)$ given by

$$\begin{split} \Sigma' &= \Sigma'^{(0)} \cup \Sigma'^{(1)} \cup \Sigma'^{(2)}, \text{ where} \\ \Sigma'^{(0)} &: \left\{ F_i^{\alpha} &= 0, F_{ij}^{\alpha} &= 0 \right\}, \\ \Sigma'^{(1)} &: \left\{ dF_i^{\alpha} &= 0, dF_{ij}^{\alpha} &= 0, \theta^{\alpha} &= 0, \omega^a - l_j^{\alpha} \omega^j &= 0 \right\}, \\ \Sigma'^{(2)} &: d\Sigma'^{(1)}. \end{split}$$

Here, and elsewhere, we write θ^{α} in place of $\pi^* \theta^{\alpha}$, where π : $G_p(M) \rightarrow M$, etc.

Restricting to the variety $V \subset G_p(M)$ defined by $\Sigma'^{(0)}$ we obtain a Pfaffian system on V, which we denote by $\hat{\Sigma}'$. Observe that $\hat{\Sigma}'$ is always in normal form.

We now consider the case of s equations in (s - 1)-unknowns ("slightly over-determined system") with two independent variables.

Let M be a (2s + 1)-dimensional manifold. On M we are given the Pfaffian system

(1.5) $\Sigma: \{ \theta^{\alpha} = 0, \alpha = 1, 2, \dots, s \}.$

Choose 1-forms (ω^i, ω^a) on M so that $(\omega^i, \omega^a, \theta^\alpha)$ form a coframe field. We will be interested in integral surfaces on which $\omega^1 \wedge \omega^2 \neq 0$. Note that our index convention becomes $1 \le i, j \le 2, 1 \le a, b \le s - 1, 1 \le \alpha$, $\beta \le s$.

Assuming that Σ is in normal form we write down $d\Sigma$, modulo Σ as usual,

(1.6)
$$d\Sigma: \left\{ d\theta^{\alpha} \equiv A^{\alpha}_{ai}\omega^{a} \wedge \omega^{i} + B^{\alpha}\omega^{1} \wedge \omega^{2} = 0 \right\}.$$

We now think of (A_{ai}^{α}) as an s by 2(s-1) matrix (A_A^{α}) by setting A = (i-1)(s-1) + a. We assume that the rank of (A_A^{α}) is maximal, i.e., equal to s. (If not, then further assuming that the system does not possess any "characteristic" (i.e., trivial) solutions, it can be shown that the system becomes involutive possibly with compatibility conditions.) Suffice it to say that then the system is not involutive.

We prolong the system. Keeping earlier notations we obtain:

(1.7)
$$\Sigma^{\prime(0)}: \left\{ F_i^{\alpha} = 0, F_{ij}^{\alpha} = 0 \right\}, \text{ where }$$
$$F_i^{\alpha} = l_i^{\alpha} = 0,$$

(1.8)
$$F_{ij}^{\alpha} = A_{aj}^{\alpha} l_i^{\alpha} - A_{ai}^{\alpha} l_j^{\alpha} + B^{\alpha} = 0.$$

Letting B = (2 - i)(s - 1) + a, we think of (l_i^a) as a vector $(l^B) \in \mathbb{R}^{2(s-1)}$. Also letting $(v^B) = {}^{t}(l^1, l^2, \dots, l^{s-1}, -l^s, \dots, -l^{2(s-1)})$ equations (1.8) become

(1.9)
$$A^{\alpha}_{B}v^{B} = B^{\alpha}.$$

The solutions of (1.9) form an (s-2)-dimensional affine space. It follows that $V \subset G_2(M)$ defined by $\Sigma'^{(0)}$ is an irreducible variety over M of fibre dimension (s-2). Let $t = (t^1, t^2, \ldots, t^{s-2})$ be a fibre coordinate system in V. Then $\hat{\Sigma}'$ on V is given by

$$\hat{\Sigma}': \left\{ \boldsymbol{\theta}^{\alpha} = 0, \, \boldsymbol{\omega}^{a} - \hat{l}_{j}^{a}(t) \, \boldsymbol{\omega}^{j} = 0 \right\},\,$$

where $(\hat{l}_i^a(t))$ denote the solutions of (1.9).

Observing that $d\theta^{\alpha} \equiv 0 \pmod{\hat{\Sigma}'}$ we compute that

$$d\hat{\Sigma}': \left\{ \theta^{\alpha} = d\omega^a - \hat{l}_j^a(t) d\omega^j - d\hat{l}_j^a(t) \omega^j = 0, a = 1, 2, \dots, s - 1 \right\}.$$

Rewriting the equations in $d\Sigma'$, we obtain

(1.10)
$$d\hat{\Sigma}': \left\{ \theta^{\alpha} \equiv a^{a}_{\epsilon j} dt^{\epsilon} \wedge \omega^{j} + b^{a} \omega^{1} \wedge \omega^{2} = 0 \right\},$$

where $(a_{\epsilon_j}^a)$ and (b^a) are functions on V and $1 \le \epsilon \le s - 2$. We see that $d\hat{\Sigma}'$ contains (s-1) equations $(\theta^{\alpha}) = 0$ and (s-2) unknowns (dt^{ϵ}) . Now applying the technique of prolongation successively we obtain the

THEOREM 1.3. Over-determined normal Pfaffian system with two independent variables in s equations and (s - 1) unknowns require at the most (s - 1) successive prolongations in order for the system to be either incompatible or involutive.

2. Higher order moving frames. We construct higher order moving frames on submanifolds of \mathbf{RP}^n . For a description of the general theory dealing with the problems of higher order contacts and frames of submanifolds of homogeneous spaces we refer to [5].

For the rest of the paper we adhere to the following index convention:

$$1 \le \alpha, \beta, \gamma, \dots \le n,$$

$$1 \le i, j, k, \dots \le p,$$

$$p + 1 \le a, b, c, \dots \le n.$$

RP^{*n*} is the real projective space of dimension *n* which we think of as lines in \mathbb{R}^{n+1} . PGL(*n* + 1; **R**), the group of projective transformations of **RP**^{*n*}, is GL(*n* + 1; **R**) modulo its center. Letting the *x*-axis to be the origin of **RP**^{*n*}, **RP**^{*n*} is realized as a homogeneous space PGL(*n* + 1; **R**)/*G*₀, where *G*₀ is the isotropy subgroup at the origin.

If $(X_{\beta}^{A})_{0 \le A, B \le n} \in GL(n + 1; \mathbf{R})$ with $X_{0}^{0} \ne 0$, then set $a^{\alpha} = X_{0}^{\alpha}/X_{0}^{0}$, $a_{\beta}^{\alpha} = X_{\beta}^{\alpha}/X_{0}^{0}$, $a_{\beta} = X_{\beta}^{0}/X_{0}^{0}$. We take $(a^{\alpha}, a_{\beta}^{\alpha}, a_{\beta})$ as a local coordinate system in the neighborhood of the identity of PGL $(n + 1; \mathbf{R})$ defined by $X_{0}^{0} \ne 0$. Then $(a^{\alpha}) \equiv 0$ defines G_{0} .

The Lie algebra $\mathscr{PGL}(n + 1; \mathbf{R})$ is the vector space direct sum $\mathscr{PGL}(n + 1; \mathbf{R}) = \mathscr{M}_0 \oplus \mathscr{GL}(n; \mathbf{R}) \oplus \mathscr{M}_0^*$ with the obvious bracket operations, where $\mathscr{M}_0 \cong \mathbf{R}^n$. Let $\Omega = (\Omega^{\alpha}, \Omega^{\alpha}_{\beta}, \Omega_{\beta})$ be the Maurer-Cartan form of PGL $(n + 1; \mathbf{R})$. It is $\mathscr{M}_0 \oplus \mathscr{GL}(n; \mathbf{R}) \oplus \mathscr{M}_0^*$ -valued and its components are the left-invariant 1-forms on PGL $(n + 1; \mathbf{R})$ which coincide with da^{α} , da^{α}_{β} , da_{β} at the identity. We record the structure equations:

$$\begin{cases} d\Omega^{\alpha} = -\Omega^{\alpha}_{\gamma} \wedge \Omega^{\gamma}, \\ d\Omega^{\alpha}_{\beta} = -\Omega^{\alpha}_{\gamma} \wedge \Omega^{\gamma}_{\beta} - \Omega^{\alpha} \wedge \Omega_{\beta} + \delta^{\alpha}_{\beta}\Omega_{\gamma} \wedge \Omega^{\gamma}, \\ d\Omega_{\beta} = -\Omega_{\gamma} \wedge \Omega^{\gamma}_{\beta}. \end{cases}$$

Let $f: S^p \to \mathbb{RP}^n$ be a *p*-dimensional submanifold given locally as a graph $(x^i) \mapsto (x^i, f^a(x))$, where $x = (x^i)$. Let $L(\mathbb{RP}^n)$ denote the bundle of linear frames over \mathbb{RP}^n . We choose the coordinates on $L(\mathbb{RP}^n)$ so that the natural projection $\mathrm{PGL}(n + 1; \mathbb{R}) \to L(\mathbb{RP}^n)$ is given by $(a^{\alpha}, a^{\alpha}_{\beta}, a_{\beta}) \mapsto (a^{\alpha}, a^{\alpha}_{\beta}) \equiv (a^{\alpha}, e_{\beta})$. Let L_0 denote the pull-back bundle $f^{-1}\mathrm{PGL}(n + 1; \mathbb{R})$.

$$\begin{array}{cccc}
L_0 & \to & \operatorname{PGL}(n+1;\mathbf{R}) \\
\downarrow & & \downarrow & \searrow \\
S & \stackrel{f}{\to} & \mathbf{RP}^n
\end{array} L(\mathbf{RP}^n)$$

We call a section $u: S \to L_0$ a zeroth order moving frame field along f. We see that a zeroth order moving frame field gives a local representation of the derivative map,

$$df = \phi^{\alpha} \otimes e_{\alpha} = u^* \Omega^{\alpha} \otimes e_{\alpha} \in \Gamma(T^*(S) \otimes f^{-1}T(\mathbf{RP}^n)).$$

Consider $u_0: S \to L_0$ given by

(2.1)
$$(x^{i}) \mapsto \begin{bmatrix} 1 & 0 & 0 \\ x^{1} & & \\ \vdots & I_{p} & 0 \\ x^{p} & & \\ f^{p+1}(x) & & \\ \vdots & \left(\frac{\partial f^{a}}{\partial x^{i}}(x)\right) & I_{n-p} \\ f^{n}(x) & & \end{bmatrix}$$

Then

$$u_0^*\Omega^a = \left(u_0^{-1}du_0\right)_0^a = -\frac{\partial f^a}{\partial x^k}dx^k + df^a = 0.$$

Hence u_0 normalizes df in the sense that

(2.2)
$$df = \phi^1 \otimes e_1 \oplus \cdots \oplus \phi^p \otimes e_p,$$

where $(\phi^i = u_0^* \Omega^i)$ form a coframe field on *S*.

Suppose we have another zeroth order moving frame field $u: S \to L_0$. Then $u = u_0 \cdot g$, where $g: S \to G_0$ is some smooth map. Consider the group action of G_0 on $\mathcal{M}_0 = \mathbb{R}^n$ defined by the equation $u^*(\Omega^{\alpha}) = (u_0 \cdot g)^*(\Omega^{\alpha})$. Using the fact that $(u_0 \cdot g)^*(\Omega^{\alpha}) = \text{the } \mathcal{M}_0$ -component of $\operatorname{Ad}(g^{-1})u_0^*\Omega$, we compute that: if $g(a_{\beta}^{\alpha}, a_{\beta}) = (A, a_{\beta}) \in G_0$ and $v \in \mathbb{R}^n$, then the action is given by $v \mapsto Av$. The obvious isotropy subgroup for this action is $G_1 < G_0$, where

$$(2.3) G_1 = \left\{ \begin{bmatrix} 1 & (a_j) & (\eta_b) \\ 0 & (a_j^i) & (\eta_b^i) \\ 0 & 0 & (b_b^a) \end{bmatrix} : \begin{pmatrix} a_j^i \end{pmatrix} \in \operatorname{GL}(p; \mathbf{R}), \\ {}^{\mathfrak{t}}(a_j) \in \mathbf{R}^{p, \mathfrak{t}}(\eta_b) \in \mathbf{R}^{n-p}, \\ (\eta_b^i) \in \mathbf{R}^{p \times (n-p)}, (b_b^a) \in \operatorname{GL}(n-p; \mathbf{R}) \right\}$$

DEFINITION 2.1. The bundle of first order moving frames of f is $L_1 = \{u_0 \cdot G_1\}$, where u_0 is given by (2.1).

 L_1 is a G_1 -principal bundle over S and any section $u: S \to L_1$ is called a first order moving frame field along f. We emphasize that any first order moving frame field along f normalizes df in the sense of (2.2).

On L_1 , $\Omega^a = 0$ for $p + 1 \le a \le n$. Differentiating both sides of the equation and using the structure equations we obtain $\Omega_i^a \land \Omega^i = 0$. By Cartan's lemma, it follows that

(2.4)
$$\Omega_{l}^{a} = A_{jk}^{a} \Omega^{k},$$

where $A_{jk}^a = A_{kj}^a$ are functions on L_1 .

Though the methods in what follows are quite general, for the remainder of this section we restrict ourselves to the case of surfaces in **RP**³ to ease computational difficulties and to simplify exposition. Note that our index convention becomes $1 \le i, j, k, \dots \le 2, 1 \le \alpha, \beta, \gamma, \dots \le 3$, and $a, b, c, \dots = 3$.

(2.4) becomes

(2.5)
$$\begin{cases} \Omega_l^3 = a\Omega^1 + b\Omega^2, \\ \Omega_2^3 = b\Omega^1 + c\Omega^2, \end{cases}$$

where a, b, c, are functions on L_1 .

Let

Then we have a vector space direct sum decomposition $\mathscr{G}_0 = \mathscr{G}_1 \oplus \mathscr{M}_1$, where \mathscr{G}_0 and \mathscr{G}_1 are Lie algebras for G_0 and G_1 respectively, and $\mathscr{M}_1 = \operatorname{span} \{ E_4, E_5 \}$. We write $(\Omega_i^3) = \Omega_i^3 \otimes E_4 \oplus \Omega_2^3 \otimes E_5 = \operatorname{the} \mathscr{M}_1$ component of Ω . Fix a first order moving frame field $\hat{u}: S \to L_1$. Write $\hat{u}^*\Omega_i^3 = \hat{x}_{ik}\hat{u}^*\Omega^k$ for some functions \hat{x}_{ik} on S. Suppose $u: S \to L_1$ is given by $u = \hat{u} \cdot g$, for a smooth map $g: S \to G_1$. Let x_{ik} be functions on S so that $u^*\Omega_i^3 = x_{ik}u^*\Omega^k$. We will compute the action of G_1 on (\hat{x}_{ik}) . Observe that $u^*((\Omega^\alpha) \oplus (\Omega_i^3)) = (\hat{u} \cdot g)^*((\Omega^\alpha) \oplus (\Omega_i^3)) = \operatorname{the} \mathscr{M}_0 \oplus \mathscr{M}_1$ -component of Ad $(g^{-1})\hat{u}^*\Omega$. Some matrix multiplications show that

(2.6)
$$X = g(\hat{X}) = \frac{1}{b} {}^{t}A\hat{X}A,$$

where

$$g = \begin{bmatrix} 1 & (a_j) & \eta^0 \\ 0 & & \\ & A & (\eta^i) \\ 0 & & \\ 0 & 0 & 0 & b \end{bmatrix} \in G_1, \quad X = (x_{jk}), \quad \hat{X} = (\hat{x}_{jk}).$$

There are four orbits of the above action represented by

(2.7)
$$\begin{pmatrix} 0 & 0 \\ 0 & 0 \end{pmatrix}, \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}, \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}, \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$$

Assuming that f is of constant orbit type, we call the first orbit type degenerate type, and the rest are called parabolic type, elliptic type, and hyperbolic type, respectively.

We give a description of the bundle of second order moving frames, denoted by L_2 , as follows.

Given a first order moving frame field $u: S \to L_1$ we write $u^*\Omega_i^3 = x_{ik}u^*\Omega^k$ ($x_{ik} = x_{ki}$ functions on S) as before. Let \mathscr{S}_2 denote the vector space of all real 2 × 2 symmetric matrices. We define $\Phi: L_1 \to \mathscr{S}_2$ by the following commutative diagram.

$$L_1 \qquad \stackrel{\Phi}{\rightarrow} \qquad \mathscr{S}_2$$

$$u \uparrow \qquad \stackrel{X_u = (x_{ik})}{\xrightarrow{X_u = (x_{ik})}}$$

 L_2 is then defined to be

$$\Phi^{-1}\left\{\begin{pmatrix}0&0\\0&0\end{pmatrix}\right\}, \quad \Phi^{-1}\left\{\begin{pmatrix}1&0\\0&0\end{pmatrix}\right\}, \quad \Phi^{-1}\left\{\begin{pmatrix}1&0\\0&1\end{pmatrix}\right\} \quad \text{or} \quad \Phi^{-1}\left\{\begin{pmatrix}0&1\\1&0\end{pmatrix}\right\}$$

depending upon the orbit type. L_2 is a G_2 -principle bundle over S, where G_2 is the isotropy subgroup of the action (2.6).

Suppose f is of degenerate type. Then the isotropy subgroup G_2 of the action (2.6) is G_1 itself, and L_1 is the bundle of Frenet frames. On $L_1, \Omega^3 = \Omega_1^3 = \Omega_2^3 = 0$. Consider the involutive left-invariant distribution on PGL(4; **R**) defined by the exterior differential system { $\Omega^3 = \Omega_1^3 = \Omega_2^3 = 0$ }. The analytic subgroup of PGL(4; **R**) corresponding to this distribution is

$$H = \left\{ \begin{bmatrix} 1 & (a_j) & \eta^0 \\ (a^i) & (a^i_j) & (\eta^i) \\ 0 & 0 & 0 & b \end{bmatrix} \in \text{PGL}(4; \mathbf{R}) \right\}.$$

Hence $f(S) \subseteq H/H \cap G_0 \cong \mathbb{RP}^2$.

We characterize the remaining (constant) type surfaces by the following theorem.

THEOREM 2.2. Let $(x^1, x^2, f(x))$ be a surface in **RP**³, and let

$$f_{ij}(x) = \frac{\partial^2 f}{\partial x^i \partial x^j}(x).$$

Then

- (i) if is of parabolic type if and only if $rank(f_{ij}) \equiv 1$,
- (ii) f is of elliptic type if and only if $rank(f_{ij}) \equiv 2$ and determinant $(f_{ij}) > 0$,
- (iii) if is of hyperbolic type if and only if $rank(f_{ij}) \equiv 2$ and determinant $(f_{ij}) < 0$.

The proof is computational. (See Theorem (2.11) of [8].)

We now restrict our attention to the hyperbolic type surfaces. The analyses of other types are completely similar using the theory of moving frames. However the hyperbolic type surfaces admit perhaps simpler geometric interpretations due to the existence of asymptotic coordinates. Note that the hyperbolic type surfaces are "negatively curved".

From (2.6) the identity component of the isotropy group G_2 is computed

$$\left\{ \begin{bmatrix} 1 & (a_j) & \eta^0 \\ 0 & a & 0 & (\eta^i) \\ 0 & 0 & \frac{b}{a} & b \\ 0 & 0 & 0 & - \end{bmatrix} \in G_1 : a, b \in \mathbf{R}^+ \right\}.$$

Let

We also let $\mathcal{M}_2 = \operatorname{span}\{E_6, E_7, E_8\}$. Then we have a vector space direct sum decomposition $\mathcal{G}_1 = \mathcal{G}_2 \oplus \mathcal{M}_2$, where \mathcal{G}_2 is the Lie algebra of G_2 . The \mathcal{M}_2 -component of Ω is given by

(2.8)
$$\Omega_1^2 \otimes E_6 \oplus \Omega_2^1 \otimes E_7 \oplus \left(\Omega_1^1 + \Omega_2^2 - \Omega_3^3\right) \otimes E_8$$

Computing the action of G_2 on \mathcal{M}_2 we discover that there are four orbit types at the next stage. We list them below.

(2.9) Type IIIa (degenerate type): $\Omega_1^2 - \Omega_2^1 = \Omega_1^1 + \Omega_2^2 - \Omega_3^3 = 0$ on L_3 . Type IIIb: $\Omega_1^1 + \Omega_2^2 - \Omega_3^3 = 0$, $\Omega_2^1 = 0$, $\Omega_1^2 = \Omega^1$ on L_3 . Type IIIc: $\Omega_1^1 + \Omega_2^2 - \Omega_3^3 = 0$, $\Omega_1^2 = 0$, $\Omega_2^1 = \Omega^2$ on L_3 . Type IIId (generic type): $\Omega_1^1 + \Omega_2^2 - \Omega_3^3 = 0$, $\Omega_2^1 = \Omega^2$, $\Omega_1^2 = \Omega^1$ on L_3 .

The first three orbit types represent ruled surfaces. We restrict ourselves to the generic type IIId. L_3 is then an integral submanifold of the exterior differential system $\{\Omega_l^1 + \Omega_2^2 - \Omega_3^3 = 0, \Omega_2^1 = \Omega^2, \Omega_l^2 = \Omega^1\}$ on L_2 , and it is G_3 -principal bundle over S. Computations reveal that the identity component of the isotropy group G_3 is

$$\left\{ \begin{bmatrix} 1 & a_1 & a_2 & \eta^0 \\ 0 & 1 & 0 & a_2 \\ 0 & 0 & 1 & a_1 \\ 0 & 0 & 0 & 1 \end{bmatrix} \in G_2 \colon a_1, a_2, \eta^0 \in \mathbf{R} \right\}.$$

Letting

we obtain the vector space direct sum decomposition

$$\mathscr{G}_{2} = \mathscr{G}_{3} \oplus \mathscr{M}_{3},$$

where \mathscr{G}_3 is the Lie algebra of G_3 and $\mathscr{M}_3 = \text{span}\{E_9, E_{10}, E_{11}, E_{12}\}$. The \mathscr{M}_3 -component of Ω is given by

(2.10)
$$(\Omega_1 - \Omega_3^2) \otimes E_9 \oplus (\Omega_2 - \Omega_3^1) \otimes E_{10} \oplus \Omega_l^1 \otimes E_{11} \oplus \Omega_3^3 \otimes E_{12}.$$

Computations show that there is a single orbit type at the next stage and that the action of G_3 on \mathcal{M}_3 allows us to make $\Omega_1 - \Omega_3^2 = \Omega_2 - \Omega_3^1 = 0$. The isotropy group G_4 is the identity.

 L_4 is the bundle of Frenet frames. Computations show that: On L_4 we have

$$(2.11) \begin{cases} \Omega^{3} = 0, \\ \Omega_{l}^{3} = \Omega^{2}, \quad \Omega_{2}^{3} = \Omega^{1}, \\ \Omega_{l}^{1} + \Omega_{2}^{2} - \Omega_{3}^{3} = 0, \quad \Omega_{2}^{2} = \Omega^{2}, \Omega_{l}^{2} = \Omega^{1}, \\ \Omega_{1} - \Omega_{3}^{2} = 0, \quad \Omega_{2} - \Omega_{3}^{1} = 0, \\ \Omega_{l}^{1} = 2a\Omega^{1} + b\Omega^{2}, \quad \Omega_{2}^{2} = a\Omega^{1} + 2b\Omega^{2}, \\ \Omega_{3} = p\Omega^{1} + q\Omega^{2}, \\ \Omega_{1} + \Omega_{3}^{2} = 2q\Omega^{1} + r\Omega^{2}, \quad \Omega_{2} + \Omega_{3}^{1} = s\Omega^{1} + 2p\Omega^{2} \end{cases}$$

where a, b, p, q, r, s are functions on L_4 .

The functions a, b, p, q, r, s are called (non-trivial) contact invariants.

At this juncture, a slightly different perspective may be helpful: Let Σ denote the exterior system on PGL(4; **R**) (with the independence condition that $\Omega^1 \wedge \Omega^2 \neq 0$) represented by the equations in (2.11). Also suppose that the functions a, b, p, q, r, s are so chosen that Σ is closed. That is, the functions a, b, p, q, r, s are compatible (but otherwise arbitrarily chosen). Counting the number of equations in Σ we see that there

exists a unique solution of the form $u: S \to PGL(4; \mathbb{R})$. Define $f: S \to \mathbb{RP}^3$ by $f \equiv \pi \circ u$, where $\pi: PGL(4; \mathbb{R}) \to \mathbb{RP}^3$ is the projection. Then u is the Frenet frame along f and all negatively curved non-ruled surfaces in \mathbb{RP}^3 arise in this way.

3. Induced projective structures. In this section we give a brief description of induced projective structures on submanifolds of \mathbf{RP}^n . For details and proofs pertaining to this section readers should consult sections three and four of [8].

In contrast to the case of Riemannian geometry, given a submanifold in \mathbf{RP}^n there are in general not one but many distinct induced projective structures on it. Roughly speaking, a choice of normal framing dtermines an induced structure.

Let $f: S^p \to \mathbf{RP}^n$ be a *p*-dimensional submanifold given locally as a graph $(x^i) \mapsto (x^i, f^a(x))$ as in §2. Recall that the bundle of first order moving frames of *f* is $L_1 = \{u_0 \cdot G_1\}$. (See 2.1.)

Let *H* be the subgroup of G_1 given by

(3.1)
$$H = \left\{ \begin{bmatrix} 1 & (a_j) & 0 \\ 0 & (a_j^i) & 0 \\ 0 & 0 & I_{n-p} \end{bmatrix} : \frac{(a_j^i) \in \operatorname{GL}(p; \mathbf{R})}{{}^{\operatorname{t}}(a_j) \in \mathbf{R}^p} \right\}.$$

Also, let N be the normal subgroup of G_1 given by

(3.2)
$$N = \left\{ \begin{bmatrix} (\eta_b) \\ I_{p+1} & (\eta_b^i) \\ 0 & (b_b^a) \end{bmatrix} : \frac{{}^{\mathfrak{t}}(\eta_b) \in \mathbf{R}^{n-p}(b_b^a) \in \operatorname{GL}(n-p;R) \\ (\eta_b^i) \in \mathbf{R}^{p \times (n-p)} \right\}.$$

Then $G_1 = H \cdot N$, a semi-direct product. And we identify G_1/N with H. Observe that H is isomorphic to the projective isotropy group.

Consider the quotient space L_1/N . Because N is a normal subgroup of G_1 , it follows from the general theory of principal bundles that $L_1/N \to S$ is a principal $G_1/N = H$ bundle. Furthermore, since H is isomorphic to the projective isotropy group of \mathbb{RP}^p , this bundle $L_1/N \to S$ is a candidate for defining a projective structure on S, provided that there is some natural way to imbed the bundle $L_1/N \to S$ into $Q(S) \to S$, where Q(S) is the principal bundle of quadratic frames over \mathbb{RP}^n . (I.e., the bundle of two-jets of local diffeomorphisms ($\mathbb{R}^p, 0$) $\to S$.)

We have the following proposition from [8].

PROPOSITION 3.1. Any map $\eta: S \to N$ determines a natural bundle map section $i_n: L_1/N \to L_1$.

Roughly speaking, a map $\eta: S \to N$ corresponds to a normal frame field along S.

The following commutative diagram defines $I_n: L_1/N \to f^{-1}Q(\mathbb{RP}^n)$.

$$f^{-1}Q(\mathbf{RP}^{n}) \rightarrow Q(\mathbf{RP}^{n})$$

$$I_{\eta} \nearrow \uparrow \qquad \uparrow$$

$$L_{1}/N \xrightarrow{i_{\eta}} L_{1} \subset L_{0} \rightarrow \mathrm{PGL}(n+1;\mathbf{R})$$

The Maurer-Cartan form plays a crucial role.

PROPOSITION 3.2.

- (i) $I_{\eta}^{*}\Theta'|_{f^{-1}Q(\mathbb{RP}^{n})} = i_{\eta}^{*}(\Omega^{i}, \Omega^{i}_{j})|_{L_{1}}$, where $\Theta' = (\theta^{i}, \theta^{i}_{j}) = the \mathbb{R}^{p} \oplus \mathscr{GL}(p; \mathbb{R})$ -component of the canonical form Θ of $Q(\mathbb{RP}^{n})$, and
- (ii) $I_{\eta}^* \theta^a |_{f^{-1}Q(\mathbb{R}\mathbb{P}^n)} = 0$, for $p + 1 \le a \le n$.

For details of the properties of Q(M) and Θ , we refer to [7, Chapter VI, §5].

DEFINITION 3.3. An induced projective structure on f is a pair $(L_1/N, I_\eta)$.

(3.3) Strictly speaking, the induced projective structures do not depend on the (η^b) -part of the map $\eta: S \to N$ (using the notation in (3.2)). Let $\pi: L_1 \to L(\mathbb{RP}^n)$ be the projection consistent with the forgetful functor $Q(\mathbb{RP}^n) \to L(\mathbb{RP}^n)$. (Note that $L_1 \subset PGL(n+1; \mathbb{R}) \subset Q(\mathbb{RP}^n)$.) Also let $\pi': G_1 \to GL(n; \mathbb{R})$ denote the group map of π . Then the totality of induced projective structures on f is parametrized by the maps $S \to \pi'(N)$, i.e., by sections of the bundle $\pi(L_1) \to \pi(L_1)/\pi'(N)$.

The next proposition states that an induced projective structure is indeed a projective structure. See [8] for a proof, and for the definition of projective structure.

PROPOSITION 3.4. There is a naturally defined bundle imbedding Φ_{η} : $L_1/N \rightarrow Q(S)$ so that

$$\Phi_{\eta}^*\Theta_{Q(S)} = I_{\eta}^*\Theta'\Big|_{f^{-1}Q(\mathbf{RP}^n)},$$

where $\Theta_{O(S)}$ is the canonical form of Q(S).

The following lemma is technically important, (and is proved in [8]).

LEMMA 3.5. Any first order moving frame field $u: S \to L_1$ can be written as $u = i_n \circ q$ for some $\eta: S \to N$ and a section $q: S \to L_1/N$.

Let $f, \bar{f}: S^p \to \mathbb{RP}^n$ be two submanifolds and $\eta, \bar{\eta}: S \to N$ be maps as before.

DEFINITION 3.6. We say that f and \overline{f} are (projectively) equivalent to each other with respect to the pair $(\eta, \overline{\eta})$ if the projective structures $(L_1/N, I_{\eta})$ and $(\overline{L}_1/N, I_{\overline{\eta}})$ are equivalent (as abstract projective structures, again see [8] for more details on equivalence).

(3.4) Suppose that f and \overline{f} are equivalent with respect to the pair $(\eta, \overline{\eta})$. Then given any section $q: S \to L_1/N$, there exists a corresponding section $\overline{q}: S \to \overline{L}_1/N$ defined by $\overline{q} = j \circ q$, where $J: L_1/N \to \overline{L}_1/N$ is the bundle isomorphism giving the equivalence. And by the definition of the equivalence of abstract projective structures we have

$$(i_{\eta} \circ q)^* (\Omega^i, \Omega^i_j) \Big|_{L_1} = (i_{\overline{\eta}} \circ \overline{q})^* (\Omega^i, \Omega^i_j) \Big|_{\overline{L}_1}.$$

(3.5) Conversely, suppose that we are given $u = i_{\eta} \circ q$: $S \to L_1$ and $\overline{u} = i_{\overline{\eta}} \circ q$: $S \to \overline{L}_1$ such that $u^*(\Omega^i, \Omega^i_j)|_{L_1} = \overline{u}^*(\Omega^i, \Omega^i_j)|_{\overline{L}_1}$. Then it is not hard to see that there is a bundle isomorphism J: $L_1/N \to \overline{L}_1/N$ with $\overline{q} = J \circ q$ giving the equivalence between $(L_1/N, I_{\eta})$ and $(\overline{L}_1/N, I_{\overline{\eta}})$. (See [8], Lemma (4.3).)

In view of the discussion in this section we can ask several different questions regarding the equivalence of induced projective structures depending on the amount of restrictions placed upon projective frames. One of these questions, where there are no restrictions on projective frames, is dealt with in [8]. However, as we shall see, the notion of projective deformations considered by E. Cartan places a severe limitation upon the choice of projective frames.

4. Projective deformations of submanifolds of RPⁿ. In this section we derive exterior differential systems describing projective deformations and draw some general conclusions.

Let $f, \bar{f}: S, S \to \mathbb{RP}^n$ be two *p*-dimensional submanifolds of \mathbb{RP}^n .

DEFINITION 4.1. f and \overline{f} are r th order projective deformations of each other if there exists a smooth map $v: S \to PGL(n + 1; \mathbb{R})$ and a diffeomorphism $F: S \to \overline{S}$ such that, for each point $s \in S$, f and $v(s) \circ \overline{f} \circ F$ define the same r-jet at s.

Since r th order deformation implies r th order contact, for sufficiently large r, r th order deformation problems admit only congruent solutions. In fact, if induced structures under consideration are G-structures of degree one then non-trivial first order deformations are already rare. (A somewhat incidental remark is that the notion of first order deformation is in general more "rigid" than the notion of equivalence of induced G-structres of degree one.)

However, in our case we have G-structures of degree two. That is to say, projective structures are naturally subbundles of the quadratic bundle. This will be reflected in Theorem 4.4.

Let $f, \bar{f}: S, \bar{S} \to \mathbb{RP}^n$ be *p*-dimensional submanifolds of \mathbb{RP}^n and let L_0 and L_1 (respectively \bar{L}_0 and \bar{L}_1) denote the bundles of zeroth and first order moving frames on f (respectively on \bar{f}).

Some computations, using Proposition 2 of §4 in [6], give the following theorems.

THEOREM 4.2. Suppose f and \bar{f} are first order projective deformations of each other. Then there exist $u: S \to L_1$, $\bar{u}: S \to \bar{L}_0$ and $F: S \to \bar{S}$ a diffeomorphism such that $u^*(\Omega^i)|_{L_1} = (\bar{u} \circ F)^*(\Omega^i)|_{\bar{L}_0}$. Conversely, suppose we have $(u, \bar{u}): S, \bar{S} \to PGL(n + 1; \mathbf{R})$ and $F: S \to \bar{S}$ a diffeomorphism so that $u^*(\Omega^i) = (\bar{u} \circ F)^*(\Omega^i)$. Then $f \equiv \pi \circ u$ and $\bar{f} \equiv \pi \circ u$ are first order deformations of each other, where $\pi: PGL(n + 1; \mathbf{R}) \to \mathbf{RP}^n$ is the natural projection given by $\pi(u) = u(0)$.

THEOREM 4.3. Suppose f and \overline{f} are second order projective deformations of each other. Then for any first order frame field $u: S \to L$, along f there exists a first order frame field $\overline{u}: \overline{S} \to \overline{L}_1$ and \overline{f} , and a diffeomorphism $F: S \to \overline{S}$ such that

(4.1)
$$\omega^i = \overline{\omega}^i, \quad \omega^i_j = \overline{\omega}^i_j, \quad \omega^a_j = \overline{\omega}^a_j$$

where $\omega^i = u^* \Omega^i$, etc. Conversely, if $u: S \to PGL(n + 1; \mathbf{R})$ and $\overline{u}: \overline{S} \to PGL(n + 1; \mathbf{R})$, and $F: S \to \overline{S}$ is a diffeomorphism, such that u and $\overline{u} \circ F$ satisfy (4.1) as well as

$$u^*\Omega^a = 0 = (\bar{u} \circ F)^*\Omega^a,$$

then $f = \pi \circ u$ and $\overline{f} = \pi \circ \overline{u}$ are second order deformations of each other.

REMARK. In the above, one can replace \overline{u} by $\overline{u} \circ F$, and thus dispense with F and \overline{S} .

COROLLARY. If first order frames u and \overline{u} along f and \overline{f} , respectively, satisfy (4.1), then they also satisfy

(4.2)
$$\omega_n^n = \overline{\omega}_n^n.$$

Proof. This will follow from the calculations leading up to (4.8).

We now prove:

THEOREM 4.4. Any two real-analytic p-dimensional submanifolds in \mathbb{RP}^n are first order deformations of each other.

Proof. Let $f, \bar{f}: S, \bar{S} \to \mathbb{RP}^n$ be the given submanifolds and let L_1 and \bar{L}_1 denote the bundles of first order moving frames on f and \bar{f} respectively. We consider the exterior differential system on $L_1 \times \bar{L}_1$ given by

$$\Sigma: \left\{ \Omega^i | _{L_1} = \Omega^i | \overline{L}_1, i = 1, 2, \dots, p \right\}$$

with specified independent variables $\Omega^1|_{L_1}$, $\Omega^2|_{L_1}$, \ldots , $\Omega^p|_{L_1}$. Writing the quadratic equations of Σ , modulo Σ , we obtain

$$d\Sigma:\left\{\left(\left.\Omega_{k}^{i}\right|_{L_{1}}-\left.\Omega_{k}^{i}\right|_{\overline{L}_{1}}\right)\wedge\left.\Omega^{k}\right|_{L_{1}}\equiv0,\,i=1,2,\ldots,p\right\}.$$

The system is in normal form and applying Cartan's involutivity criterion the system is seen to be involutive.

The rest of the proof follows easily using Theorem 4.2.

We now ask the question: Given $f: S \to \mathbb{RP}^n$ do there exist non-trivial second order deformations of it?

We consider the exterior differential system on $L_1 \times PGL(n + 1; \mathbf{R})$ with specified independent variables $\omega^1, \omega^2, \dots, \omega^p$ given by

$$(4.3) \quad \Sigma: \left\{ \omega^i = \Omega^i, \, \omega^i_j = \Omega^i_j, \, \omega^a_j = \Omega^a_j, \, 1 \le i, j \le p, \, p+1 \le a \le n \right\},$$

where $\omega^i = \Omega_{L_1}$, $\omega^i_j = \Omega^i_j|_{L_1}$ and $\omega^a_j = \Omega_j|_{L_1}$.

Note that here, and elsewhere, we write ω^i in place of $\pi^* \omega^i$, where π : $L_1 \times PGL(n + 1; \mathbf{R}) \to L_1$, etc. Hopefully this abuse of notation will not cause any confusion.

Suppose we have a *p*-dimensional solution

$$(u, \bar{u}): S \to L_1 \times \mathrm{PGL}(n+1; \mathbf{R})$$

of the system Σ in (4.1). Then \overline{f} defined by $\overline{f} \equiv \pi \circ \overline{u}$ is a second order deformation of f by Theorem 4.3.

$$S \xrightarrow{\bar{u}}_{f} PGL(n+1; \mathbf{R}) \xrightarrow{\pi}_{f} \mathbf{RP}^{n}$$

Moreover, it is easy to see that if $F: S \to \overline{S}$ is a diffeomorphism then $\overline{f} \circ F^{-1}: \overline{S} \to \mathbb{RP}^n$ is also a second order deformation of f.

We close the system Σ and write the quadratic equations modulo the system.

$$\begin{cases} \Omega_a^i \wedge \Omega^a \equiv 0, \\ -(\omega_a^i - \Omega_a^i) \wedge \omega_j^a - \omega^i \wedge (\omega_j - \Omega_j) + \delta_j^i (\omega_k - \Omega_k) \wedge \omega^k \\ & -\delta_j^i \Omega_a \wedge \Omega^a \equiv 0, \\ (\omega_b^a - \Omega_b^a) \wedge \omega_j^b - \Omega^a \wedge \Omega_j \equiv 0. \end{cases}$$

The above system is not in normal form and the general analysis is complicated. Suffice it to say that the system is over-determined and the prolongation of the system is difficult. Instead of the system (4.3) we consider a new system by imposing a genericity condition on solutions and by abusing the notation we call it Σ once again.

(4.4)
$$\Sigma: \left\{ \omega^{i} = \Omega^{i}, \, \omega^{i}_{j} = \Omega^{i}_{j}, \, \omega^{a}_{j} = \Omega^{a}_{j}, \, \Omega^{a} = 0, \\ 1 \leq i, j \leq p, \, p+1 \leq a \leq n \right\}.$$

The system is on $L_1 \times PGL(n + 1; \mathbf{R})$ and has designated independent variables $\omega^1, \omega^2, \dots, \omega^p$.

We compute the quadratic equations of the system, modulo the system as usual, and obtain

(4.5)
$$\begin{cases} -\left(\omega_a^i - \Omega_a^i\right) \wedge \omega_j^a - \omega^i \wedge \left(\omega_j - \Omega_j\right) + \delta_j^i (\omega_k - \Omega_k) \wedge \omega^k \equiv 0, \\ \left(\omega_b^a - \Omega_b^a\right) \wedge \omega_j^b \equiv 0. \end{cases}$$

The above system is in homogeneous normal form with unknowns

$$(\omega_a^i - \Omega_a^i), (\omega_j - \Omega_j) \text{ and } (\omega_b^a - \Omega_b^a)$$

Write

$$\Pi_a^i = \omega_a^i - \Omega_a^i, \quad \Pi_j = \omega_j - \Omega_j, \quad \Pi_b^a = \omega_b^a - \Omega_b^a.$$

Then (4.5) becomes

(4.6)
$$\begin{cases} \left(-A_{jk}^{a}\Pi_{a}^{i}+\delta_{k}^{i}\Pi_{j}+\delta_{j}^{i}\Pi_{k}\right)\wedge\omega^{k}\equiv0,\\ A_{jk}^{b}\Pi_{b}^{a}\wedge\omega^{k}\equiv0. \end{cases}$$

Recall that $\omega_j^a = A_{jk}^a \omega^k$ on L_1 . (See (2.4).)

We now restrict ourselves to hypersurfaces in \mathbb{RP}^{n} , (4.6) becomes

(4.7)
$$\begin{cases} \left(-A_{jk}\Pi_n^i + \delta_k^i\Pi_j + \delta_j^i\Pi_k\right) \wedge \omega^k \equiv 0.\\ A_{jk}\Pi_n^n \wedge \omega^k \equiv 0. \end{cases}$$

We assume that rank $A_{jk} \ge 2$. Note that this corresponds to either elliptic or hyperbolic type surfaces in **RP**³. By Cartan's lemma it follows that $\prod_{n=1}^{n} = 0$. We now have a partially prolonged system given by

(4.8)
$$\left\{ \omega^{i} = \Omega^{i}, \, \omega_{j}^{i} = \Omega_{j}^{i}, \, \omega_{j}^{n} = \Omega_{j}^{n}, \, \Omega^{n} = 0, \, \omega_{n}^{n} = \Omega_{n}^{n}, \\ 1 \le i, j \le p = n - 1 \right\}.$$

Exterior differentiations give

(4.9)
$$\begin{cases} \left(-A_{jk}\Pi_n^i + \delta_k^i\Pi_j + \delta_j^i\Pi_k\right) \wedge \omega^k \equiv 0, \\ A_{jk}\Pi_n^i \wedge \omega^k \equiv 0. \end{cases}$$

The system is once again over-determined.

5. Surfaces in **RP**³. Having the remark at the end of §3 in mind we make the following definition.

DEFINITION 5.1. Let $f, \bar{f}: S^p \to \mathbb{RP}^n$ be two submanifolds. Also let $u = i_\eta \circ q: S \to L_1$ and $\bar{u} = i_{\bar{\eta}} \circ \bar{q}: S \to \overline{L}_1$ be projective frames along f and \bar{f} respectively. Then we say that f and \bar{f} are projectively equivalent to each other with respect to the pair (u, \bar{u}) if the induced projective structures $(L_1/N, I_\eta)$ and $(\overline{L}_1/N, \overline{I}_{\bar{\eta}})$ are equivalent and the resulting equivalence carries q to \bar{q} .

The following lemma is merely a reformulation of the above definition.

LEMMA 5.2. Keeping the same notation as in the above definition, f and \bar{f} are projectively equivalent with respect to the pair (u, \bar{u}) if and only if $u^*(\Omega^i, \Omega^i_j)|_{L_1} = \bar{u}^*(\Omega^i, \Omega^i_j)|_{\bar{L}_1}$.

We now make a detailed study of second order deformations of surfaces in **RP**³. To do so, we recall earlier notations from §4 and restrict ourselves to hyperbolic type surfaces in **RP**³. (So p = 2 and n = 3.)

The system (4.8) becomes

(5.1) $\Sigma: \left\{ \omega^i = \Omega^i, \Omega^3 = 0, \omega_j^i = \Omega_j^i, \Omega_j^3 = \Omega_j^3, \omega_3^3 = \Omega_3^3, i, j = 1, 2 \right\}.$ The system is on $L_1 \times PGL(4; \mathbf{R})$ with specified independent variables ω^1 and ω^2 .

Observe that from the computations we made in §2 (see (2.9)) it follows that the solutions $\overline{f} = \pi \circ \overline{u}$ of the above system have the same third order type as f. In other words, if we assume that f has constant third order type IIId (the generic type), then any second order projective deformation of f is also of generic type. Thus assuming f to be of generic type, without loss of generality we restrict our system to $L_3 \times PGL(4; \mathbf{R})$. We take the generic type IIId.

We write down the quadratic equations of Σ .

(5.2)
$$\begin{cases} \left[\left(\omega_{3}^{1} - \omega_{2} \right) - \left(\Omega_{3}^{1} - \Omega_{2} \right) \right] \wedge \omega^{2} + 2\omega^{1} \wedge (\omega_{1} - \Omega_{1}) \equiv 0, \\ \left[\left(\omega_{3}^{1} - \omega_{2} \right) - \left(\Omega_{3}^{1} - \Omega_{2} \right) \right] \wedge \omega^{1} \equiv 0, \\ \left[\left(\omega_{3}^{2} - \omega_{1} \right) - \left(\Omega_{3}^{2} - \Omega_{1} \right) \right] \wedge \omega^{2} \equiv 0, \\ \left[\left(\omega_{3}^{2} - \omega_{1} \right) - \left(\Omega_{3}^{2} - \Omega_{1} \right) \right] \wedge \omega^{1} + 2\omega^{2} \wedge (\omega_{2} - \Omega_{2}) \equiv 0, \\ \theta^{1} \wedge \left[\left(\omega_{3}^{2} + \omega_{1} \right) - \left(\Omega_{3}^{2} + \Omega^{1} \right) \right] \\ + \theta^{2} \wedge \left[\left(\omega_{3}^{1} + \omega_{2} \right) - \left(\Omega_{3}^{1} + \Omega_{2} \right) \right] \equiv 0. \end{cases}$$

Letting $\Pi^1 = (\omega_3^1 - \omega_2) - (\Omega_3^1 - \Omega_2)$, $\Pi^2 = (\omega_3^2 - \omega_1) - (\Omega_3^2 - \Omega_1)$, $\Pi^3 = 2(\omega_1 - \Omega_1)$ and $\Pi^4 = 2(\omega_2 - \Omega_2)$, we rewrite (5.2).

(5.3)
$$\begin{cases} \Pi^{1} \wedge \omega^{2} & -\Pi^{3} \wedge \omega^{1} & \equiv 0 \\ \Pi^{1} \wedge \omega^{1} & \equiv 0 \\ & \Pi^{2} \wedge \omega^{2} & \equiv 0 \\ & \Pi^{2} \wedge \omega^{1} & -\Pi^{4} \wedge \omega^{2} \equiv 0 \\ \Pi^{1} \wedge \omega^{2} + \Pi^{2} \wedge \omega^{1} + \Pi^{3} \wedge \omega^{1} + \Pi^{4} \wedge \omega^{2} \equiv 0. \end{cases}$$

We have five equations and four unknowns and the system is overdetermined. According to the general theory the system requires at the most four successive prolongations.

We prolong the system by setting $\Pi^a = l_j^a \omega^j$, where $1 \le a \le 4$. Substituting into (5.3) we obtain

(5.4)
$$\begin{cases} l_1^1 + l_2^3 = 0, \\ l_2^1 = 0, \\ l_1^2 = 0, \\ l_2^2 + l_1^4 = 0, \\ l_1^1 - l_2^2 - l_2^3 + l_1^4 = 0. \end{cases}$$

We obtain three dimensional solutions given by $l_2^1 = l_1^2 = 0$, and $l_1^1 = l_2^2 = -l_2^3 = -l_1^4$, l_1^3 , l_2^4 arbitrary.

The prolonged system is on $L_3 \times PGL(4; \mathbf{R}) \times \mathbf{R}^3$.

(5.5)
$$\hat{\Sigma}' = \Sigma \cup \left\{ \Pi^1 = l_1^1 \omega^1, \, \Pi^2 = l_1^1 \omega^2, \, \Pi^3 = l_1^3 \omega^1 - l_1^1 \omega^2, \\ \Pi^4 = -l_1^1 \omega^1 + l_2^4 \omega^2 \right\}$$

We now have four equations and three unknowns.

Suppose (u, \overline{u}) : $S \to L_3 \times PGL(4; \mathbf{R})$ solves the above system. Then in particular we must have

$$\begin{cases} (u, \bar{u})^* \Pi^1 = u^* (\omega_3^1 - \omega_2) - \bar{u}^* (\Omega^{31} - \Omega_2) = t u^* \omega^1, \\ (u, \bar{u})^* \Pi^2 = u^* (\omega_3^2 - \omega_1) - \bar{u}^* (\Omega_3^2 - \Omega_1) = t u^* \omega^2, \end{cases}$$

for some function t on S. Let

$$K = \begin{bmatrix} 1 & 0 & 0 & t/2 \\ 0 & 1 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix} : S \to G_3$$

(recall from (2.9) that G_3 is the isotropy group for L_3). Also let $\hat{u} = uK$. Observe that (\hat{u}, \bar{u}) also solves the system with $t \equiv 0$. Hence, without losing generality, we replace (5.5) by

(5.6)
$$\Sigma \cup \{ \Pi^1 = 0, \Pi^2 = 0, \Pi^3 = l_1^3 \omega^1, \Pi^4 = l_2^4 \omega^2 \}.$$

Differentiate both sides of the equations $\Pi^1=0$ and $\Pi^2=0$ and obtain

$$\begin{cases} \omega^2 \wedge \left(\omega_3 - \Omega_3 - l_2^4 \omega^1\right) \equiv 0, \\ \omega^1 \wedge \left(\omega_3 - \Omega_3 - l_1^3 \omega^2\right) \equiv 0. \end{cases}$$

It follows that $\omega_3 - \Omega_3 = l_2^4 \omega^1 + l_1^3 \omega^2$.


The system is now on $L_3 \times \text{PGL}(4; \mathbf{R}) \times \mathbf{R}^2$.

(5.7) $\Sigma \cup \{ \Pi_1 = 0, \Pi_2 = 0 \}$

$$\cup \left\{ \omega_3 - \Omega_3 = l_2^4 \omega^1 + l_1^3 \omega^2, \, \Pi^3 = l_1^3 \omega^1, \, \Pi^4 = l_2^4 \omega^2 \right\}.$$

Recalling the computations we made in §2 (see (2.11)) we see that the solutions $\overline{f} = \pi \circ \overline{u}$ of the above system are of the same fourth order type as f. We restrict the system to $L_4 \times \text{PGL}(4; \mathbb{R}) \times \mathbb{R}^2$. The isotropy subgroup G_4 is trivial and the Frenet frame field $u: S \to L_4$ defines a unique map $\eta: S \to N \triangleleft G_1$. Similarly if $\overline{u}: S \to \text{PGL}(4; \mathbb{R})$ gives rise to a solution \overline{f} then \overline{u} actually is the Frenet frame field along \overline{f} and it defines a unique map $\overline{\eta}: S \to N \triangleleft G_1$. Let $u = i_{\eta} \circ q$ and $\overline{u} = i_{\overline{\eta}} \circ \overline{q}$ be the decompositions given by Lemma 3.5.

We then have the following commutative diagram.



The top horizontal arrow is given by $u \mapsto v \cdot u$ where $v: S \to PGL(4; \mathbf{R})$ achieves the deformations as in Definition 4.1. The middle horizontal arrow gives the projective equivalence with $\bar{q} = J \circ q$ as in (3.5).

THEOREM 5.3. Let $f, \bar{f}: S \rightarrow \mathbf{RP}^3$ be two non-ruled negatively curved surfaces in \mathbf{RP}^3 . Then f and \bar{f} are second order deformations of each other if and only if f and \bar{f} are projectively equivalent with respect to the Frenet frames.

Proof. Suppose f and \overline{f} are second order deformations of each other. Let u be the Frenet frame field along f. Then (u, \overline{u}) satisfy (4.1) and (4.2), (for n = 3), for some first order frame field \overline{u} along \overline{f} , by Theorem 4.3 and its Corollary. Recall that a Frenet frame is a fourth order frame, which is characterized by the table,

First order
Second order
Third order
Fourth order

$$\omega_1^3 = \omega^2, \ \omega_2^3 = \omega^1$$

 $\omega_1^1 + \omega_2^2 = \omega_3^3, \ \omega_2^1 = \omega^2, \ \omega_1^2 = \omega^1$
 $\omega_1 = \omega_3^2, \ \omega_2 = \omega_3^1$

where each order includes all the characterizations of the preceding orders as well. It follows then from (4.1) and (4.2), and as u is the Frenet frame, that \bar{u} is a third order frame field along f.

By the calculations leading up to (5.6) we have

(*)
$$\begin{pmatrix} \omega_3^1 - \omega_2 - (\overline{\omega}_3^1 - \overline{\omega}_2) = t\omega^1 \\ \omega_3^2 - \omega_1 - (\overline{\omega}_3^2 - \overline{\omega}_1) = t\omega^2 \end{pmatrix}$$

for some function t on S. Let

$$\begin{bmatrix} 1 & 0 & 0 & t/2 \\ 0 & 1 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \end{bmatrix} : S \to G_3.$$

Then \hat{u} : $\bar{u}K$ is also a third order frame field along \bar{f} . A direct calculation shows that (u, \hat{u}) satisfy (4.1), (4.2) and (*) with t = 0. Of course, in our case $\omega_3^1 = \omega_2$ and $\omega_3^2 = \omega_1$ as u is the Frenet frame. Consequently \hat{u} is the Frenet frame along \bar{f} . Then by Lemma 5.2, f and \bar{f} are projectively equivalent with respect to the pair of Frenet frames (u, \hat{u}) . To prove the converse, we assume that f and \bar{f} are projectively equivalent with respect to the pair (u, \bar{u}) where once again u, \bar{u} denote the Frenet frames along f and \bar{f} respectively. Then we have

$$u^*(\Omega^i, \Omega^i_j)\Big|_{L_1} = \overline{u}^*(\Omega^i, \Omega^i_j)\Big|_{\overline{L}_1}.$$

Now u, \bar{u} are the Frenet frames. Thus

$$u^*\Omega_1^3 = u^*\Omega^2 = \overline{u}^*\Omega^2 = \overline{u}^*\Omega_1^3$$
 and $u^*\Omega_2^3 = u^*\Omega^1 = \overline{u}^*\Omega_2^1 = \overline{u}^*\Omega_2^3$.

That is, (u, \bar{u}) solves the system

$$\Sigma: \left\{ \left. \Omega^{i} \right|_{L_{1}} = \left. \Omega^{i} \right|_{\overline{L}_{1}}, \left. \Omega^{i}_{j} \right|_{L_{1}} = \left. \Omega^{i}_{j} \right|_{\overline{L}_{1}}, \left. \Omega^{3}_{j} \right|_{L_{1}} = \left. \Omega^{3}_{j} \right|_{\overline{L}_{1}}, i, j = 1, 2 \right\}$$

on $L_{1} \times \overline{L}_{1}$. \Box

Here, the author is thankful to the referee for suggesting a revision of the proof of Theorem 5.3 which made the proof more readable.

We continue our analysis of the system (5.7). We compute the quadratic equations, modulo the system as usual, and obtain

(5.8)
$$\begin{cases} \omega^{1} \wedge (dl_{1}^{3} - 2l_{1}^{3}\Omega_{1}^{1}) \equiv 0, \\ \omega^{2} \wedge (dl_{2}^{4} - 2l_{2}^{4}\Omega_{2}^{2}) \equiv 0, \\ \omega^{2} \wedge (dl_{1}^{3} - 2l_{1}^{3}\Omega_{1}^{1}) + \omega \wedge (dl_{2}^{4} - 2l_{2}^{4}\Omega_{2}^{2}) \equiv 0. \end{cases}$$

We have three equations and two unknowns dl_1^3 and dl_2^4 . The system is over-determined. We prolong the system by adding equations

(5.9)
$$\begin{cases} dl_1^3 - 2l_1^3\Omega_1^1 = l\omega^1, \\ dl_2^4 - 2l_2^4\Omega_2^2 = l\omega^2. \end{cases}$$

Exterior differentiations of equations in (5.9) give

(5.10)
$$\begin{cases} dl \wedge \omega^{1} = -l\omega^{1} \wedge 3\omega_{1}^{1} + l_{1}^{3}\omega^{1} \wedge (4\omega_{1} - 2\omega^{2}), \\ dl \wedge \omega^{2} = -l\omega^{2} \wedge 3\omega_{2}^{2} + 2l_{2}^{4}\omega^{2} \wedge (\omega_{2}^{2} - \omega^{1}). \end{cases}$$

We have two equations and 1 unknown dl. We prolong the system by throwing in the equation

(5.11)
$$dl = 2l_2^4 A \omega^1 + 2l_1^3 B \omega^2 - l \omega_3^3,$$

where

$$A = \omega^2 \wedge (2\omega_2 - \omega^1)(e_1, e_2), \quad B = \omega^1 \wedge (\omega^2 - 2\omega_1)(e_1, e_2),$$

and e_1, e_2 are the frame field dual to ω^1, ω^2 . Observe that A and B are known functions on S.

Differentiating both sides of the equation (5.11) we finally obtain the compatibility condition of E. Cartan

(5.12)
$$2l_1^3(dr \wedge \omega^2) + 2l_2^4(ds \wedge \omega^1) + 3l(r-s)\omega^1 \wedge \omega^2 = 0,$$

where r and s are contact invariants computed in (2.11).

If $r \equiv s \equiv \text{constant}$ then the equation (5.12) is identically satisfied. In this case a three parameter family of solutions is possible. Otherwise, we let $dr = r_1\omega^1 + r_2\omega^2$ and $ds = s_1\omega^1 + s_2\omega^2$. Then (5.12) becomes

(5.13)
$$2l_1^3r_1 - 2l_2^4s_2 + 3l(r-s) = 0.$$

Solving for l_1^3 , l_2^4 and l we obtain at the most a two parameter family of solutions. This gives the

THEOREM 5.4. For a generic non-ruled negatively curved surface in \mathbb{RP}^3 there exists at the most a two parameter family of non-trivial second order deformations of it.

Settling the actual existence question of the above two parameter family of solutions would require a considerable amount of computations yet. A possible line of attack would be to set up an exterior system anew describing the system of differential equations coming from the compatibility condition.
