# ON GLOBAL REGULAR SOLUTIONS TO THE NAVIER-STOKES EQUATIONS IN CYLINDRICAL DOMAINS

#### Abstract

We consider the incompressible fluid motion described by the Navier-Stokes equations in a cylindrical domain $\Omega \subset \mathbb{R}^{3}$ under the slip boundary conditions. First we prove long time existence of regular solutions such that $v \in W_{2}^{2,1}(\Omega \times(0, T)), \nabla p \in L_{2}(\Omega \times(0, T))$, where $v$ is the velocity of the fluid and $p$ the pressure. To show this we need smallness of $\left\|v_{,_{3}}(0)\right\|_{L_{2}(\Omega)}$ and $\left\|f_{, x_{3}}\right\|_{L_{2}(\Omega \times(0, T))}$, where $f$ is the external force and $x_{3}$ is the axis along the cylinder. The above smallness restrictions mean that the considered solution remains close to the two-dimensional solution, which, as is well known, is regular.

Having $T$ sufficiently large and imposing some decay estimates on $\|f(t)\|_{L_{2}(\Omega)}$ we continue the local solution step by step up to the global one.

## 1. Introduction

We consider the initial-boundary value problems to the Navier-Stokes equations

where $\Omega \subset \mathbb{R}^{3}$ is a cylindrical domain, $S=\partial \Omega, v=\left(v_{1}(x, t), v_{2}(x, t), v_{3}(x, t)\right) \in$ $\mathbb{R}^{3}$ is the velocity of the fluid, $p=p(x, t) \in \mathbb{R}$ the pressure, $f=\left(f_{1}(x, t), f_{2}(x, t)\right.$, $\left.f_{3}(x, t)\right) \in \mathbb{R}^{3}$ the external force field, $x=\left(x_{1}, x_{2}, x_{3}\right)$ the global Cartesian system in $\Omega, \bar{n}$ is the unit outward vector normal to $S, \bar{\tau}_{\alpha}, \alpha=1,2$, is the tangent vector to $S$.

By $\mathbb{T}(v, p)$ we denote the stress tensor of the form

where $\nu>0$ is the viscosity coefficient, $I$ is the unit matrix and $\mathbb{D}(v)$ is the dilatation tensor of the form

Finally, $\gamma \geq 0$ is the slip coefficient.
By the dot we denote the scalar product in $\mathbb{R}^{3}$.
We assume that $\Omega$ is a cylinder parallel to the $x_{3}$-axis with arbitrary cross section. Moreover, $S=S_{1} \cup S_{2}$, where $S_{1}$ is the part of the boundary parallel to the $x_{3}$-axis and $S_{2}$ is perpendicular to it. Hence

where $a, c_{0}$ are given positive numbers and $\varphi_{0}\left(x_{1}, x_{2}\right)=c_{0}$ describes a sufficiently smooth closed curve in the plane $x_{3}=$ const.

The aim of this paper is to prove the existence of global regular solutions to problem (1.1) without restrictions on the size of norms of the initial velocity and the external force. The problem of wellposedness and regularity of weak solutions has a long history. In 1933 J . Leray (see [13]) proved the existence of global regular two-dimensional solutions in $\mathbb{R}^{3}$ and in 1959 O. A. Ladyzhenskaya (see [9]) showed the result in a bounded domain. Next many results of global regular solutions were proved under smallness conditions. In [7] H. Fujita and T. Kato assumed smallness of initial velocity in the homogeneous space $\dot{H}^{1 / 2}$. The result was improved in [20] by F. Weissler to the Lebesgue space $L_{3}$. In [3]
M. Cannone, Y. Meyer and F. Planchon proved existence of global unique regular solutions imposing smallness of initial velocity in $\dot{B}_{p, \infty}^{-1+3 / p}, p<\infty$.

The result allows a construction of global solution with strongly oscilating initial velocity with large norms either in $\dot{H}^{1 / 2}$ or $L_{3}$. Most recently, Koch and Tataru [8] proved the existence of a global unique solutions with sufficiently small initial velocity belonging to the space of vector fields whose components are derivatives of BMO functions.

A very clear and deep historical review can be found in [6].
The existence of global regular two-dimensional solutions (see [9], [13]) implies, by a perturbation argument, the existence of solutions to the 3d NavierStokes equations in their neighbourhood in some spaces. To realize the perturbation we are free in choosing basic spaces, domains and boundary conditions. Choosing Besov spaces and periodic boundary conditions, J. Y. Chemin, I. Gallagher and M. Paicu (see [6]) and the first two persons in [5] proved the existence of global regular solutions varying slowly in one direction. Hence, the solutions are in some sense close to two-dimensional solutions.

In [4] a construction of a regular solution is made in two steps. First there is proved the existence of solutions to the Navier-Stokes equations with two independent variables $\left(x_{1}, x_{2}\right)$ with the initial data being the mean with respect to $x_{3}$ of the initial velocity. Next a solution to the Navier-Stokes equations is derived by a perturbation argument applied to the above solutions.

For more references concerning the regularity problem see [6].
In this paper we prove the existence of global regular solutions under smallness of quantities $\left\|v_{, x_{3}}(0)\right\|_{L_{2}(\Omega)}$ and $\left\|f_{, x_{3}}\right\|_{L_{2}\left(0, T ; L_{6 / 5}(\Omega)\right)}$.

The main step of this proof is solvability of the problem for one component of the vorticity, $\chi=v_{2, x_{1}}-v_{1, x_{2}}$, which is possible under boundary slip conditions because they imply good boundary conditions for $\chi$ (see problem (3.16)).

It seems that our smallness condition (1.5) below is less restrictive than the corresponding one in [6].

The idea of considering the problem for the vorticity is taken from [10] (see also [22], [24]-[27]). But in [22], [25]-[27] stability results for axially symmetric solutions with small swirl were proved.

We should mention that the proof in this paper does not work for non-slip boundary conditions. However, for the space periodic case the proof holds and will be much simpler.

The techniques of papers [4]-[6] need much effords to be applicable for any bounded domain.

The paper is organized in the following way. In Section 2 there are introduced spaces used in this paper. In Section 3 we derived problems for $h=v_{, x_{3}}$ and $\chi$ which help us to show an a priori estimate in Section 4. In Section 5 the
existence of solutions to problem (1.1) is proved by the Leray-Schauder fixed point theorem. In Section 6 the existence is extended to any time step by step.

We should mention that long time existence to problem (1.1) was considered in [17] and global existence in [16].

Finally in Appendix some auxiliary results are either proved or formulated.
To prove global existence of solutions to (1.1) we shall examine problem (1.1) step by step in time. Therefore instead of (1.1) we consider the system of problems

where $k \in \mathbb{N}_{0}=\mathbb{N} \cup\{0\}$ and $v(k T)$ is calculated as a trace of $v$ from the interval $((k-1) T, k T]$.

To formulate existence results for problem (1.4) we introduce the following assumptions

where $c$ does not depend on $T$ and $k$.
Theorem A. Let the Assumptions 1-3 hold. Then there exists a solution to problem (1.4) such that

where $\varphi$ is an increasing positive function.
Remark $\mathrm{A}_{1}$. In general the constant $A=A(k, T)$ depends on $k, T$, because the quantities $K_{2}, K_{3}, K_{4}$ depend on the time integral norms of $f$ and on

Hence Theorem A is a local existence theorem and in reality describes existence in the interval $[0, T]$ only, because quantities (1.7) are not yet defined for $k \geq 1$.

Therefore the part of Theorem A for intervals $[k T,(k+1) T], k \geq 1$, is important for the proof of global existence only.

Hence the main step in the proof of global existence consists in obtaining estimations for quantities (1.7) independent of $k$.

Remark $\mathrm{A}_{2}$. Since $A$ depends on $T$ by time integral norms of the external force $f, T$ should not be very small for solutions to problem (1.4). It is understandable because smallness restriction on quantity $d(k, T)$ is imposed (see Assumptions 2, 3). However, it is not convenient to have large $T$ because then more restrictions on the external force $f$ must be imposed.

Theorem B. Let the assumptions of Theorem A hold. Let either Assumption 6.3 (see (6.28), (6.29)) or Assumption 6.4 (see (6.30)-(6.32)) hold. Then there exists a global solution to problem (1.1) such that $v \in W_{2}^{2,1}(\Omega \times(k T$, $(k+1) T)), \nabla p \in L_{2}(\Omega \times(k T,(k+1) T))$ for any $k \in \mathbb{N}_{0}$.

## 2. Notation

By $c$ we denote a generic constant which changes its value from line to line. In general it depends on the constants of imbeddings, regularity of the boundary and so on.

By $\varphi$ we denote a generic function which is always positive and increasing of its arguments. It also may change its form from line to line.

We denote

## 3. Auxiliary results

We start from the weak solutions because in this paper the existence of regularized weak solution will be proved.

Definition 3.1. By a weak solution to problem (1.1) we mean $v \in V_{2}^{0}\left(\Omega^{T}\right)$ such that $\operatorname{div} v=0,\left.v \cdot \bar{n}\right|_{S}=0$, and satisfying the integral identity

To prove the existence of weak solutions we need the Korn inequality.
Lemma 3.2 (see [19]). Assume that $E_{\Omega}(v)=\|\mathbb{D}(v)\|_{L_{2}(\Omega)}^{2}, \operatorname{div} v=0$ and $\left.v \cdot \bar{n}\right|_{S}=0$. Assume that the cylindrical domain $\Omega$ is not axially symmetric. Then there exists a constant $c_{1}$, which depends at most on $\Omega$ and $S$, such that

where $\lambda \in[0,1]$ and $\widetilde{v}, \widetilde{h}$ are considered as given functions.
Moreover, we assume that $\widetilde{h}=\widetilde{v}_{, x_{3}}, g=f_{, x_{3}}, h(k T)=v(k T)_{, x_{3}}$. Differentiating (5.1) with respect to $x_{3}$ and subtracting from (5.2) we obtain $h=v_{, x_{3}}$. Problems (5.1), (5.2) determine the mappings

## 6. Global existence

To prove the global existence of solutions to problem (1.1) we have to show that the constant $A$ appearing in Lemma 4.8 does not depend on $k$. For this purpose we have to show that, for any $k \in \mathbb{N}_{0}$,

+e^{-c_{1}^{\prime}(t-k T)+\int_{k T}^{t} \alpha d t^{\prime}} X(k T)
$$

Hence
(6.16) $X(t) \leq e^{-2 \delta(t-k T)+\int_{k T}^{t} \alpha\left(t^{\prime}\right) d t^{\prime}} \frac{1}{c_{1}^{\prime}-2 \delta}\|f(k T)\|_{L_{2}(\Omega)}^{2}$

$$
+e^{-c_{1}^{\prime}(t-k T)+\int_{k T}^{t} \alpha d t^{\prime}} X(k T) .
$$

Setting $t=(k+1) T$ and using the Korn inequality we obtain from (6.16) the relation

+c_{3}^{\prime} e^{-c_{1}^{\prime} T+c_{4}^{\prime} \varphi(A(k, T))}\|h(k T)\|_{H^{1}(\Omega)}^{2} .

Proof. Let us consider problem (3.15). Multiplying (3.15) ${ }_{1}$ by $\operatorname{div} \mathbb{T}(h, q)$ and integrating over $\Omega$ yields

\leq & \left(\|v\|_{L_{\infty}(\Omega)}\|\nabla h\|_{L_{2}(\Omega)}+\|\nabla v\|_{L_{3}(\Omega)}\|h\|_{L_{6}(\Omega)}\right)\|\operatorname{div} \mathbb{T}(h, q)\|_{L_{2}(\Omega)} \\
& +\|g\|_{L_{2}(\Omega)}\|\operatorname{div} \mathbb{T}(h, q)\|_{L_{2}(\Omega)} .
\end{aligned}
$$

From (6.24) we have
(6.25) $\frac{d}{d t}\left[\frac{1}{4} \int_{\Omega}|\mathbb{D}(h)|^{2} d x+\gamma \int_{S_{1}}\left|h \cdot \bar{\tau}_{\alpha}\right|^{2} d S_{1}\right]+\frac{1}{2} \int_{\Omega}|\operatorname{div} \mathbb{T}(h, q)|^{2} d x$

\leq c\left(\|v\|_{L_{\infty}(\Omega)}^{2}+\|\nabla v\|_{L_{3}(\Omega)}^{2}\right)\|h\|_{H^{1}(\Omega)}^{2}+\|g\|_{L_{2}(\Omega)}^{2} .
$$

Using Lemma A. 5 and the Korn inequality yields

and $c_{1}^{\prime}, c_{2}^{\prime}$ do not depend on $t$

To prove global existence of solution to problem (1.1) we have to show inequalities (6.1) and (6.2) for any $k \in \mathbb{N}_{0}$. For this purpose we use Lemmas 6.1 and 6.2. Let us introduce the assumptions

& +e^{-c_{1}^{\prime} T+c_{4}^{\prime} \varphi(A(T))}\|h(0)\|_{H^{1}(\Omega)}^{2} \leq\|h(0)\|_{H^{1}(\Omega)}^{2}
\end{align*}

Assumptions 6.4. Assume that

for $\delta>0, t \in(k T,(k+1) T], k \in \mathbb{N}_{0}$. Assume also
(6.31) $\quad c_{3}^{\prime} e^{-2 \delta T+c_{4}^{\prime} \varphi(A(T))}\|f(k T)\|_{L_{2}(\Omega)}^{2}+c_{3}^{\prime} e^{-c_{1}^{\prime} T+c_{4}^{\prime} \varphi(A(T))}\|v(0)\|_{H^{1}(\Omega)}^{2}$

\leq\|v(0)\|_{H^{1}(\Omega)}^{2}
$$

$$
\begin{align*}
c_{3}^{\prime} e^{-2 \delta T+c_{4}^{\prime} \varphi(A(T))}\|g(k T)\|_{L_{2}(\Omega)}^{2}+c_{3}^{\prime} e^{-c_{1}^{\prime} T+c_{4}^{\prime} \varphi(A(T))}\|h(0)\|_{H^{1}(\Omega)}^{2}  \tag{6.32}\\
\leq\|h(0)\|_{H^{1}(\Omega)}^{2}
\end{align*}

for any $k \in \mathbb{N}_{0}$.
Proof of Theorem B. Take $k=0$. Then $A(0, T)=A(T)$ and in view of Assumptions 6.3 and 6.4 we obtain

holds, where $a_{1}$ is a constant.
Lemma A.1. The constant $a_{1}$ does not depend on $T$.
Proof. From [26] we have

where $d \geq \operatorname{diam} \Omega$ and $c$ does not depend on $T$.
We express the above integral in the form

Changing variables $y_{n}=x_{n} / \sqrt{\tau}, d x_{n}=\sqrt{\tau} d y_{n}$ we get

I_{1}^{\prime}=\int_{0}^{1} d \tau \tau^{1 / 2 p+1 / 2-3 / 2}\left(\int_{0}^{\infty} y_{n}^{p} e^{-p y_{n}^{2}} d y_{n}\right)^{1 / p} \leq c(p) \int_{0}^{1} d \tau \tau^{1 / 2 p-1} \leq c(p)
$$

Next

I_{2} & \leq \int_{1}^{T} d \tau \frac{1}{\tau^{3 / 2}}\left(\int_{0}^{d} d^{p} d x_{n}\right)^{1 / p} \\
& =d^{1+1 / p} \int_{1}^{T} \frac{d \tau}{\tau^{3 / 2}} \leq 2 d^{1+1 / p}\left(1-\frac{1}{\sqrt{T}}\right) \leq 2 d^{1+1 / p}
\end{aligned}
$$

which concludes the proof.
Lemma A.2. The constant $a_{2}$ in the imbedding

To apply the interpolation inequality (3.1) from [12, Chapter 2, Section 3] we have to extend $u$ outside of $\Omega$ in such a way that the extended function $\widetilde{u}$ vanishes outside a compact set. Then the interpolation inequality holds without a lower order term on the r.h.s. Hence, we extend $u$ by the Hestenes-Whitney method in such a way that $\left.\widetilde{u}\right|_{\Omega}=u, \operatorname{supp} \widetilde{u}=\widetilde{\Omega}$ and $\widetilde{\Omega}$ is a compact set. Moreover, $\|\widetilde{u}\|_{H^{1}(\widetilde{\Omega})} \leq$ $c_{1}^{\prime}\|u\|_{H^{1}(\Omega)},\|\widetilde{u}\|_{L_{2}(\widetilde{\Omega})} \leq c_{2}^{\prime}\|u\|_{L_{2}(\Omega)}$, where the constants $c_{1}^{\prime}$, $c_{2}^{\prime}$ depend on $\Omega$. For $\widetilde{u}$ we have the interpolation

\|\widetilde{u}\|_{L_{p}(\widetilde{\Omega})} \leq c_{3}^{\prime}\|\nabla \widetilde{u}\|_{L_{2}(\widetilde{\Omega})}^{\alpha}\|\widetilde{u}\|_{L_{2}(\widetilde{\Omega})}^{1-\alpha}, \quad \alpha=\frac{3}{3}-\frac{3}{p} \leq 1
$$

where $c_{3}^{\prime}$ depends on $\widetilde{\Omega}$.
Next, we have

Setting $\alpha q=2$ and applying the Young inequality yields

with constant $c_{5}^{\prime}$ independent of $T$.
Let $u \in V_{2}^{1}\left(\Omega^{T}\right)$. By (A.5) we have

\|v\|_{W_{r}^{2,1}\left(\Omega^{T}\right)}+\|\nabla p\|_{L_{r}\left(\Omega^{T}\right)} \leq a_{4}\left(\|f\|_{L_{r}\left(\Omega^{T}\right)}+\left\|v_{0}\right\|_{W_{r}^{2-2 / r}(\Omega)}\right) \tag{A.10}
\end{equation*}

where $a_{4}$ does not depend on $T$.
Proof. We use [21, Chapter 3, Theorem 3.1.1].
Let us consider the elliptic problem

Lemma A.5. Let $f \in L_{2}(\Omega), S \in C^{2}$. Then there exists a solution to problem (A.11) such that $v \in H^{2}(\Omega)$ and $\nabla p \in L_{2}(\Omega)$ and the following estimate
