# dirichlet heat kernel estimates for fractional LAPLACIAN WITH GRADIENT PERTURBATION

#### Abstract

Suppose that $d \geq 2$ and $\alpha \in(1,2)$. Let $D$ be a bounded $C^{1,1}$ open set in $\mathbb{R}^{d}$ and $b$ an $\mathbb{R}^{d}$-valued function on $\mathbb{R}^{d}$ whose components are in a certain Kato class of the rotationally symmetric $\alpha$-stable process. In this paper, we derive sharp two-sided heat kernel estimates for $\mathcal{L}^{b}=\Delta^{\alpha / 2}+b \cdot \nabla$ in $D$ with zero exterior condition. We also obtain the boundary Harnack principle for $\mathcal{L}^{b}$ in $D$ with explicit decay rate.


1. Introduction. Throughout this paper we assume $d \geq 2, \alpha \in(1,2)$ and that $X$ is a (rotationally) symmetric $\alpha$-stable process on $\mathbb{R}^{d}$. The infinitesimal generator of $X$ is $\Delta^{\alpha / 2}:=-(-\Delta)^{\alpha / 2}$. We will use $B(x, r)$ to denote the open ball centered at $x \in \mathbb{R}^{d}$ with radius $r>0$.

Definition 1.1. For a function $f$ on $\mathbb{R}^{d}$, we define for $r>0$,

$$
M_{f}^{\alpha}(r)=\sup _{x \in \mathbb{R}^{d}} \int_{B(x, r)} \frac{|f|(y)}{|x-y|^{d+1-\alpha}} d y .
$$

A function $f$ on $\mathbb{R}^{d}$ is said to belong to the Kato class $\mathbb{K}_{d, \alpha-1}$ if $\lim _{r \downarrow 0} M_{f}^{\alpha}(r)=0$.
Since $1<\alpha<2$, using Hölder's inequality, it is easy to see that for every $p>d /(\alpha-1), L^{\infty}\left(\mathbb{R}^{d} ; d x\right)+L^{p}\left(\mathbb{R}^{d} ; d x\right) \subset \mathbb{K}_{d, \alpha-1}$. Throughout this paper we will assume that $b=\left(b^{1}, \ldots, b^{d}\right)$ is an $\mathbb{R}^{d}$-valued function on $\mathbb{R}^{d}$ such that $|b| \in \mathbb{K}_{d, \alpha-1}$. Define $\mathcal{L}^{b}=\Delta^{\alpha / 2}+b \cdot \nabla$. Intuitively, the fundamental solution $p^{b}(t, x, y)$ of $\mathcal{L}^{b}$ and the fundamental solution $p(t, x, y)$ of $\Delta^{\alpha / 2}$, which is also the transition density of $X$, should be related by the following Duhamel formula:

p^{b}(t, x, y)=p(t, x, y)+\int_{0}^{t} \int_{\mathbb{R}^{d}} p^{b}(s, x, z) b(z) \cdot \nabla_{z} p(t-s, z, y) d z d s \tag{1.1}
\end{equation*}
$$

[^0]Applying the above formula repeatedly, one expects that $p^{b}(t, x, y)$ can be expressed as an infinite series in terms of $p$ and its derivatives. This motivates the following definition. Define $p_{0}^{b}(t, x, y)=p(t, x, y)$ and, for $k \geq 1$,

\begin{equation*}
p_{k}^{b}(t, x, y):=\int_{0}^{t} \int_{\mathbb{R}^{d}} p_{k-1}^{b}(s, x, z) b(z) \cdot \nabla_{z} p(t-s, z, y) d z d s \tag{1.2}
\end{equation*}
$$

The following results are shown in [6], Theorem 1, Lemmas 15 and 23, and their proofs. Here and in the sequel, we use $:=$ as a way of definition. For $a, b \in \mathbb{R}$, $a \wedge b:=\min \{a, b\}$ and $a \vee b:=\max \{a, b\}$.

THEOREM 1.2. (i) There exist $T_{0}>0$ and $c_{1}>1$ depending on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that $\sum_{k=0}^{\infty} p_{k}^{b}(t, x, y)$ converges locally uniformly on $\left(0, T_{0}\right] \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ to a positive jointly continuous function $p^{b}(t, x, y)$ and that on $\left(0, T_{0}\right] \times \mathbb{R}^{d} \times \mathbb{R}^{d}$,

$$
\begin{equation*}
c_{1}^{-1}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \leq p^{b}(t, x, y) \leq c_{1}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \tag{1.3}
\end{equation*}
$$

Moreover, $\int_{\mathbb{R}^{d}} p^{b}(t, x, y) d y=1$ for every $t \in\left(0, T_{0}\right]$ and $x \in \mathbb{R}^{d}$.
(ii) The function $p^{b}(t, x, y)$ defined in (i) can be extended uniquely to a positive jointly continuous function on $(0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ so that for all $s, t \in(0, \infty)$ and $(x, y) \in \mathbb{R}^{d} \times \mathbb{R}^{d}, \int_{\mathbb{R}^{d}} p^{b}(t, x, z) d z=1$ and

$$
\begin{equation*}
p^{b}(s+t, x, y)=\int_{\mathbb{R}^{d}} p^{b}(s, x, z) p^{b}(t, z, y) d z \tag{1.4}
\end{equation*}
$$

(iii) If we define

$$
\begin{equation*}
P_{t}^{b} f(x):=\int_{\mathbb{R}^{d}} p^{b}(t, x, y) f(y) d y \tag{1.5}
\end{equation*}
$$

then for any $f, g \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$, the space of smooth functions with compact supports,

$$
\lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} t^{-1}\left(P_{t}^{b} f(x)-f(x)\right) g(x) d x=\int_{\mathbb{R}^{d}}\left(\mathcal{L}^{b} f\right)(x) g(x) d x
$$

Thus $p^{b}(t, x, y)$ is the fundamental solution of $\mathcal{L}^{b}$ in the distributional sense.
Here and in the rest of this paper, the meaning of the phrase "depending on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero" is that the statement is true for any $\mathbb{R}^{d}$-valued function $\tilde{b}$ on $\mathbb{R}^{d}$ with

$$
M_{|\tilde{b}|}^{\alpha}(r) \leq M_{|b|}^{\alpha}(r) \quad \text { for all } r>0
$$

Note that the Green function $G(x, y)$ of $X$ is $c /|x-y|^{d-\alpha}$ and so $\left|\nabla_{x} G(x, y)\right| \leq$ $c /|x-y|^{d-\alpha+1}$. This indicates that $\mathbb{K}_{d, \alpha-1}$ is the right class of functions for gradient perturbations of fractional Laplacian. The same phenomenon happens for $\Delta+b \cdot \nabla$; see [18].

It is easy to show (see Proposition 2.3 below) that the operators $\left\{P_{t}^{b} ; t \geq 0\right\}$ defined by (1.5) form a Feller semigroup and so there exists a conservative Feller process $X^{b}=\left\{X_{t}^{b}, t \geq 0, \mathbb{P}_{x}, x \in \mathbb{R}^{d}\right\}$ in $\mathbb{R}^{d}$ such that $P_{t}^{b} f(x)=\mathbb{E}_{x}\left[f\left(X_{t}^{b}\right)\right]$. The process $X^{b}$ is, in general, nonsymmetric. We call $X^{b}$ an $\alpha$-stable process with drift $b$, since its infinitesimal generator is $\mathcal{L}^{b}$.

For any open subset $D \subset \mathbb{R}^{d}$, we define $\tau_{D}^{b}=\inf \left\{t>0: X_{t}^{b} \notin D\right\}$. We will use $X^{b, D}$ to denote the subprocess of $X^{b}$ in $D$; that is, $X_{t}^{b, D}(\omega)=X_{t}^{b}(\omega)$ if $t<\tau_{D}^{b}(\omega)$ and $X_{t}^{b, D}(\omega)=\partial$ if $t \geq \tau_{D}^{b}(\omega)$, where $\partial$ is a cemetery state. The subprocess of $X$ in $D$ will be denoted by $X^{D}$. Throughout this paper, we use the convention that for every function $f$, we extend its definition to $\partial$ by setting $f(\partial)=0$. The infinitesimal generator of $X^{b, D}$ is $\left.\mathcal{L}^{b}\right|_{D}$, that is, $\mathcal{L}^{b}$ on $D$ with zero exterior condition. The process $X^{b, D}$ has a transition density $p_{D}^{b}(t, x, y)$ with respect to the Lebesgue measure; see (3.4) below. The transition density $p_{D}^{b}(t, x, y)$ of $X^{b, D}$ is the fundamental solution of $\left.\mathcal{L}^{b}\right|_{D}$. The transition density of $X^{D}$ is denoted by $p_{D}(t, x, y)$, and it is the fundamental solution of $\left.\mathcal{L}\right|_{D}$.

The purpose of this paper is to establish the following sharp two-sided estimates on $p_{D}^{b}(t, x, y)$ in Theorem 1.3. To state this theorem, we first recall that an open set $D$ in $\mathbb{R}^{d}$ is said to be a $C^{1,1}$ open set if there exist a localization radius $R_{0}>0$ and a constant $\Lambda_{0}>0$ such that for every $z \in \partial D$, there exist a $C^{1,1}$-function $\phi=\phi_{z}: \mathbb{R}^{d-1} \rightarrow \mathbb{R}$ satisfying $\phi(0)=0, \nabla \phi(0)=(0, \ldots, 0)$, $\|\nabla \phi\|_{\infty} \leq \Lambda_{0},|\nabla \phi(x)-\nabla \phi(z)| \leq \Lambda_{0}|x-z|$ and an orthonormal coordinate system $C S_{z}: y=\left(y_{1}, \ldots, y_{d-1}, y_{d}\right):=\left(\tilde{y}, y_{d}\right)$ with its origin at $z$ such that

$$
B\left(z, R_{0}\right) \cap D=\left\{y \in B\left(0, R_{0}\right) \text { in } C S_{z}: y_{d}>\phi(\tilde{y})\right\}
$$

The pair $\left(R_{0}, \Lambda_{0}\right)$ is called the characteristics of the $C^{1,1}$ open set $D$. We remark that in some literatures, the $C^{1,1}$ open set defined above is called a uniform $C^{1,1}$ open set as $\left(R_{0}, \Lambda_{0}\right)$ is universal for every $z \in \partial D$. For $x \in D$, let $\delta_{D}(x)$ denote the Euclidean distance between $x$ and $\partial D$. Note that a bounded $C^{1,1}$ open set may be disconnected.

THEOREM 1.3. Let $D$ be a bounded $C^{1,1}$ open subset of $\mathbb{R}^{d}$ with $C^{1,1}$ characteristics $\left(R_{0}, \Lambda_{0}\right)$. Define

$$
f_{D}(t, x, y)=\left(1 \wedge \frac{\delta_{D}(x)^{\alpha / 2}}{\sqrt{t}}\right)\left(1 \wedge \frac{\delta_{D}(y)^{\alpha / 2}}{\sqrt{t}}\right)\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right)
$$

For each $T>0$, there are constants $c_{1}=c_{1}\left(T, R_{0}, \Lambda_{0}, d, \alpha, \operatorname{diam}(D), b\right) \geq 1$ and $c_{2}=c_{2}(T, d, \alpha, D, b) \geq 1$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that:
(i) on $(0, T] \times D \times D$,

$$
c_{1}^{-1} f_{D}(t, x, y) \leq p_{D}^{b}(t, x, y) \leq c_{1} f_{D}(t, x, y)
$$

(ii) on $[T, \infty) \times D \times D$,

$$
c_{2}^{-1} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq p_{D}^{b}(t, x, y) \leq c_{2} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2},
$$

where $-\lambda_{0}^{b, D}:=\sup \operatorname{Re}\left(\sigma\left(\left.\mathcal{L}^{b}\right|_{D}\right)\right)<0$.
Here diam $(D)$ denotes the diameter of $D$. At first glance, one might think that the estimates in Theorem 1.3 can be obtained from the estimates for $p_{D}(t, x, y)$ by using a Duhamel formula similar to (1.1) with $p^{b}, p$ and $\mathbb{R}^{d}$ replaced by $p_{D}^{b}, p_{D}$ and $D$, respectively. Unfortunately such an approach does not work for $p_{D}^{b}(t, x, y)$. This is because unlike the whole space case, we do not have a good control on $\nabla_{z} p_{D}(s, z, y)$ when $z$ is near the boundary of $D$. When $D=\mathbb{R}^{d}, p(t, x, y)$ is the transition density of the symmetric $\alpha$-stable process, and there is a nice bound for $\nabla_{z} p(t, z, y)$. This is the key reason why the result in Theorem 1.2(i) can be established by using Duhamel's formula. Instead, we establish Theorem 1.3 by using probabilistic means through the Feller process $X^{b}$. More specifically, we adapt the road map outlined in our paper [9] that establishes sharp two-sided Dirichlet heat kernel estimates for symmetric $\alpha$-stable processes in $C^{1,1}$ open sets. Clearly, many new and major difficulties arise when adapting the strategy outlined in [9] to $X^{b}$. Symmetric stable processes are Lévy processes that are rotationally symmetric and self-similar. The Feller process $X^{b}$ here is typically nonsymmetric, which is the main difficulty that we have to overcome. In addition, $X^{b}$ is neither self-similar nor rotationally symmetric. Specifically, our approach consists of the following four ingredients:
(i) determine the Lévy system of $X^{b}$ that describes how the process jumps;
(ii) derive an approximate stable-scaling property of $X^{b}$ in bounded $C^{1,1}$ open sets, which will be used to derive heat kernel estimates in bounded $C^{1,1}$ open sets for small time $t \in(0, T]$ from that at time $t=1$;
(iii) establish sharp two-sided estimates with explicit boundary decay rate on the Green functions of $X^{b}$ and its suitable dual process in $C^{1,1}$ open sets with sufficiently small diameter;
(iv) prove the intrinsic ultracontractivity of (the nonsymmetric process) $X^{b}$ in bounded open sets, which will give sharp two-sided Dirichlet heat kernel estimates for large time.

In step (ii), we choose a large ball $E$ centered at the origin so that our bounded $C^{1,1}$ open set $D$ is contained in $\frac{1}{4} E$. Then we derive heat kernel estimates in $D$ at time $t=1$ carefully so that the constants depend on the quantity $M$ defined in (6.5), not on the diameter of $D$ directly. Note that the constant $M$ has the correct scaling property, while the diameter of $D$ does not. In fact, the constant $c_{1}$ in Theorem 1.3 depends on the diameter of $D$ only through $M$.

We also establish the boundary Harnack principle for $X^{b}$ and its suitable dual process in $C^{1,1}$ open sets with explicit boundary decay rate (Theorem 6.2). However, we like to point out that Theorem 6.2 is not used in the proof of Theorem 1.3.

By integrating the two-sided heat kernel estimates in Theorem 1.3 with respect to $t$, one can easily get the following estimates on the Green function $G_{D}^{b}(x, y)=$ $\int_{0}^{\infty} p_{D}^{b}(t, x, y) d t$.

Corollary 1.4. Let $D$ be a bounded $C^{1,1}$ open set in $\mathbb{R}^{d}$. Then there is a constant $c=c(D, d, \alpha, b) \geq 1$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that on $D \times D$,

$$
\begin{aligned}
& c^{-1} \frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}}{|x-y|^{\alpha}}\right) \\
& \quad \leq G_{D}^{b}(x, y) \leq \frac{c}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}}{|x-y|^{\alpha}}\right) .
\end{aligned}
$$

The above result was obtained independently as the main result in [7]. Clearly the heat kernel $p_{D}^{b}(t, x, y)$ contains much more information than the Green function $G_{D}^{b}(x, y)$. The estimates on $p_{D}^{b}(t, x, y)$ are not studied in [7].

The sharp two-sided estimates for $p_{D}(t, x, y)$, corresponding to the case $b=0$ in Theorem 1.3, were first established in [9]. Theorem 1.3 indicates that short time Dirichlet heat kernel estimates for the fractional Laplacian in bounded $C^{1,1}$ open sets are stable under gradient perturbations. Such stability should hold for much more general open sets.

We say that an open set $D$ is $\kappa$-fat if there exists an $R_{1}>0$ such that for every $x \in D$ and $r \in\left(0, R_{1}\right]$, there is some $y$ such that $B(y, \kappa r) \subset B(x, r) \cap D$. The pair ( $R_{1}, \kappa$ ) is called the characteristics of the $\kappa$-fat open set $D$.

CONJECTURE 1.5. Let $T>0$ and $D$ be a bounded $\kappa$-fat open subset of $\mathbb{R}^{d}$. Then there is a constant $c_{1} \geq 1$ depending only on $T, D, \alpha$ and $b$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that

$$
c_{1}^{-1} p_{D}(t, x, y) \leq p^{b}(t, x, y) \leq c_{1} p_{D}(t, x, y) \quad \text { for } t \in(0, T] \text { and } x, y \in D
$$

and

$$
c_{1}^{-1} G_{D}(x, y) \leq G_{D}^{b}(x, y) \leq c_{1} G_{D}(x, y) \quad \text { for } x, y \in D
$$

In the remainder of this paper, the constants $C_{1}, C_{2}, C_{3}, C_{4}$ will be fixed throughout this paper. The lower case constants $c_{0}, c_{1}, c_{2}, \ldots$ can change from one appearance to another. The dependence of the constants on the dimension $d$ and the stability index $\alpha$ will not be always mentioned explicitly. We will use $d x$ to denote the Lebesgue measure in $\mathbb{R}^{d}$. For a Borel set $A \subset \mathbb{R}^{d}$, we also use $|A|$ to denote its Lebesgue measure. The space of continuous functions on $\mathbb{R}^{d}$ will be denoted as $C\left(\mathbb{R}^{d}\right)$, while $C_{b}\left(\mathbb{R}^{d}\right)$ and $C_{\infty}\left(\mathbb{R}^{d}\right)$ denote the space of bounded continuous functions on $\mathbb{R}^{d}$ and the space of continuous functions on $\mathbb{R}^{d}$ that vanish
at infinity, respectively. For two nonnegative functions $f$ and $g$, the notation $f \asymp g$ means that there are positive constants $c_{1}$ and $c_{2}$ so that $c_{1} g(x) \leq f(x) \leq c_{2} g(x)$ in the common domain of definition for $f$ and $g$.
2. Feller property and Lévy system. Recall that $d \geq 2$ and $\alpha \in(1,2)$. A (rotationally) symmetric $\alpha$-stable process $X=\left\{X_{t}, t \geq 0, \mathbb{P}_{x}, x \in \mathbb{R}^{d}\right\}$ in $\mathbb{R}^{d}$ is a Lévy process such that

$$
\mathbb{E}_{x}\left[e^{i \xi \cdot\left(X_{t}-X_{0}\right)}\right]=e^{-t|\xi|^{\alpha}} \quad \text { for every } x \in \mathbb{R}^{d} \text { and } \xi \in \mathbb{R}^{d}
$$

The infinitesimal generator of this process $X$ is the fractional Laplacian $\Delta^{\alpha / 2}$, which is a prototype of nonlocal operators. The fractional Laplacian can be written in the form

$$
\begin{equation*}
\Delta^{\alpha / 2} u(x)=\lim _{\varepsilon \downarrow 0} \int_{\left\{y \in \mathbb{R}^{d}:|y-x|>\varepsilon\right\}}(u(y)-u(x)) \frac{\mathcal{A}(d,-\alpha)}{|x-y|^{d+\alpha}} d y, \tag{2.1}
\end{equation*}
$$

where $\mathcal{A}(d,-\alpha):=\alpha 2^{\alpha-1} \pi^{-d / 2} \Gamma\left(\frac{d+\alpha}{2}\right) \Gamma\left(1-\frac{\alpha}{2}\right)^{-1}$.
We will use $p(t, x, y)$ to denote the transition density of $X$ (or equivalently the heat kernel of the fractional Laplacian $\Delta^{\alpha / 2}$ ). It is well known (see, e.g., [2, 12]) that

$$
p(t, x, y) \asymp t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}} \quad \text { on }(0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}
$$

The next two lemmas will be used later.

LEMMA 2.1. If $f$ is a function belonging to $\mathbb{K}_{d, \alpha-1}$, then for any compact subset $K$ of $\mathbb{R}^{d}$,

$$
\sup _{x \in \mathbb{R}^{d}} \int_{K} \frac{|f|(y)}{|x-y|^{d-\alpha}} d y<\infty
$$

Proof. This follows immediately from the fact that $d-\alpha<d+1-\alpha$. We omit the details.

Recall that we are assuming that $b$ is an $\mathbb{R}^{d}$-valued function on $\mathbb{R}^{d}$ such that $|b| \in \mathbb{K}_{d, \alpha-1}$.

Lemma 2.2. If $f$ is a function belonging to $\mathbb{K}_{d, \alpha-1}$, then

$$
\lim _{t \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} \int_{0}^{t} P_{s}^{b}|f|(x) d s=0
$$

Proof. By (1.3),

$$
\begin{aligned}
& \lim _{t \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} \int_{0}^{t} P_{s}^{b}|f|(x) d s \\
& \leq c_{1} \lim _{t \rightarrow 0} \sup _{x \in \mathbb{R}^{d}} \int_{0}^{t}\left(s \int_{B\left(x, s^{1 / \alpha}\right)^{c}} \frac{|f(y)|}{|y-x|^{d+\alpha}} d y\right. \\
& \\
& \left.\quad+s^{-d / \alpha} \int_{B\left(x, s^{1 / \alpha}\right)}|f(y)| d y\right) d s .
\end{aligned}
$$

So it suffices to show that the right-hand side is zero. Clearly, for any $s \leq 1$, we have

$$
\begin{equation*}
\int_{B\left(x, s^{1 / \alpha}\right)}|f(y)| d y \leq\left(s^{1 / \alpha}\right)^{d+1-\alpha} \sup _{x \in \mathbb{R}^{d}} \int_{B(x, 1)} \frac{|f(y)|}{|y-x|^{d+1-\alpha}} d y . \tag{2.2}
\end{equation*}
$$

Applying [36], Lemma 1.1, we get

$$
\begin{equation*}
\sup _{x \in \mathbb{R}^{d}} \int_{B\left(x, s^{1 / \alpha}\right)^{c}} \frac{|f(y)|}{|y-x|^{d+\alpha}} d y \leq c_{2}\left(s^{1 / \alpha}\right)^{d+1-\alpha}\left(s^{1 / \alpha}\right)^{-(d+\alpha)}=c_{2} s^{1 / \alpha-2} \tag{2.3}
\end{equation*}
$$

Now the conclusion follows immediately from (2.2) and (2.3).
By the semigroup property of $p^{b}(t, x, y)$ and (1.3), there are constants $c_{1}$, $c_{2} \geq 1$, such that on $(0, \infty) \times \mathbb{R}^{d} \times \mathbb{R}^{d}$,

\begin{align*}
& c_{1}^{-1} e^{-c_{2} t}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right)  \tag{2.4}\\
& \quad \leq p^{b}(t, x, y) \leq c_{1} e^{c_{2} t}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right)
\end{align*}
$$

Proposition 2.3. The family of operators $\left\{P_{t}^{b} ; t \geq 0\right\}$ defined by (1.5) forms a Feller semigroup. Moreover, it satisfies the strong Feller property; that is, for each $t>0, P_{t}^{b} f$ maps bounded measurable functions to continuous functions.

Proof. Since $p^{b}(t, x, y)$ is continuous, by the bounded convergence theorem, $P_{t}^{b}$ enjoys the strong Feller property. Moreover, for every $f \in C_{\infty}\left(\mathbb{R}^{d}\right)$ and $t>0$,

\lim _{x \rightarrow \infty}\left|P_{t}^{b} f(x)\right| \leq \lim _{x \rightarrow \infty} c_{1} e^{c_{2} t} \int_{\mathbb{R}^{d}}\left(t^{-d / \alpha} \wedge \frac{t}{|y|^{d+\alpha}}\right)|f(x+y)| d y=0
$$

and so $P_{t}^{b} f \in C_{\infty}\left(\mathbb{R}^{d}\right)$. By (2.4), we have

& \quad \leq c_{1} e^{c_{2} t_{0}} \sup _{t \leq t_{0}} \sup _{x \in \mathbb{R}^{d}} \int_{\left\{y \in \mathbb{R}^{d}:|x-y| \geq \delta\right\}}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) d y
\end{aligned}
$$

$$
\begin{aligned}
& =c_{3} e^{c_{2} t_{0}} \sup _{t \leq t_{0}} \int_{\delta}^{\infty} r^{d-1}\left(t^{-d / \alpha} \wedge \frac{t}{r^{d+\alpha}}\right) d r \\
& \leq c_{4} e^{c_{2} t_{0}} \int_{\delta t_{0}^{-1 / \alpha}}^{\infty} u^{d-1}\left(1 \wedge \frac{1}{u^{d+\alpha}}\right) d u
\end{aligned}
$$

for some $c_{3}=c_{3}(d)>0$ and $c_{4}=c_{4}(d)>0$. Thus

$$
\begin{equation*}
\limsup _{t_{0} \downarrow 0} \sup _{t \leq t_{0}} \mathbb{P}_{x \in \mathbb{R}^{d}}\left(\left|X_{t}^{b}-X_{0}^{b}\right| \geq \delta\right)=0 \tag{2.5}
\end{equation*}
$$

For every $f \in C_{b}\left(\mathbb{R}^{d}\right), x \in \mathbb{R}^{d}$ and $\varepsilon>0$, there is a $\delta>0$ so that $|f(y)-f(x)|<\varepsilon$ for every $y \in B(x, \delta)$. Therefore we have by (2.5),

\begin{aligned}
\lim _{t \downarrow 0} \mid & P_{t}^{b} f(x)-f(x) \mid \\
& =\lim _{t \downarrow 0}\left|\int_{\mathbb{R}^{d}} p^{b}(t, x, y)(f(y)-f(x)) d y\right| \\
\leq & \lim _{t \downarrow 0} \int_{\left\{y \in \mathbb{R}^{d}:|y-x|<\delta\right\}} p^{b}(t, x, y)|f(y)-f(x)| d y \\
& \quad+\lim _{t \downarrow 0} 2\|f\|_{\infty} \mathbb{P}_{x}\left(\left|X_{t}^{b}-x\right| \geq \delta\right)<\varepsilon .
\end{aligned}
$$

Therefore for every $f \in C_{b}\left(\mathbb{R}^{d}\right)$ and $x \in \mathbb{R}^{d}, \lim _{t \downarrow 0} P_{t}^{b} f(x)=f(x)$. This completes the proof of the proposition.

We will need the next result, which is an extension of Theorem 1.2(iii).
Proposition 2.4. For any $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $g \in C_{\infty}\left(\mathbb{R}^{d}\right)$, we have

\lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} t^{-1}\left(P_{t}^{b} f(x)-f(x)\right) g(x) d x=\int_{\mathbb{R}^{d}}\left(\mathcal{L}^{b} f\right)(x) g(x) d x .

Proof. This proposition can be proved by following the proof of [6], Theorem 1, with some obvious modifications. Indeed, one can follow the same argument of the proof of [6], Theorem 1, until the second display in [6], page 195, with $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $g \in C_{\infty}\left(\mathbb{R}^{d}\right)$. Let $\varepsilon>0$, and use the same notation as in [6], page 195, except that $K:=\left\{z: \operatorname{dist}\left(z, K_{1}\right) \leq 1\right\}$ and we ignore $K_{2}$. Since $h(x, y)=\nabla f(y) g(x)$ is still uniformly continuous, there exists a $\delta>0$ such that for all $x, y, z$ with $|x-z|<\delta$ and $|y-z|<\delta$, we have that $|h(x, y)-h(z, z)|<\varepsilon$. Thus the third display in [6], page 195, can be modified as

& \leq \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{0}^{t} \frac{p(t-s, x, z) p(s, z, y)}{t} d s|b(z)||h(x, y)-h(z, z)| d x d y d z
\end{aligned}
$$

$$
\begin{aligned}
\leq & 2\|h\| \int_{K^{c}} \int_{K_{1}} \int_{0}^{t}\left(\int_{\mathbb{R}^{d}} p(t-s, x, z) d x\right) \frac{p(s, z, y)}{t} d s|b(z)| d y d z \\
& +2\|h\| \int_{K} \iint_{(B(z, \delta) \times B(z, \delta))^{c}} \int_{0}^{t} \frac{p(t-s, x, z) p(s, z, y)}{t} d s|b(z)| d x d y d z \\
& +\varepsilon \int_{K} \iint_{B(z, \delta) \times B(z, \delta)} \int_{0}^{t} \frac{p(t-s, x, z) p(s, z, y)}{t} d s|b(z)| d x d y d z .
\end{aligned}
$$

The remainder of the proof is the same as that of the proof of [6], Theorem 1.
The Feller process $X^{b}$ possesses a Lévy system (see [33]), which describes how $X^{b}$ jumps. Intuitively, since the infinitesimal generator of $X^{b}$ is $\mathcal{L}^{b}, X^{b}$ should satisfy

d X_{t}^{b}=d X_{t}+b\left(X_{t}^{b}\right) d t
$$

So $X^{b}$ should have the same Lévy system as that of $X$, as the drift does not contribute to the jumps. This is indeed true, and we are going to give a rigorous proof.

It is well known that the symmetric stable process $X$ has Lévy intensity function

$$
J(x, y)=\mathcal{A}(d,-\alpha)|x-y|^{-(d+\alpha)}
$$

The Lévy intensity function gives rise to a Lévy system $(N, H)$ for $X$, where $N(x, d y)=J(x, y) d y$ and $H_{t}=t$, which describes the jumps of the process $X$ : for any $x \in \mathbb{R}^{d}$ and any nonnegative measurable function $f$ on $\mathbb{R}_{+} \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ vanishing on $\left\{(s, x, y) \in \mathbb{R}_{+} \times \mathbb{R}^{d} \times \mathbb{R}^{d}: x=y\right\}$ and stopping time $T$ (with respect to the filtration of $X$ ),

$$
\mathbb{E}_{x}\left[\sum_{s \leq T} f\left(s, X_{s-}, X_{s}\right)\right]=\mathbb{E}_{x}\left[\int_{0}^{T}\left(\int_{\mathbb{R}^{d}} f\left(s, X_{s}, y\right) J\left(X_{s}, y\right) d y\right) d s\right]
$$

(See, e.g., [12], proof of Lemma 4.7, and [13], Appendix A.)
We first show that $X^{b}$ is a solution to the martingale problem of $\mathcal{L}^{b}$.
THEOREM 2.5. For every $x \in \mathbb{R}^{d}$ and every $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$,

$$
M_{t}^{f}:=f\left(X_{t}^{b}\right)-f\left(X_{0}^{b}\right)-\int_{0}^{t} \mathcal{L}^{b} f\left(X_{s}^{b}\right) d s
$$

is a martingale under $\mathbb{P}_{x}$.
Proof. Define the adjoint operator $P_{t}^{b, *}$ of $P_{t}^{b}$ with respect to the Lebesgue measure by

$$
P_{t}^{b, *} f(x):=\int_{\mathbb{R}^{d}} p^{b}(t, y, x) f(y) d y
$$

It follows immediately from (1.3) and the continuity of $p^{b}(t, x, y)$ that, for any $g \in C_{\infty}\left(\mathbb{R}^{d}\right)$ and $s>0$, both $P_{s}^{b} g$ and $P_{s}^{b, *} g$ are in $C_{\infty}\left(\mathbb{R}^{d}\right)$. Thus, for any $f, g \in$
$C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $s>0$, by applying Proposition 2.4 with $h=P_{s}^{b, *} g$ and (1.4), we get that

& \lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} t^{-1}\left(P_{t+s}^{b} f(x)-P_{s}^{b} f(x)\right) g(x) d x \\
& \quad=\lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} t^{-1}\left(P_{t}^{b} f(x)-f(x)\right) P_{s}^{b, *} g(x) d x \\
& \quad=\int_{\mathbb{R}^{d}} \mathcal{L}^{b} f(x) P_{s}^{b, *} g(x) d x=\int_{\mathbb{R}^{d}} \mathbb{E}_{x}\left[\mathcal{L}^{b} f\left(X_{s}^{b}\right)\right] g(x) d x
\end{aligned}
$$

which implies that

$$
\begin{equation*}
\int_{\mathbb{R}^{d}}\left(P_{t}^{b} f(x)-f(x)\right) g(x) d x=\int_{\mathbb{R}^{d}} \mathbb{E}_{x}\left[\int_{0}^{t}\left(\mathcal{L}^{b} f\right)\left(X_{s}^{b}\right) d s\right] g(x) d x \tag{2.6}
\end{equation*}
$$

Using the strong Feller property of $P_{t}^{b}$, Lemmas 2.1 and 2.2 , we can easily see that the function

$$
x \mapsto P_{t}^{b} f(x)-f(x)-\mathbb{E}_{x}\left[\int_{0}^{t} \mathcal{L}^{b} f\left(X_{s}^{b}\right) d s\right]=\mathbb{E}_{x}\left[M_{t}^{f}\right]
$$

is continuous, and thus is identically zero on $\mathbb{R}^{d}$ by (2.6). It follows that for any $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $x \in \mathbb{R}^{d}, M^{f}$ is a martingale with respect to $\mathbb{P}_{x}$.

Theorem 2.5 in particular implies that $X_{t}^{b}=\left(X_{t}^{b, 1}, \ldots, X_{t}^{b, d}\right)$ is a semimartingale. By Itô's formula, we have that, for any $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$,

\begin{equation*}
f\left(X_{t}^{b}\right)-f\left(X_{0}^{b}\right)=\sum_{i=1}^{d} \int_{0}^{t} \partial_{i} f\left(X_{s-}^{b}\right) d X_{s}^{b, i}+\sum_{s \leq t} \eta_{s}(f)+\frac{1}{2} A_{t}(f) \tag{2.7}
\end{equation*}
$$

where

$$
\begin{equation*}
\eta_{s}(f)=f\left(X_{s}^{b}\right)-f\left(X_{s-}^{b}\right)-\sum_{i=1}^{d} \partial_{i} f\left(X_{s-}^{b}\right)\left(X_{s}^{b, i}-X_{s-}^{b, i}\right) \tag{2.8}
\end{equation*}
$$

and

$$
\begin{equation*}
A_{t}(f)=\sum_{i, j=1}^{d} \int_{0}^{t} \partial_{i} \partial_{j} f\left(X_{s-}^{b}\right) d\left\langle\left(X^{b, i}\right)^{c},\left(X^{b, j}\right)^{c}\right\rangle_{s} \tag{2.9}
\end{equation*}
$$

Now suppose that $A$ and $B$ are two bounded closed sets having a positive distance from each other. Let $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ with $f=0$ on $A$ and $f=1$ on $B$. Then we know that $N_{t}^{f}:=\int_{0}^{t} \mathbf{1}_{A}\left(X_{s-}^{b}\right) d M_{s}^{f}$ is a martingale. Combining Theorem 2.5 and (2.7)-(2.9) with (2.1), we get that

N_{t}^{f} & =\sum_{s \leq t} \mathbf{1}_{A}\left(X_{s-}^{b}\right) f\left(X_{s}^{b}\right)-\int_{0}^{t} \mathbf{1}_{A}\left(X_{s}^{b}\right)\left(\Delta^{\alpha / 2} f\left(X_{s}^{b}\right)\right) d s \\
& =\sum_{s \leq t} \mathbf{1}_{A}\left(X_{s-}^{b}\right) f\left(X_{s}^{b}\right)-\int_{0}^{t} \mathbf{1}_{A}\left(X_{s}^{b}\right) \int_{\mathbb{R}^{d}} f(y) J\left(X_{s}^{b}, y\right) d y d s
\end{aligned}
$$

By taking a sequence of functions $f_{n} \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ with $f_{n}=0$ on $A, f_{n}=1$ on $B$ and $f_{n} \downarrow \mathbf{1}_{B}$, we get that, for any $x \in \mathbb{R}^{d}$,

$$
\sum_{s \leq t} \mathbf{1}_{A}\left(X_{s-}^{b}\right) \mathbf{1}_{B}\left(X_{s}^{b}\right)-\int_{0}^{t} \mathbf{1}_{A}\left(X_{s}^{b}\right) \int_{B} J\left(X_{s}^{b}, y\right) d y d s
$$

is a martingale with respect to $\mathbb{P}_{x}$. Thus,

$$
\mathbb{E}_{x}\left[\sum_{s \leq t} \mathbf{1}_{A}\left(X_{s-}^{b}\right) \mathbf{1}_{B}\left(X_{s}^{b}\right)\right]=\mathbb{E}_{x}\left[\int_{0}^{t} \int_{\mathbb{R}^{d}} \mathbf{1}_{A}\left(X_{s}^{b}\right) \mathbf{1}_{B}(y) J\left(X_{s}^{b}, y\right) d y d s\right]
$$

Using this and a routine measure theoretic argument, we get

$$
\mathbb{E}_{x}\left[\sum_{s \leq t} f\left(X_{s-}^{b}, X_{s}^{b}\right)\right]=\mathbb{E}_{x}\left[\int_{0}^{t} \int_{\mathbb{R}^{d}} f\left(X_{s}^{b}, y\right) J\left(X_{s}^{b}, y\right) d y d s\right]
$$

for any nonnegative measurable function $f$ on $\mathbb{R}^{d} \times \mathbb{R}^{d}$ vanishing on $\{(x, y) \in$ $\left.\mathbb{R}^{d} \times \mathbb{R}^{d}: x=y\right\}$. Finally following the same arguments as in [12], Lemma 4.7, and [13], Appendix A, we get:

THEOREM 2.6. $\quad X^{b}$ has the same Lévy system $(N, H)$ as $X$; that is, for any $x \in \mathbb{R}^{d}$ and any nonnegative measurable function $f$ on $\mathbb{R}_{+} \times \mathbb{R}^{d} \times \mathbb{R}^{d}$ vanishing on $\left\{(s, x, y) \in \mathbb{R}_{+} \times \mathbb{R}^{d} \times \mathbb{R}^{d}: x=y\right\}$ and stopping time $T$ (with respect to the filtration of $X^{b}$ )

$$
\begin{equation*}
\mathbb{E}_{x}\left[\sum_{s \leq T} f\left(s, X_{s-}^{b}, X_{s}^{b}\right)\right]=\mathbb{E}_{x}\left[\int_{0}^{T}\left(\int_{\mathbb{R}^{d}} f\left(s, X_{s}^{b}, y\right) J\left(X_{s}^{b}, y\right) d y\right) d s\right] \tag{2.10}
\end{equation*}
$$

For any open subset $E$ of $\mathbb{R}^{d}$, let $E_{\partial}=E \cup\{\partial\}$, where $\partial$ is the cemetery point. Define for $x, y \in E$,

N^{E}(x, d y):=J(x, y) d y, \quad N^{E}(x, \partial):=\int_{E^{c}} J(x, y) d y
$$

and $H_{t}^{E}:=t$. Then it follows from the theorem above that $\left(N^{E}, H^{E}\right)$ is a Lévy system for $X^{b, E}$; that is, for any $x \in E$, any nonnegative measurable function $f$ on $\mathbb{R}_{+} \times E \times E_{\partial}$ vanishing on $\left\{(s, x, y) \in \mathbb{R}_{+} \times E \times E: x=y\right\}$ and stopping time $T$ (with respect to the filtration of $X^{b, E}$ )

$$
\begin{align*}
\mathbb{E}_{x} & {\left[\sum_{s \leq T} f\left(s, X_{s-}^{b, E}, X_{s}^{b, E}\right)\right] }  \tag{2.11}\\
& =\mathbb{E}_{x}\left[\int_{0}^{T}\left(\int_{E_{\partial}} f\left(s, X_{s}^{b, E}, y\right) N^{E}\left(X_{s}^{b, E}, d y\right)\right) d H_{s}^{E}\right]
\end{align*}
$$

3. Subprocess of $\boldsymbol{X}^{\boldsymbol{b}}$. In this section we study some basic properties of subprocesses of $X^{b}$ in open subsets. These properties will be used in later sections.

Lemma 3.1. For any $\delta>0$, we have

$$
\lim _{s \downarrow 0} \sup _{x \in \mathbb{R}^{d}} \mathbb{P}_{x}\left(\tau_{B(x, \delta)}^{b} \leq s\right)=0
$$

Proof. By the strong Markov property of $X^{b}$ (see, e.g., [3], pages 43 and 44), we have for every $x \in \mathbb{R}^{d}$,

$$
\begin{align*}
\mathbb{P}_{x} & \left(\tau_{B(x, \delta)}^{b} \leq s\right) \\
\leq & \mathbb{P}_{x}\left(\tau_{B(x, \delta)}^{b} \leq s, X_{s}^{b} \in B(x, \delta / 2)\right)+\mathbb{P}_{x}\left(X_{s}^{b} \in B(x, \delta / 2)^{c}\right) \\
\leq & \mathbb{E}_{x}\left[\mathbb{P}_{X_{\tau_{B(x, \delta)}^{b}}}\left(\left|X_{s-\tau_{B(x, \delta)}^{b}}^{b}-X_{0}^{b}\right| \geq \delta / 2\right) ; \tau_{B(x, \delta)}^{b}<s\right]  \tag{3.1}\\
& \quad+\mathbb{P}_{x}\left(\left|X_{s}^{b}-X_{0}^{b}\right| \geq \delta / 2\right) \\
\leq & 2 \sup _{t \leq s} \sup _{x \in \mathbb{R}^{d}} \mathbb{P}_{x}\left(\left|X_{t}^{b}-X_{0}^{b}\right| \geq \delta / 2\right) .
\end{align*}
$$

Now the conclusion of the lemma follows from (2.5).
A point $z$ on the boundary $\partial G$ of a Borel set $G$ is said to be a regular boundary point with respect to $X^{b}$ if $\mathbb{P}_{z}\left(\tau_{G}^{b}=0\right)=1$. A Borel set $G$ is said to be regular with respect to $X^{b}$ if every point in $\partial G$ is a regular boundary point with respect to $X^{b}$.

Proposition 3.2. Suppose that $G$ is a Borel set of $\mathbb{R}^{d}$ and $z \in \partial G$. If there is a cone $A$ with vertex $z$ such that $\operatorname{int}(A) \cap B(z, r) \subset G^{c}$ for some $r>0$, then $z$ is a regular boundary point of $G$ with respect to $X^{b}$.

Proof. This result follows from (1.3) and Blumenthal's zero-one law by a routine argument. For example, the reader can follow the argument in the proof of [25], Proposition 2.2. Even though [25], Proposition 2.2, is stated for open sets, the proof there works for Borel sets. We omit the details.

This result implies that all bounded Lipschitz open sets, and in particular, all bounded $C^{1,1}$ open sets, are regular with respect to $X^{b}$. Repeating the argument in the second part of the proof of [17], Theorem 1.23 , we immediately get the following result.

Proposition 3.3. Suppose that $D$ is an open set in $\mathbb{R}^{d}$, and $f$ is a bounded Borel function on $\partial D$. If $z$ is a regular boundary point of $D$ with respect to $X^{b}$, and $f$ is continuous at $z$, then

$$
\lim _{\bar{D} \ni x \rightarrow z} \mathbb{E}_{x}\left[f\left(X_{\tau_{D}^{b}}^{b}\right) ; \tau_{D}^{b}<\infty\right]=f(z)
$$

Let

$$
\begin{equation*}
k_{D}^{b}(t, x, y):=\mathbb{E}_{x}\left[p^{b}\left(t-\tau_{D}^{b}, X_{\tau_{D}^{b}}^{b}, y\right) ; \tau_{D}^{b}<t\right] \tag{3.2}
\end{equation*}
$$

and

$$
\begin{equation*}
p_{D}^{b}(t, x, y):=p^{b}(t, x, y)-k_{D}^{b}(t, x, y) . \tag{3.3}
\end{equation*}
$$

Then $p_{D}^{b}(t, x, y)$ is the transition density of $X^{b, D}$. This is because by the strong Markov property of $X^{b}$, for every $t>0$ and Borel set $A \subset \mathbb{R}^{d}$,

$$
\begin{equation*}
\mathbb{P}_{x}\left(X_{t}^{b, D} \in A\right)=\int_{A} p_{D}^{b}(t, x, y) d y \tag{3.4}
\end{equation*}
$$

We will use $\left\{P_{t}^{b, D}\right\}$ to denote the semigroup of $X^{D}$ and $\left.\mathcal{L}^{b}\right|_{D}$ to denote the infinitesimal generator of $\left\{P_{t}^{b, D}\right\}$. Using some standard arguments (e.g., [4, 17]), we can show the following:

THEOREM 3.4. Let $D$ be an open set in $\mathbb{R}^{d}$. The transition density $p_{D}^{b}(t, x, y)$ is jointly continuous on $(0, \infty) \times D \times D$. For every $t>0$ and $s>0$,

$$
\begin{equation*}
p_{D}^{b}(t+s, x, y)=\int_{D} p_{D}^{b}(t, x, z) p_{D}^{b}(s, z, y) d z . \tag{3.5}
\end{equation*}
$$

If $z$ is a regular boundary point of $D$ with respect to $X^{b}$, then for any $t>0$ and $y \in D, \lim _{D \ni x \rightarrow z} p_{D}^{b}(t, x, y)=0$.

Proof. Note that by (2.4), there exist $c_{1}, c_{2}>0$ such that for all $t_{0}>0$ and $\delta>0$,

\sup _{t \leq t_{0}} \sup _{|x-y| \geq \delta} p^{b}(t, x, y) & \leq c_{1} e^{c_{2} t_{0}} \sup _{t \leq t_{0}} \sup _{|x-y| \geq \delta}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right)  \tag{3.6}\\
& \leq c_{1} e^{c_{2} t_{0}} \frac{t_{0}}{\delta^{d+\alpha}}<\infty
\end{align*}
$$

We first show that $k_{D}^{b}(t, x, \cdot)$ is jointly continuous on $(0, \infty) \times D \times D$. For any $\delta>0$, define $D_{\delta}=\left\{x \in D: \operatorname{dist}\left(x, D^{c}\right)<\delta\right\}$. For $0 \leq s<r$ and $x, y \in D_{\delta}$, define

h(s, r, x, y)=\mathbb{E}_{x}\left[p^{b}\left(r-\tau_{D}^{b}, X_{\tau_{D}^{b}}^{b}, y\right) ; s \leq \tau_{D}^{b}<r\right] .

Note that

\mathbb{E}_{x}\left[h\left(s, r, X_{s}^{b}, y\right)\right] & =\mathbb{E}_{x}\left[h\left(s, r, X_{s}^{b}, y\right) ; s<\tau_{D}^{b}\right]+\mathbb{E}_{x}\left[h\left(s, r, X_{s}^{b}, y\right) ; s \geq \tau_{D}^{b}\right] \\
& =h(s, r+s, x, y)+\mathbb{E}_{x}\left[h\left(s, r, X_{s}^{b}, y\right) ; s \geq \tau_{D}^{b}\right]
\end{aligned}
$$

and

$$
\begin{aligned}
k_{D}^{b}(t, x, y)= & h(0, t, x, y) \\
= & h(s, t, x, y)+\mathbb{E}_{x}\left[p^{b}\left(t-\tau_{D}^{b}, X_{\tau_{D}^{b}}^{b}, y\right) ; \tau_{D}^{b}<s\right] \\
= & \mathbb{E}_{x}\left[h\left(s, t-s, X_{s}^{b}, y\right)\right]-\mathbb{E}_{x}\left[h\left(s, t-s, X_{s}^{b}, y\right) ; \tau_{D}^{b} \leq s\right] \\
& +\mathbb{E}_{x}\left[p^{b}\left(t-\tau_{D}^{b}, X_{\tau_{D}^{b}}^{b}, y\right) ; \tau_{D}^{b}<s\right] .
\end{aligned}
$$

For all $t_{1}, t_{2} \in(0, \infty)$, by (3.6), $p^{b}(r, z, y)$ is bounded on $\left(0, t_{2}\right] \times D^{c} \times D_{\delta}$ by a constant $c_{3}$. Consequently, $h(s, r, x, y)$ is bounded by $c_{3}$ for all $x, y \in D_{\delta}$ and $s, r \in\left(0, t_{2}\right]$ with $s<r \wedge\left(t_{1} / 3\right)$. Thus we have from the above display as well as (3.6) that for all $t \in\left[t_{1}, t_{2}\right], s<t_{1} / 2$ and $x, y \in D_{\delta}$,

\end{aligned}

which by Lemma 3.1 goes to 0 as $s \rightarrow 0$ (uniformly in $(t, x, y) \in\left[t_{1}, t_{2}\right] \times D_{\delta} \times$ $D_{\delta}$ ). Since $p^{b}(t, x, y)$ is jointly continuous, it follows from the bounded convergence theorem that $\mathbb{E}_{x}\left[h\left(s, t-s, X_{s}^{b}, y\right)\right]$ is jointly continuous in $(s, t, y) \in$ $\left[0, t_{1} / 3\right] \times\left[t_{1}, t_{2}\right] \times D_{\delta}$. On the other hand, for $(s, t, y)$ in any locally compact subset of $\left(0, t_{1} / 3\right) \times\left[t_{1}, t_{2}\right] \times D_{\delta}, \mathbb{E}_{x}\left[h\left(s, t-s, X_{s}^{b}, y\right)\right]=\int_{\mathbb{R}^{d}} p(s, x, z) h(s, t-$ $s, z, y) d y$ is equi-continuous in $x$. Therefore $\mathbb{E}_{x}\left[h\left(s, t-s, X_{s}^{b}, y\right)\right]$ is jointly continuous in $(s, t, x, y) \in\left(0, t_{1} / 3\right) \times\left[t_{1}, t_{2}\right] \times D_{\delta} \times D_{\delta}$. Consequently, $k_{D}^{b}(t, x, y)$ is jointly continuous in $(s, t, y) \in\left[0, t_{1} / 3\right] \times\left[t_{1}, t_{2}\right] \times D_{\delta}$ and hence on $(0, \infty) \times D \times$ $D$. Since $p^{b}(t, x, y)$ is jointly continuous, we can now conclude that $p_{D}^{b}(t, x, y)$ is jointly continuous on $(0, \infty) \times D \times D$.

By Proposition 3.3, the last assertion of the theorem can be proved using the argument in the last paragraph of the proof of [17], Theorem 2.4. We omit the details.

The next result is a short time lower bound estimate for $p_{D}^{b}(t, x, y)$ near the diagonal. The technique used in its proof is well known. We give the proof here to demonstrate that symmetry of the process is not needed.

Proposition 3.5. For any $a_{1} \in(0,1), a_{2}>0, a_{3}>0$ and $R>0$, there is a constant $c=c\left(d, \alpha, a_{1}, a_{2}, a_{3}, R, b\right)>0$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that such that for all $x_{0} \in \mathbb{R}^{d}$ and $r \in$ ( $0, R$ ],

& p_{B\left(x_{0}, r\right)}^{b}(t, x, y) \geq c t^{-d / \alpha}  \tag{3.7}\\
& \quad \quad \text { for all } x, y \in B\left(x_{0}, a_{1} r\right) \text { and } t \in\left[a_{2} r^{\alpha}, a_{3} r^{\alpha}\right] .
\end{align*}
$$

Proof. Let $\kappa:=a_{2} /\left(2 a_{3}\right)$ and $B_{r}:=B\left(x_{0}, r\right)$. We first show that there is a constant $c_{1} \in(0,1)$ so that (3.7) holds for all $r>0, x, y \in B\left(x_{0}, a_{1} r\right)$ and $t \in$ [ $\kappa c_{1} r^{\alpha}, c_{1} r^{\alpha}$ ].

For $r>0, t \in\left[\kappa c_{1} r^{\alpha}, c_{1} r^{\alpha}\right]$, and $x, y \in B\left(x_{0}, a_{1} r\right)$, since $|x-y| \leq 2 a_{1} r \leq$ $2 a_{1}\left(\kappa c_{1}\right)^{-1 / \alpha} t^{-1 / \alpha}$ and $t \leq c_{1} r^{\alpha} \leq R^{\alpha}$, we have by (2.4), (3.2) and (3.3),

& -c_{3} \mathbb{E}_{x}\left[\mathbf{1}_{\left\{\tau_{B_{r}}^{b} \leq t\right\}}\left(\left(t-\tau_{B_{r}}^{b}\right)^{-d / \alpha} \wedge \frac{t-\tau_{B_{r}}^{b}}{\left|X_{\tau_{B_{r}}^{b}}^{b}-y\right|^{d+\alpha}}\right)\right],
\end{align*}
$$

where the positive constants $c_{i}=c_{i}\left(d, \alpha, a_{1}, a_{2}, a_{3}, R, b\right), i=2,3$, are independent of $c_{1} \in(0,1]$. Observe that

\left|X_{\tau_{B_{r}}^{b}}^{b}-y\right| \geq\left(1-a_{1}\right) r \quad \text { for } t-\tau_{B_{r}}^{b} \leq t \leq c_{1} r^{\alpha}

\end{equation*}

Note that if $c_{1}<\left(\left(1-a_{1}\right) / 2\right)^{\alpha}$, by (2.4), for $t \leq c_{1} r^{\alpha}$,

& \leq c_{3} \int_{B\left(x,\left(1-a_{1}\right) r / 2\right)^{c}} \frac{t}{|x-y|^{d+\alpha}} d z \\
& \leq c_{4} \frac{t}{r^{\alpha}} \leq c_{4} c_{1},
\end{aligned}
$$

where $c_{4}$ is independent of $c_{1}$. Now by the same argument as in the proof of Lemma 3.1, we have

p_{B_{r}}^{b}(t, x, y) & \geq\left(c_{2} c_{1}^{1+d / \alpha}-c_{3} \frac{c_{1}^{1+d / \alpha}}{\left(1-a_{1}\right)^{d+\alpha}} \mathbb{P}_{x}\left(\tau_{B_{r}}^{b} \leq t\right)\right) t^{-d / \alpha} \\
& \geq\left(c_{2} c_{1}^{1+d / \alpha}-c_{3} \frac{c_{1}^{1+d / \alpha}}{\left(1-a_{1}\right)^{d+\alpha}} \mathbb{P}_{x}\left(\tau_{B\left(x,\left(1-a_{1}\right) r\right)}^{b} \leq t\right)\right) t^{-d / \alpha} \\
& \geq c_{1}^{1+d / \alpha}\left(c_{2}-2 c_{4} c_{3} \frac{c_{1}}{\left(1-a_{1}\right)^{d+\alpha}}\right) t^{-d / \alpha}
\end{aligned}
$$

Clearly we can choose $c_{1}<a_{3} \wedge\left(\left(1-a_{1}\right) / 2\right)^{\alpha}$ small so that $p_{B_{r}}^{b}(t, x, y) \geq$ $c_{5} t^{-d / \alpha}$. This establishes (3.7) for any $x_{0} \in \mathbb{R}^{d}, r>0$ and $t \in\left[\kappa c_{1} r^{\alpha}, c_{1} r^{\alpha}\right]$.

Now for $r>0$ and $t \in\left[a_{2} r^{\alpha}, a_{3} r^{\alpha}\right]$, define $k_{0}=\left[a_{3} / c_{1}\right]+1$. Here for $a \geq 1$, [ $a$ ] denotes the largest integer that does not exceed $a$. Then, since $c_{1}<a_{3}, t / k_{0} \in$ [ $\kappa c_{1} r^{\alpha}, c_{1} r^{\alpha}$ ]. Using the semigroup property (3.5) $k_{0}$ times, we conclude that for all $x, y \in B\left(x_{0}, a_{1} r\right)$ and $t \in\left[a_{2} r^{\alpha}, a_{3} r^{\alpha}\right]$,

& \quad \times p_{B\left(x_{0}, r\right)}^{b}\left(t / k_{0}, w_{n-1}, y\right) d w_{1} \cdots d w_{n-1} \\
& \geq \int_{B\left(x_{0}, a_{1} r\right)} \cdots \int_{B\left(x_{0}, a_{1} r\right)} p_{B\left(x_{0}, r\right)}^{b}\left(t / k_{0}, x, w_{1}\right) \cdots \\
& \quad \times p_{B\left(x_{0}, r\right)}^{b}\left(t / k_{0}, w_{n-1}, y\right) d w_{1} \cdots d w_{n-1} \\
& \geq c_{5}\left(t / k_{0}\right)^{-d / \alpha}\left(c_{5}\left(t / k_{0}\right)^{-d / \alpha}|B(0,1)|\left(a_{1} r\right)^{d}\right)^{k_{0}-1} \geq c_{6} t^{-d / \alpha}
\end{aligned}
$$

The proof of (3.7) is now complete.
Using the domain monotonicity of $p_{D}^{b}$, the semigroup property (3.5) and the Lévy system of $X^{b}$, the above proposition yields the following.

COROLLARY 3.6. For every open subset $D \subset \mathbb{R}^{d}, p_{D}^{b}(t, x, y)$ is strictly positive.

Proof. For $x \in D$, denote by $D(x)$ the connected component of $D$ that contains $x$. If $y \in D(x)$, using a chaining argument and Proposition 3.5, we have

& \quad \geq \mathbb{E}_{x}\left[p_{D}^{b}\left(t-\tau_{D(x)}^{b}, X_{\tau_{D(x)}^{b}}^{b}, y\right) ; \tau_{D(x)}^{b}<t, X_{\tau_{D(x)}^{b}}^{b} \in D(y)\right] \\
& \quad \geq \int_{0}^{t} \int_{D(x)} p_{D(x)}^{b}(s, x, z)\left(\int_{D(y)} J(z, w) p_{D(y)}^{b}(t-s, w, y) d w\right) d z d s>0
\end{aligned}
$$

The corollary is thus proved.
In the remainder of this section we assume that $D$ is a bounded open set in $\mathbb{R}^{d}$. The proof of the next lemma is standard; for example, see [24], Lemma 6.1.

Lemma 3.7. There exist positive constants $C_{1}$ and $C_{2}$ depending only on $d$, $\alpha, \operatorname{diam}(D)$ and $b$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that

$$

Proof. Put $L:=\operatorname{diam}(D)$. By (1.3), for every $x \in D$ we have

\mathbb{P}_{x}\left(\tau_{D}^{b} \leq 1\right) & \geq \mathbb{P}_{x}\left(X_{1}^{b} \in \mathbb{R}^{d} \backslash D\right)=\int_{\mathbb{R}^{d} \backslash D} p^{b}(1, x, y) d y \\
& \geq c_{1} \int_{\mathbb{R}^{d} \backslash D}\left(1 \wedge \frac{1}{|x-y|^{d+\alpha}}\right) d y \\
& \geq c_{1} \int_{\{|z| \geq L\}}\left(1 \wedge \frac{1}{|z|^{d+\alpha}}\right) d z>0 .
\end{aligned}
$$

Thus

\sup _{x \in D} \int_{D} p_{D}^{b}(1, x, y) d y=\sup _{x \in D} \mathbb{P}_{x}\left(\tau_{D}^{b}>1\right)<1
$$

The Markov property of $X^{b}$ then implies that there exist positive constants $c_{2}$ and $c_{3}$ such that

It follows from (1.3) that there exists $c_{4}>0$ such that $p_{D}^{b}(1, x, y) \leq p^{b}(1, x, y) \leq$ $c_{4}$ for every $(x, y) \in D \times D$. Thus for any $(t, x, y) \in(1, \infty) \times D \times D$, we have

Combining the result above with (1.3) we know that there exists a positive constant $c_{1}=c_{1}(d, \alpha, \operatorname{diam}(D), b)$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for any $(t, x, y) \in(0, \infty) \times D \times D$,

p_{D}^{b}(t, x, y) \leq c_{1}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) . \tag{3.11}
\end{equation*}

Therefore the Green function $G_{D}^{b}(x, y)=\int_{0}^{\infty} p_{D}^{b}(t, x, y) d t$ is finite and continuous off the diagonal of $D \times D$ and

G_{D}^{b}(x, y) \leq c_{2} \frac{1}{|x-y|^{d-\alpha}} \tag{3.12}
\end{equation*}
$$

for some positive constant $c_{2}=c_{2}(d, \alpha, \operatorname{diam}(D), b)$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero.
4. Uniform estimates on Green functions. Let

g_{D}(x, y):=\frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{D}(x) \delta_{D}(y)}{|x-y|^{2}}\right)^{\alpha / 2}

The following lemma is needed in deriving sharp bounds on the Green function $G_{U}^{b}$ when $U$ is some small $C^{1,1}$ open set. It can be regarded as a new type of $3 G$ estimates.

LEMmA 4.1. There exists a positive constant $C_{3}=C_{3}(d, \alpha)$ such that for all $x, y, z \in D$,

g_{D}(x, z) \frac{g_{D}(z, y)}{|z-y| \wedge \delta_{D}(z)} \leq C_{3} g_{D}(x, y)\left(\frac{1}{|x-z|^{d+1-\alpha}}+\frac{1}{|z-y|^{d+1-\alpha}}\right) \tag{4.1}
\end{equation*}

and

\begin{align*}
& \frac{g_{D}(x, z)}{|x-z| \wedge \delta_{D}(x)} \frac{g_{D}(z, y)}{|z-y| \wedge \delta_{D}(z)}  \tag{4.2}\\
& \quad \leq C_{3} \frac{g_{D}(x, y)}{|x-y| \wedge \delta_{D}(x)}\left(\frac{1}{|x-z|^{d+1-\alpha}}+\frac{1}{|z-y|^{d+1-\alpha}}\right) .
\end{align*}
$$

Proof. Put $r(x, y)=\delta_{D}(x)+\delta_{D}(y)+|x-y|$. Note that for $a, b>0$,

& \quad \asymp g_{D}(x, y) \frac{|z-y|+\delta_{D}(z)}{|z-y| \delta_{D}(z)} \frac{\delta_{D}(z)^{\alpha} r(x, y)^{\alpha}}{r(x, z)^{\alpha} r(z, y)^{\alpha}}\left(\frac{|x-y|}{|x-z| \cdot|z-y|}\right)^{d-\alpha} \tag{4.6}
\end{align*}
$$

$$
\begin{aligned}
& \leq g_{D}(x, y) \frac{r(y, z)}{|z-y|} \frac{\delta_{D}(z)^{\alpha-1} r(x, y)^{\alpha}}{r(x, z)^{\alpha} r(z, y)^{\alpha}}\left(\frac{|x-y|}{|x-z| \cdot|z-y|}\right)^{d-\alpha} \\
& =g_{D}(x, y) \frac{r(x, y)}{|z-y| r(x, z)}\left(\frac{\delta_{D}(z) r(x, y)}{r(x, z) r(z, y)}\right)^{\alpha-1}\left(\frac{|x-y|}{|x-z| \cdot|z-y|}\right)^{d-\alpha}
\end{aligned}
$$

Since $r(x, y) \leq r(x, z)+r(z, y)$,

\frac{\delta_{D}(z) r(x, y)}{r(x, z) r(z, y)} \leq \frac{\delta_{D}(z)}{r(x, z)}+\frac{\delta_{D}(z)}{r(z, y)} \leq 2 .

On the other hand, since $\delta_{D}(y) \leq \delta_{D}(x)+|x-y|$,

& \quad \leq c_{1} g_{D}(x, y)\left(\frac{1}{|x-z|}+\frac{1}{|z-y|}\right)\left(\frac{1}{|x-z|^{d-\alpha}}+\frac{1}{|z-y|^{d-\alpha}}\right) \\
& \quad \leq c_{2} g_{D}(x, y)\left(\frac{1}{|x-z|^{d+1-\alpha}}+\frac{1}{|z-y|^{d+1-\alpha}}\right)
\end{aligned}
$$

where $c_{1}$ and $c_{2}$ are positive constants depending only on $d$ and $\alpha$. This proves (4.1).

Now we show that (4.2) holds. Note that by (4.5),

& \quad \asymp \frac{\delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}}{|x-z|^{d+1-\alpha}|z-y|^{d+1-\alpha}} \frac{|x-z| \cdot|z-y|}{\left(|x-z| \wedge \delta_{D}(x)\right)\left(|z-y| \wedge \delta_{D}(z)\right)}  \tag{4.7}\\
& \quad \times \frac{\delta_{D}(z)^{\alpha}}{r(x, z)^{\alpha} r(z, y)^{\alpha}} \\
& \quad \asymp \frac{g_{D}(x, y)}{|x-y| \wedge \delta_{D}(x)} \cdot \frac{|x-y|^{d+1-\alpha}}{|x-z|^{d+1-\alpha}|z-y|^{d+1-\alpha}} \cdot I,
\end{align*}
$$

where

I:=\frac{|x-y| \wedge \delta_{D}(x)}{|x-y|} \cdot \frac{|x-z| \cdot|z-y|}{\left(|x-z| \wedge \delta_{D}(x)\right)\left(|z-y| \wedge \delta_{D}(z)\right)} \frac{\delta_{D}(z)^{\alpha} r(x, y)^{\alpha}}{r(x, z)^{\alpha} r(z, y)^{\alpha}} .
$$

It follows from (4.3) and the fact that $|x-z|+\delta_{D}(z) \asymp r(x, z)$ that

& \times \frac{|x-z| \cdot|z-y|\left(|x-z|+\delta_{D}(x)\right)\left(|z-y|+\delta_{D}(z)\right)}{\left(|x-z| \delta_{D}(x)\right)\left(|z-y| \delta_{D}(z)\right)} \frac{\delta_{D}(z)^{\alpha} r(x, y)^{\alpha}}{r(x, z)^{\alpha} r(z, y)^{\alpha}} \\
\asymp & \frac{\delta_{D}(z)^{\alpha-1} r(x, y)^{\alpha-1}}{r(x, z)^{\alpha-1} r(z, y)^{\alpha-1} \leq \delta_{D}(z)^{\alpha-1}\left(\frac{1}{r(x, z)^{\alpha-1}}+\frac{1}{r(y, z)^{\alpha-1}}\right)} \\
\leq & 2 .
\end{aligned}
$$

Inequality (4.2) now follows from (4.7).
Recall that $G_{D}$ is the Green function of $X^{D}$. It is known that

see [8], Corollary 3.3. Recall also that $b$ is an $\mathbb{R}^{d}$-valued function on $\mathbb{R}^{d}$ such that $|b| \in \mathbb{K}_{d, \alpha-1}$.

Proposition 4.2. If $D$ is a bounded open set, and $\mathbf{1}_{D} b$ has compact support in $D$, then $G_{D}^{b}$ satisfies

Proof. Recall that by Theorem 2.5, for every $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right), M_{t}^{f}:=f\left(X_{t}^{b}\right)-$ $f\left(X_{0}^{b}\right)-\int_{0}^{t} \mathcal{L}^{b} f\left(X_{s}^{b}\right) d s$ is a martingale with respect to $\mathbb{P}_{x}$. Since $\mathbf{1}_{D} b$ has compact support in $D$, in view of (3.12), (4.8) and the fact that $|b| \in \mathbb{K}_{d, \alpha-1}, M_{t \wedge \tau_{D}}^{f}$ is a uniformly integrable martingale.

Define $D_{j}:=\left\{x \in D: \operatorname{dist}\left(x, D^{c}\right)>1 / j\right\}$. Let $\phi \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ with $\phi \geq 1$, $\operatorname{supp}[\phi] \subset B(0,1)$ and $\int_{\mathbb{R}^{d}} \phi(x) d x=1$. For any $\psi \in C_{c}(D)$, define $f=G_{D} \psi$ and $f_{n}:=\phi_{n} * f$, where $\phi_{n}(x):=n^{d} \phi(n x)$. Clearly $f_{n} \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ and $f_{n}$ converges uniformly to $f=G_{D} \psi$. Fix $j \geq 1$. Since $\mathbb{E}_{x}\left[M_{0}^{f_{n}}\right]=\mathbb{E}_{x}\left[M_{\tau_{D_{j}}}^{f_{n}}\right]$, and for every $y \in D_{j}$ and sufficiently large $n$,

\phi_{n} *\left(\Delta^{\alpha / 2} f\right)(y)=\int_{B(0,1 / n)} \phi_{n}(z) \Delta^{\alpha / 2}\left(G_{D} \psi\right)(y-z) d z
$$

we have, by Dynkin's formula, that for sufficiently large $n$,

& \quad=\int_{D_{j}} G_{D_{j}}^{b}(x, y)\left(\Delta^{\alpha / 2} f_{n}(y)+b(y) \cdot \nabla f_{n}(y)\right) d y
\end{aligned}
$$

$$
\begin{aligned}
& =\int_{D_{j}} G_{D_{j}}^{b}(x, y)\left(\phi_{n} *\left(\Delta^{\alpha / 2} f\right)(y)+b(y) \cdot \phi_{n} *(\nabla f)(y)\right) d y \\
& =\int_{D_{j}} G_{D_{j}}^{b}(x, y)\left(-\phi_{n} * \psi(y)+b(y) \cdot \phi_{n} *\left(\nabla\left(G_{D} \psi\right)(y)\right)\right) d y
\end{aligned}
$$

Taking $n \rightarrow \infty$, we get, by (3.12), (4.8) and the fact that $|b| \in \mathbb{K}_{d, \alpha-1}$,

\end{equation*}

Now using the fact that $\mathbf{1}_{D} b$ has compact support in $D$, taking $j \rightarrow \infty$, we have by (3.12), (4.8) and the fact that $|b| \in \mathbb{K}_{d, \alpha-1}$,

Hence we have

This shows that for each $x \in D$, (4.9) holds for a.e. $y \in D$. Since $G_{D}^{b}$ is continuous off the diagonal of $D \times D$, we get that (4.9) holds for all $x, y \in D$.

We will derive two-sided estimates on the Green function of $X^{b}$ on certain nice open sets when the diameter of such open sets are less than or equal to some constant depending on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero.

Proposition 4.3. There exists a positive constant $r_{*}=r_{*}(d, \alpha, b)$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for any ball $B=B\left(x_{0}, r\right)$ of radius $r \leq r_{*}$ and any $n \geq 1$,

2^{-1} G_{B}(x, y) \leq G_{B}^{b_{n}}(x, y) \leq 2 G_{B}(x, y), \quad x, y \in B
$$

where

$$
\begin{equation*}
b_{n}(x)=b(x) \mathbf{1}_{B^{c}}(x)+b(x) \mathbf{1}_{K_{n}}(x), \quad x \in \mathbb{R}^{d} \tag{4.11}
\end{equation*}
$$

with $K_{n}$ being an increasing sequence of compact subsets of B such that $\bigcup_{n} K_{n}=$ $B$.

Proof. It is well known that there exists a constant $c_{1}=c_{1}(d, \alpha)>1$ such that

& c_{1}^{-1} \frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{B}(x) \delta_{B}(y)}{|x-y|^{2}}\right)^{\alpha / 2} \\
& \quad \leq G_{B}(x, y) \leq c_{1} \frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{B}(x) \delta_{B}(y)}{|x-y|^{2}}\right)^{\alpha / 2} . \tag{4.12}
\end{align*}

Define $\widetilde{I}_{k}^{n}(x, y)$ recursively for $n \geq 1, k \geq 0$ and $(x, y) \in B \times B$ by

\end{aligned}

Iterating (4.9) gives that for each $m \geq 2$ and for every $(x, y) \in B \times B$,

G_{B}^{b_{n}}(x, y)=\sum_{k=0}^{m} \widetilde{I}_{k}^{n}(x, y)+\int_{B} G_{B}^{b_{n}}(x, z) b_{n}(z) \cdot \nabla_{z} \widetilde{I}_{m}^{n}(z, y) d z \tag{4.13}
\end{equation*}
$$

Using induction, Lemma 4.1 , (4.8) with $D=B$ and (4.12), we see that there exists a positive constant $c_{2}$ (in fact, one can take $c_{2}=2 d C_{3} c_{1}^{3}$ where $C_{3}$ is the constant in Lemma 4.1) depending only on $d$ and $\alpha$ such that for $n, k \geq 1$ and $(x, y) \in B \times B$,

\left|\nabla_{x} \widetilde{I}_{k}^{n}(x, y)\right| \leq c_{2} \frac{G_{B}(x, y)}{|x-y| \wedge \delta_{B}(x)}\left(c_{2} M_{|b|}^{\alpha}(2 r)\right)^{k} \tag{4.15}
\end{equation*}
$$

There exists an $\widehat{r}_{1}>0$ depending on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that

\begin{equation*}
c_{2} M_{|b|}^{\alpha}(r)<\frac{1}{1+2 c_{2}} \quad \text { for every } 0<r \leq \widehat{r}_{1} \tag{4.16}
\end{equation*}
$$

Equations (3.12) and (4.15), (4.16) imply that if $r \leq \widehat{r}_{1} / 2$, then for $n \geq 1$ and $(x, y) \in B \times B$,

& \left|\int_{B} G_{B}^{b_{n}}(x, z) b_{n}(z) \cdot \nabla_{z} \widetilde{I}_{m}^{n}(z, y) d z\right| \\
& \quad \leq c_{2}\left(\int_{B} G_{B}^{b_{n}}(x, z)\left|b_{n}(z)\right| \frac{G_{B}(z, y)}{|z-y| \wedge \delta_{B}(z)} d z\right)\left(c_{2} M_{|b|}^{\alpha}(2 r)\right)^{m} \\
& \quad \leq c_{3}\left(\int_{B} \frac{1}{|x-z|^{d-\alpha}} \frac{G_{B}(z, y)}{|z-y|}|b(z)| d z\right)\left(\frac{1}{1+2 c_{2}}\right)^{m} \\
& \quad \leq c_{4}\left(\int_{B} \frac{1}{|x-z|^{d+1-\alpha}} \frac{|b(z)|}{|z-y|^{d+1-\alpha}} d z\right)\left(\frac{1}{1+2 c_{2}}\right)^{m} \\
& \quad \leq c_{5}\left(1+2 c_{2}\right)^{-m}|x-y|^{-(d+1-\alpha)} \int_{B}\left(\frac{|b(z)|}{|x-z|^{d+1-\alpha}}+\frac{|b|(z)}{|y-z|^{d+1-\alpha}}\right) d z \\
& \quad \leq c_{6}\left(1+2 c_{2}\right)^{-(m+1)}|x-y|^{-(d+1-\alpha)}
\end{aligned}
$$

which goes to zero as $m \rightarrow \infty$. In the second inequality, we have used the fact that $b_{n}$ is compactly supported in $B$. Thus, by (4.13), $G_{B}^{b_{n}}(x, y)=\sum_{k=0}^{\infty} \widetilde{I}_{k}^{n}(x, y)$.

Moreover, by (4.14),

It follows that for any $x_{0} \in \mathbb{R}^{d}$ and $B=B\left(x_{0}, r\right)$ of radius $r \leq \widehat{r}_{1} / 2$,

G_{B}(x, y) / 2 \leq G_{B}^{b_{n}}(x, y) \leq 3 G_{B}(x, y) / 2 \quad \text { for all } n \geq 1 \text { and } x, y \in B
$$

This proves the theorem.
For any bounded $C^{1,1}$ open set $D$ with characteristic ( $R_{0}, \Lambda_{0}$ ), it is well known (see, e.g., [34], Lemma 2.2) that there exists $L=L\left(R_{0}, \Lambda_{0}, d\right)>0$ such that for every $z \in \partial D$ and $r \leq R_{0}$, one can find a $C^{1,1}$ open set $U_{(z, r)}$ with characteristic $\left(r R_{0} / L, \Lambda_{0} L / r\right)$ such that $D \cap B(z, r / 2) \subset U_{(z, r)} \subset D \cap B(z, r)$. For the remainder of this paper, given a bounded $C^{1,1}$ open set $D, U_{(z, r)}$ always refers to the $C^{1,1}$ open set above.

For $U_{(z, r)}$, we also have a result similar to Proposition 4.3.
Proposition 4.4. For every $C^{1,1}$ open set $D$ with the characteristic $\left(R_{0}, \Lambda_{0}\right)$, there exists $r_{0}=r_{0}\left(d, \alpha, R_{0}, \Lambda_{0}, b\right) \in\left(0,\left(R_{0} \wedge 1\right) / 8\right]$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for all $n \geq 1$, $z \in \partial D$ and $r \leq r_{0}$, we have

2^{-1} G_{U_{(z, r)}}(x, y) \leq G_{U_{(z, r)}}^{b_{n}}(x, y) \leq 2 G_{U_{(z, r)}}(x, y), \quad x, y \in U_{(z, r)} \tag{4.17}

where

\begin{equation*}
b_{n}(x)=b(x) \mathbf{1}_{U_{(z, r)}^{c}}(x)+b(x) \mathbf{1}_{K_{n}}(x), \quad x \in \mathbb{R}^{d} \tag{4.18}
\end{equation*}
$$

with $K_{n}$ being an increasing sequence of compact subsets of $U_{(z, r)}$ such that $\bigcup_{n} K_{n}=U_{(z, r)}$.

Proof. It is well known (see [23], e.g.) that, for any bounded $C^{1,1}$ open set $U$, there exists $c_{1}=c_{1}\left(R_{0}, \Lambda_{0}, \operatorname{diam}(U)\right)>1$ such that

It follows from this, the fact that $r^{-1} U_{(z, r)}$ is a $C^{1,1}$ open set with characteristic $\left(R_{0} / L, \Lambda_{0} L\right)$ and scaling that, for any bounded $C^{1,1}$ open set $D$ with characteristics $\left(R_{0}, \Lambda_{0}\right)$, there exists a constant $c_{2}=c_{2}\left(R_{0}, \Lambda_{0}, d\right)>1$ such that for all
$z \in \partial D, r \leq R_{0}$ and $x, y \in U_{(z, r)}$,

& c_{2}^{-1} \frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{U_{(z, r)}}(x) \delta_{U_{(z, r)}}(y)}{|x-y|^{2}}\right) \\
& \quad \leq G_{U_{(z, r)}}(x, y) \leq c_{2} \frac{1}{|x-y|^{d-\alpha}}\left(1 \wedge \frac{\delta_{U_{(z, r)}}(x) \delta_{U_{(z, r)}}(y)}{|x-y|^{2}}\right)
\end{aligned}
$$

Now we can repeat the argument of Theorem 4.3 to complete the proof.
Now we are going to extend Propositions 4.3 and 4.4 to $G_{B}^{b}$ and $G_{U(z, r)}^{b}$. For the remainder of this section, we let $U$ be either a ball $B=B\left(x_{0}, r\right)$ with $r \leq r_{*}$ where $r_{*}$ is the constant in Proposition 4.3 or $U(z, r)$ [for a $C^{1,1}$ open set $D$ with the characteristic $\left(R_{0}, \Lambda_{0}\right)$ ] with $r \leq r_{0}$ where $r_{0}$ is the constant in Proposition 4.4. We also let $b_{n}$ be defined by either (4.11) or (4.18), and we will take care of the two cases simultaneously.

By [6], Lemma 13, and its proof, there exists a constant $C_{4}>0$ such that

\int_{\mathbb{R}^{d}} \int_{0}^{t} p(t-s, x, z)|b(z)|\left|\nabla_{z} p(s, z, y)\right| d s d z \leq C_{4} p(t, x, y) \mathbb{N}_{b}(t)

\end{equation*}

where

\mathbb{N}_{b}(t):=\sup _{w \in \mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{0}^{t}|b(z)|\left(|w-z|^{-d-1} \wedge s^{-(d+1) / \alpha}\right) d s d z
$$

which is finite and goes to zero as $t \rightarrow 0$ by [6], Corollary 12 . We remark that the constant $C_{4}$ here is independent of $t$ and is not the same constant $C_{4}$ from [6], Lemma 13. Moreover,

= & C_{4} p(t, x, y) \\
& \times \sup _{w \in \mathbb{R}^{d}} \int_{U \backslash K_{n}} \int_{0}^{t}|b(z)|\left(|w-z|^{-d-1} \wedge s^{-(d+1) / \alpha}\right) d s d z .
\end{align*}
$$

Now, by [6], (27),

Choose $T_{1}>0$ small so that

We will fix this constant $T_{1}$ until the end of this section.
LEMMA 4.5. For all $k \geq 1$ and $(t, x, y) \in\left(0, T_{1}\right] \times \mathbb{R}^{d} \times \mathbb{R}^{d}$,

Proof. We prove the lemma by induction. For $k=1$, we have

& =C_{4} 2^{-k} p(t, x, y) \sup _{w \in \mathbb{R}^{d}} \int_{U \backslash K_{n}} \int_{0}^{t}|b(z)|\left(|w-z|^{-d-1} \wedge s^{-(d+1) / \alpha}\right) d s d z
\end{align*}

On the other hand, by the induction assumption, (4.20) and (4.23),

Proof. Without of loss of generality, we may assume that $0<t_{0} \leq T_{1} / 2$, where $T_{1}$ is the constant in (4.23). We first consider the case $(t, x, y) \in\left[t_{0}, T_{1}\right] \times$ $\mathbb{R}^{d} \times \mathbb{R}^{d}$. By Theorem 1.2(i) and Lemma 4.5,

Now, by the first case, we see that the above goes to zero as $n \rightarrow \infty$. Iterating the above argument one can deduce that the theorem holds for $L=\left[t_{0}, k T_{0} / 2\right]$ for any integer $k \geq 2$. This completes the proof of the first claim of the theorem.

First observe that by (1.3), for each fixed $x \in \mathbb{R}^{d}$ and for every $0 \leq t_{1}<t_{2}<$ $\cdots<t_{k}$, the distributions of $\left\{\left(X_{t_{1}}^{b_{n}}, \ldots, X_{t_{k}}^{b_{n}}\right), \mathbb{P}_{x}\right\}$ form a tight sequence. Thus it follows from the Markov property and [22], Theorem 2 (see also [20], Corollary 3.7.4, and [1], Theorem 3) that, for each $x \in \mathbb{R}^{d}$, the laws of $\left\{X^{b_{n}}, \mathbb{P}_{x}\right\}$
form a tight sequence in the Skorohod space $D\left([0, \infty), \mathbb{R}^{d}\right)$. Combining this and Theorem 4.6 with [20], Corollary 4.8.7, we get that $X^{b_{n}}$ converges to $X^{b}$ weakly. It follows directly from the definition of Skorohod topology on $D\left([0, \infty), \mathbb{R}^{d}\right)$ (see, e.g., [20], Section 3.5) that $\left\{t<\tau_{U}^{b}\right\}$ and $\left\{t>\tau_{\bar{U}}^{b}\right\}$ are disjoint open subsets in $D\left([0, \infty), \mathbb{R}^{d}\right)$. Thus the boundary of $\left\{t<\tau_{U}^{b}\right\}$ in $D\left([0, \infty), \mathbb{R}^{d}\right)$ is contained in $\left\{\tau_{U}^{b} \leq t \leq \tau_{\bar{U}}^{b}\right\}$. Note that, by the strong Markov property,

The last equality follows from the regularity of $\bar{U}$; that is, $\mathbb{P}_{z}\left(\tau_{\bar{U}}^{b}=0\right)=1$ for every $z \in \partial U$; see Proposition 3.2. Therefore, using the Lévy system for $X^{b}$,

which implies that the boundary of $\left\{t<\tau_{U}^{b}\right\}$ in $D\left([0, \infty), \mathbb{R}^{d}\right)$ is $\mathbb{P}_{x}$-null for every $x \in U$. For every $f \in C_{b}(\bar{U}), f\left(X_{t}^{b}\right) \mathbf{1}_{\left\{t<\tau_{U}^{b}\right\}}$ is a bounded function on $D\left([0, \infty), \mathbb{R}^{d}\right)$ with discontinuity contained in the boundary of $\left\{t<\tau_{U}^{b}\right\}$. Thus we have (cf. Theorem 2.9.1(vi) in [19])

where $C_{1}$ and $C_{2}$ are the constants in Lemma 3.7 with $D=U$. By the bounded convergence theorem and Fubini's theorem, from (4.27) we have

On the other hand, by the choice of $T$ and the fact that $C_{1}$ and $C_{2}$ depending only on $d, \alpha, \operatorname{diam}(U)$ and $b$, with the dependence on $b$ only through the rate at which
$M_{|b|}^{\alpha}(r)$ goes to zero, we have by Lemma 3.7

& \quad \leq 2 C_{1}\|f\|_{\infty} \int_{T}^{\infty} e^{-C_{2} t} d t<\varepsilon .

This completes the proof of (4.26).

As immediate consequences of (4.26) and Propositions 4.3 and 4.4, we get the following:

THEOREM 4.7. There exists a constant $r_{*}=r_{*}(d, \alpha, b)>0$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for any ball $B=B\left(x_{0}, r\right)$ of radius $r \leq r_{*}$,

THEOREM 4.8. For every $C^{1,1}$ open set $D$ with the characteristic $\left(R_{0}, \Lambda_{0}\right)$, there exists a constant $r_{0}=r_{0}\left(d, \alpha, R_{0}, \Lambda_{0}, b\right) \in\left(0,\left(R_{0} \wedge 1\right) / 8\right]$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for any for any $z \in \partial D$ and $r \leq r_{0}$, we have

We will need the above two results later on.
5. Duality. In this section we assume that $E$ is an arbitrary bounded open set in $\mathbb{R}^{d}$. We will discuss some basic properties of $X^{b, E}$ and its dual process under some reference measure. The results of this section will be used later in this paper.

By Theorem 3.4 and Corollary 3.6, $X^{b, E}$ has a jointly continuous and strictly positive transition density $p_{E}^{b}(t, x, y)$. Using the continuity of $p_{E}^{b}(t, x, y)$ and the estimate

p_{E}^{b}(t, x, y) \leq p^{b}(t, x, y) \leq c_{1} e^{c_{2} t}\left(t^{-d / \alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right)

the proof of the next proposition is easy. We omit the details.
Proposition 5.1. $\quad X^{b, E}$ is a Hunt process, and it satisfies the strong Feller property, that is, for every $f \in L^{\infty}(E), P_{t}^{E} f(x):=\mathbb{E}_{x}\left[f\left(X_{t}^{b, E}\right)\right]$ is bounded and continuous in $E$.

Define

$$
h_{E}(x):=\int_{E} G_{E}^{b}(y, x) d y \quad \text { and } \quad \xi_{E}(d x):=h_{E}(x) d x
$$

The following result says that $\xi_{E}$ is a reference measure for $X^{b, E}$.
Proposition 5.2. $\xi_{E}$ is an excessive measure for $X^{b, E}$, that is, for every Borel function $f \geq 0$,

\int_{E} f(x) \xi_{E}(d x) \geq \int_{E} \mathbb{E}_{x}\left[f\left(X_{t}^{b, E}\right)\right] \xi_{E}(d x)
$$

Moreover, $h_{E}$ is a strictly positive, bounded continuous function on $E$.
Proof. By the Markov property, we have for any Borel function $f \geq 0$ and $x \in E$,

\begin{aligned}
\int_{E} \mathbb{E}_{y}\left[f\left(X_{t}^{b, E}\right)\right] G_{E}^{b}(x, y) d y & =\mathbb{E}_{x} \int_{0}^{\infty} \mathbb{E}_{X_{s}^{b, E}}\left[f\left(X_{t}^{b, E}\right)\right] d s \\
& =\int_{0}^{\infty} \mathbb{E}_{x}\left[f\left(X_{t+s}^{b, E}\right)\right] d s \\
& \leq \int_{E} f(y) G_{E}^{b}(x, y) d y
\end{aligned}
$$

Integrating with respect to $x$, we get by Fubini's theorem

\int_{E} \mathbb{E}_{y}\left[f\left(X_{t}^{b, E}\right)\right] h_{E}(y) d y \leq \int_{E} f(y) h_{E}(y) d y
$$

The second claim follows from (3.12), the continuity of $G_{E}^{b}$ and the strict positivity of $p_{E}^{b}$ (Corollary 3.6).

We define a transition density with respect to the reference measure $\xi_{E}$ by

Let

Then $\bar{G}_{E}^{b}(x, y)$ is the Green function of $X^{b, E}$ with respect to the reference measure $\xi_{E}$.

Before we discuss properties of $\bar{G}_{E}^{b}(x, y)$, let us first recall some definitions.
Definition 5.3. Suppose that $U$ is an open subset of $E$. A Borel function $u$ on $E$ is said to be:
(i) harmonic in $U$ with respect to $X^{b, E}$ if

for every bounded open set $B$ with $\bar{B} \subset U$;
(ii) excessive with respective to $X^{b, E}$ if $u$ is nonnegative and for every $t>0$ and $x \in E$

u(x) \geq \mathbb{E}_{x}\left[u\left(X_{t}^{b, E}\right)\right] \quad \text { and } \quad u(x)=\lim _{t \downarrow 0} \mathbb{E}_{x}\left[u\left(X_{t}^{b, E}\right)\right]
$$

(iii) a potential with respect to $X^{b, E}$ if it is excessive with respect to $X^{b, E}$ and for every sequence $\left\{U_{n}\right\}_{n \geq 1}$ of open sets with $\bar{U}_{n} \subset U_{n+1}$ and $\bigcup_{n} U_{n}=E$,

$$
\lim _{n \rightarrow \infty} \mathbb{E}_{x}\left[u\left(X_{\tau_{U_{n}}^{b}}^{b, E}\right)\right]=0, \quad \xi_{E} \text {-a.e. } x \in E
$$

(iv) a pure potential with respect to $X^{b, E}$ if it is a potential with respect to $X^{b, E}$ and

$$
\lim _{t \rightarrow \infty} \mathbb{E}_{x}\left[u\left(X_{t}^{b, E}\right)\right]=0, \quad \xi_{E} \text {-a.e. } x \in E ;
$$

(v) regular harmonic with respect to $X^{b, E}$ in $U$ if $u$ is harmonic with respect to $X^{b, E}$ in $U$ and (5.1) is true for $B=U$.

We list some properties of the Green function $\bar{G}_{E}^{b}(x, y)$ of $X^{b, E}$ that we will need later:
(A1) $\bar{G}_{E}^{b}(x, y)>0$ for all $(x, y) \in E \times E ; \bar{G}_{E}^{b}(x, y)=\infty$ if and only if $x=$ $y \in E$.
(A2) For every $x \in E, \bar{G}_{E}^{b}(x, \cdot)$ and $\bar{G}_{E}^{b}(\cdot, x)$ are extended continuous in $E$.
(A3) For every compact subset $K$ of $E, \int_{K} \bar{G}_{E}^{b}(x, y) \xi_{E}(d y)<\infty$.
(A3) follows from (3.12) and Proposition 5.2. Both (A1) and (A2) follow from (3.12), Proposition 5.2, domain monotonicity of Green functions and the lower bound in (4.12).

From (A1)-(A3), we know that the process $X^{b, E}$ satisfies the condition ( $R$ ) on [16], page 211, and the conditions (a) and (b) of [16], Theorem 5.4. It follows from [16], Theorem 5.4, that $X^{b, E}$ satisfies Hunt's Hypothesis (B). Thus by [16], Theorem $13.24, X^{b, E}$ has a dual process $\widehat{X}^{b, E}$, which is a standard process.

In addition, we have the following.
(A4) For each $y, x \mapsto \bar{G}_{E}^{b}(x, y)$ is excessive with respect to $X^{b, E}$ and harmonic with respect to $X^{b, E}$ in $E \backslash\{y\}$. Moreover, for every open subset $U$ of $E$, we have

where $T_{U}^{b}:=\inf \left\{t>0: X_{t}^{b, E} \in U\right\}$. In particular, for every $y \in E$ and $\varepsilon>0$, $\bar{G}_{E}^{b}(\cdot, y)$ is regular harmonic in $E \backslash B(y, \varepsilon)$ with respect to $X^{b, E}$.

Proof of (A4). It follows from [15], Proposition 3, and [29], Theorem 2 on page 373 , that, to prove (A4), it suffices to show that, for any $x \in E \backslash U$, the function

y \mapsto \mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{T_{U}}^{b, E}, y\right)\right]
$$

is continuous on $U$. (See the proof of [31], Theorem 1.) Fix $x \in E \backslash U$ and $y \in U$. Put $r:=\delta_{U}(y)$. Let $\widehat{y} \in B(y, r / 4)$. It follows from (2.11) and (3.12) that, for any $\delta \in\left(0, \frac{r}{2}\right)$,

\mathbb{E}_{x}[ & \left.\bar{G}_{E}^{b}\left(X_{T_{U}^{b}}^{b, E}, \widehat{y}\right) ; X_{T_{U}^{b}}^{b, E} \in B(y, \delta)\right] \\
= & \int_{B(y, \delta)}\left(\int_{E \backslash U} G_{E \backslash U}^{b}(x, w) \frac{\mathcal{A}(d,-\alpha)}{|w-z|^{d+\alpha}} d w\right) \bar{G}_{E}^{b}(z, \widehat{y}) d z \\
\leq & \frac{c_{1}}{\inf _{\tilde{y} \in \overline{B(y, r / 4)}} h_{E}(\widetilde{y})} \\
& \quad \times \int_{B(y, \delta)}\left(\int_{E \backslash U} \frac{1}{|x-w|^{d-\alpha}} \frac{1}{|w-z|^{d+\alpha}} d w\right) \frac{d z}{|z-\widehat{y}|^{d-\alpha}} .
\end{aligned}
$$

Thus, for any $\epsilon>0$, there is a $\delta \in\left(0, \frac{r}{2}\right)$ such that

\mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{T_{U}}^{b, E}, y\right) ; X_{T_{U}}^{b, E} \in B(y, \delta)\right] \leq \frac{\varepsilon}{4} \quad \text { for every } \widehat{y} \in B(y, r / 4) \tag{5.3}
\end{equation*}
$$

Now we fix this $\delta$ and let $\left\{y_{n}\right\}$ be a sequence of points in $B(y, r / 4)$ converging to $y$. Since the function $(z, u) \mapsto \bar{G}_{E}^{b}(z, u)$ is bounded and continuous in $(E \backslash$ $B(y, \delta)) \times B\left(y, \frac{\delta}{2}\right)$, we have by the bounded convergence theorem that there exists $n_{0}>0$ such that for all $n \geq n_{0}$,

\end{align*}
$$

Since $\varepsilon>0$ is arbitrary, combining (5.3) and(5.4), the proof of (A4) is now complete.

THEOREM 5.4. For each $y \in E, x \mapsto \bar{G}_{E}^{b}(x, y)$ is a pure potential with respect to $X^{b, E}$. In fact, for every sequence $\left\{U_{n}\right\}_{n \geq 1}$ of open sets with $\overline{U_{n}} \subset U_{n+1}$ and $\bigcup_{n} U_{n}=E, \lim _{n \rightarrow \infty} \mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{\tau_{U_{n}}^{b}}^{b, E}, y\right)\right]=0$ for every $x \neq y$ in $E$. Moreover, for every $x, y \in E$, we have $\lim _{t \rightarrow \infty} \mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{t}^{b, E}, y\right)\right]=0$.

Proof. For $y \in E$, let $X^{b, E, y}$ denote the $h$-conditioned process obtained from $X^{b, E}$ with $h(\cdot)=\bar{G}_{E}^{b}(\cdot, y)$, and let $\mathbb{E}_{x}^{y}$ denote the expectation for $X^{b, E, y}$ starting from $x \in E$.

Let $x \neq y \in E$. Using (A1), (A2), (A4) and the strict positivity of $\bar{G}_{E}^{b}$, and applying [30], Theorem 2, we get that the lifetime $\zeta^{b, E, y}$ of $X^{b, E, y}$ is finite $\mathbb{P}_{x}^{y}$-a.s. and

\lim _{t \uparrow \zeta^{b, E, y}} X_{t}^{b, E, y}=y, \quad \mathbb{P}_{x}^{y} \text {-a.s. } \tag{5.5}
\end{equation*}

Let $\left\{E_{k}, k \geq 1\right\}$ be an increasing sequence of relatively compact open subsets of $E$ such that $E_{k} \subset \bar{E}_{k} \subset E$ and $\bigcup_{k=1}^{\infty} E_{k}=E$. Then

\mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{\tau_{E_{k}}^{b}}^{b, E}, y\right)\right]=\bar{G}_{E}^{b}(x, y) \mathbb{P}_{x}^{y}\left(\tau_{E_{k}}^{b}<\zeta^{b, E, y}\right)
$$

By (5.5), we have $\lim _{k \rightarrow \infty} \mathbb{P}_{x}^{y}\left(\tau_{E_{k}}^{b}<\zeta^{b, E, y}\right)=0$. Thus

\lim _{k \rightarrow \infty} \mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{\tau_{E_{k}}^{b}}^{b, E}, y\right)\right]=0
$$

The last claim of the theorem is easy. By (3.11) and (3.12), for every $x, y \in E$, we have

\mathbb{E}_{x}\left[\bar{G}_{E}^{b}\left(X_{t}^{b, E}, y\right)\right] \leq \frac{c}{t^{d / \alpha} h_{E}(y)} \int_{E} \frac{d z}{|z-y|^{d-\alpha}},

which converges to zero as $t$ goes to $\infty$.

We note that

\int_{E} \bar{G}_{E}^{b}(x, y) \xi_{E}(d x) \leq \frac{\left\|h_{E}\right\|_{\infty}}{h_{E}(y)} \int_{E} G_{E}^{b}(x, y) d x=\left\|h_{E}\right\|_{\infty}<\infty .
$$

So we have
(A5) for every compact subset $K$ of $E, \int_{K} \bar{G}_{E}^{b}(x, y) \xi_{E}(d x)<\infty$.
Using (A1)-(A5), (3.12) and Theorem 5.4 we get from [28, 29] that $X^{b, E}$ has a Hunt process as a dual.

Theorem 5.5. There exists a transient Hunt process $\widehat{X}^{b, E}$ in $E$ such that $\widehat{X}^{b, E}$ is a strong dual of $X^{b, E}$ with respect to the measure $\xi_{E}$; that is, the density of the semigroup $\left\{\widehat{P}_{t}^{E}\right\}_{t \geq 0}$ of $\widehat{X}^{b, E}$ is given by $\bar{p}_{E}^{b}(t, y, x)$ and thus

\int_{E} f(x) P_{t}^{E} g(x) \xi_{E}(d x)=\int_{E} g(x) \widehat{P}_{t}^{E} f(x) \xi_{E}(d x) \quad \text { for all } f, g \in L^{2}\left(E, \xi_{E}\right)
$$

Proof. The existence of a dual Hunt process $\widehat{X}^{b, E}$ is proved in [28, 29]. To show $\widehat{X}^{b, E}$ is transient, we need to show that for every compact subset $K$ of $E$, $\int_{K} \bar{G}_{E}^{b}(x, y) \xi_{E}(d x)$ is bounded. This is just (A5) above.

In Theorem 2.6, we have determined a Lévy system $(N, H)$ for $X^{b}$ with respect to the Lebesgue measure $d x$. To derive a Lévy system for $\widehat{X}^{b, E}$, we need to consider a Lévy system for $X^{b, E}$ with respect to the reference measure $\xi_{E}(d x)$. One can easily check that, if

\begin{aligned}
\bar{N}^{E}(x, d y) & :=\frac{J(x, y)}{h_{E}(y)} \xi_{E}(d y) \\
\bar{N}^{E}(x, \partial) & :=\int_{E^{c}} J(x, y) d y
\end{aligned} \quad \text { for }(x, y) \in E \times E,
$$

and $\bar{H}_{t}^{E}:=t$, then $\left(\bar{N}^{E}, \bar{H}^{E}\right)$ is a Lévy system for $X^{b, E}$ with respect to the reference measure $\xi_{E}(d x)$. It follows from [21] that a Lévy system $\left(\widehat{N}^{E}, \widehat{H}^{E}\right)$ for $\widehat{X}^{b, E}$ satisfies $\widehat{H}_{t}^{E}=t$ and

\widehat{N}^{E}(y, d x) \xi_{E}(d y)=\bar{N}^{E}(x, d y) \xi_{E}(d x)
$$

Therefore, using $J(x, y)=J(y, x)$, we have for every stopping time $T$ with respect to the filtration of $\widehat{X}^{b, E}$,

& =\mathbb{E}_{x}\left[\int_{0}^{T}\left(\int_{E} f\left(s, \widehat{X}_{s}^{b, E}, y\right) \frac{J\left(\widehat{X}_{s}^{b, E}, y\right)}{h_{E}\left(\widehat{X}_{s}^{b, E}\right)} \xi_{E}(d y)\right) d \widehat{H}_{s}^{E}\right]  \tag{5.6}\\
& =\mathbb{E}_{x}\left[\int_{0}^{T}\left(\int_{E} f\left(s, \widehat{X}_{s}^{b, E}, y\right) \frac{J\left(\widehat{X}_{s}^{b, E}, y\right) h_{E}(y)}{h_{E}\left(\widehat{X}_{s}^{b, E}\right)} d y\right) d s\right] .
\end{align*}
$$

That is,

\widehat{N}^{E}(x, d y)=\frac{J(x, y) h_{E}(y)}{h_{E}(x)} d y
$$

Let

$$
P_{t}^{b, E} f(x):=\int_{E} \bar{p}_{E}^{b}(t, x, y) f(y) \xi_{E}(d y)
$$

and

$$
\widehat{P}_{t}^{b, E} f(x):=\int_{E} \bar{p}_{E}^{b}(t, y, x) f(y) \xi_{E}(d y)
$$

For any open subset $U$ of $E$, we use $\widehat{X}^{b, E, U}$ to denote the subprocess of $\widehat{X}^{b, E}$ in $U$, that is, $\widehat{X}_{t}^{b, E, U}(\omega)=\widehat{X}_{t}^{b, E}(\omega)$ if $t<\widehat{\tau}_{U}^{b, E}(\omega)$ and $\widehat{X}_{t}^{b, E, U}(\omega)=\partial$ if $t \geq \widehat{\tau}_{U}^{b, E}(\omega)$, where $\widehat{\tau}_{U}^{b, E}:=\inf \left\{t>0: \widehat{X}_{t}^{b, E} \notin U\right\}$, and $\partial$ is the cemetery state. Then by [37], Theorem 2, and Remark 2 following it, $X^{b, U}$ and $\widehat{X}^{b, E, U}$ are dual processes with respect to $\xi_{E}$. Now we let

\widehat{p}_{U}^{b, E}(t, x, y):=\frac{p_{U}^{b}(t, y, x) h_{E}(y)}{h_{E}(x)} \tag{5.7}
\end{equation*}

By the joint continuity of $p_{U}^{b}(t, x, y)$ (Theorem 3.4) and the continuity and positivity of $h_{E}$ (Proposition 5.2), we know that $\widehat{p}_{U}^{b, E}(t, \cdot, \cdot)$ is jointly continuous on $U \times U$. Thus we have the following.

THEOREM 5.6. For every open subset $U, \widehat{p}_{U}^{b, E}(t, x, y)$ is strictly positive and jointly continuous on $U \times U$ and is the transition density of $\widehat{X}^{b, E, U}$ with respect to the Lebesgue measure. Moreover,

\widehat{G}_{U}^{b, E}(x, y):=\frac{G_{U}^{b}(y, x) h_{E}(y)}{h_{E}(x)} \tag{5.8}
\end{equation*}
$$

is the Green function of $\widehat{X}^{b, E, U}$ with respect to the Lebesgue measure so that for every nonnegative Borel function $f$,

\mathbb{E}_{x}\left[\int_{0}^{\hat{\tau}_{U}^{b, E}} f\left(\widehat{X}_{t}^{b, E}\right) d t\right]=\int_{U} \widehat{G}_{U}^{b, E}(x, y) f(y) d y
$$

6. Scaling property and uniform boundary Harnack principle. In this section, we first study the scaling property of $X^{b}$, which will be used later in this paper.

For $\lambda>0$, let $Y_{t}^{b, \lambda}:=\lambda X_{\lambda^{-\alpha} t}^{b}$. For any function $f$ on $\mathbb{R}^{d}$, we define $f^{\lambda}(\cdot)=$ $f(\lambda \cdot)$. Then we have

\mathbb{E}_{x}\left[f\left(Y_{t}^{b, \lambda}\right)\right]=\int_{\mathbb{R}^{d}} p^{b}\left(\lambda^{-\alpha} t, \lambda^{-1} x, y\right) f^{\lambda}(y) d y
$$

It follows from Theorem 1.2(iii) that for any $f, g \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$,

\begin{aligned}
& \lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} t^{-1}\left(\mathbb{E}_{x}\left[f\left(Y_{t}^{b, \lambda}\right)\right]-f(x)\right) g(x) d x \\
& \quad=\lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} \lambda^{-\alpha}\left(\lambda^{\alpha} t\right)^{-1}\left(P_{\lambda^{-\alpha} t}^{b} f^{\lambda}\left(\lambda^{-1} x\right)-f^{\lambda}\left(\lambda^{-1} x\right)\right) g^{\lambda}\left(\lambda^{-1} x\right) d x \\
& \quad=\lim _{t \downarrow 0} \int_{\mathbb{R}^{d}} \lambda^{d-\alpha}\left(\lambda^{\alpha} t\right)^{-1}\left(P_{\lambda^{-\alpha} t}^{b} f^{\lambda}(z)-f^{\lambda}(z)\right) g^{\lambda}(z) d z \\
& \quad=\lambda^{d-\alpha} \int_{\mathbb{R}^{d}}\left(-(-\Delta)^{\alpha / 2} f^{\lambda}(z)+b(z) \cdot \nabla f^{\lambda}(z)\right) g^{\lambda}(z) d z \\
& \quad=\lambda^{d-\alpha} \int_{\mathbb{R}^{d}}\left(-(-\Delta)^{\alpha / 2} f^{\lambda}(z)+\lambda b(z) \cdot \nabla f(\lambda z)\right) g(\lambda z) d z \\
& \quad=\int_{\mathbb{R}^{d}}\left(-(-\Delta)^{\alpha / 2} f(x)+\lambda^{1-\alpha} b\left(\lambda^{-1} x\right) \cdot \nabla f(x)\right) g(x) d x
\end{aligned}
$$

Thus $\left\{\lambda X_{\lambda^{-\alpha} t}^{b, D}, t \geq 0\right\}$ is the subprocess of $X^{\lambda^{1-\alpha} b\left(\lambda^{-1} .\right)}$ in $\lambda D$. So for any $\lambda>0$, we have

\text { for } t>0 \text { and } x, y \in \lambda D,
$$

$$
\begin{equation*}
G_{\lambda D}^{\lambda^{1-\alpha} b\left(\lambda^{-1} .\right)}(x, y)=\lambda^{\alpha-d} G_{D}^{b}\left(\lambda^{-1} x, \lambda^{-1} y\right) \quad \text { for } x, y \in \lambda D \tag{6.2}
\end{equation*}
$$

Define

$$
\begin{equation*}
b_{\lambda}(x):=\lambda^{1-\alpha} b(x / \lambda) \quad \text { for } x \in \mathbb{R}^{d} \tag{6.3}
\end{equation*}
$$

Then we have

$$
\begin{aligned}
M_{\left|b_{\lambda}\right|}^{\alpha}(r) & =\lambda^{1-\alpha} \sum_{i=1}^{d} \sup _{x \in \mathbb{R}^{d}} \int_{|x-y| \leq r} \frac{\left|b^{i}\right|\left(\lambda^{-1} y\right) d y}{|x-y|^{d+1-\alpha}} \\
& =\sum_{i=1}^{d} \sup _{\widehat{x} \in \mathbb{R}^{d}} \int_{|\widehat{x}-z| \leq \lambda^{-1} r} \frac{\left|b^{i}\right|(z) d z}{|\widehat{x}-z|^{d+1-\alpha}}=M_{|b|}^{\alpha}\left(\lambda^{-1} r\right) .
\end{aligned}
$$

Therefore for every $\lambda \geq 1$ and $r>0$,

$$
\begin{equation*}
M_{\left|b_{\lambda}\right|}^{\alpha}(r)=M_{|b|}^{\alpha}\left(\lambda^{-1} r\right) \leq M_{|b|}^{\alpha}(r) . \tag{6.4}
\end{equation*}
$$

In the remainder of this paper, we fix a bounded $C^{1,1}$ open set $D$ in $\mathbb{R}^{d}$ with $C^{1,1}$ characteristics $\left(R_{0}, \Lambda_{0}\right)$ and a ball $E \subset \mathbb{R}^{d}$ centered at the origin so that $D \subset \frac{1}{4} E$. Define

\begin{equation*}
M:=M(b, E):=\sup _{x, y \in 3 E / 4} \frac{h_{E}(x)}{h_{E}(y)}, \tag{6.5}
\end{equation*}
$$

which is a finite positive constant no less than 1 . Note that, in view of scaling property (6.2), we have

M(b, E)=M\left(b_{\lambda}, \lambda E\right) \tag{6.6}
\end{equation*}
$$

Although $E$ and $D$ are fixed, the constants in all the results of this section will depend only on $d, \alpha, R_{0}, \Lambda_{0}, b$ and $M$ (not the diameter of $D$ directly) with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero. In view of (6.4) and (6.6), the results of this section in particular hold for $\mathcal{L}^{b_{\lambda}}$ (equivalently, for $X^{b_{\lambda}}$ ) and the pair $(\lambda D, \lambda E)$ for every $\lambda \geq 1$.

In the remainder of this section, we will establish a uniform boundary Harnack principle on $D$ for certain harmonic functions for $X^{b, E}$ and $\widehat{X}^{b, E}$. Since the arguments are mostly similar for $X^{b, E}$ and $\widehat{X}^{b, E}$, we will only give the proof for $\widehat{X}^{b, E}$.

A real-valued function $u$ on $E$ is said to be harmonic in an open set $U \subset E$ with respect to $\widehat{X}^{b, E}$ if for every relatively compact open subset $B$ with $\bar{B} \subset U$,

\mathbb{E}_{x}\left[\left|u\left(\widehat{X}_{\widehat{\tau}_{B}^{b, E}}^{b, E}\right)\right|\right]<\infty \quad \text { and } \quad u(x)=\mathbb{E}_{x}\left[u\left(\widehat{X}_{\widehat{\tau}_{B}^{b, E}}^{b, E}\right)\right] \quad \text { for every } x \in B \tag{6.7}
\end{equation*}
$$

A real-valued function $u$ on $E$ is said to be regular harmonic in an open set $U \subset$ $E$ with respect to $\widehat{X}^{b, E}$ if (6.7) is true with $B=U$. Clearly, a regular harmonic function in $U$ is harmonic in $U$.

For any bounded open set $U$, define the Poisson kernel for $X^{b}$ of $U$ as

When $U \subset E$, we define the Poisson kernel for $\widehat{X}^{b, E}$ of $U \subset E$ as

\begin{align*}
\mathbb{E}_{x}[ & \left.f\left(\widehat{X}_{\widehat{\tau}_{U}^{b, E}}^{b, E}\right) ; \widehat{X}_{\widehat{\tau}_{U}^{b, E}-}^{b, E} \neq \widehat{X}_{\widehat{\tau}_{U}^{b, E}}^{b, E}\right] \\
& =\mathbb{E}_{x} \int_{0}^{\widehat{\tau}_{U}^{b, E}}\left(\int_{\bar{U}^{c}} f(z) \frac{J\left(\widehat{X}_{s}^{b, E}, z\right) h_{E}(z)}{h_{E}\left(\widehat{X}_{s}^{b, E}\right)} d z\right) d s \\
& =\int_{U} \frac{G_{U}^{b}(y, x) h_{E}(y)}{h_{E}(x)} \int_{\bar{U}^{c}} f(z) \frac{J(y, z) h_{E}(z)}{h_{E}(y)} d z d y  \tag{6.9}\\
& =\int_{\bar{U}^{c}} \widehat{K}_{U}^{b, E}(x, z) f(z) d z .
\end{align*}
$$

Lemma 6.1. Suppose that $U$ is a bounded $C^{1,1}$ open set in $\mathbb{R}^{d}$ with $U \subset \frac{1}{2} E$ and $\operatorname{diam}(U) \leq 3 r_{*}$ where $r_{*}$ is the constant in Theorem 4.7. Then

\mathbb{P}_{x}\left(X_{\tau_{U}^{b}}^{b} \in \partial U\right)=0 \quad \text { for every } x \in U \tag{6.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathbb{P}_{x}\left(\widehat{X}_{\widehat{\tau}_{U}^{b, E}}^{b, E} \in \partial U\right)=0 \quad \text { for every } x \in U \tag{6.11}
\end{equation*}
$$

Proof. The proof is similar to that of [4], Lemma 6. For our readers' convenience, we are going to spell out the details of the proof of (6.11). Let $B_{x}:=$ $B\left(x, \delta_{U}(x) / 3\right)$. By (5.6) we have for $x \in U$,

& \quad=\int_{B_{x}} \frac{G_{B_{x}}^{b}(y, x) h_{E}(y)}{h_{E}(x)}\left(\int_{\left(\frac{3}{4} E\right) \backslash U} \frac{J(y, z) h_{E}(z)}{h_{E}(y)} d z\right) d y .
\end{aligned}
$$

Since $\operatorname{diam}(U) \leq 3 r_{*}, \delta_{U}(x) / 3 \leq r_{*}$, thus by Theorem 4.7, for $x \in U$,

\mathbb{P}_{x}\left(\widehat{X}_{\hat{\tau}_{B_{x}}^{b, E}}^{b, E} \in\left(\frac{3}{4} E\right) \backslash U\right)
$$

\begin{align*}

where $M$ is the constant defined in (6.5). Let $V_{x}:=B\left(\delta_{U}(x)^{-1} x, 1 / 3\right)$. By the scaling property of $X$,

Let $z \in \partial D$. We will say that a function $u: \mathbb{R}^{d} \rightarrow \mathbb{R}$ vanishes continuously on $D^{c} \cap B(z, r)$ if $u=0$ on $D^{c} \cap B(z, r)$, and $u$ is continuous at every point of $\partial D \cap$ $B(z, r)$.

THEOREM 6.2 (Boundary Harnack principle). There exist positive constants $c_{1}=c_{1}\left(d, \alpha, R_{0}, \Lambda_{0}, b\right)$ and $r_{1}=r_{1}\left(d, \alpha, R_{0}, \Lambda_{0}, b\right)$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for all $z \in \partial D, r \in\left(0, r_{1}\right]$ and all function $u \geq 0$ on $\mathbb{R}^{d}$ that is positive harmonic with respect to $X^{b}$ (or $\widehat{X}^{b, E}$, resp.) in $D \cap B(z, r)$, and vanishes continuously on $D^{c} \cap B(z, r)$ (or $D^{c}$, resp.) we have

Recall that there exists $L=L\left(R_{0}, \Lambda_{0}, d\right)$ such that for every $z \in \partial D$ and $r \leq R_{0} / 2$, one can find a $C^{1,1}$ open set $U=U_{(z, r)}$ with $C^{1,1}$ characteristic $\left(r R_{0} / L, \Lambda_{0} L / r\right)$ such that $D \cap B(z, r / 2) \subset U \subset D \cap B(z, r)$. Without loss of generality, we assume $z=0$.

Note that, by the same proof as that of [11], Lemma 4.2, every nonnegative function $u$ in $\mathbb{R}^{d}$ that is harmonic with respect to $\widehat{X}^{b, E}$ in $D \cap B(0, r)$ and vanishes continuously on $D^{c}$ is regular harmonic in $D \cap B(0, r)$ with respect to $\widehat{X}^{b, E}$.

For all functions $u \geq 0$ on $E$ that is positive regular harmonic for $\widehat{X}^{b, E}$ in $D \cap$ $B(0, r)$ and vanishing on $D^{c}$, by (5.6) and Lemma 6.1, we have

7. Small time heat kernel estimates. Our strategy is to first establish sharp two-sided estimates on $p_{D}^{b}(t, x, y)$ at time $t=1$. We then use a scaling argument to establish estimates for $t \leq T$.

We continue to fix a ball $E$ centered at the origin and a $C^{1,1}$ open set $D \subset \frac{1}{4} E$ with characteristics $\left(R_{0}, \Lambda_{0}\right)$. Recall that $M>1$ is the constant defined in (6.5).

The next result follows from Proposition 3.5, (5.7) and (6.5).
Proposition 7.1. For all $a_{1} \in(0,1), a_{2}, a_{3}, R>0$, there is a constant $c_{1}=c_{1}\left(d, \alpha, a_{1}, a_{2}, a_{3}, R, M, b\right)>0$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero such that for all open ball $B\left(x_{0}, r\right) \subset \frac{3}{4} E$ with $r \leq R$,

Again, we emphasize that the constants in all the results of the remainder of this section (except Theorem 7.8 where the constant also depends on $T$ for an obvious reason) will depend only on $d, \alpha, R_{0}, \Lambda_{0}, M$ (not the diameter of $D$ directly) and $b$ with the dependence on $b$ only through the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero. In view of (6.3), (6.4) and (6.6), in particular, all the results of this section are applicable to $\mathcal{L}^{b_{\lambda}}$ and the pair ( $\lambda D, \lambda E$ ) for every $\lambda \geq 1$.

Recall that $r_{*}$ and $r_{0}$ are the constants from Theorems 4.7 and 4.8, respectively, which depend only on $d, \alpha, R_{0}, \Lambda_{0}$ and $b$ with the dependence on $b$ only via the rate at which $M_{|b|}^{\alpha}(r)$ goes to zero.

Choose $Q_{x} \in \partial D$ such that $\delta_{D}(x)=\left|x-Q_{x}\right|$, and choose a $C^{1,1}$ open set $U:=U_{\left(Q_{x},\left(r_{0} \wedge r_{*}\right) / 2\right)}$ with $C^{1,1}$ characteristic $\left(\left(r_{0} \wedge r_{*}\right) R_{0} /(2 L), 2 \Lambda_{0} L /\left(r_{0} \wedge r_{*}\right)\right)$ such that $D \cap B\left(Q_{x},\left(r_{0} \wedge r_{*}\right) / 4\right) \subset U \subset D \cap B\left(Q_{x},\left(r_{0} \wedge r_{*}\right) / 2\right)$.

\begin{aligned}
c^{-1}(1 & \left.\wedge \delta_{D_{t}}(x)^{\alpha / 2}\right)\left(1 \wedge \delta_{D_{t}}(y)^{\alpha / 2}\right)\left(1 \wedge \frac{1}{|x-y|^{d+\alpha}}\right) \\
& \leq p_{D_{t}}^{t^{(\alpha-1) / \alpha} b\left(t^{1 / \alpha} .\right)}(1, x, y) \\
& \leq c\left(1 \wedge \delta_{D_{t}}(x)^{\alpha / 2}\right)\left(1 \wedge \delta_{D_{t}}(y)^{\alpha / 2}\right)\left(1 \wedge \frac{1}{|x-y|^{d+\alpha}}\right)
\end{aligned}
$$

The above holds in view of (6.3), (6.4), (6.6) and the fact that for $t \leq T$, the $D_{t}$ 's are $C^{1,1}$ open sets in $\mathbb{R}^{d}$ with the same $C^{1,1}$ characteristics $\left(R_{0}(T)^{-1 / \alpha}, \Lambda_{0}(T)^{-1 / \alpha}\right)$. The theorem is thus proved.
8. Large time heat kernel estimates. Recall that we have fixed a ball $E$ centered at the origin, and $M>1$ is the constant in (6.5). Let $U$ be an arbitrary open set $U \subset \frac{1}{4} E$, and we let

$$
\bar{p}_{U}^{b, E}(t, x, y):=\frac{p_{U}^{b}(t, x, y)}{h_{E}(y)}
$$

which is strictly positive, bounded and continuous on $(t, x, y) \in(0, \infty) \times U \times U$ because $p_{U}^{b}(t, x, y)$ is strictly positive, bounded and continuous on $(t, x, y) \in$ $(0, \infty) \times U \times U$, and $h_{E}(y)$ is strictly positive and continuous on $E$. For each $x \in U,(t, y) \mapsto \bar{p}_{U}^{b, E}(t, x, y)$ is the transition density of $\left(X^{b, U}, \mathbb{P}_{x}\right)$ with respect to the reference measure $\xi_{E}$, and, for each $y \in U,(t, x) \mapsto \bar{p}_{U}^{b, E}(t, x, y)$ is the transition density of $\left(\widehat{X}^{b, E, U}, \mathbb{P}_{y}\right)$, the dual process of $X^{b, U}$ with respect to the reference measure $\xi_{E}$.

Let

$$
P_{t}^{b, E, U} f(x):=\int_{U} \bar{p}_{U}^{b, E}(t, x, y) f(y) \xi_{E}(d y)
$$

and

$$
\widehat{P}_{t}^{b, E, U} f(x):=\int_{U} \bar{p}_{U}^{b, E}(t, y, x) f(y) \xi_{E}(d y)
$$

Let $\mathcal{L}_{U}^{b, E}$ and $\widehat{\mathcal{L}}_{U}^{b, E}$ be the infinitesimal generators of the semigroups $\left\{P_{t}^{b, E, U}\right\}$ and $\left\{\widehat{P}_{t}^{b, E, U}\right\}$ on $L^{2}\left(U, \xi_{E}\right)$, respectively.

Note that, since for each $t>0, \bar{p}_{U}^{b, E}(t, x, y)$ is bounded in $U \times U$, it follows from Jentzsch's theorem ([32], Theorem V.6.6, page 337) that the common value $-\lambda_{0}^{b, E, U}:=\sup \operatorname{Re}\left(\sigma\left(\mathcal{L}_{U}^{b, E}\right)\right)=\sup \operatorname{Re}\left(\sigma\left(\widehat{\mathcal{L}}_{U}^{b, E}\right)\right)$ is an eigenvalue of multiplicity 1 for both $\mathcal{L}_{U}^{b, E}$ and $\widehat{\mathcal{L}}_{U}^{b, E}$, and that an eigenfunction $\phi_{U}^{b, E}$ of $\mathcal{L}_{U}^{b, E}$ associated with $\lambda_{0}^{b, E, U}$ can be chosen to be strictly positive with $\left\|\phi_{U}^{b, E}\right\|_{L^{2}\left(U, \xi_{E}(d x)\right)}=1$, and an eigenfunction $\psi_{U}^{b, E}$ of $\widehat{\mathcal{L}}_{U}^{b, E}$ associated with $\lambda_{0}^{b, E, U}$ can be chosen to be strictly positive with $\left\|\psi_{U}^{b, E}\right\|_{L^{2}\left(U, \xi_{E}(d x)\right)}=1$.

It is clear from the definition that, for any Borel function $f$,

$$
P_{t}^{b, E, U} f(x)=P_{t}^{b, U} f(x) \quad \text { for every } x \in U \text { and } t>0
$$

Thus the operators $\left.\mathcal{L}^{b}\right|_{U}$ and $\mathcal{L}_{U}^{b, E}$ have the same eigenvalues. In particular, the eigenvalue $\lambda_{0}^{b, E, U}$ does not depend on $E$, and so from from now on we will denote it by $\lambda_{0}^{b, U}$.

DEFINITION 8.1. The semigroups $\left\{P_{t}^{b, E, U}\right\}$ and $\left\{\widehat{P}_{t}^{b, E, U}\right\}$ are said to be intrinsically ultracontractive if, for any $t>0$, there exists a constant $c_{t}>0$ such that

$$
\bar{p}_{U}^{b, E}(t, x, y) \leq c_{t} \phi_{U}^{b, E}(x) \psi_{U}^{b, E}(y) \quad \text { for } x, y \in U
$$

It follows from [26], Theorem 2.5, that if $\left\{P_{t}^{b, E, U}\right\}$ and $\left\{\widehat{P}_{t}^{b, E, U}\right\}$ are intrinsically ultracontractive, then for any $t>0$ there exists a positive constant $c_{t}>1$ such that

$$
\begin{equation*}
\bar{p}_{U}^{b, E}(t, x, y) \geq c_{t}^{-1} \phi_{U}^{b, E}(x) \psi_{U}^{b, E}(y) \quad \text { for } x, y \in U \tag{8.1}
\end{equation*}
$$

THEOREM 8.2. For every $B\left(x_{0}, 2 r\right) \subset U$ there exists a constant $c=c(d, \alpha, r$, $\operatorname{diam}(U), M)>0$ such that for every $x \in D$,

$$
\begin{equation*}
\mathbb{E}_{x}\left[\int_{0}^{\tau_{U}^{b}} \mathbf{1}_{B\left(x_{0}, r\right)}\left(X_{t}^{b, U}\right) d t\right] \geq c \mathbb{E}_{x}\left[\tau_{U}^{b}\right] \tag{8.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathbb{E}_{x}\left[\int_{0}^{\hat{\tau}_{U}^{b, E}} \mathbf{1}_{B\left(x_{0}, r\right)}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right] \geq c \mathbb{E}_{x}\left[\widehat{\tau}_{U}^{b, E}\right] \tag{8.3}
\end{equation*}
$$

Proof. The method of the proof to be given below is now well known; see [10, 27]. For the reader's convenience, we present the details here. We give the proof of (8.3) only. The proof for (8.2) is similar. Fix a ball $B\left(x_{0}, 2 r\right) \subset U$ and put

$$
B_{0}:=B\left(x_{0}, r / 4\right), \quad K_{1}:=\overline{B\left(x_{0}, r / 2\right)} \quad \text { and } \quad B_{2}:=B\left(x_{0}, r\right)
$$

Let $\left\{\theta_{t}, t>0\right\}$ be the shift operators of $\widehat{X}^{b, E}$, and we define stopping times $S_{n}$ and $T_{n}$ recursively by

$$
\begin{aligned}
& S_{1}(\omega):=0, \\
& T_{n}(\omega):=S_{n}(\omega)+\widehat{\tau}_{U \backslash K_{1}}^{b, E} \circ \theta_{S_{n}}(\omega) \quad \text { for } S_{n}(\omega)<\widehat{\tau}_{U}^{b, E}
\end{aligned}
$$

and

$$
S_{n+1}(\omega):=T_{n}(\omega)+\widehat{\tau}_{B_{2}}^{b, E} \circ \theta_{T_{n}}(\omega) \quad \text { for } T_{n}(\omega)<\widehat{\tau}_{U}^{b, E}
$$

Clearly $S_{n} \leq \widehat{\tau}_{U}^{b, E}$. Let $S:=\lim _{n \rightarrow \infty} S_{n} \leq \widehat{\tau}_{U}^{b, E}$. On $\left\{S<\widehat{\tau}_{U}^{b, E}\right\}$, we must have $S_{n}<T_{n}<S_{n+1}$ for every $n \geq 0$. Using the fact that $\mathbb{P}_{x}\left(\widehat{\tau}_{U}^{b, E}<\infty\right)=1$ for every $x \in U$ and the quasi-left continuity of $\widehat{X}^{b, E, U}$, we have $\mathbb{P}_{x}\left(S<\widehat{\tau}_{U}^{b, E}\right)=0$. Therefore, for every $x \in U$,

$$
\begin{equation*}
\mathbb{P}_{x}\left(\lim _{n \rightarrow \infty} S_{n}=\lim _{n \rightarrow \infty} T_{n}=\widehat{\tau}_{U}^{b, E}\right)=1 \tag{8.4}
\end{equation*}
$$

For any $x \in K_{1}$, by Proposition 7.1 we have

$$
\mathbb{E}_{x}\left[\widehat{\tau}_{B_{2}}^{b, E}\right] \geq c_{0} \int_{B\left(x_{0}, r / 2\right)} \int_{r^{\alpha}}^{2 r^{\alpha}} \widehat{p}_{B_{2}}^{b, E}(t, x, y) d t d y \geq c_{1} \quad \text { for every } x \in K_{1}
$$

Now it follows from the strong Markov property that

$$
\begin{aligned}
\mathbb{E}_{x}\left[S_{n+1}-T_{n}\right] & =\mathbb{E}_{x}\left[\mathbb{E}_{\widehat{X}_{T_{n}}^{b, E, U}}\left[\widehat{\tau}_{B_{2}}^{b, E}\right] ; T_{n}<\widehat{\tau}_{U}^{b, E}\right] \\
& \geq c_{1} \mathbb{P}_{x}\left(\widehat{X}_{T_{n}}^{b, E, U} \in B_{0}\right) \\
& =c_{1} \mathbb{E}_{x}\left[\mathbb{P}_{\widehat{X}_{S_{n}}^{b, E, U}}\left(\widehat{X}_{\widehat{\tau}_{U \backslash K_{1}}^{b, E, U}}^{b, E} \in B_{0}\right)\right] .
\end{aligned}
$$

Note that for any $x \in U \backslash B_{2}$, by (6.9), we have

$$
\begin{aligned}
& \mathbb{P}_{x}\left(\widehat{X}_{\hat{\tau}_{U \backslash K_{1}}^{b, E, U}}^{b, E, U} \in B_{0}\right) \\
& \quad=\int_{U \backslash K_{1}} \frac{G_{U \backslash K_{1}}^{b}(y, x)}{h_{E}(x)} \int_{B_{0}}\left(\frac{J(y, z) h_{E}(z)}{h_{E}(y)} d z\right) \xi_{E}(d y) \\
& \quad \geq M^{-1} \mathcal{A}(d,-\alpha) \int_{U \backslash K_{1}} \frac{G_{U \backslash K_{1}}^{b}(y, x)}{h_{E}(x)} \int_{B_{0}}\left(\frac{d z}{(\operatorname{diam}(U))^{d+\alpha}}\right) \xi_{E}(d y) \\
& \quad=c_{2} \mathbb{E}_{x}\left[\widehat{\tau}_{U \backslash K_{1}}^{b, E}\right]
\end{aligned}
$$

for some constant $c_{2}=c_{2}(\alpha, r, \operatorname{diam}(U), M)>0$. It follows then

$$
\begin{equation*}
\mathbb{E}_{x}\left[S_{n+1}-T_{n}\right] \geq c_{1} c_{2} \mathbb{E}_{x}\left[\mathbb{E}_{\widehat{X}_{S_{n}}^{b, E, U}}\left[\widehat{\tau}_{U \backslash K_{1}}^{b, E}\right]\right]=c_{1} c_{2} \mathbb{E}_{x}\left[T_{n}-S_{n}\right] \tag{8.5}
\end{equation*}
$$

Since $\widehat{X}_{t}^{b, E, U} \in B_{2}$ for $T_{n}<t<S_{n+1}$, we have, by (8.4),

$$
\begin{aligned}
\mathbb{E}_{x}[ & \left.\int_{0}^{\hat{\tau}_{U}^{b, E}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right] \\
& =\mathbb{E}_{x}\left[\sum_{n=1}^{\infty}\left(\int_{S_{n}}^{T_{n}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t+\int_{T_{n}}^{S_{n+1}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right)\right] \\
& \geq \mathbb{E}_{x}\left[\sum_{n=1}^{\infty}\left(\int_{T_{n}}^{S_{n+1}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right)\right]=\mathbb{E}_{x}\left[\sum_{n=1}^{\infty}\left(S_{n+1}-T_{n}\right)\right] .
\end{aligned}
$$

Using (8.4) and (8.5) and noting that $\widehat{X}_{t}^{b, E, U} \notin U \backslash B_{2}$ for $t \in\left[T_{n}, S_{n+1}\right.$ ), we get

$$
\begin{aligned}
\mathbb{E}_{x} & {\left[\int_{0}^{\widehat{\tau}_{U}^{b, E}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right] } \\
& \geq c_{1} c_{2} \mathbb{E}_{x}\left[\sum_{n=1}^{\infty}\left(T_{n}-S_{n}\right)\right] \\
& \geq c_{1} c_{2} \mathbb{E}_{x}\left[\sum_{n=1}^{\infty}\left(\int_{S_{n}}^{T_{n}} \mathbf{1}_{U \backslash B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t+\int_{T_{n}}^{S_{n+1}} \mathbf{1}_{U \backslash B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right)\right] \\
& =c_{1} c_{2} \mathbb{E}_{x}\left[\int_{0}^{\hat{\tau}_{U}^{b, E}} \mathbf{1}_{U \backslash B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right] .
\end{aligned}
$$

Thus

$$
\mathbb{E}_{x}\left[\int_{0}^{\widehat{\tau}_{U}^{b, E}} \mathbf{1}_{B_{2}}\left(\widehat{X}_{t}^{b, E, U}\right) d t\right] \geq \frac{c_{1} c_{2}}{1+c_{1} c_{2}} \mathbb{E}_{x}\left[\widehat{\tau}_{U}^{b, E}\right] .
$$

THEOREM 8.3. $\left\{P_{t}^{b, E, U}\right\}$ and $\left\{\widehat{P}_{t}^{b, E, U}\right\}$ are intrinsically ultracontractive.
Proof. Since $\psi_{U}^{b, E}=e^{\lambda_{0}^{b, U}} \widehat{P}_{1}^{b, E, U} \psi_{U}^{b, E}$, it follows that $\psi_{U}^{b, E}$ is strictly positive, bounded and continuous in $U$. Theorem 8.2 implies that

$$
\begin{align*}
\mathbb{E}_{x}\left[\hat{\tau}_{U}^{b, E}\right] & \leq c_{1} \int_{B_{2}} \frac{G_{U}^{b, E}(z, y)}{h_{E}(y)} \psi_{U}^{b, E}(z) \xi_{E}(d z)  \tag{8.6}\\
& \leq c_{1} \int_{U} \frac{G_{U}^{b, E}(z, y)}{h_{E}(y)} \psi_{U}^{b, E}(z) \xi_{E}(d z)=\frac{c_{1}}{\lambda_{0}^{b, U}} \psi_{U}^{b, E}(y) .
\end{align*}
$$

Similarly,

$$
\begin{equation*}
\mathbb{E}_{x}\left[\tau_{U}^{b}\right] \leq \frac{c_{2}}{\lambda_{0}^{b, U}} \phi_{U}^{b, E}(x) \tag{8.7}
\end{equation*}
$$

By the semigroup property and (1.3),

$$
\begin{aligned}
\bar{p}_{U}^{b, E} & (t, x, y) \\
& =\int_{U} \bar{p}_{U}^{b, E}(t / 3, x, z) \int_{U} \bar{p}_{U}^{b, E}(t / 3, z, w) \bar{p}_{U}^{b, E}(t / 3, w, y) \xi_{E}(d w) \xi_{E}(d z) \\
& \leq c_{3} t^{-d / \alpha} \int_{U} \bar{p}_{U}^{b, E}(t / 3, x, z) \xi_{E}(d z) \int_{U} \bar{p}_{U}^{b, E}(t / 3, w, y) \xi_{E}(d w) \\
& =c_{3} t^{-d / \alpha} \mathbb{P}_{x}\left(\tau_{U}^{b, E}>t / 3\right) \mathbb{P}_{y}\left(\widehat{\tau}_{U}^{b, E}>t / 3\right) \\
& \leq\left(9 c_{3} / t^{2}\right) t^{-d / \alpha} \mathbb{E}_{x}\left[\tau_{U}^{b}\right] \mathbb{E}_{y}\left[\widehat{\tau}_{U}^{b, E}\right] .
\end{aligned}
$$

This together with (8.6) and (8.7) establishes the intrinsic ultracontractivity of $\left\{P_{t}^{b, E, U}\right\}$ and $\left\{\widehat{P}_{t}^{b, E, U}\right\}$.

Applying [26], Theorem 2.7, we obtain:
THEOREM 8.4. There exist positive constants $c$ and $v$ such that

$$
\begin{equation*}
\left|\frac{M_{U}^{b, E} e^{t \lambda_{0}^{b, U}} \bar{p}_{U}^{b, E}(t, x, y)}{\phi_{U}^{b, E}(x) \psi_{U}^{b, E}(y)}-1\right| \leq c e^{-v t}, \quad(t, x, y) \in(1, \infty) \times U \times U \tag{8.8}
\end{equation*}
$$

where $M_{U}^{b, E}:=\int_{U} \phi_{U}^{b, E}(y) \psi_{U}^{b, E}(y) \xi_{E}(d y) \leq 1$.
Now we can present the following:
Proof of Theorem 1.3(ii). Assume that the ball $E$ is large enough so that $D \subset \frac{1}{4} E$. Since $\phi_{D}^{b, E}=e^{\lambda_{0}^{, D}} P_{1}^{b, D} \phi_{D}^{b, E}$ and $\psi_{D}^{b, E}=e^{\lambda_{0}^{b, D}} \widehat{P}_{1}^{b, E, D} \psi_{D}^{b, E}$, we have from Theorem 1.3(i) that on $D$,

$$
\begin{align*}
\phi_{D}^{b, E}(x) & \asymp\left(1 \wedge \delta_{D}(x)^{\alpha / 2}\right) \int_{D}\left(1 \wedge \delta_{D}(y)^{\alpha / 2}\right)\left(1 \wedge \frac{1}{|x-y|^{d+\alpha}}\right) \phi_{D}^{b, E}(y) d y \\
& \asymp \delta_{D}(x)^{\alpha / 2} \tag{8.9}
\end{align*}
$$

and

$$
\psi_{D}^{b, E}(x) \asymp\left(1 \wedge \delta_{D}(x)^{\alpha / 2}\right) \int_{D}\left(1 \wedge \delta_{D}(y)^{\alpha / 2}\right)\left(1 \wedge \frac{1}{|x-y|^{d+\alpha}}\right)
$$

$$
\begin{equation*}
\times \frac{h_{E}(y)}{h_{E}(x)} \psi_{D}^{b, E}(y) d y \tag{8.10}
\end{equation*}
$$

$$
\asymp \delta_{D}(x)^{\alpha / 2} .
$$

Theorem 8.3, (8.9) and (8.10) imply that

$$
c_{t}^{-1} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq \bar{p}_{D}^{b, E}(t, x, y) \leq c_{t} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}
$$

for every $(t, x, y) \in(0, \infty) \times D \times D$, and so

$$
c_{1}^{-1} c_{t}^{-1} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq p_{D}^{b}(t, x, y) \leq c_{1} c_{t} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}
$$

for every $(t, x, y) \in(0, \infty) \times D \times D$.
Furthermore, by Theorem 8.4 and (8.9), there exist $c_{2}>1$ and $T_{1}>0$ such that for all $(t, x, y) \in\left[T_{1}, \infty\right) \times D \times D$,

$$
c_{2}^{-1} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq \bar{p}_{D}^{b, E}(t, x, y) \leq c_{2} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2},
$$

which implies that

$$
c_{3}^{-1} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq p_{D}^{b}(t, x, y) \leq c_{3} e^{-t \lambda_{0}^{b, D}} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} .
$$

If $T<T_{1}$, by Theorem 1.3(i), there is a constant $c_{2} \geq 1$ such that

$$
c_{2}^{-1} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2} \leq p_{D}^{b}(t, x, y) \leq c_{2} \delta_{D}(x)^{\alpha / 2} \delta_{D}(y)^{\alpha / 2}
$$

for every $t \in\left[T, T_{1}\right)$ and $x, y \in D$. This establishes Theorem 1.3(ii).
REMARK 8.5. (i) Using Corollary 1.4 and the argument of the proof of Lemma 6.1, (6.10) is, in fact, true for all bounded open sets $U$ with exterior cone condition.
(ii) In view of Corollary 1.4, estimate (4.8) and Lemma 4.1, we can deduce from (4.10) by the dominated convergence theorem that Proposition 4.2 holds for general $b$ with $|b| \in \mathbb{K}_{d, \alpha-1}$.

Acknowledgments.
