A PHYSICALLY CONSISTENT, DISCRETE *n*-BODY MODEL

1. Introduction. A dynamical model of a physical phenomenon is said to be physically consistent if the model (a) conserves energy, (b) conserves linear momentum, (c) conserves angular momentum, and (d) is symmetric in the physical sense, that is (see [3]), the form of its dynamical equations is invariant with respect to translation, rotation and uniform motion. Unfortunately, the equations of many interesting, physically consistent models have eluded solution by analytical mathematical methods. It was natural then, with the emergence of the modern digital computer, that there were developed varieties of discrete n-body, "molecular" type, models which were used to approximate solutions of such equations (see, e.g., [1], [2], [4], [7]-[12], and the additional references contained therein). However, none of these discrete models was, itself, physically consistent, which forced the unnatural development of computational contrivances, like "artificial viscosity", in order to achieve numerical stability.

Our objective here, then, is to construct a physically consistent, discrete *n*-body model. Our approach will be of sufficient generality so as to include both Newtonian and classical molecular *n*-body forces. During the discussion, it will be worth noting that, unlike other discrete approaches, our definitions of kinetic energy, potential energy, linear momentum, and angular momentum are *identical* with those of classical, continuous *n*-body models.

2. The discrete model. For a positive time step Δt , let $t_k = k \Delta t$, $k = 0, 1, 2, \cdots$. At time t_k , let particle P_i of mass m_i be located at $x_{i,k} = (x_{i,k}, y_{i,k}, z_{i,k})$, have velocity $v_{i,k} = (v_{i,k,x}, v_{i,k,y}, v_{i,k,z})$, and have acceleration $a_{i,k} = (a_{i,k,x}, a_{i,k,y}, a_{i,k,z})$, for $i = 1, 2, \cdots, n$. Position, velocity, and acceleration are assumed to be related by the formulas

(2.1)
$$(v_{i,k+1} + v_{i,k})/2 = (x_{i,k+1} - x_{i,k})/(\Delta t),$$

(2.2)
$$a_{i,k} = (v_{i,k+1} - v_{i,k})/(\Delta t).$$

If $F_{i,k} = (F_{i,k,x}, F_{i,k,y}, F_{i,k,z})$ is the force acting on P_i at time t_k , then force and acceleration are assumed to be related by the discrete dynamical

equation

$$F_{i,k} = m_i \mathbf{a}_{i,k}.$$

In particular, we will consider only forces which have components of attraction which behave like $p/(r^{\alpha})$ and components of repulsion which behave like $q/(r^{\beta})$, where p, q, α , β are nonnegative parameters with $\beta > \alpha \ge 2$, and where r is the distance between a pair of particles, as follows [5]. Let $r_{ij,k}$ be the distance between P_i and P_j at t_k . Then $F_{i,k}$, the force exerted on P_i at time t_k by the remaining (n-1) particles P_j of the system, is defined by

$$F_{i,k} = m_i \sum_{j=1;j\neq i}^{n} \left\{ m_j \left(-\frac{p \sum_{\xi=0}^{n-2} (r_{ij,k}^{\xi} r_{ij,k+1}^{n-\xi-2})}{r_{ij,k}^{n-1} r_{ij,k+1}^{\eta-1} (r_{ij,k+1} + r_{ij,k})} + \frac{q \sum_{\xi=0}^{n-2} (r_{ij,k}^{\xi} r_{ij,k+1}^{\theta-\xi-2})}{r_{ij,k}^{\theta-1} r_{ij,k+1}^{\theta-1} (r_{ij,k+1} + r_{ij,k})} \right) \cdot (x_{i,k+1} + x_{i,k} - x_{j,k+1} - x_{j,k}) \right\}$$

Finally, at t_k , the kinetic energy K_k , potential energy V_k , linear momentum M_k , and angular momentum L_k of the system are defined by

(2.5)
$$K_k = \sum_{i=1}^n \frac{1}{2} m_i (v_{i,k,x}^2 + v_{i,k,y}^2 + v_{i,k,z}^2),$$

(2.6)
$$V_{k} = \sum_{i,j=1;i$$

$$M_k = \sum_{i=1}^n m_i v_{i,k},$$

(2.8)
$$L_k = \sum_{i=1}^n m_i(\mathbf{x}_{i,k} \times \mathbf{v}_{i,k}).$$

- 3. Physical consistency of the discrete model. We will show now that the discrete model of §2 satisfies the physical consistency criteria (a)–(d) of §1.
 - (a) Conservation of energy. For the proof, see [5].
 - (b) Conservation of linear momentum. From (2.3) and (2.4), note that

(3.1)
$$\sum_{i=1}^{n} m_{i} a_{i,k} = 0, \quad k = 0, 1, 2, \cdots.$$

From (2.2) and (3.1), then,

(3.2)
$$\sum_{i=1}^{n} m_i v_{i,k} = \sum_{i=1}^{n} m_i v_{i,0}, \qquad k = 1, 2, \cdots.$$

From (2.7) and (3.2), finally,

$$M_k = \sum_{i=1}^n m_i v_{i,0}, \qquad k = 1, 2, \cdots.$$

(c) Conservation of angular momentum. From (2.1)-(2.3) and (2.8),

$$L_{k+1} - L_k = \Delta t \sum_{i=1}^n \left(\frac{x_{i,k+1} + x_{i,k}}{2} \right) \times F_{i,k}.$$

Let the torque T_k of the system at t_k be defined by

$$T_k = \sum_{i=1}^n \left(\frac{x_{i,k+1} + x_{i,k}}{2} \right) \times F_{i,k}.$$

Then, $T_k \equiv 0$ implies $L_k = L_0$, $k = 1, 2, \cdots$.

(d) Symmetry. For the proof, see [6].
