

The Krichever Map, Vector Bundles Over Algebraic Curves, and Heisenberg Algebras*

Abstract. We study the Grassmannian Gr_X^n consisting of equivalence classes of rank n algebraic vector bundles over a Riemann surface X with an holomorphic trivialization at a fixed point p . Commutative subalgebras of $gl(n, H_\lambda)$, H_λ being the ring of functions holomorphic on a punctured disc about p , define flows on the Grassmannian, giving rise to classes of solutions to multi-component KP hierarchies. These commutative subalgebras correspond to Heisenberg algebras in the Kac–Moody algebra associated to $gl(n, H_\lambda)$. One can obtain, by the Krichever map, points of Gr_X^n (and solutions of mcKP) from coverings $f: Y \rightarrow X$ and other geometric data. Conversely for every point of Gr_X^n and for every choice of Heisenberg algebra we construct, using the cotangent bundle of Gr_X^n , an algebraic curve covering X and other data, thus inverting the Krichever map. We show the explicit relation between the choice of Heisenberg algebra and the geometry of the covering space.

1. Introduction

1.1. In the seventies it was discovered that one could obtain solutions of certain non-linear evolutionary equations of “soliton type” in terms of θ -functions of Riemann surfaces or, more generally, one could construct solutions from coherent sheaves on algebraic curves, see e.g., [Kr, Mum1, Du, KrN, vMM]. (In fact, certain solutions of the Korteweg–de Vries equation (KdV) in terms of elliptic functions were known classically [KdV].) Somewhat later it was discovered that solutions of such equations could be identified with points of infinite dimensional Grassmannians, or, equivalently, with the orbits of infinite dimensional groups in representation spaces (see e.g., [Sa, DaJKM, Ka]).

Both points of view, the algebro-geometric one and the representation theoretic, could be connected by associating to a Riemann surface (along with a line

bundle and other ingredients that won't concern us for the moment) a point of an infinite dimensional Grassmannian, [SeW]. This map from algebro-geometric data to Grassmannians we will call (as is now standard) the *Krichever map*.

In the representation theoretic approach one starts with, say, an affine, simply laced, Kac–Moody algebra $\hat{\mathfrak{g}}$ and a highest weight representation (see [Ka]). For every maximal Heisenberg algebra \mathcal{H} in $\hat{\mathfrak{g}}$ one has an explicit construction of the basic representation in terms of vertex operators, certain formal infinite order differential operators in an infinite number of variables (see [KaP, Lep]). In the realization determined by \mathcal{H} the defining equations of the orbit of the associated Kac–Moody group through the highest weight vector are then differential equations in terms of the variables occurring in the corresponding vertex operators, see, e.g., [KaW]. For the simplest choice of Heisenberg algebra, the principal one, one obtains the generalized Korteweg–de Vries hierarchies and it is mainly in this context that the Krichever map is studied (especially in connection with the Schottky problem [Mull, Sh]), but see also [Di].

The question we want to address in this paper is the significance of the choice of Heisenberg algebra (which plays such an important role in the representation theory) for the algebro-geometric picture.

First recall ([KaP, Lep]) that every partition \underline{n} of an integer n determines a Heisenberg algebra $\mathcal{H}^{\underline{n}}$ in $\widehat{sl}(n, \mathbb{C})$, the non-twisted affine Kac–Moody algebra based on the loop group of $sl(n, \mathbb{C})$, and that every conjugacy class of Heisenberg algebras corresponds to one unique partition. The principal Heisenberg algebra $\mathcal{H}^{\text{princ}}$ of $\widehat{sl}(n, \mathbb{C})$ corresponds to the partition of n into a single part. Next recall that in the standard treatment of algebro-geometric solutions of generalized KdV hierarchies, corresponding to the principal Heisenberg $\mathcal{H}^{\text{princ}}$, the geometric data for the Krichever map involves a Riemann surface Y covering the Riemann sphere in such a way that inverse image of the North Pole (“infinity”) is a single point of Y .

We will explain that this generalizes as follows: the number of points over infinity should correspond to the number of parts in the partition. More precisely, solutions of soliton hierarchies, coming from other choices of Heisenbergs $\mathcal{H}^{\underline{n}}$, where $\underline{n} = (n_1, n_2, \dots, n_k)$ is a partition of n into k parts, can be obtained from Riemann surfaces covering the Riemann sphere with k points (with ramification index n_i at the i^{th} point) lying over the north pole.

In fact, we study a more general situation of algebraic curves Y covering a fixed nonsingular and irreducible Riemann surface X . Any coherent torsion free sheaf on Y will push forward to a vector bundle on X . The collection of vector bundles on X of fixed rank together with a trivialization at some fixed point $p \in X$ forms an infinite dimensional Grassmannian Gr_X^n described in Sect. 2, (see also [PrS]). In this situation the Krichever map associates a point $W \in Gr_X^n$ to any covering $f: Y \rightarrow X$, a coherent sheaf on Y and data at $f^{-1}(p)$. This is described in detail in Sect. 5.

To invert the Krichever map and obtain the geometric data from the point $W \in Gr_X^n$ we introduce in Sect. 3 the *non-commutative stabilizer algebra* S_W of W . This is the subalgebra of elements s of the loop algebra such that $sW \subset W$. We show that it may be thought of as a subspace (of codimension $2n^2g$, with g the genus of X) of the fiber of the cotangent bundle $T^*Gr_X^n$, and that for the case of $X = \mathbf{P}^1$ it may be identified with this fiber. In a similar context cotangent bundles

of moduli spaces have appeared earlier in Hitchin's work on Higgs bundles and spectral curves, see [Hi] (see also [AHH, B]).¹

By projection from the Kac–Moody algebra to the loop algebra we obtain from every Heisenberg algebra $\widehat{\mathcal{H}}^n$ a maximal Abelian subalgebra \mathcal{H}^n of the loop algebra. We will refer also to this as a Heisenberg algebra (of type n). The finite order part of the intersection $S_W^n = S_W \cap \mathcal{H}^n$ is a finitely generated commutative \mathbb{C} -algebra. So we can associate to every point of the infinite Grassmannian Gr_X^n , $\phi(n)$ (the number of partitions of n) distinct commutative rings and we prove in Sects. 6 and 7 that the compactification of the spectrum of each of these rings is an algebraic curve Y covering X with the branching behaviour over $p \in X$ determined by the choice of partition. (In the best case the pullback divisor $f^*(p)$ is of the form $\sum n_i p_i$, $p_i \in Y$ if the n_i are the parts of the partition. In general the situation can be considerably more complicated, see Theorem 7.5.1 for a more precise statement. We stress that for most W the curve constructed by this method is just the original X , see Example 6.2.) We can also construct a coherent sheaf on Y corresponding to the S_W^n module W , as well as the other geometric data, so that we obtain in this way an inverse of the Krichever map, generalizing a procedure in [SeW], cf. also [Mum1]. (In this paper we study only the finite order parts of these stabilizer algebras so that our curves are algebraic. More generally one can study holomorphic stabilizer algebras but in that setting the geometric data may be more complicated, see Example 6.2.)

Now there are, again for every Heisenberg algebra, natural flows on the Grassmannian that preserve the curves and are called therefore isospectral. In Sect. 8 we briefly discuss the associated differential equations and their Hamiltonian structure. They turn out to be certain subsystems of the multicomponent KP hierarchy studied in, e.g., [UT, Di]. Other papers that consider the relation between vector bundles and soliton equations are [Mul2, PrW].

We conclude with some remarks in Sect. 9. Some of the results of this paper were announced in [AB].

2. The Infinite Grassmannian Gr_X^n

2.0. Pressley and Segal introduced in [PrS] (Sect. 8.11) an infinite dimensional Grassmannian which can be identified with the space of holomorphic vector bundles over a Riemann surface X together with an holomorphic trivialization in a disc around a fixed point $p \in X$. The Grassmannian consists of certain subspaces of the Hilbert space $L^2(S^1, \mathbb{C}^n)$, where S^1 is the boundary of the disk, given by the L^2 -completion of the restriction of the holomorphic sections of the vector bundle in the complement of the disk to the boundary. There is a natural transitive action of the smooth loop group on this Grassmannian, so it is also an homogeneous space for this group. In this section we will describe a variant of their construction so as to study the space Gr_X^n of equivalence classes of pairs (\mathcal{E}, t) , where \mathcal{E} is an algebraic vector bundle over X and t is an holomorphic trivialization of \mathcal{E} at p . In this set-up there is no a priori connection between the radius of convergence of the local

holomorphic coordinate at p and that of the local trivialization, cf. [ADKP]. Along the way we will also make some remarks about formal trivializations and the corresponding formal Grassmannian as in, for instance, [KNTY].

2.1. Let X be an integral, smooth, projective, algebraic curve (over the complex numbers as always in this paper) and p some point on X fixed once and for all. In this sub-section we recall the definitions of algebraic and holomorphic local coordinates λ^{-1} at p . (We use λ^{-1} instead of just λ so that our conventions match those of the usual infinite Grassmannian based on the Riemann sphere, where p is considered to be the point at infinity.)

Let \mathcal{O}_X be the (algebraic) structure sheaf of X and let $\mathcal{O}_{X,p}$ be the ring of rational functions which are regular at p . This is a local ring with maximal ideal \mathfrak{m}_p given by functions which vanish at p . An *algebraic local coordinate* is a generator λ^{-1} of \mathfrak{m}_p . Notice that this defines an injective local \mathbb{C} -algebra homomorphism $l: \mathcal{O}_{X,p} \rightarrow \mathbb{C}[[\lambda^{-1}]]$ of the local ring to the ring of formal power series.

Recall [Ser] that an algebraic curve (X, \mathcal{O}_X) (or more generally an algebraic variety) has canonically associated to it an analytic space $(X, \mathcal{O}_X^{\text{hol}})$, where $\mathcal{O}_X^{\text{hol}}$ is the sheaf of germs of holomorphic functions on X . (So X has now the complex, instead of the Zariski, topology.) To define an *holomorphic local coordinate* the ring $\mathcal{O}_{X,p}$ is replaced by $\mathcal{O}_{X,p}^{\text{hol}}$, the ring of germs of holomorphic functions at p on X . This, too, is a local ring with maximal ideal $\mathfrak{m}_p^{\text{hol}}$, the germs of holomorphic functions at p which vanish at p . A generator λ^{-1} of $\mathfrak{m}_p^{\text{hol}}$ gives then an holomorphic local coordinate. As above, this defines an injective local homomorphism of \mathbb{C} -algebras $l: \mathcal{O}_{X,p}^{\text{hol}} \rightarrow \mathbb{C}[[\lambda^{-1}]]$. (The image is $\mathbb{C}\{\lambda^{-1}\}$, the formal power series in λ^{-1} which converge in some neighborhood of ∞ .) Of course any algebraic local coordinate is also holomorphic. For both kinds of local coordinates we have by definition $l(1) = 1$. We will denote the image $l(\mathcal{O}_{X,p})$ by A_p , when l is either algebraic or holomorphic.

From now on we will fix an holomorphic local coordinate λ^{-1} (which might happen to be algebraic).

A local coordinate induces an injection:

$$l: K_X \hookrightarrow L_\lambda = \mathbb{C}[[\lambda]] \oplus \lambda^{-1}\mathbb{C}\{\lambda^{-1}\}. \tag{2.1.1}$$

Here K_X is the function field of X , i.e., the quotient field of the integral domain $\mathcal{O}_{X,p}$, and L_λ is the field of Laurent series (in λ^{-1}), the quotient field of the ring of convergent power series (in λ^{-1}). We will in the sequel not distinguish between K_X and its image in L_λ .

For any point q on X the local ring $\mathcal{O}_{X,q}$ is a subring of K_X , so the map (2.1.1) gives a map $\mathcal{O}_{X,q} \hookrightarrow K_X \hookrightarrow L_\lambda$. Let us denote by $A_q = l(\mathcal{O}_{X,q})$ the image in L_λ . Define

$$H^0(X, \mathcal{O}_X(*p)) = \bigcup_{k=0}^{\infty} H^0(X, \mathcal{O}_X(kp)). \tag{2.1.2}$$

Then $H^0(X, \mathcal{O}_X(*p))$ is the subring of K_X consisting of the meromorphic functions on X with only possible pole (of finite order) at p . $H^0(X, \mathcal{O}_X(*p))$ is the (algebraic) coordinate ring of the affine curve $X - p$, in particular $H^0(X, \mathcal{O}_X(*p))$ is a Dedekind domain. Since $H^0(X, \mathcal{O}_X(*p))$ is the intersection of the local rings $\mathcal{O}_{X,q}$, $q \neq p$ we get an inclusion $H^0(X, \mathcal{O}_X(*p)) \hookrightarrow L_\lambda$. We will denote the image by A_X , i.e.,

$$A_X = \bigcap_{q \neq p} A_q = l(H^0(X, \mathcal{O}_X(*p))). \tag{2.1.3}$$

Remark. The local ring $\mathcal{O}_{X,p}$ has the formal completion $\widehat{\mathcal{O}}_{X,p}$; this is a local ring with maximal ideal $\widehat{\mathfrak{m}}_p$. A *formal local coordinate* at p is given by $\widehat{l}^{-1}(\lambda^{-1})$, where \widehat{l} is any isomorphism of local \mathbb{C} -algebras $\widehat{l}: \widehat{\mathcal{O}}_{X,p} \xrightarrow{\sim} \mathbb{C}[[\lambda^{-1}]]$; in particular the maximal ideal $\widehat{\mathfrak{m}}_p$ maps isomorphically to the ideal generated by λ^{-1} . We will denote the formal local coordinate simply by λ^{-1} . Using this we can inject the function field K_X in $F_\lambda = \mathbb{C}[\lambda] \oplus \lambda^{-1}\mathbb{C}[[\lambda^{-1}]]$, the field of formal Laurent series. The field L_λ is a subfield of F_λ and this gives also A_X as a subring of F_λ .

2.2. *Examples.* If X has genus 0, we take λ to be the usual affine coordinate on \mathbb{P}^1 , and p the point at infinity. Then λ^{-1} is an algebraic coordinate at ∞ and A_X is the polynomial ring $\mathbb{C}[\lambda] \subset L_\lambda$.

If X has genus 1, i.e., X is an elliptic curve, we use the Weierstrass \wp -function: for z a local holomorphic coordinate around p there is a unique meromorphic function $\wp(z)$ on X which is holomorphic outside p and has polar part $1/z^2$ at p . Then, identifying $\wp(z)$ with its Laurent series in $L_{z^{-1}}$,

$$A_X = \mathbb{C} \oplus \mathbb{C}\wp(z) \oplus \mathbb{C}\wp'(z) \oplus \mathbb{C}\wp(z)^2 \oplus \dots \subset L_{z^{-1}}. \tag{2.2.1}$$

If one prefers, one can introduce a new holomorphic local coordinate $\lambda^{-1} := \wp(z)^{-1/2}$ around p . Then, using the differential equation relating the Weierstrass \wp -function and its derivative:

$$\wp'(z)^2 = 4\wp(z)^3 - g_2\wp(z) - g_3, \tag{2.2.2}$$

we get, defining $\mu := \lambda^3(4 - g_2\lambda^{-4} - g_3\lambda^{-6})^{1/2}$, for the coordinate ring

$$A_X = \mathbb{C}[\lambda^2, \mu] \subset L_\lambda. \tag{2.2.3}$$

The inclusion $\mathbb{C}[\lambda^2] \subset A_X$ induces a very simple covering map $X \rightarrow \mathbb{P}^1$, showing that it is in general natural to choose a local coordinate λ^{-1} such that a power of λ has no poles outside p . We will see similar choices of local coordinates in Sect. 5. Note that here we might have started with z being a local algebraic coordinate, but that if one wants A_X to have the form (2.2.3) one ends up with λ^{-1} being not algebraic, but holomorphic.

2.3. Now let \mathcal{E} be the sheaf of algebraic sections of a rank n algebraic vector bundle E over X . We want to discuss trivializations of \mathcal{E} at p . As with local coordinates this depends on whether we are working in the algebraic, holomorphic, or formal category. Recall that the stalk \mathcal{E}_p is a free $\mathcal{O}_{X,p}$ -module of rank n , and so is isomorphic to $(\mathcal{O}_{X,p})^n$, the direct sum of n copies of the stalk at p of the structure sheaf. An *algebraic trivialization* of \mathcal{E} at p is a choice of isomorphism $i: \mathcal{E}_p \xrightarrow{\sim} (\mathcal{O}_{X,p})^n$. If λ^{-1} is a local holomorphic coordinate, inducing the injection $l: \mathcal{O}_{X,p} \rightarrow \mathbb{C}\{\lambda^{-1}\}$, we continue to call the composition

$$t = l \circ i: \mathcal{E}_p \xrightarrow{\sim} (\mathcal{O}_{X,p})^n \rightarrow (\mathbb{C}\{\lambda^{-1}\})^n, \tag{2.3.1}$$

an algebraic trivialization, where l acts componentwise.

Letting \mathcal{E}^{hol} denote the sheaf of germs of holomorphic sections of E , we note that the stalk at p , $\mathcal{E}_p^{\text{hol}}$, is simply given by $\mathcal{O}_{X,p}^{\text{hol}} \otimes \mathcal{E}_p$ and that this is a free $\mathcal{O}_{X,p}^{\text{hol}}$ module of rank n . An *holomorphic trivialization* is a choice of isomorphism $i: \mathcal{E}_p^{\text{hol}} \xrightarrow{\sim} (\mathcal{O}_{X,p}^{\text{hol}})^n$. Again, if λ^{-1} is a local holomorphic coordinate, giving the isomorphism $l: (\mathcal{O}_{X,p}^{\text{hol}})^n \rightarrow (\mathbb{C}\{\lambda^{-1}\})^n$, we continue to call the composition $t = l \circ i$ an holomorphic trivialization.

Note that the basis picked out by the choice of the isomorphism i corresponds under the trivialization t to the standard basis $\{e_i\}_{i=0}^{n-1}$ of $(\mathbb{C}\{\lambda^{-1}\})^n$, since $l(1) = 1$, e_i being the column vector with a 1 on the i^{th} place as its only non-zero entry. (We have the, maybe deplorable, convention of indexing n -component vectors, matrices etc. by the integers $0, 1, \dots, n - 1$.)

We will call two pairs (\mathcal{E}, t) and (\mathcal{E}', t') *isomorphic* (notation: $(\mathcal{E}, t) \sim (\mathcal{E}', t')$) if there exists an isomorphism of $\mathcal{O}_X^{\text{hol}}$ -modules $\phi: \mathcal{E}^{\text{hol}} \rightarrow \mathcal{E}'^{\text{hol}}$ such that the induced map $t' \circ \phi \circ t^{-1}: (\mathbb{C}\{\lambda^{-1}\})^n \rightarrow (\mathbb{C}\{\lambda^{-1}\})^n$ is the identity. In other words ϕ gives an isomorphism of the holomorphic vector bundles E^{hol} and E'^{hol} and maps one trivialization at p to the other. We will denote the isomorphism class containing (\mathcal{E}, t) by $[\mathcal{E}, t]$. We remark here that by the GAGA principle [Ser] ϕ actually comes from an isomorphism of the algebraic sheaves \mathcal{E} and \mathcal{E}' .

Definition 2.3.1. *The set of equivalence classes $[\mathcal{E}, t]$, where t is an holomorphic trivialization at p , is the Grassmannian, Gr_X^n ; the algebraic Grassmannian, $Gr_X^{n, \text{alg}}$, is then the set of equivalence classes $[\mathcal{E}, t]$, where t is an algebraic trivialization.*

Note that our Grassmannians depend also on the choices of the point p and of the local coordinate λ^{-1} , although, for simplicity's sake, we suppress this from the notation.

Remark. We can of course also define a formal Grassmannian $Gr_X^{n, \text{form}}$ by taking equivalence classes of pairs (\mathcal{E}, t) , where t is now a *formal trivialization*. To define formal trivializations introduce the *formal stalk*, $\hat{\mathcal{E}}_p$ of the bundle E at p by $\hat{\mathcal{E}}_p = \hat{\mathcal{O}}_{X,p} \otimes \mathcal{E}_p$. This is a free module of rank n over $\hat{\mathcal{O}}_{X,p}$ and a choice of isomorphism $i: \hat{\mathcal{E}}_p \xrightarrow{\sim} (\hat{\mathcal{O}}_{X,p})^n$ defines a formal trivialization $t = \hat{l} \circ i$, where $\hat{l}: (\hat{\mathcal{O}}_{X,p})^n \rightarrow (\mathbb{C}[[\lambda^{-1}]])^n$ is given by the formal local coordinate.

2.4. In this subsection we describe Gr_X^n as a collection of subspaces of the space of n -component Laurent series L_X^n . We first recall the X -lattice approach to vector bundles (cf. [H]). Let V be an n dimensional vector space over the function field K_X of X and let a family $\{M_q \subset V\}_{q \in X}$ be given where M_q is a free rank n module over the local ring $\mathcal{O}_{X,q}$. Assume furthermore that for almost all $q \in X$, for some fixed basis ε_i of V , $M_q = \bigoplus \mathcal{O}_{X,q} \varepsilon_i$. Then the family $\{M_q\}$ is (essentially) what is called an X -lattice in [H]. Their study leads to the adèlic description of the moduli space of vector bundles over X , cf. also [AtB].

Let $\mathcal{E}_0 = K_X \otimes_{\mathcal{O}_X} \mathcal{E}$ be the space of meromorphic sections of our rank n vector bundle E . This is an n dimensional vector space over K_X and there is for every q in X an injection $i_q: \mathcal{E}_q \rightarrow \mathcal{E}_0$ from the stalk at q to the “generic stalk” \mathcal{E}_0 . The image of i_q will be still denoted by \mathcal{E}_q . Then the collection $\{\mathcal{E}_q\}$ in \mathcal{E}_0 is an X -lattice. Conversely every X -lattice $\{M_q\}$ determines a locally free sheaf \mathcal{E} by defining $\mathcal{E}(U) = \bigcap_{q \in U} M_q$ for all open U in X . Isomorphic locally free sheaves $\mathcal{E}, \mathcal{E}'$ give rise to equivalent X -lattices, i.e., families $\{\mathcal{E}_q\}, \{\mathcal{E}'_q\}$ with $\mathcal{E}_q = \gamma \mathcal{E}'_q$ for $\gamma \in Gl(n, K_X)$, and vice versa.

Now return to the situation where we fix an holomorphic trivialization t of \mathcal{E} at p . We can identify the space of meromorphic sections of \mathcal{E} with $K_X \otimes \mathcal{E}_p$. Any element e of \mathcal{E}_q extends to a meromorphic section of E , so determines, by taking the germ at p , an element $i_q(e)$ of $K_X \otimes \mathcal{E}_p$. The holomorphic trivialization t induces (using also (2.1.1)) an homomorphism:

$$t: K_X \otimes \mathcal{E}_p \rightarrow L_X^n. \tag{2.4.1}$$

We will still denote by \mathcal{E}_q the image in $L_\lambda^n \equiv (L_\lambda)^n$. In this way we obtain an X -lattice $\{\mathcal{E}_q\}$ in $t(K_X \otimes \mathcal{E}_p)$ inside L_λ .

Lemma 2.4.1. *Isomorphic pairs (\mathcal{E}, t) give identical families $\{\mathcal{E}_q\}$ in L_λ^n .*

Proof. Assume $(\mathcal{E}, t) \sim (\mathcal{E}', t')$ and let ϕ denote the isomorphism. Then ϕ gives isomorphisms $\phi_q: \mathcal{E}_q \rightarrow \mathcal{E}'_q$ and $\phi_p: \mathcal{E}_p \rightarrow \mathcal{E}'_p$ and we know that $t = t' \circ \phi_p$. Let i_q denote the map $\mathcal{E}_q \rightarrow K_X \otimes \mathcal{E}_p$ and i'_q the corresponding map on \mathcal{E}'_q . Then the following diagram commutes:

$$\begin{array}{ccccc} \mathcal{E}_q & \xrightarrow{i_q} & K_X \otimes \mathcal{E}_p & \xrightarrow{t} & L_\lambda \\ \phi_q \downarrow & & \phi_p \downarrow & & \parallel \\ \mathcal{E}'_q & \xrightarrow{i'_q} & K_X \otimes \mathcal{E}'_p & \xrightarrow{t'} & L_\lambda \end{array} \quad (2.4.2)$$

Since we wished to show that $t \circ i_q = t' \circ i'_q \circ \phi_q$, this proves the Lemma. ■

The vector bundle analogue of (2.1.2) is the following:

$$H^0(X, \mathcal{E}(*p)) := \bigcup_{k \geq 0} H^0(X, \mathcal{E}(kp)) \quad (2.4.3)$$

This is the space of meromorphic sections of E with possible poles at p , and it is the intersection (in $K_X \otimes \mathcal{E}_p$) of the $\mathcal{E}_q, q \neq p$. So, using the trivialization as described above, we get a subspace in L_λ^n :

$$W = W(\mathcal{E}, t) = \bigcap_{p \neq q} \mathcal{E}_q \subset L_\lambda^n, \quad (2.4.4)$$

which depends only on the isomorphism class $[\mathcal{E}, t]$, by the commutative diagram 2.4.2. This is a finitely generated projective module of rank n over A_X , the coordinate ring of $X - p$. In general this module is not free, however it has the following property: the K_X -vector space $V = K_X \otimes_{A_X} W = t(K_X \otimes \mathcal{E}_p) \subset L_\lambda^n$ has a basis $\{e_i = \gamma e_i\}$ with $\gamma \in Gl(n, \mathbb{C}\{\lambda^{-1}\})$. Indeed any (algebraic) basis of \mathcal{E}_p gives a basis of V and will be related to the trivializing basis of the holomorphic stalk, $\{e_i\}$, by an element of $Gl(n, \mathbb{C}\{\lambda^{-1}\})$. The W 's arising from algebraic trivializations are then characterized by the fact that $V = K_X \otimes_{A_X} W$ has a basis related to $\{e_i\}$ by an element of $Gl(n, A_p)$, so that in this case we could take in fact $\{e_i\}$ as basis for V .

Conversely, let W be a finitely generated projective A_X -module of rank n in L_λ^n such that $V = K_X \otimes_{A_X} W$ has some basis $\{e_i\}$ related to the standard basis by an element of $Gl(n, \mathbb{C}\{\lambda^{-1}\})$. Then we have for each $q \in X_p$ an $A_q = \mathcal{O}_{X,q}$ -module $\mathcal{E}_q = A_q \otimes W$ of rank n , which is free because W is projective. Automatically the \mathcal{E}_q are of the form $\bigoplus A_q e_i$ for almost all $q \in X - p$. Indeed any basis $\{\bar{e}_i\}$ of $\mathcal{E}_{\bar{q}}$ for some $\bar{q} \in X - p$ will be a basis also for almost all \mathcal{E}_q and $\{\bar{e}_i\}$ is related to $\{e_i\}$ by an element of $Gl(n, K_X)$. To complete the collection $\{\mathcal{E}_q\}_{q \in X - p}$ to an X -lattice in V (in order to obtain a locally free sheaf) we just have to specify \mathcal{E}_p . Any free A_p module in V will do, so we can take $\mathcal{E}_p = \bigoplus A_p e_i$. Any other choice of basis $\{e'_i\}$ of V , with $e'_i = \gamma' e_i, \gamma' \in Gl(n, \mathbb{C}\{\lambda^{-1}\})$, will be related by an element of $Gl(n, K_X) \cap Gl(n, \mathbb{C}\{\lambda^{-1}\}) = Gl(n, A_p)$ to $\{e_i\}$. This does not change \mathcal{E}_p and so gives the same X -lattice and the same locally free sheaf \mathcal{E} . This sheaf has a distinguished trivialization $t_i = \gamma^{-1} e_i = \gamma'^{-1} e'_i$. Note that the construction depends on the choice of basis $\{e_i\}$ in L_λ^n and that we are free to perform $Gl(n, K_X)$ transformations on it. Taking this into account we find that we have proven

Proposition 2.4.2. Gr_X^n is in one to one correspondence with the collection of rank n projective A_X -modules W in L_λ^n such that $V = K_X \otimes_{A_X} W$ has a basis $\{\varepsilon_i = ge_i\}$, where the g belongs to $Gl(n, \mathbb{C}\{\lambda^{-1}\})$.

The algebraic Grassmannian is distinguished by the fact that the standard basis $\{e_i\}$ gives a basis for V , or in other words that the element g connecting the standard basis $\{e_i\}$ and $\{\varepsilon_i\}$ belongs to the subgroup $Gl(n, A_p)$.

Remark. The formal Grassmannian is similarly equivalent to the finitely generated rank n projective A_X -modules W in F_λ^n , such that $V = K_X \otimes_{A_X} W$ has a basis $\{\varepsilon_i = ge_i, g \in Gl(n, \llbracket \lambda^{-1} \rrbracket)\}$ that is also a basis for almost all localizations.

2.5. Let us consider the special case where $X = \mathbf{P}^1$ and λ^{-1} is the standard algebraic coordinates at ∞ . Then A_X is the principal ideal domain $\mathbb{C}[\lambda]$ and all locally free A_X modules $W \subset L_\lambda$ coming from an element of $Gr_{\mathbf{P}^1}^n$ are in this case free as A_X -modules. Geometrically this reflects the fact that all algebraic vector bundles over $\mathbf{P}^1 - \infty$ are algebraically trivializable. So we have a basis $\{w_i\}$ for W which gives, by juxtaposition, an element g of $Gl(n, L_\lambda)$, i.e., the columns of g are the w_i 's. (We can think of $Gl(n, L_\lambda)$ as the group of real analytic maps from an infinitesimal circle around p with only possibly a finite order pole at p in the interior of the circle.) This shows that for $X = \mathbf{P}^1$ the elements of the Grassmannian lie on the orbit of $Gl(n, L_\lambda)$ through the distinguished subspace

$$H_X^{(n, \text{alg})} = \bigoplus_{i=0}^{n-1} A_X e_i \subset L_\lambda^n, \tag{2.5.1}$$

corresponding to the trivial bundle $\mathcal{O}_{\mathbf{P}^1}^n$ with its natural trivialization at ∞ , since $W = gH_X^{(n, \text{alg})}$.

Conversely for any Riemann surface an element of the $Gl(n, L_\lambda)$ orbit through $H_X^{(n, \text{alg})}$ lies in the Grassmannian Gr_X^n . This follows from the following proposition:

Proposition 2.5.1. Let $g \in Gl(n, L_\lambda)$, then

$$g = g_K g_-, \quad \text{with } g_K \in Gl(n, K_X), \quad g_- \in Gl(n, \mathbb{C}\{\lambda^{-1}\}). \tag{2.5.2}$$

Proof. Let σ^{-1} be an algebraic local coordinate at p . Then there is a unique isomorphism $\phi: L_\lambda \rightarrow L_\sigma$ that restricts to an isomorphism $\mathbb{C}\{\lambda^{-1}\} \rightarrow \mathbb{C}\{\sigma^{-1}\}$. We extend ϕ by componentwise action to matrices. Then by the Birkhoff factorization (cf. [PrS, Theorem 8.2.1]) we have for $\tilde{g} = \phi(g)$ a decomposition $\tilde{g} = \tilde{g}_+ \cdot D \cdot \tilde{g}_-$, with \tilde{g}_+ polynomial in σ , $D = \text{diag}(\sigma^{a_1}, \sigma^{a_2}, \dots, \sigma^{a_n})$, $a_i \in \mathbb{Z}$ and $\tilde{g}_- \in Gl(n, \mathbb{C}\{\sigma^{-1}\})$. Then, clearly, $\tilde{g}_+ \cdot D \in Gl(n, K_X)$ and applying ϕ^{-1} proves the proposition. ■

So if $g \in Gl(n, L_\lambda)$ then $W = gH_X^{(n, \text{alg})} = \bigoplus_{i=0}^{n-1} A_X g e_i = \bigoplus_{i=0}^{n-1} A_X g_K e_i$, with $\{\varepsilon_i = g_- e_i\}$. Then $V = K_X \otimes W$ has the basis required by Proposition 2.4.2 and the free, rank n , A_X -module W belongs to the Grassmannian. If g_- happens to belong to $Gl(n, A_p)$ we get in this manner an element of the algebraic Grassmannian.

Since this W is free as an A_X module, we see that for general X the orbit of $Gl(n, L_\lambda)$ through the element (2.5.1) will give us the part of the Grassmannian corresponding to bundles \mathcal{E} such that \mathcal{E} is algebraically trivializable over $X - p$. For $X = \mathbf{P}^1$ this gives the whole Grassmannian.

To describe the Grassmannian for an arbitrary curve X as an homogeneous space, we will in the next subsection change the framework to allow the action of

matrices with infinite order poles at p , essentially by tensoring everything in sight by the appropriate ring of holomorphic functions. Another approach would be to use the X -lattices of A_p modules \mathcal{E}_p included in the n -component Laurent series L_λ^n (or in the n -component formal Laurent series F_λ^n in the formal category) briefly mentioned in Sect. 2.4. This would exhibit our Grassmannians as homogeneous spaces of adélic groups, which seems to be more complicated than the holomorphic loop group setting that we are going to use. However if one is interested in these curves in arbitrary characteristic (for instance in the context of string theory, see for example [KaSU]), the adélic setting seems appropriate.

2.6. We have noted in the previous subsection that for $X = \mathbf{P}^1$ an element W of the Grassmannian is free as an A_X -module. This is not the case, of course, for an arbitrary algebraic curve X . However, as is well known, every holomorphic bundle on $X - p$, now thought of as a complex manifold, is trivial, since $X - p$ is a Stein manifold. So we can consider instead of W the tensor product $W^{\text{hol}} := A_X^{\text{hol}} \otimes_{A_X} W$, which is then free of rank n over A_X^{hol} , where A_X^{hol} is the ring of holomorphic functions on $X - p$, usually denoted $\mathcal{O}(X - p)$. If W corresponds to the equivalence class of a pair (\mathcal{E}, t) , then W^{hol} is the space $H^0(X - p, \mathcal{E}^{\text{hol}})$ of holomorphic sections of \mathcal{E}^{hol} over $X - p$. Now A_X^{hol} is not contained in L_λ , since there are in A_X^{hol} functions with essential singularities at p . This leads us to look for a space in which both L_λ and A_X^{hol} are contained. This will also allow us later on to consider “time flows” of points of the Grassmannians with exponential singularities.

Let λ^{-1} be a local holomorphic coordinate at p . We can think of λ^{-1} as an holomorphic function from a neighborhood of $p \in X$ to a neighborhood of the origin in \mathbb{C} and we can consider for small ε the disks D_ε of radius ε around $p \in X$, using the holomorphic local coordinate. Let \dot{D}_ε be this disk with p deleted. Define then (cf. [ADKP]):

$$H = \lim_{\varepsilon \rightarrow 0} \mathcal{O}_X^{\text{hol}}(\dot{D}_\varepsilon), \tag{2.6.1}$$

the space of germs of functions holomorphic in a deleted neighborhood of p . We can think of H as consisting of certain functions with, in general, expansions in λ infinite in both directions, in which case we will write $H = H_\lambda$. In the sequel we will refer to functions (or more generally vectors or matrices) having a finite number of positive powers in λ in their expansions as being *finite order*. For instance the subfield of Laurent series L_λ of the field of formal Laurent series F_λ makes up the finite order elements in H_λ (and hence, in particular K_X is made up of finite order elements). However A_X^{hol} , which contains functions with essential singularities at p , is also included in H_λ , but a general element of F_λ does not belong to H_λ .

The group $Gl(n, H_\lambda)$ acts on $H_\lambda^n = \mathbb{C}^n \otimes_{\mathbb{C}} H_\lambda$. Put

$$H_X^{(n, \text{hol})} = \bigoplus_{i=0}^{n-1} A_X^{\text{hol}} e_i \subset H_\lambda^n. \tag{2.6.2}$$

Consider an element W of the Grassmannian Gr_X^n . Then $W^{\text{hol}} = A_X^{\text{hol}} \otimes W$ is a subspace of H_λ^n .

Lemma 2.6.1. *The map*

$$W \mapsto W^{\text{hol}} = A_X^{\text{hol}} \otimes W \tag{2.6.3}$$

from elements $W \in Gr_X^n$ to subspaces of H_λ^n is injective.

Proof. Let W' be the finite order part of W^{hol} so that we have an exact sequence of A_X -modules:

$$0 \rightarrow W \rightarrow W' \rightarrow W'/W \rightarrow 0. \tag{2.6.4}$$

Since A_X^{hol} is flat over A_X we get, by tensoring, another exact sequence:

$$0 \rightarrow A_X^{\text{hol}} \otimes W \rightarrow A_X^{\text{hol}} \otimes W' \rightarrow A_X^{\text{hol}} \otimes (W'/W) \rightarrow 0. \tag{2.6.5}$$

Now $W^{\text{hol}} = A_X^{\text{hol}} \otimes W' = A_X^{\text{hol}} \otimes W$ so we get $A_X^{\text{hol}} \otimes (W'/W) = 0$. On the other hand we can construct (see 2.4) from W and W' coherent sheaves \mathcal{E} and \mathcal{E}' on X by gluing in the stalk $\mathcal{E}_p = \mathcal{E}'_p = \bigoplus A_p \varepsilon_i$ at p , where ε_i is the basis of $V = W_X \otimes W$ that exists by Proposition 2.4.2. Then \mathcal{E}'/\mathcal{E} is an algebraic coherent sheaf on the projective curve X and $\mathcal{O}_X^{\text{hol}} \otimes (\mathcal{E}'/\mathcal{E})$ the corresponding analytic sheaf. But by the sequence 2.6.5 and because $\mathcal{E}_p = \mathcal{E}'_p$ we see that in fact $\mathcal{O}_X^{\text{hol}} \otimes (\mathcal{E}'/\mathcal{E}) = 0$, so, by GAGA, also $\mathcal{E}'/\mathcal{E} = 0$ and hence $W = W'$. So the finite order part of W^{hol} is W and W^{hol} determines W uniquely. ■

As we said before W^{hol} is free of rank n over A_X^{hol} , so we have a basis $\{w_i\}_{i=1}^n$ of W^{hol} . Then $W^{\text{hol}} = gH_X^{(n, \text{hol})}$, for $g \in Gl(n, H_\lambda)$ given by the juxtaposition of the basis $\{w_i\}_{i=1}^n$. The stabilizer of $H_X^{(n, \text{hol})}$ in $Gl(n, H_\lambda)$ is the subgroup $Gl(n, A_X^{\text{hol}})$ so we find that the (holomorphic) Grassmannian is contained in the homogeneous space:

$$Gl(n, H_\lambda)/Gl(n, A_X^{\text{hol}}). \tag{2.6.6}$$

In fact,

Proposition 2.6.2.

$$Gr_X^n = Gl(n, H_\lambda)/Gl(n, A_X^{\text{hol}}).$$

Proof. It remains to show that if $\tilde{W} = gH_X^{(n, \text{hol})}$, for $g \in Gl(n, H_\lambda)$, then $\tilde{W} = W^{\text{hol}}$ for some W in Gr_X^n . Since g gives an holomorphic matrix valued function on a deleted neighborhood \tilde{D}_ε of p it gives a transition function from D_ε to $X - p$, and thus an holomorphic vector bundle on X with trivializations on D_ε and $X - p$. The sections of this bundle over $X - p$ in the trivialization over D_ε give back \tilde{W} . By the GAGA principle, every holomorphic vector bundle on X is indeed algebraic and thus $\tilde{W} = W^{\text{hol}}$ for this algebraic bundle with holomorphic trivialization at p . ■

Remark. We have seen in Sect. 2.5 that $W \in Gr_X^n$ is free iff $W = gH_X^{(n, \text{alg})}$ for some $g \in Gl(n, L_\lambda)$. So in this case we also have $W^{\text{hol}} = gH_X^{(n, \text{hol})}$ for the same g . The converse is also true: if $W^{\text{hol}} = gH_X^{(n, \text{hol})}$ for a finite order g then W is free, as easily follows from Lemma 2.6.1.

If $\{w_i\}_{i=1}^n$ is a set of linearly independent elements of W (over A_X) then the images of these elements in $W^{\text{hol}} = A_X^{\text{hol}} \otimes W$ are independent over A_X^{hol} . However, since A_X^{hol} is not a field, they may not span. If one takes the element $g \in Gl(n, L_\lambda)$ obtained by juxtaposition of the vectors w_i then the vector bundle $\tilde{\mathcal{E}}$ obtained by this transition matrix will be algebraically trivialisable over $X - p$. Its algebraic sections over $X - p$ will be given by $gH_X^{(n, \text{alg})}$ which is in general just a subset of the finite order part W of W^{hol} : there will be elements of W not obtainable by A_X -linear combinations of the finite order set $w_i = g \cdot e_i$, except in case that the w_i form a basis for W over A_X to begin with. So the algebraic and holomorphic bundles $\tilde{\mathcal{E}}, \tilde{\mathcal{E}}^{\text{hol}}$ are just subbundles of \mathcal{E} and \mathcal{E}^{hol} , in general.

2.7. Any Riemann surface X admits a covering map $f: X \rightarrow \mathbf{P}^1$ of degree k , for all sufficiently large k , so in a sense all Grassmannians Gr_X^n based on X are included in

the Grassmannian $Gr_{\mathbf{P}^1}^{nk}$ (in many different ways). More concretely, if we choose for instance, as in Sect. 2.2, the local coordinate λ on X at p in such a way that $A_X = \mathbb{C} \oplus \mathbb{C}\lambda^k \oplus \dots$ we can define $z = \lambda^k$ and think of z as the standard algebraic coordinate on \mathbf{P}^1 . Then A_X is free over $\mathbb{C}[z]$ of rank k and hence $W \in Gr_X^n$ is free of rank nk over $\mathbb{C}[z]$. We can identify in an obvious way L_λ^n with L_z^{kn} (see Sect. 4.2) and using this we see that W is an element of $Gr_{\mathbf{P}^1}^{nk}$ corresponding to the class $[f_*\mathcal{E}, f_*t]$, if W corresponds to the bundle \mathcal{E} . Here f_*t is the trivialization of the push forward bundle $f_*\mathcal{E}$ determined by the basis $\{z^j t^{-1}(e_i)\}_{i,j=0}^{i=n-1, j=k-1}$ of the $\hat{\mathcal{O}}_{\mathbf{P}^1, \infty}$ module $(f_*\mathcal{E})_\infty$; this will be explained in more detail in Sect. 5.

One can also map Gr_X^n into an universal Grassmannian Gr of subspaces W of H_z (see 2.6) that have a Fredholm projection $W \rightarrow H_{z,+}$, where $H_{z,+}$ is the subspace of H_z consisting of holomorphic functions on $\mathbf{P}^1 - \infty$ (here we think of z as a coordinate on \mathbf{P}^1). (This is the definition in [ADKP], see also [SeW, PrS].) This works as follows. First note that $A_X \subset L_\lambda$ has a projection to $\mathbb{C}[\lambda]$ with zero kernel and cokernel of dimension g . Then $H_X^{(n, \text{alg})}$, and thus also $H_X^{(n, \text{hol})} = A_X^{\text{hol}} \otimes H_X^{(n, \text{alg})}$, has a projection to $\mathbb{C}[\lambda]$ (respectively $H_{\lambda,+}^n$) with zero kernel and cokernel of dimension ng . Finally, we use the isomorphism $H_\lambda^n \rightarrow H_z$ given by $\lambda^k e_i \mapsto z^{nk+i}$ to get a subspace $W(X, n) \subset H_z$ which belongs to Gr . Now, Gr is an homogeneous space of the group A_∞ consisting of invertible operators on H_z whose diagonal blocks with respect to the decomposition $H_z = H_{z,+} \oplus H_{z,-}$ are Fredholm; here $H_{z,-}$ is the ring of convergent power series in z^{-1} . The action of $Gl(n, H_\lambda)$ on H_λ^n then translates to an action of a subgroup $\tilde{Gl}(n, H_\lambda)$ of A_∞ on H_z . Thus we see that $Gr_X^n = Gl(n, H_\lambda)H_\lambda^{n, \text{hol}}$ corresponds to the orbit $\tilde{Gl}(n, H_\lambda)W(X, n)$ contained in the universal Grassmannian Gr . In fact the points of Gr_X^n considered in Gr are characterized by the fact that they are stable under the action of the image of A_X^{hol} thought of as a subring of H_z using the map $\lambda \mapsto z^n$ (cf. [PrS]). (Note that for every n we get a different subring in H_z isomorphic to A_X^{hol} .) The fact that $W(X, n)$ belongs to Gr implies that there exists an infinite matrix $\gamma(X, n) \in A_\infty$ such that

$$W(X, n) = \gamma(X, n)H_{z,+}.$$

In general $\gamma(X, n)$ however will not belong to the image of the loop group in the group of infinite matrices.

3. The Cotangent Bundle to the Grassmannian

3.1. In this section we study the cotangent bundle to the Grassmannian Gr_X^n of vector bundles on X and we will show that the fiber of the cotangent bundle at a point W contains as a finite codimensional subspace the *stabilizer algebra* S_W^{hol} of W^{hol} : the linear transformations of H^n that map W^{hol} onto itself. In the sequel, commutative subalgebras of the finite order part of S_W^{hol} will be used to construct covering spaces for X .

3.2. We recall here some well known facts about symplectic reduction for homogeneous spaces, see for more details e.g., Guillemin, Sternberg [GS1]. Let G be a Lie group, \mathfrak{g} its Lie algebra and denote by L_g, R_g the action of $g \in G$ on G from the left and the right respectively. These actions lift to symplectic actions on the cotangent bundle T^*G with moment maps $J_L, J_R: T^*G \rightarrow \mathfrak{g}^*$ given by $J_L(\mu_g) = R_g^* \mu_g, J_R(\mu_g) = -L_g^* \mu_g$ for all $\mu_g \in T_g^*G$. We trivialize T^*G by *right identification*: $\mu_g \in T_g^*G$ is identified with the pair $(g, \mu) \in G \times \mathfrak{g}^*$, such that

$\langle \mu, X \rangle = \langle \mu_g, R_{g*} X \rangle$, $X \in \mathfrak{g}$. Then in these coordinates

$$\begin{array}{ccc} \mathfrak{g}^* & \xleftarrow{J_L} G \times \mathfrak{g}^* & \xrightarrow{J_R} \mathfrak{g}^* \\ \mu & \longleftarrow (g, \mu) & \longrightarrow -\text{Ad}_{g^{-1}}^*(\mu) \end{array}$$

where Ad_g^* denotes the coadjoint action of g on \mathfrak{g}^* , i.e., Ad_g^* is the dual map to Ad_g .

Now let K be a Lie subgroup of G and \mathfrak{k} the corresponding subalgebra of \mathfrak{g} . The right action of G on T^*G restricts to a right action of K with moment map $J_{R,K}: T^*G \rightarrow \mathfrak{k}^*$. In fact $J_{R,K} = \pi_{\mathfrak{k}^*} \circ J_R$, where $\pi_{\mathfrak{k}^*}$ is the restriction of linear forms on \mathfrak{g} to \mathfrak{k} .

Now consider the Marsden–Weinstein reduction $J_{R,K}^{-1}(0)/K$ at $0 \in \mathfrak{k}^*$ of T^*G under the K -action. The inverse image of zero under $\pi_{\mathfrak{k}^*}$ is isomorphic to $(\mathfrak{g}/\mathfrak{k})^*$. Let us choose a complement of \mathfrak{k} in \mathfrak{g} : $\mathfrak{g} = \mathfrak{Q} \oplus \mathfrak{k}$. Here \mathfrak{Q} is just a vector subspace, not in general a subalgebra. Then $(\mathfrak{g}/\mathfrak{k})^* \simeq \mathfrak{Q}^*$ and

$$J_{R,K}^{-1}(0) = \{(g, \mu) \in G \times \mathfrak{g}^* \mid \text{Ad}_{g^{-1}}^*(\mu) \in \mathfrak{Q}^*\}.$$

Now the right action of K on T^*G in the right trivialization is just $(g, \mu) \mapsto (gk, \mu)$, hence the Marsden–Weinstein reduction of T^*G by this action in this trivialization is a bundle over the quotient G/K , with fiber at the point gK given by the space $\text{Ad}_g^*(\mathfrak{Q}^*)$. If we choose on \mathfrak{g} an Ad -invariant nondegenerate bilinear form $\langle \cdot, \cdot \rangle: \mathfrak{g} \times \mathfrak{g} \rightarrow \mathbb{C}$ we can identify \mathfrak{g}^* with \mathfrak{g} and under this identification \mathfrak{Q}^* gets identified with the perpendicular $\mathfrak{k}^\perp = \{x \in \mathfrak{g} \mid \langle x, y \rangle = 0, \forall y \in \mathfrak{k}\}$. The fiber over gK can then finally be identified with $\text{Ad}_g(\mathfrak{k}^\perp)$.

Summing up: the cotangent bundle to G/K can be identified, given the choice of bilinear form, with pairs (gK, s) , with $s \in \text{Ad}_g(\mathfrak{k}^\perp)$.

We remark here that in the infinite dimensional situation one must take care about what is meant by the cotangent bundle. If one is not working in the Hilbert space setting then it is usually not the case that a nondegenerate bilinear form gives an identification of \mathfrak{g} with \mathfrak{g}^* , but if the form is continuous then it does give a map $\mathfrak{g} \rightarrow \mathfrak{g}^*$. In the case that \mathfrak{g} is split into $\mathfrak{k} \oplus \mathfrak{Q}$ then \mathfrak{k}^\perp gives in general only a subspace of \mathfrak{Q}^* and thus the above formulation gives only a subspace of the fiber of the cotangent bundle. We ignore this subtlety in this paper.

3.3. We now apply this to our situation: the holomorphic Grassmannian, which is according to Sect. 2.6 a homogeneous space for the loop group $Gl(n, H_\lambda)$ with stabilizer at the origin $Gl(n, A_X^{\text{hol}})$. Since elements of these groups may be considered as holomorphic maps into $Gl(n, \mathbb{C})$, we may differentiate pointwise to get the Lie algebras $\mathfrak{g} = gl(n, H_\lambda)$ and $\mathfrak{k} = gl(n, A_X^{\text{hol}})$. We will identify a complementary subspace for $gl(n, A_X^{\text{hol}})$ in the Lie algebra $gl(n, H_\lambda)$ and an invariant bilinear form such that with respect to this form $(gl(n, A_X^{\text{hol}}))^\perp$ is easily identified. To this end we first study a bilinear form on the space H_λ of germs of holomorphic functions in a deleted neighborhood of p .

First recall some basic facts about complex valued harmonic functions of one complex variable. Recall that a smooth function h is harmonic if $\partial\bar{\partial}h = 0$. If h is harmonic on a disc, D , then h may be written $h = h_+ + h_-$, where h_+ is holomorphic and h_- is antiholomorphic on D . This fact easily follows by noting that ∂h is a closed holomorphic one form. On a punctured disc, \dot{D} , it similarly follows that h may be written in the form $h = h_+ + h_-$ (on D) if and only if $\oint_{\partial D} \partial h = 0$ (otherwise there is a $\log z\bar{z}$ term).

We will be interested in global harmonic functions on $X - p$, the set of which we denote by $\text{Har}(X - p)$. A basic fact we need is that given any positive integer k , one can construct an harmonic function h_k on $X - p$ such that $(h_k) - \lambda^k$ is regular at p . Furthermore h_k is unique up to a constant. The uniqueness follows easily from the fact that the only global harmonic functions on X are constants. Existence comes from looking at the long exact sequence of

$$0 \rightarrow \text{Har} \rightarrow \text{Har}(np) \rightarrow \mathcal{O}(np)/\mathcal{O} \rightarrow 0,$$

where Har denotes the sheaf of harmonic functions which are regular at p , $\text{Har}(np)$ is the sheaf of harmonic functions whose behaviour at p is at worst λ^n , and $\mathcal{O}(np)/\mathcal{O}$ is the skyscraper sheaf of principal parts of meromorphic functions with poles at p of order at most n . In the long exact sequence one must see that $H^1(\text{Har}) \simeq H^1(\text{Har}(np)) \simeq \mathbb{C}$ in order to see that $0 \rightarrow H^0(\text{Har}) \rightarrow H^0(\text{Har}(np)) \rightarrow H^0(\mathcal{O}(np)/\mathcal{O}) \rightarrow 0$ is exact. However H^1 of these sheaves is easily computed from the short exact sequence

$$0 \rightarrow \mathcal{O}(np) \rightarrow \text{Har}(np) \xrightarrow{\bar{\delta}} \bar{K} \rightarrow 0,$$

where \bar{K} denotes the sheaf of anti-holomorphic one forms.

Now assume that the genus of X is g and let $\{a_1, a_2, \dots, a_g\}$ be the *gap-values* of $p \in X$, see [GH, p. 273]. For each a_i let h_{a_i} be the harmonic function on $X - p$ with $h_{a_i} - \lambda^{a_i+1}$ regular at p . Considering the h_{a_i} as harmonic functions on \dot{D}_ε , set $d(h_{a_i})_+ = \tilde{h}_i d\lambda$ and let

$$V = \bigoplus_1^g \mathbb{C}(\tilde{h})_+. \tag{3.3.1}$$

Proposition 3.3.1.

$$H_\lambda = A_X^{\text{hol}} \oplus \mathbb{C}\{\lambda^{-1}\}\lambda^{-1} \oplus V. \tag{3.3.2}$$

Proof. The gaps a_i are precisely those integers for which there is no holomorphic function on $X - p$ with pole of order a_i at p , thus the three subspaces are clearly pairwise disjoint. To see that they span H_λ define a sheaf $\mathcal{F} := \mathcal{O}_X^{\text{hol}}(X - p) \oplus \mathcal{O}_X^{\text{hol}}(\dot{D}_\varepsilon)$ on the Riemann surface X (with the complex topology). The stalk of \mathcal{F} at q is isomorphic to $\mathcal{O}_q^{\text{hol}}$ iff $q \notin \dot{D}_\varepsilon$ and to $\mathcal{O}_q^{\text{hol}} \oplus \mathcal{O}_q^{\text{hol}}$ if $q \in \dot{D}_\varepsilon$. Hence we have an exact sequence of sheaves:

$$0 \rightarrow \mathcal{O}_X^{\text{hol}} \rightarrow \mathcal{F} \rightarrow \mathcal{O}_X^{\text{hol}}(\dot{D}_\varepsilon) \rightarrow 0.$$

Here on the level of the stalks the injection of $\mathcal{O}_X^{\text{hol}}$ is given by $f \mapsto (f|_{X-p}, f|_{\dot{D}_\varepsilon})$ and the surjection is given by $(f, g) \mapsto 1/2(f - g)$. In cohomology we get:

$$0 \rightarrow H^0(X, \mathcal{O}_X^{\text{hol}}) \rightarrow H^0(X, \mathcal{F}) \rightarrow H^0(X, \mathcal{O}_X^{\text{hol}}(\dot{D}_\varepsilon)) \rightarrow H^1(X, \mathcal{O}_X^{\text{hol}}) \rightarrow 0, \tag{3.3.3}$$

since all the higher cohomology groups vanish ($X - p$ and \dot{D}_ε are Stein). This gives, after taking the limit $\varepsilon \rightarrow 0$:

$$0 \rightarrow \mathbb{C} \rightarrow A_X^{\text{hol}} \oplus \mathbb{C} \oplus \mathbb{C}\{\lambda^{-1}\}\lambda^{-1} \rightarrow H_\lambda \rightarrow H^1(X, \mathcal{O}_X^{\text{hol}}) \rightarrow 0, \tag{3.3.4}$$

where the injection of constants is given by $c \mapsto (c, c, 0)$. Now $H^1(X, \mathcal{O}_X^{\text{hol}}) \simeq H^1(X, \mathcal{O}_X)$ is g dimensional and one easily checks that V maps injectively to $H^1(X, \mathcal{O}_X)$. ■

There is another description of the gap-values, namely a_i is a gap-value if and only if there is a global holomorphic one-form on X which vanishes at p to precisely the order $a_i - 1$. For each i let ω_i be a global holomorphic one form with leading term $\lambda^{1-a_i}d(\lambda^{-1}) = -\lambda^{-a_i-1}d\lambda$. Locally, on a disc around p , $\omega_i = g_i d\lambda$ where $g_i(\lambda) = -\lambda^{-a_i-1} + \text{lower order}$. Let

$$U = \bigoplus_1^g \mathbb{C}g_i . \tag{3.3.5}$$

Note that although the g_i 's are not uniquely determined, the space U is independent of the choices, furthermore, if we let $\Omega^{1,0}(X)$ denote the holomorphic one-forms on X , U is isomorphic to $\Omega^{1,0}(X)$.

We now define a bilinear form on H_λ by

$$\langle f, g \rangle := \text{Res}_p(fgd\lambda) = \oint fgd\lambda, \quad f, g \in H_\lambda . \tag{3.3.6}$$

Since f and g are just germs of holomorphic functions on a deleted neighborhood of p the integral must be interpreted as occurring on the boundary of a small disc D_ϵ on which representative functions for f and g are defined.

Proposition 3.3.2. *With respect to the pairing (3.3.6) we have*

$$(A_X^{\text{hol}})^\perp = A_X^{\text{hol}} \oplus V \oplus U . \tag{3.3.7}$$

Proof. To see that $A_X^{\text{hol}} \oplus V \oplus U \subset (A_X^{\text{hol}})^\perp$ first take $f \in A_X^{\text{hol}}$ and $g \in A_X^{\text{hol}} \oplus U$. Then $fgd\lambda$ extends to an holomorphic one-form on $X - p$ so it must have zero residue. If instead we take $g \in V$ then $g = h_+$ for some harmonic function on $X - p$ and $gd\lambda = \partial(h_+) = \partial h$. So by Stokes' theorem $\oint fgd\lambda = \oint f\partial h = \int_{X-D_\epsilon} d(fh) = 0$, since $df = 0$ and $d\partial h = \bar{\partial}\partial h = 0$.

Conversely, it is a result of A.H. Read [R] (see also [Ro]) that if ω is a continuous section over ∂D_ϵ of the holomorphic cotangent bundle, and $\oint_{\partial D_\epsilon} f\omega = 0$ for all functions f which are holomorphic on $X - D_\epsilon$ and continuous up to the boundary, then ω extends holomorphically to $X - D_\epsilon$. Using the fact that an holomorphic function on $\overline{X - D_\epsilon}$ can be approximated uniformly by an holomorphic function on $X - p$ (cf. Simha [Si]), and shrinking the neighborhood slightly, it follows that if ω is an holomorphic one-form on a punctured disc about p and $\oint_{\partial D_\epsilon} f\omega = 0$ for all $f \in \mathcal{O}(X - p)$ then ω extends to an holomorphic one-form on $X - p$. Hence, from the assumption that $g \in (A_X^{\text{hol}})^\perp$ we conclude that $gd\lambda$ extends to a global holomorphic one-form ω on $X - p$ satisfying $\oint_{\partial D_\epsilon} \omega = 0$. Now note that $\partial: \text{Har}(X - p) \rightarrow \Omega^{1,0}(X - p)/\Omega^{1,0}(X)$ is onto, and that for $h \in \text{Har}(X - p)$, $\partial h = dh_+$, so we can identify $(A_X^{\text{hol}})^\perp$ with the holomorphic parts of harmonic functions on $X - p$, i.e., $g \in A_X^{\text{hol}} \oplus V \oplus U$. ■

Note that the direct sums in (3.3.7) is the direct sum of vector spaces. We now extend this result to $\text{Mat}_n(H_\lambda)$, the vector space of $n \times n$ matrices with coefficients in H_λ , by defining the bilinear form

$$\langle A(\lambda), B(\lambda) \rangle := \oint \text{tr}(A(\lambda)B(\lambda)d\lambda), \quad A(\lambda), B(\lambda) \in \text{Mat}_n(H_\lambda) . \tag{3.3.8}$$

It follows immediately from the above proposition that

$$\text{Mat}_n(A_X^{\text{hol}})^\perp = \text{Mat}_n(A_X^{\text{hol}} \oplus V \oplus U) , \tag{3.3.9}$$

and thus we may identify the fiber of the cotangent bundle of the holomorphic Grassmannian at the point $W^{\text{hol}} = gH_X^{n, \text{hol}}$ as the space

$$T_W^* Gr_X^n = \text{Ad}_g(\text{Mat}_n(A_X^{\text{hol}} \oplus V \oplus U)). \tag{3.3.10}$$

Let us define

$$S_W^{\text{hol}} = \text{Ad}_g(\text{gl}(n, A_X^{\text{hol}})). \tag{3.3.11}$$

Since, clearly,

$$S_W^{\text{hol}} = \{s \in \text{gl}(n, H_\lambda) \mid sW^{\text{hol}} \subset W^{\text{hol}}\}, \tag{3.3.12}$$

we refer to S_W^{hol} as the *holomorphic stabilizer algebra* of W^{hol} in $\text{gl}(n, H_\lambda)$. Since

$$T_W^* Gr_X^n = S_W^{\text{hol}} \oplus \text{Ad}_g(\text{Mat}_n(V \oplus U)) \tag{3.3.13}$$

we see that the fiber of the cotangent bundle of the Grassmannian at W contains the stabilizer algebra as codimension $2n^2g$ subspace S_W^{hol} , where g is the genus of X . The A_X^{hol} -module S_W^{hol} is just $\text{End}_{A_X^{\text{hol}}}(W^{\text{hol}})$. Similarly we can introduce $S_W^{\text{fin}} = \{s \in \text{gl}(n, L_\lambda) \mid sW \subset W\}$ so that $S_W^{\text{fin}} = \text{End}_{A_X}(W)$. The relation between the two endomorphism rings is given by:

Lemma 3.3.3.

$$S_W^{\text{hol}} \simeq A_X^{\text{hol}} \otimes S_W^{\text{fin}}.$$

Proof. We have an homomorphism

$$\Phi: A_X^{\text{hol}} \otimes \text{End}_{A_X}(W) \rightarrow \text{End}_{A_X^{\text{hol}}}(A_X^{\text{hol}} \otimes W), \tag{3.3.14}$$

so that the tensor product $b \otimes f$, with $b \in A_X^{\text{hol}}, f \in \text{End}_{A_X}(W)$, gets mapped to the endomorphism of W^{hol} that sends $\beta \otimes w$ to $b\beta \otimes f(w)$, where $\beta \in A_X^{\text{hol}}, w \in W$. This homomorphism is easily checked to be injective. Note that, as W^{hol} is free, $\text{End}_{A_X^{\text{hol}}}(W^{\text{hol}}) = \text{gl}(n, A_X^{\text{hol}})$, and that, if W were free, we would have $\text{End}_{A_X}(W) \simeq \text{gl}(n, A_X)$. Since $\text{gl}(n, A_X^{\text{hol}}) = A_X^{\text{hol}} \otimes \text{gl}(n, A_X)$ in this case Φ is an isomorphism. For the general case write the projective A_X -module W as a direct summand, $F = W \oplus W'$, of a free module F and put $F^{\text{hol}} = A_X^{\text{hol}} \otimes F$. Then any element s of $\text{End}_{A_X^{\text{hol}}}(W^{\text{hol}})$ can be extended to an endomorphism of F^{hol} (say by the zero map on the complement of W^{hol}) and hence it can be written as $s = \sum f_i(1 \otimes \tilde{s}_i)$ with $f_i \in A_X^{\text{hol}}$ and $\tilde{s}_i \in \text{End}(F)$. Let $\pi_W: F \rightarrow W$ be the projection on the first summand in the decomposition $F = W \oplus W'$ and define $s_i = \pi_W \circ \tilde{s}_i \circ \pi_W$; this is an element of $\text{End}(W)$. Then, since tensoring with a fixed module is a functor, $1 \otimes s_i = (1 \otimes \pi_W) \circ (1 \otimes \tilde{s}_i) \circ (1 \otimes \pi_W)$. But $1 \otimes \pi_W = \pi_{W^{\text{hol}}}$, so $1 \otimes s_i = \pi_{W^{\text{hol}}} \circ (1 \otimes \tilde{s}_i) \circ \pi_{W^{\text{hol}}}$ and $\sum f_i(1 \otimes s_i) = \pi_W \circ \sum f_i(1 \otimes \tilde{s}_i) \circ \pi_W = \pi_W \circ s \circ \pi_W$. So we get for s , thought of as an endomorphism of W^{hol} , the expression $s = \sum f_i(1 \otimes s_i)$ and Φ is surjective. ■

In case W is free there is a simple expression for the finite order stabilizer algebra. Recall from 2.6 that W is free iff $W^{\text{hol}} = gH_X^{n, \text{hol}}$ for g finite order. Then we have:

Lemma 3.3.4. *If $W = gH_X^{n, \text{hol}}$ with g a finite order element of $Gl(n, H_\lambda)$ then*

$$S_W^{\text{fin}} = \text{Ad}_g(\text{gl}(n, A_X)).$$

Proof. The holomorphic stabilizer algebra of $H_X^{n, \text{hol}}$ is of course $\text{gl}(n, A_X^{\text{hol}})$ and the finite order part is $\text{gl}(n, A_X)$. Let s be an element of S_W^{fin} , then

$sW^{\text{hol}} = sgH_X^{\eta, \text{hol}} \subset W^{\text{hol}} = gH_X^{\eta, \text{hol}}$, so $\text{Ad}_{g^{-1}}(s)$ is an element of the finite order stabilizer of $H_X^{\eta, \text{hol}}$, i.e., of $gl(n, A_X)$, as g is assumed to be of finite order. Hence $S_W^{\text{fin}} \subset \text{Ad}_g(gl(n, A_X))$. The reverse inclusion is immediate. ■

Note that in case $X = \mathbf{P}^1$ the situation becomes much simpler: we can identify S_W^{fin} with the fiber at W of the cotangent bundle of the Grassmannian.

We will study stabilizer algebras in more detail in Sect. 6.

4. Heisenberg Algebras

4.1. Let $gl(r, H_\lambda)$ be the “real analytic loop algebra on an infinitesimal circle around p .” Consider the subalgebra $\mathcal{H}^r = H_\lambda[P_r]$ of $gl(r, H_\lambda)$ consisting of polynomials over H_λ in the generator P_r , the $r \times r$ matrix

$$P_r = \begin{pmatrix} 0 & 1 & 0 & \dots & 0 & 0 \\ 0 & 0 & 1 & \dots & 0 & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots & \vdots \\ 0 & 0 & 0 & \dots & 1 & 0 \\ 0 & 0 & 0 & \dots & 0 & 1 \\ \lambda & 0 & 0 & \dots & 0 & 0 \end{pmatrix} = \lambda E_{r-1,0} + \sum_{i=0}^{r-2} E_{ii+1}. \tag{4.1.1}$$

Note that, since $P_r^r = \lambda I_r$, the general element of \mathcal{H}^r may be written in the two distinct forms:

$$\sum_{i=0}^{r-1} h_i(\lambda) P_r^i, \quad h_i(\lambda) \in H_\lambda, \tag{4.1.2}$$

or,

$$\sum_{i=-\infty}^{\infty} t_i P_r^i, \quad t_i \in \mathbf{C}. \tag{4.1.3}$$

\mathcal{H}^r is an abelian subalgebra of $gl(r, H_\lambda)$ which extends to the principal Heisenberg subalgebra of the Kac–Moody central extension of $gl(r, H_\lambda)$. In general we will refer to such Abelian subalgebras of $gl(r, H_\lambda)$ also as Heisenberg subalgebras.

Let n be a positive integer and fix a partition $\underline{n} = (n_1 \geq n_2 \geq \dots n_k > 0)$ of n into k parts. (So we have $n = \sum_{i=1}^k n_i$.) The Heisenberg subalgebra $\mathcal{H}^{\underline{n}}$ of type \underline{n} in $gl(r, H_\lambda)$ is

$$\mathcal{H}^{\underline{n}} = \bigoplus_{i=1}^k \mathcal{H}^{n_i} \subset gl(r, H_\lambda), \tag{4.1.4}$$

where each principal Heisenberg subalgebra \mathcal{H}^{n_i} is embedded in $gl(r, H_\lambda)$ as a diagonal block, i.e.:

$$\mathcal{H}^{\underline{n}} = \left\{ \left(\begin{array}{cccc} H^{n_1} & 0 & \dots & 0 \\ 0 & H^{n_2} & \dots & 0 \\ \vdots & \vdots & \ddots & 0 \\ 0 & \dots & \dots & H^{n_k} \end{array} \right) \middle| H^{n_i} \in \mathcal{H}^{n_i} \right\}. \tag{4.1.5}$$

When the partition \underline{n} is understood we shall denote by $\mathcal{P}_a, 1 \leq a \leq k$, the element of $\mathcal{H}^{\underline{n}}$ with P_{n_a} in the a^{th} block and zeroes elsewhere. Thus, the general element of $\mathcal{H}^{\underline{n}}$ may be written in either of the following forms:

$$\sum_{i=0}^{r-1} \sum_{a=1}^k h_i^a(\lambda) \mathcal{P}_a^i, \quad h_i^a(\lambda) \in H_\lambda, \tag{4.1.6}$$

or,

$$\sum_{i=-\infty}^{\infty} \sum_{a=1}^k t_i^a \mathcal{P}_a^i, \quad t_i^a \in \mathbb{C}. \tag{4.1.7}$$

The algebras $\mathcal{H}^{\underline{n}}$ exhaust, up to isomorphism, all maximum Abelian subalgebras of $gl(n, H_\lambda)$ that are stable under the Cartan involution $\omega_0: gl(n, \mathbb{C}) \rightarrow gl(n, \mathbb{C})$ given by $X \rightarrow -X^*$ (see for instance [tKr]).

4.2. We can identify the principal Heisenberg algebra \mathcal{H}^r with H_z by the \mathbb{C} -algebra isomorphism $\mathcal{H}^r \rightarrow H_z$ given by

$$\sum_{i=0}^{r-1} h_i(\lambda) P_r^i \mapsto \sum_{i=0}^{r-1} h_i(z^r) z^i. \tag{4.2.1}$$

This shows that \mathcal{H}^r is an integral domain.

The space H_λ^r is an \mathcal{H}^r -module and the space H_z is a H_z -module. Using the above \mathbb{C} -algebra isomorphism there is a module isomorphism $H_\lambda^r \rightarrow H_z$ given by

$$\sum_{i=0}^{r-1} \alpha_i(\lambda) e_i \mapsto \sum_{i=0}^{r-1} \alpha_i(z^r) z^i. \tag{4.2.2}$$

Similarly, given a fixed partition $\underline{n} = (n_1 \geq n_2 \geq \dots n_k > 0)$, we have a \mathbb{C} -algebra isomorphism $\mathcal{H}^{\underline{n}} \rightarrow H_z^k$ by identifying the diagonal $n_i \times n_i$ block of $\mathcal{H}^{\underline{n}}$ with the i^{th} component of H_z^k . The ring structure of H_z^k is given by componentwise multiplication. This also induces a module isomorphism from $H_\lambda^{\underline{n}}$ to H_z^k . Note that arbitrary Heisenberg algebras are not integral domains: they contain zero-divisors.

4.3. The finite order part of $\mathcal{H}^{\underline{n}}, L_\lambda^{\underline{n}} = \bigoplus L_\lambda[\mathcal{P}_a]$ is built up out of blocks $L_\lambda[\mathcal{P}_a]$ of principal finite order Heisenberg algebras. There is a natural filtration on $L_\lambda^{\underline{n}}$ which will be important for us in the later sections.

In general if R is a \mathbb{C} -algebra an *order function* on R is a map $\mathfrak{o}: R \rightarrow \mathbb{Z}$ such that $\mathfrak{o}(r_1 r_2) \leq \mathfrak{o}(r_1) + \mathfrak{o}(r_2)$ and $\mathfrak{o}(cr) = \mathfrak{o}(r)$ for all $r, r_1, r_2 \in R, c \in \mathbb{C}$. Given an order function we define a filtration $\dots R_i \subset R_{i+1} \subset \dots$ of R by declaring R_i to be the set of elements r of R that have order $\mathfrak{o}(r)$ less than or equal i .

On the ring of Laurent series we define an order by $\mathfrak{o}(f(\lambda)) = k$ if $f(\lambda) = \sum_{i=-\infty}^k f_i \lambda^i, f_k \neq 0$. Define then on the finite order principal Heisenberg algebra $L_\lambda[P_n]$ an order \mathfrak{o}_n by giving the generator P_n order 1 and λ order n . In other words if $s \in L_\lambda[P_n]$ has an expansion $s = \sum_{i=0}^{n-1} f_i(\lambda) P_n^i$ then $\mathfrak{o}_n(s) = \max_i(n \cdot \mathfrak{o}(f_i(\lambda)) + i)$. Note that this filtration corresponds to the natural filtration on $L_z \subset H_z$ under the isomorphism $\mathcal{H}^{\underline{n}} \rightarrow H_z$ of Eq. (4.2.1).

Finally for s an element of an arbitrary finite order Heisenberg algebra $L_\lambda^{\underline{n}}$ we define

$$\mathfrak{o}_{\underline{n}} = \max_{i=1}^k \mathfrak{o}_{n_i}[\pi_i(s)], \tag{4.3.1}$$

where

$$\pi_i: \mathcal{H}^{\underline{n}} \rightarrow \mathcal{H}^{n_i} \tag{4.3.2}$$

is the projection of the i^{th} block of size $n_i \times n_i$ in the Heisenberg algebra. Let us denote by L_s the elements of order s in L_λ^n . Then we have $L_s \subset L_{s+1}$ and $L_{s+1}/L_s \simeq \mathbb{C}^k$, where k is the number of parts of \underline{n} .

5. Covering Maps and Direct Images

5.1. Our Grassmannians Gr_X^n are constructed from rank n bundles \mathcal{E} on the curve X . Now it is known that “generically” such bundles are the direct image of a line bundle under an n -sheeted covering map $f: Y \rightarrow X$, where Y is a smooth curve; for a precise formulation see [BNR]. We will consider more generally curves Y that may be singular, reducible or even decomposable. This makes it then natural to consider also torsion free coherent sheaves, not only bundles. For the reader’s convenience we will include some of the standard definitions and results; for more details see e.g., [Ha].

5.2. Let Y be an algebraic projective curve and \mathcal{O}_Y its algebraic structure sheaf. An algebraic coherent sheaf \mathcal{F} is a sheaf of \mathcal{O}_Y -modules that is locally the cokernel of a morphism of free finite modules: we have for every $q \in Y$ a subset U containing q and an exact sequence, for some nonnegative integers α, β :

$$\mathcal{O}_Y(U)^\alpha \rightarrow \mathcal{O}_Y(U)^\beta \rightarrow \mathcal{F}(U) \rightarrow 0 . \tag{5.2.1}$$

A coherent sheaf \mathcal{F} is called *torsion-free* if $s \cdot f = 0, s \in \mathcal{O}_{Y,q}, f \neq 0 \in \mathcal{F}_q$, with s not a zero divisor, implies $s = 0$. We will always assume sheaves to be coherent and torsion-free in the sequel.

The *rank* of \mathcal{F} at q is the maximal number of linearly independent elements (over $\mathcal{O}_{Y,q}$) in \mathcal{F}_q . The rank of a coherent sheaf is constant inside every irreducible component of Y . Another local invariant of \mathcal{F} is the *fiber dimension* $\mu_q(\mathcal{F})$ at a closed point q defined as follows: let $\mathfrak{m}_q \subset \mathcal{O}_{Y,q}$ be the maximal ideal of q and $K_q = \mathcal{O}_{Y,q}/\mathfrak{m}_q \simeq \mathbb{C}$ the local residue field. Then we put $\mu_q(\mathcal{F}) = \dim_{K_q}(\mathcal{F}_q/\mathfrak{m}_q \mathcal{F}_q)$. By Nakayama’s lemma this is also the minimal number of generators of \mathcal{F}_q ; in other words the fiber dimension is the minimal β that can occur in the sequence (5.2.1). The rank of \mathcal{F} and the fiber dimension of \mathcal{F} at q will be equal if and only if \mathcal{F}_q is free. If q is a nonsingular point the stalk $\mathcal{O}_{Y,q}$ is a Dedekind domain. Since a finitely generated torsion-free module over a Dedekind domain is locally free (see [Bo, VII, Sect. 5.10]) in the case of a smooth point the stalk of \mathcal{F} is free. In particular if Y is a nonsingular irreducible curve every torsion free coherent sheaf is locally free, i.e., the sheaf of sections of an algebraic vector bundle.

5.3. Continue with X being an irreducible, reduced, nonsingular, projective curve and Y an arbitrary reduced projective curve. An l -fold branched cover of X by Y is a morphism $f: Y \rightarrow X$ such that for every $x \in X$ the inverse image $f^{-1}(x)$ consists of a finite number of points $\{y_1, y_2, \dots, y_k\}$, with $k = \ell$ for all but a finite number of x , and such that the rank of \mathcal{O}_{Y,y_i} (over $\mathcal{O}_{X,x}$) is ℓ_i , with $\sum_1^k \ell_i = \ell$. Here we use the local homomorphism

$$f_{y_i}^\# : \mathcal{O}_{X,x} \rightarrow \mathcal{O}_{Y,y_i} \tag{5.3.1}$$

to give \mathcal{O}_{Y,y_i} the structure of an $\mathcal{O}_{X,x}$ -module. We will refer to the rank ℓ_i as the *ramification index* of the covering map at y_i .

Let now \mathcal{F} be a sheaf (i.e., a coherent torsion-free sheaf) on Y , of rank m_i at the i^{th} point lying over $x \in X$. We don't assume these m_i to be constant or even non-zero. Then the *direct image sheaf* $f_*\mathcal{F}$ on X is defined by $f_*\mathcal{F}(U) := \mathcal{F}(f^{-1}(U))$; the structure of $\mathcal{O}_X(U)$ module is again provided by using the homomorphism $f^\#$. The direct image sheaf is then a coherent torsion free sheaf of rank $n = \sum_i \ell_i m_i$ (this is independent of the choice of the point x) on X , and since X is non-singular this is in fact a rank n vector bundle.

In this way we obtain from sheaves \mathcal{F} on Y vector bundles $\mathcal{E} = f_*\mathcal{F}$ on X . Next we investigate how to obtain the other ingredient going into the concoction of an element of Gr_X^n : the local trivialization t of \mathcal{E} at the point $p \in X$.

5.4. If (Y, \mathcal{O}_Y) is an algebraic curve, there exists a unique analytic space $(Y, \mathcal{O}_Y^{\text{hol}})$ associated to it and for any algebraic coherent sheaf \mathcal{F} we have a unique analytic coherent sheaf $\mathcal{F}^{\text{hol}} = \mathcal{O}_Y^{\text{hol}} \otimes \mathcal{F}$. If $f: Y \rightarrow X$ is an algebraic ℓ -fold branched cover we can extend it to the corresponding analytic spaces and $f_*\mathcal{F}^{\text{hol}}$ is for any coherent sheaf \mathcal{F} an analytic coherent sheaf on $(X, \mathcal{O}_X^{\text{hol}})$. If X is nonsingular this is the sheaf of sections of an holomorphic bundle on X .

We will be interested in the situation where the fiber $f^{-1}(p) = \{p_1, \dots, p_k\}$ of the special point p on X contains only nonsingular points. In this case the stalk $(f_*\mathcal{F}^{\text{hol}})_p$ can be described very explicitly. If λ^{-1} is a local holomorphic coordinate at p then $f_{p_i}^\#(\lambda^{-1})$ belongs to $m_{p_i}^{\ell_i}$ but not to $m_{p_i}^{\ell_i+1}$, where ℓ_i is the ramification index at p_i . By choosing a local holomorphic coordinate z_i at p_i appropriately we may assume that $f_{p_i}^\#(\lambda^{-1}) = z_i^{\ell_i}$. Then a basis for \mathcal{O}_{Y, p_i} as a $\mathcal{O}_{X, p}$ module is provided by $\{1, z_i, z_i^2, \dots, z_i^{\ell_i-1}\}$. If \mathcal{F} has rank m_i at p_i then we can choose a basis $\{f_1^{(i)}, f_2^{(i)}, \dots, f_{m_i}^{(i)}\}$ for \mathcal{F}_{p_i} over \mathcal{O}_{Y, p_i} and doing this at all points of the fiber $f^{-1}(p)$ will give a basis of $(f_*\mathcal{F})_p$ over $\mathcal{O}_{X, p}$, viz.,

$$\{z_i^\beta f_\gamma^{(i)} \mid 1 \leq \gamma \leq m_i, 0 \leq \beta \leq \ell_i - 1, 1 \leq i \leq k\}. \tag{5.4.1}$$

Summarizing, the following

Geometric Data.

- (1) An ℓ -fold branched covering map $f: Y \rightarrow X$, where Y is an arbitrary projective reduced curve and X is a smooth integral projective curve, such that $f^{-1}(p)$ consists of k nonsingular points p_i with ramification indices ℓ_i ,
- (2) Local holomorphic coordinates z_i at p_i such that $z_i^{\ell_i} = f_{p_i}^\#(\lambda^{-1})$,
- (3) A torsion-free coherent sheaf \mathcal{F} of rank m_i at p_i with a basis of \mathcal{F}_{p_i} at each point p_i ,

determine an element $[\mathcal{E}, t]$ of the Grassmannian Gr_X^n , where $n = \sum \ell_i m_i$: namely, put $\mathcal{E} = f_*\mathcal{F}$ and construct the trivialization from the basis (5.4.1).

The equivalent description of $[\mathcal{E}, t] \in Gr_X^n$ in terms of an A_X submodule W of L_λ^n is obtained from the geometric data as follows: let σ be a section of \mathcal{F} over $Y - f^{-1}(p)$, i.e., $\sigma \in H^0(Y - f^{-1}(p), \mathcal{F})$. Then σ determines a section of the rank n bundle $\mathcal{E} = f_*\mathcal{F}$ over $X - p$ and using the basis (5.4.1) and the local coordinate λ^{-1} we obtain, an element of L_λ^n as in Sect. (2.3). The space $W \subset L_\lambda^n$ is the collection of elements of L_λ^n obtained in this way from sections of $H^0(Y - f^{-1}(p), \mathcal{F})$. Similarly W^{hol} is obtained by pushing down the sections of $H^0(Y - f^{-1}(p), \mathcal{F}^{\text{hol}})$ and again using the basis (5.4.1) to obtain an element of H_λ^n .

The simplest case of this construction is that where the sheaf \mathcal{F} has rank 1 everywhere on Y . Then the covering map $f: Y \rightarrow X$ has degree n and the partition of n that defines the relevant Heisenberg algebra is given by the ramification indices

at the p_i . The simplest subcase here is maybe that where there is a single point lying over $p \in X$ and the associated Heisenberg is the principal Heisenberg of size n . This is the situation that leads to the KdV hierarchies, in case $X = \mathbf{P}^1$, cf. [SW].

5.5. In this subsection we study the stabilizer algebra of the element $W \in Gr_X^n$ which we obtain from the above geometric data. Recall from Sect. 3.3 that the stabilizer algebra of $W \in Gr_X^n$, is given by $S_W^{\text{hol}} = \{s \in gl(n, H_\lambda) \mid sW^{\text{hol}} \subset W^{\text{hol}}\}$. Now notice that multiplication by an holomorphic function \tilde{s} on $Y - f^{-1}(p)$ preserves the space $H^0(Y - f^{-1}(p), \mathcal{F}^{\text{hol}})$ of holomorphic sections. Thus the pushforward $s = f_*(\tilde{s})$ gives an element of S_W^{hol} when expanded in the basis (5.4.1). Indeed we will argue that s belongs to the intersection of this stabilizer algebra and an Heisenberg algebra corresponding to a partition of n to be determined below.

First observe that the action of the element z_i on \mathcal{O}_{Y, p_i} , considered as an $\mathcal{O}_{X, p}$ -module with basis $\{1, z_i, z_i^2, \dots, z_i^{l_i-1}\}$, is given with respect to this basis by multiplication by the matrix:

$$\begin{pmatrix} 0 & 0 & \dots & 0 & 0 & \lambda^{-1} \\ 1 & 0 & \dots & 0 & 0 & 0 \\ 0 & 1 & \dots & 0 & 0 & 0 \\ \vdots & \vdots & \ddots & \vdots & \vdots & \vdots \\ 0 & 0 & \dots & 1 & 0 & 0 \\ 0 & 0 & \dots & 0 & 1 & 0 \end{pmatrix}, \tag{5.5.1}$$

i.e., z_i is represented by the inverse of the generator of the principal Heisenberg algebra of size l_i , see Sect. 4.4. The basis $\{1, z_i, z_i^2, \dots, z_i^{l_i-1}\}$ of \mathcal{O}_{Y, p_i} as $\mathcal{O}_{X, p}$ module, along with a basis $\{f_0^i, f_1^i, \dots, f_{m_i-1}^i\}$ of \mathcal{F}_{p_i} as \mathcal{O}_{Y, p_i} -module, induces a basis of \mathcal{F}_{p_i} as $\mathcal{O}_{X, p}$ module, namely;

$$\{f_0^i, f_1^i, \dots, f_{m_i-1}^i, z_i f_0^i, z_i f_1^i, \dots, z_i f_{m_i-1}^i, \dots, z_i^{l_i-1} f_0^i, z_i^{l_i-1} f_1^i, \dots, z_i^{l_i-1} f_{m_i-1}^i\}. \tag{5.5.2}$$

With respect to this basis the action of z_i^{-1} on \mathcal{F}_{p_i} is represented by the element $P_{l_i m_i}^{m_i}$, the m_i^{th} power of the generator of the principal Heisenberg algebra of size $l_i m_i$.

Next observe that any holomorphic function \tilde{s} on $Y - f^{-1}(p)$ may be expanded in terms of the local coordinates at the points p_i over p to give a k -tuple $\{s_1(z_1), s_2(z_2), \dots, s_k(z_k)\}$, with $s_i(z_i) \in H_{z_i^{-1}}$. Hence in the pushforward, $s = f_*(\tilde{s})$, each component $s_i(z_i)$ is represented as an expansion in the element $P_{m_i l_i}^{m_i}$ of the principal Heisenberg algebra $\mathcal{H}^{m_i l_i}$. Putting this all together we get a representation for \tilde{s} as an element of $\mathcal{H}^{\underline{n}}$, where \underline{n} is the partition of $n = m_1 l_1 + m_2 l_2 + \dots + m_k l_k$ into the k parts $m_i l_i$. So we find, as promised, that the pushforward of a holomorphic function on $Y - f^{-1}(p)$ belongs to $S_W^{\text{hol}} \cap \mathcal{H}^{\underline{n}}$. In fact:

Lemma 5.5.1. *Let W be a point of the Grassmannian given by the geometric data in Sect. 5.4. Then*

$$f_*(H^0(Y - f^{-1}(p), \mathcal{O}_Y^{\text{hol}})) = S_W^{\text{hol}} \cap \mathcal{H}^{\underline{n}}. \tag{5.5.3}$$

Proof. It remains to be shown that $(S_W^{\text{hol}} \cap \mathcal{H}^{\underline{n}}) \subset f_*(H^0(Y - f^{-1}(p), \mathcal{O}_Y^{\text{hol}}))$. Let $s \in S_W^{\text{hol}} \cap \mathcal{H}^{\underline{n}}$. Using the isomorphism $\mathcal{H}^{\underline{n}} \rightarrow H_k^{\underline{n}}$ induced by the partition \underline{n} into

k parts (see Sect. 4.2) and identifying $H_{z^{-1}}^k$ with $\bigoplus_{i=1}^k H_{z_i^{-1}}$ we see that s can be thought of as an holomorphic function \tilde{s} in a deleted neighborhood of $f^{-1}(p)$. Since $s \in S_W^{\text{hol}}$ the function \tilde{s} stabilizes $H^0(Y - f^{-1}(p), \mathcal{F})$, and therefore \tilde{s} extends to an holomorphic function on all of $Y - f^{-1}(p)$. (We use here the fact that $H^0(Y - f^{-1}(p), \mathcal{F})$ is free.) ■

It follows then that we also have:

$$f_*(H^0(Y - f^{-1}(p), \mathcal{O}_Y)) = S_W^{\text{fin}} \cap \mathcal{H}^n. \tag{5.5.4}$$

Note that we have made here a choice of ordering of the basis (5.4.1) to represent holomorphic functions by explicit matrices. The choice we made seems the most natural; it has the fortunate effect that for a covering map $f: Y \rightarrow X$ with k points over $p \in X$ the holomorphic functions on $Y - f^{-1}(p)$ corresponds to a subalgebra of an Heisenberg algebra determined by a partition with also k parts. However other choices are possible and this will give the holomorphic functions as subalgebras of more complicated Heisenbergs. For instance we might take as basis for \mathcal{F}_{p_i} :

$$\{f_0^i, z_i f_0^i, \dots, z_i^{l_i-1} f_0^i, f_1^i, z_i f_1^i, \dots, z_i^{l_i-1} f_1^i, \dots, f_{m_i-1}^i, z_i f_{m_i-1}^i, \dots, z_i^{l_i-1} f_{m_i-1}^i\}.$$

In this case z_i^{-1} acts on \mathcal{F}_{p_i} as the matrix $\text{diag}(P_{l_i}, P_{l_i}, \dots, P_{l_i})$ (m_i terms) and a holomorphic section will be represented using this ordering at all points p_i by a matrix from the Heisenberg algebra corresponding to the partition $n = l_1 + \dots + l_1 + l_2 + \dots + l_2 + \dots + l_k + \dots + l_k$ (every l_i repeated m_i times). Also intermediate conventions for the ordering can of course be chosen. In the direct Krichever problem (obtaining a point in the infinite Grassmannian from geometric data) we can choose not to use these artificially complicated Heisenbergs, but in the inverse process of obtaining geometric data from a point in the Grassmannian we can't avoid them. This is the reason that Theorem 7.5.1 is rather complicated.

5.6. This ring $S_W^n = S_W^{\text{fin}} \cap \mathcal{H}^n$, where W comes from the geometric data in (5.4) is, as we have seen, isomorphic to the ring A_Y of rational functions on Y regular except possibly at points in $f^{-1}(p)$. We have a filtration

$$A_Y = A_0 \subset A_1 \subset A_2 \subset \dots, \quad A_s = H^0(Y, \mathcal{O}_Y(sD)), \tag{5.6.1}$$

where $D = p_1 + p_2 + \dots + p_k$. So A_s consists of the regular functions on $Y - f^{-1}(p)$ that have at most a pole of order s at any of the points in $f^{-1}(p)$. By Riemann–Roch we have for large s :

$$A_{s+1}/A_s \simeq \mathbb{C}^k. \tag{5.6.2}$$

In Sect. 4.3 we introduced a filtration on the finite order Heisenberg algebra $L_\lambda^n = \bigoplus_{i=1}^k L_\lambda[\mathcal{P}_{n_i}]$. We have to change this slightly to obtain a filtration on $S_W^n \subset \bigoplus L_\lambda[\mathcal{P}_{n_i}]$ that corresponds to the filtration on A_Y . We saw that z_i^{-1} corresponds to the element $\mathcal{P}_{\ell_i m_i}^{m_i}$. Since z_i^{-1} has a single pole at p_i we should give $\mathcal{P}_{\ell_i m_i}^{m_i}$ order 1, not m_i as in Sect. 4.3.

In other words if $n_i = \ell_i m_i$ we define on the subalgebra

$$L_\lambda[\mathcal{P}_{\ell_i m_i}^{m_i}] \subset L_\lambda[\mathcal{P}_{\ell_i m_i}] \tag{5.6.3}$$

a modified order function

$$\mathfrak{o}_{n_i, \ell_i}(s) = \mathfrak{o}_i(s)/m_i, \quad s \in L_\lambda[\mathcal{P}_{\ell_i m_i}^{m_i}]. \tag{5.6.4}$$

Then, on the subalgebra

$$L_\lambda^{n, \ell} = \bigoplus_{i=1}^k L_\lambda[\mathcal{P}_{\ell, m_i}^n], \tag{5.6.5}$$

define the order

$$\mathfrak{o}_{n, \ell}(s) = \max_1^k [\mathfrak{o}_{n_i, \ell_i}(\pi_i(s))], \quad s \in L_\lambda^{n, \ell}. \tag{5.6.6}$$

With this new definition of the filtration the correspondence of A_Y and S_W^n is an isomorphism of filtered \mathbb{C} -algebras.

6. Stabilizer Algebras and Their Spectra

6.1. Let W be an element of Gr_X^n and recall from Sect. 3.3 that the *stabilizer algebra* of W^{hol} is

$$S_W^{\text{hol}} = \{s \in gl(n, H_\lambda) \mid sW^{\text{hol}} \subset W^{\text{hol}}\}. \tag{6.1.1}$$

This is a noncommutative algebra associated to W which can be identified with a large subspace of the fiber of the cotangent bundle of the Grassmannian at W . We saw in the previous section that for W coming from a covering map $f: Y \rightarrow X$, and additional data, the commutative subalgebra $S_W^{\text{hol}} \cap \mathcal{H}^n$ has a natural geometric interpretation: it is essentially the ring of holomorphic functions on the analytic space $Y - f^{-1}(p)$. In the same way the finite order part $S_W^{\text{fin}} \cap \mathcal{H}^n$ can be identified with the coordinate ring of the affine curve $Y - f^{-1}(p)$.

Wanting to obtain the geometric data from W we define for arbitrary W (not a priori coming from the Geometric Data of Sect. 5.4) and arbitrary partition of n :

$$S_W^n = S_W^{\text{fin}} \cap \mathcal{H}^n. \tag{6.1.2}$$

For brevity we refer to this as the *stabilizer algebra of type \underline{n}* . This is an abelian subalgebra of the finite order stabilizer S_W^{fin} which in general is not maximal. We will see that S_W^n is the affine coordinate ring of a curve, $\text{Spec}(S_W^n)$, covering X . In Sect. 7 we will construct a compactification for $\text{Spec}(S_W^n)$ and we will show that we can in fact reconstruct all the data from W and the choice of Heisenberg algebra \mathcal{H}^n .

6.2. *Example.* Although \mathcal{H}^n is a maximal Abelian subalgebra of $gl(n, H_\lambda)$, it is in general not true that the stabilizer S_W^n is maximal Abelian in S_W^{fin} . For example let $W \in Gr_X^2$ have a basis over A_X consisting of $w_1 = \begin{pmatrix} 1 \\ b \end{pmatrix}$, $w_2 = \begin{pmatrix} 0 \\ 1 \end{pmatrix}$, where $b \notin K_X$, for K_X the quotient field of A_X . Consider then the principal stabilizer subalgebra S_W^2 , corresponding to the partition of 2 into one part. It consists of polynomials over L_λ in the matrix $P_2 = \begin{pmatrix} 0 & 1 \\ \lambda & 0 \end{pmatrix}$ stabilizing W , since W is free over A_X . But for any $f(\lambda) \in L_\lambda$ we have $f(\lambda)P_2 w_2 \notin W$, since clearly no element of W has a zero as second component. Hence $S_W^2 = A_X \cdot 1_{2 \times 2}$. This means that any element of S_W commutes with S_W^2 , which is therefore not maximal.

We can also use this example to point out that, despite Lemma 3.3.3, it is not in general true that the holomorphic stabilizer of type \underline{n} , $S_W^{n, \text{hol}}$, is obtained by tensoring the finite order stabilizer of type \underline{n} , S_W^n , with A_X^{hol} . Indeed, if we take for

simplicity $X = \mathbf{P}^1$ and b above to be of the form h/g , where h and g are holomorphic on $X - p$ and have an essential singularity at p , then the ring

$$R = A_X^{\text{hol}} \cdot 1_{2 \times 2} \oplus A_X^{\text{hol}} \cdot f(\lambda) \begin{pmatrix} 0 & 1 \\ \lambda & 0 \end{pmatrix} \tag{6.2.1}$$

certainly belongs to $S_W^{2, \text{hol}}$ if $f(\lambda) = g^2(\lambda)$. So $S_W^{2, \text{hol}}$ is strictly bigger than $A_X^{\text{hol}} \otimes S_W^2 = A_X^{\text{hol}} \cdot 1_{2 \times 2}$. Note that in this example $\text{Spec}(S_W^2)$ is just $X - p$, but that R can be thought of as the ring of analytic functions of the ‘‘hyperelliptic analytic curve’’ $z^2 = \lambda(g(\lambda))^4$. In general, it seems that to study the holomorphic stabilizer algebra $S_W^{n, \text{hol}}$ one has to introduce infinite genus curves or similar complicated objects [McK].

6.3. Let us list some algebraic properties of the finite order stabilizer algebra S_W^n . It is a reduced ring, i.e., it does not contain any nilpotents, and it is torsion free as A_X -module. Furthermore, W is finitely generated and projective, so there is a free finite rank A_X module F and an other module W' with $F = W \oplus W'$. Thus $S_W^{\text{fin}} (= \text{End}(W))$, and hence S_W^n , is an A_X -submodule of the endomorphism ring $\text{End}(F)$, which is itself of finite rank and free. Since A_X is Noetherian it follows that S_W^n is finitely generated and Noetherian. Finally, since the ring A_X is always contained as a diagonal subring in S_W^n , it follows that S_W^n is an integral extension of A_X .

This last fact can be seen very explicitly in the case W is free: let $s \in S_W^n$, then s is conjugate to an element of $gl(n, A_X)$ (see Lemma 3.3.4). Hence the characteristic polynomial of s , $P_s(t) = \det(t\mathbf{1}_n - s)$ belongs to $A_X[t]$, and is of the form

$$t^n + a_1 t^{n-1} + \dots + a_n = 0, \quad a_i \in A_X. \tag{6.3.1}$$

Since s satisfies, by the Cayley–Hamilton theorem, its own characteristic equation we see that s is integral over A_X .

6.4. Associated to a commutative ring A is a topological space $\text{Spec}(A)$, the set of prime ideals in A , with as basis of open sets $D(f) = \{p \in \text{Spec}(A) \mid f \notin p\}$, where $f \in A$. $X = \text{Spec}(A)$ comes naturally equipped with a sheaf of local rings, the structure sheaf \mathcal{O}_X . The space of sections of the structure sheaf over the open set $D(f)$ is the localization A_f and the stalk at a point p of X is the local ring $\mathcal{O}_{X,p} = A_p$. For instance $\text{Spec}(A_X)$ is the affine curve $X - p$ together with its sheaf of regular functions. Here we want to consider the space $\text{Spec}(S_W^n)$.

Since the commutative ring S_W^n is an integral extension of A_X , the Krull dimensions of S_W^n and A_X are equal and hence also $\text{Spec}(S_W^n)$ is a curve.

As a topological space $\text{Spec}(S_W^n)$ decomposes into a finite number of irreducible components $V(\mathfrak{p}_a) = \{p \in \text{Spec}(A) \mid \mathfrak{p}_a \subset p\}$, where the \mathfrak{p}_a are the minimal primes of S_W^n , $a = 1, \dots, r$. The elements of the minimal primes \mathfrak{p}_a are precisely the zero divisors of S_W^n . Since S_W^n is a subring of an Heisenberg algebra the zero-divisors are easy to identify using the block structure and so we can determine the minimal primes and hence the decomposition of $\text{Spec}(S_W^n)$ into irreducible components.

Recall from Sect. 3.2 that a principal Heisenberg algebra (corresponding to a partition of n into one part) is an integral domain. Hence also a stabilizer algebra S_W^n of principal type is an integral domain and in this case $\langle 0 \rangle$ is the unique minimal prime and $\text{Spec}(S_W^n)$ is irreducible. (This is the situation one usually finds discussed in the literature on the Krichever method in soliton theory, where one studies the KdV or KP hierarchies related to the principal Heisenberg algebra, see e.g., [SeW].)

To study the general case of a stabilizer algebra $S_{\mathbb{W}}^n$ contained in a non-principal Heisenberg, we use the projections π_i introduced in (4.3.2). Let $s \in S_{\mathbb{W}}^n$, n a partition of n into $k > 1$ parts, so \mathcal{H}^n is not an integral domain in this case, although $S_{\mathbb{W}}^n$ might be. Then we define the *support* of s as the subset

$$S(s) = \{i \in I \mid \pi_i(s) \neq \emptyset\}, I = \{1, 2, \dots, k\}. \tag{6.4.1}$$

We say that s has full support if $S(s) = I$. If s and t are two elements in $S_{\mathbb{W}}^n$ then $S(st) = S(s) \cap S(t)$ since the principal Heisenberg algebras are integral domains. Thus it follows that if s has full support then it can not be a zero-divisor. In fact from the following lemma we see that s is a zero-divisor if and only if it does not have full support:

Lemma 6.4.1. *Let $s \in S_{\mathbb{W}}^n$, Then there exists a $t \in S_{\mathbb{W}}^n$ with $S(t) = I - S(s)$ and hence $st = 0$.*

Proof. Consider the projection $\pi_{S(s)} = \bigoplus_{i \in S(s)} \pi_i$. Then $\pi_{S(s)}(s) = s$ is a non-zero-divisor in $\pi_{S(s)}(S_{\mathbb{W}}^n)$. Now $\pi_{S(s)}(S_{\mathbb{W}}^n)$ is an integral extension of A_X (since $S_{\mathbb{W}}^n$ is) and hence we have an equation for $\pi_{S(s)}(s)$ of the form $(\pi_{S(s)}(s))^n + \sum_i a_i (\pi_{S(s)}(s))^i = 0$, with $a_i \in A_X$ and $a_0 \neq 0$ (since $\pi_{S(s)}(s)$ is a non-zero-divisor). Define then

$$t = a_0 \mathbf{1}_n + \left(s^n + \sum_{i=1}^{n-1} a_i s^i \right) \in S_{\mathbb{W}}^n. \tag{6.4.2}$$

This element has support $S(t) = I - S(s)$. ■

Because of the multiplicative property of supports, $S(s_1 s_2) = S(s_1) \cap S(s_2)$, we obtain r minimal subsets S_a , $1 \leq a \leq r \leq k$ of $I = \{1, 2, \dots, k\}$ such that

- (1) $S_a \cap S_b = \emptyset$ if $a \neq b$;
- (2) $I = \bigcup S_a$;
- (3) $\exists z_a \in S_{\mathbb{W}}^n$ with $S(z_a) = S_a$;
- (4) if for some $z \neq 0 \in S_{\mathbb{W}}^n$ we have $S(z) \subset S_a$ then $S(z) = S_a$.

Consider the projection:

$$\pi_{S_a} : S_{\mathbb{W}}^n \rightarrow \bigoplus_{j \in S_a} \pi_j(S_{\mathbb{W}}^n). \tag{6.4.3}$$

The image is (by (4)) an integral domain and the kernel $\mathfrak{p}_a = \ker \pi_{S_a}$ is a prime ideal. In fact this is a minimal prime ideal: suppose that $\mathfrak{p} \subset \mathfrak{p}_a$ is a prime ideal and let $x \in \mathfrak{p}_a$; then by Lemma 6.4.1 there exists a $z \in S_{\mathbb{W}}^n$ with $S(z) = S_a$ and $zx = 0$; now $z \bmod \mathfrak{p}$ is not zero and hence $x \bmod \mathfrak{p}$ must be zero for otherwise there would be a zero-divisor in the integral domain $S_{\mathbb{W}}^n/\mathfrak{p}$; this means that $\mathfrak{p} = \mathfrak{p}_a$ and \mathfrak{p}_a is indeed minimal. So in this case $\text{Spec}(S_{\mathbb{W}}^n)$ has r irreducible components isomorphic to $\text{Spec}(S_{\mathbb{W}}^n/\mathfrak{p}_a)$.

For example, consider an elliptic curve X with affine coordinate ring A_X given in Eq. (2.2.3). Take $g = \begin{pmatrix} 1 & 0 \\ \lambda^{-2k} & 1 \end{pmatrix} \in GL(2, H_\lambda)$ and the free A_X -module $W = g \cdot H_X^{(2, \text{alg})} \in Gr_X^2$. Then $s = \begin{pmatrix} \lambda^{2k} & 0 \\ 0 & -\lambda^{2k} \end{pmatrix}$ is an element of the stabilizer subalgebra $S_{\mathbb{W}}^1$ of type (1, 1), corresponding to the ‘‘homogeneous’’ Heisenberg algebra

of $gl(2, H_\lambda)$, since $g^{-1}sg \in gl(2, A_X)$. But $\lambda^{2k} \in A_X$ and $\mathbf{1} \in S_W^{1,1}$ so also the zero-divisors $\begin{pmatrix} \lambda^{2k} & 0 \\ 0 & 0 \end{pmatrix}$ and $\begin{pmatrix} 0 & 0 \\ 0 & \lambda^{2k} \end{pmatrix}$ belong to $S_W^{1,1}$. In fact $S_W^{1,1} \simeq A_X \begin{pmatrix} \lambda^{2k} & 0 \\ 0 & 0 \end{pmatrix} \oplus A_X \begin{pmatrix} 0 & 0 \\ 0 & \lambda^{2k} \end{pmatrix}$ is the direct sum of two copies of A_X and its spectrum consists of two copies of the affine curve $X - p$ touching to order k at the points over the origin of the Riemann sphere. Of course the method of Sect. 5 provides us with examples of non-principal stabilizer algebras which are irreducible.

It can happen that S_W^n is the Cartesian product of $\kappa > 1$ \mathbb{C} -algebras. In this case $\text{Spec}(S_W^n)$ is the disjoint union of κ components and S_W^n will contain κ nontrivial idempotents; an idempotent is an element $e \in S_W^n$ such that $e \neq 0, 1$ and $e^2 = e$. Idempotents are zero-divisors that are independent of λ . Now since the restriction of e to any of the diagonal blocks is not a zero-divisor we must have

$$e = \sum_i e_i \mathbf{1}_{n_i},$$

where $e_i = 0$ or 1 , $\mathbf{1}_{n_i}$ is the identity matrix in the n_i th diagonal block of H^n and not all of the e_i 's are simultaneously 0 or 1. The fact that S_W^n contains an idempotent means that W is a direct sum

$$W = eW \oplus (1 - e)W$$

and that the summands are embeddings of elements of lower rank Grassmannians Gr_X^p and Gr_X^q . In other words, there is an element $g \in gl(n, H_\lambda)$ such that $W = gH_X^{(n, \text{hol})}$ and such that g is the direct sum of two elements, eg and $(1 - e)g$, of lower dimensional loop groups $gl(p, H_\lambda)$ and $gl(q, H_\lambda)$ (where $p = \sum_{i=1}^k e_i n_i$, $q = \sum_{i=1}^k (1 - e_i) n_i$).

6.5. The total quotient ring $Q(S_W^n)$ is the ring of fractions $(S^{-1})(S_W^n)$, where S is the multiplicative set of non-zero-divisors in S_W^n . As is well known (see e.g., [Ku]) this is the Cartesian product of the fields $F^i = Q(S_W^n/\mathfrak{p}_i)$ of rational functions on the irreducible components $\text{Spec}(S_W^n/\mathfrak{p}_i)$. Another convenient description of this ring of rational functions is given by the following

Lemma 6.5.1. $Q(S_W^n) = K_X \otimes_{A_X} S_W^n$.

Proof. Recall that if B, C are rings, S a multiplicative subset in B and $\phi: B \rightarrow C$ a homomorphism such that:

- (1) For all $s \in S$, $\phi(s)$ is invertible in C ;
- (2) If $\phi(b) = 0$ then there exists an $s \in S$ such that $sb = 0$;
- (3) Every element of C can be written as $\phi(b)\phi(s)^{-1}$, for $b \in B, s \in S$, then $C \simeq S^{-1}B$. We check these conditions for the homomorphism $\psi: S_W^n \rightarrow K_X \otimes_{A_X} S_W^n, s \mapsto 1 \otimes s$ and the multiplicative set of non-zero-divisors in S_W^n .

Since S_W^n is an integral extension of A_X also $K_X \otimes_{A_X} S_W^n$ is an integral extension of K_X . Let $s \in S$. Then $\psi(s)$ satisfies a monic equation $\psi(s)^n + k_{n-1}\psi(s)^{n-1} + \dots + k_0 = 0, k_i \in K_X$. Since for $s \in S$ also $\psi(s)$ is a non-zero-divisor we may assume that $k_0 \neq 0$ and we see that $\psi(s)$ is invertible (since $\psi(s)^{-1} = -\frac{1}{k_0}(\psi(s)^{n-1} + k_{n-1}\psi(s)^{n-2} + \dots + k_1)$), verifying property (1).

Next suppose that $\psi(t) = 0$, and $t \in S_{\mathbb{W}}^n$. Then there exists an $a \in A_X$ such that $at = 0$. But $S_{\mathbb{W}}^n$ is torsion free as A_X -module and hence $t = 0$. This proves part (2).

For part (3) let $Y = \sum \frac{\alpha_i}{\beta_i} \otimes s_i \in K_X \otimes S_{\mathbb{W}}^n$. Then $Y = \sum \frac{\alpha_i B_i}{\beta_1 \dots \beta_t} \otimes s_i$, where $B_i = \prod_{i \neq j} \beta_j$ and we find $Y = \frac{1}{\beta_1 \dots \beta_t} \otimes \sum \alpha_i B_i s_i = \psi(\sum \alpha_i B_i s_i) \psi(\beta_1 \dots \beta_t)^{-1}$, and also point (3) is verified. ■

So $K_X \otimes S_{\mathbb{W}}^n = F_1 \times F_2 \times \dots \times F_r$, where F_a is the function field of the a^{th} irreducible component $\text{Spec}(S_{\mathbb{W}}^n/\mathfrak{p}_a)$ of $\text{Spec}(S_{\mathbb{W}}^n)$. The support of F_a is of course the subset $S_a \subset I = \{1, 2, \dots, k\}$ introduced in Sect. 6.4 to determine the minimal primes of $S_{\mathbb{W}}^n$.

6.6. In the previous subsection we saw that we could determine the irreducible components of $\text{Spec}(S_{\mathbb{W}}^n)$ by studying the decomposition into fields of the tensor product $K_X \oplus S_{\mathbb{W}}^n$. By tensoring with the larger field L_λ of Laurent series we get even more detailed information about $\text{Spec}(S_{\mathbb{W}}^n)$: we will use the field decomposition of the tensor product $L_\lambda \otimes S_{\mathbb{W}}^n$ to define a filtration on $S_{\mathbb{W}}^n$ which allows us (in the next chapter) to compactify $\text{Spec}(S_{\mathbb{W}}^n)$ to a projective curve Y with a natural covering map $Y \rightarrow X$.

Each field F_a occurring in $K_X \oplus S_{\mathbb{W}}^n$ will decompose in general into more fields after tensoring with L_λ : $L_\lambda \otimes F_a = F_a^1 \times F_a^2 \times \dots \times F_a^{k_a}$. (The number of fields k_a occurring in this decomposition will turn out to be the number of points lying over $p \in X$ in the irreducible component of the compactification Y of $\text{Spec}(S_{\mathbb{W}}^n)$ with function field F_a .) The number of fields $\sum k_a$ in $L_\lambda \otimes S_{\mathbb{W}}^n$ is at most k , the number of blocks in the Heisenberg algebra.

Let us denote by S_a^e the support of the field F_a^e . Let $f \in F_a^e$ and $i \in S_a^e$. If $\pi_i(f)$ is the zero of a polynomial $P(t) \in L_\lambda[t]$, then the i^{th} diagonal block of $P(f) \in F_a^e$ is the zero matrix. Hence $P(f)$ is identically zero and all projections $\pi_i(f)$, $i \in S_a^e$ satisfy the same equations. This means that all projections $\pi_i(F_a^e)$ are isomorphic field extensions of L_λ of degree $\ell_a^e = [F_a^e : L_\lambda]$. Each $\pi_i(F_a^e)$ is a subfield of $L_\lambda[P_i]$.

First we state some general facts about $L_\lambda[P_n]$. $L_\lambda[P_n]$ is a finite field extension of L_λ with $[L_\lambda[P_n] : L_\lambda] = n$ (since $P_n^n = \lambda$). In fact $L_\lambda[P_n]$ is a Galois extension of L_λ with Galois group $\mathbb{Z}_n = \{1, \omega, \omega^2, \dots, \omega^{n-1}\}$, where ω is a primitive n^{th} root of unity. This group acts by multiplication $P_n \mapsto \omega^i P_n$, $i = 0, 1, \dots, n - 1$ on the generator of the extension. By Galois theory the only subfield extensions of $L_\lambda[P_n]$ are the fixed fields of subgroups H of \mathbb{Z}_n . These fields are of the form $L_\lambda[P_n^m]$,

$m = \frac{n}{\ell}$, corresponding to the subgroups \mathbb{Z}_ℓ of \mathbb{Z}_n , where ℓ runs over the divisors of n . In particular this means that the minimal polynomial of an element X of $L_\lambda[P_n]$ (generating some subfield $L_\lambda[X]$ of $L_\lambda[P_n]$) must have degree ℓ dividing n , and in this case $X \in L_\lambda[P_n^m]$, $m = \frac{n}{\ell}$.

Hence if i is in the support S_a^e of the field F_a^e and ℓ_a^e is the degree $[F_a^e : L_\lambda]$ of the extension (equivalently ℓ_a^e is the rank of $\pi_i(S_{\mathbb{W}}^n)$), then ℓ_a^e divides n_i , the size of the i^{th} block: $n_i = m_i \ell_a^e$ and we have:

$$S_{\mathbb{W}}^n \subset \bigoplus_{i=1}^k L_\lambda[P_{n_i}^{m_i}]. \tag{6.6.1}$$

We then define on S_W^n the filtration $\mathfrak{o}_{\underline{n}, \underline{\ell}}$, see (5.6.6), induced by the inclusion (6.6.1) where $\underline{\ell}$ is the collection of integers $\ell_i = n_i/m_i$. Note that for all $i, j \in S_a^e, s \in S_W^n$ we have $\mathfrak{o}_{n_i, \ell_i}(\pi_i(s)) = \mathfrak{o}_{n_j, \ell_j}(\pi_j(s))$. In other words the blocks within the support of a single field component contribute in the same way to the order of s . If each of the fields F_a^e has support in a single block, (i.e., if there are exactly k fields in $L_\lambda \otimes S_W^n$), $\underline{\ell}$ is a partition of the rank ℓ of S_W^n over A_X .

Proposition 6.6.1. *Let $S_W^n = S_W^{\text{fin}} \cap \mathcal{H}^n$ be the stabilizer algebra of type $\underline{n} = n_1 + n_2 + \dots + n_k$ of $W \in Gr_X^n$. If $k_0 \leq k$ is the number of fields in $L_\lambda \otimes S_W^n$ and $(S_W^n)_i$, denotes the elements of order at most i in S_W^n , then*

$$(S_W^n)_{i+1}/(S_W^n)_i \simeq \mathbb{C}^{k_0}, \tag{6.6.2}$$

for all i larger than some i_0 .

Proof. We first study the simplest case: a principal stabilizer algebra S_W^n of rank n over A_X . Let $\{s_1, s_2, \dots, s_n\}$ be a maximal independent set in S_W^n . Then $\{s_1, s_2, \dots, s_n\}$ is also a basis for $L_\lambda \otimes S_W^n = L_\lambda[P_n]$ (or rather the elements $1 \otimes s_i$ are, but we will not make this distinction). Hence in particular we can write

$$P_n = \sum_{i=1}^n a_i(\lambda)s_i, \quad a_i(\lambda) \in L_\lambda. \tag{6.6.3}$$

We can split each of the Laurent series $a_i(\lambda)$ into a Laurent polynomial $\beta_i(\lambda) \in \mathbb{C}[\lambda, \lambda^{-1}]$ and another Laurent series $\gamma_i(\lambda)$ such that $a_i(\lambda) = \beta_i(\lambda) + \gamma_i(\lambda)$, and $\mathfrak{o}_n(\beta_i(\lambda)s_i) \geq 1, \mathfrak{o}_n(\gamma_i(\lambda)s_i) < 1$. Then we have, recalling that P_n has order 1:

$$\sum_{i=1}^n \beta_i(\lambda)s_i = P_n + \text{lower order terms}. \tag{6.6.4}$$

Now every Laurent polynomial $\beta_i(\lambda)$, when multiplied by any sufficiently high power of λ , is the highest order part of an element $f_i(\lambda) \in A_X$: $f_i(\lambda) = \beta_i(\lambda)\lambda^m + \text{lower order terms}$. We fix an m_0 that works for all $\beta_i(\lambda)$ and find:

$$\sigma := \sum_{i=1}^n f_i(\lambda)s_i = \lambda^{m_0}P_n + \text{lower order terms}. \tag{6.6.5}$$

Now, as $f_i \in A_X$ and $s_i \in S_W^n$, we have $\sigma \in S_W^n$ and we have found an element of order $1 \pmod n$. The first n powers of σ are then independent and, remembering that multiplication by λ increases the order of an element by n , we see that there is at least one element of every sufficiently high order in S_W^n . Since $S_W^n \subset L_\lambda[P_n]$ there is exactly one independent element of each high enough order (up to addition of lower order elements) and we find $(S_W^n)_{i+1}/(S_W^n)_i = \mathbb{C}$ for large i .

The general case is essentially the same: for every field F_a^e in $L_\lambda \otimes S_W^n$, with support S_a^e and of dimension ℓ_a^e over L_λ , one shows that there is an element $\sigma_a^e \in S_W^n$ which has its highest order term in the blocks indexed by $i \in S_a^e$ and with order $\mathfrak{o}_{\underline{n}, \underline{\ell}}(\sigma_a^e) = 1 \pmod{\ell_a^e}$. The first ℓ_a^e powers of σ_a^e are independent and since multiplying by λ increases the order in this block ℓ_a^e , we find again an element of every high enough order in S_W^n . Since such elements $\sigma_a^e, \sigma_{a'}^e$ (and their first $\ell_a^e, \ell_{a'}^e$, respectively $\ell_{a'}^e$ powers) for distinct subfields F_a^e and $F_{a'}^e$ are linearly independent we find for every field in $L_\lambda \otimes S_W^n$ one independent element and S_W^n contains k_0 independent elements of all high enough orders. ■

To finish this discussion of the filtration of $S_{\mathbb{W}}^n$ we note that $(S_{\mathbb{W}}^n)_0$ is isomorphic to \mathbb{C}^k if $S_{\mathbb{W}}^n$ is the Cartesian product of κ \mathbb{C} -algebras (see the discussion at the end of Sect. 6.4) and that

$$(S_{\mathbb{W}}^n)_i = 0, \quad i < 0. \tag{6.6.6}$$

To prove this last statement we use the natural filtration of the n -component Laurent series L_{λ}^n given by $\mathfrak{o}(s) = \max_{i=0}^{n-1} (s_i(\lambda))$ if $s = (s_0(\lambda), \dots, s_{n-1}(\lambda)) \in L_{\lambda}^n$. This induces a filtration on the subspaces $W \in Gr_X^n$ which has the following interpretation: if W corresponds to a bundle E and $w \in W$ has order k then w corresponds to a section ε of \mathcal{E} which has a pole of order k at p and is regular elsewhere. If k is negative then ε has a zero and is a global section of \mathcal{E} . Since the space of global sections is finite dimensional there can occur only a finite number of negative orders for elements of a fixed W . Consider then an element $s \in S_{\mathbb{W}}^n$ and $w \in W$ such that $s \cdot w \neq 0$. One easily checks that if the order of s were negative the order of $s \cdot w$ would be strictly less than the order of w . But this would imply, since $sW \subset W$, that in the set $\{s^i \cdot w\} \subset W$ an infinite number of elements of distinct negative order occur, which is impossible. This proves (6.6.6).

7. The Compactification of $\text{Spec}(S_{\mathbb{W}}^n)$

7.1. Next we want to compactify the affine curve $\text{Spec}(S_{\mathbb{W}}^n)$. This uses the filtration on $S_{\mathbb{W}}^n$ described in Sect. 6.6. Let us first recall some elementary facts about filtered and graded rings and homogeneous spectra (see e.g. Hartshorne [Ha]).

Let A be a ring with some order function \mathfrak{o} and corresponding filtration $A_0 \subset A_1 \subset A_2 \subset \dots$, (so A_{-1} is zero). Define an associated graded ring

$$R(A) = \bigoplus_{i=0}^{\infty} R_i, \tag{7.1.1}$$

where $R_i = A_i$. To simplify notation we will write usually R if it is clear to which filtered ring A we refer. Let w denote the element of degree 1 in R which is the image of $1 \in A$ under the embedding of A_0 in A_1 . So if α belongs to A_i we obtain an element $\alpha^{(i)} \in R_i$ and we have $\alpha^{(j)} = \alpha^{(i)} w^{j-i}$ if $j \geq i$.

Define for arbitrary homogeneous element $f \in R$ the homogeneous ring of quotients of R by $R_{(f)} = \{g/f^n \mid \deg(g) = \deg(f^n), n \geq 0\}$. Then one can recover the original ring A and its filtration from the pair (R, w) : we have $A \cong R_{(w)}$, via $\alpha \in A_i \mapsto \alpha^{(i)}/w^i \in R_{(w)}$.

Consider next the homogeneous spectrum of R . Let $R_+ = \bigoplus_{i=1}^{\infty} R_i$ and define

$$\text{Proj}(R) = \{p \in \text{Spec}(R) \mid p \text{ is homogeneous and } R_+ \not\subset p\}. \tag{7.1.2}$$

Recall that an ideal I of a graded ring is called homogeneous if $I = \bigoplus I \cap R_i$ or equivalently if it is generated by homogeneous elements. $\text{Proj}(R)$ is a topological space with basic open sets

$$D_+(f) = \{p \in \text{Proj}(R) \mid f \notin p\}, \tag{7.1.3}$$

for f a homogeneous element of R . Just as $\text{Spec}(A)$ also $X = \text{Proj}(R)$ has its sheaf of local rings, again denoted by \mathcal{O}_X and called the structure sheaf. The space of sections of the structure sheaf over the basic open set $D_+(f)$ is the ring $R_{(f)}$ and the stalk at a point $p \in X$ is the local ring $\mathcal{O}_{X,p} = R_{(p)}$, the degree zero part of the ring of

quotients of R with denominator set the homogeneous elements of R not in p . Closed sets of $\text{Proj}(R)$ are the components of $D_+(f)$ or more generally of the form $V(I) = \{p \in \text{Proj}(R) \mid I \subset p\}$ for homogeneous ideals I .

In contrast to an open subset $D_+(f)$ (which is isomorphic to the affine scheme $\text{Spec}(R_{(f)})$), the closed sets $V(I)$ don't have a canonical scheme structure. However, note that $V(I^n) = V(I)$, $n > 0$ and that we have an isomorphism of topological spaces

$$\phi_n : \text{Proj}(R/I^n) \rightarrow V(I^n), \quad q \in \text{Proj}(R/I^n) \mapsto \psi_n^{-1}(q), \tag{7.1.4}$$

where $\psi_n : R \rightarrow R/I^n$ is the canonical surjection.

Letting $Y_n = \text{Proj}(R/I^n)$ and \mathcal{O}_{Y_n} its structure sheaf we have a closed immersion

$$(\phi_n, \phi_n^\#) : (Y_n, \mathcal{O}_{Y_n}) \rightarrow (X, \mathcal{O}_X). \tag{7.1.5}$$

This means that the map $\phi_n^\# : \mathcal{O}_X \rightarrow \phi_{n*} \mathcal{O}_{Y_n}$ is surjective, where $\phi_n^\#$ is, on the level of stalks, the canonical map $R_{(\phi_n(q))} \rightarrow (R/I^n)_{(q)}$. Hence each closed immersion defines a sheaf of ideals \mathfrak{I}^n , the kernel of $\phi_n^\#$, and $\mathcal{O}_X/\mathfrak{I}^n$ is a sheaf with support on $V(I)$. We define the n^{th} infinitesimal neighborhood of $V(I)$ as the scheme $(V(I), \mathcal{O}_X/\mathfrak{I}^n)$; it carries information about the way $V(I)$ is embedded in X . It is then natural to consider the inverse limit of these scheme structures on $V(I)$. The locally ringed space $\hat{X} = (V(I), \mathcal{O}_{\hat{X}})$ with $\mathcal{O}_{\hat{X}} = \varprojlim \mathcal{O}_X/\mathfrak{I}^n$ is called the *formal completion* of X along the subscheme $V(I)$. The formal completion is independent of the ideal we use to define the subset $V(I)$.

Lemma 7.1.1. *Let R be a Noetherian graded ring and I a homogeneous ideal of R such that $V(I)$ contains only a finite number of maximal ideals p_1, p_2, \dots, p_k . Then the structure sheaf $\mathcal{O}_{\hat{X}}$ of the formal completion of $X = \text{Proj}(R)$ along $V(I)$ has a stalk at p_i isomorphic to the m_{p_i} -adic completion $\hat{\mathcal{O}}_{X, p_i}$ of the local ring \mathcal{O}_{X, p_i} , where m_{p_i} is the maximal ideal of \mathcal{O}_{X, p_i} .*

Proof. Without loss of generality we may assume that I is a radical ideal; then we have $I = \bigcap p_i$. Using the fact that R is Noetherian and hence the ideals p_i are finitely generated one checks that also $I^n = \bigcap p_i^n$. Now the ideals p_i^n, p_j^n are coprime if $i \neq j$ and hence by the Chinese remainder theorem we have $R/I^n = \bigoplus R/p_i^n$. Hence we also have $\hat{R} = \varprojlim R/I^n = \bigoplus \varprojlim R/p_i^n$. The ring \hat{R} determines the formal completion sheaf $\mathcal{O}_{\hat{X}}$: we have $\mathcal{O}_{\hat{X}, p_i} = \hat{R}_{(\hat{p}_i)}$, where $\hat{p}_i = \varprojlim p_i/I^n$. But

$$\hat{R}_{(\hat{p}_i)} = \varprojlim R_{(p_i)}/m_{p_i}^n = \varprojlim \mathcal{O}_{X, p_i}/m_{p_i}^n = \hat{\mathcal{O}}_{X, p_i}. \tag{7.1.6}$$

■

If R is a finitely generated graded \mathbb{C} -algebra with $\text{Proj}(R)$ isomorphic to the Proj of a quotient S of the polynomial algebra $\mathbb{C}[t_0, \dots, t_N]$ with $\deg(t_i) = 1$ we call $\text{Proj}(R)$ and also R *projective*, since in that case $\text{Proj}(R)$ is isomorphic to a closed subscheme in the projective space \mathbb{P}^N .

Let us return to the case where we have a filtered ring A , an associated graded ring $R(A)$. Then we have

$$\text{Proj}(R) = D_+(w) \cup V(w). \tag{7.1.7}$$

Now $D_+(w) \simeq \text{Spec}(R_{(w)}) \simeq \text{Spec}(A)$, so we see that $V(I)$ is “the divisor at infinity” that has to be added to $\text{Spec}(A)$ to obtain the projective scheme $\text{Proj}(R)$. We have seen that each of the rings $R/w^n R$ determines, via $\text{Proj}(R/w^n R)$, a closed subscheme structure on $V(w)$.

We will be interested in the case where $X = \text{Proj}(R)$ is projective of dimension 1 and $V(w)$ contains a finite number of closed points. Then Lemma 7.1.1 tells us in particular that the points in $V(w)$ that we have to add to complete $\text{Spec}(A)$ are all nonsingular if and only if the stalks of the formal completion are isomorphic to the ring of formal power series in $\dim(X) = 1$ variables.

7.2. We can first of all apply this to the ring A_X of Sect. 2.1. This ring is filtered by the order of the pole at p . It will be no surprise that the Proj of $R(A_X)$ is nothing but a projective nonsingular integral scheme isomorphic to X itself and that the Proj of $R/w^n R$ can be identified with the n^{th} infinitesimal neighborhood of p , the missing point which has to be added to the space $\text{Spec}(A_X) \cong X - p$ to get X back.

This can be seen as follows. A_X is a subalgebra of $L_\lambda = \mathbb{C}[\lambda] \oplus \mathbb{C}\{\lambda^{-1}\}/\lambda$ and for every $i \geq i_0$, for some i_0 , there are normalized elements

$$f_i = \sum_{j \geq 0} c_j \lambda^{i-j}, \quad c_0 = 1 \tag{7.2.1}$$

of order i . Then the graded ring $R = R(A_X)$ is a subalgebra of $L_{\bar{\lambda}, w^{-1}} = L_{\bar{\lambda}} \otimes L_{w^{-1}}$ generated by a subset of the elements of R of the form

$$f_i^{(i)} = \sum_{j \geq 0} c_j \bar{\lambda}^{i-j} w^j, \tag{7.2.2}$$

corresponding to a set of generators for A_X . (So one can identify λ with $\bar{\lambda}/w$.) One checks that R is a quotient of a quasi-homogeneous polynomial algebra and that $\text{Proj}(R)$ is projective and hence complete.

Next we investigate $V(w)$, the divisor at infinity that we have to add to make $\text{Spec}(A_X)$ complete in $X' = \text{Proj}(R)$. Let us for simplicity first consider the closed subscheme structure on $V(w)$ determined by R/wR . The normalization of the f_i in (7.2.1) is such that $f_i f_j = \lambda^{i+j} + \text{lower order}$ for all $i, j \geq i_0$. These elements f_i of A_X give elements $f_i^{(i)}$ of R satisfying $f_i^{(i)} f_j^{(j)} = \bar{\lambda}^{i+j} \pmod{wR}$. This allows us to define a map

$$\phi: R/wR \rightarrow \mathbb{C}[t], \quad \deg(t) = 1, \tag{7.2.3}$$

by setting the restriction ϕ_j to $(R/wR)_j$ for $j < i_0$ equal to zero and defining $\phi_i(f_i^{(i)}) = t^i$ (and extending linearly). So t can be identified with $\bar{\lambda} \pmod{wR}$. Then ϕ is a graded ring homomorphism and $\phi_i, i \geq i_0$ is the isomorphism. In general if $\phi: R \rightarrow S$ is a homomorphism of graded rings such that the restriction $\phi_n: R_n \rightarrow S_n$ is an isomorphism for all n large enough, then we have $\text{Proj}(R) \simeq \text{Proj}(S)$. We call R and S *isomorphic in large degree* in this case. So in our case, where $R = R(A_X)$, the quotient R/wR is isomorphic in large degree to the polynomial ring in one variable and one sees that $\text{Proj}(R/wR)$ consists of one point p (corresponding to the zero ideal in $\mathbb{C}[t]$). Hence $\text{Proj}(R(A_X))$ is obtained from $\text{Spec}(A)$ by adding a single point p .

To investigate whether this added point is nonsingular or not we study the formal completion of $\text{Proj}(R)$ along the point $V(w)$. The structure sheaf of this formal completion is obtained from the inverse limit of the rings $R/w^n R$. Now for $i \geq i_0 + n$ we have $R_i/w^n R_{i-n} = \mathbb{C}\bar{\lambda}^i \oplus \mathbb{C}w\bar{\lambda}^{i-1} \oplus \dots \oplus w^{n-1}\bar{\lambda}^{i+1-n} \pmod{w^n R}$. Hence the ring $R/w^n R$ is isomorphic in large degree to $\mathbb{C}[w, \bar{\lambda}]/\langle w^n \rangle$. The stalk of the structure sheaf of $\text{Proj}(R/w^n R)$ at the unique maximal ideal is isomorphic to the localization of $\mathbb{C}[w, \bar{\lambda}]/\langle w^n \rangle$ at $\langle w \rangle$ which is easily calculated to be $\mathbb{C}[\mu]/\mu^n$, where $\mu = w/\bar{\lambda} = 1/\lambda$ is a local coordinate at $p \in V(w)$. Hence the stalk of the formal

completion is $\mathbb{C}[[\mu]]$ and the added point is indeed nonsingular. Since $\text{Proj}(R) = \text{Spec}(A_X) \cup V(w)$ and A_X is the coordinate ring of a nonsingular curve we see that all points of $\text{Proj}(R)$ are nonsingular and $X' = \text{Proj}(R)$ is a nonsingular reduced curve with $\text{Spec}(A_X)$ as open subscheme. In particular X and X' have the same function field. By the uniqueness, up to isomorphism, of a nonsingular irreducible projective curve with given function field we have then $\text{Proj}(R) = X$, and we have recovered our complete curve from the affine coordinate ring together with its filtration and the local coordinate $\mu = 1/\lambda$ at p .

7.3. Next we consider the stabilizer algebra S_W^n for $W \in Gr_X^n$ and \underline{n} a partition into k parts. Let $R = R(S_W^n)$. Then, since S_W^n is finitely generated, as before R is a quotient of a quasi-homogeneous polynomial ring and hence $\text{Proj}(R)$ is a projective complete curve. We have $\text{Proj}(R) = \text{Spec}(S_W^n) \cup V(w)$. Similar to the discussion for A_X we introduce normalized elements in S_W^n . To that end let S_a^e be the support of the field F_a^e in the decomposition of $L_\lambda \otimes S_W^n$ and define

$$\lambda_a^e = \sum_{i \in S_a^e} \mathcal{P}_{n_i}^{m_i} \in \mathcal{H}^n, \tag{7.3.1}$$

where n_i/m_i is the degree of the field extension F_a^e over L_λ . Note that λ_a^e is an element of order 1 in the filtration $\mathfrak{o}_{\underline{n}, \ell}$, see Sect. 5.6. Then we require that the highest order term of the normalized element $\sigma_{a,i}^e \in S_W^n$ of order i with highest order term in the blocks indexed by S_a^e is precisely $(\lambda_a^e)^i$. (It is easy to check that we can indeed normalize elements of S_W^n in this way.)

Then we have

$$\sigma_{a,i}^e \sigma_{b,j}^f = \delta_{e,f} \delta_{a,b} (\lambda_a^e)^{i+j} + \text{lower order}, \quad i, j \geq i_0. \tag{7.3.2}$$

We find in the same way as before that $R/w^n R \simeq \prod \mathbb{C}[w, \bar{\lambda}_a^e]/w^n$ (isomorphism in large degree), where $\bar{\lambda}_a^e/w = \lambda_a^e$ and the product is taken over the indices describing the k_0 fields in $L_\lambda \otimes S_W^n$. Hence the k_0 stalks of the formal completion of $\text{Proj}(R)$ along $V(w)$ are isomorphic to the formal power series rings $\mathbb{C}[[\mu_a^e]]$, where $\mu_a^e = w/\lambda_a^e = (\lambda_a^e)^{-1}$. Hence $V(w)$ consists of exactly k_0 nonsingular points p_a^e that have to be added to $\text{Spec}(S_W^n)$ to obtain the reduced complete curve $Y = Y_W^n = \text{Proj}(R(S_W^n))$. Here again the μ_a^e are local coordinates at the points p_a^e .

So now we have constructed from S_W^n a curve Y_W^n . Since A_X is a subring of S_W^n and the filtration of A_X is obtained by restriction of the filtration of S_W^n we have also an inclusion of $R(A_X)$ in $R(S_W^n)$. This defines an ℓ -fold branched covering map $f: Y_W^n \rightarrow X$. The fiber of the point $p \in X$ consists of the points p_a^e corresponding to one of the fields F_a^e . Since multiplication by λ of an element σ_a^e of S_W^n with its highest order component in the blocks indexed by the support of the field F_a^e increases the order by $\ell_a^e = [F_a^e: L_\lambda]$, the ramification index of p_a^e is indeed ℓ_a^e . The local coordinate μ_a^e satisfies clearly $\phi^\#(\lambda^{-1}) = (\mu_a^e)^{\ell_a^e}$.

7.4. Now consider the element W of Gr_X^n . It is a finitely generated torsion free module over S_W^n and hence defines a torsion free coherent sheaf over $\text{Spec}(S_W^n)$. To extend it to Y_W^n we need a filtration on W compatible with the filtration on S_W^n . Recall from Sect. 6.6 that $S_W^n \subset \bigoplus_{i=1}^k L_\lambda[P_{n_i}^{m_i}]$, with $n_i = m_i \ell_i$ and that the filtration of S_W^n is obtained from this inclusion, see (5.5.6). Similarly the filtration on W is obtained from the inclusion $W \subset L_\lambda^n$, where we decompose $L_\lambda^n = \bigoplus_{i=1}^k L_\lambda^{n_i}$ and introduce a filtration on it as follows. If $\{e_0^{(i)}, e_1^{(i)}, \dots, e_{n_i-1}^{(i)}\}$ is the natural basis of the component $L_\lambda^{n_i}$, i.e., $e_j^{(i)} = e_t$, with $t = n_1 + n_2 + \dots + n_{i-1} + j$, we give $e_j^{(i)}$ order q_j where $j = q_j m_i + r_j, 0 \leq r_j < m_i$ and within this block multiplication by

λ increases the order by ℓ_i . One easily checks that this gives $L_\lambda^n = \bigoplus_{i=1}^k L_\lambda^{n_i}$ the structure of filtered $\bigoplus_{i=1}^k L_\lambda[\mathcal{P}^{m_i}]$ -module.

Define then $F = \bigoplus F_i$, where $F_i = W_i$ are the elements of W of order i or less. Then F is a graded, torsion free, finitely generated $R = R(S_W^n)$ module. It defines a torsion free coherent sheaf \mathcal{F} on the curve Y_W^n in the usual way. The space of sections of \mathcal{F} over $Y_W^n - f^{-1}(p)$ can then be identified with W , if we take as basis for the holomorphic stalks $\mathcal{F}_{p_a^e}$, thought of as free $\mathcal{O}_{Y_W^n, p_a^e}$ submodules of L_λ , the basis $\{e_0^{(i)}, e_1^{(i)}, \dots, e_{m_i-1}^{(i)}\}_{i \in S_a^e}$. Note that in this manner we get as basis for $\mathcal{F}_{p_a^e}$ over $\mathcal{O}_{X,p}$ the elements

$$\{e_0^{(i)}, e_1^{(i)}, \dots, e_{m_i-1}^{(i)}, (\lambda_a^e)^{-1}e_0 = e_{m_i}^{(i)}, (\lambda_a^e)^{-1}e_1 = e_{m_i+1}^{(i)}, \dots, e_{n_i-1}^{(i)}\}_{i \in S_a^e}. \tag{7.4.1}$$

This uses the fact that

$$(\lambda_a^e)^{-1}e_j^{(i)} = (\mathcal{P}_{n_i}^{m_i})^{-1}e_j^{(i)} = e_{j+m_i}^{(i)}, \quad j < n_i - m_i. \tag{7.4.2}$$

In this way we have found also the sheaf \mathcal{F} and the trivialization of it at the points in the inverse image of $p \in X$.

7.5. Let us summarize in the following theorem our construction of the inverse of the Krichever map of 5.4.

Theorem 7.5.1. *Let X be a nonsingular curve, $p \in X$ a point, λ^{-1} a local holomorphic coordinate at p and Gr_X^n the Grassmannian (of rank n bundles + trivializations) constructed from these data (see Sect. 2). Let $W \in Gr_X^n$, let \underline{n} be a partition (n_1, n_2, \dots, n_k) of n and let S_W^n be the finite order stabilizer algebra of W of type \underline{n} (Sect. 6), corresponding to the Heisenberg algebra \mathcal{H}^n (Sect. 4). Let $\{F_a^e\}$ be the k_0 fields occurring in the decomposition of the tensor product $L_\lambda \otimes S_W^n$ (Sect. 6.6) and let ℓ_a^e be the degree of the field extension F_a^e over L_λ , the field of Laurent series (Sect. 2.1).*

Then there exists a curve Y_W^n and a covering map $f: Y_W^n \rightarrow X$ such that $f^{-1}(p)$ consists of k_0 nonsingular points p_a^e , one for each field F_a^e , and such that the pull back divisor $f^(p)$ is $\sum \ell_a^e p_a^e$.*

Let $S_a^e \subset \{1, 2, \dots, k\}$ be the support of the field F_a^e (Sect. 6.4). For each $i \in S_a^e$ the part n_i of \underline{n} is divisible by ℓ_a^e , say $m_i = n_i/\ell_a^e$, and we put $m_a^e = \sum_{i \in S_a^e} m_i$. Then there exists an algebraic coherent torsion free sheaf \mathcal{F} on Y_W^n such that the stalk $\mathcal{F}_{p_a^e}$ is free of rank m_a^e for each point p_a^e in the inverse image of p . Furthermore there is a basis for each of the holomorphic stalks $\mathcal{F}_{p_a^e}^{\text{hol}}$ such that the space of algebraic sections of \mathcal{F} over $Y_W^n - f^{-1}(p)$, with respect to these bases, can be identified with the element W in Gr_X^n (Sect. 5.4).

8. Time Evolution, Lax Equation, and Multi-component KP Equations

8.1. In this section we study the flows on the Grassmannian by exponentiation of elements of \mathcal{H}^n . These flows leave invariant the commutative algebra S_W^n , and hence also the curve $\text{Spec}(S_W^n)$. The flow on the Grassmannian gives a flow of modules over this ring which can be interpreted as a flow of bundles over the curve. In the case that the bundles have rank one, these flows are linear with respect to the toral structure of the Jacobian of the curve.

In Sect. 8.3 we relate these flows to multi-component KP equations by mapping Gr_X^n into the universal Grassmannian. Finally, in Sect. 8.4, we give an Hamiltonian interpretation of these flows on the cotangent bundle of the Grassmannian.

8.2. Let $\sigma \in \mathcal{H}^n$. Consider the flow on Gr_X^n given by:

$$W(t) = \exp(t\sigma)W. \tag{8.2.1}$$

Since for $W = gH_X^{(n, \text{hol})}$ we have that $S_W^{\text{hol}} = g(gl(n, A_X^{\text{hol}}))g^{-1}$, it follows that

$$S_W^{\text{hol}}(t) = \exp(t\sigma)g(gl(n, A_X^{\text{hol}}))g^{-1}\exp(-t\sigma). \tag{8.2.2}$$

Thus if $s \in S_W^{\text{hol}} \cap \mathcal{H}^n$ then, since \mathcal{H}^n is commutative, it follows that $s = \exp(-t\sigma) \cdot s \cdot \exp(t\sigma)$ is an element of $S_W^{\text{hol}} \cap \mathcal{H}^n$, i.e., $S_W^{\text{hol}} \cap \mathcal{H}^n$ does not depend on the parameter t . In particular, the finite order part, S_W^n , is also independent of t , as is its completion Y_W^n . Thus the curve $\text{Spec}(S_W^n)$ is independent of the flows. Furthermore the one parameter family of S_W^n modules $W(t)$ corresponds to a one parameter family of bundles $E(t)$ over the curve $\text{Spec}(S_W^n)$ as constructed in Chap. 7.

8.3. As we explained in Sect. 2.7 the Grassmannian Gr_X^n is a subvariety of the universal Grassmannian $Gr = Gr(H_z)$. When we are interested in flows on Gr_X^n determined by a partition $\underline{n} = (n_1, \dots, n_k)$, of n into k parts, it is more convenient to map Gr_X^n into $Gr(H_z^k)$, the Grassmannian of subspaces of H_z^k whose projection to $H_{z,+}^k$ is Fredholm. Here we use the map $H_\lambda^n \rightarrow H_z^k$ given by

$$\lambda^l e_i \mapsto z^{n_{al}+j} \bar{e}_a, \tag{8.3.1}$$

where $i = n_1 + \dots + n_{a-1} + j$, and e_i (respectively \bar{e}_a) give a basis for \mathbb{C}^n (resp. \mathbb{C}^k). (Of course the Grassmannians $Gr(H_z^k)$ and $Gr(H_z)$ are isomorphic.)

The action of the Heisenberg algebra \mathcal{H}^n translates into an action of the algebra of diagonal $k \times k$ matrices on H_z^k generated by $A_a^i \equiv z^i E_{aa}$, where $i \in \mathbb{Z}$ and $1 \leq a \leq k$. Indeed the map (8.3.1) induces the map $\mathcal{P}_a \mapsto z E_{aa}$, where the element \mathcal{P}_a of \mathcal{H}^n is defined in Sect. 4.1. Let Γ^n denote the group of transformations on H_z^k of the form $\phi^n(t) = \exp(\sum_{i>0} \sum_{a=1}^k t_i^a A_a^i)$, where the t_i^a are thought of as time variables. For $W \in Gr(H_z^k)$, put $\tilde{W}(t) = \phi^n(t)^{-1}W$. We say that $W(t)$ belongs to the big cell when the projection $W(t) \rightarrow H_{z,+}^k$ is an isomorphism, where $H_{z,+}^k$ is the subspace of H_z^k of k -component vectors of the form $\sum_{i \geq 0} f_i z^i, f_i \in \mathbb{C}^k$. If W is in the big cell there is a unique $k \times k$ matrix wave function

$$w_W(t) = \phi^n(t) \left(1_{k \times k} + \sum_{i>0} w_i z^{-i} \right) \in W, \tag{8.3.2}$$

where the w_i are $k \times k$ matrix functions of the t_i^a , and we say that a $k \times k$ matrix belongs to W if its columns do. We let $\tilde{\partial} = \sum_{a=1}^k \tilde{\partial}_{t_i^a}$ act as a differential operator on matrices from the right. More generally we consider $k \times k$ matrices with coefficients pseudo-differential operators in $\tilde{\partial}$. Then we have

$$\phi^n(t)(\tilde{\partial}E) = \phi^n(t)(zE), \tag{8.3.3}$$

for any $k \times k$ matrix E (possibly dependent upon t). The wave operator is then the matrix pseudo-differential operator defined by

$$\hat{w} = 1_{k \times k} + \sum_{i>0} \tilde{\partial}^{-i} w_i, \tag{8.3.4}$$

and we have

$$w_W(t) = \phi^n(t) \cdot \hat{w}. \tag{8.3.5}$$

The wave operator \hat{w} satisfies the equation

$$\partial_{t^i} \hat{w} = -\hat{w}(R_a^i)_-, \tag{8.3.6}$$

where $R_a^i = \hat{w}^{-1} \cdot \bar{\partial}^i(E_{aa}) \cdot \hat{w}$ and the subscript $-$ denotes the formal integral operator part of a pseudo-differential operator (i.e., the negative order part). The multi-component KP equation is then given by

$$\partial_{t^i} Q = [Q, (R_a^i)_+], \tag{8.3.7}$$

where $Q = \hat{w}^{-1} A \bar{\partial} \hat{w}$, for a constant diagonal matrix A with distinct non-zero eigenvalues (cf. [DaJKM, UT, Di]). In [BtK] it is explained that with the multi-component KP equation naturally are associated also difference equations (besides the differential equations (8.3.7)), coming from group elements commuting with the Heisenberg algebra. In this paper we will not discuss these discrete equations, which are in the simplest case the equations for the Toda-lattice.

Now let us assume that $W \in Gr_X^n$ maps to an element of $Gr(H_z^k)$ of index zero (this is not essential but will make the formulae much simpler). Then the flow on Gr_X^n from Sect. 8.2 will give rise to a multi-component KP flow on the image, \bar{W} , of W in $Gr(H_z^k)$. The elements of \bar{W} coming from finite order elements of $W(t)$, i.e., those of the form $\phi^n(t)(\sum_{-\infty}^l a_i z^i)$, generate a free rank k module over the ring of differential operators. A basis for this module is given by the k columns of the wave function (see [DS, SeW, BtK]). This means that for any $f \in A_X$ (so $fW \subset W$) we have

$$\bar{f}w_W(t) = w_W(t)P_f, \tag{8.3.8}$$

where \bar{f} denotes f realized as a matrix of size $k \times k$ acting on H_z^k , using 8.1.3, and P_f is a $k \times k$ matrix of differential operators. The map $f \mapsto \bar{f} \mapsto P_f$ gives a map from A_X to a commutative subring \bar{A}_X of all $k \times k$ matrix differential operators. (For the simplest case of $X = \mathbf{P}^1$ and the principal Heisenberg algebra ($k = 1$) this ring is $\bar{A}_X = \mathbb{C}[L]$, the ring of polynomials in the Lax-operator L , the unique n^{th} order differential operator such that $\lambda w_W = w_W L$.)

Similarly, we have, for any element s of the stabilizer algebra $S_{\bar{w}}^n$ of type n for $W \in Gr_X^n$, a differential operator P_s . This gives a ring of commutative matrix differential operators $\bar{S}_{\bar{w}}^n$. Of course $\bar{A}_X \subset \bar{S}_{\bar{w}}^n$.

8.4. We now sketch how the Heisenberg flows on Gr_X^n are related to Hamiltonian flows on the duals of loop algebras and to Hamiltonian flows on the cotangent bundle of Gr_X^n .

First note that the action of the group $Gl(n, H_\lambda)$ on Gr_X^n lifts to an Hamiltonian action on $T^*Gr_X^n$ in the usual way that any group action on a manifold lifts to an Hamiltonian action on the cotangent bundle. On the other hand, to give an Hamiltonian version of the Heisenberg flows on the dual of a loop algebra one must consider Lax pairs and the Adler, Kostant, Symes (AKS) theorem [Ad, Ko, Sy] (see also [FNR, RSTS]). This version of the flows works out completely only in the standard setting with $X = \mathbf{P}^1$, however we can make some comments on the more general situation.

We first discuss the case in which $X = \mathbf{P}^1$ so that $A_X^{\text{hol}} = H_{\lambda,+}$, the space of holomorphic functions on $\mathbf{P}^1 - \infty$. Let $\sum t^i \mathcal{P}_a^i$ be an element of \mathcal{H}^n and set $W(t) = \exp(-\sum t^i \mathcal{P}_a^i) W$. Assume that $W(t)$ belongs to the big cell of $Gr_{\mathbf{P}^1}^n$, so that $W(t) = g_-(t)H_{\lambda,+}$, where $g(t) = \exp(-\sum t^i \mathcal{P}_a^i)g$ admits a Birkhoff decomposition

of the form $g(t) = g_-(t)g_+(t)$ without diagonal term. Define the resolvents (cf. [GD]):

$$R_a(t) = g^{-1}(t)\mathcal{P}_a g_-(t) . \tag{8.4.1}$$

Let $R(t) = \sum A_a R_a$ for some choice of constants $A_a \in \mathbb{C}$. We have the Lax equation

$$\partial_{t^a} R = [(R_a^i)_+, R] \tag{8.4.2}$$

since $g^{-1}\partial_{f^a}g_- = -(R_a^i)_-$. Equation (8.4.2) can be realized as an Hamiltonian flow on the dual of the Lie algebra $gl(n, H_{\lambda,+})$ with Hamiltonian function given by the restriction of an Ad*-invariant function on $gl(n, H_{\lambda})^*$. Indeed, the splitting of $gl(n, H_{\lambda})$ from Proposition 3.3.1, applied to the case $X = \mathbf{P}^1$, yields

$$gl(n, H_{\lambda}) = gl(n, \lambda^{-1}\mathbb{C}\{\lambda^{-1}\}) \oplus gl(n, H_{\lambda,+}) . \tag{8.4.3}$$

Using the pairing (3.3.6) this gives an identification

$$gl(n, H_{\lambda,+})^* \sim gl(n, \lambda^{-1}\mathbb{C}\{\lambda^{-1}\}) . \tag{8.4.4}$$

If F is an Ad*-invariant function on $gl(n, H_{\lambda})^*$ we may restrict to $gl(n, H_{\lambda,+})^*$ since (8.4.3) gives

$$gl(n, H_{\lambda})^* = gl(n, \lambda^{-1}\mathbb{C}\{\lambda^{-1}\})^* \oplus gl(n, H_{\lambda,+})^* . \tag{8.4.5}$$

Using the identification (8.4.4) the Hamiltonian flow for F on $gl(n, H_{\lambda,+})^*$ is given by the Lax pair

$$\frac{d}{dt} A = [(dF(A))_+, A] , \tag{8.4.6}$$

where $A \in gl(n, \lambda^{-1}\mathbb{C}\{\lambda^{-1}\})$ and $dF(A)$ is the differential at A of F as a function on $gl(n, H_{\lambda})^*$, thought of as an element of $T_A^*(gl(n, H_{\lambda})^*) \sim gl(n, H_{\lambda})$. For example, if

$$F_{ij}(A(\lambda)) = \frac{1}{j} \oint \text{tr}(\lambda^i A(\lambda)^j) \tag{8.4.7}$$

then

$$dF_{ij}(A(\lambda)) = \lambda^i A(\lambda)^{j-1} . \tag{8.4.8}$$

To realize (8.4.2) as a flow of this type we must first consider $R(t)$ as an element of $gl(n, \lambda^{-1}\mathbb{C}\{\lambda^{-1}\})$. Since $R_a(t)$ has order 1 in λ this is easily achieved by multiplying Eq. (8.4.2) by λ^{-2} . Next, we must find an Ad*-invariant function F such that $dF(\lambda^{-2}R(t)) = R_a^i$. This is possible provided we choose the constants, A_a , distinct. Indeed, since R is the conjugate of the matrix $\mathcal{P} = \sum A_a \mathcal{P}_a$ which is in block form, so that $R^{j-1}(t)$ is the conjugate of $\mathcal{P}^{j-1} = \sum A_a^{j-1} \mathcal{P}_a^{j-1}$, it is possible to find a linear combination, F , of the F_{ij} 's which gives $dF(\lambda^{-2}R(t)) = R_a^i$.

Consider now the situation where there is a Laurent series $f(\lambda) \in L_{\lambda}$ such that $L(\lambda) = f(\lambda)R$ belongs to $gl(n, H_{\lambda,+})$. Then we see that $s = f(\lambda)A_a \mathcal{P}_a$ belongs to $S_W^{\text{hol}} \cap \mathcal{H}^n$, the holomorphic stabilizer algebra of type \underline{n} for W . Since from chapter 3 we have that S_W^{hol} is contained in the cotangent fiber to Gr_X^n at the point W , we may consider the evolution of the pair $(W(t), L(\lambda)(t))$ as a flow through the point $(W(0), L(\lambda)(0))$ in the cotangent bundle $T^*Gr_X^n$. For $X = \mathbf{P}^1$ this flow can be related to the AKS theorem and collective integrability by using a modification of the Ad*-invariant function used to give the Hamiltonian. This modification depends

on the function $f(\lambda)$ and thus on the initial value, $W(0)$. Thus the flow for a particular Heisenberg element σ on the whole of the Grassmannian does not arise in this way from a single Hamiltonian. However, this description of the flows does give a collective Hamiltonian version that generalizes to the case of a general base curve X . To justify these remarks we now give a brief excursion into the geometric proof of the AKS theorem (see e.g., [RSTS, GS2]).

Recall from Sect. 3 that the cotangent bundle $T^*(G/K)$ of the homogeneous space G/K is symplectically equivalent to the Marsden–Weinstein reduction of T^*G under the right action of K . We now consider Hamiltonian flows on this cotangent bundle arising from Ad^* -invariant functions on \mathfrak{g}^* .

If f is a function on \mathfrak{g}^* we can pull it back via the moment map for the left action of G on T^*G to form a function F on T^*G which is invariant under the left action of G on T^*G . In the case that f is invariant under the Ad^* action then F is also invariant under the right action of G on T^*G , in particular, F is invariant under the right K action and so reduces to a function \tilde{F} on $T^*(G/K)$.

To compute the Hamiltonian flow of \tilde{F} on $T^*(G/K)$ we follow the prescription of [GS2] for computing flows for collective Hamiltonians: For $(g, \mu) \in G \times \mathfrak{g}^*$, let

$$\xi = df(\mu) \in (\mathfrak{g}^*)^* \simeq \mathfrak{g} . \tag{8.4.9}$$

Then the Hamiltonian flow of F through (g, μ) is given by

$$(g, \mu) \rightarrow (\exp(t\xi)g, \mu) . \tag{8.4.10}$$

Now, as in chapter 3, we let $J_{R,K}$ denote the moment map for the right K action on T^*G , so that we may identify $T^*(G/K)$ with $J_{R,K}^{-1}(0)/K$. If (g, μ) is in $J_{R,K}^{-1}(0)$ then the flow for \tilde{F} through the point $(gK, \mu) \in T^*(G/K)$ is just the projection of the above flow, i.e.

$$(gK, \mu) \rightarrow (\exp(t\xi)gK, \mu) . \tag{8.4.11}$$

If the algebra \mathfrak{g} splits into two subalgebras, $\mathfrak{g} = \mathfrak{k} \oplus \mathfrak{Q}$, then there is a left L action on $T^*(G/K)$ with moment map

$$(gK, \mu) \mapsto \text{Ad}_g^* \mu \in \mathfrak{Q}^* . \tag{8.4.12}$$

In this case, the Hamiltonian on $T^*(G/K)$ is just the pullback by this map of the restriction of f to \mathfrak{Q}^* . Thus the Lax pair flow for f on \mathfrak{Q}^* given by the AKS theorem is just the image of the flow (8.4.10) under the moment map (8.4.11).

We now apply this construction to our situation where $G = \text{Gl}(n, H_\lambda)$ and $K = \text{Gl}(n, A_X^{\text{hol}})$ so $\mathfrak{g} = \mathfrak{gl}(n, H_\lambda)$ and $\mathfrak{k} = \mathfrak{gl}(n, A_X^{\text{hol}})$. Again, we begin with the case $X = \mathbf{P}^1$ so that $A_{\mathbf{P}^1}^{\text{hol}} = H_{\lambda,+}$ and (8.4.3) gives a splitting of $\mathfrak{gl}(n, H_\lambda)$ into two subalgebras. The above construction suggests we consider AKS flow on $\mathfrak{Q}^* = \mathfrak{gl}(n, \lambda^{-1} \mathbf{C} \{ \lambda^{-1} \})^* \sim \mathfrak{gl}(n, H_{\lambda,+})$. In order that Eq. (8.4.2) be considered as a Lax pair flow on $\mathfrak{gl}(n, H_{\lambda,+})$ we must find a function $f(\lambda)$ such that $L(\lambda) = f(\lambda)R(\lambda) \in \mathfrak{gl}(n, H_{\lambda,+})$. In this case, $s = g_- L(\lambda) g^{-1} = f(\lambda) \sum A_a \mathcal{P}_a \in S_W^{\text{hol}} \cap \mathcal{H}^2$. If F is the Ad^* -invariant function on $\mathfrak{gl}(n, H_\lambda)^*$ which gives the flow (8.4.2) as an Hamiltonian flow on $\mathfrak{gl}(n, H_{\lambda,+})^*$, then we must find a new Hamiltonian \tilde{F} such that $d\tilde{F}(L(\lambda)) = dF(R(\lambda))$. For instance, if $F = F_{ij}$ so $F(R(\lambda)) = \oint \text{tr}(\lambda^i R(\lambda)^j)$ then \tilde{F} will be given by

$$\tilde{F}(L(\lambda)) = \oint \text{tr}(f(\lambda)\lambda^i (f(\lambda)^{-1}L(\lambda))^j) . \tag{8.4.13}$$

Example (The non-linear Schrödinger flows). Take $n = 2$, $\underline{n} = (1, 1)$, and $X = \mathbf{P}^1$. We choose $W = gH_X^{(2, \text{hol})} = gH_{\lambda,+}^2 \in Gr_X^2$ and $s_0 \in S_W^n$. We assume that W is in the “big cell” so that we may take $g = g_- \in Lgl_-(n, \mathbb{C})$. Then $s_0 = g_- L(\lambda)g_-^{-1}$ for some matricial polynomial $L(\lambda)$, by Lemma 3.3.4, (6.1.2), and the fact that $A_X = \mathbb{C}[\lambda]$. Since the leading order term in g_- is the identity matrix, s_0 and $L(\lambda)$ must have the same leading order terms. Assume this to be $\lambda^k \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix}$. Furthermore assume that $L(\lambda)$ is traceless. Then s_0 is also traceless and hence has the form

$$s_0(\lambda) = p(\lambda) \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix},$$

where $p(\lambda) = \lambda^k + p_{k-1}\lambda^{k-1} + \dots$ is in $\mathbb{C}((\lambda^{-1}))$. Then we have

$$\frac{1}{2} d(F_{k,2} - p_{k-1}F_{k-1,2})(s_0) = \lambda \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} + O(\lambda^{-1}),$$

and

$$\frac{1}{2} d(F_{k+1,2} - p_{k-1}F_{k,2} - (p_{k-2} - p_{k-1}^2)F_{k-1,2})(s_0) = \lambda^2 \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} + O(\lambda^{-1}).$$

These give the x and t flows respectively on Gr_X^2 that give rise to solutions of the non-linear Schrödinger equation. So we see in this example that the Hamiltonians for the flows in the cotangent bundle to the Grassmannian depend on the initial condition (viz., s_0) chosen in the fiber.

Finally we remark that when X is more general than \mathbf{P}^1 , the Lie algebra splitting from chapter 3 is not a splitting into two subalgebras but only into a subalgebra plus a linear subspace. Thus we cannot apply the AKS theorem in this setting. However, the Heisenberg flows may still be realized as Hamiltonian flows on $T^*Gr_X^n$ with Ad^* -invariant Hamiltonian, as in Eq. (8.4.11). Indeed, if we choose a flow generator $\sigma \in \mathcal{H}^n$, it is then necessary to find $s \in S_W^n$ and an Ad^* -invariant function f on $gl(n, H_\lambda)^*$ so that the Hamiltonian flow for f through $(W, s) \in T^*Gr_X^n$, given by (8.4.11) is just $(\exp(t\sigma)W, s)$. This is achieved by finding f and s so that $(df(s))_+ = \sigma$. This may not be possible for all choices of $\sigma \in \mathcal{H}^n$ but since $s \in \mathcal{H}^n$ it follows that $df(s) \in \mathcal{H}^n$ as well so that at least some of the Heisenberg flows may be realized in this way.

9. Remarks

9.1. According to Theorem 7.5.1 we obtain for every point W of Gr_X^n and every choice of Heisenberg algebra, i.e., for every choice of partition \underline{n} of n , a curve Y_W^n covering X . We have not discussed the relation between these curves for the various choices of Heisenberg algebra. In fact this is rather mysterious to us. The first idea that one has is that somehow the curves corresponding to a single W should be the same. This can however not be literally true since for the principal Heisenberg algebra one obtains always an irreducible curve while, as we have seen in Sect. 6.4, for other Heisenbergs one can get reducible curves. Also note that if we consider the flows $W \mapsto W(t)$ of type \underline{n} on Gr_X^n , i.e., the flows corresponding to the Heisenberg algebra \mathcal{H}^n , the curve Y_W^n remains invariant, while the curves obtained from the choice of other Heisenbergs will change.

9.2. In Sect. 8 we derived differential equations coming from Heisenberg flows on the Grassmannian by embedding Gr_X^n into a universal Grassmannian, thereby exhibiting these equations as subsystems of multicomponent KP systems.

Now in case $X = \mathbf{P}^1$ the equations corresponding to the various Heisenbergs can be formulated entirely in terms of the representation theory of the loop algebra of $gl(n, \mathbb{C})$ (cf. [KaW, BtK]). These representations involve a decomposition of the loop algebra in elements containing only positive or only negative powers of λ , i.e. the decomposition of Proposition 3.3.1 for $X = \mathbf{P}^1$. One can also formulate these equations in terms of Lax equations on the dual of the loop algebra, again using the decomposition in positive and negative parts related to the Riemann sphere.

This makes one think that it should be possible to formulate the equations of Sect. 8 intrinsically in terms of constructions related to the Riemann surface X , without using the embedding into a universal Grassmannian. However there are a lot of things apparently still unknown. For instance the representation theory seems not to be developed yet (see however the papers [CEH, Che, DJM]). One way of constructing representations related to X would be to consider the sections of a determinant bundle over Gr_X^n as in for instance [PrS] for the case of $X = \mathbf{P}^1$. In [Br] noncommutative theta functions related to vector bundles on curves are constructed using this determinant bundle. The connection to differential equations remains to be worked out. If one wants to get Lax equations on the dual of the loop algebra related to the curve X one runs into the problem that the decomposition of Proposition 3.3.1 is not, as is usual in AKS theory, into two subspaces but that there is a finite dimensional piece in the middle. Lax type equations coming from such decompositions into three subspaces have been studied in [Mi]. Of course there is also the theory of Poisson–Lie groups, R -matrices etc. (see e.g., [Lu, LuW, STS1, STS2]) that could be developed in the context of Gr_X^n , see also [KS].

9.3. The Grassmannian Gr_X^n that we have used in this paper depended on choosing a point p on the Riemann surface X . Of course it is possible to extend the theory by choosing a finite number of points $\{p_i\}$ on X , so that the elements of the generalized Grassmannian consists of equivalence classes of vector bundles on X together with trivializations at $\{p_i\}$. To obtain an inverse Krichever map analogous to the one described in Theorem 7.5.1 one should then choose at every point in $\{p_i\}$ an Heisenberg algebra. The case of two points is relevant for the study of harmonic maps. For instance in [Hi2] one can find that both the homogeneous and the principal Heisenberg algebra of the loop group of $sl(2, \mathbb{C})$ are relevant for the construction of all harmonic maps from the 2-torus to the 3-sphere, using spectral curves.
