# Existence of Solutions for a Class of Variable Exponent Integrodifferential System Boundary Value Problems

This paper investigates the existence of solutions for a class of variable exponent integrodifferential system with multipoint and integral boundary value condition in half line. When the nonlinearity term $f$ satisfies sub- $\left(p^{-}-1\right)$ growth condition or general growth condition, we give the existence of solutions and nonnegative solutions via Leray-Schauder degree at nonresonance, respectively. Moreover, the existence of solutions for the problem at resonance has been discussed.

## 1. Introduction

In this paper, we consider the existence of solutions for the following variable exponent integrodifferential system

with the following nonlinear multipoint and integral boundary value condition

u(+\infty)=\int_{0}^{+\infty} e(t) u(t) d t+e_{1}, \quad \lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}(t)=\sum_{i=1}^{m-2} \alpha_{i} w\left(\xi_{i}\right)\left|u^{\prime}\right|^{p\left(\xi_{i}\right)-2} u^{\prime}\left(\xi_{i}\right)+e_{2} \tag{1.2}
\end{equation*}

where $u:[0,+\infty) \rightarrow \mathbb{R}^{N} ; S$ and $T$ are linear operators defined by

where $\psi \in C(D, \mathbb{R}), x \in C(D, \mathbb{R}), D=\{(s, t) \in[0,+\infty) \times[0,+\infty)\} ; \int_{0}^{+\infty}|\psi(s, t)| d s$ and $\int_{0}^{+\infty}|X(s, t)| d s$ are uniformly bounded with $t ; p \in C([0,+\infty), \mathbb{R}), p(t)>1, \lim _{t \rightarrow+\infty} p(t)$ exists and $\lim _{t \rightarrow+\infty} p(t)>1 ;-\Delta_{p(t)} u:=-\left(w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}\right)^{\prime}$ is called the weighted $p(t)$-Laplacian; $w \in C([0,+\infty), \mathbb{R})$ satisfies $0<w(t)$, for all $t \in(0,+\infty)$, and $(w(t))^{-1 /(p(t)-1)} \in L^{1}(0,+\infty) ; 0<$ $\xi_{1}<\cdots<\xi_{m-2}<+\infty, \alpha_{i} \geq 0,(i=1, \ldots, m-2)$ and $0 \leq \sum_{i=1}^{m-2} \alpha_{i} \leq 1 ; e \in L^{1}(0,+\infty)$ is nonnegative, $\sigma=\int_{0}^{+\infty} e(t) d t$ and $\sigma \in[0,1] ; e_{1}, e_{2} \in \mathbb{R}^{N} ; \delta$ is a positive parameter.

If $\sum_{i=1}^{m-2} \alpha_{i}<1$ and $\sigma<1$, we say the problem is nonresonant; but if $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1]$ and $\sigma=1$, we say the problem is resonant.

The study of differential equations and variational problems with variable exponent growth conditions is a new and interesting topic. Many results have been obtained on these problems, for example, [1-23]. We refer to [3, 19, 23], for the applied background on these problems. If $w(t) \equiv 1$ and $p(t) \equiv p$ (a constant), $-\Delta_{p(t)}$ becomes the well-known $p$-Laplacian. If $p(t)$ is a general function, $-\Delta_{p(t)}$ represents a nonhomogeneity and possesses more nonlinearity, and thus $-\Delta_{p(t)}$ is more complicated than $-\Delta_{p}$. For example, if $\Omega \subset \mathbb{R}^{n}$ is a bounded domain, the Rayleigh quotient

is zero in general, and only under some special conditions $\lambda_{p(x)}>0$ (see [9, 16-18]), but the fact that $\lambda_{p}>0$ is very important in the study of $p$-Laplacian problems.

Integral boundary conditions for evolution problems have been applied variously in chemical engineering, thermoelasticity, underground water flow, and population dynamics. There are many papers on the differential equations with integral boundary value conditions, for example, [24-29]. On the existence of solutions for $p(x)$-Laplacian systems boundary value problems, we refer to [2,4,7,8,10-12,20-22]. In [20], the present author deals with the existence and asymptotic behavior of solutions for (1.1) with the following linear boundary value conditions

when $0 \leq \sum_{i=1}^{m-2} \alpha_{i}<1$ and $0 \leq \int_{0}^{+\infty} e(t) \leq 1$. But results on the existence of solutions for variable exponent integrodifferential systems with nonlinear boundary value conditions are rare. In this paper, when $p(t)$ is a general function, we investigate the existence of solutions and nonnegative solutions for variable exponent integrodifferential systems with nonlinear multipoint and integral boundary value conditions, when the problem is at nonresonance. Moreover, we discuss the existence of solutions for the problem at resonance. Since the nonlinear multipoint boundary value condition is on the derivative of solution $u$, we meet more difficulties than [20].

Let $N \geq 1$ and $J=[0,+\infty)$, the function $f=\left(f^{1}, \ldots, f^{N}\right): J \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \rightarrow$ $\mathbb{R}^{N}$ is assumed to be Caratheodory, by this we mean,
(i) for almost every $t \in J$, the function $f(t, r, \cdot, \cdot, \cdot)$ is continuous;
(ii) for each $(x, y, z, w) \in \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N}$, the function $f(\cdot, x, y, z, w)$ is measurable on J;
(iii) for each $R>0$, there is a $\beta_{R} \in L^{1}(J, \mathbb{R})$ such that, for almost every $t \in J$ and every $(x, y, z, w) \in \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N}$ with $|x| \leq R,|y| \leq R,|z| \leq R,|w| \leq R$, one has

Throughout the paper, we denote

w(+\infty)\left|u^{\prime}\right|^{p(+\infty)-2} u^{\prime}(+\infty)=\lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}(t) .

The inner product in $\mathbb{R}^{N}$ will be denoted by $\langle\cdot, \cdot\rangle,|\cdot|$ will denote the absolute value and the Euclidean norm on $\mathbb{R}^{N}$. Let $A C(0,+\infty)$ denote the space of absolutely continuous functions on the interval $(0,+\infty)$. For $N \geq 1$, we set $C=C\left(J, \mathbb{R}^{N}\right), C^{1}=\left\{u \in C \mid u^{\prime} \in C((0,+\infty)\right.$, $\left.\mathbb{R}^{N}\right), \lim _{t \rightarrow 0^{+}} w(t)^{1 /(p(t)-1)} u^{\prime}(t)$ exists $\}$. For any $u(t)=\left(u^{1}(t), \ldots, u^{N}(t)\right) \in C$, we denote $\left|u^{i}\right|_{0}=$ $\sup _{t \in(0,+\infty)}\left|u^{i}(t)\right|,\|u\|_{0}=\left(\sum_{i=1}^{N}\left|u^{i}\right|_{0}^{2}\right)^{1 / 2}$, and $\|u\|_{1}=\|u\|_{0}+\left\|(w(t))^{1 /(p(t)-1)} u^{\prime}\right\|_{0}$. Spaces $C$ and $C^{1}$ will be equipped with the norm $\|\cdot\|_{0}$ and $\|\cdot\|_{1}$, respectively. Then, $\left(C,\|\cdot\|_{0}\right)$ and $\left(C^{1},\|\cdot\|_{1}\right)$ are Banach spaces. Denote $L^{1}=L^{1}\left(J, \mathbb{R}^{N}\right)$ with the norm $\|u\|_{L^{1}}=\left[\sum_{i=1}^{N}\left(\int_{0}^{\infty}\left|u^{i}\right| d t\right)^{2}\right]^{1 / 2}$.

We say a function $u: J \rightarrow \mathbb{R}^{N}$ is a solution of (1.1) if $u \in C^{1}$ with $w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}$ absolutely continuous on $(0,+\infty)$, which satisfies (1.1) a.e. on $J$.

In this paper, we always use $C_{i}$ to denote positive constants, if it cannot lead to confusion. Denote

We say $f$ satisfies sub- $\left(p^{-}-1\right)$ growth condition, if $f$ satisfies

\lim _{|x|+|y|+|z|+|w| \rightarrow+\infty} \frac{f(t, x, y, z, w)}{(|x|+|y|+|z|+|w|)^{q(t)-1}}=0, \quad \text { for } t \in J \text { uniformly, } \tag{1.9}

where $q(t) \in C(J, \mathbb{R})$ and $1<q^{-} \leq q^{+}<p^{-}$. We say $f$ satisfies general growth condition, if $f$ does not satisfy sub- $\left(p^{-}-1\right)$ growth condition.

We will discuss the existence of solutions of (1.1)-(1.2) in the following three cases.
Case (i): $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma \in[0,1) ;$
Case (ii): $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma=1$;
Case (iii): $\sum_{i=1}^{m-2} \alpha_{i}=1, \sigma=1$.

This paper is divided into five sections. In the second section, we present some preliminary and give the operator equations which have the same solutions of (1.1)-(1.2) in the three cases, respectively. In the third section, we will discuss the existence of solutions of (1.1)-(1.2) when $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma \in[0,1)$, and we give the existence of nonnegative solutions. In the fourth section, we will discuss the existence of solutions of (1.1)-(1.2) when $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma=1$. In the fifth section, we will discuss the existence of solutions of (1.1)(1.2) when $\sum_{i=1}^{m-2} \alpha_{i}=1, \sigma=1$.

## 2. Preliminary

For any $(t, x) \in J \times \mathbb{R}^{N}$, denote $\varphi(t, x)=|x|^{p(t)-2} x$. Obviously, $\varphi$ has the following properties.
Lemma 2.1 (see [7]). $\varphi$ is a continuous function and satisfies the following.
(i) For any $t \in[0,+\infty), \varphi(t, \cdot)$ is strictly monotone, that is

(ii) There exists a function $\beta:[0,+\infty) \rightarrow[0,+\infty), \beta(s) \rightarrow+\infty$ as $s \rightarrow+\infty$, such that

It is well known that $\varphi(t, \cdot)$ is a homeomorphism from $\mathbb{R}^{N}$ to $\mathbb{R}^{N}$ for any fixed $t \in$ $[0,+\infty)$. For any $t \in J$, denote by $\varphi^{-1}(t, \cdot)$ the inverse operator of $\varphi(t, \cdot)$, then

\varphi^{-1}(t, x)=|x|^{(2-p(t)) /(p(t)-1)} x, \quad \text { for } x \in \mathbb{R}^{N} \backslash\{0\}, \quad \varphi^{-1}(t, 0)=0 \tag{2.3}

It is clear that $\varphi^{-1}(t, \cdot)$ is continuous and sends bounded sets into bounded sets.
Let us now consider the following problem with boundary value condition (1.2)

\left(w(t) \varphi\left(t, u^{\prime}(t)\right)\right)^{\prime}=g(t), \quad t \in(0,+\infty) \tag{2.4}
\end{equation*}

where $g \in L^{1}$.
If $u$ is a solution of (2.4) with (1.2), by integrating (2.4) from 0 to $t$, we find that

w(t) \varphi\left(t, u^{\prime}(t)\right)=w(0) \varphi\left(0, u^{\prime}(0)\right)+\int_{0}^{t} g(s) d s \tag{2.5}
\end{equation*}

Define operator $F: L^{1} \rightarrow C$ as

F(g)(t)=\int_{0}^{t} g(s) d s, \quad \forall t \in J, \forall g \in L^{1} \tag{2.6}
\end{equation*}

By solving for $u^{\prime}$ in (2.5) and integrating, we find that

u(t)=u(0)+F\left\{\varphi^{-1}\left[t,(w(t))^{-1}\left(w(0) \varphi\left(0, u^{\prime}(0)\right)+F(g)\right)\right]\right\}(t), \quad t \in J . \tag{2.7}

In the following, we will give the operator equations which have the same solutions of (1.1)-(1.2) in three cases, respectively.

### 2.1. Case (i): $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma \in[0,1)$

We denote $\rho=w(0) \varphi\left(0, u^{\prime}(0)\right)$ in (2.7). It is easy to see that $\rho$ is dependent on $g(\cdot)$, then we find that

u(t)=u(0)+F\left\{\varphi^{-1}\left[t,(w(t))^{-1}(\rho+F(g))\right]\right\}(t), \quad t \in J \tag{2.8}
\end{equation*}
$$

The boundary value condition (1.2) implies that

u(0)= & \frac{\int_{0}^{+\infty}\left\{e(t) \int_{0}^{t} \varphi^{-1}\left[r,(w(r))^{-1}(\rho+F(g)(r))\right] d r\right\} d t+e_{1}}{1-\sigma} \\
& -\frac{\int_{0}^{+\infty} \varphi^{-1}\left[r,(w(r))^{-1}(\rho+F(g)(r))\right] d r}{1-\sigma},  \tag{2.9}\\
\rho= & \frac{1}{1-\sum_{i=1}^{m-2} \alpha_{i}}\left(\sum_{i=1}^{m-2} \alpha_{i} \int_{0}^{\xi_{i}} g(s) d s-\int_{0}^{+\infty} g(s) d s+e_{2}\right) .
\end{align*}

For fixed $h \in L^{1}$, we define $\rho: L^{1} \rightarrow \mathbb{R}^{N}$ as

\rho(h)=\frac{1}{1-\sum_{i=1}^{m-2} \alpha_{i}}\left(\sum_{i=1}^{m-2} \alpha_{i} \int_{0}^{\xi_{i}} h(t) d t-\int_{0}^{+\infty} h(t) d t+e_{2}\right) . \tag{2.10}

Lemma 2.2. $\rho: L^{1} \rightarrow \mathbb{R}^{N}$ is continuous and sends bounded sets of $L^{1}$ to bounded sets of $\mathbb{R}^{N}$. Moreover,

|\rho(h)| \leq \frac{2 N}{1-\sum_{i=1}^{m-2} \alpha_{i}} \cdot\left(\|h\|_{L^{1}}+\left|e_{2}\right|\right) \tag{2.11}
\end{equation*}

Proof. Since $\rho(\cdot)$ consists of continuous operators, it is continuous. It is easy to see that

This completes the proof.

It is clear that $\rho(\cdot)$ is continuous and sends bounded sets of $L^{1}$ to bounded sets of $\mathbb{R}^{N}$, and hence it is a compact continuous mapping.

If $u$ is a solution of (2.4) with (1.2), we find that

u(0)= & \frac{\int_{0}^{+\infty}\left\{e(t) \int_{0}^{t} \varphi^{-1}\left[r,(w(r))^{-1}(\rho+F(g)(r))\right] d r\right\} d t+e_{1}}{1-\sigma}  \tag{2.13}\\
& -\frac{\int_{0}^{+\infty} \varphi^{-1}\left[r,(w(r))^{-1}(\rho+F(g)(r))\right] d r}{1-\sigma}
\end{align*}

We denote

K(h)(t):=(K \circ h)(t)=F\left\{\varphi^{-1}\left[t,(w(t))^{-1}(\rho(h)+F(h))\right]\right\}(t), \quad \forall t \in(0,+\infty) . \tag{2.14}

We say a set $U \subset L^{1}$ be equi-integrable, if there exists a nonnegative $\rho_{*} \in L^{1}(J, \mathbb{R})$, such that

Lemma 2.3. The operator $K$ is continuous and sends equi-integrable sets in $L^{1}$ to relatively compact sets in $C^{1}$.

Proof. It is easy to check that $K(h)(t) \in C^{1}$, for all $h \in L^{1}$. Since $(w(t))^{-1 /(p(t)-1)} \in L^{1}$ and

it is easy to check that $K$ is a continuous operator from $L^{1}$ to $C^{1}$.
Let now $U$ be an equi-integrable set in $L^{1}$, then there exists a nonnegative $\rho_{*} \in L^{1}(J, \mathbb{R})$, such that

We want to show that $\overline{K(U)} \subset C^{1}$ is a compact set.
Let $\left\{u_{n}\right\}$ be a sequence in $K(U)$, then there exists a sequence $\left\{h_{n}\right\} \subset U$ such that $u_{n}=K\left(h_{n}\right)$. Since $h_{n}(t)=\left(h_{n}^{1}(t), \ldots, h_{n}^{N}(t)\right)$, where $h_{n}^{i}(t) \in L^{1}(J, \mathbb{R})(i=1, \ldots, N)$, we have

\end{equation*}

then for any $t_{1}, t_{2} \in J$ with $t_{1}<t_{2}$, we have

\left|\int_{t_{1}}^{t_{2}} h_{n}(t) d t\right| & =\sqrt{\sum_{i=1}^{N}\left(\int_{t_{1}}^{t_{2}} h_{n}^{i}(t) d t\right)^{2}} \leq \sqrt{\sum_{i=1}^{N}\left(\int_{t_{1}}^{t_{2}}\left|h_{n}^{i}(t)\right| d t\right)^{2}}  \tag{2.19}\\
& \leq \sqrt{\sum_{i=1}^{N}\left(\int_{t_{1}}^{t_{2}}\left|h_{n}(t)\right| d t\right)^{2}} \leq N \int_{t_{1}}^{t_{2}}\left|h_{n}(t)\right| d t
\end{align*}

which together with (2.17) implies

\left|F\left(h_{n}\right)\left(t_{1}\right)-F\left(h_{n}\right)\left(t_{2}\right)\right| & =\left|\int_{0}^{t_{1}} h_{n}(t) d t-\int_{0}^{t_{2}} h_{n}(t) d t\right| \\
& =\left|\int_{t_{1}}^{t_{2}} h_{n}(t) d t\right| \leq N \int_{t_{1}}^{t_{2}}\left|h_{n}(t)\right| d t \leq N \int_{t_{1}}^{t_{2}} \rho_{*}(t) d t . \tag{2.20}
\end{align*}

Hence, the sequence $\left\{F\left(h_{n}\right)\right\}$ is uniformly bounded. According to the absolute continuity of Lebesgue integral, for any $\varepsilon>0$, there exists a $\delta>0$ such that if $0 \leq t_{1}-t_{2}<\delta$, then we have $0 \leq N \int_{t_{1}}^{t_{2}} \rho_{*}(t) d t<\varepsilon$. Thus, (2.20) means that $\left\{F\left(h_{n}\right)\right\}$ is equicontinuous.

Denote $\Omega_{m}=[0, m]$. Obviously, $\left\{F\left(h_{n}\right)\right\}$ is uniformly bounded and equicontinuous on $\Omega_{m}$ for $m=1,2, \ldots$ By Ascoli-Arzela Theorem, there exists a subsequence $\left\{F\left(h_{n}^{(1)}\right)\right\}$ of $\left\{F\left(h_{n}\right)\right\}$ being convergent in $C\left(\Omega_{1}\right)$, we may assume $F\left(h_{n}^{(1)}\right) \rightarrow v_{1}(\cdot)$ in $C\left(\Omega_{1}\right)$. Since $\left\{F\left(h_{n}^{(1)}\right)\right\}$ is uniformly bounded and equicontinuous on $\Omega_{2}$, there exists a subsequence $\left\{F\left(h_{n}^{(2)}\right)\right\}$ of $\left\{F\left(h_{n}^{(1)}\right)\right\}$ such that $\left\{F\left(h_{n}^{(2)}\right)\right\}$ is convergent in $C\left(\Omega_{2}\right)$, we may assume $F\left(h_{n}^{(2)}\right) \rightarrow v_{2}(\cdot)$ in $C\left(\Omega_{2}\right)$. Obviously, $v_{2}(t)=v_{1}(t)$, for any $t \in \Omega_{1}$. Repeating the process, we get a subsequence $\left\{F\left(h_{n}^{(m+1)}\right)\right\}$ of $\left\{F\left(h_{n}^{(m)}\right)\right\}$ such that $\left\{F\left(h_{n}^{(m+1)}\right)\right\}$ is convergent in $C\left(\Omega_{m+1}\right)$, we may assume $F\left(h_{n}^{(m+1)}\right) \rightarrow$ $v_{m+1}(\cdot)$ in $C\left(\Omega_{m+1}\right)$. Obviously, $v_{m+1}(t)=v_{m}(t)$ for any $t \in \Omega_{m}$. Select the diagonal element, we can see that $\left\{F\left(h_{n}^{(n)}\right)\right\}$ is a subsequence of $\left\{F\left(h_{n}\right)\right\}$ which satisfies that $\left\{F\left(h_{n}^{(n)}\right)\right\}$ is convergent in $C\left(\Omega_{m}\right)(m=1,2, \ldots)$ and $F\left(h_{n}^{(n)}\right) \rightarrow v_{m}(\cdot)$ in $C\left(\Omega_{m}\right)(m=1,2, \ldots)$. Thus, we get a function $v$ which is defined on $[0,+\infty)$ such that $v(t)=v_{m}(t)$ for any $t \in \Omega_{m}$, and $F\left(h_{n}^{(n)}\right) \rightarrow v(\cdot)$ in $C\left(\Omega_{m}\right)(m=1,2, \ldots)$.

From (2.20), it is easy to see that for any $n=1,2, \ldots, \lim _{t \rightarrow \infty} F\left(h_{n}\right)(t)$ exists (we denote the limit by $F\left(h_{n}^{(n)}\right)(+\infty)$ ), and, for any $\varepsilon>0$, there exists an integer $R_{\varepsilon}>0$ such that $\int_{R_{\varepsilon}}^{+\infty} \rho_{*}(t) d t<\varepsilon / N$, and then

From (i), we get $\rho_{0}=\rho_{2}(u)$, it means that $\rho_{2}$ is continuous. This completes the proof.

It is clear that $\rho_{2}(\cdot)$ is continuous and sends bounded sets of $L^{1}$ to bounded sets of $\mathbb{R}^{N}$, and, hence, it is a compact continuous mapping.

## 3. Existence of Solutions in Case (i)

In this section, we will apply Leray-Schauder's degree to deal with the existence of solutions for (1.1)-(1.2) when $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma \in[0,1)$. Moreover, we give the existence of nonnegative solutions.

Theorem 3.1. In Case ( $i$ ), if $f$ satisfies sub-( $p^{-}-1$ ) growth condition, then problem (1.1)-(1.2) has at least a solution for any fixed parameter $\delta$.

Proof. Denote $\Psi_{f}(u, \lambda):=P\left(\lambda \delta N_{f}(u)\right)+K\left(\lambda \delta N_{f}(u)\right)$, where $N_{f}(u)$ is defined in (2.32). We know that (1.1)-(1.2) has the same solution of

It is easy to see that the operator $P$ is compact continuous. According to Lemmas 2.2 and 2.3, we can see that $\Psi_{f}(\cdot, \cdot)$ is compact continuous from $C^{1} \times[0,1]$ to $C^{1}$.

We claim that all the solutions of (3.1) are uniformly bounded for $\lambda \in[0,1]$. In fact, if it is false, we can find a sequence of solutions $\left\{\left(u_{n}, \lambda_{n}\right)\right\}$ for (3.1) such that $\left\|u_{n}\right\|_{1} \rightarrow+\infty$ as $n \rightarrow+\infty$ and $\left\|u_{n}\right\|_{1}>1$ for any $n=1,2, \ldots$.

From Lemma 2.2, we have

Thus, the Leray-Schauder degree $d_{\mathrm{LS}}\left[I-\Psi_{f}(\cdot, \lambda), B\left(R_{0}\right), 0\right]$ is well defined for each $\lambda \in[0,1]$, and

Theorem 3.2. In the Case ( $i$ ), assume that $f$ satisfies general growth condition and $\left(\mathrm{A}_{1}\right)$ is satisfied, then the problem (1.1)-(1.2) has at least one solution on $\overline{\Omega_{\varepsilon}}$ when the positive parameter $\delta$ is small enough.

Proof. Denote $\Psi_{f}(u, \lambda)=P\left(\lambda \delta N_{f}(u)\right)+K\left(\lambda \delta N_{f}(u)\right)$. According to Lemma 2.4, $u$ is a solution of

then we can conclude that the system (1.1)-(1.2) has a solution on $\overline{\Omega_{\varepsilon}}$.
$\left(1^{\circ}\right)$ If there exists a $\lambda \in[0,1)$ and $u \in \partial \Omega_{\varepsilon}$ is a solution of (3.15) with (1.2), then $(\lambda, u)$ satisfies

& \leq w\left(t_{2}\right)\left|u^{\prime}\left(t_{2}\right)\right|^{p\left(t_{2}\right)-2}\left|\left(u^{i}\right)^{\prime}\left(t_{2}\right)\right| \leq\left|\rho\left(\lambda \delta N_{f}\right)\right|+\lambda\left|\delta F\left(N_{f}\right)\left(t_{2}\right)\right| .

&=\frac{1}{1-\sum_{i=1}^{m-2} \alpha_{i}}\left(-\sum_{i=1}^{m-2} \alpha_{i} \int_{\xi_{i}}^{+\infty} \delta N_{f}(u)(r) d r-\left(1-\sum_{i=1}^{m-2} \alpha_{i}\right) \int_{t}^{+\infty} \delta N_{f}(u)(r) d r+e_{2}\right) \\

## 4. Existence of Solutions in Case (ii)

In this section, we will apply Leray-Schauder's degree to deal with the existence of solutions for (1.1)-(1.2) when $\sum_{i=1}^{m-2} \alpha_{i} \in[0,1), \sigma=1$.

Theorem 4.1. Assume that $\Omega$ is an open bounded set in $C^{1}$ such that the following conditions hold.

has no solution on $\partial \Omega$.

( $3^{0}$ ) The Brouwer degree $d_{B}\left[\omega, \Omega \cap \mathbb{R}^{N}, 0\right] \neq 0$.
Then, problems (1.1)-(1.2) have a solution on $\bar{\Omega}$.
Proof. For any $\lambda \in(0,1]$, it is easy to have problem (4.1) can be written in the equivalent form

It is easy to see that the operator $P_{1}$ is compact continuous. According to Lemmas 2.5 and 2.6, we can conclude that $\Phi_{f}$ is continuous and compact from $C^{1} \times[0,1]$ to $C^{1}$. We assume that for $\lambda=1,(4.3)$ does not have a solution on $\partial \Omega$, otherwise we complete the proof. Now from hypothesis $\left(1^{0}\right)$, it follows that (4.3) has no solutions for $(u, \lambda) \in \partial \Omega \times(0,1]$.

For $\lambda \in[0,1]$, if $u$ is a solution of (4.3), we have

$\left(4^{0}\right)$ the Brouwer degree $d_{B}\left[\omega_{g}, b\left(R_{0}\right), 0\right] \neq 0$ for large enough $R_{0}>0$, where $b\left(R_{0}\right)=\left\{x \in \mathbb{R}^{N}\right.$ $\left||x|<R_{0}\right\}$.
Then, problem (4.14) with (1.2) has at least one solution.

## 5. Existence of Solutions in Case (iii)

In this section, we will apply Leray-Schauder's degree to deal with the existence of solutions for (1.1)-(1.2) when $\sum_{i=1}^{m-2} \alpha_{i}=1, \sigma=1$.

Theorem 5.1. Assume that $\Omega$ is an open bounded set in $C^{1}$ such that the following conditions hold.

\lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}(t)=\sum_{i=1}^{m-2} \alpha_{i} w\left(\xi_{i}\right)\left|u^{\prime}\right|^{p\left(\xi_{i}\right)-2} u^{\prime}\left(\xi_{i}\right)+\lambda e_{2}
\end{gather*}
$$

has no solution on $\partial \Omega$.
( $2^{0}$ ) The equation

\omega^{*}(a):=\sum_{i=1}^{m-2} \alpha_{i} \int_{\xi_{i}}^{+\infty} \delta f(t, a, 0, S(a), T(a)) d t-e_{2}=0 \tag{5.2}
\end{equation*}

has no solution on $\partial \Omega \cap \mathbb{R}^{N}$.
$\left(3^{0}\right)$ The Brouwer degree $d_{B}\left[\omega^{*}, \Omega \cap \mathbb{R}^{N}, 0\right] \neq 0$.
Then, problems (1.1)-(1.2) have a solution on $\bar{\Omega}$.

Proof. Let us consider the following problem:

For any $\lambda \in(0,1]$, observe that, if $u$ is a solution to (5.1) or $u$ is a solution to (5.3), we have necessarily

Q_{\lambda}: L^{1} \longrightarrow \mathbb{R}^{N}, \quad h \longmapsto \sum_{i=1}^{m-2} \alpha_{i} \int_{\xi_{i}}^{+\infty} h(t) d t-\lambda e_{2} \\
Q_{\lambda}^{*}: L^{1} \longrightarrow L^{1}, \quad h \longmapsto \tau(t)\left(\sum_{i=1}^{m-2} \alpha_{i} \int_{\xi_{i}}^{+\infty} h(t) d t-\lambda e_{2}\right),  \tag{5.7}\\
K_{2}^{\lambda}(h)(t):=F\left\{\varphi^{-1}\left[t,(w(t))^{-1}\left(\rho_{2}^{\lambda}\left(\left(I-Q_{\lambda}^{*}\right) h\right)+F\left(\left(I-Q_{\lambda}^{*}\right) h\right)\right)\right]\right\}(t), \quad \forall t \in[0,+\infty),

According to Lemmas 2.8 and 2.9 , we can conclude that $\Phi_{f}^{*}(\cdot, \cdot)$ is continuous and compact from $C^{1} \times[0,1]$ to $C^{1}$. We assume that for $\lambda=1,(5.9)$ does not have a solution on $\partial \Omega$, otherwise we complete the proof. Now, from hypothesis $\left(1^{0}\right)$, it follows that (5.9) has no solutions for $(u, \lambda) \in \partial \Omega \times$ $(0,1]$. For $\lambda=0$, (5.3) is equivalent to the problem

It is easy to see that $\left(u^{i}\right)^{\prime}$ keeps the same sign of $c^{i}$. From $u(+\infty)=\int_{0}^{+\infty} e(t) u(t) d t$, we have $\int_{0}^{+\infty} e(t)(u(+\infty)-u(t)) d t=0$. From the continuity of $u$, there exist $t_{i} \in(0,+\infty)$, such that $\left(u^{i}\right)^{\prime}\left(t_{i}\right)=0, i=1, \ldots, N$. Hence, $u^{\prime} \equiv 0$, it holds $u \equiv d$, a constant. Thus, by (5.11), we have

Thus, $\rho_{2}^{0}(0)=0$, then $K_{2}^{0}(0) \equiv 0$. From (5.18), we have

Our next theorem is a consequence of Theorem 5.1. As an application of Theorem 5.1. Let us consider the following equation with (1.2)

where $b: J \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \rightarrow \mathbb{R}^{N}$ is Caratheodory, $g=\left(g^{1}, \ldots, g^{N}\right): J \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times$ $\mathbb{R}^{N} \times \mathbb{R}^{N} \rightarrow \mathbb{R}^{N}$ is continuous and Caratheodory, and, for any fixed $y_{0} \in \mathbb{R}^{N} \backslash\{0\}$, if $y_{0}^{i} \neq 0$, then $g^{i}\left(t, y_{0}, 0, S\left(y_{0}\right), T\left(y_{0}\right)\right) \neq 0$, for all $t \in J$, for all $i=1, \ldots, N$.

Theorem 5.2. Assume that the following conditions hold.

(2 $\left.2^{0}\right) \lim _{|x|+|y|+|z|+|w| \rightarrow+\infty}\left(b(t, x, y, z, w) /(|x|+|y|+|z|+|w|)^{q(t)-1}\right)=0$, for $t \in J$ uniformly,
$\left(3^{0}\right)$ for large enough $R_{0}>0$, the equation

has no solution on $\partial B\left(R_{0}\right) \cap \mathbb{R}^{N}$, where $B\left(R_{0}\right)=\left\{u \in C^{1}\|u\|_{1}<R_{0}\right\}$,
$\left(4^{0}\right)$ the Brouwer degree $d_{B}\left[\omega_{g^{*}}^{*}, b\left(R_{0}\right), 0\right] \neq 0$ for large enough $R_{0}>0$, where $b\left(R_{0}\right)=\left\{x \in \mathbb{R}^{N}\right.$ $\left||x|<R_{0}\right\}$.

Then, problem (5.22) with (1.2) has at least one solution.
Proof. Denote

Similar to the proof of Theorem 4.2, we obtain that all the solutions of (5.26) are uniformly bounded for $\lambda \in[0,1]$. Then, there exists a big enough $R_{0}>0$ such that all the solutions of (5.26) belong to $B\left(R_{0}\right)$, and then we have

If we prove that $d_{\mathrm{LS}}\left[I-\widetilde{\Phi}_{f}(\cdot, 0), B\left(R_{0}\right), 0\right] \neq 0$, then we obtain the existence of solutions for (5.22) with (1.2).

Now, we consider the following equation

\left(w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}\right)^{\prime}=\lambda N_{g}(u)+(1-\lambda) Q^{*} N_{g}(u), \quad t \in(0,+\infty), \\
u(+\infty)=\int_{0}^{+\infty} e(t) u(t) d t+\lambda e_{1},  \tag{5.28}\\
\lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{(t)-2} u^{\prime}(t)=\sum_{i=1}^{m-2} \alpha_{i} w\left(\xi_{i}\right)\left|u^{\prime}\right|^{\prime\left(\xi_{i}\right)-2} u^{\prime}\left(\xi_{i}\right)+\lambda e_{2},
\end{gather*}
$$

where $N_{g}(u)=g\left(t, u,(w(t))^{1 /(p(t)-1)} u^{\prime}, S(u), T(u)\right)$.
We denote $G(\cdot, \cdot): C^{1} \times J \rightarrow L^{1}$ defined by

G(u, \lambda)=\lambda N_{g}(u)+(1-\lambda) Q^{*}\left(N_{g}(u)\right) . \tag{5.29}
\end{equation*}

Similar to the proof of Theorem 5.1, we know that (5.28) has the same solution of

Similar to the discussions of Theorem 4.2, we can obtain that all the solutions of (5.28) are uniformly bounded for each $\lambda \in(0,1]$. When $\lambda=0$, similar to the proof of Theorem 5.1, we can prove that (5.28) has no solution on $\partial B\left(R_{0}\right)$. Then, we get that the Leray-Schauder degree $d_{\mathrm{LS}}\left[I-\Phi_{g}^{*}(\cdot, \lambda), B\left(R_{0}\right), 0\right]$ is well defined for $\lambda \in[0,1]$, which implies that

Now it is clear that $\Phi_{g}^{*}(u, 1)=\widetilde{\Phi}_{f}(u, 0)$. So $d_{\mathrm{LS}}\left[I-\Phi_{g}^{*}(\cdot, 1), B\left(R_{0}\right), 0\right]=d_{\mathrm{LS}}\left[I-\widetilde{\Phi}_{f}(\cdot, 0)\right.$, $\left.B\left(R_{0}\right), 0\right]$. If we prove that $d_{\mathrm{LS}}\left[I-\Phi_{g}^{*}(\cdot, 0), B\left(R_{0}\right), 0\right] \neq 0$, then we obtain the existence of solutions for (5.22) with (1.2). Similar to the proof of Theorem 5.1, we have

According to hypothesis $\left(4^{0}\right)$, this last degree is different from zero. We obtain that (5.22) with (1.2) has at least one solution. This completes the proof.

Similar to Corollary 4.3 and Theorem 4.4, we have the following.
Corollary 5.3. If b: $J \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \times \mathbb{R}^{N} \rightarrow \mathbb{R}^{N}$ is Caratheodory, which satisfies the conditions of Theorem 5.2, $g(t, u, v, S(u), T(u))=\beta(t)\left(|u|^{q(t)-2} u+|v|^{q(t)-2} v+|S(u)|^{q(t)-2} S(u)+\right.$ $\left.|T(u)|^{q(t)-2} T(u)\right)$, where $\beta(t) \in L^{1}(J, \mathbb{R}), \beta(t), q(t) \in C(J, \mathbb{R})$ are positive functions, and satisfies $1<$ $q^{-} \leq q^{+}<p^{-}, \psi(s, t)$ and $\chi(s, t)$ are nonnegative, then (5.22) with (1.2) has at least one solution.

Theorem 5.4. We assume that conditions of $\left(1^{0}\right),\left(3^{0}\right)$, and $\left(4^{0}\right)$ of Theorem 5.2 are satisfied, then problem (4.48) with (1.2) has at least one solution when the parameter $\delta$ is small enough.

## 6. Examples

Example 6.1. Consider the following problem

\lim _{t \rightarrow+\infty} u(t)= & \int_{0}^{+\infty} e^{-t} u(t) d t, \quad \lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}(t)=\sum_{i=1}^{m-2} \alpha_{i} w\left(\xi_{i}\right)\left|u^{\prime}\right|^{p\left(\xi_{i}\right)-2} u^{\prime}\left(\xi_{i}\right), \tag{1}
\end{align*}
$$

where $p(t)=6+e^{-t} \sin t, q(t)=3+2^{-t} \cos t, S(u)(t)=\int_{0}^{\infty} e^{-2 s-t}(\sin s t+1) u(s) d s$.
Obviously, $e^{-t}|u|^{q(t)-2} u+S(u)(t)+(t+1)^{-2}$ is Caratheodory, $q(t) \leq 4<5 \leq p(t), \sum_{i=1}^{m-2} \alpha_{i}<$ 1 , the conditions of Corollary 4.3 are satisfied, then $\left(S_{1}\right)$ has a solution.

Example 6.2. Consider the following problem:

& \lim _{t \rightarrow+\infty} u(t)=\int_{0}^{+\infty} e^{-2 t} u(t) d t, \quad \lim _{t \rightarrow+\infty} w(t)\left|u^{\prime}\right|^{p(t)-2} u^{\prime}(t)=\sum_{i=1}^{m-2} \alpha_{i} w\left(\xi_{i}\right)\left|u^{\prime}\right|^{p\left(\xi_{i}\right)-2} u^{\prime}\left(\xi_{i}\right),
\end{align*}
$$

where $h$ is Caratheodory and

& f\left(t, u,(w(t))^{1 /(p(t)-1)} u^{\prime}, S(u)\right)=e^{-t}|u|^{q(t)-2} u+e^{-t} w(t)^{(q(t)-1) /(p(t)-1)}\left|u^{\prime}\right|^{q(t)-2} u^{\prime}+S(u)(t), \\
& p(t)=7+3^{-t} \cos 3 t, \quad q(t)=4+e^{-2 t} \sin 2 t, \quad S(u)(t)=\int_{0}^{\infty} e^{-s-2 t}(\cos s t+1) u(s) d s . \tag{6.1}
\end{align*}
$$

Obviously, $e^{-t}|u|^{q(t)-2} u+e^{-t} w(t)^{(q(t)-1) /(p(t)-1)}\left|u^{\prime}\right|^{q(t)-2} u^{\prime}+S(u)(t)$ is Caratheodory, $q(t) \leq$ $5<6 \leq p(t), \sum_{i=1}^{m-2} \alpha_{i}<1$, the conditions of Theorem 3.2 are satisfied, then $\left(S_{2}\right)$ has a solution when $\delta$ is small enough.
