## Convergence of Infinite Family of Multivalued Quasi-Nonexpansive Mappings Using Multistep Iterative Processes

We prove strong and weak convergence results using multistep iterative sequences for countable family of multivalued quasinonexpansive mappings by using some conditions in uniformly convex real Banach space. The results presented extended and improved the corresponding result of Zhang et al. (2013), Bunyawat and Suantai (2012), and some others from finite family, one countable family, and two countable families to k-number of countable families of multivalued quasi-nonexpansive mappings. Also we used a numerical example in C++ computational programs to prove that the iterative scheme we used has better rate of convergence than other existing iterative schemes.

### 1. Introduction

Let X be real Banach space. The convex subset K is called proximal set if for each  $x \in X$  there exists at least one  $y \in K$  such that  $\|x - y\| = d(x, K) = \inf\{\|x - k\| : k \in K\}$ . Every closed convex subset of uniformly convex Banach spaces is proximal. We use the following notations for multivalued mappings:

C(X): collection of all nonempty compact subsets of X;

P(X): collection of all nonempty proximal bounded subsets of X;

CB(X): collection of all nonempty bounded closed subsets of X.

Let H be Hausdorff metric induced by d of K defined as  $H(A,B) = \max\{\sup_{y \in B} d(x,B), \sup_{x \in A} d(A,y)\}$ , for every  $A, B \in CB(K)$ . Let  $T: K \to P(K)$ ; a multivalued mapping is said to be nonexpansive if  $H(Tx,Ty) \leq \|x-y\|$ , for all  $x,y \in K$ . An element  $p \in K$  is called fixed point of T if  $p \in T(p)$ , where the set of all fixed points of T is denoted by  $F_T$ . The mapping T is said to be quasi nonexpansive if

 $F_T \neq \emptyset$  and  $H(Tx,Tp) \leq \|x-p\|$  for all  $x \in K$  and  $p \in F_T$ . It is known that every nonexpansive multivalued mapping with  $F_T \neq \emptyset$  is quasi nonexpansive, but there exist quasi-nonexpansive mappings which are not nonexpansive. It is well known that if T is quasi-nonexpansive mapping, then  $F_T$  is closed.

Definition 1. A map  $T: K \to CB(K)$  is called hemicompact if, for any sequence  $\{x_n\}$  in K such that  $d(x_n, Tx_n) \to 0$  as  $n \to \infty$ , there exists a subsequence  $\{x_{n_k}\}$  of  $\{x_n\}$  such that  $x_{n_k} \to p \in K$ . It is clear that if K is compact, then every multivalued mapping T is hemicompact.

Definition 2. A Banach space X is said to satisfy Opial's condition if  $z \neq y$  imply that

$$\lim_{n \to \infty} \sup \|x_n - z\| < \lim_{n \to \infty} \sup \|x_n - y\|. \tag{1}$$

The study of multivalued nonexpansive mappings is harder than the corresponding theory of single-valued nonexpansive mappings. In 1969, Nadler Jr. [1] proved the convergence theorem for multivalued contraction mappings. Then in 1973, Markin [2] studied the multivalued contraction and nonexpansive mappings in Hausdorff metric space. Later in

1997, Hu et al. [3] proved the convergence theorems for finding common fixed point of two multivalued nonexpansive mappings that satisfies certain contractive conditions. Sastry and Babu [4] proved the convergence of Mann and Ishikawa iterates to a fixed point q of the multivalued mapping T with fixed point p under certain conditions. They proved with the help of example that limit of the sequence is different from the point of initial choice. Then Abbas et al. [5] introduced the new one-step iterative processes to compute the common fixed point of two multivalued nonexpansive mappings in a real uniformly convex Banach space. Let  $S, T: K \to P(K)$  be two multivalued nonexpansive mappings. They introduced iteration as follows:

$$x_{n+1} = a_{n}x_{n} + b_{n}y_{n} + c_{n}z_{n}, \quad n \in N,$$

where  $y_n \in Tx_n$ ,  $z_n \in Sx_n$ , such that  $||y_n - p|| \le d(p, Sx_n)$  and  $||z_n - p|| \le d(p, Tx_n)$  for  $p \in F(S) \cap F(T)$  and  $a_n, b_n, c_n \in (0, 1)$  satisfying  $a_n + b_n + c_n \le 1$ . Then they obtained strong convergence theorems for the proposed process under some basic boundary conditions.

In 2012 Bunyawat and Suantai [6] introduced the one-step iterative process as follows:

$$x_{n+1} = \alpha_{n,0} x_n + \sum_{i=1}^{\infty} \alpha_{n,i} x_{n,i},$$

where the sequence  $\{\alpha_{n,i}\}_{i=0}^{\infty} \subset [0,1)$  satisfying  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$  and  $x_{n,i} \in T_i x_n$  such that  $d(p, x_{n,i}) = d(p, T_i x_n)$  for  $i \in N$ . They proved the convergence of iterative processes to common fixed point of countable family of multivalued quasi-nonexpansive mappings in uniformly convex Banach space.

Then Zhang et al. in 2013 introduced the two-step iterative process as follows:

$$x_{n+1} = \alpha_{n,0} x_n + \sum_{i=1}^{\infty} \alpha_{n,i} y_{n,i},$$

$$y_n = \beta_{n,0} x_n + \sum_{i=1}^{\infty} \beta_{n,i} x_{n,i},$$

where the sequences  $\{\alpha_{n,i}\}_{i=0}^{\infty}$ ,  $\{\beta_{n,i}\}_{i=0}^{\infty} \subset [0,1)$  satisfying  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$ ,  $\sum_{i=0}^{\infty} \beta_{n,i} = 1$ ,  $y_{n,i} \in T_i y_n$  such that  $d(p,y_{n,i}) = d(p,T_i y_n)$  and  $x_{n,i} \in T_i x_n$  such that  $d(p,x_{n,i}) = d(p,T_i x_n)$  for  $i \in N$ . Zhang et al. extended the results of Bunyawat and Suantai from one countable family to two countable families and also gave a new proof for the iteration used in the paper of Abbas et al. [5].

In the same year Ahmed and Altwqi introduced the threestep iterative process as follows:

$$x_{n+1} = \alpha_{n,0} x_n + \sum_{i=1}^{p} \alpha_{n,i} y_{n,i},$$

$$y_n = \beta_{n,0} x_n + \sum_{i=1}^{p} \beta_{n,i} z_{n,i},$$

$$z_n = \gamma_{n,0} x_n + \sum_{i=1}^{p} \gamma_{n,i} x_{n,i},$$

where  $z_{n,i} \in T_i z_n$ ,  $y_{n,i} \in T_i y_n$ , and  $x_{n,i} \in T_i x_n$  and the sequences  $\{\alpha_{n,i}\}_{i=0}^p, \{\beta_{n,i}\}_{i=0}^p, \{\gamma_{n,i}\}_{i=0}^p \subset [0,1)$  satisfying  $\sum_{i=0}^p \alpha_{n,i} = 1 \sum_{i=0}^p \beta_{n,i} = 1, \sum_{i=0}^p \gamma_{n,i} = 1$ , and proved the strong and weak convergence results for three finite families of multivalued nonexpansive mappings.

Different iterative processes have been used to approximate fixed points of multivalued mappings. Many authors have intensively studied the fixed point theorems and got some results. At the same time, they extended these results to many discipline branches, such as control theory, convex optimization, variational inequalities, differential inclusion, and economics (see [7–19]).

Motivated by [6, 20–22], in this paper, we extended the result of Zhang et al. [21] from two countable families to *k*-number of countable families and proved weak and strong convergence results of two new multistep iterative processes to common fixed point of countable family of multivalued quasi-nonexpansive mappings in a uniformly convex Banach space. Also with the help of numerical example we compare the convergence step of two different multistep iterative processes. We use the following iteration processes:

$$x_{n+1} = \alpha_{n,0} x_n + \sum_{i=1}^{\infty} \alpha_{n,i} u_{n,i}^{1},$$

$$y_n^{j} = \beta_{n,0}^{j} x_n + \sum_{i=1}^{\infty} \beta_{n,i}^{j} u_{n,i}^{j+1}, \quad j = 1, 2, \dots, k-2,$$

$$y_n^{k-1} = \beta_{n,0}^{k-1} x_n + \sum_{i=1}^{\infty} \beta_{n,i}^{k-1} u_{n,i}^{k},$$

$$x_{n+1} = \alpha_{n,0} y_n^{1} + \sum_{i=1}^{\infty} \alpha_{n,i} u_{n,i}^{1},$$

$$y_n^{j} = \beta_{n,0}^{j} y_n^{j+1} + \sum_{i=1}^{\infty} \beta_{n,i}^{j} u_{n,i}^{j+1}, \quad j = 1, 2, \dots, k-2,$$

$$y_n^{k-1} = \beta_{n,0}^{k-1} x_n + \sum_{i=1}^{\infty} \beta_{n,i}^{k-1} u_{n,i}^{k},$$

where  $u_{n,i}^{j} \in T_{i}^{j} y_{n}^{j}$ , j = 1, 2, ..., k - 1 such that  $d(p, u_{n,i}^{j}) = d(p, T_{i}^{j} y_{n}^{j})$ , j = 1, 2, ..., k - 1 and  $u_{n,i}^{k} \in T_{i}^{k} x_{n}$  such that  $d(p, u_{n,i}^{k}) = d(p, T_{i}^{k} x_{n})$ ,  $\{\alpha_{n,i}\}_{i=0}^{\infty}$ , and  $\{\beta_{n,i}^{j}\}_{i=0}^{\infty}$ , j = 1, 2, ..., k - 1 are sequences in [0, 1] which satisfies  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$  and

Remark 3. If k = 1 and 2, then multistep iteration (6) reduces to one-step and two-step iterations (3) and (4) defined by Bunyawat and Suantai and Zhang et al. whereas for k = 3, i = p multistep iteration (6) reduces to finite three-step iteration (5) defined by Ahmed and Altwqi.

**Lemma 4** (see [6]). Let X be a uniformly convex Banach space, r > 0 a positive number, and  $B_r(0)$  a closed ball of X. Then, for any given sequence  $\{x_n\}_{n=1}^{\infty} \subset B_r(0)$  and for any given sequence  $\{\lambda_i\}_{i=1}^{\infty}$  of positive number with  $\sum_{n=1}^{\infty} \lambda_n = 1$ , there exists a continuous, strictly increasing, and convex function  $g:[0,2r) \to [0,\infty)$  with g(0)=0 such that, for any positive integer i,j with  $i \neq j$ 

$$\left\| \sum_{n=1}^{\infty} \lambda_n x_n \right\|^2 \le \sum_{n=1}^{\infty} \lambda_n \left\| x_n \right\|^2 - \lambda_i \lambda_j g\left( \left\| x_i - x_j \right\| \right). \tag{8}$$

**Lemma 5** (see [23]). Suppose that X is a uniformly convex Banach space and 0 for all positive integers <math>n. Also suppose that  $\{x_n\}$  and  $\{y_n\}$  are two sequences of E such that  $\limsup_{n\to\infty} \|x_n\| \le r$ ,  $\limsup_{n\to\infty} \|y_n\| \le r$ , and  $\limsup_{n\to\infty} \|tx_n + (1-t)y_n\| = r$  hold for some  $r \ge 0$ ; then  $\lim_{n\to\infty} \|x_n - y_n\| = 0$ .

**Lemma 6** (see [24, 25]). Let  $\{a_n\}$  be a sequence of nonnegative real numbers satisfying the following property:  $a_{n+1} \le (1 - t_n)a_n + b_n + t_nc_n$ , where  $\{t_n\}$ ,  $\{b_n\}$ , and  $\{c_n\}$  satisfy the following restrictions:

- (i)  $\sum_{n=1}^{\infty} t_n = \infty$ ;
- (ii)  $\sum_{n=1}^{\infty} b_n < \infty$ ;
- (iii)  $\limsup_{n\to\infty} c_n \le 0$ .

Then,  $\{a_n\}$  converges to zero as  $n \to \infty$ .

### 2. Main Results

2.1. Weak and Strong Convergence Results for New Multistep Iterative Scheme (6)

**Theorem 7.** Let K be a nonempty closed convex subset of a uniformly convex Banach space X with Opial's condition. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be k sequences of multivalued quasi-nonexpansive mappings from K into P(K) with  $F = \bigcap_{j=1}^k [\bigcap_{i=1}^\infty T_i^j] \neq \emptyset$  and  $p \in F$ . Let  $\{x_n\}$  be the sequence defined by (6) and then it converges weakly to a point  $q \in F$ .

*Proof.* Let  $p \in F$ ; first we prove that  $\{x_n\}$  is bounded and  $\lim_{n \to \infty} ||x_n - p||$  exists. Now from Lemma 5 and (6), we have

From (6), we get

So from (15), we say that  $\{\|x_n - p\|\}$  is nondecreasing and bounded and hence,  $\{x_n\}$  is bounded and  $\lim_{n\to\infty} ||x_n-p||$ 

Now we prove that  $\lim_{n\to\infty} ||x_n - u_{n,m}^k|| = 0$  and  $\lim_{n\to\infty} \|y_n^j - u_{n,m}^j\| = 0$ , where j = 1, 2, ..., k-1. From (15), we can write as

Since we assume that  $\limsup_{n\to\infty}\alpha_{n,0}<1$ ,  $\limsup_{n\to\infty}\beta_{n,0}^j<1$ ,  $j=1,2,\ldots,k-2$ ,  $\liminf_{n\to\infty}\alpha_{n,0}\alpha_{n,0}$ ,  $\alpha_{n,m}>0$ ,  $\liminf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0$ ,  $j=1,2,\ldots,k-1$ , and  $\lim_{n\to\infty}\|x_n-x_n\|$  $p\|$  exist, we have  $\lim_{n\to\infty} g(\|x_n - u_{n,m}^k\|) = 0$  and from the continuity of *q*, we have

$$\lim_{n \to \infty} \left\| x_n - u_{n,m}^k \right\| = 0, \quad \text{for each } m \in \mathbb{N}.$$
 (17)

Now we will prove that  $\lim_{n\to\infty} ||x_n - u_{n,m}^j|| = 0$ , for each  $j = 1, 2, \ldots, k - 1.$ 

From (9) and (10), we have

$$\|y_n^{k-2} - p\|^2 \le \|x_n - p\|^2 - \beta_{n,0}^{k-2} \beta_{n,m}^{k-2} g(\|x_n - u_{n,m}^{k-1}\|).$$
 (18)

Now, by putting (10) in (12), we have

$$\|y_{n}^{k-3} - p\|^{2} \le \|x_{n} - p\|^{2} - (1 - \beta_{n,0}^{k-3}) \beta_{n,0}^{k-2} \beta_{n,m}^{k-2} g(\|x_{n} - u_{n,m}^{k-1}\|).$$
(19)

Now continuing like this at last, we have

$$\|x_{n+1} - p\|^{2} \leq \|x_{n} - p\|^{2}$$

$$- (1 - \alpha_{n,0}) (1 - \beta_{n,0}^{1}) \cdots (1 - \beta_{n,0}^{k-3}) \qquad (20)$$

$$\times \beta_{n,0}^{k-2} \beta_{n,k}^{k-2} g(\|x_{n} - u_{n,m}^{k-1}\|);$$

we can write it as

$$(1 - \alpha_{n,0}) \left( 1 - \beta_{n,0}^{1} \right) \cdots \left( 1 - \beta_{n,0}^{k-3} \right) \beta_{n,0}^{k-2} \beta_{n,k}^{k-2} g \left( \left\| x_{n} - u_{n,m}^{k-1} \right\| \right)$$

$$\leq \left\| x_{n} - p \right\|^{2} - \left\| x_{n+1} - p \right\|^{2}. \tag{21}$$

Since we assume that  $\limsup_{n\to\infty}\alpha_{n,0}<1$ ,  $\limsup_{n\to\infty}\beta_{n,0}^j<1$ ,  $j=1,2,\ldots,k-2$ ,  $\liminf_{n\to\infty}\alpha_{n,0}\alpha_{n,m}>0$ ,  $\liminf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0$ ,  $j=1,2,\ldots,k-1$ , and  $\lim_{n\to\infty}\|x_n-p\|$  exists, we have  $\lim_{n\to\infty}g(\|x_n-u_{n,m}^{k-1}\|)=0$  and from the continuity of g, we have

$$\lim_{n \to \infty} ||x_n - u_{n,m}^{k-1}|| = 0, \quad \text{for each } m \in \mathbb{N}.$$
 (22)

So by repeating these steps for different values of j = 1, 2, ..., k-2, we have

$$\lim_{n \to \infty} \|x_n - u_{n,m}^j\| = 0, \quad \text{for each } m \in \mathbb{N},$$

$$\text{where } j = 1, 2, \dots, k - 1.$$

Next, we prove that  $\lim_{n\to\infty} \|y_n^j - u_{n,m}^j\| = 0$ , for each  $m \in N$ , where j = 1, 2, ..., k - 1.

From (6), we have

$$\|x_{n} - y_{n}^{j}\| = \|\beta_{n,0}^{j} x_{n} + \sum_{i=1}^{\infty} \beta_{n,i}^{j} u_{n,i}^{j+1} - x_{n}\|$$

$$\leq \sum_{i=1}^{\infty} \beta_{n,i}^{j} \|x_{n} - u_{n,i}^{j+1}\|,$$
(24)

where j = 1, 2, ..., k - 2.

From (23), we have

$$\lim_{n \to \infty} ||x_n - y_n^j|| = 0, \quad \text{where } j = 1, 2, \dots, k - 1.$$
 (25)

By using triangle inequality, we have

$$\|y_n^j - u_{n,m}^j\| \le \|y_n^j - x_n\| + \|x_n - u_{n,m}^j\|.$$
 (26)

Together with (23) and (25), we have

$$\lim_{n \to \infty} \left\| y_n^j - u_{n,m}^j \right\| = 0, \quad \text{where } j = 1, 2, \dots, k - 1,$$
for each  $m \in \mathbb{N}$ .

Now, we prove that  $\{x_n\}$  converges weakly to a point  $q \in F$ . Since we have proved that  $\{x_n\}$  is bounded, there exists a subsequence  $\{x_{n_k}\}_{k=1}^{\infty}$  of  $\{x_n\}$  such that  $x_{n_k}$  converges weakly to  $q \in K$ ; using (25), we can say that  $y_{n_k}^j$  converges weakly to  $q \in K$ , for j = 1, 2, ..., k - 1. Now suppose that there exist  $i \in N$ , such that  $T_i^j q \neq q$ , for j = 1, 2, ..., k; then by Opial's condition we have

$$\lim_{n \to \infty} \sup_{n \to \infty} \left\| x_{n_k} - q \right\| < \limsup_{n \to \infty} \left\| x_{n_k} - T_i^k q \right\| \tag{28}$$

$$\limsup_{n \to \infty} \|y_{n_k}^j - q\| < \limsup_{n \to \infty} \|y_{n_k}^j - T_i^j q\|,$$
where  $j = 1, 2, ..., k - 1$ . (29)

As  $\{T_i^j\}_{j=1}^k$  are k-multivalued quasi-nonexpansive mappings, we have

$$||x_{n_{k}} - T_{i}^{k}q|| \leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + ||u_{n_{k},i}^{k} - T_{i}^{k}q||$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + d\left(T_{i}^{k}x_{n_{k}}, T_{i}^{k}q\right)$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + H\left(T_{i}^{k}x_{n_{k}}, T_{i}^{k}q\right)$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + ||x_{n_{k}} - q||,$$

$$||y_{n_{k}}^{j} - T_{i}^{j}q|| \leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + ||u_{n_{k},i}^{j} - T_{i}^{j}q||$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + d\left(T_{i}^{j}y_{n_{k}}^{j}, T_{i}^{j}q\right)$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + H\left(T_{i}^{j}y_{n_{k}}^{j}, T_{i}^{j}q\right)$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + ||y_{n_{k}}^{j} - q||,$$

$$(30)$$

where j = 1, 2, ..., k - 1.

Taking  $\limsup_{k\to\infty}$  of both sides of (30) and from (17) and (27), we have

$$\limsup_{k \to \infty} \left\| x_{n_k} - T_i^k q \right\| \le \limsup_{k \to \infty} \left\| x_{n_k} - q \right\|, \tag{31}$$

$$\limsup_{k \to \infty} \left\| y_{n_k}^j - T_i^j q \right\| \le \limsup_{k \to \infty} \left\| y_{n_k}^j - q \right\|. \tag{32}$$

Now combining (28) with (31) and (29) with (32), we have

$$\lim_{k \to \infty} \sup \|x_{n_k} - q\| < \limsup_{k \to \infty} \|x_{n_k} - q\|,$$

$$\lim_{k \to \infty} \sup \|y_{n_k}^j - q\| < \limsup_{k \to \infty} \|y_{n_k}^j - q\|,$$
(33)

which gives contradiction, so we have  $T_i^j q = q$ , for j = 1, 2, ..., k and  $i \in N$ ; this implies  $q \in F$ . Now we prove that  $\{x_n\}$  converges weakly to q. Let  $\{x_{m_k}\}$  be another subsequence of  $\{x_n\}$  that converges weakly to some  $r \in K$ . Again as above

we conclude that  $r \in F$ . We show that q = r. Let  $q \neq r$ , since  $\lim_{n \to \infty} ||x_n - p||$  exists for every  $p \in F$ . From (1), we have

$$\lim_{n \to \infty} \|x_n - q\| = \limsup_{k \to \infty} \|x_{n_k} - q\| < \limsup_{k \to \infty} \|x_{n_k} - r\|$$

$$= \limsup_{k \to \infty} \|x_{m_k} - r\| < \limsup_{k \to \infty} \|x_{m_k} - q\|$$

$$= \lim_{n \to \infty} \|x_n - q\|.$$
(34)

It implies that  $\lim_{n\to\infty} \|x_n - q\| < \lim_{n\to\infty} \|x_n - q\|$ , a contradiction. So we have q = r. It means that  $\{x_n\}$  converges weakly to q as  $n\to\infty$ .

For  $T_i^1 = T$ ,  $T_i^j = S$ , j = 1, 2, ..., k - 1, and  $T_i^k = W$ , Theorem 7 reduces to the following corollary.

**Corollary 8.** Let K be a nonempty closed convex subset of a uniformly convex Banach space X with Opial's condition. Let T, S, and W be three multivalued quasi-nonexpansive mappings from K into P(K) with  $F = F(T) \cap F(S) \cap F(W) \neq \emptyset$  and  $p \in F$ . Let  $\{x_n\}$  be the iteration defined as

$$x_{n+1} = \alpha_n x_n + (1 - \alpha_n) T y_n,$$
  

$$y_n = \beta_n x_n + (1 - \beta_n) S z_n,$$
  

$$z_n = \gamma_n x_n + (1 - \gamma_n) W x_n,$$
(35)

where  $y_n \in Ty_n$  such that  $d(p, y_n) = d(p, Ty_n)$ ,  $z_n \in Sz_n$  such that  $d(p, z_n) = d(p, Sz_n)$ , and  $x_n \in Wx_n$  such that  $d(p, x_n) = d(p, Wx_n)$ ,  $\{\alpha_n\}$ ,  $\{\beta_n\}$ , and  $\{\gamma_n\}$  are sequences in [0, 1] which satisfies  $\limsup_{n \to \infty} \alpha_n < 1$  and  $\limsup_{n \to \infty} \beta_n < 1$ ,  $\liminf_{n \to \infty} \alpha_n (1 - \alpha_n) > 0$ ,  $\liminf_{n \to \infty} \beta_n (1 - \beta_n) > 0$ , and  $\liminf_{n \to \infty} \gamma_n (1 - \gamma_n) > 0$ ; then  $\{x_n\}$  converges weakly to a point  $q \in F$ .

**Theorem 9.** Let X be a uniformly convex real Banach space and let K be a bounded and closed convex subset of X. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be a sequence of multivalued quasinonexpansive and continuous mappings from K into P(K) with  $F := \bigcap_{i=1}^{\infty} F(T_i^j) \neq \emptyset$ , j = 1, 2, ..., k and  $p \in F$ . Let  $\{x_n\}$  be a sequence defined by (2) with  $\{\alpha_{n,i}\}_{i=0}^{\infty}$  and  $\{\beta_{n,i}^j\}_{i=0}^{\infty}$ , j = 1, 2, ..., k-1 are sequences in [0,1] which satisfies  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$  and  $\sum_{i=0}^{\infty} \beta_{n,i}^j = 1$ , j = 1, 2, ..., k-1,  $\lim \sup_{n \to \infty} \alpha_{n,0} < 1$  and  $\lim \sup_{n \to \infty} \beta_{n,0}^j < 1$ , j = 1, 2, ..., k-2, and  $\lim \inf_{n \to \infty} \alpha_{n,0} \alpha_{n,m} > 0$  and  $\lim \inf_{n \to \infty} \beta_{n,0}^j \beta_{n,i}^j > 0$ , j = 1, 2, ..., k-1, for all  $i \in N$ . Assume that one of  $T_i^j$  is hemicompact. Then  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

*Proof.* Let  $T_i^j$  is hemicompact for some  $i, j \in N$ , then from (17) and (27), we have  $\lim_{n \to \infty} d(x_n, T_i^k x_n) = 0$ , for all  $i \in N$ , and  $\lim_{n \to \infty} d(y_n^j, T_i^j y_n^j) = 0$ , for all  $i \in N$ ,  $j = 1, 2, \ldots, k - 1$ . So there exists a subsequence  $\{x_{n_k}\}$  of  $\{x_n\}$  such that  $\lim_{k \to \infty} x_{n_k} = q \in K$ ; using (25), we can say that  $\lim_{k \to \infty} y_{n_k}^j = q \in K$ . From continuity of

 $\{T_i^j\}_{j=1}^k, i \in N$ , we have  $\lim_{m \to \infty} d(x_{n_m}, T_i^k x_{n_m}) \to d(q, T_i^k q)$  and  $\lim_{m \to \infty} d(y_{n_m}^j, T_i^j y_{n_m}^j) \to d(q, T_i^j q)$ . This implies that  $d(q, T_i^j q) = 0, j = 1, 2, \dots, k$ , and  $q \in F$ . Since  $\lim_{n \to \infty} \|x_n - q\|$  exists, it follows that  $\{x_n\}$  converges strongly to q.

**Theorem 10.** Let X be a uniformly convex real Banach space and let K be a compact convex subset of X. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be a sequence of multivalued quasi-nonexpansive mappings from K into P(K) with  $F := \bigcap_{i=1}^{\infty} F(T_i^j) \neq \emptyset$ ,  $j=1,2,\ldots,k$ , and  $p \in F$ . Let  $\{x_n\}$  be a sequence defined by (2) with  $\{\alpha_{n,i}\}_{i=0}^{\infty}$  and  $\{\beta_{n,i}^j\}_{i=0}^{\infty}$ ,  $j=1,2,\ldots,k-1$  are sequences in [0,1] which satisfies  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$  and  $\sum_{i=0}^{\infty} \beta_{n,i}^j = 1$ ,  $j=1,2,\ldots,k-1$ ,  $\lim\sup_{n\to\infty}\alpha_{n,0}<1$  and  $\lim\sup_{n\to\infty}\beta_{n,0}^j<1$ ,  $j=1,2,\ldots,k-2$ , and  $\lim\inf_{n\to\infty}\alpha_{n,0}\alpha_{n,m}>0$  and  $\lim\inf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0$ ,  $j=1,2,\ldots,k-1$ , for all  $i\in N$ . Then  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

*Proof.* Since K is compact, there exists a subsequence  $\{x_{n_k}\}$  of  $\{x_n\}$  such that  $\lim_{k\to\infty} \|x_{n_k} - q\| = 0$  for some  $q \in K$ ; also from (25), we can say that

$$\lim_{k \to \infty} \| y_{n_k}^j - q \| = 0, \quad j = 1, 2, \dots, k - 1.$$
 (36)

Now, we have

$$\begin{split} d\left(q,T_{i}^{k}q\right) &\leq d\left(q,x_{n_{k}}\right) + d\left(x_{n_{k}},T_{i}^{k}x_{n_{k}}\right) + H\left(T_{i}^{k}x_{n_{k}},T_{i}^{k}q\right) \\ &\leq 2\left\|x_{n_{k}} - q\right\| + d\left(x_{n_{k}},T_{i}^{k}x_{n_{k}}\right) \longrightarrow 0 \quad \text{as } k \longrightarrow \infty, \\ d\left(q,T_{i}^{j}q\right) &\leq d\left(q,y_{n_{k}}^{j}\right) + d\left(x_{n_{k}},T_{i}^{j}y_{n_{k}}^{j}\right) + H\left(T_{i}^{j}y_{n_{k}}^{j},T_{i}^{j}q\right) \\ &\leq 2\left\|y_{n_{k}}^{j} - q\right\| + d\left(y_{n_{k}}^{j},T_{i}^{j}y_{n_{k}}^{j}\right) \longrightarrow 0 \quad \text{as } k \longrightarrow \infty, \\ \text{where } j = 1,2,\dots,k-1. \end{split}$$

Hence this implies that  $q \in F$  and  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

Remark 11. If in iterative process defined by (6) we use k = 1 and 2, Theorems 7, 9, and 10 reduce into convergence results proved by Bunyawat and Suantai [6, 22] and Zhang et al. [21].

For k = 3 and i = p (any finite number), Theorems 7, 9, and 10 reduce into result proved by Ahmed and Altwqi [26].

# 2.2. Strong and Weak Convergence Results for New Multistep Iterative Scheme (7)

**Theorem 12.** Let K be a nonempty closed convex subset of a uniformly convex Banach space X with Opial's condition. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be k sequences of multivalued quasinonexpansive mappings from K into (K) with  $F = \bigcap_{j=1}^k [\bigcap_{i=1}^\infty T_i^j] \neq \emptyset$  and  $p \in F$ . Let  $\{x_n\}$  be the sequence defined by (7); then it converges weakly to a point  $q \in F$ .

*Proof.* Let  $p \in F$ , first we prove that  $\{x_n\}$  is bounded and  $\lim_{n \to \infty} \|x_n - p\|$  exists. Now, from Lemma 5 and (7), we have

$$\|y_{n}^{k-1} - p\|^{2} = \|\beta_{n,0}^{k-1}x_{n} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-1}u_{n,i}^{k} - p\|^{2}$$

$$\leq \beta_{n,0}^{k-1}\|x_{n} - p\|^{2} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-1}\|u_{n,i}^{k} - p\|^{2}$$

$$-\beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g(\|x_{n} - u_{n,m}^{k}\|)$$

$$\leq \beta_{n,0}^{k-1}\|x_{n} - p\|^{2} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-1}(d(u_{n,i}^{k}, T_{i}^{k}p))^{2}$$

$$-\beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g(\|x_{n} - u_{n,m}^{k}\|)$$

$$\leq \beta_{n,0}^{k-1}\|x_{n} - p\|^{2} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-1}(H(T_{i}^{k}x_{n}, T_{i}^{k}p))^{2}$$

$$-\beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g(\|x_{n} - u_{n,m}^{k}\|)$$

$$\leq \beta_{n,0}^{k-1}\|x_{n} - p\|^{2} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-1}\|x_{n} - p\|^{2}$$

$$-\beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g(\|x_{n} - u_{n,m}^{k}\|)$$

$$\leq \|x_{n} - p\|^{2} - \beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g(\|x_{n} - u_{n,m}^{k}\|)$$

$$\leq \|x_{n} - p\|^{2} - \beta_{n,0}^{k-1}\beta_{n,i}^{k-1}u_{n,i}^{k-1} - p\|^{2}$$

$$\leq \beta_{n,0}^{k-2}\|y_{n}^{k-1} - p\|^{2} + \sum_{i=1}^{\infty}\beta_{n,i}^{k-2}\|u_{n,i}^{k-1} - p\|^{2}$$

$$-\beta_{n,0}^{k-2}\beta_{n,m}^{k-2}g(\|y_{n}^{k-1} - u_{n,m}^{k-1}\|)$$

$$\leq \beta_{n,0}^{k-2}\beta_{n,m}^{k-2}g(\|y_{n}^{k-1} - u_{n,m}^{k-1}\|)$$

$$\leq \beta_{n,0}^{k-2}\beta_{n,m}^{k-2}g(\|y_{n}^{k-1} - u_{n,m}^{k-1}\|)$$

$$\leq \beta_{n,0}^{k-2}\beta_{n,n}^{k-2}g(\|y_{n}^{k-1} - u_{n,m}^{k-1}\|)$$

$$\leq \beta_{n,0}^{k-2}\beta_{n,n}^{k-2}\beta_{n,n}^{k-2}\beta_{n,n}^{k-2}\beta_{n,n}^{k-2}\beta_{n,n}^{k-2}\beta_{n,n}^{$$

$$\begin{aligned} \left\| y_{n}^{k-3} - p \right\|^{2} &= \left\| \beta_{n,0}^{k-3} y_{n}^{k-2} + \sum_{i=1}^{\infty} \beta_{n,i}^{k-3} u_{n,i}^{k-2} - p \right\|^{2} \\ &\leq \beta_{n,0}^{k-3} \left\| y_{n}^{k-2} - p \right\|^{2} + \sum_{i=1}^{\infty} \beta_{n,i}^{k-3} \left\| u_{n,i}^{k-2} - p \right\|^{2} \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right) \\ &\leq \beta_{n,0}^{k-3} \left\| y_{n}^{k-2} - p \right\|^{2} + \sum_{i=1}^{\infty} \beta_{n,i}^{k-3} \left( d \left( u_{n,i}^{k-2}, T_{i}^{k-2} p \right) \right)^{2} \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right) \\ &\leq \beta_{n,0}^{k-3} \left\| y_{n}^{k-2} - p \right\|^{2} \\ &+ \sum_{i=1}^{\infty} \beta_{n,i}^{k-3} \left( H \left( T_{i}^{k-2} y_{n}^{k-2}, T_{i}^{k-2} p \right) \right)^{2} \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right) \\ &\leq \beta_{n,0}^{k-3} \left\| y_{n}^{k-2} - p \right\|^{2} + \sum_{i=1}^{\infty} \beta_{n,i}^{k-3} \left\| y_{n}^{k-2} - p \right\|^{2} \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right) \\ &\leq \left\| y_{n}^{k-2} - p \right\|^{2} - \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right), \\ \left\| y_{n}^{k-3} - p \right\|^{2} &\leq \left\| x_{n} - p \right\|^{2} \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| x_{n} - u_{n,m}^{k} \right\| \right) \\ &- \beta_{n,0}^{k-3} \beta_{n,m}^{k-3} g \left( \left\| y_{n}^{k-2} - u_{n,m}^{k-2} \right\| \right) \\ &\leq \left\| x_{n} - p \right\|^{2} - \beta_{n,0}^{k-1} \beta_{n,m}^{k-1} g \left( \left\| x_{n} - u_{n,m}^{k} \right\| \right). \end{aligned}$$

$$(40)$$

Now continuing like this at last, we have

$$\|y_{n}^{1} - p\| \leq \|x_{n} - p\|^{2} - \beta_{n,0}^{k-1} \beta_{n,m}^{k-1} g(\|x_{n} - u_{n,m}^{k}\|), \qquad (41)$$

$$\|x_{n+1} - p\|^{2} = \|\alpha_{n,0} y_{n}^{1} + \sum_{i=1}^{\infty} \alpha_{n,i} u_{n,i}^{1} - p\|^{2}$$

$$\leq \alpha_{n,0} \|y_{n}^{1} - p\|^{2} + \sum_{i=1}^{\infty} \alpha_{n,i} \|u_{n,i}^{1} - p\|^{2}$$

$$\leq \alpha_{n,0} \|y_{n}^{1} - p\|^{2} + \sum_{i=1}^{\infty} \alpha_{n,i} (d(u_{n,i}^{1}, T_{i}^{1} p))^{2}$$

$$\leq \alpha_{n,0} \|y_{n}^{1} - p\|^{2} + \sum_{i=1}^{\infty} \alpha_{n,i} (H(T_{i}^{1} y_{n}^{1}, T_{i}^{1} p))^{2}$$

$$\leq \alpha_{n,0} \|y_{n}^{1} - p\|^{2} + \sum_{i=1}^{\infty} \alpha_{n,i} \|y_{n}^{1} - p\|^{2}$$

$$\leq \|y_{n}^{1} - p\|^{2}. \qquad (42)$$

By putting (41) in (42), we get

$$\|x_{n+1} - p\|^2 \le \|x_n - p\|^2 - \beta_{n,0}^{k-1} \beta_{n,m}^{k-1} g(\|x_n - u_{n,m}^k\|).$$
 (43)

So from (43), we say that  $\{\|x_n - p\|\}$  is nondecreasing and bounded and hence,  $\{x_n\}$  is bounded and  $\lim_{n\to\infty} \|x_n - p\|$  exists.

Now we prove that  $\lim_{n\to\infty} \|x_n - u_{n,m}^k\| = 0$ ,  $\lim_{n\to\infty} \|x_n - y_n^j\| = 0$  and  $\lim_{n\to\infty} \|y_n^j - u_{n,m}^j\| = 0$ , where  $j = 1, 2, \dots, k-1$ . From (43), we can write as

$$\beta_{n,0}^{k-1}\beta_{n,m}^{k-1}g\left(\left\|x_{n}-u_{n,m}^{k}\right\|\right) \leq \left\|x_{n}-p\right\|^{2}-\left\|x_{n+1}-p\right\|^{2}.$$
 (44)

Now from (7), as we assume that the following conditions hold:  $\limsup_{n\to\infty}\alpha_{n,0}<1$ ,  $\limsup_{n\to\infty}\beta_{n,0}^j<1$ ,  $j=1,2,\ldots,k-2$ ,  $\liminf_{n\to\infty}\alpha_{n,0}\alpha_{n,m}>0$ ,  $\liminf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0$ ,  $j=1,2,\ldots,k-1$ , and  $\lim_{n\to\infty}\|x_n-p\|$  exist. So from these conditions, we have  $\lim_{n\to\infty}g(\|x_n-u_{n,m}^k\|)=0$  and then using the continuity of g, we have

$$\lim_{n \to \infty} \left\| x_n - u_{n,m}^k \right\| = 0, \quad \text{for each } m \in \mathbb{N}.$$
 (45)

From (38) and (39), we have

$$\|y_n^{k-2} - p\|^2 \le \|x_n - p\|^2 - \beta_{n,0}^{k-2} \beta_{n,m}^{k-2} g(\|y_n^{k-1} - u_{n,m}^{k-1}\|).$$
(46)

Now by putting (39) in (40), we have

$$\|y_n^{k-3} - p\|^2 \le \|x_n - p\|^2 - \beta_{n,0}^{k-2} \beta_{n,m}^{k-2} g(\|y_n^{k-1} - u_{n,m}^{k-1}\|).$$

Now continuing like this at last, we have

$$\|x_{n+1} - p\|^{2} \le \|x_{n} - p\|^{2} - \beta_{n,0}^{k-2} \beta_{n,m}^{k-2} g(\|y_{n}^{k-1} - u_{n,m}^{k-1}\|);$$
(48)

we can write it as

$$\beta_{n,0}^{k-2}\beta_{n,m}^{k-2}g\left(\left\|y_{n}^{k-1}-u_{n,m}^{k-1}\right\|\right) \leq \left\|x_{n}-p\right\|^{2}-\left\|x_{n+1}-p\right\|^{2}.$$
(49)

Since we assume that  $\liminf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0, \ j=1,2,\ldots,k-1$  and  $\lim_{n\to\infty}\|x_n-p\|$  exists, we have  $\lim_{n\to\infty}g(\|y_n^{k-1}-u_{n,m}^{k-1}\|)=0$  and from the continuity of g, we have

$$\lim_{n \to \infty} \|y_n^{k-1} - u_{n,m}^{k-1}\| = 0, \quad \text{for each } m \in \mathbb{N}.$$
 (50)

So by repeating these steps for different values of j = 1, 2, ..., k-2, we have

$$\lim_{n \to \infty} \|y_n^j - u_{n,m}^j\| = 0, \quad \text{for each } m \in \mathbb{N},$$

$$\text{where } j = 1, 2, \dots, k - 1.$$

Now, we prove that  $\lim_{n\to\infty} ||x_n - y_n^j|| = 0$ , from (7), we have

$$\|x_{n} - y_{n}^{k-1}\| = \|x_{n} - \beta_{n,0}^{k-1} x_{n} - \sum_{i=1}^{\infty} \beta_{n,i}^{k-1} u_{n,i}^{k}\|,$$
where  $u_{n,i}^{k} \in T_{i}^{k} x_{n}$ , (52)

$$\|x_{n} - y_{n}^{k-1}\| \le \beta_{n,0}^{k-1} \|x_{n} - x_{n}\| + \sum_{i=1}^{\infty} \beta_{n,i}^{k-1} \|x_{n} - u_{n,i}^{k}\|$$

$$\le \sum_{i=1}^{\infty} \beta_{n,i}^{k-1} \|x_{n} - u_{n,i}^{k}\|.$$
(53)

Taking limit  $n \to \infty$  of both sides of (53) and using (45), we have

$$\lim_{n \to \infty} \|x_n - y_n^{k-1}\| = 0. \tag{54}$$

Again using (7), we have

$$\|x_{n} - y_{n}^{k-2}\| = \|x_{n} - \beta_{n,0}^{k-2} y_{n}^{k-1} - \sum_{i=1}^{\infty} \beta_{n,i}^{k-2} u_{n,i}^{k-1}\|$$

$$\leq \beta_{n,0}^{k-2} \|x_{n} - y_{n}^{k-1}\| + \beta_{n,i}^{k-2} \|x_{n} - u_{n,i}^{k-1}\|,$$

$$\|x_{n} - u_{n,i}^{k-1}\| \leq \|x_{n} - y_{n}^{k-1}\| + \|y_{n}^{k-1} - u_{n,i}^{k-1}\|.$$

$$(55)$$

From (51) and (54), we have  $\lim_{n\to\infty} ||x_n - y_n^{k-2}|| = 0$ . Now by repeating these steps for all values of j = 1, 2, ..., k-3, we get

$$\lim_{n \to \infty} ||x_n - y_n^j|| = 0, \quad \text{where } j = 1, 2, \dots, k - 1.$$
 (56)

Now to prove weak convergence of  $\{x_n\}$  to a point  $q \in F$ , we will use (43); that is,  $\{x_n\}$  is bounded, so there exists a subsequence  $\{x_{n_k}\}_{k=1}^{\infty}$  of  $\{x_n\}$  such that  $x_{n_k}$  converges weakly to  $q \in K$ ; then using (56), we claim that  $y_{n_k}^j$  converges weakly to  $q \in K$ , for j = 1, 2, ..., k - 1. Now assume that there exist  $i \in N$ , such that  $T_i^j q \neq q$ , for j = 1, 2, ..., k; then by Opial's condition we have

$$\lim_{n \to \infty} \sup_{n \to \infty} \left\| x_{n_k} - q \right\| < \lim_{n \to \infty} \sup_{n \to \infty} \left\| x_{n_k} - T_i^k q \right\|, \tag{57}$$

$$\limsup_{n \to \infty} \|y_{n_k}^j - q\| < \limsup_{n \to \infty} \|y_{n_k}^j - T_i^j q\|,$$
where  $j = 1, 2, \dots, k - 1$ . (58)

As  $\{T_i^j\}_{j=1}^k$  are k-multivalued quasi nonexpansive mappings, we have

$$||x_{n_{k}} - T_{i}^{k}q|| \leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + ||u_{n_{k},i}^{k} - T_{i}^{k}q||$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + d\left(T_{i}^{k}x_{n_{k}}, T_{i}^{k}q\right)$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + H\left(T_{i}^{k}x_{n_{k}}, T_{i}^{k}q\right)$$

$$\leq ||x_{n_{k}} - u_{n_{k},i}^{k}|| + ||x_{n_{k}} - q||,$$

$$||y_{n_{k}}^{j} - T_{i}^{j}q|| \leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + ||u_{n_{k},i}^{j} - T_{i}^{j}q||$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + d\left(T_{i}^{j}y_{n_{k}}^{j}, T_{i}^{j}q\right)$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + H\left(T_{i}^{j}y_{n_{k}}^{j}, T_{i}^{j}q\right)$$

$$\leq ||y_{n_{k}}^{j} - u_{n_{k},i}^{j}|| + ||y_{n_{k}}^{j} - q||,$$

$$(59)$$

where j = 1, 2, ..., k - 1.

Taking  $\limsup_{k\to\infty}$  of both sides of (59) and from (45) and (51), we have

$$\limsup_{k \to \infty} \left\| x_{n_k} - T_i^k q \right\| \le \limsup_{k \to \infty} \left\| x_{n_k} - q \right\|, \tag{60}$$

$$\limsup_{k \to \infty} \|y_{n_k}^j - T_i^j q\| \le \limsup_{k \to \infty} \|y_{n_k}^j - q\|. \tag{61}$$

Now combining (57) with (60) and (58) with (61), we have

$$\lim_{k \to \infty} \sup_{k \to \infty} \left\| x_{n_k} - q \right\| < \lim_{k \to \infty} \sup_{k \to \infty} \left\| x_{n_k} - q \right\|,$$

$$\lim_{k \to \infty} \sup_{k \to \infty} \left\| y_{n_k}^j - q \right\| < \lim_{k \to \infty} \sup_{k \to \infty} \left\| y_{n_k}^j - q \right\|,$$
(62)

which gives contradiction, so we have  $T_i^j q = q$ , for  $j = 1, 2, \ldots, k$  and  $i \in N$ ; this implies that  $q \in F$ . Now we prove that  $\{x_n\}$  converges weakly to q. Let  $\{x_{m_k}\}$  be another subsequence of  $\{x_n\}$  that converges weakly to some  $r \in K$ . Again as above we conclude that  $r \in F$ . We show that q = r. Let  $q \neq r$ , since  $\lim_{n \to \infty} \|x_n - p\|$  exists for every  $p \in F$ . From (1), we have

$$\lim_{n \to \infty} \|x_n - q\| = \limsup_{k \to \infty} \|x_{n_k} - q\| < \limsup_{k \to \infty} \|x_{n_k} - r\|$$

$$= \limsup_{k \to \infty} \|x_{m_k} - r\| < \limsup_{k \to \infty} \|x_{m_k} - q\|$$

$$= \lim_{n \to \infty} \|x_n - q\|.$$
(63)

It implies that  $\lim_{n\to\infty} \|x_n - q\| < \lim_{n\to\infty} \|x_n - q\|$ , a contradiction. So we have q = r. It means that  $\{x_n\}$  converges weakly to q as  $n\to\infty$ .

**Theorem 13.** Let X be a uniformly convex real Banach space and let K be a bounded and closed convex subset of X. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be a sequence of multivalued quasinonexpansive and continuous mappings from K into P(K) with

 $F:=\bigcap_{i=1}^{\infty}F(T_i^j)\neq\varnothing,\ j=1,2,\ldots,k\ and\ p\in F.\ Let\ \{x_n\}$  be a sequence defined by (7) with  $\{\alpha_{n,i}\}_{i=0}^{\infty}$  and  $\{\beta_{n,i}^j\}_{i=0}^{\infty},\ j=1,2,\ldots,k-1$  are sequences in [0,1] which satisfies  $\sum_{i=0}^{\infty}\alpha_{n,i}=1$  and  $\sum_{i=0}^{\infty}\beta_{n,i}^j=1,\ j=1,2,\ldots,k-1$ ,  $\lim\inf_{n\to\infty}\beta_{n,0}^j\beta_{n,i}^j>0$ ,  $j=1,2,\ldots,k-1$ , for all  $i\in N$ . Assume that one of  $T_i^j$  is hemicompact. Then  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

*Proof.* Let  $T_i^j$  is hemicompact for some  $i, j \in N$ ; then from (45) and (50), we have  $\lim_{n \to \infty} d(x_n, T_i^k x_n) = 0$ , for all  $i \in N$ , and  $\lim_{n \to \infty} d(y_n^j, T_i^j y_n^j) = 0$ , for all  $i \in N$ ,  $j = 1, 2, \ldots, k - 1$ . So there exists a subsequence  $\{x_{n_k}\}$  of  $\{x_n\}$  such that  $\lim_{k \to \infty} x_{n_k} = q \in K$  using (56); we can say that  $\lim_{k \to \infty} y_{n_k}^j = q \in K$ . From continuity of  $\{T_i^j\}_{j=1}^k$ ,  $i \in N$ , we have  $\lim_{m \to \infty} d(x_{n_m}, T_i^k x_{n_m}) \to d(q, T_i^k q)$  and  $\lim_{m \to \infty} d(y_{n_m}^j, T_i^j y_{n_m}^j) \to d(q, T_i^j q)$ . This implies that  $d(q, T_i^j q) = 0, j = 1, 2, \ldots, k$  and  $q \in F$ . Since  $\lim_{n \to \infty} \|x_n - q\|$  exists, it follows that  $\{x_n\}$  converges strongly to q.

**Theorem 14.** Let X be a uniformly convex real Banach space and let K be a compact convex subset of X. For  $i \in N$ , let  $\{T_i^j\}_{j=1}^k$  be a sequence of multivalued quasi-nonexpansive mappings from K into P(K) with  $F := \bigcap_{i=1}^{\infty} F(T_i^j) \neq \emptyset$ , j = 1, 2, ..., k and  $p \in F$ . Let  $\{x_n\}$  be a sequence defined by (7) with  $\{\alpha_{n,i}\}_{i=0}^{\infty}$  and  $\{\beta_{n,i}^j\}_{i=0}^{\infty}$ , j = 1, 2, ..., k-1 are sequences in [0,1] which satisfies  $\sum_{i=0}^{\infty} \alpha_{n,i} = 1$  and  $\sum_{i=0}^{\infty} \beta_{n,i}^j = 1$ , j = 1, 2, ..., k-1, lim  $\inf_{n \to \infty} \beta_{n,0}^j \beta_{n,i}^j > 0$ , j = 1, 2, ..., k-1, for all  $i \in N$ . Then  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

*Proof.* Since *K* is compact, there exists a subsequence  $\{x_{n_k}\}$  of  $\{x_n\}$ , such that  $\lim_{k\to\infty} ||x_{n_k}-q||=0$  for some  $q\in K$ ; also from (56), we can say that

$$\lim_{k \to \infty} \| y_{n_k}^j - q \| = 0, \quad j = 1, 2, \dots, k - 1.$$
 (64)

Now, we have

$$d\left(q, T_{i}^{k}q\right) \leq d\left(q, x_{n_{k}}\right) + d\left(x_{n_{k}}, T_{i}^{k}x_{n_{k}}\right) + H\left(T_{i}^{k}x_{n_{k}}, T_{i}^{k}q\right)$$

$$\leq 2 \left\|x_{n_{k}} - q\right\| + d\left(x_{n_{k}}, T_{i}^{k}x_{n_{k}}\right) \longrightarrow 0 \quad \text{as } k \longrightarrow \infty,$$

$$d\left(q, T_{i}^{j}q\right) \leq d\left(q, y_{n_{k}}^{j}\right) + d\left(x_{n_{k}}, T_{i}^{j}y_{n_{k}}^{j}\right) + H\left(T_{i}^{j}y_{n_{k}}^{j}, T_{i}^{j}q\right)$$

$$\leq 2 \left\|y_{n_{k}}^{j} - q\right\| + d\left(y_{n_{k}}^{j}, T_{i}^{j}y_{n_{k}}^{j}\right) \longrightarrow 0 \quad \text{as } k \longrightarrow \infty,$$

$$\text{where } j = 1, 2, \dots, k - 1.$$

$$(65)$$

Hence this implies that  $q \in F$  and  $\{x_n\}$  converges strongly to common fixed point of  $\{T_i^j\}$ .

nonexpansive mappings. From the table we can compare the converging step of one-step, two-step, multistep (6), and multistep (7) iterative
schemes and conclude that multistep iterative scheme (7) converges faster than one-step, two-step, and multistep iterative schemes (6).

Remark 15. Since iterations used in [4–6, 15, 21] are special case of iterative scheme (6), motivated from them, we generalize in the following sense.

- (1) Since we prove our result for quasi-nonexpansive mappings so generalizes from nonexpansive to quasi nonexpansive.
- (2) We generalize from single-valued to multivalued mappings.
- (3) Our results extended from one and two countable families to *k*-number of countable families of multivalued quasi-nonexpansive mappings.
- (4) We prove weak and strong convergence results for new multistep iterative scheme (7). With the help of numerical example of multivalued quasinonexpansive mappings and computational program in C++ we prove fast rate of convergence of new multistep iterative scheme (7).

### 3. Numerical Computation

We use the following numerical example of finite family of multivalued quasi-nonexpansive mappings to compare the converging steps of one-step, two-step, and two new multistep iterative procedures. Let  $\{T_i^j\}$ :  $[0,1] \rightarrow [0,1]$ 

be k-countable family of multivalued quasi-nonexpansive mappings defined as

$$T_i^j x = \left[0, \frac{x}{i+j+1}\right], \text{ where } x \in [0,1], i \in \mathbb{N}, j=1,2,\ldots,k.$$
(66)

Now using the initial value  $x_0 = 0.5$  and different initial conditions used in result proved above in C++ program, we get the following observation for different iterations.

#### 4. Conclusion

After analyzing the comparison shown in Table 1 we conclude that the iterative scheme (7) converges faster than other existing iterative schemes and rate of convergence increases as the number of step of iterations increases for multivalued quasi-nonexpansive mappings.
