# Positive Periodic Solutions for Impulsive Functional Differential Equations with Infinite Delay and Two Parameters

We apply the Krasnoselskii's fixed point theorem to study the existence of multiple positive periodic solutions for a class of impulsive functional differential equations with infinite delay and two parameters. In particular, the presented criteria improve and generalize some related results in the literature. As an application, we study some special cases of systems, which have been studied extensively in the literature.

## 1. Introduction

First, we give the following definitions. Let  $J \subset \mathbb{R}$  denote by  $PC(J, \mathbb{R}^n)$  the set of operators  $\varphi : J \rightarrow \mathbb{R}^n$  which are continuous for  $t \in J, t \neq t_k$  and have discontinuities of the first kind at the points  $t_k \in J (k \in \mathbb{Z}_+)$  but are continuous from the left at these points. For each  $y = (y_1, y_2, \dots, y_n)^T \in \mathbb{R}^n$ , the norm of  $y$  is defined as  $|y| = \sum_{i=1}^n |y_i|$ . The matrix  $A > B (A \leq B)$  means that each pair of corresponding elements of  $A$  and  $B$  satisfies the inequality " $>$ " (" $\leq$ "). In particular,  $A$  is called a positive matrix if  $A > 0$ .

Impulsive differential equations are suitable for the mathematical simulation of evolutionary process whose states are subject to sudden changes at certain moments. Equations of this kind are found in almost every domain of applied sciences; numerous examples are given in [1–3]. In recent years, in [4–11], many researchers have obtained some properties of impulsive differential equations, such as oscillation, asymptotic behavior, stability, and existence of solutions. However, to this day, still no scholars investigate the existence of multiple positive periodic solutions for impulsive functional differential equations with infinite delay and two parameters. Motivated by this, in this paper, we mainly consider the

following impulsive functional differential equations with two parameters:

$$y'(t) = -A(t, y(t))y(t) + \lambda B(t, y(t))F(t, u(t)),$$

$$t \in \mathbb{R}, t \neq t_k, \quad (1)$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in \mathbb{Z}_+,$$

$$y'(t) = A(t, y(t))y(t) - \lambda B(t, y(t))F(t, u(t)),$$

$$t \in \mathbb{R}, t \neq t_k, \quad (2)$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in \mathbb{Z}_+,$$

where

$$u(t) = \left( y(c_1(t)), \dots, y(c_{n-1}(t)) \right),$$

$$\int_{-\infty}^t k(t-\xi)y(\xi)d\xi, \quad (3)$$

and  $\lambda > 0, \mu > 0$  are two parameters,  $A(t, y(t)) = \text{diag}[a_1(t, y(t)), a_2(t, y(t)), \dots, a_n(t, y(t))]$ ,  $B(t, y(t)) = \text{diag}[b_1(t, y(t)), b_2(t, y(t)), \dots, b_n(t, y(t))]$ ,  $a_i, b_i \in C(\mathbb{R} \times \mathbb{R}^+, \mathbb{R}^+)$  ( $i = 1, 2, \dots, n$ ) are  $\omega$ -periodic, that is,  $a_i(t+\omega, y(t+\omega)) =$

$a_i(t, y(t)), b_i(t + \omega, y(t + \omega)) = b_i(t, y(t)), F = (f_1, \dots, f_n)^T$ ,  $F(t, u(t))$  is an operator on  $R \times BC(R, R^n)$  (here  $BC(R, R^n)$  denotes the Banach space of bounded continuous operator  $\phi : R \rightarrow R^n$  with the norm  $\|\phi\| = \sum_{i=1}^n \sup_{\theta \in R} |\phi(\theta)|$ , where  $\phi = (\phi_1, \dots, \phi_n)^T$ ),  $f_i(t + \omega, u(t + \omega)) = f_i(t, u(t))$ ,  $\Delta y(t_k) = y(t_k^+) - y(t_k^-)$  (here  $y(t_k^+)$  represents the right limit of  $y(t)$  at the point  $t_k$ ),  $I_k = (I_{1k}, I_{2k}, \dots, I_{nk}) \in C(R_+^n, R^n)$ , that is,  $y(t)$  changes decreasingly suddenly at times  $t_k$ .  $\omega > 0$  is a constant,  $Z_+ = \{1, 2, 3, \dots\}$ ,  $R = (-\infty, +\infty)$ ,  $R_+ = [0, +\infty)$ , and  $R_- = (-\infty, 0]$ . We assume that there exists an integer  $q > 0$  such that  $t_{k+q} = t_k + \omega$ ,  $I_{i(k+q)} = I_{ik}$ ,  $i = 1, 2, \dots, n$ , where  $0 < t_1 < t_2 < \dots < t_q < \omega$ .

Models of forms (1) and (2) have been proposed for population dynamics (single species growth models), physiological processes (such as production of blood cells, respiration, and cardiac arrhythmias), and other practical problems. Equations (1) and (2) are very general and incorporate many famous mathematical models extensively studied in the literature [12–21]. In this paper, we will study the existence of positive periodic solutions in more cases than the previously mentioned papers and obtain some easily verifiable sufficient criteria.

Throughout the paper, we make the following assumptions.

- (H<sub>1</sub>)  $a_i, b_i : R \times R_+ \rightarrow R_+$  satisfy Caratheodory conditions; that is,  $a_i(t, y)$  and  $b_i(t, y)$  are locally Lebesgue measurable in  $t$  for each fixed  $y$  and are continuous in  $y$  for each fixed  $t$  are  $\omega$ -periodic functions in  $t$ . Moreover, there exist  $\omega$ -periodic functions  $a_{1i}, a_{2i}, b_{1i}, b_{2i} : R \rightarrow R_+$ , which are locally bounded Lebesgue measurable so that  $a_{1i}(t) \leq a_i(t, y(t)) \leq a_{2i}(t)$ ,  $b_{1i}(t) \leq b_i(t, y(t)) \leq b_{2i}(t)$  and  $\int_0^\omega a_{1i}(t)dt > 0$ ,  $\int_0^\omega b_{1i}(t)dt > 0$ .  $\lambda > 0, \mu > 0$  are two parameters.
- (H<sub>2</sub>)  $f_i(t, u(t))$  is  $\omega$ -periodic with respect to the first variable, that is,  $f_i(t + \omega, u(t + \omega)) = f_i(t, u(t))$  such that  $f_i(t, u(t)) \neq 0, i = 1, 2, \dots, n$ .
- (H<sub>3</sub>) The delay kernel  $k : R_+ \rightarrow R_+$  is integrable and is normalized such that  $\int_0^{+\infty} k(t)dt = 1, c_j(t) : R \rightarrow R$  such that  $c_j(t) \leq t, j = 1, 2, \dots, n - 1$ .
- (H<sub>4</sub>)  $\{t_k\}, k \in Z_+$  satisfies  $0 < t_1 < t_2 < \dots < t_k < \dots$ , and  $\lim_{k \rightarrow +\infty} t_k = +\infty; I_k : R \times R_+ \rightarrow R, k \in Z_+$  satisfy Caratheodory conditions and are  $\omega$ -periodic functions in  $t$ . Moreover,  $I_k(t, 0) = 0$  for all  $k \in Z_+$ . There exists a positive constant  $q$  such that  $t_{k+q} = t_k + \omega, I_{k+q}(t_{k+q}, y(t_{k+q})) = I_k(t_k, y(t_k)), k \in Z_+$ . Without loss of generality, we can assume that  $t_k \neq 0$  and  $[0, \omega] \cap \{t_k, k \in Z_+\} = \{t_1, t_2, \dots, t_q\}$ .

In addition, the parameters in this paper are assumed to be not identically equal to zero.

To conclude this section, we summarize in the following a few concepts and results that will be needed in our arguments.

*Definition 1* (see [22]). Let  $X$  be a real Banach space and let  $E$  be a closed, nonempty subset of  $X$ .  $E$  is said to be a cone if

- (1)  $\alpha x + \beta y \in E$  for all  $x, y \in E$ , and  $\alpha, \beta > 0$ ;
- (2)  $x, -x \in E$  imply  $x = 0$ .

**Lemma 2** (see Krasnoselskii’s fixed point theorem [23–26]). *Let  $E$  be a cone in a real Banach space  $X$ . Assume that  $\Omega_1$  and  $\Omega_2$  are open subsets of  $X$  with  $0 \in \Omega_1 \subset \overline{\Omega_1} \subset \Omega_2$ , where  $\Omega_i = \{x \in X : \|x\| < r_i\}$  ( $i = 1, 2$ ). Let  $T : E \cap (\Omega_2 \setminus \overline{\Omega_1}) \rightarrow E$  be a completely continuous operator and satisfies either*

$$(1) \|Tx\| \geq \|x\|, \text{ for any } x \in E \cap \partial\Omega_1 \text{ and } \|Tx\| \leq \|x\|, \text{ for any } x \in E \cap \partial\Omega_2,$$

or

$$(2) \|Tx\| \leq \|x\|, \text{ for any } x \in E \cap \partial\Omega_1 \text{ and } \|Tx\| \geq \|x\|, \text{ for any } x \in E \cap \partial\Omega_2.$$

Then,  $T$  has a fixed point in  $E \cap (\Omega_2 \setminus \overline{\Omega_1})$ .

For convenience in the following discussion, we introduce the following notations:

$$\begin{aligned} F^a &= \limsup_{u \in E, \|u\| \rightarrow a} \max_{t \in [0, \omega]} \frac{\int_0^\omega |F(t, u(t))| dt}{\|u\|}, \\ F_a &= \liminf_{u \in E, \|u\| \rightarrow a} \min_{t \in [0, \omega]} \frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|}, \\ I^a &= \limsup_{y \in E, \|y\| \rightarrow a} \max_{t \in [0, \omega]} \frac{\sum_{t \leq t_k < t + \omega} |I_k(t, y)|}{\|y\|}, \\ I_a &= \liminf_{y \in E, \|y\| \rightarrow a} \min_{t \in [0, \omega]} \frac{\sum_{t \leq t_k < t + \omega} |I_k(t, y)|}{\|y\|}, \end{aligned} \tag{4}$$

where  $a$  denotes either 0 or  $\infty, \|u\| = \max\{|u_1|, |u_2|, \dots, |u_n|\}$ , and  $\|y\| = \max\{|y_1|, |y_2|, \dots, |y_n|\}$ .

The paper is organized as follows. In Section 2, firstly, we give some definitions and lemmas. Secondly, we derive some existence theorems for one or two positive periodic solutions of (1) which are established by using Krasnoselskii’s fixed point theorem under some conditions. In Section 3, existence theorems for one or two positive periodic solutions of (2) are also established by using Krasnoselskii’s fixed point theorem under some conditions. As applications in Section 4, we study some particular cases of systems (1) and (2) which have been investigated extensively in the references mentioned earlier.

## 2. Existence of Periodic Solution of (1)

We establish the existence of positive periodic solutions of (1) by applying the Krasnoselskii’s fixed point theorem on cones. We will first make some preparations and list below a few preliminary results. For  $(t, s) \in R^2, 1 \leq i \leq n$ , we define

$$G_i(t, s) = \frac{e^{\int_t^s a_i(\xi, y(\xi)) d\xi}}{e^{\int_0^\omega a_i(\xi, y(\xi)) d\xi} - 1}, \tag{5}$$

$$G(t, s) = \text{diag} [G_1(t, s), G_2(t, s), \dots, G_n(t, s)].$$

It is clear that  $G_i(t + \omega, s + \omega) = G_i(t, s)$ ,  $(\partial G_i(t, s) / \partial t) = a_i(t, y(t))G_i(t, s)$ ,  $G_i(t, t + \omega) - G_i(t, t) = 1$ . In view of  $(H_1)$ , we also define for  $1 \leq i \leq n$

$$\alpha_i := \min_{0 \leq t \leq s \leq \omega} |G_i(t, s)| = \frac{1}{e^{\int_0^\omega a_{2i}(\xi) d\xi} - 1},$$

$$\beta_i := \max_{0 \leq t \leq s \leq \omega} |G_i(t, s)| = \frac{e^{\int_0^\omega a_{2i}(\xi) d\xi}}{e^{\int_0^\omega a_{1i}(\xi) d\xi} - 1},$$

$$\alpha = \min_{1 \leq i \leq n} \alpha_i, \quad \beta = \max_{1 \leq i \leq n} \beta_i, \quad \sigma = \frac{\alpha}{\beta} \in (0, 1), \quad (6)$$

$$B_i(t) = \max \{|b_{1i}(t)|, |b_{2i}(t)|\},$$

$$B'_i(t) = \min \{|b_{1i}(t)|, |b_{2i}(t)|\},$$

$$B(t) = \max_{1 \leq i \leq n} \{B_i(t)\}, \quad B'(t) = \min_{1 \leq i \leq n} \{B'_i(t)\}.$$

Let  $X = \{y = (y_1(t), y_2(t), \dots, y_n(t))^T \in PC(R, R^n) \mid y(t + \omega) = y(t)\}$  with the norm  $\|y\| = \sum_{i=1}^n |y_i|_0, |y_i|_0 = \sup_{t \in [0, \omega]} |y_i(t)|$ . It is easy to verify that  $(X, \|\cdot\|)$  is a Banach space. Define  $E$  as a cone in  $X$  by

$$E = \left\{ y = (y_1(t), y_2(t), \dots, y_n(t))^T \in X : y_i(t) \geq \sigma \|y_i\|_0, \right. \\ \left. t \in [0, \omega] \right\}. \quad (7)$$

We easily verify that  $E$  is a cone in  $X$ . We define an operator  $T : X \rightarrow X$  as follows:

$$(Ty)(t) = ((T_1y)(t), (T_2y)(t), \dots, (T_ny)(t))^T, \quad (8)$$

where

$$(T_iy)(t) = \lambda \int_t^{t+\omega} G_i(t, s) b_i(s, y(s)) f_i(s, u(s)) ds \\ + \mu \sum_{t \leq t_k < t+\omega} G_i(t, t_k) I_{ik}(t_k, y(t_k)). \quad (9)$$

The proofs of the main results in this paper are based on an application of Krasnoselskii's fixed point theorem in cones. To make use of the fixed point theorem in cone, firstly, we need to introduce some definitions and lemmas.

**Definition 3** (see [1]). A function  $y : R \rightarrow (0, +\infty)$  is said to be a positive solution of (1) if the following conditions are satisfied:

- (a)  $y(t)$  is absolutely continuous on each  $(t_k, t_{k+1})$ ;
- (b) for each  $k \in Z_+$ ,  $y(t_k^+)$  and  $y(t_k^-)$  exist, and  $y(t_k^-) = y(t_k)$ ;
- (c)  $y(t)$  satisfies the first equation of (1) for almost everywhere in  $R$  and  $y(t_k)$  satisfies the second equation of (1) at impulsive point  $t_k, k \in Z_+$ .

**Definition 4** (see [22]). Let  $X$  be a real Banach space;  $E$  is a cone of  $X$ . The semiorder induced by the cone  $E$  is denoted by " $\leq$ ". That is,  $x \leq y$  if and only if  $y - x \in E$  for any  $x, y \in E$ .

**Lemma 5** (see [27]). Assume that  $f(t)$  and  $g(t)$  are continuous nonnegative functions defined on the interval  $[\alpha, \beta]$ ; then there exists  $\xi \in [\alpha, \beta]$  such that

$$\int_\alpha^\beta f(t) g(t) dt = f(\xi) \int_\alpha^\beta g(t) dt. \quad (10)$$

**Lemma 6.** Assume that  $(H_1)$ – $(H_4)$  hold. The existence of positive  $\omega$ -periodic solution of (1) is equivalent to that of nonzero fixed point of  $T$  in  $E$ .

*Proof.* Assume that  $y = (y_1(t), y_2(t), \dots, y_n(t))^T \in X$  is a periodic solution of (1). Then, we have

$$\left[ y_i(t) e^{\int_0^t a_i(s, y(s)) ds} \right]' \\ = \lambda e^{\int_0^t a_i(s, y(s)) ds} b_i(t, y(t)) f_i(t, u(t)), \\ t \neq t_k, \quad i = 1, 2, \dots, n. \quad (11)$$

Integrating the above equation over  $[t, t + \omega]$ , we can have

$$y_i(v) e^{\int_0^v a_i(s, y(s)) ds} \Big|_t^{t_{m_1} + n\omega} \\ + y_i(v) e^{\int_0^v a_i(s, y(s)) ds} \Big|_{t_{m_1} + n\omega}^{t_{m_2} + n\omega} \\ + \dots + y_i(v) e^{\int_0^v a_i(s, y(s)) ds} \Big|_{t_{m_q} + n\omega}^{t+\omega} \\ = \lambda \int_t^{t+\omega} e^{\int_0^v a_i(s, y(s)) ds} b_i(v, x(v)) f_i(v, u(v)) dv, \quad (12)$$

where  $t_{m_k} + n\omega \in (t, t + \omega)$ ,  $m_k \in \{1, 2, \dots, q\}$ ,  $k = 1, 2, \dots, q$ ,  $n \in Z_+$ .

Therefore,

$$y_i(t) e^{\int_0^t a_i(s, y(s)) ds} \left[ e^{\int_t^{t+\omega} a_i(s, y(s)) ds} - 1 \right] \\ - \sum_{t \leq t_k < t+\omega} \Delta y_i(t_{m_k}) e^{\int_0^{t_{m_k} + n\omega} a_i(s, y(s)) ds} \\ = \lambda \int_t^{t+\omega} e^{\int_0^v a_i(s, y(s)) ds} b_i(v, y(v)) f_i(v, u(v)) dv, \quad (13)$$

which can be transformed into

$$y_i(t) = \lambda \int_t^{t+\omega} G_i(t, s) b_i(s, y(s)) f_i(s, u(s)) ds \\ + \mu \sum_{t \leq t_k < t+\omega} G_i(t, t_k) I_{ik}(t_k, y(t_k)) \\ = (T_iy)(t). \quad (14)$$

Thus,  $y_i$  is a periodic solution for (9).

If  $y = (y_1(t), y_2(t), \dots, y_n(t))^T \in X$  and  $Ty = (T_1y, T_2y, \dots, T_ny)^T = y$  with  $y \neq 0$ , then for any  $t = t_k$ , derivative the two sides of (9) about  $t$ ,

$$\begin{aligned} & (T_i y)'(t) \\ &= \frac{d}{dt} \left[ \lambda \int_t^{t+\omega} G_i(t, s) b_i(s, y(s)) f_i(s, u(s)) ds \right] \\ &= \lambda [G_i(t, t+\omega) b_i(t+\omega, y(t+\omega)) f_i(t+\omega, u(t+\omega)) \\ &\quad - G_i(t, t) b_i(t, y(t)) f_i(t, u(t))] \\ &\quad - a_i(t, y(t)) y_i(t) \\ &= -a_i(t, y(t)) y_i(t) + \lambda b_i(t, y(t)) f_i(t, u(t)) \\ &= y_i'(t). \end{aligned} \tag{15}$$

For any  $t = t_j, j \in Z_+$ , we have from (9) that

$$\begin{aligned} y_i(t_j^+) - y_i(t_j) &= \lambda \int_{t_j}^{t_j+\omega} [G_i(t_j^+, s) - G_i(t_j, s)] \\ &\quad \times b_i(s, y(s)) f_i(s, u(s)) ds \\ &\quad + \mu \sum_{t_j^+ \leq t_k < t_j+\omega} G_i(t_j^+, t_k) I_{ik}(t_k, y(t_k)) \\ &\quad - \mu \sum_{t_j \leq t_k < t_j+\omega} G_i(t_j, t_k) I_{ik}(t_k, y(t_k)) \\ &= \mu I_{ik}(t_k, y(t_k)). \end{aligned} \tag{16}$$

Hence  $y(t) = (y_1(t), y_2(t), \dots, y_n(t))^T \in X$  is a positive  $\omega$ -periodic solution of (1). Thus we complete the proof of Lemma 6.  $\square$

**Lemma 7.** Assume that  $(H_1)$ – $(H_4)$  hold. Then  $T : E \rightarrow E$  is well defined.

*Proof.* From (9), it is easy to verify that  $(Ty)(t)$  is continuous in  $(t_k, t_{k+1})$ ,  $(Ty)(t_k^+)$  and  $(Ty)(t_k^-)$  exist, and  $(Ty)(t_k^-) = (Ty)(t_k)$  for each  $k \in Z_+$ . Moreover, for any  $y \in E$

$$\begin{aligned} & (Ty)(t+\omega) \\ &= \lambda \int_{t+\omega}^{t+2\omega} G(t+\omega, s) b(s, y(s)) F(s, u(s)) ds \\ &\quad + \mu \sum_{t+\omega \leq t_k < t+2\omega} G(t+\omega, t_k) I_k(t_k, y(t_k)) \end{aligned}$$

$$\begin{aligned} &= \lambda \int_t^{t+\omega} G(t+\omega, v+\omega) b(v+\omega, y(v+\omega)) \\ &\quad \times F(v+\omega, u(v+\omega)) dv \\ &\quad + \mu \sum_{t \leq t_k < t+\omega} G(t, t_k) I_k(t_k, y(t_k)) \\ &= \lambda \int_t^{t+\omega} G(t, s) b(s, y(s)) F(s, u(s)) ds \\ &\quad + \mu \sum_{t \leq t_k < t+\omega} G(t, t_k) I_k(t_k, y(t_k)) \\ &= (Ty)(t). \end{aligned} \tag{17}$$

Therefore,  $(Ty) \in X$ . From (9), we have

$$\begin{aligned} |T_i y|_0 &\leq \beta_i \left[ \lambda \int_0^\omega |b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} I_{ik}(t_k, y(t_k)) \right]. \end{aligned} \tag{18}$$

On the other hand, we obtain

$$\begin{aligned} (T_i y)(t) &\geq \alpha_i \left[ \lambda \int_0^\omega |b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} I_{ik}(t_k, y(t_k)) \right] \\ &\geq \frac{\alpha_i}{\beta_i} |T_i y|_0 \\ &\geq \sigma |T_i y|_0. \end{aligned} \tag{19}$$

Therefore,  $Ty \in E$ . This completes the proof of Lemma 7.  $\square$

**Lemma 8.** Assume that  $(H_1)$ – $(H_4)$  hold. Then  $T : E \rightarrow E$  is completely continuous.

*Proof.* We first show that  $T$  is continuous. By  $(H_3)$ – $(H_4)$ ,  $f$  and  $H_k$  are continuous in  $y$ ; it follows that for any  $\epsilon > 0$ , let  $\delta > 0$  be small enough to satisfy that if  $y, y^* \in E$ , with  $|y - y^*| < \delta$ ,

$$\begin{aligned} |f(s, u(s)) - f(s, u^*(s))| &< \frac{\epsilon}{2B\lambda\beta\omega}, \quad s \in R, \\ |H_k(t_k, y(t_k)) - I_k(t_k, y^*(t_k))| &< \frac{\epsilon}{2\beta\mu q}, \quad k \in Z_+. \end{aligned} \tag{20}$$

Therefore,

$$\begin{aligned} & \| (Ty)(t) - (Ty^*)(t) \| \\ &= \sum_{i=1}^n |T_i y - T_i y^*|_0 \\ &\leq \beta \sum_{i=1}^n \lambda \int_t^{t+\omega} |b_i(s, y(s)) f_i(s, u(s)) \\ &\quad - b_i(s, y(s)) f_i(s, u^*(s))| ds \\ &\quad + \beta \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |I_{ik}(t_k, y(t_k)) \\ &\quad - I_{ik}(t_k, y^*(t_k))| \\ &< \beta \lambda \bar{B} \omega \frac{\epsilon}{2B\lambda\beta\omega} + \beta \mu q \frac{\epsilon}{2\beta\mu q} \\ &= \epsilon, \end{aligned} \tag{21}$$

which implies that  $T$  is continuous on  $E$ .

Next we show that  $T$  maps a bounded set into a bounded set. Indeed, let  $C \in E$  be a bounded set. For any  $t \in R$  and  $x \in C$ , by (9), we have

$$\begin{aligned} \| (Ty)(t) \| &= \sum_{i=1}^n |T_i y|_0 \\ &\leq \beta \left[ \lambda \sum_{i=1}^n \int_t^{t+\omega} |b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |I_{ik}(t_k, y(t_k))| \right] \\ &= \beta \left[ \int_0^\omega b_{2i}(s) F(s, u(s)) ds \right. \\ &\quad \left. + \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right]. \end{aligned} \tag{22}$$

Since  $C$  is bounded, in view of the continuity of  $T$ , it follows from (21) that  $Ty$  is bounded and  $\{Ty : y \in C\}$  is uniformly bounded. Finally, we show that the family of functions  $\{Ty : y \in C\}$  is equicontinuous on  $[0, \omega]$ . Let  $\theta_1, \theta_2 \in [0, \omega]$  with  $\theta_1 < \theta_2$ . From (9), for any  $y \in C$ , we have

$$\begin{aligned} & \| (Ty)(\theta_2) - (Ty)(\theta_1) \| \\ &\leq \lambda \sum_{i=1}^n \left[ \int_{\theta_1}^{\theta_2} (G_i(\theta_2, s) - G_i(\theta_1, s)) \right. \\ &\quad \times b_i(s, y(s)) f_i(s, u(s)) ds \\ &\quad + \int_{\theta_2}^{\theta_1+\omega} (G_i(\theta_2, s) - G_i(\theta_1, s)) \\ &\quad \times b_i(s, y(s)) f_i(s, u(s)) ds \end{aligned}$$

$$\begin{aligned} & + \sum_{\theta_1 \leq t_k < \theta_2} (G_i(\theta_2, t_k) - G_i(\theta_1, t_k)) \\ &\quad \times |I_{ik}(t_k, y(t_k))| \\ & + \sum_{\theta_2 \leq t_k < \theta_1+\omega} (G_i(\theta_2, t_k) - G_i(\theta_1, t_k)) \\ &\quad \times |I_{ik}(t_k, y(t_k))| \Big]. \end{aligned} \tag{23}$$

Since for  $y \in C, t \in [0, \omega], 0 \leq k \leq q, b_i(t, y(t)), f_i(t, u(t)),$  and  $I_{ik}(t_k, y(t_k))$  are uniformly bounded in  $X$ , in view of (23), it is easy to see that when  $\theta_2 - \theta_1$  tends to zero,  $|(Ty)(\theta_2) - (Ty)(\theta_1)|$  tends uniformly to zero in  $X$ . Hence,  $\{Ty : y \in C\}$  is a family of uniformly bounded and equicontinuous functions on  $[0, \omega]$ . By Arzela-Ascoli theorem, the operator  $T$  is completely continuous. The proof of Lemma 8 is complete.  $\square$

Our main results of this paper are as follows.

**Theorem 9.** Assume that  $(H_1)$ - $(H_4)$  and

$(H_5)$  there exists a  $R > 0$  such that  $F(t, u) \geq (R / (2\alpha\sigma B'(\xi)\lambda\omega)), \sum_{t \leq t_k < t+\omega} I_k(t_k, y(t_k)) \geq (R / (2\alpha\sigma\mu)),$  for  $\|u\| \leq \|y\| \in [\sigma R, R];$

$(H_6) F^0 = I^0 = F^\infty = I^\infty = 0$

hold. Then, (1) has two positive  $\omega$ -periodic solutions.

*Proof.* First, we define  $\Omega_R = \{y \in X : \|y\| < R\}$ ; then  $\Omega_R$  is an open subset of  $X$ . Then, for any  $y \in E \cap \partial\Omega_r$ , we have  $y(t) \geq \sigma R$ . Consequently,

$$u_j(t) = y(c_j(t)) \geq \sigma \|y\| \geq \sigma \|u(t)\|, \tag{24}$$

$$u_n(t) = \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \geq \sigma \|y\| \geq \sigma \|u(t)\|;$$

then

$$\|u(t)\| = \max_{1 \leq j \leq n-1} \left\{ y(c_j(t)), \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \right\} \geq \sigma R, \tag{25}$$

and from the definition of  $u(t)$ , we know  $\|u(t)\| \leq \|y(t)\|$ . From (9),  $(H_5)$ , and Lemma 5, we get

$$\begin{aligned} \| (Ty)(t) \| &= \sum_{i=1}^n |T_i y|_0 \\ &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right] \end{aligned}$$

$$\begin{aligned}
 &\geq \lambda B'(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds \\
 &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\
 &= \alpha \left[ \lambda B'(\xi) \int_0^\omega |F(s, u(s))| ds \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\
 &\geq \alpha \sigma \left( \lambda B'(\xi) \omega \frac{R}{2\alpha \sigma B'(\xi) \lambda \omega} + \frac{R\mu}{2\alpha \sigma \mu} \right) = R \\
 &> \|y\|.
 \end{aligned} \tag{26}$$

This yields

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_R. \tag{27}$$

On the other hand, if  $F^0 = I^0 = 0$  holds, then we can choose  $0 < R_1 < R$ , so that  $\int_0^\omega |f(t, u(t))| dt \leq \epsilon \|u\|$ ; from the definition of  $u(t)$ , we know  $\|u\| \leq \|y\|$ . Thus, we have  $\int_0^\omega |f(t, u(t))| dt \leq \epsilon \|y\|$ ,  $\sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \leq \epsilon \|y\|$  for  $y \in [0, R_1]$ ,  $t \in [0, \omega]$ ,  $1 \leq k < q$ , where constant  $\epsilon > 0$  satisfies  $\epsilon \beta (\lambda B(\xi) + \mu) \leq 1$ . By (9) and Lemma 5, we can obtain

$$\begin{aligned}
 (Ty)(t) &= \sum_{i=1}^n (T_i y) \\
 &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} G_i(t, s) b_i(s, y(s)) f_i(s, u(s)) ds \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} G_i(t, t_k) I_{ik}(t_k, y(t_k)) \right] \\
 &\leq \lambda B(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds \\
 &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\
 &= \beta \left[ \lambda B(\xi) \int_0^\omega |F(s, u(s))| ds \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\
 &\leq \epsilon \beta (\lambda B(\xi) + \mu) \|y\| \\
 &\leq \|y\|.
 \end{aligned} \tag{28}$$

This yields

$$\|(Ty)(t)\| \leq \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{R_1}. \tag{29}$$

In view of (27) and (29), by Lemma 5, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_R \setminus \overline{\Omega_{R_1}})$  with  $R_1 < \|y^*\| < R$ , which is a positive  $\omega$ -periodic solution of (1).

Likewise, in view of  $F^\infty = I^\infty = 0$ , for any  $0 < \epsilon < 1/(4\beta B(\xi)\lambda\omega)$ , there is  $N > 0$  such that

$$F(t, u(t)) \leq \epsilon \|u\|, \quad \text{for } \|u\| > N. \tag{30}$$

Let  $\Omega_{R_2} = \{y \in X : \|y\| < R_2\}$ , where

$$\begin{aligned}
 R_2 \geq &4N + 4B(\xi) \lambda \omega \max_{t \in [0, \omega], \|u\| \leq N} F(t, u(t)) \\
 &+ 2\beta \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))|.
 \end{aligned} \tag{31}$$

Then for any  $y \in E \cap \partial\Omega_{R_2}$ , from (9), (30), and (31), we have

$$\begin{aligned}
 \|(Ty)(t)\| &= \sum_{i=1}^n |T_i y|_0 \\
 &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| ds \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right] \\
 &\leq \beta B(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds \\
 &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\
 &= \beta \left[ \lambda B(\xi) \int_t^{t+\omega} |F(s, u(s))| ds \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\
 &= \beta \left\{ \lambda B(\xi) \left[ \int_{I_1} |F(s, u(s))| ds \right. \right. \\
 &\quad \left. \left. + \int_{I_2} |F(s, u(s))| ds \right] \right. \\
 &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right\} \\
 &\leq \frac{R_2}{4} + \frac{\|y\|}{4} + \frac{R_2}{2} \\
 &= \|y\|,
 \end{aligned} \tag{32}$$

where  $I_1 = \{s \in [0, \omega], \|u(s)\| \leq N\}$ ,  $I_2 = \{s \in [0, \omega], \|u(s)\| > N\}$ . This yields

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{R_2}. \quad (33)$$

In view of (27) and (33), by Lemma 5, it follows that  $T$  has a fixed point  $\bar{y} \in E \cap (\Omega_{R_2} \setminus \overline{\Omega_R})$  with  $R < \|\bar{y}\| < R_2$ , which is a positive  $\omega$ -periodic solution of (1). Therefore (1) has at least two positive periodic solutions; that is,  $R_1 < \|y^*\| < R < \|\bar{y}\| < R_2$ . This proves Theorem 9.  $\square$

**Corollary 10.** Assume that  $(H_1)$ – $(H_4)$  and

$(H_5)$  There exists a  $R > 0$  such that  $F(t, u) \geq (R/2\alpha\sigma B'(\xi)\lambda\omega)$ ,  $\sum_{t \leq t_k < t+\omega} I_k(t_k, y(t_k)) \geq (R/2\alpha\sigma\mu)$ , for  $\|u\| \leq \|y\| \in [\sigma R, R]$ ;

$(H_7)$   $F^0 = I^0 = 0$ , or  $F^\infty = I^\infty = 0$

hold. Then, (1) has a positive  $\omega$ -periodic solution.

**Theorem 11.** Assume that  $(H_1)$ – $(H_4)$  and

$(H_8)$  there exists a  $r > 0$  such that  $F(t, u) \leq (r/2\beta B(\xi)\lambda\omega)$ ,  $\sum_{t \leq t_k < t+\omega} I_k(t_k, y(t_k)) \leq (r/2\beta\mu)$ , for  $\|u\| \leq \|y\| \leq r$ ;

$(H_9)$   $F_0 = I_0 = F_\infty = I_\infty = \infty$

hold. Then, (1) has two positive  $\omega$ -periodic solutions.

*Proof.* We define  $\Omega_r = \{y \in X : \|y\| < r\}$ , where  $R$  satisfied  $(H_8)$ ; then  $\Omega_r$  is an open subset of  $X$  and  $0 \in \Omega_r$ . For any  $y \in E \cap \partial\Omega_r$ , by the definition of  $u(t)$ , we get  $\|u(t)\| \leq \|y(t)\| = r$ . Furthermore, by (9),  $(H_8)$ , and Lemma 5, we have

$$\begin{aligned} \|(Ty)(t)\| &= \sum_{i=1}^n |T_i y|_0 \\ &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right] \\ &\leq \lambda B(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds \\ &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\ &= \beta \left[ \lambda B(\xi) \int_0^\omega |F(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\ &\leq \beta \left( \lambda B(\xi) \omega \frac{r}{2\beta B(\xi)\lambda\omega} + \frac{r}{2\beta\mu} \right) \leq r = \|y\|. \end{aligned} \quad (34)$$

This implies for any  $y \in E \cap \partial\Omega_r$

$$\|Ty\| \leq \|y\|. \quad (35)$$

On the one hand, since  $F_0 = I_0 = \infty$ , then for any  $M_1 > 1/(2\alpha B'(\xi)\sigma\lambda\omega)$  there exists  $0 < r_1 < r$  such that

$$\begin{aligned} F(t, u(t)) &\geq M_1 \|u\|, \quad \text{for } \|u\| < r_1, \\ u_j &\geq \sigma \|u\|, \quad j = 1, 2, \dots, n. \end{aligned} \quad (36)$$

Letting  $\Omega_{r_1} = \{y \in X : \|y\| < r_1\}$ , then for any  $y \in E \cap \partial\Omega_{r_1}$ , one has  $\|y(t)\| = r_1$ ,  $\sum_{t \leq t_k < t+\omega} |H_k(t_k, y(t_k))| \geq (1/(2\alpha\mu))\|y(t)\| = (r_1/(2\alpha\mu))$ ,  $y(t) \geq \sigma\|y(t)\| = \sigma r_1$ . Consequently,

$$\begin{aligned} u_j(t) &= y(c_j(t)) \geq \sigma \|y\| \geq \sigma \|u(t)\|, \\ u_n(t) &= \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \geq \sigma \|y\| \geq \sigma \|u(t)\|, \\ \sigma r_1 &\leq \|u(t)\| \\ &= \max_{1 \leq j \leq n-1} \left\{ y(c_j(t)), \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \right\} \\ &\leq \|y(t)\| = r_1, \end{aligned} \quad (37)$$

where, together with (42) and Lemma 5, we have

$$\begin{aligned} \|(Ty)(t)\| &= \sum_{i=1}^n |T_i y|_0 \\ &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right] \\ &\geq \alpha B'(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds \\ &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\ &= \alpha \left[ \lambda B'(\xi) \int_t^{t+\omega} |F(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\ &\geq \alpha \lambda B'(\xi) M_1 \sigma \|y(t)\| \omega + \frac{\|y(t)\|}{2} \\ &= \|y\|. \end{aligned} \quad (38)$$

This implies for any  $y \in E \cap \partial\Omega_{r_1}$

$$\|Ty\| \geq \|y\|. \quad (39)$$

In view of (35) and (39), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_R \setminus \overline{\Omega_{r_1}})$  with  $r_1 < \|y^*\| < r$ , which is a positive  $\omega$ -periodic solution of (1). On the other hand, if  $F_\infty = I_\infty = \infty$ , then for any  $M_2 > (1/2\alpha B'(\xi)\sigma\lambda\omega)$  there exists  $r_2 > r$  such that

$$F(t, u(t)) \geq M_2 \|u\|, \quad \text{for } \|u\| > r_2, \tag{40}$$

$$u_j \geq \sigma \|u\|, \quad j = 1, 2, \dots, n.$$

Letting  $\Omega_{r_2} = \{y \in X : \|y\| < r_2\}$ , then for any  $y \in E \cap \partial\Omega_{r_2}$ , one has  $\|y(t)\| = r_2$ ,  $\sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \geq (1/2\alpha\mu)\|y(t)\| = (r_2/2\alpha\mu)$ ,  $y(t) \geq \sigma \|y(t)\| = \sigma r_2$ . Consequently,

$$u_j(t) = y(c_j(t)) \geq \sigma \|y\| \geq \sigma \|u(t)\|,$$

$$u_n(t) = \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \geq \sigma \|y\| \geq \sigma \|u(t)\|,$$

$$\|u(t)\| = \max_{1 \leq j \leq n-1} \left\{ y(c_j(t)), \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \right\}$$

$$\geq \sigma \|y(t)\| = \sigma r_2,$$

where, together with (41) and Lemma 5, we have

$$\|(Ty)(t)\| = \sum_{i=1}^n |T_i y|_0$$

$$= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| ds \right.$$

$$\left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right]$$

$$\geq \alpha B'(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds$$

$$+ \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))|$$

$$= \alpha \left[ \lambda B'(\xi) \int_t^{t+\omega} |F(s, u(s))| ds \right.$$

$$\left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right]$$

$$\geq \alpha \lambda B'(\xi) M_2 \sigma r_2 \omega + \frac{\|y(t)\|}{2}$$

$$\geq \|y\|.$$

This yields

$$\|(Ty)(t)\| \geq \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{r_2}. \tag{43}$$

In view of (35) and (43), by Lemma 2, it follows that  $T$  has a fixed point  $\bar{y} \in E \cap (\Omega_{r_2} \setminus \overline{\Omega_r})$  with  $r < \|\bar{y}\| < r_2$ , which is a

positive  $\omega$ -periodic solution of (1). Therefore, (1) has at least two positive periodic solutions; that is  $r_1 < \|y^*\| < r < \|\bar{y}\| < r_2$ . This proves Theorem 11.  $\square$

**Corollary 12.** Assume that  $(H_1)$ – $(H_4)$  and

$$(H_8) \text{ there exists a } r > 0 \text{ such that } F(t, u) \leq (r/2\beta B(\xi)\lambda\omega),$$

$$\sum_{t \leq t_k < t+\omega} H_k(t_k, y(t_k)) \leq (r/2\beta\mu), \text{ for } \|u\| \leq \|y\| \leq r;$$

$$(H_{10}) F_0 = I_0 = \infty, \text{ or } F_\infty = I_\infty = \infty;$$

hold. Then, (1) has a positive  $\omega$ -periodic solution.

**Theorem 13.** Assume that  $(H_1)$ – $(H_5)$ , and  $(H_8)$  hold. Then, (1) has a positive  $\omega$ -periodic solution  $y$  with  $\|y\|$  lying between  $R$  and  $r$ , which are defined in  $(H_5)$  and  $(H_8)$ , respectively.

*Proof.* Without loss of generality, we may assume that  $r < R$ ; then for any  $y \in E \cap \partial\Omega_r$ , by the definition of  $u(t)$ , we get  $\|u(t)\| \leq \|y(t)\| = r$ . Furthermore, by (9),  $(H_8)$ , and Lemma 5, we have

$$\|(Ty)(t)\| = \sum_{i=1}^n |T_i y|_0$$

$$= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t, s) b_i(s, y(s)) f_i(s, u(s))| \right.$$

$$\left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right]$$

$$\leq \lambda B(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t, s) f_i(s, u(s))| ds$$

$$+ \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))|$$

$$= \beta \left[ \lambda B(\xi) \int_0^\omega |F(s, u(s))| ds \right.$$

$$\left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right]$$

$$\leq \beta \left( \lambda B(\xi) \omega \frac{r}{2\beta B(\xi)\lambda\omega} + \frac{r}{2\beta\mu} \right)$$

$$\leq r = \|y\|.$$

(44)

This implies for any  $y \in E \cap \partial\Omega_r$

$$\|(Ty)\| \leq \|y\|. \tag{45}$$



Now, we let  $\Omega_R = \{y \in X : \|y\| < R\}$ ; then  $\Omega_R$  is an open subset of  $X$ . Then, for any  $y \in E \cap \partial\Omega_R$ , we have  $y(t) \geq \sigma R$ . Consequently,

$$\begin{aligned} u_j(t) &= y(c_j(t)) \geq \sigma \|y\| \geq \sigma \|u(t)\|, \\ u_n(t) &= \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \geq \sigma \|y\| \geq \sigma \|u(t)\|, \\ \|u(t)\| &= \max_{1 \leq j \leq n-1} \left\{ y(c_j(t)), \int_{-\infty}^t k(t-\xi) y(\xi) d\xi \right\} \\ &\geq \sigma R, \end{aligned} \tag{46}$$

and from the definition of  $u(t)$ , we know  $\|u(t)\| \leq \|y(t)\|$ . From (9),  $(H_5)$ , and Lemma 5, we get

$$\begin{aligned} \|(Ty)(t)\| &= \sum_{i=1}^n |T_i y|_0 \\ &= \sum_{i=1}^n \left[ \lambda \int_t^{t+\omega} |G_i(t,s) b_i(s, y(s)) f_i(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \right] \\ &\geq \lambda B'(\xi) \sum_{i=1}^n \int_t^{t+\omega} |G_i(t,s) f_i(s, u(s))| ds \\ &\quad + \mu \sum_{i=1}^n \sum_{t \leq t_k < t+\omega} |G_i(t, t_k) I_{ik}(t_k, y(t_k))| \\ &= \alpha \left[ \lambda B'(\xi) \int_0^\omega |F(s, u(s))| ds \right. \\ &\quad \left. + \mu \sum_{t \leq t_k < t+\omega} |I_k(t_k, y(t_k))| \right] \\ &\geq \alpha \sigma \left( \lambda B'(\xi) \omega \frac{R}{2\alpha \sigma B'(\xi) \lambda \omega} + \frac{R\mu}{2\alpha \sigma \mu} \right) = R \\ &> \|y\|. \end{aligned} \tag{47}$$

This yields

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_R. \tag{48}$$

In view of (45) and (48), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_R \setminus \overline{\Omega_r})$  with  $r < \|y^*\| < R$ , which is a positive  $\omega$ -periodic solution of (1). This proves Theorem 13.  $\square$

**Theorem 14.** *In addition to  $(H_1)$ – $(H_4)$ , suppose the following conditions hold:*

- $(H_{11})$   $0 < F^0 \leq (1/2\beta\lambda B(\xi)\omega)$ ,  $0 < I^0 \leq (1/2\beta\mu)$ ;
  - $(H_{12})$   $F_\infty \geq (1/2\alpha\sigma\lambda B'(\xi)\omega)$ ,  $I_\infty \geq (1/2\alpha\sigma\mu)$ ;
- then, (1) has a positive  $\omega$ -periodic solution.

*Proof.* In view of  $0 < F^0 \leq (1/2\beta\lambda B(\xi)\omega)$ ,  $0 < I^0 \leq (1/2\beta\mu)$ , there exists a sufficiently small  $r > 0$  such that

$$\begin{aligned} \frac{\int_0^\omega |F(t, u(t))| dt}{\|u\|} &\leq \frac{1}{2\beta\lambda B(\xi)\omega}, \quad \text{for any } \|u(t)\| \leq r, \\ \frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|} &\leq \frac{1}{2\beta\mu}, \quad \text{for any } \|y(t)\| \leq r, \end{aligned} \tag{49}$$

which yields

$$\begin{aligned} \int_0^\omega |F(t, u(t))| dt &\leq \frac{1}{2\beta\lambda B(\xi)\omega} \|u\| \\ &\leq \frac{r}{2\beta\lambda B(\xi)\omega}, \quad \text{for any } \|u(t)\| \leq r, \\ \sum_{t \leq t_k < t+\omega} |I_k(t, y)| &\leq \frac{1}{2\beta\mu} \|y\| \\ &\leq \frac{r}{2\beta\mu}, \quad \text{for any } \|y(t)\| \leq r. \end{aligned} \tag{50}$$

Therefore, condition  $(H_8)$  is satisfied. On the other hand, since  $F_\infty \geq (1/2\alpha\sigma\lambda B'(\xi)\omega)$ ,  $I_\infty \geq (1/2\alpha\sigma\mu)$ , there exists a sufficiently large  $R > 0$  ( $R > r$ ) such that

$$\begin{aligned} \frac{\int_0^\omega |F(t, u(t))| dt}{\|u\|} &\geq \frac{1}{2\alpha\sigma\lambda B'(\xi)\omega}, \quad \text{for any } \|u(t)\| \in [\sigma R, R], \\ \frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|} &\geq \frac{1}{2\alpha\sigma\mu}, \quad \text{for any } \|y(t)\| \in [\sigma R, R], \end{aligned} \tag{51}$$

which yields

$$\begin{aligned} \int_0^\omega |F(t, u(t))| dt &\geq \frac{1}{2\alpha\sigma\lambda B'(\xi)\omega} \|u\| \\ &\geq \frac{R}{2\alpha\sigma\lambda B'(\xi)\omega}, \quad \text{for any } \|u(t)\| \in [\sigma R, R], \\ \sum_{t \leq t_k < t+\omega} |I_k(t, y)| &\geq \frac{1}{2\alpha\sigma\mu} \|y\| \\ &\geq \frac{R}{2\alpha\sigma\mu}, \quad \text{for any } \|y(t)\| \in [\sigma R, R]. \end{aligned} \tag{52}$$

Thus, condition  $(H_5)$  is satisfied. By Theorem 13, we complete the proof.  $\square$

**Theorem 15.** Assume that  $(H_1)$ – $(H_4)$  and

$$\begin{aligned} (H_{13}) \quad & F_0 > (1/2\alpha\sigma\lambda B'(\xi)\omega), I_0 > 1/2\alpha\sigma\mu; \\ (H_{14}) \quad & 0 < F^\infty \leq (1/2\beta\lambda B(\xi)\omega), 0 < I^\infty \leq (1/(2\beta\sigma\mu)) \end{aligned}$$

hold. Then, (1) has a positive  $\omega$ -periodic solution.

*Proof.* In view of  $F_0 > (1/2\alpha\sigma\lambda B'(\xi)\omega)$ ,  $I_0 > (1/2\alpha\sigma\mu)$ , for  $\epsilon = \min\{F_0 - (1/2\alpha\sigma\lambda B'(\xi)\omega), I_0 - (1/2\alpha\sigma\mu)\}$ , there exists a sufficiently small  $r > 0$  such that

$$\frac{\int_0^\omega |F(t, u(t))| dt}{\|u\|} \geq F_0 - \epsilon \geq \frac{1}{2\alpha\sigma\lambda B'(\xi)\omega},$$

for any  $0 \leq \|u(t)\| \leq r$ ,

$$u_j(t) \geq \sigma \|u(t)\|, \tag{53}$$

$$\frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|} \geq I_0 - \epsilon \geq \frac{1}{2\alpha\sigma\mu},$$

for any  $\|y(t)\| \in [\sigma r, r]$ ,

which yields

$$\begin{aligned} & \int_0^\omega |F(t, u(t))| dt \\ & \geq \frac{1}{2\alpha\sigma\lambda B'(\xi)\omega} \|u\| \\ & \geq \frac{r}{2\alpha\sigma\lambda B'(\xi)\omega}, \quad \text{for any } \|u(t)\| \in [\sigma r, r], \end{aligned} \tag{54}$$

$$\begin{aligned} \sum_{t \leq t_k < t+\omega} |I_k(t, y)| & \geq \frac{1}{2\alpha\sigma\mu} \|y\| \\ & \geq \frac{r}{2\alpha\sigma\mu}, \quad \text{for any } \|y(t)\| \in [\sigma r, r]. \end{aligned}$$

Therefore, condition  $(H_5)$  is satisfied. On the other hand, since  $0 < F^\infty \leq (1/2\beta\lambda B(\xi)\omega)$ ,  $0 < I^\infty \leq (1/2\beta\sigma\mu)$ , for  $\epsilon = \max\{(1/2\beta\lambda B(\xi)\omega) - F^\infty, (1/2\beta\sigma\mu) - I^\infty\}$ , there exists a sufficiently large  $R (R > r)$  such that

$$\frac{\int_0^\omega |F(t, u(t))| dt}{\|u\|} \leq F^\infty + \epsilon \leq \frac{1}{2\beta\lambda B(\xi)\omega},$$

for any  $\|u(t)\| \geq R$ ,

$$\frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|} \leq I^\infty + \epsilon \leq \frac{1}{2\beta\mu},$$

for any  $\|y(t)\| \geq R$ .

In the following, we consider two cases to prove  $(H_8)$  to be satisfied:  $\int_0^\omega |F(t, u(t))| dt, \sum_{t \leq t_k < t+\omega} |I_k(t, y)|$  are bounded or unbounded. The bounded case is clear. If  $\int_0^\omega |F(t, u(t))| dt$ , and  $\sum_{t \leq t_k < t+\omega} |I_k(t, y)|$  are unbounded, then there exist

$u^*, y^* \in R_+^n, R_1 = \|y^*\| \geq \|u^*\| \geq R$  and  $t_0 \in [0, \omega]$  such that

$$\int_0^\omega |F(t, u(t))| dt \leq \int_0^\omega |F(t, u^*(t))| dt,$$

for any  $\|u(t)\| \leq \|u^*\| \leq R_1$ ,

$$\sum_{t \leq t_k < t+\omega} |I_k(t, y)| \leq \sum_{t \leq t_k < t+\omega} |I_k(t, y^*)|,$$

for any  $\|y(t)\| \leq \|y^*\| + R_1$ .

Since  $R_1 = \|y^*\| \geq \|u^*\| \geq R$ , then we get

$$\begin{aligned} & \int_0^\omega |F(t, u(t))| dt \\ & \leq \int_0^\omega |F(t, u^*(t))| dt \leq \frac{\|u^*\|}{2\beta\lambda B(\xi)\omega} \\ & \leq \frac{\|y^*\|}{2\beta\lambda B(\xi)\omega} = \frac{R_1}{2\beta\lambda B(\xi)\omega}, \\ & \text{for any } \|u(t)\| \leq \|u^*\| \leq R_1, \end{aligned} \tag{57}$$

$$\begin{aligned} & \sum_{t \leq t_k < t+\omega} |I_k(t, y)| \\ & \leq \sum_{t \leq t_k < t+\omega} |I_k(t, y^*)| \leq \frac{\|y^*\|}{2\beta\mu} = \frac{R_1}{2\beta\mu}, \\ & \text{for any } \|y(t)\| \leq \|y^*\| + R_1. \end{aligned}$$

Thus, condition  $(H_8)$  is satisfied. By Theorem 14, we complete the proof.  $\square$

**Theorem 16.** Assume that  $(H_1)$ – $(H_5)$ ,  $(H_{11})$ , and  $(H_{14})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < R < \|\bar{y}\|$ , where  $R$  is defined in  $(H_5)$ .

*Proof.* From  $(H_5)$  and the proof of Theorem 9, we know that there exists a sufficiently large  $R > 0$  such that

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_R. \tag{58}$$

On the one hand, from  $(H_{11})$  and the proof of Theorem 14, we know that there exists a sufficiently small  $r > 0 (r < R)$  such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_r. \tag{59}$$

In view of (58) and (59), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_R \setminus \bar{\Omega}_r)$  with  $r < \|y^*\| < R$ , which is a positive  $\omega$ -periodic solution of (1).

On the other hand, from  $(H_{14})$  and the proof of Theorem 15, we know that there exists a sufficiently large  $R_1 > 0 (R_1 > R)$  such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{R_1}. \tag{60}$$

In view of (58) and (60), by Lemma 2, it follows that  $T$  has a fixed point  $\bar{y} \in E \cap (\Omega_{R_1} \setminus \bar{\Omega}_R)$  with  $R < \|\bar{y}\| < R_1$ , which is

a positive  $\omega$ -periodic solution of (1). Thus, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $r < \|y^*\| < R < \|\bar{y}\| < R_1$ . The proof is completed.  $\square$

**Corollary 17.** *In addition to  $(H_1)$ – $(H_5)$ , suppose  $(H_{11})$  or  $(H_{14})$  holds. Then, (1) has at least one positive  $\omega$ -periodic solution.*

**Theorem 18.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_8)$ ,  $(H_{12})$ , and  $(H_{13})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < r < \|\bar{y}\|$ , where  $r$  is defined in  $(H_8)$ .*

*Proof.* From  $(H_8)$  and the proof of Theorem 9, we know that there exists a sufficiently small  $r > 0$  such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_r. \quad (61)$$

On the one hand, from  $(H_{12})$  and the proof of Theorem 14, we know that there exists a sufficiently large  $r_1 > 0$  ( $r_1 > r$ ) such that

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{r_1}. \quad (62)$$

In view of (61) and (62), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_{r_1} \setminus \overline{\Omega_r})$  with  $r < \|y^*\| < r_1$ , which is a positive  $\omega$ -periodic solution of (1).

On the other hand, from  $(H_{13})$  and the proof of Theorem 15, we know that there exists a sufficiently small  $r^* > 0$  ( $r^* < r$ ) such that

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{r^*}. \quad (63)$$

In view of (61) and (63), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_r \setminus \overline{\Omega_{r^*}})$  with  $r^* < \|y^*\| < r$ , which is a positive  $\omega$ -periodic solution of (1). Thus, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $r^* < \|y^*\| < r < \|\bar{y}\| < r_1$ . The proof is completed.  $\square$

**Corollary 19.** *In addition to  $(H_1)$ – $(H_4)$ , and  $(H_8)$ , suppose  $(H_{12})$  or  $(H_{13})$  holds. Then, (1) has at least one positive  $\omega$ -periodic solution.*

**Theorem 20.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_6)$ ,  $(H_{12})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < \|\bar{y}\|$ .*

*Proof.* From  $(H_6)$  and the proof of Theorem 9, if  $F^0 = I^0 = 0$ , we know that there exists a sufficiently small  $r > 0$  such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_r. \quad (64)$$

In view of  $F^\infty = I^\infty = 0$ , we know that there exists a sufficiently large  $R > 0$  ( $R > r$ ) such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_R. \quad (65)$$

On the one hand, from  $(H_{12})$  and the proof of Theorem 14, we know that there exists a sufficiently large  $r_1 > 0$  ( $R > r_1 > r$ ) such that

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{r_1}. \quad (66)$$

In view of (64) and (66), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_{r_1} \setminus \overline{\Omega_r})$  with  $r < \|y^*\| < r_1$ , which is a positive  $\omega$ -periodic solution of (1). In view of (65) and (66), by Lemma 2, it follows that  $T$  has a fixed point  $\bar{y} \in E \cap (\Omega_R \setminus \overline{\Omega_{r_1}})$  with  $r_1 < \|\bar{y}\| < R$ , which is a positive  $\omega$ -periodic solution of (1). Thus, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $r < \|y^*\| < r_1 < \|\bar{y}\| < R$ . The proof is completed.  $\square$

**Corollary 21.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_7)$ , and  $(H_{12})$  hold. Then, (1) has at least one positive  $\omega$ -periodic solution.*

**Theorem 22.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_6)$ , and  $(H_{13})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < \|\bar{y}\|$ .*

*Proof.* From  $(H_{13})$  and the proof of Theorem 15, we know that there exists a sufficiently small  $r > 0$  such that

$$\|Ty\| > \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_r. \quad (67)$$

From  $(H_6)$  and the proof of Theorem 9, on the one hand, if  $F^0 = I^0 = 0$ , we know that there exists a sufficiently small  $r^* > 0$  ( $r^* < r$ ) such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_{r^*}. \quad (68)$$

In view of (67) and (68), by Lemma 2, it follows that  $T$  has a fixed point  $y^* \in E \cap (\Omega_r \setminus \overline{\Omega_{r^*}})$  with  $r^* < \|y^*\| < r$ , which is a positive  $\omega$ -periodic solution of (1).

On the other hand, if  $F^\infty = I^\infty = 0$ , we know that there exists a sufficiently large  $R > 0$  ( $R > r$ ) such that

$$\|Ty\| < \|y\|, \quad \text{for any } y \in E \cap \partial\Omega_R. \quad (69)$$

In view of (67) and (69), by Lemma 2, it follows that  $T$  has a fixed point  $\bar{y} \in E \cap (\Omega_R \setminus \overline{\Omega_r})$  with  $r < \|\bar{y}\| < R$ , which is a positive  $\omega$ -periodic solution of (1). Thus, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $r^* < \|y^*\| < r < \|\bar{y}\| < R$ . The proof is completed.  $\square$

**Corollary 23.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_7)$ , and  $(H_{13})$  hold. Then, (1) has at least one positive  $\omega$ -periodic solution.*

*Similarly, one can prove the following theorems and corollaries.*

**Theorem 24.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_9)$ , and  $(H_{11})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < \|\bar{y}\|$ .*

**Corollary 25.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_{10})$ , and  $(H_{11})$  hold. Then, (1) has at least one positive  $\omega$ -periodic solution.*

**Theorem 26.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_9)$ , and  $(H_{14})$  hold. Then, (1) has at least two positive  $\omega$ -periodic solutions  $y^*, \bar{y}$  satisfying  $0 < \|y^*\| < \|\bar{y}\|$ .*

**Corollary 27.** *Assume that  $(H_1)$ – $(H_4)$ ,  $(H_{10})$ , and  $(H_{14})$  hold. Then, (1) has at least one positive  $\omega$ -periodic solution.*

### 3. Existence of Periodic Solution of (2)

Now, we are in a position to attack the existence of positive periodic solutions of (2). By carrying out similar arguments as in Section 2, it is not difficult to establish sufficient criteria for the existence of positive periodic solutions of (2). For simplicity, we prefer to list below the corresponding criteria for (2) without proof, since the proofs are very similar to those in Section 2.

For  $(t, s) \in R^2, 1 \leq i \leq n$ , we define

$$G_i^*(t, s) = \frac{e^{-\int_t^s a_i(\xi, y(\xi))d\xi}}{1 - e^{-\int_0^\omega a_i(\xi, y(\xi))d\xi}}$$

$$= \frac{e^{\int_s^{t+\omega} a_i(\xi, y(\xi))d\xi}}{e^{\int_0^\omega a_i(\xi, y(\xi))d\xi} - 1}, \tag{70}$$

$$G^*(t, s) = \text{diag} [G_1^*(t, s), G_2^*(t, s), \dots, G_n^*(t, s)].$$

It is clear that  $G_i^*(t, t) \geq G_i^*(t, s) \geq G_i^*(t, t + \omega)$ ,  $\partial G_i^*(t, s)/(\partial t) = a_i(t, y(t))G_i^*(t, s)$ ,  $G_i^*(t, t) - G_i^*(t, t + \omega) = 1$ . In view of  $(H_1)$ , we also define for  $1 \leq i \leq n$

$$\alpha_i^* := \min_{0 \leq t \leq s \leq \omega} |G_i^*(t, s)| = \frac{1}{e^{\int_0^\omega a_{2i}(\xi)d\xi} - 1} = \alpha_i,$$

$$\beta_i^* := \max_{0 \leq t \leq s \leq \omega} |G_i^*(t, s)| = \frac{e^{\int_0^\omega a_{2i}(\xi)d\xi}}{e^{\int_0^\omega a_{1i}(\xi)d\xi} - 1} = \beta_i,$$

$$\alpha^* = \min_{1 \leq i \leq n} \alpha_i^* = \alpha, \quad \beta^* = \max_{1 \leq i \leq n} \beta_i^* = \beta,$$

$$\delta = \frac{\alpha^*}{\beta^*} \in (0, 1) = \sigma, \tag{71}$$

$$B_i(t) = \max \{|b_{1i}(t)|, |b_{2i}(t)|\},$$

$$B'_i(t) = \min \{|b_{1i}(t)|, |b_{2i}(t)|\},$$

$$B(t) = \max_{1 \leq i \leq n} \{B_i(t)\},$$

$$B'(t) = \min_{1 \leq i \leq n} \{B'_i(t)\}.$$

Let  $X = \{y = (y_1(t), y_2(t), \dots, y_n(t))^T \in PC(R, R^n) \mid y(t + \omega) = y(t)\}$  with the norm  $\|y\| = \sum_{i=1}^n |y_i|_0, |y_i|_0 = \sup_{t \in [0, \omega]} |y_i(t)|$ . It is easy to verify that  $(X, \|\cdot\|)$  is a Banach space. Define  $P$  as a cone in  $X$  by

$$P = \{y = (y_1(t), y_2(t), \dots, y_n(t))^T \in X : y_i(t) \geq \delta \|y_i\|_0, t \in [0, \omega]\}. \tag{72}$$

We easily verify that  $P$  is a cone in  $X$ . We define an operator  $\phi : X \rightarrow X$  as follows:

$$(\phi y)(t) = ((\phi_1 y)(t), (\phi_2 y)(t), \dots, (\phi_n y)(t))^T, \tag{73}$$

where

$$(\phi_i y)(t) = \lambda \int_t^{t+\omega} G_i^*(t, s) b_i(s, y(s)) f_i(s, u(s)) ds + \mu \sum_{t \leq t_k < t+\omega} G_i^*(t, t_k) I_{ik}(t_k, y(t_k)). \tag{74}$$

The proof of the following lemmas, theorems, and corollaries is similar to those in Section 2; we omit all the details here.

**Lemma 28.** Assume that  $(H_1)$ – $(H_4)$  hold. The existence of positive  $\omega$ -periodic solution of (2) is equivalent to that of nonzero fixed point of  $\phi$  in  $P$ .

**Lemma 29.** Assume that  $(H_1)$ – $(H_4)$  hold. Then  $\phi : P \rightarrow P$  is well defined.

**Lemma 30.** Assume that  $(H_1)$ – $(H_4)$  hold. Then  $\phi : P \rightarrow P$  is completely continuous.

**Theorem 31.** Assume  $(H_1)$ – $(H_4)$  and  $(H_5)$  hold. Moreover, if one of the following conditions holds:

$$(H_6); (H_{11}), (H_{14}), \tag{75}$$

then, (2) has two positive  $\omega$ -periodic solutions  $y^*$  and  $\bar{y}$  satisfying  $0 < \|y^*\| < R < \|\bar{y}\|$ , where  $R$  is defined in  $(H_5)$ .

**Theorem 32.** Assume  $(H_1)$ – $(H_4)$  and  $(H_8)$  hold. Moreover, if one of the following conditions holds:

$$(H_9); (H_{12}), (H_{13}), \tag{76}$$

then, (2) has two positive  $\omega$ -periodic solutions  $y^*$  and  $\bar{y}$  satisfying  $0 < \|y^*\| < r < \|\bar{y}\|$ , where  $r$  is defined in  $(H_8)$ .

**Theorem 33.** Assume  $(H_1)$ – $(H_4)$  hold. Moreover, if one of the following conditions holds:

$$(H_6), (H_{12}); (H_6), (H_{13});$$

$$(H_9), (H_{11}); (H_9), (H_{14}), \tag{77}$$

then, (2) has two positive  $\omega$ -periodic solutions  $y^*$  and  $\bar{y}$  satisfying  $0 < \|y^*\| < \|\bar{y}\|$ .

**Theorem 34.** Assume  $(H_1)$ – $(H_5)$  hold. Moreover, if one of the following conditions holds:

$$(H_7); (H_8); (H_{11}); (H_{14}), \tag{78}$$

then, (2) has at least one positive  $\omega$ -periodic solution.

**Theorem 35.** Assume  $(H_1)$ – $(H_4)$  and  $(H_8)$  hold. Moreover, if one of the following conditions holds:

$$(H_{10}); (H_{12}); (H_{13}), \tag{79}$$

then, (2) has at least one positive  $\omega$ -periodic solution.

**Theorem 36.** Assume  $(H_1)$ – $(H_4)$  hold. Moreover, if one of the following conditions holds:

$$\begin{aligned} &(H_7), (H_{10}); (H_7), (H_{12}); \\ &(H_7), (H_{13}); (H_{10}), (H_{11}); \\ &(H_{10}), (H_{14}); (H_{11}), (H_{12}); \\ &(H_{13}), (H_{14}), \end{aligned} \tag{80}$$

then, (2) has at least one positive  $\omega$ -periodic solution.

### 4. Applications

In this section, as some applications of our main results, we will consider some special cases of systems (1) and (2), which have been investigated extensively in the literature.

*Application 1.* Consider the following equations:

$$\begin{aligned} y'(t) = & -A(t, y(t))y(t) \\ & + \lambda B(t, y(t))F(t, u(t)), \quad t \in \mathbb{R}, \end{aligned} \tag{81}$$

$$\begin{aligned} y'(t) = & A(t, y(t))y(t) \\ & - \lambda B(t, y(t))F(t, u(t)), \quad t \in \mathbb{R}, \end{aligned} \tag{82}$$

where  $u(t) = (y(c_1(t)), \dots, y(c_{n-1}(t)), \int_{-\infty}^t k(t - \xi)y(\xi)d\xi)$ , which are special cases of systems (1) and (2) without impulse, respectively. First, we list several assumptions:

- $(P_1) = (H_1)$ ;
- $(P_2) = (H_2)$ ;
- $(P_3) = (H_3)$ ;
- $(P_4)$  there exists a  $R > 0$  such that  $F(t, u) \geq (R/(\alpha\sigma B'(\xi)\lambda\omega))$  for  $\|u\| \leq \|y\| \in [\sigma R, R]$ ;
- $(P_5)$  there exists a  $r > 0$  such that  $F(t, u) \leq (r/(2\beta B(\xi)\lambda\omega))$  for  $\|u\| \leq \|y\| \leq r$ ;
- $(P_6) F^0 = 0$ ;
- $(P_7) F^\infty = 0$ ;
- $(P_8) F_0 = \infty$ ;
- $(P_9) F_\infty = \infty$ ;
- $(P_{10}) F^0 = \eta_1 \in (0, 1/\beta\lambda B(\xi)\omega)$ ;
- $(P_{11}) F^\infty = \theta_1 \in (0, 1/\beta\lambda B(\xi)\omega)$ ;
- $(P_{12}) F_0 = \eta_2 \in (1/\alpha\sigma\lambda B'(\xi)\omega, \infty)$ ;
- $(P_{13}) F_\infty = \theta_2 \in (1/\alpha\sigma\lambda B'(\xi)\omega, \infty)$ .

By applying theorems in Sections 2 and 3 and to systems (81) and (82), respectively, we obtain the following theorems.

**Theorem 37.** Assume  $(P_1)$ – $(P_4)$  hold. Moreover, if one of the following conditions holds:

$$(P_6), (P_7); (P_{10}), (P_{11}), \tag{83}$$

then, (81) and (82) have at least two positive  $\omega$ -periodic solutions.

**Theorem 38.** Assume  $(P_1)$ – $(P_3)$  and  $(P_5)$  hold. Moreover, if one of the following conditions holds:

$$(P_8), (P_9); (P_{12}), (P_{13}), \tag{84}$$

then, (81) and (82) have at least two positive  $\omega$ -periodic solutions.

**Theorem 39.** Assume  $(P_1)$ – $(P_3)$  hold. Moreover, if one of the following conditions holds:

$$\begin{aligned} &(P_6), (P_7), (P_{12}); (P_6), (P_7), (P_{13}); \\ &(P_8), (P_9), (P_{10}); (P_8), (P_9), (P_{11}), \end{aligned} \tag{85}$$

then, (81) and (82) have at least two positive  $\omega$ -periodic solutions.

**Theorem 40.** Assume  $(P_1)$ – $(P_4)$  hold. Moreover, if one of the following conditions holds:

$$(P_5); (P_8); (P_9); (P_{10}); (P_{11}), \tag{86}$$

then, (81) and (82) have at least one positive  $\omega$ -periodic solution.

**Theorem 41.** Assume  $(P_1)$ – $(P_3)$  and  $(P_5)$  hold. Moreover, if one of the following conditions holds:

$$(P_6); (P_7); (P_{12}); (P_{13}), \tag{87}$$

then (81) and (82) have at least one positive  $\omega$ -periodic solution.

**Theorem 42.** Assume  $(P_1)$ – $(P_3)$ , hold. Moreover, if one of the following conditions holds:

$$\begin{aligned} &(P_6), (P_9); (P_6), (P_{13}); \\ &(P_7), (P_8); (P_7), (P_{12}); \\ &(P_8), (P_{11}); (P_9), (P_{10}); \\ &(P_{10}), (P_{13}); (P_{11}), (P_{12}), \end{aligned} \tag{88}$$

then, (81) and (82) have at least one positive  $\omega$ -periodic solution.

*Application 2.* Consider the following equations:

$$y'(t) = -a(t)y(t) + f(t, u(t)), \quad t \in \mathbb{R}, t \neq t_k, \tag{89}$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in \mathbb{Z}_+,$$

$$y'(t) = a(t)y(t) - f(t, u(t)), \quad t \in \mathbb{R}, t \neq t_k, \tag{90}$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in \mathbb{Z}_+,$$

where

$$u(t) = \left( y(g_1(t)), \dots, y(g_{n-1}(t)), \int_{-\infty}^t k(t - \xi)y(\xi)d\xi \right), \tag{91}$$

which are special cases of systems (1) and (2), respectively. For convenience in the following discussion, on the one hand, we introduce the following notations:

$$\begin{aligned}
 f^a &= \limsup_{u \in E, \|u\| \rightarrow a} \max_{t \in [0, \omega]} \frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|}, \\
 f_a &= \liminf_{u \in E, \|u\| \rightarrow a} \min_{t \in [0, \omega]} \frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|}, \\
 I^a &= \limsup_{y \in E, \|y\| \rightarrow a} \max_{t \in [0, \omega]} \frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|}, \\
 I_a &= \liminf_{y \in E, \|y\| \rightarrow a} \min_{t \in [0, \omega]} \frac{\sum_{t \leq t_k < t+\omega} |I_k(t, y)|}{\|y\|},
 \end{aligned} \tag{92}$$

where  $a$  denotes either 0 or  $\infty$ ,  $\|u\| = \max\{|u_1|, |u_2|, \dots, |u_n|\}$ . On the other hand, we list several assumptions:

- (A<sub>1</sub>) = (H<sub>1</sub>);
- (A<sub>2</sub>) = (H<sub>2</sub>);
- (A<sub>3</sub>) = (H<sub>3</sub>);
- (A<sub>4</sub>) = (H<sub>4</sub>);
- (A<sub>5</sub>) there exists a  $R > 0$  such that  $f(t, u) \geq (R/2\alpha\sigma\lambda\omega)$ ,  $\sum_{t \leq t_k < t+\omega} H_k(t_k, y(t_k)) \geq (R/2\alpha\sigma\mu)$ , for  $\|u\| \leq \|y\| \in [\sigma R, R]$ ;
- (A<sub>6</sub>) there exists a  $r > 0$  such that  $f(t, u) \leq (r/2\beta\lambda\omega)$ ,  $\sum_{t \leq t_k < t+\omega} I(t_k, y(t_k)) \leq (r/2\beta\mu)$ , for  $\|u\| \leq \|y\| \leq r$ ;
- (A<sub>7</sub>)  $f^0 = I^0 = 0$ ;
- (A<sub>8</sub>)  $f^\infty = I^\infty = 0$ ;
- (A<sub>9</sub>)  $f_0 = I_0 = \infty$ ;
- (A<sub>10</sub>)  $f_\infty = I_\infty = \infty$ ;
- (A<sub>11</sub>)  $f^0 = \rho_1 \in (0, 1/2\beta\lambda\omega)$ ,  $I^0 = \xi_1 \in (0, 1/2\beta\mu)$ ;
- (A<sub>12</sub>)  $f^\infty = \varrho_1 \in (0, 1/2\beta\lambda\omega)$ ,  $I^\infty = \varsigma_1 \in (0, 1/2\beta\mu)$ ;
- (A<sub>13</sub>)  $f_0 = \rho_2 \in (1/2\alpha\sigma\lambda\omega, \infty)$ ,  $I_0 = \xi_2 \in (1/2\alpha\sigma\mu, \infty)$ ;
- (A<sub>14</sub>)  $f_\infty = \varrho_2 \in (1/2\alpha\sigma\lambda\omega, \infty)$ ,  $I_\infty = \varsigma_2 \in (1/2\alpha\sigma\mu, \infty)$ .

By applying theorems in Sections 2 and 3 and to systems (89) and (90), respectively, we obtain the following theorems.

**Theorem 43.** Assume (A<sub>1</sub>)–(A<sub>5</sub>) hold. Moreover, if one of the following conditions holds:

$$(A_7), (A_8); (A_{11}), (A_{12}), \tag{93}$$

then, (89) and (90) have at least two positive  $\omega$ -periodic solutions.

**Theorem 44.** Assume (A<sub>1</sub>)–(A<sub>4</sub>) and (A<sub>6</sub>) hold. Moreover, if one of the following conditions holds:

$$(A_9), (A_{10}); (A_{13}), (A_{14}), \tag{94}$$

then, (89) and (90) have at least two positive  $\omega$ -periodic solutions.

**Theorem 45.** Assume (A<sub>1</sub>)–(A<sub>4</sub>) hold. Moreover, if one of the following conditions holds:

$$\begin{aligned}
 &(A_7), (A_8), (A_{13}); (A_7), (A_8), (A_{14}); \\
 &(A_9), (A_{10}), (A_{11}); (A_9), (A_{10}), (A_{12}),
 \end{aligned} \tag{95}$$

then, (89) and (90) have at least two positive  $\omega$ -periodic solutions.

**Theorem 46.** Assume (A<sub>1</sub>)–(A<sub>5</sub>) hold. Moreover, if one of the following conditions holds:

$$(A_5); (A_9); (A_{10}); (A_{11}); (A_{12}), \tag{96}$$

then, (89) and (90) have at least one positive  $\omega$ -periodic solution.

**Theorem 47.** Assume (A<sub>1</sub>)–(A<sub>4</sub>) and (A<sub>6</sub>) hold. Moreover, if one of the following conditions holds:

$$(A_7); (A_8); (A_{13}); (A_{14}), \tag{97}$$

then, (89) and (90) have at least one positive  $\omega$ -periodic solution.

**Theorem 48.** Assume (A<sub>1</sub>)–(A<sub>4</sub>) hold. Moreover, if one of the following conditions holds:

$$\begin{aligned}
 &(A_7), (A_{10}); (A_7), (A_{14}); \\
 &(A_8), (A_9); (A_8), (A_{13}); \\
 &(A_9), (A_{12}); (A_{10}), (A_{11}); \\
 &(A_{11}), (A_{14}); (A_{12}), (A_{13}),
 \end{aligned} \tag{98}$$

then, (89) and (90) have at least one positive  $\omega$ -periodic solution.

*Application 3.* Consider the following equations:

$$y'(t) = -a(t)y(t) + f(t, u(t)), \quad t \in \mathbb{R}, \tag{99}$$

$$y'(t) = a(t)y(t) - f(t, u(t)), \quad t \in \mathbb{R}, \tag{100}$$

where

$$\begin{aligned}
 u(t) &= \left( y(c_1(t)), \dots, y(c_{n-1}(t)), \right. \\
 &\quad \left. \int_{-\infty}^t k(t-\xi)y(\xi)d\xi \right),
 \end{aligned} \tag{101}$$

which are special cases of systems (89) and (90) without impulse, respectively, that is,  $I(t_k, y(t_k)) = 0$ . For convenience in the following discussion, we list several assumptions:

- (A<sub>1</sub><sup>\*</sup>) = (H<sub>1</sub>);
- (A<sub>2</sub><sup>\*</sup>) = (H<sub>2</sub>);
- (A<sub>3</sub><sup>\*</sup>) = (H<sub>3</sub>);

(A<sub>4</sub><sup>\*</sup>) there exists a  $R > 0$  such that  $f(t, u) \geq (R/2\alpha\sigma\lambda\omega)$ , for  $\|u\| \leq \|y\| \in [\sigma R, R]$ ;

(A<sub>5</sub><sup>\*</sup>) there exists a  $r > 0$  such that  $f(t, u) \leq (r/2\beta\lambda\omega)$ , for  $\|u\| \leq \|y\| \leq r$ ;

(A<sub>6</sub><sup>\*</sup>)  $f^0 = 0$ ; (A<sub>7</sub><sup>\*</sup>)  $f^\infty = 0$ ;

(A<sub>8</sub><sup>\*</sup>)  $f_0 = \infty$ ; (A<sub>9</sub><sup>\*</sup>)  $f_\infty = \infty$ ;

(A<sub>10</sub><sup>\*</sup>)  $f^0 = \rho_1 \in (0, 1/(2\beta\lambda\omega))$ ;

(A<sub>11</sub><sup>\*</sup>)  $f^\infty = \varrho_1 \in (0, 1/(2\beta\lambda\omega))$ ;

(A<sub>12</sub><sup>\*</sup>)  $f_0 = \rho_2 \in (1/(2\alpha\sigma\lambda\omega), \infty)$ ;

(A<sub>13</sub><sup>\*</sup>)  $f_\infty = \varrho_2 \in (1/(2\alpha\sigma\lambda\omega), \infty)$ .

We obtain the following theorems.

**Corollary 49.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>4</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_6^*), (A_7^*); (A_{10}^*), (A_{11}^*), \tag{102}$$

then, (99) and (100) have at least two positive  $\omega$ -periodic solutions.

**Corollary 50.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>3</sub><sup>\*</sup>) and (A<sub>5</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_8^*), (A_9^*); (A_{12}^*), (A_{13}^*), \tag{103}$$

then, (99) and (100) have at least two positive  $\omega$ -periodic solutions.

**Corollary 51.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>3</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_6^*), (A_7^*), (A_{12}^*); (A_6^*), (A_7^*), (A_{13}^*); \tag{104}$$

$$(A_8^*), (A_9^*), (A_{10}^*); (A_8^*), (A_9^*), (A_{11}^*),$$

then, (99) and (100) have at least two positive  $\omega$ -periodic solutions.

**Corollary 52.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>4</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_5^*); (A_8^*); (A_9^*); (A_{10}^*); (A_{11}^*), \tag{105}$$

then, (99) and (100) have at least one positive  $\omega$ -periodic solution.

**Corollary 53.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>3</sub><sup>\*</sup>), (A<sub>5</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_6^*); (A_7^*); (A_{12}^*); (A_{13}^*), \tag{106}$$

then, (99) and (100) have at least one positive  $\omega$ -periodic solution.

**Corollary 54.** Assume (A<sub>1</sub><sup>\*</sup>)–(A<sub>3</sub><sup>\*</sup>) hold. Moreover, if one of the following conditions holds:

$$(A_6^*), (A_9^*); (A_6^*), (A_{13}^*); \tag{107}$$

$$(A_7^*), (A_8^*); (A_7^*), (A_{12}^*);$$

$$(A_8^*), (A_{11}^*); (A_9^*), (A_{10}^*);$$

$$(A_{10}^*), (A_{13}^*); (A_{11}^*), (A_{12}^*),$$

then, (99) and (100) have at least one positive  $\omega$ -periodic solution.

Hence, our results generalize and improve the corresponding results of [16].

**Application 4.** Consider the generalized logistic model of single species [16, 21] with impulse and two parameters:

$$y'(t) = y(t) a(t) - \lambda y(t) \left[ \sum_{i=1}^n b_i(t) y(t - \tau_i(t)) + c(t) \int_{-\infty}^t k(t-s) y(s) ds \right], \tag{108}$$

$$t \in \mathbb{R}, t \neq t_k,$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in \mathbb{Z}_+,$$

where  $a(t), b_i(t), \tau_i(t), c(t) \in C(\mathbb{R}, \mathbb{R}_+)$  are  $\omega$ -periodic,  $\lambda > 0, \mu > 0$  are two parameters, and  $k : \mathbb{R}_+ \rightarrow \mathbb{R}_+$  is integrable such that  $\int_0^\omega k(t)dt = 1$ .

**Theorem 55.** Assume that  $I_k \in C(\mathbb{R}, \mathbb{R}_-)$  and the following conditions hold:

- (1)  $I^0 = 0, I_\infty = \infty$ ;
- (2)  $\sum_{i=1}^n b_i^L + c^L > 0$ ;

then, (108) has at least one positive  $\omega$ -periodic solution, where

$$\alpha = \frac{1}{e^{\int_0^\omega a(t)dt} - 1}, \quad \beta = \frac{e^{\int_0^\omega a(t)dt}}{e^{\int_0^\omega a(t)dt} - 1}, \tag{109}$$

$$\sigma = \frac{\alpha}{\beta}, \quad g^M = \max_{t \in [0, \omega]} g(t), \quad g^L = \min_{t \in [0, \omega]} g(t).$$

*Proof.* We let

$$f(t, u(t)) = u_0 \left[ \sum_{i=1}^n b_i(t) u_i(t) + c(t) u_{n+1} \right], \tag{110}$$

$$u = (u_0, u_1, \dots, u_n, u_{n+1}) \in \mathbb{R}^{n+2}.$$

Then, (108) can be seen as a special form of (2) satisfying  $(H_1)$ – $(H_4)$ . We can construct the same Banach space  $X$  and cones  $E$  as in Section 2. Then for any  $y \in E$ ,

$$\begin{aligned} & \int_0^\omega |f(t, u(t))| dt \\ &= \int_0^\omega \left| u_0 \left[ \sum_{i=1}^n b_i(t) u_i + c(t) u_{n+1} \right] \right| dt \quad (111) \\ &\geq \sigma \|u\|^2 \left[ \sum_{i=1}^n b_i^L + c^L \right] \omega, \end{aligned}$$

so we have

$$\frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|} \rightarrow \infty, \quad \|u\| \rightarrow \infty; \quad (112)$$

that is,  $f_\infty = \infty$ . On the other hand,

$$\begin{aligned} & \int_0^\omega |f(t, u(t))| dt \\ &= \int_0^\omega \left| u_0 \left[ \sum_{i=1}^n b_i(t) u_i + c(t) u_{n+1} \right] \right| dt \quad (113) \\ &\leq \|u\|^2 \left[ \sum_{i=1}^n b_i^M + c^M \right] \omega, \end{aligned}$$

which can lead to

$$\frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|} \rightarrow 0, \quad \|u\| \rightarrow 0; \quad (114)$$

that is,  $f^0 = 0$ . Then in view of (2), (112), and (114), we can obtain that (108) has at least one positive  $\omega$ -periodic solution. The proof is complete.  $\square$

*Application 5.* Consider the generalized so-called Nicholson’s Blowflies model [19, 20] with impulse and two parameters:

$$\begin{aligned} y'(t) &= -y(t) a(t) \\ &+ \lambda b(t) y(t - \tau(t)) e^{-c(t)y(t-\tau(t))}, \quad (115) \\ &t \in R, \quad t \neq t_k, \end{aligned}$$

$$\Delta y(t_k) = \mu I_k(t_k, y(t_k)), \quad k \in Z_+,$$

where  $a(t), b(t), c(t)\tau(t) \in C(R, R_+)$  are  $\omega$ -periodic and  $\lambda > 0, \mu > 0$  are two parameters.

**Theorem 56.** Assume that  $I_k \in C(R, R_-)$  and the following conditions hold:

$$(3) \quad I^0 = \infty, \quad I_\infty = 0;$$

then, (115) has at least one positive  $\omega$ -periodic solution, where

$$\eta = \frac{1}{e^{\int_0^\omega a(t)dt} - 1}, \quad \theta = \frac{e^{\int_0^\omega a(t)dt}}{e^{\int_0^\omega a(t)dt} - 1}, \quad (116)$$

$$\delta = \frac{\eta}{\theta}, \quad g^M = \max_{t \in [0, \omega]} g(t), \quad g^L = \min_{t \in [0, \omega]} g(t).$$

*Proof.* We let  $f(t, u(t)) = b(t)u(t)e^{-c(t)u(t)}$ . Then, (115) can be seen as a special form of (1) satisfying  $(H_1)$ – $(H_4)$ . We can construct the same Banach space  $X$  and cones  $P$  as in Section 2. Then for any  $y \in P$ ,

$$\begin{aligned} & \int_0^\omega |f(t, u(t))| dt \\ &= \int_0^\omega |b(t) u(t) e^{-c(t)u(t)}| dt \quad (117) \\ &\geq \|u\| \frac{b^L}{e^{c^M \|u\|}} \omega. \end{aligned}$$

So we have

$$\frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|} \rightarrow 0, \quad \|u\| \rightarrow \infty; \quad (118)$$

that is,  $f_\infty = 0$ . On the other hand,

$$\begin{aligned} & \int_0^\omega |f(t, u(t))| dt \int_0^\omega |b(t) u(t) e^{-c(t)u(t)}| dt \\ &\leq \|u\| \frac{b^M}{e^{c^L \|u\|}} \omega, \quad (119) \end{aligned}$$

which can lead to

$$\frac{\int_0^\omega |f(t, u(t))| dt}{\|u\|} \rightarrow \infty, \quad \|u\| \rightarrow 0; \quad (120)$$

that is,  $f^0 = \infty$ . Then in view of (1), (93), and (120), we can obtain that (115) has at least one positive  $\omega$ -periodic solution. The proof is complete.  $\square$
