# EXACT LOCAL WHITTLE ESTIMATION OF FRACTIONAL INTEGRATION

#### Abstract

An exact form of the local Whittle likelihood is studied with the intent of developing a general-purpose estimation procedure for the memory parameter $(d)$ that does not rely on tapering or differencing prefilters. The resulting exact local Whittle estimator is shown to be consistent and to have the same $N\left(0, \frac{1}{4}\right)$ limit distribution for all values of $d$ if the optimization covers an interval of width less than $\frac{9}{2}$ and the initial value of the process is known.


1. Introduction. Semiparametric estimation of the memory parameter $(d)$ in fractionally integrated $(I(d))$ time series is appealing in empirical work because of the general treatment of the short-memory component that it affords. Two common statistical procedures in this class are log-periodogram (LP) regression [1, 10] and local Whittle (LW) estimation [5, 11]. LW estimation is known to be more efficient than LP regression in the stationary $\left(|d|<\frac{1}{2}\right)$ case, although numerical optimization methods are needed in the calculation. Outside the stationary region, it is known that the asymptotic theory for the LW estimator is discontinuous at $d=\frac{3}{4}$ and again at $d=1$, is awkward to use because of nonnormal limit theory and, worst of all, the estimator is inconsistent when $d>1$ [8]. Thus, the LW estimator is not a good general-purpose estimator when the value of $d$ may take on values in the nonstationary zone beyond $\frac{3}{4}$. Similar comments apply in the case of LP estimation [4].

To extend the range of application of these semiparametric methods, data differencing and data tapering have been suggested [3, 15]. These methods have the advantage that they are easy to implement and they make use of existing algorithms once the data filtering has been carried out. Differencing has the disadvantage that prior information is needed on the appropriate order of differencing. Tapering has the disadvantage that the filter distorts the trajectory of the data and inflates the asymptotic variance. As a consequence, there is presently

[^0]no general-purpose efficient estimation procedure when the value of $d$ may take on values in the nonstationary zone beyond $\frac{3}{4}$.

The present paper studies an exact form of the local Whittle estimator which does not rely on differencing or tapering and which seems to offer a good generalpurpose estimation procedure for the memory parameter that applies throughout the stationary and nonstationary regions of $d$. The estimator, which we call the exact LW estimator, is shown to be consistent and to have $N\left(0, \frac{1}{4}\right)$ limit distribution when the optimization covers an interval of width less than $\frac{9}{2}$. The exact LW estimator therefore has the same limit theory as the LW estimator has for stationary values of $d$. The approach seems to offer a useful alternative for applied researchers who are looking for a general-purpose estimator and want to allow for a substantial range of stationary and nonstationary possibilities for $d$. The method has the further advantage that it provides a basis for constructing asymptotic confidence intervals for $d$ that are valid irrespective of the true value of the memory parameter.

The exact LW estimator given here assumes the initial value of the data to be known. This restriction can be removed by estimating it along with $d$, as shown by Shimotsu [14]. Also, computation of the estimator involves a numerical optimization that is more demanding than conventional LW estimation. Our experience from simulations indicates that the computation time required is about ten times that of the LW estimator and is well within the capabilities of a small notebook computer.
2. Exact local Whittle estimation. We consider the fractional process $X_{t}$ generated by the model

where $I\{\cdot\}$ is the indicator function and $u_{t}$ is stationary with zero mean and spectral density $f_{u}(\lambda) \sim G_{0}$ as $\lambda \rightarrow 0$. Expanding the binomial in (1) gives the form

where

is Pochhammer's symbol for the forward factorial function and $\Gamma(\cdot)$ is the gamma function. When $d_{0}$ is a positive integer, the series in (2) terminates, giving the usual formulae for the model (1) in terms of differences and higher-order differences of $X_{t}$. An alternative form for $X_{t}$ is obtained by inversion of (1), giving a valid representation for all values of $d_{0}$,

Define the discrete Fourier transform (d.f.t.) and the periodogram of a time series $a_{t}$ evaluated at frequency $\lambda$ as

2.1. Exact local Whittle likelihood and estimator. We start with the likelihood function of the stationary innovation $u_{t}$. The (negative) Whittle likelihood of $u_{t}$ based on frequencies up to $\lambda_{m}$ and up to scale multiplication is

where $m$ is some integer less than $n$. We want to transform the likelihood function (4) to be data dependent.

If $\left|d_{0}\right|<\frac{1}{2}$, it is known that $I_{u}\left(\lambda_{j}\right)$ can be approximated by $\lambda_{j}^{2 d_{0}} I_{x}\left(\lambda_{j}\right)$ [10, 12]. Therefore, if one views $I_{u}\left(\lambda_{j}\right)$ as the $j$ th observation of $u_{t}$ in the frequency domain, replacing $I_{u}\left(\lambda_{j}\right)$ in (4) with $\lambda_{j}^{2 d_{0}} I_{x}\left(\lambda_{j}\right)$ and adding the Jacobian $\sum_{j=1}^{m} \log \lambda_{j}^{-2 d}$ to (4) makes it data dependent. Indeed, the resulting objective function coincides with that of the LW estimator.

However, when $d_{0}$ takes a larger value, in particular when $\left|d_{0}\right|>1, \lambda_{j}^{2 d_{0}} I_{x}\left(\lambda_{j}\right)$ no longer provides a good approximation of $I_{u}\left(\lambda_{j}\right)$. In this paper, we propose to use a "corrected" d.f.t. of $X_{t}$ that can approximate $I_{u}\left(\lambda_{j}\right)$ and validly transform (4) in such cases. Lemma 5.1 in Section 5 provides the necessary algebraic relationship for these quantities for any value of $d_{0}$, namely,

The function $v_{x}\left(\lambda_{j} ; d_{0}\right)$ in (5) adds a correction term that involves $\widetilde{X}_{\lambda_{j} n}\left(d_{0}\right)$ to the d.f.t. $w_{x}\left(\lambda_{j}\right)$, which ensures that the relationship (5) holds exactly for all $d_{0}$. Accordingly, we may interpret $v_{x}\left(\lambda_{j} ; d_{0}\right)$ as a well-suited proxy for the
$j$ th frequency domain observation of $X_{t}$. Consequently, replacing $I_{u}\left(\lambda_{j}\right)$ in (4) with $\left|D_{n}\left(e^{i \lambda_{j}} ; d\right)\right|^{2}\left|v_{x}\left(\lambda_{j} ; d\right)\right|^{2}$, adding the Jacobian $\sum_{j=1}^{m} \log \left|D_{n}\left(e^{i \lambda_{j}} ; d\right)\right|^{-2}$ and using (5) again give, in conjunction with the local approximation $f_{u}\left(\lambda_{j}\right) \sim G$ and $\left|D_{n}\left(e^{i \lambda_{j}} ; d\right)\right|^{2} \sim \lambda_{j}^{2 d}[8]$,

where $I_{\Delta^{d} x}\left(\lambda_{j}\right)$ is the periodogram of

We propose to estimate $d$ and $G$ by minimizing $Q_{m}(G, d)$, so that

where $\Delta_{1}$ and $\Delta_{2}$ are the lower and upper bounds of the admissible values of $d$ such that $-\infty<\Delta_{1}<\Delta_{2}<\infty$. Concentrating $Q_{m}(G, d)$ with respect to $G$, we find that $\widehat{d}$ satisfies

The estimator $\widehat{d}$ is based on the transformation of the Whittle likelihood function of $u_{t}$ by (5). Since (5) follows from a purely algebraic manipulation and holds exactly for any $d$, we call $\widehat{d}$ the exact local Whittle estimator of $d$. [The word "exact" is used to distinguish the proposed estimator (which relies on an exact algebraic manipulation) from the conventional local Whittle estimator, which is based on the approximation $I_{x}\left(\lambda_{j}\right) \sim \lambda_{j}^{-2 d} I_{u}\left(\lambda_{j}\right)$. Of course, the Whittle likelihood is itself an approximation of the exact likelihood, but this should cause no confusion.]
2.2. Consistency. We now introduce the assumptions on $m$ and the stationary component $u_{t}$ in (1).

## ASSUMPTION 1.

ASSUMPTION 2. In a neighborhood $(0, \delta)$ of the origin, $f_{u}(\lambda)$ is differentiable and

in which $F_{t}$ is the $\sigma$-field generated by $\varepsilon_{s}, s \leq t$, and there exists a random variable $\varepsilon$ such that $E \varepsilon^{2}<\infty$ and for all $\eta>0$ and some $K>0$, $\operatorname{Pr}\left(\left|\varepsilon_{t}\right|>\eta\right) \leq K \operatorname{Pr}(|\varepsilon|>\eta)$.

Assumption 4.

ASSUMPTION 5.

Assumptions 1-3 are analogous to Assumptions A1-A3 of [11]. However, we impose them in terms of $u_{t}$ rather than $X_{t}$. Assumption 4 is slightly stronger than Assumption A4 of [11]. Assumption 5 restricts the length of the interval of permissible values in the optimization (6), although it imposes no restrictions on the value of $d_{0}$ itself. For instance, if we assume the data are overdifferenced at most once and hence $d_{0} \geq-1$, then taking $\left[\Delta_{1}, \Delta_{2}\right]=[-1,3.5]$ makes $\widehat{d}$ consistent for any $d_{0} \in\left[\overline{\Delta_{1}}, \Delta_{2}\right]$. When one wants to allow the interval of permissible values to be wider than $\frac{9}{2}$, the tapered estimators with sufficiently high order of tapering provide useful alternatives.

Under these conditions we may now establish the consistency of $\widehat{d}$.

THEOREM 2.1. Suppose $X_{t}$ is generated by (1) with $d_{0} \in\left[\Delta_{1}, \Delta_{2}\right]$ and Assumptions $1-5$ hold. Then $\widehat{d} \xrightarrow{p} d_{0}$ as $n \rightarrow \infty$.

Assumption 5 is necessary for the following reason. Loosely speaking, we prove consistency by showing that (i) when $\left|d-d_{0}\right|$ is small, $R(d)-R\left(d_{0}\right)$ converges uniformly to a nonrandom function that achieves its minimum at $d_{0}$, and (ii) when $\left|d-d_{0}\right|$ is large, $R(d)-R\left(d_{0}\right)$ is uniformly bounded away from 0 . When $\left|d-d_{0}\right|$
is larger than $\frac{1}{2}$, the periodogram $I_{\Delta^{d} x}\left(\lambda_{j}\right)$ in the objective function does not behave like $\lambda_{j}^{2\left(d-d_{0}\right)} I_{u}\left(\lambda_{j}\right)$. Consequently, $R(d)-R\left(d_{0}\right)$ does not converge to a nonrandom function, and we need an alternative way to bound it away from zero. For instance, when $\frac{1}{2} \leq d-d_{0} \leq \frac{3}{2}$, the normalized d.f.t. is expressed as [cf. (30) in the proof of consistency]

The leakage from the last term prevents the uniform convergence of $R(d)-R\left(d_{0}\right)$ and complicates the proof. When $\left|d-d_{0}\right|$ is larger, $\lambda_{j}^{-\left(d-d_{0}\right)} w_{\Delta^{d} x}\left(\lambda_{j}\right)$ has further additional terms [e.g., the equation below (51)], and we were able to show the necessary results only for $\left|d-d_{0}\right| \leq \frac{9}{2}$, which is why we need Assumption 5. Lemma 5.10 in Section 5 is the main tool in handling the effects of such additional terms. We could relax Assumption 5 if we could extend Lemma 5.10 to hold with more general summands $\left(1-e^{i \lambda_{j}}\right)^{k} Q_{k}+\cdots+Q_{0}$, but we were not able to do so.

REMARK 1. An alternative way of accommodating a wider range of $d$ without sacrificing efficiency is to use a two-step procedure. A two-step estimator based on the objective function $R(d)$ that uses a (higher-order) tapered estimator in the first step would have the same asymptotic variance as the exact LW estimator. (Strictly speaking, the asymptotic properties of tapered estimators have been established only under the alternative type of fractionally integrated process generated as in (8), although some results on the difference between their d.f.t.'s are available [12].)

REMARK 2. The model (1) assumes, in effect, that the initial value of $X_{t}$ is known. In practice, it is more natural to allow for an unknown initial value, $\mu_{0}$, and model $X_{t}$ as

Estimation of $\mu_{0}$ affects the limiting behavior of the estimator. According to Shimotsu [14], (i) if $\mu_{0}$ is replaced with the sample average $\bar{X}=n^{-1} \sum_{t=1}^{n} X_{t}$, then the estimator is consistent for $d_{0} \in\left(-\frac{1}{2}, 1\right)$ and asymptotically normal for $d_{0} \in\left(-\frac{1}{2}, \frac{3}{4}\right)$, but simulations suggest that the estimator is inconsistent for $d_{0}>1$; and (ii) if $\mu_{0}$ is replaced by $X_{1}$, then the estimator is consistent for $d_{0} \geq \frac{1}{2}$ and
asymptotically normal for $d_{0} \in\left[\frac{1}{2}, 2\right)$, but simulations suggest that the estimator is inconsistent for $d_{0} \leq 0$. To accommodate unknown $\mu_{0}$, it is possible to extend Theorem 2.1 for $X_{t}$ generated by (7) by estimating $\mu_{0}$ along with $d_{0}$. For instance, Shimotsu [14] proposes estimating $\mu_{0}$ by

where $w(d)$ is a smooth (twice continuously differentiable) weight function such that $w(d)=1$ for $d \leq \frac{1}{2}, w(d) \in[0,1]$ for $\frac{1}{2} \leq d \leq \frac{3}{4}$ and $w(d)=0$ for $d \geq \frac{3}{4}$, and replacing $X_{t}$ with $X_{t}-\widehat{\mu}(d)$ in the periodograms in the objective function. Shimotsu [14] shows the resulting estimator of $d$ is consistent and asymptotically normal for $d_{0} \in\left(-\frac{1}{2}, 2\right)$, excluding arbitrary small intervals around 0 and 1. Another possibility would be to replace $X_{t}$ with $X_{t}-\mu$ in the periodogram ordinates and minimize the objective function with respect to $(d, G, \mu)$.

REMARK 3. Fractionally integrated processes as defined in (1) are more restrictive in some ways than the stationary frequency domain characterization used in [11] and elsewhere. It might be possible to extend the results in this paper to the class of nonstationary processes analyzed by [13] and seek to achieve a similar degree of generality to Robinson [11], but we do not attempt to do so here.

REMARK 4. Another popular definition of a fractionally integrated process provides for different generating mechanisms according to the specific range of values taken by $d_{0}$, as in

with corresponding extensions for larger values of $d_{0}$, so that $X_{t}$ or its (higherorder) difference is stationary. While we do not explore the effects of these alternative generating mechanisms here, simulation results suggest that the version of the exact LW estimator in [14] is consistent for this type of fractionally integrated process.
2.3. Asymptotic normality. We introduce some further assumptions that are used to derive the limit distribution theory.

Assumption $1^{\prime}$. Assumption 1 holds, and also for some $\beta \in(0,2]$

Assumption $3^{\prime}$. Assumption 3 holds and also

for finite constants $\mu_{3}$ and $\mu_{4}$.

\frac{1}{m}+\frac{m^{1+2 \beta}(\log m)^{2}}{n^{2 \beta}}+\frac{\log n}{m^{\gamma}} \rightarrow 0 \quad \text { for any } \gamma>0

AsSumption 5'. Assumption 5 holds.
Assumptions $1^{\prime}-3^{\prime}$ are analogous to Assumptions $\mathrm{A} 1^{\prime}-\mathrm{A} 3^{\prime}$ of [11], except that our assumptions are in terms of $u_{t}$ rather than $X_{t}$. Assumption $4^{\prime}$ is slightly stronger than Assumption $4^{\prime}$ of [11].

The following theorem establishes the asymptotic normality of the exact local Whittle estimator for $d_{0} \in\left(\Delta_{1}, \Delta_{2}\right)$. (The approximate mean squared error and the corresponding optimal bandwidth can be obtained heuristically in the same manner as in [2].)

THEOREM 2.2. Suppose $X_{t}$ is generated by (1) with $d_{0} \in\left(\Delta_{1}, \Delta_{2}\right)$ and Assumptions $1^{\prime}-5^{\prime}$ hold. Then

3. Simulations. This section reports some simulations that were conducted to examine the finite sample performance of the exact LW estimator (hereafter, exact estimator), the LW estimator (hereafter, untapered estimator) and the LW estimator with two types of tapering studied by Hurvich and Chen [3] and Velasco [15] with Bartlett's window [hereafter, tapered (HC) and tapered (V) estimator, resp.]. The tapered (HC) estimator and tapered (V) estimator are consistent and asymptotically normal for $d \in(-0.5,1.5)$ with limiting variances $1.5 /(4 m)$ and $2.1 /(4 m)$, respectively (see Remark 1). We generate $I(d)$ processes according to (3) with $u_{t} \sim$ i.i.d. $N(0,1) . \Delta_{1}$ and $\Delta_{2}$ are set to -6 and 6 . Although this setting violates Assumption 5, it does not appear to adversely affect the performance of the exact estimator. The bias, standard deviation and mean squared error (MSE) were computed using 10,000 replications. The sample size and band parameter $m$ were chosen to be $n=500$ and $m=n^{0.65}=56$. Values of $d$ were selected in the interval [-3.5, 3.5].

Tables 1 and 2 show the simulation results. The exact estimator has little bias for all values of $d$. The untapered estimator has a large bias for $d>1$, corroborating the theoretical result that it converges to unity in probability [8]. When $-0.5<d<1$, the exact and untapered estimators have similar variance

and MSE. The variances of the tapered estimators are always larger than those of the exact estimator. Again, this outcome corroborates the theoretical result that the tapered estimators have larger asymptotic variance. The tapered (HC) estimator has small bias and performs better than the tapered (V) estimator for $-0.5<d<2$. However, the tapered (HC) estimator has around $50 \%$ larger MSE than the exact estimator even for those values of $d$ due to its large variance.

Figures 1 and 2 plot kernel estimates of the densities of the four estimators for the values $d=-0.7,0.3,1.3$ and 2.3. The sample size and $m$ were chosen as $n=500$ and $m=n^{0.65}$, and 10,000 replications were used. When $d=-0.7$, the exact and tapered (V) estimators have symmetric distributions centered on -0.7 , with the tapered estimator having a flatter distribution. The untapered and tapered (HC) estimators appear to be biased. When $d=0.3$, the untapered and exact estimators have almost identical distributions, whereas the two tapered estimators have more dispersed distributions. When $d=1.3$, the untapered estimator is centered on unity. In this case, the exact estimator seems to work well, having a symmetric distribution centered on 1.3. The tapered estimators have flatter distributions than the exact estimator but otherwise appear reasonable and they are certainly better than the inconsistent untapered estimator. When $d=2.3$, the untapered and tapered $(\mathrm{V})$ estimators appear centered on 1.0 and 2.0, respectively. In this case, the tapered (HC) estimator is upward biased. Again, the exact estimator has a symmetric distribution centered on the true value 2.3.

In summary, there seems to be little doubt from these results that the exact LW estimator is the best general-purpose estimator over a wide range of $d$ values.

4. Proofs. In this and the following section, $|x|_{+}$denotes $\max \{x, 1\}$ and $x^{*}$ denotes the complex conjugate of $x . C, c$ and $\varepsilon$ denote generic constants such that $C, c \in(1, \infty)$ and $\varepsilon \in(0,1)$ unless specified otherwise, and they may take different values in different places.
4.1. Proof of consistency. Define $G(d)=G_{0} \frac{1}{m} \sum_{1}^{m} \lambda_{j}^{2\left(d-d_{0}\right)}$ and $S(d)=$ $R(d)-R\left(d_{0}\right)$. Rewrite $S(d)$ as

\sum_{j=[\kappa m]}^{m}\left|\int_{(j-1) / m}^{j / m}\left\{\left(\frac{j}{m}\right)^{\gamma}-x^{\gamma}\right\} d x\right|+\int_{\kappa-(2 / m)}^{\kappa} x^{\gamma} d x \\
\leq \frac{c}{m^{2}} \sum_{j=[\kappa m]}^{m}\left(\frac{j}{m}\right)^{-C-1}+\frac{c}{m}=O\left(m^{-1}\right),
\end{gathered}
$$

by the mean value theorem. Part (b) follows immediately from part (a).
Lemma 5.5. For $p \sim m / e$ as $m \rightarrow \infty$ and $\Delta \in\left(0, \frac{1}{2 e}\right)$, there exist $\varepsilon \in(0,0.1)$ and $\bar{\kappa} \in\left(0, \frac{1}{4}\right)$ such that, for all fixed $\kappa \in(0, \bar{\kappa}]$ and sufficiently large $m$ :
(a) $\inf _{-C \leq \gamma \leq-1+2 \Delta} \frac{1}{m} \sum_{j=[\kappa m]}^{m}\left(\frac{j}{p}\right)^{\gamma} \geq 1+2 \varepsilon$,
(b)

\inf _{1 \leq \gamma \leq C} \frac{1}{m} \sum_{j=[\kappa m]}^{m}\left(\frac{j}{p}\right)^{\gamma} & \sim \inf _{1 \leq \gamma \leq C} \frac{e^{\gamma}}{\gamma+1}\left(1-\kappa^{\gamma+1}\right) \geq \frac{e}{2}\left(1-\kappa^{2}\right)
\end{aligned}
$$

where the last inequality holds because $e^{\gamma} /(\gamma+1)$ is monotone increasing for $\gamma \geq 1$. Since $2 \Delta e<1$, choosing $\kappa$ sufficiently small gives the stated results.

\end{aligned}

Note that, uniformly in $r=1, \ldots, m-1$ and $\alpha$,

\left|\left(\frac{r}{m}\right)^{\alpha}-\left(\frac{r+1}{m}\right)^{\alpha}\right|=\left(\frac{r}{m}\right)^{\alpha}\left|1-\left(1+\frac{1}{r}\right)^{\alpha}\right| \leq c\left(\frac{r}{m}\right)^{-C} \frac{1}{r} \tag{73}
\end{equation*}

because $\sup _{\alpha}\left|(1+x)^{\alpha}-1\right| \leq C 2^{C} x$ for $0 \leq x \leq 1$. The results in ([11], page 1637) imply that $E\left|w_{u}\left(\lambda_{j}\right)-C\left(e^{i \lambda_{j}}\right) w_{\varepsilon}\left(\lambda_{j}\right)\right|^{2}=O\left(j^{-1} \log (j+1)\right)$ uniformly in $j=$ $1, \ldots, m$, giving

+J_{n}(L) \widetilde{D}_{n \lambda}\left(e^{-i \lambda} L ; d\right)\left(e^{-i \lambda} L-1\right)
$$

where

$$
\begin{aligned}
\widetilde{J}_{n \lambda}\left(e^{-i \lambda} L\right) & =\sum_{p=0}^{n-1} \tilde{j}_{\lambda p} e^{-i p \lambda} L^{p}, & \tilde{j}_{\lambda p}=\sum_{p+1}^{n} \frac{1}{k} e^{i k \lambda} \\
\widetilde{D}_{n \lambda}\left(e^{-i \lambda} L ; d\right) & =\sum_{p=0}^{n-1} \tilde{d}_{\lambda p} e^{-i p \lambda} L^{p}, & \tilde{d}_{\lambda p}=\sum_{p+1}^{n} \frac{(-d)_{k}}{k!} e^{i k \lambda} .
\end{aligned}

Proof. For part (a) see [9], formula (32). For part (b), from Lemma 2.1 of [7] we have $D_{n}(L ; d)=D_{n}\left(e^{i \lambda} ; d\right)+\widetilde{D}_{n \lambda}\left(e^{-i \lambda} L ; d\right)\left(e^{-i \lambda} L-1\right)$, and the stated result follows immediately.

where, uniformly in $j=1, \ldots, m$, as $n \rightarrow \infty$,

E\left|j^{1 / 2} r_{n j}\right|^{2} & =o(1)+O\left(j^{-1}\right) \\
E \sup _{\theta}\left|n^{\theta-1 / 2} j^{1 / 2-\theta} \Psi_{n j}(\theta)\right|^{2} & =O\left((\log n)^{6}\right)
\end{aligned}
$$

$$

U_{2 n}^{\prime}(\theta) & =\frac{(-\theta)_{n}}{n!} \frac{e^{i \lambda_{j}}}{1-e^{i \lambda_{j}}} L^{r} \sum_{k=1}^{n} \bar{u}_{k}-\frac{(-\theta)_{n}}{n!} \frac{e^{i \lambda_{j}}}{1-e^{i \lambda_{j}}} L^{r} \sum_{k=1}^{n} e^{i k \lambda_{j}} \bar{u}_{k} \\
& =\frac{(-\theta)_{n}}{n!} \frac{e^{i \lambda_{j}}}{1-e^{i \lambda_{j}}} \sum_{k=1}^{n-r} u_{k}-\frac{(-\theta)_{n}}{n!} \frac{e^{i \lambda_{j}}}{1-e^{i \lambda_{j}}} e^{i r \lambda_{j}} \sum_{q=1}^{n-r} e^{i q \lambda_{j}} u_{q} .
\end{aligned}
$$

Since $E\left(\sum_{k=1}^{n-r} u_{k}\right)^{2}=O\left(n^{1 / 2}\right)$ for any $r, E \sup _{\theta}\left|n^{\theta-1 / 2} j^{1 / 2-\theta} U_{2 n}^{\prime}(\theta)\right|^{2}=O(1)$ and (82) follow if, for $m=o(n)$,

\max _{1 \leq r \leq n} \max _{1 \leq j \leq m} E\left|(2 \pi r)^{-1 / 2} \sum_{k=1}^{r} e^{i k \lambda_{j}} u_{k}\right|^{2}=O(1) \tag{83}

We establish (83) to complete the proof of part (a). An elementary calculation gives

where $K_{r}(\lambda)=(2 \pi r)^{-1} \sum_{s=1}^{r} \sum_{t=1}^{r} e^{i(t-s) \lambda}$ is Fejér's kernel. From Zygmund [16], pages $88-90, \quad \int_{-\pi}^{\pi}\left|K_{r}(\lambda)\right| d \lambda<A$ and $\left|K_{r}(\lambda)\right| \leq A r^{-1} \lambda^{-2}$ for a finite constant $A$. Furthermore, from Assumption 1 there exists $\eta \in(0, \pi)$ such that $\sup _{\lambda \in[-\eta, \eta]}\left|f_{u}(\lambda)\right|<C$, and $\inf _{|\lambda|>\eta}\left|\lambda-\lambda_{j}\right| \geq \eta / 2$ if $\lambda_{j}<\eta / 2$. It follows that for sufficiently large $n$

\int_{-\pi}^{\pi} & f_{u}(\lambda) K_{r}\left(\lambda-\lambda_{j}\right) d \lambda \\
& =\int_{|\lambda| \leq \eta} f_{u}(\lambda) K_{r}\left(\lambda-\lambda_{j}\right) d \lambda+\int_{\eta \leq|\lambda| \leq \pi} f_{u}(\lambda) K_{r}\left(\lambda-\lambda_{j}\right) d \lambda \\
& \leq A C+A r^{-1}(\eta / 2)^{-2} \int_{\eta \leq|\lambda| \leq \pi} f_{u}(\lambda) d \lambda<\infty
\end{aligned}
$$

uniformly in $j=1, \ldots, m$, and (83) follows.
For part (b), in view of (76), $D_{n}\left(e^{i \lambda_{j}} ; 0\right)=1$ and $\widetilde{D}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L ; 0\right)=0$, part (b) follows if, as $n \rightarrow \infty$, uniformly in $j=1, \ldots, m$,

\begin{equation*}
E\left|j^{1 / 2} n^{-1 / 2} \widetilde{J}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L\right)\left(\bar{u}_{n}-C(1) \varepsilon_{n}\right)\right|^{2}=o(1)+O\left(j^{-1}\right) \tag{84}
\end{equation*}
$$

Using the same decomposition as (79), write $j^{1 / 2} n^{-1 / 2} \widetilde{J}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L\right)\left(\bar{u}_{n}-\right.$ $C(1) \varepsilon_{n}$ ) as

& \sum_{p=0}^{n-2} \frac{j^{1 / 2}}{\sqrt{n}} c_{n p} \sum_{q=0}^{p}\left(u_{n-q}-C(1) \varepsilon_{n-q}\right)  \tag{85}\\
& \quad+\frac{j^{1 / 2}}{n \sqrt{n}} \frac{e^{i \lambda_{j}}}{1-e^{i \lambda_{j}}} \sum_{k=1}^{n}\left(u_{n-k}-C(1) \varepsilon_{n-k}\right) \\
& \quad-\frac{j^{1 / 2}}{n} \frac{e^{i \lambda_{j}} \sqrt{2 \pi}}{1-e^{i \lambda_{j}}}\left[w_{u}\left(\lambda_{j}\right)-C(1) w_{\varepsilon}\left(\lambda_{j}\right)\right] . \tag{86}
\end{align*}

If we have

o(p), & \text { as } p \rightarrow \infty,\end{cases} \tag{87}
\end{align*}

then it follows from Minkowski's inequality and the order of $c_{n p}$ given by (80) that

& +o\left((j / n)^{1 / 2} \sum_{p=\sqrt{n / j}}^{n / j} p^{-1 / 2}+(j / n)^{1 / 2} \sum_{p=n / j}^{n} \frac{n}{j} p^{-3 / 2}\right)
\end{aligned}
$$

\begin{aligned}
& =O\left((j / n)^{1 / 4}\right)+o(1) \\
& =o(1)
\end{aligned}
$$

because $\sqrt{n / j} \geq \sqrt{n / m} \rightarrow \infty$ from Assumption $4^{\prime}$. To prove (87), note that when $p=0$, (87) follows immediately. When $p \geq 1$, observe that

Since the first term on the right-hand side is uniformly $O(p)$ from (68) and the second term on the right-hand side is equal to $2 C(1)^{2}(p+1)$, the first part of (87) holds. For the second part of (87), note that the left-hand side of (87) is equal to $\left(\gamma_{q}=E u_{t} u_{t+q}\right)$

If $\sum_{-\infty}^{\infty} a_{r}$ converges, then $\sum_{|r| \geq p+1} a_{r}$ tends to 0 as $p \rightarrow \infty$; thus the first and third terms are $o(p)$ because both $\sum_{-\infty}^{\infty} \gamma_{r}$ and $\sum_{-\infty}^{\infty} c_{r}$ converge. The second and fourth terms are $o(p)$ from Kronecker's lemma, and the second part of (87) follows. Obviously $E|(86)|^{2}=O\left(j^{-1}\right)$, and (84) follows.

For part (c), first from Lemma 2.1 of [7] and Lemma 5.7 we have

& +J_{n}(L) \widetilde{J}_{n \lambda}\left(e^{-i \lambda} L\right)\left(e^{-i \lambda} L-1\right), \\
D_{n}(L ; \theta)= & D_{n}\left(e^{i \lambda} ; \theta\right)+\widetilde{D}_{n \lambda}\left(e^{-i \lambda} L ; \theta\right)\left(e^{-i \lambda} L-1\right) .
\end{aligned}

It follows that

= & J_{n}\left(e^{i \lambda}\right)^{2} D_{n}\left(e^{i \lambda} ; \theta\right) \bar{u}_{t} \\
& +D_{n}\left(e^{i \lambda} ; \theta\right)\left[J_{n}\left(e^{i \lambda}\right)+J_{n}(L)\right] \widetilde{J}_{n \lambda}\left(e^{-i \lambda} L\right)\left(e^{-i \lambda} L-1\right) \bar{u}_{t} \\
& +J_{n}(L)^{2} \widetilde{D}_{n \lambda}\left(e^{-i \lambda} L ; \theta\right)\left(e^{-i \lambda} L-1\right) \bar{u}_{t}
\end{aligned}
$$

Taking its d.f.t. gives

& \quad-(2 \pi n)^{-1 / 2} D_{n}\left(e^{i \lambda_{j}} ; \theta\right)\left[J_{n}\left(e^{i \lambda_{j}}\right)+J_{n}(L)\right] \widetilde{J}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L\right) \bar{u}_{n} \\
& \quad-(2 \pi n)^{-1 / 2} J_{n}(L)^{2} \widetilde{D}_{n \lambda_{s}}\left(e^{-i \lambda_{j}} L ; \theta\right) \bar{u}_{n} .
\end{aligned}
$$

By the same argument as the ones used in showing (77) and (82), we obtain

E\left|L^{q} \widetilde{J}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L\right) \bar{u}_{n}\right|^{2}=O\left(n j^{-1}\right), \quad q=0,1, \ldots
$$

In conjunction with $J_{n}\left(e^{i \lambda_{j}}\right)=O(\log n)$, Minkowski's inequality and (82), it follows that

& E \sup _{\theta}\left|n^{\theta-1 / 2} j^{1 / 2-\theta} D_{n}\left(e^{i \lambda_{j}} ; \theta\right)\left[J_{n}\left(e^{i \lambda_{j}}\right)+J_{n}(L)\right] \widetilde{J}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L\right) \bar{u}_{n}\right|^{2} \\
& \quad=O\left((\log n)^{2}\right)
\end{aligned}
$$

E \sup _{\theta}\left|n^{\theta-1 / 2} j^{1 / 2-\theta} J_{n}(L)^{2} \widetilde{D}_{n \lambda_{j}}\left(e^{-i \lambda_{j}} L ; \theta\right) \bar{u}_{n}\right|^{2}
$$

$$
=O\left((\log n)^{6}\right)
$$

for $j=1, \ldots, m$, giving the stated result.
Lemma 5.10. Let $Q_{k}, k=0, \ldots, 3$, be any real numbers, $\kappa \in\left(0, \frac{1}{8}\right)$, and $1 / m+m / n \rightarrow 0$ as $n \rightarrow \infty$. Then there exists $\eta>0$ not depending on $Q_{k}$ such that, for sufficiently large $n$ :
(a) $m^{-1} \sum_{j=[\kappa m]}^{m}\left|\left(1-e^{i \lambda_{j}}\right)^{3} Q_{3}+\left(1-e^{i \lambda_{j}}\right)^{2} Q_{2}+\left(1-e^{i \lambda_{j}}\right) Q_{1}+Q_{0}\right|^{2}$

\geq \eta\left(m^{6} n^{-6} Q_{3}^{2}+m^{4} n^{-4} Q_{2}^{2}+m^{2} n^{-2} Q_{1}^{2}+Q_{0}^{2}\right)
$$

(b) $m^{-1} \sum_{j=[\kappa m]}^{m} \mid\left(1-e^{i \lambda_{j}}\right)^{-1} Q_{3}+\left(1-e^{i \lambda_{j}}\right)^{-2} Q_{2}$

$$
\begin{gathered}
+\left(1-e^{i \lambda_{j}}\right)^{-3} Q_{1}+\left.\left(1-e^{i \lambda_{j}}\right)^{-4} Q_{0}\right|^{2} \\
\geq \eta\left(m^{-2} n^{2} Q_{3}^{2}+m^{-4} n^{4} Q_{2}^{2}+m^{-6} n^{6} Q_{1}^{2}+m^{-8} n^{8} Q_{0}^{2}\right)
\end{gathered}
$$

Proof. Define

Since $1-e^{i \lambda}=-i \lambda+O\left(\lambda^{2}\right)$ as $\lambda \rightarrow 0$, we have

Applying $2|a||b| \leq|a|^{2}+|b|^{2}$ to the product terms involving the remainder terms, we obtain

where $R(\lambda)=O\left(\lambda^{7}\right) Q_{3}^{2}+O\left(\lambda^{5}\right) Q_{2}^{2}+O\left(\lambda^{3}\right) Q_{1}^{2}+O(\lambda) Q_{0}^{2}$. First we show that

When $\operatorname{sgn}\left(Q_{2}\right) \neq \operatorname{sgn}\left(Q_{0}\right)$, then (90) holds from Lemma 5.4. When $\operatorname{sgn}\left(Q_{2}\right)=$ $\operatorname{sgn}\left(Q_{0}\right)$, without loss of generality assume $Q_{2}, Q_{0}>0$. Note that $\lambda_{j}^{2} Q_{2}$ is an increasing function of $j$. Now suppose $\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0} \geq 0$. Then, since $\left(\lambda_{3 m / 4}\right)^{2}=\frac{9}{4}\left(\lambda_{m / 2}\right)^{2}$, we have, for $j=3 m / 4, \ldots, m$,

\lambda_{j}^{2} Q_{2}-Q_{0} & \geq \frac{9}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0} \\
& =\frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}+2\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0} \\
& \geq \frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}+Q_{0} .
\end{aligned}

Now suppose $\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0}<0$. Then, since $\left(\lambda_{m / 4}\right)^{2}=\frac{1}{4}\left(\lambda_{m / 2}\right)^{2}$, we have, for $j=1, \ldots, m / 4$,

\lambda_{j}^{2} Q_{2}-Q_{0} & \leq \frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0} \\
& =-\frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}+\left[\frac{1}{2}\left(\lambda_{m / 2}\right)^{2} Q_{2}-Q_{0}\right] \\
& \leq-\frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}-\frac{1}{2} Q_{0}
\end{aligned}
$$

Therefore, either for $j=1, \ldots, m / 4$ or for $j=3 m / 4, \ldots, m$, we have

\left|\lambda_{j}^{2} Q_{2}-Q_{0}\right| \geq \frac{1}{4}\left(\lambda_{m / 2}\right)^{2} Q_{2}+\frac{1}{2} Q_{0} \tag{91}

and (90) follows immediately. The same argument gives, if $\operatorname{sgn}\left(Q_{3}\right)=\operatorname{sgn}\left(Q_{1}\right)$,

\end{equation*}
$$

either for $j=1, \ldots, m / 4$ or for $j=3 m / 4, \ldots, m$, and it follows from (91) and (92) that

$$
m^{-1} \sum_{j=[\kappa m]}^{m}\left(\lambda_{j}^{3} Q_{3}-\lambda_{j} Q_{1}\right)^{2} \geq \eta\left(m^{6} n^{-6} Q_{3}^{2}+m^{2} n^{-2} Q_{1}^{2}\right)
$$

For $R(\lambda)$ in (89), it follows from Lemma 5.4 that

\begin{aligned}
m^{-1} & \sum_{j=[\kappa m]}^{m} R\left(\lambda_{j}\right) \\
& =O\left(m^{7} n^{-7}\right) Q_{3}^{2}+O\left(m^{5} n^{-5}\right) Q_{2}^{2}+O\left(m^{3} n^{-3}\right) Q_{1}^{2}+O\left(m n^{-1}\right) Q_{0}^{2}
\end{aligned}
$$

and part (a) follows. For part (b), rewrite the term inside the summation as

$$
\left|\left(1-e^{i \lambda_{j}}\right)^{-4} A\left(\lambda_{j}\right)\right|^{2}=\left|\lambda_{j}^{-4}\left(1+O\left(\lambda_{j}\right)\right) A\left(\lambda_{j}\right)\right|^{2}
$$

Applying (88) and the following argument with (91) and (92) gives part (b).
