

# A FUNCTIONAL LIMIT THEOREM FOR LIMIT ORDER BOOKS WITH STATE DEPENDENT PRICE DYNAMICS<sup>1</sup>

We consider a stochastic model for the dynamics of the two-sided limit order book (LOB). Our model is flexible enough to allow for a dependence of the price dynamics on volumes. For the joint dynamics of best bid and ask prices and the standing buy and sell volume densities, we derive a functional limit theorem, which states that our LOB model converges in distribution to a fully coupled SDE-SPDE system when the order arrival rates tend to infinity and the impact of an individual order arrival on the book as well as the tick size tends to zero. The SDE describes the bid/ask price dynamics while the SPDE describes the volume dynamics.

**1. Introduction.** In modern financial markets, almost all transactions are settled through Limit Order Books (LOBs). An LOB is a record—maintained by an exchange or specialist—of unexecuted orders awaiting execution. Unexecuted (standing) orders are executed against incoming market orders according to a set of precedence rules. Most exchanges give orders at better price levels priority over orders submitted at less competitive price levels (“price priority”) and orders with the same price-priority are typically (though not always) executed on a first-in-first-out basis (“time-priority”).<sup>2</sup> From a mathematical perspective, LOBs can thus be viewed as high-dimensional complex priority queuing systems. In this paper, we present a probabilistic framework within which to derive functional scaling limits for LOBs from individual order arrival dynamics. We assume that order arrivals and cancellations follow a Poisson dynamics relative to the best bid and ask prices. With our choice of scaling, prices follow a diffusion process while volume density functions can be described by an infinite dimensional SDE, that is coupled with the price process. As a special case we obtain law-of-large-numbers-type scaling with absolutely continuous (in time) volume density functions.

1.1. *Literature review.* There is a substantial economic and econometric literature on LOBs [2, 4, 8, 11, 12, 29] that puts a lot of emphasis on the realistic modeling of the working of the LOB. At the same time, only few authors have

analyzed LOB dynamics from a more probabilistic perspective. Kruk [20] studied a queuing theoretic LOB model with finitely many price levels. For the special case of two price levels, in his model the scaled number of standing buy and sell orders at the top of the book converges weakly to a semimartingale reflected two-dimensional Brownian motion in the first quadrant. Cont, Stoikov and Talreja [6] proposed an LOB model with finitely many submission price levels where the LOB dynamics follows an ergodic Markov process. Cont and DeLarrard [5] established a scaling limit for a Markovian limit order market in which the state of the book is represented by the best bid and ask prices along with the liquidity standing at these prices (“top of the book”). Under heavy traffic conditions, their bid and ask queue lengths are given by a two-dimensional Brownian motion in the first quadrant with reflection to the interior at the boundaries, similar to the diffusion limit for two price levels in [20].

When scaling limits of financial price fluctuations or joint price and volume fluctuations at selected price levels [5, 20] are studied, the limit can naturally be described by ordinary differential equations or finite-dimensional diffusion processes, depending on the choice of scaling. The mathematical analysis is more challenging when the dynamics of the full book is considered. To the best of our knowledge, Osterrieder [28] was the first to model LOBs as measure-valued diffusions. Horst and Paulsen [14] were the first to prove a scaling limit for the full order book. With their choice of scaling, the joint dynamics of volumes and prices converges to a coupled system of two PDEs that describe the limiting volume dynamics and two ODEs that describe the limiting price dynamics. A related model with state-dependent prices in the approximating sequence but constant prices in the limit is analyzed in [10] where the scaling limit is also empirically tested against real LOB data. Lakner et al. [25] derived a scaling limit for a one-sided limit order book model under the assumption that average investors place their limit orders above the current best ask price. The opposite case when orders are placed in the spread with higher probability is analyzed in [24], where the authors use a coupling between a simple one-sided limit order book model and a branching random walk to characterize the diffusion limit. Lasry and Lions [26], starting from a mean-field game perspective, also describe the LOB by a coupled PDE model with the interface given by the price; see also [23]. Keller-Ressel and Müller [19] describe the LOB as a coupled system of SPDEs separated by a random interface (Stochastic Stefan problem) that can again be interpreted as the price.

Despite the considerable empirical evidence that the state of the order book, especially order imbalance at the top of the book, has a noticeable impact on order dynamics (see [2, 4, 12] and references therein) the order flow in most limit order book models either follows independent Poisson dynamics or depends on the price process only as in [10, 14, 24, 25]. Notable exceptions are the papers by Abergel and Jeddi [1], where Hawkes-type dynamics are used, Huang et al. [15] and Huang and Rosenbaum [16] where the ergodicity of a general Markovian order

book model is studied and the diffusivity of the rescaled price process in this general framework is derived and Horst and Kreher [13] who obtained a deterministic scaling limit for LOBs with fully state dependent event dynamics. In this paper, we consider a diffusion limit for the full LOB dynamics, both prices and volumes, where the price dynamics depends on standing volumes.

1.2. *Our contribution.* As in [14], our limit result requires two time scales: a fast time scale for cancellations and limit order placements outside the spread and a comparably slow time scale for market order arrivals and limit order placements in the spread. The different time scales account for the well-documented fact that placements and cancellations occur much more frequently than price changes. For instance, using LOBSTER data for January 2, 2014, Horst and Paulsen [14] computed the empirical probabilities for an incoming order to trigger price change for Apple (0.016), Ebay (0.02), Facebook (0.02) and Microsoft (0.002). Estimates of similar order are reported in [10] for the stock Bank of America.

In our model, market orders and limit order placements in the spread trigger price changes. We refer to these order types as *active orders*. The probability of an active order being a market order or spread placement at the bid or ask side of the book depends on the standing volume. Limit order placements outside the spread and cancellations of standing volume do not lead to price changes. We refer to these order types as *passive orders*. Passive orders arrive according to an independent Poisson at random distances from the best bid and ask price for random amounts (placements) and propositions (cancellations), respectively.

In this framework, after suitable scaling the price processes follow diffusion processes whose coefficients depend on standing volumes, and the volume density functions (in absolute coordinates) are deterministic and absolutely continuous (in time) functions of the price process. In particular, all fluctuations in standing volumes result from fluctuations in the price process. While such a scaling already results in a realistic limiting LOB dynamics, it seems desirable to us to allow for additional fluctuations in standing volumes that do not originate from price fluctuations. Our framework is flexible enough to allow for such fluctuations. In a model with both positive and negative placements (additive cancellations), we may allow placements to be correlated on a common factor that translates into an additive martingale part driving the volume dynamics. While the “common factor extension” should be viewed as a mostly mathematical extension it does shed further light on the importance of time scales in our model. Our analysis suggests that even the simple case of correlated additive volume fluctuations requires some form of “common factor” upon which to condition volume fluctuations that changes on a much slower time scale than individual order arrival dynamics and cancellations. Of course, many other approaches to modelling volume fluctuations are perceivable.

Our main result states that when the rate of active order arrivals scales by a factor  $n$ , the rate of passive order arrivals scales by a factor  $n^2$ , the tick size scales by a

factor  $1/\sqrt{n}$ , the sizes (proportions) of incoming orders (canceled volumes) scale by a factor  $1/n^2$  and the impact of the common factor scales by a factor  $1/n$ , then the price processes converge to an SDE and the volume density functions in absolute coordinates converge to an infinite dimensional SDE (SPDE in relative coordinates) as  $n \rightarrow \infty$ . The convergence concept we use is weak convergence in the class of càdlàg stochastic processes with sample paths in  $\mathbb{R}^2 \times (H^{-1})^2$  where  $H^{-1}$  denotes the Sobolev space of order  $-1$ . The main challenge is to prove convergence of the  $(H^{-1})^2$ -valued volume processes. To prove tightness, we decompose the volume processes into three components describing the aggregate placements, the proportionality of the cancellations and the impact of the common factor at the various price levels, respectively. We establish norm-bounds for each of these processes from which we then deduce that the volume process as a whole satisfies a standard tightness criteria. To characterize the limit, we first prove joint convergence of prices and the martingale part of the volume processes. Subsequently, we identify the limits of aggregate placements and cancellations and use C-tightness (i.e., tightness with continuous limit processes) of the price and martingale part to prove joint convergence of all the processes to the desired limit.

The key observation is that tightness of the volume processes is guaranteed under mild assumptions on the price process; it does not require any particular dependence of prices on volumes. In particular, it does *not* require the price process to be independent from volumes. The *characterization* of the limiting volume dynamics requires joint convergence of volumes and prices along a subsequence. This is guaranteed if the price process is C-tight, a condition which, too, does not require any particular assumptions on the interplay between prices and volumes. If the limiting price process is known upfront, either because the approximating price process is independent from volumes as in [14] or the limiting price process is state-independent as in [10], then the limiting volume process exists and the joint dynamics of prices and volumes is fully specified. The added difficulty under state dependence is the identification of the limiting price/volume process. To this end, we first characterize the limiting volume dynamics as a function of the—unknown yet existing—weak accumulation point of the price process. Based on this partial characterization result, we then fully characterize the joint evolution of prices and volumes.

The remainder of this paper is organized as follows. In Section 2, we define a sequence of limit order books in terms of our scaling parameters, state the main result and give an outline of the proof. Section 3 is devoted to the analysis of the volume dynamics. Section 4 characterizes the joint limit of the price/volume process. A general result on the characterization of stochastic process limits, general tightness results and some technical proofs are collected in an [Appendix](#).

*Notational conventions.* For any (deterministic or random) function  $u : [0, \infty) \times \mathbb{R} \rightarrow \mathbb{R}$ , we denote by  $u(t) : \mathbb{R} \rightarrow \mathbb{R}$  the function  $x \mapsto u(t, x)$  for  $t \in [0, \infty)$ . Unless otherwise stated,  $(L^p, \|\cdot\|_{L^p})$  ( $p \in [1, \infty]$ ) refers to the space

$L^p(\mathbb{R}, \mathcal{B}(\mathbb{R}), dx)$ .  $L^2$  is equipped with the usual inner product  $\langle \cdot, \cdot \rangle$ . For  $\sigma$ -algebras  $\mathcal{G} \subset \mathcal{F}$ , we shall write  $E_{\mathcal{G}}[\cdot] := E[\cdot | \mathcal{G}]$ . Further, all random variables are defined on a common probability space  $(\Omega, \mathcal{F}, \mathbb{P})$ . We may write  $X(t)$  or  $X_t$  for the value of a stochastic process  $X$  at time  $t \geq 0$ .

**2. Model and main results.**

2.1. *The discrete model.* In this section, we introduce a sequence of continuous time order book models with state-dependent price dynamics. The set of price levels at which orders can be submitted in the  $n$ th model is  $\{x_j^n\}_{j \in \mathbb{Z}}$ . We put  $x_j^n := j \cdot \Delta x^n$  for each  $j \in \mathbb{Z}$  where  $\Delta x^n$  is the *tick size*, that is, the minimum difference between two consecutive price levels.

The *state* of the order book at time  $t \geq 0$  is given by a pair  $(B_t^n, A_t^n)$  with  $B_t^n \leq A_t^n$  of best bid and ask prices together with the buy and sell limit order volumes standing at the different price levels. We identify volumes at the best bid and ask side of the book with step functions  $v_{b/a} : [0, \infty) \rightarrow \mathbb{R}$

$$v_b^n(t, x) := \sum_{j \in \mathbb{Z}} v_{b,t}^{n,j} \mathbb{1}_{[x_j^n, x_{j+1}^n)}(x),$$

$$v_a^n(t, x) := \sum_{j \in \mathbb{Z}} v_{a,t}^{n,j} \mathbb{1}_{[x_j^n, x_{j+1}^n)}(x) \quad (x \in \mathbb{R})$$

with the interpretation that the liquidity available for selling  $j \in \mathbb{N}$  ticks *below* the best bid price at time  $t \geq 0$  is given by

$$\int_{B_t^n + j \Delta x^n}^{B_t^n + (j+1) \Delta x^n} v_b^n(x) dx = \Delta x^n \cdot v_b^{n, B_t^n / \Delta x^n + j},$$

while the liquidity available for buying  $j \in \mathbb{N}$  ticks *above* the best ask price at that time is given by

$$\int_{A_t^n + j \Delta x^n}^{A_t^n + (j+1) \Delta x^n} v_a^n(x) dx = \Delta x^n \cdot v_a^{n, A_t^n / \Delta x^n + j}.$$

Our choice of notation allows to treat both sides of the books symmetrically, and hence simplifies the presentation of the results.<sup>3</sup> We are mainly interested in the volume density functions in *relative coordinates*, denoted

$$u_b^n(t, x) := v_b^n(t, B_t^n + x) \quad \text{and} \quad u_a(t, x) := v_a^n(t, A_t^n + x),$$

respectively. That is,  $u_b^n(t, j \cdot \Delta x^n)$  denotes the liquidity standing  $j$  ticks below the best bid and  $u_a^n(t, j \cdot \Delta x^n)$  denotes the liquidity standing  $j$  ticks above the best ask.

We call  $\{u_{b/a}^n(t, x) : x \geq 0\}$  the *visible book* and  $\{u_{b/a}^n(t, x) : x < 0\}$  the *shadow book* at time  $t \geq 0$  of the bid ( $b$ ), respectively, the ask ( $a$ ) side of the book. The visible book collects the orders awaiting execution. The shadow book specifies the volumes that will be placed into the spread, should such an event occur next. Since several consecutive spread placements may occur the shadow book is defined on the whole negative half-line. It will undergo random fluctuations similar to the visible book and is just convenient tool to describe spread placements. Its precise working will be further described in Section 2.1.1 below. See also [13, 14] for a discussion of the shadow book.

Throughout, indices  $b$  and  $a$  refer to bid and ask side volumes, respectively. We often use the index  $r$  to refer to either side of the book. Occasionally, we drop the index altogether and write for instance just  $v(t, x)$  if we give generic arguments that apply to both sides of the book. In both cases, we use  $R^n(t)$  or  $R_t^n$  to denote either the best bid ( $r = b$ ) or the best ask ( $r = a$ ) price.

ASSUMPTION 2.1. The sequence of initial data  $(A_0^n, B_0^n, v_a^n(0, \cdot), v_b^n(0, \cdot))$  converges to  $(A_0, B_0, v_{a,0}(\cdot), v_{b,0}(\cdot))$  in both  $\mathbb{R}^2 \times L^2 \times L^2$  and  $\mathbb{R}^2 \times L^\infty \times L^\infty$ .

There are eight events—labeled  $\mathbf{M}_r, \mathbf{L}_r, \mathbf{C}_r, \mathbf{P}_r$  ( $r = a, b$ )—that change the state of the book. The events  $\mathbf{M}_b, \mathbf{L}_b, \mathbf{C}_b, \mathbf{P}_b$  affect the bid side of the book:

- $\mathbf{M}_b$  . . . market sell order
- $\mathbf{L}_b$  . . . buy limit order placed in the spread
- $\mathbf{C}_b$  . . . cancellation of buy volume
- $\mathbf{P}_b$  . . . buy limit order not placed in spread.

The events  $\mathbf{M}_a, \mathbf{L}_a, \mathbf{C}_a, \mathbf{P}_a$  affect the ask side of the book:

- $\mathbf{M}_a$  . . . market buy order
- $\mathbf{L}_a$  . . . sell limit order placed in the spread
- $\mathbf{C}_a$  . . . cancellation of sell volume
- $\mathbf{P}_a$  . . . sell limit order not placed in the spread.

In the sequel, we specify how different order types change the state of the book.

2.1.1. *Active orders and price dynamics.* We assume that market order arrivals (Events  $\mathbf{M}_{b/a}$ ) and placements of limit orders in the spread (Events  $\mathbf{L}_{b/a}$ ) lead to price changes. In fact, a market order that does not lead to a price change is equivalent to a cancellation at the top of the book. We refer to these order types as *active orders*.

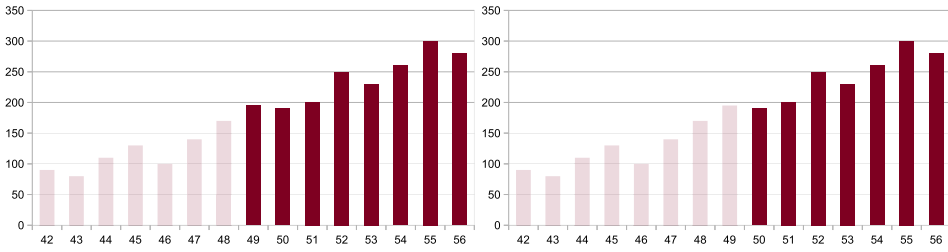


FIG. 1. Ask-side volume function at time  $\tilde{\tau}_i^n$  – (left) and  $\tilde{\tau}_i^n$  (right) of the visible (dark coloured) and shadow book (light coloured) when a market order arrives at  $\tilde{\tau}_i^n$ .

ASSUMPTION 2.2. Active orders arrive according to a Poisson process  $\tilde{N}^n$  with intensity  $\mu^n$ . The corresponding jump times  $(\tilde{\tau}_i^n)_{i=1}^\infty$  will be called active order times.

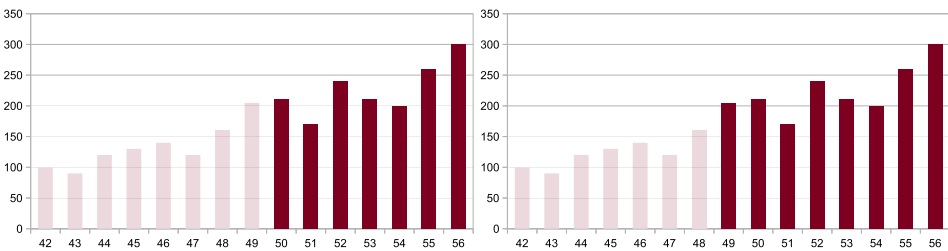


FIG. 2. Ask-side volume function at time  $\tilde{\tau}_{i+1}^n$  – (left) and  $\tilde{\tau}_{i+1}^n$  (right) of the visible and shadow book when a spread placement occurs at  $\tilde{\tau}_{i+1}^n$ .

In our model market, orders match precisely against the volume at the top of the book. In other words, a market order arriving at time  $\tilde{\tau}_i^n$  is good for  $v_r^n(\tilde{\tau}_i^n-, R^n(\tilde{\tau}_i^n-)) \cdot \Delta x^n$  shares. We further assume that limit orders placed into the spread are placed at the first best price increment and that their sizes are determined by the shadow book. Specifically, a limit order placed into the spread at time  $\tilde{\tau}_j^n$  is placed at the price level  $R^n(\tilde{\tau}_j^n-) - \Delta x^n$  and its size is  $v_r^n(\tilde{\tau}_j^n-, R^n(\tilde{\tau}_j^n-) - \Delta x^n) \cdot \Delta x^n$ . If another limit order placement occurs at the next active order time  $\tilde{\tau}_{j+1}^n$ , then the order is placed at  $R^n(\tilde{\tau}_j^n-) - 2\Delta x^n$  and its size is  $v_r^n(\tilde{\tau}_{j+1}^n-, R^n(\tilde{\tau}_j^n-) - 2\Delta x^n) \cdot \Delta x^n$ . In between two active orders, cancellations and placements may occur in the shadow book so typically  $v_r^n(\tilde{\tau}_{j+1}^n-, R^n(\tilde{\tau}_j^n-) - 2\Delta x^n) \neq v_r^n(\tilde{\tau}_j^n-, R^n(\tilde{\tau}_j^n-) - 2\Delta x^n)$ ; cf. Section 2.1.2 and Figures 1 and 2.

We allow the probabilities of price changes to depend on standing volumes. To this end, we fix smooth nonnegative functions  $\varphi^r : \mathbb{R} \rightarrow \mathbb{R}$  and put

$$Y_t^{r,n} := \langle v_r^n(t, \cdot), \varphi^r(\cdot - R^n(t)) \rangle \quad (r = a, b).$$

We interpret  $Y_t^{r,n}$  as a measure for the volume standing at the top of the book or the total bid ( $r = b$ ) or ask ( $r = a$ ) side volume, depending on the choice of  $\varphi^r$ . The price dynamics is now defined as

$$(1) \quad dR^n(t) = \Delta x^n \xi_{r, \tilde{N}^n(t)}^n d\tilde{N}^n(t),$$

where the random variables  $\xi_{r, \tilde{N}^n(t)}^n$  take values in  $\{0, -1, +1\}$ . Their distribution will depend on the bid and ask price and on the state of the volumes placed. Hence, the model considered is not of zero-intelligence type. More precisely, we work under the following assumption.

ASSUMPTION 2.3. Let  $(\mathcal{F}_t^n)$  denote the filtration generated by the  $n$ th model [the precise definition is given in (9) below]. For  $r = a, b$ , there exist functions  $b_r^n \in C^1(\mathbb{R}^4)$  and  $\sigma_r^n \in C^1(\mathbb{R}^4; \mathbb{R}^{2 \times 1})$  such that

$$(2) \quad E_{\mathcal{F}_{t-}^n \vee \sigma(\tilde{N}^n(t))}[\xi_{r, \tilde{N}^n(t)}^n] = \frac{1}{\sqrt{n}} b_r^n(B_{t-}^n, A_{t-}^n, Y_{t-}^{b,n}, Y_{t-}^{a,n}),$$

$$(3) \quad \text{Cov}_{\mathcal{F}_{t-}^n \vee \sigma(\tilde{N}^n(t))} \left[ \begin{pmatrix} \xi_{b, \tilde{N}^n(t)}^n \\ \xi_{a, \tilde{N}^n(t)}^n \end{pmatrix} \right] = \begin{pmatrix} \sigma_b^n \\ \sigma_a^n \end{pmatrix} \cdot \begin{pmatrix} \sigma_b^n \\ \sigma_a^n \end{pmatrix}^\top (B_{t-}^n, A_{t-}^n, Y_{t-}^{b,n}, Y_{t-}^{a,n}),$$

for any  $t > 0$ , and  $(b_r^n, \sigma_r^n)$  converges to  $(b_r, \sigma_r)$  in  $C(\mathbb{R}^4) \times C(\mathbb{R}^4; \mathbb{R}^{2 \times 1})$  (uniformly) such that the matrix  $\begin{pmatrix} \sigma_b \\ \sigma_a \end{pmatrix}$  is invertible and  $(b_r, \sigma_r) \in C^1(\mathbb{R}^4) \times C^1(\mathbb{R}^4; \mathbb{R}^{2 \times 1})$  and the limiting objects are uniformly bounded.

LEMMA 2.4. *The sequence of price processes  $(A^n, B^n)$  is C-tight.*

PROOF. Immediately by Theorem C.1 and Lemma C.2 as price increments are bounded by  $\Delta x^n$ .  $\square$

It is clearly desirable to avoid crossing of bid and ask prices. One possibility is to introduce a reflection term and to scale the prices such that they converge to reflected Brownian motion in the limit as in [18]. Another is to consider short time scales as illustrated by the following example.

EXAMPLE 2.5. Let us assume that

$$\mathbb{P}_{\mathcal{F}_{t-}^n \vee \sigma(\tilde{N}^n(t))}[\xi_{b/a, \tilde{N}^n(t)}^n = \pm 1] = g_r^n(\pm 1, B_{t-}^n, A_{t-}^n, Y_{t-}^{b,n}, Y_{t-}^{a,n})$$

for smooth functions  $g_r^n(\pm 1, \cdot)$  that satisfy for any  $(y^1, y^2, y^3, y^4) \in \mathbb{R}^4$ ,

$$\begin{aligned} g_b^n(+1, y^1, y^2, y^3, y^4) &= g_a^n(-1, y^1, y^2, y^3, y^4) \\ &= 0 \quad \text{if } y^2 - y^1 < \varepsilon \text{ for some } \varepsilon > 0 \end{aligned}$$



and

$$g_r^n(+1, y^1, y^2, y^3, y^4) - g_r^n(-1, y^1, y^2, y^3, y^4) = \frac{1}{\sqrt{n}} b_r^n(y^1, y^2, y^3, y^4).$$

Then Assumption 2.3 is satisfied up to some stopping time. If we further assume that  $\xi_{b, \tilde{N}^n(t)}^n \cdot \xi_{a, \tilde{N}^n(t)}^n = 0$ , then at most one price moves at any active order time.

Notice that the above example makes sense for short times. The next example avoids this limitation.

EXAMPLE 2.6. For simplicity, we give an example where price dynamics do not depend on  $Y$ . It is, however, simple to extend the example. Let  $\zeta_{l,i}^n, l = 1, 2, i \in \mathbb{N}$ , be the increments (indexed by  $i$ ) of two independent Donsker-type approximations of two independent geometrical Brownian motions denoted by  $S_t^l, l = 1, 2$ , both of which are constructed such that positivity of the cumulative sum of  $(\zeta_{l,i}^n)_{i \in \mathbb{N}}$  is ensured for any  $n$ —for instance, by reflection. We may suppose that  $\zeta_{l,i}^n$  takes values in  $\{0, \pm 1\}$ . Define  $\xi_{b,i}^n := \zeta_{1,i}^n$  and  $\xi_{2,i}^n := \zeta_{1,i}^n + \zeta_{2,i}^n$ . Hence,  $\xi_{r,i}^n$  take values in  $\{0, \pm 1, \pm 2\}$ —an inconsequential violation of the assumption that  $-1 \leq \xi \leq 1$ . In the limit, we have  $B_t = S_t^1$  and  $A_t = S_t^1 + S_t^2 \geq B_t$ .

2.1.2. *Passive orders and volume changes.* Limit order placements outside the spread and cancellations of standing volume do not change prices. We refer to these order types as *passive orders*. In our model, cancellations (Events  $\mathbf{C}_{b/a}$ ) occur for random *proportions* of the standing volume while limit order placements outside the spread (Events  $\mathbf{P}_{b/a}$ ) occur for random *volumes* at random price levels.

ASSUMPTION 2.7. Passive orders arrive according to independent Poisson processes  $N_b^n$  and  $N_a^n$  that are independent of  $\tilde{N}^n$  with intensities  $\lambda_b^n$  and  $\lambda_a^n$  at the bid and ask side of the book, respectively. The corresponding jump times  $(\tau_{b/a,i}^n)_{i=1}^\infty$  will be called passive order times.

The *submission and cancellation price levels* are chosen *relative* to the best prices. Specifically, we assume that the distances to the best prices are chosen according to a sequence of i.i.d. random variables  $(\pi_i)_{i=0}^\infty$  where each  $\pi_i$  is of the form

$$(4) \quad \pi_i = (\pi_i^{\mathbf{C}_b}, \pi_i^{\mathbf{C}_a}, \pi_i^{\mathbf{P}_b}, \pi_i^{\mathbf{P}_a}, \pi_i^{\mathbf{N}_b}, \pi_i^{\mathbf{N}_a}).$$

The entries take values in an interval  $[-M, M]$ , for some  $M > 0$ ; positive values indicate changes in the visible book while negative values indicate changes in the shadow book. Superscripts indicate event types and “N” stands for “noise”. For instance,  $\pi_i^{\mathbf{C}_a} \in [0, \Delta x^n)$  means that if the  $i$ th event is a passive order, then it triggers a ask-side cancellation at the top of the visible book while  $\pi_i^{\mathbf{C}_a} \in [-\Delta x^n, 0)$

corresponds to an ask-side cancellation one tick below the best ask, that is, a cancellation in the shadow book. The precise meaning of the entries will become clear in (6) below.

For  $r = a, b$ , passive order sizes are described by a sequence of i.i.d. random variables  $(\omega_i)_{i=0}^\infty$  where each  $\omega_i$  is of the form

$$(5) \quad \omega_i = (\omega_i^{C_b}, \omega_i^{C_a}, \omega_i^{P_b}, \omega_i^{P_a}, \omega_i^{N_b}, \omega_i^{N_a}).$$

The random variables  $\omega_i^{P_r}$  take values in  $[0, \infty)$ ; they describe the *sizes* of order placements. Likewise, the random variables  $\omega_i^{C_r}$  take values in  $[0, 1]$  and describe the *proportions* of cancellations. We notice that  $\omega_i^{C_r} = 1$  corresponds to a wipe-out of the orders at the corresponding price level that is, in principle, not forbidden. The resulting dynamics of the buy and sell side volume density functions satisfies

$$(6) \quad \begin{aligned} dv_r^n(t, \cdot) = & \left[ \mathbf{1}_{I^n(R^n(\tilde{\tau}_{N^n(t-)}^n) + \pi_{N_r^n(t)}^{P_r})}(\cdot) \omega_{N_r^n(t-)}^{P_r} \frac{\Delta v^n}{\Delta x^n} \right. \\ & \left. - \mathbf{1}_{I^n(R^n(\tilde{\tau}_{N^n(t-)}^n) + \pi_{N_r^n(t)}^{C_r})}(\cdot) \omega_{N_r^n(t-)}^{C_r} v_r^n(\tau_{r, N_r^n(t-)}^n, \cdot) \frac{\Delta v^n}{\Delta x^n} \right], \end{aligned}$$

where  $\Delta v^n$  is a scaling parameter that measures the impact of an individual order on the state of the book and  $I^n(y)$  is the subinterval corresponding to tick-size  $\Delta x^n$  that  $y$  belongs to, that is,

$$(7) \quad \mathbf{1}_{I^n(y)}(x) := \sum_{j \in \mathbb{Z}} \mathbf{1}_{[x_j^n, x_{j+1}^n)}(y) \mathbf{1}_{[x_j^n, x_{j+1}^n)}(x).$$

The specific structure of the dependence of the volume density functions on the bid and ask price as well as the random submission price levels reflects the fact that submission and cancellation price levels are chosen relative to the best bid/ask price.

REMARK 2.8. In real-world markets, only one event (market order arrival, cancellation, placement) happens at a time. Within our framework, this corresponds to the special case where only one of the four random variables  $\omega^{C_{b/a}}, \omega^{P_{b/a}}$  is different from zero. Our mathematical framework is flexible enough to allow for such a dependence structure.

Within the framework described thus far, (random) fluctuations in limiting volumes will originate entirely from fluctuations in prices through the price-dependent order arrival and cancellation dynamics.<sup>4</sup> Our mathematical framework is flexible enough to also allow fluctuations in volumes to originate directly from

order placements if we allow for a second type of placements that are correlated on a “common factor” rather than the price process. In the simplest case, the “common factor” dynamics is specified by sequences of i.i.d. random variables  $(\tilde{\xi}_{r,i})_{i=0}^\infty$  ( $r = a, b$ ). For the scaling limit, it will be important that this common factor changes at the same rate as prices do. To simplify the analysis, we assume that it actually stays constant between two active order times and specify our volume dynamics as

$$\begin{aligned}
 (8) \quad dv_r^n(t, \cdot) = & \left[ \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(t-)}^n) + \pi_{N_r^n(t)}^{\mathbf{P}_r})}(\cdot) \omega_{N_r^n(t-)}^{\mathbf{P}_r} \frac{\Delta v^n}{\Delta x^n} \right. \\
 & - \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(t-)}^n) + \pi_{N_r^n(t)}^{\mathbf{C}_r})}(\cdot) \omega_{N_r^n(t-)}^{\mathbf{C}_r} v_r^n(\tau_{r, N_r^n(t-)}^n, \cdot) \frac{\Delta v^n}{\Delta x^n} \\
 & \left. + \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(t-)}^n) + \pi_{N_r^n(t)}^{\mathbf{N}_r})}(\cdot) \omega_{N_r^n(t-)}^{\mathbf{N}_r} \tilde{\xi}_{r, \tilde{N}^n(t-)} \sqrt{\Delta v^n} \right] dN_r^n(t).
 \end{aligned}$$

We notice that the common factor is modulated by the nonnegative i.i.d. noise variables  $\omega_i^{\mathbf{N}_r}$  that change between two consecutive passive orders. We motivate the particular choice of the noise terms after the main result is formulated, below Corollary 2.11.

We assume that the following condition holds.

ASSUMPTION 2.9.

- The random variables  $(\pi_i^{\mathbf{T}})_{\mathbf{T}=\mathbf{C}_r, \mathbf{P}_r, \mathbf{N}_r, r=a,b, i \in \mathbb{N}}$ , are i.i.d. with Lipschitz continuous densities  $f^{\mathbf{T}}$  on some compact interval  $[-M, M]$  and independent of the Poisson processes.
- The variables  $(\omega_i^{\mathbf{T}})_{\mathbf{T}=\mathbf{C}_r, \mathbf{P}_r, \mathbf{N}_r, r=a,b, i \in \mathbb{N}}$ , are i.i.d., independent of the Poisson processes and have a finite fourth moment.
- The variables  $\tilde{\xi}_{r,i}$  are i.i.d., independent of all other random variables and take the values  $\pm 1$  with equal probability.

For future use, we also introduce the filtration  $\mathcal{F}^n$  generated by the  $n$ th model. More precisely, we set

$$\begin{aligned}
 (9) \quad \mathcal{F}_t^n := \sigma & \left( (\tilde{N}_s^n)_{0 \leq s \leq t}, (\xi_{a,k}^n)_{k=1}^{\tilde{N}^n(t)}, (\xi_{b,k}^n)_{k=1}^{\tilde{N}^n(t)}, (N_a^n(s))_{0 \leq s \leq t}, (N_b^n(s))_{0 \leq s \leq t}, \right. \\
 & (\omega_k^{\mathbf{C}_a}, \omega_k^{\mathbf{P}_a}, \omega_k^{\mathbf{N}_a})_{k=1}^{N_a^n(t)}, (\omega_k^{\mathbf{C}_b}, \omega_k^{\mathbf{P}_b}, \omega_k^{\mathbf{N}_b})_{k=1}^{N_b^n(t)}, (\pi_k^{\mathbf{C}_a}, \pi_k^{\mathbf{P}_a}, \pi_k^{\mathbf{N}_a})_{k=1}^{N_a^n(t)}, \\
 & \left. (\pi_k^{\mathbf{C}_b}, \pi_k^{\mathbf{P}_b}, \pi_k^{\mathbf{N}_b})_{k=1}^{N_b^n(t)}, (\tilde{\xi}_{b,k}^n)_{k=1}^{\tilde{N}^n(t)}, (\tilde{\xi}_{a,k}^n)_{k=1}^{\tilde{N}^n(t)} \right).
 \end{aligned}$$

2.2. *The main result.* We prove below that our LOB model converges to a continuous time limit if the order arrival rates tend to infinity and the impact of an individual order arrival on the book as well as the tick size tends to zero in a

particular way. In order to make the convergence concept precise, and to state the main result, we need to introduce further notation. For  $m \in (-\infty, \infty)$ , we denote by  $(H^m, \|\cdot\|_m)$  the space of Bessel potentials equipped with the usual Sobolev norm and inner product. Set

$$\mathcal{E}' = \bigcup_m H^{-m} \supset \dots \supset H^{-1} \supset L^2 \supset H^1 \supset \dots \supset \bigcap_m H^m = \mathcal{E}.$$

It is well known that  $H^0 = L^2$  and that  $\mathcal{E}$  is a complete separable metric space. Sobolev’s embedding theorem indicates that each element of  $\mathcal{E}$  is an infinitely differentiable function. In what follows, denote the dual between  $\mathcal{E}'$  and  $\mathcal{E}$  by  $\langle \cdot, \cdot \rangle$ , which is consistent with the inner product of  $H^0 = L^2$ .

The convergence concept we use is weak convergence in the Skorokhod space  $\mathcal{D} := \mathcal{D}([0, \infty); \mathbb{R}^2 \times H^{-1} \times H^{-1})$  of all càdlàg functions on  $[0, \infty)$  taking values in the space  $\mathbb{R}^2 \times H^{-1} \times H^{-1}$ . The space  $\mathcal{D}$  is equipped with the usual Skorokhod metric (see Jacod and Shiryaev [17]).

We are now ready to state the main result of this paper. The main assumptions and the assertions of the theorem are discussed below. The proof is carried out in the subsequent sections.

**THEOREM 2.10.** *Let Assumptions 2.1–2.9 be satisfied and assume that the scaling parameters  $\lambda_{b/a}^n$  (arrival rate of passive orders),  $\mu^n$  (arrival rate of active orders),  $\Delta v^n$  (order sizes) and  $\Delta x^n$  (tick size) satisfy the following conditions:*

$$\lambda_{b/a}^n = n^2; \quad \mu^n = n; \quad \Delta v^n = n^{-2}; \quad \Delta x^n = n^{-1/2}.$$

*Then there are three independent Wiener processes  $\widetilde{W}$ ,  $W_a$  and  $W_b$  ( $\widetilde{W}$  being two-dimensional) such that the sequence  $(A^n, B^n, v_a^n, v_b^n)$  of stochastic processes converges in distribution in  $\mathcal{D}([0, \infty); \mathbb{R}^2 \times H^{-1} \times H^{-1})$  to  $(A, B, v_a, v_b)$ . Here,  $(A, B)$  is a two-dimensional diffusion process satisfying the SDE:*

$$\begin{aligned} dA_t &= b_a(B_t, A_t, Y_t^b, Y_t^a) dt + \sigma_a(B_t, A_t, Y_t^b, Y_t^a) d\widetilde{W}_t; & A_0 &= a_0; \\ dB_t &= b_b(B_t, A_t, Y_t^b, Y_t^a) dt + \sigma_b(B_t, A_t, Y_t^b, Y_t^a) d\widetilde{W}_t; & B_0 &= b_0; \end{aligned}$$

*with  $\sigma_a = (\sigma^{11}, \sigma^{12})$ ,  $\sigma_b = (\sigma^{21}, \sigma^{22})$ ,  $Y_t^a = \langle v_a(t, \cdot), \varphi^a(\cdot - A_t) \rangle$  and  $Y_t^b = \langle v_b(t, \cdot), \varphi^b(\cdot - B_t) \rangle$ , respectively. Moreover, the volume density processes satisfy the infinite-dimensional SDE*

$$\begin{aligned} v_b(t, \cdot) &= v_{b,0}(\cdot) + \int_0^t (E[\omega_1^{\mathbf{P}^b}] f^{\mathbf{P}^b}(\cdot - B_s) - E[\omega_1^{\mathbf{C}^b}] f^{\mathbf{C}^b}(\cdot - B_s) v_b(s, \cdot)) ds \\ &\quad + \sqrt{2} E[\omega_1^{\mathbf{N}^b}] \int_0^t f^{\mathbf{N}^b}(\cdot - B_s) dW_b(s), \quad t \geq 0; \\ v_a(t, \cdot) &= v_{a,0}(\cdot) + \int_0^t (E[\omega_1^{\mathbf{P}^a}] f^{\mathbf{P}^a}(\cdot - A_s) - E[\omega_1^{\mathbf{C}^a}] f^{\mathbf{C}^a}(\cdot - A_s) v_a(s, \cdot)) ds \\ &\quad + \sqrt{2} E[\omega_1^{\mathbf{N}^a}] \int_0^t f^{\mathbf{N}^a}(\cdot - A_s) dW_a(s), \quad t \geq 0. \end{aligned}$$

If  $\omega_1^{\mathbf{N}_r} = 0$  (no common factor), then the volume density functions are absolutely continuous in time.

For any  $T \in (0, \infty)$ , existence and uniqueness of an adapted solution to the above coupled SDE system in  $L^2(\Omega; C([0, T]; \mathbb{R}^2)) \times L^2(\Omega; C([0, T]; L^2(\mathbb{R}; \mathbb{R}^2)))$  is obvious; see [7] for a general theory on stochastic equations in infinite dimensions. If the model parameters are sufficiently smooth, then the density functions are smooth as well. The following corollary is a consequence of the Itô–Kunita formula.

**COROLLARY 2.11.** *If  $v_{r,0}$  and the densities  $f^{\mathbf{T}}$  belong to  $H^m$  with  $m > 3$ , then  $v_r(t)$  take values in  $H^m$ , and hence by embedding, in  $C^2(\mathbb{R})$ . Then the relative volume processes  $u_b(t, x) = v_b(t, B_t + x)$ ,  $u_a(t, x) = v_a(t, A_t + x)$  satisfy the nonlocal stochastic partial differential equations*

$$\begin{aligned} du_a(t, x) &= [E[\omega_1^{\mathbf{P}^a}]f^{\mathbf{P}^a}(x) - E[\omega_1^{\mathbf{C}^a}]f^{\mathbf{C}^a}(x)u_a(t, x) \\ &\quad + Du_a(t, x)b_a(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle)] dt \\ &\quad + \frac{1}{2} \text{tr}\{\sigma_a \sigma_a^\top(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle)D^2u_a(t, x)\} dt \\ &\quad + \sqrt{2}E[\omega_1^{\mathbf{N}^a}]f^{\mathbf{N}^a}(x) dW_a(t) \\ &\quad + Du_a(t, x)\sigma_a(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle) d\widetilde{W}(s), \quad t \geq 0; \\ u_a(0, x) &= v_{a,0}(x + a_0); \end{aligned}$$

$$\begin{aligned} du_b(t, x) &= [E[\omega_1^{\mathbf{P}^b}]f^{\mathbf{P}^b}(x) - E[\omega_1^{\mathbf{C}^b}]f^{\mathbf{C}^b}(x)u_b(t, x) \\ &\quad + Du_b(t, x)b_b(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle)] dt \\ &\quad + \frac{1}{2} \text{tr}\{\sigma_b \sigma_b^\top(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle)D^2u_b(t, x)\} dt \\ &\quad + \sqrt{2}E[\omega_1^{\mathbf{N}^b}]f^{\mathbf{N}^b}(x) dW_b(t) \\ &\quad + Du_b(t, x)\sigma_b(B_t, A_t, \langle u_b(t), \varphi^b \rangle, \langle u_a(t), \varphi^a \rangle) d\widetilde{W}(s), \quad t \geq 0; \\ u_b(0, x) &= v_{b,0}(x + b_0) \end{aligned}$$

which are coupled with the SDE for the price system given in Theorem 2.10.

Some comments on our scaling assumptions are in order. The assumption that market orders match precisely against the standing volume at the top of the book and that market orders of smaller size are viewed as cancellation is made for mathematical convenience. There is some empirical evidence, though, that this assumption is not too restrictive. In an empirical study the authors of [9] found that in their

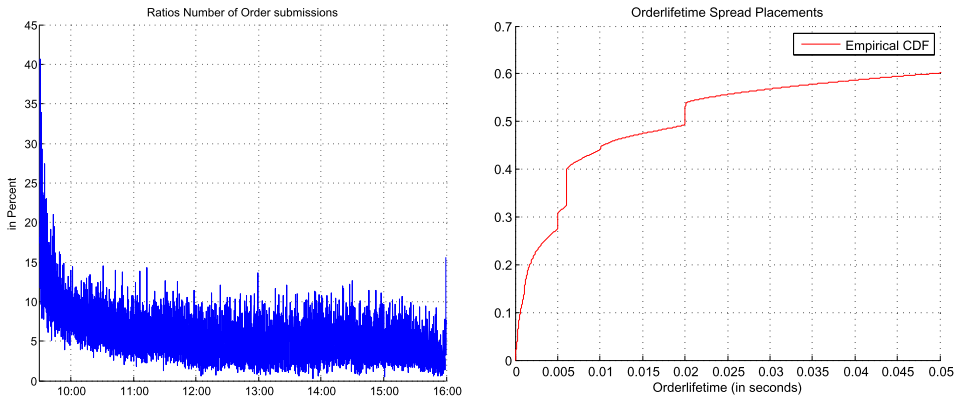


FIG. 3. Average percentage of spread placement per second (left) and empirical lifetime distribution of spread placements for APPL (right).

data sample around 85% of the sell market orders that lead to price changes match exactly the size of the volume standing at the best bid price.

The assumptions that market orders and limit order placements in the spread occur at the same rate and that the liquidity at the top of the book is an indicator for volumes placed in the spread are key to our analysis. They await empirical verification.<sup>5</sup>

The assumption that  $\frac{\mu^n}{\lambda^n} \rightarrow 0$  has also been made in [13, 14]. It states that passive events happen much more frequently than active ones. There is strong empirical evidence supporting the assumption that spread placements. For instance, Figure 3(left) shows the intra-day evolution of the proportion of spread placements among all orders for all NASDAQ traded stocks for the month of March 2016. The proportions of spread placements is particularly low for very liquid stocks such as APPL, MSFT or BAC; see [14] and references therein. Moreover, it is well known that many spread placements have very short lifetimes. As an example, Figure 3(right) displays the cumulative distribution function of the time to cancellation of spread placements for APPL (consolidated NASDAQ data; March 2016). As we can see, more than 60% of all spread placements are cancelled after less than 5 milli-seconds.<sup>6</sup> Of course, our model can not reasonably account for such ping-orders.

The scaling assumptions  $\mu^n \sim (\Delta x^n)^{-1}$  as in [13, 14], respectively, our assumption  $\sqrt{\mu^n} \sim (\Delta x^n)^{-1}$  are standard to obtain an ODE, respectively, diffusion

approximations of the price process. The assumption  $\lambda_r^n \sim \Delta v^n$  is as in [13, 14]. It guarantees that the order of magnitude of aggregate placements and cancellations over a given period of time does not change with the model index  $n$ . Furthermore, from the proof of Lemma 3.11 we see that our proof requires  $\mu^n \sim \lambda^n (\Delta x^n)^2$ . This is again the same condition as in [13, 14] taking into account that the different scaling of the tick size (with our choice of rates,  $\Delta p^n = \Delta x^n = n^{-1}$  in [13, 14]). Altogether, this explains the absolutely continuous part of the limiting volume process; it describes the expected volume placement and cancellation activity; see [13, 14] for details. Summarizing, the absolutely continuous part requires the scaling conditions

$$\mu^n \sim \Delta x^n, \quad \lambda_r^n \sim \Delta v^n, \quad \mu^n \sim \lambda_r^n (\Delta x^n)^2.$$

The specific choice  $\mu^n \sim n$ ,  $\lambda_r^n \sim n^2$  and  $\Delta x^n \sim n^{-1/2}$  was made for notational convenience.

The diffusion part of the limiting volume density function is a direct consequence of the noise term  $\tilde{\xi}_{r,i}^n$  in (8) that does not change in-between price changes. The intuition is that in between two consecutive price changes a law of large numbers applies to the volume density function whose increment can hence be approximated by its expected value plus a random term of order  $\sqrt{\Delta v^n}$  that translates into a Brownian motion as  $n \rightarrow \infty$ . If the scaling constant  $\sqrt{\Delta v^n}$  is replaced by a smaller one, then the dynamics of the limiting volume density function will take the form of an (infinite-dimensional) ODE in a random environment generated by the price process. The SPDE dynamics of the volume process in relative coordinates is a direct consequence of the diffusive limiting price process and does not depend on the scaling of the noise terms.

The requirement of a single common factor driving the noise along all passive events can easily be relaxed. Indeed, suppose that we have finitely or infinitely many factors with weights depending on the location of the passive event. This would result in limiting dynamics of the same form as above, except that the single driving Brownian motions were to be replaced by sums of the form  $\sum_i e_{a/b}^i(\cdot) dW_{a/b}^i(s)$ . As long as the (coloured) noise  $\sum_i e_{a/b}^i(x) dW_{a/b}^i(s)$  exists in a suitable space of square integrable smooth functions (in  $x$ ), the analysis should essentially stay the same.

*2.3. Outline of the proof.* The proof of Theorem 2.10 is carried out in the following sections. The main challenge is convergence, especially tightness of the volume densities. Since the price process is C-tight by construction tightness of the volume process implies tightness of the price-volume process, and hence existence of an accumulation point.

We split the dynamics of the volume density functions into the three processes  $V_r^{n,i}(t, \cdot)$  ( $i = 1, 2, 3$ ) that we are going to handle separately, before finally pasting them back together to obtain the limiting dynamics. From equation (8), we iden-

tify the following three processes which drive the evolution of the volume density function ( $r = a, b$ ):

$$(10a) \quad V_r^{n,1}(t, x) = \sum_{i=1}^{N_r^n(t)} \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(\tau_{r,i}^n)})+\pi_i^{\mathbf{P}_r})}(x) \omega_i^{\mathbf{P}_r} \frac{\Delta v^n}{\Delta x^n},$$

$$(10b) \quad V_r^{n,2}(t, x) = \sum_{i=1}^{N_r^n(t)} \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(\tau_{r,i}^n)})+\pi_i^{\mathbf{C}_r})}(x) \omega_i^{\mathbf{C}_r} \frac{\Delta v^n}{\Delta x^n},$$

$$(10c) \quad V_r^{n,3}(t, x) = \sum_{i=1}^{N_r^n(t)} \mathbf{1}_{I^n(R^n(\tilde{\tau}_{\tilde{N}^n(\tau_{r,i}^n)})+\pi_i^{\mathbf{N}_r})}(x) \omega_i^{\mathbf{N}_r} \tilde{\xi}_{r, \tilde{N}^n(\tau_{r,i}^n)+1} \sqrt{\Delta v^n},$$

corresponding to the volume changes due to incoming order placements ( $V_r^{n,1}$ ), the proportional cancellations of standing volume ( $V_r^{n,2}$ ) and aggregated random fluctuations ( $V_r^{n,3}$ ). In the limit the increasing functions (in time)  $V_r^{n,1}$  and  $V_r^{n,2}$  will translate into the integrals w.r.t. the functions  $f^{\mathbf{P}_r}$  and  $f^{\mathbf{C}_r}$ . The process  $V_r^{n,3}$  will contribute the martingale part.<sup>7</sup>

Unfortunately, these processes are not convenient for characterizing the limit process. They are not Markov chains, and  $V_r^{n,3}$  is not a martingale. The ‘‘Markovization’’ is achieved by registering changes to the order book only along active order times and by considering the process as if these times were deterministic. More precisely, we define time-changes together with their inverses by

$$(11) \quad \begin{aligned} \bar{\eta}_u^n &:= \tilde{\tau}_{[nu]}^n, & u &\in [0, \infty); \\ \eta_u^n &:= \inf\{t : t > 0, \bar{\eta}_t^n > u\} - \frac{1}{n}, & u &\in [0, \infty), \end{aligned}$$

and introduce the following processes:

$$(12a) \quad \bar{A}^n(u) := A_0^n + \Delta x^n \sum_{i=1}^{[nu]} \xi_{a,i}^n,$$

$$(12b) \quad \bar{B}^n(u) := B_0^n + \Delta x^n \sum_{i=1}^{[nu]} \xi_{b,i}^n,$$

$$(12c) \quad \bar{V}_r^{n,1}(u, x) := \sum_{i=1}^{N_r^n(\tilde{\tau}_{[nu]}^n)} \omega_i^{\mathbf{P}_r} \mathbf{1}_{I^n(\bar{R}^n(\eta_{r,i}^n)+\pi_i^{\mathbf{P}_r})}(x) \frac{\Delta v^n}{\Delta x^n},$$

$$(12d) \quad \bar{V}_r^{n,2}(u, x) := \sum_{i=1}^{N_r^n(\tilde{\tau}_{[nu]}^n)} \omega_i^{\mathbf{C}_r} \mathbf{1}_{I^n(\bar{R}^n(\eta_{r,i}^n)+\pi_i^{\mathbf{C}_r})}(x) \frac{\Delta v^n}{\Delta x^n},$$

$$(12e) \quad \bar{V}_r^{n,3}(u, x) := \sum_{i=1}^{N_r^n(\tilde{\tau}_{[nu]}^n)} \omega_i^{N_r} \mathbf{1}_{I^n(\bar{R}^n(\eta_{\tau_{r,i}^n}^n) + \pi_i^{N_r})}(x) \tilde{\xi}_r, \tilde{N}^n(\tau_{r,i}^n) + 1 \sqrt{\Delta v^n},$$

$$(12f) \quad \bar{v}_r^n(u, x) := v_r^n(0, x) + \bar{V}_r^{n,1}(u, x) + \bar{V}_r^{n,3}(u, x)$$

$$- \sum_{i=1}^{N_r^n(\tilde{\tau}_{[nu]}^n)} \omega_i^{C_r} \mathbf{1}_{I^n(\bar{R}^n(\eta_{\tau_{r,i}^n}^n) + \pi_i^{C_r})}(x) v_r^n(\tau_{r,i}^n, x) \frac{\Delta v^n}{\Delta x^n}.$$

In a first step, we prove in Section 3.1 tightness of each of the processes  $\bar{V}_r^{n,i}$  and of  $\bar{v}_r^n$  in the distributional sense indicated above. For this part, we heavily rely on Mitoma’s theorem (Theorem C.3) together with Kurtz’s criterion (Theorem C.1). Extending the tightness result from  $\bar{v}_r^n$  to  $v_r^n$  requires  $C$ -tightness of  $\bar{v}_r^n$ . Hence, in Section 3.2, we first characterize the limit  $\bar{v}_r$  of  $\bar{v}_r^n$ , depending on the yet unknown limiting price process  $(A, B)$ . Convergence of the placement term is standard; convergence of the martingale term follows from a general result on the convergence of stochastic process limits, given in Appendix A. The challenge is to prove convergence of *aggregate* cancellations.<sup>8</sup> In Section 3.3, we extend our tightness result to the process

$$\hat{v}_r^n := \bar{v}_r^n \circ \eta^n$$

that accounts for the random event times. As a byproduct, we obtain that the limits of all the processes  $\bar{v}_r^n, \hat{v}_r^n$  and  $v_r^n$  coincide. More precisely, we first use  $C$ -tightness of the sequence  $\bar{v}_r^n$  to establish the joint convergence  $(\bar{v}_r^n, \eta^n) \xrightarrow{n \rightarrow \infty} (\bar{v}_r, \text{id})$  (in a weak sense). By Lemma C.5, this implies that

$$\lim_{n \rightarrow \infty} \hat{v}_r^n = \lim_{n \rightarrow \infty} \bar{v}_r^n \circ (\eta^n) = \bar{v}_r.$$

Subsequently, we prove the tightness of  $v_r^n$  and further verify that  $\hat{v}_r^n - v_r^n$  converges to 0 in an  $L^2(\Omega; L^2(\mathbb{R}))$ -sense (this is where we need  $\hat{v}_r^n$ ), thereby implying that

$$\lim_{n \rightarrow \infty} v_r^n = \lim_{n \rightarrow \infty} \hat{v}_r^n = \bar{v}_r.$$

At this stage, we have only treated the convergence of each of the individual sequences of processes  $(A^n, B^n, v_b^n)$  and  $(A^n, B^n, v_a^n)$  to some limiting processes. However, as all these limiting processes are actually continuous, joint tightness and, finally, joint weak convergence of  $(A^n, B^n, v_b^n, v_a^n)$  follows by Corollary C.4. The last step, performed in Section 4 is then to characterize the limit of the price processes, and consequently, of the full model.

**3. The scaling limit of the volume density.** In this section, we prove weak convergence in a distributional sense of the volume density function. While we do

<sup>8</sup>The process  $\bar{V}_r^{n,2}$  only describes the proportionality of cancellation but not the actual volumes.

not yet know at this point whether there is a unique accumulation point of the sequence of processes  $(A^n, B^n)$ , we *do* know that there are such accumulation points and all these points are processes, which are continuous in time; see Lemma 2.4. By choosing a proper sub-sequence, we can, therefore, assume that  $(A^n, B^n)$  does converge to a continuous limiting process  $(A, B)$ , and we will often do so in this section.

Throughout, we use the symbol  $C$  for deterministic constants which may change from occurrence to occurrence.

3.1. *Tightness of the auxiliary process  $\bar{v}_r^n$ .* We first prove tightness of the processes  $\bar{v}_r^n$ . The arguments are the same for the bid and ask side of the book. We shall therefore drop the index indicating of the bid/ask side and write  $R^n$  or  $\bar{R}^n$  for the price process in what follows. Further, where appropriate we drop the index  $n$  and denote the random location of any activity in the book simply by  $\pi$  or  $\pi_i$  and its size by  $\omega$  or  $\omega_i$ , disregarding the type (placement, cancellation, noise).

We start with an elementary auxiliary lemma on the distribution of a Poisson process as seen from a second, independent Poisson process. The lemma will be key to compute the distribution of passive order arrivals between two consecutive active order times.

LEMMA 3.1. *Let  $N_1$  and  $N_2$  be two independent Poisson processes with intensities  $\lambda_1$  and  $\lambda_2$ , respectively. Moreover, let  $T_i, i = 1, \dots$ , denote the jump times of the Poisson process  $N_1$ . For any  $\alpha = 1, 2, \dots$ , the random variable  $N_2(T_\alpha)$  has a negative binomial (NB) distribution with parameters  $r = \alpha$  and  $p = \frac{\lambda_2}{\lambda_1 + \lambda_2}$ , that is, we have*

$$P(N_2(T_\alpha) = l) = \binom{l + \alpha - 1}{\alpha - 1} \left(\frac{\lambda_2}{\lambda_1 + \lambda_2}\right)^l \left(\frac{\lambda_1}{\lambda_1 + \lambda_2}\right)^\alpha, \quad l = 0, 1, \dots$$

*In particular, the moment-generating function reads*

$$E e^{tN_2(T_\alpha)} = \left(\frac{1 - p}{1 - pe^t}\right)^\alpha \quad \text{for } t < -\log p,$$

and

$$E \left[ \prod_{i=0}^{k-1} (N_2(T_\alpha) - i) \right] = \left( \prod_{i=0}^{k-1} (\alpha + i) \right) \frac{\lambda_2^k}{\lambda_1^k}, \quad k = 1, \dots, 4.$$

In what follows, we denote by  $\bar{\mathcal{F}}^n$  the filtration generated by the processes  $\bar{V}_r^{n,1/2/3}$  and  $\bar{v}_r^n$  ( $r = a, b$ ).

In the next two lemmas, we provide  $L^p$  estimates for the processes  $\bar{V}^{n,1/2}$  and  $\bar{V}^{n,3}$ , respectively. The arguments for  $\bar{V}^{n,1}$  and  $\bar{V}^{n,2}$  are the same. The arguments for  $\bar{V}^{n,3}$  are similar. However, since the scaling for  $\bar{V}^{n,3}$  is much smaller we need

to take advantage of the martingale-difference structure in order to avoid mixed terms.

LEMMA 3.2. *There is a constant  $C > 0$  (independent of  $n, s, t$ ) such that for any  $0 < s \leq t$  we have*

$$\begin{aligned}
 E_{\mathcal{F}_s^n} [\|\bar{V}^{n,1/2}(t, \cdot) - \bar{V}^{n,1/2}(s, \cdot)\|_{L^2}^2] &\leq C \left( (t-s)^2 + \frac{|t-s|}{n} \right), \\
 \sup_{x \in \mathbb{R}} E_{\mathcal{F}_s^n} [(\bar{V}^{n,1/2}(t, x) - \bar{V}^{n,1/2}(s, x))^2] &\leq C \left( (t-s)^2 + \frac{|t-s|}{n} \right), \\
 E_{\mathcal{F}_s^n} [\|\bar{V}^{n,1/2}(t, \cdot) - \bar{V}^{n,1/2}(s, \cdot)\|_{L^4}^4] \\
 &\leq C \left( (t-s)^4 + \frac{|t-s|^3}{n} + \frac{|t-s|^2}{n^2} + \frac{|t-s|}{n^3} \right), \\
 \sup_{x \in \mathbb{R}} E_{\mathcal{F}_s^n} [(\bar{V}^{n,1/2}(t, x) - \bar{V}^{n,1/2}(s, x))^4] \\
 &\leq C \left( (t-s)^4 + \frac{|t-s|^3}{n} + \frac{|t-s|^2}{n^2} + \frac{|t-s|}{n^3} \right).
 \end{aligned}$$

PROOF. We drop the superscripts. Without any loss of generality, we can choose  $s = 0$ . Let  $\alpha := \lfloor nt \rfloor$  and consider

$$E[\bar{V}(t, x)^2] = E \left[ \left( \sum_{i=1}^{N(\tilde{\tau}_\alpha)} \mathbf{1}_{I(\bar{R}(\eta_{\tau_i}) + \pi_i)}(x) \omega_i \right)^2 \right] \left( \frac{\Delta v}{\Delta x} \right)^2.$$

Using the fact that the random variables  $\omega_i$  are i.i.d. and independent of the Poisson processes, we get

$$\begin{aligned}
 E[\bar{V}(t, x)^2] &= E \left[ \sum_{i < j; i, j=1}^{N(\tilde{\tau}_\alpha)} 2 E_{\mathcal{F}_{\tau_i} \vee \sigma(\pi_i, \omega_i, \bar{R}_{\eta_{\tau_i}})} [\omega_j \mathbf{1}_{I(\bar{R}(\eta_{\tau_j}) + \pi_j)}(x)] \right. \\
 &\quad \times \omega_i \mathbf{1}_{I(\bar{R}(\eta_{\tau_i}) + \pi_i)}(x) \\
 &\quad \left. + \sum_{i=1}^{N(\tilde{\tau}_\alpha)} E[\omega_i^2] \mathbf{1}_{I(\bar{R}(\eta_{\tau_i}) + \pi_i)}(x) \right] \left( \frac{\Delta v}{\Delta x} \right)^2.
 \end{aligned}$$

As the random variable  $\pi$  has a density  $f$  with support in  $[-M, M]$ , for any deterministic  $y$  we can bound

$$\begin{aligned}
 (13) \quad E[\mathbf{1}_{I(y + \pi_i)}(x)] &= \sum_{j \in \mathbb{Z}} \mathbf{1}_{[x_j, x_{j+1}[}(x) \int_{x_j - y}^{x_{j+1} - y} f(z) dz \\
 &\leq \|f\|_{L^\infty} \Delta x \mathbf{1}_{[y - M - \Delta x, y + M + \Delta x]}(x).
 \end{aligned}$$

Conditioning on the  $\sigma$ -algebra generated by all sources of randomness *except*  $(\pi_i)_{i \in \mathbb{N}}$ , these bounds enable us to estimate

$$\begin{aligned} & E[\bar{V}(t, x)^2] \\ & \leq E \left[ 2E[\omega_1]^2 \|f\|_{L^\infty}^2 \Delta x^2 \sum_{i < j; i, j=1}^{N(\tilde{\tau}_\alpha)} \mathbf{1}_{[\bar{R}(\eta_{\tau_i}) - M - \Delta x, \bar{R}(\eta_{\tau_j}) + M + \Delta x]}(x) \right. \\ & \quad \left. + E[\omega_1^2] \|f\|_{L^\infty} \Delta x \sum_{i=1}^{N(\tilde{\tau}_\alpha)} \mathbf{1}_{[\bar{R}(\eta_{\tau_i}) - M - \Delta x, \bar{R}(\eta_{\tau_i}) + M + \Delta x]}(x) \right] \left( \frac{\Delta v}{\Delta x} \right)^2. \end{aligned}$$

At this stage, we can easily bound  $\bar{V}$  both in  $L^2(\mathbb{R})$  and as a supremum in  $x$ . More precisely, we have

$$\begin{aligned} & E[\|\bar{V}(t)\|_{L^2}^2] + \sup_{x \in \mathbb{R}} E[\bar{V}(t, x)^2] \\ & \leq (4(M + \Delta x) + 1)(E[\omega_1]^2 \|f\|_{L^\infty}^2 \Delta x^2 E[N(\tilde{\tau}_\alpha)(N(\tilde{\tau}_\alpha) - 1)] \\ & \quad + E[\omega_1^2] \|f\|_{L^\infty} \Delta x E[N(\tilde{\tau}_\alpha)]) \left( \frac{\Delta v}{\Delta x} \right)^2. \end{aligned}$$

Finally, inserting the moment formulas given in Lemma 3.1 and applying the trivial estimate  $\alpha = \lfloor nt \rfloor \leq nt$  together with Assumption 2.9, we arrive at

$$\begin{aligned} E[\|\bar{V}(t)\|_{L^2}^2] + \sup_{x \in \mathbb{R}} E[\bar{V}(t, x)^2] & \leq Cn^{-7/2} \left\{ n^{-1/2} nt(1 + nt) \frac{n^4}{n^2} + nt \frac{n^2}{n} \right\} \\ & = C(t^2 + (n^{-1} + n^{-3/2})t) \leq C \left( t^2 + \frac{t}{n} \right). \end{aligned}$$

The estimate for the fourth moment follows analogously and is therefore skipped.  $\square$

LEMMA 3.3. *There is a constant  $C$  (independent of  $n, s, t$ ) such that, for every  $0 < s \leq t$ ,*

$$\begin{aligned} & E_{\mathcal{F}_s^n} \left[ \sup_{s \leq u \leq t} \|\bar{V}^{n,3}(u) - \bar{V}^{n,3}(s)\|_{L^2}^2 \right] \\ (14) \quad & + \sup_{x \in \mathbb{R}} E_{\mathcal{F}_s^n} \left[ \sup_{s \leq u \leq t} |\bar{V}^{n,3}(u, x) - \bar{V}^{n,3}(s, x)|^2 \right] \leq C|t - s|, \end{aligned}$$

$$\begin{aligned} & E_{\mathcal{F}_s^n} \left[ \sup_{s \leq u \leq t} \|\bar{V}^{n,3}(u) - \bar{V}^{n,3}(s)\|_{L^4}^4 \right] \\ (15) \quad & + \sup_{x \in \mathbb{R}} E_{\mathcal{F}_s^n} \left[ \sup_{s \leq u \leq t} |\bar{V}^{n,3}(u, x) - \bar{V}^{n,3}(s, x)|^4 \right] \leq C \left( (t - s)^2 + \frac{|t - s|}{n} \right). \end{aligned}$$

PROOF. Again, we restrict ourselves to proving the case  $s = 0$  and drop all superscripts from the notation. Rewriting  $\bar{V}$  in a form more clearly expressing its

martingale structure, we consider

$$\begin{aligned} \bar{V}(t) &= \sum_{i=1}^{N(\tilde{\tau}_\alpha)} \mathbf{1}_{I(\bar{R}(\eta_i^n)+\pi_i)}(x) \omega_i \tilde{\xi}_{\tilde{N}(\tau_i)} \sqrt{\Delta v} \\ &= \sum_{j=0}^{\alpha-1} \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} \mathbf{1}_{I(\bar{R}(j/n)+\pi_i)}(x) \omega_i \tilde{\xi}_j \sqrt{\Delta v}, \end{aligned}$$

where we again use the short-hand notation  $\alpha = \lfloor tn \rfloor$ . Using Doob’s inequality and the fact that  $E[\tilde{\xi}_i \tilde{\xi}_j] = \delta_{ij}$  with  $\tilde{\xi}_i^2 = 1$ , we have

$$\begin{aligned} E \left[ \sup_{0 \leq u \leq t} |\bar{V}(u, x)|^2 \right] &\leq 4E[|\bar{V}(t, x)|^2] \\ &= 4\Delta v E \left[ \left( \sum_{j=0}^{\alpha-1} \tilde{\xi}_j \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} \mathbf{1}_{I(\bar{R}(j/n)+\pi_i)}(x) \omega_i \right)^2 \right] \\ &= 4\Delta v E \left[ \sum_{j=0}^{\alpha-1} \left( \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} \mathbf{1}_{I(\bar{R}(j/n)+\pi_i)}(x) \omega_i \right)^2 \right]. \end{aligned}$$

Next, we estimate the contribution of the random locations  $\pi$  as in (13). We have

$$\begin{aligned} E \left[ \sup_{0 \leq u \leq t} \|\bar{V}(u)\|_{L^2}^2 \right] &\leq 4\Delta v E \left[ \sum_{j=0}^{\alpha-1} \left\{ \sum_{i \neq i' = N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} \omega_i \omega_{i'} \int_{\mathbb{R}} \mathbf{1}_{I(\bar{R}(j/n)+\pi_i)}(x) \mathbf{1}_{I(\bar{R}(j/n)+\pi_{i'})}(x) dx \right\} \right. \\ &\quad \left. + \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} \omega_i^2 \int_{\mathbb{R}} \mathbf{1}_{I(\bar{R}(j/n)+\pi_i)}(x) dx \right] \\ &\leq 4\Delta v E \left[ \sum_{j=0}^{\alpha-1} \left\{ \sum_{i \neq i' = N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} E[\omega_1]^2 \|f\|_{L^\infty}^2 \Delta x^2 (2M) \right. \right. \\ &\quad \left. \left. + \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} E[\omega_1^2] \|f\|_{L^\infty} \Delta x (2M) \right\} \right], \end{aligned}$$

and similarly,

$$\begin{aligned} \sup_{x \in \mathbb{R}} E \left[ \sup_{0 \leq u \leq t} |\bar{V}(u, x)|^2 \right] &\leq 4\Delta v E \left[ \sum_{j=0}^{\alpha-1} \left\{ \sum_{i \neq i' = N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} E[\omega_1]^2 \|f\|_{L^\infty}^2 \Delta x^2 \right. \right. \\ &\quad \left. \left. + \sum_{i=N(\tilde{\tau}_j)+1}^{N(\tilde{\tau}_{j+1})} E[\omega_1^2] \|f\|_{L^\infty} \Delta x \right\} \right]. \end{aligned}$$

Since the distribution of the increments  $N(\tilde{\tau}_{j+1}) - N(\tilde{\tau}_j)$  does not depend on  $j$ , we see that

$$\begin{aligned} & E\left[\sup_{0 \leq u \leq t} \|\bar{V}(u)\|_{L^2}^2\right] + \sup_{x \in \mathbb{R}} E\left[\sup_{0 \leq u \leq t} |\bar{V}(u, x)|^2\right] \\ & \leq C \Delta v E[\alpha \{E[\omega_1]^2 \|f\|_{L^\infty}^2 (\Delta x)^2 N(\tilde{\tau}_1)(N(\tilde{\tau}_1) - 1) \\ & \quad + E[\omega_1^2] \|f\|_{L^\infty} \Delta x N(\tilde{\tau}_1)\}]. \end{aligned}$$

Again appealing to Lemma 3.1 (with  $\alpha = 1$ ) together with Assumption 2.9, we obtain

$$\begin{aligned} E\left[\sup_{0 \leq u \leq t} \|\bar{V}(u)\|_{L^2}^2\right] + \sup_{x \in \mathbb{R}} E\left[\sup_{0 \leq u \leq t} |\bar{V}(u, x)|^2\right] & \leq C \frac{1}{n^2} nt \left\{ \frac{2n^4}{n^2} + \frac{1}{\sqrt{n}} \frac{n^2}{n} \right\} \\ & = Ct\{2 + 1/\sqrt{n}\} \leq Ct. \end{aligned}$$

As in the proof of Lemma 3.2, the estimate for the fourth moment follows by the similar arguments.  $\square$

At this stage, we can patch together the estimates in Lemmas 3.2 and 3.3 to obtain a similar one for the process  $\bar{v}^n$ . The proof is based on an event-by-event decomposition of the limit order book dynamics. More precisely, in terms of the increments (again, we drop indices indicating the order book side)

$$\begin{aligned} h_i^{n,1}(x) & := \omega_i^{\mathbf{P}} \mathbf{1}_{I^n(\bar{R}^n(\eta_{\tau_i^n}^n) + \pi_i^{\mathbf{P}})}(x) \frac{\Delta v^n}{\Delta x^n}, \\ h_i^{n,2}(x) & := \omega_i^{\mathbf{C}} \mathbf{1}_{I^n(\bar{R}^n(\eta_{\tau_i^n}^n) + \pi_i^{\mathbf{C}})}(x) \frac{\Delta v^n}{\Delta x^n}, \\ h_i^{n,3}(x) & := \mathbf{1}_{I^n(\bar{R}^n(\eta_{\tau_i^n}^n) + \pi_i^{\mathbf{N}})}(x) \omega_i^{\mathbf{N}} \tilde{\xi}_{a, \tilde{N}^n(\tau_i^n) + 1} \sqrt{\Delta v^n} \end{aligned}$$

of the processes  $\bar{V}^{n,j}$  ( $j = 1, 2, 3$ ) one has the following generic decomposition:

$$\begin{aligned} \bar{v}^n(t, x) & = \prod_{i=1}^{N^n(\tilde{\tau}_{[nt]}^n)} (1 - h_i^{n,2}(x)) \bar{v}^n(0, x) \\ (16) \quad & + \prod_{i=1}^{N_{a/b}^n(\tilde{\tau}_{[nt]}^n)} (1 - h_i^{n,2}(x)) \\ & \times \left[ \sum_{i=1}^{N^n(\tilde{\tau}_{[nt]}^n)} \frac{1}{\prod_{m=1}^i (1 - h_m^{n,2}(x))} (h_i^{n,1}(x) + h_i^{n,3}(x)) \right]. \end{aligned}$$

LEMMA 3.4. *There exists a sequence of nonnegative adapted process  $C_t^n$  and a deterministic constant  $C$  such that, for  $p \in \{2, 4\}$ ,*

$$E_{\mathcal{F}_s^n} \left[ \sup_{s \leq r \leq t} \|\bar{v}^n(r) - \bar{v}^n(s)\|_{L^p}^p \right] \leq C_s^n ((t-s)^p + (t-s)),$$

$$E \left[ \sup_{r \leq t} \|\bar{v}^n(r)\|_{L^p}^p \right] \leq C(t^p + t + 1),$$

$$\sup_{x \in \mathbb{R}} E \left[ \sup_{r \leq t} |\bar{v}^n(r, x)|^p \right] \leq C(t^p + t + 1)$$

with

$$(17) \quad C_s^n \leq C(\|\bar{v}^n(s)\|_{L^4}^4 + \|\bar{v}^n(s)\|_{L^2}^2 + 1),$$

$$\sup_n E \left[ \sup_{0 \leq s \leq t} C_s^n \right] \leq C(t^4 + t + 1).$$

PROOF. We may again drop the dependence on  $n$  from the notation and w.l.o.g. assume  $s = 0$ . Note that  $0 \leq 1 - h_i^2(x) \leq 1$  and

$$\left| \prod_{i=1}^{N(\tilde{\tau}_{[nt]})} (1 - h_i^2(x)) - 1 \right| \leq \sum_{i=1}^{N(\tilde{\tau}_{[nt]})} h_i^2(x) = \bar{V}^2(t, x).$$

Hence, (16) together with Lemma 3.2 and 3.3 implies that, for  $p \in \{2, 4\}$ ,

$$(18) \quad E[|\bar{v}(t, x) - \bar{v}(0, x)|^p]$$

$$= E \left[ \left| \left( \prod_{i=1}^{N(\tilde{\tau}_{[nt]})} (1 - h_i^2) - 1 \right) \bar{v}(0, x) + \prod_{i=1}^{N(\tilde{\tau}_{[nt]})} (1 - h_i^2) \left( \sum_{i=1}^{N(\tilde{\tau}_{[nt]})} \frac{1}{\prod_{m=1}^i (1 - h_m^2)} (h_i^1 + h_i^3) \right) \right|^p \right]$$

$$(19) \quad \leq C \left\{ |\bar{v}(0, x)|^p \sup_{x \in \mathbb{R}} E[(\bar{V}^2(t, x))^p] + E[|\bar{V}^1(t, x)|^p + \sup_{0 \leq s \leq t} |\bar{V}^3(s, x)|^p] \right\}.$$

It follows for  $p \in \{2, 4\}$  that

$$E \left[ \sup_{0 \leq u \leq t} \|\bar{v}(u) - \bar{v}(0)\|_{L^p}^p \right] \leq C(\|\bar{v}(0)\|_{L^p}^p + 1)(t^p + t).$$

For a general  $s \in [0, t]$ , this proves the estimate for a  $\mathcal{F}_s^n$ -measurable random variable  $C_s^n$  that depends in an affine way on  $\|\bar{v}(s)\|_{L^p}^p + \|\bar{v}(s)\|_{L^2}^2$ . Note, however, that it follows in a similar way that for  $p \in \{2, 4\}$

$$\sup_{n \in \mathbb{N}^+} \left( E \left[ \sup_{0 \leq s \leq t} \|\bar{v}^n(s)\|_{L^p}^p \right] + \sup_{x \in \mathbb{R}} E \left[ \sup_{0 \leq s \leq t} |\bar{v}^n(s, x)|^p \right] \right) < C(t^4 + t + 1),$$

so that we can, indeed, find a deterministic constant  $C$  which is independent of  $s$ ,  $t$  and  $n$  and bounds  $E[\sup_{0 \leq s \leq t} C_s^n] \leq C(t^4 + t + 1)$ .  $\square$

REMARK 3.5. Using the same arguments as in the above proof, we obtain for  $p \in \{2, 4\}$  and  $k = 0, 1, 2, \dots$ ,

$$E \left[ \sup_{i \in [N^n(\tilde{\tau}_k^n), N^n(\tilde{\tau}_{k+1}^n)] \cap \mathbb{N}^+} \|v^n(\tau_{a,i}) - v^n(\eta_k^n)\|_{L^p}^p \right] \leq C \frac{t + t^p}{n},$$

where the constant  $C$  is independent of  $n$ ,  $k$  and  $t$ .

We are now ready to state and prove the main result of this section.

PROPOSITION 3.6. *The processes  $\bar{v}_r^n$  and  $\bar{V}_r^{n,i}$  ( $r = a, b; i = 1, 2, 3$ ) are tight as processes with paths in  $\mathcal{D}([0, \infty); H^{-1})$ .*

PROOF. Let  $X^n \in \{\bar{v}_r^n, \bar{V}_r^{n,1}, \bar{V}_r^{n,2}, \bar{V}_r^{n,3}\}$ .

By Mitoma’s theorem (see Theorem C.3), we need to prove tightness of the processes  $\langle X^n, \phi \rangle$  for any test function  $\phi \in \mathcal{E} \subset L^2(\mathbb{R})$ , for which we, in turn, will appeal to Kurtz’s criterion (see Theorem C.1). Hence, we need to estimate

$$E_{\mathcal{F}_s^n} [|\langle X^n(t) - X^n(s), \phi \rangle|^2].$$

As  $X^n$  takes values in  $L^2$ , the bracket  $\langle X^n, \phi \rangle$  is equal to the  $L^2$  inner product  $\langle X^n, \phi \rangle_{L^2}$ . By Lemmas 3.2, 3.3 and 3.4, for each  $T > 0$  and  $0 \leq s < t \leq T$ ,

$$\begin{aligned} E_{\mathcal{F}_s^n} [|\langle X^n(t) - X^n(s), \phi \rangle|^2] &\leq E_{\mathcal{F}_s^n} [\|X^n(t) - X^n(s)\|_{L^2}^2] \|\phi\|_{L^2}^2 \\ &\leq C_s^n [(t - s)^2 + (t - s)] \|\phi\|_{L^2}^2 \end{aligned}$$

for some sequence of adapted processes  $C_t^n$  with

$$\sup_n E \left[ \sup_{0 \leq \tau \leq T} C_\tau^n \right] < \infty.$$

Hence, the second condition of Theorem C.1 follows with  $\gamma_n(\delta) = \sup_{\tau \in [0, T]} C_\tau^n \times (\delta^2 + \delta)$ . The first condition, tightness of the sequence of random variables  $\langle X^n(t), \phi \rangle$  for each rational  $t$ , follows from uniform boundedness of the sequence of random variables  $\langle X^n(t), \phi \rangle$  in  $L^2(\Omega, \mathcal{F}, P)$ .

Furthermore, again by Lemmas 3.2, 3.3 and 3.4,

$$\sup_n E \left[ \sup_{t \in [0, T]} \|X^n(t)\|_{L^2}^2 \right] \leq C(T + T^2),$$

for some constant  $C$  that is independent of  $n$  and  $T$ . As a result, it follows from the Markov inequality that

$$\sup_n P \left( \sup_{t \in [0, T]} \|X^n(t)\|_{L^2}^2 > N \right) \leq \frac{C(T + T^2)}{N} \rightarrow 0 \quad \text{as } N \rightarrow \infty.$$



Thus, by Mitoma’s theorem  $X^n$  is tight as sequences of processes with paths in  $\mathcal{D}([0, \infty); H^{-1})$ .  $\square$

REMARK 3.7. The preceding proof *almost* gives us tightness in  $\mathcal{D}([0, \infty); L^2(\mathbb{R}))$  for  $L^2(\mathbb{R})$  equipped with the weak topology. Note, however, that  $L^2(\mathbb{R})$  is not a metric space when equipped with the weak topology. Hence, we cannot use Kurtz’s criterion as it does not apply to nonmetric state spaces.

3.2. *Characterization of the limit of  $\bar{v}_r^n$ .* In this section, we characterize the limit of the sequence  $\bar{v}_r^n$ . Again, we drop indices where appropriate. We start with establishing joint convergence in distribution of bid/ask prices along with the aggregate fluctuations of standing volumes on one side of the book.

PROPOSITION 3.8. For  $r = a, b$ ,  $(\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3}) \Rightarrow (A, B, \bar{V}_r^3)$ , with  $(A, B)$  being a two-dimensional continuous process, and for any choice  $\phi_1, \dots, \phi_l \in \mathcal{E}$  the  $l$ -dimensional process  $(\langle V_r^3, \phi_1 \rangle, \dots, \langle V_r^3, \phi_l \rangle)$  is a martingale w.r.t. the filtration generated by the process  $(A, B, \bar{V}_r^3)$  with quadratic covariation

$$[\langle V_r^3, \phi_i \rangle, \langle V_r^3, \phi_j \rangle]_t = \int_0^t \sigma(\phi_i)(R_s)\sigma(\phi_j)(R_s) ds, \quad t \geq 0, 1 \leq i, j \leq l,$$

$$\sigma(\phi)(y) := \sqrt{2}E[\omega_1^N] \int_{\mathbb{R}} f^{N_r}(x - y)\phi(x) dx.$$

PROOF. Combining Proposition 3.6, Corollary C.4 and C-tightness of the price process (Lemma 2.4), we conclude that  $(\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3})$  is tight as a sequence of processes with sample paths in  $\mathcal{D}([0, \infty); \mathbb{R}^2 \times H^{-1})$  and that  $(\bar{A}^n, \bar{B}^n)$  converges in distribution to a two-dimensional continuous process  $(A, B)$  along a subsequence.

Since the sequence of price processes is C-tight and converges to  $(A, B)$  it is sufficient to characterize the weak accumulation point  $\bar{V}^3$ . To this end, we assume w.l.o.g. that  $E[\omega_1^N] > 0$ . We now proceed in several steps:

(i) First, we define, for any  $\phi \in \mathcal{E}$ ,

$$\bar{Y}_t^n(\phi) = \langle \phi, \bar{V}_t^{n,3} \rangle, \quad t \in [0, \infty),$$

and denote by  $\mathcal{G}^n$  the filtration generated by the processes  $(\bar{A}_t^n, \bar{B}_t^n, \bar{V}_t^{n,3}(t))$ . Note that the sequence  $(\bar{A}^n, \bar{B}^n, \bar{Y}^n(\phi))$  converges in distribution to  $(A, B, \bar{Y}(\phi))$  where  $\bar{Y}(\phi) := \langle \phi, \bar{V}^3 \rangle$  as a sequence of processes whose sample paths belong to  $\mathcal{D}(0, \infty; \mathbb{R}^3)$ .

We are now going to use Lemma A.2 to verify the claimed form of the quadratic variation. For simplicity, we start with the special case  $l = 1$ . For this, we assume that  $\phi \geq 0$ ; otherwise, we make the decomposition  $\phi = \phi^+ - \phi^-$  and consider  $\phi^+$  and  $\phi^-$ , respectively, just noting that both  $\phi^+$  and  $\phi^-$  belong to  $H^1$ . Let

$$\begin{aligned}
 a_0^n(\phi)(R) &:= \left( \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - R) dx \int_{x_j^n}^{x_{j+1}^n} \phi(x) dx \right)^2 (\Delta x^n)^{-2} E[\omega_1^{\mathbf{N}}]^2, \\
 a_1^n(\phi)(R) &:= \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - R) dx \left| \int_{x_j^n}^{x_{j+1}^n} \phi(x) dx \right|^2 (\Delta x^n)^{-2} E[(\omega_1^{\mathbf{N}})^2], \\
 \sigma^n(\phi)(R) &:= \left( 2a_0^n(\phi)(R) + \frac{1}{n} a_1^n(\phi)(R) \right)^{1/2}.
 \end{aligned}$$

Note that for any deterministic  $y$  and any random variable  $\pi$  with density  $f$ , (7) implies

$$\begin{aligned}
 &E \left[ \int \mathbf{1}_{I^n(y+\pi)}(x) \phi(x) dx \right] \\
 &= \sum_j \int \mathbf{1}_{[x_j^n, x_{j+1}^n]}(y+z) f(z) dz \int \mathbf{1}_{x_j^n, x_{j+1}^n]}(x) \phi(x) dx \\
 &= \sum_j \int \mathbf{1}_{[x_j^n, x_{j+1}^n]}(x) f(x-y) dx \int \mathbf{1}_{x_j^n, x_{j+1}^n]}(x) \phi(x) dx.
 \end{aligned}$$

Since the number of passive order arrivals  $(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n)$  on  $[\frac{k-1}{n}, \frac{k}{n})$  follows a negative binomial distribution  $\text{NB}(1, \frac{\lambda^n}{\lambda^n + \mu^n})$  (see Lemma 3.1), we have [using (12e)]:

$$\begin{aligned}
 &E_{\mathcal{G}_{\frac{k-1}{n}}^n} [ |\bar{Y}_{\frac{k}{n}}^n(\phi) - \bar{Y}_{\frac{k-1}{n}}^n(\phi)|^2 ] \\
 &= \Delta v^n \left\{ E[(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n)(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n - 1)] \right. \\
 &\quad \times \left( \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - \bar{R}_{\frac{k-1}{n}}^n) dx \int_{x_j^n}^{x_{j+1}^n} \phi(x) dx \right)^2 E[\omega_1^{\mathbf{N}}]^2 \\
 &\quad + E[(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n)] \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - \bar{R}_{\frac{k-1}{n}}^n) dx \\
 (20) \quad &\quad \left. \times \left| \int_{x_j^n}^{x_{j+1}^n} \phi(x) dx \right|^2 E[(\omega_1^{\mathbf{N}})^2] \right\} \\
 &= \Delta v^n (\Delta x^n)^2 \left\{ E[(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n)(N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n - 1)] a_0^n(\phi)(\bar{R}_{\frac{k-1}{n}}^n) \right.
 \end{aligned}$$

$$\begin{aligned}
 &+ E[(N_{\tau_k^n}^n - N_{\tau_{k-1}^n}^n)]a_1^n(\phi)(\bar{R}_{\frac{k-1}{n}}^n)\} \\
 &= \frac{1}{n^3}(2n^2a_0^n(\phi) + na_1^n(\phi))(\bar{R}_{\frac{k-1}{n}}^n) \\
 &= \frac{1}{n}(\sigma^n(\phi)(\bar{R}_{\frac{k-1}{n}}^n))^2.
 \end{aligned}$$

Set

$$\sigma(\phi)(R) = \sqrt{2} \int_{\mathbb{R}} f(x - R)\phi(x) dx E[\omega_1^N], \quad t \in [0, \infty).$$

Note that  $\sigma \geq 0$  since  $\phi$  is nonnegative.

(ii) We claim that  $\sigma^n(\phi) \rightarrow \sigma$  uniformly. First, note that  $\|a_1^n(\phi)\|_{L^\infty} \leq \|\phi\|_\infty^2 E[\omega_1^N]$ . Hence,  $\frac{1}{n}a_1^n(\phi) \rightarrow 0$  uniformly, and we may ignore the second term in the definition of  $\sigma^n$ . Further note that

$$\begin{aligned}
 &\left| \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - R) dx \int_{x_j^n}^{x_{j+1}^n} \phi(x) dx \frac{1}{\Delta x^n} - \int_{\mathbb{R}} f(x - R)\phi(x) dx \right| \\
 &\leq \sum_j \int_{x_j^n}^{x_{j+1}^n} f(x - R) \left| \frac{1}{\Delta x^n} \int_{x_j^n}^{x_{j+1}^n} \phi(y) dy - \phi(x) \right| dx.
 \end{aligned}$$

By the mean value theorem, there exists  $y \in [x_j^n, x_{j+1}^n]$  with  $\frac{1}{\Delta x^n} \int_{x_j^n}^{x_{j+1}^n} \phi(y) dy = \phi'(y)$ . For  $x < y$ ,  $|x - y| \leq \Delta x^n$ , we have

$$|\phi(x) - \phi(y)| = \int_{\mathbb{R}} \mathbf{1}_{[x,y]}(z)\phi'(z) dz \leq \sqrt{\Delta x^n} \|\phi\|_{H^1}.$$

Therefore,

$$\|\sigma^n(\phi) - \sigma(\phi)\|_{L^\infty} \leq \sqrt{2} E[\omega_1^N] \sqrt{\Delta x^n} \|\phi\|_{H^1} + o(1),$$

and we have established uniform convergence of  $\sigma^n(\phi)$  to  $\sigma(\phi)$ .

(iii) We need to verify the conditions of Lemma A.2 outlined in Assumption A.1, that is,

$$(A.1) \quad \sup_n \|\sigma^n\|_{L^\infty} < \infty,$$

$$(A.2) \quad E \sum_{k=1}^{\lfloor nt \rfloor + 1} |\bar{Y}_{\frac{k}{n}}^n(\phi) - \bar{Y}_{\frac{k-1}{n}}^n(\phi)|^4 \rightarrow 0,$$

$$(A.3) \quad \sup_n E \left[ \sup_{k \leq \lfloor nt \rfloor} |\bar{Y}_{k/n}^n - \bar{Y}_{(k-1)/n}^n| \right] < \infty.$$

Note that (31) follows immediately from boundedness of  $f^{\mathbf{N}^r}$  and of  $\phi$ . (33) is a direct consequence of Lemma 3.3. As for (32),

$$\begin{aligned} E_{\mathcal{G}_{\frac{k-1}{n}}^n} [|\bar{Y}_{\frac{k}{n}}^n(\phi) - \bar{Y}_{\frac{k-1}{n}}^n(\phi)|^4] &\leq C(\Delta v^n)^2(\Delta x^n)^4 E[|N_{\tilde{\tau}_k^n}^n - N_{\tilde{\tau}_{k-1}^n}^n|^4] \\ &\leq C \frac{1}{n^6} [n^4 + n] \\ &\leq C \frac{1}{n^2}, \end{aligned}$$

where  $C$  is a positive constant which is independent of  $n$  and may vary from line to line. Thus, for any  $t \in (0, \infty)$ ,

$$E \sum_{k=1}^{\lfloor nt \rfloor + 1} |\bar{Y}_{\frac{k}{n}}^n(\phi) - \bar{Y}_{\frac{k-1}{n}}^n(\phi)|^4 \leq C(nt + 1) \frac{1}{n^2} \rightarrow 0 \quad \text{as } n \rightarrow \infty.$$

(iv) The previous arguments easily extend to the finite dimensional case. For each  $l \in \mathbb{N}^+$  and any family of nonnegative functions  $\phi_1, \dots, \phi_l$ , the process  $(\bar{Y}^n(\phi_1), \dots, \bar{Y}^n(\phi_l))$  converges jointly to  $(\bar{Y}(\phi_1), \dots, \bar{Y}(\phi_l))$  in distribution. We compute for  $i, j = 1, \dots, l$ ,

$$\begin{aligned} E_{\mathcal{G}_{\frac{k-1}{n}}^n} [(\bar{Y}_{\frac{k}{n}}^n(\phi_j) - \bar{Y}_{\frac{k-1}{n}}^n(\phi_j))(\bar{Y}_{\frac{k}{n}}^n(\phi_i) - \bar{Y}_{\frac{k-1}{n}}^n(\phi_i))] \\ = \frac{(\sigma^n(\phi_j + \phi_i))^2 - (\sigma^n(\phi_j - \phi_i))^2}{4n} (\bar{R}_{\frac{k-1}{n}}^n) \\ = \frac{1}{n} \sigma^n(\phi_j) \sigma^n(\phi_i) (\bar{R}_{\frac{k-1}{n}}^n). \end{aligned}$$

Since  $\mathcal{E}$  is dense in  $H^1$ , this completes the proof.  $\square$

The previous proposition characterizes the quadratic variation of the limiting volume density processes. Next, we are going to study the limiting dynamics of aggregate order placements and cancellations, disregarding the random fluctuations. As we expect order placements and cancellations to contribute to the drift part of the limiting model, we find it helpful to rewrite their dynamics in the form of an integral in time. That is, if we write

$$\begin{aligned} \bar{V}^{n,2}(t, x) &= \int_0^{\lfloor nt \rfloor} g^n(s, x) ds, \\ \bar{V}^{n,1}(t, x) &= \int_0^{\lfloor nt \rfloor} \tilde{g}^n(s, x) ds, \end{aligned}$$

it is clear that we can identify the limiting drift term by studying the limits of  $g^n$  and  $\tilde{g}^n$ . Comparing with (12), we have

$$g^n(t, x) := \sum_{k=1}^{\infty} \sum_{i=N^n(\tilde{\tau}_{k-1}^n)+1}^{N^n(\tilde{\tau}_k^n)} \mathbf{1}_{I^n(\pi_i^C + \bar{R}_{\frac{k-1}{n}}^n)}(x) \omega_i^C \mathbf{1}_{[\frac{k}{n}, \frac{k+1}{n})}(t) \frac{\Delta v^n}{\Delta x^n} n,$$

$$\tilde{g}^n(t, x) := \sum_{k=1}^{\infty} \sum_{i=N^n(\tilde{\tau}_{k-1}^n)+1}^{N^n(\tilde{\tau}_k^n)} \mathbf{1}_{(\pi_i^P + \bar{R}_{\frac{k-1}{n}}^n)}(x) \omega_i^P \mathbf{1}_{[\frac{k}{n}, \frac{k+1}{n})}(t) \frac{\Delta v^n}{\Delta x^n} n.$$

With regards to aggregate cancellations,  $g^n$  only captures the proportionality of cancellations in terms of present volume. Therefore, we need to introduce another term  $\bar{g}^n$  describing the actual cancellations, that is,

$$\bar{v}^n(t, x) - v(0, x) - \bar{V}^{n,1}(t, x) - \bar{V}^{n,3}(t, x) = \int_0^{\lfloor \frac{nt}{n} \rfloor} \bar{g}^n(s, x) ds.$$

Clearly,  $\bar{g}^n$  is given by

$$\bar{g}^n(t, x) := \sum_{k=1}^{\infty} \sum_{i=N^n(\tilde{\tau}_{k-1}^n)+1}^{N^n(\tilde{\tau}_k^n)} \mathbf{1}_{I^n(\pi_i^C + \bar{R}_{\frac{k-1}{n}}^n)}(x) \omega_i^C v^n(\tau_{i-1}^n, x) \mathbf{1}_{[\frac{k}{n}, \frac{k+1}{n})}(t) \frac{\Delta v^n}{\Delta x^n} n.$$

We will analyze the impact of order cancellations in the limit in two steps: first we show that we can replace  $\bar{g}^n$  by the (much simpler) expression  $g^n \bar{v}^n$  in the limit (see Lemma 3.10). Then we characterize the limit of the latter term in the appropriate sense (see Lemma 3.11, where we also characterize the limiting object of the order placements).

REMARK 3.9. From the proof of Lemma 3.2, it follows that, for  $p \in \{2, 4\}$ ,

$$E[\|g^n(t)\|_{L^p}^p] + \sup_{x \in \mathbb{R}} E_{\mathcal{F}_t^n} E[|g^n(t, x)|^p] \leq C,$$

which implies that

$$\sup_{x \in \mathbb{R}} E \int_0^t |g^n(s, x)|^p ds + E \int_{\mathbb{R}} \int_0^t |g^n(s, x)|^p ds dx \leq Ct,$$

with the constants  $C$  being independent of  $n$  and  $t$ .

LEMMA 3.10. For any  $t > 0$ , we have

$$(21) \quad \lim_{n \rightarrow \infty} E \left[ \int_{\mathbb{R}} \int_0^{\lfloor \frac{nt}{n} \rfloor} |\bar{g}^n(s, x) - g^n(s, x) \bar{v}^n(s, x)|^2 ds dx \right] = 0.$$

PROOF. Using Fubini’s theorem and Remark 3.5 we have

$$\begin{aligned}
 & E \int_{\mathbb{R}} \int_0^{\lfloor \frac{nt}{n} \rfloor} |\bar{g}^n(s, x) - g^n(s, x) \bar{v}^n(s, x)|^2 ds dx \\
 &= \int_0^{\lfloor \frac{nt}{n} \rfloor} E \int_{\mathbb{R}} \left| \sum_{k \in \mathbb{N}^+} \sum_{i=N^n(\bar{\tau}_{k-1}^n)+1}^{N^n(\bar{\tau}_k^n)} \mathbf{1}_{I^n(\tau_i^C + \bar{R}_{\frac{k}{n}})}(x) \right. \\
 &\quad \times \omega_i^C(v^n(\tau_{i-1}^n, x) - \bar{v}^n(s, x)) \mathbf{1}_{[\frac{k}{n}, \frac{k+1}{n})}(s) \frac{\Delta v^n}{\Delta x^n n^{-1}} \left. \right|^2 dx ds \\
 &\leq \int_0^{\lfloor \frac{nt}{n} \rfloor} \sum_{k \in \mathbb{N}^+ \cup \{0\}} \mathbf{1}_{[\frac{k}{n}, \frac{k+1}{n})}(s) \left( E \int_{\mathbb{R}} |g^n(s, x)|^4 dx \right)^{1/2} \\
 &\quad \times \left( E \sup_{i \in [N^n(\bar{\tau}_{k-1}^n), N^n(\bar{\tau}_k^n)] \cap \mathbb{N}^+} \|v^n(\tau_i) - v^n(\bar{\tau}_{k-1}^n)\|_{L^4}^4 \right)^{1/2} ds \\
 &\leq C \frac{1}{\sqrt{n}} \int_0^{\lfloor \frac{nt}{n} \rfloor} \left( E \int_{\mathbb{R}} |g^n(s, x)|^4 dx \right)^{1/2} ds \\
 &\leq C \frac{1}{\sqrt{n}} \left( E \int_0^{\lfloor \frac{nt}{n} \rfloor} \int_{\mathbb{R}} |g^n(s, x)|^4 dx \right)^{1/2},
 \end{aligned}$$

which by Remark 3.9 converges to zero as  $n$  tends to infinity.  $\square$

We can now analyze the limiting objects obtained from order placements and cancellations. The proof of Lemma 3.11 is technical and rather long and hence postponed to Appendix B.

LEMMA 3.11. For any  $t = \frac{\lfloor nt \rfloor}{n}$  with  $n \in \mathbb{N}$ ,

$$\begin{aligned}
 (22) \quad \forall \alpha \in \{0, 1\}: \quad & \lim_{n \rightarrow \infty} \sup_{x \in \mathbb{R}} E \left[ \left| \int_0^t (g^n(s, x) - E[\omega_1^C] f^C(x - R_s)) \right. \right. \\
 & \quad \left. \left. \times (1 - \alpha + \alpha \bar{v}^n(s, x)) ds \right|^2 \right] = 0,
 \end{aligned}$$

$$(23) \quad \lim_{n \rightarrow \infty} \sup_{x \in \mathbb{R}} E \left[ \left| \int_0^t (\tilde{g}^n(s, x) - E[\omega_1^P] f^P(x - R_s)) ds \right|^2 \right] = 0.$$

Combining the characterization of the limit of the fluctuation part of  $\bar{v}_t^n$  obtained in Proposition 3.8 with the characterization of the limits of order cancellations and placements obtained in Lemma 3.11 together with Lemma 3.10, we are in the position to study the limit of  $\bar{v}^n$  itself.

**THEOREM 3.12.** *Suppose that (along a properly chosen subsequence)  $(\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3}, \bar{v}_r^n) \Rightarrow (A, B, V_r^3, v_r)$ , where  $(A, B)$  is the (not yet identified) limit of  $(A^n, B^n)$  (along the chosen subsequence) and  $V_r^3$  the limit obtained in Proposition 3.8. Then*

$$v_r(t, \cdot) = v_r(0, \cdot) + \int_0^t (E[\omega_1^P]f^P(\cdot - R_s) - E[\omega_1^C]f^C(\cdot - R_s)v_r(s, \cdot)) ds + V_r^3(t, \cdot), \quad t \geq 0,$$

and  $V_r^3$  remains a martingale under the filtration generated by  $(A, B, v_r, V_r^3)$ .

**PROOF.** First, note that the  $v_r$  is already measurable w.r.t.  $R$  and  $V_r^3$ , hence the filtration does not change when  $v_r$  is added and  $V_r^3$  trivially stays a martingale.

The sequence of price processes is  $C$ -tight and converges in distribution to some limit  $(A, B)$  along a subsequence. The processes  $\bar{V}_r^{n,3}$  and  $\bar{v}_r^n$  are tight, due to Proposition 3.6 and  $\bar{V}_r^{n,3}$  is even  $C$ -tight, due to Proposition 3.8. Hence, the sequence  $(\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3}, \bar{v}_r^n)$  is tight as a sequence of processes with sample paths in  $\mathcal{D}(0, \infty; \mathbb{R}^2 \times H^{-1} \times H^{-1})$ . In order to identify the limit of  $\bar{v}_r^n$  as a function of the (existing, yet still to be identified) limit of the price process, we use the additive decomposition

$$(24) \quad \begin{aligned} \bar{v}_r^n(t, x) - v_r^n(0, x) &= \bar{V}_r^{n,1}(t, x) + \tilde{V}_r^{n,2}(t, x) + \bar{V}_r^{n,3}(t, x), \quad (t, x) \in [0, \infty) \times \mathbb{R}, \end{aligned}$$

where

$$\tilde{V}_r^{n,2}(t, x) := \int_0^{\lfloor nt \rfloor} \bar{g}^n(s, x) ds.$$

In view of Skorohod’s lemma (see Lemma C.6), we may w.l.o.g. assume that all processes are defined on a common probability space  $(\Omega, \mathcal{F}, \mathbb{P})$  such that, for some process  $v_r$  to be determined, the sequence  $(\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3}, \bar{v}_r^n)$  converges almost surely to some limit  $(A, B, V_r^3, v_r)$  as a sequence of processes with sample paths in  $\mathcal{D}(0, \infty; \mathbb{R}^2 \times H^{-1} \times H^{-1})$ . In particular, and this will be used below, as a sequence in  $\mathbb{R}^2 \times H^{-1} \times H^{-1}$ ,

$$\lim_{n \rightarrow \infty} (\bar{A}^n, \bar{B}^n, \bar{V}_r^{n,3}, \bar{v}_r^n) = (A, B, V_r^3, v_r) \quad \mathbb{P} \otimes dt\text{-a.e.}$$

Indeed, taking  $\bar{v}_r^n$ , for example, the sample paths are càdlàg, and hence they have at most countably many discontinuities. For almost all  $\omega \in \Omega$ , the convergence  $\lim_{n \rightarrow \infty} \|\bar{v}_r^n(t, \cdot) - v_r(t, \cdot)\|_{H^{-1}}^2 = 0$  at each point of continuity can be derived in a similar way to [17], Proposition VI.1.17. Then dominated convergence yields

$$\lim_{n \rightarrow \infty} E \int_0^T \|\bar{v}_r^n(t, \cdot) - v_r(t, \cdot)\|_{H^{-1}}^2 \wedge 1 dt = 0 \quad \text{for all } T > 0.$$

This allows us to choose a subsequence that is converging a.e. in  $H^{-1}$ .

Operating in the probability space  $(\Omega, \mathcal{F}, \mathbb{P})$ , the decomposition (24) of the volume process shows that we need to identify the limit of  $\tilde{V}^{n,2}$  in order to identify that of  $\bar{v}_a^n$ . For this, we first show that it is enough to identify weak limits in the Hilbert space  $L^2(\Omega \times [0, T] \times \mathbb{R})$  for arbitrary  $T > 0$ . In fact, by Lemma 3.4 the sequence  $\bar{v}_r^n$  is uniformly bounded in  $L^2(\Omega \times [0, T] \times \mathbb{R})$ . By Lemma 3.2 and Lemma 3.3 the same applies to  $\bar{V}^{n,1}$  and  $\bar{V}^{n,3}$ . Hence, the sequence  $(\bar{v}^n, \bar{V}^{n,1}, \bar{V}^{n,3})$  has a weak accumulation point in  $L^2(\Omega \times [0, T] \times \mathbb{R})$ . By the Banach–Saks theorem, the weak accumulation point is a strong limit in Cesaro sense of a subsequence. Since  $L^2(\Omega \times [0, T] \times \mathbb{R}) \subset L^2(\Omega \times [0, T]; H^{-1})$ , this shows that the weak limit coincides with  $(v_r, V^1, V^3)$  as a weak limit in  $L^2(\Omega \times [0, T] \times \mathbb{R})$ . As a result, it is enough to identify the weak limit  $K$  of  $\tilde{V}_r^{n,2}$  in  $L^2(\Omega \times [0, T] \times \mathbb{R})$ . By Lemma 3.10 and 3.11, this is equivalent to identifying the weak limit of the process

$$(t, x) \mapsto \int_0^t E[\omega_1^C] f^C(x - R_s) \bar{v}_r^n(s, x) ds.$$

In order to identify  $K$ , we test against test functions  $\psi \in L^\infty(\Omega \times [0, T])$  and  $\phi \in L^2(\mathbb{R})$ . Weak convergence of  $\bar{v}^n$  and  $\tilde{V}^{n,2}$  in  $L^2(\Omega \times [0, T] \times \mathbb{R})$  yields that

$$\begin{aligned} & E \int_0^T \int_{\mathbb{R}} \psi(t) K(t, x) \phi(x) dx dt \\ &= \lim_{n \rightarrow \infty} E \int_0^T \psi(t) \langle \tilde{V}_r^{n,2}(t), \phi \rangle dt \\ &= \lim_{n \rightarrow \infty} E \int_0^T \psi(t) \int_0^{\lfloor nt \rfloor} \int_{\mathbb{R}} \bar{g}^n(s, x) \phi(x) dx ds dt \\ &\quad \text{(by Lemma 3.10)} \\ &= \lim_{n \rightarrow \infty} E \int_0^T \psi(t) \int_0^{\lfloor nt \rfloor} \int_{\mathbb{R}} g^n(s, x) \bar{v}_r^n(s, x) \phi(x) dx ds dt \\ &\quad \text{(by Lemma 3.11)} \\ &= E[\omega_{r,1}^C] \lim_{n \rightarrow \infty} E \int_0^T \psi(t) \int_0^{\lfloor nt \rfloor} \int_{\mathbb{R}} f^C(x - R_s) \bar{v}_r^n(s, x) \phi(x) dx ds dt \\ &= E[\omega_{r,1}^C] \lim_{n \rightarrow \infty} E \int_0^T \int_{\mathbb{R}} f^C(x - R_s) \bar{v}_r^n(s, x) \phi(x) dx \\ &\quad \times E_{\mathcal{F}_{\lfloor ns \rfloor/n}} \left[ \int_{\lfloor ns \rfloor/n}^T \psi(t) dt \right] ds \\ &\quad \text{(by the weak convergence in Hilbert space)} \end{aligned}$$



$$\begin{aligned}
 &= E[\omega_{r,1}^{\mathbf{C}}] E \int_0^T \int_{\mathbb{R}} f^{\mathbf{C}}(x - R_s) v_r(s, x) \phi(x) dx E_{\overline{\mathcal{F}}_s} \left[ \int_s^T \psi(t) dt \right] ds \\
 &= E[\omega_{r,1}^{\mathbf{C}}] E \int_0^T \psi(t) \int_0^t \int_{\mathbb{R}} f^{\mathbf{C}}(x - R_s) v_r(s, x) \phi(x) dx ds dt,
 \end{aligned}$$

where  $\overline{\mathcal{F}}_t$  denotes the filtration generated by all the processes  $\overline{A}^n, \overline{B}^n, A, B, \overline{v}_r^n$  and  $v_r$ . Since  $\phi \in L^2$  and  $\psi \in L^\infty(\Omega \times [0, T])$  are arbitrary, we get

$$K(t, x) = E[\omega_1^{\mathbf{C}}] \int_0^t f^{\mathbf{C}}(x - R_s) v_r(s, x) ds$$

for almost every  $(t, \omega, x) \in [0, T] \times \Omega \times \mathbb{R}$ . Hence, the limit  $v_r$  satisfies

$$\begin{aligned}
 v_r(t, \cdot) &= v_r(0, \cdot) + \int_0^t (E[\omega_1^{\mathbf{P}r}] f^{\mathbf{P}r}(\cdot - R_s) - E[\omega_1^{\mathbf{C}r}] f^{\mathbf{C}r}(\cdot - R_s) v_r(s, \cdot)) ds \\
 &\quad + V_r^3(t, \cdot), \quad t \geq 0. \quad \square
 \end{aligned}$$

3.3. *The limit of the volume density.* With tightness of the sequence of auxiliary processes  $\overline{v}_r^n$  established in Proposition 3.6, we can now turn to the actual volume densities  $v_r^n$ . To this end, we introduce the processes

$$\widehat{v}_r^n(u) := \overline{v}_r^n \circ \eta_u^n, \quad \widehat{V}_r^{n,i}(u) := \overline{V}_r^{n,i} \circ \eta_u^n \quad (r = a, b; i = 1, 2, 3),$$

where the time-change  $\eta_u^n$  was defined in (11). In view of Kurtz’s [21] strong approximation result for Poisson processes by Brownian motion, for any  $T > 0$

$$\lim_{n \rightarrow \infty} \sup_{0 \leq t \leq T} |\eta_t^n - t| = 0 \quad \mathbb{P}\text{-a.s.}$$

As a result, Lemma C.5 and Theorem 3.12 imply that the limit of  $(A^n, B^n, \widehat{v}_r^n)$  coincides with that of  $(\overline{A}^n, \overline{B}^n, \overline{v}_r^n)$ , namely  $(A, B, v_r)$  of Theorem 3.12.

Let  $\delta v_r^n := v_r^n - \widehat{v}_r^n$  and  $\delta V_r^{n,i} := V_r^{n,i} - \widehat{V}_r^{n,i}$  ( $i = 1, 2, 3$ ). Our goal is to prove that  $\delta v_r^n$  converges weakly to 0 as  $n \rightarrow \infty$ . We shall then deduce that convergence of  $\widehat{v}^n$  implies convergence of  $v^n$ . The first step is to establish moment estimates for the processes  $V^{n,i}$  ( $i = 1, 2, 3$ ) similar to Lemmas 3.3 and 3.4. Analogous to Proposition 3.6 these estimates indicate tightness of  $v_r^n$ , and thus the tightness of  $(A^n, B^n, v_r^n)$ . The rather technical proof is deferred to Appendix B.

LEMMA 3.13. *For  $r = a, b$  and  $i = 1, 2, 3$ , it holds that*

$$\begin{aligned}
 E_{\mathcal{F}_s^n} \left[ \sum_{i=1}^3 \|V_r^{n,i}(t) - V_r^{n,i}(s)\|_{L^2}^2 \right] &\leq C_s^n [(t - s) + (t - s)^2], \quad 0 \leq s \leq t < \infty, \\
 E_{\mathcal{F}_s^n} [\|v_r^n(t) - v_r^n(s)\|_{L^2}^2] &\leq C_s^n [(t - s) + (t - s)^2], \quad 0 \leq s \leq t < \infty,
 \end{aligned}$$

with  $\sup_n E[\sup_{s \in [0,t]} C_s^n] \leq C(t^2 + t)$ ,  $t \in [0, \infty)$ , where the constant  $C$  is independent of  $n, s$  and  $t$ .

Furthermore, we will show that  $\delta v_r^n(t)$  converges point-wise to 0 in an  $L^2$ -sense for which we need some elementary results on Poisson processes.

LEMMA 3.14. *Let  $N_1$  and  $N_2$  be two independent Poisson processes with intensities  $\lambda_1$  and  $\lambda_2$ , respectively. Moreover, let  $T_i, i = 1, \dots$ , denote the jump times of the Poisson process  $N_1$ . Then we have*

$$E[N_2(t) - N_2(T_{N_1(t)})] = \frac{\lambda_2}{\lambda_1}(1 - e^{-\lambda_1 t}),$$

$$E[(N_2(t) - N_2(T_{N_1(t)}))(N_2(t) - N_2(T_{N_1(t)}) - 1)] = 4 \frac{\lambda_2^2}{\lambda_1^2}(1 - (1 + t\lambda_1)e^{-\lambda_1 t}).$$

PROOF. Notice that conditional on  $N_1(t) = l$ , the relative difference  $(t - T_l)/t$  has a beta distribution with parameters 1 and  $l$ , as this is the distribution of the differences in the order statistics of  $l$  random variables distributed uniformly on  $[0, 1]$ . Hence, elementary calculations give

$$E[N_2(t) - N_2(T_l) | N_1(t) = l] = \sum_{k=0}^{\infty} k \int_0^1 e^{-\lambda_2 t x} \frac{(\lambda_2 t x)^k}{k!} \frac{1-x}{B(1, l)} dx = \frac{\lambda_2 t}{1+l}$$

and

$$E[(N_2(t) - N_2(T_l))(N_2(t) - N_2(T_l) - 1) | N_1(t) = l]$$

$$= \sum_{k=0}^{\infty} k(k-1) \int_0^1 e^{-\lambda_2 t x} \frac{(\lambda_2 t x)^k}{k!} \frac{1-x}{B(1, l)} dx$$

$$= \frac{2\lambda_2^2 t^2}{2 + 3l + l^2}.$$

Multiplying these terms with  $P(N_1(t) = l) = e^{-\lambda_1 t} \frac{(\lambda_1 t)^l}{l!}$  and summing over  $l$  gives the formulas from above.  $\square$

LEMMA 3.15. *Let  $u = u(t) = u(t, x)$  denote any of the processes  $\delta v_r^n, \delta V_r^{n,i}, i = 1, 2, 3$ . Moreover, assume that the sequence  $v_r^n(0)$  is uniformly bounded in  $L^2$ . Then there is a constant  $C$  independent of  $n$  or  $t$  such that*

$$E[\|u(t)\|_{L^2}^2] \leq C \frac{1}{n}(1 + t + t^2), \quad \forall t \in [0, \infty).$$

PROOF. Let us first consider  $u = \delta V_r^{n,i}$  for some  $i = 1, 2, 3, r = a, b$ . Note that for some random variables  $\omega_i$  and  $\pi_i$  we have for some scaling constant  $\varepsilon$  (either equal to  $\Delta v / \Delta x$  or equal to  $\sqrt{\Delta v}$ )

$$u(t, x)^2 = \left( \sum_{i=N(\tilde{\tau}_{N(t)})}^{N(t)} \mathbf{1}_{I(R^n(\tilde{\tau}_{N(t)} + \pi_i)(x))} \omega_i \right)^2 \varepsilon^2,$$

as  $\tilde{\xi}_{r,i}$  is constant in  $i$  and  $\tilde{\xi}_{r,i}^2 = 1$ . Letting  $\mathcal{G}$  denote the  $\sigma$ -algebra generated by all sources of randomness *except*  $(\omega_i)_{i \in \mathbb{N}^+}$ , we have

$$\begin{aligned} & E[u(t, x)^2] \\ &= E \left[ \left\{ \sum_{i \neq i' = N(\tilde{\tau}_{\tilde{N}(t)})}^{N(t)} E_{\mathcal{G}}[\omega_i \omega_{i'}] \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_i)}(x)} \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_{i'})}(x)} \right. \right. \\ &\quad \left. \left. + \sum_{i=N(\tilde{\tau}_{\tilde{N}(t)})}^{N(t)} E_{\mathcal{G}}[\omega_i^2] \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_i)}(x)} \right\} \right] \varepsilon^2 \\ &= E \left[ \left\{ \sum_{i \neq i' = N(\tilde{\tau}_{\tilde{N}(t)})}^{N(t)} \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_i)}(x)} \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_{i'})}(x)} E[\omega_1]^2 \right. \right. \\ &\quad \left. \left. + \sum_{i=N(\tilde{\tau}_{\tilde{N}(t)})}^{N(t)} \mathbf{1}_{I(R^n(\tilde{\tau}_{\tilde{N}(t)}) + \pi_i)}(x)} E[\omega_1^2] \right\} \right] \varepsilon^2. \end{aligned}$$

Furthermore, conditioning on the  $\sigma$ -algebra generated by all sources of randomness *except* for  $(\pi_i)_{i \in \mathbb{N}^+}$ , we can bound in a similar way to (13)

$$\begin{aligned} & E[u(t, x)^2] \\ &\leq E \left[ E[\omega_1]^2 \|f\|_{L^\infty}^2 \Delta x^2 (N(t) - N(\tilde{\tau}_{\tilde{N}(t)}))(N(t) - N(\tilde{\tau}_{\tilde{N}(t)}) - 1) \right. \\ &\quad \left. \times \mathbf{1}_{[R(\tilde{\tau}_{\tilde{N}(t)}) - M, R(\tilde{\tau}_{\tilde{N}(t)}) + M]}(x)} \right. \\ &\quad \left. + E[\omega_1^2] \|f\|_{L^\infty}^2 \Delta x (N(t) - N(\tilde{\tau}_{\tilde{N}(t)})) \mathbf{1}_{[R(\tilde{\tau}_{\tilde{N}(t)}) - M, R(\tilde{\tau}_{\tilde{N}(t)}) + M]}(x)} \right] \varepsilon^2. \end{aligned}$$

Hence, plugging in Lemma 3.14, we obtain

$$\begin{aligned} E[\|u(t)\|_{L^2}^2] &\leq C(\Delta x^2 E[(N(t) - N(\tilde{\tau}_{\tilde{N}(t)}))(N(t) - N(\tilde{\tau}_{\tilde{N}(t)}) - 1)] \\ &\quad + \Delta x E[(N(t) - N(\tilde{\tau}_{\tilde{N}(t)}))]) \varepsilon^2 \\ &= C \left( \Delta x^2 4 \frac{\lambda^2}{\mu^2} [1 - (1 + t\mu)e^{-\mu t}] + \Delta x \frac{\lambda}{\mu} [1 - e^{-\mu t}] \right) \varepsilon^2 \\ &\leq C \left( \frac{1}{n} \frac{n^4}{n^2} + \frac{1}{\sqrt{n}} \frac{n^2}{n} \right) \varepsilon^2 \\ &= C(n + \sqrt{n}) \varepsilon^2. \end{aligned}$$

Now we recall that  $\varepsilon^2 = \frac{\Delta v^2}{\Delta x^2} = n^{-3}$  in case  $i = 1, 2$  and  $\varepsilon^2 = \Delta v = n^{-2}$  in case  $i = 3$ .

The proof for the estimate of  $\delta v_r^n$  works in precisely the same way as the proof of Lemma 3.4, taking into account the appropriate estimates for  $\delta V_r^{n,i}$  derived above.  $\square$

Combining these lemmas with the results in Theorem 3.12, we can now prove convergence of the volume densities. We denote by  $(A, B)$  an accumulation point of the sequence of price processes. Ex post, we shall see that the limit is unique, and hence we do not actually need to work with such a subsequence.

**THEOREM 3.16.** *The sequence of processes  $(A^n, B^n, v_a^n, v_b^n)$  is tight. Given a subsequence such that  $(A^n, B^n, v_a^n, v_b^n) \Rightarrow (A, B, v_a, v_b)$  for some volume processes  $v_a$  and  $v_b$ . Then*

$$(25) \quad \begin{aligned} v_r(t, \cdot) &= v_{r,0}(\cdot) + \int_0^t (E[\omega_1^{Pr}]f^{Pr}(\cdot - R_s) - E[\omega_1^{Cr}]f^{Cr}(\cdot - R_s)v_r(s, \cdot)) ds \\ &+ V_r^3(t, \cdot), \quad t \geq 0. \end{aligned}$$

$V_a^3$  and  $V_b^3$  are martingales w.r.t. the filtration generated by  $(A, B, v_a, v_b)$ , and their quadratic covariance diagonalizes. More precisely, given test functions  $\phi_a^1, \dots, \phi_a^l, \phi_b^1, \dots, \phi_b^k \in \mathcal{E}$ , then for any  $1 \leq i \leq l, 1 \leq j \leq k$  we have

$$[(\phi_a^i, V_a^3), (\phi_b^j, V_b^3)]_t = 0, \quad t \geq 0.$$

**PROOF.** Recall that

$$(A^n, B^n, \widehat{v}_a^n)(u) = (\overline{A}^n, \overline{B}^n, \overline{v}_a^n) \circ \eta_u^n.$$

Since the time change process converges almost surely to the identity uniformly on compact time intervals, it follows from Lemma C.5 and Theorem 3.12 that  $(A^n, B^n, \widehat{v}_a^n) \Rightarrow (A, B, v_a)$ . On the other hand, in a similar way to Proposition 3.6 we derive from Lemma 3.13 the tightness of  $(A^n, B^n, v_a^n)$ . Additionally, Lemma 3.15 implies that the limit of  $(A^n, B^n, v_a^n)$  coincides with that of  $(A^n, B^n, \widehat{v}_a^n)$ , namely  $(A, B, v_a)$ . This implies the  $C$ -tightness of  $(A^n, B^n, v_a^n)$  and thus the tightness of  $(A^n, B^n, v_a^n, v_b^n)$  by Corollary C.4. Finally, we verify that  $(A^n, B^n, v_a^n, v_b^n) \Rightarrow (A, B, v_a, v_b)$  as in Theorem 3.12, that is, by once more referring to Lemma A.2. The diagonalization of the quadratic covariation in the limit is clear as the quadratic covariation is diagonal at each level  $n$ .  $\square$

**4. Characterization of the limit price process—proof of the main theorem.** So far, we have shown that the sequence of processes  $(B^n, A^n, v_a^n, v_b^n)$  is  $C$ -tight. As  $Y^{r,n}$  is a continuous function of  $v^{r,n}$  together with  $R^n$ , it follows that  $(B^n, A^n, v_a^n, v_b^n, Y^{a,n}, Y^{b,n})$  is tight, as well. As a result, any accumulation point  $(Y^r)$  of  $(Y^{r,n})$  is of the form

$$(26) \quad Y_t^r = \langle v_r(t, \cdot), \phi^r(\cdot - R_t) \rangle,$$

where  $(A, B)$  is a weak accumulation point of the sequence of price processes. In this section, we first characterize the process  $(A, B)$ ; then we characterize the full limiting dynamics and prove convergence to a unique limit.

4.1. *Convergence of the limiting price process.* In order to characterize the limiting price dynamics notice that the price processes satisfy

$$\begin{aligned}
 \bar{R}_t^n &= R_0^n + \Delta x^n \sum_{i=1}^{\lfloor nt \rfloor} \xi_{r,i}^n \\
 &= R_0^n + \int_0^t b_r(\bar{B}_s^n, \bar{A}_s^n, \bar{Y}_s^{b,n}, \bar{Y}_s^{a,n}) ds + M_r^n(t) + S_r^n(t),
 \end{aligned}
 \tag{27}$$

with

$$\begin{aligned}
 M_r^n(t) &:= \Delta x^n \sum_{i=1}^{\lfloor nt \rfloor} (\xi_{r,i}^n - E_{\mathcal{F}_{\frac{i-1}{n}}} \xi_{r,i}^n), \\
 S_r^n(t) &:= \int_0^t b_r^n(\bar{B}_{s-}^n, \bar{A}_{s-}^n, \bar{Y}_{s-}^{b,n}, \bar{Y}_{s-}^{a,n}) ds - \int_0^t b_r(\bar{B}_s^n, \bar{A}_s^n, \bar{Y}_s^{b,n}, \bar{Y}_s^{a,n}) ds.
 \end{aligned}$$

Denoting  $\bar{Z}_s^n := (\bar{B}_s^n, \bar{A}_s^n, \bar{Y}_s^{b,n}, \bar{Y}_s^{a,n})$ , we have

$$\begin{aligned}
 E[|S_r^n(t)|^2] &\leq CE \left[ \left| \int_0^t (b_r^n(\bar{Z}_{s-}^n) - b_r(\bar{Z}_{s-}^n)) ds \right|^2 \right] \\
 &\quad + CE \left[ \left| \int_0^t (b_r(\bar{Z}_{s-}^n) - b_r(\bar{Z}_s^n)) ds \right|^2 \right] + o(1) \\
 &\leq C \|b_r^n - b_r\|_{L^\infty}^2 + o(1),
 \end{aligned}$$

where in view of the fact  $b_r \in C(\mathbb{R}^4; \mathbb{R})$  and the continuity of limit process  $(B, A, Y^b, Y^a)$ , we apply dominated convergence theorem to the second term on the right-hand side of the first inequality. In view of Assumption 2.3, this implies  $\lim_{n \rightarrow \infty} E|S_r^n(t)|^2 = 0$  for any  $t > 0$ . By Lemma A.2, the martingale  $M_r^n$  converges in distribution to a martingale  $M_r$  ( $r = a, b$ ) with quadratic covariation

$$\begin{aligned}
 [(M^b, M^a)]_t &= \begin{pmatrix} \int_0^t |\sigma_b(B_s, A_s, Y_s^b, Y_s^a)|^2 ds & \int_0^t \sigma_a \sigma_b^\top(B_s, A_s, Y_s^b, Y_s^a) ds \\ \int_0^t \sigma_a \sigma_b^\top(B_s, A_s, Y_s^b, Y_s^a) ds & \int_0^t |\sigma_a(B_s, A_s, Y_s^b, Y_s^a)|^2 ds \end{pmatrix}, \\
 & \tag{28} \hspace{20em} t \geq 0.
 \end{aligned}$$

Indeed, condition (31) of the lemma is true by Assumption 2.3, whereas condition (32) is clear from the scaling  $\Delta x^n = 1/\sqrt{n}$ . Finally, (33) is trivial as the jumps are even uniformly bounded.

Since we have joint tightness of the drift and the martingale part in (27), we conclude that the limiting price process must be of the form

$$(29) \quad \begin{aligned} A_t &= A_0 + \int_0^t b_a(B_s, A_s, Y_s^b, Y_s^a) ds + M_t^a, \\ B_t &= B_0 + \int_0^t b_b(B_s, A_s, Y_s^b, Y_s^a) ds + M_t^b, \quad t \geq 0. \end{aligned}$$

4.2. *Characterization of the limiting dynamics.* It remains to characterize the full limiting dynamics. As the respective bounded variation parts have already been determined, we need to prove that the martingale parts can be represented in terms of four independent Brownian motions. To this end, we fix finitely many test function  $\phi_a^1, \dots, \phi_a^m, \phi_b^1, \dots, \phi_b^l$ , and consider the vector of processes

$$(\bar{B}^n, \bar{A}^n, \langle \bar{v}_a^n, \phi_a^1 \rangle, \dots, \langle \bar{v}_a^n, \phi_a^m \rangle, \langle \bar{v}_b^n, \phi_b^1 \rangle, \dots, \langle \bar{v}_b^n, \phi_b^l \rangle)$$

along with a weak accumulation point

$$(B, A, \langle v_a, \phi_a^1 \rangle, \dots, \langle v_a, \phi_a^m \rangle, \langle v_b, \phi_b^1 \rangle, \dots, \langle v_b, \phi_b^l \rangle).$$

Since  $\bar{Y}^{b,n}$  and  $\bar{Y}^{a,n}$  are obtained by integrating the volume densities against test functions, there is no loss in generality in not including them in the above vector. There is also no loss in generality in assuming that all test functions are strictly positive.

Let  $Z_r^i$  denote the martingale part of the process  $\langle v_r, \phi_r^i \rangle$ . From Proposition 3.8, Theorem 3.16 and the independence of the Poisson processes  $N^n$  and  $\tilde{N}_r^n$  ( $r = a, b$ ) we conclude that for  $r, \tilde{r} \in \{a, b\}$ ,

$$(30) \quad \begin{aligned} [Z_r^i, Z_{\tilde{r}}^j]_t &= \int_0^t \sigma(\phi_r^i)(R_s) \sigma(\phi_{\tilde{r}}^j)(R_s) ds, \\ [Z_a^i, Z_b^j]_t &= 0, \quad [Z_r^i, M^{\tilde{r}}]_t = 0, \quad t \geq 0. \end{aligned}$$

The covariance structure of the martingale parts is as in Corollary A.3 with  $F_t$  being the matrix with rows  $\sigma_a(B_t, A_t, Y_t^b, Y_t^a)$  and  $\sigma_b(B_t, A_t, Y_t^b, Y_t^a)$ ,  $\sigma_t^i := \sigma(\phi_a^i)(A_t)$ , and  $\tau_t^j := \sigma(\phi_b^j)(B_t)$ . Since the test functions are strictly positive, we conclude from that corollary that there exist independent Wiener processes  $\tilde{W}$ ,  $W_a$  and  $W_b$  ( $\tilde{W}$  being two-dimensional) such that the weak accumulation point has the same distribution as the the system of coupled SDEs

$$\begin{aligned} dA_t &= b_a(B_t, A_t, Y_t^b, Y_t^a) dt + \sigma_a(B_t, A_t, Y_t^b, Y_t^a) d\tilde{W}_t; & A_0 &= a_0; \\ dB_t &= b_b(B_t, A_t, Y_t^b, Y_t^a) dt + \sigma_b(B_t, A_t, Y_t^b, Y_t^a) d\tilde{W}_t; & B_0 &= b_0; \\ v_b(t, \cdot) &= v_{b,0}(\cdot) + \int_0^t (E[\omega_1^{\mathbf{P}^b}] f^{\mathbf{P}^b}(\cdot - B_s) - E[\omega_1^{\mathbf{C}^b}] f^{\mathbf{C}^b}(\cdot - B_s) v_b(s, \cdot)) ds \\ &\quad + \sqrt{2} E[\omega_1^{\mathbf{N}^b}] \int_0^t f^{\mathbf{N}^b}(\cdot - B_s) dW_b(s), \quad t \geq 0; \end{aligned}$$

$$\begin{aligned}
 v_a(t, \cdot) &= v_{a,0}(\cdot) + \int_0^t (E[\omega_1^{\mathbf{P}^a}]f^{\mathbf{P}^a}(\cdot - A_s) - E[\omega_1^{\mathbf{C}^a}]f^{\mathbf{C}^a}(\cdot - A_s)v_a(s, \cdot)) ds \\
 &\quad + \sqrt{2}E[\omega_1^{\mathbf{N}^a}] \int_0^t f^{\mathbf{N}^a}(\cdot - A_s) dW_a(s), \quad t \geq 0
 \end{aligned}$$

upon integration of the volume density functions with our test functions. In particular, by Corollary A.3 the driving Wiener processes do not depend on the choice of the test functions.

Standard results on infinite-dimensional stochastic equations [7] guarantee that the above coupled system does indeed admit a unique adapted solution  $(B, A, Y^b, Y^a, v_a, v_b)$  in  $L^2(\Omega; C([0, T]; \mathbb{R}^4 \times (L^2)^2))$  for any  $T > 0$ . Since two  $H^{-1}$ -valued random variables have the same distribution if the inner products with respect to any finite collection of test functions have the same distribution, this shows that

$$(B^n, A^n, Y^{b,n}, Y^{a,n}, v_a^n, v_b^n) \Rightarrow (B, A, Y^b, Y^a, v_a, v_b)$$

and hence completes the proof of our main result.

REMARK 4.1. The ‘‘volume at the top’’ follows a two-dimensional Brownian motion with drift; for  $r = a, b$ ,

$$\begin{aligned}
 Y_t^r &= \langle v_{r,0}(\cdot), \varphi \rangle + \int_0^t (E[\omega_1^{\mathbf{P}^r}]\langle f^{\mathbf{P}^r}, \varphi^r \rangle + f_s^r) ds \\
 &\quad + \sqrt{2}E[\omega_1^{\mathbf{N}^r}] \int_0^t \langle f^{\mathbf{N}^r}, \varphi^r \rangle dW_r(s) \\
 &\quad - \int_0^t \langle v_r(s, \cdot), D\varphi^r(\cdot - R_s)\sigma_r(B_t, A_t, Y_t^b, Y_t^a) d\widetilde{W}(s) \rangle, \quad t \geq 0,
 \end{aligned}$$

where

$$\begin{aligned}
 f_t^r &:= \left\langle v_r(t, \cdot), \frac{1}{2} \operatorname{tr}\{\sigma_r\sigma_r'(B_t, A_t, Y_t^b, Y_t^a)D^2\varphi^r(\cdot - R_t)\} \right. \\
 &\quad \left. - b_r(B_t, A_t, Y_t^b, Y_t^a)D\varphi^r(\cdot - R_t) \right\rangle \\
 &\quad - E[\omega_1^{\mathbf{C}^r}]\langle f^{\mathbf{C}^r}(\cdot)v_r(t, \cdot), \varphi^r \rangle.
 \end{aligned}$$

### APPENDIX A: A RESULT ON THE CHARACTERIZATION OF STOCHASTIC PROCESS LIMITS

In this appendix, we establish a result on the characterization of stochastic process limits in terms of Brownian integrals. Specifically, we assume that we are

given a sequence of stochastic processes  $(X^n, Z^n)$  (piece-wise constant with jump times  $k/n$ ) with

$$Z_t^n := \sum_{k=1}^{\lfloor nt \rfloor} \Delta Z_k^n,$$

such that

$$E_{\mathcal{B}_{k/n}^n} [\Delta Z_k^n] = 0,$$

$$E_{\mathcal{B}_{k/n}^n} [\Delta Z_k^n (\Delta Z_k^n)^\top] = \frac{1}{n} \sigma_n \sigma_n^\top \left( X_{k/n}^n, \frac{k}{n} \right),$$

where  $\mathcal{B}_{k/n}^n := \sigma(X_0^n, \dots, X_{k/n}^n, \Delta Z_1^n, \dots, \Delta Z_{k-1}^n)$  and the processes may be multi-dimensional.

ASSUMPTION A.1. Let  $\sigma$  be a continuous function and assume that the following assumptions hold (for any fixed  $t > 0$  where appropriate):

$$(31) \quad \|\sigma_n - \sigma\|_{L^\infty} \xrightarrow{n \rightarrow \infty} 0, \quad \|\sigma\|_{L^\infty} < \infty,$$

$$(32) \quad E \left[ \sum_{k=1}^{\lfloor nt \rfloor} |\Delta Z_k^n|^4 \right] \xrightarrow{n \rightarrow \infty} 0,$$

$$(33) \quad \sup_{n \in \mathbb{N}} E \left[ \sup_{k \leq \lfloor nt \rfloor} |\Delta Z_k^n| \right] < \infty.$$

Notice that (31) directly implies

$$(34) \quad E \left[ \frac{1}{n} \left| \sum_{k=1}^{\lfloor nt \rfloor} \sigma_n \sigma_n^\top \left( X_{k/n}^n, \frac{k}{n} \right) - \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}^n, \frac{k}{n} \right) \right| \right] \xrightarrow{n \rightarrow \infty} 0.$$

LEMMA A.2. Suppose that  $(X^n)$  is C-tight and that there are stochastic processes  $X$  and  $Z$  defined on some probability space such that  $(X^n, Z^n) \Rightarrow (X, Z)$ . If Assumption A.1 is satisfied, then  $Z$  has quadratic variation

$$[Z]_t = \int_0^t \sigma(X_s, s) \sigma(X_s, s)^\top ds, \quad t \geq 0.$$

Moreover,  $Z$  is a martingale w.r.t. the filtration generated by  $X$  and  $Z$ .

PROOF. By (33), the martingales  $Z^n$  satisfy the condition of Jacod and Shiryaev [17], Corollary VI.6.30. Therefore, we have that both  $Z^n$  and their quadratic covariation processes  $[Z^n]$  converge weakly and that the limit of  $[Z^n]$  is the quadratic covariation of the limiting process  $Z$  of the sequence  $Z^n$ . Symbolically,

$$(Z^n, [Z^n]) \xrightarrow{n \rightarrow \infty} (Z, [Z]).$$



By C-tightness of  $X^n$ , we may add  $X^n$  to the convergence and obtain

$$(X^n, Z^n, [Z^n]) \xrightarrow{n \rightarrow \infty} (X, Z, [Z]).$$

Hence, we are left with identifying

$$[Z]_t = \lim_{n \rightarrow \infty} \sum_{k=1}^{\lfloor nt \rfloor} \Delta Z_k^n (\Delta Z_k^n)^\top.$$

To this end, by Skorokhod’s lemma, we may assume (changing probability spaces as needed) that  $(X^n, Z^n, [Z^n]) \rightarrow (X, Z, [Z])$  a.s. Note that

$$\begin{aligned} & E \left[ \left| [Z^n]_t - \int_0^t (\sigma \sigma^\top)(X_s, s) ds \right| \right] \\ & \leq E \left[ \left| \sum_{k=1}^{\lfloor nt \rfloor} \Delta Z_k^n (\Delta Z_k^n)^\top - \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}, \frac{k}{n} \right) \right| \right] \\ & \quad + E \left[ \left| \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}, \frac{k}{n} \right) - \int_0^t \sigma \sigma^\top (X_s, s) ds \right| \right]. \end{aligned}$$

Convergence of the second term to 0 follows immediately from dominated convergence using continuity of  $\sigma$  and (31). We continue to further split the first term:

$$\begin{aligned} & E \left[ \left| \sum_{k=1}^{\lfloor nt \rfloor} \Delta Z_k^n (\Delta Z_k^n)^\top - \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}, \frac{k}{n} \right) \right| \right] \\ & \leq E \left[ \left| \sum_{k=1}^{\lfloor nt \rfloor} \Delta Z_k^n (\Delta Z_k^n)^\top - \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma_n \sigma_n^\top \left( X_{k/n}^n, \frac{k}{n} \right) \right| \right] \\ & \quad + E \left[ \left| \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma_n \sigma_n^\top \left( X_{k/n}^n, \frac{k}{n} \right) - \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}^n, \frac{k}{n} \right) \right| \right] \\ & \quad + E \left[ \left| \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}^n, \frac{k}{n} \right) - \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \sigma \sigma^\top \left( X_{k/n}, \frac{k}{n} \right) \right| \right] \\ & =: \text{I} + \text{II} + \text{III}. \end{aligned}$$

Regarding I, note that the sequence of random variables

$$C_k^n := \Delta Z_k^n (\Delta Z_k^n)^\top - \frac{1}{n} \sigma_n \sigma_n^\top \left( X_{k/n}^n, \frac{k}{n} \right)$$

satisfy  $E[C_k^n] = 0$  and  $\text{cov}(C_k^n, C_l^n) = 0$  if  $k \neq l$ . Moreover, since  $C_k^n$  is obtained from  $\Delta Z_k^n (\Delta Z_k^n)^\top$  by subtracting a conditional expectation, the fourth moment of

$\Delta Z_k^n$  is an upper bound of the variance of  $C_k^n$  where

$$\text{cov}(C_k^n, C_l^n) := E[(C_k^n, C_l^n)], \quad \text{var}[C_k^n] := E[(C_k^n, C_k^n)]$$

for the standard inner product on the space of matrices. Hence, by Jensen’s inequality and (32),

$$I \leq \sqrt{E\left[\left|\sum_{k=1}^{\lfloor nt \rfloor} C_k^n\right|^2\right]} = \sqrt{\sum_{k=1}^{\lfloor nt \rfloor} \text{var}[C_k^n]} \leq \sqrt{\sum_{k=1}^{\lfloor nt \rfloor} E[|\Delta Z_k^n|^4]} \xrightarrow{n \rightarrow \infty} 0.$$

II converges to 0 by (34). For III, note that the integrand converges a.s. by the convergence of  $X^n$  to  $X$ , and convergence of the expectation follows by dominated convergence.

Finally, note that if  $(X, Z, [Z]) = (X, Z, \int_0^\cdot \sigma \sigma^\top(X_s, s) ds)$  in law, then we really must have  $[Z] = \int_0^\cdot \sigma \sigma^\top(X_s, s) ds$  as random variables, that is, the proposed equality actually also holds on the original probability space before applying Skorokhod’s lemma.

We are left to prove that the limiting process  $Z$  is a (local) martingale w.r.t. the filtration generated by  $(X, Z)$ . Note that this will follow by a combination of [17], Propositions IX.1.10 and IX.1.12, if we can show uniform integrability of the family  $(Z_t^n)_{n \in \mathbb{N}^+, t \in [0, T]}$  of random variables for arbitrary intervals  $[0, T]$ . This follows from (31) as

$$\begin{aligned} \sup_n \sup_{t \in [0, T]} E[|Z_t^n|^2] &\leq \sup_n \sum_{k=1}^{\lfloor nt \rfloor} E[|\Delta Z_k^n|^2] \leq \sup_n \frac{1}{n} \sum_{k=1}^{\lfloor nt \rfloor} \|\sigma_n\|_{L^\infty}^2 \\ &\leq \left(\sup_n \|\sigma_n\|_{L^\infty}^2\right) T < \infty. \end{aligned} \quad \square$$

The preceding lemma suggests that  $Z$  can be represented as a Brownian integral. As the quadratic variation of a martingale does not determine its distribution in general, we now prove that we can find indeed a multi-dimensional Brownian motion  $W$  such that

$$Z_t = Z_0 + \int_0^t \sigma(X_s, s) dW_s.$$

While probably standard, we have not been able to find a reference for this statement directly applicable to our situation. Therefore, we give a formal proof of the special case needed for the representation step in the main theorem.

**COROLLARY A.3.** *Let  $Z = (Z^A, Z^B, Z^C)$  be a continuous local martingale taking values in  $\mathbb{R}^{d+n+m}$  such that the differential quadratic covariation satisfies*

$$d[Z]_t = \begin{pmatrix} A_t & 0 & 0 \\ 0 & B_t & 0 \\ 0 & 0 & C_t \end{pmatrix} dt,$$

where  $A_t = F_t F_t^\top$  for a  $d \times d$ -dimensional invertible process  $F$  and where

$$B_t^{i,j} = \sigma_t^i \sigma_t^j, \quad i, j = 1, \dots, n,$$

$$C_t^{l,k} = \tau_t^l \tau_t^k, \quad l, k = 1, \dots, m,$$

for processes  $\sigma, \tau$  taking values in  $\mathbb{R}_{>0}^n$  and  $\mathbb{R}_{>0}^m$ , respectively. Then we can find a  $(d + 2)$ -dimensional standard Brownian motion  $(W, U, V)$  such that

$$Z_t^A = Z_0^A + \int_0^t F_s dW_s,$$

$$Z_t^B = Z_0^B + \int_0^t \text{diag}(\sigma_s^1, \dots, \sigma_s^n) dU_s,$$

$$Z_t^C = Z_0^C + \int_0^t \text{diag}(\tau_s^1, \dots, \tau_s^m) dV_s.$$

The proof of Corollary A.3 builds on the following multi-variate extension of Lévy’s characterization of Brownian motion. The result appears to be standard; we provide a proof (taken from [27]) for completeness.

**THEOREM A.4.** *Let  $X$  be an  $l$ -dimensional continuous local martingale with quadratic covariation  $\langle X \rangle_t = \Sigma_t$  and  $X_0 = 0$ . Suppose that  $\Sigma$  is deterministic,  $\Sigma_0 = 0$  and for any  $a \in \mathbb{R}^d$  we have  $t \mapsto a^\top \Sigma_t a$  is continuous and increasing. Then for any  $0 \leq s < t$  the increment  $X_t - X_s$  is independent of  $\mathcal{F}_s$  and distributed according to  $\mathcal{N}(0, \Sigma_t - \Sigma_s)$ .*

**PROOF.** Choose  $a \in \mathbb{R}^d$  and set  $Y = a^\top X$ , so that  $[Y]_t = a^\top \Sigma_t a$ . The process

$$M_t = f(Y_t, [Y]_t) \equiv \exp\left(iY_t + \frac{1}{2}[Y]_t\right)$$

$$= \exp\left(ia^\top X_t + \frac{1}{2}a^\top \Sigma_t a\right)$$

is bounded by  $|M_t| \leq \exp(a^\top \Sigma_t a/2)$ . Applying Itô’s lemma for continuous semimartingales to  $f$  gives

$$dM_t = f_1(Y_t, [Y]_t) dY_t + f_2(Y_t, [Y]_t) d[Y]_t + \frac{1}{2} f_{11}(Y_t, [Y]_t) d[Y]_t$$

$$= iM_t dY_t.$$

As a bounded local martingale on  $[0, T]$ ,  $M$  is a (true) martingale. So,

$$E[\exp(ia^\top(X_t - X_s)) | \mathcal{F}_s] = E[M_t \exp(-ia^\top X_s - a^\top \Sigma_t a/2) | \mathcal{F}_s]$$

$$= M_s \exp(-ia^\top X_s - a^\top \Sigma_t a/2)$$

$$= \exp(a^\top(\Sigma_s - \Sigma_t)a/2).$$

This is the characteristic function of the multivariate normal, independently of  $\mathcal{F}_s$ , with mean zero and covariance matrix  $\Sigma_t - \Sigma_s$ , as required.  $\square$

**PROOF OF COROLLARY A.3.** Define processes  $W, \tilde{U}, \tilde{V}$  taking values in  $\mathbb{R}^d, \mathbb{R}^n, \mathbb{R}^m$ , respectively, by

$$\begin{aligned} W_t &:= \int_0^t F_s^{-1} dZ_s^A, \\ \tilde{U}_t &:= \int_0^t \text{diag}((\sigma_s^1)^{-1}, \dots, (\sigma_s^n)^{-1}) dZ_s^B, \\ \tilde{V}_t &:= \int_0^t \text{diag}((\tau_s^1)^{-1}, \dots, (\tau_s^m)^{-1}) dZ_s^C. \end{aligned}$$

We compute the quadratic covariation of the joint process  $(W, \tilde{U}, \tilde{V})$ . For any  $1 \leq i, j \leq d$ , we have

$$\begin{aligned} d[W^i, W^j]_t &= \sum_{\nu, \mu=1}^d (F_t^{-1})^{i, \nu} (F_t^{-1})^{j, \mu} d\langle Z^i, Z^j \rangle_t \\ &= \sum_{\nu, \mu=1}^d (F_t^{-1})^{i, \nu} A_t^{i, j} (F_t^{-1})^{j, \mu} dt = \delta^{i, j} dt. \end{aligned}$$

On the other hand, using the structure of  $B_t$  and  $C_t$ , respectively, we obtain for any  $1 \leq i, j \leq n$  and  $1 \leq l, k \leq m$ ,

$$d[\tilde{U}^i, \tilde{U}^j]_t = d[\tilde{V}^l, \tilde{V}^k]_t = dt.$$

The cross terms  $[W^i, \tilde{U}^j], [W^i, \tilde{V}^l], [\tilde{U}^j, \tilde{V}^l]$  vanish. Hence, the quadratic covariation of the process  $(W, \tilde{U}, \tilde{V})$  is the deterministic matrix-valued process

$$\Sigma_t = t \begin{pmatrix} I_d & 0 & 0 \\ 0 & E_n & 0 \\ 0 & 0 & E_m \end{pmatrix},$$

where  $E_k$  denotes the  $k \times k$  matrix with all entries equal to 1. As one can immediately see that  $t \mapsto a^\top \Sigma_t a$  is continuous and increasing for any  $a \in \mathbb{R}^{d+n+m}$ , Theorem A.4 implies that  $(W, \tilde{U}, \tilde{V})$  is a Gaussian process with increments distributed according to  $\mathcal{N}(0, \Sigma_t - \Sigma_s)$ .

The special structure of the matrices  $\Sigma_t$  implies that  $W$  is a  $d$ -dimensional standard Brownian motion, whereas all the components of  $\tilde{U}$  and  $\tilde{V}$  are, respectively, identical one-dimensional Brownian motions. Hence, we may choose  $U := \tilde{U}^1, V := \tilde{V}^1$ , and obtain the conclusion.  $\square$

**REMARK A.5.** The conditions of Corollary A.3 can clearly be relaxed. For instance, it is enough that for any time  $t$  at least one of the nonnegative processes

$\sigma^1, \dots, \sigma^n$  is strictly positive. On the other hand, if all of them vanish identically, then we may not be able to find a suitable Brownian motion on the same probability space. In the nonregular case, we therefore need to weaken the statement to an equality in distribution, and use techniques similar to [22] to derive the result.

APPENDIX B: TECHNICAL PROOFS

PROOF OF LEMMA 3.11. We prove (22); the second assertion follows similarly. Without any loss of generality, we assume  $E[\omega_1^C] = 1$ . For each  $s \in (\frac{1}{n}, t)$  with  $n \in \mathbb{N}^+$ , we choose  $k_s^n \in \mathbb{Z}$  such that  $s \in [\frac{k_s^n+1}{n}, \frac{k_s^n+2}{n})$ . For  $s \in (0, \frac{1}{n})$ , put  $k_s^n = 0$ . For notational simplicity, we set  $\tilde{v}^n(s, x) = 1 - \alpha + \alpha \bar{v}^n(s, x)$ , with  $\alpha \in \{1, 0\}$ . Then

$$\begin{aligned} & \sup_{x \in \mathbb{R}} E \left| \int_0^t (g^n(s, x) - E[\omega_1^C] f^C(x - R_s)) \tilde{v}^n(s, x) ds \right|^2 \\ & \leq 2 \sup_{x \in \mathbb{R}} E \left| \int_0^t (f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n) - f^C(x - R_s)) \tilde{v}^n(s, x) ds \right|^2 \\ & \quad + 2 \sup_{x \in \mathbb{R}} E \left| \int_0^t (g^n(s, x) - f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n)) \tilde{v}^n(s, x) ds \right|^2 \\ & := 2(\Gamma_1 + \Gamma_2). \end{aligned}$$

Since  $f^C$  is Lipschitz continuous and vanishes outside a compact interval there exists a constant  $C < \infty$  such that

$$\begin{aligned} \Gamma_1 &= \sup_{x \in \mathbb{R}} E \left| \int_0^t (f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n) - f^C(x - R_s)) \tilde{v}^n(s, x) ds \right|^2 \\ & \leq C \sup_{x \in \mathbb{R}} E \int_0^t |\tilde{v}^n(s, x)|^2 ds E \int_0^t |R_s - \bar{R}_{\frac{k_s^n}{n}}^n|^2 \wedge 1 ds. \end{aligned}$$

Hence, by Lemma 3.4,  $\Gamma_1 \rightarrow 0$  as  $n \rightarrow \infty$  by dominated convergence, due to the a.s. continuity  $A$ . Using independence of cancellation price levels and volumes, a direct computation yields

$$\begin{aligned} \Gamma_2 &= \sup_{x \in \mathbb{R}} E \left| \int_0^t (g^n(s, x) - f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n)) \tilde{v}^n(s, x) ds \right|^2 \\ &= \sup_{x \in \mathbb{R}} E \left| \int_0^t \left( \sum_{i=N^n(\bar{\tau}_{k_s^n}^n)+1}^{N^n(\bar{\tau}_{k_s^n+1}^n)} \sum_{j \in \mathbb{Z}} \mathbf{1}_{[x_j^n, x_{j+1}^n)} (\pi_i^C + \bar{R}_{\frac{k_s^n}{n}}^n) \omega_i^C \mathbf{1}_{[x_j^n, x_{j+1}^n)}(x) \frac{\Delta v^n}{\Delta x^n} \right. \right. \\ & \quad \left. \left. - f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n) \right) \tilde{v}^n(s, x) ds \right|^2 \end{aligned}$$

$$\begin{aligned}
 &\leq 3 \sup_{x \in \mathbb{R}} E \left| \int_0^t \sum_{i=N^n(\tilde{\tau}_{k_s^n}^n)+1}^{N^n(\tilde{\tau}_{k_s^n}^n+1)} \sum_{j \in \mathbb{Z}} \left( \mathbf{1}_{[x_j^n, x_{j+1}^n)} (\pi_i^{\mathbf{C}} + \bar{R}_{\frac{k_s^n}{n}}^n) \omega_i^{\mathbf{C}} \right. \right. \\
 &\quad \left. \left. - \int_{[x_j^n, x_{j+1}^n)} f^{\mathbf{C}}(y - \bar{R}_{\frac{k_s^n}{n}}^n) dy \right) \mathbf{1}_{[x_j^n, x_{j+1}^n)}(x) \frac{\Delta v^n \tilde{v}^n(s, x) n}{\Delta x^n} ds \right|^2 \\

 &\quad + 3 \sup_{x \in \mathbb{R}} E \left| \int_0^t ((N^n(\tilde{\tau}_{k_s^n}^n+1) - N^n(\tilde{\tau}_{k_s^n}^n)) n \Delta v^n - 1) f^{\mathbf{C}}(x - \bar{R}_{\frac{k_s^n}{n}}^n) \tilde{v}^n(s, x) ds \right|^2 \\
 &:= 3(\gamma_0 + \gamma_1 + \gamma_2).
 \end{aligned}$$

To estimate  $\gamma_0$  we use again independence of involved random variables, the fact that

$$E_{\mathcal{F}_{\frac{k_s^n}{n}}^n} [\mathbf{1}_{[x_j^n, x_{j+1}^n)} (\pi_i^{\mathbf{C}} + \bar{R}_{\frac{k_s^n}{n}}^n) \omega_i^{\mathbf{C}}] = \int_{[x_j^n, x_{j+1}^n)} f^{\mathbf{C}}(y + \bar{R}_{\frac{k_s^n}{n}}^n) dy$$

along with Lemmas 3.1 and 3.4 and the properties of the scaling constants to conclude that

$$\begin{aligned}
 \gamma_0 &\leq Ct^2 \sup_{x \in \mathbb{R}} E \sup_{s \in [0, t]} |\tilde{v}^n(s, x)|^2 \frac{\lambda^n}{\mu^n} \left( \frac{n \Delta v^n}{\Delta x^n} \right)^2 \|f^{\mathbf{C}}\|_{L^\infty} \Delta x^n \\
 &\leq Ct^2(t^2 + t + 1) \Delta x^n \longrightarrow 0, \quad \text{as } n \rightarrow \infty.
 \end{aligned}$$

To estimate  $\gamma_1$ , we first deduce from Lipschitz continuity of  $f^{\mathbf{C}}$  for  $x \in [x_j^n, x_{j+1}^n)$  that

$$\begin{aligned}
 \frac{1}{\Delta x^n} \int_{[x_j^n, x_{j+1}^n)} |f^{\mathbf{C}}(y - \bar{R}_{\frac{k_s^n}{n}}^n) - f^{\mathbf{C}}(x - \bar{R}_{\frac{k_s^n}{n}}^n)| dy &\leq L \frac{1}{\Delta x^n} \int_{[x_j^n, x_{j+1}^n)} |\Delta x^n| dy \\
 &= L \Delta x^n.
 \end{aligned}$$

Thus, using again Lemmas 3.1 and 3.4, the properties of the scaling constants and the fact that  $f^{\mathbf{C}}$  vanishes outside a compact interval we find a constant  $C < \infty$  such that

$$\begin{aligned}
 \gamma_1 &\leq Ct^2 n^{-1} \sup_{x \in \mathbb{R}} E \sup_{s \in [0, t]} |\tilde{v}^n(s, x)|^2 \\
 &\leq Ct^2(t^2 + t + 1) n^{-1} \longrightarrow 0 \quad \text{as } n \rightarrow \infty.
 \end{aligned}$$

In view of Lemma 3.1, boundedness of  $f^C$  and independence of involved random variables, we have

$$\begin{aligned}
 \gamma_2 &= \sup_{x \in \mathbb{R}} E \left| \int_0^t ((N^n(\tilde{\tau}_{k_s^n+1}) - N^n(\tilde{\tau}_{k_s^n}))n \Delta v^n - 1) f^C(x - \bar{R}_{\frac{k_s^n}{n}}^n) \tilde{v}^n(s, x) ds \right|^2 \\
 &\leq 2 \sup_{x \in \mathbb{R}} E \left| \sum_{l=1}^{\lfloor nt \rfloor} ((N^n(\tilde{\tau}_l^n) - N^n(\tilde{\tau}_{l-1}^n))n \Delta v^n - 1) f^C(x - \bar{R}_{\frac{l-1}{n}}^n) \tilde{v}^n\left(\frac{l-1}{n}, x\right) \frac{1}{n} \right|^2 \\
 &\quad + 2 \sup_{x \in \mathbb{R}} E \left| \int_0^{\frac{1}{n}} f^C(x - \bar{R}_0^n) \tilde{v}^n(0, x) ds \right|^2 \\
 &\leq 2(\Delta v^n)^2 E \sup_{x \in \mathbb{R}} \sum_{l=1}^{\lfloor nt \rfloor} \left| (N^n(\tilde{\tau}_l^n) - N^n(\tilde{\tau}_{l-1}^n)) - E[N^n(\tilde{\tau}_l^n) - N^n(\tilde{\tau}_{l-1}^n)] \right| \\
 &\quad \times \left| f^C(x - \bar{R}_{\frac{l-1}{n}}^n) \tilde{v}^n\left(\frac{l-1}{n}, x\right) \right|^2 + C/n \\
 &\leq \frac{C}{n} \left( 1 + t \sup_{x \in \mathbb{R}} E \sup_{s \in [0, t]} |\tilde{v}^n(s, x)|^2 \right) \longrightarrow 0, \quad \text{as } n \rightarrow \infty. \quad \square
 \end{aligned}$$

 & \leq C \Delta v^n \sum_{l=0}^{\infty} \frac{(\mu^n t)^l}{l!} e^{-\mu^n t} E_{\tilde{N}^n(t)=l} \left[ \sum_{k=1}^l (N^n(\tilde{\tau}_k^n) - N^n(\tilde{\tau}_{k-1}^n)) \right.
 \end{aligned}$$

$$\begin{aligned}
 & \times (N^n(\tilde{\tau}_k^n) - N^n(\tilde{\tau}_{k-1}^n) - 1)(\Delta x^n)^2 \\
 & + \sum_{k=1}^l (N^n(\tilde{\tau}_k^n) - N^n(\tilde{\tau}_{k-1}^n)) + (N^n(t) - N^n(\tilde{\tau}_l^n))(N^n(t) - N^n(\tilde{\tau}_l^n) - 1) \\
 & \times (\Delta x^n)^2 + (N^n(t) - N^n(\tilde{\tau}_l^n)) \Big] \\
 & = C \Delta v^n \sum_{l=0}^{\infty} \frac{(\mu^n t)^l}{l!} e^{-\mu^n t} \\
 & \times E[lN^n(\beta(1, l))(N^n(\beta(1, l)) - 1)(\Delta x^n)^2 + lN^n(\beta(1, l)) \\
 & + N^n(\beta(1, l))(\Delta x^n)^2 + N^n(\beta(1, l))] \\
 & = C \Delta v^n \sum_{l=0}^{\infty} \frac{(\mu^n t)^l}{l!} e^{-\mu^n t} \sum_{m=0}^{\infty} [lm(m-1)(\Delta x^n)^2 + m^2(\Delta x^n)^2 + (l+1)m] \\
 & \times \int_0^1 \frac{(\lambda^n tz)^m}{m!} e^{-\lambda^n tz} \frac{(1-z)^{l-1}}{B(1, l)} dz \\
 & \leq Ct \Delta v^n \left[ \frac{(\lambda^n \Delta x^n)^2}{\mu^n} + \lambda^n \right] \\
 & \leq Ct,
 \end{aligned}$$

with the constant  $C$  independent of  $n$  and  $t$ .

The estimate of  $v_{a/b}^n$  follows precisely in the same way as the proof of Lemma 3.4, taking into account the appropriate estimates for  $V_{a/b}^{n,i}$  derived above. □

### APPENDIX C: CLASSICAL TIGHTNESS RESULTS

For the convenience of the reader, we recall some classical results on tightness which the derivations of Section 3 are based on. We first note that though the following theorems and lemmas may be originally established on finite time intervals, we state them on the half-line  $[0, \infty)$  since there is no essential difficulty to make such extensions in the spirit of Jacod and Shiryaev [17].

The first result is a sufficient condition for tightness in the Skorokhod space  $\mathcal{D}([0, \infty); E)$  for a complete separable metric state space  $(E, \rho)$  due to Aldous and Kurtz. We take it from [30], Theorem 6.8.

**THEOREM C.1.** *Let  $X_n$  be a sequence of processes taking values in  $\mathcal{D}([0, \infty); E)$  such that the family  $(X_n(t))_{n \in \mathbb{N}^+}$  of random variables is tight (in  $E$ ) for any*

rational  $t$ . Moreover, assume that for each  $N \in \mathbb{N}^+$ , there is a number  $p > 0$  and processes  $(\gamma_n(\delta))_{\delta \in [0, \infty)}$ ,  $n \in \mathbb{N}^+$ , such that

$$E[\rho(X_n(t + \delta), X_n(t))^p | \mathcal{F}_t^n] \leq E[\gamma_n(\delta) | \mathcal{F}_t^n], \quad \forall t, t + \delta \in [0, N],$$

$$\lim_{\delta \rightarrow 0} \limsup_{n \rightarrow \infty} E[\gamma_n(\delta)] = 0,$$

where the filtration  $\mathcal{F}^n$  is generated by  $X^n$ . Then  $(X_n)_{n \in \mathbb{N}^+}$  is tight in  $\mathcal{D}([0, \infty); E)$ .

PROOF. See [30], Theorem 6.8. Note that Walsh assumes one joint filtration  $\mathcal{F}_t$ , whereas we allow for filtrations depending on  $n$ . This difference is, however, inconsequential, for example, by choosing  $X^n$  to be defined on a common probability space in an independent way and then choosing  $\mathcal{F}_t$  to be the filtration generated by all the filtrations  $\mathcal{F}_t^n$ .  $\square$

The following lemma on C-tightness is borrowed from [17], Proposition 3.26, page 351.

LEMMA C.2. For a sequence  $X^n$  with paths in  $\mathcal{D}([0, \infty); \mathbb{R}^d)$  ( $d \in \mathbb{N}^+$ ), it is C-tight if and only if it is tight and for all  $N \in \mathbb{N}^+$ ,  $\varepsilon > 0$ , there holds

$$\lim_{n \rightarrow \infty} \mathbb{P}^n \left( \sup_{t \leq N} |\Delta X_t^n| > \varepsilon \right) = 0.$$

The main theoretical tool in this paper is Mitoma’s theorem, on basis of [30], Theorem 6.13, Lemma 6.14, Corollary 6.16, note on page 365, which relates tightness of distribution-valued processes to real-valued processes obtained by applying test-functions. We specialize the general formulation given in [30] so that the theorem can be directly applied to our setting.

THEOREM C.3 (Mitoma’s theorem). For any positive integer  $d$ , let  $X^n := (X_1^n, \dots, X_d^n)$  be a sequence of processes with sample paths lying in  $\mathcal{D}([0, \infty); (\mathcal{E}')^d)$ . The sequence  $X^n$  is tight as processes with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^d)$ , if and only if for any  $\phi_1, \dots, \phi_d \in \mathcal{E}$  we have tightness of the sequence of  $\mathcal{D}([0, \infty); \mathbb{R})$ -valued processes  $\sum_{i=1}^d \langle X_i^n, \phi_i \rangle$ . If, furthermore, for any  $\varepsilon, N \in (0, \infty)$  there exists  $\tilde{N} \in (0, \infty)$  such that  $\sup_n \mathbb{P}(\sup_{t \in [0, N]} \sum_{i=1}^d \|X_i^n(t)\|_{L^2} > \tilde{N}) < \varepsilon$ , then  $X^n$  is tight as a sequence of processes with paths in  $\mathcal{D}([0, \infty); (H^{-1})^d)$ .

Here, we choose  $H^{-1}$  for convenience. Indeed, in view of the arguments in [30], page 335, Example 1a, we can replace the space  $H^{-1}$  by  $H^{-m}$  for any  $m > 1/2$ . On the other hand, an immediate application of Theorem C.3 is the following corollary, which states that joint tightness of a pair of sequences of stochastic processes follows from individual tightness assuming that at least one of the involved sequences is C-tight, that is, all its accumulation points are continuous processes.

**COROLLARY C.4.** *Let  $Y^n$  and  $Z^n$  be sequences of stochastic processes taking values in  $(\mathcal{E}')^d$  and  $(\mathcal{E}')^l$ , respectively, with  $d, l \in \mathbb{N}^+$ . If  $Y^n$  is  $C$ -tight with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^d)$  and  $Z^n$  is tight with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^l)$ , then the pair of processes  $(Y^n, Z^n)$  is tight with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^{d+l})$ .*

**PROOF.** We first note that for the finite-dimensional case where  $(\mathcal{E}')^d$  and  $(\mathcal{E}')^l$  are replaced by Euclidean spaces, Corollary C.4 coincides with [17], Cor. VI.3.33. Obviously the  $C$ -tightness of  $Y^n$  with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^d)$  implies that of  $\sum_{i=1}^d \langle Y_i^n, \phi_i \rangle$  with paths in  $\mathcal{D}([0, \infty); \mathbb{R})$  for any  $\phi_1, \dots, \phi_d \in \mathcal{E}$ . As Theorem C.3 allows us to prove the tightness of distribution-valued processes by verifying that of the real-valued processes obtained by applying test-functions, there follows the tightness of pair of processes  $(Y^n, Z^n)$  with paths in  $\mathcal{D}([0, \infty); (\mathcal{E}')^{d+l})$ .  $\square$

We remark that the method of proof for the finite-dimensional case (see [17], page 353, Corollary VI.3.33) cannot directly be applied to Corollary C.4, as the compactness of the unit ball is key to their proof of the finite-dimensional case. On the other hand, if we replace  $(\mathcal{E}')^d$  for  $Y^n$  by  $\mathbb{R}^m \times (\mathcal{E}')^d$  with  $m \in \mathbb{N}^+$ , then Corollary C.4 still holds, since the finite-dimensional space is isomorphic as well as homeomorphic to some subspace of  $\mathcal{E}'$ .

We also use a lemma of Billingsley about weak limits under time-changes.

**LEMMA C.5.** *Let  $X^n$  be a sequence of processes taking values in  $\mathcal{D}([0, \infty); E)$  for some separable metric space  $E$  and let  $\Phi^n$  be a sequence of nondecreasing processes with paths in  $\mathcal{D}([0, \infty); [0, \infty))$ . Assume that  $(X^n, \Phi^n)$  converge weakly to a pair of processes  $(X, \Phi) \in \mathcal{D}([0, \infty); E \times [0, \infty))$  such that  $X \in C([0, \infty); E)$  with probability 1. Then*

$$X^n \circ \Phi^n \Rightarrow X \circ \Phi.$$

**PROOF.** The proof in Billingsley ([3], page 151, for the special case  $E = \mathbb{R}$ ) can be immediately adapted to this more general setting.  $\square$

Finally, we recall Skorokhod’s lemma [3], Theorem 6.7 on page 70.

**LEMMA C.6.** *Let  $\mu_n \Rightarrow \mu$  be a weakly converging sequence of probability measures on a metric space such that the support of  $\mu$  is separable. Then there is a probability space  $(\Omega, \mathcal{F}, P)$  and a sequence of random variables  $X_n$  with distribution  $\mu_n$  together with a random variable  $X$  with distribution  $\mu$  such that*

$$\forall \omega \in \Omega : \lim_{n \rightarrow \infty} X_n(\omega) = X(\omega).$$
