Optimal lower bounds on hitting probabilities for stochastic heat equations in spatial dimension $k \ge 1^*$

Abstract

We establish a sharp estimate on the negative moments of the smallest eigenvalue of the Malliavin matrix γ_Z of Z := (u(s, y), u(t, x) - u(s, y)), where u is the solution to a system of d non-linear stochastic heat equations in spatial dimension $k \ge 1$. We also obtain the optimal exponents for the L^p -modulus of continuity of the increments of the solution and of its Malliavin derivatives. These lead to optimal lower bounds on hitting probabilities of the process $\{u(t, x) : (t, x) \in [0, \infty[\times \mathbb{R}^k\} \text{ in the non-Gaussian case in terms of Newtonian capacity, and improve a result in Dalang, Khoshnevisan and Nualart [Stoch PDE: Anal Comp 1 (2013) 94–151].$

Keywords: hitting probabilities; systems of non-linear stochastic heat equations; spatially homogeneous Gaussian noise; Malliavin calculus.

1 Introduction and main results

Consider the following system of stochastic partial differential equations:

$$\frac{\partial}{\partial t}u_i(t,x) = \frac{1}{2}\Delta_x u_i(t,x) + \sum_{j=1}^d \sigma_{ij}(u(t,x))\dot{F}^j(t,x) + b_i(u(t,x)), \tag{1.1}$$

for $1 \leq i \leq d, t \in [0,T]$ and $x \in \mathbb{R}^k$ ($k \geq 1$), where $u := (u_1, \ldots, u_d)$ with initial conditions u(0,x) = 0 for all $x \in \mathbb{R}^k$, and the Δ_x denotes the Laplacian in the spatial variable x. The functions $\sigma_{ij}, b_i : \mathbb{R}^d \to \mathbb{R}$ are globally Lipschitz functions, $i, j \in \{1, \ldots, d\}$. We set $b = (b_i)$ and $\sigma = (\sigma_{ij})$.

The noise $\dot{F} = (\dot{F}_1, \dots, \dot{F}_d)$ is a spatially homogeneous centered Gaussian generalized random field with covariance of the form

$$\mathbb{E}[\dot{F}^{i}(t,x)\dot{F}^{j}(s,y)] = \delta(t-s)\|x-y\|^{-\beta}\delta_{ij},$$

where $\beta \in]0, 2 \wedge k[$, $\delta(\cdot)$ denotes the Dirac delta function, δ_{ij} the Kronecker symbol and $\|\cdot\|$ is the Euclidean norm. In particular, the *d*-dimensional driving noise \dot{F} is white in time and with a spatially homogeneous covariance given by the Riesz kernel $f(x) = \|x\|^{-\beta}$.

The solution u of (1.1) is known to be a d-dimensional random field (see the end of this section where precise definitions and references are given). The potential theory for u has been developed by Dalang, Khoshnevisan and Nualart [6]. Fix T > 0 and let $I \times J \subset [0,T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. In the case where the noise is additive, i.e., $\sigma \equiv \text{Id}$ and $b \equiv 0$, Dalang, Khoshnevisan and Nualart [6, Theorem 1.5] prove that for fixed M > 0, there exists c > 0 depending on I, J and M such that for all compact sets $A \subseteq [-M, M]^d$,

$$\mathbb{P}\{u(I \times J) \cap A \neq \emptyset\} \ge c \operatorname{Cap}_{d-(\frac{4+2k}{2})}(A), \tag{1.3}$$

where $u(I \times J)$ denotes the range of $I \times J$ under the random map $(t, x) \mapsto u(t, x)$, and Cap_{β} denotes the capacity with respect to the Newtonian β -kernel (we refer to [6, Section 1] for the definition of capacity). If the noise is multiplicative, i.e., σ and b are not constants (but are sufficiently regular), then using techniques of Malliavin calculus, Dalang, Khoshnevisan and Nualart [6, Theorem 1.2(b)] prove that for fixed M > 0 and $\eta > 0$, there exists c > 0 depending on I, J, M and η such that for all compact sets $A \subseteq [-M, M]^d$,

$$\mathsf{P}\{u(I \times J) \cap A \neq \emptyset\} \ge c \operatorname{Cap}_{d-(\frac{4+2k}{2})+\eta}(A).$$
(1.4)

For systems of linear and/or non-linear stochastic heat equations in spatial dimension 1 driven by a *d*-dimensional space-time white noise, this type of question was studied in Dalang, Khoshnevisan and Nualart [4] and [5], in which the lower bounds on hitting probabilities in the Gaussian case (additive noise) and non-Gaussian case (multiplicative noise) are not identical. This discrepancy has been filled recently by Dalang and Pu [7], in which we have obtained the optimal lower bounds on hitting probabilities for systems of non-linear stochastic heat equations in spatial dimension 1.

The aim of this paper is to remove the η in the dimension of capacity in (1.4), so that we obtain the optimal lower bounds on hitting probabilities for systems of non-linear stochastic heat equations in higher spatial dimension.

In [6], the lower bound on the hitting probability in (1.4) follows from the properties of the probability density function of the solution (see [6, Theorems 1.6 and 1.8]), in particular, the upper bound on the joint probability density function (denoted by $p_Z(\cdot, \cdot)$) of the random vector

$$Z := (u(s, y), u(t, x) - u(s, y)).$$
(1.5)

In [6, Corollary 5.10], the formula for the density function $p_Z(\cdot, \cdot)$ is given in terms of the Malliavin derivative and the Skorohod integral (we refer to Section 2 for the elements of Malliavin calculus). From this formula, in order to establish an upper bound on the density function $p_Z(\cdot, \cdot)$, the main effort is to analyze the L^p -modulus of continuity of the increments of the solution (see [6, (2.6)]) and of the Malliavin derivative of the increments of the solution (see [6, Proposition 5.1]), and the negative moments of the smallest eigenvalue of the Malliavin matrix γ_Z of Z (see [6, Proposition 5.6]). We point out that the estimates in [6, (2.6), Propositions 5.1 and 5.6] are not sharp, and that is why the extra term η appears in (1.4).

We first look at the L^p -modulus of continuity of the increments of the solution. Hölder continuity for the solution to stochastic heat equation with spatially correlated noise has been studied by many authors; see, for example, [8, 9, 17]. Sanz-Solé and Sarrà [17] use the factorization method to study the Hölder continuity for the solution to (1.1) (with d = 1), when the initial condition is bounded and δ -Hölder continuous for some $\delta \in]0,1[$, and the spatial covariance of the noise \dot{F} is the Fourier transform of a tempered measure μ on \mathbb{R}^k . In particular, [17, Theorem 2.1] shows that, if the measure μ satisfies the condition

$$\int_{\mathbb{R}^k} \frac{\mu(d\xi)}{(1+\|\xi\|^2)^\eta} < \infty, \quad \text{for some} \quad \eta \in \]0,1[,$$

then for any $p \ge 2$ and $\gamma \in]0, \delta \land (1 - \eta)[$, there exists C(p, T) > 0 such that for all (t, x), $(s, y) \in [0, T] \times \mathbb{R}^k$,

$$\mathbb{E}\left[|u(t,x) - u(s,y)|^{p}\right] \le C(p,T) \left(|t-s|^{\gamma/2} + ||x-y||^{\gamma}\right)^{p};$$

see [17, (10) and (19)]. In the case where $f = \mathscr{F}\mu$ is the Riesz kernel $f(x) = ||x||^{-\beta}$ and the initial value vanishes, this result of Sanz-Solé and Sarrà becomes: for any $\gamma \in]0, \frac{2-\beta}{2}[$,

$$\mathbb{E}\left[|u(t,x) - u(s,y)|^{p}\right] \le C(p,T) \left(|t-s|^{\gamma/2} + ||x-y||^{\gamma}\right)^{p}$$
(1.6)

for all (t, x), $(s, y) \in [0, T] \times \mathbb{R}^k$. Note that the right endpoint $\gamma = \frac{2-\beta}{2}$ is excluded.

Li [9] has studied the Hölder continuity for stochastic fractional heat equations without drift in the case where the Gaussian noise is white in time and colored in space with covariance of the form (1.2). Based on some estimates of the fractional heat kernel, [9, Theorems 1, 2 and 3] obtains spatial and temporal L^p -Hölder continuity of the solution to stochastic fractional heat equation. In these results, the exponent in time is optimal while the exponent in space is not ([9, Remark 2]).

The first contribution of this paper is the following sharp estimate of the L^p -Hölder continuity for the solution to (1.1), improving (1.6). We have the following.

Theorem 1.1. Assume that σ_{ij} and b_i are globally Lipschitz continuous. There exists a constant $C_{p,T} > 0$ such that for all $s, t \in [0,T]$, $s \leq t$, $x, y \in \mathbb{R}^k$, $p \geq 2$,

$$\mathbb{E}\left[\|u(t,x) - u(s,y)\|^{p}\right] \le C_{p,T} \left(|t-s|^{(2-\beta)/4} + \|x-y\|^{(2-\beta)/2}\right)^{p}.$$
(1.7)

We also need the L^p -Hölder continuity for the Malliavin derivative of the solution to (1.1). We consider the following hypotheses on the coefficients of the system (1.1):

- **P1** The functions σ_{ij} and b_i are infinitely differentiable with bounded partial derivatives of all positive orders, and the σ_{ij} are bounded, for $1 \le i, j \le d$.
- **P2** The matrix σ is uniformly elliptic, that is, $\|\sigma(x)\xi\|^2 \ge \rho^2 > 0$ for some $\rho > 0$, for all $x \in \mathbb{R}^d$, $\|\xi\| = 1$.

Analogous to Theorem 1.1, we have the following sharp estimate of the L^p -Hölder continuity for the Malliavin derivative of the solution to (1.1), which is an improvement of [6, Proposition 5.1].

Theorem 1.2. Assume **P1**. Then for any T > 0 and $p \ge 2$, there exists a constant $C := C_{p,T} > 0$ such that for any $0 \le s \le t \le T$, $x, y \in \mathbb{R}^k$, $m \ge 1$ and $i \in \{1, \ldots, d\}$,

$$\|D^{m}(u_{i}(t,x)-u_{i}(s,y))\|_{L^{p}(\Omega;(\mathscr{H}^{d}_{T})^{\otimes m})} \leq C\left(|t-s|^{\frac{2-\beta}{4}}+\|x-y\|^{\frac{2-\beta}{2}}\right).$$
(1.8)

Theorems 1.1 and 1.2 are proved in Section 4. Turning to the negative moments of the smallest eigenvalue of the Malliavin matrix γ_Z of the random vector Z (defined in (1.5)), we have the following sharp estimate, which is an improvement of [6, Proposition 5.6].

Theorem 1.3. Assume **P1** and **P2**. Fix T > 0 and let $I \times J \subset [0,T] \times \mathbb{R}^k$ be a closed non-trivial rectangle (that is, I is a non-trivial interval and $J = J_1 \times \cdots \times J_n$, where J_1, \ldots, J_k are non-trivial intervals). There exists C > 0 depending on T such that for all $s, t \in I, 0 \leq t - s < 1, x, y \in J$, $(s, y) \neq (t, x)$, and p > 1,

$$E\left[\left(\inf_{\substack{\xi = (\lambda, \mu) \in \mathbb{R}^{2d} : \\ \|\lambda\|^2 + \|\mu\|^2 = 1}} \xi^T \gamma_Z \xi \right)^{-2dp} \right] \le C(|t - s|^{\frac{2-\beta}{2}} + \|x - y\|^{2-\beta})^{-2dp}.$$
(1.9)

Theorem 1.3 is proved in Section 5. Using Theorems 1.1, 1.2 and 1.3 and some results of [6], we establish a sharp upper bound on the joint probability density function (denoted by $p_{s,y;t,x}(\cdot, \cdot)$) of the random vector (u(s, y), u(t, x)) and the optimal lower bounds on hitting probabilities of the solution to (1.1).

Theorem 1.4. Assume **P1** and **P2**. Fix T > 0 and let $I \times J \subset [0,T] \times \mathbb{R}^k$ be a closed nontrivial rectangle. There exists c > 0 such that for all $s, t \in I$, $x, y \in J$ with $(s, y) \neq (t, x)$, $z_1, z_2 \in \mathbb{R}^d$ and $p \ge 1$,

$$p_{s,y;t,x}(z_1, z_2) \le c \left[|t-s|^{\frac{2-\beta}{4}} + ||x-y||^{\frac{2-\beta}{2}} \right]^{-d} \left[\frac{\left(|t-s|^{\frac{2-\beta}{4}} + ||x-y||^{\frac{2-\beta}{2}} \right)^2}{||z_1 - z_2||^2} \land 1 \right]^{\frac{x}{2d}}.$$
(1.10)

Theorem 1.5. Assume **P1** and **P2**. Fix T > 0 and M > 0. Let $I \times J \subset [0,T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. There exists c > 0 depending on I, J and M such that for all compact sets $A \subseteq [-M, M]^d$,

$$P\{u(I \times J) \cap A \neq \emptyset\} \ge c \operatorname{Cap}_{d-(\frac{4+2k}{2-\beta})}(A).$$
(1.11)

Theorem 1.4 is an improvement of [6, Theorem 1.6(b)] and Theorem 1.5 is an improvement of [6, Theorem 1.2(b)], and they are proved in Section 3. The main ingredients which allow for these improvements are the sharp L^p -Hölder continuity estimates of Theorems 1.1 and 1.2 and a better estimate on the Malliavin derivative of u(t, x) given in Lemma 5.3 below.

We conclude this section by giving a rigorous formulation of (1.1), following Walsh [18]. We first define precisely the driving noise that appears in (1.1). Let "·" denote the temporal variable and "*" the spatial variable. Let $\mathscr{D}(\mathbb{R}^{k+1})$ be the space of C^{∞} test-functions with compact support. Then $F = \{F(\phi) = (F^1(\phi), \ldots, F^d(\phi)), \phi \in \mathscr{D}(\mathbb{R}^{k+1})\}$ is an $L^2(\Omega, \mathscr{F}, \mathbb{P})^d$ -valued mean zero Gaussian process with covariance

$$\mathbb{E}\left[F^{i}(\phi)F^{j}(\psi)\right] = \delta_{ij} \int_{\mathbb{R}^{+}} dr \int_{\mathbb{R}^{k}} dy \int_{\mathbb{R}^{k}} dz \,\phi(r,y) \|y-z\|^{-\beta} \psi(r,z).$$

Using elementary properties of the Fourier transform (see Dalang [2]), this covariance can also be written as

$$\mathbf{E}\left[F^{i}(\phi)F^{j}(\psi)\right] = \delta_{ij} c_{k,\beta} \int_{\mathbb{R}_{+}} dr \int_{\mathbb{R}^{k}} d\xi \, \|\xi\|^{\beta-k} \mathscr{F}\phi(r,*)(\xi) \overline{\mathscr{F}\psi(r,*)(\xi)},$$

where $c_{k,\beta}$ is a constant and $\mathscr{F}f(\xi)$ is the Fourier transform of f, that is,

$$\mathscr{F}f(\xi) = \int_{\mathbb{R}^k} e^{-i\xi \cdot x} f(x) dx.$$

Following Walsh [18], a rigorous formulation of (1.1) through the notion of *mild* solution is as follows. Let $M = (M^1, \ldots, M^d), M^i = \{M^i_t(A), t \ge 0, A \in \mathscr{B}_b(\mathbb{R}^k)\}$ be the

d-dimensional worthy martingale measure obtained as an extension of the process \dot{F} as in Dalang and Frangos [3], so that the covariation measure of M is

$$Q(A \times B \times]s, t]) = (t - s) \int_A dy \int_B dz \, ||y - z||^{-\beta}$$

and the dominating measure of M is K = Q. Then a *mild solution* of (1.1) is a jointly measurable \mathbb{R}^d -valued process $u = \{u(t, x), t \ge 0, x \in \mathbb{R}^k\}$, adapted to the natural filtration generated by M, such that

$$u_{i}(t,x) = \int_{0}^{t} \int_{\mathbb{R}^{k}} S(t-s,x-y) \sum_{j=1}^{d} \sigma_{ij}(u(s,y)) M^{j}(ds,dy) + \int_{0}^{t} ds \int_{\mathbb{R}^{k}} dy S(t-s,x-y) b_{i}(u(s,y)), \quad i \in \{1,\dots,d\},$$
(1.12)

where S(t,x) is the fundamental solution of the deterministic heat equation in \mathbb{R}^k , that is,

$$S(t,x) = (2\pi t)^{-k/2} \exp\left(-\frac{\|x\|^2}{2t}\right),$$

and the stochastic integral is interpreted in the sense of [18].

Using the results of Dalang [2], existence and uniqueness of the solution of (1.1) holds, as discussed in [6, Section 2], under the condition

$$0 < \beta < (2 \land k), \tag{1.13}$$

and in this case, there exists a unique L^2 -continuous solution of (1.12) satisfying

$$\sup_{(t,x)\in[0,T]\times\mathbb{R}^k} \mathbb{E}\left[|u_i(t,x)|^p\right] < \infty, \quad i \in \{1,\dots,d\},$$
(1.14)

for any T > 0 and $p \ge 1$.

2 Elements of Malliavin calculus

In this section, we introduce, following Nualart [11] (see also [16]), some elements of Malliavin calculus. Let $\mathscr{S}(\mathbb{R}^k)$ be the Schwartz space of C^{∞} functions on \mathbb{R}^k with rapid decrease. Let \mathscr{H} denote the completion of $\mathscr{S}(\mathbb{R}^k)$ endowed with their inner product

$$\begin{split} \langle \phi, \psi \rangle_{\mathscr{H}} &= \int_{\mathbb{R}^k} dx \int_{\mathbb{R}^k} dy \, \phi(x) \|x - y\|^{-\beta} \psi(y) \\ &= c_{k,\beta} \int_{\mathbb{R}^k} d\xi \, \|\xi\|^{\beta - k} \mathscr{F} \phi(\xi) \overline{\mathscr{F} \psi(\xi)}, \end{split}$$

 $\phi, \psi \in \mathscr{S}(\mathbb{R}^k).$

For $h = (h_1, \ldots, h_d) \in \mathscr{H}^d$ and $\tilde{h} = (\tilde{h}_1, \ldots, \tilde{h}_d) \in \mathscr{H}^d$, we set $\langle h, \tilde{h} \rangle_{\mathscr{H}^d} = \sum_{i=1}^d \langle h_i, \tilde{h}_i \rangle_{\mathscr{H}}$. Let T > 0 be fixed. We set $\mathscr{H}_T^d = L^2([0,T]; \mathscr{H}^d)$ and for $0 \le s \le t \le T$, we will write $\mathscr{H}_{s,t}^d = L^2([s,t], \mathscr{H}^d)$.

The centered Gaussian noise F can be used to construct an isonormal Gaussian process $\{W(h), h \in \mathscr{H}_T^d\}$ as follows. Let $\{e_j, j \ge 0\} \subset \mathscr{S}(\mathbb{R}^k)$ be a complete orthonormal system of the Hilbert space \mathscr{H} . Then for any $t \in [0, T]$, $i \in \{1, \ldots, d\}$ and $j \ge 0$, set

$$W_j^i(t) = \int_0^t \int_{\mathbb{R}^k} e_j(x) \cdot F^i(ds, dx),$$

so that $(W_j^i, j \ge 1)$ is a sequence of independent standard real-valued Brownian motions such that, for any $\phi \in \mathscr{D}([0,T] \times \mathbb{R}^k)$,

$$F^{i}(\phi) = \sum_{j=0}^{\infty} \int_{0}^{T} \left\langle \phi(s, *), e_{j}(*) \right\rangle_{\mathscr{H}} dW^{i}_{j}(s),$$

where the series converges in $L^2(\Omega, \mathscr{F}, \mathsf{P})$. For $h^i \in \mathscr{H}_T$, we set

$$W^{i}(h) = \sum_{j=0}^{\infty} \int_{0}^{T} \left\langle h^{i}(s,*), e_{j}(*) \right\rangle_{\mathscr{H}} dW^{i}_{j}(s),$$

where, again, the series converges in $L^2(\Omega, \mathscr{F}, \mathbf{P})$. In particular, for $\phi \in \mathscr{D}([0, T] \times \mathbb{R}^k)$, $F^i(\phi) = W^i(\phi)$. Finally, for $h = (h_1, \ldots, h_d) \in \mathscr{H}^d_T$, we set

$$W(h) = \sum_{i=1}^{d} W^{i}(h^{i}).$$

With this isonormal Gaussian process, we can use the framework of Malliavin calculus. Let S denote the class of smooth random variables of the form

$$G = g(W(h_1), \ldots, W(h_n))$$

where $n \geq 1$, $g \in \mathscr{C}_p^{\infty}(\mathbb{R}^n)$, the set of real-valued functions g such that g and all its partial derivatives have at most polynomial growth and $h_i \in \mathscr{H}_T^d$. Given $G \in S$, its derivative $(D_rG = (D_r^{(1)}G, \ldots, D_r^{(d)}G), r \in [0, T])$ is an \mathscr{H}_T^d -valued random vector defined by

$$D_r G = \sum_{i=1}^n \partial_i g(W(h_1), \dots, W(h_n)) h_i(r).$$

For $\phi \in \mathscr{H}^d$ and $r \in [0,T]$, we write $D_{r,\phi}G = \langle D_rG, \phi(*) \rangle_{\mathscr{H}^d}$. More generally, the derivative $D^mG = (D^m_{(r_1,\ldots,r_m)}, (r_1,\ldots,r_m) \in [0,T]^m)$ of order $m \ge 1$ of G is the $(\mathscr{H}^d_T)^{\otimes m}$ -valued random vector defined by

$$D^m_{(r_1,\ldots,r_m)}G = \sum_{i_1,\ldots,i_m=1}^n \frac{\partial}{\partial x_{i_1}} \cdots \frac{\partial}{\partial x_{i_m}} g(W(h_1),\ldots,W(h_n))h_{i_1}(r_1) \otimes \cdots \otimes h_{i_m}(r_m),$$

where the notation \otimes denotes the tensor product of functions.

For $p, m \ge 1$, the space $\mathbb{D}^{m,p}$ is the closure of S with respect to the seminorm $\|\cdot\|_{m,p}$ defined by

$$\|G\|_{m,p}^p = \mathbb{E}[|G|^p] + \sum_{j=1}^m \mathbb{E}\left[\|D^j G\|_{(\mathscr{H}^d_T)^{\otimes j}}^p\right].$$

We set $\mathbb{D}^{\infty} = \bigcap_{p \geq 1} \bigcap_{m \geq 1} \mathbb{D}^{m,p}$.

The derivative operator D on $L^2(\Omega)$ has an adjoint, termed the Skorohod integral and denoted by δ , which is an unbounded and closed operator on $L^2(\Omega, \mathscr{H}_T^d)$; see [11, Section 1.3]. Its domain, denoted by Dom δ , is the set of elements $u \in L^2(\Omega, \mathscr{H}_T^d)$ such that there exists a constant c such that $|\mathbf{E}[\langle DG, u \rangle_{\mathscr{H}_T^d}]| \leq c ||G||_{0,2}$, for any $G \in \mathbb{D}^{1,2}$. If $u \in \text{Dom } \delta$, then $\delta(u)$ is the element of $L^2(\Omega)$ characterized by the following duality relation:

$$\mathbf{E}[G\,\delta(u)] = \mathbf{E}\left[\langle DG, u \rangle_{\mathscr{H}^d_T}\right], \quad \text{for all } G \in \mathbb{D}^{1,2}.$$

Recall from [6, Section 3] that for $r \in [0, t]$ and $i, l \in \{1, ..., d\}$, the derivative of $u_i(t, x)$ satisfies the system of equations

$$D_r^{(l)}(u_i(t,x)) = \sigma_{il}(u(r,*))S(t-r,x-*) + a_i(l,r,t,x),$$
(2.1)

where

$$a_i(l,r,t,x) = \int_r^t \int_{\mathbb{R}^k} S(t-\theta, x-\eta) \sum_{j=1}^d D_r^{(l)}(\sigma_{ij}(u(\theta,\eta))) M^j(d\theta, d\eta) + \int_r^t d\theta \int_{\mathbb{R}^k} d\eta \, S(t-\theta, x-\eta) D_r^{(l)}(b_i(u(\theta,\eta))),$$
(2.2)

and $D_r^{(l)}(u_i(t,x)) = 0$ if r > t. Moreover, by [13, Proposition 6.1], for any p > 1, $m \ge 1$ and $i \in \{1, \ldots, d\}$, the order m derivative satisfies

$$\sup_{(t,x)\in[0,T]\times\mathbb{R}^k} \mathbb{E}\left[\|D^m(u_i(t,x))\|_{(\mathscr{H}^d_T)^{\otimes m}}^p\right] < \infty,$$
(2.3)

and D^m also satisfies the system of stochastic partial differential equations given in [13, (6.29)] and obtained by iterating the calculation that leads to (2.1). In particular, $u(t,x) \in (\mathbb{D}^{\infty})^d$, for all $(t,x) \in [0,T] \times \mathbb{R}^k$.

3 Proof of Theorems 1.4 and 1.5 (assuming Theorems 1.1-1.3)

Recall that the Malliavin matrix γ_Z of Z = (u(s, y), u(t, x) - u(s, y)) is a symmetric $2d \times 2d$ random matrix with four $d \times d$ blocs of the form

$$\gamma_Z = \begin{pmatrix} \gamma_Z^{(1)} & \vdots & \gamma_Z^{(2)} \\ \vdots & \ddots & \vdots & \ddots \\ \gamma_Z^{(3)} & \vdots & \gamma_Z^{(4)} \end{pmatrix}$$

where

$$\begin{split} \gamma_{Z}^{(1)} &= \Big(\langle D(u_{i}(s,y)), D(u_{j}(s,y)) \rangle_{\mathscr{H}_{T}^{d}} \Big)_{i,j=1,...,d} \,, \\ \gamma_{Z}^{(2)} &= \Big(\langle D(u_{i}(s,y)), D(u_{j}(t,x) - u_{j}(s,y)) \rangle_{\mathscr{H}_{T}^{d}} \Big)_{i,j=1,...,d} \,, \\ \gamma_{Z}^{(3)} &= \Big(\langle D(u_{i}(t,x) - u_{i}(s,y)), D(u_{j}(s,y)) \rangle_{\mathscr{H}_{T}^{d}} \Big)_{i,j=1,...,d} \,, \\ \gamma_{Z}^{(4)} &= \Big(\langle D(u_{i}(t,x) - u_{i}(s,y)), D(u_{j}(t,x) - u_{j}(s,y)) \rangle_{\mathscr{H}_{T}^{d}} \Big)_{i,j=1,...,d} \,. \end{split}$$

We let (1) denote the couples of $\{1, \ldots, d\} \times \{1, \ldots, d\}$, (2) denote the couples of $\{1, \ldots, d\} \times \{d+1, \ldots, 2d\}$, (3) denote the couples of $\{d+1, \ldots, 2d\} \times \{1, \ldots, d\}$ and (4) denote the couples of $\{d+1, \ldots, 2d\} \times \{d+1, \ldots, 2d\}$.

We first state two results which follow exactly along the same lines as [6, Propositions 5.3 and 5.4], using (2.3) and our Theorem 1.2 instead of their [6, (3.2) and Proposition 5.1]. Their proofs are omitted.

Proposition 3.1. Fix T > 0 and let $I \times J \subset [0,T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. Let A_Z denote the cofactor matrix of γ_Z . Assuming **P1**, for any $(s,y), (t,x) \in I \times J$, $(s,y) \neq (t,x), p > 1$,

$$\mathbf{E}\left[|(A_Z)_{m,l}|^p\right]^{1/p} \leq \begin{cases} c_{p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{2d} & \text{if } (m,l) \in (\mathbf{1}), \\ c_{p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{2d-1} & \text{if } (m,l) \in (\mathbf{2}) \text{ or } (\mathbf{3}), \\ c_{p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{2d-2} & \text{if } (m,l) \in (\mathbf{4}). \end{cases}$$

Proposition 3.2. Fix T > 0 and let $I \times J \subset [0, T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. Assuming **P1**, for any $(s, y), (t, x) \in I \times J$, $(s, y) \neq (t, x)$, p > 1,

$$\mathbb{E}\left[\|D^{k}(\gamma_{Z})_{m,l}\|_{\mathscr{H}^{\otimes k}}^{p}\right]^{1/p} \leq \begin{cases} c_{k,p,T} & \text{if } (m,l) \in (\mathbf{1}), \\ c_{k,p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}}) & \text{if } (m,l) \in (\mathbf{2}) \text{ or } (\mathbf{3}), \\ c_{k,p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{2} & \text{if } (m,l) \in (\mathbf{4}). \end{cases}$$

The next result is an improvement of [6, Proposition 5.5].

Proposition 3.3. Fix T > 0 and let $I \times J \subset [0, T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. Assume **P1** and **P2**. There exists C depending on T such that for any $(s, y), (t, x) \in I \times J$, $(s, y) \neq (t, x), p > 1$,

$$\mathbb{E}\left[(\det \gamma_Z)^{-p} \right]^{1/p} \le C(|t-s|^{\frac{2-\beta}{4}} + ||x-y||^{\frac{2-\beta}{2}})^{-2d}.$$
(3.1)

Proof. Similar to the proof of [6, Proposition 5.5] (see also [5, Proposition 6.6]), this is a consequence of [6, (5.11)], our Theorem 1.3 and [6, Proposition 5.7].

From Propositions 3.1–3.3, we obtain the following result, which improves [6, Theorem 5.8]. The proof is similar to that of [6, Theorem 5.8] (but using our Proposition 3.3 instead of [6, Proposition 5.5]) and hence is omitted.

Proposition 3.4. Fix T > 0 and let $I \times J \subset [0, T] \times \mathbb{R}^k$ be a closed non-trivial rectangle. Assume **P1** and **P2**. For any $(s, y), (t, x) \in I \times J$, $(s, y) \neq (t, x)$, $k \ge 0$ and p > 1,

$$\mathbb{E}\left[\|(\gamma_{Z})_{m,l}^{-1}\|_{k,p}\right] \leq \begin{cases} c_{k,p,T} & \text{if } (m,l) \in (\mathbf{1}), \\ c_{k,p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{-1} & \text{if } (m,l) \in (\mathbf{2}) \text{ or } (\mathbf{3}), \\ c_{k,p,T}(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}})^{-2} & \text{if } (m,l) \in (\mathbf{4}). \end{cases}$$
(3.2)

We are now ready to prove Theorems 1.4 and 1.5.

Proof of Theorem 1.4. We recall from the proof of [6, Theorem 1.6(b)] that

$$p_{s,y;t,x}(z_1, z_2) = p_Z(z_1, z_2 - z_1), \text{ for all } z_1, z_2 \in \mathbb{R}^d,$$

and

$$p_{Z}(z_{1}, z_{2} - z_{1}) \leq \prod_{i=1}^{d} \left(\mathbb{P}\left\{ |u_{i}(t, x) - u_{i}(s, y)| > |z_{1}^{i} - z_{2}^{i}| \right\} \right)^{\frac{1}{2d}} \\ \times \|H_{(1, \dots, 2d)}(Z, 1)\|_{0, 2},$$
(3.3)

where the random variable $H_{(1,...,2d)}(Z,1)$ is given by the formula in [6, Corollary 5.10]. Using Chebyshev's inequality and Theorem 1.1, we see that

$$\prod_{i=1}^{d} \left(\mathbf{P}\left\{ |u_i(t,x) - u_i(s,y)| > |z_1^i - z_2^i| \right\} \right)^{\frac{1}{2d}} \le c \left[\frac{\left(|t-s|^{\frac{2-\beta}{4}} + ||x-y||^{\frac{2-\beta}{2}} \right)^2}{||z_1 - z_2||^2} \wedge 1 \right]^{\frac{2}{2d}}.$$

It remains to prove that

$$\|H_{(1,\ldots,2d)}(Z,1)\|_{0,2} \le c_T \left(|t-s|^{\frac{2-\beta}{4}} + \|x-y\|^{\frac{2-\beta}{2}}\right)^{-d}.$$
(3.4)

The proof of (3.4) is similar to that of [6, Proposition 5.11] by using the continuity of the Skorohod integral δ (see [11, Proposition 3.2.1] and [12, (1.11) and p. 131]) and Hölder's inequality for Malliavin norms (see [19, Proposition 1.10, p. 50]). Comparing with the estimate in [6, Proposition 5.11], we are able to remove the extra exponent η because of the correct estimate on the inverse of the matrix γ_Z in Proposition 3.4.

Proof of Theorems 1.5. The proof is similar to that of [6, Theorem 1.2(b)]. We remark that the estimate in [6, Lemma 2.3] remains valid for $\tilde{\gamma} = \gamma = 2 - \beta$. Then by using Theorem 1.4, we follow along the same lines as in the proof of [6, Theorem 1.2(b)] with $d + \eta$ there replaced by d, to obtain the optimal lower bounds on hitting probabilities in terms of capacity.

4 **Proof of Theorems 1.1 and 1.2**

In this section, we establish the L^p -Hölder continuity of the solution and its Malliavin derivative. First, we recall some estimates on the Green kernel S(t, x).

Lemma 4.1. There exist some M_0 , $m_0 > 0$ such that for all t > 0, $x, y \in \mathbb{R}^k$,

$$|S(t,x) - S(t,y)| \le M_0 ||x - y|| t^{-\frac{k+1}{2}} \left(e^{-\frac{||x||^2}{m_0 t}} + e^{-\frac{||y||^2}{m_0 t}} \right).$$
(4.1)

Proof. This is a consequence of the mean-value theorem.

Lemma 4.2 ([1, Lemma 6.4]). There exist some $N_0 > 0$ such that for all t > 0, $x, y \in \mathbb{R}^k$,

$$\int_{\mathbb{R}^k} |S(t, x+z) - S(t, y+z)| dz \le N_0 \left(\frac{\|x-y\|}{t^{1/2}} \wedge 1\right).$$
(4.2)

Lemma 4.3. There exists a constant $C_0 > 0$ such that for all t > 0, $x, y \in \mathbb{R}^k$,

$$\int_{\mathbb{R}^k} \|z\|^{-\beta} |S(t, x+z) - S(t, y+z)| dz \le C_0 t^{-\beta/2} \left(\frac{\|x-y\|}{t^{1/2}} \wedge 1\right).$$
(4.3)

Proof. First, by Lemma 4.1,

$$\begin{split} &\int_{\mathbb{R}^{k}} \|z\|^{-\beta} |S(t, x+z) - S(t, y+z)| dz \\ &\leq M_{0} \|x-y\| t^{-\frac{k+1}{2}} \int_{\mathbb{R}^{k}} \|z\|^{-\beta} \left(e^{-\frac{\|x+z\|^{2}}{m_{0}t}} + e^{-\frac{\|y+z\|^{2}}{m_{0}t}} \right) dz \\ &\leq 2M_{0} \|x-y\| t^{-\frac{k+1}{2}} \sup_{x \in \mathbb{R}^{k}} \int_{\mathbb{R}^{k}} \|z\|^{-\beta} e^{-\frac{\|x+z\|^{2}}{m_{0}t}} dz \\ &= 2M_{0} \|x-y\| t^{-\frac{k+1}{2}} \int_{\mathbb{R}^{k}} \|z\|^{-\beta} e^{-\frac{\|z\|^{2}}{m_{0}t}} dz \\ &= C \|x-y\| t^{-\frac{\beta+1}{2}}, \end{split}$$
(4.4)

where the first equality holds since the function $x \mapsto \int_{\mathbb{R}^k} ||z||^{-\beta} e^{-||x+z||^2/(m_0 t)} dz$ is a nonnegative definite function (its Fourier transform is a nonnegative function), which is therefore maximized at x = 0.

On the other hand, using the same arguments as above,

$$\begin{split} &\int_{\mathbb{R}^{k}} \|z\|^{-\beta} |S(t, x+z) - S(t, y+z)| dz \\ &\leq \int_{\mathbb{R}^{k}} \|z\|^{-\beta} |S(t, x+z) + S(t, y+z)| dz \\ &\leq 2 \sup_{x \in \mathbb{R}^{k}} \int_{\mathbb{R}^{k}} \|z\|^{-\beta} S(t, x+z) dz \\ &= 2 \int_{\mathbb{R}^{k}} \|z\|^{-\beta} S(t, z) dz = C t^{-\frac{\beta}{2}}. \end{split}$$
(4.5)

Therefore, (4.5) and (4.4) imply (4.3).

Proof. By the change of variable [z - v = v'], the integral in (4.6) is equal to

$$\begin{split} \int_{0}^{s} dr \int_{\mathbb{R}^{k}} dz \, |S(r, x - z) - S(r, y - z)| \\ \times \int_{\mathbb{R}^{k}} dv' \, \|v'\|^{-\beta} |S(r, x - z + v') - S(r, y - z + v')|. \end{split}$$

Applying Lemma 4.3 first and then Lemma 4.2, this is bounded above by

$$C \int_{0}^{s} dr \, r^{-\beta/2} \Big(\frac{\|x-y\|}{r^{1/2}} \wedge 1 \Big) \int_{\mathbb{R}^{k}} dz \, |S(r,x-z) - S(r,y-z)|$$

$$\leq C \int_{0}^{s} dr \, r^{-\beta/2} \Big(\frac{\|x-y\|^{2}}{r} \wedge 1 \Big) \leq C \int_{0}^{\infty} dr \, r^{-\beta/2} \Big(\frac{\|x-y\|^{2}}{r} \wedge 1 \Big)$$

$$= C \int_{0}^{\|x-y\|^{2}} r^{-\beta/2} dr + C \|x-y\|^{2} \int_{\|x-y\|^{2}}^{\infty} r^{-\beta/2-1} dr$$

$$= C \|x-y\|^{2-\beta} + C \|x-y\|^{2+2 \times (1-1-\beta/2)} = 2C \|x-y\|^{2-\beta}.$$

Lemma 4.5. There exists a constant C > 0 such that for all $t \ge 0$, $\delta \ge 0$ and $x \in \mathbb{R}^k$,

$$\int_{0}^{t} dr \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \, \|z - v\|^{-\beta} |S(r + \delta, x - z) - S(r, x - z)| \, |S(r + \delta, x - v) - S(r, x - v)| \leq C \delta^{(2-\beta)/2}.$$
(4.7)

Proof. The proof follows the same lines as the proof of [9, Theorem 2]. We include the details here for reader's convenience. Denote I_1 the triple integral on the left-band side of (4.7). Since the two functions $z \mapsto ||z||^{-\beta}$ and $z \mapsto S(r, z)$ are nonnegative definite, the convolution of these two functions is also nonnegative definite and hence maximized at 0. Therefore, for all $x, v \in \mathbb{R}^k$, $\delta \ge 0$ and r > 0,

$$\begin{split} &\int_{\mathbb{R}^{k}} \|z - v\|^{-\beta} |S(r + \delta, x - z) - S(r, x - z)| \, dz \\ &\leq \int_{\mathbb{R}^{k}} \|z\|^{-\beta} (S(r + \delta, x - v - z) + S(r, x - v - z)) \, dz \\ &\leq \int_{\mathbb{R}^{k}} \|z\|^{-\beta} (S(r + \delta, z) + S(r, z)) \, dz \\ &= c \left((r + \delta)^{-\beta/2} + r^{-\beta/2} \right) \leq 2c \, r^{-\beta/2}, \end{split}$$

where the equality follows from the fact $S(r,z) = r^{-k/2}S(1,z/\sqrt{r})$. Therefore, for all $t \ge 0$, $\delta \ge 0$ and $x \in \mathbb{R}^k$,

$$I_1 \le \int_0^t dr \, r^{-\beta/2} \int_{\mathbb{R}^k} dv \, |S(r+\delta, x-v) - S(r, x-v)|.$$

Since there are constants c, C > 0 such that for all r > 0 and $x \in \mathbb{R}^k$, $\frac{\partial S}{\partial r}(r, x) \leq \frac{C}{r}S(cr, x)$,

$$\int_{\mathbb{R}^k} dv \left| S(r+\delta, x-v) - S(r, x-v) \right| \le \int_{\mathbb{R}^k} dv \int_r^{r+\delta} d\rho \, \frac{C}{\rho} \, S(c\rho, x-v)$$

$$= C \int_{r}^{r+\delta} \frac{d\rho}{\rho} = \log(r+\delta) - \log r,$$

we see that

$$I_{1} \leq C \int_{0}^{t} r^{-\beta/2} (\log(r+\delta) - \log r) dr$$

= $\frac{2C}{2-\beta} \left(\log(1+\delta/t) t^{(2-\beta)/2} + \int_{0}^{t} r^{(2-\beta)/2} \frac{\delta}{r(r+\delta)} dr \right)$
:= $\frac{2C}{2-\beta} (I_{3} + I_{4}).$ (4.8)

For I_4 , using the change of variables $s = r/\delta$,

+

$$I_4 = \delta^{(2-\beta)/2} \int_0^{t/\delta} \frac{1}{s^{\beta/2}(s+1)} ds \le \delta^{(2-\beta)/2} \int_0^\infty \frac{1}{s^{\beta/2}(s+1)} ds = c \,\delta^{(2-\beta)/2}. \tag{4.9}$$

In order to estimate I_3 , we use the fact that there exists C > 1 such that for all $\mu > 0$,

$$0 < \log(1+\mu) \le C \mu^{(2-\beta)/2}.$$

Hence,

$$I_3 = \log(1 + \delta/t)t^{(2-\beta)/2} \le C \, (\delta/t)^{(2-\beta)/2} t^{(2-\beta)/2} = C \, \delta^{(2-\beta)/2}. \tag{4.10}$$

Finally, (4.8)–(4.10) imply (4.7).

Remark 4.6. Regarding [9], we point out that in the case of the ordinary heat kernel, the argument for the estimate in [9, (2.26)] does not apply since the lower bound in [9, (1.7)] does not apply to the heat kernel. However, in the case of the heat kernel, the statement of [9, (2.26)] (together with [9, (2.27) and (2.28)]) remains valid by the following calculation:

$$\int_{\mathbb{R}^k} \|x\|^{-\beta} S(r,x) dx = \int_{\mathbb{R}^k} r^{-\beta/2} \|z\|^{-\beta} S(1,z) dz = C r^{-\beta/2}.$$

Based on the above estimates on the Green kernel, we now prove Theorems 1.1 and 1.2.

Proof of Theorem 1.1. By (1.14), it suffices to prove (1.7) when t - s and ||x - y|| are small. Without loss of generality, we assume that $t - s \le 1/2$ and $||x - y|| \le 1/2$. Denote

$$I_{ij}(t,x) = \int_0^t \int_{\mathbb{R}^k} S(t-\theta, x-\eta) \sigma_{ij}(u(\theta,\eta)) M^j(d\theta, d\eta).$$

From (1.12),

$$\begin{split} |u_i(t,x) - u_i(s,y)| &\leq \sum_{j=1}^d |I_{ij}(t,x) - I_{ij}(s,x)| + \sum_{j=1}^d |I_{ij}(s,x) - I_{ij}(s,y)| \\ &+ \int_s^t \int_{\mathbb{R}^k} S(t-\theta,x-\eta) |b_i(u(\theta,\eta))| d\eta d\theta \\ &+ \int_0^s \int_{\mathbb{R}^k} |S(t-\theta,x-\eta) - S(t-\theta,y-\eta)| |b_i(u(\theta,\eta))| d\eta d\theta \\ &+ \int_0^s \int_{\mathbb{R}^k} |S(t-\theta,y-\eta) - S(s-\theta,y-\eta)| |b_i(u(\theta,\eta))| d\eta d\theta \end{split}$$

$$:= I_1 + I_2 + I_3 + I_4 + I_5. \tag{4.11}$$

By Burkholder's inequality, for any $p \ge 2$,

$$\begin{split} \mathbf{E}[|I_1|^p] &\leq c \sum_{j=1}^d \mathbf{E}\left[\left| \int_s^t d\theta \int_{\mathbb{R}^k} dz \int_{\mathbb{R}^k} dv \, \frac{1}{\|z-v\|^{\beta}} \right. \\ & \times S(t-\theta, x-z) \left| \sigma_{ij}(u(\theta,z)) \right| S(t-\theta, x-v) \left| \sigma_{ij}(u(\theta,v)) \right| \right|^{\frac{p}{2}} \right] \\ & + c \sum_{j=1}^d \mathbf{E}\left[\left| \int_0^s d\theta \int_{\mathbb{R}^k} dz \int_{\mathbb{R}^k} dv \, \frac{1}{\|z-v\|^{\beta}} |S(t-\theta, x-z) - S(s-\theta, x-z)| \right. \\ & \left. \times \left| \sigma_{ij}(u(\theta,z)) \right| \left| S(t-\theta, x-v) - S(s-\theta, x-v) \right| \left| \sigma_{ij}(u(\theta,v)) \right| \right|^{\frac{p}{2}} \right]. \end{split}$$

Using Minkowski inequality and the Cauchy-Schwartz inequality, (1.14) and the linear growth property of the functions σ_{ij} , this is bounded above by

$$c\left[\int_{s}^{t} d\theta \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \frac{1}{\|z-v\|^{\beta}} S(t-\theta, x-z) S(t-\theta, x-v)\right]^{\frac{p}{2}} + c\left[\int_{0}^{s} d\theta \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \frac{1}{\|z-v\|^{\beta}} |S(t-\theta, x-z) - S(s-\theta, x-z)| \times |S(t-\theta, x-v) - S(s-\theta, x-v)|\right]^{\frac{p}{2}}.$$

The first term above is equal to $c(t-s)^{(2-\beta)p/4}$ by [6, (6.3)] and the second term above is bounded above by $c(t-s)^{(2-\beta)p/4}$ by Lemma 4.5. Hence for any $p \ge 2$,

$$\mathbf{E}[|I_1|^p] \le c \left(t-s\right)^{\frac{(2-\beta)p}{4}}.$$
(4.12)

Similarly, applying Burkholder's inequality and taking the absolute value inside,

$$\mathbb{E}[|I_2|^p] \le c \sum_{j=1}^d \mathbb{E}\left[\left| \int_0^s dr \int_{\mathbb{R}^k} dz \int_{\mathbb{R}^k} dv \, \|z - v\|^{-\beta} |S(r, x - z) - S(r, y - z)| \, |\sigma_{ij}(u(s - r, z))| \right. \right. \\ \left. \times \left| S(r, x - v) - S(r, y - v)| \, |\sigma_{ij}(u(s - r, v))| \right|^{p/2} \right].$$

By the Minkowski inequality with respect to the measure $||z - v||^{-\beta}|S(r, x - z) - S(r, y - z)||S(r, x - v) - S(r, y - v)|drdvdz$, the Cauchy-Schwartz inequality, (1.14) and the linear growth property of the functions σ_{ij} , this is bounded above by

where the inequality follows from Lemma 4.4.

For the estimate of I_3 , using the Minkowski inequality with respect to the measure $S(t - \theta, x - \eta) d\eta d\theta$, (1.14) and the linear growth property of the functions b_i , we have

where the second inequality follows from [15, Lemme A2].

Similarly, by the Minkowski inequality with respect to the measure $|S(t - \theta, y - \eta) - S(s - \theta, y - \eta)|d\eta d\theta$, (1.14) and the linear growth property of the functions b_i ,

where the second inequality follows from [15, Lemme A3].

Hence, (4.11)–(4.16) imply (1.7).

Proof of Theorem 1.2. The proof is similar to that of Theorem 1.1 by using Lemmas 4.4 and 4.5. From (2.3), we assume that $t - s \le 1/2$ and $||x - y|| \le 1/2$.

Therefore, (4.17)–(4.25) together prove (1.8) for m = 1. The case m > 1 follows along the same lines by induction using (2.3) and the stochastic partial differential equations satisfied by the iterated derivatives (cf. [13, Proposition 6.1]).

5 Proof of Theorem 1.3

We first state an elementary fact that will be used several times later on.

Lemma 5.1. *Fix* $\gamma \in]0, 1[$ *and* $\mu > 0$ *.*

(a) The function $x \mapsto (x + \mu)^{\gamma} - x^{\gamma}$ is nonincreasing on $[0, \infty[$ and the function $x \mapsto x^{\gamma} - (x - \mu)^{\gamma}$ is nonincreasing on $[\mu, \infty[$.

(b) $(1+x)^{\gamma} - 1 \leq \gamma x$ for all $x \geq 0$.

We recall from [6, p. 148] an estimate on the Malliavin derivative of the solution.

Lemma 5.2. For all $q \ge 1$, $0 < \epsilon \le s \le T$ and $s - \epsilon \le \rho \le T$, there exists C > 0 such that for all $i \in \{1, \ldots, d\}$,

Note that (5.1) is exactly the estimate between (6.2) and (6.3) in [6, p. 148] and (5.2) follows from the calculation below [6, (6.3)]. We give the proof of (5.1) in the appendix for reader's convenience.

We next give an estimate on $a_i(l, r, t, x)$, which is a refinement of [6, Lemma 6.2].

Lemma 5.3. Assume **P1**. Fix T > 0, $c_0 > 1$ and $0 < \gamma_0 < 1$. For any $q \ge 1$, there exists a constant $c = c(c_0, \gamma_0, q, T) > 0$ such that for every $0 < \epsilon \le s \le t \le T$ with $t - s > c_0 \epsilon^{\gamma_0}$ and $x \in \mathbb{R}^k$,

$$W := \mathbf{E} \left[\sup_{\xi \in \mathbb{R}^d : \|\xi\| \le 1} \left(\int_{s-\epsilon}^s dr \sum_{l=1}^d \left\| \sum_{i=1}^d a_i(l,r,t,x)\xi_i \right\|_{\mathscr{H}}^2 \right)^q \right]$$

$$I_{1,i} := c \sum_{l=1}^{d} \mathbb{E}\Big[\Big(\int_{a_i}^{b_i} dr \int_{\mathbb{R}^k} dz \int_{\mathbb{R}^k} dv \, \|z - v\|^{-\beta} S(t - r, x - z) \|D_{\cdot,*}(u_l(r, z))\|_{\mathscr{H}^d_{s - \epsilon, s}} \\ \times S(t - r, x - v) \|D_{\cdot,*}(u_l(r, v))\|_{\mathscr{H}^d_{s - \epsilon, s}}\Big)^q\Big],$$

and

$$a_1 = s - \epsilon, \ b_1 = s, \ a_2 = s, \ b_2 = s + c_0 \epsilon^{\gamma_0}, \ a_3 = s + c_0 \epsilon^{\gamma_0}, \ b_3 = t.$$

We now estimate $I_{1,i}$. Applying Hölder's inequality and the Cauchy-Schwartz inequality,

In the case i = 1, we find that, by (5.2) and [6, (6.3)],

$$\leq c \left(\delta^{-\gamma_{0}} \epsilon^{\gamma_{0}} + \epsilon \right)^{\frac{2-\beta}{2}(1+q)} \leq c' \, \epsilon^{\frac{2-\beta}{2}\gamma_{0}(1+q)}, \tag{5.46}$$

where, in the first inequality, we use the assumption $t - s \leq \delta^{-\gamma_0} \epsilon^{\gamma_0}$. Therefore, from (5.45) and (5.46), we obtain

$$\mathbb{E}\left[\sup_{\|\xi\|=1} |A_3|^q\right] \le c \,\epsilon^{\frac{2-\beta}{2}\gamma_0(q-1) + \frac{2-\beta}{2}\gamma_0(1+q)} = c \,\epsilon^{(2-\beta)\gamma_0 q}.$$
(5.47)

We proceed to study the term \tilde{B}_4 . Following the calculation in [6, p. 130], by hypothesis **P1** and the semigroup property of S(t, v),

$$I_{1} = \int_{0}^{\epsilon} dr \int_{\|v\| \le \theta_{0}\sqrt{r}} dv \, \|v\|^{-\beta} (t-s+2r)^{-k/2} \exp\Big(-\frac{\|y-x+v\|^{2}}{2(t-s+2r)}\Big),$$

$$I_{2} = \int_{0}^{\epsilon} dr \int_{\|v\| > \theta_{0}\sqrt{r}} dv \, \|v\|^{-\beta} (t-s+2r)^{-k/2} \exp\Big(-\frac{\|y-x+v\|^{2}}{2(t-s+2r)}\Big).$$

The constant θ_0 above is a fixed and sufficiently large constant such that

$$\frac{2\tilde{c}}{2-\beta}\theta_0^{-\beta} < \frac{3c_0}{8},\tag{5.49}$$

(5.50)

As for I_1 , it is bounded above by

$$\int_0^{\epsilon} dr \, (t-s+2r)^{-k/2} \int_{\|v\| \le \theta_0 \sqrt{r}} dv \, \|v\|^{-\beta},$$

and the *dv*-integral is equal to $c_k \theta_0^{k-\beta} r^{(k-\beta)/2}$, so

$$I_{1} \leq c_{k} \theta_{0}^{k-\beta} \int_{0}^{\epsilon} dr \, r^{(k-\beta)/2} (t-s+2r)^{-k/2}$$

$$\leq c_{k} \theta_{0}^{k-\beta} \int_{0}^{\epsilon} dr \, (t-s+2r)^{-\beta/2}$$

$$= c_{k} \theta_{0}^{k-\beta} (2-\beta)^{-1} \epsilon^{\frac{2-\beta}{2}} \left[(2+(t-s)/\epsilon)^{\frac{2-\beta}{2}} - ((t-s)/\epsilon)^{\frac{2-\beta}{2}} \right]$$

$$\leq c_{k} \theta_{0}^{k-\beta} (2-\beta)^{-1} \epsilon^{\frac{2-\beta}{2}} \left[(2+\delta^{-1})^{\frac{2-\beta}{2}} - (\delta^{-1})^{\frac{2-\beta}{2}} \right], \qquad (5.51)$$

where, in the last inequality, we use the assumption $\epsilon < \delta(t-s)$ and Lemma 5.1(a). Since $\lim_{\delta \to 0} (2+\delta^{-1})^{\frac{2-\beta}{2}} - (\delta^{-1})^{\frac{2-\beta}{2}} = 0$, we choose δ sufficiently small such that

$$B_{3} = \int_{t-\epsilon}^{t} dr \sum_{l=1}^{d} \|\sum_{i=1}^{d} a_{i}(l,r,t,x)\mu_{i}\|_{\mathscr{H}}^{2}.$$

By hypothesis P2 and [6, Lemma 6.1]

$$\tilde{A}_{2} \geq c \|\mu\|^{2} \int_{s-\epsilon}^{s} dr \|S(t-r,x-*)\|_{\mathscr{H}}^{2}$$
$$= c \|\mu\|^{2} \left((t-s+\epsilon)^{\frac{2-\beta}{2}} - (t-s)^{\frac{2-\beta}{2}} \right).$$
(5.58)

Similarly,

$$B_{1} \geq c \|\mu\|^{2} \int_{(t-\epsilon)\vee s}^{t} dr \|S(t-r,x-*)\|_{\mathscr{H}}^{2}$$

= $c \|\mu\|^{2} (t - ((t-\epsilon)\vee s))^{\frac{2-\beta}{2}} = c \|\mu\|^{2} ((t-s)\wedge\epsilon)^{\frac{2-\beta}{2}}.$ (5.59)

From (5.38), (5.58) and (5.59), we see that

$$\begin{split} \tilde{A}_1 + \tilde{A}_2 + B_1 &\geq c \left(\|\lambda - \mu\| \epsilon^{\frac{2-\beta}{2}} + \|\mu\|^2 \left((t-s-\epsilon)^{\frac{2-\beta}{2}} - (t-s)^{\frac{2-\beta}{2}} + ((t-s)\wedge\epsilon)^{\frac{2-\beta}{2}} \right) \right) \\ &= c \, \epsilon^{\frac{2-\beta}{2}} \left(\|\lambda - \mu\| + \|\mu\|^2 \left((\frac{t-s}{\epsilon} + 1)^{\frac{2-\beta}{2}} - (\frac{t-s}{\epsilon})^{\frac{2-\beta}{2}} + ((\frac{t-s}{\epsilon})\wedge 1)^{\frac{2-\beta}{2}} \right) \right) \end{split}$$

Denote $\zeta(x) := (x+1)^{\frac{2-\beta}{2}} - x^{\frac{2-\beta}{2}} + (x \wedge 1)^{\frac{2-\beta}{2}}$, $x \in [0, \infty[$. Then it is clear that $\hat{c}_0 := \min_{0 \le x < \infty} \zeta(x) > 0$. Thus we have

The estimates of A_2 and A_4 in this subcase are the same as those in (5.40) and (5.41) respectively. Hence we have for any $q \ge 1$,

The term B_2 is similar to $J_2^{(2)}$ and B_3 is similar to $J_2^{(3)}$, so as in (5.20) and (5.21), for any $q \ge 1$,

$$\mathsf{E}\Big[\sup_{\|\xi\|=1}|B_2|^q\Big] \le c\,\epsilon^{(2-\beta)q}, \qquad \mathsf{E}\Big[\sup_{\|\xi\|=1}|B_3|^q\Big] \le c\,\epsilon^{(2-\beta)q}. \tag{5.62}$$

Moreover, as in (5.42), by [6, Lemma 6.2] with a = 1, for any $q \ge 1$,

(5.63)

where, in the second inequality, we have used the assumption $t - s \leq \delta^{-1} \epsilon$.

We proceed to estimate the q-th moment of A_3 . Again, we follow the calculation in [6, p. 129], use our Theorem 1.1 instead of their (2.6), to replace their exponent γ by $2 - \beta$. where, in the inequality, we use the assumption $t - s \leq \delta^{-1} \epsilon$. Therefore,

Furthermore, under the assumption $(1 + \alpha)\epsilon^{1/2} < \frac{1}{2}||x - y||$, the estimate of \tilde{B}_4 follows exactly the same lines as in [6, pp. 130–131]. Indeed, by hypothesis **P1** and using change of variable,

$$I_{2} = \int_{0}^{\epsilon} dr \int_{\|v\| \ge \sqrt{r}(1+\alpha)} dv \, \|v\|^{-\beta} (t-s+2r)^{-k/2} \exp\Big(-\frac{\|y-x+v\|^{2}}{2(t-s+2r)}\Big).$$

Using the change of variables $\rho = \frac{t-s+2r}{\alpha^2 \epsilon}$ and the inequality $t-s \le \delta^{-1} \epsilon$, we follow the calculation in [6, pp. 130–131] to see that, under the assumption $(1+\alpha)\epsilon^{1/2} < \frac{1}{2}||x-y||$,

where by (5.61)–(5.66), $\tilde{Z}_{\epsilon} := \sup_{\|\xi\|=1} 8(A_2 + A_3 + A_4 + A_5 + B_2 + B_3)$ satisfies that, for any $q \ge 1$,

$$\mathsf{E}\Big[|\tilde{Z}_{\epsilon}|^q\Big] \le c \,\epsilon^{(2-\beta)q}.\tag{5.68}$$

We choose α large enough so that $\frac{4}{3}\Phi(\alpha) < \frac{c'}{2}$, to get

$$\inf_{\|\xi\|=1} \xi^T \gamma_Z \xi \ge \frac{c'}{2} \,\epsilon^{\frac{2-\beta}{2}} - \tilde{Z}_{\epsilon}. \tag{5.69}$$

Subcase B. In this final subcase, we suppose that $\epsilon < \delta(t-s) \le \delta ||x-y||^2$. Choose and fix $0 < \epsilon < \delta(t-s)$. During the course of our proof of **Case 1**, we established that

Case 1: $\rho \leq s$. Applying Minkowski's inequality with respect to the measure $||z - v||^{-\beta}S(\rho - \theta, x - z)S(\rho - \theta, x - v)dvdzd\theta$,

$$B \leq c \sum_{j=1}^{d} \sup_{(t,x)\in[0,T]\times\mathbb{R}^{k}} \mathbb{E}\left[\|D(u_{j}(t,x))\|_{\mathscr{H}_{T}^{d}}^{2q}\right] \\ \times \left(\int_{s-\epsilon}^{\rho} d\theta \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \, \|z-v\|^{-\beta} S(\rho-\theta,x-z) S(\rho-\theta,x-v)\right)^{q} \\ \leq c \left(\int_{s-\epsilon}^{\rho} d\theta \int_{\mathbb{R}^{k}} \mu(d\xi) |\mathscr{F}S(\rho-\theta,*)(\xi)|^{2}\right)^{q},$$
(A.5)

where the second inequality holds by (2.3). Similarly, using Minkowski's inequality with respect to the measure $S(\rho - \theta, x - \eta)d\theta d\eta$,

$$C \leq c \sum_{j=1}^{a} \sup_{(t,x)\in[0,T]\times\mathbb{R}^{k}} \mathbb{E}\left[\left\|D(u_{j}(t,x))\right\|_{\mathscr{H}_{T}^{q}}^{2q}\right] \left(\int_{s-\epsilon}^{\rho} d\theta \int_{\mathbb{R}^{k}} d\eta S(\rho-\theta,x-\eta)\right)^{2q}$$
$$\leq c \left(\rho-s+\epsilon\right)^{2q} \leq c' \left(\rho-s+\epsilon\right)^{(2-\beta)q/2}$$
$$= c'' \left(\int_{s-\epsilon}^{\rho} d\theta \int_{\mathbb{R}^{k}} \mu(d\xi) |\mathscr{F}S(\rho-\theta,*)(\xi)|^{2}\right)^{q}, \tag{A.6}$$

where the second inequality holds by (2.3) and the equality follows from [6, Lemma 6.1].

Hence, in **Case 1**, (A.2), (A.5) and (A.6) prove (5.1).

Case 2: $\rho > s$. Let $a_1 = s - \epsilon$, $b_1 = s$, $a_2 = s$, $b_2 = \rho$. From (A.3), we bound *B* by $B_1 + B_2$, where for i = 1, 2,

$$B_{i} \leq c \sum_{j=1}^{d} \mathbb{E}\bigg[\bigg(\int_{a_{i}}^{b_{i}} d\theta \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \, \|z - v\|^{-\beta} S(\rho - \theta, x - z) \|D_{\cdot,*} u_{j}(\theta, z)\|_{\mathscr{H}^{d}_{s-\epsilon, s \wedge \theta}} \times S(\rho - \theta, x - v) \|D_{\cdot,*} u_{j}(\theta, v)\|_{\mathscr{H}^{d}_{s-\epsilon, s \wedge \theta}}\bigg)^{q}\bigg].$$

From the calculation in (A.5), we have

$$B_1 \le c \left(\int_{s-\epsilon}^s d\theta \int_{\mathbb{R}^k} \mu(d\xi) |\mathscr{F}S(\rho-\theta,*)(\xi)|^2 \right)^q.$$
(A.7)

Applying Hölder's inequality with respect to the measure $||z - v||^{-\beta}S(\rho - \theta, x - z)S(\rho - \theta, x - v)dvdzd\theta$ and the Cauchy-Schwartz inequality,

$$B_{2} \leq c \sum_{j=1}^{d} \int_{s}^{\rho} d\theta \int_{\mathbb{R}^{k}} dz \int_{\mathbb{R}^{k}} dv \, \|z - v\|^{-\beta} S(\rho - \theta, x - z) S(\rho - \theta, x - v)$$

$$\times \sup_{x \in \mathbb{R}^{k}} \mathbb{E} \left[\|D_{\cdot,*} u_{j}(\theta, x)\|_{\mathscr{H}^{d}_{s-\epsilon,s\wedge\theta}}^{2q} \right]$$

$$= c \sum_{j=1}^{d} \int_{s}^{\rho} d\theta \, (\rho - \theta)^{-\frac{\beta}{2}} \sup_{x \in \mathbb{R}^{k}} \mathbb{E} \left[\|D_{\cdot,*} u_{j}(\theta, x)\|_{\mathscr{H}^{d}_{s-\epsilon,s}}^{2q} \right], \tag{A.8}$$

where the equality follows from [6, (6.3)].

Moreover, from (A.4), we bound C by $C_1 + C_2$, where for i = 1, 2,

$$C_i \le c \sum_{j=1}^d \mathbb{E}\bigg[\bigg(\int_{a_i}^{b_i} d\theta \int_{\mathbb{R}^k} d\eta \, S(\rho - \theta, x - \eta) \| D_{\cdot, *} u_j(\theta, \eta) \|_{\mathscr{H}^d_{s-\epsilon, s \wedge \theta}} \bigg)^{2q} \bigg].$$

Similar to the derivation of the first inequality in (A.6), we see that

$$C_{1} \leq c \left(\int_{s-\epsilon}^{s} d\theta \int_{\mathbb{R}^{k}} d\eta S(\rho - \theta, x - \eta) \right)^{2q} = c \epsilon^{2q}$$

$$\leq c' \left((\rho - s + \epsilon)^{\frac{2-\beta}{2}} - (\rho - s)^{\frac{2-\beta}{2}} \right)^{q}$$

$$= c'' \left(\int_{s-\epsilon}^{s} d\theta \int_{\mathbb{R}^{k}} \mu(d\xi) |\mathscr{F}S(\rho - \theta, *)(\xi)|^{2} \right)^{q},$$
(A.9)

where the second inequality holds since by Lemma 5.1(a), $(\rho - s + \epsilon)^{\frac{2-\beta}{2}} - (\rho - s)^{\frac{2-\beta}{2}} \ge (T + \epsilon)^{\frac{2-\beta}{2}} - T^{\frac{2-\beta}{2}} \ge C \epsilon$ for all $\epsilon \in [0, T]$, and the second equality follows from [6, Lemma 6.1]. Applying Hölder's inequality with respect to the measure $S(\rho - \theta, x - \eta)d\theta d\theta$ and the Cauchy-Schwartz inequality,

$$C_{2} \leq c \sum_{j=1}^{a} \int_{s}^{\rho} d\theta \int_{\mathbb{R}^{k}} d\eta S(\rho - \theta, x - \eta) \sup_{x \in \mathbb{R}^{k}} \mathbb{E} \left[\|D_{\cdot,*} u_{j}(\theta, x)\|_{\mathscr{H}_{s-\epsilon,s\wedge\theta}^{d}}^{2q} \right]$$
$$= c \int_{s}^{\rho} d\theta \sum_{j=1}^{d} \sup_{x \in \mathbb{R}^{k}} \mathbb{E} \left[\|D_{\cdot,*} u_{j}(\theta, x)\|_{\mathscr{H}_{s-\epsilon,s}^{d}}^{2q} \right].$$
(A.10)

Denote

$$\varphi(\theta) = \sum_{j=1}^{d} \sup_{x \in \mathbb{R}^{k}} \mathbb{E} \big[\| D_{\cdot,*} u_{j}(\theta, x) \|_{\mathscr{H}^{d}_{s-\epsilon,s}}^{2q} \big].$$

We deduce, from (A.1), (A.2) and (A.7)-(A.10), that

$$\varphi(\rho) \le c \left(\int_{s-\epsilon}^{s} d\theta \int_{\mathbb{R}^{k}} \mu(d\xi) |\mathscr{F}S(\rho-\theta,*)(\xi)|^{2} \right)^{q} + c \int_{s}^{\rho} (1+(\rho-\theta)^{-\beta/2})\varphi(\theta) d\theta.$$

By Gronwall's lemma ([2, Lemma 15]), we conclude that for $\rho \geq s$,

$$\varphi(\rho) \le c \left(\int_{s-\epsilon}^{s} d\theta \int_{\mathbb{R}^{k}} \mu(d\xi) |\mathscr{F}S(\rho-\theta,*)(\xi)|^{2} \right)^{q},$$

which implies (5.1).
