# Level-set percolation of the Gaussian free field on regular graphs II: finite expanders

#### Abstract

We consider the zero-average Gaussian free field on a certain class of finite $d$-regular graphs for fixed $d \geq 3$. This class includes $d$-regular expanders of large girth and typical realisations of random $d$-regular graphs. We show that the level set of the zero-average Gaussian free field above level $h$ exhibits a phase transition at level $h_{\star}$, which agrees with the critical value for level-set percolation of the Gaussian free field on the infinite $d$-regular tree. More precisely, we show that, with probability tending to one as the size of the finite graphs tends to infinity, the level set above level $h$ does not contain any connected component of larger than logarithmic size whenever $h>h_{\star}$, and on the contrary, whenever $h<h_{\star}$, a linear fraction of the vertices is contained in connected components of the level set above level $h$ having a size of at least a small fractional power of the total size of the graph. It remains open whether in the supercritical phase $h<h_{\star}$, as the size of the graphs tends to infinity, one observes the emergence of a (potentially unique) giant connected component of the level set above level $h$. The proofs in this article make use of results from the accompanying paper [2].

## 1 Introduction

In this article we study level-set percolation of the zero-average Gaussian free field on a class of large $d$-regular graphs with $d \geq 3$. This class contains $d$-regular expanders of large girth and typical realisations of random $d$-regular graphs. Through suitable local approximations of the zero-average Gaussian free field by the Gaussian free field on the infinite $d$-regular tree we are able to establish a phase transition for level-set percolation of the zero-average Gaussian free field which occurs at the critical value for level-set percolation in the infinite model, that is, on the $d$-regular tree.

[^0]Level-set percolation and the local picture of the zero-average Gaussian free field have been previously studied by the first author in [1] for the situation where the underlying sequence of finite graphs is given by the discrete tori of growing side length in dimension $d \geq 3$. The motivation for investigating the zero-average Gaussian free field on the different class of finite graphs considered here (see (1.1)-(1.3) below) stems from the insight that analysing probabilistic models on these types of finite graphs has led to often very explicit and strong results over the years. Examples include the emergence of a giant connected component for Bernoulli bond percolation (see e.g. [4] and recently [15]), cutoff phenomena for random walks (see e.g. [17]) and the appearance of a giant connected component in the vacant set of simple random walk (see e.g. [8]). Actually, we will borrow the assumptions (1.1)-(1.3) on the finite graphs from [8].

From a more general perspective, level-set percolation of the Gaussian free field is a significant representative of a percolation model with long-range dependencies and it has attracted attention for a long time, dating back to [19], [16] and [6]. More recent developments can be found for instance in [21], [20], [23], [11] and [10]. For the particular case of the Gaussian free field on regular trees we also refer to [24], [25] and [2]; for more general transient trees to [3].

We now describe our results more precisely. We let $d \geq 3$ and assume that $\left(\mathcal{G}_{n}\right)_{n \geq 1}$ is a sequence of graphs satisfying the following conditions.
Assumptions 1.1. There exist some $\alpha, \beta>0$ and an increasing sequence of positive integers $\left(N_{n}\right)_{n \geq 1}$ with $N_{n} \xrightarrow{n \rightarrow \infty} \infty$ such that for all $n \geq 1$

- $\mathcal{G}_{n}$ is a simple, connected graph with $N_{n}$ vertices which is d-regular (that is, all its vertices have degree $d$ ),
- for all $x \in \mathcal{G}_{n}$ there is at most one cycle in the ball of radius $\left\lfloor\alpha \log _{d-1}\left(N_{n}\right)\right\rfloor$ around $x$ (see (2.2) and above it for the precise meaning),
- the spectral gap of $\mathcal{G}_{n}$, denoted by $\lambda_{\mathcal{G}_{n}}$, satisfies $\lambda_{\mathcal{G}_{n}} \geq \beta$.

Here by spectral gap we mean the smallest non-zero eigenvalue of $I-P$, where $I$ is the identity matrix and $P$ is the transition matrix of the simple random walk on the graph (see also [22], Definition 2.1.3 and beneath it).

These assumptions are satisfied for two important classes of graphs: (a) random $d$-regular graphs, (b) $d$-regular expanders of large girth. Both classes are subject of intensive research (see for example the monographs [26] for (a) and [14, 18] for (b)). For an explanation of why assumptions (1.1)-(1.3) are satisfied by those two classes of graphs we refer to [8], Section 2.2 and Remark 1.4. We also remark that assumptions very similar to ours were used in recent studies of quantum ergodicity on graphs [5].

On $\mathcal{G}_{n}$ we consider the zero-average Gaussian free field (see Section 2.2 for more details about it) with law $\mathbb{P}^{\mathcal{G}_{n}}$ on $\mathbb{R}^{\mathcal{G}_{n}}$ and canonical coordinate process $\left(\Psi_{\mathcal{G}_{n}}(x)\right)_{x \in \mathcal{G}_{n}}$ so that,
under $\mathbb{P}^{\mathcal{G}_{n}},\left(\Psi_{\mathcal{G}_{n}}(x)\right)_{x \in \mathcal{G}_{n}}$ is a centred Gaussian field on $\mathcal{G}_{n}$ with covariance $\mathbb{E}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}(x) \Psi_{\mathcal{G}_{n}}(y)\right]=G_{\mathcal{G}_{n}}(x, y)$ for all $x, y \in \mathcal{G}_{n}$, where $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ is the zero-
average Green function on $\mathcal{G}_{n}$ (see (2.17)).
The zero-average Gaussian free field is a natural version of the Gaussian free field for finite graphs. However, due to the zero-average property (see below (2.19)), it comes with some peculiarities like the lack of an FKG-inequality and of the domain Markov property.

Our main interest lies in analysing the size (i.e. the number of contained vertices) of the connected components of the level sets of $\Psi_{\mathcal{G}_{n}}$, i.e. of

In order to do so, it will be helpful to locally describe $\Psi_{\mathcal{G}_{n}}$ via the Gaussian free field on the infinite $d$-regular tree $\mathbb{T}_{d}$ with root denoted by o, that is, the centred Gaussian field on $\mathbb{T}_{d}$ with law $\mathbb{P}^{\mathbb{T}_{d}}$ on $\mathbb{R}^{\mathbb{T}_{d}}$ and canonical coordinate process $\left(\varphi_{\mathbb{T}_{d}}(x)\right)_{x \in \mathbb{T}_{d}}$ so that,
under $\mathbb{P}^{\mathbb{T}_{d}},\left(\varphi_{\mathbb{T}_{d}}(x)\right)_{x \in \mathbb{T}_{d}}$ is a centred Gaussian field on $\mathbb{T}_{d}$ with covariance
$\mathbb{E}^{\mathrm{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}(x) \varphi_{\mathbb{T}_{d}}(y)\right]=g_{\mathbb{T}_{d}}(x, y)$ for all $x, y \in \mathbb{T}_{d}$, where $g_{\mathbb{T}_{d}}(\cdot, \cdot)$ is the Green
function of simple random walk on $\mathbb{T}_{d}$ (see (2.7)).
The Gaussian free field on $\mathbb{T}_{d}$ has first been studied in [24]. Recently, more refined results have been obtained by the authors in the accompanying paper [2]. These results lay the groundwork for the present article and they will be central in our analysis of the zero-average Gaussian free field on the graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$. For now, we only recall the critical value of level-set percolation of $\varphi_{\mathrm{T}_{d}}$, that is,

h_{\star}:=\inf \left\{h \in \mathbb{R} \mid \mathbb{P}^{\mathbb{T}_{d}}\left[\left|\mathcal{C}_{o}^{\mathbb{T}_{d}, h}\right|=\infty\right]=0\right\} \tag{1.7}
\end{equation*}

where $\mathcal{C}_{o}^{\mathbb{T}_{d}, h}$ is the connected component of the level set $E_{\bar{\varphi}_{\mathrm{T}_{d}}}^{>h}:=\left\{x \in \mathbb{T}_{d} \mid \varphi_{\mathbb{T}_{d}}(x) \geq h\right\}$ of $\varphi_{\mathbb{T}_{d}}$ above level $h$ containing the root $\mathrm{o} \in \mathbb{T}_{d}$. There is a crucial spectral characterisation of $h_{\star}$ derived in [24], which leads to the proof of $0<h_{\star}<\infty$ on $\mathbb{T}_{d}$ for $d \geq 3$ (see [24], Proposition 3.3 and Corollary 4.5). Actually, in the accompanying paper [2] we make heavy use of this characterisation to obtain new results about $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$.

Our main results concerning the size of the connected components of the level sets of $\Psi_{\mathcal{G}_{n}}$ on the finite graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$ satisfying (1.1)-(1.3) are the following: we show in essence that (see Section 4, Theorem 4.1, for the precise statement)
in the subcritical phase $h>h_{\star}$, with high probability for large $n$, the level set $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ of $\Psi_{\mathcal{G}_{n}}$ only contains microscopic connected components
(i.e. containing at most a logarithmic number of vertices of $\mathcal{G}_{n}$ );
and furthermore that (see Section 5, Theorem 5.1, for the precise statement)
in the supercritical phase $h<h_{\star}$, with high probability for large $n$, a linear fraction of the vertices of $\mathcal{G}_{n}$ is contained in at least mesoscopic connected components of the level set $E_{\bar{\Psi}_{\mathcal{G}_{n}}}^{>h}$ of $\Psi_{\mathcal{G}_{n}}$ (i.e. containing a fractional power of the number of vertices of $\mathcal{G}_{n}$ ).

Although giving a strong hint to, the result (1.9) leaves open whether in the supercritical phase $h<h_{\star}$, with high probability for large $n$, there actually is a macroscopic (giant) connected component in the level set above level $h$, i.e. containing a number of vertices comparable to $\mathcal{G}_{n}$. Furthermore, in the affirmative, one could ask if this giant component is unique, that is, if the second-largest connected component of the level set above level $h<h_{\star}$ only contains a negligible number of vertices compared to $\mathcal{G}_{n}$ (see also Remark 5.7).

As a comparison, the emergence of a unique giant connected component in the supercritical phase has been shown for Bernoulli bond percolation on $d$-regular expanders of large girth in [4] (see also [15]) and for vacant-set percolation of simple random walk on exactly the same graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$ like here in [8]. In the latter, this result is achieved by relating the model to vacant-set percolation of random interlacements on $\mathbb{T}_{d}$. Subsequently, more refined results have been obtained about the vacant set of simple random walk on random regular graphs in [9] and [7].

In the models mentioned above, the assertion of existence and uniqueness of a giant component in the supercritical phase is achieved by a 'sprinkling argument' starting from a statement like (1.9). In our situation, it would correspond to showing that distinct mesoscopic connected components of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ for a supercritical level $h<h_{\star}$ are going to be connected at a slightly smaller level $h^{\prime}<h$ with high probability, thus forming large clusters. As [8] shows, it can be very involved to carry out sprinkling arguments in the non-i.i.d. setting. The main obstacle to perform such an argument in our context are the restrictions stemming from the defining zero-average property of the field we are considering (see below (2.19)). This property prevents the zero-average Gaussian free field from satisfying the FKG-inequality and the domain Markov property (see also Remark 5.7). We point out that sprinkling techniques have been already applied in the discussion of level-set percolation of the Gaussian free field in [12] to construct an infinite connected component with the underlying graph being $\mathbb{Z}^{d}$ for high dimension $d$.

Let us briefly mention in what way the constants $\alpha$ and $\beta$ from the assumptions (1.2) and (1.3) influence the results. The first result (1.8) is essentially not affected by the value of the constants but it relies strongly on their existence (see Remark 4.4 for more details). In contrast, in (1.9) the size of the mesoscopic components depends on the two constants (more precisely, $\alpha$ and $\beta$ appear as multiplicative factors in the fractional power).

Let us now comment on the proofs of Theorem 4.1 and Theorem 5.1 (corresponding to (1.8) and (1.9)). In both cases, the general philosophy is to locally approximate $\Psi_{\mathcal{G}_{n}}$ on the finite graphs by $\varphi_{\mathbb{T}_{d}}$ on the $d$-regular tree and by that reduce the analysis to the infinite model, which is easier to understand. A similar strategy has been successfully carried out in [4] and [8] where the connected components in question are locally approximated by Galton-Watson trees. In our setting the situation is considerably more complicated since neither the connected components of the level sets of $\Psi_{\mathcal{G}_{n}}$ nor the connected components of the level sets of $\varphi_{\mathbb{T}_{d}}$ (used in the approximation) are locally Galton-Watson trees, even if the connected components of $E_{\varphi_{T_{d}}}^{>h}$ share some global properties with them, as shown in [2]. The exact way how the local approximation by $\varphi_{\mathrm{T}_{d}}$ is performed differs considerably between the subcritical and supercritical phase.

In the supercritical phase $h<h_{\star}$, we use an approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathrm{T}_{d}}$ via local charts around vertices of $\mathcal{G}_{n}$ with a tree-like neighbourhood (Theorem 3.1). Then the proof of Theorem 5.1 (corresponding to (1.9)) is, roughly said, a second moment computation based on this local approximation and involving a good control of the supercritical level sets of $\varphi_{\mathbb{T}_{d}}$, obtained in the accompanying paper [2].

More precisely, to show (1.9) we prove that the number of vertices contained in mesoscopic connected components of the level set $E_{\bar{\Psi}_{\mathcal{G}_{n}}}^{\geq h}$ concentrates around its expectation, which we show to grow linearly in the total number of vertices. The concentration follows by a variance computation and a second moment inequality. Actually, when estimating the expectation and variance, it is enough to consider only vertices with a tree-like neighbourhood since the assumption (1.2) (together with (1.1)) guarantees that the number of vertices having a tree-like neighbourhood is comparable to the total number of vertices in $\mathcal{G}_{n}$ (Remark 5.3). Thanks to the approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ around such vertices (Theorem 3.1 mentioned above), we are able to transfer the computations to the regular tree. The linear lower bound on the expectation ((5.9) in Lemma 5.4) now follows rather directly from this approximation and from [2], Theorem 5.3, showing that connected components of the level sets of $\varphi_{\mathrm{T}_{d}}$ are mesoscopic with positive probability in the supercritical phase. The control of the variance follows along similar lines (Lemma 5.6). It requires the approximation of $\Psi_{T_{d}}$ by $\varphi_{T_{d}}$ on neighbourhoods of vertices
with a tree-like and disjoint neighbourhood. This is provided by Theorem 3.1 as well. Once we have reduced the computations to quantities for $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$, we can apply a decoupling inequality ([20], Corollary 1.3) and deduce the bound on the variance again from results on $\varphi_{\mathrm{T}_{d}}$ developed in the accompanying paper [2].

For the subcritical phase $h>h_{\star}$ (Theorem 4.1 corresponding to (1.8)) the local approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ around vertices with tree-like neighbourhood is not good enough. On the one hand, the connected components of $E_{\bar{\Psi}_{\mathcal{G}_{n}}}^{\geq h}$ may have a diameter that is larger than the diameter of those neighbourhoods (at least if $h$ is close to $h_{\star}$ ). On the other hand, one expects that the connected components are typically 'thin'. These two points of 'thinness' and of 'escaping the local charts' suggest that the approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ should rather be carried out along the connected components of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$. We achieve this by employing an exploration process uncovering the connected component of the level set containing a given vertex (Algorithm 1 in Section 4). Roughly said, by exploring $\Psi_{\mathcal{G}_{n}}$ vertex by vertex we are able to couple it vertex by vertex to a number of independent copies of $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$, hence bringing back the problem to the tree. Results from [2] on $\varphi_{\mathbb{T}_{d}}$ in the subcritical phase then conclude the proof.

More precisely, the exploration process aggregates the vertices found in the connected component of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ containing a fixed $x \in \mathcal{G}_{n}$ into a union of disjoint subtrees of $\mathcal{G}_{n}$. The decomposition into a union of disjoint subtrees is determined during the exploration and it is dictated by the geometric properties of the graph $\mathcal{G}_{n}$ and of the evolving set of explored vertices. These geometric conditions guarantee that for each of the disjoint subtrees we can approximate the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ on the subtree by an independent copy of the Gaussian free field $\varphi_{T_{d}}$ on $\mathbb{T}_{d}$ (Lemma 4.5). In order to do so, it is crucial to have a good understanding of the conditional distribution of the zero-average Gaussian free field (Propositions 2.1 and 3.6). As a consequence, the size of each disjoint subtree of $\mathcal{G}_{n}$ constructed by the exploration process is dominated by the size of the connected component containing the root $o \in \mathbb{T}_{d}$ of the level set of $\varphi_{\mathbb{T}_{d}}$ above a slightly lower level $h-\varepsilon$ (Corollary 4.6). The last two ingredients for the proof of (1.8) are now a control on the number of disjoint subtrees (Lemma 4.3, already proven in [8]) and a control on the exponential moments of the size of the connected component of the level set of $\varphi_{T_{d}}$ containing the root $o \in \mathbb{T}_{d}$ in the subcritical phase (see [2], Theorem 6.1).

Incidentally, let us point out that exploration processes are frequently used in the Bernoulli percolation literature and actually, a variant of such an algorithm was applied in [8] to deal with the vacant set of simple random walk in the subcritical phase. However, in our setting we cannot follow the 'standard' procedure. Usually, to show statements like (1.8), a good control on the termination time of the exploration process is necessary, i.e. on the time by which the connected component is completely uncovered. This is typically done by comparing the number of yet unexplored vertices to a random walk of negative drift. In our case this is not possible, essentially again because locally the connected components of $E_{\bar{\Psi}_{\mathcal{G}_{n}}}^{\geq h}$ are not approximated by Galton-Watson trees (as mentioned earlier).

The structure of the article is as follows. In Section 2 we collect the notation and some results on the Gaussian free fields on both the finite graphs and the infinite tree. In particular, in Section 2.1 we recall results on $\varphi_{\mathbb{T}_{d}}$ from [24] and [2]. Then in Section 3 we investigate the local picture of the zero-average Gaussian free field on $\mathcal{G}_{n}$ and its connection to the Gaussian free field on $\mathbb{T}_{d}$. The content of these first two sections will be subsequently used to show Theorem 4.1 (corresponding to (1.8)) and Theorem 5.1 (corresponding to (1.9)). More precisely, in Section 4 we deal with the subcritical phase, ultimately proving the non-existence of connected components of $E_{\bar{\Psi}_{\mathcal{G}_{n}}}^{>h}$ for $h>h_{\star}$ of larger than logarithmic size (Theorem 4.1). Finally, in Section 5 we conclude with the
proof of Theorem 5.1 showing that for $h<h_{\star}$ most vertices of $\mathcal{G}_{n}$ live in a connected component of $E_{\Psi_{\mathcal{G}_{n}}}^{>h}$ of at least mesoscopic size.

## 2 Notation and useful results

In this section we introduce our main notation and recall the essential material about the Gaussian free field on the $d$-regular tree $\mathbb{T}_{d}$ that will be needed in the study of the zero-average Gaussian free field on the finite graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$ (Section 2.1). We then continue with some results on the zero-average Gaussian free field (Section 2.2) and on the zero-average Green function on $\mathcal{G}_{n}$ (Section 2.3).

As mentioned earlier, we consider for fixed $d \geq 3$ the $d$-regular graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$, satisfying the assumptions (1.1)-(1.3). For the constants $\alpha$ and $\beta$ appearing in these assumptions we assume without loss of generality that

$$
\begin{equation*}
\alpha \leq 1 \quad \text { and } \quad \beta \leq 2 \tag{2.1}
\end{equation*}
$$

Indeed, for $\alpha$ this is trivial and for $\beta$ it follows from the fact that the matrix $P$ (see below (1.3)) is a symmetric stochastic matrix and thus all its eigenvalues are contained in the interval $[-1,1]$. Consequently the eigenvalues of $I-P$ are contained in $[0,2]$.

For the general graph notation introduced in the next two paragraphs, $\mathcal{G}$ stands either for $\mathcal{G}_{n}$ or for $\mathrm{T}_{d}$ with root o.

By $x \in \mathcal{G}$ resp. $U \subseteq \mathcal{G}$ we mean a vertex resp. a subset of vertices of the graph $\mathcal{G}$. We let $d_{\mathcal{G}}(\cdot, \cdot)$ denote the graph distance on $\mathcal{G}$. For any $U \subseteq \mathcal{G},|U|$ stands for its cardinality, and $\partial_{\mathcal{G}} U:=\{y \in \mathcal{G} \backslash U \mid y$ has some neighbour $x \in U$ in $\mathcal{G}\}$ denotes its (outer) boundary in $\mathcal{G}$. For any $R \geq 0$ and $x \in \mathcal{G}$ we define the balls and spheres of radius $R$ around $x$ to be $B_{\mathcal{G}}(x, R):=\left\{y \in \mathcal{G} \mid d_{\mathcal{G}}(x, y) \leq R\right\}$ and $S_{\mathcal{G}}(x, R):=\left\{y \in \mathcal{G} \mid d_{\mathcal{G}}(x, y)=R\right\}$. The maximum number of edges that can be deleted from the subgraph of $\mathcal{G}$ induced by some connected subset $U \subseteq \mathcal{G}$ while keeping it connected is called tree excess of $U$ and we denote it by $\operatorname{tx}(U)$. (I.e., $\operatorname{tx}(U):=$ 'number of edges of $\mathcal{G}$ with both vertices in $U^{\prime}-|U|+1$.) Note that $\operatorname{tx}(U)=0$ if and only if (the subgraph induced by) $U$ is a tree. In particular, the assumption (1.2) can be rewritten as

\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x,\left\lfloor\alpha \log _{d-1}\left(N_{n}\right)\right\rfloor\right)\right) \leq 1 \quad \text { for all } n \geq 1 \text { and } x \in \mathcal{G}_{n} \tag{2.2}
\end{equation*}
$$

For $x, z \in \mathcal{G}$ a path from $x$ to $z$ is a sequence of vertices $x=y_{0}, y_{1}, \ldots, y_{m}=z$ in $\mathcal{G}$ for some $m \geq 0$ such that $y_{i}$ and $y_{i-1}$ are neighbours for all $i=1, \ldots, m$ (if $m \geq 1$ ). It is a non-backtracking path from $x$ to $z$ if in addition $y_{i} \neq y_{i-2}$ for all $i=2, \ldots, m$ (if $m \geq 2$ ); note that we are not requiring $y_{i} \neq y_{i-k}$ for $k>2$ here.

We write $P_{x}^{\mathcal{G}}$ for the canonical law of the simple random walk on $\mathcal{G}$ starting at $x \in \mathcal{G}$ as well as $E_{x}^{\mathcal{G}}$ for the corresponding expectation. The canonical process for the discrete-time walk is denoted by $\left(X_{k}\right)_{k \geq 0}$. For the continuous-time walk with i.i.d. mean-one exponential holding times we write $\left(\bar{X}_{t}\right)_{t \geq 0}$. Given $U \subseteq \mathcal{G}$ we write $T_{U}:=\inf \left\{k \geq 0 \mid X_{k} \notin U\right\}$ for the exit time from $U$ and $H_{U}:=\inf \left\{k \geq 0 \mid X_{k} \in U\right\}$ for the entrance time in $U$ of the discrete-time walk (here we set $\inf \emptyset:=\infty$ ). For the continuous-time simple random walk $T_{U}$ and $H_{U}$ are defined accordingly. In the special case of $U=\{z\}$ we use $H_{z}$ in place of $H_{\{z\}}$.

For $\mathcal{G}=\mathbb{T}_{d}$ we need some extra notation. In this case, there is a unique nonbacktracking path of length $d_{\mathbb{T}_{d}}(x, z)$ between any two vertices $x, z \in \mathbb{T}_{d}$ (namely the geodesic path). For $x \in \mathbb{T}_{d} \backslash\{0\}$ let $\bar{x}$ be the unique neighbour of $x$ on the nonbacktracking path from $x$ to $o$. Moreover, let $\overline{\mathrm{o}} \in \mathbb{T}_{d}$ denote a fixed neighbour of the root $\mathrm{o} \in \mathbb{T}_{d}$. For $x \in \mathbb{T}_{d}$ we define

U_{x}:=\left\{z \in \mathbb{T}_{d} \mid \text { the geodesic path from } z \text { to } x \text { does not contain } \bar{x}\right\} . \tag{2.3}
\end{equation*}
$$

In particular $\mathbb{T}_{d}=\{\mathrm{o}\} \cup \bigcup_{i=1}^{d} U_{x_{i}}$ if $S_{\mathrm{T}_{d}}(\mathrm{o}, 1)=:\left\{x_{1}, \ldots, x_{d}\right\}$. In the special case of $x=\mathrm{o}$ we write $\mathbb{T}_{d}^{+}:=U_{\mathrm{o}}$. We also set $B_{\mathbb{T}_{d}}^{+}(\mathrm{o}, R):=\left\{y \in \mathbb{T}_{d}^{+} \mid d_{\mathbb{T}_{d}}(\mathrm{o}, y) \leq R\right\}$ and similarly $S_{\mathrm{T}_{d}}^{+}(\mathrm{o}, R):=\left\{y \in \mathbb{T}_{d}^{+} \mid d_{\mathrm{T}_{d}}(\mathrm{o}, y)=R\right\}$ for $R \geq 0$.

Finally, some notation for the finite graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$. For all $n \geq 1$ and $x \in \mathcal{G}_{n}$ we fix a cover tree $\pi_{n, x}$ of $\mathcal{G}_{n}$ at $x$, that is, a surjective map $\pi_{n, x}: \mathbb{T}_{d} \rightarrow \mathcal{G}_{n}$ such that $\pi_{n, x}(\mathbf{o})=x$ and such that for all $y \in \mathbb{T}_{d}$ one has $\pi_{n, x}\left(S_{\mathbb{T}_{d}}(y, 1)\right)=S_{\mathcal{G}_{n}}\left(\pi_{n, x}(y), 1\right)$, meaning that $\pi_{n, x}$ preserves the neighbourhood of radius 1 of any $y \in \mathbb{T}_{d}$. Note that:
if $x \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0$ for some $R \geq 0$, then the map $\pi_{n, x}$ restricted to $B_{\mathbb{T}_{d}}(\mathbf{o}, R)$ induces a graph isomorphism from $B_{\mathbb{T}_{d}}(\mathbf{o}, R)$ to $B_{\mathcal{G}_{n}}(x, R)$;
a sequence of vertices $o=y_{0}, y_{1}, \ldots, y_{m} \in \mathbb{T}_{d}, m \geq 0$, is a non-backtracking
path in $\mathbb{T}_{d}$ starting at o if and only if $x=\pi_{n, x}\left(y_{0}\right), \pi_{n, x}\left(y_{1}\right), \ldots, \pi_{n, x}\left(y_{m}\right) \in \mathcal{G}_{n}$
is a non-backtracking path in $\mathcal{G}_{n}$ starting at $x$.
Furthermore, for the cover tree $\pi_{n, x}$ of $\mathcal{G}_{n}$ at $x$, the process $\left(\pi_{n, x}\left(X_{k}\right)\right)_{k \geq 0}$ under $P_{o}^{\mathbb{T}_{d}}$ has the same law as $\left(X_{k}\right)_{k \geq 0}$ under $P_{x}^{\mathcal{G}_{n}}$. Hence, for $U \subseteq \mathcal{G}_{n}$ and $k \geq 0$,

P_{x}^{\mathcal{G}_{n}}\left[X_{k} \in U\right]=P_{o}^{\mathrm{T}_{d}}\left[\pi_{n, x}\left(X_{k}\right) \in U\right]=P_{o}^{\mathrm{T}_{d}}\left[X_{k} \in \pi_{n, x}^{-1}(U)\right] \tag{2.6}
\end{equation*}
$$

A final word on the convention followed concerning constants: by $c, c^{\prime}, \ldots$ we denote positive constants with values changing from place to place and which only depend on the dimension $d$ and the constants $\alpha$ and $\beta$ from the assumptions (1.1)-(1.3). Numbered constants $c_{0}, c_{1}, \ldots$ are defined in the place of first occurrence and thereafter remain fixed. The dependence of constants on additional parameters appears in the notation.

### 2.1 Some properties of the Gaussian free field on regular trees

In this section we recall basic facts related to the Green function and the Gaussian free field on $\mathbb{T}_{d}$. We also restate a couple of results about $\varphi_{\mathbb{T}_{d}}$ that were derived by the authors in the accompanying paper [2] and that will be used in several occasions throughout the rest of this article.

The Green function $g_{\mathbb{T}_{d}}(\cdot, \cdot)$ of simple random walk on $\mathbb{T}_{d}$ is (see [28], Lemma 1.24, for the explicit computation)

g_{\mathbb{T}_{d}}(x, y):=E_{x}^{\mathbb{T}_{d}}\left[\sum_{k=0}^{\infty} \mathbf{1}_{\left\{X_{k}=y\right\}}\right]=\frac{d-1}{d-2}\left(\frac{1}{d-1}\right)^{d_{\mathbb{T}_{d}}(x, y)} \text { for } x, y \in \mathbb{T}_{d} \tag{2.7}
\end{equation*}
$$

For $U \subseteq \mathbb{T}_{d}$ the Green function $g_{\mathbb{T}_{d}}^{U}(\cdot, \cdot)$ of simple random walk on $\mathbb{T}_{d}$ killed when exiting $U$ is $g_{\mathbb{T}_{d}}^{U}(x, y):=E_{x}^{\mathrm{T}_{d}}\left[\sum_{0 \leq k<T_{U}} \mathbf{1}_{\left\{X_{k}=y\right\}}\right]$. The functions $g_{\mathbb{T}_{d}}(\cdot, \cdot)$ and $g_{\mathbb{T}_{d}}^{U}(\cdot, \cdot)$ are related by the identity

g_{\mathbb{T}_{d}}(x, y)=g_{\mathbb{T}_{d}}^{U}(x, y)+E_{x}^{\mathbb{T}_{d}}\left[g_{\mathbb{T}_{d}}\left(X_{T_{U}}, y\right) \mathbf{1}_{\left\{T_{U}<\infty\right\}}\right] \quad \text { for } x, y \in \mathbb{T}_{d} \tag{2.8}
\end{equation*}
$$

We continue by collecting known results and properties of $\varphi_{\mathrm{T}_{d}}$. Recall from (1.6) that $\left(\varphi_{\mathbb{T}_{d}}(x)\right)_{x \in \mathbb{T}_{d}}$ is the centred Gaussian field with covariance given by $g_{\mathbb{T}_{d}}(\cdot, \cdot)$. An important feature of the Gaussian free field is the domain Markov property: for $U \subseteq \mathbb{T}_{d}$ let $\left(\varphi_{\mathbb{T}_{d}}^{U}(x)\right)_{x \in \mathbb{T}_{d}}$ be a new field defined by

\varphi_{\mathbb{T}_{d}}^{U}(x):=\varphi_{\mathbb{T}_{d}}(x)-E_{x}^{\mathbb{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}\left(X_{T_{U}}\right) \mathbf{1}_{\left\{T_{U}<\infty\right\}}\right] \quad \text { for } x \in \mathbb{T}_{d}
$$

Then,
under $\mathbb{P}^{\mathbb{T}_{d}},\left(\varphi_{\mathbb{T}_{d}}^{U}(x)\right)_{x \in \mathbb{T}_{d}}$ is a centred Gaussian field on $\mathbb{T}_{d}$ which is independent from $\left(\varphi_{\mathbb{T}_{d}}(x)\right)_{x \in \mathbb{T}_{d} \backslash U}$ and has covariance

$$
\begin{equation*}
\mathbb{E}^{\mathrm{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}^{U}(x) \varphi_{\mathbb{T}_{d}}^{U}(y)\right]=g_{\mathbb{T}_{d}}^{U}(x, y) \text { for all } x, y \in \mathbb{T}_{d} \tag{2.9}
\end{equation*}
$$

As a consequence of (2.9), the Gaussian free field on $\mathbb{T}_{d}$ can be obtained by the following recursive construction (explained in detail in [2], Section 2.1). Let $\left(Y_{x}\right)_{x \in \mathbb{T}_{d}}$ be a collection of independent centred Gaussian variables defined on some auxiliary probability space $(\Omega, \mathcal{A}, \mathbb{P})$ such that $Y_{o} \sim \mathcal{N}\left(0, g_{\mathbb{T}_{d}}(\mathbf{o}, \mathbf{o})\right)=\mathcal{N}\left(0, \frac{d-1}{d-2}\right)$ and $Y_{x} \sim \mathcal{N}\left(0, g_{\mathbb{T}_{d}}^{U_{x}}(x, x)\right)=$ $\mathcal{N}\left(0, \frac{d}{d-1}\right)$ for $x \neq \mathrm{o}$. Define recursively

$$
\begin{equation*}
\widetilde{\varphi}(\mathrm{o}):=Y_{\mathrm{o}} \quad \text { and } \quad \widetilde{\varphi}(x):=\frac{1}{d-1} \widetilde{\varphi}(\bar{x})+Y_{x} \quad \text { for } x \in \mathbb{T}_{d} \backslash\{\mathrm{o}\} \tag{2.10}
\end{equation*}
$$

Then,

$$
\begin{equation*}
\text { under } \mathbb{P} \text {, the law of }(\widetilde{\varphi}(x))_{x \in \mathbb{T}_{d}} \text { is } \mathbb{P}^{\mathbb{T}_{d}}, \tag{2.11}
\end{equation*}
$$

so that (2.10) can be used as an alternative description of $\left(\varphi_{\mathbb{T}_{d}}(x)\right)_{x \in \mathbb{T}_{d}}$. In particular, it gives a representation of the conditional distribution of $\varphi_{\mathbb{T}_{d}}$ given $\varphi_{\mathbb{T}_{d}}(\mathrm{o})=a \in \mathbb{R}$,

$$
\begin{equation*}
\mathbb{P}_{a}^{\mathrm{T}_{d}}\left[\left(\varphi_{\mathbb{T}_{d}}(y)\right)_{y \in \mathbb{T}_{d}} \in \cdot\right]:=\mathbb{P}^{\mathbb{T}_{d}}\left[\left(\varphi_{\mathbb{T}_{d}}(y)\right)_{y \in \mathbb{T}_{d}} \in \cdot \mid \varphi_{\mathbb{T}_{d}}(\mathbf{o})=a\right], \tag{2.12}
\end{equation*}
$$

with corresponding expectation $\mathbb{E}_{a}^{\mathrm{T}_{d}}$.
We turn to known results about level-set percolation of the Gaussian free field on $\mathbb{T}^{d}$ from [24] and [2]. First, there is a characterisation of the critical value $h_{\star}$ through eigenvalues $\left(\lambda_{h}\right)_{h \in \mathbb{R}}$ of certain self-adjoint operators $\left(L_{h}\right)_{h \in \mathbb{R}}$ (see [24], Section 3, summarised in [2], Proposition 2.1). Important for us will be that (see [24], Proposition 3.3)
the map $h \mapsto \lambda_{h}$ is a decreasing homeomorphism from $\mathbb{R}$ to $(0, d-1)$ and $h_{\star}$ is the unique value in $\mathbb{R}$ such that $\lambda_{h_{\star}}=1$.

To restate the other results we remind that $\mathcal{C}_{0}^{\mathbb{T}_{d}, h}$ denotes the connected component of the level set $E_{\varphi_{T_{d}}}^{>h}$ above level $h$ containing the root $o \in \mathbb{T}_{d}$ (see below (1.7)). The second result says that (see [2], Theorem 5.1)
the 'forward percolation probability' $h \mapsto \eta^{+}(h)$ given by $\eta^{+}(h):=$ $\mathbb{P}^{\mathbb{T}_{d}}\left[\left|\mathcal{C}_{0}^{\mathbb{T}_{d}, h} \cap \mathbb{T}_{d}^{+}\right|=\infty\right]$ is continuous and positive on $\left(-\infty, h_{\star}\right)$ and vanishes on $\left(h_{\star}, \infty\right)$.

The third result controls the subcritical behaviour (see [2], Theorem 6.1). It shows that (with $Y \sim \mathcal{N}\left(0, \frac{d}{d-1}\right)$ and $\mathbb{E}^{Y}$ the expectation with respect to $Y$ )
for $h>h_{\star}$ there exists $\delta_{h}>0$ such that the function $g_{h}(a):=$ $\mathbb{E}_{a}^{\mathbb{T}_{d}}\left[\left(1+\delta_{h}\right)^{\mid \mathcal{C}_{o}^{\mathbb{T}_{d}}, h} \cap \mathbb{T}_{d}^{+} \mid\right]$satisfies for all $a \geq h$ the equality $g_{h}(a)=$ $\left(1+\delta_{h}\right) \mathbb{E}^{Y}\left[g_{h}\left(\frac{a}{d-1}+Y\right)\right]^{d-1}$. Moreover, there exist $c_{h}, c_{h}^{\prime}>0$ such that $g_{h}(a) \leq c_{h} \exp \left(c_{h}^{\prime} a^{3 / 2}\right)$ for all $a \geq h$.

Finally, the last result about $\varphi_{\mathbb{T}_{d}}$ needed in the sequel in the supercritical regime is the following fact in which the $\lambda_{h}, h \in \mathbb{R}$, from (2.13) appear: by [2], Theorem 5.3,

\lim _{k \rightarrow \infty} \mathbb{P}^{\mathbb{T}_{d}}\left[\left|\mathcal{C}_{\mathrm{o}}^{\mathbb{T}_{d}, h} \cap S_{\mathbb{T}_{d}}^{+}(\mathbf{o}, k)\right| \geq \frac{\lambda_{h}^{k}}{k^{2}}\right]=\eta^{+}(h)>0 \quad \text { for all } h<h_{\star} \tag{2.16}
\end{equation*}

### 2.2 Some properties of the zero-average Gaussian free field

We now introduce the zero-average Green function associated to the simple random walk on $\mathcal{G}_{n}$. We then remind of a basic property of the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ of similar type as (2.9) (see (2.20) and (2.21)) and use it to compute conditional distributions of $\Psi_{\mathcal{G}_{n}}$ (Proposition 2.1). Let us point out that the formulas for the conditional distribution of the zero-average Gaussian free field are derived without using any particular geometric property of the underlying graph. In other words, the formulas
hold in general for the zero-average Gaussian free field on any (simple and connected) finite graph.

The zero-average Green function $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ associated with the simple random walk on $\mathcal{G}_{n}$ is given by

$$
\begin{equation*}
G_{\mathcal{G}_{n}}(x, y):=\int_{0}^{\infty}\left(P_{x}^{\mathcal{G}_{n}}\left[\bar{X}_{t}=y\right]-\frac{1}{N_{n}}\right) d t \quad \text { for } x, y \in \mathcal{G}_{n} \tag{2.17}
\end{equation*}
$$

It is symmetric, finite and positive-semidefinite, i.e. for any $f: \mathcal{G}_{n} \rightarrow \mathbb{R}$ one has $\sum_{x, y \in \mathcal{G}_{n}} f(x) G_{\mathcal{G}_{n}}(x, y) f(y) \geq 0$ (see [1], Remark 1.2). For $U \subseteq \mathcal{G}_{n}$ we define $g_{\mathcal{G}_{n}}^{U}(\cdot, \cdot)$ to be the Green function of simple random walk on $\mathcal{G}_{n}$ killed when exiting $U$, that is, for $x, y \in \mathcal{G}_{n}$,

$$
\begin{equation*}
g_{\mathcal{G}_{n}}^{U}(x, y):=E_{x}^{\mathcal{G}_{n}}\left[\sum_{0 \leq k<T_{U}} \mathbf{1}_{\left\{X_{k}=y\right\}}\right]=\sum_{k=0}^{\infty} P_{x}^{\mathcal{G}_{n}}\left[X_{k}=y, k<T_{U}\right] . \tag{2.18}
\end{equation*}
$$

As $g_{\mathbb{T}_{d}}^{U}(\cdot, \cdot)$ it is symmetric, finite and vanishes for $x \notin U$ or $y \notin U$. The functions $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ and $g_{\mathcal{G}_{n}}^{U}(\cdot, \cdot)$ are related by a similar expression as the identity (2.8) for the Green functions on $\mathbb{T}_{d}$. More precisely, for $U \subsetneq \mathcal{G}_{n}$ and $x, y \in \mathcal{G}_{n}$ it holds (see [1], Lemma 1.4)

$$
\begin{equation*}
G_{\mathcal{G}_{n}}(x, y)=g_{\mathcal{G}_{n}}^{U}(x, y)+E_{x}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{T_{U}}, y\right)\right]-\frac{1}{N_{n}} E_{x}^{\mathcal{G}_{n}}\left[T_{U}\right] \tag{2.19}
\end{equation*}
$$

(Lemma 1.4 in [1] is stated in the case of a discrete $d$-dimensional torus as underlying graph. However, its proof applies as well to the graph $\mathcal{G}_{n}$.)

Recall from (1.4) that $\left(\Psi_{\mathcal{G}_{n}}(x)\right)_{x \in \mathcal{G}_{n}}$ is the centred Gaussian field with covariance given by $G_{\mathcal{G}_{n}}(\cdot, \cdot)$. We point out that the Green function $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ is called 'zero-average' since its average over $\mathcal{G}_{n}$ in any of the two arguments is zero. This implies that the average of $\Psi_{\mathcal{G}_{n}}(x)$ over $x \in \mathcal{G}_{n}$ vanishes $\mathbb{P}^{\mathcal{G}_{n}}$-almost surely and explains the name 'zero-average Gaussian free field'.

In the same way as the identity (2.8) allows for the property (2.9) of the Gaussian free field $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$, the identity (2.19) implies a similar (but not equal) property of the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$. It is given below and follows from [1], Lemma 1.7. There it is stated and proved for the zero-average Gaussian free field on the discrete $d$-dimensional torus but the proof applies, with the obvious adjustments, also to our situation. For $U \subsetneq \mathcal{G}_{n}$ set

$$
\begin{equation*}
\varphi_{\mathcal{G}_{n}}^{U}(x):=\Psi_{\mathcal{G}_{n}}(x)-E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{T_{U}}\right)\right] \quad \text { for } x \in \mathcal{G}_{n} \tag{2.20}
\end{equation*}
$$

Then,
under $\mathrm{P}^{\mathcal{G}_{n}},\left(\varphi_{\mathcal{G}_{n}}^{U}(x)\right)_{x \in \mathcal{G}_{n}}$ is a centred Gaussian field on $\mathcal{G}_{n}$ with
covariance $\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x) \varphi_{\mathcal{G}_{n}}^{U}(y)\right]=g_{\mathcal{G}_{n}}^{U}(x, y)$ for all $x, y \in \mathcal{G}_{n}$.
Note that $\left(\varphi_{\mathcal{G}_{n}}^{U}(x)\right)_{x \in \mathcal{G}_{n}}$ cannot be independent from $\left(\Psi_{\mathcal{G}_{n}}(x)\right)_{x \in \mathcal{G}_{n} \backslash U}$ due to the zeroaverage property of $\Psi_{\mathcal{G}_{n}}$. However, there is still some independence present, and we will actually take advantage of it in the derivation of conditional distributions of $\Psi_{\mathcal{G}_{n}}$ in Proposition 2.1 (see (2.28)). We would like to remark once more that property (2.21) above and Proposition 2.1 below do not rely on the particular geometry of the graph $\mathcal{G}_{n}$ but hold in general.

We will now compute the exact expression for the conditional distribution of $\Psi_{\mathcal{G}_{n}}(x)$ for $x \in \mathcal{G}_{n}$ given $\Psi_{\mathcal{G}_{n}}$ on some $A \subsetneq \mathcal{G}_{n}$. For the remainder of this section let us introduce the notation $\mathcal{F}_{A}$ with $A \subseteq \mathcal{G}_{n}$ non-empty to denote the $\sigma$-algebra

Proposition 2.1. Let $A \subsetneq \mathcal{G}_{n}$ non-empty and $x \in \mathcal{G}_{n}$. Then $\mathbb{P}^{\mathcal{G}_{n}}$-almost surely

\mathbb{E}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right]=E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{H_{A}}\right)\right]-\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} E_{\pi}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{H_{A}}\right)\right] \tag{2.23}
\end{equation*}
$$

and

$$
\begin{align*}
& \operatorname{Var}_{\mathbb{P}_{\mathcal{G}_{n}}}\left(\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right) \\
& \quad=G_{\mathcal{G}_{n}}(x, x)-E_{x}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right)\right]+\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} E_{\pi}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right)\right] \tag{2.24}
\end{align*}
$$

Here $E_{\pi}^{\mathcal{G}_{n}}$ is the expectation with respect to $\frac{1}{N_{n}} \sum_{z \in \mathcal{G}_{n}} P_{z}^{\mathcal{G}_{n}}$, i.e. the canonical law of simple random walk on $\mathcal{G}_{n}$ starting at a uniformly chosen vertex.

Proof. We will abbreviate $U:=\mathcal{G}_{n} \backslash A \subsetneq \mathcal{G}_{n}$. In particular $T_{U}=H_{A}$. Note that by (2.20) one can write $\Psi_{\mathcal{G}_{n}}(x)=\varphi_{\mathcal{G}_{n}}^{U}(x)+E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{H_{A}}\right)\right]$, the second term actually being $\mathcal{F}_{A^{-}}$ measurable. Hence $\mathbb{E}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right]=E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{H_{A}}\right)\right]+\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right]$ and moreover also $\operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right)=\operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right)$. For (2.23) it is therefore enough to show that $\mathbb{P}^{\mathcal{G}_{n}}$-almost surely

On the other hand, for (2.24) it is enough to show (use (2.19) to manipulate the first two terms on the right hand side of (2.24))

\end{equation*}

Let us fix $x_{0} \in A$. We claim that

\end{equation*}

To see (2.27) first note that $\mathcal{F}_{A}=\sigma\left(\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), \Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), y \in A\right)$. Moreover, by the zero-average property of $\Psi_{\mathcal{G}_{n}}$ (see below (2.19)), one $\mathbb{P}^{\mathcal{G}_{n}}$-almost surely has

& \stackrel{(2.20)}{=}-\frac{1}{N_{n}} \sum_{z \in \mathcal{G}_{n}}\left(\varphi_{\mathcal{G}_{n}}^{U}(z)+E_{z}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{T_{U}}\right)\right]-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right)\right) \\
&=-\frac{1}{N_{n}} \sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)-\frac{1}{N_{n}} \sum_{z \in \mathcal{G}_{n}} E_{z}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{T_{U}}\right)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right)\right]
\end{aligned}
$$

Since the latter sum is $\sigma\left(\Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), y \in A\right)$-measurable, the two $\sigma$-algebras $\sigma\left(\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), \Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), y \in A\right)$ and $\sigma\left(\sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z), \Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right), y \in A\right)$ coincide, which shows (2.27).

Now note that
for $z \in \mathcal{G}_{n}$ and $y \in A$ the Gaussian random variables $\varphi_{\mathcal{G}_{n}}^{U}(z)$ and $\Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right)$ are independent.

Indeed, $\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(z)\left(\Psi_{\mathcal{G}_{n}}(y)-\Psi_{\mathcal{G}_{n}}\left(x_{0}\right)\right)\right]=G_{\mathcal{G}_{n}}(z, y)-E_{z}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{T_{U}}, y\right)\right]-G_{\mathcal{G}_{n}}\left(z, x_{0}\right)+$ $E_{z}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{T_{U}}, x_{0}\right)\right]$ by (2.20) and (1.4). This by (2.19) and (2.18) is equal to $g_{\mathcal{G}_{n}}^{U}(z, y)$ $g_{\mathcal{G}_{n}}^{U}\left(z, x_{0}\right)=0$ (since $y, x_{0} \notin U$ ).

Recall that for random variables $U, Y, Z$ such that $U$ is integrable and $Z$ is independent of $\sigma(U, Y)$ one has $\mathbb{E}[U \mid \sigma(Y, Z)]=\mathbb{E}[U \mid \sigma(Y)]$ almost surely (see e.g. [27], 9.7(k)). Hence $\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right]=\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \sigma\left(\sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)\right)\right] \mathbb{P}^{\mathcal{G}_{n}}$-almost surely by (2.27) and (2.28). Since, in general, $\operatorname{Var}(X \mid \sigma(Y))=\mathbb{E}\left[X^{2} \mid \sigma(Y)\right]-\mathbb{E}[X \mid \sigma(Y)]^{2}$, the same observation shows that one also has $\operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right)=\operatorname{Var}_{\mathbb{P}_{\mathcal{G}_{n}}}\left(\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \sigma\left(\sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)\right)\right)$. Therefore, the conditional expectation and variance to be considered in (2.25) and (2.26) are actually only with respect to the sigma-algebra generated by the single Gaussian random variable $\sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)$. So by the formula for conditional expectation/variance of the bivariate centred Gaussian distribution we have

& \operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right)=\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x)^{2}\right]-\frac{\mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(x) \sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)\right]^{2}}{\mathbb{E}^{\mathcal{G}_{n}}\left[\left(\sum_{z \in U} \varphi_{\mathcal{G}_{n}}^{U}(z)\right)^{2}\right]} . \tag{2.29}
\end{align*}

For every $u \in \mathcal{G}_{n}$ one has $\sum_{z \in U} \mathbb{E}^{\mathcal{G}_{n}}\left[\varphi_{\mathcal{G}_{n}}^{U}(u) \varphi_{\mathcal{G}_{n}}^{U}(z)\right]=\sum_{z \in U} g_{\mathcal{G}_{n}}^{U}(u, z)=E_{u}^{\mathcal{G}_{n}}\left[T_{U}\right]$ by (2.21) and (2.18). By applying this and (2.9) inside (2.29) we obtain

\operatorname{Var}_{\mathbb{P}_{\mathcal{G}_{n}}}\left(\varphi_{\mathcal{G}_{n}}^{U}(x) \mid \mathcal{F}_{A}\right) & =g_{\mathcal{G}_{n}}^{U}(x, x)-\frac{E_{x}^{\mathcal{G}_{n}}\left[T_{U}\right]^{2}}{\sum_{z \in U} E_{z}^{\mathcal{G}_{n}}\left[T_{U}\right]} .
\end{align*}

We are almost done. Observe that by (2.21), (2.20) and the zero-average property of $\Psi_{\mathcal{G}_{n}}$ it $\mathbb{P}^{\mathcal{G}_{n}}$-almost surely holds

This combined with (2.30) shows (2.25). On the other hand, by the formula above (2.30), (2.19) and the zero-average property of $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ (see below (2.19)) one has

& =\frac{1}{N_{n}} \sum_{z \in \mathcal{G}_{n}}\left(E_{z}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{T_{U}}\right), x\right]-\frac{1}{N_{n}} E_{z}^{\mathcal{G}_{n}}\left[T_{U}\right]-G_{\mathcal{G}_{n}}(z, x)\right) \\
& =E_{\pi}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{T_{U}}, x\right)\right]-\frac{E_{\pi}\left[T_{U}\right]}{N_{n}}
\end{aligned}

This combined with (2.30) proves (2.26) and concludes the proof of Proposition 2.1.

### 2.3 An upper bound on the zero-average Green function on $\mathcal{G}_{n}$

We conclude Section 2 with an upper bound on $G_{\mathcal{G}_{n}}(\cdot, \cdot)$ which is going to be of particular use in the proof of Proposition 3.5 needed for the supercritical phase. Note that the obtained bound (2.33) relies on the assumptions (1.1)-(1.3) on the geometry of $\mathcal{G}_{n}$, and resembles the expression for the Green function $g_{\mathbb{T}_{d}}(\cdot, \cdot)$ on $\mathbb{T}_{d}$ (see (2.7)). We first define the new constant

\end{equation*}

In particular, for all $n$ large enough and $x, y \in \mathcal{G}_{n}$ satisfying $d_{\mathcal{G}_{n}}(x, y) \leq \frac{c_{0}}{3} \log _{d-1}\left(N_{n}\right)$ it holds that

For this proof we set $u_{n}:=\frac{c_{0}}{\beta} \ln \left(N_{n}\right)=\frac{\alpha}{d-1} \ln \left(N_{n}\right) \stackrel{(2.1)}{\leq} \ln \left(N_{n}\right)$ and $w_{n}:=$ $\left\lfloor\alpha \log _{d-1}\left(N_{n}\right)\right\rfloor$. By [22], Corollary 2.1.5, one then has (the stationary distribution of $\left(\bar{X}_{t}\right)_{t \geq 0}$ is the uniform distribution on $\mathcal{G}_{n}$ due to (1.1))

On the other hand, by switching to the discrete-time walk $\left(X_{k}\right)_{k \geq 0}$ and with $M_{t} \sim \operatorname{Poi}(t)$ for $t \geq 0$ describing the number of jumps of the continuous-time simple random walk up to time $t$ we have

& \quad \leq \sum_{k=0}^{w_{n}} P_{x}^{\mathcal{G}_{n}}\left[X_{k}=y\right] \underbrace{\int_{0}^{\infty} \frac{t^{k}}{k!} e^{-t} d t}_{=1}+\int_{0}^{u_{n}} \mathbb{P}\left[M_{t} \geq w_{n}\right] d t+\frac{u_{n}}{N_{n}} \tag{2.35}
\end{align*}

Note that for $0 \leq t \leq u_{n}$, by Markov's inequality, $\mathbb{P}\left[M_{t} \geq w_{n}\right]=\mathbb{P}\left[(d-1)^{M_{t}} \geq N_{n}^{\alpha}\right] \leq$ $N_{n}^{-\alpha} \mathbb{E}\left[e^{\ln (d-1) M_{t}}\right]=N_{n}^{-\alpha} e^{t(d-2)} \leq N_{n}^{-\alpha} e^{u_{n}(d-2)}=N_{n}^{-\alpha} e^{\alpha \ln \left(N_{n}\right)-u_{n}}=e^{-u_{n}}=N_{n}^{-c_{0} / \bar{\beta}}$. Therefore (2.35) implies

& \quad{ }_{(2.31)}^{(2.6)} \sum_{k=0}^{w_{n}} P_{o}^{\mathbb{T}_{d}}\left[X_{k} \in \pi_{n, x}^{-1}(\{y\})\right]+2 \ln \left(N_{n}\right) N_{n}^{-\frac{c_{0}}{\beta}}
\end{align*}
$$

for the cover tree $\pi_{n, x}$ of $\mathcal{G}_{n}$ at $x$. To bound the sum appearing on the right hand side of (2.36) we consider different cases for $\pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}\left(\mathrm{o}, w_{n}\right)$.

If $\left|\pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}\left(\mathrm{o}, w_{n}\right)\right|=0$, then the sum on the last line of (2.36) vanishes and together with (2.34) this shows (2.32).

If $\left|\pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}\left(\mathbf{o}, w_{n}\right)\right|=1$, say the intersection is $\{u\}$ (this is in particular the case if $y \in B_{\mathcal{G}_{n}}\left(x, w_{n}\right)$ and $\left.\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, w_{n}\right)\right)=0\right)$, then the sum appearing on the right hand side of (2.36) can be rewritten as

It remains to consider the last case, that is, $\left|\pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}\left(\mathbf{o}, w_{n}\right)\right| \geq 2$. Then $B_{\mathcal{G}_{n}}\left(x, w_{n}\right)$ contains a (unique by (1.2)) cycle of some length $\ell$. Let us abbreviate $B:=$ $B_{\mathbb{T}_{d}}\left(\mathbf{o}, w_{n}\right)$ and define for $m \geq 0$ the disjoint intervals $I_{m}:=\left[d_{\mathcal{G}_{n}}(x, y)+m \ell, d_{\mathcal{G}_{n}}(x, y)+\right.$ $(m+1) \ell$ ) of length $\ell$. We claim that one has the disjoint union

This fact is a direct consequence of Lemma 2.3 stated and proved below. We first conclude the proof of Proposition 2.2 assuming (2.37). The sum on the last line of (2.36) can be bounded, in case $\left|\pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}\left(\mathbf{o}, w_{n}\right)\right| \geq 2$, by

& \stackrel{(2.7)}{=} \sum_{z \in \pi_{n, x}^{-1}(\{y\}) \cap B} \frac{d-1}{d-2}\left(\frac{1}{d-1}\right)^{d_{\mathrm{T}_{d}}(0, z)(2.37)} \leq 2 \frac{d-1}{d-2} \sum_{m=0}^{\infty}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}(x, y)+m \ell} \\
& \quad=2 \frac{d-1}{d-2}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}(x, y)} \frac{1}{1-\left(\frac{1}{d-1}\right)^{\ell}} \leq \frac{16}{7} \frac{d-1}{d-2}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}(x, y)}
\end{aligned}
$$

where in the last step we use that $d \geq 3$ and $\ell \geq 3$, too, since $\ell$ is the length of a cycle. This, combined with (2.34) and (2.36), concludes the proof of (2.32) also in this case, once (2.37) is asserted. To derive (2.33) from (2.32) it is enough to recall that $c_{0} \leq 1$ and $\beta \leq 2$ (see (2.31) and (2.1)). Hence one has $\frac{c_{0}}{3}<\min \left\{c_{0}, \frac{c_{0}}{\beta}\right\}$ and therefore for $n$ large enough also

& \leq \underbrace{\frac{5}{7} \frac{d-1}{d-2}}_{\geq 1}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}(x, y)} \tag{2.38}
\end{align*}
$$

assuming $x, y \in \mathcal{G}_{n}$ are such that $d_{\mathcal{G}_{n}}(x, y) \leq \frac{c_{0}}{3} \log _{d-1}\left(N_{n}\right)$. We can combine (2.32) with (2.38) to obtain (2.33).

To conclude the proof of Proposition 2.2 it only remains to show (2.37), which follows directly from the next lemma.

Lemma 2.3. Let $x \in \mathcal{G}_{n}, R \geq 0$ and assume $B_{\mathcal{G}_{n}}(x, R)$ contains a unique cycle of length $\ell$. Recall that $\pi_{n, x}$ is the fixed cover tree of $\mathcal{G}_{n}$ at $x$ and assume $y \in B_{\mathcal{G}_{n}}(x, R)$. Then

Moreover, for all $k \geq 0$ one has

\end{equation*}

Proof. For any vertex $z \in \pi_{n, x}^{-1}(\{y\}) \cap B_{\mathbb{T}_{d}}(\mathrm{o}, R)$ there is a unique non-backtracking path of length $d_{\mathbb{T}_{d}}(\mathrm{o}, z)$ from o to $z$ in $B_{\mathbb{T}_{d}}(\mathrm{o}, R)$. Therefore, by the one-to-one correspondence from (2.5), every such $z$ uniquely determines a non-backtracking path of length $d_{\mathbb{T}_{d}}(\mathbf{o}, z)$ connecting $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$. Thus (2.39) is clear and for (2.40) it is enough to show that for all $k \geq 0$ one has

Let us denote by $C:=\left\{c_{1}, \ldots, c_{\ell}\right\} \subseteq \mathcal{G}_{n}$ the unique cycle of length $\ell$ in $B_{\mathcal{G}_{n}}(x, R)$ and by $x=x_{0}, \ldots, x_{i}$ for some $i \geq 0$ the unique non-backtracking path in $B_{\mathcal{G}_{n}}(x, R)$ from $x$ to $C$ such that $x_{i} \in C$ and $x_{0}, \ldots, x_{i-1} \notin C$ (if $i \geq 1$ ). This path is unique for if $x=\widetilde{x}_{0}, \ldots, \widetilde{x}_{j}$ was another such path, then one could find a cycle different from $C$ in $\left\{x_{0}, \ldots, x_{i}, \widetilde{x}_{0}, \ldots, \widetilde{x}_{j}, c_{1}, \ldots, c_{\ell}\right\} \subseteq B_{\mathcal{G}_{n}}(x, R)$. Analogously, we let $y=y_{0}, \ldots, y_{j}$ for some
$j \geq 0$ be the unique non-backtracking path in $B_{\mathcal{G}_{n}}(x, R)$ from $y$ to $C$ such that $y_{j} \in C$ and $y_{0}, \ldots, y_{j-1} \notin C$ (if $j \geq 1$ ). We distinguish two cases: either $\left\{x_{0}, \ldots, x_{i}\right\} \cap\left\{y_{0}, \ldots, y_{j}\right\}=\emptyset$ or the intersection is not empty.

In the first case any non-backtracking path from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ starts with the segment $x_{0}, \ldots, x_{i}$ from $x$ to $C$ and ends with the segment $y_{j}, \ldots, y_{0}$ from $C$ to $y$ because a non-backtracking path $v_{0}, \ldots, v_{s}$ from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ with $\left(v_{0}, \ldots, v_{i}\right) \neq\left(x_{0}, \ldots, x_{i}\right)$ or $\left(v_{s-j}, \ldots, v_{s}\right) \neq\left(y_{j}, \ldots, y_{0}\right)$ would imply the existence of a cycle different from $C$ in $\left\{v_{0}, \ldots, v_{s}\right\} \cup\left\{c_{1}, \ldots, c_{\ell}\right\} \cup\left\{x_{0}, \ldots, x_{i}\right\} \cup\left\{y_{0}, \ldots, y_{j}\right\} \subseteq B_{\mathcal{G}_{n}}(x, R)$. In between the segments $x_{0}, \ldots, x_{i}$ and $y_{j}, \ldots, y_{0}$ any of those non-backtracking paths can only visit vertices in $C$ (else there would be another cycle in $B_{\mathcal{G}_{n}}(x, R)$ ) and they can only do so in clockwise or anti-clockwise direction (because they are non-backtracking). To wrap up: any non-backtracking path from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ starts with the segment $x_{0}, \ldots, x_{i}$, then goes $M$ times (for some $M \geq 0$ and some direction) around the cycle $C$ from $x_{i}$ to $x_{i}$, then continues (in the same direction) along the cycle from $x_{i}$ to $y_{j}$ (note that $x_{i} \neq y_{j}$ by assumption) and then ends with the segment $y_{j}, \ldots, y_{0}$.

In the second case, that is if $\left\{x_{0}, \ldots, x_{i}\right\} \cap\left\{y_{0}, \ldots, y_{j}\right\} \neq \emptyset$, let $m \in\{0, \ldots, i\}$ and $m^{\prime} \in\{0, \ldots, j\}$ be such that $x_{m}=y_{m^{\prime}}$ and $\left\{x_{0}, \ldots, x_{m-1}\right\} \cap\left\{y_{0}, \ldots, y_{m^{\prime}-1}\right\}=\emptyset$. In other words, $x_{m}=y_{m^{\prime}}$ is the first common vertex of the paths $x_{0}, \ldots, x_{i}$ and $y_{0}, \ldots, y_{j}$. Any non-backtracking path from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ starts with the segment $x_{0}, \ldots, x_{m}$ and ends with the segment $y_{m^{\prime}}, \ldots, y_{0}$ because a non-backtracking path $v_{0}, \ldots, v_{s}$ from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ with $\left(v_{0}, \ldots, v_{m}\right) \neq\left(x_{0}, \ldots, x_{m}\right)$ or $\left(v_{s-m^{\prime}}, \ldots, v_{s}\right) \neq\left(y_{m^{\prime}}, \ldots, y_{0}\right)$ would imply the existence of a cycle different from $C$ in $\left\{v_{0}, \ldots, v_{s}\right\} \cup\left\{c_{1}, \ldots, c_{\ell}\right\} \cup$ $\left\{x_{0}, \ldots, x_{i}\right\} \cup\left\{y_{0}, \ldots, y_{j}\right\} \subseteq B_{\mathcal{G}_{n}}(x, R)$. In between the segments $x_{0}, \ldots, x_{m}$ and $y_{m^{\prime}}, \ldots, y_{0}$ any of those non-backtracking paths either does not do anything (possible since $x_{m}=$ $y_{m^{\prime}}$ by definition, i.e. the full path is $x_{0}, \ldots, x_{m}, y_{m^{\prime}-1}, \ldots, y_{0}$ ) or it has to form a nonbacktracking path from $x_{m}$ to itself of non-zero length. Note that in any graph a nonbacktracking path (of non-zero length) from a vertex to itself necessarily contains vertices of a cycle. In our situation $C$ is the only cycle in $B_{\mathcal{G}_{n}}(x, R)$ and so any non-backtracking path (of non-zero length) from $x_{m}$ to $x_{m}$ necessarily touches $C$. Therefore, it has to start with the segment $x_{m}, \ldots, x_{i}$ from $x_{m}$ to $C$ and end with the segment $x_{i}, \ldots, x_{m}$ from $C$ to $x_{m}$ (else there would be a cycle different from $C$ in $B_{\mathcal{G}_{n}}(x, R)$ ). Between the segments $x_{m}, \ldots, x_{i}$ and $x_{i}, \ldots, x_{m}$ it can only visit vertices in $C$ (else there would be another cycle in $\left.B_{\mathcal{G}_{n}}(x, R)\right)$ and it has to do at least one full turn around the cycle in clockwise or anti-clockwise direction (because non-backtracking). To wrap up: any non-backtracking path from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ is either of the form $x_{0}, \ldots, x_{m}, y_{m^{\prime}-1}, \ldots, y_{0}$ or between the initial segment $x_{0}, \ldots, x_{m}$ and the final segment $y_{m^{\prime}}, \ldots, y_{0}$ it continues with the segment $x_{m}, \ldots, x_{i}$, then goes $M$ times (for some $M \geq 1$ and some direction) around the cycle $C$ from $x_{i}$ to $x_{i}$ and then goes back to $y_{m^{\prime}}$ through $x_{i}, \ldots, x_{m}$.

In any of the two cases, different non-backtracking paths from $x$ to $y$ in $B_{\mathcal{G}_{n}}(x, R)$ differ by at least $\ell$ in length (the length of the cycle) except if they go around the full cycle both $M$ times but in different directions (clockwise or anti-clockwise). This shows (2.41) and concludes the proof of Lemma 2.3 and hence also of Proposition 2.2.

## 3 The local picture of the zero-average Gaussian free field

In this section we investigate the local behaviour of the zero-average Gaussian free field and we derive key results and estimates that will be used in Section 4 and Section 5 for proving the main theorems of this article (Theorem 4.1 and Theorem 5.1 corresponding to (1.8) and (1.9)). The results in this section support the intuition that the local picture of the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$ is given by the Gaussian free field $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$. We will see two instances here: first we show in Section 3.1 that one
can locally approximate $\Psi_{\mathcal{G}_{n}}$ around vertices of $\mathcal{G}_{n}$ with a tree-like neighbourhood (Theorem 3.1). This will be the type of approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ needed to deal with the supercritical phase in Section 5 and to prove Theorem 5.1 (corresponding to (1.9)). Then in Section 3.2 we derive that in certain situations the conditional distributions of $\Psi_{\mathcal{G}_{n}}$ (given in Proposition 2.1) resemble conditional distributions of $\varphi_{\mathbb{T}_{d}}$ (Proposition 3.6, see also (3.14)). This will be the crucial ingredient for approximating $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ along the connected components of subcritical level sets and ultimately proving Theorem 4.1 (corresponding to (1.8)) in Section 4.

### 3.1 A local approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ on tree-like neighbourhoods

The goal of this section is to prove Theorem 3.1 below, stating the approximation of the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ on neighbourhoods of vertices with tree-like surroundings by the Gaussian free field $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$. This supports the intuition that the local picture of $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$ is given by $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$. The approximation derived here will be used in Section 5 to prove the main result (1.9), i.e. that a linear fraction of the vertices of $\mathcal{G}_{n}$ is contained in mesoscopic connected components of the level set above level $h$ if $h<h_{\star}$. Theorem 3.1 will allow us to reduce the required computations on $\Psi_{\mathcal{G}_{n}}$ to computations on $\varphi_{\mathbb{T}_{d}}$.

For the remainder of Section 3.1 we introduce some notation. Recall (2.4). If $n \geq 1$, $x \in \mathcal{G}_{n}$ and $R \geq 1$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0$, then we use $\rho_{x, R}: B_{\mathcal{G}_{n}}(x, R) \rightarrow B_{\mathbb{T}_{d}}(\mathrm{o}, R)$ to denote the graph isomorphism given by $\left(\left.\pi_{n, x}\right|_{B_{\mathbb{T}_{d}}(0, R)}\right)^{-1}$. Furthermore, for all $n \geq 1$ and pairs $x, x^{\prime} \in \mathcal{G}_{n}$ we fix $z_{x, x^{\prime}} \in \pi_{n, x}^{-1}\left(\left\{x^{\prime}\right\}\right) \subseteq \mathbb{T}_{d}$. If $n \geq 1, x, x^{\prime} \in \mathcal{G}_{n}, R \geq 1$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)\right)=0$ and $B_{\mathcal{G}_{n}}(x, R) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)=\emptyset$, then let $\rho_{x, x^{\prime}, R}$ : $B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right) \rightarrow B_{\mathbb{T}_{d}}(\mathrm{o}, R) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R\right)$ denote the graph isomorphism given by $\left(\left.\pi_{n, x}\right|_{B_{\mathbb{T}_{d}}(0, R) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R\right)}\right)^{-1}$. Finally, recall the constant $c_{0}$ from (2.31). The main result of this section is the following
Theorem 3.1. For all $n$ large enough, $x, x^{\prime} \in \mathcal{G}_{n}, 1 \leq r<R \leq \frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, 2 R)\right)=\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R\right)\right)=0$ and $B_{\mathcal{G}_{n}}(x, 2 R) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R\right)=\emptyset$, there exists a coupling $\mathbb{Q}_{n}$ of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ such that for all $\varepsilon>0$

& \mathbb{Q}_{n}\left[\sup _{y \in B_{\mathcal{G}_{n}}(x, r) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, r\right)}\left|\Psi_{\mathcal{G}_{n}}(y)-\varphi_{\mathbb{T}_{d}}\left(\rho_{x, x^{\prime}, 2 R}(y)\right)\right|>\varepsilon\right]  \tag{3.1}\\
& \quad \leq 8 d(d-1)^{r} \exp \left(-\frac{\varepsilon^{2}(d-1)(d-2)}{24 d^{2}}(d-1)^{R-2 r}\right)
\end{align*}
$$

In particular, for all large $n, x \in \mathcal{G}_{n}, 1 \leq r<R \leq \frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, 2 R)\right)=0$, there exists a coupling $\mathbb{Q}_{n}$ of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ such that for all $\varepsilon>0$ the same bound as in (3.1) applies to $\mathbb{Q}_{n}\left[\sup _{y \in B_{\mathcal{G}_{n}}(x, r)}\left|\Psi_{\mathcal{G}_{n}}(y)-\varphi_{\mathbb{T}_{d}}\left(\rho_{x, 2 R}(y)\right)\right|>\varepsilon\right]$.

We now proceed with some preparations for the proof of Theorem 3.1. The first goal is an easy preliminary coupling of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathrm{T}_{d}}$ around vertices of $\mathcal{G}_{n}$ with tree-like neighbourhood (Lemma 3.3). In its proof we use the following observation.
Remark 3.2. Let $x, x^{\prime} \in \mathcal{G}_{n}$ and $R \geq 1$ satisfy $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0, \operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)\right)=0$ and $B_{\mathcal{G}_{n}}(x, R) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)=\emptyset$. Assume that $U \subseteq B_{\mathcal{G}_{n}}(x, R-1) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R-1\right)$, so that $\partial_{\mathcal{G}_{n}} U \subseteq B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)$. Then for any $y \in B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right) \subseteq \mathcal{G}_{n}$ the image under $\pi_{n, x}$ of the law of the simple random walk on $\mathbb{T}_{d}$ started at $\rho_{x, x^{\prime}, R}(y) \in$ $B_{\mathbb{T}_{d}}(\mathbf{o}, R) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R\right) \subseteq \mathbb{T}_{d}$ and stopped when exiting $\rho_{x, x^{\prime}, R}(U)$ is the same as the law of the simple random walk on $\mathcal{G}_{n}$ started at $y$ and stopped when exiting $U$. In particular, the hitting distribution of the boundary $\partial_{\mathcal{G}_{n}} U$ of the walk on $\mathcal{G}_{n}$ is the image under $\pi_{n, x}$ of the hitting distribution of $\partial_{\mathbb{T}_{d}} \rho_{x, x^{\prime}, R}(U)$ of the walk on $\mathbb{T}_{d}$, that is, for all $y \in U$ and
$z \in \partial_{\mathcal{G}_{n}} U$ we have

Similarly, for any $x \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0, U \subseteq B_{\mathcal{G}_{n}}(x, R-1)$, and $y \in B_{\mathcal{G}_{n}}(x, R) \subseteq$ $\mathcal{G}_{n}$ the image under $\pi_{n, x}$ of the law of the simple random walk on $\mathbb{T}_{d}$ started at $\rho_{x, R}(y) \in$ $B_{\mathbb{T}_{d}}(\mathrm{o}, R) \subseteq \mathbb{T}_{d}$ and stopped when exiting $\rho_{x, R}(U)$ is the same as the law of the simple random walk on $\mathcal{G}_{n}$ started at $y$ and stopped when exiting $U$. So (3.2) holds for $\rho_{x, x^{\prime}, R}$ replaced by $\rho_{x, R}$.

As a direct implication of the above Remark 3.2 we obtain a straightforward way to couple $\Psi_{\mathcal{G}_{n}}$ on $B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)$ with $\varphi_{\mathbb{T}_{d}}$ on $B_{\mathbb{T}_{d}}(\mathbf{o}, R) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R\right)$.
Lemma 3.3. Assume that $x, x^{\prime} \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)\right)=0$ satisfy $B_{\mathcal{G}_{n}}(x, R) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)=\emptyset$ for some $R \geq 1$. Let $U \subseteq B_{\mathcal{G}_{n}}(x, R-1) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R-1\right)$. Then there exists a coupling of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ such that for all $y \in B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)$ one has

\begin{equation*}
\Psi_{\mathcal{G}_{n}}(y)-E_{y}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{T_{U}}\right)\right]=\varphi_{\mathbb{T}_{d}}\left(\rho_{x, x^{\prime}, R}(y)\right)-E_{\rho_{x, x^{\prime}, R}(y)}^{\mathrm{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}\left(X_{T_{\rho_{x, x^{\prime}, R}(U)}}\right)\right] . \tag{3.3}
\end{equation*}
$$

Similarly, if we only have $x \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0$ for some $R \geq 1$ and $U \subseteq$ $B_{\mathcal{G}_{n}}(x, R-1)$, then (3.3) holds for all $y \in B_{\mathcal{G}_{n}}(x, R)$ with $\rho_{x, x^{\prime}, R}$ replaced by $\rho_{x, R}$.

Proof. The proof is analogous to the proof of Lemma 1.10 in [1]. Since both sides of (3.3) describe centred Gaussian fields, it is enough to check that the covariance is the same. By (2.21) resp. by (2.9) the covariance of the field for $y, z \in B_{\mathcal{G}_{n}}(x, R) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)$ is $g_{\mathcal{G}_{n}}^{U}(y, z)$ on the left resp. $g_{\mathbb{T}_{d}}^{\rho_{x, x^{\prime}, R}(U)}\left(\rho_{x, x^{\prime}, R}(y), \rho_{x, x^{\prime}, R}(z)\right)$ on the right hand side. These two covariances are equal by Remark 3.2 and hence the proof is complete.

We can now lay out the strategy for proving Theorem 3.1. The idea is to combine the coupling of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ from Lemma 3.3 (for some suitable choice of $U$ ) with uniform bounds on the variance of the expectations appearing in (3.3). These uniform bounds are shown in Proposition 3.5 and will ultimately lead to the proof of Theorem 3.1. Before that, we show a simple estimate of the hitting distribution of a sphere by the simple random walk on $\mathbb{T}_{d}$ (Lemma 3.4). This estimate is needed for the proof of the bounds in Proposition 3.5.
Lemma 3.4. Let $R \geq 0$. Then for all $y \in B_{\mathbb{T}_{d}}(\mathbf{o}, R)$ and $z \in S_{\mathbb{T}_{d}}(\mathbf{o}, R)$ one has

Proof. Note that the statement we need to prove only depends on the distance of the vertex $y$ to the centre of $B_{\mathbb{T}_{d}}(\mathbf{o}, R)$. We denote by $\mathrm{o}=y_{0}, y_{1}, \ldots, y_{R}$ a fixed nonbacktracking path from o to $S_{\mathrm{T}_{d}}(\mathrm{o}, R)=: S$, so that $d_{\mathbb{T}_{d}}\left(y_{k}, \mathrm{o}\right)=k$ for $k=0, \ldots, R$. First, we argue that $P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=z\right] \leq P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=y_{R}\right]$ for all $z \in S$ and $k=0, \ldots, R$. Indeed, fix $z \in S$ and $k \in\{0, \ldots, R\}$ and let

so that $y_{i_{0}}$ is the last common vertex of the two non-backtracking paths from o to $z$ resp. to $y_{R}$. Note that any path from $y_{k}$ to $z$ in $\mathbb{T}_{d}$ has to pass through $y_{i_{0}}$ and also that $P_{y_{i_{0}}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=z\right]=P_{y_{i_{0}}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=y_{R}\right]$ because $z, y_{R} \in S$ and $d_{\mathbb{T}_{d}}\left(y_{i_{0}}, z\right)=d_{\mathbb{T}_{d}}\left(y_{i_{0}}, y_{R}\right)$ by definition of $y_{i_{0}}$. As claimed, one obtains

& \stackrel{(*)}{=} P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=y_{R}, H_{y_{i_{0}}} \leq H_{S}\right] \leq P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=y_{R}\right],
\end{aligned}
$$

where in both $(*)$ we use the strong Markov property.
It remains to show $P_{y_{k}}^{\mathbb{T}_{d}}\left[X_{H_{S}}=y_{R}\right] \leq(d-1)^{-(R-k)}$ for $k=0, \ldots, R$. To this end, let $A_{k}:=S_{\mathrm{T}_{d}}(\mathrm{o}, R) \cap U_{y_{k}}$ (see (2.3)). By definition we have $y_{R} \in A_{k}$ and $\left|A_{k}\right|=(d-1)^{R-k}$. Moreover, by symmetry it holds $P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=z\right]=P_{y_{k}}^{\mathrm{T}_{d}}\left[X_{H_{S}}=y_{R}\right]$ for all $z \in A_{k}$. Hence

from which the required claim follows directly.
Proposition 3.5. For all $R \geq 1$ and $y \in B_{\mathbb{T}_{d}}(\mathrm{o}, R)$ one has

\operatorname{Var}_{\mathbb{P}^{T_{d}}}\left(E_{y}^{\mathbb{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}\left(X_{H_{S_{\mathrm{T}_{d}}(0, R)}}\right)\right]\right) \leq \frac{d^{2}}{(d-1)(d-2)}\left(\frac{1}{d-1}\right)^{R-2 d_{\mathrm{T}_{d}}(y, \mathrm{o})} \tag{3.5}
\end{equation*}

Also, for all $n$ large enough, $x \in \mathcal{G}_{n}$ and $1 \leq R \leq \frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, 2 R)\right)=0$ and $y \in B_{\mathcal{G}_{n}}(x, R)$ one has

Proof. We start with (3.5). Let us abbreviate $S:=S_{\mathbb{T}_{d}}(\mathrm{o}, R)$. We first expand the variance to obtain

Fix $z_{1} \in S$. Note that all vertices of $S$ are at even distance from $z_{1}$ and more precisely that in $S$ there is/there are

This implies that for fixed $z_{1} \in S$ it holds

Since $|S|=d(d-1)^{R-1}$, we can combine (3.7) and (3.9) to obtain

which is equal to the right hand side of (3.5) and concludes the proof of the first part.
For the proof of (3.6) we proceed similarly. Let us abbreviate $S^{\prime}:=S_{\mathcal{G}_{n}}(x, R)$ and note that $P_{y}^{\mathcal{G}_{n}}$-almost surely $H_{S^{\prime}}=T_{B_{\mathcal{G}_{n}}(x, R-1)}$. Since by assumption we have $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, 2 R)\right)=0$, Remark 3.2 implies that for every $z \in S^{\prime}$ we have

\end{aligned} .

Furthermore, for $n$ large enough, the inequality (2.33) in Proposition 2.2 applies to $G_{\mathcal{G}_{n}}\left(z_{1}, z_{2}\right)$ with $z_{1}, z_{2} \in S^{\prime}$ since $d_{\mathcal{G}_{n}}\left(z_{1}, z_{2}\right) \leq 2 R \leq \frac{c_{0}}{3} \log _{d-1}\left(N_{n}\right)$ by assumption on $R$. Therefore, by expanding the variance we obtain similarly to (3.7) the inequality

& \leq 3 \frac{d-1}{d-2}\left(\frac{1}{d-1}\right)^{2\left(R-d_{\mathcal{G}_{n}}(y, x)\right)} \sum_{z_{1}, z_{2} \in S^{\prime}}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}\left(z_{1}, z_{2}\right)} \tag{3.10}
\end{align*}
$$

assuming $n$ is large enough. We now argue that for fixed $z_{1} \in S^{\prime}$ the vertices in $S^{\prime}$ can be again characterised by (3.8). Indeed, the assumption $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, 2 R)\right)=0$ implies that any shortest path from $z_{1}$ to some $z_{2} \in S^{\prime}$ necessarily remains in $B_{\mathcal{G}_{n}}(x, R)$ for which $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0$ holds. Therefore, $d_{\mathcal{G}_{n}}\left(z_{1}, z_{2}\right)$ can be computed by only considering the shortest connection in $B_{\mathcal{G}_{n}}(x, R)$ between $z_{1}$ and $z_{2}$ and so we are in the tree-like situation of (3.8). Thus, the same computation as in (3.9) leads to $\sum_{z_{2} \in S^{\prime}}\left(\frac{1}{d-1}\right)^{d_{\mathcal{G}_{n}}\left(z_{1}, z_{2}\right)}=\frac{d}{d-1}$. This combined with (3.10) concludes the proof of (3.6) since $\left|S^{\prime}\right|=d(d-1)^{R-1}$ as $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, R)\right)=0$.

We now have all the ingredients for the proof of Theorem 3.1, by which we conclude Section 3.1.

Proof of Theorem 3.1. Let us abbreviate $V:=B_{\mathcal{G}_{n}}(x, r) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, r\right)$ and also $\rho:=\rho_{x, x^{\prime}, R}$. Under the assumptions of the theorem we can apply Lemma 3.3 with $U:=B_{\mathcal{G}_{n}}(x, R-1) \cup$ $B_{\mathcal{G}_{n}}\left(x^{\prime}, R-1\right) \supseteq V$. Thus we obtain a coupling $\mathbb{Q}_{n}$ of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ such that for all $\varepsilon>0$

\end{align*}

where $\rho(U)=B_{\mathbb{T}_{d}}(\mathrm{o}, R-1) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R-1\right) \subseteq B_{\mathbb{T}_{d}}(\mathrm{o}, 2 R) \cup B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, 2 R\right)$. We now consider the two terms on the right hand side of (3.11) separately. For the first term a union bound leads to, abbreviating $S:=S_{\mathbb{T}_{d}}(\mathbf{o}, R)$ and $S^{\prime}:=S_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, R\right)$,

& \quad+\sum_{y \in B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, r\right)} \mathbb{P}^{\mathbb{T}_{d}}\left[\left|E_{y}^{\mathrm{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}\left(X_{H_{S^{\prime}}}\right)\right]\right|>\frac{\varepsilon}{2}\right]

The expectations appearing inside the probabilities on the right hand side of (3.12) are centred Gaussian variables with respect to $\mathbb{P}^{\mathrm{T}_{d}}$. By (3.5) their variance is bounded by $\frac{d^{2}}{(d-1)(d-2)}\left(\frac{1}{d-1}\right)^{R-2 r}$. Hence the exponential Markov inequality implies that the probabilities on the right hand side of (3.12) are bounded by $2 \exp \left(-\frac{\varepsilon^{2}(d-1)(d-2)}{8 d^{2}}(d-1)^{R-2 r}\right)$.

For the second term on the right hand side of (3.11) we similarly have by a union bound that, abbreviating $\bar{S}:=S_{\mathcal{G}_{n}}(x, R)$ and $\bar{S}^{\prime}:=S_{\mathcal{G}_{n}}\left(x^{\prime}, R\right)$,

& \quad+\sum_{y \in B_{\mathcal{G}_{n}}\left(x^{\prime}, r\right)} \mathbb{P}^{\mathcal{G}_{n}}\left[\left|E_{y}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(X_{H_{\bar{S}^{\prime}}}\right)\right]\right|>\frac{\varepsilon}{2}\right] .
\end{align*}

The expectations appearing inside the probabilities on the right hand side of (3.13) are centred Gaussian variables with respect to $\mathbb{P}^{\mathcal{G}_{n}}$. So by the exponential Markov inequality and (3.5) the probabilities are bounded by $2 \exp \left(-\frac{\varepsilon^{2}(d-1)(d-2)}{24 d^{2}}(d-1)^{R-2 r}\right)$.

The above computations prove Theorem 3.1 since one has $\left|B_{\mathcal{G}_{n}}(x, r)\right|=\left|B_{\mathcal{G}_{n}}\left(x^{\prime}, r\right)\right|=$ $\left|B_{\mathbb{T}_{d}}(\mathbf{o}, r)\right|=\left|B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, r\right)\right| \leq d(d-1)^{r}$ as $\operatorname{tx}\left(B_{\mathcal{G}_{n}}(x, r)\right)=\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, r\right)\right)=0$ by assumption.

### 3.2 The conditional distribution of $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$

We continue the investigation of the conditional distributions of the zero-average Gaussian free field started in Proposition 2.1, now for the specific graphs $\mathcal{G}_{n}, n \geq 1$. The detailed understanding of conditional distributions will be needed in Section 4 to control the behaviour of the exploration process used in the proof of the main subcritical result (1.8). Under certain geometric conditions (see (3.17)-(3.19)), the conditional distributions of $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$ will show strong similarities with the conditional distribution of the Gaussian free field $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$ (Proposition 3.6, see also (3.14)). This feature reflects the general philosophy that the local picture of $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$ is given by $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$.

Results about the conditional distribution of the Gaussian free field $\varphi_{\mathbb{T}_{d}}$ on $\mathbb{T}_{d}$ follow directly from (2.9). In particular, if $x^{\prime} \in \mathbb{T}_{d}$ and $A^{\prime}:=\mathbb{T}_{d} \backslash U_{x^{\prime}}$ (recall definition (2.3)), then by (2.10) and (2.11) one has

\operatorname{Var}_{\mathbb{P}^{\mathbb{T}_{d}}}\left(\varphi_{\mathbb{T}_{d}}\left(x^{\prime}\right) \mid \sigma\left(\varphi_{\mathbb{T}_{d}}(y), y \in A^{\prime}\right)\right) & =\frac{d}{d-1} .
\end{align*}

In contrast, by Proposition 2.1 we have that for any $x \in \mathcal{G}_{n}, \Psi_{\mathcal{G}_{n}}(x)$ conditionally on $\left(\Psi_{\mathcal{G}_{n}}(y)\right)_{y \in A}$ for $A \subsetneq \mathcal{G}_{n}$ non-empty is a Gaussian random variable with mean and variance given by the right hand sides of (2.23) and (2.24). However, we show in Proposition 3.6 below that in specific (geometric) situations these expressions resemble (3.14). We now introduce the requirements needed on $x \in \mathcal{G}_{n}$ and $A \subseteq \mathcal{G}_{n}$.

We set $B_{\mathcal{G}_{n}}(A, r):=\left\{z \in \mathcal{G}_{n} \mid z \in B_{\mathcal{G}_{n}}(w, r)\right.$ for some $\left.w \in A\right\}$ for $A \subsetneq \mathcal{G}_{n}$ non-empty and $r \geq 1$. Moreover, for $x \in \partial_{\mathcal{G}_{n}} A$ we define

\begin{equation*}
F_{A}(x, r):=\left\{z \in B_{\mathcal{G}_{n}}(A, r) \backslash A \mid z \text { is connected to } x \text { in } B_{\mathcal{G}_{n}}(A, r) \backslash A\right\} . \tag{3.15}
\end{equation*}
$$

In particular $x \in F_{A}(x, r)$. We set

$$
\begin{equation*}
s_{n}:=\max \left\{1,\left\lfloor 8 \log _{d-1}\left(\log _{d-1}\left(N_{n}\right)\right)\right\rfloor\right\} \text { for } n \geq 1 \tag{3.16}
\end{equation*}
$$

and say that $x \in \partial_{\mathcal{G}_{n}} A$ is a good vertex at the boundary of $A$ if the following three properties hold:
$\left|B_{\mathcal{G}_{n}}(x, 1) \cap A\right|=1$, write $\bar{x} \in A$ for the unique vertex in this intersection (note that for $x^{\prime} \in \mathbb{T}_{d}$ the notation $\bar{x}^{\prime}$ has been defined above (2.3));
$\operatorname{tx}\left(F_{A}\left(x, s_{n}\right)\right)=0 ;$
for all $y \in \partial_{\mathcal{G}_{n}} A \backslash\{x\}$ every path in $\mathcal{G}_{n} \backslash A$ from $y$ to $x$ leaves $B_{\mathcal{G}_{n}}\left(A, s_{n}\right)$.

Equivalently, $F_{A}\left(x, s_{n}\right)$ is proper in the notation of [8] (see Figure 1 for an illustration of the conditions (3.17)-(3.19)).


Figure 1: (adapted from [8]) The point $x \in \partial_{\mathcal{G}_{n}} A$ is a good vertex at the boundary of $A$, the points in $F_{A}\left(x, s_{n}\right)$ are marked grey.

For $A \subsetneq \mathcal{G}_{n}$ non-empty we set

We are now ready to state Proposition 3.6. Observe the analogies between its statement and (3.14).

Proposition 3.6. For every $b, b^{\prime}>0$ there exists $c_{b, b^{\prime}}>0$ such that for $n \geq 1, A \subseteq \mathcal{G}_{n}$ non-empty with $|A| \leq b \ln \left(N_{n}\right), x \in G_{A}$ and on the event $\left\{\sup _{z \in A}\left|\Psi_{\mathcal{G}_{n}}(z)\right| \leq b^{\prime} \sqrt{\ln \left(N_{n}\right)}\right\}$ it holds (recall $\mathcal{F}_{A}$ from (2.22))

\begin{align*}
&\left|\mathbb{E}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right]-\frac{1}{d-1} \Psi_{\mathcal{G}_{n}}(\bar{x})\right| \leq c_{b, b^{\prime}}\left(\ln \left(N_{n}\right)\right)^{-2},  \tag{3.21}\\
&\left|\operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right)-\frac{d}{d-1}\right| \leq c_{b, b^{\prime}}\left(\ln \left(N_{n}\right)\right)^{-3} . \tag{3.22}
\end{align*}
$$

Recall that $\bar{x} \in A$ denotes the unique neighbour of $x$ in $A$ (see (3.17)).
To show Proposition 3.6 and conclude this section we will manipulate the explicit expressions for the conditional expectation and variance obtained in Proposition 2.1. In these expressions one considers the hitting time of $A$ for the simple random walk on $\mathcal{G}_{n}$ and in the proof of Proposition 3.6 we will look at different situations for when the hitting happens (see the beginning of the proof of Proposition 3.6 below). Since $x \in G_{A}$ in the statement, the simple random walk started at $x$ has to leave $F_{A}\left(x, s_{n}\right)$ to hit $A$ and so $P_{x}^{\mathcal{G}_{n}}$-almost surely either $H_{A}=T_{F_{A}\left(x, s_{n}\right)}$ or $H_{A}>T_{F_{A}\left(x, s_{n}\right)}$. We will further split the latter case into whether $H_{A}$ happens before or after an additional time

$$
\begin{equation*}
t_{n}:=\frac{1}{\lambda_{\mathcal{G}_{n}}}\left(\ln \left(N_{n}\right)\right)^{2}, \tag{3.23}
\end{equation*}
$$

by which the distribution of the simple random walk is very close to the stationary distribution (here the uniform distribution on $\mathcal{G}_{n}$ ). This follows from e.g. [22], Corollary 2.1.5. So in the proof of Proposition 3.6 we will consider the three situations $H_{A}=T_{F_{A}\left(x, s_{n}\right)}$, $T_{F_{A}\left(x, s_{n}\right)}<H_{A}<T_{F_{A}\left(x, s_{n}\right)}+t_{n}$ and $H_{A} \geq T_{F_{A}\left(x, s_{n}\right)}+t_{n}$ separately. Before that, we collect in Lemma 3.7 some preliminary observations about the simple random walk on $\mathcal{G}_{n}$ and subsequently start with the proof of Proposition 3.6. For the rest of this section we will abbreviate $F_{A}:=F_{A}\left(x, s_{n}\right)$. It is also convenient to consider the continuous-time
simple random walk $\left(\bar{X}_{t}\right)_{t \geq 0}$. We remind that for the exit time from $U \subseteq \mathcal{G}_{n}$ (resp. for the entrance time in $U \subseteq \mathcal{G}_{n}$ ) of this walk we use the same notation $T_{U}$ (resp. $H_{U}$ ) as for the discrete-time simple random walk.
Lemma 3.7. For $n \geq 1, A \subseteq \mathcal{G}_{n}$ non-empty and $x \in G_{A}$ one has

\frac{1}{d-1}-c\left(\ln \left(N_{n}\right)\right)^{-7} \leq P_{x}^{\mathcal{G}_{n}}\left[H_{A}=T_{F_{A}}\right] \leq \frac{1}{d-1},  \tag{3.24}\\
P_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}\right] \leq c \ln \left(N_{n}\right),  \tag{3.25}\\
\mathcal{G}_{n}\left[H_{A}>T_{F_{A}}\right]=\sum_{z \in B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c}} P_{x}^{\mathcal{G}_{n}}\left[\bar{X}_{T_{F_{A}}}=z, H_{A}>T_{F_{A}}\right] . \tag{3.26}
\end{gather*}
$$

Moreover, for every $b>0$ there exists $c_{b}>0$ such that for $n \geq 1, A \subseteq \mathcal{G}_{n}$ non-empty with $|A| \leq b \ln \left(N_{n}\right)$ and $x \in G_{A}$ one has

$$
\begin{gather*}
P_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}<H_{A}<T_{F_{A}}+t_{n}\right] \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-5},  \tag{3.27}\\
\sum_{w \in \mathcal{G}_{n}}\left|P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A} \geq t_{n}\right]-\frac{1}{N_{n}}\right| \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-5}, \quad \text { for } z \in \mathcal{G}_{n}  \tag{3.28}\\
\left|\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]}-P_{x}^{\mathcal{G}_{n}}\left[H_{A}>T_{F_{A}}\right]\right| \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-3} . \tag{3.29}
\end{gather*}
$$

Proof. Due to (3.18), the probability $P_{x}^{\mathcal{G}_{n}}\left[H_{A}=T_{F_{A}}\right]$ is equal to the probability that a (discrete-time) random walk on $\mathbb{Z}$ started at 1 and jumping with probability $\frac{d-1}{d}$ to the right and $\frac{1}{d}$ to the left hits 0 before hitting $s_{n}+1$. Similarly, $E_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}\right]$ is equal to the expected time until this random walk hits 0 or $s_{n}+1$. Thus (see e.g. [13], (2.4) and (3.4) in Chapter 14) it holds

\begin{aligned}
& P_{x}^{\mathcal{G}_{n}}\left[H_{A}=T_{F_{A}}\right]=1-\frac{d-2}{d-1}\left(1-\left(\frac{1}{d-1}\right)^{s_{n}+1}\right)^{-1} \leq 1-\frac{d-2}{d-1}=\frac{1}{d-1} \\
& E_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}\right]=\frac{d}{d-2}\left(\frac{\left(s_{n}+1\right)(d-2)}{(d-1)\left(1-\left(\frac{1}{d-1}\right)^{s_{n}+1}\right)}-1\right) \leq \frac{2 d}{d-1}\left(s_{n}+1\right) \stackrel{(3.16)}{\leq} c \ln \left(N_{n}\right)
\end{aligned}
$$

Since $\left(1-\left(\frac{1}{d-1}\right)^{s_{n}+1}\right)^{-1} \leq\left(1-\left(\log _{d-1}\left(N_{n}\right)\right)^{-8}\right)^{-1} \leq 1+c\left(\ln \left(N_{n}\right)\right)^{-7}$, one also has $P_{x}^{\mathcal{G}_{n}}\left[H_{A}=T_{F_{A}}\right] \geq 1-\frac{d-2}{d-1}\left(1+c\left(\ln \left(N_{n}\right)\right)^{-7}\right) \geq \frac{1}{d-1}-c\left(\ln \left(N_{n}\right)\right)^{-7}$. Thus (3.24) and (3.25) are shown.

To see (3.26) observe that on the event $\left\{H_{A}>T_{F_{A}}\right\}$, at the moment the simple random walk started at $x$ leaves $F_{A}$, it is in some $z \in \partial_{\mathcal{G}_{n}} F_{A} \cap B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{\text {c }}$ (note that indeed $z \notin B_{\mathcal{G}_{n}}\left(A, s_{n}\right)$ since else there would exist a path like those excluded by (3.19)). In other words,

\text { under } P_{x}^{\mathcal{G}_{n}} \text { and on }\left\{H_{A}>T_{F_{A}}\right\}, \quad \bar{X}_{T_{F_{A}}} \in \partial_{\mathcal{G}_{n}} F_{A} \cap B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c} . \tag{3.30}
\end{equation*}
$$

This shows (3.26). To derive (3.27) we apply the strong Markov property of simple random walk for time $T_{F_{A}}$ and obtain for $n \geq 1$

\begin{equation*}
P_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}<H_{A}<T_{F_{A}}+t_{n}\right] \stackrel{(3.30)}{\leq} \sup _{z \in B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c}} P_{z}^{\mathcal{G}_{n}}\left[H_{A}<t_{n}\right] \tag{3.31}
\end{equation*}
$$

Roughly speaking, the right hand side of (3.31) is small since it is difficult for the simple random walk to hit $A$ within time $t_{n}$ because it starts at distance larger than $s_{n}$ from $A$ and the environment is nearly treelike (see (1.2)). More precisely, we can apply [8], Lemma 3.4 (for $T:=t_{n}, r:=0, s:=s_{n}$ and using (1.2)) to find $c, c^{\prime}>0$ such that for $z \in B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c}$ one has for $n \geq 1$

$$
P_{z}^{\mathcal{G}_{n}}\left[H_{A}<t_{n}\right] \leq \sum_{y \in A} P_{z}^{\mathcal{G}_{n}}\left[H_{y}<t_{n}\right] \leq|A|\left(c t_{n}(d-1)^{-s_{n}}+e^{-c^{\prime} t_{n}}\right) \stackrel{(3.16)}{\leq} c_{b}\left(\ln \left(N_{n}\right)\right)^{-5},
$$

where the last inequality also uses the assumption on $A$, (3.23) and (1.3). This combined with (3.31) gives (3.27).

For (3.28) the idea is that on the event $\left\{H_{A} \geq t_{n}\right\}$ the simple random walk started at $z$ has, roughly speaking, reached the stationary distribution by time $t_{n}$ without having hit $A$. We observe that for $z, w \in \mathcal{G}_{n}$ one has

& \left|P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A} \geq t_{n}\right]-\frac{1}{N_{n}}\right| \\
& \leq P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A}<t_{n}\right]+\left|P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w\right]-\frac{1}{N_{n}}\right| \\
& \stackrel{(*)}{\leq} P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A}<t_{n}\right]+\exp \left(-\lambda_{\mathcal{G}_{n}} t_{n}\right) \\
& \stackrel{(3.23)}{=} P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A}<t_{n}\right]+\exp \left(-\left(\ln \left(N_{n}\right)\right)^{2}\right),
\end{aligned}
$$

where in (*) we apply [22], Corollary 2.1.5. Hence for $n \geq 1, z \in \mathcal{G}_{n}$, one has

$$
\sum_{w \in \mathcal{G}_{n}}\left|P_{z}^{\mathcal{G}_{n}}\left[\bar{X}_{t_{n}}=w, H_{A} \geq t_{n}\right]-\frac{1}{N_{n}}\right| \leq P_{z}^{\mathcal{G}_{n}}\left[H_{A}<t_{n}\right]+N_{n} e^{-\left(\ln \left(N_{n}\right)\right)^{2}}
$$

which together with the above estimate on $P_{z}^{\mathcal{G}_{n}}\left[H_{A}<t_{n}\right]$ gives (3.28). It remains to show (3.29). We start by computing (using also (3.20) of [8] in the second inequality)

\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A} \mathbf{1}_{H_{A}=T_{F_{A}}}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} \leq \frac{E_{x}^{\mathcal{G}_{n}}\left[T_{F_{A}}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} \stackrel{(3.25)}{\leq} c \ln \left(N_{n}\right) \frac{4|A|}{N_{n}} \leq \frac{c_{b}\left(\ln \left(N_{n}\right)\right)^{2}}{N_{n}} \tag{3.32}
\end{equation*}
$$

Now by (3.30) and the strong Markov property for time $T_{F_{A}}$ one has $E_{x}^{\mathcal{G}_{n}}\left[H_{A} \mathbf{1}_{H_{A}>T_{F_{A}}}\right]=$ $\sum_{z \in B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c}} P_{x}^{\mathcal{G}_{n}}\left[\bar{X}_{T_{F_{A}}}=z, H_{A}>T_{F_{A}}\right] E_{z}^{\mathcal{G}_{n}}\left[H_{A}\right]$. This combined with (3.26) shows

$$
\begin{equation*}
\left|\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A} \mathbf{1}_{H_{A}>T_{F_{A}}}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]}-P_{x}^{\mathcal{G}_{n}}\left[H_{A}>T_{F_{A}}\right]\right| \leq \sup _{z \in B_{\mathcal{G}_{n}}\left(A, s_{n}\right)^{c}}\left|\frac{E_{z}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]}-1\right| . \tag{3.33}
\end{equation*}
$$

By [8], Proposition 3.5, we can bound the absolute value on the right hand side of (3.33) by $c|A|(d-1)^{-s_{n}}\left(\ln \left(N_{n}\right)\right)^{4} \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-3}$. Since $P_{x}^{\mathcal{G}_{n}}$-almost surely either $H_{A}=T_{F_{A}}$ or $H_{A}>T_{F_{A}}$, the combination of (3.32) and (3.33) concludes the proof.

Proof of Proposition 3.6. We start with the basic observation that by (2.23) one has $\left|\mathbb{E}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right]-\frac{1}{d-1} \Psi_{\mathcal{G}_{n}}(\bar{x})\right| \leq U_{A, x}^{\mathcal{G}_{n}}+V_{A, x}^{\mathcal{G}_{n}}+W_{A, x}^{\mathcal{G}_{n}}$, where

V_{A, x}^{\mathcal{G}_{n}} & :=\left|E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(\bar{X}_{H_{A}}\right) \mathbf{1}_{\left\{T_{F_{A}}<H_{A}<T_{F_{A}}+t_{n}\right\}}\right]\right|, \\
W_{A, x}^{\mathcal{G}_{n}} & :=\left|E_{x}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(\bar{X}_{H_{A}}\right) \mathbf{1}_{\left\{H_{A} \geq T_{F_{A}}+t_{n}\right\}}\right]-\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} E_{\pi}^{\mathcal{G}_{n}}\left[\Psi_{\mathcal{G}_{n}}\left(\bar{X}_{H_{A}}\right)\right]\right| .
\end{aligned}
$$

Hence the proof of (3.21) follows once we show that
there exists $c_{b, b^{\prime}}>0$ such that for $n \geq 1, A \subseteq \mathcal{G}_{n}$ non-empty with $|A| \leq b \ln \left(N_{n}\right), x \in G_{A}$ and on the event $\left\{\sup _{z \in A}\left|\Psi_{\mathcal{G}_{n}}(z)\right| \leq b^{\prime} \sqrt{\ln \left(N_{n}\right)}\right\}$
one has $U_{A, x}^{\mathcal{G}_{n}}+V_{A, x}^{\mathcal{G}_{n}}+W_{A, x}^{\mathcal{G}_{n}} \leq c_{b, b^{\prime}}\left(\ln \left(N_{n}\right)\right)^{-2}$.
Similarly we have $\left|\operatorname{Var}_{\mathbb{P}^{\mathcal{G}_{n}}}\left(\Psi_{\mathcal{G}_{n}}(x) \mid \mathcal{F}_{A}\right)-\frac{d}{d-1}\right| \leq \bar{U}_{A, x}^{\mathcal{G}_{n}}+\bar{V}_{A, x}^{\mathcal{G}_{n}}+\bar{W}_{A, x}^{\mathcal{G}_{n}}$ by (2.24), where

$$
\begin{aligned}
\bar{U}_{A, x}^{\mathcal{G}_{n}} & :=\left|G_{\mathcal{G}_{n}}(x, x)-E_{x}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right) \mathbf{1}_{\left\{H_{A}=T_{F_{A}}\right\}}\right]-\frac{d}{d-1}\right| \\
\bar{V}_{A, x}^{\mathcal{G}_{n}} & :=E_{x}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right) \mathbf{1}_{\left\{T_{F_{A}}<H_{A}<T_{F_{A}}+t_{n}\right\}}\right] \\
\bar{W}_{A, x}^{\mathcal{G}_{n}} & :=\left|E_{x}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right) \mathbf{1}_{\left\{H_{A} \geq T_{F_{A}}+t_{n}\right\}}\right]-\frac{E_{x}^{\mathcal{G}_{n}}\left[H_{A}\right]}{E_{\pi}^{\mathcal{G}_{n}}\left[H_{A}\right]} E_{\pi}^{\mathcal{G}_{n}}\left[G_{\mathcal{G}_{n}}\left(X_{H_{A}}, x\right)\right]\right| .
\end{aligned}
$$

Thus the proof of (3.22) follows once we show that
there exists $c_{b}>0$ such that for $n \geq 1, A \subseteq \mathcal{G}_{n}$ non-empty with $|A| \leq b \ln \left(N_{n}\right)$ and $x \in G_{A}$ one has $\bar{U}_{A, x}^{\mathcal{G}_{n}}+\bar{V}_{A, x}^{\mathcal{G}_{n}}+\bar{W}_{A, x}^{\mathcal{G}_{n}} \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-3}$.

It remains to show (3.34) and (3.35). For (3.34) we bound the three terms $U_{A, x}^{\mathcal{G}_{n}}, V_{A, x}^{\mathcal{G}_{n}}$ and $W_{A, x}^{\mathcal{G}_{n}}$ separately. On $\left\{H_{A}=T_{F_{A}}\right\}$ one has $P_{x}^{\mathcal{G}_{n}}$-almost surely $\Psi_{\mathcal{G}_{n}}\left(\bar{X}_{H_{A}}\right)=\Psi_{\mathcal{G}_{n}}(\bar{x})$ due to $x \in G_{A}$. So $U_{A, x}^{\mathcal{G}_{n}}=\left|\Psi_{\mathcal{G}_{n}}(\bar{x})\right| \cdot\left|P_{x}^{\mathcal{G}_{n}}\left[H_{A}=T_{F_{A}}\right]-\frac{1}{d-1}\right| \leq b^{\prime} \sqrt{\ln \left(N_{n}\right)} c\left(\ln \left(N_{n}\right)\right)^{-7}$ by (3.24), where in the last inequality we also use that $\bar{x} \in A$. This shows $U_{A, x}^{\mathcal{G}_{n}} \leq c_{b^{\prime}}\left(\ln \left(N_{n}\right)\right)^{-6}$.

We turn to $V_{A, x}^{\mathcal{G}_{n}}$. Hence $V_{A, x}^{\mathcal{G}_{n}} \leq c_{b, b^{\prime}}\left(\ln \left(N_{n}\right)\right)^{-4}$.

Finally, we consider $W_{A, x}^{\mathcal{G}_{n}}$. Let us define

We come to the proof of (3.35) for which we bound the three terms $\bar{U}_{A, x}^{\mathcal{G}_{n}}, \bar{V}_{A, x}^{\mathcal{G}_{n}}$ and $\bar{W}_{A, x}^{\mathcal{G}_{n}}$ separately. For $\bar{U}_{A, x}^{\mathcal{G}_{n}}$ we first note that one has

All in all we have shown $\bar{Z}_{A, x}^{\mathcal{G}_{n}} \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-5}$. Thus by (3.39) we deduce $\bar{W}_{A, x}^{\mathcal{G}_{n}} \leq c_{b}\left(\ln \left(N_{n}\right)\right)^{-3}$ and (3.35) is shown. This concludes the proof of Proposition 3.6 and Section 3.2.

## 4 Microscopic components in the subcritical phase

We start the analysis of level-set percolation of the zero-average Gaussian free field $\Psi_{\mathcal{G}_{n}}$ on $\mathcal{G}_{n}$. The goal of this section is to show (1.8) in the form of Theorem 4.1 below, i.e. the existence of a subcritical phase in which, with high probability for large $n$, level sets of $\Psi_{\mathcal{G}_{n}}$ only have connected components of cardinality at most logarithmic in the size of the graph. To precisely state the result, we recall from the introduction the critical value $h_{\star}$ for level-set percolation of the Gaussian free field $\varphi_{T_{d}}$ on $\mathbb{T}_{d}$ (see (1.7)) and also the notation $E_{\Psi_{\mathcal{G}_{n}}}^{>h}$ for the level set of $\Psi_{\mathcal{G}_{n}}$ above level $h \in \mathbb{R}$ (see (1.5)). For $h \in \mathbb{R}$ we further denote by $\mathcal{C}_{\max }^{\mathcal{G}_{n}, h}$ an arbitrary connected component of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ with maximal number of vertices. We will only be interested in its cardinality. Moreover, for $x \in \mathcal{G}_{n}$ and $h \in \mathbb{R}$ we define $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ to be the connected component of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ containing $x$. The main result of this section is
Theorem 4.1. Let $h>h_{\star}$. Then for all $\kappa>0$ there exist $c_{h, \kappa}>0$ and $K_{h, \kappa}>0$ such that for all $n \geq 1$

\mathbb{P}^{\mathcal{G}_{n}}\left[\left|\mathcal{C}_{\max }^{\mathcal{G}_{n}, h}\right| \geq K_{h, \kappa} \ln \left(N_{n}\right)\right] \leq c_{h, \kappa} N_{n}^{-\kappa}

In particular $\lim _{n \rightarrow \infty} \mathbb{P}^{\mathcal{G}_{n}}\left[\left|\mathcal{C}_{\text {max }}^{\mathcal{G}_{n}, h}\right| \leq K_{h} \ln \left(N_{n}\right)\right]=1$ for some $K_{h}>0$.
Before explaining the details of the proof of Theorem 4.1, let us make the basic observation that a union bound reduces the problem to show that for $h>h_{\star}$ and for all $\kappa>0$ there exist $c_{h, \kappa}>0$ and $K_{h, \kappa}>0$ such that for all $n \geq 1$ and $x \in \mathcal{G}_{n}$

So it remains to show (4.1). We will make use of a certain exploration process exploring $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ for a fixed $x \in \mathcal{G}_{n}$. This will enable us to control $\mathbb{P}^{\mathcal{G}_{n}}\left[\left|\mathcal{C}_{x}^{\mathcal{G}_{n}, h}\right| \geq K_{h, \kappa} \ln \left(N_{n}\right)\right]$. A similar approach has for example been followed in [8] to prove a result analogous to the above Theorem 4.1 but for the vacant set of simple random walk on $\mathcal{G}_{n}$ in place of the level set of the zero-average Gaussian free field.

We now give the idea of the proof of (4.1). The details of the exploration process itself are given afterwards. A crucial ingredient is the precise understanding of the conditional distribution of the zero-average Gaussian free field on non-explored vertices given its value on already explored vertices. As we have seen in Proposition 3.6 in Section 3.2, under certain geometric conditions the conditional distribution of $\Psi_{\mathcal{G}_{n}}$ shows strong similarities with the conditional distribution of the Gaussian free field $\varphi_{T_{d}}$ on $\mathbb{T}_{d}$. While exploring $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$, the exploration process will separate the vertices found in $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ into a union of rooted disjoint subtrees of $\mathcal{G}_{n}$ in which all vertices except for the root satisfy the aforementioned geometric conditions. In this way we reduce the proof of (4.1) to a control of the number of vertices contained in these union of subtrees (Proposition 4.2). As a result from [8] shows (see also Lemma 4.3), the number of steps the exploration process encounters a situation in which the geometric assumptions fail to be satisfied is not too large. This controls the number of distinct subtrees created by the exploration process because in each subtree there is exactly one vertex which does not satisfy the conditions (its root). Since the other vertices of a subtree satisfy the geometric conditions, we can employ the similarity between the conditional distribution of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathrm{T}_{d}}$ to couple the zero-average Gaussian free field on each distinct subtree separately with an independent copy of the Gaussian free field $\varphi_{\mathrm{T}_{d}}$ on $\mathbb{T}_{d}$ (Lemma 4.5). This translates the question about the number of vertices contained in the disjoint subtrees into the number of vertices contained in connected components of the level set of $\varphi_{T_{d}}$ (Corollary 4.6). A result from [2] (recalled in (2.15)) about exponential moments of the size of these connected components then ultimately leads to the proof of Proposition 4.2 and hence of (4.1).

We now describe the exploration process exploring $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ for a fixed $x \in \mathcal{G}_{n}$ and to facilitate the discussion we include a concrete algorithm implementing it (Algorithm 1). The exploration process is a modified breadth-first-search that discovers the field $\Psi_{\mathcal{G}_{n}}$ on the graph step by step. It employs two queues (a primary and a secondary one) that work in the usual first-in-first-out manner and store the vertices to be explored. The exploration process starts by revealing $\Psi_{\mathcal{G}_{n}}(x)$. The vertices where $\Psi_{\mathcal{G}_{n}}$ has been revealed are called explored and they can be either part of $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ or not. If a vertex is explored and is revealed to be part of $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$, then its neighbours which are neither already explored nor already in one of the two queues are added to the primary queue. To avoid ambiguity, we suppose that the vertices of $\mathcal{G}_{n}$ are equipped with some ordering and that they are added to the queue following this ordering. Vertices taken out of the primary queue are first checked to be good vertices at the boundary of the so far explored vertices (recall (3.20) and above it for the definition): if they are, the exploration process proceeds with their exploration; if they are not, they are transferred to the secondary queue and their exploration is postponed. The first vertex in the secondary queue is only taken out to be explored if the primary queue is empty.

To formalise this exploration process we now give an algorithm implementing it (see Algorithm 1 below). The algorithm constructs on some auxiliary probability space $(\Omega, \mathcal{A}, \mathbb{P})$ a family of random variables $(\psi(z))_{z \in B}$ such that $(\psi(z))_{z \in B}$ under $\mathbb{P}$ has the same distribution as $\left(\Psi_{\mathcal{G}_{n}}(z)\right)_{z \in B}$ under $\mathbb{P}^{\mathcal{G}_{n}}$. Here $B \subseteq \mathcal{G}_{n}$ is some (random) connected set of vertices containing $x$. We use $\mathrm{PQ}, \mathrm{SQ}$ and E to denote the evolving sets of vertices in the primary queue, vertices in the secondary queue and explored vertices during the run of the algorithm. Furthermore, we also keep track of the explored vertices $z \in \mathrm{E}$ for which $\psi(z) \geq h$ using the set $\mathrm{C} \subseteq \mathrm{E}$. Additionally to the exploration, the algorithm aggregates the vertices discovered to be in C into disjoint subtrees $\left(\mathrm{T}^{y}\right)_{y}$ of $\mathcal{G}_{n}$ indexed by bad vertices $y \in \mathcal{G}_{n}$ (meaning they were in SQ at some point of the algorithm). Moreover, the algorithm stops for one of two reasons: either because both the primary and secondary queue are empty, or because it already discovered that C has at least size $K_{h, \kappa} \ln \left(N_{n}\right)$ for some $K_{h, \kappa}$ to be specified later (below (4.21)).

We need some more notation for the algorithm. Let $\left(\xi_{z}\right)_{z \in \mathcal{G}_{n}}$ be i.i.d. standard normal random variables on the auxiliary probability space $(\Omega, \mathcal{A}, \mathbb{P})$. For $A \subseteq \mathcal{G}_{n}$ non-empty and $u \in \mathcal{G}_{n}$ we abbreviate by $a(u, \psi, A)$ the right hand side of (2.23) where $x$ and $\Psi_{\mathcal{G}_{n}}$ are replaced by $u$ and $\psi$. In particular, $a(u, \psi, A)$ is a random variable measurable with respect to $\sigma(\psi(w), w \in A)$. By $b(u, A)$ we abbreviate the right hand side of (2.24) where $x$ is replaced by $u$. For $A=\emptyset$ and $u \in \mathcal{G}_{n}$ we define $a(u, \psi, \emptyset):=0$ and $b(u, \emptyset):=G_{\mathcal{G}_{n}}(u, u)$. By Proposition 2.1 and the fact that $\psi$ is a Gaussian field, we have that
for $A \subseteq \mathcal{G}_{n}$ and $u \in \mathcal{G}_{n}$ the random variable $a(u, \psi, A)+\xi_{u} \cdot b(u, A)^{\frac{1}{2}}$ under $\mathbb{P}$ has the same distribution as $\Psi_{\mathcal{G}_{n}}(u)$ conditional on $\sigma\left(\Psi_{\mathcal{G}_{n}}(w), w \in A\right)$ under $\mathbb{P}^{\mathcal{G}_{n}}$.

The algorithm is as follows:

Let $\mathrm{E}_{\text {end }}, \mathrm{C}_{\text {end }}$ and $\mathrm{T}_{\text {end }}^{w}, w \in \mathcal{G}_{n}$, denote the sets $\mathrm{E}, \mathrm{C}$ and $\mathrm{T}^{w}, w \in \mathcal{G}_{n}$, at the end of the algorithm. By that moment we have constructed $(\psi(z))_{z \in \mathrm{E}_{\text {end }}}$ and (see (4.2))
$(\psi(z))_{z \in \mathrm{E}_{\text {end }}}$ under $\mathbb{P}$ has the same distribution as $\left(\Psi_{\mathcal{G}_{n}}(z)\right)_{z \in \mathrm{E}_{\text {end }}}$ under $\mathbb{P}^{\mathcal{G}_{n}}$.
By construction of the algorithm one has $\left|\mathrm{C}_{\text {end }}\right| \leq K_{h, \kappa} \ln \left(N_{n}\right)+1$ and so by (1.1) also

This is due to $\mathrm{E} \subseteq B_{\mathcal{G}_{n}}(\mathrm{C}, 1)$ with $B_{\mathcal{G}_{n}}(\emptyset, 1):=\{x\}$ holding at any moment of the algorithm since a vertex can only get explored (except for $x$ ) if at some point it was added to a queue, meaning it was a neighbour of a vertex added to $C$.

Note that, whenever some $y \in \mathcal{G}_{n}$ is taken out of SQ on line 3 of the algorithm (a bad vertex), one has $\mathrm{PQ}=\emptyset$ at that moment by construction. Until the next bad vertex is taken out of SQ, all vertices $z \in \mathcal{G}_{n}$ considered by the algorithm and which are found to be good and in C will be part of $\mathrm{T}_{\text {end }}^{y}$. So if $y_{1}, \ldots, y_{k_{\text {end }}}$ denote the successive vertices that were taken out of SQ during the algorithm, then $C_{\text {end }}=\bigcup_{i=1}^{k_{\text {end }}} \mathrm{T}_{\text {end }}^{y_{i}}$. In particular, $y_{1}=x$ and $k_{\text {end }}$ is the total number of bad vertices encountered by the algorithm.

Furthermore, on the event that the algorithm terminates because both queues become empty (and not because at some point $\left|C_{\text {end }}\right| \geq K_{h, \kappa} \ln \left(N_{n}\right)$ ), note that $\left|C_{\text {end }}\right|$ has the same distribution as $\left|\mathcal{C}_{x}^{\mathcal{G}_{n}, h}\right|$ under $\mathbb{P}^{\mathcal{G}_{n}}$ by (4.3). Therefore $\mathbb{P}\left[\left|\mathrm{C}_{\text {end }}\right|<K_{h, \kappa} \ln \left(N_{n}\right)\right]=$ $\mathbb{P}^{\mathcal{G}_{n}}\left[\left|\mathcal{C}_{x}^{\mathcal{G}_{n}, h}\right|<K_{h, \kappa} \ln \left(N_{n}\right)\right]$.

We want to distinguish the situation in which the field $\psi$ produced by the algorithm has anomalous values, meaning $|\psi(z)| \geq M_{n}$ for some $z \in \mathrm{E}_{\text {end }}$ and $M_{n}>0$. We are going to specify this value now. Note that for any $\kappa>0$ there is $c_{\kappa}>0$ such that

This can be shown by the same computations as in [21], equations (2.35)-(2.38), replacing $g(0)$ therein with $\sup _{z \in \mathcal{G}_{n}} G_{\mathcal{G}_{n}}(z, z)$, which is bounded by $3 \frac{d-1}{d-2}$ (see (2.33)). We set

& \stackrel{(4.3)}{\leq} \mathbb{P}\left[\sum_{i=1}^{k_{\text {end }}}\left|\mathrm{T}_{\text {end }}^{y_{i}}\right| \geq K_{h, \kappa} \ln \left(N_{n}\right), \sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right]+2 N_{n}^{-1-\kappa} .

Thus in order to show (4.1) and ultimately Theorem 4.1 we need to show
Proposition 4.2. Let $h>h_{\star}$. Then for all $\kappa>0$ there exist $c_{h, \kappa}>0$ and $K_{h, \kappa}>0$ such that for all $n \geq 1$ and $x \in \mathcal{G}_{n}$ one has for the Algorithm 1 above

The proof of Proposition 4.2 relies on the following two lemmas. The first one (Lemma 4.3, already proven in [8]) bounds the number of bad vertices $k_{\text {end }}$ encountered by Algorithm 1, that is, the number of vertices of $\mathcal{G}_{n}$ that at some point during the run of the algorithm were in the secondary queue SQ. The second one (Lemma 4.5) constructs for each $i=1, \ldots, k_{\text {end }}$ a coupling of $\psi$ on $\mathrm{T}_{\text {end }}^{y_{i}}$ with an independent copy of $\varphi_{\mathrm{T}_{d}}$, showing that $\psi$ on $\mathrm{T}_{\text {end }}^{y_{i}}$ can be approximated by $\varphi_{\mathrm{T}_{d}}$. This makes use of Proposition 3.6. Via Corollary 4.6 of Lemma 4.5 we then prove Proposition 4.2.
Lemma 4.3. There exists $c_{1}>0$ such that for all $n \geq 1$ and $x \in \mathcal{G}_{n}$ one has for the above Algorithm 1 that $k_{\text {end }} \leq c_{1} K_{h, \kappa}^{2} s_{n}=: k_{\max }$ (recall that $s_{n}$ is given in (3.16)).

Proof. This follows from [8], Proposition 5.4. Although the algorithm employed there does not exactly match our algorithm, the proof does not rely on a specific algorithm (as explained in the proof of Proposition 5.4 in [8]). It is purely deterministic and only uses the properties (1.1) and (1.2) of $\mathcal{G}_{n}$. The assumption (1.3) is not needed.

Remark 4.4. Lemma 4.3 relies on the assumption (1.2) which we borrowed from [8]. This assumption could be weakened slightly, for instance by requiring that there is at most one cycle in every ball of radius $\left(\ln \left(N_{n}\right)\right)^{1-\varepsilon}$ for a very small $\varepsilon>0$. However, this would require an extension of combinatorial arguments of [8] which we try to avoid here. To understand the role of the assumption (1.2), note that by Lemma 5.5 of [8] this assumption implies that every connected subset $U$ of $\mathcal{G}_{n}$ of size at most $\theta \ln N_{n}$ with $\theta>0$ satisfies $\operatorname{tx}(U) \leq c \theta^{2}$ (with $c$ depending on $\alpha$ and $d$ as usual), i.e. $U$ only contains a uniformly bounded (in $n$ ) number of cycles. Heuristically, Lemma 4.3 then follows from the fact that when a bad vertex $z$ is encountered during the run of the algorithm (that is, $z$ is not a good vertex at the boundary of the so far explored vertices E , cf. line 13 of the algorithm), then, due to (3.17)-(3.19), there is a cycle in $\mathrm{E} \cup F_{\mathrm{E}}\left(z, s_{n}\right)$ (see (3.15)). Since $\mathrm{E} \cup F_{\mathrm{E}}\left(z, s_{n}\right)$ contains at most $d\left(K_{h, \kappa} \ln \left(N_{n}\right)+1\right)+(d-1)^{s_{n}} \leq \theta \ln \left(N_{n}\right)$ vertices by (4.4) and (3.15), encountering more that $c_{1} K_{h, \kappa}^{2} s_{n}$ bad vertices would then lead to a contradiction with the above mentioned Lemma 5.5 of [8], for details see [8], Lemmas 5.6-5.8.
Lemma 4.5. Let $h \in \mathbb{R}$ and $\varepsilon>0$. Consider Algorithm 1 and recall $k_{\max }$ from Lemma 4.3. Then on the same auxiliary space $(\Omega, \mathcal{A}, \mathbb{P})$ as $\psi$ one can define centred Gaussian fields $\phi^{1}, \ldots, \phi^{k_{\max }}$ on $\mathbb{T}_{d}$ such that, conditionally on $\psi\left(y_{1}\right), \ldots, \psi\left(y_{k_{\text {end }}}\right)$, the following properties hold (see (2.12) for notation):
for all $n$ large enough and all $i=1, \ldots, k_{\text {end }}$ there exists a set $B^{i}$ with $\mathrm{T}_{\text {end }}^{y_{i}} \subseteq B^{i} \subseteq B_{\mathcal{G}_{n}}\left(\mathrm{~T}_{\text {end }}^{y_{i}}, 1\right)$ and an injection $\tau^{i}: B^{i} \rightarrow \mathrm{~T}_{d}$ such that $\tau^{i}\left(\mathrm{~T}_{\text {end }}^{y_{i}}\right)$ is a connected subset of $\mathbb{T}_{d}$ containing the root $\mathrm{o} \in \mathbb{T}_{d}$ and on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$ one has $\left|\psi(z)-\phi^{i}\left(\tau^{i}(z)\right)\right| \leq \varepsilon$ for all $z \in B^{i}$;
for all $i=1, \ldots, k_{\text {end }}$ the field $\phi^{i}$ has the same distribution as $\varphi_{\mathbb{T}_{d}}$ under $\mathbb{P}_{\psi\left(y_{i}\right)}^{\mathbb{T}_{d}}$, and for all $i=k_{\text {end }}+1, \ldots, k_{\max }$ the field $\phi^{i}$ has the same distribution as $\varphi_{\mathrm{T}_{d}}$ under $\mathbb{P}_{M_{n}}^{\mathrm{T}_{d}}$;
$\phi^{1}, \ldots, \phi^{k_{\text {max }}}$ are independent.
Proof. Let $Y_{x}^{i}$ for $x \in \mathbb{T}_{d} \backslash\{\mathrm{o}\}$ and $1 \leq i \leq k_{\max }$ be a sequence of i.i.d. random variables of distribution $\mathcal{N}\left(0, \frac{d}{d-1}\right)$ defined on the auxiliary probability space $(\Omega, \mathcal{A}, \mathbb{P})$. Let $i \in$ $\left\{1, \ldots, k_{\text {end }}\right\}$. As explained below (4.4), the subtree $\mathrm{T}_{\text {end }}^{y_{i}}$ of $\mathcal{G}_{n}$ is constructed between line 3 (when $y_{i}$ is taken out of SQ) and line 26 of the algorithm (after which the next bad vertex $y_{i+1}$ is taken out of SQ or the algorithm terminates because $i=k_{\text {end }}$ ). The injection $\tau^{i}$ and the random field $\phi^{i}$ will be defined according to the behaviour of the algorithm during this time.

On line 4 of the algorithm we generate $\psi\left(y_{i}\right)$. If $\psi\left(y_{i}\right)<h$, then the algorithm continues back on line 2 and $\mathrm{T}_{\text {end }}^{y_{i}}=\emptyset$. In this case define recursively $\phi^{i}(\mathbf{o}):=\psi\left(y_{i}\right)$ and $\phi^{i}(z):=\frac{1}{d-1} \phi^{i}(\bar{z})+Y_{x}^{i}$ for $z \in \mathbb{T}_{d} \backslash\{\mathrm{o}\}$. Then (4.8) holds for $\phi^{i}$ by (2.10)-(2.12). Moreover (4.7) is trivially satisfied since $\mathrm{T}_{\text {end }}^{y_{i}}=\emptyset$ ( set $B^{i}:=\emptyset$ ). Otherwise we have $\psi\left(y_{i}\right) \geq h$ and $y_{i}$ is added to $\boldsymbol{T}^{y_{i}}$. If the algorithm terminates on line 8, then $\mathrm{T}_{\text {end }}^{y_{i}}=\left\{y_{i}\right\}$. In this case set $B^{i}:=\left\{y_{i}\right\}$ and $\tau^{i}\left(y_{i}\right):=\mathrm{o} \in \mathbb{T}_{d}$ and again recursively define $\phi^{i}(\mathrm{o}):=\psi\left(y_{i}\right)$ and $\phi^{i}(z):=\frac{1}{d-1} \phi^{i}(\bar{z})+Y_{x}^{i}$ for $z \in \mathbb{T}_{d} \backslash\{0\}$. Then (4.8) holds for $\phi^{i}$ by (2.10)-(2.12) and also (4.7) is satisfied since $\left|\psi\left(y_{i}\right)-\phi^{i}\left(\tau^{i}\left(y_{i}\right)\right)\right|=0$. If the algorithm does not terminate on line 8 , then on line 10 we now add all neither explored nor already queuing neighbours of $y_{i}$ to PQ (which before that was empty). Consider the while-loop on line 11. During this while-loop, if $z$ is taken out of PQ and $z \notin G_{\mathrm{E}}$, then it is transferred to SQ and it will not be part of $\mathrm{T}_{\text {end }}^{y_{i}}$. Let $z_{1}, \ldots, z_{m}$ be the successive vertices taken out of PQ during the while-loop which are in $G_{\mathrm{E}}$ at the moment they are checked (on line 13). Possibly there are no such vertices, so we might have $\left\{z_{1}, \ldots, z_{m}\right\}=\emptyset$ and $\mathrm{T}_{\text {end }}^{y_{i}}=\left\{y_{i}\right\}$. In any case, $\mathrm{T}_{\text {end }}^{y_{i}}=\left\{y_{i}\right\} \cup\left\{z_{1}, \ldots, z_{m} \mid \psi\left(z_{i}\right) \geq h\right\} \subseteq\left\{y_{i}, z_{1}, \ldots, z_{m}\right\} \subseteq B_{\mathcal{G}_{n}}\left(\mathrm{~T}_{\text {end }}^{y_{i}}, 1\right)$. The injection
$\tau^{i}$ we are going to construct now, will map $B^{i}:=\left\{y_{i}, z_{1}, \ldots, z_{m}\right\}$ to $\mathbb{T}_{d}$. By definition one has $\bar{z}_{1}=y_{i}$ whereas for $j=2, \ldots, m$ one has $\bar{z}_{j}=z$ for some $z \in\left\{y_{i}, z_{1}, \ldots, z_{j-1}\right\}$. More precisely, $\bar{z}_{j}$ is the unique neighbour of $z_{j}$ in E at the moment $z_{j}$ was added to PQ (which happened on line 10 or line 22). There cannot be more than one since at a later point $z_{j} \in G_{\mathrm{E}}$ and the set of explored vertices only grows. Since there are at most $d-1$ not explored neighbours that can be added on line 10 or 22 (except if $i=1$ when $y_{1}=x$ and on line 10 there are added exactly $d$ neighbours), this shows that for $z \in B^{i}$ there are at most $d-1$ elements $w \in\left\{z_{1}, \ldots, z_{m}\right\}$ such that $\bar{w}=z$ (exactly $d$ elements if $i=1$ and $\left.z=y_{1}\right)$. Therefore, we can define $\tau^{i}: B^{i} \rightarrow \mathbb{T}_{d}$ inductively by $\tau^{i}\left(y_{i}\right):=\mathrm{o}$ and such that $\tau^{i}$ restricted to $\left\{w \in\left\{z_{1}, \ldots, z_{m}\right\} \mid \bar{w}=z\right\}$ is an injective map to $S_{\mathrm{T}_{d}}(\mathbf{o}, 1)$ for $z=y_{i}$ and an injective map to $S_{\mathrm{T}_{d}}\left(\tau^{i}(z), 1\right) \backslash\left\{\tau^{i}(\bar{z})\right\}$ for $z \in\left\{z_{1}, \ldots, z_{m}\right\}$. Note that $\tau^{i}\left(B^{i}\right)$ is a connected subset of $\mathbb{T}_{d}$ containing the root $o \in \mathbb{T}_{d}$. By construction also $\tau^{i}\left(\mathbb{T}_{\text {end }}^{y_{i}}\right)$ is a connected subset of $\mathbb{T}_{d}$ containing $o \in \mathbb{T}_{d}$ because $y_{i} \in \mathrm{~T}_{\text {end }}^{y_{i}}$ with $\tau^{i}\left(y_{i}\right)=0$ and $B^{i} \subseteq B_{\mathcal{G}_{n}}\left(\mathrm{~T}_{\text {end }}^{y_{i}}, 1\right)$. We now define $\phi^{i}$ on $\tau^{i}\left(B^{i}\right) \subseteq \mathbb{T}_{d}$ and check the remaining properties in (4.7) and (4.8) for this case.

Set $\phi^{i}(\mathbf{o})=\phi^{i}\left(\tau^{i}\left(y_{i}\right)\right):=\psi\left(y_{i}\right)$ and for $j=1, \ldots, m$ define inductively $\phi^{i}\left(\tau^{i}\left(z_{j}\right)\right):=$ $\frac{1}{d-1} \phi^{i}\left(\tau^{i}\left(\bar{z}_{j}\right)\right)+\xi_{z_{j}} \cdot\left(\frac{d}{d-1}\right)^{\frac{1}{2}}$. Recall that here $\xi_{z_{j}}$ for $j=1, \ldots, m$ are the i.i.d. standard Gaussian random variables used to define $\psi\left(z_{1}\right), \ldots, \psi\left(z_{m}\right)$ at the respective moments on line 16 of the algorithm. Note that conditionally on $\psi\left(y_{i}\right)$, the field $\left(\phi^{i}\left(\tau^{i}(z)\right)\right)_{z \in B^{i}}$ has the same distribution as $\left(\varphi_{\mathbb{T}_{d}}\left(\tau^{i}(z)\right)\right)_{z \in B^{i}}$ under $\mathbb{P}_{\psi\left(y_{i}\right)}^{\mathbb{T}_{d}}$. This follows by (2.10)-(2.12) since $\tau^{i}$ is defined in such a way that $\tau^{i}(\bar{z})$ (in the notation of (3.17)) for $z \in\left\{z_{1}, \ldots, z_{m}\right\}$ is equal to $\overline{\tau^{i}(z)}$ (in the notation above (2.3)). We extend $\phi^{i}$ to all $w \in U:=\mathbb{T}_{d} \backslash B^{i}$ by recursively defining $\phi^{i}(w):=\frac{1}{d-1} \phi^{i}(\bar{w})+Y_{w}^{i}$. Then (4.8) holds for $\phi^{i}$ by (2.10)-(2.12). We proceed to show the remaining claim of (4.7). Note that $\left|\psi\left(y_{i}\right)-\phi^{i}\left(\tau^{i}\left(y_{i}\right)\right)\right|=\left|\psi\left(y_{i}\right)-\phi^{i}(\mathrm{o})\right|=$ $\left|\psi\left(y_{i}\right)-\psi\left(y_{i}\right)\right|=0$ by definition. For $j=1, \ldots, m$ one has

& \quad \leq\left|a\left(z_{j}, \psi, \mathrm{E}\right)-\frac{1}{d-1} \psi\left(\bar{z}_{j}\right)\right|+\left|\xi_{z_{j}}\right| \cdot\left|b\left(z_{j}, \mathrm{E}\right)^{\frac{1}{2}}-\left(\frac{d}{d-1}\right)^{\frac{1}{2}}\right|+\frac{1}{d-1}\left|\psi\left(\bar{z}_{j}\right)-\phi^{i}\left(\tau^{i}\left(\bar{z}_{j}\right)\right)\right| .
\end{aligned}
$$

To the first two differences on the right hand side we can apply (3.21) and (3.22) (on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$ ) since at any moment of the algorithm $|\mathrm{E}| \leq\left|\mathrm{E}_{\text {end }}\right| \leq$ $c_{h, \kappa} \ln \left(N_{n}\right)$ by (4.4). We also use the inequality $|\sqrt{s}-\sqrt{t}|=\frac{|s-t|}{\sqrt{s}+\sqrt{t}} \leq \frac{1}{\sqrt{t}}|s-t|$. So by Proposition 3.6 (for $b:=c_{h, \kappa}$ and $b^{\prime}:=c_{\kappa}$ ) we find $c_{h, \kappa}^{\prime}>0$ such that for all $j=1, \ldots, m$

Now note that on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$ one has, again by using Proposition 3.6 for the same $b:=c_{h, \kappa}$ and $b^{\prime}:=c_{\kappa}$, that for $j=1, \ldots, m$

& \stackrel{(3.21)}{\geq}\left|\xi_{z_{j}}\right| \cdot\left(\frac{d}{d-1}-c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-3}\right)^{\frac{1}{2}}-\left(\frac{1}{d-1} \psi\left(\bar{z}_{j}\right)+c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-2}\right) \\
& \geq\left|\xi_{z_{j}}\right|-M_{n},
\end{aligned}
$$

where the last inequality holds if $n$ is large enough. Combine this with the previous inequality to obtain that for $n$ large enough, $j=1, \ldots, m$ and on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$

This is the main ingredient to show the remainder of (4.7). By induction we will now show that for $n$ large enough and on $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$ one has

For $j=1$ one has $\bar{z}_{1}=y_{i}$ and the last summand on the right hand side of (4.10) vanishes by definition of $\phi^{i}\left(\tau^{i}\left(y_{i}\right)\right)$. Assume the statement holds for $1 \leq j<m$. Then either $\bar{z}_{j+1}=y_{i}$ and therefore the last summand on the right hand side of (4.10) vanishes again, or $\bar{z}_{j+1}=z_{k}$ for some $k \in\{1, \ldots, j\}$ and the induction hypothesis implies $\left|\psi\left(\bar{z}_{j+1}\right)-\phi^{i}\left(\tau^{i}\left(\bar{z}_{j+1}\right)\right)\right| \leq k\left(1+2 M_{n}\right) c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-2} \leq j\left(1+2 M_{n}\right) c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-2}$. In any case, using (4.10),

& \leq(j+1)\left(1+2 M_{n}\right) c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-2} .
\end{aligned}
$$

This concludes the induction.
Let $\varepsilon>0$. Since $\left\{z_{1}, \ldots, z_{m}\right\} \subseteq \mathrm{E}_{\text {end }}$, one has $m \leq\left|\mathrm{E}_{\text {end }}\right| \leq c_{h, \kappa} \ln \left(N_{n}\right)$ by (4.4). Moreover, $M_{n}=c_{\kappa} \sqrt{\ln \left(N_{n}\right)}$. So by (4.11) we obtain that for $n$ large enough and on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$, it hold that $\left|\psi\left(z_{j}\right)-\phi^{i}\left(\tau^{i}\left(z_{j}\right)\right)\right| \leq c_{h, \kappa} \ln \left(N_{n}\right)(1+$ $\left.2 c_{\kappa} \sqrt{\ln \left(N_{n}\right)}\right) c_{h, \kappa}^{\prime}\left(\ln \left(N_{n}\right)\right)^{-2} \leq \varepsilon$ for $j=1, \ldots, m$. We deduce (4.7).

It remains to show (4.8) for $i=k_{\text {end }}+1, \ldots, k_{\max }$ and (4.9). For $i=k_{\text {end }}+1, \ldots, k_{\max }$ define recursively $\phi^{i}(\mathrm{o}):=M_{n}$ and $\phi^{i}(z):=\frac{1}{d-1} \phi^{i}(\bar{z})+Y_{x}^{i}$ for $z \in \mathbb{T}_{d} \backslash\{\mathrm{o}\}$, so that (4.8) holds for $\phi^{i}$ by (2.10)-(2.12). Finally, note that for each $i=1, \ldots, k_{\max }$ the field $\phi^{i}$ is constructed using $\left(Y_{x}^{i}\right)_{x \in \mathbb{T}_{d} \backslash\{0\}}$ and possibly the i.i.d. random variables $\left(\xi_{z}\right)_{z \in B^{i}}$ and $\Psi\left(y_{i}\right)$. Since for $j=1, \ldots, k_{\max }$ with $j \neq i$ one has that $\left(Y_{x}^{i}\right)_{x \in \mathbb{T}_{d} \backslash\{0\}}$ is independent of $\left(Y_{x}^{j}\right)_{x \in \mathbb{T}_{d} \backslash\{0\}}$ and $B^{i} \cap B^{j}=\emptyset$, this shows (4.9) conditionally on $\Psi\left(y_{1}\right), \ldots, \Psi\left(y_{k_{\text {end }}}\right)$ (all random variables are Gaussian). The proof is complete.

Corollary 4.6. Let $h \in \mathbb{R}$ and $\varepsilon>0$. Consider Algorithm 1 and recall $k_{\text {max }}$ from Lemma 4.3. Then on the same auxiliary space $(\Omega, \mathcal{A}, \mathbb{P})$ as $\psi$ one can define random variables $Z^{1}, \ldots, Z^{k_{\max }}$ such that, conditionally on $\psi\left(y_{1}\right), \ldots, \psi\left(y_{k_{\text {end }}}\right)$, the following properties hold (see (2.12) and below (1.7) for notation):
for all $n$ large enough and all $i=1, \ldots, k_{\text {end }}$ one has $Z^{i} \geq\left|T_{\text {end }}^{y_{i}}\right|$ on
the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$;
$Z^{i}$ is distributed as $\left|\mathcal{C}_{\mathrm{o}}^{\mathrm{T}_{d}, h-\varepsilon}\right|$ under $\mathbb{P}_{\psi\left(y_{i}\right)}^{\mathrm{T}_{d}}$ for all $i=1, \ldots, k_{\mathrm{end}}$ and as
$\left|\mathcal{C}_{\mathrm{o}}^{\mathrm{T}_{d}, h-\varepsilon}\right|$ under $\mathbb{P}_{M_{n}}^{\mathrm{T}_{d}}$ for all $i=k_{\text {end }}+1, \ldots, k_{\max }$;
$Z^{1}, \ldots, Z^{k_{\max }}$ are independent.
Proof. We consider Lemma 4.5 and define $Z^{i}$ as the size of the connected component of $\left\{w \in \mathbb{T}_{d} \mid \phi^{i}(w) \geq h-\varepsilon\right\}$ containing the root $o \in \mathbb{T}_{d}$. Then (4.13) and (4.14) follow from (4.8) and (4.9). We turn to (4.12). Note that for $i=1, \ldots, k_{\text {end }}$ and $z \in \mathrm{~T}_{\text {end }}^{y_{i}}$ one has $\left|\psi(z)-\phi^{i}\left(\tau^{i}(z)\right)\right| \leq \varepsilon$ by (4.7) under the assumptions of (4.12). This shows that $\phi^{i}\left(\tau^{i}(z)\right) \geq h-\varepsilon$ since $\psi(z) \geq h$ due to $z \in \mathrm{~T}_{\text {end }}^{y_{i}}$. Hence $\tau^{i}\left(\mathrm{~T}_{\text {end }}^{y_{i}}\right) \subseteq\left\{w \in \mathbb{T}_{d} \mid \phi^{i}(w) \geq\right.$ $h-\varepsilon\}$. As $\tau^{i}\left(\mathrm{~T}_{\text {end }}^{y_{i}}\right)$ is also a connected subset of $\mathbb{T}_{d}$ containing o $\in \mathbb{T}_{d}$, we conclude $\left|\tau^{i}\left(\mathrm{~T}_{\text {end }}^{y_{i}}\right)\right| \leq Z^{i}$ by definition of $Z^{i}$. The proof of (4.12) follows since $\tau^{i}$ is an injection and hence $\left|\tau^{i}\left(\mathrm{~T}_{\text {end }}^{y_{i}}\right)\right|=\left|\mathrm{T}_{\text {end }}^{y_{i}}\right|$.

We are now ready to show Proposition 4.2, which as explained above its statement implies Theorem 4.1 and thereby concludes Section 4.

Proof of Proposition 4.2. Let $h>h_{\star}$ and $\kappa>0$. Choose $\varepsilon>0$ small enough such that $h-\varepsilon>h_{\star}$. Moreover, let $\delta_{h-\varepsilon}>0$ be such that $g_{h-\varepsilon}$ defined in (2.15) has the properties explained therein. Let $K=K_{h, \kappa}>0$ to be fixed later (below (4.21)). By conditioning on $\mathcal{F}_{\text {end }}:=\sigma\left(\psi\left(y_{1}\right), \ldots, \psi\left(y_{k_{\text {end }}}\right)\right)$ and then applying (4.12), one has for $n$ large enough

Since $\left\{\sum_{i=1}^{k_{\max }} Z^{i} \geq K \ln \left(N_{n}\right)\right\}=\left\{\prod_{i=1}^{k_{\max }}\left(1+\delta_{h-\varepsilon}\right)^{Z^{i}} \geq\left(1+\delta_{h-\varepsilon}\right)^{K \ln \left(N_{n}\right)}\right\}$, the conditional Markov inequality leads to $\mathbb{P}$-almost surely

By (2.10)-(2.12) one has $\mathbb{E}_{\psi\left(y_{i}\right)}^{\mathrm{T}_{d}}\left[\left(1+\delta_{h-\varepsilon}\right)^{\left|\mathcal{C}_{o}^{\mathbb{T}_{d}, h-\varepsilon}\right|}\right] \leq \mathbb{E}_{M_{n}}^{\mathbb{T}_{d}}\left[\left(1+\delta_{h-\varepsilon}\right)^{\left|\mathcal{C}_{o}^{\mathbb{T}_{d}, h-\varepsilon}\right|}\right]$ for $i=$ $1, \ldots, k_{\text {end }}$ on the event $\left\{\sup _{z \in \mathrm{E}_{\text {end }}}|\psi(z)|<M_{n}\right\}$. This combined with (4.15) and (4.16) shows that for $n$ large enough

Let us write $S_{\mathbb{T}_{d}}(\mathrm{o}, 1)=:\left\{x_{1}, \ldots, x_{d}\right\}$ so that $\mathbb{T}_{d}=\{\mathrm{o}\} \cup \bigcup_{i=1}^{d} U_{x_{i}}$ (see (2.3)). Note that for $n$ large enough one has $M_{n} \geq h$. Therefore [2], equation (2.11), implies that

where $Y \sim \mathcal{N}\left(0, \frac{d}{d-1}\right)$ and the expectation $\mathbb{E}^{Y}$ is taken with respect to $Y$. The inner expectation on the right hand side of (4.18) is $g_{h-\varepsilon}\left(\frac{M_{n}}{d-1}+Y\right)$ by definition (see (2.15)). Thus (4.18) shows that for $n$ large enough

\mathbb{E}_{M_{n}}^{\mathbb{T}_{d}}\left[\left(1+\delta_{h-\varepsilon}\right)^{\left|\mathcal{C}_{o}^{\mathbb{T}_{d}, h-\varepsilon}\right|}\right] \leq\left(\left(1+\delta_{h-\varepsilon}\right) \mathbb{E}^{Y}\left[g_{h-\varepsilon}\left(\frac{M_{n}}{d-1}+Y\right)\right]^{d-1}\right)^{\frac{d}{d-1}} \tag{4.19}
\end{equation*}
$$

For $n$ large enough (so $M_{n} \geq h$ ) one has that $\left(1+\delta_{h-\varepsilon}\right) \mathbb{E}^{Y}\left[g_{h-\varepsilon}\left(\frac{M_{n}}{d-1}+Y\right)\right]^{d-1}=g_{h-\varepsilon}\left(M_{n}\right)$
by (2.15). Hence (4.19) and (4.17) imply that for $n$ large enough

& \leq\left(1+\delta_{h-\varepsilon}\right)^{-K \ln \left(N_{n}\right)}\left(g_{h-\varepsilon}\left(M_{n}\right)\right)^{\frac{d}{d-1} k_{\max }}
\end{align*}
$$

By (2.15) we know that there exist $c_{h}>0$ and $c_{h}^{\prime}>0$ such that for $n$ large enough one has $g_{h-\varepsilon}\left(M_{n}\right) \leq c_{h} \exp \left(c_{h}^{\prime} M_{n}^{3 / 2}\right)=c_{h} \exp \left(c_{h}^{\prime}\left(c_{\kappa} \sqrt{\ln \left(N_{n}\right)}\right)^{3 / 2}\right) \leq c_{h} \exp \left(c_{h, \kappa}\left(\ln \left(N_{n}\right)\right)^{3 / 4}\right)$ for some $c_{h, \kappa}>0$. Now recall that $k_{\max }=c_{1} K^{2} s_{n}$. Therefore, by (3.16), we can find $c_{h}, c_{h, \kappa}>0$ for which $\left(g_{h-\varepsilon}\left(M_{n}\right)\right)^{\frac{d}{d-1} k_{\max }} \leq c_{h} \exp \left(c_{h, \kappa} K^{2}\left(\ln \left(N_{n}\right)\right)^{7 / 8}\right)$. So for some $c_{h}>0$ and $c_{h, \kappa}>0$ we obtain that $\left(1+\delta_{h-\varepsilon}\right)^{-K \ln \left(N_{n}\right)}\left(g_{h-\varepsilon}\left(M_{n}\right)\right)^{\frac{d}{d-1} k_{\max }} \leq c_{h} \exp \left(-c_{h, \kappa} K \ln \left(N_{n}\right)\right)$ for all $n$ large enough. Hence by (4.20), for $n \geq 1$,

Take $K=K_{h, \kappa}>0$ large enough such that $c_{h, \kappa} N_{n}^{-c_{h, \kappa}^{\prime} K_{h, \kappa}} \leq N_{n}^{-1-\kappa}$. Then by (4.21) we can find $c_{h, \kappa}>0$ large enough such that (4.6) holds for all $n \geq 1$. The proof of Proposition 4.2 and ultimately of Theorem 4.1 is complete.

## 5 Mesoscopic components in the supercritical phase

The last section of this article concerns the proof of (1.9) in the form of Theorem 5.1 below, that is, the existence of a supercritical phase (complementary to the subcritical situation in Section 4) in which the connected components of the levels sets of $\Psi_{\mathcal{G}_{n}}$ of at least mesoscopic size contain a non-negligible fraction of the vertices of $\mathcal{G}_{n}$. By mesoscopic size we mean that the number of vertices contained is a fractional power of the total number of vertices of $\mathcal{G}_{n}$. To be more specific, we recall the critical value $h_{\star}$ (see (1.7)) and the notation $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ for the connected component of the level set of $\Psi_{\mathcal{G}_{n}}$ above level $h \in \mathbb{R}$ containing $x \in \mathcal{G}_{n}$ (see beginning of Section 4). Similarly, we denote by $\mathcal{C}_{x}^{\mathbb{T}_{d}, h}$ for $x \in \mathbb{T}_{d}$ and $h \in \mathbb{R}$ the connected component of the level set of $\varphi_{\mathbb{T}_{d}}$ above level $h$ containing $x$. We also remind of the function $\eta^{+}$given in (2.14). The main result of this section is the following
Theorem 5.1. Let $h<h_{\star}$. Then there exist $c_{h}>0$ (see beginning of the proof of Lemma 5.4) such that

\lim _{n \rightarrow \infty} \mathbb{P}^{\mathcal{G}_{n}}\left[\sum_{x \in \mathcal{G}_{n}} \mathbf{1}_{\left\{\left|\mathcal{C}_{x}^{\mathcal{G}_{n}, h}\right| \geq N_{n}^{c_{h}}\right\}} \geq \frac{\eta^{+}(h)}{2} N_{n}\right]=1 . \tag{5.1}
\end{equation*}
$$

As explained in the introduction below (1.9), it remains open whether in the supercritical phase $h<h_{\star}$, as the size of the graphs tends to infinity, one actually observes the emergence of a (unique) giant connected component of the level set above level $h$ (see also Remark 5.7).

We now give the idea of the proof of Theorem 5.1. Roughly, the strategy is to control the expectation and variance of the sum in (5.1) and then to deduce Theorem 5.1 via a second moment inequality. Now recall that by (1.2) all vertices of $\mathcal{G}_{n}$ have an almost tree-like neighbourhood. One can also show that only a negligible fraction does not have an exactly tree-like neighbourhood of smaller size (Remark 5.3). So essentially we can consider only vertices with a tree-like neighbourhood in the sum in (5.1). Moreover, instead of counting the vertices $x \in \mathcal{G}_{n}$ with $\left|\mathcal{C}_{x}^{\mathcal{G}_{n}, h}\right| \geq N_{n}^{\gamma}$ for some
fixed $\gamma>0$ (i.e. contained in a mesoscopic connected component of $E_{\Psi_{\mathcal{G}_{n}}}^{\geq h}$ ), it will be easier to only consider the vertices $x \in \mathcal{G}_{n}$ for which the connected component $\mathcal{C}_{x}^{\mathcal{G}_{n}, h}$ is already mesoscopic when intersected with the tree-like neighbourhood of $x$ (see (5.3)). We show that the expected number of such vertices grows linearly in the total number of vertices of the graph $\mathcal{G}_{n}$ as $n$ tends to infinity (Lemma 5.4). A variance computation then implies that the number of vertices contained in mesoscopic components concentrates around its expectation as $n$ goes to infinity (Lemma 5.6). The computations concerning the expectation and variance rely on the local approximation of $\Psi_{\mathcal{G}_{n}}$ by $\varphi_{\mathbb{T}_{d}}$ around vertices with tree-like neighbourhood that we developed in Section 3.1, which allows us to reduce the computations about $\Psi_{\mathcal{G}_{n}}$ to computations about $\varphi_{\mathrm{T}_{d}}$ and apply results from Section 2.1 on $\varphi_{\mathbb{T}_{d}}$. With a second moment inequality Theorem 5.1 promptly follows. The section ends with open questions in the supercritical regime $h<h_{\star}$ (Remark 5.7).

It will be convenient to introduce some additional notation. For $x \in \mathcal{G}_{n}, n \geq 1$ and $R \geq 0$ we set $S_{\mathcal{G}_{n}}^{+}(x, R):=\pi_{n, x}\left(S_{\mathbb{T}_{d}}^{+}(\mathrm{o}, R)\right)$ (see below (2.3) for the notation). We also define

r_{n}:=\max \left\{1,\left\lfloor\frac{c_{0}}{18} \log _{d-1}\left(N_{n}\right)\right\rfloor\right\} \text { and } R_{n}:=\max \left\{1,\left\lfloor\frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)\right\rfloor\right\} . \tag{5.2}
\end{equation*}
$$

For $n \geq 1, h \in \mathbb{R}$ and $\gamma>0$ we define the events

A_{x}^{\mathrm{T}_{d}, h, \gamma}:=\left\{\left|\mathcal{C}_{x}^{\mathrm{T}_{d}, h} \cap S_{\mathbb{T}_{d}}^{+}\left(x, r_{n}\right)\right| \geq N_{n}^{\gamma}\right\} & \text { for } x \in \mathbb{T}_{d} . \tag{5.3}
\end{align*}
$$

Note that the dependency on $n$ in the definition of $A_{x}^{\mathbb{T}_{d}, h, \gamma}$ in (5.3) does not appear in the notation. Finally, we define (with $c_{0}$ as in (2.31))

By (2.13) note that $\gamma_{h}$ is decreasing in $h$ and $\gamma_{h}>0$ for $h<h_{\star}$.
In the remainder of this section we will apply several times Theorem 3.1 for $r=r_{n}$ and $R=R_{n}$ given in (5.2). Note that, for $n$ large enough, $1 \leq r_{n}<R_{n} \leq \frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)$ as required by Theorem 3.1 and furthermore $r_{n} \leq \frac{c_{0}}{18} \log _{d-1}\left(N_{n}\right)$ and $R_{n}-2 r_{n} \geq$ $\left(\frac{c_{0}}{6} \log _{d-1}\left(N_{n}\right)-1\right)-2 \frac{c_{0}}{18} \log _{d-1}\left(N_{n}\right)=\frac{c_{0} \log _{d-1}\left(N_{n}\right)}{18}-1$. Therefore Theorem 3.1 directly implies (with the notation from the beginning of Section 3.1)
Lemma 5.2 (Corollary of Theorem 3.1). There exist $c, c^{\prime}>0$ such that for all $n \geq 1$ and $x, x^{\prime} \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0, \operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)\right)=0$ and $B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right) \cap$ $B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)=\emptyset$, there exists a coupling $\mathbb{Q}_{n}$ of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathbb{T}_{d}}$ satisfying for all $\varepsilon>0$

\mathbb{Q}_{n}\left[\sup _{y \in V_{n}}\left|\Psi_{\mathcal{G}_{n}}(y)-\varphi_{\mathbb{T}_{d}}\left(\rho_{x, x^{\prime}, 2 R_{n}}(y)\right)\right|>\varepsilon\right] \leq c \exp \left(-c^{\prime} \varepsilon^{2} N_{n}^{\frac{c_{0}}{18}}\right) \tag{5.5}
\end{equation*}

where $V_{n}:=B_{\mathcal{G}_{n}}\left(x, r_{n}\right) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, r_{n}\right)$. In particular, there exist $c, c^{\prime}>0$ such that for all $n \geq 1, x \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0$, there is a coupling $\mathrm{Q}_{n}$ of $\Psi_{\mathcal{G}_{n}}$ and $\varphi_{\mathrm{T}_{d}}$ such that for all $\varepsilon>0$ the same bound as in (5.5) applies to $\mathbb{Q}_{n}\left[\sup _{y \in B_{\mathcal{G}_{n}}\left(x, r_{n}\right)} \mid \Psi_{\mathcal{G}_{n}}(y)-\right.$ $\left.\varphi_{\mathbb{T}_{d}}\left(\rho_{x, 2 R_{n}}(y)\right) \mid>\varepsilon\right]$.

As the following remark explains, the assumptions on the vertices in the statement of Lemma 5.2 are typical.
Remark 5.3. Recall $R_{n}$ from (5.2). For $n$ large enough the number of vertices $x \in \mathcal{G}_{n}$ that do not satisfy $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0$ is negligible when compared to the total number of vertices of $\mathcal{G}_{n}$. Indeed, for $n$ large enough one has $2 R_{n} \leq\left\lfloor\alpha \log _{d-1}\left(N_{n}\right)\right\rfloor$ by (2.31) and (2.1) and thus $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right) \leq 1$ for all $x \in \mathcal{G}_{n}$ by assumption (1.2). Now by [8],

Lemma 6.1, we have for $n$ large enough

where in $(*)$ we use that $\left\lfloor\alpha \log _{d-1}\left(N_{n}\right)\right\rfloor-2 R_{n} \geq \alpha \log _{d-1}\left(N_{n}\right)-1-\frac{c_{0}}{3} \log _{d-1}\left(N_{n}\right) \geq$ $\frac{2 \alpha}{3} \log _{d-1}\left(N_{n}\right)-1$ (because $c_{0} \leq \alpha$ by (2.31) and (2.1)). Moreover, for $n$ large enough, also the number of pairs of vertices $x, x^{\prime} \in \mathcal{G}_{n}$ for which $B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right) \neq \emptyset$ is negligible when compared to the total number $N_{n}^{2}$ of pairs of vertices of $\mathcal{G}_{n}$. Indeed, for $n$ large enough and for such $x, x^{\prime} \in \mathcal{G}_{n}$ one has $x^{\prime} \in B_{\mathcal{G}_{n}}\left(x, 4 R_{n}\right)$ and hence

\begin{align*}
& \left|\left\{x, x^{\prime} \in \mathcal{G}_{n} \mid B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right) \neq \emptyset\right\}\right| \leq \sum_{x \in \mathcal{G}_{n}}\left|B_{\mathcal{G}_{n}}\left(x, 4 R_{n}\right)\right| \\
& \quad \stackrel{(1.1)}{\leq} N_{n}\left|B_{\mathbb{T}_{d}}\left(\mathbf{o}, 4 R_{n}\right)\right|=N_{n} \frac{d(d-1)^{4 R_{n}}-2}{d-2}  \tag{5.7}\\
& \quad \stackrel{(5.2)}{\leq} N_{n} d(d-1)^{\frac{2 c_{0}}{3}} \log _{d-1}\left(N_{n}\right) \leq d N_{n}^{\frac{5}{3}}
\end{align*}
$$

where the last inequality follows because $c_{0} \leq 1$ (see (2.31)).
We are now ready to proceed with the expectation and variance computation announced after the statement of Theorem 5.1.
Lemma 5.4. Let $h<h_{\star}$. There exists $c_{h}>0$ such that for all $0<\varepsilon<\frac{h_{\star}-h}{2}$ and $\zeta>0$ one has for $n$ large enough

\mathbb{P}^{\mathcal{G}_{n}}\left[A_{x}^{\mathcal{G}_{n}, h, c_{h}}\right] \geq \eta^{+}(h+\varepsilon)-\zeta \quad \text { for } x \in \mathcal{G}_{n} \text { with } \operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0 \tag{5.8}
\end{equation*}
$$

As a consequence, one has

\liminf _{n \rightarrow \infty} \frac{1}{N_{n}} \mathbb{E}^{\mathcal{G}_{n}}\left[\sum_{x \in \mathcal{G}_{n}} \mathbf{1}_{A_{x}^{\mathcal{G}_{n}, h, c_{h}}}\right] \geq \eta^{+}(h)>0 . \tag{5.9}
\end{equation*}
$$

Proof. Let $h<h_{\star}$ and take $\delta:=\frac{h_{\star}-h}{2}>0$ so that $h+\delta<h_{\star}$. Let $\varepsilon<\delta$. Set also $c_{h}:=\gamma_{h+\delta}$. For $x \in \mathcal{G}_{n}$ as in the statement of (5.8) we can apply Lemma 5.2 and obtain that for $n \geq 1$ one has (recall that $\rho_{x, 2 R_{n}}$ is a graph isomorphism from $B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)$ to $B_{\mathbb{T}_{d}}\left(\mathrm{o}, 2 R_{n}\right)$, see beginning of Section 3.1)

& \stackrel{(5.3)}{\geq} \mathbb{Q}_{n}\left[A_{0}^{\mathbb{T}_{d}, h+\varepsilon, \gamma_{h+\delta}}, \sup _{y \in B_{\mathcal{G}_{n}}\left(x, r_{n}\right)}\left|\Psi_{\mathcal{G}_{n}}(y)-\varphi_{\mathbb{T}_{d}}\left(\rho_{x, 2 R_{n}}(y)\right)\right| \leq \varepsilon\right]  \tag{5.10}\\
& \geq \mathbb{P}^{\mathbb{T}_{d}}\left[A_{0}^{\mathbb{T}_{d}, h+\varepsilon, \gamma_{h+\delta}}\right]-c \exp \left(-c^{\prime} \varepsilon^{2} N_{n}^{\frac{c_{0}}{18}}\right) .
\end{align*}

Note that since $0<\varepsilon<\delta$ one has $\gamma_{h+\delta}<\gamma_{h+\varepsilon}$ and hence

& \underset{(5.4)}{(5.3)} \liminf _{n \rightarrow \infty} \mathbb{P}^{\mathbb{T}_{d}}\left[\left|\mathcal{C}_{\mathbf{o}}^{\mathbb{T}_{d}, h+\varepsilon} \cap S_{\mathbb{T}_{d}}^{+}\left(\mathrm{o}, r_{n}\right)\right| \geq \lambda_{h+\varepsilon}^{\frac{c_{0}}{20} \log _{d-1}\left(N_{n}\right)}\right]  \tag{5.11}\\
& \stackrel{(*)}{\geq} \liminf _{n \rightarrow \infty} \mathbb{P}^{\mathbb{T}_{d}}\left[\left|\mathcal{C}_{\mathbf{o}}^{\mathbb{T}_{d}, h+\varepsilon} \cap S_{\mathbb{T}_{d}}^{+}\left(\mathbf{o}, r_{n}\right)\right| \geq \frac{\lambda_{h+\varepsilon}^{r_{n}}}{r_{n}^{2}}\right] \stackrel{(2.16)}{=} \eta^{+}(h+\varepsilon),
\end{align*}
$$

where in (*) we use that $\lambda_{h+\varepsilon}>1$ (see (2.13)) and the definition of $r_{n}$ (see (5.2)). By combining (5.10) and (5.11) we find (5.8). For (5.9) we only need to notice that,
for $n$ large enough, $\left|\left\{x \in \mathcal{G}_{n} \mid \operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0\right\}\right| \geq N_{n}-(d-1) N_{n}^{1-\frac{2 \alpha}{3}}$ by (5.6). So (5.9) follows from (5.8) by summing only over $x \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=0$ and applying (2.14).

As a next step we want to show that $\sum_{x \in \mathcal{G}_{n}} \mathbf{1}_{A_{x}^{\mathcal{G}_{n}, h, c_{h}}}$ for $h<h_{\star}$ and the $c_{h}>0$ from Lemma 5.4 concentrates around its expectation. A variance computation will be enough. The main ingredient is contained in the next lemma.
Lemma 5.5. Let $h<h_{\star}$. There exist $c, c^{\prime}>0$ such that for all $n \geq 1, x, x^{\prime} \in \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)\right)=0$ and $B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)=\emptyset$ one has for all $\gamma>0$ and $\varepsilon>0$

\mathbb{P}^{\mathcal{G}_{n}}\left[A_{x}^{\mathcal{G}_{n}, h, \gamma}, A_{x^{\prime}}^{\mathcal{G}_{n}, h, \gamma}\right] \leq \mathbb{P}^{\mathbb{T}_{d}}\left[A_{0}^{\mathrm{T}_{d}, h-\varepsilon, \gamma}\right]^{2}+c \exp \left(-c^{\prime} \varepsilon^{2} N_{n}^{\frac{c_{0}}{18}}\right) \tag{5.12}
\end{equation*}
$$

Proof. Let us abbreviate $V_{n}:=B_{\mathcal{G}_{n}}\left(x, r_{n}\right) \cup B_{\mathcal{G}_{n}}\left(x^{\prime}, r_{n}\right)$. For $x, x^{\prime} \in \mathcal{G}_{n}$ as in the assumptions we can apply Lemma 5.2 and obtain that for all $n \geq 1, \gamma>0$ and $\varepsilon>0$ one has (recall the notation $\rho_{x, x^{\prime}, 2 R_{n}}$ and $z_{x, x^{\prime}}$ from the beginning of Section 3.1)

& \quad+c \exp \left(-c^{\prime} \varepsilon^{2} N_{n}^{\frac{c_{0}}{18}}\right) \\

To further bound the probability on the right hand side of (5.13) we apply the decoupling inequality [20], Corollary 1.3 , with $\delta:=\frac{\varepsilon}{2}, K_{1}:=B_{\mathbb{T}_{d}}\left(\mathbf{o}, r_{n}\right), K_{2}:=B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, r_{n}\right)$ and $f_{1}, f_{2}: \mathbb{R}^{\mathbb{T}_{d}} \rightarrow[0,1]$ such that

(the decoupling inequality [20], Corollary 1.3, is stated for the Gaussian free field on $\mathbb{Z}^{d}$ but its proof directly applies also for the Gaussian free field $\varphi_{T_{d}}$ on $\mathbb{T}_{d}$ ). We obtain that for all $n \geq 1, \gamma>0$ and $\varepsilon>0$

& +2 \mathbb{P}^{\mathbb{T}_{d}}\left[\sup _{y \in K_{2}}\left|E_{y}^{\mathbb{T}_{d}}\left[\varphi_{\mathbb{T}_{d}}\left(X_{H_{K_{1}}}\right) \mathbf{1}_{\left\{H_{K_{1}}<\infty\right\}}\right]\right|>\frac{\varepsilon}{4}\right] \tag{5.14}
\end{align*}

Note that, since we are on a tree and $K_{1}$ and $K_{2}$ are two disjoint connected sets, there is a unique pair of vertices $z_{1} \in K_{1}, z_{2} \in K_{2}$ with $d_{\mathbb{T}_{d}}\left(K_{1}, K_{2}\right):=\inf _{z \in K_{1}, z^{\prime} \in K_{2}} d_{\mathbb{T}_{d}}\left(z, z^{\prime}\right)=$ $d_{\mathbb{T}_{d}}\left(z_{1}, z_{2}\right)$. Moreover, on the event $\left\{H_{K_{1}}<\infty\right\}$ one $P_{y}^{\mathrm{T}_{d} \text {-almost surely has } \varphi_{\mathbb{T}_{d}}\left(X_{H_{K_{1}}}\right)=, ~=~}$ $\varphi_{\mathrm{T}_{d}}\left(z_{1}\right)$ for $y \in K_{2}$. Therefore,

where in $(*)$ we use the exponential Markov inequality for the centred Gaussian random variable $\varphi_{\mathbb{T}_{d}}\left(z_{1}\right)$ and in (**) we use that $P_{z_{2}}^{\mathbb{T}_{d}}\left[H_{z_{1}}<\infty\right]=\left(\frac{1}{d-1}\right)^{d_{\mathbb{T}_{d}}\left(z_{1}, z_{2}\right)}$ (see e.g. [28], proof of Lemma 1.24). Since $K_{1} \subseteq B_{\mathbb{T}_{d}}\left(\mathbf{o}, 2 R_{n}\right), K_{2} \subseteq B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, 2 R_{n}\right)$ and $B_{\mathbb{T}_{d}}\left(\mathrm{o}, 2 R_{n}\right) \cap$ $B_{\mathbb{T}_{d}}\left(z_{x, x^{\prime}}, 2 R_{n}\right)=\emptyset$ by assumption, one has the estimate $d_{\mathbb{T}_{d}}\left(z_{1}, z_{2}\right)=d_{\mathbb{T}_{d}}\left(K_{1}, K_{2}\right)>$ $2\left(2 R_{n}-r_{n}\right) \geq \frac{5 c_{0}}{9} \log _{d-1}\left(N_{n}\right)-4$ for $n$ large enough. Hence $\exp \left(-c \varepsilon^{2}(d-1)^{2 d_{\mathbb{T}_{d}}\left(z_{1}, z_{2}\right)}\right) \leq$ $c \exp \left(-c^{\prime} \varepsilon^{2} N_{n}^{\frac{10 c_{0}}{9}}\right)$. Therefore we can combine (5.13), (5.14) and (5.15) to obtain that for all $n \geq 1, \gamma>0$ and $\varepsilon>0$ (using also the symmetry of $\mathbb{T}_{d}$ )

This concludes the proof of (5.12) since by (5.3) it holds $A_{0}^{\mathbb{T}_{d}, h-\frac{\varepsilon}{2}, \gamma} \subseteq A_{0}^{\mathbb{T}_{d}, h-\varepsilon, \gamma}$.
We are now ready to for the variance computation. This is the last ingredient for the proof of Theorem 5.1.

Lemma 5.6. Let $h<h_{\star}$. Then for the $c_{h}>0$ from Lemma 5.4 one has

We define $W \subseteq \mathcal{G}_{n} \times \mathcal{G}_{n}$ to be the set of pairs $\left(x, x^{\prime}\right) \in \mathcal{G}_{n} \times \mathcal{G}_{n}$ with $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right)\right)=$ $\operatorname{tx}\left(B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)\right)=0$ and $B_{\mathcal{G}_{n}}\left(x, 2 R_{n}\right) \cap B_{\mathcal{G}_{n}}\left(x^{\prime}, 2 R_{n}\right)=\emptyset$. For $x, x^{\prime} \in \mathcal{G}_{n}$ such that $\left(x, x^{\prime}\right) \notin W$ we can bound the probability on the right hand side of (5.17) by one. This will be good enough since for $n$ large enough $\left|\left(\mathcal{G}_{n} \times \mathcal{G}_{n}\right) \backslash W\right| \leq 2 N_{n} \cdot(d-1) N_{n}^{1-\frac{2 \alpha}{3}}+d N_{n}^{\frac{5}{3}} \leq$ $d N_{n}\left(2 N_{n}^{1-\frac{2 \alpha}{3}}+N_{n}^{\frac{2}{3}}\right)$ by (5.6) and (5.7). For $x, x^{\prime} \in \mathcal{G}_{n}$ such that $\left(x, x^{\prime}\right) \in W$ we use (5.12) instead. There are at most $N_{n}^{2}$ such pairs. Thus we obtain for all $n \geq 1, \gamma>0$ and $\varepsilon>0$

+d\left(2 N_{n}^{-\frac{2 \alpha}{3}}+N_{n}^{-\frac{1}{3}}\right)-\frac{1}{N_{n}^{2}} \mathbb{E}^{\mathcal{G}_{n}}\left[\sum_{x \in \mathcal{G}_{n}} \mathbf{1}_{A_{x}^{\mathcal{G}_{n}, h, \gamma}}\right]^{2} \tag{5.18}

Now we apply (5.18) to $\gamma:=c_{h}>0$ for the $c_{h}$ from Lemma 5.4 and deduce that for all $0<\varepsilon<\frac{h_{\star}-h}{2}$

The statement follows by letting $\varepsilon$ tend to zero and applying (2.14).
Proof of Theorem 5.1. We will show that the probability of the complementary event tends to zero. For $n \geq 1$ define $W_{n}^{\geq h}:=\sum_{x \in \mathcal{G}_{n}} \mathbf{1}_{A_{x}^{\mathcal{G}_{n}, h, c_{h}}}$ with $c_{h}>0$ as in Lemma 5.4.

Then we can estimate

\quad=\mathbb{P}^{\mathcal{G}_{n}}\left[\frac{1}{N_{n}} \mathbb{E}^{\mathcal{G}_{n}}\left[W_{n}^{\geq h}\right]-\frac{1}{N_{n}} W_{n}^{\geq h}>\frac{1}{N_{n}} \mathbb{E}^{\mathcal{G}_{n}}\left[W_{n}^{\geq h}\right]-\frac{\eta^{+}(h)}{2}\right]

& \stackrel{(*)}{\leq} \limsup _{n \rightarrow \infty} \frac{4}{\eta^{+}(h)^{2}} \operatorname{Var}_{\mathbb{P}_{\mathcal{G}_{n}}}\left(\frac{1}{N_{n}} W_{n}^{\geq h}\right) \stackrel{(5.16)}{=} 0,

where in $(*)$ we use Chebyshev's inequality. This concludes the proof of Theorem 5.1.
Remark 5.7. It remains open whether in the supercritical phase $h<h_{\star}$, with high probability for large $n$, there actually is a macroscopic (giant) connected component of the level set above level $h$ (i.e. containing a number of vertices comparable to $\mathcal{G}_{n}$ ), and whether this giant component is unique (meaning the size of the second-largest connected component is negligible compared to $\mathcal{G}_{n}$ ). For other probabilistic models on essentially the same class of graphs this has been shown. One example is the emergence of a unique giant connected component for Bernoulli bond percolation on $d$-regular expanders of large girth (see [4] and also [15]). A second example is the emergence of a unique giant connected component in the vacant set of simple random walk on the same graphs $\left(\mathcal{G}_{n}\right)_{n \geq 1}$ as considered here (see [8]). As briefly mentioned in the introduction below (1.9), such results are typically obtained by a sprinkling argument out of an intermediary result like Theorem 5.1. In our setting, the zero-average property of $\Psi_{\mathcal{G}_{n}}$ (see below (2.19)) prevents us from easily implementing such a strategy. In particular, due to the zero-average property, the field $\Psi_{\mathcal{G}_{n}}$ neither satisfies an FKG-inequality nor does it possess the domain Markov property of the Gaussian free field $\varphi_{\mathrm{T}_{d}}$ (compare (2.21) with (2.9)). In contrast, the sprinkling argument in [12] for constructing an infinite connected component for the Gaussian free field on $\mathbb{Z}^{d}$ for high-dimension $d$ crucially relies on the domain Markov property of the Gaussian free field on $\mathbb{Z}^{d}$ for $d \geq 3$.
