Subscription Rates. Current issues are \$20 per volume (six issues of one calendar year) in the U.S. and Canada, \$15 per volume elsewhere. Single issues are \$5.25. Back numbers for all issues up to and including 1956 (Vol. XXVII) are \$12 per volume, \$3.50 per issue; issues from 1957 on are \$20 per volume, \$5.25 per issue; for complete sets, \$200 for the first 25 volumes, \$10 per additional volume purchased at the same time as Volumes I through XXV.

Communications concerning **subscriptions, back numbers, payment of dues, membership, changes of address, etc.**, should be addressed to Professor George J. Resnikoff, Treasurer, Department of Statistics, California State College, Hayward, California 94542.

Papers to be submitted for publication should be sent to the Editor, D. L. Burkholder, Department of Mathematics, University of Illinois, Urbana, Illinois 61803. **Abstracts and corrected galley proofs** should be sent to the Managing Editor, P. L. Meyer, Department of Mathematics, Washington State University, Pullman, Washington 99163.

Preparation of manuscripts. Each manuscript should be typewritten, double spaced, with wide margins at sides, top, and bottom, and the original should be submitted with one additional copy, on paper that will take corrections. Dittoed or mimeographed papers are acceptable only if completely legible. Footnotes should be reduced to a minimum, and where possible replaced by remarks in the text, or bibliography at the end of the paper; formulae in footnotes should be avoided. References should follow the new style.

Figures, charts, and diagrams should be professionally drawn on plain white paper or tracing cloth in black India ink twice the size they are to be printed.

Authors are asked to keep in mind the typographical difficulties of complicated mathematical formulae. The difference between capital and lower-case letters should be clearly shown; care should be taken to avoid confusion between such pairs as zero and the letter O, the numeral 1 and the letter l, numeral 1 used as superscript and prime ('), alpha and a, kappa and k, mu and u, nu and v, eta and n, etc. Subscripts or superscripts should be clearly below or above the line. Bars above groups of letters (e.g., log x) and underlined letters (e.g., x) are difficult to print and should be avoided. Symbols are automatically italicized by the printer and should not be underlined on manuscripts. Boldface letters may be indicated by underlining with a wavy line on the manuscript; boldface subscripts and superscripts are not available. Complicated exponentials should be represented with the symbol exp. In writing square roots the fractional exponent is preferable to the radical sign. Fractions *in the body of the text* (as opposed to displayed expressions) and fractions occurring in the numerators or denominators of fractions are preferably written with the

solidus; thus $(a + b)/(c + d)$ rather than $\frac{a + b}{c + d}$, and ab/cd rather than $\frac{ab}{cd}$.

Authors will ordinarily receive only galley proofs. Fifty reprints without covers will be furnished free. Additional reprints and covers will be furnished at cost.
