All other communications should be addressed to the managing editor, or Elaine Barth, University of California, Los Angeles, California 90024.

There are page-charges associated with articles appearing in the *Pacific Journal of Mathematics*. These charges are expected to be paid by the author's University, Government Agency or Company. If the author or authors do not have access to such Institutional support these charges are waived. Single authors will receive 50 free reprints; joint authors will receive a total of 100 free reprints. Additional copies may be obtained at cost in multiples of 50.
