

Differential Equations in the Spectral Parameter, Darboux Transformations and a Hierarchy of Master Symmetries for KdV

Abstract. We study a certain family of Schrödinger operators whose eigenfunctions $\varphi(x, \lambda)$ satisfy a differential equation in the spectral parameter λ of the form $B(\lambda, \partial_\lambda)\varphi = \Theta(x)\varphi$. We show that the flows of a hierarchy of master symmetries for KdV are tangent to the manifolds that compose the strata of this class of *bispectral* potentials. This extends and complements a result of Duistermaat and Grünbaum concerning a similar property for the Adler and Moser potentials and the flows of the KdV hierarchy.

1. Introduction

The theory of solitons is still a source of surprises and unexpected connections. The purpose of this article is to report another one of these connections. More specifically, the link between a hierarchy of nonlinear evolution equations closely related to the Korteweg-de Vries (KdV) equation and the *bispectral problem*, which was introduced in [8]. This problem, for the Schrödinger operator $L = -\partial_x^2 + u$, can be formulated as follows: When do the solutions $\varphi(x, \lambda)$ of

$$L\varphi = \lambda\varphi \tag{1}$$

also satisfy a differential equation in the spectral parameter λ of the form

$$B(\lambda, \partial_\lambda)\varphi = \Theta(x)\varphi, \tag{2}$$

where $B(\lambda, \partial_\lambda)$ is a differential operator of positive order and $\Theta(x)$ is independent of λ ? The solution to this problem, under very mild assumptions on $u(x)$, turns out to be related to the theory of the KdV equation

$$u_t = -u_{xxx} + 6u_x u \tag{3}$$

in a very peculiar form. As shown in [8], the bispectral potentials that are bounded¹ at $x = \infty$ can be divided into two classes according to the dimension of the space of common solutions of Eqs. (1) and (2). This space can have dimension 1 or 2. If there exists a pair (B, Θ) such that this space is two-dimensional, we shall say that the potential is a *rank two bispectral potential*. The remaining bispectral potentials are called *rank one*. These last ones had been previously studied by Adler, Airault, McKean, and Moser [1, 2] in a different context. They have the remarkable property of remaining rational under the flows of the KdV hierarchy, from which Eq. (3) is the first nontrivial example. Although the rank two bispectral potentials were completely characterized via rational Darboux transformations in [8], they have always been much more mysterious than its complement. One reason is that the rank two potentials did not appear explicitly in any previous work. Another one is the fact that, in general, they do not remain rational under the flows of the KdV hierarchy. The main contribution of the present work is to establish the invariance of the class of rank two bispectral potentials, and of certain manifolds contained therein, by the flows of a hierarchy of nonlinear evolution equations intimately related to KdV. This hierarchy has a number of interesting properties, some of which we shall describe in Sect. 2. It is composed of master symmetries [10] for the KdV hierarchy and it also appeared in the work of Levi [20].

In order to describe our results in more detail we need to introduce another key element in the picture. This element is the concept of rational Darboux transformations. By a Darboux transformation we mean the process of constructing from $L = -\partial_x^2 + u$ and $\phi \in \ker L$ another operator $\tilde{L} = -\partial_x^2 + \tilde{u}$ such that

$$\tilde{u} = u - 2\partial_x^2 \log \phi. \quad (4)$$

This corresponds to factoring the operator L into A^*A , where A and A^* are first order differential operators, and setting $\tilde{L} = AA^*$. In Sect. 3 we present a more detailed description of this important transformation that appeared in a number of different contexts, [1, 5–7, 21, 25] to cite just a few. If the potentials u and \tilde{u} are both rational functions of x , we call the corresponding Darboux transformation a *rational one*. We remark that given a rational function u , it is extremely unlikely that \tilde{u} will also be rational. Notwithstanding, this phenomenon appears throughout the study of the bispectral problem. In fact, the potentials that stay rational by the KdV flows can be characterized as the result of successive applications of rational Darboux transformations to potentials of the form $v(v-1)/x^2$, with $v \in \mathbf{Z}_{>0}$. The rank two classes can be obtained by the union of the set of potentials of the form c/x^2 with those constructed by rational Darboux transformations applied to $(l^2 - 1/4)/x^2$, with $l \in \mathbf{Z}_{>0}$. Since each time we apply Darboux a new parameter is introduced we can look at the potentials resulting of n Darboux transformations as an n -dimensional complex manifold. The following questions arise naturally:

1. Is there some hierarchy of nonlinear evolution equations whose flows preserve the rationality of the potentials in the rank two class?
2. If so, are the potentials in the orbit of such flows still bispectral?
3. Is this hierarchy related to some completely integrable system and can it be described in terms of some recursion operator?

Our answers to these questions are in terms of a hierarchy evolution equations defined via the recursion operator

$$N_u = -\partial_x^2 + 4u + 2u_x \partial_x^{-1}, \tag{5}$$

which gives rise to the higher order KdV flows

$$X_j(u) = N_u^j u_x. \tag{6}$$

We start with

$$\tau_0(u) = \frac{1}{2} x u_x + u \tag{7}$$

and define

$$\tau_j(u) = N_u^j \tau_0(u). \tag{8}$$

The hierarchy $\{\tau_j\}_{j=0}^\infty$ answers the first and the second questions affirmatively, see Sect. 4. The answer to the third question, which is also positive, is developed in Sect. 2.

We present a few examples in order to illustrate the next sections and the bispectral property. The most simple examples of bispectral potentials are those of the form

$$u(x) = \frac{c}{x^2}, \tag{9}$$

with $c \in \mathbb{C}$. It is easy to see that if we take $\Phi(z)$ a solution of

$$-\Phi'' + \frac{c}{z^2} \Phi = \Phi, \tag{10}$$

and define

$$\varphi(x, \lambda) = \Phi(x\lambda^{1/2}), \tag{11}$$

then

$$L\varphi = \lambda\varphi \tag{12}$$

and

$$\left[-(2\lambda^{1/2}\partial_\lambda)^2 + \frac{c}{\lambda} \right] \varphi = x^2\varphi. \tag{13}$$

Since the function Φ is an arbitrary solution of (10), the space of common solutions of (12) and (13) has dimension 2. Hence, c/x^2 belongs to the rank two family of bispectral potentials. It is easy to check that c/x^2 is a stationary solution of $\partial_t u = \tau_0(u)$. The next example is given by

$$u_1 = \frac{l^2 - 1/4}{x^2} - 2\partial_x^2 \log(x^{-l+1/2} + t_0 x^{l+1/2}).$$

It was shown in [8] that the potential u_1 above is bispectral. It is obtained by applying one Darboux transformation to $u_0 = (l^2 - 1/4)/x^2$, as will be shown in Sect. 3. A straightforward computation shows that

$$\tau_0(u_1) = t_0 l \frac{\partial u_1}{\partial t_0}$$

and

$$\tau_1(u_1) = 0.$$

Hence, $\tau_j(u_1) = 0$ for $j \geq 1$. In other words, the vector fields τ_j , $j \in \mathbf{Z}_{>0}$, are all tangent to the one-dimensional manifold of potentials obtained by applying Darboux to u_0 . Theorem 8 extends this result to an arbitrary number of Darboux transformations.

The plan for this work is the following:

In Sect. 2 we develop the theory of the hierarchy of vector fields $\{\tau_j\}_{j=0}^\infty$. We also describe the corresponding hierarchy associated to the mKdV equation. In Sect. 3 we study the potentials u_n obtained by n Darboux transformations to $u_0 = (l^2 - 1/4)/x^2$. Such potentials depend on n parameters and form certain n -dimensional manifolds, which we denote by M_n . In Sect. 4 we prove the main result of this paper, namely, that the vector fields τ_j , $j = 0, 1, \dots$, are tangent to the manifold M_n .

2. A Hierarchy of Master Symmetries Associated to KdV

2.1. Preliminaries

In this section we collect a few properties of hierarchies of nonlinear evolution equations connected with the KdV equation

$$u_t = -u_{xxx} + 6u_x u \stackrel{\text{def}}{=} X_1(u). \tag{14}$$

Our approach is geometric and based on recursion operators [22–24, 29]. We look at the right-hand side of this equation as a vector field defined on a vector space \mathcal{U} . For our purposes it is convenient to take \mathcal{U} to be a space of functions $u(x)$ satisfying the following two properties:

1. The function $u(x)$ is holomorphic in an open sector S containing an unbounded subinterval of the negative real axis. (The sector S depends on the function u .)
2. The asymptotic behavior of $u(x)$, as $x \rightarrow \infty$, is²

$$u(x) = \mathcal{O}\left(\frac{1}{x^2}\right), \quad x \in S.$$

The usual space where the formalism of recursion operators is employed is a space of rapidly decaying C^∞ functions on the line. Our choice of spaces is motivated by the fact that we will be working with rational functions of x and with functions that are rational in $\log x$ and $x^{1/2}$. Henceforth, we choose a branch of the logarithm with a cut coincident to the *positive real axis*.

We proceed with two important remarks. The first one is that we can write

$$X_1(u) = N_u X_0(u),$$

where $X_0(u) \stackrel{\text{def}}{=} u_x$, and N_u is a linear map, depending on $u \in \mathcal{U}$, defined by

$$N_u \psi = -\partial_x^2 \psi + 4u\psi + 2u_x \partial_x^{-1} \psi \tag{15}$$

for $\psi \in \mathcal{U}$. Here, by $\partial_x^{-1}\psi$ we mean

$$\partial_x^{-1}\psi = \int_{\infty}^x \psi(s)ds,$$

where the path of integration connecting ∞ to x lies in S . Notice that, since $u \in \mathcal{U}$, we have that $u_x = \mathcal{O}(1/x^3)$ and $\partial_x^{-1}u = \mathcal{O}(1/x)$ for x in any subsector whose rays are in the interior of S . The proof of this is a straightforward adaptation of Theorems 8.7 and 8.8, Chap. 3, of [31]. We shall now state some properties of \mathbf{N}_u considered as a tensor field of type $(1, 1)$ on \mathcal{U} . For a pair of constant vector fields φ and ψ in \mathcal{U} and an arbitrary vector field $X(u)$ we define the directional derivatives

$$X'_u(\varphi) \stackrel{\text{def}}{=} \frac{d}{d\varepsilon} X(u + \varepsilon\varphi)|_{\varepsilon=0}$$

and

$$\mathbf{N}'_u(\varphi; \psi) \stackrel{\text{def}}{=} \frac{d}{d\varepsilon} \mathbf{N}_{u+\varepsilon\psi}\varphi|_{\varepsilon=0}.$$

For \mathbf{N}_u we have explicitly

$$\mathbf{N}'_u(\varphi; \psi) = 4\varphi\psi + 2\psi_x \partial_x^{-1}\varphi. \quad (16)$$

The Nijenhuis torsion of \mathbf{N}_u is the vector valued 2-form given by

$$\mathbf{T}_u(\varphi, \psi) = \mathbf{N}'_u(\psi, \mathbf{N}_u\varphi) - \mathbf{N}'_u(\varphi, \mathbf{N}_u\psi) + \mathbf{N}_u\mathbf{N}'_u(\varphi, \psi) - \mathbf{N}_u\mathbf{N}'_u(\psi, \varphi). \quad (17)$$

Notice that \mathbf{T}_u is skew-symmetric in (φ, ψ) . In fact, Eq. (17) is a particular case of a more general definition of the Nijenhuis torsion [9] of a tensor of type $(1, 1)$ on a manifold. If X and Y are vector fields on this manifold and G is a tensor field of type $(1, 1)$, the torsion of G is a vector valued 2-form defined by

$$\mathbf{T}_u(X, Y) \stackrel{\text{def}}{=} [GX, GY] - G[X, GY] - G[GX, Y] + G^2[X, Y], \quad (18)$$

where the bracket $[\cdot, \cdot]$ denotes the vector field commutator [3, 16, 18]

$$[X, Y](u) = Y'_u X(u) - X'_u Y(u). \quad (19)$$

If the manifold is also a vector space we can consider the constant vector fields given by $X(u) = \varphi$ and $Y(u) = \psi$, where φ and ψ are fixed elements of the underlying vector space. By using Eq. (19) it is easy to obtain Eq. (17) from (18). It is also easy to verify that for \mathbf{N}_u given by (15), the torsion

$$\mathbf{T}_u(\varphi, \psi) = 0.$$

Since the torsion is a tensorial quantity it also vanishes for arbitrary vector fields, provided that we use now Eq. (18) to compute it. Recall that the Lie derivative of the $(1, 1)$ tensor \mathbf{N}_u along the vector field $X(u)$ is a tensor field of the same type defined by

$$\mathcal{L}_X(\mathbf{N}_u)\varphi = \mathbf{N}'_u(\varphi; X) + \mathbf{N}_u X'_u\varphi - X'_u\mathbf{N}_u\varphi.$$

The second important remark is that for \mathbf{N}_u given by (15) and $X_0(u) = u_x$, we have that

$$\mathcal{L}_{X_0}(\mathbf{N}_u) = 0.$$

So, we can say that X_0 is an infinitesimal symmetry of N_u .

The consequence of the two remarks above is the following: The iterated vector fields

$$X_j \stackrel{\text{def}}{=} N_u^j X_0$$

satisfy $[X_j, X_l] = 0$.

The vector fields X_j generate the higher order KdV flows [29, 23, 24]

$$\partial_t u = X_j(u).$$

These flows can also be obtained via the Lax pair formalism [19] and by fractional powers of differential operators. See [12, 13, 30] and references therein for a more comprehensive list of references on such approaches.

2.2. Master Symmetries

We shall now construct, from our point of view, a hierarchy of master symmetries for the KdV equation. The concept of master symmetries was introduced by Fuchssteiner and was applied to a number of important examples such as the Benjamin-Ono equation and the K.P. hierarchy [10, 11, 27, 28].

Consider the vector field

$$\tau_0(u) = \frac{1}{2}xu_x + u.$$

If we compute the Lie derivative of N_u , with respect to τ_0 , we find

$$\mathcal{L}_{\tau_0}(N_u) = N_u. \tag{20}$$

Leibniz rule gives

$$\mathcal{L}_{\tau_0}(N_u^j) = jN_u^j. \tag{21}$$

Due to Eq. (20), by analogy with the definition of a conformal symmetry of a Riemannian metric, it seems natural to call τ_0 a conformal symmetry of N_u . Let's now consider the hierarchy $\{\tau_j\}_{j=0}^\infty$ obtained by defining

$$\tau_j = N_u^j \tau_0.$$

The vector fields τ_j , for $j \geq 0$, do not commute with one another, since τ_0 is not a symmetry of N_u . However, they do verify the following remarkable commutation relation

$$[\tau_j, \tau_l] = (l - j)\tau_{j+l}, \tag{22}$$

as will be shown below. The reader familiar with Virasoro algebras will recognize Eq. (22) as defining a Virasoro algebra of zero central charge.

To prove Eq. (22) we start by remarking that such objects are well defined in the space \mathcal{U} , since $\tau_0(\mathcal{U}) \subset \mathcal{U}$ and $N_u(\mathcal{U}) \subset \mathcal{U}$. Secondly, we prove that the vanishing of the torsion of N_u yields

$$\mathcal{L}_{N_u X}(N_u) = N_u \mathcal{L}_X(N_u), \tag{23}$$

and hence

$$\mathcal{L}_{N_u^j X}(N_u) = N_u^j \mathcal{L}_X(N_u). \tag{24}$$

Indeed, from the vanishing of the torsion and by Leibniz rule

$$\begin{aligned} 0 &= [N_u X, N_u Y] - N_u [N_u X, Y] - N_u [X, N_u Y] + N_u^2 [X, Y] \\ &= \mathcal{L}_{N_u X}(N_u Y) - N_u \mathcal{L}_{N_u X}(Y) - N_u \mathcal{L}_X(N_u Y) + N_u^2 \mathcal{L}_X(Y) \\ &= (\mathcal{L}_{N_u X}(N_u) - N_u \mathcal{L}_X(N_u))Y. \end{aligned}$$

Now, we compute

$$\begin{aligned} [\tau_j, \tau_l] &= \mathcal{L}_{\tau_j}(N_u^l \tau_0) \\ &= \mathcal{L}_{\tau_j}(N_u^l) \tau_0 + N_u^l \mathcal{L}_{\tau_j}(\tau_0) \\ &= \mathcal{L}_{N_u^j \tau_0}(N_u^l) \tau_0 - N_u^l \mathcal{L}_{\tau_0}(N_u^j \tau_0) \\ &= \mathcal{L}_{N_u^j \tau_0}(N_u^l) \tau_0 - N_u^l \mathcal{L}_{\tau_0}(N_u^j) \tau_0 - N_u^{l+j} \mathcal{L}_{\tau_0} \tau_0 \\ &= \mathcal{L}_{N_u^j \tau_0}(N_u^l) \tau_0 - N_u^l \mathcal{L}_{\tau_0}(N_u^j) \tau_0. \end{aligned}$$

From Eqs. (24) and (21) we get

$$\begin{aligned} [\tau_j, \tau_l] &= N_u^j \mathcal{L}_{\tau_0}(N_u^l) \tau_0 - N_u^l \mathcal{L}_{\tau_0}(N_u^j) \tau_0 \\ &= (N_u^j / N_u^l - N_u^l / N_u^j) \tau_0 \\ &= (l - j) \tau_{j+l}. \end{aligned}$$

The first two nonlinear master symmetry fields constructed above are given by

$$\begin{aligned} \tau_1(u) &= -\frac{x}{2}(u_{xxx} - 6uu_x) - 2u_{xx} + u_x \partial_x^{-1} u + 4u^2, \\ \tau_2(u) &= \frac{x}{2}(u_{5x} - 10uu_{3x} - 18u_x u_{xx} + 24u^2 u_x) + 3u_{4x} - u_{3x} \partial_x^{-1} u \\ &\quad - 24uu_{xx} - 15u_x^2 + u_x(4u \partial_x^{-1} u + 2 \partial_x^{-1} \tau_1(u)) + 16u^3. \end{aligned}$$

In order to fully appreciate the power of the remark that the torsion of N_u vanishes, the reader should try to prove Eq. (22) for $0 \leq l, j \leq 2$ directly!

The master symmetry vector fields defined above are deeply connected to the KdV flows. To show this we first compute the commutator of X_0 and τ_0 , which gives

$$[X_0, \tau_0] = -\frac{1}{2} X_0. \tag{25}$$

Thus, by repeating the argument given above for $[\tau_j, \tau_l]$ we find that

$$[X_j, \tau_l] = \mathcal{L}_{N_u^j X_0}(N_u^l \tau_0) \tag{26}$$

$$= \mathcal{L}_{N_u^j X_0}(N_u^l) \tau_0 + N_u^l \mathcal{L}_{N_u^j X_0}(\tau_0) \tag{27}$$

$$= N_u^j \mathcal{L}_{X_0}(N_u^l) \tau_0 - N_u^l \mathcal{L}_{\tau_0}(N_u^j) X_0 - N_u^{l+j} \mathcal{L}_{\tau_0}(X_0) \tag{28}$$

$$= -N_u^l \mathcal{L}_{\tau_0}(N_u^j) X_0 - N_u^{l+j} \mathcal{L}_{\tau_0}(X_0) \tag{29}$$

$$= -j N_u^{l+j} X_0 - \frac{1}{2} N_u^{l+j} X_0 \tag{30}$$

$$= (-j - \frac{1}{2}) X_{l+j}. \tag{31}$$

In going from Eq. (29) to (30) we used Eqs. (21) and (25). The conclusion from Eq. (31) is that the master symmetry fields can be used to generate, via commutators, the fields in the KdV hierarchy. We summarize the results thus far in the following:³

Proposition 1. *The hierarchy $\{\tau_j\}_{j=0}^\infty$ satisfies*

$$[\tau_j, \tau_l] = (l - j)\tau_{j+l}$$

and

$$[X_j, \tau_l] = -(j + \frac{1}{2})X_{l+j}.$$

2.3. Transformation Properties

We shall now consider the relation of the KdV hierarchy with the mKdV one. It is well known that the Miura map

$$u = F(v) \stackrel{\text{def}}{=} v^2 + v_x \tag{32}$$

is a transformation that maps solutions of the mKdV equation

$$v_t = -v_{xxx} + 6v^2v_x \stackrel{\text{def}}{=} Y_1(v) \tag{33}$$

into solutions of the KdV equation (14). We shall look at (33) as a vector field in the space \mathcal{V} of holomorphic functions defined in a sector near ∞ , around the negative real axis, and with asymptotic behavior of the form $\mathcal{O}(1/x)$. We remark that the Miura map $v \mapsto F(v)$ is a point transformation from \mathcal{V} into \mathcal{U} . Its directional derivative is given by

$$F'_v \dot{v} = 2v\dot{v} + \dot{v}_x.$$

The corresponding transformation law for vector fields is

$$X(F(v)) = F'_v \cdot Y(v).$$

In particular, the vector fields X_1 and Y_1 defined above are F -related. Next, we exhibit a torsionless tensor field of type $(1, 1)$ on \mathcal{V} , which is F -related to the tensor N_u defined in Eq. (15). It is given by the following linear map:

$$M_v : \psi \mapsto M_v \psi \stackrel{\text{def}}{=} \partial_x(-\partial_x \psi + 4v\partial_x^{-1}(v\psi)).$$

Remark that if v and ψ are in \mathcal{V} , so is $M_v \psi$. One can easily check that, for $u = F(v)$,

$$N_u \cdot F'_v = F'_v \cdot M_v.$$

Consequently, the torsion of M_v and N_u are F -related. A straightforward computation gives that the torsion of M_v vanishes. We also remark that if we define the vector fields Y_0 and σ_0 by

$$Y_0(v) \stackrel{\text{def}}{=} v_x$$

and

$$\sigma_0(v) = \frac{1}{2}(xv)_x,$$

then Y_0 and σ_0 are F -related to X_0 and τ_0 , respectively. Once again, Y_0 is a symmetry of M_v and σ_0 is a conformal symmetry of M_v . The mKdV hierarchy is obtained by

$$Y_j \stackrel{\text{def}}{=} M_v^j Y_0$$

and the associated master symmetry hierarchy by

$$\sigma_j \stackrel{\text{def}}{=} \mathbf{M}_v^j \sigma_0 .$$

Obviously, these hierarchies are also F -related to the corresponding ones in the “KdV domain” and satisfy equations similar to (22) and (25). We close this section by calling attention to the fact that $\mathbf{M}_v \psi = \mathbf{M}_{-v} \psi$. This will play an important role in the final steps of the proof of Theorem 8.

3. Darboux Transformations and Families of Bispectral Potentials

3.1. Outline of this Section and Preliminary Remarks

The first goal of this section is to describe the potentials u_n obtained by n successive applications of the Darboux transformations to

$$L_0 = -\partial_x^2 + u_0 , \tag{34}$$

where $u_0 = (l^2 - 1/4)/x^2$ and $l \in \mathbf{Z}_{>0}$. As we shall see, each Darboux transformation introduces a new complex parameter in the resulting potential. By introducing such parameters in a suitable way we shall construct an n -dimensional complex manifold M_n , given by⁴

$$M_n \stackrel{\text{def}}{=} \{u_n(\cdot ; t_0, \dots, t_{n-1}) \mid (t_0, \dots, t_{n-1}) \in \mathbf{C}^n\} .$$

If $n \leq l$, then u_n is a rational function of x . It is a consequence of [8] that there exists a differential operator $B(k, \partial_k)$ and a function $\Theta(x)$ such that the space of common solutions of

$$(-\partial_x^2 + u_n)\varphi = k^2\varphi \tag{35}$$

and

$$B(k, \partial_k)\varphi = \Theta(x)\varphi \tag{36}$$

has dimension 2. Furthermore, any rank two bispectral potential, modulo translation and addition of a constant, belongs to the union of $\bigcup_{l>0} \bigcup_{0 \leq n \leq l} M_{n,l}$ with the set of potentials of the form c/x^2 and $ax + b$, where a , b , and c are arbitrary constants [8].

This section was influenced by the exposition in [32], which unfortunately was not made available to a larger audience. This brings in the second goal of this section, which is to extend the construction of the manifolds $M_{n,l}$ for $n > l$. This was not done in [32]. For such values of n , $M_{n,l}$ has elements that are not rational anymore. However, we shall prove the peculiar fact that the potentials in this case are rational functions in $x^{1/2}$ and $\log x$. Since, as shown in [8], the bispectral potentials are always rational functions of x , for $n > l$ the manifolds $M_{n,l}$ are not composed of bispectral potentials anymore. The interesting fact is that the tangency result of Sect. 4 remains in this case.

⁴ Strictly speaking u_n and M_n are also dependent on l , and we should write $u_{n,l}$ and $M_{n,l}$. However, we will do this only when it is unavoidable

The plan for this section is the following:

In Sect. 3.2 we give the general description of applying n Darboux transformations to $u_0 = (l^2 - 1/4)/x^2$. In this paragraph this is done without specifying the choices of the element in $\ker L_{n-1}$ at the n^{th} step. This construction is completed in Sect. 3.4 with the help of the concept of dominant and recessive solutions. In Sect. 3.3 we collect a few general facts about the intertwining operator U_n such that $L_n U_n = U_n L_0$. In Sect. 3.5 we prove some results about the functions v_n , which are related to u_n via the Miura map.

3.2. The Construction

We shall first establish some terminology. In what follows, A will denote the first-order differential operator

$$A = \partial_x - v \tag{37}$$

and A^* its formal adjoint

$$A^* = -\partial_x - v. \tag{38}$$

If we take

$$v = \chi'/\chi, \tag{39}$$

where χ is a solution of

$$L\chi = (-\partial_x^2 + u)\chi = 0,$$

then

$$L = A^*A. \tag{40}$$

We remark that the relation between v and u here is given by the Miura map $u = v^2 + v_x$. We start from L_0 as in Eq. (34), and χ_0 a nonzero element in $\ker L_0$. This gives a factorization

$$L_0 = A_0^*A_0$$

with A_0 , A_0^* , and v as in Eqs. (37), (38), and (39). Take

$$L_1 \stackrel{\text{def}}{=} A_0A_0^*.$$

A simple computation shows that $L_1 = -\partial_x^2 + u_1$, with

$$u_1 = u_0 - 2\partial_x^2 \log \chi_0.$$

Suppose we have found pairs $(\chi_0, L_0), \dots, (\chi_{n-2}, L_{n-2})$ such that

$$L_j = A_j^*A_j, \quad \text{for } 0 \leq j \leq n-2, \tag{41}$$

and

$$L_j = A_{j-1}A_{j-1}^*, \quad \text{for } 0 < j \leq n-1. \tag{42}$$

We take $\chi_{n-1} \in \ker L_{n-1} \setminus \{0\}$, set

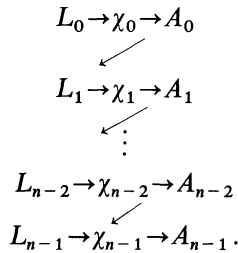
$$A_{n-1} \stackrel{\text{def}}{=} \partial_x - v_{n-1}, \tag{43}$$

$$v_{n-1} \stackrel{\text{def}}{=} \chi'_{n-1}/\chi_{n-1}, \tag{44}$$

and

$$L_n \stackrel{\text{def}}{=} A_{n-1} A_{n-1}^* . \tag{45}$$

Notice that our choice of $\chi_{n-1} \in \ker L_{n-1}$ gives $L_{n-1} = A_{n-1}^* A_{n-1}$. We can illustrate this process via the following diagram:



We define a sequence of operators $\{U_n\}_{n=0}^\infty$ as follows:

$$U_0 = 1$$

and, for $n > 0$,

$$U_n \stackrel{\text{def}}{=} A_{n-1} U_{n-1} . \tag{46}$$

The operator L_n is related to L_0 by means of U_n ,

$$L_n U_n = U_n L_0 . \tag{47}$$

So, U_n intertwines the operators L_n and L_0 . We remark that this formalism follows very closely that of [1], which starts from $-\partial_x^2$ and generates the potentials in the manifold of rational solutions of KdV.

The attentive reader might have noticed that the previous construction of L_n is not complete if we do not have a mechanism for generating the elements in the kernel of L_{n-1} . Fortunately, such mechanism is given by the formula

$$\chi_{n-1} = \frac{\alpha}{\chi_{n-2}} + \frac{\beta}{\chi_{n-2}} \int \chi_{n-2}^2(s) ds , \tag{48}$$

where $\chi_{n-2} \in \ker L_{n-2}$. The proof of this is elementary. Indeed, from $L_{n-1} = A_{n-2} A_{n-2}^*$ it follows that $1/\chi_{n-2} \in \ker L_{n-2}$. Equation (48) is just the requirement that the Wronskian of χ_{n-1} and $1/\chi_{n-2}$ be a constant.

Since

$$v_{n-1} = \frac{\chi'_{n-1}}{\chi_{n-1}} \tag{49}$$

and

$$u_n = v_{n-1}^2 - v'_{n-1} , \tag{50}$$

it follows that each step of the Darboux method introduces a new parameter, which is essentially the ratio β/α in Eq. (48). In the forthcoming construction, instead of using (48) we shall actually exhibit elements in the kernel of L_{n-1} .

3.3. A Few Facts

Let U_n^* be the formal adjoint of the operator U_n defined in (46). Then, we have the following elementary fact

Lemma 2. For $n \geq 0$,

$$L_0^n = U_n^* U_n \tag{51}$$

and

$$L_n^n = U_n U_n^*. \tag{52}$$

Proof. We first prove (52) by induction. Suppose that

$$L_{n-1}^{n-1} = U_{n-1} U_{n-1}^*,$$

then

$$\begin{aligned} L_n^n &= (A_{n-1} A_{n-1}^*) \dots (A_{n-1} A_{n-1}^*) \\ &= A_{n-1} (A_{n-1}^* A_{n-1}) \dots (A_{n-1}^* A_{n-1}) A_{n-1} \\ &= A_{n-1} U_{n-1} U_{n-1}^* A_{n-1}^* \\ &= U_n U_n^*. \end{aligned}$$

To prove (51), Eq. (47) implies that $L_n^n U_n = U_n L_0^n$, and hence $U_n U_n^* U_n = U_n L_n^n$. But since U_n is a monic differential operator and the cancellation law holds for such operators [17], it follows that $U_n^* U_n = L_0^n$. Q.E.D.

Lemma 2 implies that the process of applying n Darboux transformations leads to a factorization of L_0^n . It also implies that $\ker U_n \subset \ker L_0^n$. From Eq. (47) it follows that $\ker U_n$ is invariant by L_0 , and in fact is nilpotent of degree less than n in this space. Our next step is to construct $\ker L_0^n$ by exhibiting sequences $\{\psi_j^\pm\}_{j=0}^{l-1}$ of functions satisfying

$$L_0 \psi_j^\pm = \psi_{j-1}^\pm \tag{53}$$

with

$$\psi_0^\pm = x^{\pm l + 1/2} \in \ker L_0.$$

For $j \leq l$, the trick lies in noticing that [32]

$$L_0 x^{2j \pm l + 1/2} = [(2j \pm l)^2 - l^2] x^{2(j-1) \pm l + 1/2}.$$

We define $\mu_0^\pm = 1$ and

$$\mu_j^\pm = \frac{1}{(2j \pm l)^2 - l^2} \mu_{j-1}^\pm, \tag{54}$$

for $1 \leq j \leq l-1$. Thus, we have that

$$\psi_j^\pm \stackrel{\text{def}}{=} \mu_j^\pm x^{2j \pm l + 1/2}, \tag{55}$$

satisfies Eq. (53) for $j \leq l-1$. To extend this for $j \geq l$ we have to look at the “+” and the “-” cases separately. In the “+” case, Eqs. (54) and (55) can be used to define ψ_j^+ for every $j \geq 1$. To extend the definition of ψ_j^- , for $j \geq l$, first we define α_i and β_i

recursively by setting $\alpha_0 = \mu_{l-1}^- / (-2l)$, $\beta_0 = 0$, and for $i \geq 1$:

$$\alpha_i = \frac{-1}{4i(l+i)} \alpha_{i-1},$$

$$\beta_i = \frac{-1}{4i(l+i)} \beta_{i-1} - \frac{(l+2i)}{2i(l+i)} \alpha_i.$$

Second, we take, for $i \geq 0$,

$$\psi_{l+i}^- \stackrel{\text{def}}{=} \alpha_i x^{l+2i+1/2} \log x + \beta_i x^{l+2i+1/2}.$$

It is easy to check that

$$L_0 \psi_{l+i}^- = \psi_{l+i-1}^- . \tag{56}$$

Using Eqs. (53) and (56), it is straightforward to show that $\{\psi_i^\pm\}_{i=0}^{n-1}$ is a basis for $\ker L_0^n$.

3.4. Dominant and Recessive Solutions

We shall next recall the concept of dominant and recessive solutions, which was crucial in [8] to construct the bispectral potentials of rank two. It was shown therein that if we apply $n \leq l$ Darboux transformations to L_0 , the resulting potential is such that the differential equation

$$-\partial_x^2 \varphi + u_n \varphi = 0, \tag{57}$$

has a regular singular point at $x=0$. Furthermore,

$$u_n \sim \frac{\varrho^2 - 1/4}{x^2},$$

as $x \rightarrow 0$, for some $\varrho \in \mathbb{Z}_{\geq 0}$. In this situation, the two roots of the indicial equation differ by an integer, and the Frobenius series representing the solutions of (57) might require logarithmic terms. In any case, (57) always admits one solution of the form $\varphi_- = x^{\varrho+1/2}(1 + \mathcal{O}(x))$, as $x \rightarrow 0$, which is uniquely determined by this asymptotic behavior. Any nonzero multiple of this solution is called *recessive*. On the other hand, any other linearly independent solution is called *dominant*. In this case, however, the solution is not uniquely determined by its leading behavior, since adding $c\varphi_-$ to a dominant solution does not alter this leading behavior.

The manifold M_n will be constructed by applying n successive Darboux transformations to L_0 , using at each step a dominant eigenfunction for the eigenvalue zero. Before completing such a construction, we still need a few general facts about differential operators.

The intertwining operator U_n of Eq. (46) is monic and therefore can be written as [17]

$$U_n \varphi = \frac{W[\varphi_1, \dots, \varphi_n, \varphi]}{W[\varphi_1, \dots, \varphi_n]}, \tag{58}$$

where $\text{span}\{\varphi_1, \dots, \varphi_n\} = \ker U_n$. If we compare both sides of the equation $L_n U_n = U_n L_0$, we obtain that

$$u_n = u_0 - 2\partial_x^2 \log W_n, \tag{59}$$

where $W_n = W[\varphi_1, \dots, \varphi_n]$. The facts that $\varphi_i \in \ker U_n \subset \ker L_0^n$, as we showed in Lemma 2, and that

$$\ker L_0^n = \text{span}\{\psi_0^\pm, \dots, \psi_{n-1}^\pm\}$$

imply that W_n is a polynomial in $x^{1/2}$ and in $\log x$. Hence, the asymptotic behavior of u_n in a sector near $x = \infty$ is

$$u_n = \mathcal{O}(1/x^2), \tag{60}$$

and $u_n \in \mathcal{U}$. This remark is important because we want to be able to apply to u_n nonlocal operators involving \int_x^∞ .

We are ready now to define the manifold M_n by induction. It will be parametrized by⁵ the n -tuple $(t_0, \dots, t_{n-1}) \in \mathbb{C}^n$. We start with

$$\chi_0 \stackrel{\text{def}}{=} U_0(\psi_0^- + t_0\psi_0^+) = \psi_0^- + t_0\psi_0^+, \tag{61}$$

which is obviously in $\ker L_0$. The operators A_0 , U_1 , and L_1 are defined as in Eqs. (43), (45), and (46), with $n = 1$.

Suppose that A_j , χ_j , U_j , and L_j have been defined as in Eqs. (37), (38), (39), (41), and (42) with $\chi_j = U_j(\psi_j^- + t_0\psi_j^+ + \dots + t_j\psi_0^+) \in \ker L_j$ for $0 \leq j \leq n-2$. We take

$$U_{n-1} = A_{n-2}U_{n-2} = \left(\partial_x - \frac{\chi'_{n-2}}{\chi_{n-2}} \right) U_{n-2}$$

and

$$\chi_{n-1} \stackrel{\text{def}}{=} U_{n-1}(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-1}\psi_0^+).$$

Now, we claim that $\chi_{n-1} \in L_{n-1}$. Indeed, first we note that

$$L_{n-1}U_{n-1}\psi_0^+ = U_{n-1}L_0\psi_0^+ = 0. \tag{62}$$

Second, we remark that

$$\begin{aligned} &L_{n-1}U_{n-1}(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-2}\psi_1^+) \\ &= A_{n-2}A_{n-2}^*A_{n-2} \dots A_0(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-2}\psi_1^+) \\ &= A_{n-2}L_{n-2}U_{n-2}(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-2}\psi_1^+) \\ &= A_{n-2}U_{n-2}L_0(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-2}\psi_1^+). \end{aligned}$$

But since $L_0\psi_{j+1}^\pm = \psi_j^\pm$, we have that the right-hand side of the previous equation is

$$A_{n-2}U_{n-2}(\psi_{n-2}^- + t_0\psi_{n-2}^+ + \dots + t_{n-2}\psi_0^+) = A_{n-2}\chi_{n-2} = 0. \tag{63}$$

Putting Eqs. (62) and (63) together it follows that

$$L_{n-1}\chi_{n-1} = 0. \tag{64}$$

The next goal is to show that if $0 \leq n \leq l$, then at $x = 0$, $U_{n-1}(\psi_0^+)$ is recessive and $U_{n-1}(\psi_{n-1}^- + t_0\psi_{n-1}^+ + \dots + t_{n-2}\psi_1^+)$ is dominant. The proof of this will be based on two lemmas.

⁵ The use of the variables t_j , $j \geq 0$, is due to Wright [32]

Lemma 3. *If χ and f are holomorphic in an open sector S near $x=0$, with asymptotics*

$$\chi = x^\gamma(1 + \mathcal{O}(x)) \quad (65)$$

and

$$f = x^\beta(1 + \mathcal{O}(x)), \quad (66)$$

then, for x in a subsector of S ,

$$\chi \partial_x \chi^{-1} f = (\beta - \gamma)x^{\beta-1} + \mathcal{O}(x^\beta). \quad (67)$$

The proof of this lemma is a straightforward computation. We also note that if $\beta \neq \gamma$, then Eq. (67) can be rewritten as

$$\chi \partial_x \chi^{-1} f = (\beta - \gamma)x^{\beta-1}(1 + \mathcal{O}(x)). \quad (68)$$

We are now ready to show:

Lemm 4. *Let*

$$\varphi_j^+ \stackrel{\text{def}}{=} U_j(\psi_0^+) \quad (69)$$

and

$$\varphi_j^- \stackrel{\text{def}}{=} U_j(\psi_j^- + t_0 \psi_j^+ + \dots + t_{j-1} \psi_1^+). \quad (70)$$

If $0 \leq j \leq l-1$, then φ_j^+ is recessive and φ_j^- is dominant at $x=0$.

Proof. We shall first show by induction that

$$\chi_j = \lambda_j x^{\gamma_j}(1 + \mathcal{O}(x))$$

for $0 \leq j \leq l-1$, where $\gamma_j = j - l + 1/2$ and $\lambda_j \neq 0$. Indeed, for $j=0$ this property is obviously satisfied. Suppose it is true up to $j-1$, let's prove it for j . But if we recall that

$$\chi_j = U_j(\psi_j^- + t_0 \psi_j^+ + \dots + t_j \psi_0^+),$$

we get

$$\chi_j = A_{j-1} \dots A_0 (\mu_j^- x^{2j-l+1/2} (1 + \mathcal{O}(x))).$$

Using Lemma 4,

$$\begin{aligned} \chi_j &= \chi_{j-1} \partial_x \frac{1}{\chi_{j-1}} \chi_{j-2} \partial_x \frac{1}{\chi_{j-2}} \dots \chi_0 \partial_x \frac{1}{\chi_0} (\mu_j^- x^{2j-l+1/2} (1 + \mathcal{O}(x))) \\ &= \mu_j^- \lambda_j x^{j-l+1/2} (1 + \mathcal{O}(x)), \end{aligned}$$

where

$$\lambda_j = \prod_{i=1}^j (2j - 2i + 2) \neq 0.$$

Therefore, $\chi_j = \lambda_j x^{\gamma_j}(1 + \mathcal{O}(x))$, with γ_j and λ_j as above. A similar computation with $\varphi_j^+ = U_j(\psi_0^+)$ gives

$$\varphi_j^+ = 2^j \prod_{i=1}^j (l - i + 1) x^{l-j+1/2} (1 + \mathcal{O}(x)).$$

Hence, for $0 \leq j \leq l-1$, $U_j(\psi_0^+)$ is recessive and $\varphi_j^- = \chi_j - t_j \varphi_j^+$ is dominant at $x=0$. Q.E.D.

The consequence of the previous lemma is that for $0 \leq j \leq l$ the potential u_j was obtained from $u_0 = (l^2 - 1/4)/x^2$ using at the j^{th} Darboux transformation a dominant element in the kernel of L_{j-1} .

If we try to apply more than l Darboux transformations to $u_0 = (l^2 - 1/4)/x^2$ we have to introduce logarithmic terms in the functions ψ_j^\pm . The corresponding potentials cease to be rational and the asymptotics of the eigenfunctions get a little bit more complicated. However, the construction described above can be continued for arbitrary values of n . The only point that needs to be verified is that $\varphi_j^+ = U_j(\psi_0^+)$ and $\varphi_j^- = U_j(\psi_j^- + t_0\psi_j^+ + \dots + t_{j-1}\psi_1^+)$ are linearly independent. This guarantees that at this step we are obtaining a generic element in the kernel of L_{j-1} . The following lemma provides a general proof of this fact and an alternative one for $j < l$.

Lemma 5. *For every $j \geq 0$, φ_j^+ and φ_j^- , as defined in Eqs. (69) and (70), are linearly independent.*

Proof. If $j = 0$, this is immediate since $U_0 = 1$ and $\varphi_0^\pm = \psi_0^\pm$. Let's assume that $j \geq 1$. If $\alpha\varphi_j^- + \beta\varphi_j^+ = 0$, then

$$\alpha(\psi_j^- + t_0\psi_j^+ + \dots + t_{j-1}\psi_1^+) + \beta\psi_0^+ \in \ker U_j.$$

From Eq. (58) we have that $\ker U_j = \text{span}\{\phi_0, \dots, \phi_{j-1}\}$, with $\phi_i = \psi_i^- + t_0\psi_i^+ + \dots + t_i\psi_0^+$. But $L_0\phi_0 = 0$ and $L_0\phi_i = \phi_{i-1}$ for $i \geq 1$. So, if we write

$$\alpha(\psi_j^- + t_0\psi_j^+ + \dots + t_j\psi_1^+) + \beta\psi_0^+ = \sum_{i=0}^{j-1} \varepsilon_i \phi_i,$$

where $\varepsilon_i \in \mathbb{C}$, and apply L_j^i to both sides we get $\alpha\psi_0 = 0$. Hence, $\alpha = 0$. Since $\psi_0^+ \notin \ker U_j$ for $j > 0$, it follows that $\varphi_j^+ \neq 0$, which implies that $\beta = 0$. Q.E.D.

The statements 1 and 2 of the next proposition summarize the results so far. The results 3 and 4 can be found in [8, 32].

Proposition 6. *The potential u_n obtained by the preceding construction has the following properties:*

1. *We can write for any n*

$$u_n = \frac{l^2 - 1/4}{x^2} - 2\partial_x^2 \log W_n \tag{71}$$

with

$$W_n = W[\psi_0^-, t_0\psi_0^+, \dots, \psi_{n-1}^-, t_0\psi_{n-1}^+ + \dots + t_{n-1}\psi_0^+]. \tag{72}$$

2. *The asymptotic behavior of u_n at $x = \infty$, in a sector of angle smaller than 2π near to infinity, is $u_n = \mathcal{O}(1/x^2)$.*

3. *(Duistermaat and Grünbaum [8]) For $0 < n \leq l$, the manifold*

$$M_n \stackrel{\text{def}}{=} \{u_n(\cdot; t_0, \dots, t_{n-1}) \mid (t_0, \dots, t_{n-1}) \in \mathbb{C}^n\}$$

is composed of rank 2 bispectral potentials.

4. *(Wright [32]) For $0 < n \leq l$, the most general potential obtained by a sequence of n Darboux transformations using at the j^{th} step, $0 < j \leq n$, a dominant element in $\ker L_{j-1}$ belongs to M_n .*

3.5. The mKdV Fields

We shall now collect a few facts about the function v_n , which is given by

$$v_n = \partial_x \log \chi_n. \tag{73}$$

Since χ_n satisfies $L_n \chi_n = 0$, it follows that

$$u_n = v_n^2 + v'_n. \tag{74}$$

It is also easy to check that

$$u_{n+1} = u_n - 2\partial_x^2 \log \chi_n.$$

The function v_n can be written explicitly as

$$\begin{aligned} v_n &= \partial_x \log \chi_n \\ &= \partial_x \log \frac{W[\phi_{n-1}, \dots, \phi_0, \phi_n]}{W[\phi_{n-1}, \dots, \phi_0]} \\ &= \partial_x \log \frac{W_{n+1}}{W_n}. \end{aligned} \tag{75}$$

We note that the field v_n depends on $n + 1$ variables t_0, \dots, t_n , and not n as u_n . In the next section the following lemma will play an important role:

Lemma 7. *For every $n \geq 1$, there exists $c_n \neq 0$, independent of x , such that*

$$\frac{\partial}{\partial t_n} \chi_n = \frac{c_n}{\chi_{n-1}}. \tag{76}$$

Proof. From the definition of χ_n we have that

$$\frac{\partial}{\partial t_n} \chi_n = U_n(\psi_0^+).$$

We claim that $U_n(\psi_0^+) \in \ker A_{n-1}^*$. Indeed,

$$\begin{aligned} A_{n-1}^* U_n(\psi_0^+) &= A_{n-1}^* A_{n-1} U_{n-1} \psi_0^+ \\ &= L_{n-1} U_{n-1} \psi_0^+ \\ &= U_{n-1} L_0 \psi_0^+ \\ &= 0. \end{aligned}$$

But, $\ker A_{n-1}^* = \text{span}\{1/\chi_{n-1}\}$. For $n \leq l$, since the function $U_n(\psi_0^+)$ has nonzero asymptotics as $x \rightarrow 0$, it follows that $\exists c_n \in \mathbb{C} \setminus \{0\}$ such that (76) holds. This constant c_n can be computed explicitly using the techniques of Lemmas 3 and 4. For $n > l$, the fact that $c_n \neq 0$ follows from the fact that $\psi_0^+ \notin \ker U_j$. Q.E.D.

4. The Tangency Property

In this section we shall show that the vector fields τ_j , $j \geq 0$, are tangent to the manifold M_n of potentials obtained by n successive applications of Darboux to $u_0 = (l^2 - 1/4)/x^2$. Our proof follows closely an ingenious argument of Adler and

Moser [1], which was used to prove the tangency of the higher order KdV vector fields to the manifolds of rational solutions of KdV. The key element in this proof is the relation among the KdV flows, the mKdV flows, the Miura map and the Darboux transformation.

Theorem 8. *The vector fields τ_j , defined by*

$$\tau_0(u) = \frac{1}{2}xu_x + u$$

and

$$\tau_j(u) = N_u^j \tau_0,$$

are tangent to the manifold M_n .

Proof. We shall show by induction on n that $\tau_j(u_n)$ is a linear combination of $\partial u_n / \partial t_k$, with $0 \leq k \leq n-1$. For $n=0$ this is trivial, since $u_0 = (l^2 - 1/4)/x^2$, and $\tau_0(u_0) = 0$, which implies that $\tau_j(u_0) = 0$, for $j \geq 0$. Suppose that we have established the existence of coefficients $\gamma_{jk}(t_0, \dots, t_{n-1})$, independent of x (but possibly depending on n) such that

$$\tau_j(u_n) = \sum_{k=0}^{n-1} \gamma_{jk} \frac{\partial}{\partial t_k} u_n.$$

Since u_n is related to v_n via the Miura map $F(v) = v^2 + v_x$, we have that

$$(2v_n + \partial_x)\sigma_j(v_n) = \tau_j(u_n) = \sum_{k=0}^{n-1} \gamma_{jk} \frac{\partial}{\partial t_k} u_n.$$

Here, σ_j is the j^{th} master symmetry field associated to the mKdV hierarchy as defined in Sect. 2. But,

$$\frac{\partial}{\partial t_k} u_n = (2v_n + \partial_x) \frac{\partial}{\partial t_k} v_n,$$

and hence

$$(2v_n + \partial_x)\sigma_j(v_n) = (2v_n + \partial_x) \sum_{k=0}^{n-1} \gamma_{jk} \frac{\partial}{\partial t_k} v_n.$$

Therefore,

$$\sigma_j(v_n) - \sum_{k=0}^{n-1} \gamma_{jk} \frac{\partial}{\partial t_k} v_n \in \ker(\partial_x + 2v_n).$$

Now, $\ker(\partial_x + 2v_n)$ is 1-dimensional and generated by $1/\chi_n^2$ because of Eq. (73). Therefore, we can write

$$\sigma_j(v_n) - \sum_{k=0}^{n-1} \gamma_{jk} \frac{\partial}{\partial t_k} v_n = \frac{\beta}{\chi_n^2}, \tag{77}$$

where the constant β is independent of x . Our next task is to rewrite the right-hand side of (77) as $\gamma_{jn} \partial v_n / \partial t_n$. In order to do that we compute

$$\frac{\partial}{\partial t_n} v_n = \frac{\partial}{\partial t_n} \frac{\partial}{\partial x} \log \chi_n = \frac{\partial}{\partial x} \left(\frac{1}{\chi_n} \frac{\partial}{\partial t_n} \chi_n \right).$$

Using Lemma 7 we get that

$$\frac{\partial}{\partial t_n} v_n = c_n \frac{\partial}{\partial x} \left(\frac{1}{\chi_n} \frac{1}{\chi_{n-1}} \right),$$

for some nonzero c_n . Hence,

$$\frac{\partial}{\partial t_n} v_n = c_n \frac{1}{\chi_n^2} W[\chi_n, \chi_{n-1}^{-1}].$$

We recall from the previous section that χ_n and χ_{n-1}^{-1} are linearly independent solutions of $L_n \varphi = 0$. Therefore, the Wronskian $W[\chi_n, \chi_{n-1}^{-1}]$ is a nonzero constant independent of x . So we can write

$$\frac{\beta}{\chi_n^2} = \gamma_{jn} \frac{\partial}{\partial t_n} v_n, \tag{78}$$

where γ_{jn} is also independent of x . Equations (77) and (78) give that

$$\sigma_j(v_n) = \sum_{k=0}^n \gamma_{jk} \frac{\partial}{\partial t_k} v_n.$$

We conclude using that $u_{n+1} = v_n^2 - v_n'$ and that \mathbf{M}_v is invariant by reflections $v \mapsto -v$. Therefore,

$$\begin{aligned} \tau_j(u_{n+1}) &= \tau_j(v_n^2 - v_n') \\ &= (\partial_x - 2v_n) \sigma_j(-v_n) \\ &= -(\partial_x - 2v_n) \sigma_j(v_n) \\ &= (2v_n - \partial_x) \sum_{k=0}^n \gamma_{jk} \frac{\partial}{\partial t_k} v_n \\ &= \sum_{k=0}^n \gamma_{jk} \frac{\partial}{\partial t_k} u_{n+1}. \quad \text{Q.E.D.} \end{aligned}$$

Remarks. 1. The Darboux transformation that sends $u_n \mapsto \tilde{u} = u_{n+1}$, changes the sequence γ_{jk} as follows:

$$\tilde{\gamma}_{jk} = \begin{cases} \gamma_{jk} & \text{for } 0 \leq k \leq n-1, \\ \text{function of } (t_0 \dots t_n) & \text{for } k = n, \\ 0 & \text{for } k > n. \end{cases}$$

2. We can construct a family of rational solutions of the master symmetry fields by solving equations of the form:

$$\frac{dt_k}{ds} = \gamma_{jk}(t_0, \dots, t_n)$$

for $0 \leq k \leq n$. However, since the master symmetry flows do not commute with one another, we cannot expect to be able to find new time variables s_0, \dots, s_n such that

$$\frac{\partial t_k}{\partial s_k} = \gamma_{jk}(t_0, \dots, t_n),$$

as in the case of the KdV hierarchy [1]. Indeed, we can check that such variables do not exist in a few examples.

3. It is not hard to adapt the reasoning in the proof of Theorem 8 to the case of u_0 of the form $v(v-1)/x^2$ for v a natural number. The manifolds generated by successive applications of Darboux to such potentials are composed of Adler-Moser potentials. Therefore, the master symmetries are also tangent to the manifolds of rational solutions of KdV that decay at infinity. Now, the manifolds of Adler-Moser potentials are contained in the class of bispectral potentials [8]. When the latter manifolds are united with the manifolds $M_{n,l}$, for $0 \leq n < l$, they exhaust, modulo translation, the class of bispectral potentials that decay at infinity [8]. Therefore, the master symmetries of KdV are tangent to *all* the manifolds that satisfy the class of bispectral potentials decaying at infinity.

The results obtained above can be translated in the “mKdV domain.” We define the manifold M'_n by

$$M'_n = \{v_n(\cdot; t_0, \dots, t_n) \mid (t_0, \dots, t_n) \in \mathbb{C}^{n+1}\}.$$

One simple consequence of the proof of Theorem 8 is:

Corollary 9. *The vector fields σ_j , defined by*

$$\sigma_0(u) = \frac{1}{2}(xu)_x$$

and

$$\sigma_j(u) = M'_j \sigma_0,$$

are tangent to the manifold M'_n .

We conclude this section with a small digression on the matrix case of the bispectral problem. In [33, 34] the bispectral problem was introduced for matrix differential operators. The question is analogous to the one formulated in Sect. 1, except that one now allows the operator $B(\lambda, \partial_\lambda)$ to have matrix coefficients, and requires its leading order coefficient to be nonsingular. The remark is that the matrix differential operator

$$L = \begin{bmatrix} 0 & \partial_x + v_n \\ \partial_x - v_n & 0 \end{bmatrix}$$

possesses the bispectral property. The case $n=1$ was proved in [34] as a consequence of a more general result for matrix differential operators. The case of arbitrary n can be obtained as a consequence of the results in [8]. Details will appear elsewhere.

5. Final Remarks

The main motivation for the present work was to understand the results of [8] in terms of hierarchies of nonlinear evolution equations. This can also be looked upon as part of a long term program of attacking the bispectral problem in the case where L is a matrix differential operator or a scalar differential operator of order greater than two. Some initial steps have been done in this direction in related works [14, 33–35]. We believe that similar results to the ones described here concerning the hierarchy of master symmetries of KdV should also hold in the higher order case. We are currently pursuing some of these avenues.

We close with some general remarks:

It is interesting to note that if one looks at the bispectral problem as stated in Sect. 1, one very trivial symmetry appears: If $u(x)$ is bispectral, then so is $u(x + x_0)$. In other words, $X_0(u) = u_x$ is the infinitesimal generator of a one-parameter group of symmetries for the class of bispectral potentials. Another symmetry, which is not so obvious is the following: If $u(x)$ is bispectral, then so is the potential $t^2u(xt)$ for any value of t . This transformation is induced by a change of scale in the Schrödinger operator, namely $x \mapsto tx$. It turns out that the infinitesimal generator of the one-parameter group of symmetries

$$S(t) : u(x) \mapsto t^2u(xt)$$

is exactly $2\tau_0(u) = xu_x + 2u$. To check this just differentiate $S(t)u$ at $t=1$. The remarkable fact, which certainly deserves further investigation, is that the hierarchies of vector fields obtained by applying the Nijenhuis tensor N_u to τ_0 and to X_0 are deeply connected to the bispectral problem. As we showed in this paper the elements in the hierarchy $\{\tau_j\}_{j \geq 0}$ are tangent to the manifolds of rank two bispectral potentials. This, added to the earlier result of Duistermaat and Grünbaum [8], which says that the manifolds of rational solutions of the KdV hierarchy $\{X_j\}_{j \geq 0}$ are also bispectral, indicates that there should be some more general theory lurking in the background of the results in [8, 14, 33–35].

Another remark of interest is that the tangency result of Sect. 4 also holds for the manifolds of rational solutions of KdV. In other words, the manifolds of rational solutions of KdV are also invariant by the flows of the master symmetry hierarchy $\{\tau_j\}_{j \geq 0}$. The proof of this follows the same lines of the proof in Sect. 4. This yields the following picture:

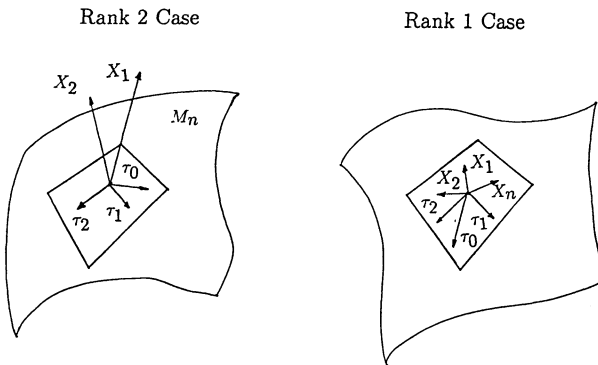


Fig. 1. The vector fields in the master symmetry hierarchy are tangent to both the rank 1 and rank 2 bispectral potentials. The vector fields in the KdV hierarchy are tangent only to rank 1 bispectral potentials

In [15] a differential equation was found, which is very similar to $u_t = \tau_1(u)$. It works for the potentials obtained by applying Darboux once to $u_0 = 3/4x^2$. The coefficients of this equation, however, do not seem to be the appropriate ones for the constructions of the whole hierarchy by means of a recursion operator.
