# Behavior of the empirical Wasserstein distance in $\mathbb{R}^{d}$ under moment conditions

#### Abstract

We establish some deviation inequalities, moment bounds and almost sure results for the Wasserstein distance of order $p \in[1, \infty)$ between the empirical measure of independent and identically distributed $\mathbb{R}^{d}$-valued random variables and the common distribution of the variables. We only assume the existence of a (strong or weak) moment of order $r p$ for some $r>1$, and we discuss the optimality of the bounds.

## 1 Introduction and notations

We begin with some notations, that will be used all along the paper. Let $X_{1}, \ldots, X_{n}$ be $n$ independent and identically distributed (i.i.d.) random variables with values in $\mathbb{R}^{d}$ ( $d \geq 1$ ), with common distribution $\mu$. Let $\mu_{n}$ be the empirical distribution of the $X_{i}$ 's, that is

$$
\mu_{n}=\frac{1}{n} \sum_{k=1}^{n} \delta_{X_{k}} .
$$

Let $X$ denote a random variable with distribution $\mu$. For any $x \in \mathbb{R}^{d}$, let $|x|=$ $\max \left\{\left|x_{1}\right|, \ldots,\left|x_{d}\right|\right\}$. Define then the tail of the distribution $\mu$ by

$$
H(t)=\mathbb{P}(|X|>t)=\mu\left(\left\{x \in \mathbb{R}^{d} \text { such that }|x|>t\right\}\right) .
$$

As usual, for any $q \geq 1$, the weak moment of order $q$ of the random variable $X$ is defined by

$$
\|X\|_{q, w}^{q}:=\sup _{t>0} t^{q} H(t),
$$

and the strong moment of order $q \geq 1$ is defined by
$$
\|X\|_{q}^{q}=\mathbb{E}\left(|X|^{q}\right)=q \int_{0}^{\infty} t^{q-1} H(t) d t
$$

For $p \geq 1$, the Wasserstein distance between two probability measures $\nu_{1}, \nu_{2}$ on $\left(\mathbb{R}^{d}, \mathcal{B}\left(\mathbb{R}^{d}\right)\right)$ is defined by

$$
W_{p}^{p}\left(\nu_{1}, \nu_{2}\right)=\inf _{\pi \in \Pi\left(\nu_{1}, \nu_{2}\right)} \int_{\mathbb{R}^{d} \times \mathbb{R}^{d}}|x-y|_{2}^{p} \pi(d x, d y),
$$

where $|\cdot|_{2}$ is the euclidean norm on $\mathbb{R}^{d}$ and $\Pi\left(\nu_{1}, \nu_{2}\right)$ is the set of probability measures on the product space $\left(\mathbb{R}^{d} \times \mathbb{R}^{d}, \mathcal{B}\left(\mathbb{R}^{d}\right) \otimes \mathcal{B}\left(\mathbb{R}^{d}\right)\right)$ with margins $\nu_{1}$ and $\nu_{2}$.

In this paper, we prove deviation inequalities, moment inequalities and almost sure results for the quantity $W_{p}\left(\mu_{n}, \mu\right)$, when $X$ has a weak or strong moment of order $r p$ for $r>1$. As in [16], the upper bounds will be different according as $p>d \min \{(r-1) / r, 1 / 2\}$ (small dimension case) or $p<d \min \{(r-1) / r, 1 / 2\}$ (large dimension case). Most of the proofs are based on Lemma 6 in [16] (see the inequality (6.4) in Section 6), which may be seen as an extension of Èbralidze's inequality [15] to the case $d>1$. Hence we shall use the same approach as in [10], where we combined Èbralidze's inequality with truncation arguments to get moment bounds for $W_{p}\left(\mu_{n}, \mu\right)$ when $d=1$.

There are many ways to see that the upper bounds obtained in the present paper are optimal in some sense, by considering the special cases $d=1, p=1, p=2$, or by following the general discussion in [16], and we shall make some comments about this question all along the paper. However, the optimality for large $d$ is only a kind of minimax optimality: one can see that the rates are exact for compactly supported measures which are not singular with respect to the Lebesgue measure on $\mathbb{R}^{d}$ (by using, for instance, Theorem 2 in [12]).

In fact, since the rates depend on the dimension $d$, it is easy to see that they cannot be optimal for all measures: for instance the rates will be faster as announced if the measure $\mu$ is supported on a linear subspace of $\mathbb{R}^{d}$ with dimension strictly less than $d$. This is of course not the end of the story, and the problem can be formulated in the general context of metric spaces $(X, \delta)$. For instance, for compactly supported measures, Boissard and Le Gouic [9] proved that the rates of convergence depend on the behavior of the metric entropy of the support of $\mu$ (with an extension to non-compact support in their Corollary 1.3). In the same context, Bach and Weed [2] obtain sharper results by generalizing some ideas going back to Dudley ([14], case $p=1$ ). They introduce the notion of Wasserstein dimension $d_{p}^{*}(\mu)$ of the measure $\mu$, and prove that $n^{p / s} \mathbb{E}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)\right)$ converges to 0 for any $s>d_{p}^{*}(\mu)$ (with sharp lower bounds in most cases).

Note that our context and that of Bach and Weed are clearly distinct: we consider measures on $\mathbb{R}^{d}$ having only a finite moment of order $r p$ for $r>1$, while they consider measures on compact metric spaces. However, the Wasserstein dimension is well defined for any probability measure (thanks to Prohorov's theorem), and some arguments in [2] are common with [12] and [16]. A reasonable question is then: in the case of a singular measures on $\mathbb{R}^{d}$, are the results of the present paper still valid if we replace the dimension $d$ by any $d^{\prime} \in\left(d_{p}^{*}(\mu), d\right]$ ?

The paper is organized as follows: in Section 2 we state some deviations inequalities for $W_{p}\left(\mu_{n}, \mu\right)$ under weak moment assumptions. In Section 3 we bound up the probability of large and moderate deviations. In Section 4 we present some almost sure results, and in Section 5 we give some upper bounds for the moments of order $r$ of $W_{p}\left(\mu_{n}, \mu\right)$ (von Bahr-Esseen and Rosenthal type bounds) under strong moment assumptions. The proofs are given in Section 6.

All along the paper, we shall use the notation $f(n, \mu, x) \ll g(n, \mu, x)$, which means that there exists a positive constant $C$, not depending on $n, \mu, x$ such that $f(n, \mu, x) \leq$ $C g(n, \mu, x)$ for all positive integer $n$ and all positive real $x$.

## 2 Deviation inequalities under weak moments conditions

In this section, we give some upper bound for the quantity $\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right)$ when the random variables $X_{i}$ have a weak moment of order $r p$ for some $r>1$. We first consider the case where $r \in(1,2)$.
Theorem 2.1. If $\|X\|_{r p, w}<\infty$ for some $r \in(1,2)$, then

$$
\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right) \ll \begin{cases}\frac{\|X\|_{r p, w}^{r p}}{x^{r} n^{r-1}} & \text { if } p>\frac{d(r-1)}{r} \\ \frac{\|X\|_{r p, w}^{r p}(\log n)^{r}}{x^{r} n^{r-1}}\left(1+\log _{+}\left(\frac{x^{\frac{1}{p}} n^{\frac{r}{d r-d}}}{\|X\|_{r p, w}}\right)\right)^{r} & \text { if } p=\frac{d(r-1)}{r} \\ \frac{\|X\|_{r p, w}^{r p}}{x^{r} n^{r p / d}} & \text { if } p \in\left[1, \frac{d(r-1)}{r}\right)\end{cases}
$$

for any $x>0$, where $\log _{+}(x)=\max \{0, \log x\}$.
Remark 2.2. As will be clear from the proof, the upper bounds of Theorem 2.1 still hold if the quantity $\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right)$ is replaced by its maximal version

$$
\mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n x\right)
$$

Since $\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \leq(r /(r-1))\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r, w}$, according to the discussion after Theorem 1 in [16], if $p \neq d(r-1) / r$, one can always find some measure $\mu$ for which the rates of Theorem 2.1 are reached (see example (e) in [16] for $p>d(r-1) / r$ and example (c) in [16] for $p<d(r-1) / r)$.

We now consider the case where $r>2$. We follow the approach of Fournier and Guillin [16], but we use a different upper bound for the quantity controlled in their Lemma 13 (see the proof of Theorem 2.3 for more details).
Theorem 2.3. If $\|X\|_{r p, w}<\infty$ for some $r \in(2, \infty)$, then for any $q>r$,

$$
\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right) \ll a\left(n, \frac{x}{\|X\|_{r p, w}^{p}}\right)+\frac{\|X\|_{r p, w}^{r p}}{x^{r} n^{r-1}}+\frac{1}{x^{q} n^{q / 2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{q},
$$

for any $x>0$, where

$$
a(n, x)=C \begin{cases}\exp \left(-c n x^{2}\right) \mathbf{1}_{x \leq A} & \text { if } p>d / 2 \\ \exp \left(-c n\left(x / \log \left(2+x^{-1}\right)\right)^{2}\right) \mathbf{1}_{x \leq A} & \text { if } p=d / 2 \\ \exp \left(-c n x^{d / p}\right) \mathbf{1}_{x \leq A} & \text { if } p \in[1, d / 2)\end{cases}
$$

for some positive constants $C, c$ depending only on $p, d$, and a positive constant $A$ depending only on $p, d, r$.
Remark 2.4. Let us compare our inequality with that of Theorem 2 of Fournier and Guillin [16] (under the moment condition (3) in [16]). We first note that the inequality in [16] is stated under a strong moment of order $r p$ for $r>2$, but their proof works also under a weak moment of order rp. Hence, under the assumptions of our Theorem 2.3, Fournier and Guillin obtained the bound (we assume here that $\|X\|_{r p, w}=1$ for the sake of simplicity):

$$
\begin{equation*}
\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right) \ll a(n, x)+\frac{n}{(n x)^{(r p-\varepsilon) / p}}, \tag{2.1}
\end{equation*}
$$

for any $\varepsilon>0$ (the constant implicitly involved in the inequality depending on $\varepsilon$ ). In particular, one cannot infer from (2.1) that

$$
\limsup _{n \rightarrow \infty} n^{r-1} \mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>x\right) \ll \frac{\|X\|_{r, w}^{r p}}{x^{r}},
$$

which follows from our Theorem 2.3.

## 3 Large and moderate deviations

We consider here the probability of moderate deviations, that is

$$
\mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>\frac{x}{n^{1-\alpha}}\right),
$$

for $\alpha \leq 1$ in a certain range and $x>0$. As usual, the case $\alpha=1$ is the probability of large deviations.

As for partial sums, we shall establish two type of results, under weak moment conditions or under strong moment conditions. If the random variables have a weak moment of order $r p$ for some $r>1$, the results of Subsection 3.1 are immediate corollaries of the theorems of the preceding section. On the contrary, the Baum-Katz type results of Subsection 3.2 cannot be derived from the results of Section 2 and will be proved in Subsection 6.4.

### 3.1 Weak moments

As a consequence of Theorem 2.1, we obtain the following corollary.
Corollary 3.1. If $\|X\|_{r p, w}<\infty$ for some $r \in(1,2)$, then,

- If $p>d(r-1) / r$ and $1 / r \leq \alpha \leq 1$,

$$
\limsup _{n \rightarrow \infty} n^{\alpha r-1} \mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>\frac{x}{n^{1-\alpha}}\right) \ll \frac{\|X\|_{r p, w}^{r p}}{x^{r}} .
$$

- If $p=d(r-1) / r$ and $1 / r<\alpha \leq 1$,

$$
\limsup _{n \rightarrow \infty} \frac{n^{\alpha r-1}}{(\log n)^{2 r}} \mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>\frac{x}{n^{1-\alpha}}\right) \ll \frac{\|X\|_{r p, w}^{r p}}{x^{r}} .
$$

- If $p \in[1, d(r-1) / r)$ and $(d-p) / d \leq \alpha \leq 1$,

$$
\limsup _{n \rightarrow \infty} n^{(p r-(1-\alpha) r d) / d} \mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>\frac{x}{n^{1-\alpha}}\right) \ll \frac{\|X\|_{r p, w}^{r p}}{x^{r}} .
$$

Remark 3.2. Let us comment on the case $p=1, d=1$. In that case, del Barrio et al. [4] proved that, for $\beta \in(1,2), n^{(\beta-1) / \beta} W_{1}\left(\mu_{n}, \mu\right)$ is stochastically bounded if and only if $\|X\|_{\beta, w}<\infty$ (see their Theorem 2.2). This is consistent with the first inequality of Corollary 3.1 applied with $r=\beta$ and $\alpha=1 / r$.
Remark 3.3. Let us now comment on the case $p=2, d=1$. In that case del Barrio et al. [5] proved that, if the distribution function $F$ of $X$ is twice differentiable and if $F^{\prime} \circ F^{-1}$ is a regularly varying function in the neighborhood of 0 and 1 , then there exists a sequence of positive numbers $v_{n}$ tending to $\infty$ as $n \rightarrow \infty$, such that $v_{n} W_{2}^{2}\left(\mu_{n}, \mu\right)$ converges in distribution to a non degenerate distribution. For instance, it follows from their Theorem 4.7 that, if $X$ is a positive random variable, $F$ is twice differentiable and $F(t)=\left(1-t^{-\beta}\right)$ for any $t>t_{0}$ and some $\beta>2$, then $n^{(\beta-2) / \beta} W_{2}^{2}\left(\mu_{n}, \mu\right)$ converges in distribution to a non degenerate distribution. In that case, there is a weak moment of

order $\beta$, and, for $\beta \in(2,4)$, the first inequality of Corollary 3.1 applied with $r=\beta / 2$ and $\alpha=1 / r$ gives

$$
\limsup _{n \rightarrow \infty} \mathbb{P}\left(n^{(\beta-2) / \beta} W_{2}^{2}\left(\mu_{n}, \mu\right)>x\right) \ll \frac{\|X\|_{\beta, w}^{\beta}}{x^{\beta / 2}} .
$$

Hence, in the case where $\beta \in(2,4)$, our result is consistent with that given in [5], and holds without assuming any regularity on $F$.

As a consequence of Theorem 2.3, we obtain the following corollary.
Corollary 3.4. If $\|X\|_{r p, w}<\infty$ for some $r \in(2, \infty)$, then, for any

$$
\begin{gathered}
\alpha \in\left(\max \left(\frac{1}{2}, \frac{d-p}{d}\right), 1\right] \\
\limsup _{n \rightarrow \infty} n^{\alpha r-1} \mathbb{P}\left(W_{p}^{p}\left(\mu_{n}, \mu\right)>\frac{x}{n^{1-\alpha}}\right) \ll \frac{\|X\|_{r p, w}^{r p}}{x^{r}} .
\end{gathered}
$$

### 3.2 Baum-Katz type results

In this subsection, we shall prove some deviation results in the spirit of Baum and Katz [7]. Recall that, for partial sums $S_{n}=Y_{1}+\cdots+Y_{n}$ of i.i.d real-valued random variables such that $\left\|Y_{1}\right\|_{r}<\infty$ for some $r>1$ and $\mathbb{E}\left(Y_{1}\right)=0$, one has: for any $\alpha>1 / 2$ such that $1 / r \leq \alpha \leq 1$, and any $x>0$,

$$
\sum_{n=1}^{\infty} n^{\alpha r-2} \mathbb{P}\left(\max _{1 \leq k \leq n}\left|S_{k}\right|>n^{\alpha} x\right)<\infty
$$

We first consider the case where the variables have a strong moment of order $r p$ for $r \in(1,2)$.
Theorem 3.5. If $\|X\|_{r p}<\infty$ for some $r \in(1,2)$, then, for any $x>0$,

- If $p>d(r-1) / r$ and $1 / r \leq \alpha \leq 1$,

$$
\sum_{n=1}^{\infty} n^{\alpha r-2} \mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n^{\alpha} x\right)<\infty
$$

- If $p \in[1, d(r-1) / r)$ and $\alpha \in((d-p) / d, 1]$,

$$
\sum_{n=1}^{\infty} n^{(p r-(1-\alpha) r d-d) / d} \mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n^{\alpha} x\right)<\infty
$$

- If $p \in[1, d(r-1) / r)$,

$$
\sum_{n=1}^{\infty} \frac{1}{n} \mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n^{(d-p) / d}(\log n)^{1 / r} x\right)<\infty
$$

Remark 3.6. Our proof does not allow to deal with the case where $p=d(r-1) / r$. As an interesting consequence of Theorem 3.5, we shall obtain almost sure convergence rates for the sequence $W_{p}^{p}\left(\mu_{n}, \mu\right)$ (see Corollary 4.1 of the next section).

We now consider the case where the variables have a strong moment of order $r p$ for $r>2$.
Theorem 3.7. If $\|X\|_{r p}<\infty$ for some $r \in(2, \infty)$, then, for any $x>0$ and any

$$
\begin{gathered}
\alpha \in\left(\max \left(\frac{1}{2}, \frac{d-p}{d}\right), 1\right] \\
\sum_{n=1}^{\infty} n^{\alpha r-2} \mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n^{\alpha} x\right)<\infty .
\end{gathered}
$$

## 4 Almost sure results

Using well known arguments, we derive from Theorem 3.5 the following almost sure rates of convergence for the sequence $W_{p}^{p}\left(\mu_{n}, \mu\right)$ (taking $\alpha=1 / r$ in the case where $p>d(r-1) / r$, and applying the third item in the case where $p<d(r-1) / r)$.
Corollary 4.1. If $\|X\|_{r p}<\infty$ for some $r \in(1,2)$, then

- If $p>d(r-1) / r$,

$$
\lim _{n \rightarrow \infty} n^{(r-1) / r} W_{p}^{p}\left(\mu_{n}, \mu\right)=0 \text { a.s. }
$$

- If $p \in[1, d(r-1) / r)$,

$$
\lim _{n \rightarrow \infty} \frac{n^{p / d}}{(\log n)^{1 / r}} W_{p}^{p}\left(\mu_{n}, \mu\right)=0 \text { a.s. }
$$

Remark 4.2. Let us comment on these almost sure results in the case where $p=1$ and $d<r /(r-1)$. Recall the dual expression of $W_{1}\left(\mu_{n}, \mu\right)$ :

$$
\begin{equation*}
W_{1}\left(\mu_{n}, \mu\right)=\sup _{f \in \Lambda_{1}}\left|\frac{1}{n} \sum_{k=1}^{n}\left(f\left(X_{k}\right)-\mu(f)\right)\right| \tag{4.1}
\end{equation*}
$$

where $\Lambda_{1}$ is the the set of functions $f$ such that $|f(x)-f(y)| \leq|x-y|_{2}$. Since the function $g: x \mapsto|x|_{2}$ belongs to $\Lambda_{1}$, we get

$$
W_{1}\left(\mu_{n}, \mu\right) \geq \frac{1}{n}\left|\sum_{k=1}^{n}\left(\left|X_{k}\right|_{2}-\mathbb{E}\left(\left|X_{k}\right|_{2}\right)\right)\right| .
$$

Now, by the classical Marcinkiewicz-Zygmund theorem (see [20]) for i.i.d. random variables, we know that

$$
\lim _{n \rightarrow \infty} \frac{n^{(r-1) / r}}{n}\left|\sum_{k=1}^{n}\left(\left|X_{k}\right|_{2}-\mathbb{E}\left(\left|X_{k}\right|_{2}\right)\right)\right|=0 \text { a.s. }
$$

if and only if $\|X\|_{r}<\infty$. It follows that, for $p=1$, the rates given in Corollary 4.1 are optimal in the case where $d<r /(r-1)$.

We now give some almost sure rates of convergence when $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$. Note that this condition is a bit more restrictive than $\|X\|_{2 p}<\infty$ (but is satisfied, for instance, if $\|X\|_{r p}<\infty$ for some $r>2$ ).
Theorem 4.3. Assume that $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$.

- If $p>d / 2$, there exists an universal positive constant $C$ depending only on $(p, d)$ such that

$$
\limsup _{n \rightarrow \infty} \sqrt{\frac{n}{\log \log n}} W_{p}^{p}\left(\mu_{n}, \mu\right) \leq C \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t \quad \text { a.s. }
$$

- If $p \in[1, d / 2)$, there exists an universal positive constant $C$ depending only on ( $p, d$ ) such that

$$
\limsup _{n \rightarrow \infty}\left(\frac{n}{\log \log n}\right)^{p / d} W_{p}^{p}\left(\mu_{n}, \mu\right) \leq C \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t \quad \text { a.s. }
$$

Remark 4.4. In the case $p>d / 2$, the rate $\sqrt{n / \log \log n}$ has been obtained recently by Dolera and Reggazini ([11], Theorem 2.3) under the more restrictive condition $\|X\|_{r p}<\infty$ for some $r>2$.

Remark 4.5. In the case $p=1, d=1$, it follows from the central limit theorem for $W_{1}\left(\mu_{n}, \mu\right)$ (see [4]) and from Theorem 10.12 in [18] that $\left(\sqrt{n / \log \log n} W_{1}\left(\mu_{n}, \mu\right)\right)_{n \geq 0}$ is almost surely relatively compact if $\int_{0}^{\infty} \sqrt{H(t)} d t<\infty$, which is consistent with the first item of Theorem 4.3.
Remark 4.6. For $p=1$, concerning the rate of Corollary 4.1 when $d>r /(r-1)$ or the rate of Theorem 4.3 when $d>2$, the situation is not as clear as in the small dimension case. According to Talagrand [23], if $d>2$ and $\mu$ is the uniform measure on $[0,1]^{d}$, $W_{1}\left(\mu_{n}, \mu\right)$ is, almost surely, exactly of order $n^{-1 / d}$. More generally, let us recall a result by Dobrić and Yukich [13]: if $d>2$ and $\mu$ is compactly supported, then, almost surely,

$$
\begin{align*}
c^{\prime}(d) \int\left(f_{\mu}(x)\right)^{(d-1) / d} \leq \liminf _{n \rightarrow \infty} n^{1 / d} & W_{1}\left(\mu_{n}, \mu\right) \\
& \leq \limsup _{n \rightarrow \infty} n^{1 / d} W_{1}\left(\mu_{n}, \mu\right) \leq c(d) \int\left(f_{\mu}(x)\right)^{(d-1) / d} \tag{4.2}
\end{align*}
$$

where $c(d), c^{\prime}(d)$ depend only on $d$, and $f_{\mu}$ is the density of the absolutely continuous part of $\mu$ (hence the limit is zero if $\mu$ is singular with respect to the Lebesgue measure on $\mathbb{R}^{d}$ ). Actually, it was announced in [13] that $c^{\prime}(d)=c(d)$, but a gap in the proof has been pointed out in [6].
Remark 4.7. If $p<d / 2$, Barthe and Bordenave [6] (see their Theorem 2) proved that, almost surely,

$$
\begin{align*}
\beta_{p}^{\prime}(d) \int\left(f_{\mu}(x)\right)^{(d-p) / d} \leq \liminf _{n \rightarrow \infty} & n^{p / d} W_{p}^{p}\left(\mu_{n}, \mu\right) \\
& \leq \limsup _{n \rightarrow \infty} n^{p / d} W_{p}^{p}\left(\mu_{n}, \mu\right) \leq \beta_{p}(d) \int\left(f_{\mu}(x)\right)^{(d-p) / d} \tag{4.3}
\end{align*}
$$

provided $\|X\|_{r p}<\infty$ for some $r>4 d /(d-2 p)$, which is a generalization of (4.2). For $p<d / 2$, Theorem 4.3 is difficult to compare with (4.3), because the results do not hold under the same assumptions on $d$ and $H$. A reasonable questions is: does (4.3) hold if $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$ and $p<d / 2$ ?

## 5 Moment inequalities

In this section, we give some upper bounds for the moments $\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r}^{r}$ when the variables have a strong moment of order $r p$.

As will be clear from the proofs, the maximal versions of these inequalities hold, namely: the quantity $\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r}$ can be replaced by

$$
\frac{1}{n^{r}}\left\|\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)\right\|_{r}^{r}
$$

in all the statements of this section.

### 5.1 Moment of order 1 and 2

Theorem 5.1. Let $q \in(1,2]$. If $\|X\|_{p}<\infty$, then, for any $M>0$,

- If $p>d(q-1) / q$,

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>M} d t+\frac{1}{n^{(q-1) / q}} \int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq M} d t
$$

- If $p=d(q-1) / q$,

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>M} d t+\frac{\log n}{n^{p / d}} \int_{0}^{\infty} t^{p-1}(H(t))^{(d-p) / d} \mathbf{1}_{t \leq M} d t
$$

- If $p \in[1, d(q-1) / q)$,

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>M} d t+\frac{1}{n^{p / d}} \int_{0}^{\infty} t^{p-1}(H(t))^{(d-p) / d} \mathbf{1}_{t \leq M} d t
$$

The constants implicitly involved in these inequalities do not depend on $M$.
Remark 5.2. In particular, if $H(t) \leq C t^{-p}(\log (1+t))^{-a}$ for some $C>0, a>1$, then

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1}=O\left(\frac{1}{(\log n)^{a-1}}\right)
$$

Remark 5.3. If $\|X\|_{r p, w}<\infty$ for $r \in(1,2)$ and $p \neq d(r-1) / r$, we easily infer from Theorem 5.1 that

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \begin{cases}\frac{\|X\|_{r p, w}^{p}}{n^{(r-1) / r}} & \text { if } p>d(r-1) / r \\ \frac{\|X\|_{r p, w}^{p}}{n^{p / d}} & \text { if } p \in[1, d(r-1) / r)\end{cases}
$$

which can also be deduced from Theorem 2.1. If $p=d(r-1) / r$, we get

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \frac{\|X\|_{r p, w}^{p}(\log n)^{2}}{n^{p / d}} .
$$

Now, if $\|X\|_{2 p, w}<\infty$, we get from Theorem 5.1 that

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1} \ll \begin{cases}\frac{\|X\|_{2 p, w}^{p} \log n}{\sqrt{n}} & \text { if } p>d / 2 \\ \frac{\|X\|_{2 p, w}^{p}(\log n)^{2}}{\sqrt{n}} & \text { if } p=d / 2 \\ \frac{\|X\|_{2 p, w}^{p}}{n^{p / d}} & \text { if } p \in[1, d / 2)\end{cases}
$$

Finally, if $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$, the rates in the cases $p>d / 2$ and $p=d / 2$ can be slightly improved (taking $q=2$ and $M=\infty$ in Theorem 5.1); this can be directly deduced from Theorem 5.4 below.

Note that all those bounds are consistent with that given in Theorem 1 of [16], and slightly more precise in terms of the moment conditions. Hence, the discussion on the optimality of the rates in [16] is also valid for our Theorem 5.1 (see Remark 5.5 below). For $p<d / 2$ and $\|X\|_{q}<\infty$ for some $q>d p /(d-p)$, it follows from Theorem 2(ii) in [12] that $\liminf _{n \rightarrow \infty} n^{p / d}\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1}>0$ if $\mu$ has a non degenerate absolutely continuous part with respect to the Lebesgue measure, and that $\lim \sup _{n \rightarrow \infty} n^{p / d}\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1}=0$ if $\mu$ is singular. Still for $p<d / 2$, we refer to the paper [2], which shows that, for compactly supported singular measures, the rates of convergence of $\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{1}$ can be much faster than $n^{-p / d}$.
Theorem 5.4. If $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$, then

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{2}^{2} \ll \begin{cases}\frac{1}{n}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{2} & \text { if } p>d / 2 \\ \frac{(\log n)^{2}}{n}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{2} & \text { if } p=d / 2 \\ \frac{1}{n^{2 p / d}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{2} & \text { if } p \in[1, d / 2)\end{cases}
$$

Remark 5.5. According to the discussion after Theorem 1 in [16], if $p \neq d / 2$, one can always find some measure $\mu$ for which the rate of Theorem 5.4 is reached (see example (a) and (b) in [16] for $p>d / 2$ and example (c) in [16] for $p<d / 2$ ).

Note also that, for $\mathbb{E}\left(W_{1}\left(\mu_{n}, \mu\right)\right)$ instead of $\left\|W_{1}\left(\mu_{n}, \mu\right)\right\|_{2}$, the bounds of Theorem 5.4 can be obtained from the general bound given in Theorem 3.8 of [19], under the condition $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$ (taking a ball of radius $r=H^{-1}(\alpha)$ to bound up the term $\tau_{n}^{\alpha}$ in [19], and noting that $\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t<\infty$ is equivalent to $\left.\int_{0}^{1}\left(H^{-1}(\alpha)\right)^{p} \alpha^{-1 / 2} d \alpha<\infty\right)$.

In the case $d=1, p=1$, del Barrio et al. [4] proved that $\sqrt{n} W_{1}\left(\mu_{n}, \mu\right)$ is stochastically bounded if and only if $\int_{0}^{\infty} \sqrt{H(t)} d t<\infty$ (see their Theorem 2.1(b)), which is consistent with the first inequality of Theorem 5.4. For $d=1, p>1$, we refer to the paper by Bobkov and Ledoux [8] for some conditions on $\mu$ ensuring faster rates of convergence. Finally, when $p=1, d=2$ and $\mu$ is the uniform measure over [ 0,1$]^{2}$, Ajtai et al. [1] proved that $\mathbb{E}\left(W_{1}\left(\mu_{n}, \mu\right)\right)$ is exactly of order $(\log n / n)^{1 / 2}$, while we get a rate of order $\log n / \sqrt{n}$, which is therefore suboptimal in that particular case. For other discussions about the rates, see for instance [17], Sections 2.3 and 2.4.

## 5.2 von Bahr-Esseen type inequalities

In this subsection, we shall prove some moment inequalities in the spirit of von Bahr and Esseen [3]. Recall that, for partial sums $S_{n}=Y_{1}+\cdots+Y_{n}$ of i.i.d real-valued random variables such that $\left\|Y_{1}\right\|_{r}<\infty$ for some $r \in[1,2]$ and $\mathbb{E}\left(Y_{1}\right)=0$, the inequality of von Bahr and Esseen reads as follows:

$$
\begin{equation*}
\left\|\frac{S_{n}}{n}\right\|_{r}^{r} \leq \frac{2\left\|Y_{1}\right\|_{r}^{r}}{n^{r-1}} \tag{5.1}
\end{equation*}
$$

In the case case where $r \in(1,2)$, we prove the following result.
Theorem 5.6. If $\|X\|_{r p}<\infty$ for some $r \in(1,2)$, then

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r}^{r} \ll \begin{cases}\frac{\|X\|_{r p}^{r p}}{n^{r-1}} & \text { if } p>d(r-1) / r \\ \frac{\|X\|_{r p}^{r p}}{n^{r p} / d} & \text { if } p \in[1, d(r-1) / r)\end{cases}
$$

Remark 5.7. For $d=1$, the first inequality of Theorem 5.6 has been proved in [10]. Our proof does not allow to deal with the case where $p=d(r-1) / r$. However, in that case, it is easy to see that

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r}^{r} \leq \frac{(\log n)^{r}}{n^{r-1}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / r} d t\right)^{r}
$$

(same proof as the second inequality of Theorem 5.4). For $p=1$ and $d<r /(r-1)$, using the dual expression of $W_{1}\left(\mu_{n}, \mu\right)$ (see (4.1)), we get the upper bound

$$
\begin{equation*}
\left\|\sup _{f \in \Lambda_{1}}\left|\frac{1}{n} \sum_{k=1}^{n}\left(f\left(X_{k}\right)-\mu(f)\right)\right|\right\|_{r}^{r} \ll \frac{\|X\|_{r}^{r}}{n^{r-1}} \tag{5.2}
\end{equation*}
$$

where $\Lambda_{1}$ is the the set of functions $f$ such that $|f(x)-f(y)| \leq|x-y|_{2}$. Note that (5.2) may be seen as a uniform version of the inequality (5.1) over the class $\Lambda_{1}$.

### 5.3 Rosenthal type inequalities

In this subsection, we shall prove some moment inequalities in the spirit of Rosenthal [22]. Recall that, for partial sums $S_{n}=Y_{1}+\cdots+Y_{n}$ of i.i.d real-valued random variables
such that $\left\|Y_{1}\right\|_{r}<\infty$ for some $r \geq 2$ and $\mathbb{E}\left(Y_{1}\right)=0$, the inequality of Rosenthal reads as follows: there exists two positive constants $c_{1}(r)$ and $c_{2}(r)$ such that

$$
\left\|\frac{S_{n}}{n}\right\|_{r}^{r} \leq c_{1}(r) \frac{\left\|Y_{1}\right\|_{2}^{r}}{n^{r / 2}}+c_{2}(r) \frac{\left\|Y_{1}\right\|_{r}^{r}}{n^{r-1}} .
$$

We refer to Pinelis [21] for the expression of the possible constants $c_{1}(r)$ and $c_{2}(r)$.
In the case where $r>2$, we prove the following result.
Theorem 5.8. If $\|X\|_{r p}<\infty$ for some $r>2$, then

$$
\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r}^{r} \ll \begin{cases}\frac{1}{n^{r / 2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{r}+\frac{\|X\|_{r p}^{r p}}{n^{r-1}} & \text { if } p>\frac{d(r-1)}{r} \\ \frac{1}{n^{r / 2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{r}+\frac{n^{\gamma}}{n^{p r / d}}\|X\|_{r p}^{r p} & \text { if } p \in\left(\frac{d}{2}, \frac{d(r-1)}{r}\right] \\ \frac{(\log n)^{r}}{n^{r / 2}}\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} d t\right)^{r}+\frac{(\log n)^{2}}{n^{r / 2}}\|X\|_{r p}^{r p} & \text { if } p=\frac{d}{2} \\ \frac{\|X\|_{r p}^{r p}}{n^{r p / d}} & \text { if } p \in\left[1, \frac{d}{2}\right)\end{cases}
$$

where, for the second inequality, $\gamma$ can be taken as $\gamma=\frac{\varepsilon(2 p-d)}{d(r-2+\varepsilon)}$ for any $\varepsilon>0$ (and the constants implicitely involved in the inequality depend on $\varepsilon$ ).
Remark 5.9. For $d=1$, the first inequality of Theorem 5.8 has been proved in [10]. As a consequence of the two first inequalities of Theorem 5.8, we obtain that, if $p>d / 2$,

$$
\limsup _{n \rightarrow \infty} \sqrt{n}\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r} \ll \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t
$$

As a consequence of the third inequality of Theorem 5.8 , we obtain that, if $p=d / 2$,

$$
\limsup _{n \rightarrow \infty} \frac{\sqrt{n}}{\log n}\left\|W_{p}^{p}\left(\mu_{n}, \mu\right)\right\|_{r} \ll \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t
$$

Note also that, according to the discussion after Theorem 1 in [16], if $p \neq d / 2$, one can always find some measure $\mu$ for which the rates of Theorem 5.8 are reached (see example (a) in [16] for $p>d / 2$ and example (c) in [16] for $p<d / 2$ ).

## 6 Proofs

The starting point of the proofs is Lemmas 5 and 6 in [16], which we recall below.
For $\ell \geq 0$, let $\mathcal{P}_{\ell}$ be the natural partition of $(-1,1]^{d}$ into $2^{d \ell}$ translations of $\left(-2^{-\ell}, 2^{-\ell}\right]^{d}$. Let also $B_{0}=(-1,1]^{d}$ and for any integer $m \geq 1, B_{m}=\left(-2^{m}, 2^{m}\right]^{d} \backslash\left(-2^{m-1}, 2^{m-1}\right]^{d}$. For a set $F \subset \mathbb{R}^{d}$ and $a>0$, we use the standard notation $a F=\{a x: x \in F\}$. For a probability measure $\nu$ on $\mathbb{R}^{d}$ and $m \geq 0$, let $\mathcal{R}_{B_{m}} \nu$ be the probability measure on $(-1,1]^{d}$ defined as the image of $\left.\nu\right|_{B_{m}} / \nu\left(B_{m}\right)$ by the map $x \mapsto x / 2^{m}$. For two probability measures $\mu$ and $\nu$ on $\mathbb{R}^{d}$, by Lemma 5 in [16], there exists a positive constant $\kappa_{p, d}$ depending only on $p$ and $d$ such that

$$
\begin{equation*}
W_{p}^{p}(\mu, \nu) \leq \kappa_{p, d} \mathcal{D}_{p}(\mu, \nu) \tag{6.1}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathcal{D}_{p}(\mu, \nu):=\sum_{m \geq 0} 2^{p m}\left|\mu\left(B_{m}\right)-\nu\left(B_{m}\right)\right|+\sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m}\right) \wedge \nu\left(B_{m}\right)\right) \mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu, \mathcal{R}_{B_{m}} \nu\right) \tag{6.2}
\end{equation*}
$$

with

$$
\begin{equation*}
\mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu, \mathcal{R}_{B_{m}} \nu\right)=\frac{2^{p}-1}{2} \sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\frac{\mu\left(2^{m} F \cap B_{m}\right)}{\mu\left(B_{m}\right)}-\frac{\nu\left(2^{m} F \cap B_{m}\right)}{\nu\left(B_{m}\right)}\right| . \tag{6.3}
\end{equation*}
$$

In addition, by Lemma 6 in [16],

$$
\mathcal{D}_{p}(\mu, \nu) \leq\left(\frac{3}{2} \vee \frac{2^{p}-1}{2}\right) \Delta_{p}(\mu, \nu)
$$

where

$$
\Delta_{p}(\mu, \nu)=\sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\mu\left(2^{m} F \cap B_{m}\right)-\nu\left(2^{m} F \cap B_{m}\right)\right| .
$$

From the considerations above, there exists a constant $C$ depending only on $p$ and $d$ such that

$$
\begin{equation*}
W_{p}^{p}\left(\mu_{k}, \mu\right) \leq C \Delta_{p}\left(\mu_{k}, \mu\right), \tag{6.4}
\end{equation*}
$$

where $\mu_{k}=\frac{1}{k} \sum_{i=1}^{k} \delta_{X_{i}}$. This inequality may be seen as an extension to the case $d>1$ of Èbralidze's inequality [15], which we used in [10] to obtain moment bounds for $W_{p}^{p}\left(\mu_{n}, \mu\right)$ when $d=1$.

As in [10] we shall use truncation arguments. For a positive real $M$, let $\mathcal{C}_{M}=$ $[-M, M]^{d}$,

$$
A_{p, M}\left(\mu_{k}, \mu\right)=\sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-\mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)\right|
$$

and

$$
B_{p, M}\left(\mu_{k}, \mu\right)=\sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}^{c}\right)-\mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}^{c}\right)\right| .
$$

With these notations, it follows that

$$
\begin{equation*}
\Delta_{p}\left(\mu_{k}, \mu\right) \leq A_{p, M}\left(\mu_{k}, \mu\right)+B_{p, M}\left(\mu_{k}, \mu\right) . \tag{6.5}
\end{equation*}
$$

For the proofs, we shall follow the order of the theorems, except for Theorem 5.6 whose proof comes naturally after those of Theorems 2.1 and 2.3.

### 6.1 Proof of Theorem 2.1

Let $M>0$ and $x>0$. Starting from (6.4) and (6.5), we get that

$$
\begin{align*}
\mathbb{P}\left(\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right)>n x\right) \leq \mathbb{P}\left(\max _{1 \leq k \leq n}\right. & \left.k A_{p, M}\left(\mu_{k}, \mu\right)>(n x / 2 C)\right) \\
& +\mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>(n x / 2 C)\right) . \tag{6.6}
\end{align*}
$$

Let $y=x / 2 C$. By Markov's inequality at order $q \in(r, 2)$ and $s \in[1, r)$,

$$
\begin{align*}
& \mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \leq \frac{\left\|\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)\right\|_{q}^{q}}{n^{q} y^{q}},  \tag{6.7}\\
& \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \leq \frac{\left\|\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)\right\|_{s}^{s}}{n^{s} y^{s}} . \tag{6.8}
\end{align*}
$$

To deal with (6.7), we first note that

$$
\begin{align*}
& \left\|\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)\right\|_{q} \\
& \ll \sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell}\left\|_{1 \leq k \leq n} \sum_{F \in \mathcal{P}_{\ell}}\left|k \mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-k \mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)\right|\right\|_{q} . \tag{6.9}
\end{align*}
$$

Now, clearly

$$
\begin{align*}
& \left\|\max _{1 \leq k \leq n} \sum_{F \in \mathcal{P}_{\ell}}\left|k \mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-k \mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)\right|\right\|_{q} \\
& \quad \leq\left\|\max _{1 \leq k \leq n}\left(k \mu_{k}\left(B_{m} \cap \mathcal{C}_{M}\right)+k \mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)\right\|_{q} \leq 2 n\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} . \tag{6.10}
\end{align*}
$$

On the other hand, by the (maximal version of) von Bahr-Essen inequality (see [3]),

$$
\left\|\max _{1 \leq k \leq n}\left|k \mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-k \mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)\right|\right\|_{q}^{q} \ll n \mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)
$$

so that, by using Hölder's inequality and the fact that $\left|\mathcal{P}_{\ell}\right|=2^{\ell d}$,

\begin{align*}
& \sum_{F \in \mathcal{P}_{\ell}}\left\|\max _{1 \leq k \leq n}\left|k \mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-k \mu\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)\right|\right\|_{q} \\
& \ll 2^{\ell d(q-1) / q} n^{1 / q}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} . \tag{6.11}
\end{align*}
$$

Combining (6.7), (6.10) and (6.11), we obtain that

& \mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \\
& \quad \ll \frac{1}{y^{q}}\left(\sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} \sum_{\ell \geq 0} \frac{1}{2^{p \ell}} \min \left(1, n^{-(q-1) / q} 2^{\ell d(q-1) / q}\right)\right)^{q} . \tag{6.12}
\end{align*}

In the same way, for the term (6.8), we obtain the upper bound

\end{align*}

- If $p>d(r-1) / r$, then, taking $q>r$ such that $p>d(q-1) / q$ and $s=1$, we get the upper bounds

\end{align*}
$$

and

\begin{equation*}
\mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \ll \frac{1}{y} \int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>M} d t \tag{6.15}
\end{equation*}
$$

Using that $H(t) \leq\|X\|_{r p, w}^{r p} t^{-r p}$ for $r \in(1,2)$, we infer from (6.6), (6.14) and (6.15) that

Taking $M=(n x)^{1 / p}$, we obtain the desired result when $p>d(r-1) / r$.

- If $p=d(r-1) / r$, then, taking $q=r$, we get the upper bound

\end{align*}
$$

Using that $H(t) \leq\|X\|_{r p, w}^{r p} t^{-r p}$ for $r \in(1,2)$, we infer from (6.6), (6.15) and (6.16) that

Taking $M=(n x)^{1 / p}$, we obtain the desired result when $p=d(r-1) / r$.

- If $p<d(r-1) / r$, then, taking $q>r$ and $s \in(1, r)$ such that $p<d(s-1) / s$, we get the upper bounds

\end{align*}
$$

and

$$
\begin{align*}
& \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \\
& \quad \ll \frac{1}{n^{s p / d} y^{s}}\left(\sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}^{c}\right)\right)^{1 / s}\right)^{s} \ll \frac{1}{n^{s p / d} y^{s}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / s} \mathbf{1}_{t>M} d t\right)^{s}, \tag{6.18}
\end{align*}
$$

Using that $H(t) \leq\|X\|_{r p, w}^{r p} t^{-r p}$ for $r \in(1,2)$, we infer from (6.6), (6.17) and (6.18) that

B_{p, M}^{*}\left(\mu_{k}, \mu\right)=\sum_{m \geq 0} 2^{p m}\left|\mu_{k}\left(B_{m} \cap \mathcal{C}_{M}^{c}\right)-\mu\left(B_{m} \cap \mathcal{C}_{M}^{c}\right)\right|
$$

With these notations,

& \mathbb{P}\left(\sum_{m \geq 0} 2^{p m}\left|\mu_{n}\left(B_{m}\right)-\mu\left(B_{m}\right)\right| \geq x /(2 C)\right) \leq \mathbb{P}\left(A_{p, M}^{*}\left(\mu_{n}, \mu\right)>x /(4 C)\right) \\
&+\mathbb{P}\left(B_{p, M}^{*}\left(\mu_{n}, \mu\right)>x /(4 C)\right) \tag{6.21}
\end{align*}
$$

Let $y=x / 4 C$. By Markov's inequality at order $q>2$ and 1 ,

\begin{align*}
& \mathbb{P}\left(A_{p, M}^{*}\left(\mu_{n}, \mu\right)>y\right) \leq \frac{\left\|A_{p, M}^{*}\left(\mu_{n}, \mu\right)\right\|_{q}^{q}}{y^{q}},  \tag{6.22}\\
& \mathbb{P}\left(B_{p, M}^{*}\left(\mu_{n}, \mu\right)>y\right) \leq \frac{\left\|B_{p, M}^{*}\left(\mu_{n}, \mu\right)\right\|_{1}}{y} . \tag{6.23}
\end{align*}

Applying Rosenthal's inequality, we get

& \ll \frac{1}{\sqrt{n}} \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t \leq M} d t+\frac{1}{n^{(q-1) / q}} \int_{0}^{\infty} t^{p-1} H^{1 / q}(t) \mathbf{1}_{t \leq M} d t
\end{aligned}
$$

Choosing $q>r$, it follows that

& \ll \frac{1}{\sqrt{n}} \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t+\frac{M^{p(q-r) / q}}{n^{(q-1) / q}} \tag{6.24}
\end{align*}
$$

the last inequality being true since we assumed that $\sup _{t>0} t^{r p} H(t)=1$.
On another hand,

\end{align*}

Gathering (6.21) - (6.25), we get that for any $q>r$,

\end{align*}
$$

Hence choosing $M=n^{1 / p} x^{1 / p}$, we infer from (6.19), (6.20) and (6.26) that for any $q>r$,

\end{align*}
$$

Note that

\int_{0}^{\infty} x^{r-2}\left(\int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>(n x)^{1 / p}} d t\right) d x \ll \frac{1}{n^{r-1}} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll \frac{\|X\|_{r p}^{r p}}{n^{r-1}} \tag{6.30}
\end{equation*}
$$

Let $\beta<(q-1) / q$. Applying Hölder's inequality, we obtain

& \ll \frac{1}{n^{q-1}} \int_{0}^{\infty} x^{r-1-q}(n x)^{(q-1-q \beta) / p}\left(\int_{0}^{\infty} t^{q(p-1+\beta)} H(t) \mathbf{1}_{t \leq(n x)^{1 / p}} d t\right) d x \\
& \ll \frac{n^{(q-1-q \beta) / p}}{n^{q-1}} \int_{0}^{\infty} t^{q(p-1+\beta)} H(t)\left(\int_{0}^{\infty} x^{r-1-q+(q-1-q \beta) / p} \mathbf{1}_{x \geq t^{p} / n} d x\right) d t \tag{6.31}
\end{align*}
$$

Taking $\beta$ close enough to $(q-1) / q$ in such a way that $q+1-r-(q-1-q \beta) / p>1$, we get

\end{equation*}

Gathering (6.29), (6.30) and (6.32), we obtain the desired result.

- If $p<d(r-1) / r$, let $q>r, s \in(1, r)$ such that $p<d(s-1) / s$, and let $M=n^{1 / d} x^{1 / p}$. From (6.6), (6.17) (6.18) we get the upper bound

& \ll \frac{1}{n^{s p / d}} \int_{0}^{\infty} x^{r-1-s}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / s} \mathbf{1}_{t>M} d t\right)^{s} d x \\
&+\frac{1}{n^{q p / d}} \int_{0}^{\infty} x^{r-1-q}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq M} d t\right)^{q} d x . \tag{6.33}
\end{align*}
$$

Proceeding exactly as for (6.31)-(6.32), with the choice $M=n^{1 / d} x^{1 / p}$, we get

& \ll \frac{1}{n^{p r / d}} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll \frac{\|X\|_{r p}^{r p}}{n^{p r / d}} . \tag{6.34}
\end{align*}
$$

In the same way, we get

& \frac{1}{n^{p s / d}} \int_{0}^{\infty} x^{r-1-s}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / s} \mathbf{1}_{t>n^{1 / d} x^{1 / p}} d t\right)^{s} d x \\
& \ll \frac{1}{n^{p r / d}} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll \frac{\|X\|_{r p}^{r p}}{n^{p r / d}} . \tag{6.35}
\end{align*}

Gathering (6.33), (6.34) and (6.35), we obtain the desired result.

\end{aligned}

Hence, it remains to prove that

\end{align*}

Interverting the sum and the integral, we easily get that

+\frac{n^{q-q \alpha}}{n^{q p / d} x^{q}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq n^{(p-d(1-\alpha)) /(d p)}} d t\right)^{q} . \tag{6.38}
\end{array}
$$

Proceeding as in (6.37) (taking the quantity $\beta<(q-1) / q$ close enough to $(q-1) / q$ in such a way that $(p-d(1-\alpha))((r-q)+(q-1-\beta q) / p)<0)$, we get that

$$
\begin{equation*}
\sum_{n=1}^{\infty} n^{(p r-(1-\alpha) r d-d) / d} \frac{n^{q-q \alpha}}{n^{q p / d}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq n^{(p-d(1-\alpha)) /(d p)}} d t\right)^{q} \ll\|X\|_{p r}^{p r}<\infty \tag{6.39}
\end{equation*}
$$

In the same, we get

$$
\begin{equation*}
\sum_{n=1}^{\infty} n^{(p r-(1-\alpha) r d-d) / d} \frac{n^{s-s \alpha}}{n^{s p / d}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / s} \mathbf{1}_{t>n^{(p-d(1-\alpha)) /(d p)}} d t\right)^{s} \ll\|X\|_{p r}^{p r}<\infty \tag{6.40}
\end{equation*}
$$

The second item of Theorem 3.5 follows from (6.38), (6.39) and (6.40).

- If $p<d(r-1) / r$, let $q \in(r, 2], s \in(1, r)$ such that $p<d(s-1) / s$, and let $M=(\log n)^{1 / p r}$. From (6.6), (6.17) and (6.18), we get the upper bound

& \quad+\frac{1}{(\log n)^{q / r} x^{q}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq(\log n)^{1 / p r}} d t\right)^{q} . \tag{6.41}
\end{align*}
$$

Proceeding as in (6.37) (taking the quantity $\beta<(q-1) / q$ close enough to $(q-1) / q$ in such a way that $(q / r)-(q-1-\beta q) /(p r)>1)$, we get that

\sum_{n=1}^{\infty} \frac{1}{n(\log n)^{q / r}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq(\log n)^{1 / p r}} d t\right)^{q} \ll\|X\|_{p r}^{p r}<\infty \tag{6.42}
\end{equation*}
$$

In the same, we get

\begin{equation*}
\sum_{n=1}^{\infty} \frac{1}{n(\log n)^{s / r}}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / s} \mathbf{1}_{t>(\log n)^{1 / p r}} d t\right)^{s} \ll\|X\|_{p r}^{p r}<\infty \tag{6.43}
\end{equation*}
$$

The third item of Theorem 3.5 follows from (6.41), (6.42) and (6.43).

### 6.5 Proof of Theorem 3.7

Let $r>2$. As in the proof of Theorem 2.3, we assume without loss of generality that $\|X\|_{r p, w}=1$; hence, we can use directly some of the upper bounds given in the proof of Theorem 2.3.

From (6.19), we see that

\max _{1 \leq k \leq n} k W_{p}^{p}\left(\mu_{k}, \mu\right) \leq C \sum_{m \geq 0} 2^{p m} \max _{1 \leq k \leq n}\left|k \mu_{k}\left(B_{m}\right)-k \mu\left(B_{m}\right)\right|+C \max _{1 \leq k \leq n} k V_{k}^{p} \tag{6.44}
\end{equation*}
$$

Now, for any $x>0$

$$
\mathbb{P}\left(\max _{1 \leq k \leq n} k V_{k}^{p}>x /(2 C)\right) \leq \sum_{k=1}^{n} \mathbb{P}\left(k V_{k}^{p}>x /(2 C)\right) \leq n \max _{1 \leq k \leq n} \mathbb{P}\left(k V_{k}^{p}>x /(2 C)\right)
$$

By (6.20), it follows that, for any $x>0$,

\mathbb{P}\left(\max _{1 \leq k \leq n} k V_{k}^{p}>x /(2 C)\right) \leq n \max _{1 \leq k \leq n} a(k, x / k) \leq n a(n, x / n) \tag{6.45}

the last inequality being true because $k \rightarrow a(k, x / k)$ is increasing. Now, by definition of $a(n, x)$, we infer that, for any

\end{gathered}

Hence, it remains to prove that

\sum_{n=1}^{\infty} n^{\alpha r-2} \mathbb{P}\left(\sum_{m \geq 0} 2^{p m} \max _{1 \leq k \leq n}\left|k \mu_{k}\left(B_{m}\right)-k \mu\left(B_{m}\right)\right| \geq n^{\alpha} x /(2 C)\right)<\infty \tag{6.46}
\end{equation*}
$$

Arguing as in the proof of Theorem 2.3, and using a maximal version of Rosenthal's inequality (see for instance [21]), we get that, for any $q>r$ and $M>0$,

\begin{align*}
& \mathbb{P}\left(\sum_{m \geq 0} 2^{p m} \max _{1 \leq k \leq n}\left|k \mu_{k}\left(B_{m}\right)-k \mu\left(B_{m}\right)\right| \geq n^{\alpha} x /(2 C)\right) \ll \frac{n^{(1-\alpha) q}}{x^{q} n^{q / 2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{q} \\
& \quad+\frac{n^{1-q \alpha}}{x^{q}}\left(\int_{0}^{\infty} t^{p-1} H^{1 / q}(t) \mathbf{1}_{t \leq M} d t\right)^{q}+\frac{n^{1-2 \alpha}}{x^{2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t>M} d t\right)^{2} \tag{6.47}
\end{align*}
$$

Clearly, since $\alpha \in(1 / 2,1]$, taking $q$ large enough, we get that

\sum_{n=1}^{\infty} n^{\alpha r-2} \frac{n^{(1-\alpha) q}}{n^{q / 2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{q}<\infty
$$

Let $M=n^{\alpha / p}$ and $\beta>1 / 2$. Applying Hölder's inequality, we get

\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t^{p / \alpha}>n} d t\right)^{2} \ll n^{\alpha(1-2 \beta) / p} \int_{0}^{\infty} t^{2(p-1+\beta)} H(t) \mathbf{1}_{t^{p / \alpha}>n} d t
$$

Hence, the sum over $n$ of the last term in (6.47) multiplied by $n^{\alpha r-2}$ will be finite provided

$$
\sum_{n=1}^{\infty} n^{\alpha(r-2)+\alpha(1-2 \beta) / p-1} \int_{0}^{\infty} t^{2(p-1+\beta)} H(t) \mathbf{1}_{t^{p / \alpha}>n} d t<\infty
$$

Taking $\beta$ close enough to $1 / 2$ so that $\alpha(r-2)+\alpha(1-2 \beta) / p>0$ and interverting the sum and the integral, we get that

$$
\sum_{n=1}^{\infty} n^{\alpha(r-2)+\alpha(1-2 \beta) / p-1} \int_{0}^{\infty} t^{2(p-1+\beta)} H(t) \mathbf{1}_{t^{p / \alpha}>n} d t \ll \int_{0}^{\infty} t^{p r-1} H(t) d t \ll\|X\|_{p r}^{p r}<\infty
$$

Arguing as in (6.31) with $\beta<(q-1) / q$, we get

\left(\int_{0}^{\infty} t^{p-1} H^{1 / q}(t) \mathbf{1}_{t^{p / \alpha} \leq n} d t\right)^{q} \ll n^{\alpha(q-1-\beta q) / p} \int_{0}^{\infty} t^{q(p-1+\beta)} H(t) \mathbf{1}_{t^{p / \alpha} \leq n} d t .
$$

Hence, the sum over $n$ of the second term in (6.47) multiplied by $n^{\alpha r-2}$ will be finite provided

\sum_{n=1}^{\infty} n^{\alpha(r-q)+\alpha(q-1-\beta q) / p-1} \int_{0}^{\infty} t^{q(p-1+\beta)} H(t) \mathbf{1}_{t^{p / \alpha} \leq n} d t<\infty

Taking $\beta$ close enough to $(q-1) / q$ so that $\alpha(r-q)+\alpha(q-1-\beta q) / p<0$ and interverting the sum and the integral, we get that

All the previous considerations end the proof of (6.46) and then of the theorem.

$$

Note that $n_{k+1} \leq 2 \mathrm{e} n_{k}$ and $m_{k} \sim 2^{-1} k^{-1 / 2} n_{k}$, as $k \rightarrow \infty$. Setting

\mu_{n_{k}, n}=\frac{1}{n-n_{k}} \sum_{i=n_{k}+1}^{n} \delta_{X_{i}}
$$

we first write that, for $n_{k}+1 \leq n<n_{k+1}$,

& \frac{\mu_{n}\left(\tilde{F}_{m}\right)}{\mu_{n}\left(B_{m}\right)}-\frac{\mu\left(\tilde{F}_{m}\right)}{\mu\left(B_{m}\right)}=\frac{n_{k}\left(\mu_{n_{k}}\left(\tilde{F}_{m}\right)-\mu\left(\tilde{F}_{m}\right)\right)}{n \mu_{n}\left(B_{m}\right)} \\
&+\frac{\left(n-n_{k}\right)\left(\mu_{n_{k}, n}\left(\tilde{F}_{m}\right)-\mu\left(\tilde{F}_{m}\right)\right)}{n \mu_{n}\left(B_{m}\right)}+\frac{\mu\left(B_{m}\right)-\mu_{n}\left(B_{m}\right)}{\mu_{n}\left(B_{m}\right) \mu\left(B_{m}\right)} \mu\left(\tilde{F}_{m}\right)
\end{aligned}
$$

Taking into account that, for any positive measure $\nu$,

$$
\sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}} \nu\left(\tilde{F}_{m}\right) \leq\left(2^{p}-1\right)^{-1} \nu\left(B_{m}\right),
$$

simple algebras lead to the following inequality: for $n_{k}+1 \leq n<n_{k+1}$,

\sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}} \frac{n_{k}\left|\mu_{n_{k}}\left(\tilde{F}_{m}\right)-\mu\left(\tilde{F}_{m}\right)\right|}{n \mu_{n}\left(B_{m}\right)} \leq \sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\frac{\mu_{n_{k}}\left(\tilde{F}_{m}\right)}{\mu_{n_{k}}\left(B_{m}\right)}-\frac{\mu\left(\tilde{F}_{m}\right)}{\mu\left(B_{m}\right)}\right| \\
+\frac{1}{2^{p}-1} \frac{\left|\mu_{n_{k}}\left(B_{m}\right)-\mu_{n}\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)}+\frac{1}{2^{p}-1} \frac{\left|\mu_{n_{k}}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)} .
\end{array}
$$

Similarly, for $n_{k}+1 \leq n<n_{k+1}$,

\begin{aligned}
& \sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}} \frac{\left(n-n_{k}\right)\left|\mu_{n_{k}, n}\left(\tilde{F}_{m}\right)-\mu\left(\tilde{F}_{m}\right)\right|}{n \mu_{n}\left(B_{m}\right)} \\
& \leq \frac{\left(n-n_{k}\right)}{n} \sum_{\ell \geq 1} 2^{-p \ell} \sum_{F \in \mathcal{P}_{\ell}}\left|\frac{\mu_{n_{k}, n}\left(\tilde{F}_{m}\right)}{\mu_{n_{k}, n}\left(B_{m}\right)}-\frac{\mu\left(\tilde{F}_{m}\right)}{\mu\left(B_{m}\right)}\right|+\frac{\left(n-n_{k}\right)}{\left(2^{p}-1\right) n} \frac{\left|\mu_{n_{k}, n}\left(B_{m}\right)-\mu_{n}\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)} \\
&+\frac{\left(n-n_{k}\right)}{\left(2^{p}-1\right) n} \frac{\left|\mu_{n_{k}, n}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)} .
\end{aligned}
$$

So overall, for $n_{k}+1 \leq n<n_{k+1}$,

\begin{align*}
& \mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu_{n}, \mathcal{R}_{B_{m}} \mu\right) \leq \mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu_{n_{k}}, \mathcal{R}_{B_{m}} \mu\right)+\frac{\left(n-n_{k}\right)}{n} \mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu_{n_{k}, n}, \mathcal{R}_{B_{m}} \mu\right) \\
&+ \frac{1}{2} \frac{\left|\mu_{n_{k}}\left(B_{m}\right)-\mu_{n}\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)}+\frac{1}{2} \frac{\left|\mu_{n_{k}}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)}+\frac{1}{2} \frac{\left|\mu_{n}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{\mu_{n}\left(B_{m}\right)} \\

&+\max _{n_{k}+1 \leq n \leq n_{k+1}} \frac{\left(n-n_{k}\right)}{n} \sum_{m \geq 0} 2^{p m} \mu\left(B_{m}\right) \frac{\mathcal{D}_{p}\left(\mathcal{R}_{B_{m}} \mu_{n_{k}, n}, \mathcal{R}_{B_{m}} \mu\right)}{v_{n_{k+1}}} \\
& \quad+\max _{n_{k} \leq n \leq n_{k+1}}\left(2+\frac{\left(n-n_{k}\right)}{2 n}\right) \sum_{m \geq 0} 2^{p m} \frac{\left|\mu_{n}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{v_{n_{k+1}}} \\
&+\max _{n_{k}+1 \leq n \leq n_{k+1}} \frac{\left(n-n_{k}\right)}{n} \sum_{m \geq 0} 2^{p m} \frac{\left|\mu_{n_{k}, n}\left(B_{m}\right)-\mu\left(B_{m}\right)\right|}{v_{n_{k+1}}} . \tag{6.49}
\end{align*}
$$

We first deal with the third term in the right-hand side of (6.49). With this aim, let

\sum_{m \geq 0} 2^{p m} \frac{\mu\left(B_{m} \cap \mathcal{C}_{n_{k}}^{c}\right)}{v_{n_{k+1}}} \ll \frac{1}{v_{n_{k+1}}} \int_{0}^{\infty} & t^{p-1} H(t) \mathbf{1}_{t>M_{n_{k}}} d t \\
& \ll \int_{0}^{\infty} t^{2 p-1} H(t) \mathbf{1}_{t>M_{n_{k}}} d t \rightarrow 0, \text { as } k \rightarrow \infty \tag{6.51}
\end{align*}
$$

On the other hand,

\max _{n_{k} \leq n \leq n_{k+1}} \mu_{n}\left(B_{m} \cap \mathcal{C}_{n_{k}}^{c}\right) \leq \frac{1}{n_{k}} \sum_{i=1}^{n_{k+1}} \mathbf{1}_{\left\{X_{i} \in B_{m}\right\}} \mathbf{1}_{\left\{\left|X_{i}\right|>M_{n_{k}}\right\}} \ll \frac{1}{n_{k}} \sum_{i=1}^{n_{k+1}} \mathbf{1}_{\left\{X_{i} \in B_{m}\right\}} \mathbf{1}_{\left\{\left|X_{i}\right|>c M_{i}\right\}},
$$

where $c$ is a universal positive constant. Hence to prove that

\max _{n_{k} \leq n \leq n_{k+1}} \sum_{m \geq 0} 2^{p m} \frac{\mu_{n}\left(B_{m} \cap \mathcal{C}_{n_{k}}^{c}\right)}{v_{n_{k+1}}} \rightarrow 0, \text { almost surely, as } k \rightarrow \infty \tag{6.52}
\end{equation*}
$$

it suffices to prove that

\begin{equation*}
\frac{1}{n v_{n}} \sum_{i=1}^{n} \sum_{m \geq 0} 2^{p m} \mathbf{1}_{\left\{X_{i} \in B_{m}\right\}} \mathbf{1}_{\left\{\left|X_{i}\right|>c M_{i}\right\}} \rightarrow 0, \text { almost surely, as } n \rightarrow \infty \tag{6.53}
\end{equation*}
$$

But

$$
\begin{aligned}
& \sum_{i \geq 1} \frac{1}{\sqrt{i L L i}} \sum_{m \geq 0} 2^{p m} \mathbb{P}\left(X_{i} \in B_{m},\left|X_{i}\right|>c M_{i}\right) \ll \sum_{i \geq 1} \frac{1}{\sqrt{i L L i}} \int_{0}^{\infty} t^{p-1} H(t) \mathbf{1}_{t>c M_{i}} d t \\
& \ll \int_{0}^{\infty} t^{2 p-1} H(t) d t<\infty .
\end{aligned}
$$

By using Kronecker's lemma and recalling that $n v_{n}=(n L L n)^{1 / 2}$, this shows that (6.53) holds and so (6.52) does also.

We show now that there exists a positive constant $C$ such that, almost surely,

\leq & \left(\frac{c_{1}}{\lambda V n_{k} v_{n_{k+1}}}\right)^{q} q^{q / 2} n_{k+1}^{q / 2} V^{q}+\left(\frac{c_{2}}{\lambda V n_{k} v_{n_{k+1}}}\right)^{q} q^{q} n_{k+1}\left(\int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq M_{n_{k}}} d t\right)^{q} .
\end{aligned}
$$

Select now

and take $\lambda=\lambda_{\gamma}=2 c_{1} \mathrm{e}^{2} \sqrt{\gamma}$. With this choice of $q_{k}$, it follows that

& \ll \sum_{k \geq 4}\left(n_{k+1}-n_{k}\right) \sum_{m=0}^{s_{k}+1} \exp \left(-\frac{a C^{2} n_{k}^{2} b_{m}^{2} v_{n_{k}}^{2}}{\left(n_{k+1}-n_{k}\right) 2^{2 p m} \mu\left(B_{m}\right)}\right) \\

\sum_{F \in \mathcal{P}_{\ell}} \| \max _{1 \leq k \leq n} \mid k \mu_{k}\left(2^{m} F \cap B_{m} \cap \mathcal{C}_{M}\right)-k \mu\left(2^{m} F\right. & \left.\cap B_{m} \cap \mathcal{C}_{M}\right) \mid \|_{q} \leq 2^{\ell d / 2} \sqrt{n}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / 2} \\
& +2^{\ell d(q-1) / q} n^{1 / q}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} \tag{6.70}
\end{align*}
$$

So, starting from (6.9) and taking into account (6.10) and (6.70) together with the fact that for non-negative reals $a, b, c, \min (a, b+c) \leq \min (a, b)+\min (a, c)$, we get

$$
\begin{equation*}
\left\|\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)\right\|_{q} \ll n\left(I_{1}+I_{2}\right) \tag{6.71}
\end{equation*}
$$

where

$$
I_{1}=\sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell} \min \left(\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q}, n^{-1 / 2} 2^{\ell d / 2}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / 2}\right)
$$

and

$$
I_{2}=\sum_{m \geq 0} 2^{p m} \sum_{\ell \geq 0} 2^{-p \ell}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} \min \left(1, n^{-(q-1) / q} 2^{\ell d(q-1) / q}\right)
$$

Combining (6.67) and (6.71), we obtain that

$$
\begin{equation*}
\mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \ll \frac{\left(I_{1}+I_{2}\right)^{q}}{y^{q}} . \tag{6.72}
\end{equation*}
$$

From (6.72), we see that four cases arise:

- $p>d(r-1) / r$. In that case $p>d / 2$, and

$$
I_{1} \leq n^{-1 / 2} \sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / 2} \ll n^{-1 / 2} \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t \leq M} d t
$$

Consequently

$$
\int_{v_{n}}^{\infty} x^{r-1-q} I_{1}^{q} d x \ll n^{-q / 2} v_{n}^{r-q}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{q}
$$

Choosing $v_{n}=n^{-1 / 2} \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t$, we get

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} I_{1}^{q} d x \ll n^{-r / 2}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{r} \tag{6.73}
\end{equation*}
$$

Let us now deal with the term involving $I_{2}$. First, we choose $q$ close enough to $r$ in such a way that $p>d(q-1) / q$. In that case

$$
I_{2} \leq n^{-(q-1) / q} \sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} \ll n^{-(q-1) / q} \int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq M} d t
$$

Let $M=(n x)^{1 / p}$. Arguing as in (6.31) with $\beta<(q-1) / q$, we get

$$
\int_{0}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll \frac{n^{(q-1-\beta q) / p}}{n^{q-1}} \int_{0}^{\infty} t^{q(p-1+\beta)} H(t) \int_{0}^{\infty} x^{r-1-q} x^{(q-1-\beta q) / p} \mathbf{1}_{x \geq t^{p} / n} d x d t
$$

Taking $\beta$ close enough to $(q-1) / q$ in such a way that $r-q+(q-1-\beta q) / p<0$, we get that

$$
\begin{equation*}
\int_{0}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll n^{-(r-1)} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll n^{-(r-1)}\|X\|_{r p}^{r p} \tag{6.74}
\end{equation*}
$$

From (6.72), (6.73) and (6.74), we get that

$$
\begin{align*}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)\right. & >n x /(2 C)) d x \\
& \ll n^{-r / 2}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t\right)^{r}+n^{-(r-1)}\|X\|_{r p}^{r p} \tag{6.75}
\end{align*}
$$

In the same way, since $p>d / 2$, we infer from (6.69) that

$$
\begin{aligned}
& \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \ll \frac{1}{n x^{2}}\left(\sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}^{c}\right)\right)^{1 / 2}\right)^{2} \\
& \ll \frac{1}{n x^{2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t>M} d t\right)^{2}
\end{aligned}
$$

Proceeding again as in (6.31) with $\beta>1 / 2$, we infer that

$$
\begin{aligned}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k\right. & \left.k B_{p, M}\left(\mu_{k}, \mu\right)>n x /(2 C)\right) d x \\
& \ll \frac{n^{(1-2 \beta) / p}}{n} \int_{0}^{\infty} t^{2(p-1+\beta)} H(t) \int_{0}^{\infty} x^{r-3} x^{(1-2 \beta) / p} \mathbf{1}_{x<t^{p} / n} d x d t
\end{aligned}
$$

Taking $\beta$ close enough to $1 / 2$ in such a way that $(r-2)+(1-2 \beta) / p>0$, we get that

$$
\begin{align*}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)\right. & >n x /(2 C)) d x \\
& \ll n^{-(r-1)} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll n^{-(r-1)}\|X\|_{r p}^{r p} \tag{6.76}
\end{align*}
$$

Finally, starting from (6.66) with $v_{n}=n^{-1 / 2} \int_{0}^{\infty} t^{p-1} \sqrt{H(t)} d t$, and gathering (6.6), (6.67), (6.68), (6.75) and (6.76), Theorem 5.8 is proved in the case where $p>d(r-1) / r$.

- $d / 2<p \leq d(r-1) / r$. In that case we use the upper bound (6.73) without any changes. Let us now deal with the term involving $I_{2}$. Starting from the definition of $I_{2}$, and considering the two cases where either $2^{\ell}<n^{1 / d}$ or $2^{\ell} \geq n^{1 / d}$, we infer that

$$
I_{2} \ll n^{-p / d} \sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{1 / q} \ll n^{-p / d} \int_{0}^{\infty} t^{p-1}(H(t))^{1 / q} \mathbf{1}_{t \leq M} d t
$$

Let $M=(n x)^{1 / p} / u_{n}$ for some sequence of positive numbers $\left(u_{n}\right)_{n>0}$ that will be chosen later. Arguing as in (6.74), we get

$$
\begin{equation*}
\int_{0}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll n^{q-r-p q / d} u_{n}^{p(r-q)} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll n^{q-r-p q / d} u_{n}^{p(r-q)}\|X\|_{r p}^{r p} . \tag{6.77}
\end{equation*}
$$

In the same way, arguing as to get (6.76),

$$
\begin{align*}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n}\right. & \left.k B_{p, M}\left(\mu_{k}, \mu\right)>n x /(2 C)\right) d x \\
& \ll n^{-(r-1)} u_{n}^{p(r-2)} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll n^{-(r-1)} u_{n}^{p(r-2)}\|X\|_{r p}^{r p} \tag{6.78}
\end{align*}
$$

Now $n^{q-r-p q / d} u_{n}^{(r-q) p}=n^{-(r-1)} u_{n}^{p(r-2)}$ iff $u_{n}^{p}=n^{-1 /(q-2)} n^{(1-p / d) q /(q-2)}$. With this choice of $u_{n}$ and taking $q=r+\varepsilon$, we have

$$
\begin{aligned}
& n^{q-r-p q / d} u_{n}^{(r-q) p}=n^{-r p / d}\left(n^{(d-p) / d} / u_{n}^{p}\right)^{q-r}=n^{-r p / d} n^{(2 p-d)(q-r) /(d(q-2))} \\
&=n^{-r p / d} n^{\varepsilon(2 p-d) /(d(r-2+\varepsilon))} .
\end{aligned}
$$

Hence, with this choice of $u_{n}$, the upper bounds (6.73), (6.77) and (6.78) give the desired inequality for $d / 2<p \leq d(r-1) / r$.

- $p<d / 2$. Note first that, by homogeneity, the general inequality may be deduced from the case where $\|X\|_{r p}=1$ by considering the variables $X_{i} /\|X\|_{r p}$. Hence, from now, we shall assume that $\|X\|_{r p}=1$.

Let $M=(n x)^{1 / p} / u_{n}$ for some sequence of positive numbers $\left(u_{n}\right)_{n>0}$. We first note that, since $q>d /(d-p)$ (indeed $q>2$ and $d /(d-p)<2)$, the upper bound (6.77) holds. Taking $u_{n}=n^{1 / p} / n^{1 / d}$, we get

$$
\begin{equation*}
\int_{0}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll n^{-r p / d} \tag{6.79}
\end{equation*}
$$

Let us now deal with the term involving $I_{1}$. Starting from the definition of $I_{1}$, and considering the two cases where

$$
\text { either } \quad 2^{\ell}<n^{1 / d}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{(2-q) /(d q)} \quad \text { or } \quad 2^{\ell} \geq n^{1 / d}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{(2-q) /(d q)}
$$

we infer that

$$
\begin{equation*}
I_{1} \ll n^{-p / d} \sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}\right)\right)^{(d+p(q-2)) /(d q)} \ll n^{-p / d} \int_{0}^{\infty} t^{p-1}(H(t))^{(d+p(q-2)) /(d q)} d t \tag{6.80}
\end{equation*}
$$

We choose now $q>r$ such that $(d+p(q-2)) /(d q)>1 / r$ (this is true whatever $q$ if $p \geq d / r$, otherwise we need to choose $r<q<r(d-2 p) /(d-r p)$ ). Since $\|X\|_{r p}=1$, $H(t) \leq \min \left(1, t^{-r p}\right)$, which together (6.80) and the choice of $q$ implies that $I_{1} \ll n^{-p / d}$. Consequently, taking $v_{n}=n^{-p / d}$,

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} I_{1}^{q} d x \ll n^{-q p / d} v_{n}^{r-q} \ll n^{-r p / d} \tag{6.81}
\end{equation*}
$$

From (6.72), (6.79) and (6.81), we get that

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)>n x /(2 C)\right) d x \ll n^{-r p / d} \tag{6.82}
\end{equation*}
$$

On another hand, since $p<d / 2$, we infer from (6.69) that

$$
\begin{aligned}
\mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n y\right) \ll \frac{1}{n^{2 p / d} x^{2}}( & \left.\sum_{m \geq 0} 2^{p m}\left(\mu\left(B_{m} \cap \mathcal{C}_{M}^{c}\right)\right)^{1 / 2}\right)^{2} \\
& \ll \frac{1}{n^{2 p / d} x^{2}}\left(\int_{0}^{\infty} t^{p-1} \sqrt{H(t)} \mathbf{1}_{t>M} d t\right)^{2}
\end{aligned}
$$

Proceeding again as in (6.78), we get

$$
\begin{align*}
\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)\right. & >n x /(2 C)) d x \\
& \ll \frac{u_{n}^{p(r-2)}}{n^{((r-2) d+2 p) / d}} \int_{0}^{\infty} t^{r p-1} H(t) d t \ll n^{-r p / d}, \tag{6.83}
\end{align*}
$$

the last inequality being true because $u_{n}=n^{1 / p} / n^{1 / d}$ and $\|X\|_{r p}=1$.
Finally, starting from (6.66) with $v_{n}=n^{-p / d}$, and gathering (6.6), (6.82) and (6.83), Theorem 5.8 is proved in the case where $p<d / 2$ and $\|X\|_{r p}=1$.

- $p=d / 2$. Again, without loss of generality we can assume that $\|X\|_{r d / 2}=1$. We proceed as before to handle the term $\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)>n x /(2 C)\right) d x$. We take $q>r$ and use the Rosenthal inequality. We then infer that

$$
\begin{aligned}
I_{1} \ll n^{-1 / 2} \log n\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)}\right. & \left.\mathbf{1}_{t \leq M} d t\right) \\
& +n^{-1 / 2}\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \log (1 / H(t)) \mathbf{1}_{t \leq M} d t\right)
\end{aligned}
$$

Therefore, if we choose

$$
\begin{equation*}
v_{n} \geq n^{-1 / 2} \max \left(\log n \int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} d t, \int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \log (1 / H(t)) d t\right)=: v_{n}(1) \tag{6.84}
\end{equation*}
$$

we get

$$
\begin{aligned}
\int_{v_{n}}^{\infty} x^{r-1-q} I_{1}^{q} d x \ll n^{-r / 2}(\log n)^{r}\left(\int_{0}^{\infty}\right. & \left.t^{d / 2-1} \sqrt{H(t)} d t\right)^{r} \\
& +n^{-r / 2}\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \log (1 / H(t)) d t\right)^{r}
\end{aligned}
$$

Since $H(t) \leq \min \left(1, t^{-r d / 2}\right)$ and $r>2$, it follows that

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} I_{1}^{q} d x \ll n^{-r / 2}(\log n)^{r}\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} d t\right)^{r}+n^{-r / 2} \tag{6.85}
\end{equation*}
$$

On another hand, we have

$$
\int_{v_{n}}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll n^{-q / 2} \int_{v_{n}}^{\infty} x^{r-1-q}\left(\int_{0}^{\infty} t^{d / 2-1} H^{1 / q}(t) \mathbf{1}_{t \leq M} d t\right)^{q} d x
$$

Selecting

$$
M=(n x)^{2 / d} / u_{n} \text { with } u_{n}=n^{1 / d}
$$

we get, by taking into account previous computations, that

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} I_{2}^{q} d x \ll n^{-r / 2} \int_{0}^{\infty} t^{r d / 2-1} H(t) d t=n^{-r / 2} . \tag{6.86}
\end{equation*}
$$

We handle now the quantity $\int_{v_{n}}^{\infty} x^{r-1} \mathbb{P}\left(\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)>n x /(2 C)\right) d x$. We shall apply the Rosenthal inequality as we did to handle $\left\|\max _{1 \leq k \leq n} k A_{p, M}\left(\mu_{k}, \mu\right)\right\|_{q}$, but with $q \in(2, r)$. We then infer that

$$
\begin{equation*}
\left\|\max _{1 \leq k \leq n} k B_{p, M}\left(\mu_{k}, \mu\right)\right\|_{q} \ll n\left(J_{1}+J_{2}+J_{3}\right) \tag{6.87}
\end{equation*}
$$

with

$$
\begin{gathered}
J_{1}=n^{-1 / 2} \log n \int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \mathbf{1}_{t>M} d t \\
J_{2}=n^{-1 / 2} \int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \log (1 / H(t)) \mathbf{1}_{t>M} d t
\end{gathered}
$$

and

$$
J_{3}=n^{-1 / 2} \int_{0}^{\infty} t^{d / 2-1} H^{1 / q}(t) \mathbf{1}_{t>M} d t
$$

Note that since $M=(n x)^{2 / d} / u_{n}$ with $u_{n}=n^{1 / d}$, applying Hölder's inequality as in previous computations, we get

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} J_{3}^{q} d x \ll n^{-r / 2} \int_{0}^{\infty} t^{r d / 2-1} H(t) d t \tag{6.88}
\end{equation*}
$$

On another hand, using that $H(t) \leq \min \left(1, t^{-r d / 2}\right.$ ), we have (since $r>2$ and $M^{d / 2}=$ $x \sqrt{n}$ ),

$$
\begin{aligned}
\int_{v_{n}}^{\infty} x^{r-1-q} J_{1}^{q} d x \leq n^{-q / 2}(\log n)^{q} \int_{v_{n}}^{\infty} x^{r-1-q}\left(\int_{M}^{\infty} t^{d / 2-1} t^{-r d / 4} d t\right)^{q} d x \\
\ll n^{-r q / 4}(\log n)^{q} \int_{v_{n}}^{\infty} x^{r(1-q / 2)-1} d x \ll n^{-r q / 4}(\log n)^{q} v_{n}^{r} v_{n}^{-r q / 2}
\end{aligned}
$$

Therefore if

$$
\begin{equation*}
v_{n} \geq n^{-1 / 2}(\log n)^{2 / r}=: v_{n}(2) \tag{6.89}
\end{equation*}
$$

we get

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} J_{1}^{q} d x \ll n^{-r / 2}(\log n)^{2} \tag{6.90}
\end{equation*}
$$

We handle now the term involving $J_{2}$. We have

$$
\int_{v_{n}}^{\infty} x^{r-1-q} J_{2}^{q} d x=n^{-q / 2} \int_{v_{n}}^{\infty} x^{r-1-q}\left(\int_{0}^{\infty} t^{d / 2-1} \sqrt{H(t)} \log (1 / H(t)) \mathbf{1}_{t>M} d t\right)^{q} d x
$$

If $v_{n} \geq n^{-1 / 2}$, using that $H(t) \leq \min \left(1, t^{-r d / 2}\right)$, simple computations lead to

$$
\int_{v_{n}}^{\infty} x^{r-1-q} J_{2}^{q} d x \ll n^{-r / 2}\left(\sqrt{n} v_{n}\right)^{r(1-q / 2)}\left\{\left(\log \left(\sqrt{n} v_{n}\right)\right)^{q}+1\right\}
$$

Therefore, if (6.89) holds, we get

$$
\begin{equation*}
\int_{v_{n}}^{\infty} x^{r-1-q} J_{2}^{q} d x \ll n^{-r / 2}(\log n)^{2} \tag{6.91}
\end{equation*}
$$

$$
\text { Empirical Wasserstein distance in } \mathbb{R}^{d}
$$

So finally if we choose

$$
v_{n}=\max \left(v_{n}(1), v_{n}(2)\right),
$$

the constraints (6.84) and (6.89) are satisfied. Starting from (6.66), and gathering the bounds (6.6), (6.85), (6.86), (6.87), (6.88), (6.90), and (6.91), we get the desired inequality in the case $\|X\|_{r d / 2}=1$.
